Banking outlets in 4,373 GPs

Bhubaneswar, August 11: For providing basic banking facilities in unbanked Gram Panchayats (GPs), the state Cabinet, led by Chief Minister Naveen Patnaik, Friday approved a scheme to open Customer Service Point (CSP) Plus banking outlets with a support amount of ₹500 crore.

The Cabinet has **CABINE** approved the scheme to open CSP Plus banking outlets in coordination with six Public Sector Banks (PSBs)-SBI, Punjab National Bank (PNB), UCO Bank, Union Bank of India, Bank of Baroda and Bank of India in 4,373 unbanked GPs of the state with budgetary support of around ₹500 crore, said Finance Minister Bikram Keshari Arukha.

Out of 6,798 GPs in the state, around 65 percent (4,373) do not have brick and mortar branches

Since banking is an essential service for financial inclusion, every GP of the state needs to be provided with a brick and mortar branch for uninterrupted

banking services, he said. However, the progress in terms of setting up brick and mortar branches in unbanked GPs by banks is very slow and negligible. Therefore, the state government has come

DECISION forward with an ambitious target of providing banking services to every GP through CSP Plus banking outlets, Arukha stated.

The minister further informed that the scheme will be implemented in a phased manner within FY 2023-24.

The government of Odisha will provide rent free banking space for 5 years. In addition to this, the government will also bear onetime expenses for fixed costs and recurring expenses for a period of

New Delhi, August 11: In a bid to overhaul colonial-era criminal laws in the country, the government Friday introduced three bills in the Lok Sabha that calls for capital punishment in gruesome crimes like mob lynching and minor rape.

Home Minister Amit Shah introduced the Bharatiya Nyaya Sanhita (BNS) Bill, 2023, Bharatiya Nagarik Suraksha Sanhita (BNSS) Bill, 2023 and Bharatiya Sakshya (BS) Bill, 2023 that will replace the Indian Penal Code, 1860, Criminal Procedure Act, 1898 and the Indian Evidence Act, 1872, respectively. The Minister urged Lok Sabha Speaker Om Birla to refer the three bills for examination by the Parliamentary Standing Committee on Home Affairs.

Shah said the new laws, once passed, will bring an overhaul of the criminal justice system and everyone will get justice in a maximum of three years.

The BNS Bill has provisions that seek to repeal sedition, and award maximum capital punishment for crimes such as mob lynching and rape of minors, the Home minister said. The bill also has provisions to provide community service as one of the punishments for first-time petty offences. It also lists new offences such as acts of secession, armed rebellion, subversive activities, separatist activities or endangering the sovereignty or unity and integrity of India.

The offences against women and children, murder and offences against the State have been given precedence. Shah said, adding that various offences have been made gender-neutral. Under the new laws, the

instead. Rising prices for ingredients, including dairy products, have put global fast food chains in India under pressure to trim costs while keeping customers satisfied.

Domino's promotion price for its cheapest pizza is just 60 US cents in India. where its franchisee has publicly flagged concerns over a 40 percent surge in the price of cheese during the financial year that ended in March.

Many Subway and McDonald's outlets in India have also removed tomatoes from their menus in recent weeks citing quality issues after prices surged around 450 percent to record highs.



NGT STAY ON TAMPARA LAKE BEAUTIFICATION

Bhubaneswar, August 11: The National Green Tribunal (NGT) Friday put a stay on all 'illegal construction work in Tampara Lake under Chhatrapur tehsil of Ganjam district.

Hearing a petition filed by Cuttack-based Wildlife Society of Orissa, the tribunal asked the Ganjam Collector to ensure that no illegal construction is carried out and no part of the lake is encroached upon.

The tribunal $\ensuremath{\hat{h}as}$ constituted a four-member high-level committee that would visit the lake site and conduct an enquiry to ascertain the veracity of the allegations made in the petition filed by the Wildlife Society of Orissa.

The committee comprised senior scientists of Ministry of Environment, Forests and Climate Change (MoEF&CC), Regional Office here and Central Pollution Control Board, the Ganiam Collector or his nominee not below the rank of Additional District Magistrate (ADM), and the Secretary of

The green panel asked Ganjam Collector to ensure that no illegal construction is carried out and no part of Tampara Lake is encroached upon

State Wetland Authority or his nominee of a senior rank.

The tribunal has directed the committee to submit the enquiry report following the on-site visit within four weeks.

Rushikulya river basin (Southeast of Rushikulya river and east of National Highway-16) has been designated as a Ramsar Site October 12, 2021. The lake has already been placed in the Wetland Atlas prepared by MoEF&CC in 2010 prior to its inclusion as a Ramsar site which is protected under Wetland Conservation protected Rules, 2017. Rushikulya estuary near the lake is known as a prominent Olive Ridley nesting site. 'Permanent constructions in-

cluding restaurants, hotels, Tampara resorts and cottages and so many other concrete structures are coming up within the water area and within 50 metres of Tampara Lake. Berhampur Development Authority (BeDA) has finalised additional infrastructure projects at a cost of ₹8 crore to transform the lake into a tourist destination and the above project is also found mention in 'Swadesh Darshan' scheme of the Union government," said Sankar Prasad Pani, advocate for Wildlife Society of Orissa.

The Wildlife Society of Orissa alleged in its petition that the water body has been filled with earth and murram for construction purposes which was revealed in Google Earth image captured June 2. It alleged that construction

works are going on in several plots in the lake area which are earmarked as forest land.

The shift to electric transportation was necessary in view of the threat posed by climate change, he said.

As a policy, these e-autos are operated exclusively by women, transgenders and HIV positive people, he said.

Bhubaneswar, August 11: World Elephant Day is being celebrated August 12 since 2012 to raise awareness about the critical issues faced by jumbos and to advocate for their protection and conservation. However, the situation in Odisha is critical when it comes to safety of elephants as their deaths due to poaching, mishaps and diseases are increasing by the day. Keeping this in view, the state Forest department is likely to tag radio collars on elephants WORLD from October this year.

As per reports presented in the Assembly, out of 935 pachyderms were killed during the period from 2011-12 to 2021-22,

141 jumbos died in accidents and 135 due to electrocution. Similarly, 307 elephants died due to several diseases. Poachers killed as many as 48 elephants while 119 died of natural causes. The reasons for the death of another 131 elephants are yet to be ascertained.

Besides, the state has seen 50 per cent increase in human casualties in encounters with wild elephants in the first three months of 2023-24. The period has witnessed 57 deaths as compared to 38 deaths in the correspon-



IIT scientists find effect of power plants on cloud formation off Cit

D n international team of researchers led by those of Technology (IIT) Madras studied how atmospheric conversion of gaseous emissions from power plants into particulate matter (PM) results in particles that are rich in sulphate and consequently have high cloud forming potential compared to natural

> counterparts. The findings, published in the peer-reviewed Climate and Atmospheric Science, provides important scientific insights for framing the policies related to controlling the PM2.5.

The group of 27 researchers from 17 distinct institutions across eight countries delved into the impact of emissions from the Neyveli coal-fired power plant located about 200 km south of Chennai, Tamil Nadu, on aerosol growth and cloud-form-

ing properties. "Our study provides a rare opportunity to examine the sen-

sitivity of cloud-forming aerosol particles to new particle formation and growth due to sulphur dioxide (SO2) emissions from a coal-fired power plant under relatively cleaner conditions," said Sachin S Gunthe, Coordinator, Centre for Atmospheric Sciences, department of Civil Engineering, IIT Madras, in a statement. "These findings have impor-

tant implications for assessing the climate impacts of anthropogenic aerosols and highlight the need for comprehensive emission control measures," he added. The study was conducted

amidst the Covid-19 lockdown in India when anthropogenic emissions, such as traffic and industries, significantly decreased.

The researchers successfully demonstrated that when local sources of anthropogenic emissions stop, the SO2 emissions from power plants may amplify the mass of PM2.5 through the formation of new particles,



which contradicts common assumptions.

The team found that the conversion of gaseous SO2 emissions from power plants into particulate matter contributes to an elevated mass load of aerosols rich in sulphates with high cloud-forming potential within the atmosphere.

Atmospheric aerosol particles are essential for cloud formation, ensuring the availability of freshwater to sustain life on Earth.

They also interact with incoming solar radiation, significantly impacting the planet's radiative budget.

The study revealed a remarkable event where long-range transport of SO2 gas emitted from the Neyveli power plant

resulted in new particle formation (NPF) in Chennai, generating particles generally known as 'secondary aerosols'.

These sulphate-rich particles rapidly grew into the size relevant and required for the cloud formation exhibiting a high ability to uptake water.

The study emphasised that, therefore, under cleaner conditions with reduced human activities, the availability of lowvolatility vapours of specific gases increases the chances of formation and growth of new aerosol particles, as opposed to the usual scenario where these low-volatile gases may condense on pre-existing aerosol particles resulting from human activities in an urban setup like Chennai.

"This study's outcomes imply that the existing strategies aimed at reducing PM2.5 levels from traffic and industries in India's polluted coastal clusters need thorough revaluation," Prof. Gunthe said.

died during the last five years in

the state. Reports said that 451 elephants have died in between April 1, 2018 and August 10, 2023 in the state. Among them, 21 elephants have died in Ganjam district while eight elephants died under North Ghumusar forest division alone in the district.

As many as 50 elephants have died of poisoning and poaching in the state during the last five years while 84 got electrocuted, 22 died in train mishaps, four in road accidents while 174 jumbos died normally. Causes of death of 105 elephants are yet to be ascertained but a majority of them are suspected to have died of poaching.

In 12 jumbo death cases, forest officials were found to have connived to destroy evidences to hush up the wildlife crimes. Elephant census is held every two year but it was halted due to

spread of Covid-19 pandemic. The last elephant census was conducted in 2017. Six years have passed but the jumbo census is yet to be conducted. It is learnt that the state government has started making preparations to conduct jumbo census in May 2024

When contacted, environmentalist Ranjit Pattnaik said that there should be proper coordination among all departments and awareness among people to check the jumbo deaths.

Fertliser shortage riles farmers

Kendrapara, August 11: Black marketing of fertilizers has hit the farmers here at a time when they are preparing fields for the ensuing kharif season, a report said Friday

The district experienced medium floods following incessant rainfall that lashed the state at the onset of monsoon. Floods were witnessed in seven rivers and 27 nullahs which submerged farmlands spread in 118 revenue villages. Although the farmlands are vet to be cleared of floodwater, the farmers without losing heart have started preparing for kharif cultivation.

The farmers, after sowing seeds, were gearing up for transplantation when black marketing of fertilizers has come as a rude shock to them. The farmers have to cough out more money to buy fertilizers from the open market due to short supply of fertilizers to various primary agricultural credit societies (PACS) in the district.



Farmers and farmer leaders apprehend that short supply and black marketing of fertilizers might seriously impact the farm works during this kharif season. While the price of a sack of urea is ₹270, traders and black marketeers are selling it at whopping ₹480 per sack.

This year farmers have taken up cultivation on 1.17.554 hectare of farmland for the kharif season out of the total farmland of 1,42,165 hectare in the district," a farmer leader Gayadhar Dhal said

The farmers need a total of 9.500 metric tonne of urea fertiliser to continue with their cultivation. There is need of 900 MT of urea for Kendrapara block, 585 MT for Derabish block, 318 MT for Marshaghai block and

1.270 MT for Mahakalapara block. Similarly, urea requirement is 420 MT for Garadpur block, 545 MT for Pattamundai block, 311 MT for Aul block, 1,030 MT for Rajkanika block and 1,121 MT for Rainagar block.

This apart, the farmers also need 14,400 metric tonne of other fertilizers for proper growth of their paddy crops. However, chemical fertilizer is yet to reach the 114 PACSs or 311 registered fertiliser sales cen tres in the district.

"This will seriously impact the paddy cultivation during the kharif season," Dhal lamented.

Another farmer leader Ghanashyam Behera said the scarcity of fertilizers has resulted in skyrocketing prices. The state government and Centre always speak of giving utmost importance to agriculture and farmers' welfare. However, the reality is different with farm-

ers feeling the pinch of fertiliser shortage in the market and government stores.

The government has not only failed to provide fertiliser, seeds and pesticides to the farmers but the training programme announced for the farmers is also limited to pen and paper. Farmers have been feeling let down with fertilizer shortage hitting them right from the start of kharif season.

Mrutyunjaya Samal, a farmer of Bagada village, said he has undertaken cultivation of kharif crops on three acre land. He has borrowed for the purpose and purchased seeds with the loan money. However, he has failed to transplant the saplings due to lack of ferlitisers

When contacted, district agriculture officer Himanshu Mohan Mishra said that they have sent the indent for fertilizers and have received only 6 metric tonne for the district so far. He assured that farmers will soon get rid of fertilizer shortage by next week.

Lost Opportunities

The Centre's longing for an extension to its trusted and tested babus was made obvious when it approached the Supreme Court seeking an unprecedented extension to the Enforcement Directorate (ED) chief SK Mishra. It became the precursor to the extension of tenures of Cabinet Secretary Rajiv Gauba and Union Home Secretary Ajay Kumar Bhalla.

For Gauba, this marks the third consecutive extension, making him the longest-serving Cabinet Secretary, while Bhalla's fourth extension also positions him as the second Union Home Secretary to complete five years in the role. These three extensions happened by relaxing rules and have raised concerns among other senior babus who may have missed out on career advancement. Sources have informed DKB that the babus most impacted are those from batches up to 1986.

Why did the Cabinet Secretary and Union Home Secretary get extensions for consecutive terms? There is a growing perception among senior bureaucrats that the extensions for the Cabinet Secretary and Home Secretary are linked to the 2024 general elections. The Modi sarkar is known to prefer continuity and retaining experienced individuals. But as elections approach and the focus shifts to electoral campaigns, administration matters take a backseat. And Chief Election Commissioner Rajiv Kumar, Gauba and Bhalla – all batchmates – can make a formidable combination, prioritising seamless collaboration between the Cabinet Secretariat, Home Ministry and the Election Commission.

In the process, however, the ambitions of several senior babus have been thwarted. The disruption will have a ripple effect which may spread beyond those immediately affected by the unprecedented extensions. If it becomes the norm, some babus fear that there would be just one cabinet secretary across seven to eight batches and one home secretary across five batches. It is this fear that some are expressing privately, knowing that the government can amend any rule.

Officers challenge frequent transfers

In a move aimed at challenging a deeply entrenched administrative practice, the Kerala IAS Officers' Association and two serving IAS of-

ficers – B Ashok and Priyanka G - have taken the Pinarayi Vijayan government to the Central Administrative Tribunal (CAT) over what they deem to be arbitrary and disruptive transfers in the state.



Their plea contends that the

current transfer policy not only hampers effective governance but also compromises their ability to execute long-term development initiatives. They have argued that the constant upheaval caused by transfers adversely affects the continuity of government programmes, leading to inefficiencies and even stalling of crucial projects. Apparently, they blame the LDF government's administrative failures such as stray dog menace, poor solid waste management and even low-level corruption on the short tenures of officers.

According to sources, the application states that such orders are issued to accommodate babus who are favourably disposed towards the political executive, often displacing eligible and efficient officers who, according to the rules, are entitled to enjoy a minimum two-year tenure in their allotted posts. Apparently, only 12 of the 126 IAS officers in Kerala have completed more than two years in a post.

The IAS officers approached the CAT as a "last resort" a year after their complaint to the Chief Minister did not have any effect on the transfers. There are other issues too, such as the government allowing non-IAS officers to encroach on the IAS turf, but clearly, the transfers are the biggest bugbear.

CAT's eventual decision on the issue has the potential to set a precedent, not only influencing transfers in Kerala but in other states as well.

erate three times as much electricity as the Three Gorges Dam, currently the world's largest hydropower plant, and China has built a new railroad and highway to transport heavy equipment, materials, and workers to the remote project site. We will find out more only when construction is far enough along that the dam can no longer be hidden from commercially available satellite imagery. At that point, it will be a fait accompli. China has used this strategy to build 11 giant dams on

the Mekong, not only gaining geopolitical leverage over its neighbours, but also wreaking environmental havoc. China is now the world's most dammed country, with more large dams in operation than the rest of the world combined, and it is constructing or planning at least eight more dams on the Mekong alone.

Opacity has also been a defining feature of the lending binge that has made China the world's largest sovereign creditor to developing countries. Almost every Chinese loan issued in the last decade has included a sweeping confidentiality clause compelling the borrowing country not to disclose the loan's

terms. Many African, Asian, and Latin American countries have become ensnared in a debt trap, leaving them highly vulnerable to Chinese pressure to pursue policies that advance China's economic and geopolitical interests. According to one study, the loan contracts give China "broad latitude to cancel loans or accelerate repayment if it disagrees with a orrower's policies.

But there can be no better illustration of the global costs of Chinese secrecy than the COVID-19 pandemic. Had China's government responded quickly to evidence that a deadly new coronavirus had emerged in Wuhan, warning the public and implementing control measures, the damage could have been contained. Instead, the Communist Party of China (CPC) rushed to suppress and discredit information about the outbreak, paving the way for a raging worldwide pandemic that killed almost seven million people and disrupted countless lives and livelihoods. To this day, Chinese obfuscation has prevented scientists from confirming the true origins of COVID-19, which, lest we forget, emerged in China's main hub

for research on super-viruses. China's willingness to violate international laws, rules, and norms compounds the opacity problem. The Chinese government has repeatedly reneged on its international commitments, including promises to safeguard the autonomy of Hong Kong and not to militarise features in the South China Sea. It was China's furtive violation of its commitment not to alter unilaterally the status quo of its disputed Himalayan border with India that triggered a threeyear (and counting) military standoff between the two countries. There is no reason to expect China to abandon its rulebreaking, its debt-based coercion, or its other malign activities any time soon. Chinese President Xi Jinping – who has strengthened the CPC's control over information, cutting off outside analysts' access even to economic data - is now on track to hold power for life, and remains eager to reshape the international

order to China's benefit. Ominously, Xi's appetite for risk appears to be growing. This partly reflects time pressure: Xi seems to believe that China has a narrow window of opportunity to achieve global preeminence before unfavourable demographic, economic, and geopolitical trends catch up with it. But Xi has also been emboldened by the international community's utter failure to impose meaningful consequences on China for its bad behaviour.

Whereas Russia launched a full-scale invasion of Ukraine, China prefers incrementalism, enabled by stealth and deception, to advance its revisionist agenda. This, together with tremendous economic clout, shields it from a decisive Western response. That is why, barring a major strategic blunder by Xi, China's salami-slicing expansionism is likely to persist.

that research in the country has been lacking with meagre funds at the disposal of higher educational institutions. There have been reports of research work being curtailed due to inadequate funds. In this backdrop, the National Research Foundation (NRF) Bill, 2023. though much delayed, has been hailed as a landmark decision that aims to bridge the gap. However, the big question remains unanswered as to how much funds would be made available in the coming years. The Ministry of Human Resource Development has been pushing higher education institutions to increase their intake capacity by 25%, while the Ministry of Finance has sought to ban the creation of new teaching posts since end-2020. At the Central level, student financial aid was cut to ₹2,078 crore in FY23 from ₹2,482 crore in FY22; allocations for research and innovation were down by 8%, reaching ₹218 crore. The institutions of learning are beset with multiple crises -- a financial crunch at university level, a deficit in research opportunities for faculty, poor infrastruc-

A section of scientists has rightly raised the question of private funding that has found mention in the NRF. In fact, as per government announcement, over 70% of the funding envisioned under NRF is expected to come from the private sector. Meanwhile, the Breakthrough Science Society in a public statement alleged that basic research may not be supported under the present policy. It rightly pointed out that private funding in this regard may be a 'wild dream' as the corporate sector is reluctant to invest in its own businesses. It is a well-known fact that the private sector has been shy in investing in research and only those that will bring it profits may attract consideration. One may mention the US has an inheritance tax, which is the tax an individual has to pay to the government if the wealth is passed on to the next generation. Because of concepts like inheritance tax, people donate their wealth. These are the kind of policies that support philanthropy. But the scenario in India is different and it may not be easy for the state universities,

through donations or from the

IPS officers, who are currently being vetted by party seniors.

Microgreens

66 ▲ Iways eat your greens," was once the advice of every mother who was concerned about the health of her children. A new way of eating vegetables has become known in the USA in the past five years or so and the trend (you might say fashion) is now broadening its appeal to the UK and other countries with one writer claiming they are becoming the "highest-flying salad items since rocket". (The joke doesn't work in US English, where the vegetable is usually called arugula.) People have long grown mustard and cress on wet flannel to harvest for salad. Like these sprouts, microgreens are young plants, no more than a week or so old, usually with only their first seed leaves developed. The leaves and stems are harvested and served in a mixed salad. Unlike alfalfa and bean sprouts the roots aren't eaten, not least because microgreens are usually grown in soil. A very wide variety is available, not just common salad plants such as arugula, lettuce and celery, but also red beet, cabbage, basil. endive. purslane, rapini (the edible leaves of an immature white turnip), dill, sorrel, and many others. Nor are microgreens always vegetables: some are flower plants such as chrysanthemums. Part of the appeal is that the salad is often as fresh as can be, with the plants being harvested moments before they're served. Supporters claim their flavour is often more intense than other salads or the mature plants and that they contain health-giving minerals. This puts them into the class of functional foods or nutraceuticals.

UNLESS THERE IS INCREASE IN INDUSTRY **PARTICIPATION IN RESEARCH, FUNDS WOULD NOT BE FORTHCOMING TO** ACADEMIC INSTITUTIONS

Coming to the question of research, there is lack of a truly functional research ecosystem. India's investment in research and innovation as a percentage of GDP steadily dropped from 0.84% in 2008 to about 0.69% in 2018 and may be less than 0.7% presently, the lowest in the world. India lags in patent applications compared to China, the US and many other countries. Moreover, papers by Indian scientists in peer reviewed journals are far less than Western countries though the number of scientists in the country is quite high. The obstacles faced are not just limited to research funding but also inconsistent funding flow, complex application process, bias towards established researchers and research institutions. The bias is manifest from the fact that around 60-65% of research funding goes to IITs and IISERs and just 11 percent to state-run universities, which are around 400 or so in number. The need for giving more funds to the state universities, most of which are severely starved of funds, is an immediate necessity and how much the NRF is expected to private sector.

The lack of academia-industry connect is a major hindrance that aggravates the already challenging lack of translational research. As a result, most of the research currently being carried out in Indian institutions can be classified as 'solutions looking for a problem', rather than 'a solution to a problem'. Unless there is increase in industry participation in research, funds would not be forthcoming to academic institutions.

It is surprising to note that of the total universities in the country - both public and private only 3 to 4% have Ph.D programmes. It goes without saying that the NRF should be the harbinger of research by generating funds and making these available to at least 100 or 150 state universities that have the potential and expertise to gear up research and innovation. India with many higher educational institutes and a large pool of scientists would be at risk of lagging behind most countries if research activities are not taken up seriously and in diverse fields. The gap must be bridged. INFA

Haryana govt rejects 'ethnic cleansing' charge

Chandigarh, August 11: The Harvana government Friday rejected in the high court the suggestion that a demolition drive in violence-hit Nuh did not follow procedure and was an exercise in "ethnic cleansing", as the bench hearing the case referred it to the chief justice's court

Monday, the Punjab and Haryana High court had halted the demolition of "illegally-constructed" buildings in Muslimdominated Nuh, questioning if a particular community was being targeted after communal violence broke out there.

As the case came up for hearing before the division bench of Justices Arun Palli and Jagmohan Bansal Friday, Haryana's Additional Advocate General Deepak Sabharwal told the court that due procedure established under the law was followed.

"We have apprised the court that it is not at all a case of ethnic cleansing and the government never works like this. For the state, all are equal. Entire procedure followed before the demolition was carried out," he told reporters later.

Five people, including two home guards, were killed in the Nuh violence, which later spread to adjoining Gurugram where an imam was murdered in an attack on a mosque.

The Nuh administration maintained that the bulldozed buildings were illegal and notices had been sent to them.

At the same time, officials also claimed that some of the demolished buildings belonged to "rioters". They said stones were hurled from some of them.

While talking about the communal violence. Harvana Home Minister Anil Vij too had justified the use of bulldozers. "Bulldozer are part of the treatment," he had told reporters.

Exodus of informal workers creates crisis in Gurugram

Gurugram, August 11: The recent communal flare-up in Gurugram and neighbouring Nuh district in Haryana has led to the mass exodus of informal workers from the city.

These workers include parking attendants, cab drivers, office peons and security staff.





In its final order, the poll panel has revised the nomenclature of one parliamentary and 19 assembly constituencies. According to a statement by the poll body, 19 assembly and two Lok Sabha constituencies have been reserved for Scheduled Tribes (STs). One Lok Sabha and nine assembly constituencies have been reserved for Scheduled Castes (SCs). It said more than 1,200 representations were considered before finalising the report. Forty-five per cent of the suggestions and objections received by the panel were addressed in the final order.

When the bench asked Sibal about the idea mooted by it for setting up a committee, the senior lawyer said, "My problem is when someone threatens shopkeepers to throw out Muslims in the next two days, this committee is not going to help.'

Sibal said police keep on saying that FIR has been registered but the offenders are never arrested or prosecuted. "The problem is not the registration of FIRs, but what progress is made? They do not arrest anybody, nor do they prosecute anybody. Nothing happens after the FIRs are lodged," Sibal said. The matter will now be heard on August 18.

New Delhi, August 11: India Friday advised its nationals residing in violence-hit Niger to leave that country as soon as possible in view of escalating violence there.

At present, around 250 Indians are living in Niger that has witnessed widespread protests and violence following last month's coup, according to officials. New Delhi, August 11: Doctors and their families must not receive any gifts, travel facilities, hospitality, cash or access to recreation from pharma companies or their representatives, commercial healthcare establishments and medical device firms under any pretext, the NMC has said in its new regu-

lations. The 'Regulations relating to Professional Conduct of Registered Medical Practitioners", issued on August 2. also bar doctors from endorsing any drug brands, medicine and equipment or advertise them.

According to the regulations, any request for medical records to a registered medical practitioner (RMP) responsible for patient records in a hospital either by the patients or authorised attendant has to be duly acknowledged and documents have to be supplied within five working days instead of the existing provision of 72 days. In case of medical emergen-

cies, efforts should be made to make the medical records available at the earliest. Efforts shall be made to computerise patient's medical records for quick retrieval and security.

Within three years from the date of publication of these reg-



ulations, the registered medical practitioner shall ensure fully digitized records, abiding by the provisions of the IT Act, data protection and privacy laws, or any other applicable laws, rules,

and regulations notified from time to time for protecting the privacy of the patient, the regulations stated

Every self-employed registered medical practitioner shall maintain medical records of patients (inpatients) for 3 years from the date of the last contact with the patient for treatment, in a standard proforma laid down by the NMC.

As per the regulations issued by NMC in a gazette notification, a registered medical practitioner should attend continuing professional development programs regularly each year, totalling at least 30 credit hours every five years.

Only recognised medical colleges and health institutions or medical societies accredited or authorised by EMRB/state medical councils can offer trainings and credit hours for this purpose. Credit hours awarded shall be updated online against the unique registration number of registered medical practitioner on the EMRB-NMC website.

According to the regulations, "RMPs and their families must not receive any gifts, travel facilities, hospitality, cash or monetary grants, consultancy fee or honorariums, or access to entertainment or recreation from pharmaceutical companies or their representatives, commercial healthcare establishments, medical device companies, or corporate hospitals under any pretext."

However, this does not include salaries and benefits that registered medical practitioners may receive as employees of these organisations, the regulations stated.

Also, registered medical practitioners should not be involved in any third-party educational activity like CPD, seminar, workshop, symposia, conference, etc., which involves direct or indirect sponsorships from pharmaceutical companies or the allied health sector.

Historic Banyan tree struggles for survival

A 150-year-old Banyan tree imported from India and one of the largest in the US is today struggling for its survival as deadly wildfires swept through the Hawaiian island of Maui, scorching buildings and killing more than 50 people. The 46-trunk Banyan tree, called paniana in Hawaiian, was a mere 8-foot sapling when it was planted in Maui's Lahaina town in 1873, according to the online portal lahainatown.Com.

according to Poweroutage.us. Witnesses to the conflagration

that hit Lahaina spoke of their terror as the blaze consumed a town in what seemed to be minutes to many of them. Some escaped the racing flames by jumping into the Pacific Ocean. Thousands of tourists and locals were evacuated from the

western side of Maui, which has a year-round population of about 166,000, with some taking shelter on the island or on the neighboring island of Oahu. Tourists camped out in the Kahului Airport, waiting for flights back home.

Many more people suffered

burns, smoke inhalation and other injuries.

Governor Josh Green said the scope of the disaster would surpass that of 1960, one year after Hawaii became a U.S. state, when a tsunami killed 61 people on the Big Island of Hawaii. Lahaina's 200-year-old Waiola Church was among the structures destroyed by the fire, local media reported. The landmark was the focal point of Christianity on Maui and the burial site of early members of the Kingdom of Hawaii's royal family, according to the church's website.

The note said Francis was saddened to learn of the destruction and "expressed solidar ity with all those suffering from this tragedy, especially those whose loved ones have died or are missing." He also offered prayers for emergency responders who are providing aid to the victims.

other cultural treasures remains unclear. The historic 60-foot(18meter)-tall banvan tree marking the spot where Hawaiian King Kamehameha III's 19thcentury palace stood was still standing, though some of its boughs appeared charred, according to a Reuters witness.

The Lahaina fire was one of three major wildfires on Maui, all of them still burning, that were fueled by dry conditions, a buildup of fuel and 60 mile-perhour (100 km per hour) gusts of wind.

Winds were forecast to ease to 6 mph (9.7 kph) Friday as firefighters were to work to secure the perimeter of the wild land areas that burned Maui County.

As of Thursday evening, the Lahaina fire was 80% contained, while the Pulehu fire, burning to the east, was 70% contained. There was no estimate for the Upcountry fire in the center of the eastern mass of the island, Maui County said.

Pak SC strikes down judgments review law

Islamabad, August 11: Pakistan's Supreme Court Friday struck down a recently enacted law modifying the review process of its judgements, a major ruling that will diminish the chances of former prime minister Nawaz Sharif's bid to challenge his lifetime disgualification from holding any public office. A three-member bench of the apex court led by Chief Justice Umar Ata Bandial and comprising Justice Ijazul Ahsan and Justice Munib Akhtar unanimously ruled that the Supreme Court (Review of Judgments and Orders) Act 2023 was "unconstitutional". The 87-page order said: "Parliament cannot legislate regarding any matter relating to iurisdiction and powers of the Supreme Court.' Moreover, the bench in its order contended that "any legislation ... Under the garb of "enlargement of [the] jurisdiction of the Supreme Court", is indisputably an intrusion in the independence of the judiciary."

Chinese Navy warship docks at Colombo Port

Colombo: A Chinese Navy warship capable of surveillance has docked at the Colombo port, nearly a year after another spy vessel berthed at a strategic port in the country and raised concerns in India. The Chinese People's Liberation Army Navy warship HAI YANG 24 HAO arrived at the port of Colombo Thursday, the Sri Lankan Navy said. The vessel is to leave Saturday. "The 129 metre-long ship which arrived in Colombo is manned by a crew of 138 and it is commanded by Commander Jin Xin. The ship is scheduled to depart the country tomorrow," the Navy statement said. According to media reports Friday, Sri Lanka delayed its arrival upon concerns raised by India. "The Chinese authorities sought permission for it earlier, but Sri Lanka delayed permission because of resistance from India," the Daily Mirror newspaper reported. Despite a briefing by Sri Lanka to Indian officials, the latter remained concerned about the research ship's visit to the island nation. In August last year, a similar visit by the Chinese ballistic missile and satellite tracking ship, 'Yuan Wang 5', which arrived in the southern Sri Lankan port of Hambantota elicited strong reactions from India.

What is the law?

The law is unclear and full of gaps. The United Nations 1966 Outer Space Treaty says that no nation can claim sovereignty over the Moon - or other celestial bodies - and that the exploration of space should be carried out for the benefit of all countries.

But lawyers say it is unclear whether or not a private entity could claim sovereignty over a part of the Moon. "Space mining is subject to relatively little existing policy or governance, despite these potentially high stakes," The RAND Corporation said in a blog last year.

The 1979 The Moon Agreement states that no part of the Moon "shall become property of any State, international intergovernmental or non-governmental organization, national organization or non-governmental entity or of any natural person." It has not been ratified by any major space power.

The United States in 2020 announced the Artemis Accords, named after NASA's Artemis Moon program, to seek to build on existing international space law by establishing "safety zones" on the Moon. Russia and China have not joined the accords.



Govt hits foreign e-gaming players **OVERSEAS PLAYERS TOO WILL HAVE TO PAY 28% GST ON BETS PLACED ON DOMESTIC E-GAMING PLATFORMS**

New Delhi, August 11: Domestic online gaming companies will be required to deduct 28 per cent GST on bets placed from overseas locations, including by foreign players, as such bets will also be treated as actionable claims.

The amendment to this effect has been approved by Parliament in the Integrated GST (IGST) Act Friday.

The GST Council had last week cleared changes in Central GST (IGST) and IGST laws to levy 28 per cent tax on full face value of bets in online gaming, casinos, and horse race clubs. The amendment in IGST Act

gives powers to the Government to notify such goods, so that in case of import of such goods IGST can be levied and collected as regular inter-State supply under provisions of IGST Act. Tax experts said this amendment is aimed at plugging the loophole with regard to the col-

lection of IGST from bets coming from overseas locations. Currently, in case of import of intangible goods such as actionable claims involved in or by way of online money gaming, which do not physically cross

IIP growth dips to 3.7% in June

New Delhi, August 11: India's industrial production growth declined to a three-month low of 3.7 per cent in June mainly due to poor showing by the manufacturing sector, according to the official data released Friday.

The factory output growth measured in terms of the Index of Industrial Production (IIP) stood at 12.6 per cent in June 2022 on account of a lower base effect.

The previous low of IIP was at 1.9 per cent in March 2023. Thereafter, it rose to 4.5 per cent in April and further to 5.3 per cent in May.

During the first quarter (April-June) of 2023-24, the IIP growth works out to be 4.5 per cent, down from 12.9 per cent in the corresponding period a year ago.

DOMINO India rice export ban puts mkt on edge for copycat curbs **EFFECT TIGHTER GLOBAL RICE SUPPLIES WILL FURTHER HEIGHTEN FOOD INFLATION WORRIES**

Mumbai, August 11: India's rice export ban has the world market bracing for similar actions by rival suppliers to avoid potential domestic shortages as sellers try to fill the 10 million metric tonne (MMT) gap left by New Delhi, stoking concerns over already high global food inflation.

India's latest restrictions are almost identical to those it imposed in 2007 and 2008, analysts say, which triggered a domino effect as many other countries were forced to curb exports to safeguard local consumers.

This time around the impact on supplies and prices could be even more sweeping, as India now accounts for more than 40% of global rice trade compared with around a 22% share 15 years

ago, ratcheting up pressure on rice exporting nations such as Thailand and Vietnam to follow suit

"India is now much more important for rice trade than it was in 2007 and 2008. The Indian ban back then forced other exporters to implement similar restrictions in a domino effect. Even this time, they have few options but to react to market forces," a New-Delhi based grains dealer with a global trade house

said on condition of anonymity. The impact on prices of the world's most consumed staple has been swift, hitting 15-year highs, after India surprised buyers last month by imposing a ban on widely consumed non-basmati white rice sales to dampen price rises. New Delhi had already restricted lower quality

Chennai, August 11: A dominant India mauled reigning Asian champions Japan 5-0 to enter their fourth final of the Asian Champions Trophy (ACT) hockey tournament at the Mayor Radhakrishnan Stadium here Friday

While three-time champions India adopted a high-press hockey from the onset. Japan played deep into their defence to thwart the home team's attacks.

It was complete domination from the Indians as they found the back of the net five times through Akashdeep Singh (19th minute), skipper Harmanpreet Singh (23rd), Mandeep Singh (30th), Sumit (39th) and Karthi Selvam (51st).

India will take Malaysia in the final Saturday, whom the hosts had blanked 5-0 in the round-robin stage while Japan will lock horns against title holders South Korea in the thirdfourth place playoff match.

The Indians Friday proved that the 1-1 draw against Japan in the round-robin league stage was just an abberation as they completely dominated the game from start to finish.

The opening quarter saw attacking intents from both the sides. While the hosts won a penalty corner just a couple of minutes into the game, Harmanpreet's drag-flick was

denied by Japanese goalkeeper Takashi Yoshikawa.

India had three more attempts in the first quarter, but failed to find the net. The Japanese too came close to scoring on an occasion in the eighth minute, but to no avail. The Indians set the pace of the game and enjoyed bulk of the possession, while Japan played catch-up hockey.

After a barren first quarter, India finally took the lead in the 19th minute through Akashdeep, who slapped the ball in from a rebound after Hardik Singh's initial shot was saved by Japan's second goalkeeper Takumi Kitagawa.

India kept up the tempo and earned their second penalty corner four minutes later and skipper Harmanpreet sounded the board with a fierce low flick to the left of the Japanese goalie to double India's lead.

It was relentless attacking from the Indians as the play was mostly inside the Japanese half. Just at the stroke of halftime, India tripled their lead through Mandeep. It was Manpreet Singh who was instrumental in getting the third goal as he intercepted the ball in the mid-field and then beat three Japanese defenders to set it up for Mandeep.

AIFF decides on I-League

format for coming season

New Delhi, August 11: The All-India Football Federation's (AIFF) League Committee Friday decided on the I-League 2023-24 format with 13 clubs participating in a home-and-away double roundrobin format. The participation of the clubs, however, is subject to the fulfillment of the AIFF's Club Licensing process.

A total of 156 matches will be played throughout the season, with each team playing 24 matches. The club finishing at the top of the table at the end of the league will be declared I-League 2023-24 champions and will be eligible for promotion to the Indian Super League 2024-25 provided they fulfill the Club Licensing criteria.

"More and more clubs are coming up to participate in not just the I-League, but the third division as well. We are all committed to arriving at the best decisions to make the league structure competitive. That would encourage clubs to aspire to rise from the district level to the national level, and help in the overall improvement of Indian football," AIFF Secretary General Dr. Shaji Prabhakaran said. Last season's champions Puniab

FC have already been promoted to the ISL. The two relegated sides from the 2022-23 I-League season - Mumbai Kenkre FC and Sudeva Delhi FC – have been replaced by Delhi FC and Shillong Lajong FC, the top two sides from the 2022-23 Second Division League. Inter Kashi and Namdhari FC have been admitted into the I-League as corporate entries, the AIFF release said.

The committee reiterated that clubs could register five foreigners in their squads, with a maximum of three allowed on the pitch at a time for the I-League 2023-24. There will no longer be any AFC player quota requirements.

"Earlier, we did not have a properly tiered league structure, but that has changed. Now, the ISL, the I-League, Second Division and Third Division are all connected with each other to create a strong league structure," said committee chairperson Lalnghinglova Hmar.

For the newly formed 3rd Division League, nine state FAs fulfilled the criteria for nominating teams – Chhattisgarh, Delhi, Goa, Gujarat, Karnataka, Madhya Pradesh, Punjab, Rajasthan and Maharashtra.

FIH 'abandons' trial of new penalty corner rule

Chennai, August 11: The International Hockey Federation (FIH) Friday said it has decided to "abandon" the trial of the new penalty corner rule as it doesn't want to tinker much with the existing set piece regulation. a glamour aspect of the sport.

"FIH has decided to put on hold and abandon the new penalty corner rule trial. The format that was being considered during the trial will not be taken into consideration anymore," FIH president Tayyab Ikram said on the sidelines of the ongoing Asian Champions Trophy here. According to the proposed

rule, all attackers except the pusher at the backline must start at least five metres outside the striking circle called the 'D' which is 12 metres from the goal post.

The ball must travel outside the dotted line, which is five metres beyond the 'D' before it can be played back into the striking circle for a shot on goal.

The new rule was being tried out for the safety of PC defenders, which would have given them more time to react to situations while rushing out to defend drag-flicks that are generally struck at a pace of around 150kmph. But the FIH played cautiously as it knew that the new rule could have spelt the doom for the art of drag-flick.
