Muslim couple lynched after son elopes with Hindu girl

Sitapur, August 20: In a shocking incident, a Muslim couple was beaten to death with iron rods and sticks by their neighbours after their son eloped with a Hindu girl in Uttar Pradesh's Sitapur district.

Three people have been arrested in the case, and the police say that the murder was allegedly a result of an affair between the victim's son and the daughter of one of the accused. The couple, Abbas and his wife Kamrul Nisha, died on the spot following the attack and all the accused fled from the spot.

Sitapur SP Chakresh Mishra said a few years back Abbas' son had eloped with a girl from the neighbouring household. A case was registered in this regard and Abbas' son was sent to jail.

When Abbas' son was released from jail a few days back, some members of the family planned the attack on the couple, the po lice said. "According to the villagers, the son of the deceased couple and Shaukat Rampal's daughter Ruby had an affair. Shaukat had abducted Ruby in the year 2020. At that time, Ruby was a minor and after registering a case, the police sent Shaukat to jail. He again abducted and married Ruby in June," Chakresh Mishra said. Police say that the three main accused have been arrested and a hunt is on for the remaining two.

Most corruption plaints against MHA employees

New Delhi, August 20: The highest number of corruption complaints last year was against employees of the Union Home Ministry, followed by those working for the railways and in banks. according to the Central Vigilance Commission's latest annual report. In total, 1,15,203 such complaints were received for all categories of officers and employees across central government departments and organisations in 2022, it stated. Of these, according to the report, 85,437 were disposed of and 29,766 were pending -- 22,034 for more than three months.

While home ministry received 46.643 complaints against its employees last year, 10,580 were received by the railways and 8,129 by banks, according to Central Vigilance Commission's annual report

report, which was made public recently, stated. Banks had disposed 7,762 corruption complaints and 367 were pending -78 for more three months. There were 7,370 complaints against employees of Government of National Capital

RUSSIAN MOON MISSION FAILS

Moscow, August 20: Russia's first moon mission in 47 years failed when its Luna-25 spacecraft spun out of control and crashed into the moon after a problem preparing for pre-landing orbit, underscoring the post-Soviet decline of a once mighty space programme.

August 23. The space agency said the lander module would undergo internal checks ahead of the planned soft landing. The lander module (LM), comprising the lander 'Vikram' and rover 'Pragyan', is expected to touch down on the lunar surface Wednesday, August 23 at 18.04 hours ISRO said. According to ISRO, India's pursuit of space exploration will reach a remarkable milestone with the Chandrayaan-3 mission poised to achieve a soft landing on the surface of the moon. This eagerly anticipated event will be broadcast live August 23, starting from 17:27 hrs IST on multiple platforms, including the ISRO Website, its YouTube channel, ISRO's Facebook page, and DD National TV channel. "The soft landing of Chandrayaan-3 is a monumental moment," ISRO said.

Her family members and other villagers could not find her even after a frantic search. When some villagers went inside the forest Sunday morning, they found the body on the ground and noticed footsteps of an elephant near the body.

Bolangir forest ranger Keshab Kishore Nayak along with forester Byasadev Sahu, forest guards and elephant squad reached the spot and launched an investigation.

After confirming that the woman died after being trampled by the elephant, her body was taken in a special vehicle by the forest department and the post-mortem conducted at Bhima Bhoi Medical College

Mumbai, August 20: Stateowned Bank of Baroda has put on the block a property owned by actor and sitting BJP Member of Parliament Sunny Deol to recover ₹56 crore through an eauction to be held August 25.

The Gurdaspur MP, whose latest flick Gaddar 2 is a box office success having already grossed over ₹300 crore since the release last week, has been in default on a ₹55.99 crore loan from the bank and interest and penalty, since December 2022, the second largest state-owned lender said in a public tender Sunday.

The bank, which has attached the property, Sunny Villa located on the Gandhigram Road in the tony Juhu area of the megapolis, has fixed the reserve price for the auction at ₹51.43 crore and an earnest money deposit of ₹5.14 crore. Apart from the Sunny Villa, the 599.44 square metre property

THE 28-YEAR-OLD FROM A HARYANA VILLAGE HAS **BEEN RESCUING SNAKES WHICH**

ENTER PEOPLE'S HOMES AND OTHER PLACES FOR NEARLY A DECADE NOW

Chandigarh, August 20: Once bitten, twice 'not' shy! Snakes may rattle many but rescuing the reptiles is a child's play for Pawan Jogpal from Haryana's Fatehabad district, who is undeterred even after being bitten 10 times

The 28-year-old man from Bhattu Kalan village said he has been rescuing snakes, which enter people's homes in the rural hinterland and other places, for

nearly a decade now. Jogpal claimed he has rescued more than 5,600 snakes and has been bitten 10 times so far.

"The latest snake I rescued was a baby cobra, which was spotted in an open area near the venue of the Independence Day function in Fatehabad, where the chief minister was to unfurl the national flag," he said.

Jogpal said he rescued many snakes who took shelter on trees during the recent floods which caused waterlogging in many areas. The rescued snakes are released in the forests. he said.

"I have been rescuing snakes for more than 10 years now. Most of them are the ones which enter people's homes and gardens in villages," Jogpal said.

Asked what prompted him to take up snake rescue as a full time job, he shared an anecdote. Jogpal said when he was

around 17 years old, a snake had entered his house in his village. He said while the neighbours and other people gathered there



tried to kill it, he was persuading them not to harm the creature. "I tried to rescue it, but in the meantime someone hit the snake and killed it. That incident left a deep impression on me. Later, I started

watching the Discovery channel. First, I started rescuing small snakes. I read many books about snakes and gathered knowledge about them." he said

"Now, I can handle snakes

quite easily. So far, I have res cued more than 5,600 snakes. I have been bitten 10 times by snakes, including a cobra due to which I was hospitalised for two days. I was also bitten by a wolf snake, which was non-venomous," Jogpal said.

He said he also rescues monitor lizards or any bird which he finds injured. "People call me over phone and I reach there with my team and we rescue snakes and leave them in jungles," he said.

Jogpal said he has three more people who work for him in his team. "We carry special gloves, sticks, shoes, hook and other safety gear with us," he said.

Jogpal said he also tries to create awareness among people about snakes.

"In our area, people don't kill snakes anymore. If they spot a snake, they call me and we rescue it. I tell people that snakes only attack in self-defence whenthey feel their life is in danger,' he said.





Ensure 'proactive disclosure' under RTI Act: SC to govt

New Delhi, August 20: The Supreme Court has directed the Central Information Commission (CIC) and the State Information Commissions (SICs) to ensure proper implementation of provisions of the Right to Information (RTI) Act, 2005 including on proactive disclosure of information by public au-

thorities. A three-judge bench, led by Chief Justice DY Chandrachud, said public accountability is a crucial feature that governs the relationship be-

tween 'duty bearers' and 'right holders' The top court said

power and accountability go hand in hand and noted that while all citizens shall have the 'right to information' under Section 3 of the Act, the co-relative 'duty' in the form of the

to Information Act deals with the obligations of public authorities.

Section 4(1)(b) of the RTI Act lays down the information which should be disclosed by public authorities on a suo motu or proactive basis. Section 4(2) and Section 4(3) prescribe the method of dissemination of this information.

The apex court stated this in a judgement on a plea seeking effective implementation of a provision of the Right to

Information Act which mandates public authorities to suo motu disclose vital information about

their functioning. The top court was hearing a plea filed by Kishan Chand Jain seeking effective implementation of the mandate of Section 4 of the RTI Act dealing with the obligations of public authorities. The PIL contended that the provision is the soul of RTI without which it remains an ornamental law. The plea also referred to the reports of the Central Information Commission which reflect poor compliance with the mandate of Section 4. It said that the Department of Personnel and Training had issued an Office Memorandum requiring a third-party audit, which witnessed poor participation.

Govt urged to make traditional clothes must at Srimandir

Puri: Servitors of Srimandir's Khuntia Nijog have urged the state government to make traditional clothes mandatory for devotees visiting the shrine. They have submitted a memorandum in this regard to 5T Secretary VK Pandian during the later's Puri visit recently. "In our memorandum, we've urged the state government to make traditional attire must for devotees visiting Srimandir. We've also urged for strict implementation of the ban on use of mobile phones on the temple premises," said the Nijog's president

Hajuri Krushna Chandra Khuntia.

NHRC SEEKS REPORTS ON 'HOUSES TO HOMELESS'

GYAN RANJAN MOHAPATRA, OP

Bhubaneswar, August 20: The National Human Rights Commission (NHRC) has sought fresh reports from Keonjhar and Koraput collectors within four weeks on allotment of houses to the homeless.

The commission's move came while hearing a plea filed by rights activist Radhakanta Tripathy. In his petition, Tripathy had alleged that hundreds of poor families have been living without proper shelter due to the negligence and inaction of the state government.

The commission picked up 40 cases in three districts - Ganjam, Koraput and Keonjhar - relating to alleged discrimination against potential beneficiaries of Prime Minister Awas Yojna (PMAY) and conducted a virtual hearing August 4.

The commission closed the cases of Ganjam district after the collector submitted that the beneficiaries have pucca houses.

Out of the cases related to 140 households, 45 were allotted houses under PMAY, while 45 were on the waiting list, said the Keonjhar collector.

The NHRC directed the Keonjhar collector to submit a report within four weeks men-

In two cases, the beneficiaries will be considered after fresh entry starts in PMAY portal. In one case, the beneficiary did not have land. Hence, benefit of PMAY cannot be granted to him.

Plan afoot to build in-stream storages in Boudh, Sonepur

OST NEWS NETWOR

Sonepur, August 20: The state government is set to build two instream storage structures in Mahanadi basin to store water of Mahanadi and Tel rivers at Khairamal in Boudh district and at Godhaneswar in Subarnapur district, a report said Sunday

Funds worth ₹1,950 crore will be spent for construction of the two projects. The matter came to the fore after the state government Friday gave its approval to a proposal submitted by the state Water Resources department.

It is learnt that very soon the state Water Resources department will float tenders for construction of the two projects which will open the floodgates of opportunity for the residents of Subarnapur and Boudh districts. The in-stream storage struc-

tures aim at creation of large tanks on Mahanadi riverbed without any displacement. The construction was necessitated after it was observed that the water flow in Mahanadi was reducing to a great extent during non-monsoonal seasons due to construction of several barrages by the Chhattisgarh government upstream of the river.

The Godhaneswar project will be bigger than that of Khairamal. Water of the two rivers were flowing into the sea during the rainy season without being put into any use while the riverbed was remaining dry during summer.

The projects, when completed, will ensure availability of drinking water, increase in ground water level, water conservation apart from boosting fisheries and water tourism. The twin projects will also help provide water to industrial plants and lead to growth of hotel and hospitality industries.

The twin projects will help fulfil the growing water demand for drinking and domestic purposes and irrigation to the farmlands during rabi season through mega lift irrigation points built on Mahanadi and Tel river basins.

Concerned, the state government prepared a master plan to make proper use of the water of Mahanadi and its tributaries. The state government in 2017 decided to construct multiple barrages on Mahanadi. A preliminary survey was conducted and later a technical advisory committee gave its approval to construction of the projects. However, the projects

got delayed Sonepur MLA and the then state finance minister Niranjan Pujari while presenting the annual Budget for 2023-24 FY had announced construction of the two projects in Subarnapur and Boudh districts.

The Water Resources department in Boudh had prepared a detailed project report (DPR) of ₹925.59 crore for construction of the project at Khairamal in the

Pandian visited Rameswar and reviewed the implementation of the proposed Khairamal project. He assured that the projects will receive administrative approvals very soon. Finally, after the state government's approval August 18, it was learnt that the tender will be invited as per EPC (engineering procurement and con-



Patients' Dilemma

The cost of medicines has been rising by leaps and bounds and in many cases these are sold at prohibitive prices. The common man is hit hard and often has to pay hefty amounts for treatment. The desire for maximising profit among many pharmaceutical companies manufacturing branded drugs is such that the prices of medicines are pegged way too higher than the manufacturing costs. On the other hand, it also has to be acknowledged that the cost of research and discovering combinations of chemicals that work against a particular ailment must be high for top pharma companies. These high research costs are generally bypassed by smaller companies producing generic drugs which they can manufacture without long drawn research and chemical trials on the actual effectiveness of different combinations of drugs. Since the patents of most drugs from original manufacturers expire due to a built-in lifespan, generic manufacturers are then free to produce the same drugs without research or even randomized trials. Because the laws in India do not make dissolution testing mandatory for generic manufacturers, the efficacy of the generic drug is in question, compared to the original.

Then there is also the issue of long and complex generic names of drugs and more importantly the combinations with other chemicals in varying percentages of a particular drug. The task of writing down the generic names with the exact combinations of varied chemicals would become near impossible for doctors. This would also create a situation where patients, unable to decipher the particulars, are left at the mercy of the pharmacist at the counter who might choose to present the drug whose manufacturer offers the highest commission. These more often than not, would be newer companies that are testing their drugs rather than reputed established brands. As a fallout, the patient might become the scapegoat. A time seems to be coming when pharmacies, in place of doctors, will be courted by pharmaceutical companies for pushing their brands.

The Union Health Ministry has dropped broad hints that a quid pro quo exists between a section of physicians and many pharmaceutical companies. It is said that palms are greased by way of commissions in cash and kind. The over 60-page guidelines for the professional conduct of registered doctors of modern medicine recently notified by the country's apex regulator National Medical Commission (NMC) contain provisions ranging from what medical degrees doctors can mention on their prescription pads to the kind of advertisements they can put out, the records they must keep and the way they treat patients through teleconsultation. This would also imply that doctors might be compelled to spend much more time maintaining documents that would be required by the government rather than treating patients or upgrading their skills. The guidelines also warn doctors against receiving commissions from pharmacies and diagnostic laboratories as well as attending conferences sponsored by pharmaceutical companies. Here, it may be noted that every other country encourages its medical fraternity to stay updated on the latest development in medical science by attending national and international conferences and meetings which are mostly sponsored by pharma companies. The government of India would not be able to state when it last organized any conference of doctors where papers were presented about innovations and improvements. By stopping the inflow of knowledge, the new guidelines will hinder the growth of medical care in India.

According to the new guidelines, all doctors will mandatorily be required to prescribe generic drugs failing which they will be penalised and even their licence to practice may also be suspended.

What has triggered vehement protests from the medical fraternity is the guideline urging doctors to use generic drugs and inform patients that they are equivalent to branded medicines. Doctors are asked to encourage people to purchase drugs from Jan Aushadhi Kendras and other generic drug outlets.

The regulations notified on August 2 stated, "Generic medicines are 30 to 80 per cent cheaper than branded drugs. Hence, prescribing generic medicines may overtly bring down health care costs and improve access to quality care." However, in a recent study, it has been found that generic drugs have a markup of about 1000 percent over manufacturing costs. This may be due to the fact that these manufacturers hardly have any costs of research, innovation and testing and their efficacy would be doubtful. In other words, the government wants to drag allopathic medicine down to the level of untested Ayurveda and Ayush medicines and on the other hand put a leash to control doctors and the whole of the medical fraternity. The move to force doctors to prescribe only generic medicines is facing a storm of protest from the medical community so much so that the Indian Medical Association (IMA) has compared it to "running trains without tracks." It believes the matter is of great concern since it directly impacts patients' care and safety. There is justification to the criticism that the government has no mechanism to ensure quality control for generic drugs by local companies which have far less capital to invest than big pharmaceutical companies.

History offers hints about how the backlash against AI will play out, though some parallels are more useful than others. The most common analogy is to the Luddites, who reacted to industrialisation in earlynineteenth-century England by destroying the machines. But this comparison is inapt, given that AI is an indestructible dig ital tool. Similarly, AI is unlikely to revive trade unions, which were born of industrialisation, because it primarily threatens white-collar jobs, rather than assembly-line workers.

To find an adequate historical comparison, we need to go back further to the Middle Ages, when powerful craft guilds - associations of lawyers, notaries, artisans, scribes, painters, sculptors, musicians, physicians, and so forth-regulated skilled pro-

Though guilds benefited society by ensuring product quality and certifying practitioners' qualifications, their main purpose was to protect and enrich their members by excluding competitors. Such monopolisation generated large profits with which to reward political elites at the expense of consumers - "a conspiracy against the public," as Adam Smith put it.

Guilds were generally conservative when it came to innovation. Though they promoted a favourable environment for technological change through technical specialisation, artisan upward mobility, and monopoly rents, they resisted new devices and products, banned members from adopting novel processes, and boycotted wares and workers from places that used forbidden techniques. In response to guilds' petitions, local rulers often passed laws blocking innovation.

The printing press is a case in point. Invented in 1440, it did not become widely used until the eighteenth century, owing to obstruction by scribes' guilds. Similarly, in fifteenth-century Cologne, masters of the linentwisters' guild banned horsepowered twisting-wheels for fear that horses would take their jobs. But this is not to suggest that

and AI; prohibiting the automation of certain tasks on guilds were anti-technology. While they fiercely opposed ethical grounds; or limiting aclabour-replacing innovations, cess to certain client data for they were generally open to privacy reasons, thus curbing the

learning potential of the tech nology. Medical doctors, for example, will probably insist that they be given the last word in AIassisted disease diagnosis, and reputable news outlets will want to check the reliability of facts reported in AI-written articles.

As is always the case, some members of a given profession will be more vulnerable than others. In the Middle Ages, the wealthiest masters exerted the most influence over public authorities, and often shaped policies to their own benefit-rather than to the benefit of all guild members. Today, partners in law firms will welcome the cost cutting automation of tasks performed by younger associates (such as writing standard contracts or finding legal prece dents), so long as they can retain the high-value-added tasks that they themselves perform.

Some countries will be much more exposed to a guild-style backlash than others. In Europe guilds formally disappeared after the French Revolution, when rulers came under pres sure to establish more egalitarian societies and unleash industrialisation. Nonetheless the corporatist mindset has survived across the continent, as evidenced by persistent over-regulation in the services sector. By contrast, the US has no history of craft guilds.

To unleash AI's full potential, policymakers and innovators alike should promote uses that elevate, rather than suppress, human agency. If AI is seen as more of a threat than a source of empowerment, wellorganised lobbies will delay or even derail its adoption in many sectors. The slow diffusion of the printing press is a cautionary reminder. In their eagerness to usher in the future, AI developers should heed the lessons of the past.

Moniker

oniker has had so many spellings that it's difficult to keep track of them all. Jonathon Green gives 14 in The Cassell Dictionary of Slang, for example. This variability is a sure sign the word was for long passed from person to person in speech rather than in writing. The first known written example is from 1851, in Henry Mayhew's London Labour and the London Poor, in which Mayhew gives it as monekeer. It was recorded in the Sydney Slang Dictionary in Australia in 1881, spelled monniker, and seems to have reached the USA not long after. This may imply that it was a London term, exported by migrants. Most slang writers, including Eric Partridge and Jonathon Green, suggest it was originally tramps' slang. As a moniker was often, even usually, an assumed name or nickname, this is plausible. There are as many suggestions of its origin as there are variants on its name, though few of them sound even marginally convincing. A long list of them is given in Paul Beale's 1984 revision of Eric Partridge's Dictionary of Slang and Unconventional English. Some early forms have suggested to writers that it might be from monarch, the idea being that it is one's name that partly rules one's life. One learned proposal was that it was ekename (an ancient term for a nickname, from eke, additional - a relative of eke out - which changed to nickname through a shift of the n in an ekename) that was converted into moniker by backslang. A further idea is that that it comes from the saintly name Monica. Others link it to one or other of a pair of Italian words, which is just possible if we assume that it's old enough to have entered slanguage via Lingua Franca. The association with tramps has led some writers to find a source in Shelta, an ancient secret language used by Irish and Welsh tinkers and gypsies, in which it would be derived from Irish ainm, name (support for this is in The Secret Languages of Ireland by R A Stewart Macalister, dated 1937, which gives munika as one form of the Shelta word.) Expert opinion, for which you may read "guesswork" if you like, is leaning towards a blend of monogram with signature, largely because moniker can mean someone's John Hancock.

months in July and the Reserve Bank of India hinting at far more increase in prices, the government is mulling wheat imports from Russia to stem food shortage despite the highest ever production of 330.53 tonnes.

Price curbs are not easy. So, after over 53 years, the government is considering wheat imports to boost supplies and curb inflation ahead of the series of state elections this year and the Lok Sabha polls next year. The exercise may cause foreign exchange drain. The balance of payment position is largely not in favour because of the import surges. An eightfold rise in incomes is needed at constant 7.6% growth till 2047 for the country to be called developed. A tall order indeed.

Import is also needed to serve the free food grain programme to 81 crore people. This has affected the stocks that need fast replenishment. Any fall in supplies is feared to raise the prices beyond the normal level. Wheat production is estimated at 112 million tonnes, according to the third advance estimates. It is higher than last year's figure of 107.4 million tonnes and even

In 2017, private firms had imported 5.9 million tonnes of wheat. However, in diplomatic terms no import was made since 1970, when the PL480 imports were stopped with the Green Revolution changing the food grain scenario.

The government is exploring the possibility of imports through private trade and government-togovernment deals. It is serious about checking prices of key commodities such as fuel, cereals, and pulses and wants to improve supplies in rural areas to ease the impact on the poor. Remember, they are a major vote bank. Even small price disturbance can have wider political repercussions, which the Centre wants to stay clear of now.

In its August bulletin, the RBI has cautioned on the price front. It has found July inflation abnormally high at 7.44% in terms of consumer price index (CPI). The RBI has raised its second quarter, July-September, inflation forecast to 6.2% against 5.4% earlier. It states that incidence of supply shock is not over as it was evidenced with the sudden spurt in tomato prices and slow surge in onion prices.

curring incidence of vegetable price shocks warrants major reforms in perishable supply chains covering transportation networks, warehousing and storage technologies and value addition processes that dampen the amplitude of these swings.

Prime Minister Modi has a dream for India-- to be among the most developed economies in the world. That's also a dream that Indians have been cherishing since long. Can it happen in a hurry? The government thinks it can with the unleashing of spending spree ahead of elections and high debt. Normally, a debt should not be an issue if it is supported with high income, low inflation and measured actions for improvement of the living conditions, just not vague development. Spending and debt, however, spurt prices.

A State Bank of India research note claims that India could get to the third global spot in GDP terms as early as 2027, provided the economy grows at 8.7% for four years till then. Even with a bit of slip, touching the third is almost a certainty. That, however, does not guarantee the overall living condition would match

India is aiming to surpass.

By virtue of population, India could qualify to be a "large economy" but in actual terms it would remain a poor country. It ranks 139th in the world and the poorest among the G20 nations with a per capita income of \$2601. So, without check on prices, increase in production and jobs, the country may attain a "high" rank, but in the real sense it has to work harder to come out of the developing syndrome.

The per capita income must rise by eightfold to \$21,664, as per International Monetary Fund's classification. According to July 2023 RBI bulletin, the economy has to grow at 7.6% for 25 years till 2047 to attain a moderately high-income level. So far, the economy has clocked growth higher than 7.6% just seven times since 1991.

This calls for larger sharing of the fruits of growth and not just linear increases. The New Education Policy needs a thorough review and reforms else a generation could forfeit the opportunity to move up the income ladder. An affordable price regime is a must to ensure that India can leapfrog.

Promising breakthrough

Sir, Surgeons at the New York University Langone Transplant Institute accomplished a remarkable feat by performing a kidney transplant using a pig's kidney in a person who had died. This breakthrough is significant because it indicates that using pig organs could be a potential solution for organ shortages in human transplant procedures. The transplant took place on July 14 under the leadership of Dr. Robert Montgomery, who heads the Department of Surgery and directs the NYU Langone Transplant Institute. By using a pig kidney with specific genetic changes, the doctors were able to prevent immediate rejection by the human body. This procedure marked a major advancement in the field of xenotransplantation (the transfer of organs between species). The pig kidney, which was genetically modified, continued to function well for more than 32 days after transplantation. This shows promise for eventually conducting similar transplants in living patients who require organ replacements. The pig kidney's performance exceeded expectations. It demonstrated the ability to concentrate urine and eliminate creatinine, a byproduct of muscle function that can be harmful if it accumulates in the body. This suggests that the pig kidney was able to function similarly to a human kidney.



Mumbai, August 20: In light of incidents of people getting stung by jellyfish at Juhu beach here. the Brihanmumbai Municipal Corporation (BMC) Saturday issued an advisory for citizens to take precautions while venturing into the sea.

Officials from the fisheries department and senior civic officials visited the beach in the western suburbs and caution boards were placed at various locations warning people about the presence of jellyfish and stingrays, an official said.

The civic body in the advisory has asked citizens not ven-

ture into the sea without clothes and wear gumboots on the beach, the official said, adding that children have been advised against entering the water.

According to the fisheries department, jellyfish and stingrays get washed up on the beach in large numbers from August to October.

The sharp barbs of stingrays can pierce the skin, while a sting from the jellyfish can cause a surge of electricity, a burning sensation, itching and swelling, it stated.

Experts have advised the use of saltwater to clean the injured area immediately, before consulting a doctor, the civic body stated.

Lifeguards at the beach can be called in for assistance and ambulances are stationed placed at various places, the advisory said.



Step-kids excluded from 2-child limit for panchayat members: HC

Mumbai, August 20: The limit of two children set for panchayat members in Maharashtra will only include biological offspring and not stepchildren, the Nagpur bench of the Bombay High Court ruled on Saturday.

A division bench of Justices A S Chandurkar and Vrushali Joshi directed for a petition filed by one Khairunisa Sheikh Chand, challenging her disqualification as the member of a gram panchayat on the ground that she has more than three children, to be heard by a single bench of

the high court on merits. Chand in her plea claimed that her husband Sheikh Chand had two sons from a previous marriage and that they now have

only one child from their marriage.

The single bench referred the matter to the division bench to clarify whether the expression 'two children' in the provisions of the Maharashtra Village Panchayats Act has been used in a generic sense to include stepchildren or in a restricted sense to mean only children born to the person.

The division bench in its order noted that the expression 'two children' has a direct nexus with the word member as used in the provision of the Act.

'The expression 'two children' in the context of a male member would include all his children for whose birth he is responsible, irrespective of the fact that they were born from his previous



and/or present wedlock. In the context of a female member, it would include all children whom she has given birth to, irre-

spective of the fact that they were born from her previous and/ or present wedlock," the court said.

The petitioner's advocate Sukrut Sohoni argued that the expression 'two children' under the Act would mean only the biological children of the person in question and the stepchildren of the person cannot be taken into consideration for disqualification.

The high court in its order noted that a person, male or female, may be disqualified if they had given birth to child/children in an earlier wedlock and had again given birth to child/children in subsequent marriage.

"It will therefore have to be held that the expression 'two children' is related to the 'person' who is a member of a panchayat and who is sought to be disqualified," the court said.

In case of a male member, if he is responsible for the birth of more than two children irrespective of the number of marriages, then he would be disqualified, it added.

'Same analogy would apply to a female member when she has given birth to more than two children irrespective of the fact that the children are born from previous or present marriage,' the court said in its judgment.

The court noted that the obiective behind the provision was to disgualify a person, who has birthed more than two children.

"It is not the object of the said provision to discourage remarriage of a person who has more than two childrenfrom his or her previous wedlock," the court said.



Rare 'Tytler's leaf Warbler' bird spotted in Bihar

THE WINGED BEAUTY IS A 'THREATENED SPECIES' ON THE INTERNATIONAL UNION FOR CONSERVATION OF NATURE (IUCN) LIST

Patna, August 20: 'Tytler's leaf Warbler', a rare bird species that migrate from higher to lower altitude in the country during winter, was spotted for the first time in Bihar, a state forest official said Sunday. Tytler's leaf Warbler is a

medium-sized bird having a comparatively long and slender bill and prominent supercilium. Such a bird was recently spotted at Sundervan in the bird ringing station in Bhagalpur district, state Additional Principal Chief

Conservator of Forests & Chief Wildlife Warden PK Gupta said.

Tytler's leaf Warbler is a "threatened bird species" on the International Union for Conservation of Nature (IUCN) list. "During the bird monitoring activities at Sundervan in Bhagalpur, we recently spotted a warbler of the Phylloscopidae family."It is the first authentic record of the occurrence of this species in the lower elevation at an altitude of 52 metres above the mean sea level (MSL) and also in the Gangetic plains in Bihar. Therefore, we are very excited after the discovery of the rare



bird species," Gupta said. As far as available records, Tytler's leaf Warbler follows an altitudinal migration, he said."It breeds in the western Himalayas, Himachal Pradesh and Uttarakhand at the high altitude. In winter, it migrates to southern India, particularly in the Western Ghats and the Nilgiris," he said.

Earlier, the species was oc-

casionally sighted in the Saurashtra and Morbi region of Gujarat, Panna and Melghat tiger reserves and Ranganathittu Bird Sanctuary (Karnataka), the forest official said."Collection of the species from Etawah (on April 7, 1879) and Gorakhpur (February 18, 1910) is the easternmost existing record of the species reported during return migration," the chief wildlife warden said, adding, after that, "no sighting of Tytler's leaf Warbler has been recorded" from this area

Gorakhpur, according to the forest rules, is considered in eastern India. Bihar has become the fourth state in the country to have a bird ringing (tagging) station wherein rings are placed on the legs of winged species to study their migration pattern, mortality, territoriality and other behaviour with the help of encrypted codes embedded in the attached tracking device, Gupta said.

"Bird ringing is a useful research instrument used to collect information on the survival, productivity and movement of migratory birds, helping us to keep an eye ontheir populations," the official added.

Moscow, August 20: Russia's first moonshot in nearly half a century has failed after its Luna-25 spacecraft spun out of control and smashed into the moon. Following are details about

LUNA-25: It was Russia's first moon mission since the Soviet Union's Luna-24 returned with samples from the moon in 1976. A Soyuz 2.1 rocket carrying the Luna-25 craft blasted off from the Vostochny cosmodrome, 3,450 miles

(5,550 km) east of Moscow, at 2:11 a.m. Moscow time August. 11. The lander was boosted out

of Earth's orbit toward the moon a little over an hour later. It entered the moon's orbit August 16 and was due to attempt a soft landing on Monday.

WHAT DOES FAILURE MEAN FOR **RUSSIA?**

Failure for the prestige mission underscores the decline of Russia's space power since the glory days of Cold War competition when Moscow was the first to launch a satellite to orbit



the Earth - Sputnik 1, in 1957 - and Soviet cosmonaut Yuri Gagarin became the first man to travel into space in 1961.

Russia had not attempted a moon mission since Luna-24 in

1976 when Leonid Brezhnev ruled the Kremlin. Luna-25 was supposed to execute a soft landing on the south pole of the moon August 21, according to Russian space officials.

Failure also underscores the pressure on Russia's \$2 trillion economy, which has so far withstood what the West casts as the most stringent sanctions ever imposed.

The West says the sanctions have weakened Russia's economy, particularly the high-technology parts of it which often rely on imports. President Vladimir

Putin says Russia's economy is showing remarkable strength. Over the past three decades.

Russia has considered various moon missions which were delayed or shelved amid the chaos of the 1991 fall of the Soviet Union and the ensuing economic and political turmoil.

The failure of the 2011 Fobos-Grunt mission to one of the moons of Mars underscored the challenges facing Russia's space programme: it could not even exit the Earth's orbit and fell back to Earth, smashing into the Pacific Ocean in 2012.

Talks between regional bloc and Niger's junta yield little, says official

Niamey, August 20: Mutinous soldiers in Niger are under pressure from regional sanctions as they refuse to reinstate the country's president whom they toppled nearly a month ago while being fearful of attacks from France, an official said.

The official spoke to The Associated Press on condition of anonymity after Saturday's meeting between Niger's new military regime and a delegation from the West African regional bloc, ECOWAS.

He said the roughly two-hour discussion aimed at finding a peaceful solution to the country's deepening crisis, vielded little with no clarity on the next steps. It was the first time head of the junta, Gen. Abdourahmane Tchiani, met with the delegation after rebuffing previous attempts.

Saturday's meeting was a last-



ditch diplomacy scramble by the bloc to resolve the crisis peacefully and followed last week's announcement that 11 of its 15 member states had agreed to intervene militarily if democratically-elected President Bazoum was not released from house arrest and reinstated.

The bloc's three other countries under military rule following coups, Guinea, Mali and Burkina Faso, were not included. The latter two had previously warned they would consider intervention in Niger an act of war.

On August 10, ECOWAS ordered the deployment of a "standby force" to go into Niger and restore constitutional rule. It's unclear if and when the troops would intervene.

Islamabad, August 20: In a dramatic turn of events, Pakistan's President Arif Alvi denied Sunday signing Official Secrets (Amendment) Bill 2023 and the Pakistan Army (Amendment) Bill, 2023, claiming that he was shocked to know that his staff "undermined" his orders and failed to return the unsigned bills within the stipulated time.

In the statement posted on his X account, President Alvi claimed to have instructed his staff to return the bills unsigned within the stipulated time to render them ineffective.

"As God is my witness, I did not sign Official Secrets Amendment Bill, 2023 and Pakistan Army Amendment Bill, 2023 as I disagreed with these laws," said Alvi, who belonged to jailed former Prime Minister Imran Khan's Pakistan Tehreek-e-Insaf party before assuming the post. The report of the bill com-

pleting the process to become law emerged as former foreign minister Shah Mahmood Qureshi, also a close aide of Khan, was arrested under the Official Secrets Act in connection with the leakage of a confidential diplomatic cable last year.

There was no statement from the President's House. Addressing a press conference, Interim Law Minister Ahmad Irfan Aslam said that the bills have become laws after President Alvi failed

to exercise either of the two op-

tions given in Article 75 of the constitution He said that the amended Army Act was sent to the office

of the president August 2 while the Secret Act was sent to his office August 8. He said the president could have recorded his observation within ten days as he did on several previous oc-

casions To a question, the law minister said that he has not witnessed such a situation in the past history of the country when the president raised an objection to a law by saying that he had not signed it or it became law after he rejected it.

Information Minister Murtaza Solangi said at the same presser that the interim government has no plan to confiscate the record from the office of the president. "No action will be taken against the president; we have full respect for the president and his office," he said.

Kishida visits Fukushima plant

Tokyo, August 20: Japanese Prime Minister Fumio Kishida made a brief visit to the tsunamiwrecked Fukushima nuclear plant Sunday to highlight the safety of an impending release of treated radioactive wastewater into the Pacific Ocean, a divisive plan that his government wants to start soon despite protests at home and abroad.

His trip comes hours after he returned home Saturday from a summit with US and South Korean leaders at the American presidential retreat of Camp David. Before leaving Washington Friday, Kishida said it is time to make a decision on the treated water's release date. which has not been set due to the controversy surrounding the plan.

Since the government announced the release plan two years ago, it has faced strong opposition from Japanese fish-

ing organisations, which worry about further damage to the reputation of their seafood as they struggle to recover from the accident.

Groups in South Korea and China have also raised concerns, turning it into a political and diplomatic issue.

The government and the plant operator, Tokyo Electric Power Co., say the water must be removed to make room for the plant's decommissioning and to prevent accidental leaks from the tanks because much of the water is still contaminated and needs further treatment.

Japan has obtained support from the International Atomic Energy Agency to improve transparency and credibility and to ensure the plan by TEPCO meets international safety standards.

Some 1.3 million Indian-Americans voted in Arizona, Florida, Georgia, Michigan, North Carolina, Pennsylvania, Texas, and Wisconsin -- the states with no clear allegiances or leanings towards either of the two major parties in the US.

"In select swing states, the Indian-American population is larger than the margin of victory that separated Hillary Clinton and Trump in the closely contested 2016 presidential race," said Sumitra Badrinathan from the University of Pennsylvania.

The Indian-American community has historically supported the Democrats in presidential elections with exit polls from 2016 indicating that four out of five (79 per cent) Asian Americans voted for Hillary Clinton, while only 18 per cent voted for Donald Trump.

Govt to procure **2LT of onion**

he government Sunday announced it will procure an additional 2 lakh tonne (LT) of onion in order to maintain a total buffer stock of 5 lakh tonne this year and use that for retail intervention. The announcement has come a day after the government imposed a 40 per cent duty on the export of onions to improve local supplies and check its prices. For the current 2023-24 fiscal, the target for onion buffer was kept at 3 lakh tonne, which has already been procured. Currently, the same buffer stock is being disposed of in the targeted markets in select states to improve the local availability and check price rise.

"This temporarily high inflation is partly driven by vegetables. I expect the vegetable prices will contract quickly, likely by next month," the official added.

RISE IN CRUDE RATES

To a question on whether the government is concerned about the recent surge in crude oil prices, the official said that budget calculations do not include crude oil prices because the government does not give subsidies to oil marketing companies. So the fluctuation in crude prices does not have any impact on fiscal math.

"Rising crude oil price is a concern but they are still within a tolerable zone from the point of view of oil marketing companies. It doesn't necessitate any policy adjustment right now. The budget calculations are on track. I think we are quite ok with oil at about \$80-85, up to \$90 we shouldn't be worried. Beyond \$90 it has an impact on inflation and other things," the official said.

The official also ruled out any cut in excise duty on petrol and diesel, saying it is not under consideration as of now. We are not expecting any excise duty cut in petrol, diesel," he added.

'Plastic market to reach ₹10L-crore by fiscal 2027-28'

AIPMA Governing Council Chairman Arvind Mehta said: "The Indian plastic industry is poised for rapid growth. The size of the plastic industry is projected to grow from ₹3.50 lakh crore in 2022-23 to ₹10 lakh crore in 2027-28."

"The exports of plastic products are expected to grow from ₹40,000 crore to ₹1 lakh crore, reflecting the global acceptance of Indian products. This is an excellent opportunity for the Indian industry and we must make the most of it," he said in a press release

Mcap of seven of top 10 firms dips by ₹80,200 crore

From the top 10 pack, Reliance Industries, Hindustan Unilever and Infosys were the gainers while Tata Consultancy Services (TCS), HDFC Bank, ICICI Bank, ITC, State Bank of India, Bharti Airtel and Bajaj Finance saw a decline in their valuation.

The market valuation of Tata Consultancy Services (TCS) tanked ₹29,894.45 crore to ₹12,32,240.44 crore. HDFC Bank's valuation declined by ₹19,664.06 crore to ₹12,02,728.20 crore. The market valuation of Bajaj Finance eroded by ₹12,233.5 crore to ₹4,15,763.47 crore and that of ITC tumbled ₹8,338.45 crore to ₹5.50.821.26 crore. Bharti Airtel's market capitalisation (mcap) fell by ₹8,081.38 crore to ₹4,78,730.70 crore and that of State Bank of India dipped ₹1,026.33 crore to ₹5,11,424.89 crore. The mcap of ICICI Bank diminished by ₹962.07 crore to ₹6,65,550.83 crore. However, Hindustan Unilever added ₹12,347.1 crore taking its market valuation to ₹6,00,250.08 crore. GST REWARD SCHEME ON AI **'MERA BILL MERA ADHIKAR'**

Customers can soon upload GST invoice, participate in lucky draw with a cash prize of ₹10L to ₹1cr monthly/quarterly

New Delhi, August 20: Individuals may soon get rewarded for uploading GST invoice on a mobile app as the government is likely to launch the long awaited 'Mera Bill Mera Adhikar' scheme soon. Under the invoice incentivisa-

tion scheme, cash prize of ₹10 lakh to ₹1 crore monthly/quarterly could be given to individuals who upload invoice received from retailer or wholesaler on the app, two officials told PTI.

The 'Mera Bill Mera Adhikar' mobile app will be available on both IOS and android platforms. The invoice uploaded on the app should have the GSTIN of the seller, invoice number, amount paid and tax amount.

An individual would be able to upload a maximum of 25 genuine invoices in a month on the



app and the invoice should have a minimum purchase value of ₹200. an official said.

Over 500 computerised lucky draws would be conducted every months where prize money could run into lakhs of rupees. Two lucky draws will be done in a quarter where the prize amount could be ₹1 crore, officials said.

The scheme is in the process of being finalised, they said, adding it could be launched as early as this month.

To curb the menace of GST evasion, the government has already made electronic invoice mandatory for B2B transactions where the annual turnover exceeds ₹5 crore

The 'Mera Bill Mera Adhikar' scheme would ensure electronic invoice generation even in case of B2C customers so as to enable the buyer to be eligible to participate in the lucky draw.

The scheme is conceptualised in a way so as to incentivise citizens and consumers to ask for genuine invoices from the seller when making business to consumer (B2C) purchase of goods or services, which are under the purview of Goods and Services Tax.

This scheme is expected to serve multiple objectives of incentivising and rewarding compliant behaviour by the consumers, encouraging tax compliant businesses, boosting consumer spending, and, checking tax evasion.

FMCG in Q1: Volume & margins grow, small players make comeback

New Delhi, August 20: The FMCG industry witnessed growth in volume and expansion in gross margins in the June quarter aided by moderation in inflation which also boosted small players in select categories.

Several small players, which had earlier vacated some of the market segments during the peak of inflation, returned back and intensified the competition at the local level, forcing several big FMCG players to go for price corrections. As material inflation reduced

from high single digits to low single digits, there has been an uptick in volumes in both urban and rural markets, indicating promising signs of recovery in demand and makers including HUL, ITC, Godrej Consumer, Dabur, Marico and Tata Consumer are increasing spends on advertising and promotions.

Moreover, FMCG players are now passing on the benefits of



lower input costs to consumers, there is a sequential reduction in price growth.

In anticipation of lower prices, FMCG companies are also now seeing trade reducing the stock levels by 1 to 3 days only, said one of the leading makers in its earning calls.

Dabur India CEO Mohit Malhotra said: "During Q1/FY24, most of the economies witnessed a moderation in inflation. In India too, inflation showed signs of easing, as witnessed in both CPI and WPI data. With this moderation in inflation, there has been an uptick in volumes in both urban and rural markets, indicating promising signs of recovery in demand."

Dabur reported an increase of 5 per cent in net profit to ₹464 crore in the June quarter and Now inflation is kind of abated in our portfolio and will be investing money back into advertising for surging demand

Spanish Armada sinks England

SPAIN WIN MAIDEN WOMEN'S FOOTBALL WORLD CUP AS ENGLISH EVES FALTER AT FINAL HURDLE

Sydney, August 20: Spain won the FIFA Women's World Cup for the first time in their history with skipper Olga Carmona sweeping in the only goal for a welldeserved 1-0 victory over England in the final played here Sunday.

In front of a crowd of nearly 76.000 at Stadium Australia here Spain were the more accomplished side and had more chances, including missing a second half penalty. Spain's triumph is vindication for Jorge Vilda and the Spanish football federation, which stuck with the coach even after 15 players last year, said they no longer wanted to represent their country under him.

Spain are the fifth team to lift the World Cup since the tournament began in 1991. They join outgoing champions the United States, and past winners Germany, Norway and Japan. In front of Spain's Queen

Letizia. defender Carmona scored what turned out to be the winner, rampaging from left-back to thrash the ball in low and hard on 29 minutes.

Batting first, India posted a commendable 185 for the loss of five wickets, riding on some fine knocks by vice-captain Ruturaj Gaikwad (58, 43b, 6x4, 1x6), Sanju Samson (40, 26b, 5x4, 1x6) and Rinku Singh (38, 21b, 2x4, 3x6).

The Indian bowlers then restricted Ireland to 152 for the loss of eight wickets. Skipper Jasprit Bumrah (2/15), pacer Prasidh Krishna (2/29) and legspinner Ravi Bishnoi (2/37) shared six wickets among themselves while left-arm fast bowler Arshdeep Singh (1/29) picked up one wicket. Andy Balbirnie (72, 51b, 5x4, 4x6) was the lone Irish batter to offer any resistance to the Indian bowlers. By dismissing him, Arshdeep reached the milestone of 50 wickets in T20 internationals.
