

## **17 INDIANS** RESCUED **FROM LIBYA**

New Delhi, August 21: 17 Indian nationals, who were held captive by an armed group in Libya, have been rescued and brought back to India following sustained efforts by the Ministry of External Affairs (MEA), people familiar with the matter said Monday.

The Indian nationals, hailing from Punjab and Haryana, reached Delhi Sunday evening, they said. The Indian embassy in Tunis played a key role in evacuation of the Indians, the people said.

The case was brought to the attention of the Indian embassy in Tunis May 26 by the family members of the stranded Indian nationals.

The Indians were being held captive by an armed group in Zwara City in Libya after they were trafficked to that country, the people cited above said.

The Indian embassy in Tunis regularly pursued the matter with Libyan authorities throughout May and June, as well as through informal channels, they said.

# **Terror activities** surge in Jammu post 370 repeal

Jammu, August 21: Post Article 370 abrogation in August 2019, the Jammu region has witnessed an increase in terror activities with certain security indicators, including recruitment of terrorists, showing an upward trend over the past nearly four years, official data revealed.

The arrest of 231 terrorists and their over-ground workers (OGWs) between August 5, 2019 and June 16, 2023 in the stepped up counter-insurgency operations in the Jammu division was 71 per cent more than such arrests recorded between October 27. 2015 and August 4, 2019, ac-

cording to the data. The Central government abrogated Article 370 granting special status to Jammu and Kashmir August 5, 2019, and bifurcated the erstwhile state into Union territories of Jammu and Kashmir, and Ladakh.

According to the official data, eight grenade and 13 improvised explosive device (IED) attacks were recorded in the Jammu region post the abrogation of Article 370. Four grenade and seven

IED attacks were recorded from October 27, 2015 to August 4, 2019.

The casualties in IED blasts increased in the region by 73 per cent from three in 2015-19 to 11 in 2019-2023.

On comparing the pre-andpost-abrogation period of nearly four years, the incidents of terrorist initiated stand-off fire and hit and run cases witnessed an increase of 43 per cent from

and security forces 13% appreciable decline in the casualties of civilians and security forces in the terror attacks in the past nearly four vears.

Against 11 civilian killings from October 27, 2015 to August 4, 2019, there was a 63 per cent decrease with seven civilian killings reported post the abrogation of Article 370.

The casualties among the police and the security forces in terror attacks marked a decrease of 13 per cent.

While 29 personnel lost their lives and 32 others were injured in various attacks post the abrogation Article 370, the figures stood at 33 deaths and 42 injuries from October 27, 2015 to August 4, 2019, stated the data.

There has been only one weapon snatching, 19 stonepelting and 16 hartal and bandh calls -- showing 80 per cent, 62 per cent and 42 per cent decline, respectively, compared to the period of nearly four years prior to the abrogation of Article 370, it revealed.

Security officials said the terror-related incidents mostly remained restricted to the twin border districts of Rajouri and Poonch, where over 65 terrorists were neutralised in various encounters over the past four years since August 5, 2019.

## VILLA AUCTION Cong questions BoB U-turn **Ex-BDO held after** 8 years on the run –

Bank of Baroda says actor Sunny Deol has offered to settle outstanding dues worth ₹56 crore related to his Mumbai bungalow



New Delhi, August 21: The Congress Monday raised questions about the Bank of Baroda withdrawing the e-auction notice for the Juhu bungalow of BJP MP Sunny Deol, asking who triggered the "technical reasons" for the withdrawal.

Facing prospects of his bungalow in Mumbai being auctioned to recover unpaid loans, Deol has offered to settle all outstanding dues, prompting the state-owned lender to drop auction proceedings for the property.

The lender issued a statemer

from Punjab's Gurdaspur, citing technical reasons.

The Congress took a swipe at the move with AICC general secretary Jairam Ramesh, saying that undoubtedly, the public outcrv and the media coverage has led the Bank of Baroda to issue a "clarification" on the so-called "technical reasons" behind its

In an earlier post on X, Congress general secretary Ramesh had said, "Yesterday afternoon the nation got to know that Bank of Baroda had put up the Juhu residence of BJP MP Sunny Deol for e-auction since he has not paid up ₹56 crore owed to the Bank. This morning, in less than 24 hours, the nation has got to know that the Bank of Baroda has withdrawn the auction notice due to 'technical reasons'.' Wonder who triggered these

New Delhi, August 21: A wanted former block development officer (BDO) of Narayanpatna block under Koraput district was arrested Monday by the sleuths of Odisha Vigilance Directorate for his alleged involvement in multiple cases of misappropriation of government funds to the tune of ₹34 lakh.

Accused Ramesh Chandra Sahoo was arrested from New Delhi by the Vigilance Directorate and was produced before\_ Metropolitan Magistrate here for transit remand. He will be brought to Odisha on transit remand for production before Special Judge, Vigilance, Jeypore. The Vigilance Directorate said that at least seven cases have been registered against Sahoo and others on the ground of misappro priation of government funds meant for different developmental works in Narayanpatna block by not executing the works. He is accused of misappropriating funds for the construction of anganwadi centres at Tovapadar, Mankid and Dumsil. In another case, he allegedly embezzled funds meant for the construction of a road at Pachingi, officials said. Sahoo was absconding since 2015 and kept changing his locations in the last eight years. He was residing in rental accommodations in Delhi and neighboring areas. The Vigilance further said that he had also staved in Jorhat of Assam to evade arrest. The accused, recently, returned to Delhi from Assam. After receiving inputs about his whereabouts, a team was stationed to pinpoint his location, the Vigilance officials said.

## STF seizes brown sugar worth ₹1cr; 4 held

Bhubaneswar, August 21: The Odisha Police STF seized 1,100 gm of brown sugar worth ₹1 crore from Balasore town and arrested four persons in connection with it, police said Monday.

The accused persons identified as Sk Faiyaz, Sk Shamshed alias Sonu, Sk Mehmood and Sandeep Nayak are the natives of Balasore district.

A raid was conducted by the special task force (STF) Sunday evening near Balasore railway station based on intelligence

input and seized the contraband, besides a motor cycle and other materials from the four accused, a police official said. The accused persons could

not produce any valid document for possessing the brown sugar and were arrested, an STF release said.

The accused Sk Shamshed told STF team that he used to procure brown sugar regularly in huge quantity from one Sk Jamshed who purchased the same from dealers in West Bengal.

The STF has launched a manhunt to nab Jamshed, the kingpin of the racket.

A case was registered under the Narcotic Drugs and Psychotropic Substances Act. 1985 and investigation into the incident is on, it said.

The STF has since 2020 seized more than 71 kg of brown sugar and heroin, 202 gm of cocaine and more than 116 quintals of marijuana and 750 gm of opium from across the state and arrested more than 176 drug peddlers, the police official official said.

This apart, it destroyed more than 62 kg of seized brown sugar and 136 qunitals of ganja in the past one year, he added.

### Infiltration attempt foiled: 2 ultras killed

Jammu: Two Pakistani intruders were killed with the Army scuttling an infiltration bid along the Line of Control in Jammu and Kashmir's Poonch district Monday, an official said. # Welcome, buddy! Chandrayaan-2 orbiter texts Vikram

Bangalore, August 21: Days before Chandravaan-3's lander 'Vikram' attempts a soft landing on the surface of the Lunar South Pole, ISRO Monday said it has established a twoway communication with the Chandrayaan-2 orbiter 'PRADAN'

ISRO said that the orbiter sent a welcome message to lander Vikram, which is attempting to land on the far side of the Moon. 'Welcome, buddy!' Ch-2 orbiter formally welcomed Ch-3 LM. Two-way communication between the two is established. MOX has now more routes to reach the LM, the national space agency said in a post on 'X'.

ISRO said Sunday the lander module of Chandrayaan-3,



the third lunar mission of India carrying a rover in its belly, is expected to touch down on the surface of the Moon around 6.04pm August 23. The MOX (Mission Operations Complex) is located at ISRO Telemetry,

## Images of Lunar far side area captured by Lander camera

The ISRO Monday released images of Lunar far side area captured by the Lander Hazard Detection and Avoidance Camera (LHDAC). This camera that assists in locating a safe landing area -- without boulders or deep trenches -- during the descent is developed by Ahmedabad-based Space Applications Centre (SAC), a major research and development centre of ISRO. According to the space agency to achieve the mission objectives of Chandravaan-3, several advanced technologies are present in the Lander such as I HDAC. Chandravaan-3. launched July 14, is a follow-on mission to Chandrayaan-2 to demonstrate end-to-end capability in safe landing and roving on the lunar surface.

Tracking and Command Network (ISTRAC) here. ISRO also said, in an update,

that the live telecast of the landing event will begin at 5.20pm August 23. The landing will be covered live on the ISRO website,

its YouTube channel, Facebook, and public broadcaster Doordarshan. The Chandrayaan-2 spacecraft comprising orbiter, lander and rover was launched in 2019. The lander with a rover in its belly crashed into the Moon's surface, failing in its mission to achieve a soft-landing.

ISRO said in 2019 that due to the precise launch and orbital manoeuvres, the mission life of the orbiter is increased to seven years. Meanwhile, top Indian space scientists have assured that the failure of Russia's Luna-25 moon mission will have no impact on ISRO's Chandravaan-3 lunar venture. The Luna-25 spacecraft crashed into the Moon after it spun into an uncontrolled orbit, Russia's Roscosmos space agency said Sunday.

"It does not have any impact, K Sivan, who was heading ISRO when the Chandrayaan-2 mission was launched in 2019, told PTI Monday when asked if ISRO would be under additional pressure ahead of the soft landing, following the Russian setback.

During his first term as the US president, Trump described India as a "tariff king" and in May 2019, terminated India's preferential market access --Generalised System of Preferences (GSP) -- to the United States alleging India has not given the United States "equitable and reasonable access to its markets.

Bhubaneswar; August 21: With more than 60 fresh cases of dengue detected in Odisha on an average daily for about a month now, the situation in the state is turning alarming, while the Capital City has emerged as the hotspot for the vector borne disease

Of the 2,426 dengue cases detected in Odisha so far, Khurda district alone accounts for 1,220 patients. In Bhubaneswar, which is part of Khurda district, 1,164 dengue cases were detected, including 300 last week, officials said.Director, Public Health Niranjan Mishra, however, claimed that the situation in the state was not any worse in comparison to other states and its position in respect of dengue incidences will be 14th or 15th in the country's list.

He said dengue cases in Odisha went up this year as the state has extended surveillance and testing. So far, 38,500 tests have been done as against 18,700 during the same period last year, he said.

"There is nothing to panic over the situation," Mishra said adding that despite the rising dengue cases the complication rate is less than five per cent and the fatality rate is less than one per cent.

Mishra said patients can be treated even at home. "We have made provisions for dengue sample collection and treatment at

He said to deal with the rising dengue cases, a special testing centre will be opened for the patients at Capital Hospital, Bhubaneswar from Tuesday. The decision has been taken to avoid crowding.

In order to reduce load on the Capital Hospital, patients are also being admitted to four upgraded PHCs in the peripheral area of BMC since Sunday. Testing facilities are also available there, he said. 'Though we won't be able to

further increase the number of beds in Capital Hospital, treatment can be provided in the 20 PHCs in Bhubaneswar," he said, adding that it will augment the accommodating capacity to 70 beds.

Meanwhile, opposition parties have criticised Odisha government and accused it of failing to contain the spread of dengue across the state, particularly in BMC area.

BJP leader and spokesperson Dilip Mohanty claimed that over 20 dengue-positive patients have died in various hospitals of the state and alleged that the Odisha government's 'callous attitude and inefficiency' have led to rise in cases of the disease in Cuttack

and Bhubaneswar. "BMC and Cuttack Municipal Corporation's local self-governance has been waylaid and the

government failed to address the situation. The Odisha government is hiding the death numbers," alleged BJP. BJP district president of

# ED files chargesheet against infra firm MD, directors

### Central agency urges court to seize properties worth ₹21.19 crore of ARSS Infra

Bhubaneswar, August 21: The Enforcement Directorate (ED) has filed a chargesheet in a special court against the chief managing director and other directors of ARSS Infrastructure Projects Limited and its subsidiary companies, seeking their conviction in connection with a case registered under the Prevention of Money Laundering Act (PMLA), 2002, an official said, Monday,

The Central agency has requested the court to confiscate ₹21.19 crore worth properties of the infrastructure firms attached by it January 31 this year.

"ED has filed prosecution complaint under PMLA on August 5, 2023 against M/s. ARSS Damoh-Hirapur Tolls Pvt Ltd, M/s. ARSS Infrastructure Projects Ltd, M/s. Anil Contractors Pvt Ltd and its CMD, directors including Directors Subash Agarwal, Anil Agarwal, Soumendra Keshari Pattanaik, and Shiv Kumar Singla," an ED official said, Mondav

The ED launched an investigation under PMLA following

the registration of a bank fraud case and submission of chargesheet by the Central Bureau of Investigation (CBI) against ARSS Damoh-Hirapur Tolls Private Limited and others for cheating Central Bank of

India here. ARSS had reportedly availed a term loan of ₹56.29 crore from the local branch of Central Bank of India in Bhubaneswar to execute the contract for construction of Damoh-Hirapur road in Madhya Pradesh in 2011-2012. However, the firm failed to complete the work on time, prompting Madhya Pradesh Road Development Corporation Limited to terminate the agreement.

The authorities of the ARSS allegedly diverted the loan amount to other bank accounts of the firm including the cash credit loan account of ARSS Infrastructure in State Bank of India's commercial branch here.

"The said acts of M/s. ARSS-DHTPL, M/s. ARSSIPL and its Directors caused a wrongful loss of ₹22.42 crore to the bank after payment of ₹40 crore as OTS to the bank," added the ED offi-

It is worth mentioning that during the visit of 5T Secretary VK Pandian to Angul, locals proposed to name the bridge after the former Deputy Chief Minister to preserve the memory of the great freedom fighter, late Pradhan.

The Chief Minister took this decision respecting the wishes of the people

The bridge has been constructed at a cost of ₹45.79 crore. Pabitra Mohan Pradhan, born

February 8, 1908 in Poipal village, was a freedom fighter and was at the forefront of the Praja Mandal Movement in the princely states of Dhenkanal and Talcher. He organized the peasants in order to assert their land rights. He participated in the Quit India Movement (1942) and was arrested.

He fled from Talcher Jail and established a parallel government. A prize of ₹10,000 was announced by the colonial regime to catch him either dead or alive. He remained underground for five years till independence. He wrote an autobiography titled Mukti Pathe Sainika (A soldier on the path of liberation).

Pabitra Mohan Pradhan was an Executive Councillor for the princely state of Orissa, a member of the Orissa Legislative Assembly (1950-1970), four times a Minister in Orissa Cabinet and Deputy Chief Minister (1967-1970).

# mangrove forest species

One held for smuggling

#### AGENCIES

Kendrapara, August 21: Kanika forest range officials arrested one person for his involvement in smuggling mangrove species.

A source said Monday that the forest personnel seized as many as 27,728 packets of Batera Lata (salacia prinoides) root and Garani (ceriops decandra) roots along with the pick up van, used for transporting the smuggled species. The weight of the root would be approximately 6 quintals, Ranger of Kanika forest range Manas Kumar Das said.

The arrested person, identified as Shankarsan Mandal of Krushnanagar village under Talachua Marine police station, has confessed before the forest personnel that he used to smuggle the mangrove species root from the Bhitarkanika national

park area. He used to collect these mangrove species roots from one Akabar Malla, of Vekta in Rangani GP under Talachua Marine police limit. Forest officials said Batera Lata root has medicinal values and it is used to make medicine for diabetes, asthma, joint pain, weight loss, and other ailments, but there is no good scientific evidence to support these claims.

Early research shows that drinking salacia tea with each meal might lower glycated hemoglobin (HbA1C) levels in people with type 2 diabetes. Other

research indicates that taking salacia with food for 6 weeks might reduce blood sugar and HbA1C levels in patients with type 2 diabetes.

Garani is a mangrove tree species, reputed for its folkloric uses in the treatment of gastrointestinal disorders, infection, snakebites, inflammation, and cancer. The whole plant of Garani is traditionally used for treating wounds, hemorrhage, angina and diabetes. The barks are used for viral infection, the leaves and fruits for ulcer, hepatitis and the roots for pain.

Garani roots are also smuggled for selling it as sandalwood, after spraying sandal scents, Das said. Mandal was booked under the offences of smuggling forestry products and destroying the biodiversity of Bhitarkanika National Park.

share of premium for food grains (cereals, pulses and oilseeds) is fixed at 2 per cent of the sum insured (SI) and for other commercial crops it is fixed at 5 per

cent of SI. For Rabi season, the farmers' share of premium for food grain crops is fixed at 1.5 per cent of SI and for other commercial crops it is 5 per cent of SI.

One of the major drawbacks of the scheme, however, is the low coverage of framers. In Odisha out of the 50 lakh agricultural households, only about 10 lakh

took a crucial decision to bear the farmers' share of premium up to 2 hectares making enrolment under the scheme free. The rationale behind this decision is small and marginal farmers who form a considerable percentage of the total farming community were unable to bear the burden of the premium.

# Man sacrifices wife for 'special' powers

Loisingha, August 21: In a shocking incident, a man has killed his wife as human sacrifice while allegedly performing rituals to attain special powers in witchcraft at Chamarapada village under this police limits in Bolangir district. Police recovered the decomposed body of the woman from the crematorium Monday. The deceased was identified as Janaki (35) and the accused as Makaru Meher (40). residents of the same village Earlier brothers of the deceased Arjun and Gopal Rout had lodged a complaint with the police.

Locals informed that Makaru and Basanti had tied the nuptial knot in 2010 and the couple has an eight-year-old son. They informed that for the last two years Makaru had been practicing witchcraft and spending most of his time in solitary confinement. At times he used to call his wife into the room during the rituals.

Janaki for the last few days and found a foul smell coming from the house they suspected something amiss. The locals then informed other members of Makaru's family living in the same village. They arrived at Makaru's house and broke open the door only to find him sitting alone with the decomposed body of Janaki.

Later on, information was sent to Janaki's family. When they arrived they found Janaki's body being taken to the crematorium. A bitter argument broke out between the members of the two families after which two of Janaki's brothers lodged a police complaint. Police then reached the crematorium and seized Janaki's body and sent it for post-mortem. Police also detained Makaru and launched a probe into the incident, officials said



# Fertilizer woes plague Jajpur farmers Woman, son found hanging

#### **RETAILERS HAVE A FIELD DAY AS PACS FAIL TO COME TO THE RESCUE OF FARMERS**

Jajpur, August 21: Decline in supply of fertilizers and its rampant black marketing has hit the farmers hard in this district. This development comes at a time when farmers are preparing for cultivation of various crops after the receding of floodwaters. Sources said that traders are fleecing the farmers and charging much more for a packet of fertilizer than the government approved rate.

The Odisha government provides various types of fertilizers to the primary agricultural cooperative societies (PACS) and the authorised dealers through 'Markfed'. However, some of these dealers are handing over the fertilizers to retailers who are then increasing the rates. Hence it is pinching the pockets of farmers.

Sources claimed that such a situation has developed due to an unholy nexus between some 'Markfed' officials and dealers. It has been alleged that 'Markfed'

is deliberately not supplying the required quantity of fertilizers to PACS where chances of black marketing is minimal.

Reports said that a decision was taken to supply 8,499 MT of fertilizers to PACS for farmers during this kharif season.

However, 62 PACS in this district have lifted only 1829.38 MT of fertilizers between April 1 and August 18.

'Markfed' has supplied 820.30 MT of urea, the demand for which is the highest. Similarly, 750.05 MT of DAP fertilizer, 127.5 MT of MOP, 36 MT of NPKS,

The suicides came to the fore after the maid who had come to work in the house Monday, spotted the duo hanging from the ceiling and informed neighbours. They detected a foul smell emanating from the house and informed the police. Personnel from Ainthapali police station along with a forensic team reached the spot. Police broke open the door and brought down the bodies before sending them for postmortem. Police have also initiated a probe to find out the real reason due to which the two took the drastic step. They are talking to the neighbours of the deceased.

to take up this issue," said Kayal. Kayal's plea was supported by former president of RCCI, Binod Sharma. "The installation of ILS

is a must for Rourkela airport to be viable and successful in the long run. I hope that the installation will be done urgently keeping in mind Rourkela's importance as a city," stated Sharma.

Rourkela finally got a functional airport after a long battle. The Hockey World Cup proved a boon as a number of matches were hosted here.

Organisations like Sachetan Nagarik Manch (SNM), RCCI, Paschim Odisha Sanskritik Parishad. Nila Chakra and others have been demanding for an airport for quite some time now. The demand gathered momentum once the airport at Jharsuguda started operations.

Passenger response has been good since the airport here started functioning. On most days, the Bhubaneswar-Rourkela-

Bhubaneswar route has over 85 per cent bookings. However, there have been disruptions in flight operations due to various technical problems. Since then, residents of this city have realised the importance of the ILS. However, with the airport operating under multiple control - the Rourkela Steel Plant (RSP), Government of Odisha and AAI – decisionmaking is not all that easy.

General secretary of Paschimanchal Sanskrutika Parishad (PSP), Bimal Bisi informed Monday that he has been pursuing the installation of an ILS for quite some time now. "I am continuously writing on this issue to the Union Minister for Civil Aviation Jyotiraditya Scindia. Hopefully things will happen soon," he said. "We need the ISL as without it there will be severe glitches," he added.

Professor SK Biswal, a teacher at a private business school here pointed out that this city must have connectivity to various parts of India. "Rourkela has the potential for multiple flight connectivity. It should be utilised," asserted Biswal.

Sources said the ILS system will be installed either in October or November at a cost of rupees six crore. The cost of maintenance would be approximately rupees one crore per annum, they added. The sources also informed that the Odisha government has agreed to bear the entire installation cost.

# Hope for Left

ike the rest of the free world. Ecuadorian voters too seem to be a confused lot. They seem to be clueless about how to deal with drug /cartels wreaking havoc with the country gunning down their opponents, corruption by politicians and seemingly endless cycle of violence, robberies and kidnappings. The country's economy is in shambles compounded as it is by organised crimes and the COVID-19 pandemic. This is clear from the inconclusive results of the presidential election announced August 20. The elections were held in the backdrop of assassination in broad daylight of a presidential candidate and journalist-turned-politician Fernando Villavicencio on August 9 and a spate of killings of other politicians in the past few months.

The results showed Ecuador is once again ready to repose its trust in the Left rather than in conservatives, business tycoons or individuals pledging to root out corruption and mafia syndicates. Left-wing politician Luisa González is leading, securing 33 per cent votes against her close rival and businessman Daniel Noboa's tally of 24 per cent. The two have emerged winners of the first round beating six rivals. González is a camp follower of former Leftist President Rafael Correa. She has promised to revive her mentor's social programmes. It is interesting that though Ecuadorians have rallied behind González, they have demonstrated clear reservation for the Left candidate because of alleged corruption by former President Correa that had forced him to flee the country even after having implemented social welfare schemes. This has pitted González against the son of one of the country's richest men, Noboa, in a runoff presidential vote to be held in October. According to Ecuador's electoral rules, if no candidate gets more than 50 per cent of the vote, or 40 per cent with a 10-point lead, a runoff election will be held

The voting pattern indicates that the people of Ecuador are not convinced any individual without solid organisational backing or huge monetary support can take on the drug cartels and their benefactors in the political establishments. This is why fellow investigative journalist Christian Zurita, replacing the crusading anti-corruption candidate Fernando Villavicencio, who had fallen to assassins' bullets, managed to secure only 16 per cent votes.

On the other hand, González, a virtual unknown before the election, is seen as the natural successor to Correa, the Leftist, populist President who governed the country from 2007 to 2017. As the candidate for the Revolución Ciudadana party, she had said Correa would be her adviser if she was elected. Correa lives in exile in Belgium and was sentenced to eight years in prison for corruption in 2020 in absentia. The election was necessitated by the decision of the current President Guillermo Lasso to dissolve the national assembly and call early elections so as to avoid impeachment for his own alleged corruption.

The extent to which the electoral process of Ecuador has been vitiated can be gauged from the fact that hackers were in operation from diverse countries to prevent electronic voting. Under Ecuador's laws exercising franchise is mandatory for all citizens who will face punishment for not voting. The president of the national electoral council, Diana Atamaint said cyber-attacks targeting the electronic voting system were engineered from countries such as Russia, Ukraine, China, India, Pakistan, Indonesia and Bangladesh. This geographical reach clearly indicates the power and influence of the drug cartels that have virtually taken over most of Central and South America. Indians participating in these hackings should ring an alarm bell for the government

The unprecedented attacks also show to what extent drug cartels can go to manipulate the electoral outcome of Ecuador. The country was a haven of peace even till 2017, though geographically it is wedged between Colombia and Peru, two of the world's biggest producers of cocaine.

A deadly escalation of violence in recent years, fuelled by a cocaine boom in the region, has seen criminal gangs alter the landscape in Ecuador as they engage in high-level graft, extort businesses, overrun prisons, and murder anyone who gets in their way. The violence and lack of economic prospects have led to many Ecuadorians opting to leave the country - some to its neighbours, others to the United States. Over half of Ecuador's workforce is in the informal economy, meaning that millions of people do not have a contract and benefit packages to rely on in hard times

or centuries. Britain has prided itself on being a bastion of liberty and the rule of law. British leaders have talked in glowing terms of the "golden thread" that connects the Magna Carta of 1215 and the Bill of Rights of 1689 to the European Convention on Human Rights (ECHR) of 1950 and the Human Rights Act of 1998. Thus, the UK's human-rights record has been central to successive governments' efforts to exercise soft power globally.

No one has boasted more about Britain's global leadership in human rights – and its rule-of-law credentials more broadly - than the five Conservative PMs who have held office since the 2016 Brexit vote. Yet, in practice, these very ministers have been systematically undermining the rule of law, and the "law and order" party is now contemplating abandoning the ECHR.

According to The Telegraph, a newspaper close to the Conservative Party, more than one-third of the cabinet – at least eight ministers – along with other senior Tories, are pushing PM Rishi Sunak to place a commitment to withdraw from the ECHR at the center of the coming election campaign. Their justification is that judges at the European Court of Human Rights are blocking the deportation of illegal migrants from the UK to Rwanda, which has agreed to accept them (for a hefty price).

Renouncing the Convention is no idle threat. Already, the government has positioned itself to defy the Court. With the just-passed Illegal Migration Act, the government has - for the first time since ECHR was concluded – claimed the power not to comply with the Court's "interim measures." In other words, the UK government can now ignore any European order to stop flights of migrants to Rwanda. This provision directly breaches the UK's obligations under ECHR. The Illegal Migration Act is

the latest development in a downward spiral that has undermined basic rights. The government now boasts it is housing asylum-seekers in inferior accommodation, including massive barges more reminiscent of the prison ships Britain used in the nineteenth century than modern amenities.

The Act also strips asylumseekers of their right to remain in the UK while their application is considered, and provides for deportation of applicants before any effort is made to determine whether someone is, say, a victim of modern slavery. The UNHCR has condemned the legislation, stating that it "effectively extinguishes the right of refugees to be recognized and protected in the UK.

These actions follow prime ministerial rulings that renounced the government's explicit duty, enshrined in the ministerial code, to comply with international law. Government lawyers are now operating under unprecedented new guidance to proceed with drafting legislation that dismisses international conventions, even if there is a high chance of successful legal challenge

As for the ECHR, Conservative PMs have been targeting it for at least a decade. In 2013, David Cameron told the BBC that leaving the Convention might be necessary for security reasons. In 2016, Theresa May said that, while the UK should remain in the EU, it should exit the ECHR, which can "bind the hands of Parliament.'

May's successors, Boris Johnson and Liz Truss, echoed this call to abandon the ECHR. as did their far-right home secretaries. Priti Patel and Suella Braverman. Braverman claimed earlier this year - with little evidence – that "100 million people around the world...could qualify for protection under our current laws," making an immigration crackdown essential. According to a statement from

10 Downing Street in February, Sunak is considering "whether being a part of the ECHR is in the UK's long-term interests. And a few days ago, Robert Jenrick, the immigration minister, said that the government would do "whatever is necessary" to stop small boats from crossing the English Channel even if that meant pulling out of the ECHR

This wholesale Conservative attack on the ECHR reflects the view that UK sovereignty must be unlimited, unrestricted, and accountable to no one, espe cially not a European court. Even after Brexit, apparently, the UK does not enjoy enough "independence" to privilege the "us." who deserve basic rights. over the "them," who do not. It is a prejudice that is out of touch with any concept of human rights and unsuited to our interconnected world, in which each country's independence is qualified by all countries' interdependence, and where prosperity, to be sustained, must be shared

For the time being, under Attorney General Victoria Prentis, the UK may refrain from choosing non-compliance with interim European Court judgments. But the mere fact that the UK statute book now includes a provision allowing for defiance of the Court's rulings undermines the entire ECHR system.

By weakening the Court's au thority to interpret the Convention and turning its judgements into political footballs, the UK is setting a precedent that other countries will invariably follow. Indeed, the UK's alignment with "illiberal democ racies" such as Poland, Hungary and Turkey on any issue relating to human rights betrays its historical record and reputation. Should the UK leave the ECHR altogether, it would become an international outlier. alongside Russia and Belarus. Anyone who stands for the

advancement and protection of human rights must keep this in mind, knowing that rights are on the agenda when the next UK election comes. History and a sense of who we are should convince the British people not to empower leaders who show such contempt for human rights.

However, that's a common American sense. as in Cab Calloway's famous song about Minnie the Moocher ("Folks, now here's the story 'bout Minnie the Moocher, She was a red-hot hootchiecootcher"). There are several others. For example, the one that comes to mind at once for me, the most common British or Australian one, is the idea of loitering about in a bored or listless way: "He did nothing but mooch about the house, doing nothing and getting in the way". It's actually a most interesting word, one which has been around on the margins of the language since the fifteenth century with a set of meanings, none of them pleasant. In its earliest days, to mooch meant to pretend poverty or act the miser. That may come from an even earlier word, mitch, which by then had been in existence for a couple of centuries with a similar meaning. The latter is believed to derive from the Old French muchier or mucier, which meant to hide, or more pejoratively, to skulk or lurk. Both mitch and mooch survived in several senses in local dialects in Britain for centuries, with the latter becoming by far the better known. Mooch could variously mean to play truant (in particular to pick blackberries, for some unknown reason), to "loaf, skulk, sneak, or loiter" as the OED puts it, or to steal or pilfer. In the 1850s, it look on the sense you mention - to sponge on others, to borrow money or cadge things, or to slip away and let others pay for your entertainment. This is clearly where the modern American sense that you quote comes from. But it has had other senses in North America, among them to troll for fish, especially on the West Coast. In the 1920s, it was a slang term among gamblers or on fairgrounds for a sucker or easy mark. In the 1940s-50s, the noun could also refer to a drug addict, so to be on the mooch was to be addicted and a mooch pusher was a drug dealer.

# Assam seeks views on law to ban polygamy Ties with Cong: Akhilesh

Guwahati, August 21: The Assam government has sought public opinion on a proposed law to end polygamy in the state, Chief Minister Himanta Biswa Sarma said Monday.

Sharing a government public notice on 'X', formerly Twitter, Sarma appealed to the people to send their suggestions on the proposed law to ban polygamy in Assam.

The notice published by the Principal Secretary of the Home and Political Department requested the people to send their opinion by August 30 through email or by post.

It mentioned that the Assam government had formed an expert committee to study the legislative competence of the Assembly to enact a law banning polygamy, and the report stated that the state legislature is competent to enact a law to ban the marital practice.

Sharing the executive summary of the report, the public notice stated that marriage falls under the Concurrent List, enabling both the Centre and states to pass laws on it. 'The Doctrine of Repugnancy

(Article 254) stipulates that if a state legislation contradicts a central legislation, the state law will be overridden unless it received the prior assent of the President of India," it added.

Quoting the report, the notice mentioned that freedom of conscience and the right to prac-

Hoisting the National Flag on the occasion of 77th Independence Day August 15, Sarma in his official address said that a 'strict act' will be brought soon to end polygamy in Assam. May 12, Sarma had announced

the formation of the four-member expert committee headed by Justice (Retd) Rumi Kumari Phukan.

Besides Phukan, the other members of the committee are the state's Advocate General Devajit Saikia, Senior Additional Advocate General Nalin Kohli and senior Advocate Nekibur Zaman.

It was tasked to scrutinise the provisions of the Muslim Personal Law (Shariat) Act, 1937 along with Article 25 of the Constitution in relation to the **Directive Principles of State** Policy for a Uniform Civil Code.

July 13. Sarma had said the Assam government conveyed to the authorities concerned that it was in support of the Uniform Civil Code (UCC) and wanted to ban polygamy immediately in the state.

The Opposition parties had earlier slammed the decision of the government to enact a law on polygamy as diversionary and communal, especially at a time when suggestions on the UCC are being received by the Law Commission.

The development comes days before the Opposition alliance is all set to meet again, this time in Mumbai August 31 where SP and Congress are expected to discuss the final seat-sharing formula in the state for the 2024 polls.

On his past experience of SP's alliance with the Congress in 2016 assembly polls and with the BSP in 2019 Lok Sabha elections. Akhilesh Yadav said that both the alliances were a great learning experience.

"I have always entered into an alliance to defeat the BJP as the prime objective. Samajwadi Party has always decided on the seat-sharing formula with a big heart," he said.

"The problem with the Congress is that most of its ticket seekers from UP, like Jitin Prasada (Dhaurahra), RPN Singh (Kushinagar), Imran Masood (Saharanpur), Ratna Singh (Pratapgarh) and Harendra Malik (Muzaffarnagar) are no longer with the Congress while its leaders in Kanpur and Unnao are no longer active in politics. Agra, August 21: Even as the tunneling operation has picked up momentum in the vicinity of the Agra Fort, the Taj City Metro rail project has been hit by an unexpected controversy.

These last few weeks have seen a series of protests from interest groups that want the Metro to go underground on the lifeline of the city, the Mahatma Gandhi Road. The existing plan includes an overhead Metro line on pillars.

The owners of the commercial establishments, shops, and showrooms, have been agitating to demand change in the plan, as they fear that once work starts on the MG Road stretch, commercial activities would be badly affected and there would be permanent traffic jams.

At a public rally held two days ago at the Shaheed Smarak, the protesters voiced their concern and demanded urgent action to modify the plan suitably. A BJP legislator extended support to the movement, while nine other MLAs and two MPs have chosen not to join the public outcry.

The two-phased 29.6 km long Metro rail network project has picked up steam and is all set to become operational in early 2024, ahead of the target date, definitely before the Lok Sabha polls. Three stations on the Taj Mahal Eastern Gate to Shah Jahan Park roundabout are ready. Tunneling work at two different sites is continuing at a brisk pace. The traction and electrical work for the six km priority corridor from Jama Masjid to Taj East Gate is progressing toward completion.

Officials said a number of new features have been added and the trial run on the three-kilometer stretch has been successfully completed. Friday, it

# Country's oldest domestic elephant dies at 89

Tezpur, August 21: India's oldest domestic Asiatic elephant died Monday at the age of 89 in Sonitpur district of Assam, officials said.

The majestic jumbo, named Bijuli Prasad, breathed his last at the Behali tea estate of The Williamson Magor Group around 3.30 am due to age-related issues, they said. Many people who have been associated with Bijuli Prasad such as animal lovers, tea garden workers as well as locals gathered to mourn the death of the pachyderm.

"Bijuli Prasad was a symbol of pride for The Williamson



Magor Group. It was first brought to the Bargang tea estate as a calf, and later shifted here after the Bargang tea estate was sold off by the company," an official of the tea garden said

The elephant, whose age is estimated to be 89 years, was leading a royal life in the tea estate post-retirement, he said.

Padma Shri awardee and famous elephant surgeon Dr Kushal Konwar Sarma told PTI, "As far as my knowledge is concerned, Bijuli Prasad was the oldest recorded domestic elephant in India.

Usually, the wild Asiatic elephants live up to 62-65 years, while the domestic ones survive till around 80 years with proper care, he said. "After all its teeth fell off around 8-10 years ago, Bijuli Prasad could not eat anything and was about to die. Then I went there and treated him. I had changed all his regular food and started mostly boiled food like rice and soybean with high protein value. This increased his longevity," Sarma said.

An official of the Behali tea es-offered around 25 kg of food every day.

Of the total cases, 2,039 were pending trials for more than 10 years and up to 20 years, 2,324 for over five years and up to 10 years, 842 for more than three years and up to five years and 1,323 for less than three years, as on December 31, 2022, it said.

The Commission took note of the large number of cases pending trial in different courts. It was observed that as on 31.12.2022, 6,841 number of cases

A total of 60 cases were pending probe "more than three years but less than five years", 79 for "more than two years but less than three years", 138 for "more than one year but less than two years" and 373 for "less than one year", said the report released recently.

"Completion of investigation would imply filing of charge sheets in courts, wherever warranted, after receipt of sanction from the competent authority. The Commission has observed that there have been some delays in completing investigations in certain cases," it said.

Some of the reasons for the

delay include "delay in investigation due to excessive work", "inadequacy of manpower", "delay in obtaining responses to Letters Rogatory (LRs)" and "time taken in locating and examining witnesses living in distant places' among others, the report said.

There were also 52 cases of departmental action pending against 'Group A' officers of the CBI themselves, it said. Of these, 23 cases were pending for more than four years. five between three to four years, seven between two and three years, nine between one year to two years and eight for less than a year, according to the report.

There were 19 cases of departmental action pending against 'Group B and C' personnel of the federal agency. Of these, three were pending for more than four vears, it added. The CBI had registered 946 cases in 2022 -- 829 regular cases (RCs) and 117 preliminary inquiries (PEs)

Of these, 163 traps were laid for detection of bribery cases during 2022 while 46 cases for possession of disproportionate assets were registered during one year, the report said

August 21: Observing that pregnancy in cases of sexual assault is a cause of stress and trauma to the victims, the Supreme Court Monday allowed a rape survivor to undergo medical termination of her over 27-week foetus after noting that she is clinically fit for the procedure which will not adversely affect her child bearing capacity.

Under the Medical Termination of Pregnancy (MTP) Act, the upper limit for termination of pregnancy is 24 weeks for married women, special categories including survivors of rape and other vulnerable women such as those differently-abled and minors.

Taking note of the survivor's medical report, a bench of Justices B V Nagarathna and Ujjal Bhuyan said the Gujarat High Court was not right in rejecting her prayer for MTP. The top court said in Indian society within the institution of marriage, pregnancy is a reason for joy and celebration not only for the couple but also for

their family and friends. "In contrast, pregnancy outside marriage is injurious, particularly in cases of sexual assault or abuse and is

a cause of stress and trauma affecting the physical and mental health of pregnant women. Sexual assault of a woman is itself distressing and sexual abuse resulting in pregnancy compounds the injury. This is because such a pregnancy is not voluntary or mindful.

'In view of the above discussion and the medical report, we permit the appellant to terminate her pregnancy. We direct her to be present in hospital tomorrow so that

Committee on Tribal Unity (COTU) Sadar Hills Kangpokpi began the blockade on NH 2 which connects Imphal with Nagaland's Dimapur and NH 37 which links Imphal with Assam's Silchar."Volunteers of the tribal body were seen coming out on the streets at a few places of Kangpokpi district to enforce the blockade and prevent movement of vehicles," an official said.

COTU secretary Lamminlun Singsit had on August 17 said, "Highway blockades would be reimposed on NH 2 (Imphal-Dimapur) and NH 37 (Imphal-Silchar) if the supplies of essential commodities to Kuki Zo communities in the hill areas of the state are not ensured".

"Strict security measures have been taken up in all vulnerable locations and security convoy is provided in sensitive stretches to ensure free and safe movement of the vehicles," the police said.

Another tribal organisation Kuki Zo Defence Force also warned that it would impose blockades from August 26 onwards if supplies of essential goods and medicines to Kuki Zo inhabited areas are not ensured.

The violence in the state erupted in early May after a 'Tribal Solidarity March' was organised in the hill districts to protest against the Meitei com-munity's demand for Scheduled Tribe (ST) status.

he froth in the broth is a clear sign of a 'cereal killer' in the kitchen! And there are many chefs on the loose in the BJP cookhouse in Gujarat to set off smoke alarms. Similar brews in the election-bound states of Madhya Pradesh, Rajasthan and Chhattisgarh besides Karnataka is symptomatic of a deeper malaise warning the national BJP leadership of pitfalls ahead.

If Jyotiraditya Scindia who switched sides to pull down the Kamal Nathled Congress remains at the core of the internecine fights raging within the BJP in Madhva Pradesh, it is the ongoing sidelining of Vasundhara Raje that is muddying the waters in Rajasthan and the benching of former chief minister Raman Singh likewise in Chhattisgarh. Allegations levelled by a BJP MP of collusion politics between the ruling Congress and a section of the vanquished BJP leadership is fuelling fires all its own in Karnataka, while the oblique targeting of Nitin Gadkari, the Maharashtra stalwart with a reputation for efficiency and candour provides a pointer to the shape of things to come.

For now, this is about Gujarat. A catfight of sorts involving high profile party leaders at a public function in Jamnagar last week hogged headlines, bringing out the simmering disquiet in popular glare. Rivaba Jadeja who is a first time legislator of the BJP and whose claim to fame rests in the stardom of her husband cricketer Ravindra Jadeja was seen publicly upbraiding two-times party MP, Poonamben Maadam and the city mayor Binaben Kothari. The incident unfolded during a party function held to commemorate the 'mera desh, meri mitti' pro-



gramme on Thursday last.

A video clip of the unseemly scrap that went viral on social media only added fuel to the grist mill. Apparently Rivaba appeared enraged and told the mayor to 'stay within her limits'. Earlier she had an 'exchange' with the Member of Parliament. Rivaba's version was that the MP had called her 'over smart' after she took off her footwear to pay respect to the martyrs at the public event. Madaam sought

to play it down terming it a mere misunderstanding. However a visibly hurt mayor Binaben called a press conference next day to voice her anguish. The issue reached the city party chief and thereon to the state BJP president C.R. Patil.

This was one of many incidents of discontent within the Gujarat BJP which have been bubbling up to the surface with religious regularity in recent times. These acquire added importance because the state is the home turf of Prime Minister Narendra Modi and union Home Minister Amit Shah and thus constantly in their sharp sights.

Earlier this month three office-bearers of the BJP from South Gujarat were arrested on charges of defaming their own state party chief C.R.Patil who hails from the same region. The

Surat district BJP suspended the three. In another of the sequential events lining the road of dissent. BJP corporator Alpesh Limbachiya was arrested on charges of mailing copies of an anonymous letter to party leaders that accused the Vadodara mayor of corruption. His brother-in-law and some others were subsequently arrested and Limbachiya who was leader of the ruling party in the Vadodara Municipal Corporation resigned his post. There are numerous other examples, the list is long and the purge still continues. The top brass in Delhi has gone to work after matters were brought to the Prime Minister's notice. Baby killer nurse Lucy Letby sentenced to whole-life term

London, August 21: Nurse Lucy Letby was Monday sentenced to a whole-life term by a UK court for killing seven babies and attempting to murder at least six others while working at a hospital in northern England.

Justice James Goss removed any early release provisions from the whole-life sentence order, saying the exceptionally serious nature of her crimes meant that the 33-yearold will spend the rest of her life behind bars.

Letby was last week found guilty of the murder of seven newborn babies and also found guilty of seven counts of attempted murder relating to six other babies. In his sentencing remarks. Justice Goss said the nurse had acted in "gross breach of trust" and with "premeditation, calculation and cunning" as he handed down the tough custodial sentence at Manchester

Crown Court. On Friday, a jury at the same court had handed down a guilty



verdict at the end of a 10-month trial, following which Indian-origin consultant paediatrician Dr Ravi Jayaram spoke out about the alarms he and his colleagues had raised at the Countess of Chester Hospital - where the nurse committed the crimes between 2015 and 2016 at its neonatal unit.

Letby enhanced the anguish of the parents whose babies were murdered or attacked by refusing to attend her sentencing hearing.

British Prime Minister Rishi Sunak condemned the nurse as "cowardly" for this, adding that his government is looking at changing the law to compel guilty criminals to face their victims after being found guilty.

## **Ecuadorians reject oil** drilling in the Amazon

Rio De Janeiro, August 21: Ecuadorians voted against drilling for oil in a protected area of the Amazon, an important decision that will require the state oil company to end its operations in a region that's home to two uncontacted tribes and is a hotspot of biodiversity.

Yasuni National Park is inhabited by the Tagaeri and Taromenani, who live in selfisolation. In 1989, it was designated a world biosphere reserve by the United Nations Educational, Scientific and Cultural Organization, also known as UNESCO.



Encompassing a surface area of over 1 million hectares (2.5 million acres), it boasts 610 species of birds, 139 species of amphibians, and 121 species of reptiles. At least three species are endemic.

With over 90 per cent of the ballots counted by early Monday, around six in 10 Ecuadorians rejected the oil exploration in Block 43, situated within Yasuni.

The outcome represents a significant blow to Ecuadorian President Guillermo Lasso, who advocated for oil drilling, asserting that its revenues are crucial to the country's economy. State oil company Petroecuadorwill be required to dismantle its operations in the coming months.

# Historic drought, hot seas slow Panama Canal shipping

Los Angeles/Houston, August 21: Before the Ever Max ship carrying lava lamps, sofas, Halloween costumes and artificial Christmas trees could make its inaugural Panama Canal voyage this month, a historic drought forced it to drop weight by offloading hundreds of containers

The Panama Canal Authority has reduced maximum ship weights and daily ship crossings in a bid to conserve water. Maritime transportation experts fear such events could become the new normal as rainfall deficits in the world's fifthwettest country spotlight climate risks affecting the ocean shipping industry that moves 80% of global trade. Ship owners have the options of carry-

ing less cargo, shifting to al-

ternate routes that can add thousands of miles to the trip or grappling with queues that earlier this month backed up 160 vessels and delayed some ships by as much as 21 days.

The restrictions already are sending China-US spot shipping prices up as much as 36% amid soaring sea temperatures that climate scientists warn could supercharge extreme weather.

Canal operators are on a tightrope as they work to manage maritime trade disruption and prepare for what is shaping up to be an even drier period next year, said Peter Sand, chief analyst at air and ocean freight rate benchmarking platform Xeneta

More than 14,000 ships crossed the canal in 2022. Container ships are the most common users of the Panama Canal and trans-

# **Foreign trade crosses \$800bn**

AMID WEAK WORLD TRADE OUTLOOK FOR 2023 DUE TO GLOBAL UNCERTAINTIES, INDIA'S **OVERSEAS TRADE REGISTERS HEALTHY GROWTH IN THE FIRST SIX MONTHS OF THE YEAR**

New Delhi, August 21: A healthy growth in India's services segments has helped the country's total exports and imports of goods and services to cross the \$800 billion mark during the first half of 2023, despite a slowdown in global demand, think tank GTRI said in a report Monday.

According to the analysis of the Global Trade Research Initiative (GTRI), exports of goods and services rose by 1.5 per cent to \$385.4 billion during January-June this year, as against \$379.5 billion in January-June 2022.

Imports, however, dipped by 5.9 per cent to \$415.5 billion during the six months of this year, as against \$441.7 billion in January-June 2022

"India's foreign trade (exports and imports of merchandise and services) reached \$800.9 billion during January-June 2023, exhibiting a decline of 2.5 per cent over the same period last year (January-June 2022)," the report said.

Standalone, goods exports dipped by 8.1 per cent to \$218.7 billion, while imports contracted by 8.3 per cent to \$325.7 billion.

On the other hand, services exports during the six months period grew by 17.7 per cent to \$166.7 billion, while imports rose by 3.7 per cent to \$89.8 billion.

"Data is showing modest decline due to weak global demand and losing competitiveness in labour intensive sectors. The decline in merchandise exports happened despite appreciating INR (Indian Rupee). INR/USD exchange rate appreciated from 76.16 in April 2022 to 82.18 in Apr 2023," GTRI Co-founder Ajay

Bangalore, August 21: Chinese smartphone brand Honor will relaunch in India through a licensing deal with a local company and is aiming to start domestic manufacturing by early next year, its country head said.

Honor had stopped selling its smartphones in India and reportedly retreated last year amid limited marketing budget and less prudent portfolio management.

"India was never a focus market for the Huawei Technologiesowned Honor until 2020 - when it was forced to spin-off the brand and reassess strategy," said Neil Shah, vice president at Counterpoint Research.

Honor's comeback is underpinned by a licensing deal with a newly formed Gurugram-based firm Honor Tech for an undisclosed "agreed-upon cost" tied to the transfer of technology and hardware.

India targets UAE trade to broaden rupee's global reach

New Delhi, August 21: India's central bank is nudging local banks to ask their clients to settle trade between the United Arab Emirates and India

using the dirham (AED) or Indian rupee (Rs) to reduce US-dollar-based transactions, five sources told Reuters. The move is part of

the Reserve Bank of India's broader aim of promoting settlement in

local currencies with countries with which India has a trade deficit, with the knock-on effect of boosting the rupee's global reach, three banking sources said.

India's trade deficit with the UAE was \$21.62 billion in 2022/23, or 8.2% of its total deficit, government data shows. In July, the two countries agreed to facilitate trade in rupees instead of dollars. The idea, a government source said, was to reduce the outflow of dollars on account of this trade deficit.

"The RBI has asked banks to encourage clients and corporates to initiate INR-AED trades gradually, instead of using the dollar," said a treasury official at a private bank.

An RBI official communicated this message verbally to foreign exchange dealers at a

month, sources said. This communication has not been previously reported. The RBI may consider setting internal tar-

gets for the quantum of India-UAE trade it would like to see moved away from dollars, said the government source.

The central bank is "keen that volumes of such trades go up" and "has assured the market that they will be ready to support banks with INR-AED trades,' this banker said.

Wicketkeeper-batter Sanju Samson has been added to the squad as a backup for Rahul who has developed a niggle recently, informed Agarkar after announcing the squad here.

"It is not the original injury. There is a niggle. That is why Sanju is travelling (to Sri Lanka). We are expecting Rahul to be fit. If not the start of Asia cup may be by the second or the third game. Shreyas Iyer is fully fit," said Agarkar in his first media interaction since taking charge last month.

India will open their campaign against Pakistan September 2 and Rahul is likely to miss out due to his niggle.

Pacer Prasidh Krishna, who made a comeback from injury with the ongoing series in Ireland, has also been included in the Ásia Cup squad. Varma has made the cut on the back of an impressive run in his maiden T20 series in the West Indies. The 20-year-old is currently with the T20 squad in Ireland.

New Delhi, August 21: Indian captain Rohit Sharma wants his middle order batters to show flexibility as no one in the national team owns any particular batting position.

The Indian captain also said that each and every player who plays or misses out has received clear communication about what role is expected of them and where they stand in terms of their international career.

Asked how Ishan Kishan will be placed vis a vis his batting slot if KL Rahul misses out against Pakistan in the Asia Cup opener, Rohit explained the team's thought process.

"Ajit (Agarkar) is new to the picture and he didn't know what was happening before that. I have tried to keep him updated as much as possible," Rohit said while answering the PTI query. "One thing I need in this team

is everyone ready to bat anywhere. Cricket is moving in a different direction. You can step up at any position, no one should say 'I am good at this position and that position'. That is the message that has been conveyed to every individual, not now but that's happening for last two, three or four years," the skipper said.

"I know it's tough for you guys outside to understand that why is a guy who was batting at No.6 is suddenly batting at No.4. It hasn't happened overnight. He has been prepared for that role. This is international sport we are talking about. This is not club cricket.'

"He should be able to bat anywhere that team requires him to. Not like we go off to sleep at night telling a batter a position and next morning we change that position. It doesn't happen like that," Rohit said in his inimitable style.

The Indian skipper seemed a trifle irritated when asked why India doesn't have a settled No.4. We have got guys who can bat at No.4. It's not about No.4. It's about top three and there onwards, 4, 5, 6, 7 and there onwards and who can win us game. There have been challenges and guys have been put under pressure and that's a good thing.

"Unfortunately, we had injuries along the line and we had to try out different players and keep in mind workload management and see what combination suits us. We have 9 ODIs and 2 practice games and we have lot of games where these guys will get a chance to make the position their own," he added.

Mason, August 21: Novak Djokovic outlasted Carlos Alcaraz in a thrilling rematch of their Wimbledon final, winning 5-7, 7-6(9-7), 7-6(7-4) to take the Western & Southern Open.

In a match that lasted 3 hours, 49 minutes, the longest best-ofthree sets final in ATP Tour history (since 1990), the No.2-seeded Diokovic avenged his loss last month to the top-ranked Alcaraz and earned his 95th career title, passing Ivan Lendl for third among men in the professional era, dating to 1968.

In the women's final, seventhseeded Coco Gauff became the first teenager in more than 50 years to win the Western & Southern Open with a 6-3, 6-4 victory over Karolina Muchova.

Djokovic was playing his first tournament on US soil in two years because of COVID-19 restrictions. He secured his third Cincinnati championship in six years on his fifth match point when Alcaraz went wide with a forehand return.

The 36-year-old Serbian fell on his back, arms and legs spread, before heading to the net to shake hands with his Spanish opponent. He then strutted around the court and ripped his shirt apart from the buttons on down.

With temperatures hovering near 90 degrees, Djokovic survived the tournament's longest men's match since at least 1990 to become the oldest man to win the championship. Ken Rosewall was 35 when he won in 1970. The rematch of Alcaraz's five-set victory at Wimbledon broke the previous Cincinnati record of 2 hours, 49 minutes, set in 2010 as Roger Federer was beating Mardy Fish. It's the longest three-set match on the men's tour this -( season by three minutes.
