INDIA MOONWALKS

As it became the fourth country in the world after Soviet Union, the US and China to land on the moon, India also created history by becoming the first nation to successfully touch down on the South Pole of lunar surface

• A'DARK SIDE' OF MOON: The portion of the moon's surface that we cannot see from earth. This side is only accessible from space

New Delhi, August 23: India joined Wednesday an elite group of three other nations to have sent a spacecraft on the moon as Chandrayaan-3 landed a rover on the lunar surface to explore the uncharted territories near the South Pole. India also created history by becoming the first nation to achieve successful landing on the South Pole of the moon.

The erstwhile Soviet Union, the US and China have successfully carried out soft landings on the moon. They have even got back to earth samples of soil and rocks from the lunar surface.

India's third lunar mission -Chandravaan-3 landed at a place where no spacecraft has travelled so far. No other country has been able to land on this side of the moon before; this will change all narratives and stories about the moon, Prime Minister Narendra Modi said. President Droupadi Murmu also congratulated ISRO for the historical achievement. "It is a momentuous occasion," Murmu said.

Chandrayaan-3 touched down on the lunar South Pole exactly at 6.04 pm Wednesday. In a big boost to India's space prowess, the LM comprising the lander

(Vikram) and the 26 kg rover similar Russian lander crashed.

The lander and the six-wheeled rover (with total mass of 1,752 kg) are designed to operate for one lunar daylight period (about 14 Earth days) India's lunar missions began

with the launch of Chandravaan-1 October 22, 2008 that put a spacecraft in a 100km circular orbit around the moon. The spacecraft made 3,400 orbits around the Moon at a height of 100km from the lunar surface and prepared a chemical, mineralogical and photo-geologic mapping of the Moon.

The orbiter mission. had a life of two years, was, however, prematurely aborted after communication with the spacecraft was lost August 29, 2009.

A decade later, Chandrayaan-2, comprising an orbiter, lander and rover, was successfully launched July 22, 2019. The objectives of the country's second mission to the Moon were sci-

None of the moon missions of different countries were successful in their first attempts. with the then USSR succeeding to make a lunar impact on its sixth space flight. The Luna-2 mission of the Soviet Union crashed on the moon September 14, 1959, making it the first human-made object to hit another celestial body. Similarly, the National Aeronautics and Space Administration (NASA) could taste success in the lunar missions July 31, 1964, after 13 failed attempts

Nandankanan may remain open for visitors till 8pm

Efforts are on to keep open the Nandankanan Zoological Park (NZP) for visitors in the evenings. A master plan to keep the Nandankanan Zoo open for visitors for a specified period, either from 6.00pm to 7.00pm or 7.00pm to 8.00pm, has been submitted to the Central Zoo Authority (CZA) even though wildlife experts are of the opinon that night visits may disturb nocturnal animals.

The master plan has been prepared as per the government of India instructions. Earlier, all zoo authorities used to submit a master plan for 10 years, but this time it has been submitted for 20 years, informed Principal Chief Conservator of Forests (PCCF), Sushil Kumar Popli here Wednesday. Popli also said that in addition, a proposal has also been given for expansion of the area of Nandankanan by adding Krushnaprasad and Chudanga forest areas. If accepted, the total area of the zoo will be 1,043 hectares.

"A proposal for allowing night visits to the zoo has been mooted. As per the proposal, we will allow visitors during late evening hours for educational awareness. Films will also be shown and selected people will be allowed to walk around enclosures of nocturnal animals. All these proposals however, are subject to government approval," said Popli.

NZP authorities informed that at present there are 167 species and over 4,000 animals.

Board exams twice a year

MoE's 2nd attempt to revamp the exam system, after the first one introduced in 2009 did not work

New Delhi, August 23: Board examinations will be conducted twice a year and students will get an option to retain their best score, according to the New Curriculum Framework (NCF) prepared by the Ministry of Education (MoE). Aiming to make the exams 'easier', rather than 'high stakes', the various boards have also been asked to develop capacities to be able to conduct 'on-demand' examinations in due course of time.

The NCF document accessed by this agency also noted that there should be no hard separations between Arts and Sciences, Curricular and Extra-Curricular activities, and vocational and academic streams. It also said that Class XI and XII students will have to study two languages including one Indian.

"Board examinations should be offered at least twice a year to ensure that students have enough time and opportunity to perform well. Students can then appear for a board examination in subjects they have completed and feel ready for," the MoE document said. "This process could be made possible through the creation of a comprehensive test item bank which can be used to create tests using suitable software. This will enable the move towards a system of on-demand examinations in the near future as described in NEP 2020," the NCF document stated.

This however, is not the first attempt at reforming board exams. The Continuous and Comprehensive Evaluation (CCE) was introduced for Class X in 2009, but was revoked in 2017 and the board reverted to the old model of year-end exams.

The board exams for Classes X and XII were also split into two terms during the pandemic as a one-time measure, but the old format of year-end examinations was resumed for the crucial tests this year

The NCF prepared by the national steering committee, headed by former ISRO chief K Kasturirangan, also suggests that the current practice of streaming into Science, Arts or Humanities, and Commerce will be replaced by a design that enables students to choose sub-

jects that they are strong in. "There should be no hard separations between Arts and Sciences, between Curricular and Extra-Curricular activities, and between vocational and academic streams. This will eliminate harmful hierarchies among, and silos between, different areas of learning," the NCF document stated.

Udala, August 23: Udala police Wednesday arrested a lady lecturer for allegedly appearing in an examination on behalf of a girl student who was absent. Later, Gouranga filed a written complaint at the Udala police station following which a case was registered and cops arrested the lady lecturer. Police also seized the answer sheet used by her for investigation.

Meanwhile, an audio message where Gouranga is heard asking Tulika to come to a 'deserted place' has gone viral. The principal however, has denied his involvement.

Wagner chief Prigozhin feared dead AGENCIES

Moscow, August 23: A business jet en route from here to St Petersburg crashed Wednesday, killing all 10 people on board, Russian emergency officials said. Mercenary chief Yevgeny Prigozhin was on the passenger list, officials said, but it wasn't immediately clear if he was on board. Unconfirmed media reports said the jet belonged to Prigozhin, founder of the Wagner private military company. However, it was not immediately clear if he had boarded the flight. Russia's state news agency 'Tass'

cited emergency officials as saying that the crash took place in the Tver region more than 100 kilometres north of the Russian capital. "The plane that crashed

in the Tver Region listed Yevgeny Prigozhin among its passengers, (Russia's aviation agency) Rosaviatsia said," TASS news agency reported, with 'RIA Novosti' and 'Interfax'

issuing similar reports. Prigozhin, whose private military force Wagner fought alongside Russia's regular army in Ukraine, mounted a short-lived armed mutiny against Russia's military leadership in late June.

Praggna on cusp of history

Baku, August 23: In an anticlimax of sorts, the second game of the Chess World Cup final between Indian teen sensation R Praggnanandhaa and World Champion Magnus Carlsen failed to decide a winner, as it ended in a draw after 30 moves here Wednesday after 90 minutes. Carlsen was the favourite to win as he played with white pieces. However, Praggnanandhaa adopted superb defensive tactics to stall the current World No. 1. Now the championship will be de-



cided via two tie-breaks Thursday. Five-time World Champion Carlsen played a solid game with pieces against

Praggnanandhaa. The Indian however, did not face any trouble with black pieces. The first game Tuesday had ended in a stale-

mate after over four hours of play and 70-plus moves, following which Carlsen said he was a bit under the weather.

The 18-year-old Praggnanandhaa has been enjoying an incredible run in the tournament, having already beaten World No. 2 Hikaru Nakamura and World No. 3 Fabiano Caruana to set up a final date against the Norwegian Grandmaster.

Incidentally Praggnanandhaa is only the second and the youngest among Indians to play in the final of the Chess World Cup after Viswanathan Anand. The results in the ongoing tournament also helped Praggnanandhaa qualify for Candidates 2024 tournament, which will be held in Canada. He. thus, became the third youngest player after the legendary Bobby Fischer and Carlsen to qualify for the Candidates tournament.

Praggnanandhaa exuded confidence after the second game. "I really did not feel any pressure and I was comfortable playing against Carlsen," the Indian GM said. "It was a well-fought game, but I never felt for a moment that I wasnot in control of the situation,' Praggnanandhaa added.





OSCW SEEKS REPORT ON Odisha leading in rice procurement **HOME GUARD 'TORTURE'**

Bhubaneswar, August 23: The Odisha State Commission for Women (OSCW) Wednesday took suo motu cognisance and sought a report from the Crime Branch in connection with the alleged torture of a woman home guard by the wife of a senior IPS officer

The commission's chairperson Minati Behera said the panel has asked the Crime Branch ADG to submit a report within

"We have taken suo motu cognisance of the case and want the report within a fortnight," she told reporters.

Stating that the women's commission will hold discussions with the victim after she recovers, Behera said necessary step will be taken according to the law.

The OSCW's action came a dav after the Odisha Human Rights Commission (OHRC) sought a report from the police on the alleged torture of the woman home guard, who lost both her legs during a bid to die by suicide out of frustration.

A rights activist has also moved the NHRC seeking justice for the victim.

The woman has been undergoing treatment at a private hospital in Cuttack while the Odisha Police has transferred North Central range DIG Brijesh Rai to the state police headquarters after a hue and cry across the state.

According to the complaint lodged by the victim, she was subjected to both mental and physical torture by the IPS offiwas forced to wash the IPS officer's wife's clothes and after denying to carry out the work, she was beaten up August 4 and threatened to be dismissed from service.

The 47-year-old woman, who has lost her husband about two decades ago, said she wanted to end her life by jumping in front of a moving train. Though she survived, she lost both her legs in the incident.

Meanwhile, a BJP delegation led by its state vice-president Lekhasri Samantsinghar met Governor Ganeshi Lal at Raj Bhawan and sought his intervention into the matter, while alleging that the state government was attempting to hush-up the case by transferring the officer from Angul to Cuttack.

'No activity' during childhood may damage heart in later life

To activity for hours during childhood could be setting the stage for heart attacks and strokes later in life, a new study said Wednesday.

According to the study presented at the European Society of Cardiology, sedentary time accumulated from childhood to young adulthood was associated with heart damage -- even in those with normal weight and blood pressure.

"All those hours of screen time in young people add up to a heavier heart, which we know from studies in adults raises the likelihood of heart attack and stroke," said study author Andrew Agbaje of the University of Eastern Finland, Kuopio, Finland.

"Children and teenagers need to move more to protect their long-term health,'

To investigate, researchers let children wear a smartwatch with an activity tracker for seven days at 11 years of age. This was repeated at 15 years

of age and again at 24 years of age. The weight of the heart's left ventricle was assessed by echocardiography, a type of ultrasound scan, at 17 and 24 years of age and reported in grams relative to height (g/m2.7).

The researchers analysed the association between sedentary time between 11 and 24 years of age and heart measurements between 17 and 24 years of age after adjusting for factors that could influence the relationship, including age, sex, blood pressure, body fat, smoking, physical activity and socioeconomic status

The study included 766 children, of which 55 per cent were girls and 45 per cent were boys.

At 11 years of age, children were sedentary for an average of 362 minutes a day, rising to 474 minutes a day in adolescence (15 years of age), and 531 minutes a day in young adulthood (24 years of age), meaning sedentary time raised by an average of 169 minutes (2.8 hours) a day between childhood and young adulthood, the study

'3D endospine surgery now available in Odisha'

Bhubaneswar, August 23: Two most common and painful ailments of the spinal cord and vertebrae-slipped disc and sciatica could now be successfully operated on with very less pain and cuts, noted endoscopic surgeon and orthopaedician from Bhubaneswar PC Dey said Wednesday at a press conference.

With the advent of MRI, the cause of back pain is diagnosed very early and almost 100 per cent accurately. A training programme in this regard is being held from August 23 to 26, he said

Dey said that the advanced 3D endospine surgery is now available in Odisha. He said that with the advent of advanced medical science like 3D endoscopic surgeries, the treatment and surgeries of such diseases could be done with minimally invasive techniques. He said such technology has been introduced for the first time

These two diseases are often

the main causes of the commonly seen problem of back pain among the population. In most of these cases the nerves are compressed, leading to pain that grows radially. Sometimes it even leads to numbness and tingling of the foot and other health hazards

Dey explained that under this technique, a small incision of around 16mm-18mm is made on the patients under this sur-

"Endoscopic equipment like a 4 mm 3D camera, light and a decompressor are used to see deeper structures which are almost 60 to 80 times magnified, Dev said

"The pain-causing nerve points inside the body like disc material, pathological bony projections and thickened ligaments could be removed quite accurately with this technique. This aids in decompression of the parts of the affected nerves. Such surgeries are often the least painful compared to conventional surgeries, including large cuts, surgeries, and long hospitalizations," he added.

A Virtuous Cycle

t least half of the global population lacks access to essential health services, and health-care expenses push almost 100 million people into extreme poverty each year. How scarce resources are distributed should matter, and there are good reasons to believe that finance could play a crucial role in addressing this challenge. More than 60 countries have launched national financial-inclusion strategies. and academic research is keen on understanding their impact.

Until recently, there was no evidence that finance could make a significant difference for health. Randomised controlled trials that offered households financial products such as savings accounts, credit, and health insurance found no effects. But, crucially, these studies did not examine important long-term and large-scale aspects of banking, nor did they account for the financial products and services offered to businesses and health-care providers

In a recent study, I used a natural experiment that introduced variation in bank presence in India to assess the effects of improving financial inclusion nationwide, over ten years, and on different actors in the market. In contrast to previous research, I found substantial improvements in households' health.

In 2005, the Reserve Bank of India (RBI) introduced a policy to incentivise banks to open new branches in underserved districts nationwide. After five years, the number of bank branches in these districts had increased by 19 per cent. More importantly, two nationally representative household-level surveys have shown improved health in these districts compared to similar districts where the policy did not apply.

The Indian Human Development Survey (IHDS), conducted six years after the RBI policy went into effect, demonstrates that households in districts with an increased bank presence were 36 per cent less likely to experience non-chronic illnesses such as fever or diarrhoea. Likewise, the Demographics and Health Survey, conducted ten years after the policy was implemented, shows higher vaccination rates and lower risks associated with pregnancy in these districts. Decreased morbidity rates also improved health-related economic outcomes: the IHDS shows that households missed less school and work owing to illness and incurred significantly lower medical expenses.

Three mechanisms likely played a role in improving health outcomes. For starters, banks provided credit to local businesses, allowing households to earn more and invest more in health. Second, the data suggest that households directly gained access to financial services. They established savings accounts and, importantly, could also buy health insurance. In India – as in over half of developing countries - local

banks sell health-insurance policies to their customers, serving as middlemen for insurance companies in major cities. This differs sharply from most developed countries, where health insurance is purchased only directly from insurance companies or obtained from government programmes.

Lastly, health-care providers gained access to credit. Eight years after the RBI policy was implemented, the number of hospitals operating in the incentivised districts had grown by 140 per cent, and providers were more likely to report institutional loans as their primary source of finance. Local households also reported fewer problems with health-care supply. Policymakers took to heart the importance of expanding credit to health-care providers: in May 2021, during the COVID-19 crisis, the RBI provided \$6.78 billion in easily accessible credit for the sector.

The substantial effects of finance on health in this natural experiment are more evident than they were in prior randomised controlled trials. Exploring finance using a natural experiment has two important added merits. First, it allows one to capture general equilibrium effects: evidence suggests that both demand and supply of the healthcare market are stimulated, potentially creating a virtuous cycle. Second, one can explore effects on a larger scale over a longer period time. Increased bank presence could also help achieve other United Nations Sustainable Development Goals worldwide. Given the relationship between improved access to bank branches and fewer school absences owing to illness, education is one policy area that could be amenable to financialinclusion efforts. Allowing households to invest more in education and providing credit for creating new schools and training programmes could generate better education outcomes.

The success of the RBI policy bodes well for policymakers in developing countries seeking to improve health outcomes. It also warrants further study of how similar interventions could affect demand and supply in other markets. Policy incentives to increase the number of bank branches in underserved areas could ultimately have multiple positive community outcomes, beyond improved health indicators.

Mortarboard

he academic cap often called a mortarboard is quite ancient, but that word for it only dates from the middle of the nineteenth century (a less slangy way to identify it is to call it a square). The literal mortar board is the wooden plate, usually with a handle underneath, on which bricklayers carry small amounts of mortar. A similar tool is used by plasterers, but they usually call it a hawk. What seems to have happened is that the similarity in shape between the brickie's board and the academic cap led some wag, probably at Oxford University, to apply the name of the one to the other. Our first recorded use is in a book of 1853-6, The Adventures of Mr. Verdant Green, an Oxford Freshman by a clergyman named Edward Bradley, who wrote under the pen name of Cuthbert Bede (the names of the two patron saints of Durham, where he went to school). Verdant Green is a sort of undergraduate Pickwick and the book recounts his adventures. After a slow start, the book became a huge success, selling more than 200,000 copies in the next 20 years. Whether Mr Bradley invented the slang term we may never know, but his book certainly popularised it.



DIGITAL AUTHORITARIANISM

THERE IS ALSO A **NEED TO REFORM SURVEILLANCE** LAWS, WHICH **ARE HEAVILY LOADED AGAINST THE PRIVACY OF INDIVIDUALS**

n the Puttaswamy case (2017) a nine-judge bench unanimously affirmed that the right to privacy is an inalienable part of the right to life and personal liberty (Article 21). The court had nailed the chilling argument: "You may say that you want to be forgotten but the state does not want to forget you." Accordingly, it had asked the government to put in place a carefully structured regime for the protection of personal data. Justice Srikrishna submitted his recommendation for Data Protection Framework for India in 2018, largely based on the EU model. After several years of debates and deferrals, the government put in place the Digital Person Protection Act on 11 August. Responding to the Bill, Justice Srikrishna observed that "the bill is fundamentally flawed as it would permit and may encourage the executive to act capriciously & infringe on the fundamental right of privacy of personal data." Discerning analysts believe that the act will facilitate data collection and processing by the government and private entities rather than data protection and turn India into an Orwellian state.

The Act recognises that it has to balance the right of individuals to protect their personal data and the need to process such personal data for lawful purposes. The grounds for processing personal data rest on two pillars -- the data principal's consent and legitimate use. The consent has to be free, specific, informed, unconditional. and unambiguous. The new law covers all personal data and does not contain any heightened protection for any special category of data. This is unlike the EU's GDPR which provides for stronger legal protection for more sensitive information like race, ethnic background, religious beliefs, political opinion,

sexual orientation, and genetics. The data principal is the individual, data subject, while a data fiduciary is the entity that determines the means of processing personal data. The data controller does not distinguish between private and public, natural and legal persons. Specific fiduciaries like the government and its agencies are exempt from the core obligations of the act. They include activities that are in the interest of sovereignty and integrity, security of the state, public order, and incitement to violence. Justice Srikrishna is critical of these sweeping government exemptions, which are likely to be used by parties in power to settle scores with political adversaries and those who display institutional independence.

Data localisation obligation a sore issue for MNCs, mooted in 2018, has been given a go-by. The Act does not restrict the transfer of personal data out of India. The blanket exemption given to the government and its agencies under Section 17 of the Act without the consent of the data principal goes against the SC judgement in Maneka Gandhi vs UOI in 1978 which held that procedure established by law should be reasonable, fair and just. In another landmark decision in Anuradha Bhasin vs UOI (2020), when internet was disconnected in Kashmir the SC averred that the restriction must meet the proportionality test. The court struck down prohibiting internet access as invalid.

The Modi government believes that there is scaremongering in the country. Instead, we should trust it with our privacy as the data act is a new contract to participate in a digital society. Several recent pieces of legislation create databases that fit an authoritarian frame containing intimate details of Indians and their family units. This includes the Criminal Procedure (Identification) Act 2022. It creates databases unnecessary while also infringing on fundamental rights. The registration of the Births & Deaths (Amendment) Act 2023 builds a national database seeded with Aadhaar, which means data sharing literally from cradle to pyre. Further, the Act envisages that personal data can be processed for the exercise of any function of the State. This can be done without the consent of the individual as long as it is to provide a service or benefit to the individual. This runs

contrary to the concept of "informed consent.'

The inspiration seems to have been drawn from the National Intelligence Law of China where it can demand any such information as it may call for. Companies will fear a government that can pick winners and losers in India's digital market This follows a path of centralised state command where the government can select firms as national champions. In September 2018, the SC upheld but limited the Aadhaar programme. Justice DY Chandrachud in his dissenting judgement alluded to Nobel-winning Solzhenitsyn's experience in Stalinist Russia: "The invisible threads of a society networked on biometric data had grave portents for the future. Unless the law mandates an effective data protection framework, the quest for liberty and dignity would be as ephemeral as the wind."

It may be recalled that in the 2010s, personal data belonging to millions was collected without their consent by British consulting firm Cambridge Analytica, predominantly to be

used for political advertising. India requires a wider constitutional reboot on attempts to consolidate digital authoritarianism. There is also a need to reform surveillance laws, which are heavily loaded against the privacy of individuals. Without reform of surveillance governance, the present DPPA would pose bigger privacy issues in future. With general elections months away, the BJP is likely to up its antennae to collect sensitive personal data like political opinions, religious beliefs. The SC must nail the attempt of the government to ride triumphantly on digital authoritarianism.

Propelling startups from ideas to impact

THE TIME HAS JUST **TURNED RIPE FOR INDIA'S DEEP TECH STARTUPS TO TAKE ON THEIR GLOBAL PEERS AND UNWRAP THE POSSIBILITIES AHEAD**

'ndia's deep tech startup ecosystem has finally garnered the attention and policy thrust it deserved for years. The draft National Deep Tech towering vision to position India as a global deep tech innovation hub. When their global peers in the US. China and Israel are leapfrogging, the deep tech startups nurtured in India can't be laggards. And the policy takes note of the catching up that our home-

grown startups need to do. This policy open for public consultation, fosters research, development, and innovation while strengthening intellectual property rights to catalyze growth. Collaboration, not isolation, is the heart of innovation, and the draft policy advocates the creation of shared infrastructure. Startups in deep tech can flourish because the policy embraces modern regulatory standards and enables access to funding. As a nation, we are seeking to become a technology powerhouse, and the policy reflects this ambition. A pragmatic approach to galvanising growth is evident in the emphasis on public-private partnerships, seed funding, and infrastructure development.

For years, deep-tech startups have faced a profound challenge in raising funds from venture capitalists and deep-pocket investors. Only 11% of the tech-

nology-related funds reach deeptech startups. This trend does not bode well for the 3000+ deeptech startups, a third of which have moved up the innovation Startup Policy (NDTSP) has a curve, filing patents. More so, at a time when the US, the EU and China are ramping up capital for their deep tech entities, the counterparts in India can't lose edge and cool their heels.

The NDTSP recognises the critical role of funding and articulates strategies to enhance access to capital for deep tech startups through venture capital funds, angel investors, government funds, and corporate partnerships. Building on this vision to ease fund worries, the government can now think of setting up a common grant framework across ministries for the deep tech entities. The grants can be earmarked both at the Proof of Concept and prototype stages. This is important because fundraising remains the biggest hurdle for any fledgling startup. Deep tech startups often have difficulty finding product-market fit since they are more technology-driven than marketdriven. Any RoI-obsessed venture capitalist is hesitant to fund a deep tech startup due to uncertain and long break-even cycles. The match equity model paradigm has clicked in Israel and other countries where larger grants could be coupled with matching equity capital from financial investors. This will encourage fiscal prudence as well as commercial focus. One more positive takeaway of

the NDTSP is the focus on public procurement to amplify the visibility and viability of deep tech startups. When government departments and agencies buy products or solutions from such entities, it creates a virtuous cycle, stimulating market adoption and expediting the pace of innovation. The bedrock of any technological renaissance is talent acquisition. In this policy, initiatives are proposed to attract skilled professionals and promote capacity-building programmes. The policy strengthens the deep tech ecosystem with the human resources it needs to succeed by nurturing a pool

of competent individuals. To spur innovation, the policy calls for improved intellectual property regulations. The policy aligns with global best practices by simplifying patent procedures and providing legal support. Indian startups will be better positioned to compete internationally if they are supported in filing international patent applications. Today, the Patent Cooperation filing treaty is an expensive and time devouring process and Indian deep tech founders need the Indian government's support in filing patents in international markets.

For all its packages of goodies, the NDTSP is stalked by the cat-

egorisation conundrum. Concerns_ linger over classification of technologies as "deep tech." A misstep here could blur the lines between technological breakthroughs and incremental advancements, so definitions must be clear Identifying only those technologies with transformative potential as deep tech will safeguard the sector's integrity and encourage focused innovation.

There is more to the draft NDTSP than a set of provisions; it is a strategic blueprint for India's technological resurgence. With its emphasis on innovation, intellectual property protection, financial accessibility, and attracting top-tier talent, the policy weaves a narrative of possibility that enables deep tech startups to transcend boundaries and reshape industries. It is, however, crucial that we remain vigilant throughout this journey to ensure our vision is realised. The deep tech dream of India has the potential to rewrite the story of technological progress with its collaborative efforts, steadfast implementation, and adaptability to emerging challenges. The time has just turned ripe for India's deep tech startups to take on their global peers and unwrap the possibilities ahead

The issue of lassitude among pilots has become a dark cloud amid the country's growing air traffic and expanding aircraft fleet. A recent survey conducted among 500-odd pilots by Safety Matters Foundation, an NGO formed under the India Trust Act, showed that a majority of them fell asleep without planning or consent of the other crew. While regulations on flight duty time limitations and specific rest periods are in place, a more scientific approach as well as a better fatigue reporting system will help in tackling the silent danger of "fatigue." Also future high-quality intervention studies will play a crucial role in determining effective strategies for boosting pilot well-being, ultimately leading to improved flight safety and performance.

SC stays trial court's order to Azam Khan

New Delhi: The Supreme Court Wednesday stayed an order of a trial court directing Samajwadi Party leader Azam Khan to give a voice sample in a case of allegedly delivering a hate speech and using derogatory language against BSP chief Mayawati in 2007. The voice sample has been sought to match it with Khan's speech, which was made during a public meeting in Rampur's Tanda area in 2007 and recorded on a CD. A bench of justices A S Bopanna and P K Mishra issued notice to the Uttar Pradesh government and the complainant in the case on the plea filed by Khan.

Fresh spell of rain in Delhi

New Delhi: Delhi recorded a fresh snell of rain Wednesday which brought the maximum temperature down to 29.4 degrees Celsius, five notches below normal. The Safdarjung Observatory, Delhi's primary weather station, recorded 6.4 mm of rainfall between 8:30 am and 5:30 pm. The weather stations at Palam, Lodi Road. Ridge, Ayanagar, Najafgarh, Pitampura, Pusa and Mayur Vihar also recorded light rain.

18 workers hospitalised

Bharuch (Gujarat): A hazardous incident unfolded in Gujarat's Bharuch district as a toxic gas leak occurred within a factory premises Wednesday, resulting in the hospitalisation of at least 18 workers. The incident raised concerns about industrial safety and the well-being of labourers. Quick action and evacuation procedures were able to ensure the safety onsite during the incident.

Constable dies as weapon 'misfires'

Hyderabad: A 31-year-old policeman died here in the early hours of Wednesday after his service weapon allegedly misfired police said. The deceased, a head constable of the Telangana State Special Police (TSSP) 12 Battalion, was on guard duty at the platoon headquarters at Hussaini Alam here, they said. He belonged to Suryapet district.

Article 370 has 'self-limiting character': SC

CII Chandrachud said that Article 370, which continued to exist in the Indian Constitution, itself points to its self-limiting character

New Delhi, August 23: The Supreme Court Wednesday said there is "intrinsic evidence" that Article 370 has a "self-limiting character" and it seems to have worked itself out after the term of the Jammu and **Kashmir Constituent Assembly** ended in 1957.

A five-judge bench headed by Chief Justice DY Chandrachud was hearing a batch of petitions challenging abrogation of Article 370 that accorded special status to the erstwhile state of Jammu and Kashmir.

"Really speaking, though the Constitution of Jammu and Kashmir framed its relationship with Union of India, unless that relationship was embodied in the Indian Constitution, how will it bind the dominion of India or Parliament for successive years after 1957," the bench, also comprising Justices Sanjay Kishan Kaul, Sanjiv Khanna, BR Gavai and Surya Kant, said.

The bench posed questions to senior advocate Gopal

Sankaranarayanan, appearing for one of the petitioners Soayib Qureshi, who has challenged the Centre's August 5, 2019 decision to abrogate the provision.

CJI Chandrachud said in his view, Article 370 has two terminal points-first in clause 2 where it has been said that all decisions taken prior to the existence of the constituent assembly shall be placed for its approval and second, in proviso to clause 3, where it was said that the President can issue a notification declaring that Article 370 shall cease to exist or shall be operative with exceptions and modifications only on the recommendation of the Constituent Assembly of Jammu and Kashmir.'

CJI Chandrachud asked Sankaranarayanan that if this reasoning is to be accepted, then it means that once Article 370 worked itself out, the Constitution of Jammu and Kashmir will fill the void and that it will be the supreme document.

Sankaranaraynan said it is their argument that Article 370 has worked itself out once the constituent assembly ceased to exist and, therefore, it should not have been touched.

The bench, however, clarified it is not saying that all constitution amendment orders issued for the application of the provisions of the Indian Constitution with respect to Jammu and Kashmir are unconstitutional

Sankaranarayanan contended the Constitution of Jammu and Kashmir has almost all the provisions which Indian Constitution has with nominal

26 workers killed as rly bridge collapses

Aizawl/Kolkata, August 23: At least 26 workers were killed and two others injured after an underconstruction railway bridge collapsed near the mountainous Sairang area of Mizoram Wednesday, officials of Mizoram Relief and Disaster Management Department said.

Police officials, however, said that 23 workers were killed and 18 bodies recovered till 5 p.m. late Wednesday afternoon.

Rescue operations involving National and State Disaster Response Force and Young Mizo Association volunteers, were unfderway to recover the bodies from under the collapsed steel structure that had toppled off

towering columns into the forested valley below. A Mizoram government statement said that the Quick Response Team (QRT) along with National Disaster Response Force have rescued one injured worker from the top of one of the bridge pillars. Two QRT personnel -- Lalhriatzuala and Lalfakzuala -- brought down the injured worker rappelling

down over the 100 metre high pillar. Post mortem is being conducted by a team from the Zoram Medical College and Civil Hospital in Aizawl.

The bodies would be embalmed and would be handed over to the Railway Department for transportation to respective na-

tive villages, the statement said. The Railway engineers said that the accident was due to the collapse of a gantry, which was being placed over the 104metre piers of the under-construction bridge. Officials said that most of the victims are believed to be from West Bengal's Malda district. A high-level committee has been constituted by the Railway Ministry to probe the incident, railway officials said.

The railway bridge was under construction over the Kurung river connecting Bairabi (near southern Assam) to Sairang, 10 km away from the Mizoram capital Aizawl.

The accident site is about 21 km from Aizawl.

The Northeast Frontier Railway (NFR), which is implementing the 51.38-km railway project, has sent several medical and engineering teams to provide medical assistance as well as the recovery process.

NFR General Manager (Construction) Sunil Kumar Jha, along with senior officials, have also rushed to Mizoram from the NFR headquarters in

Shimla, August 23: Heavy overnight rains in Himachal Pradesh claimed 12 lives and blocked over 400 more roads besides damaging several houses, officials said Wednesday.

A total of 709 roads in the state are now shut following three major spells of heavy rains this Monsoon that have left a trail of death and destruction. Chief Minister Sukhvinder

Singh Sukhu appealed to the people to remain vigilant in view of the heavy rain forecast. All schools and colleges have

been closed for two days beginning Wednesday in Shimla, Mandi and Solan districts. Out of the 12 deaths, seven

occurred due to landslides in Mandi and Shimla. Besides, three people died of electrocution, and one death each was reported due to drowning and falling from



height in different parts of the state, according to the state emergency operation centre.

Five persons have died in landslides triggered by cloud bursts in two villages of Seraj area of Mandi district, Deputy Commissioner Arindam Chaudhary told PTI.

Two persons, Parma Nand (62) and his grandson Gopi (14), were killed in a landslide at Dagol village of Seraj in Mandi district while the other three were killed in a landslide in Sarachi village. Some more people are feared trapped in the debris. A few houses and a school were also damaged in the area.

Shimla town was badly hit, with landslides and uprooted trees blocking the main cart road, the lifeline of the town as well as the Shimla-Mehli bypass at several points. Many houses have also developed cracks and people have been evacuated as a

precautionary measure. A migrant identified as Jhalo and his wife Rajkumari were found dead in their makeshift house in Baldevan area of Shimla district, Superintendent of Police, Shimla, Sanjeev Kumar Gandhi told PTI. The police officer also appealed to residents to avoid unnecessary travel.

As many as 120 people have died in rain-related incidents in the state this month while a total of 238 people have died and 40 are still missing since the onset of monsoon in Himachal Pradesh

LCA Tejas successfully test-fires ASTRA beyond visual range missile

New Delhi, August 23: Indigenously-developed light combat aircraft Tejas on Wednesday successfully testfired an ASTRA beyond visual range (BVR) air-to-air missile off the coast of Goa. The missile release was successfully carried out from the aircraft at an altitude of about 20,000 feet, officials said.

'Tejas, Light Combat Aircraft (LCA) LSP-7 successfully fired the ASTRA indigenous beyond visual range air-to-air missile off the coast of Goa on August 23," the defence ministry said. It said all the objectives of the test were met and it was a perfect text book launch.

The test launch was monitored by the test director and scientists of Aeronautical Development Agency (ADA), Defence Research and Development Organisation (DRDO), Hindustan Aeronautics Limited (HAL) along with officials from Centre for Military Airworthiness and Certification (CEMILAC) and Directorate General of Aeronautical Quality Assurance (DG-AQA).

T'gana HC suspends judge who ordered FIR against CEC

Hyderabad, August 23: The Telangana High Court has placed under suspension a special sessions judge in connection with a "direction" given by him to police for registering an FIR against Chief Election Commissioner Rajiv Kumar and several others, saying the judge acted in "undue haste'

Official sources in Hyderabad and people aware of the development in Delhi said the suspension was initiated on the administrative side against K Jaya Kumar, the judge of special sessions court for trial of MPs/MLAs, after a complaint was lodged with the high court by a senior official of the Election Commission.

Based on a private complaint filed under Section 200 of the CrPC by Raghavendra Raju, the iudicial officer "acted in undue haste" without conducting any preliminary enquiry and without recording the statement of the complainant, the high court said.

Thus, there was a serious lapse in the procedure followed by the officer while discharging his duties, the sources said citing the order issued by the high court on the administrative side.

The FIR was registered August



11 against Telangana Excise Minister V Srinivas Goud, CEC Kumar and a host of other officials after being referred by the sessions court for allegedly "tampering" Goud's 2018 state assembly election affidavit.

The matter was referred to police by the sessions court on a private complaint which alleged that Goud, MLA from Mahabubnagar, had "tampered" with the election affidavit by suppressing facts.

While Goud was named as the first accused, CEC Kumar and several other officials were made co-accused, who the complainant alleged had colluded with the minister and closed the election affidavit without taking any further action.

The judicial officer was placed under suspension by the high court in exercise of the Telangana Civil Services Rules, 1991 "in larger public interest", the sources said citing the order.


"Momentarily, tower controller forgot this crossing and issued take off clearance to another Vistara flight VTI725 (Delhi-Bagdogra) from runway

ED arrests Maltese man who 'assisted' Kamal Nath's nephew NEW DELHI: The Enforcement Directorate on Wednesday said it has made a

fresh arrest in an alleged ₹354 crore bank fraud linked money laundering case involving Ratul Puri, the businessman nephew of senior Congress leader and former Madhya Pradesh Chief Minister Kamal Nath, and others. Nitin Bhatnagar, a Maltese citizen and a former relationship manager of the Bank of Singapore, was taken into custody under the provisions of the Prevention of Money Laundering Act (PMLA) on Tuesday. He was produced before a local court by the agency (on Tuesday) that sent him to ED custody till August 31. It is almost about four years that fresh action took place in this case as the ED filed a charge sheet against Puri in October, 2019. The money laundering case stems from a August, 2019 FIR of the CBI where it was alleged that Moser Baer India Ltd (MBIL) and its promoters allegedly cheated and defrauded the loan taken from the Central Bank of India to the tune of ₹354.51 crore. The case was registered after the bank sent a complaint to the CBI.

Lanka's dilemma

Colombo: Sri Lanka is currently processing a request by China to allow a research ship to dock in the country, a foreign ministry spokesperson said Wednesday, a year after a visit by a Chinese spy vessel to the Island nation raised security concerns in India. "The Chinese embassy here has made an application and the ministry is currently looking at it," Priyanga Wickramasingha, the foreign ministry spokesperson, told PTI. No dates have been fixed yet for the visit, she said. The Chinese research vessel 'SHI YAN 6' is expected to arrive in Sri Lanka for marine research activities in October.

Pak arrests 60

Lahore: Pakistani authorities have arrested 60 more people in connection with the unprecedented mob attack on 21 churches in Puniab province, taking the total number of suspects under detention to more than 200, a top police official said Wednesday. A mob ransacked and torched 21 churches and several houses of Christians last week over blasphemy allegations in Jaranwala town of Faisalahad district, 130 km from Punjab's provincial capital Lahore. A Christian cemetery and the office of the local assistant commissioner were also vandalised. Police had arrested 145 suspects subsequently.

SHIFTING GLOBAL ORDER

BRICS for expansion

The expansion of BRICS is the major focus area at the annual summit of the grouping as around 23 countries including Saudi Arabia, UAE, Iran have applied for membership

Johannesburg, August 23: Leaders of the BRICS bloc of leading developing nations -Brazil, Russia, India, China and South Africa - have agreed mechanisms for considering new members, South Africa's foreign minister said Wednesday.

Agreement on expansion paves the way for dozens of interested candidate nations to make their case for joining the grouping, which has pledged to become a champion of the developing "Global South"

Enlarging BRICS has topped the agenda at a summit taking place in Johannesburg, South Africa's commercial capital. While all BRICS members had publicly expressed support for growing the bloc, there had been divisions among the leaders over how much and how quickly.

"We have agreed on the matter of expansion," Naledi Pandor said on Ubuntu Radio, a station run by South Africa's foreign ministry. "We have a document that we've adopted which sets out guidelines and principles, processes for considering countries that wish to become members of BRICS...That's very positive."

Pandor said the bloc's leaders would make a more detailed announcement on expansion before the summit concludes Thursday.

The BRICS bloc brings together five of the largest developing countries of the world,



representing 41 per cent of the global population, 24 per cent of the global GDP and 16 per cent of the global trade.

Russia, isolated by the United States and Europe over its invasion of Ukraine, is also pushing to quickly grow BRICS and forge it into a counterweight to the West. Russian President Vladimir Putin, who is wanted under an international arrest warrant for alleged war crimes, sees BRICS membership as a way of showing the West he still has friends.

India fully supports the expansion of the BRICS and welcomes moving forward on it with consensus. Prime Minister Narendra Modi said even as he presented five suggestions to further broaden cooperation among the members of the grouping in a range of areas,

including space exploration. Modi said the technology will play an important role in making the grouping a "future-ready" organisation, and offered India's readiness to share expertise in the digital domain.

DETHRONING DOLLAR-DOMINANCE

More than 40 countries have expressed interest in joining BRICS, say South African officials, 22 of whom have formally asked to be admitted.

Beyond the enlargement question, boosting the use of member states' local currencies in trade and financial transactions to lessen dependency of the US dollar is also on the summit agenda. South African organisers had said there would be no

Blood, billions: Cost of Russia's war in Ukraine

Washington, August 23: Russia's invasion of Ukraine has left tens of thousands of dead, displaced millions and sown economic turmoil across the world in the 18 months since its launch February 24, 2022.

DEATH

The war has caused death on a level not seen in Europe since World War Two.

Here are some details of the

More than 9,000 civilians had been recorded as killed and more than 16,000 injured by the end of July, according to the United Nations High Commissioner for Human Rights (OHCHR), which said it believed the actual figures were considerably higher.

The war has left nearly 500,000 troops either dead or injured, according to the New York Times.

The paper cited officials from the United States, which supports Ukraine, as saying as many as 120,000 Russian troops have been killed and 170,000 to 180,000 injured, with Ukraine's military toll at 70,000 killed and 100,000 to

120,000 wounded. Russian officials say US estimates of Russian losses are far too high - and propaganda. Russian Defence Minister Sergei

Shoigu said September 21 that

5.937 Russian soldiers had been killed since the start of the war. No further updates have been given and losses are a state secret.

Ukraine has not said how many of its soldiers have been killed and says its military losses are a state secret as they affect battlefield tactics. The conflict in eastern Ukraine

began in 2014 after a pro-Russian president was toppled in Ukraine's Maidan Revolution and Russia annexed Crimea, with Russian-backed forces fighting Ukraine's armed forces.

About 14,000 people were killed there between 2014 and the end of 2021, according to the OHCHR, including 3,106 civilians. **DISPLACEMENT**

Since the 2022 invasion, millions of Ukrainians have been forced from their homes, the United Nations refugee agency has said. Ukraine has a population of more than 41 million.

An estimated 17.6 million people in Ukraine require urgent humanitarian support, including more than 5 million people internally displaced by the war, the UNHCR said.

There are over 5.9 million refugees from Ukraine recorded across Europe, according to the agency's data.

Ukraine's territory since the start of the war, an area equivalent to Massachusetts, New Hampshire and Connecticut combined, according to the Belfer Center at the Harvard Kennedy

When added to Crimea, which Russia annexed from Ukraine in 2014, Russia now controls about 17.5% of Ukraine, an area of about 41,000 square miles (106,000 square km).

After pushing back Russian forces in 2022, it has failed to make major inroads against welldug in Russian troops since launching a new counteroffensive in early June.

Ukraine has lost a swathe of its coastline, its economy has been crippled and some cities have been turned into wastelands by the fighting

Ukraine's economy contracted by 30% in 2022 and is forecast to grow by of 1% to 3% this year, according to the International Monetary Fund.

Russia's expenditure on the war is a state secret, but it coincides with a major shock to the Russian economy from the toughest ever Western sanctions imposed after the invasion.

The economy defied early expectations for a double-digit contraction in 2022, but a return to prosperity remains a long way off as the government directs more spending towards the military. Russia's economy will grow 1.5% this year, according to the International Monetary Fund, after a contraction of 2.1%

Russia has doubled its 2023 defence spending target to more than \$100 billion - a third of all public expenditure - a government document reviewed by Reuters showed, as the costs of the war in Ukraine spiral and place growing strain on Moscow's finances.

As Russia's military spending soars and sanctions squeeze its energy revenues, Moscow faces a battle to keep its budget deficit in check.

Russia has lost a major chunk of the European gas market but has been able to keep selling its oil to global markets, although the United States, Europe and other powers have limited or ended their purchases.

It has been excluded from Western financial markets, most of its oligarchs are sanctioned, and it is experiencing problems sourcing some items such as microchips

Russia has defaulted on its foreign bonds for the first time since the calamitous months following the 1917 Bolshevik revo-

lution.

The invasion and Western sanctions on Russia led to steep rises in the prices of fertiliser, wheat, metals and energy, fuelling an inflationary wave and a global food crisis.

Russia is the world's second largest oil exporter after Saudi Arabia and the world's biggest exporter of natural gas, wheat, nitrogen fertiliser and palladium.

Shortly after Russia's invasion of Ukraine, international oil prices spiked to their highest levels since the records of 2008. **WESTERN WEAPONS**

Since the invasion, the United States has committed more than \$43 billion in security assistance to Ukraine, including stinger anti-aircraft systems. Javelin anti-armour systems. 155mm Howitzers and equipment to protect against chemical, biological, radiological and nuclear attack.

The biggest overall supporters of Ukraine in nominal terms are the United States, the European Union, Britain, Germany and Japan, according to The Kiel Institute for the World Economy.

Shortcomings in Khan judgement: Pak chief justice

Islamabad, August 23: Pakistan's Chief Justice Umar Ata Bandial Wednesday said there were "shortcomings" in the Toshakhana corruption case judgment convicting former premier Imran Khan and the Supreme Court would give its verdict after seeing the outcome of the hearing in the high court.

On August 5, a trial court in Islamabad found Khan guilty of "corrupt practices" in a case pertaining to concealing details of state gifts and sentenced him to three years in prison.

New Delhi: Billionaire Gautam Adani's conglomerate clocked a 42 per cent year-on-year growth in pre-tax profit, as businesses ranging from airports to power and sea ports registered impressive growth, the group said Wednesday. All-time high EBITDA of ₹23,532 crore in April-June was almost equal to the full-year FY19 (April 2018 to March 2019 fiscal year) EBITDA of ₹24,780 crore, Adani group said in a statement. The conglomerate that spans 10 listed companies ranging from flagship incubator Adani Enterprises Ltd to ports business (Adani Ports & SEZ Ltd), renewable unit (Adani Green Energy Ltd), power utility (Adani Power Ltd). electricity transmission firm (Adani Energy Solutions), and city gas business (Adani Total Gas Ltd), had a net debt of ₹18,689.7 crore after accounting for a cash balance of ₹42,115 crore.

CCI closes case against Tata arm

New Delhi: Competition **Commission Wednesday** closed a case against Tata Motors on alleged abuse of dominant position with respect to agreements with its authorised dealers. For the case, the market for the manufacture and sale of commercial vehicles in India was considered as the relevant one. The complaint was filed against Tata Motors, Tata Capital Financial Services and Tata Motors Finance. In May 2021, the regulator ordered the Director General (DG) to carry out a detailed probe into the allegations. DG, the investigation arm of the regulator, had submitted its report in September 2022. In its 32-page order, the CCI said it is unable to agree with the finding of the DG that Tata Motors coerced its dealers to offtake vehicles as per the company's demands.

India may ban sugar exports

Mumbai, August 23: India is expected to ban mills from exporting sugar in the next season beginning October, halting shipments for the first time in seven years, as a lack of rain has cut cane yields, three government sources said.

India's absence from the world market would be likely to increase benchmark prices in New York and London that are already trading around multi-year highs, triggering fears of further inflation on global food

"Our primary focus is to fulfil local sugar requirements and produce ethanol from surplus sugarcane," said a government source who asked not to be named in line with official rules. "For the upcoming season, we will not have enough sugar to allocate for export quotas.'

India allowed mills to export only 6.1 million tonne of sugar during the current season to September 30, after letting them sell a record 11.1 million tonne last season

In 2016, India imposed a 20% tax on sugar exports to curb

Monsoon rains in the top cane growing districts of the western state of Maharashtra and the southern state of Karnataka which together account for more than half of India's total sugar output - have been as much as 50% below average so far this year, weather department data

Patchy rains would cut sugar output in the 2023/24 season and even reduce planting for the 2024/25 season, an industry official, who declined to be named.


Mumbai, August 23: Top Indian states' spending on social welfare is set to touch a 10-year high of ₹4 lakh crore, or 1.7 per cent of their combined GSDP, in the ongoing fiscal, a domestic rating agency said in a report Wednesday.

After analysing budgets of top 11 states, which account for over three-fourths of the aggregate Gross State Domestic Product (GSDP), Crisil Ratings said the growth in social welfare schemes is expected to clock a 16 per cent jump in compounded annual growth rate between 2017-18 and 2023-24.

The revenue receipts grew by 11 per cent during the same period, Crisil said.

Maharashtra, Gujarat. Karnataka, Tamil Nadu, Uttar Pradesh, Telangana, Rajasthan, West Bengal, Madhya Pradesh, Andhra Pradesh and Kerala were the 11 states accounted for in the Crisil report.

It said the share of social welfare schemes in the non-committed expenditure stood at 10 per cent in FY18.

The growth in expenditure on social welfare schemes at 16 per cent per annum is higher than the 12-13 per cent growth in expenditure on healthcare between FY18 and FY24, which witnessed the Covid-19 pandemic, the agency said.

Revenue receipts have grown at a moderate 10-11 per cent per annum between FY18 and FY24, resulting in continuing revenue deficits for the states, the agency said.

Crisil Director Aditya Jhaver advocated for higher capex allocation towards education and health, saying it has a relatively higher impact on uplifting revenue and productivity for states in the near- to medium-term.

Aldrin qualifies for finals

INDIAN LONG JUMPER **REACHES MAIDEN** FINALS AT THE WORLD CHAMPIONSHIPS, WHILE SREESHANKAR **SUFFERS SHOCK EXIT**

Budapest, August 23: National record holder long jumper Jeswin Aldrin qualified for his maiden World Athletics Championships finals but fellow competitor Murali Sreeshankar made a shock exit at the qualification round after his worst performance of the season here Wednesday.

Javelin thrower Annu Rani, also a national record holder but struggling for form for some time, produced her second worst performance of the season with a 57.05m effort to crash out in the qualification round after finishing 11th in Group A and 19th

The 21-year-old Aldrin, who entered the showpiece as season leader with his 8.42m national record effort in March. cleared 8.0m in his first attempt and fouled his next two jumps. But that was sufficient for him to make it to the 12-man final to be held Thursday.

Those who cleared automatic qualification distance of 8.15m or top 12 from the two qualification groups made it to the finals. Aldrin, who finished sixth in Group B qualification round, was the 12th best performer overall and made it to the finals as the last qualifier.

Wednesday, he became the second Indian male long jumper to qualify for the finals in the showpiece after Sreeshankar, who had finished seventh in the 2022 World Championships in USA.

The 24-year-old Sreeshankar had a disappointing series of 7.74m, 7.66m and 6.70m as he finished 12th in Group A qualification round and 22nd overall. His exit in the qualification

For Aldrin, this was his second appearance in the World Championships. He had crashed out at the qualification round in the 2022 edition in USA.

In a rare feat, two Indians Aldrin and Sreeshankar – had entered the Championships as first and second ranked long jumpers in the season leaders' list.

Aldrin has been struggling to touch the 8m mark after his big iump early in the season. He had also faced fitness issues, which led to him missing the Asian Championships in July. His most recent outing was at the CITIUS Meeting in Bern, Switzerland which he won with 8.22m.

The competition witnessed some dramatic moments with Olympic champion Miltiadis Tentoglou of Greece and defending champion Wang Jianan of China finding themselves in danger of missing out on the finals before making the grade with their third and final jumps of 8.25m and 8.34m respectively.

Young Jamaican national champion Wayne Pinnock, 22, stunned the Budapest crowd with a 8.54m new world leading jump in his first attempt in Group A qualification round. He did not take any further jumps.

Asian champion Lin Yu-Tang of Chinese Taipei also missed the final round with a best jump of 7.45m while reigning Commonwealth Games gold medallist LaQuan Nairn of Bahamas recorded a 'No-Mark' after three foul jumps.

Indian athletes have disappointed so far in the World Championships here. On the opening day Saturday, national record holder 3000m steeplechaser Sable failed to qualify for the final round after finishing a disappointing seventh in his heat race.

National record holder 100m hurdler Jyothi Yarraji failed to qualify for the semifinals Tuesday as she finished seventh in her heat. She clocked 13.05 seconds well below her national record

India secure gold, bronze at Worlds

Baku, August 23: Amanpreet Singh won the men's 25m standard pistol to give India their fifth gold medal in the ongoing Shooting Championship here Wednesday, even as the women's standard pistol trio picked up a bronze in the team competition.

The country has so far won five gold and four bronze medals, moving back up to second position on the medal tally behind China, who leads with 24 podium finishes, 13 of them being gold.

Amanpreet shot 577 in the men's standard pistol, a clear three points ahead of silver-winning Korean Lee Gunhyeok, who shot 574. Kevin Chapon of France won bronze with the same score as Lee's but with lesser inner 10s than the Korean.

Speaking to a weekly news magazine, Anand was quoted as saying that he was amazed by the fact that most of the current lot possesses a 2,700-plus Elo rating, especially below 20 years of age, terming it "special". "I'm throwing in the title early,
