#### **GITA MEHTA'S FUNERAL HELD**

Bhubaneswar, Sept 18: The mortal remains of Gita Mehta, the 80-year-old elder sister of Odisha Chief Minister Naveen Patnaik, were consigned to flames at Lodhi Road Crematorium Ground in Delhi Monday, Naveen Niwas sources said.

Gita's son Aditya Singh Mehta lit the funeral pyre in the presence of Patnaik, his businessman brother Prem Patnaik and other relatives. Many Odisha leaders including MPs and MLAs were also present at the crematorium.

People from different walks of life paid their last respects to her at Patnaik's residence on Abdul Kalam Road. Senior BJD leader and family friend AU Singhdeo and BJP national vicepresident Baijayant Panda also paid their tributes to her at the crematorium.

Gita Mehta, daughter of legendary Biju Patnaik, passed away at the age of 80 due to old age ailments Saturday.

New Delhi, Sept 18: Prime Minister Narendra Modi Monday paid tributes to "every brick" of the old Parliament building and said MPs will enter the new building with "new hope and confidence".

In his over an hour-long speech in the Lok Sabha, Modi remembered the journey of India's democracy and said the last day in this heritage building should be dedicated to the over 7,500 parliamentarians who served in this building since Independence. Parliament will shift to the

"Today, we are taking leave from this historic building. Before Independence, this was the Imperial Legislative Council and after Independence, it became the Parliament building," he said.

"We may go to the new building but... This building will always continue to inspire the coming generations. This is an important chapter in the golden journey of India's democracy," the Prime Minister said, adding that the memories of the old Parliament House belong to everyone.

Modi also recalled his first day in the Parliament House. 'When I became a Member of Parliament for the first time and entered this building... I naturally bowed my head before I set foot inside the door of this Parliament House, paying homage to this temple of democracy," he said.

"That moment was full of emotions for me, I could not have imagined but it is the strength of Indian democracy, it is a reflection of the faith of the com-

#### 'EC Appointments Bill may not be tabled'

he government may not push for passage of the Bill on appointment of CEC and election commissioners in the five-day session of Parliament that began Monday, sources said amid criticism of its provisions including by the Opposition and former chief election commissioners. They said one view within the government is to refer the Bill to the standing committee on law and justice. The Bill was introduced in Rajya Sabha by Law Minister Arjun Ram Meghwal August 10. Some former CECs, including N Gopalaswamy, VS Sampat and SY Quraishi, had Saturday written to the Prime Minister opposing the provision to equate the CEC and the ECs to the cabinet secretary.



The 1937 artwork, sold here Saturday at Saffronart's 'Evening Sale Modern Art', was among the 70 plus art pieces by eminent artists including MF Husain, VS Gaitonde, Jamini Roy and FS Souza, featured in the

It was only last month that Raza's 1989 Gestation, also an oil-on-canvas painting, was sold at ₹51.75 crore by Pundole's auction house in Mumbai, becoming the most expensive Indian artwork ever sold at auction.





# **Scrub typhus: Health teams** in Bargarh, Sundargarh dists

Bhubaneswar, Sept 18: The Odisha government has sent two health teams to Bargarh and Sundargarh districts to inquire into the deaths due to scrub typhus infection, an official said Monday.

So far, six people have died of such infection in the two dis-

"There are some discrepancies in the scrub typhus death cases because the deceased had neither gone through proper testing nor treatment at any government facility. So, we have to collect details about the tests conducted and their symptoms,' Public Health director Niranjan Mishra said. The teams will investigate the types of testing that were made in private hospitals and how the deaths occurred, he said. "Several private hospitals are conducting the

kit test, which is not confirmatory. ELISA test is the right method to detect the disease,'

the director said. According to health officials, five scrub typhus deaths have been reported in Bargarh district, while one person succumbed to the disease in Sundargarh. Scrub typhus infection spreads through bites of infected chiggers (larval mites).

The Health department has engaged accredited social health activists (ASHA) and auxiliary nurse and midwife volunteers to spread awareness about the disease. People, who frequently visit farmland or forests, are vulnerable to the infection.

The most common symptoms of scrub typhus include fever and a black inflamed mark on the skin called 'eschar'.

Bhubaneswar, Sept 18: The Economic Offences Wing (EOW) Monday conducted searches at the office of Eastern Media Limited in Rasulgarh area here in connection with a case of loan fraud, cheating, forgery and criminal intimidation against the proprietor and employees of the media house lodged by a former employee.

A 12-member team of the EOW, along with officials of Commissionerate Police, began searches at the office of Eastern Media Limited in the afternoon. The sleuths reportedly questioned the Human Resource (HR) head of daily Sambad and other staffers in the accounts section of the media house.

Meanwhile, in a press note, the EOW stated that a case (24/23) under IPC Sections 506, 467, 468, 471, 420 and 120-B has been registered against owner of the media house,

Soumya Ranjan Patnaik and others on the basis of the complaint lodged by Asim

Mohapatra, an ex-employee of Sambad/ Eastern Media Limited. 'The case has been registered

on the allegation that large number of employees of Sambad were forced to take personal loans under threat. The loan amount, running into crores, was not given to the employees concerned but allegedly used by their employer company,

Mohapatra in his complaint alleged that he was forced by the accused persons to sign on some bank loan forms against his will and paying capacity. The victim reportedly

ioined Sambad in 2015 as a district correspondent at a salary

Mohapatra was allegedly threatened that he would lose his job if refused to avail the loan. The accused persons allegedly made him sign many blank forms/documents in cluding some blank cheques.

"At that time he did not know the details but later came to know that a loan of Rs 5 lakh was it was used by Sambad/ Eastern Media Limited, Bhubaneswar. He did not get a single penny out of this loan. He was forced to sign for such loans on two different occasions in two different banks," claimed EOW.

Around 300 employees of Sambad/ Eastern Media Limited have allegedly been forced to sign on forged documents and about Rs 50 crore have thus been fraudulently secured by Soumya Ranjan.

"So far 15-20 ex-employees of Sambad have come forward with complaint of such forceful loans taken against their names using forged documents," EOW said, adding that many incriminating documents have been seized during the search.

# Bystanders less likely to give women CPR: Study

tients with an average age of 67. They looked at whether or not a bystander performed CPR, where the emergency took place, and the age and gender of the patient. The team found that only around half of patients received CPR from a bystander (54 per cent). Overall, women were slightly less likely to be given CPR (52 per cent of women compared to 55 per cent of men).

However, when the researchers looked only at cardiac arrests that happened in a public place, such as the street, the difference was greater (61 per cent of women compared to 68 per cent of men).


These lower rates of CPR in public were found in women regardless of their age, according to the researchers.

When they looked at cardiac arrests that happened in a private setting, such as a home, the data indicated that with every ten-year increase in age, men were around 9 per cent less likely to be given CPR during a


cardiac arrest. For women having a cardiac arrest in a private setting the chances of receiving CPR were around 3 per cent lower with

every ten-year increase in age. "Our study shows that women experiencing a cardiac arrest are less likely to get the CPR they need compared to men, especially if the emergency happens in public," Cournoyer said.

Bhubaneswar, Sept 18: A low pressure area (Lopar) is likely to form over north-west Bay of Bengal (BoB) and neighbourhood in the next 48 hours, IMD sources said Monday, predicting rainfall in several districts of the state for the next four days.

#### **Two U-Turns in Three Years**

In 2016, the Union Ministry for Environment made public a draft of the new forest policy. However, the government later disowned the draft after it received strong criticism for disregarding the rights of tribals and forest dwellers, which had already been legalised in 2006 by the Forest Rights Act. Additionally, the draft was criticised for making corporates' entry into forests easier.

Amid the cloud of uncertainty and policy vacuum, Lallu Singh, a parliamentarian from the ruling Bharatiya Janata Party, asked the ministry in 2017 if they had decided to have a new forest policy and when it was planning to do so. Without giving any time frame, then environment minister Vardhan informed Parliament that his ministry had tasked the Indian Institute of Forest Management in Bhopal to prepare a draft of the National Forest Policy. The institute had submitted it but the ministry



was yet to finalise it. The Centre assured Parliament that it was in the process of finalising the

new forest policy. Unlike elsewhere, ministers are held to their words given on the floor of the House. An assurance given to Parliament has to be implemented within three months, according to the Manual of Parliamentary Procedures in the Government of India. If the ministry or government department is unable to complete its job in time, it has to seek an extension. In cases where the government fails to implement its assurance, it has to request the Committee on Government

Assurances to drop it. This 15-member committee scrutinises ministerial promises, assurances and undertakings in Parliament and reports to Lok Sabha on their implementation within the stipulated

The Union government drew up another draft national forest policy in 2018. This too, repeated the transgressions of the previous one and prioritised the interests of the private sector over the rights of tribal and other forest-dependent communities. The government later went quiet on this draft policy as well.

Faced with setbacks twice, the government tried to wriggle out of the commitment. In 2019, the government asked the Parliamentary committee it not he held to its assurance to have a new National Forest Policy The committee did not agree.

The Modi government set out, for the third time, to see through a forest policy. In May 2020, the Union Environment Ministry prepared a cabinet note, a formal document outlining the policy proposal for which it is seeking approval, on a new forest policv and submitted it to the cabinet secretary, the senior most bureaucrat of the Union government reporting to the Prime Minister. But the Cabinet Secretariat, for reasons unknown, returned the note in September 2021, asking the environment ministry to revise it. The environment ministry did not bother

Instead, it again asked the committee on assurances in 2021 that it be relieved of its commitment. The committee, once again, rejected the ministry's request and "emphasised the need to safeguard ecological bal-

ance and livelihood (sic) security of people and future generations based on preservation, expansion and sustainable management of forests and recommended that the assurance be brought to its logical end".

The Committee, in its report tabled in the Lok Sabha in December 2022, reprimanded the Centre for not fulfilling its assurance to bring in a forest policy even after a lapse of five years. It said that after directing the ministry to "pursue the matter vigorously", it "could have made concerted and coordinated efforts at least from 2020 onwards to expedite implementation of this Assurance, which has not taken place unfortunately".

#### Pending Assurances, a watered-down regime

The ministry of environment has against its name a long list of assurances that it broke or dragged on inordinately. The Committee on Government Assurances (2022-23) noted that there were 49 such assurances from the ministry that were pending implementation. Of these, 40 assurances were made in the current Lok Sabha, six in the 16th Lok Sabha elected in 2014 and the remaining three were given to the House elected after the 2009 elections.

Since the delay ranged from three to 11 years for 9 assurances given by the 15th and 16th Lok Sabha, the committee had sought clarity on how the ministry planned to fulfil the promises it made.

While the ministry said that it prioritised its assurances, it informed the committee that there was no fixed timeframe and frequency of meetings to review pending assurances. They also said that they had been "trying to conduct regular reviews since last one or two months'

The Committee looked at 21 of

the 49 pending assurances. These were on forest policy, amendments to environment and biodiversity laws, river zone regulation, coastal management. regulation on hunting, and conservation of Western Ghats among others. Though the government implemented 14 of the 21 pending assurances, the promise of a new national forest policy continued to be on the back burner.

But the government hadn't exactly given up. They over the years began deconstructing the contentious elements of the policy draft and patching them on to the fabric of existing laws without a policy in place to be held accountable to. As part of the manoeuvre, by August 2023, the government brought in wholesale changes to a key forest law. The amended Forest Conservation law aligns with disputed provisions in the 2016 and 2018 draft National Forest Policy.

The Centre's communiques show that it relies in principle on the 2018 draft policy even though it wasn't officially finalised. A Press Information Bureau press release from July 2023 reads: "Ministry has formulated draft National Forest Policy after wide consultations with various stakeholders, including inter-ministerial consultations, and placed in public domain in 2018. The draft Policy recommends to integrate climate change mitigation and adaptation measures in forest management including resilience to climate change by forest-dependent communities".

# Ganjam road mishap deaths spark concern

Chhatrapur, Sept 18: There is no let-up in deaths on roads in Ganjam district with the region witnessing a 1.31 per cent rise in accident related deaths from January to June this year as compared to the corresponding period of last year, a report said.

THE NHAI AUTHORITIES NOT RISING ROAD FATALITIES

1.31 per cent rise in road accident deaths from the start of this year till the month of June in comparison with that of the last vear. On the other hand, there has been a 12.27 per cent decline in number of road accidents from January this year till the month of June. The rising deaths amid decline in accidents have raised concern among the residents as well as road safety enforcement authorities of Ganjam.

The National Highways Authority of India (NHAI) authorities not abiding by the decisions taken in the meeting of the district road safety committee is said to be the primary reason behind rising road fa-

For instance, though the committee had decided to install a signage on Khallikote ghati on National Highway-16 and issued necessary instructions to NHAI authorities in this regard at a meeting held February 27, 2023, the NHAI authorities, despite their assurance, are yet to execute it. The Supreme Court led road safety committee also expressed its displeasure over the issue.

Meanwhile, directions have been issued to conduct an audit of the NH-16 and complete it within three months. Engineering errors in highway construction and necessary places to put up signage will find place in the audit with special focus on Khallikote ghati on the highway.

The meeting also directed to put up necessary signage on national and state highways and mark accident-prone zones as black spots and take necessary steps.

The review meeting found plantation alongside the NH-16 as quite discouraging. The NHAI and PWD officials were asked to install streetlights on busy stretches and ghati roads of the

The meeting also decided to work out a standard operating procedure and take necessary steps accordingly to reduce road accidents and deaths. The meeting decided to intensify enforcement activities as deaths involving twowheelers are increasing by the day.

# Shifting cultivation bane of orange farming in Gajapati

Gumma, Sept 18: Orange cultivation in Ajaygarh and Serang panchayats under this hill-locked and forested block in Gajapati district is on the wane with farmers turning

away from the cultivation and taking to shifting and cashew cultivation, a re-Environmentalists, however, rued

the atmospheric pollution caused by the shifting cultivation in the area, and loss of nutrients in the soil due to massive cashew farming.

They said that orange cultivation in Ajaygarh and Serang panchayats are on the decline despite conducive atmosphere for the produces. In past, orange farmers used to reap a bumper harvest but now the farmers are turning away from the cultivation after being drawn towards shifting and cashew cultivation.

Observers said that the government should step in and sensitise the farmers about the benefits and earnings from orange cultivation. They should be provided with enough orange saplings

Farmers of these two panchayats should be apprised that they should not depend on cashew and shifting cultivation which give less harvest and income, said the locals, adding they should rather take up orange cultivation which will

fetch them good earnings. This will also help in conservation of traditional orange cultivation, they added.

Residents Suresh Bada Dalai, Maliya Paika, Debendra Pradhan, Rupa Sabar, Nohar Gamango, Elia Sabar and Kartik Gamango said the cultivation of a much sought after fruit like orange, if produced in the area, would augment the earnings of the local farmers while people in the state can get the fruit at a cheaper

Intellectuals of the locality said orange cultivation will benefit farmers and local residents if the state government provides incentives for the same

When contacted, block horticulture officer Dillip Dingal said plans are afoot for cultivation of orange on 70 hectare of land in Adhei, Balmunda, Gira, Tibisingh and Luhara villages under the two panchayats during 2020-24 crop years.





# Hostage Diplomacy

hina's diplomatic manoeuvrings and successes in the Middle East seem to have forced the US not to waste any more time and cement its ties with Iran. The Biden administration does not appear to have been nettled by critics in the Republican Party who have accused it of bartering away US interests. Confronted with an unprecedented crisis of legitimacy at home, the Islamic Republic of Iran is relying heavily on its strategy to use hostages to ease its economic crisis. The policy is characterised by its use of foreign prisoners to extract concessions from the West. The latest success of this is the agreement reached with the US mediated by Qatar. The agreement involves a prisoner exchange and the release of \$6 billion of Iranian funds, frozen in South Korea due to US sanctions. The money in Iranian assets - the proceeds of oil sales – were frozen under sweeping US oil and financial sanctions against Iran. Then president Trump in 2018 reimposed the sanctions when he pulled Washington out of a deal under which Iran had restricted its nuclear programme.

On September 11, Washington declared it was putting in place exemptions to assure the banks, involved in this money transfer, that they would not be placed under sanctions. The \$6 billion, which are to be transferred to Qatari banks, are intended to be used to buy food and medicine which are in short supply in Iran fuelling widespread resentment among the populace. Iran desperately needs the money to stave off the snowballing economic crisis that has been compounded by the regime's draconian treatment of the country's women fighting against medieval social taboos imposed on them by the leadership.

For its part, Tehran released five Iranian-American prisoners from Evin prison, north of Tehran, and placed them under house arrest on August 10. They will be exchanged for five Iranians imprisoned in the United States. Of these, four were tried in US courts and sentenced to prison for violating sanctions against Tehran's nuclear programme, or for attempting to send sensitive equipment and provide military information to Iran. US Secretary of State Antony Blinken called the move the first step of a process that would lead to their return home.

At the centre of the negotiations that forged this deal between the superpower which Iran brands as the "Great Satan" and the Islamic Republic which Washington calls a state sponsor of terrorism is the hugely rich state of Qatar. It hosted at least eight rounds of talks involving Tehran and Washington negotiators who were, funnily enough, sitting in separate hotels and speaking via gadgets as reported by media

Qatar will implement a financial arrangement under which it will pay banking fees and monitor how Iran spends the unfrozen cash to ensure no money is spent on items under US sanctions and the prisoners will transit Qatar when they are swapped. Iran initially wanted direct access to the funds but in the end agreed to having access via Qatar.

That Iran has gained some measure of credibility among US allies is apparent from the fact that South Korean foreign minister Park Jin said efforts were under way to transfer Iran's funds back to that country. The US-Iran relationship is not characterized by trust. Yet the US, under Biden, is now ready to judge Iran by its actions as indicated by the State Department

Interestingly, the deal sidestepped the main US-Iran dispute over Iran's nuclear aims, culminating in a rare show of cooperation between the long-time adversaries. They had been at daggers drawn on a host of issues from Iran's nuclear programme to the US military presence in the Culf

Ties between the US and Iran soured when Donald Trump quit a nuclear deal with Iran as US president in 2018. Reaching another nuclear deal has slipped out of Biden's agenda as he prepares for the 2024 US election.

However, there has not been much change in Washington's overall approach to Iran marked by deterrence, pressure and diplomacy. Once the funds are transferred, they will be held in restricted accounts in Qatar and the US will have oversight as to how and when these funds are used so as to forestall any attempt by Iran to divert them to purposes other than humanitarian.

The transfer of funds plan has drawn Republican criticism that Biden, a Democrat, is in effect paying ransom for US citizens. But, the criticism is not wholly justified as the Biden administration has made it clear that the deal does not mean that Iran would be getting any relief from sanctions.

The US claims it would continue its policy against Iran's "destabilising" activities in the region. It has only toned down its antagonism towards Iran in the backdrop of China's friendly policies in the Middle East that has been instrumental in making sworn enemies in the region friends. Hopefully this arrangement will continue until the coming presidential election. There will obviously be a re-look at the Iran policy after the election if power changes hands.

#### ■ Nit-picking

he phrase comes from the task of removing the tiny eggs of lice (nits) from someone's hair and clothing, a tedious activity that required close attention and care. The word nit, which could also refer to the eggs of other insect parasites such as fleas, has been around in the language for as long as we have records (it appears in Old English around 825 as hnitu, but it has relatives in most European languages and has been traced back to an Indo-European root, so ancient has been the association of such pests with human beings). But what seems a little odd is that the figurative sense of nit-picking, of petty criticism or fault finding, is modern. The Oxford English Dictionary records it first only in 1951, in the form nit-picker, in this helpful explanation from Collier's: "Two long-time Pentagon stand-bys are fly-speckers and nit-pickers. The first of these nouns refers to people whose sole occupation seems to be studying papers in the hope of finding flaws in the writing, rather than making any effort to improve the thought or meaning; nit-pickers are those who quarrel with trivialities of expression and meaning, but who usually end up without making concrete or justified suggestions for improvement". The first of these two slang terms has died out, with the second taking on much of its meaning. Why it took so long for this expressive figurative sense to appear is a small mystery. Perhaps we had to wait for a time when the memory of the finicky nature of the task was still current, but when the need for it in industrialised countries had been greatly reduced through better hygiene and insecticides. Or perhaps the image came not from humans, but from some natural-history programme about our simian relatives, who spend much of their time literally nit-picking as part of grooming.

ndia's official inflation rate for August is 6.83%, down from 7.44% the previous month. It is still above the 6% maximum rate which is the red line for the Reserve Bank of India. Ever since the monetary policy shifted to inflation targeting in 2016, the permissible band of inflation is between 2 and 6%, for the consumer price index (CPI). This is the seventh time in the past 12 months that the monthly inflation rate is above 6. Would that not be disconcerting to the RBI's Monetary Policy Committee (MPC)? They need to tighten money supply further to reduce inflation. But they have chosen to keep the interest rate unchanged, hoping that inflation will come down by itself. The RBI Governor too has indicated that inflation will remain high for some time.

India's CPI consists of a weighted average of around 450 different items in the consumption basket (different for rural and urban consumers). But almost 49% of the weight goes to food and related items. Hence if food inflation is high naturally the overall inflation is high. Food inflation which has a weight of nearly 49% is currently running at 10%, thanks to rising prices of vegetables, oilseeds, pulses, milk and even cereals. India has used a combination of banning exports or putting a hefty export tax on a variety of agricultural products. These include wheat, rice, sugar and onions. This affects the earnings of farmer's who were eyeing lucrative profits from exports. For instance, India exported 7.4 million tonnes of parboiled rice in 2022 but now there is a stiff 20% export duty in place. India accounts for 40% of the world's rice exports, and thanks to India's curbs, this has created additional scarcity in the world. The export curbs from India have affected importing countries like China, Philippines, Bangladesh, Indonesia and Nigeria. In Philippines a minister might have to resign due to the steep prices of rice. Has the ban or export tax reduced rice inflation

in India? Not really, because apparently the broken rice (on which the export tax applies) is headed for ethanol production. Using food to create fuel for cars is a controversial policy especially when the world is experiencing high food inflation. The FAO's all rice price index rose by 9.8% in August and is now at a 15-year high. Such inflation is bound to seep into India. The ethanol policy is motivated by trying to save precious dollars which we spend on the import of crude oil. But if domestic food inflation is the price to pay we have to think carefully about using food crops

for fuel production. Going beyond food inflation, the outlook for crude oil is also anticipating high prices. Due to supply cuts by Russia and Saudi Arabia, oil prices have already crossed 85 dollars, and will stay high. Since this affects India's imports adversely, there is a possibility that the Indian rupee will further decline from 83 to 85. Oil imports bill can only be beaten by more than expected exports of software and IT services. This is easier said than done, since there is a palpable slowdown in the software sector. Of course, the medium to long term outlook for India's software services remains very strong, as indicated

by NASSCOM, the industry

Apart from food inflation, oil prices and a slipping rupee-dollar exchange rate, one major contributor to the inflationary trend is the size of the fiscal deficit. India is running a high deficit, and its national debt is also rising. All attempts at controlling the deficit seem to be futile. Of course, during the pandemic, the deficit had to rise, since the government had to use emergency rescue measures in terms of free food, subsidised loans and ample liguidity. But some decisions can raise eyebrows. For instance, the free food grain scheme now running for more than 48 months, is costing the exchequer cumulatively 4.5 lakh crores. The cabinet recently announced the 1.7 trillion revival package for the debt-ridden telecom company Bharat Sanchar Nigam Limited. In the past seven years, as per an answer to a Parliamentary question, nearly Rs 15 trillion worth of bad loans have been written off by public sector banks. This has fiscal implications, since equity capital has to be infused into the banks by the Central government. The write-off could be one contributory factor leading to the lower bad-loan ratio and improving health of the banking sector. But what cannot be denied is that fiscal spending is too stretched and leading to inflationary pressure.

India's fiscal situation is more dire than is acknowledged. If we compare the debt service ratio, i.e. how much of the government's revenue goes simply to pay interest on the rising debt mountain, India is way above the median for all countries. Due to the high deficit, the interest rate tends to remain high, leading to a disadvantage for crucial sectors like housing, real estate and indeed all the industrial projects. India tried very hard to curtail deficit spending tendency, by trying to make it illegal to exceed a certain limit. The Fiscal Responsibility legislation passed by Parliament in 2003 made it illegal to exceed 3% of GDP as the fiscal deficit limit. The stark reality is that in not even a single year has India not breached this limit. So much so that the FRBM law has been rendered toothless. A review of the law was conducted just before the pandemic and that too won't be of much use, since debt and deficit levels are far above what

is healthy for the economy. It is true that in a noisy and competitive democracy there is a clamour for more spending by vocal groups and vested interests. On top of this there is the increasing tendency to offer freebies. Plus, the new industrial policy which offers schemes like Production Linked Incentives and also protection from imports. All of these measures, for good or bad, have fiscal implications, which not only jeopardise sustainability of debt and fiscal stance, but also add to inflationary pressures. The large and heavy overhang of India's perennial fiscal dominance (and burden) cannot be undone merely by tightening the monetary policy. Even that is showing forbearance. The inflation fight is indeed a very difficult one in India.

# A tragedy is unfolding

he poorest countries are in desperate straits, and the rest of the world is looking the other way. Doing so comes easy, because low-income countries (LICs) matter little to the fate of the world in the near term. At the end of June, the combined GDP of the 28 countries in this group was roughly \$500 billion – a drop in the \$100 trillion ocean that is the global economy. The world's poorest countries are also nobody's ideal export markets: the average annual income is barely \$1,000, and conflict and instability are the norm for about half.

Nonetheless, 700 million people live in these countries, and about half of them are in extreme poverty. Very poor people have long been accustomed to neglect from their own governments, which often have other priorities. For example, they spend about 50% more on war and defence than they do on healthcare. Nearly half their budgets go toward public-sector wages and interest payments on debt, while a mere 3% of total government spending across LICs goes to support the most vulnerable citizens. That is onetenth the average for developing economies more broadly. It therefore should surprise

no one that a human tragedy is now unfolding in these countries. Key indicators of human development in today's LICs are far worse now than they were in the LICs of 2000, before many of the latter had ascended to middle-income status. For example, maternal mortality is 25% higher now, and the share of the population with access to electricity has fallen from 52% to barely 40% across this cohort.

Making matters worse, the odds of these countries getting help from abroad have declined. Wealthier countries have chosen exactly the wrong moment to become less generous. Even before the pandemic, foreign-aid flows to the poorest countries, especially in Sub-Saharan Africa, were slowing. Today, wealthier countries are redirecting more of their foreign-aid budgets to meet the surge of refugees arriving on their own shores.

Between 2011 and 2015, grants accounted for about one-third of government revenues in the world's poorest countries; but that share has since dropped to

less than one-fifth. Poor-country governments have made up the difference by going deeper into debt – and at punishing interest rates. Government debt-to-GDP ratios in these economies soared from 36% of GDP in 2011 to 67% last year – the highest level since 2005 (with the exception of 2020). Wealthier countries, and all

international financial institutions, should move decisively on three fronts. First, they must increase concessional financing for the poorest countries, with aid going to addressing emerging challenges such as climate change, economic fragility, and pandemics. Increased aid also will help these countries invest in critical sectors such as health, education, and infrastructure, which will enhance their resilience and growth potential. International financial institutions, for their part, can help crowd in private finance in sectors that offer the promise of both development and profits.

Second, debt restructuring must be accelerated. The Common Framework for Debt Treatment Beyond the DSSI has struggled to deliver relief ever since the G20 announced it nearly

three years ago. For many lowerincome countries, restoring longterm debt sustainability will depend on debt restructuring.

Finally, we must double down on the reform agenda by ensuring that global initiatives to bolster the poorest countries are complemented by ambitious domestic measures. International financial institutions can make a difference by helping LICs mobilise domestic revenues and improve spending efficiencies and debt management

and debt management.

Time is running out. The growing hopelessness among citizens of the poorest countries will feed a vicious cycle that is already underway. Desperate to escape misery at home, many will risk everything to find refuge abroad. The suffering of millions of people in faraway lands is not as far away as it may seem. It is contagious, and it is already spilling over national borders, with unpredictable global consequences.

#### Green Card backlog

Sir, This refers to "Ramaswamy vows to end H-1B visa programme," **OrissaPOST**, Sept 18. The complicated immigration topic comes to the forefront in almost every presidential election in US, but no major break through has happened yet. When it comes to the issue of employment based Green Card for about 4,00,000 Indian workers, the waiting period of staggering 195 years implies that there is no chance of getting it in one's lifetime, while spending the whole life working for US companies. However, the instrumental role played by Indian-Americans with significant heft in economic and political spheres is apparent. In this context, the demand by a group of US lawmakers, who urged the Biden administration to prioritise Green Card applicants from India, and reduce the wait period from 195 years in terms of the current backlog, is important too. Green Card barriers disproportionately affect Indian tech professionals who constitute a large chunk of the science, technology, engineering and mathematics (STEM) talent pool, playing a crucial role in maintaining Washington's competitive edge. Long delays are a vexing wrinkle in an otherwise blossoming relationship. This should be addressed at the earliest for it can erode goodwill accrued organically over decades.

# Annamalai draws flak for remarks on Annadurai

Chennai, Sept 18: The statement of BJP Tamil Nadu state president, K. Annamalai against the first Chief Minister of Dravidian ideology, CN Annadurai popularly known as Anna (Elder Brother) September 11 has led the saffron party to a difficult situation in Tamil Nadu. Annamalai while addressing

a protest programme against Hindu Religious and Charitable Endowments minister, PK Sekar Babu on his remarks against 'Sanatana Dharma' had made a statement against Annadurai also. tongue of those who speak ill of the late Chief Minister."

He also said, "In Tamil culture, no one speaks ill of departed people, including senior political leaders and added that the AIADMK leaders who had fervently criticized M. Karunanidhi while he was alive are speaking of respect about him.

Former ministers and AIADMK senior leaders, CV Shanmugham and D. Jayakumar have also come out against Annamalai on his comments against Annadurai.

CV Shanmugham, who was a former law minister in the AIADMK government of Tamil Nadu, said that the alliance between the AIADMK and BJP in Tamil Nadu was more necessary for the BJP than the AIADMK and not otherwise. He had also castigated the Yatra undertaken by Annamalai as a 'Vasool Yatra' which means "paisa collection yatra".

Lucknow, Sep 18: With the Lok Sabha elections approaching, the caste cauldron, as always, is on the boil in Uttar Pradesh - the only difference being that from caste it has gone on to sub-castes.

Political parties in Uttar Pradesh are unabashedly organising sub caste conferences, ignoring the 2017 Supreme Court order that said that "religion, race, caste, community or language would not be allowed to play any role in the electoral process'

The BJP which, till now, had put Hindutva on its priority list, is now wooing sub-castes from the OBC category with a vengeance.

The party apparently feels that addressing Hindus, in general, will not bring in adequate numbers in the elections.

The BJP has been holding subcaste conferences in Lucknow under the leadership of its OBC leaders including Deputy Chief Minister Keshav Maurya -- an OBC himself.

The Suheldev Bhartiya Samaj Party (SBSP) President Om Prakash Rajbhar is the new selfproclaimed leader of OBCs and is p[ushing the envelope to muster backward support for

The BJP is keen to wean away a part of the Samajwadi Party's vote base and also make a dent in BSP's following by wooing Most Backward Castes.

There are over 200 sub-castes

among the OBCs that constitute 40 per cent of the state's population. The OBC population is dominated by Yadays (15 per cent) and followed by Kurmis (9

per cent). The remaining sub-castes constitute one to two per cent of the population.

The BJP, till now, has held conferences for sub-castes that include Nishad, Kashyap, Bind, Kurmi, Yadav, Chaurasia, Teli, Sahu, Nai, Vishwakarma, Baghel, Pal, Lodh, Jat, Giri, Goswami, Jaiswal, Kalvar, Saini, Mali, Gangwar and even Halwai that has a population of .02 per cent.

The party is assuring these sub-caste groups that it would protect their interests.

A senior BJP functionary admitted that the party was keen to add on to its present vote base since that would make up for any depletion due to the antiincumbency factor.

"This is a conscious effort to

bring marginalised sections of society into the party fold. What is wrong if we are trying to expand our vote base?" said the functionary.

Seeing the BJP making a concerted effort to woo the sub-caste groups, the Samajwadi Party that had so far remained content with its Yaday vote bank, has also started reaching out to non-Yadav OBCs. Its slogan of PDA (Pichhda, Dalit, Alpasankhyak) is a manifestation of its new strategy.

Samajwadi Party spokesman

of Bids in the Portal Name and address of the Sunil Sajan, meanwhile, denied that the Samajwadi Party was following in BJP's footsteps.

"We are not holding sub-caste Sammelan like the BJP and becoming blatantly casteist in approach. We are holding social justice programme for OBCs in general," he said.

The Congress, so far, has avoided any such conferences.

# DMK hits out at Guv for remarks on social justice

Chennai, Sept 18: The ruling DMK in Tamil Nadu Monday hit out at Governor R N Ravi for his comments regarding social discrimination in the state, alleging he was unable to digest its governance model of inclusive development and accused him of launching a "false propaganda." At an event in Thanjavur

Sunday, Ravi had said there exists social discrimination in the society which was unacceptable. "We have untouchability, social

discrimination. A large section of brothers and sisters are not treated equal. It is painful, it is unacceptable. It is not what the Hindu Dharma savs. Hindu Dharma talks about equality," he said.

Those from the Scheduled Castes were once 'rishis' (sages) who contributed to the Vedas. There was no discrimination and it "crept in later," he claimed.

It is a social evil and must be eradicated, he said, adding saint Ramanajucharya dedicated his whole life towards eradicating

"Unfortunately in Tamil Nadu,

in our state this social discrimination is still a national problem. Every day I read in the newspaper, I get the report, I hear the story of our brothers and sisters from scheduled caste are not being allowed access to the temples. This is strange and I am surprised and shocked. Nowhere in India, no where in Bharat our young people have caste bands (on their wrist)," he said.

"Here in our state, our youth are wearing caste band-how shameful, how shameful that a state which talks so much about social justice, which makes so much politics about social justice but they have been exploiting the people in the name of caste, in promoting social discrimination. he charged

He pointed out incidents like the one at Vengaivayal, where "human excreta" was mixed in an overhead water tank catering to the local SC citizens and another at Tuticorin where locals refused to allow their children to have food prepared by a cook from the SC community in a school.

Such discrimination "is everyday affair," in Tamil Nadu, Ravi added.



"It is shameful, it has to be addressed by social consciousness and by social reform, not by pol-

itics of vote bank." he add Ravi also said the agenda of those talking about "eradicating Hindu dharma" was to "destroy the country and weaken it," in collaboration with certain elements.



New Delhi, Sept 18: The Lok Sabha panel on privileges Monday submitted a report recommending revocation of the suspension of Congress leader Adhir Ranjan Chowdhury from the Lower House.

The report was adopted by the Privileges Committee of the Lok Sabha on August 30 and Chowdhury's suspension was revoked by Speaker Om Birla on the same day. The Committee, in its report, said Chowdhury's conduct of frequently interrupting or disturbing the proceedings of the House during the speech of the prime minister or other ministers was a "clear case of 'contempt of the

"Nevertheless, in view of the regrets expressed by Shri Adhir Ranian Chowdhurv. Member of Parliament, during his evidence before the Committee, the Committee would recommend that no further punitive action is called for in the matter," said the report, tabled by Committee Chairman Sunil Kumar Singh.

'The Committee, therefore, recommends that the suspension suffered by Shri Adhir Ranjan Chowdhury so far, be regarded as sufficient punishment and the Hon'ble Speaker, Lok Sabha may consider discontinuance/revoking the suspension ... at the earliest, even without waiting for the House to reassemble for the forthcoming Winter Session November/December 2023," the report said.

The Congress leader was suspended from Lok Sabha on August 10 for "repeated misconduct", pending an investigation by the privileges com-

Bangalore, Sept 18: India's Aditya-L1 solar mission spacecraft has commenced collecting data that will help scientists analyse the behaviour of particles surrounding Earth, ISRO said Monday.

The sensors of an instrument on board India's first solar observatory have begun measuring supra-thermal and energetic ions and electrons at distances greater than 50,000 km from Earth, it said.

'This data helps scientists analyse the behaviour of particles surrounding Earth," the Bengaluru-headquartered national space agency said in a post on social media platform X. The Supra Thermal & Energetic Particle Spectrometer (STEPS) instrument is a part of the Aditya Solar Wind Particle EXperiment (ASPEX) payload. "These STEPS measurements will persist during the cruise phase of the Aditya-L1 mission as it progresses toward the Sun-Earth L1 point. They will continue once the spacecraft is positioned in its intended orbit", ĪSRO said.

Data collected around L1 would provide insights into the origin, acceleration, and anisotropy of solar wind and space weather phenomena, it said. STEPS was developed by the Physical Research Laboratory with support from the Space

Application Centre Ahmedabad.

ISRO had launched Aditya-L1 on September 2 using a PSLV-C57 rocket. The Aditya-L1 spacecraft carries a total of seven different payloads to study the Sun, four of which will observe the light from the Sun and the remaining three will measure in situ parameters of the plasma and magnetic fields. Aditya-L1 will be placed in a halo orbit around the Lagrangian Point 1 (L1), which is 1.5 million km from the Earth in the direction of the Sun.

It will revolve around the Sun with the same relative position and hence can see the Sun continuously. STEPS comprises six sensors, each observing in different directions and measuring supra-thermal and energetic ions ranging from 20 keV/nucleon to 5 MeV/nucleon, in addition to electrons exceeding 1 MeV. These measurements are conducted using low and highenergy particle spectrometers.

The data collected during Earth's orbits helps scientists to analyse the behaviour of particles surrounding Earth, especially in the presence of the magnetic field of Earth. STEPS was activated on September 10 at a distance greater than 50,000 km from Earth. This distance is equivalent to more than eight times the Earth's radius, placing it well beyond Earth's radiation belt region, ISRO added.

#### Apex court plea says $\pm$ Adani probe panel members conflicted

New Delhi, Sept 18: An expert committee, set up by the Supreme Court to probe allegations against the Adani group following a bombshell report from a US short seller, has members with potential conflict of interest, a fresh petition filed in the Apex court on Monday said.

The six-member panel in an interim report in May found no regulatory failure or signs of price manipulation in the rise and fall of the Adani Group's stocks, giving reprieve for the embattled conglomerate that lost close to USD 150 billion in market value following the Hindenburg report.

Petitioner Anamika Jaiswal claimed that former State Bank of India chairman OP Bhatt, who is part of the six-member expert committee, is conflicted as he is also the head of renewable energy firm Greenko, which has commercial dealings with the Adani group. The petition cited Greenko's

March 14, 2022, press statement announcing the supply of up to 1,000 megawatts of renewable electricity to Adani's proposed industrial complex. It also cited news of a partnership between the two being entered into in Davos.

"The above shows a clear conflict of interest of Mr OP Bhatt which... Ought to have been pointed out by Mr Bhatt himself," the petition said. The petitioner claimed that the CBI also examined Bhatt in March 2018 in a case of alleged wrongdoing in disbursing loans to the former liquor baron and fugitive economic offender Vijay ঽ Mallya, who is accused of defrauding banks, including SBI, of USD 1.2 billion.

Bhatt was the chairman of SBI between 2006 and 2011 when a majority of loans were advanced to Mallya's companies, the petitioner claimed.

# HOW THE JUDICIARY IS RESCUING A RIVER

...And quiet flows the Sabarmati, a river that became a sterling symbol of India's struggle for freedom and its folklore through association with the Mahatma and his ashram. As happens most of the time, lost in the glitter and glitz of an urban showcase edifice was the soul and substance of the river and its waters. That was, until a wake-up call came from the Central Pollution and Control Board(CPCB) which had ranked it as the second most polluted river in the country in its report of 2022. Lots of high pitched wailing and empty 'faffing' later, the Gujarat High Court stepped in.

The Sabarmati is a rain-fed river which originates from the Aravalli hills in Rajasthan and

meanders through Ahmedabad to end up in the Bay of Khambat (Cambay of old) and melt into the Arabian Sea after a 371 km journey. It would remain partially dry for most part of the year that is until it was linked up with water from the Narmada canal, upstream of Ahmedabad. Deliberately forgotten was that Gujarat had fought its entire case for 139 metres height of the Narmada dam to take waters to Kutch and Saurashtra and not splurge it enroute.

Though the development of a waterfront along the banks of the Sabarmati river in Ahmedabad had been proposed in the sixties, it was only in May 1997 that the Ahmedabad Municipal Corporation launched a Special Purpose Vehicle (SPV)



- the Sabarmati Riverfront Development Corporation Limited (SRFDCL) under Section 149(3) of the Indian Companies Act, 1956. The aim was to provide a green lung, reconnect the city with the river and positively transform the neglected aspect of the river-

After Modi took charge as Chief Minister, the project acquired a new-found impetus. It's an almost must visit port-of-

call after Modi took over as Prime Minister. But for all its showcasing, the river per se has been declared the second most polluted one in the country with CPCB deciding to upgrade it to "category-1" or critically polluted status. The BOD (Bio oxygen demand) in Sabarmati river was found to be 292 mg per litre.

It was in 2021 that the Gujarat High Court had taken suo moto notice and has been relentless thereafter in cracking down on the civic body and errant industries. "There should be no discharge of untreated water in the Sabarmati river from either of the outfalls", the Court had then observed.

In a hearing of the suo moto river pollution petition on Friday,

closed down textile units had pleaded for some relaxation in rules to allow them to re-open "We seek your intervention in asking the Gujarat Pollution Control Board (GPCB) to adopt a pragmatic approach", went the plea. "In this matter we will desist from doing so because we have adopted a pragmatic approach for years together and everyone is suffering because of it", said Chief Justice Sunita Agarwal. The directions were straightforward, 'Follow rules' The hearing continues. In fact all government bodies which had been looking the other way while pollution ran riot in the river have buckled up after the higher judiciary cracked the

whip of joint accountability.

#### China's Yi heads to Moscow

Beijing: China's top foreign policy official is heading to Russia for security talks after two days of meetings with US President Joe Biden's national security adviser over the weekend in Malta. Foreign Minister Wang Yi, who simultaneously holds the ruling Communist Party's top foreign policy post, will be in Russia from Monday to Thursday for a round of China-Russia strategic security consultations, the Foreign Ministry said in a brief statement. The US and China are at odds over Russia's invasion of Ukraine. China has refrained from taking sides in the war, saying that while a country's territory must be respected, the West needs to consider Russia's security concerns about NATO expansion.

#### US F-35 aircraft goes missing

Washington: A US Marine Corps fighter jet has gone missing in South Carolina after its pilot safely ejected the aircraft Sunday. The US military officials have appealed to the public to help locate the missing multimillion-dollar plane, the Guardian reported. Military officials said that a Marine Corps pilot safely ejected the F-35 Lightning II jet over North Charleston Sunday afternoon after a "mishap". Base authorities said they were searching, in coordination with federal aviation regulators, around two lakes north of the city of Charleston.

## No median line in Taiwan Strait: China

*In its latest military* provocation, Beijing flies record 103 military planes toward Taiwan in a new high of activity the island calls harassment

Beijing, Sept 18: China Monday dismissed the existence of a "median line" in the volatile Taiwan Strait after Taiwan's defence ministry said it detected a record 103 Chinese warplanes flying around the self-ruled island in a 24-hour period.

"First of all, this is not a question about foreign affairs. I suggest you refer to competent Chinese authorities for specifics," Chinese Foreign Ministry Spokesperson Mao Ning said without commenting on Beijing's latest military provocation.

"Let me say that Taiwan is

part of China's territory. There is no so-called "median line" in the Taiwan Strait," Mao asserted when a reporter sought her response to Taiwan's defence ministry's statement that 40 of the 103 Chinese People's Liberation Army warplanes crossed the "median line" on the Taiwan Strait in a 24-hour span between Sunday and Monday.

China views Taiwan - a democratically governed island of 24 million – as part of its territory, despite having never governed it.

The ruling Communist Party of China has long vowed that the island must be unified with the Chinese mainland, by force if necessary, while Taiwan strongly rejects China's territorial claims over it.

According to a flight map provided by Taiwan's defence ministry, 40 of the 103 Chinese warplanes crossed the "median line" on the Taiwan Strait and entered Taiwan's self-declared air



defence identification zone (ADIZ).

Those 40 incursions were made by 10 Su-30 fighter jets, 12 J-10 fighter jets, four J-11 fighter jets, 10 J-16 fighter jets, two Y-20 aerial refuelling aircraft, and two KJ-500 airborne early warning and control planes, it said.

The ministry said it had tasked combat air patrol aircraft, navy vessels and land-based missile systems to respond.

#### **US SHUTDOWN LOOMS** McCarthy faces crucial challenge

Washington, Sept 18: US House Speaker Kevin McCarthy is facing the biggest challenge of his eight months as the top Republican in the US Congress, as he tries to muster his fractured caucus to avoid a government shutdown in less than two weeks without losing his speakership.

The Republican-controlled House of Representatives and the Democratic-led Senate have until Sept 30 to avoid the US' fourth partial government shutdown in a decade by passing spending legislation that President Joe Biden can sign into law to keep federal agencies afloat.

But hardline activism on spending, policy and impeachment have split Republicans in the House and slowed the Senate's path forward on approving bipartisan spending legislation.

Political brinkmanship has begun to attract the attention of Wall Street, with rating agency Fitch citing repeated down-tothe-wire negotiations that threaten the government's ability to pay its bills when it downgraded US debt rating to AA+ from its top-notch AAA designation earlier this year.

# **US, Iran swap detainees**

Doha, Sept 18: Five US detainees flew out of Iran Monday in a swap for five Iranians held in the US in a rare deal between the arch enemies that also unfroze \$6 billion of Tehran's funds. Despite the deal, tensions are

almost certain to remain high between the US and Iran, which are locked in various disputes, including over Tehran's nuclear programme. Iran says the programme is peaceful, but it now enriches uranium closer than ever to weapons-grade levels. The planned exchange has un-

folded amid a major American military buildup in the Persian Gulf, with the possibility of US troops boarding and guarding commercial ships in the Strait of Hormuz, through which 20% of all oil shipments pass. A senior US administration

official said the deal did not change Washington's adversarial relationship with Tehran, but the door was open for diplomacy on Iran's nuclear programme. "If we see an opportunity, we

will explore it but right now, I've really nothing to talk about," the official said, speaking on condition of anonymity. Iran's Foreign ministry spokesperson Nasser Kanaani

said two of the Iranians being released would return to Iran while two would stay in the US at their request. One detainee would join his family in a third country. Kanaani said the funds, blocked in South Korea after US sanc-

## **UKRAINE RETAKES MORE TERRITORY**

Kyiv, Sept 18: Ukraine reported Monday its troops had recaptured more territory on the eastern front and advanced in the south in its military counteroffensive against Russian forces. Deputy Defence Minister

Hanna Maliar said Kyiv's forces had retaken two square km (0.77 square mile) of land in the past week around the shattered eastern city of Bakhmut, which was captured by Russian troops in May after months of fighting.

Kyiv's forces also recaptured two villages on the southern flank of the city, Andriivka and Klishchiivka, Maliar said.

Both cities lie on higher ground and their capture could set the stage to reasserting control over the pivotal city.



#### **NET DIRECT TAX COLLECTION RISES 23.5% TO OVER ₹8.65 LAKH CR**

New Delhi, Sept 18: The net direct tax collection increased 23.51 per cent to over ₹8.65 lakh crore till mid-September on higher advance tax mop-up from corporates, the Finance Ministry said Monday.

The net collections have reached 47.45 per cent of the full-year budget estimates (BE) of ₹18.23 lakh crore.

The steady growth in tax collection was helped by a 21 per cent growth in advance tax mop-up. September 15 was the last date for paying the second instalment of advance tax for 2023-24.

In a statement, the ministry said the net direct tax collection includes corporate income tax (CIT) at ₹4,16,217 crore and personal income tax (PIT), including Securities Transaction Tax (STT), at ₹4,47,291 crore.

The net direct tax collection of ₹8,65,117 crore for the current fiscal as of September 16 grew at over 23.51 per cent, the ministry said.

The advance tax collection stood at ₹3.55 lakh crore till mid-September, a 21 per cent growth against ₹2.94 lakh crore mopped up in the corresponding period

The welfare measures are related to the amendments to LIC (Agents) Regulations, 2017, Enhancement of Gratuity Limit, and Uniform Rate of Family Pension, among others, the finance ministry said in a state-Sharing the details, the state-

ment said the ministry has enhanced the gratuity limit from Rs 3 lakh to Rs 5 lakh for LIC agents aimed at bringing substantial improvements to the working conditions and benefits for them. It has also enabled the reap-

pointed agents to be eligible for renewal commission, thereby providing them with increased financial stability.

Currently, LIC agents are not eligible for renewal commission on any business completed under the old agency.

The term insurance cover for the agents has been expanded from the existing range



of Rs 3,000-10,000 to Rs 25,000-1,50,000, it said, adding this enhancement in term insurance will significantly benefit the families of deceased agents, offering them a more substantial welfare benefit.

With regard to LIC employees, the ministry has also approved family pension at a uniform rate of 30 per cent for the welfare of the families.

More than 13 lakh agents and more than 1 lakh regular employees, who play a pivotal role in the growth of LIC and deepening of insurance penetration in India, will benefit from these welfare measures, it said.

# Over 200 organisations call for tripling RE capacity

*Underlining the climate* catastrophe, the organisations write a letter to world leaders seeking rise of renewable energy target to at least 11,000 gigawatts by 2030

New Delhi, Sept 18: A group of over 200 climate and energy organisations from around the globe issued an open letter Monday, calling on world leaders and Parties to the Paris Agreement to set a global target of tripling renewable energy capacity to at least 11,000 gigawatts by 2030 at the upcoming COP28 in the UAE

This call to action coincides with the UN General Assembly and New York Climate Week. The coalition of organisations,

including Adani, American Greenpower, Ember, and the **Energy Transition Commission**, emphasised that achieving this goal, combined with increased energy efficiency, is the most rapid and cost-effective way to decarbonise the global economy and mitigate climate change.

'Last year, power sector emissions reached an all-time high and the UN assessed that no country is currently on a credible pathway to (limiting global warming to) 1.5 degrees Celsius. It is clear that we need a profound course-correction of the energy system in this decade and time is running out," the open letter

It builds on the momentum created during COP27, which highlighted the pressing need for a rapid energy system trans-

formation and the commitment of the G20 grouping to triple renewable energy capacity by 2030.

Policymakers, including the COP28 Presidency and international energy agency heads, are already working towards this ambitious target. This includes expediting the expansion of wind, solar, hydropower, and geothermal energy sources.

This accelerated deployment will also lay the foundation for emerging technologies such as long-duration energy storage and green hydrogen, ensuring not only clean energy but also a secure and equitable global energy system by 2050, the group said.

Renewable energy has already begun to transform communities worldwide by providing clean electricity, generating millions of green jobs, and attracting investment for economic growth.

Tripling these efforts presents a significant opportunity to reduce climate-related harm to nature and communities while fostering sustainable, inclusive, and climate-resilient development.

While each country and re-

gion will adopt a unique approach to reach the shared target, the letter highlighted key actions needed for its implementation.

This includes Paris Agreement parties committing to ambitious energy transition plans with clear interim milestones, reflected in Nationally Determined Contributions and national policy frameworks and streamlining permitting schemes for grid-scale renewable energy projects, longduration energy storage, and renewable hydrogen projects.

The group encourages investment in grid action plans to expand electricity grids for renewables and long-duration energy storage and promotion of multilateral renewable energy partnerships and trade agreements to support energy transition, cooperation, and technology

Colombo, Sept 18: Three weeks back, India arrived in Sri Lanka for the Asia Cup seeking answers for a multitude of riddles. Now, Rohit Sharma's band has left these shores after building a perfect template for the World Cup challenge through middleorder clarity and an all-weather

India's middle-order uncertainty, perhaps, was the most talked about topic in the runup to the Asia Cup in view of the World Cup next month. But the return of KL Rahul and the emergence of Ishan Kishan as a middle-order option have considerably eased their worry.

Rahul's outing, in particular, will please the team management to no end. He scored a hundred against Pakistan in a Super Four match, and, more importantly, kept wickets in all the matches he played.

He dived around to take catches off pacers and kept to leftarm wrist spinner Kuldeep Yadav quite exceptionally. It was clear that Rahul is relishing the dual role and the clarity given to him by the team management.

India would have hoped for a similar return by Shreyas Iyer, but his fitness is still getting evaluated. But that will not raise much alarm in the Indian camp, because, now, they have a reliable middle-order option in Kishan.

It was a forced gamble when he was asked to bat at No.5 against Pakistan at Pallekele in a group match. Despite batting at that slot for the first time in his career, the Jharkhand player responded to the task in brilliant fashion. The left-hander made a composed fifty in that match in the company of Hardik Pandya, rescuing India from a

top-order slump.
The only point of concern for



them could be the need to buckle up on gripping surfaces against spinners, a chink exposed by Lanka's Dunith Wellalage and the Bangladesh tweakers.

The effort of their bowlers provided a complete look to India's Asia Cup romp. India have one of the better bowling units in contemporary cricket, though usually it does not get as much encomiums as their counterparts from Pakistan.

Barring a sloppy effort against Bangladesh, the Indian bowlers were ruthless especially in important matches against Pakistan and in the final against Sri Lanka. Kuldeep donned the lead role

against cross-border rivals, taking 5/25. The 28-year-old was on top of his game the whole tournament, and it came as no surprise to see him bagging the 'Player of the Series' award.

Rohit acknowledged the growth of Kuldeep as India's premier spinner in the white ball formats. While Kuldeep's transformation has added another dimension to India's bowling, the pacers too have made a statement during the Asia Cup.

India were able to field Jasprit Bumrah, Mohammed Siraj and Hardik Pandya together for the first time in a year or so, and the result was stunning. Bumrah,

injury, played in ODIs for the first time since July 2022, and dished out performances dipped in intensity with the new ball.

Siraj, who often stands in the shadow of Bumrah, showed his ruthless face while wrecking Sri Lanka in the summit clash with a spell of 6/21. Hardik has taken big strides as the third seamer, even though that has made the management take the tough call of benching Mohammed Shami, primarily for batting depth.

"We have variety in the bowling attack. They bring in different skill sets and can deliver in any bowling conditions. So, when you get all these in one team, you feel confident as a captain," said Rohit.

That confidence has led India to the Asia Cup triumph, but the title win here does not guarantee a third trophy in the quadrennial extravaganza. But they can enter the tournament with a settled squad and mind the first pre-requisite for a winning unit.

#### Ashwin named for ODIs against Australia

NEW DELHI: Seasoned spinner R Ashwin Monday made a comeback to the Indian ODI team for the three-match series against Australia while senior players including skipper Rohit Sharma and senior batter Virat Kohli were rested from the first two games. Ashwin, who last played an ODI back in January 2022 in South Africa, could be drafted into the Indian team for the World Cup if Axar Patel doesn't get fit before the September 28 deadline set by the ICC. Axar has sustained a quadriceps tear during the recently held Asia Cup in Sri Lanka. Off-spinner Washington Sundar has also been included in the squad for all three games and is another back up option for the World Cup. KL Rahul will lead the side in the first two games. The first ODI will be played in Mohali September 22, second in Indore Sept 24 and third in Rajkot Sept 27.

"I think if we can come in top four, that is more important and then it will be about stroke of luck and everything," Kapil said on the sidelines of the launch of the third edition of J&K Open to be held at Jammu Tawi Golf Course, October 4-7.

"We can't say right now that we are favourites, of course our team is very good. Heart says something else, mind says no we have to work very hard. I know our team, I don't know about other teams, so I would say it is unfair for me to give a blank answer. As far as India team is concerned, it is ready to play and win the championships...They should play passionately, enjoy themselves."

India geared up for the World Cup with the Asia Cup triumph Sunday. The 10-wicket victory against hosts Sri Lanka was set up by the pacers, who claimed all 10 wickets with Mohammed Siraj returning with magical figures of 6/21.

"It is wonderful (to see Siraj bowl). I feel so happy that nowadays in all continents our fast bowlers are taking all 10 wickets, that's the cherry on the cake,' said India's 1983 world cup winning captain.

'There was a time when we used to depend on spinners, it is not anymore, that's why the strength of the team becomes so good." Kapil, however, said as a fan he would have wanted to see a close match rather than a lop-sided final in Colombo.

"What a fantastic cricket



played! As a cricketer I would like to see much close games but as a player, I feel bowl them out for 30 and win. As a spectator, probably a little close matches would have been better.

India have a few fitness concerns ahead of the World Cup as some key players, including Axar Patel and Shreyas Iyer, suffered injuries during the Asia Cup.

While Axar is nursing both a wrist injury and a minor tear in his left quadricep, Iyer had a back spasm and played only two matches during the continental event.

"In any team, if any two main players get injured then it hurts the team's fortunes. That's why stroke of luck is required, because if your main player gets injured, the team's balance gets disturbed," Kapil said.

Kapil also lauded India opener Shubhman Gill. "This is a youngster who we can look up to. He is the future of Indian cricket. Very very proud to have a player of that ability in India," he said.

There has been a debate on the team selection with some senior players such as Shikhar Dhawan, Ravichandran Ashwin, Yuzvendra Chahal missing the World Cup bus. Kapil, however, backed the selectors, led by Ajit Agarkar, for the picking the best

#### India men climb to third spot, eves 7th in FIH ranking

Lausanne (Switzerland), Sept 18: The Indian men's hockey team has climbed to the third spot in the latest world rankings issued by the International Hockey Federation (FIH) Monday.
