

2nd Vande Bharat for Odisha from Sept 24

Bhubaneswar: The much-awaited second Vande Bharat Express in Odisha between Puri and Rourkela will start operations from September 24, the South Eastern Railway informed Thursday. Prime Minister Narendra Modi will virtually inaugurate the Puri-Rourkela Vande Bharat Express. The Puri - Rourkela-Puri Vande Bharat will run six days a week except Saturdays. It will leave Puri at 5.00am and reach Rourkela at 12.45pm. On its return journey, the train will leave Rourkela at 2.10pm and reach Puri at 9.40pm. The train will halt at Khurda Road, Bhubaneswar, Cuttack, Dhenkanal, Angul, Sambalpur and Jharsuguda.

Govt unveils new science awards

New Delhi: The Centre unveiled Thursday a new set of national awards in science, technology and innovation, called the 'Rashtriya Vigyan Puraskar', and scrapped nearly 300 awards by various science departments. An official statement said the 'Rashtriya Vigyan Puraskar' will be one of the highest recognitions in science, technology and innovation, to be given across four categories - Vigyan Ratna, Vigyan Shri, Vigyan Yuva-Shanti Swarup Bhatnagar and Vigyan Team. Scientists will be selected across 13 domains by a committee headed by principal scientific advisor to the government, the release added.

Odisha Assembly to get 1st woman Speaker today

Bhubaneswar, Sept 21: Odisha Revenue and Disaster Management minister Pramila Mallik resigned Thursday from the Naveen Patnaik cabinet, sources said here. Mallik, a sixtime MLA handed over her resignation letter to the Chief Minister which was subsequently forwarded to the governor for approval, they said.

Later in the day, Pramila filed her nomination for the post of Speaker in the Odisha Legislative Assembly. Accompanied by senior ministers and BJD women leaders, Pramila submitted her nomination paper to Odisha Legislative Assembly secretary Dasarathi Satpathy here.

Meanwhile, School and Mass Education Minister Sudam Marndi was given additional charge of the Revenue and Disaster Management department earlier held by Pramila. He had worked in the same department for three years from 2019 to 2022.

The post of Odisha Assembly Speaker fell vacant after Bikram Keshari Arukha was appointed as Finance Minister in the last Cabinet reshuffle. Pramila will

become the first woman Speaker

in the Odisha Assembly as she is expected to win uncontested. The BJP and the Congress will not field any candidate as they do not have sufficient strength to challenge the BJD. The BJD has 113 MLAs in the 147-member House while the BJP has 22 and the Congress only nine. The CPI(M) and an Independent candidate has one seat each.

"I am indebted to BJD president and Chief Minister Naveen Patnaik for nominating me as the party candidate for the Speaker election. As a Speaker, will try to accommodate all members and ensure a smooth functioning of the Assembly," Pramila said after filing the nomination. "I am overwhelmed that I will be Odisha's first woman speaker,"

New Delhi, Sept 21: In a series of flip-flops, a private agency hired by India to carry out initial scrutiny of visa applications of Canadians put out a note Thursday on its website on suspension of visa services due to 'operational reasons', withdrew it within hours and then again put it back online. The agency, 'BLS International', also informed the stock exchanges that it had suspended India visa services in Canada with immediate effect.

The note put on Canada page the firm's website, which was withdrawn and restored later, read, "Important notice from Indian mission. Due to operational reasons, with effect from September 21, 2023, Indian visa services have been suspended

till further notice. Please keep checking BLS website for further updates." India and Canada are em-

RS passes women's quota Bill

New Delhi, Sept 21: In a historic move, the Rajya Sabha unanimously passed Thursday the Women's Reservation Bill. It now needs the signature of the President to make 33 per cent reservation for women in Lok Sabha and state Assemblies official.

The Constitution (One Hundred and Twenty-Eighth Amendment) Bill, 2023, was passed in the Upper House after an 11-hour discussion in which

72 MPs from different political parties participated. As a Constitutional Amendment Bill requires majority of not less than two-third MPs of the House 'present and voting', the legislation was passed by division with 214 MPs supporting it and none voted against it. There were no abstentions and no negative votes. The Bill had been cleared Wednesday with the support of 454 MPs in the Lok Sabha. Only two lawmakers had voted against the Bill.

During the discussion, the Opposition parties asked the government to give the exact schedule regarding the implementation of the Bill. It also asked for inclusion of the OBCs in the ambit of the Bill. Congress president Mallikarjun Kharge cautioned the Modi government to ensure that this Bill doesn't turn into an election 'jumla'.

"Give us a clear date. Which month, which year you will implement the Bill. Don't turn it into an election jumla," Kharge said.

Family sues Google after man dies in mishap

LAWSUIT SAYS THE BRIDGE HAD COLLAPSED MORE THAN A DECADE BACK, BUT THE INFO WAS NOT UPDATED $\,$ ON MAPS $\,$

San Francisco, Sept 21: A family in the US has sued Google after a man died after driving his car off a collapsed bridge following directions from Google Maps. Even though the amount of compensation has not been disclosed by the plaintiff's lawyer, sources said that the amount is over USD 5 million.

In September last year, Philip Paxson drowned after his vehicle plunged off a bridge in Hickory, North Carolina that had collapsed in 2013, as per a report in the *USA Today*. Paxson's wife Alicia has also explained as to why there was the delay in moving court. "Initially we were not aware of what led to the ac-

cident. Later on we came to know that the 'Snow Creek Bridge' had collapsed many years back. However, the updated information was not available on Google Maps," she said.

In the lawsuit filed against Google's parent company 'Alphabet' this week, Paxson's wife Alicia alleged that 'Google Maps directed him to cross the 'Snow Creek Bridge' as he drove through an 'unfamiliar neighbourhood heading home from his daughter's ninth birthday party'.

The Navy veteran's body was found by state troopers 'in an upside down and partially submerged truck'. Paxson drove off an unguarded edge crashing 20 feet below, read the court filing.



There were no warning signs or barriers present along the roadway, the lawsuit stated.

"Our girls ask how and why their daddy died, and I'm at a loss



for words they can understand because, as an adult, I still can't understand how those responsible for the GPS directions and the bridge could have acted with so little regard for human life,' Alicia was quoted as saying in the report.

The lawsuit also states that in the years leading up to Paxson's death, 'Google Maps had been notified several times by a number of people urging it to update its route information'.

A Google spokesperson was quoted as saying that the company has the deepest sympathies for the Paxson family. "Our goal is to provide accurate routing information in Maps and we are reviewing this lawsuit," the spokesperson said. "We will certainly try and find out if the fault lies with our team. If so necessary steps will be taken to rectify the faults," the spokesperson added.

Multi-disciplinary care model advised for ALD

Bhubaneswar, Sept 21: The best way to treat Alcoholic Liver Disease (ALD) is to have an integrated multi-disciplinary care model in which the treating hepatologist can have the treatment counselling along with a psychiatrist, and this model can cure more people, said an expert.

Speaking at KIMS Guest Lecture Series on ALD at Kalinga Institute of Medical Sciences (KIMS) Thursday, renowned expert on ALD Prof Ashwini Singhal from the University of Alabama, Texas said, "As ALD is the outcome of addiction, a multi-disciplinary integrated approach is best suited for the cause both in Western and Indian

scenario. He said, ALD patients should have protein intake mostly from plant-based sources as per their body weight to have a better life and manage cirrhosis. He advised the patients with ALD to have more frequent meals with small amounts for better physiology and metabolism not having heavy meals with large intervals, and proper management of obesity, metabolic syndromes, and alcohol intake so as to have control over ALD.

Saving that the selection process for liver transplant (LT) in an ALD patient is a challenge world over as the medical centres differ in their approaches to finding the "suitable" patients to undergo LT. He also underscored the need for great vigil even after the transplant process as there was every chance of alcohol intake by the patient.

Prof Sanjay Satpathy, another renowned hepatologist from the USA and Medical Director at Liver Transplantation, Northwell Health, New York also spoke on "Metabolic Associated Steatotic Liver Disease (MASLD) - Where are we heading to?" as part of the KIMS Guest Lecture Series.

Universal Cancer Care

t the upcoming second United Nations High-Level Meeting on Universal Health Coverage, the world's governments are expected to adopt a new set of commitments focused on accelerating implementation of UHC. No resolution will be complete without the explicit inclusion of comprehensive cancer services.

Cancer causes an estimated ten million deaths each year. Beyond the human suffering, the disease has profound – and growing – economic consequences: by 2030, spending on cancer care worldwide is projected to reach \$458 billion. In many countries, patients have to pay for much of their cancer care out of pocket - a burden that often leads to financial

Given this, investing in cost-effective prevention and early-detection strategies is not only a moral imperative, but also an economic one. Prevention is far cheaper than treatment, and where cancer cannot be prevented, early detection makes successful treatment more likely, at a far lower cost. When cancer does progress, the full range of quality therapies - including surgery, radiation, and chemotherapy - should be accessible and affordable to all. For noncommunicable diseases overall, every dollar invested in cost-effective interventions can generate a return of up to \$7 through reduced health-

care costs and improved productivity. While prevention and treatment are vital, so is palliative care, which alleviates unnecessary suffering for patients, their families, and caregivers, and provides survivorship plans for remaining healthy. In the wake of a pandemic that significantly disrupted palliative-care services, and with a rising number of cancer survivors worldwide, investments in both areas are urgently needed. Comprehensive cancer care is essential to achieving social-development goals related to equality, social justice, and health. And, with sufficient political will, universal care can be achieved. In Pakistan, the Shaukat Khanum Cancer Hospital net work offers world-class cancer care. The King Hussein Cancer Center has significantly expanded cancer care and scientific research in Jordan, and collaborates with international partners such as St. Jude Children's Research Hospital to deliver care to patients from Syria and Lebanon.

But countries face many challenges in incorporating cancer care into UHC schemes. In Kenya, for example, collaborative efforts by a range of cancer-control

organisations have expanded access to services and removed financial barriers, but reaching rural populations remains difficult.

In Indonesia, a decentralised health system has improved health equity, but gaps remain in cancer prevention and early diagnosis. Even in Thailand, which has integrated six areas of cancer control - cancer informatics, primary prevention, early detection, treatment, palliative care, and cancer-control research – into its UHC scheme, improved public-awareness initiatives are needed to ensure that the relevant

Nonetheless, the Thai model highlights the potential public-health benefits of UHC schemes that include comprehensive cancer care. Recognising that potential, the Union for International Cancer Control, which has more than 1,150 members in more than 170 countries and territories, works continuously with governments and other stakeholders around the world to develop and implement national cancer-control strategies and integrate them into national healthinsurance plans.

Just as a goal without a plan is merely a wish, a plan without dedicated resources gathers dust. Unless essential cancer services are covered by basic health-insurance schemes, they will remain inaccessible or unaffordable to many who need them. And where insurance exists, limits on out-of-pocket spending are crucial. Cancer patients often reach their deductible soon after diagnosis, owing to the large number of tests and procedures that are required. But treatment often lasts months or years and involves numerous visits to doctors, tests, surgeries, radiation treatments, drugs, and other services.

An effective national cancer-control strategy must reflect a nuanced understanding of cost-effectiveness that encompasses not just upfront costs, but also long-term savings, including through improved quality of life and increased productivity. It must also include a commitment to addressing not only the illness itself, but each individual's holistic experience, and a firm resolve to break down financial and cultural barriers that prevent early diagnosis and treatment.

The UN High-Level Meeting provides a rare opportunity to elevate cancer care on the global UHC agenda. That is why it is welcome news that cancer has been referenced in the meeting's draft resolution. But governments must not stop at lofty pledges and verbal commitments. Only concrete action to implement UHC that includes quality cancer services and accounts for the diverse needs of populations across economic strata and regions, can ensure that cancer care does not become a missing piece in the global health puzzle.





located within the Parliament House complex. Prof Dandavate obliged me instantly. Such kind of humility and modesty from a high public figure is a rare

thing today. Yet another memorabilia of the iconic Parliament House was the library which was located within the precincts of the building before it was relocated to the Parliament Library Building few years back. The library was regularly visited by veteran Parliamentarians like Atal Bihari Vajpayee, LK Advani, KR Narayanan, Prof Madhu Dandavate, Prof ML Sondhi, just to name a few. Tables were reserved for them in the adjacent members reading room. Members used to read books and journals with rapt attention and prepare notes for their participation in debates in the House. I had seen Vajpayee evincing the contents of the books which were displayed at the library counter every Monday and they would reserve the books for their reading once

the mandatory period of one week of display was over. The library reading room in the ground floor housed in the erstwhile 'Princes Chamber' opposite to the Tea Board and Central Hall used to be a place where members would first come to browse through newspapers and magazines or submit their revulsions for reference materials to be provided by the highly efficient Reference Services located just above the reading room. Former Prime Minister Dr Manmohan Singh was a regular visitor to the reading room where prestigious magazines journals like The Times, The Economist, Far Eastern Economic Review, Economic and Political Weekly were displayed. The reading room also displayed regional newspapers and English newspapers published from state capitals. The courteous library staff were always eager to help and assist members and the members were equally respectful to the library staff.

What would be conspicuously missing in the new Parliament Building is the grandeur of the Central Hall, a mute testimony to India's pulsating democracy, where India's first Prime Minister made his famous "tryst with destiny" speech on the eve of transfer pf power in 14/15th August 1959. The Central Hall has been used to enable the President of India to address the members belonging to members of both Lok Sabha and Rajya Sabha at the commencement of the Lok Sabha after the general election and also beginning of the first session of the year, besides the joint sittings of the two houses when needed. The Central Hall continued to be an icon of solemnity and a melting pot of India's plurality exuding bonhomie and camaraderie. At the Central Hall, the members relaxed and unwinded after heated debates in the House over a cup of filtered coffee from the Coffee Board or a steaming hot tea from the Tea Board, or a sandwich or simply a frugal khichdi or dahibhat from the adjacent cafeteria. It was the Central Hall which was a level-playing field, a meeting point of members and ministers.

While the new Parliament House will be able to accommodate both members of Raiva Sabha and Lok Sabha one wonders what will happen to the parliamentary tradition of enabling the Heads of State and Governments to address the members of Parliament. This was a rare honour extended to the heads of State and Governments.

At this poignant moment one can only wish that institutions are not built by bricks and mortar alone, the eternal spirit of Parliament should permeate our collective national psyche.

Understanding the Basic Structure

the country was put in a State of Emergency, a review petition came to be heard in the apex court based upon just an oral mentioning. No less than 13 judges sat on the bench and the Constitutional Bench judgement passed on 24 April 1973 by a similar strength of judges (highest ever) in Kesavananda Bharati vs. State of Kerala was sought to be reviewed. During the hearing of the review, it is said that the great Nani Palkhivala reached the heights of advocacy never reached before, and upon a question from the Bench that they did not quite understand, what "Basic Structure" actually meant, a forceful reply by Nani came forthwith, replying that he never heard of the Supreme Court saying that they didn't understand their own judgement.

The Keshavananda judgement is one of the most celebrated judgements not only in India but also across the world. It took five long months of hearing (highest ever) for the Supreme Court to arrive at the decision. However, the decision so arrived raised more questions than answers. In the judgement, without getting into the hyper techni-

It is in this context, that one must understand the relevance of the Constitution to a common citizen. The Constitution guarantees certain Fundamental Rights to its citizens and puts restrictions on the powers of the State. For example, Article 21 restricts the State to deprive any person of his life or liberty except by procedure established by law. Moreover, Fundamental Rights are considered to be an inalienable right of a citizen which are not considered to be playthings of the majority.

In the Keshavananda case, the SC by a majority of 7:6 held that the Parliament can amend the Constitution but cannot change the Basic Structure. The question arises as to what is the "Basic Structure of the Constitution.' Despite, seven judges (majority) holding that the Parliament can amend the Constitution and the Fundamental Rights but not alter the "Basic Structure", it is interesting to note that there was no unanimity as to what constitutes the "Basic Structure". For example, Chief Justice Sikri Grover and Justice Shelat in addition to the above list also added the dignity of the individual and welfare state. Justice Hegde and Justice Mukherjea listed the sovereignty of India and its democratic character as Basic Structure. Hence, even presiding indges were not unanimous as to what "Basic Structure" entails. However, in simpler language, the "Basic Structure" of the Constitution is what the motherboard is to a computer and what spirit is to the human body. One cannot comprehend the functioning of the entity in its absence. For example, without the ethos of the democratic character of the Constitution, the procedure for the functioning of the Parliament i.e. Articles 107 to 111 would be rendered

meaningless. The "Basic Structure" doctrine was first put to a major test in the case of Indira Gandhi vs. Raj Narain, where a challenge was laid to the bizarre amendment passed by the Central Government which restricted the courts from scrutinising election of Prime Minister, President and Vice-President. The said amendment was struck down

Gandhi had accumulated all to decide whether the power of Constitution, secularism, etc. as olated the principles of free and basic features whereas Justice fair election and rule of law which forms a part of the Basic Structure. Hence, it acted as a shield against brute majority. Despite all its advantages,

many question the legitimacy of the Basic Structure. It is mainly criticised for being the weapon of judicial overreach and being uncertain and ambiguous. Recently, ex-CJI Ranjan Gogoi in his maiden speech in Rajya Sabha doubted its "jubasis". risprudential Furthermore, when the National Judicial Appointment Commission was struck down on the basis that it affects the independence of judiciary, Late Arun Jaitley called it the "tyranny of the unelected". Through the Basic Structure doctrine, the SC established itself as the final interpreter of the Constitution. In conclusion, if we were to choose between an unpredictable democracy and certain tyranny, I believe we must go for the former and let the SC be the final interpreter of our beloved Constitution.

Worsening ties

Sir, Canadian Prime Minister Justin Trudeau's recent accusation that India may have had a role in the murder of Khalistani terrorist leader Hardeep Singh Nijjar has significantly strained Indo-Canadian relations. Trudeau's handling of Sikh extremism in Canada has been widely criticised for its ineffectiveness, and there appears to be little hope for improvement under his leadership. His failure to take decisive action against Sikh extremist organisations like Sikhs for Justice (SFJ), designated as a terrorist group by India, has exacerbated tensions. SFJ's alleged involvement in inciting violence against Indian officials and advocating secession in Punjab has raised serious concerns. Critics argue that Trudeau's reluctance to address India's worries about Sikh extremism stems from his desire to retain support from the large Sikh voter base within his Liberal Party. This political consideration has seemingly taken precedence over fostering a robust relationship with India. The current state of Indo-Canadian relations is worrisome, given India's status as a rapidly growing economy and Canada's keen interest in strengthening economic ties. For a potential turnaround in their relationship, Trudeau must shift his approach and exhibit greater responsiveness to India's concerns. Concrete actions against Sikh extremist groups in Canada and a commitment to addressing India's worries are essential. Without such measures, Indo-Canadian relations are likely to worsen further.

Chandigarh, Sep 21: Rival gangsters Lawrence Bishnoi and Jaggu Bhagwanpuria Thursday separately claimed responsibility for the killing of Punjab-origin NIA-wanted gangster Sukha Duneke, who was shot dead in Canada's Winnipeg in an inter-gang rivalry

Sukhdool Singh, alias Duneke, was part of the Khalistan movement in Canada. He was believed to be an ally of the Bambiha gang and was wanted by Punjab Police in cases of extortion, attempt to murder and murder.

In a post, Bishno "Sukhdool had murdered our brother Gurlal Brar and was also behind the killing of Vicky Middukhera as well as kabaddi player Sandeep Nagal Ambian."

Likewise, in another social media post, another Punjabbased gangster Bhagwanpuria, once a close aide of Bishnoi, claimed responsibility for the killing by saying he took revenge for Ambian.

Duneke, an associate of the Devinder Bambiha Gang in Punjab, escaped to Canada in 2017 on forged documents. Wednesday, his name figured

among the list of 43 gangsters released by the National Investigation Agency (NIA) which sought information about his illegal properties.

His murder Wednesday night is similar to the killing of terrorist Hardeep Singh Nijjar in June. However, when IANS approached Punjab Police officials for comments, but they refused to comment on the killing owing to inter-gang rivalry.

Tiruppur, Sept 21: Packets of snacks and a small heap of onions await customers in front of a road-facing house in Mettukadai, located six km south of Uthukuli - a town in Tamil Nadu famed for its butter. Not more than nine of the 100 households here rear huffaloes in stark contrast to the four or five bovines in each dwelling almost

Shopkeeper Chandramani is one among the few buffalo rearers of Mettukadai, but she regrets not knowing how to work at a garment factory in Tiruppur, unlike the majority of the women here. Besides the shop, the familv has an acre of land where Chandramani's husband cultivates sorghum (broomcorn millet) once in a year to get dry fodder for the four buffaloes.

Chandramani and her husband cannot depend entirely on the income generated from milk. "The amount I spend buying hay, husk and cattle feed every month is between Rs 15,000 and 20,000. My income, on the other hand, is just enough to repay what I have borrowed to feed the bovines," says Chandramani, who guesses her age to be around 60. She makes Rs 100 to 200 per day from the shop.

Chandramani's present situation is typical of the buffalo rearers in and around Uthukuli. All of them are into it either because they do not know any other

job or it is the only option to put their small landholdings to use.

Located about 15 km east of district capital Tiruppur -- the knitwear export hub of India -- Uthukuli's rise to fame was driven by the establishment of a railway junction in the 1930s. The villagers saw an opportunity to sell curd and buttermilk to the passengers of trains passing through this

parched land. Much to their surprise, the taste of their buttermilk enthralled the Malayalam-speaking traders, who began to make a stopover in Uthukuli to buy butter. When the product got a good reception in the erstwhile princely states of Travancore. Cochin and Malabar, the fre-

quency of their visits increased. Noyyal, a tributary of River Cauvery, flows six km south of Uthukuli, which has a population of a little over 10,000. The water flow is not perennial, so rain-fed agriculture is the only way out. Since there was no cul-

tivation of paddy and other millets, the sorghum straw became the main feed for buffaloes. Drought-resistant grass species such as kolukattai pul (Anjan grass) were also fed. As a result, the milk of Uthukuli's buffaloes was thicker than the milk of buffaloes and cows from other parts of the state. Since the milk was creamier than the normal buffalo milk, the butter was thicker with less proportion of water in it.

However, the rise of the knitwear industry in Tiruppur in the 1980s opened up many employment opportunities, especially for unskilled and semiskilled labourers with little or no education. This, along with irregular rainfall, sounded death knell for the dairy industry.

"About 20 years ago, the population of buffaloes in my village outnumbered that of humans. Nowadays, so much money goes into feeding them as sorghum cultivation is not as common as it was three decades ago," says Karattupalayam native Kumara Rangasamy (59). True to his words, many farmers say they are buying hay, coming mostly from

the Cauvery Delta districts. "To work in a garment factory, all I needed were two hands and legs," adds Rangasamy, who quit that job to launch a second hand automobile spare shop in Uthukuli over a decade ago. The five acres of land that his family owns has not seen any cultivation since then, except for a few



Fresh violence erupts in Manipur, several injured



Imphal, Sep 21: More than 10 people were injured when Manipur security forces fired tear gas shells on protesters for trying to storm police stations and court arrest demanding the unconditional release of the five arrested youths Thursday.

As a precautionary measure, the state government cancelled curfew relaxations in the twin districts of Imphal from 5pm, officials said.

Responding to a call by six local clubs and Meira Paibis demanding the release of the five village volunteers, hundreds of protesters holding placards and shouting slogans tried to enter the Porompat police station in Imphal East and Singjamei police station and Kwakeithel police outpost in Imphal West district. However, police and RAF personnel deployed at strategic positions fired several rounds of tear gas shells to disperse the crowd. A protester, identified as Th Bimola at Porompat said, "We were left with no option but to court arrest as the government failed to release the five village volunteers. If such village volunteers are arrested, who will protect the Meitei villages in the periphery of the hills and

the valley Kuki Zo militants." Similar attempts to enter Mayang Imphal police station in Imphal West district and Andro police station in Imphal East district were also reported.

All Langthabal Kendra United Clubs Coordinating Committee president Yumnam Hitler said, The decision to launch the 'voluntary mass arrest' agitation was taken after the government took no steps to release the five arrested youths.'

Top court refuses to interfere with CWMA order

New Delhi, Sept 21: The Supreme Court Thursday refused to interfere with the order of the Cauvery Water Management Authority (CWMA) and the CWRC directing the Karnataka government to release 5,000 cusecs of water per day to Tamil Nadu for 15 days.

The Cauvery Water Regulation Committee (CWRC) in its September 12 order, which was upheld by CWMA, directed Karnataka to release 5,000 cusecs (cubic foot per second) of water every day for the next 15 days to Tamil Nadu.

A bench of Justices BR Gavai, PS Narasimha and Prashant Kumar Mishra said it was not inclined to entertain Tamil Nadu's plea challenging the CWMA decision on the ground that it was facing a drought-like situation due to rain deficit.

The bench noted that bodies like CWMA and CWRC, which have experts from the Meteorological Department (IMD), and those on agriculture and water resource management, have considered all relevant aspects like drought, deficit rainfall, water level in the river and

DGCA suspends **Al's Flight Safety Chief Rajeev Gupta**

New Delhi, Sept 21: Aviation watchdog DGCA Thursday said it has suspended Tata Groupowned Air India's Flight Safety Chief Rajeev Gupta for one month for certain lapses.

Besides, the regulator has directed the airline not to assign any audits, surveillance and spot checks to an auditor due to lack of diligence in work.

On July 25 and 26, the regulator's team carried out the surveillance of Air India in the areas of internal audit, accident prevention work and availability of required technical manpower.

The surveillance found deficiencies in the accident prevention work carried out by the organisation and the availability of the requisite technical manpower as required in the approved Flight Safety Manual and the relevant Civil Aviation Requirements, DGCA said in a release

"The approval of Chief of Flight Safety of Air India has been suspended for a period of one month for the lapses established," it said. Rajeev Gupta is the Chief of Flight Safety of Air India Ltd.

Watch duty time limitation norms In a "significant" move, aviation watchdog DGCA Thursday said regulations for watch duty

New Delhi, Sept 21: The Information and Broadcasting Ministry Thursday advised TV news channels to refrain from giving platform to those belonging to proscribed organisations or facing charges of terrorism and serious crimes.

In an advisory to all private satellite TV channels, the ministry said it has come to its notice that "a person" in a foreign country who faces serious cases of crime including terrorism was invited for a discussion on a television channel.

During the discussion, the person made several remarks detrimental to the sovereignty and integrity of India, its security and friendly relations with a foreign state, the ministry said, without naming the person or the news channel.

The remarks of the person

also had the potential of disturbing public order in the country, the ministry added.

While the government upnolds media freedom and respects its rights under the Constitution, the content telecast by the TV channels must adhere to the provisions of the Cable Television Networks (Regulation) Act, 1995, the ministry said. "In the light of the above, television channels are advised to refrain from giving any platform to reports/references about and views/agenda of persons of such background including those against whom there are charges of serious crimes/terrorism and belonging to organizations which have been proscribed by law, having regard to the reasonable restrictions laid down under Article 19(2) of the Constitution and mentioned under sub-section (2) of Section

Dawn on Moon; will Chandrayaan-3 wake up?

As per ISRO, the lander and rover are expected to be reactivated around September 22. However, the chances of revival are not very high due to the harsh lunar conditions

Bangalore, Sept 21: With dawn breaking on the Moon, ISRO is now gearing up to try to reestablish communication with its lunar mission Chandrayaan-3's solar-powered lander Vikram and rover Pragyan, to revive them so that they can continue with scientific experiments.

Both the lander and the rover were put into sleep mode earlier this month September 4 and 2 respectively, ahead of the lunar night setting in on Earth's only natural satellite. So, if ISRO is able to revive them as the Sun rises on the Moon again, information that is derived from experiments that could once again be conducted by the Chandrayaan-3 payloads would be a "bonus". With sunlight back on the south polar region >> Chandrayaan-3 made a historic landing on the Moon's surface August 23

The spacecraft carried two modules, Vikram and Pragyan, which were put into sleep mode after 14 days of conducting studies and experiments on the lunar surface

>> ISRO remains hopeful that the two vehicles might wake up when the sun rises again above the Moon's south pole

>> If successful, Chandrayaan-3 will continue its lunar studies beyond its initial mission duration

If not, Vikram and Pragyan

will remain on the lunar surface

indefinitely of the Moon, where both the lander and rover are located, and

be optimally charged soon, ISRO is now slated to make efforts to establish contact with them again, check their health and ability to resume functioning, and try to revive them.

'We have put both the lander and rover on sleep mode because temperature would go as low as minus 120-200 degree celsius. From September 20 onwards, sunrise will be going on at the Moon and by September 22 we hope that the solar panel and other things will be fully charged, so we will be trying to revive both the lander and rover," ISRO's Space Applications Centre Director Nilesh Desai told PTI.

"If our luck is good, we will have revival of both lander and rover and we will get some more

experimental data, which will be useful for us to further do investigation of the Moon's surface. We are eagerly waiting for activity from September 22 onwards. We hope that we are lucky enough to revive both lander and rover and get some more useful data," he said, adding that whatever data they get hereon would be a bonus.

After landing on the Moon, both the lander and the rover, and payloads onboard had performed experiments one after the other so as to complete them within 14 Earth days (one lunar day), before pitch darkness and extreme cold weather engulfed the Moon.

The lander and rover -- with a total mass of 1,752 kg -- were designed to operate for one lunar daylight period (about 14 Earth days) to study the surroundings there. However ISRO is hoping that they will come back to life when the Sun again rises on the Moon, and carry on with the experiments and studies there.

Poland will not supply weapons to Ukraine

Kyiv, Sept 21: Russian missiles and artillery pounded cities across Ukraine early Thursday, sparking fires, killing at least three people and trapping others under the rubble of destroyed buildings, authorities said, as Poland said it would stop providing weapons to its ally amid a trade dispute.

Poland, which has been a major supporter of Ukraine, said it would stop transferring weapons to its neighbour as it works to modernise its own military, but denied the decision was linked to a simmering dispute over a temporary ban on Ukrainian grain imports.

Polish Prime Minister Mateusz Morawiecki said the decision would not affect NATO and US weapons transfers through Poland."We are no longer transferring any weapons to Ukraine because now we will arm ourselves with the most modern weapons," he said in an interview on the private TV broadcaster

Polsat News late Wednesday. A dispute about whether Ukrainian grain should be allowed to enter the domestic markets of Poland and other European Union countries has pushed the tight relationship between Kyiv and Warsaw to its lowest point since Russia invaded Ukraine last year.

Morawiecki stressed that Poland would defend its economic interests, but added that the dis-

pute over grain imports would not hurt Ukraine's security."We are Morawiecki stressed that Poland not going to risk the security of Ukraine," he said. Poland has transferred large amounts of its older weapons to Ukraine and

has been upgrading its own inventory with new equipment purchased from South Korea and other countries.

Air raid sirens sounded repeatedly across Ukraine, as Russia launched dozens of missiles and, near the front lines, likely used shorter-range artillery to pound the southern city of Kherson. Three people were killed in Kherson Thursday and at least four injured after a residential building was hit, the Defence Ministry said on social media.

Stay calm but vigilant: Canadian MP

The sharp reaction from Chandra Arya, who represents the riding (electoral district) of Nepean in the House of Commons of Canada, came as extremist elements backed by a leader of the Khalistan movement openly asked Hindu Canadians to go back to India.

"A few days back Khalistan movement leader in Canada and the president of Sikhs for Justice which organises the so-called referendum Gurpatwant Singh Pannun attacked Hindu Canadians asking us to leave Canada and go back to India,' Arya, a member of the Liberal Party of Canada, said.

"I have heard from many Hindu-Canadians who are fear



ful after this targeted attack. I urge Hindu-Canadians to stay calm but vigilant. Please report any incident of Hinduphobia to your local law enforcement agencies," the Indo-Canadian MP posted on X.

Islamabad, Sept 21: Pakistan's election commission Thursday announced that the general elections in the country will take place in the last week of January 2024, amid mounting pressure from political parties that pressed for timely elections in the cashstrapped country.

In a statement, the electoral body said that it reviewed work on delimiting constituencies and the initial list for the delimitation of constituencies would be published on September 27.

It said parties would be able to file objections after that the ECP would address all objections and suggestions.

After hearing objections and suggestions regarding the list, the final list would be issued on November 30, which would be followed by the election schedule, it said. It said that by the end of delimitation, it would announce a 54-day election program and "polls will be held in the last week of January 2024.

The National Assembly was

dissolved August 9 and constitutionally, the elections should be held within 90 days but the process was delayed by the ECP

due to the delimitation exercise which became mandatory in the wake of the new census held this year. The previous government just days before the end of its term endorsed the results of the census which obligated the ECP to set up a new electoral district on the basis of the latest

population. The move led to fears that the polls meant to be held within 90 days may be delayed till next year as the delimitation process would take about four months to complete. The decision to

shorten the timeframe of the delimitation comes amid mounting pressure on the ECP from several political parties that pressed for timely elections.

The Constitution also provides that the ECP should complete the delimitation process within 120 days. Currently, a caretaker government is running the country and it will continue until the new prime minister is elected through the elections

Caretaker Prime Minister Anwaar-ul-Haq Kakar has said the interim government is committed to upholding the democratic process in Pakistan by holding general elections and it will not make any excuse to delay it.

In a letter to the ECP chief earlier this month, President Arif Alvi, who was a founding member of jailed former Prime Minister Imran Khan's Pakistan Tehreek-e-Insaf party, unilaterally proposed November 6 as the day for the polls, but the top election body avoided comment on his suggestion.

Chinese navy seeks graduate students to fly shipborne aircraft

Beijing, Sept 21: The Chinese navy wants to hire graduate students to fly shipborne aircraft, and is raising the age limit to expand its search as it seeks to improve the qualifications of its air personnel and build a "strong army"

Besides upgrading its hardware from warships to warplanes, China is also trying to improve the calibre of its recruits, as the military is a career path traditionally favoured by the less educated.

In an advertisement on social media platform WeChat, the People's Liberation Army Navy said it was seeking graduate students with master's degrees in science and engineering who are younger than 26 to pilot aircraft from ships.

Last year, it allowed undergraduates aged 24 or below to apply for the first time. Before that, the limit was high school graduates age 20 and younger."The need for high-quality military talent becomes more imperative day by day," the People's Liberation Army Navy



said in the advertisement, published on Wednesday. "The mission and tasks of the navy continue to expand. The speed of the strategic shift of the navy is being accelerated.

Candidates must be male with a clean "political history" and no legal or disciplinary history, according to the advertisement. Training will include three to four years of aviation theory and practical flight training. Those who become pilots will have free medical care for themselves and their immediate family, as well as government-provided housing.

China is in the final stages of preparing its third aircraft carrier - the Fujian - for sea trials, a key step before the warship goes into operational service. China is aiming to modernise

its military by 2035. As China speeds up training of military aircraft pilots, it has also tried to recruit serving and former British military pilots, prompting Britain to block of such moves.

BoE halts rate hikes

London: The Bank of England halted its long run of interest rate increases Thursday as the British economy slowed, but it said it was not taking a recent fall in inflation for granted. A day after a surprise slowing in Britain's fast pace of price growth, the BoE's Monetary Policy Committee voted by a narrow margin of 5-4 to keep Bank Rate at 5.25%. It was the first time since December 2021 that the BoE did not increase borrowing costs. It cut its forecast for economic growth in the July-September period to just 0.1% from August's forecast of 0.4% and noted clear signs of weakness in the housing market.

HOUSEHOLD SAVINGS MORE THAN HALVES TO 5.1% OF GDP, A 50-YEAR LOW

Household debt doubles in FY23

Mumbai, Sept 21: The net financial savings of households plunged by close to 55 per cent in FY23 to 5.1 per cent of GDP, and their indebtedness more than doubled to ₹15.6 lakh crore from FY21, primarily led by massive borrowings from banks, shows an analysis of latest official num-

According to SBI Research, a good portion of the drawdown from savings have gone to physical assets and of the ₹8.2 lakh crore increase in household indebtedness in FY23, as much as ₹7.1 lakh crore accounted for bank borrowings, primarily for home loans and other retail finances.

In FY23, household savings plunged to 5.1 per cent of GDP, from 11.5 per cent in FY21, a 50year low, and 7.6 per cent in FY20, which was not the pan-

demic period. It can be noted that the most important source of funds for the two deficit sectors -- general government finances and the nonfinancial corporations, are household savings.

The household sector in the na-

tional accounts includes, apart from individuals, all non-government, non-corporate enterprises like farm and non-farm businesses, unincorporated establishments like sole proprietorships and partnerships and non-profit institutions.

According to Soumya Kanti Ghosh, the group chief economic adviser at the State Bank of India, financial liabilities jumped by ₹8.2 lakh crore since the pandemic, outpacing the increase in gross financial savings of ₹6.7 lakh crore.

On the asset side of households, there was an increase of ₹4.1 lakh crore in insurance and provident funds and pension funds during the period.

On the liability side of the households, of the 3.2 lakh crore increase, as much as ₹7.1 lakh crore accounted for an increase in household borrowings from commercial banks.

When juxtaposed this increase in borrowings from banks with the increase in bank credit, as much as 55 per cent of the retail credit to households in the last two years have gone to housing. education and vehicle purchases.

According to Ghosh, this is possible due to the low interest rate regime, resulting in a paradigm shift of household financial savings to household physical savings in the last two years. He sees a significant long-run

relationship between housing loans and households' savings in physical assets. As a result, the decline in net financial savings of households has resulted in a concomitant increase in household savings in gross physical assets. In fact, savings in physical as-

sets, which accounted for more than two-thirds of household savings in FY12, had declined to 48 per cent in FY21

However, the trend is again shifting and the share of physical assets is expected to reach 70 per cent in FY23, due to a decline in share of financial assets.

RBI proposes tweaks in wilful defaulter norms

Mumbai. Sept 21: The Reserve Bank of India (RBI) Thursday proposed sweeping changes in norms concerning wilful defaulters, defining them as someone who has an outstanding amount of ₹25 lakh and above and has refused to repay despite having the capacity to pay.

RBI has sought comments on the new draft master direction that proposes to expand the scope for lenders which can classify borrowers as wilful defaulters, and refine the identification process.

Wilful defaulters shall not be eligible for restructuring of credit facility and cannot be on the board on any other company.

The lender shall, wherever warranted, initiate legal action against the borrowers guarantors for foreclosure recovery of dues expeditiously, the draft said.

It also proposes a review and finalisation on wilful default aspects within six months of an account being classified as a nonperforming asset. Comments on the draft can be submitted to RBI by October 31.

Bangalore, Sept 21: Global contraceptive makers are betting on condom-shy India becoming their biggest growth market, following the blockbuster IPO of a domestic prophylactic maker just weeks after the UN said the country would become the most populous by

With population decline and aging societies in major markets such as Europe, Japan and China, condom manufacturers are taking advantage of modern marketing tools to reach India's huge, young and techsavvy demographic in both urban and rural settings.

Such is the trend that the market is set to more than double to \$1.7 billion by 2030, showed data from GrandView Research.

"The Indian market is very attractive. The condom usage rate there is still low." said Kazuhiro Kamio, chief of overseas sales and marketing at Japanese condom maker Okamoto

India's market leader is domestic manufacturer Mankind Pharma with a 33% share, ahead of Reckitt Benckiser at 14%, TechSci data showed, Mankind conducted a \$520 million initial public offering (IPO) in May and saw its stock soar 32% on its market debut, valuing the company at \$7 billion.

The maker of Manforce condoms has been boosting its online presence to better cater to urbanites and investing in local-language advertising to reach more rural consumers. Like rivals, it has made moreuse of social media influencers and events.
