1st C-295 aircraft inducted into IAF

Ghaziabad: The first C-295 medium tactical transport aircraft was inducted into the Indian Air Force (IAF) Monday, boosting its logistics capabilities. The induction ceremony took place at the Hindan Air Force Station here in the presence of Defence Minister Rajnath Singh. He later took part in a 'Sarva Dharma Pooja' that was performed in the hangar to mark the occasion. IAF chief Air Chief Marshal VR Chaudhar along with senior officials of the IAF as well as of Airbus attended the induction ceremony. The first C-295 aircraft was inducted into Squadron No. 11 of the IAF. It is one of the oldest squadrons of the IAF and is currently based at Vadodara Air Force Station.

Pannun plans to divide India: NIA

New Delhi: The NIA has alleged that Canada-based Khalistani terrorist Gurpatwant Singh Pannun had planned to create a territory called the 'democratic republic of Urduistan' in an attempt to separate Kashmir from India. The NIA report states that Pannun's primary agenda through the Sikh for Justice (SFJ) organisation is to divide India. Pannun aims to divide India along religious lines. The agency has claimed in its dossier that Pannun incited young individuals to engage in a secessionist movement and encouraged them to post provocative posters bearing proliberation slogans in Punjab.

Hangzhou, Sept 25: Rookie pacer Titas Sadhu singlehandedly earned a gold medal for the Indian women's cricket team in its maiden appearance as it defeated Sri Lanka by 19 runs in a low-scoring final of the Asian Games here Monday.

On a pitch difficult for batting, the Indian women's team struggled to 116/7 but it was just about par score. However Titas, who is just four days shy of her 19th birthday, bowled a devastating first spell and finished with superb figures of 4-1-6-3 to play a big role in restricting Sri Lanka to 97/8 in 20 overs.

She had an able ally in leg-spinner Devika Vaidya (1/15), who kept a tight leash on the islanders. Left-arm spinner Rajeshwari Gayakwad (2/20) and off-spinner Deepti Sharma (1/25) started off badly but were on target during the back-end as Indian women always looked in complete control.

This was one gold medal that India were expected to win, but the standard of cricket was pretty poor, and the nature of wicket didn't help matters.

The lanky Titas bowled quick and kept her deliveries on fuller length to get three wickets in her first two overs.

Amid Opposition attack over excessive bureaucratic interference in government matters, CM defends the statewide visit of CMO officials to collect people's grievances

Bhubaneswar, Sept 25: Chief Minister Naveen Patnaik Monday asserted that no ministers-versus-officers issue exists in the state, dismissing criticisms from various quarters over holding of people's grievance meetings by a controversial CMO official.

Patnaik said in the Assembly that the CM Grievance Cell has always been handled by the CMO and ministers are not required to attend meetings, in which people seek redressal of their grievances, in Bhubaneswar. However, both the Opposition BJP and Congress ridiculed Patnaik's statement and alleged that the state is ruled by officers instead of the elected peoples' representatives. As the Opposition alleged that there was huge expenditure on the chopper ride of the CMO officials, especially Patnaik's private secretary VK Pandian, an IAS officer of the 2000 batch, the Chief Minister said no excess expenditure was made. Stating that the CM Grievance Cell is always handled by the CMO, Patnaik said once petitions are received, they are sent to the departments concerned. "Where is the issue of ministers versus officers in this?" the Chief Minister asked. Noting that the ministers have played a major role as heads of the departments in resolving the petitions, he said it is teamwork at the highest level and is professionally done in a democratic set-up. "The aim is to resolve people's grievances in the best pos-

"Otherwise, the people would have to come to the CM Grievance Cell in Bhubaneswar. How much money would they have to spend on travel and stay? How much wage loss would they have? All these have been saved by the CM Grievance Cell travelling to the

doorsteps of people," Patnaik said. "Of those 57,442 petitions, 43,536 have been resolved or disposed of," he said wondering how someone could be unhappy if people's grievances are redressed. Patnaik said the mammoth grievance hearing exercise was carried out in more than 190 locations over a period of six months. Referring to chopper use by of-

ficials, Patnaik said, "I would like to clarify that it would have taken one and half years to do the same exercise by road. Conducting three to five meetings daily in different locations is humanly impossible within a

Chief Minister said. "This exercise was also used to explain to people about the schemes of the state government, the ongoing projects in their areas and the funds sanctioned for the same," the ruling BJD president said.

"It was my specific instruction to give timelines for resolving grievances. I sincerely appreciate ministers, the district administrations, the CMO, the departments and all others involved in carrying out this mammoth exercise so professionally,' Patnaik said.

He also called upon the Opposition members to be happy that so many grievances in their areas have also been resolved. "People are happy... Opposition members should not be unhappy because of political reasons. For my government, resolving people's issues is a top priority and I will continue to do so in the best possible manner," Patnaik said.

AIADMK cuts ties with BJP-led NDA

Chennai, Sept 25: Ending its four year-old ties with the BJP, the AIADMK Monday announced walking out of the National Democratic Alliance (NDA) and said it would lead a separate front for the 2024 Lok Sabha polls.

The decision to break away from the NDA was taken at a high level meeting chaired by party chief Edappadi K Palaniswami at the AIADMK headquarters here. The decision was met with cheers from the Dravidian party workers who burst crackers outside the headquarters here.

The move to call it quits comes days after senior AIADMK leaders called on BJP chief JP Nadda in New Delhi and apprised him about the ground situation in the state arising out of the saffron party's Tamil Nadu chief K Annamalai's aggressive style of politics. They had then sought Annamalai's apology for making a remark on Dravidian stalwart CN Annadurai or that he be replaced.

Briefing reporters on today's deliberations, former minister and senior leader KP Munusamy said the party has unanimously adopted a resolution to part ways with the NDA and steer a com-bine of like-minded parties in next year's polls.

Trained to charge at anything 'khaki': Dogs foil drug raid

Kottayam (Kerala), Sept 25: A surprise search planned by the Anti-Narcotics squad of the Kottayam police at the house of a man suspected to be a drug dealer resulted in a shock for them due to the presence of several violent dogs trained to bite anyone wearing 'khaki' attire.

The presence of the dogs hindered the search process Sunday night and also enabled the accused to escape from the police who were focused on avoiding the attacks of the canines. However,

the dogs were subdued and over 17 kilograms of ganja was seized from the site, police said.

Speaking to reporters, Kottayam SP K Karthick IPS said it was close to midnight when the search team, also comprising officers from the nearby Gandhinagar police station, arrived at the location.

"We did not expect there would be so many dogs here and that they would be violent. So, we faced difficulty initially in carrying out a proper search. Fortunately, none of the officers were injured. The accused had

imparted training to the dogs to bite on seeing khaki. He had been briefly trained in dog handling by a person retired from the BSF, but was kicked out from there for asking questions like how to make dogs bite someone wearing khaki," the SP said.

The top officer of the district police also said the accused under the guise of being a dog trainer was selling drugs and the same was evident from the seizure of over 17 kgs of ganja from the site.

"According to our preliminary investigation, he (accused) was living here on rent and was known



to everyone in the area as a dog trainer. Therefore, people used to leave their dogs with him, at the rate of ₹1,000 per day, when they went outside and he would look after the canines," Karthick said.

Around 13 dogs were present there and after identifying their owners, the canines would be handed over to them. He also said that a special investigation team has been constituted to probe the case.

"We first need to catch the accused and then find out if any others were also involved in the racket," the officer said. The police decided to obtain a search warrant for the premises based on secret information received and subsequent investigation of the suspicious activities being carried out there, he said.







Pandemonium as **BJD**, **BJP trade charges**

SIX ADJOURNMENTS DISRUPT PROCEEDING

AGENCIES

Bhubaneswar, Sept 25: The Assembly Monday was adjourned at least half a dozen times as Opposition BJP members protested the rejection of their notice for a discussion on the governance style of the BJD dispensation.

While the opposition members disrupted the proceedings, the ruling BJD members also raised the issue of alleged nonmaintenance of the national highway connecting Cuttack and Sambalpur.

Unable to run the House. Speaker Pramila Mallik first adjourned the House for one hour till 11:30am, but as the ruckus continued, the House was adjourned till 4pm. When the House reassembled after the lunch, similar situation prevailed leading to back-to-back four adjournments.

The Speaker held an all-party meeting to resolve the issue, but the BJP members continued to protest over the rejection of their notice for discussion on the governance style of functioning.

The government, however, introduced four different Bills amid the din in the well.

Even before the House assembled for Question Hour, BJP members were present in the well and raised slogans protesting the rejection of their notice.

BJD members were also on their feet, protesting the alleged non-maintenance of the national highway connecting Cuttack and Sambalpur.

Outside the House, Opposition Chief Whip Mohan Majhi said that the BJP's notice for a discussion on the admissibility of an adjournment motion was rejected by the Speaker without giving any reason.

"We wanted a discussion on whether a secretary is superior or a minister in the government protocol. The democratic system has completely collapsed in the state." Majhi told reporters. He also cited instances of the Assembly rejecting written questions of some BJP members who

wanted to know the amount spent on tours of a secretarylevel officer. "The government is acting

like an escapist," Majhi alleged. Congress member Taraprasad Bahinipati accused both the BJP and the BJD for adjournment of the House.

"They (BJD and BJP) are one and not different. They got the House adjourned to prevent a discussion on issues to be raised by Congress. The verbal duel between the two parties is just

eyewash," Bahinipati said. BJD member Dipali Das said her party MLAs raised the issue of central negligence in repairing the national highway, which is the lifeline for the people of western Odisha. She claimed that many lives were lost in accidents due to poor maintenance water bodies and launch public awareness drives, he added. of the highway.

1,771 lives lost to drowning in 3 yrs

Odisha recorded 1,771 deaths due to drowning in rivers and other water bodies in the last three years, with an average of 590 fatalities annually, Minister of State (MoS) for Home Tusharkanti Behera told the Assembly while replying to a question by BJD MLA Mousadhi Bag.

State bans glue traps for rodent control

Odisha joins 20 other states & UTs in the country to prohibit the manufacture, sale and use of glue traps which cause slow and painful death to rats and other target animals

Cuttack, Sept 25: Odisha has joined 20 other states in the country to ban glue traps as a rodent control measure.

The Animal Welfare Board of Odisha (AWBO) Monday issued an order instructing all chief district veterinary officers-cummember secretaries of the district societies for the prevention of cruelty to animals to ensure compliance with Animal Welfare Board of India (AWBI) advisories banning glue traps to catch rodents and to ensure the strict prohibition of the manufacture, sale, and use of glue traps in the state.

The circular cites Section 11 of The Prevention of Cruelty to Animals Act (PCA), 1960, which prohibits causing unnecessary pain and suffering to animals. The order came in response to

an appeal made by animal welfare non-profit 'People for the

What is a glue trap

sually made of plastic trays or sheets of cardboard covered with strong glue, these traps are indiscriminate killers that frequently ensnare non-target animals. Mice, rats and other animals caught in these traps may suffocate when their noses and mouths become stuck in the glue, while some 44 even chew through their legs in a desperate bid for freedom and die from blood loss. Others starve to death after being stuck to the board for days. Those found alive may be thrown away along with the trap or face an even more traumatic death, such as bludgeoning or drowning

ccording to PETA India, the best way to control rodent populations is to make the area unattractive or inaccessible to them: eliminate food sources by keeping surfaces and floors clean and storing food in chewproof containers, sealing trash cans, and using ammonia-soaked cotton balls or rags to drive rodents away. After giving them a few days to leave, seal entry points using foam sealant, steel wool, hardware cloth, or metal flashing. Rodents can also be removed using humane cage traps but must be released where they will find adequate food, water, and shelter to help them survive.

"Glue traps are ineffective in the long term, since they don't deal with the root of the problem. More rats move in as they breed as a result of the brief increase in the food supply. The result is a vicious killing cycle in which many animals suffer and die," he said.

The matter was mentioned for urgent listing before a bench headed by Chief Justice DY Chandrachud which said the plea will be heard during the day.

When the matter came up for hearing, the counsel appearing for the petitioner said the plea has not been filed for admission alone, and in fact, it was on the issue of qualifying percentile having been reduced.

Sydney, Sept 25: As space exploration and colonisation expand, off-Earth resources will create a booming market.

The drive to explore deeper into space and establish colonies on other planets has intensified over the last decade and, with it, the importance of space resources extraction.

Obtaining valuable resources and minerals, even in extreme environments, has long been attractive to humans. We have a history of facing hazards in search of valuable resources. From the gold rush in the 1800s to the recent surge in space resources, hu-



mans have been willing to take risks to find and collect scarce and profitable materials.

With advances in space technology, we're on the edge of the next gold rush — but not on Earth. Based on recent scientific and engineering breakthroughs and commercial interests, off-Earth mining is expected to begin in the next decade.

THE NEXT GOLD RUSH IS FAR, FAR AWAY

Potential mining sites include the Moon, Mars and its moons, asteroids and even comets. Market predictions for lunar mining - particularly lunar water · project a multibillion-dollar industry by 2050. Although theoretical, these forecasts signal a worthwhile market, with Australia as a potential leader.

The motivation for off-Earth mining is multifaceted: access to an unlimited wealth of valuable space resources, the spirit of discovering new planets and the development of spin-off technologies to be used back on Earth.

NASA's Artemis programme, which Australia supports via its signing of the Artemis Accords, is aiming for a lunar colony and eventually one on Mars. The only way to reduce the enormous costs of transporting resources from Earth will be through the establishment of self-sustaining infrastructure. Water is an essential starting

point. When converted to oxygen and hydrogen, it can be used as a propellant for rockets for further space missions. Given the vast reserves of lunar ice, it's a sustainable and economical source compared with Earthly transport. The Australian Centre for Space Engineering Research,

based at the University of New South Wales, is at the forefront of this endeavour, merging terrestrial mining engineering expertise with space research. The Off-Earth Mining Forum was founded in Sydney in 2013. Since then, it has run every two years. In August this year, the first non-Sydney-based event took place in Perth, Western Australia.

Its primary objective is to position Australia as a global leader in in-situ resource utilisation by harnessing space resources to reduce potential risks of off-Earth mining. This encompasses using lunar regolith (soil) for construction or mineral extraction, focusing on lunar water.



Metal-mining pollution impacts 23mn people globally

n estimated 23 million people around the world live on flood-plains contaminated by potentially harmful concentrations of toxic waste from metal-mining activity, according to a study. The research, published re-

cently in the journal Science, provides new insights into the extensive impact of metal mining contamination on rivers and

floodplains across the world. Using a new georeferenced global database of 185.000 metal mines and employing a combination of process-based modelling and empirical testing, the research assessed the global scale of metal mining contamination in river systems and its repercussions for human populations and livestock.

The study modelled contamination from all known active

and inactive metal mining sites, including tailings storage facilities – used to store mine waste. It looked at potentially harmful contaminants such as lead, zinc, copper, and arsenic, which are transported downstream from mining operations, and often deposited along river channels and floodplains for extended peri-

ods. "Our new method for predicting the dispersal of mine waste in river systems worldwide provides governments, environmental regulators, the minindustry and local ing communities with a tool that, for the first time, will enable them to assess the offsite and downstream impacts of mining on ecosystem and human health,

said Professor Mark Macklin, from the University of Lincoln, UK.

"We expect that this will make it easier to mitigate the environmental effects of historical and present mining and, most importantly, help to minimise the impacts of future mining development on communities, while also protecting food and water se curity," said Macklin, who led the research.

Released against the backdrop of growing demand for metals and minerals to feed the demands of the green energy transition, the new results highlight the widespread reach of the contamination, affecting approximately 479,200 kilometres of river channels and encompassing 164,000 square kilometres of flood plains on a global scale.

According to the findings, approximately 23.48 million people reside on these affected floodplains, supporting 5.72 million



livestock and encompassing over 65,000 square kilometres of irrigated land.

Due to a lack of available data for several countries, the team behind the study believes these numbers to be a conservative estimate.

Various pathways exist for humans to become exposed to these contaminant metals including from direct exposure through skin contact, accidental ingestion. inhalation of contaminated

dust, and through the consumption of contaminated water and food grown on contaminated

soils, the researchers said. This poses an additional hazard to the health of urban and rural communities in low-income countries and communities dependent on these rivers and floodplains, especially in regions already burdened with waterrelated diseases, they said.

In industrialised nations in Western Europe, including the UK, and the US, this contamination constitutes a major and growing constraint to water and food security, compromises vital ecosystem services, and contributes to antimicrobial resistance in the environment.

'Rapid growth in global metal mining is crucial if the world is to make the transition to green energy," said Professor Chris Thomas who led the analysis and modelling.

"Much of the estimated global contamination we have mapped is a legacy from the industrial era rightly, modern mining is being encouraged to prioritise environmental sustainability." Thomas said.

Professor Deanna Kemp from the University of Queensland in Australia, who was part of the team behind the study, called the results "sobering."

Nayagarh, Sept 25: Agriculture in Nayagarh district is suffering as many of the deep lift irriga tion (LI) projects are lying defunct for a long time. Sources said Monday that most of the LI projects are of no use for cultivation. As per a government report, 428 out of 1,323 deep lift irrigation projects in this district have become useless.

However, sources said that more than 800 LI projects are lying defunct in this district. They pointed out that the government is spending huge amounts for installation of this particular type of irrigation project. What however, surprises them is that no review is being

Man hacked to death in Ganjam

Berhampur, Sept 25: A 22-yearold man was allegedly hacked to death and his body was dumped in a forest area in Ganjam district, police said here Monday. The body of the deceased, identified as Sunil Nayak, was found in Brundabanpur under Pattapur police station area Sunday, they added. Police arrested Monday two persons in connection with the incident. They were identified as Kuna Dalai (20) of Brundabanpur and S Malesu Patra (25) of Podamari.

Preliminary inquiry revealed an old enmity between Sunil and Kuna led to the murder, said Sabyasachi Malla, the inspector-in-charge of the Pattapur police station. Patra, the other accused person, allegedly helped Kuna in committing the murdone as to whether the projects

are running smoothly or not. Sources informed that Ranpur block with 580 has the highest number of LI projects. Nuagaon block has 290, Odagaon block 273, Nayagarh 108. The remaining LI projects are scattered over various other blocks. Out of the 1,323 projects, 1,265 run on power while the remaining 58 are solarpowered ones. The government report states

that these LI projects have been set up to provide water to 6,615 hectares of farmland during cultivation. Sadly the report also states that 2,090 hectares of farmland do not get any water through irrigation as 428 LI projects do not function properly.

To help farmers get proper

supply of water, the state gov-ernment decided to install 400 deep lift irrigation projects in FY 2021-22. So far 272 projects have been completed, out of which 58 failed to produce any water. In essence it means that 214 LI proj ects have proved successful. Permission to provide electricity to run the LI projects has already been granted by the government and the work order to this effect was issued in June this year. These successful projects will be handed over to farmers soon, sources said.

Local farmers however, pointed out that no one is trying to ascertain whether these LI projects will be useful for them. Farmers Sudam Sahu of Gania, Bibhti Nayak of Daspalla, Pabitra Swain of Nayagarh said the majority of deep LI points do not work. They have lodged repeated complaints on this issue to the concerned authorities. However, they added that no one is addressing their needs. Some even alleged that officials are pocketing government funds by showing inflated figures pertaining to LI points in the district.

Executive engineer Dushasan Jena of Nayagarh Lift Irrigation division said that the defunct projects are being activated while new ones are being set up

The saree has also received the geographical indication (GI) tag. The famous Tata Tea brand has also printed the picture of Habaspuri saree on its packets. However, the state government and the district administration

have shown no interest in promoting the saree in national and international markets. This has affected production and pushed it to the verge of extinction with its weavers losing their livelihood.

Sources said that Kondh tribals first started weaving the Habaspuri saree in the 19th century. Later, the members of Bhulia (weaver) community of Habaspur village under Junagarh block accepted it as their traditional occupation by reviving the production of Habaspuri saree.

With passage of time, the handwoven saree witnessed a decline in demand after various fancy products made their way into the

markets. Many of the weavers also let go of their traditional art and took up other occupations for a living. As a result, Habaspuri sarees vanished from stores in the markets.

The Bhulia weavers living in Habaspur village under Junagarh block revived the saree with their own intricate designs and patterns; thereby the saree got its name. However, it has become almost extinct from Habaspur village due to lack of government sponsorships and unavailability of raw materials. Despite weavers in Habaspur village seeking other jobs for a better life, the unique art is now being carried forward by weavers of other villages under the block. Earlier, over 20 weaver families in Habaspur village were engaged in weaving saree, napkins (gamchha), lungi and door and window curtains that were in high demand both in domestic and foreign markets.

Help however, has arrived from various quarters. The district administration in assistance with Vedanta Aluminium sanctioned ₹10 lakh for revival of the handloom weaving centre in the village in 2022. The house has been renovated, but till now no effort has been made to address the problems of the weavers. Local intelligentsia and residents demanded the state government's active intervention and measures for revival of the famous saree.

Road Tragedy

he recent late night road mishap that resulted in the death of a young medical practitioner Dr Amit Bisoi on 23 September at Bomikhal, Bhubaneswar should act as a warning signal for the authorities. There is no doubt that the road and highway infrastructure across Orissa has considerably improved during the past few years. Most single lane roads have been doubled or quadrupled which in turn has prompted drivers to press on the accelerator and speed up. One can also observe that with economic development more modern vehicles of various brands are plying on the roads. While vastly improving the infrastructure, no one seems to be paying attention to the needs of maintenance and upkeep of the roads and streets. Corrupt and inefficient practices during the construction of these roads also make them easily susceptible to the vagaries of nature. One of the prominent examples could be seen during the construction of the Bomikhal flyover stretching from Saheed Nagar to Cuttack-Puri Road over the train track. This over-bridge collapsed twice, first killing a scooter rider on 10 September 2017 and the second incident that occurred on 3 May 2018 killed one of the construction workers. Even today, that flyover is a traffic deathtrap. This is proven by the accident of a motorbike rider who hit the wrongly designed divider at the T-junction and fell down from the bridge thus meeting with an instant death. All this demonstrates faulty road designs, absolutely zero concern about traffic control and callous road maintenance. This is not limited to the 'smart city' Bhubaneswar alone. From Balasore to Berhampur, from Sambalpur to Malkanagiri, the humungous road infrastructure of Orissa seems to be waiting to kill or maim drivers and pedestrians alike.

Interestingly, names of prominent personalities are generally put up on roads and bridges to mark the inauguration of that stretch. The fa-

talities in Orissa should alert the authorities that it is more important to prominently display the names of the engineers in charge, the designers and the contractor/executioner of those projects so that those individuals will have accountability for faulty workmanship. Modern vehicles with faster pickup are enticing drivers to speed up. While these vehicles are meant for roads used by traffic regulation conscious citizens, sadly one observes a total lack of traffic



awareness amongst the people. Pedestrians too do not have the safety of raised and even sidewalks which forces them to walk on the roads. Many cases have been reported where pedestrians have fallen into open drains and their bodies have been recovered a few kilometers away. All such deadly accidents keep repeating because there is no accountability or responsibility. Added to this, driving licenses are issued to untrained and illiterate individuals incapable of deciphering road signs and written instructions.

It is pertinent to understand that modern communication will depend on improved road connectivity. The near future will usher in an era of AI controlled self driven vehicles that will very soon populate the roads of Bhubaneswar and Orissa too. Large stretches of roads and bridges being built in the 2020s seem to be unfit for the future vehicles. Bringing down road fatalities drastically will imply constant monitoring of new road constructions as well as their upkeep. Blind and lopsided growth is killing people on a daily basis. Immediate corrective action can and must be taken. The starting should be done by strict monitoring of traffic violations and hefty fines imposed on those who deny safety to others. The cops should stop checking people for helmets and instead check drivers under the influence of alcohol, wrong side drives, jumping traffic lights and general mischief and erratic driving on the roads. A sustained drive by traffic police on these few points will greatly help decrease road fatalities and will encourage people to be responsible for their actions.

RACE TO BOTTOM

he abusive and communal epithets hurled by the BJP MP from South Delhi Ramesh Bidhuri against the BSP MP Kunwar Danish Ali represent a race to the bottom, as language that should be banned on the streets is spoken in Parliament from the treasury benches. At this stage, the BJP is trapped by the disease of competitive communalism and attention-seeking. some of its ambitious members trying to grab the stage in desperate ways with displays one worse than the other. The lack of strong and swift action against Bidhuri legitimises such abuse. and indeed messages others that it is okay to play in this muck and contribute to a rising crescendo of communal hatred as we prepare for the 2024 elections. An immediate example is the claim by another BJP MP that Bidhuri was provoked, but that statement, too, is an at-

tempt to inject more commu-

nalism into the picture. That Bidhuri's unspeakable and violent words came while he appeared to be defending the Prime Minister should ideally and in normal circumstances be seen as an affront to the Prime Minister. There are other ways to respond to the charge, which essentially was on a different topic - that the PM grabbed attention and took credit for the moon mission instead of leaving ISRO to bask in the glory. That the rebuttal to the accusation is abuse actually makes the accusation stick, does a disservice to the PM and the party (never mind the merits or demerits of the accusation) and should shock the leadership. Further, that Bidhuri defiled Parliament in the very first session it met there in the new building marks another hijacking of what will be billed as an important achievement by the BJP. The PM himself has called the new edifice "not just a new building but the symbol of a new beginning." Bidhuri

got to give that "new beginning" a very ominous meaning. And he also ended up diverting attention away from the Nari Shakti Vandan Adhiniyam, the women reservations bill which the Prime Minister has called "a historic legislation which will further boost women empowerment ..." This should be enough to attract stern action. That this action was not forthcoming as of Sunday night beyond the issuance of a show-cause notice raises many questions.

The key of these should be the nature and character of the new BJP as it prepares to fight 2024, overtly confident that it will be returned to power but not exactly unconcerned about the "surprise" that Rahul Gandhi says awaits the party. The coming together of the Opposition, even though decried by some as a patchwork solution rather than a unified presence, has without doubt worried the BJP. There is also a strong anti-incumbency undercurrent at play, not to add the vigour with which the Opposition is taking its story to the people and responding on social media. Under these circumstances, and particularly since there are reports that the INDIA alliance appears to be picking up steam, the easiest

approach would be to fall back on the staple of communalism. If this is considered a sure-shot winner, as many in BJP tend to think, then the nation must brace for a rather horrible campaign as individual candidates race ahead of the sanctioned narrative, and land up in spaces like the one Bidhuri occupied in Parliament.

The nature of the rogue speech, the silence of the BJP leadership, the obvious pain displayed by Danish Ali who said he couldn't sleep the night the remarks were made is the exact way the cycle of abuse and violence has played out outside of Parliament. The question that was thought to be outside on the streets for those oppressed: "Where do ordinary people go for justice?" has now reached Parliament, with a Member of the Lok Sabha now asking: "Where do we go to for justice?" This is without doubt a terrible slide for the nation. At the root of this fall is the

belief among the BJP that assertion means aggression, that hitting out is the best form of defence, that violence is in our grain and must be met with double the violence, that the "other" must be put down, that the grammar of leadership is

masculine in form, shape and ac tion. This is the old language of power and control, a spent force positioning in the world of today It represents a poor projection of this nation as a harsh and desolate landscape of bitterness. We are creating a Bharat without its ideas of grace, love and togetherness. In the absence of these. India cannot thrive as a nation. however advanced the infrastructure, the businesses or other tools of modernity.

Some of these ideas will come up during the election campaign to challenge the BJP. "Love" is a language that the Congress has spoken of often in recent times. There is no doubt that the BJP campaign this time will be even more slick, well oiled, properly timed and luxuriously funded. The Opposition will be no match in money power. Yet, there are no guarantees. As the savvy former PM VP Singh once said: "In India, you can lose an election for want of money but you can never win an election just because you have money!'

While we await the formal blowing of campaign bugles. there is an easy way out of the situation created in Parliament The BJP leadership as a whole can apologise, its senior leaders including the Prime Minister can meet up with Danish Ali and assure him and the nation that this won't happen again, suitably punish the offender in this case and walk away from the ugly and choose to take the high ground. Just how many from those among the BJP ranks and those ranged against the party think that such a path is possible, desirable, even profitable? And thereby hangs the tale of a nation that can break barriers to reach the moon while it builds new barriers in the hearts and minds of the people.

THIS DAY IN HISTORY

WISDOM CORNER

- **1580:** Francis Drake completes circumnavigation of the world, sailing into Plymouth aboard the 'Golden Hind.' Also known as Drake's Raiding Expedition, the circumnavigation was an important historical maritime event that took place between 15 December 1577 and 26 September 1580. The expedition was authorised by Queen Elizabeth I and consisted of five ships led by Francis Drake. Termed a 'voyage of discovery,' it was in effect an ambitious covert raiding voyage and the start of England's challenge to the global domination of Spain and Portugal.
- **1815:** The Holy Alliance of Russia, Austria, and Prussia was formed after the final defeat of Napoleon. The alliance aimed to restrain liberalism and secularism in Europe in the wake of the devastating French Revolutionary Wars and the Napoleonic Wars; it nominally succeeded in this until the Crimean War. Chancellor Otto von Bismarck managed to reunite the Holy Alliance following the unification of Germany in 1871, but the alliance again faltered by the 1880s over Austrian and Russian conflicts of interest over the dissolution of the Ottoman Empire.
- **1960:** The first in a series of historic televised debates (seen by some 85 to 120 million viewers) between the United States presidential candidates John F. Kennedy and Vice President Richard M. Nixon was broadcast this day in 1960.
- 1969: Apple Records releases The Beatles' 11th studio album "Abbey Road," their final recordings as a quartet; tops the charts in 11 countries. It is the last album the group recorded, although "Let It Be" was the last album completed before the band's break-up in April 1970. Critics view "Abbey Road" as one of the Beatles' best and rank it as one of the greatest albums of all time. George Harrison's two songs on the album, "Something" and "Here Comes the Sun," have been regarded as among the best he wrote for the group. Instead of focusing on lowering the external debt to a sustainable level, however, the agreement aims to bring down total debt, thereby reducing the haircut imposed on foreign creditors to just 30%

This has exacerbated the crisis and is difficult to justify. In countries that do not issue global reserve currencies, there is a clear distinction between domestic and external debt. Governments can and do service

sitates either foreign-exchange earnings or new borrowing.

> Sri Lanka's crisis is largely the result of the country's inability to service its external debt due to insufficient foreigncurrency reserves. Since 2016, the government has preferred to take on new international loans, primarily from private lenders, to repay its foreign creditors, including bilateral and multilateral lenders. In early 2022, the government chose to default on its foreign loans rather than explore alternative solutions.

But restructuring domestic debt in an economy already in decline is both painful and unnecessary. Sri Lanka's domestic debt is held by various entities, including the central bank, commercial banks, and pension funds. Given that the country's banking system is already severely weakened, pension funds will almost certainly bear the brunt of the expected adjustment.

Many workers whose life savings are invested in these retirement funds earn wage incomes well below the minimum

ployed in the garment industry and tea-plantation workers, especially those from minority Tamil groups. These groups have already experienced an alarming decline in living standards. Nearly 56% of Sri Lanka's 22.2 million people are now grappling with multidimensional vulnerabilities, with women and girls being the hardest hit.

By targeting the meagre pension funds of Sri Lanka's wage workers, the government's domestic-debt restructuring plan is likely to exacerbate existing class, gender, and ethnic inequalities. A genuine resolution to Sri Lanka's prolonged economic crisis would require a dramatic change in strategy. To bring about a robust economic recovery, the government and the IMF must focus on improving the lives of working people rather than imposing on them the burden of adjustment.

Pak economic crisis

Sir, The World Bank has cautioned Pakistan that nearly 100 million of its population has fallen below the poverty line. The Washington-based lender on Friday urged the cash-stripped country to take urgent steps to achieve financial stability. It also unveiled draft policy notes for Pakistan's next government, Express Tribune newspaper reported. The election commission has announced that the polls would take place during the last week in January. The country is currently led by interim PM Anwaar-ul-Haq Kakar. The World Bank noted that poverty in Pakistan rose within one year from 34.2 per cent to 39.4 per cent, with 12.5 million more people falling below the poverty line of the USD 3.65 per day income level. The institution added that about 95 million citizens live in poverty. Tobias Haque, the World Bank's lead country economist for Pakistan, said that the country's "economic model is no longer reducing poverty, and the living standards have fallen behind peer countries." The World Bank further urged Pakistan to tax its "sacred cows" - agriculture and real estate. It further asked the Asian country to chop off wasteful expenditures in an effort to achieve economic stability through steep fiscal adjustment of over 7 per cent of the economy. The World Bank is deeply concerned about the economic situation of today. "This may be Pakistan's moment for significant policy shift," said Najy Benhassine, the country director for Pakistan at World Bank

Women dominate HP's grassroots politics

The women's power has prevailed against the sale of liquor, tobacco, cigarettes and gambling too

Shimla, Sept 25: Panchayats in Himachal Pradesh, where women voters outnumber men in every election, have been fair to women much before the passage of the Women's Reservation Bill in the Parliament.

Over a decade-and-a-half now the state government has reserved 50 per cent seats for women in all Panchayati Raj institutions -- up from the villagelevel third tier of governance except for the post of 'up-pradhan' which is open.

The result: Women, apart from contesting the 50 per cent seats reserved for them, are giving a tough fight to men in panchavats not reserved for them. The women's power has prevailed against the sale of liquor, tobacco, cigarettes and gambling too.

On an average, close to 60 per cent of seats are occupied by the women in grassroots politics, officials told IANS.

The state assembly passed the Himachal Pradesh Panchayati Raj (Amendment) Bill on April 8, 2008, leading to an increase in the reservation limit for women in panchayati raj institutions to 50 percent from 33 percent.

The Bill, introduced by the then BJP government led by Prem Kumar Dhumal, was passed unanimously, but Congress MLA Kuldeep Pathania, who is now the Speaker of the legislative assembly, had to face the ire of women legislators, including Renu Chaddha



and Urmil Thakur, who termed him anti-women.

Adopting a strategically important tool to mobilise women. Mahila Gram Sabhas are being organised twice a year to exclusively discuss issues relating to women, children and issues concerning overall development in panchavats.

The state has 3,195 panchayats, 75 panchayat samitis and 11 zila parishads

Elections are held for around 27,000 seats and 50 percent reservation means almost half of the seats would be occupied by women only, an election official told IANS.

Each panchayat has one post each of 'pradhan' or president and 'up-pradhan' or vice-president and five to 21 posts of 'panch' or ward members, depending upon the population of the panchayat. Only the post of 'uppradhan' is not reserved.

vears Besides reservation for women, there is also a provision of 15 percent reservation each for the Other Backward Classes and the Scheduled Castes. In both the cases, there is also a quota within the quota for women. The women-led panchayat of

Bandraul in Kullu district is an example of the 'pink revolution'. With a population of 2,500. the panchayat is a hub of women weavers of Kullu shawls -- a symbol of feminist empowerment and a source of rural prosperity. Its head Nirmala Thakur told

IANS that they try their best to solve their problems on time. 'We inform the weavers about the sources of their income and

benefits," she said. Apart from 40 women weavers,

self-help groups in the panchayat

are making woollen caps, mufflers, socks and gloves, which they are marketing across the country. Joint Secretary Panchayats Niraj Chandla believes, "As the participation of women is increased in the panchayati raj institutions, their role and responsibility has also increased accordingly and we get to see progressive panchayats because of women participation."

In the 2010 panchayati raj elections, the first with reserved 50 percent seats for women, a remote Kamru village in Kalpa block of Kinnaur district set an example by unanimously electing an all-women panchayat.

At that time the panchayat had 1,100 voters -- mostly tribals. Interestingly, the Cheuni pan-

chayat in Seraj assembly constituency, the remotest in Mandi district with a population of over 1,600, took the lead in 2017 in passing a resolution banning cigarettes, liquor and playing cards in its jurisdiction.

Taking a cue, at least 15 nearby panchayats have also passed such resolutions.

So is the women's clamour against liquor that also grows louder. Women's brigades across the state, especially in the rural areas, have been demanding the closure or shifting of liquor vends, mainly from residential localities

In Shimla, Kullu, Sirmaur, Kangra, Hamirpur and Mandi districts, the protests by the women against the liquor shops have been common.

Morbi town of Gujarat collapsed on October 30 last year, killing 135 persons, including women and children, and injuring 56 others. During the last hearing on August 31, Advocate General Kamal Trivedi informed the court that the SIT's final report of its probe into the collapse would be out in three weeks and subsequently submitted before the bench.Trivedi had also told the court that the government has paid Rs 50 lakh each to the kin of the seven children who lost both their parents in the bridge collapse and the government is taking care of their schooling and food under different government schemes

The kin of each deceased had been given Rs 20 lakh, of which Rs 10 lakh was from the government and an equal sum from the Oreva Group, which was responsible for the operation and maintenance of the more than 100-year-old suspension bridge.

In November last year, the Supreme Court had asked the high court to periodically monitor the probe and other aspects of the tragedy, including rehabilitation and award of compensation to the victims or their families.

Sept 25: Ahmedabad. Ahmedabad, a city where time seems to stand still, boasts of rich history, culture, and architecture. Cross the Sabarmati River, and you find yourself in old Amdavad, a place where every lane whispers tales of the past.

In old Amdavad more than 360 pols (housing clusters) emerge. each a unique blend of religious and caste diversity, showcasing a kaleidoscope of architectural styles. Ahmedabad's journey to UNESCO World Heritage Site status was a carefully curated process. The selection criteria for a World Heritage Site are stringent and demand exceptional cultural or natural significance. In Ahmedabad's case, it was the city's rich Indo-Islamic heritage, dating back to the 15th-17th centuries that caught the UNESCO's attention. Tombs, temples, gates, and exquisite monuments were among the treasures recognised. However, Ahmedabad's journey has not been without hurdles. Maintaining its World Heritage City status has been an ongoing challenge. UNESCO experts were initially skeptical, as the city lacked a comprehensive plan to safeguard its ancient citadels, mosques, and tombs. The city received a warning and now faces a potential review of its World Heritage status.

A 2019 survey revealed that 30 per cent of the heritage properties in Ahmedabad were compromised or vulnerable. The Heritage Conservation Committee (HCC), an independent body overseeing conservation measures, raised concerns. Buildings were demolished. spots lay vacant, modern structures merged with heritage buildings, and many structures were in a poor condition.

The battle to preserve this heritage is real. "Many heritage houses are in dire need of renovation, and homeowners often find themselves struggling to navigate the complexities of heritage conservation. Water leakages, crumbling walls, and sanitation issues are common problems." said a local who has lived in old Amdavad all his life. Madhish Parikh, founder, Elixir Foundation and a dedicated advocate for Ahmedabad's heritage. expressed, "The local residents lack the necessary financial resources to undertake property restoration. The current process mandates that they initiate restoration, incur the expenses, and subsequently apply for Floor Space Index (FSI) bonds from the AMC for cost reimbursement. Individuals possessing Transfer of Development Rights (TDR) certificates receive a 20 per cent refund initially and the remaining 80 per cent upon completion of the restoration project. This intricate cycle poses a significant challenge to the preservation of Ahmedabad's precious heritage.'

GUJARAT FLOODS After backlash, govt unveils relief package

Ahmedabad, Sept 25: The Gujarat government has introduced a special relief package for the farmers affected by the recent flooding caused by the over-

flowing Narmada River in Bharuch, Narmada, and Vadodara districts between September 16 and September 18.

Previously, the ruling BJP had faced criticism from the opposition, including the Congress and AAP, who accused the party of insensitivity toward the flood-affected residents in low-lying areas, and labeled the situation a 'man-made disaster.' Following a report on the estimated damages incurred by standing crops in the three districts due to the river flooding, the government has decided to allocate a special relief package from the state budget, in addition to the State Disaster Response Fund (SDRF), to assist farmers in recovering their losses.



Earlier, Congress spokesperson Manish Doshi pointed out, "Despite heavy rain in Madhya Pradesh and continuous monitoring of water levels in the Narmada dam, SSNNL officials did not release an adequate amount of

water September 15 and 16. Instead, they waited for the dam to overflow September 17, causing massive flooding downstream."

The relief package will benefit farmers who have suffered a loss of 33 per cent or more in agricultural and horticultural crops during the kharif season 2023-24 in the affected villages, as declared by the district administration, with a maximum cap of two hectares.

For non-irrigated agricultural crops, affected farmers will receive Rs 8,500 per hectare as per SDRF norms. For irrigated agriculture and rainfed horticulture crops, they will receive Rs 8,000, in addition to Rs 17,000 per hectare as per SDRF norms.

Row over Maha BJP chief's 'manage scribes' audio clip

Mumbai, Sept 25: An audio clip of Maharashtra BJP chief Chandrashekhar Bawankule in which he purportedly asked the party workers to take journalists to dhabas and treat them well to avoid negative publicity ahead of polls has gone viral, inviting allegations that BJP was trying to manage the media.

These "instructions" were purportedly given by Bawankule in Ahmednagar where he was addressing a gathering of BJP workers on the management of poll booths. Under fire from the opposition, Bawankule clarified that he only meant that journalists should be treated with respect and that the party workers should try to understand their opinions about the allocated booths.

In the audio, Bawankule can be heard saving that "small-time video journalists running news portals and residing in your booth areas sometimes present a minor incident as if some blast has taken place". "Prepare a list of such nuisance-creating journalists, including those from the electronic media or print, and invite them for a cup of tea to dhabas so that they would not write anything against us ahead of Maha Vijay 2024. You know what I mean by inviting them for a cup of tea," he added. If there are some shortcomings Sujay Vikhe Patil, local BJP MP, is there, he added.

news comes out against us. There should be positive news about us. Protect your own booths first," Bawankule said. Reacting sharply, Maharashtra opposition leader Vijay Wadettiwar said, "Not all journalists are sold out. Do you think journalists accept crumbs? An FIR under sections 143 (unlawful assembly), 147 (rioting), 153 (wantonly giving provocation with intent to cause riot), 323 (voluntarily causing hurt) and 341 (wrongful restraint) of the IPC was lodged during the day against six identifiable persons, police said.

Police said it is not yet clear whether any outfit has any role in the alleged incident.

An officer of Kadakkal police station said that according to the soldier's complaint, he saw some persons standing near his home while he was returning on his bike.

On asking them why they were there, they said somebody was lying drunk in the nearby rubber plantation and asked the soldier whether he knew that person, the complaint said.

MUSLIM STUDENT SLAPPING CASE SC pulls up UP govt for shoddy probe

New Delhi, Sept 25: There cannot be any quality education if a student is sought to be penalised on the ground that he belongs to a particular community, the Supreme Court Monday said, as it pulled up the Uttar Pradesh government for shoddy probe in a case where a Muslim school boy was allegedly slapped by his classmates on the instruction of his teacher in Muzaffarnagar.

As published details aver, the petitions filed in 2018 and 2019, are grounded on two principal legal tenets, i.e. the Right to privacy guaranteed under Article 21(Right to life and personal liberty) of the Indian Constitution and the doctrine of manifest arbitrariness which is against the essence of Article 14(Right to equality) of the Indian Constitution.

The first petition challenging the prohibition law was filed in 2018, in which several sections of the Gujarat prohibition Act, 1949 and several rules of the Bombay Foreign Liquor



Rules, 1953 were challenged. In 2019, five more petitions were filed challenging the law in this regard. The two main grounds for the challenge was the right to privacy which has been by the Apex court in many judgements since 2017 and the manifest arbitrariness in as much as who gets to drink and who does not. This pertains to health permits and to temporary permits given to out-of-state tourists which is violative of the Right to Equality under Article 14 of the Constitution, it has been made out.

The October 9 hearing is a sequel to the August 2021 decision of the Gujarat High Court Bench comprising the then Chief Justice Vikram Nath and Justice Biren Vaishnav that held the petitions to be maintainable and therefore to be heard on merits.

The preliminary objection then raised by the Gujarat government on the petition's maintainability was that the Act had already been upheld by the Supreme Court in its entirety in 1951. The judgement constitutes law declared under Article 141 of the Constitution and is therefore binding on the High Court which could not re-examine the issue. If a reasoned cause for it has come into being, the same can be examined only by the apex court.

After Narendra Modi came to power in Gujarat and began pursuing global investment to industrialise the state further, there was a move for a modicum of relaxation in liquor laws for industrial/business gatherings through liberal granting of 'permits' for the same However a major hooch tragedy in Ahmedabad in 2009 that left over a hundred people dead put paid to the efforts.

Geneva, Sept 25: Russian occupiers tortured Ukrainians so brutally that some of their victims died, and forced families to listen as they raped women next door, members of a UNmandated investigative body said Monday, in their latest findings from the field.

Erik Møse, Chair of the Commission of Inquiry on Ukraine, told the UN Human Rights Council in Geneva his team had "collected further evidence indicating that the use of torture by Russian armed forces in areas under their control has been widespread and systematic".

"In some cases, torture was inflicted with such brutality that it caused the death of the victim.



centres operated by the Russian authorities and chiefly against people accused of being Ukrainian informants.

The commission has previously said that violations committed by Russian forces in Ukraine, including the use of torture, may constitute crimes against humanity.

The UN body also found a "few cases" of violations committed by Ukrainian forces, Møse said, saying they related to instances of indiscriminate attacks and ill treatment of Russian detainees

Kyiv has previously said it checks all information regarding the treatment of prisoners of war and will investigate any violations and take appropriate legal action.

Last godfather of Sicilian mafia dies REUTERS

Italy, Sept 25: Italian Mafia boss Matteo Messina Denaro, who was convicted of multiple murders and was arrested in January after spending 30 years on the run, has died of cancer, officials said Monday.

Messina Denaro, 61, was suffering from cancer of the colon at the time of his arrest. As his condition worsened in recent weeks, he was transferred to a hospital from the maximum-security jail in central Italy where he was initially held.

He fell into a coma Friday and never regained consciousness.

"You shouldn't deny prayers to anyone, but I can't say I am sorry," Deputy Prime Minister Matteo Salvini said on Instagram.

Messina Denaro was found guilty of numerous crimes, including helping plan the 1992 murders of anti-mafia prosecutors Giovanni Falcone and Paolo Borsellino -- crimes that shocked Italy and sparked a crackdown on the Sicilian mob.



Islamabad: A top Pakistani court Monday ordered authorities to shift former prime minister Imran Khan from the Attock jail in Punjab province to high-security Adiala prison in the garrison city of Rawalpindi, according to media reports. The trading of barbs underscores the strained relations between China and the Philippines at a time when Manila is rapidly strengthening military ties with rival US, a move that has riled Beijing

Manila, Sept 25: The Philippines said Monday it executed a "special operation" to remove a floating barrier installed by China at a prime fishing patch in the South China Sea. a move that could stoke tension after a yearslong detente in Asia's most disputed waters.

The Philippines expressed outrage Sunday and shared images of Chinese coastguard policing a long, ball-buoy barrier near the Scarborough Shoal, a rocky outcrop 200 km (124 miles) from the Philippines and the site of years of intermittent flare-ups over sovereignty and fishing rights.

Hours after the national security adviser had vowed to take action, the Philippine coastguard said it had removed the floating cordon, at the behest of President Ferdinand Marcos Jr and his special task force on the South

China Sea. 'The barrier posed a hazard to navigation, a clear violation of international law. It also hinders the conduct of fishing and livelihood activities of Filipino fisherfolk," it said in a state-

ment, describing the shoal as 'an integral part of the Philippine national territory". China's foreign ministry made

no direct mention of the floating barrier but earlier Monday defended the actions of its coastguard as "necessary measures" after a Philippine bureau of fisheries vessel "intruded" into its waters Friday.

The strategic Scarborough Shoal, named after a British cargo vessel that ran aground on the atoll in the 18th century, was seized in 2012 by China, which has maintained a constant presence of coastguard and fishing

trawlers there ever since. **PEACEFUL COEXISTENCE**

Under the Philippines' pro-China former President Rodrigo Duterte, Chinese and Filipino fishermen had since 2017 enjoved a peaceful coexistence at the shoal, known for its stunning turquoise lagoon that serves as a sanctuary for fishing boats during storms.

The Philippines' foreign ministry said the barrier was a violation of international law and Manila would "take all appropriate measures to protect our country's sovereignty and the livelihood of our fisherfolk".

Japan's government urged calm and said the South China Sea was central to regional stability.

"Our country strongly opposes any conduct that heightens tension in the South China Sea,' Japanese Chief Cabinet Secretary Hirokazu Matsuno said at a regular press conference.

Control of the shoal is a sensitive issue for China as it formed part of a legal case filed by the Philippines at the Permanent Court of Arbitration in the Hague, which in 2016 ruled that Beijing's claim to 90% of the South China Sea had no basis under international law.

China has refused to recog nise the landmark ruling.

Toronto, Sept 25: A Canadian Sikh group has called on its members to protest outside the Indian diplomatic missions of main Canadian cities Monday, a week after Prime Minister Justin Trudeau raised the prospect of New Delhi's involvement in the murder of a Sikh separatist leader in British Columbia.

Trudeau said last week Canada was pursuing "credible allegations" that Indian government agents may be linked to the killing of Hardeep Singh Nijjar, who was shot dead outside a Sikh temple June 18 in Surrey a Vancouver suburb with a high Sikh population.

India swiftly denied any role in the killing and described the allegations as "absurd". The accusations have sparked tensions between the two countries, with each nation expelling diplomats, and New Delhi suspending visas for Canadians.

Jatinder Singh Grewal, a director for Sikh for Justice in Canada, told Reuters Sunday



that his organization will lead the demonstrations outside the Indian embassies and consulates in Toronto, Ottawa and Vancouver to increase public awareness about Nijjar's killing.

'We are asking Canada to expel the India ambassador," Grewal said. Representatives for India's diplomatic missions in Ottawa and Toronto were not immediately available for comment.

The Toronto Police Department said it was aware of the planned demonstrations Monday but declined to disclose details of the security preparations or potential response to any violent situations that may arise during the protest.





"Investors are likely to continue being cautious and direct their limited funding towards established business models, such as follow-on funding for companies in the mid-stream

Technology Sector', India's agritech sector witnessed its most successful year in terms of venture capital funding in 2021-22 financial year, followed by a significant decline in FY23 amid a global funding slowdown.

While FY22 witnessed a boom in agri-tech startup investments, which drove startup valuations to unprecedented heights, the correction in FY23 has led to a more prudent investment climate, it added

While the number of investment deals rose from 121 in FY22 to 140 in FY23, the total funding raised by agri-tech startups in India fell from \$1,279 million in FY22 to \$706 million in FY23

The report highlights that mid-stream agri-tech startups have begun to mature, with investments primarily in growth and late-stage funding rounds.

For example, 56 per cent of investments in startups focusing on output linkages and quality management were in their growth and late stages. The corresponding figure for other midstream startups, such as those offering agri-carbon or agri-fintech solutions, was as high as 91 per cent.

Many midstream tech startups have also ventured into inorganic expansion through strategic acquisitions, it added.

S&P RETAINS INDIA'S FY24 **GROWTH FORECAST AT 6%**

Indian economy grew 7.2% in 2022-23 fiscal year which ended March 2023

New Delhi, Sept 25: S&P Global Ratings Monday retained India's growth forecast for current fiscal at 6 per cent citing slowing world economy, rising risk of subnormal monsoons and delayed effect of rate hike.

The US-based agency sees the recent spike in vegetable price inflation as being temporary, but revised up the full fiscal retail inflation forecast to 5.5 per cent, from 5 per cent earlier, on higher global oil prices.

Growth this year will be weaker than in 2022, but our outlook remains broadly favourable. Notwithstanding the strong expansion in India in the June quarter, we maintain our forecast for fiscal 2024 (ending March 2024), given the slowing world economy, the delayed effect of rate hikes, and the rising risk of



subnormal monsoons," S&P said in its Economic Outlook for Asia Pacific Q4 2023 report.

While retaining its growth forecast for the current fiscal at 6 per cent, S&P also maintained that India's economy will grow 6.9 per cent in both 2024-25 and 2025-26 fiscal years.

S&P said India's consumption growth as well as capital expenditure remained "strong" in the June quarter.

With regard to growth in the Asia Pacific region, S&P said it remains a "multi-speed region" and slightly raised its forecast for 2023 to 3.9 per cent amid domestic resilience.









INDIAN 10M AIR RIFLE TEAM CLAIM YELLOW METAL WITH WORLD RECORD SCORE, AISHWARY BAGS INDIVIDUAL BRONZE

Hangzhou, Sept 25: Indian shooters made a telling statement at the Asian Games, winning three medals, including a team gold, as the country's marksmen asserted their class by grabbing five podium finishes in just two days of competition here.

A confident Indian 10m air rifle team led by teenage World Champion Rudrankksh Patil gave the country its first gold medal at the Games, securing the top place on the podium with a world record score here Monday.

Aishwary Pratap Singh Tomar then earned the country an individual bronze – India's fourth in shooting so far - in the event after a third-place shoot-off with compatriot Rudrankksh, who finished fourth.

The triumvirate of Anish Bhanwala, Vijayveer Sidhu and Adarsh Singh totalled 1718 to win bronze in men's 25m rapidfire pistol event. In the individual section, Sidhu settled for the fourth position.

The trio of Rudrankksh Olympian Divyansh Singh Panwar and Aishwary aggregated 1893.7 in the qualification round to beat back the challenge of the shooting powerhouse China and South Korea on way to the team gold.

In one of the most dominating displays seen by Indian air rifle shooters in multi-discipline events, the 19-year-old Rudrankksh shot a superb 632.5, Tomar 631.6 and Panwar 629.6 to aggregate the world record score as South Korea was pushed to

second spot (1890.1), while the Chinese team was a distant third with an aggregate score of 1888.2.

India would be slightly disappointed at missing a gold, or a sliver, in the individual category following the red-hot form shown by both Tomar and Rudrankksh in the qualification round.

However, both the Indians could

not recreate the magic of the qualification round in the eightshooter finals with Tomar, after a dogged battle with Rudrankksh, edging out the teenage shooter to win bronze in shoot-off for third place, scoring 228.8.

Tomar was in contention for silver with Park Hajun after that but a rank bad final shot of 9.8 eliminated him, even as the South Korean went on to take the second spot behind China's Sheng Lihao, who won gold with a world record score of 253.3. Tomar, however, said he was consistent throughout save for the 9.8 shot.

Rudrankksh and Tomar had made it to the eight-shooter finals following their superb display in the qualification round, while Divyansh missed out

thanks to an Asian Games rule that allows only two marksmen from a country to enter the finals.

Rudrankksh entered the fi nals placed third, while Aishwary was fifth after the qualification round. Divyansh was placed eighth and, had it been a World Cup or a World Championship, or any other continental shooting competition, all three Indians would have been in the eight-shooter final

The Indian trio was just unbeatable on way to team gold with Rudrankksh, true to his form, shooting superb series of 104.8, 106.1, 103.8, 105.5 106.7 and 105.6. Aishwary had a series of 104.1, 105.5, 105.3, 105.7, 105.7 and 105.3 in qualification.

Divyansh, who represented the country at the 2020 Tokyo Olympics, shot a series of 104.8, 104.3, 104.6, 104.7, 106.3 and 104.9.

Rudrankksh was not included in the ISSF World Championshipbound squad to Baku by the National Rifle Association of India (NRAI) as the federation wanted to maximise the country's chances of bagging more Paris Olympic quota places for the country by sending other marksmen.

Rudrankksh has already clinched an Olympic quota place for the country by virtue of winning the World Championships gold in Cairo last year.

In fact, while the World Championships were on in Baku last month, he shot way better that the gold-medal winner in the Azerbaijan capital in simulated conditions created for him at the Karni Singh Ranges in Delhi.

Indore, Sept 25: Members of the Pakistan cricket team were Monday issued Indian visas for the ODI World Cup, the International Cricket Council (ICC) confirmed, hours after the PCB raised serious concerns with the global body over the delay in the national team's travel to Hyderabad.

The visa clearance came less than 48 hours before Pakistan's scheduled travel to India in the wee hours of September 27. They play their first warm-up game against New Zealand in Hyderabad September 29. "Visas have been issued to Pakistan," an ICC spokesperson told PTI. However, confusion remained in the Pakistan camp over the grant of visa. "We have not got the call from Indian High Commission yet over visa clearance. Member of our team is stationed there," PCB spokesperson Umar Farooq told PTI. The confirmation from the ICC came after the PCB wrote to ICC CEO Geoff Allardice Monday over the visa delay besides claiming the anxious wait has adversely impacted the team's preparation for the 50-over showpiece.

Hangzhou: Indian rowers staged twin comebacks to bag two bronze and sign off their Asian Games campaign in the watersport with five medals here Monday. India bettered their medal count from the last edition when they had three podium finishes. However, they failed to win a gold medal this time, something the rowing squad could boast of five years ago. Overall, India finished fifth here, an improvement of one place from their 2018 outing in Indonesia, where they had grabbed one gold and two bronze medals. Hosts China topped the tally with 11 gold, two silver, while Uzbekistan finished second with two gold. four silver and one bronze. The day began with the quartet of Jaswinder Singh, Bheem Singh, Punit Kumar and Ashish Goliyan narrowly missing a silver in men's fours event. Then the men's quadruple sculls team of Satnam Singh, Parminder Singh, Jakar Khan and Sukhmeet Singh finished third on the podium with a timing of 6:08.61 seconds, behind Uzbekistan (6:04.64) and gold medallists China (6:02.65). The quadruple skulls quartet improved from fourth place to finish third in the final 500-metre of the 2000-metre race. In the men's four event too, after lying fourth in the final 500 metre of the 2000 m race, the quartet showed superb coordination to finish third with 6:10.81s, and was pipped by China (6:10.04) by a fraction of seconds.
