

### **Graft case: OSAP Commandant held**

Bhubaneswar, Oct 1: Vigilance sleuths Sunday arrested Odisha State Armed Police, 1st Battalion, Dhenkanal, Commandant Sunil Kumar Behera on the charges of corruption.

Acting on a tip-off, Vigilance sleuths intercepted Behera near Madhusudan Setu in CDA Sector 11 area September 30 while he was coming from Dhenkanal to his residence in Cuttack by his official vehicle and recovered ₹1,31,535 from his possession.

Later, simultaneous searches were conducted at multiple places belonging to him in Dhenkanal, Cuttack, Bhubaneswar and Puri. "Rs 8.70 lakh in cash was re-

covered from Behera's residential quarters at Cantonment Road in Cuttack, leading to total recovery of ₹10,01,535, which he could not account for satisfactorily," said a Vigilance official.

### Four held for killing two Manipur youths

Imphal, Oct 1: Four people were arrested by CBI in connection with the kidnapping and killing of two Manipuri youths, and the government will ensure the maximum punishment for them, Chief Minister N Biren Singh said here Sunday.

The four, including the wife of the main accused, were taken "outside the state" by a special flight, Singh said.

Officials of the chief minister's secretariat said two minor girls, aged 11 and 9 years, were detained in connection with the case but they were released later. The two are daughters of the main accused.

Hangzhou, Oct 1: India had an impressive performance in athletics Sunday, securing a remarkable tally of two gold, four silver, and three bronze medals at the Asian Games. Tajinderpal Singh Toor achieved a remarkable victory in the shot put event, claiming the top spot on the podium, while Avinash Sable set an Asian Games record as he won the gold medal in the men's 3000m steeplechase.

Jyothi Yarraji initially won a bronze in the women's 100m hurdles. However, her achievement was later upgraded to silver due to the disqualification of China's Wu Yanni, who finished second, for a false start. Furthermore, the Indian badminton team accomplished a historic feat by securing the silver medal after an intense battle against China.

Bhawanipatna, Oct 1: Three bodies with throats slit were found at the roadside near Sankarpala village under Junagarh police limits in Kalahandi district, police said

The bodies, including that of a two-year-old boy and a woman, were found in a secluded area beside the Sankarpal-Dunda Road under Junagarh police station limits. deceased woman. The deceased were identified as Raimati Majhi, aged around 35 years, her two-year-old son Sibasakti and an elderly man, 60year-old Mahendra Kumar, a po-

lice officer said. While the bodies of the deceased mother-son duo were found lying on one side of the road, Mahendra's body was found on the opposite side. As the bodies have cut injury marks, lo-



cals suspect it to be a case of murder.

However, the reason behind the murders is yet to be ascertained and the weapon used in the crime yet to be found, Junagarh police station inspector-in-charge (IIC) Sesadev Behera said.

It was learnt that Braja Majhi, the husband of the deceased woman, is reportedly lodged in the district jail at Bhawanipatna for the murder of his aunt for the last nine years.

Police reached the crime scene and started an investigation. The bodies were sent for postmortem.

### Youth hangs self in City

Bhubaneswar, Oct 1: A 25-year-old youth was found hanging under mysterious circumstances inside his rented accommodation at GGP Colony in Rasulgarh area here, Sunday. The deceased Sachitra Barik of

Balipatna used to work at a shopping mall in the City.

According to sources, Barik was stayng at a rented house along with one of his friends in GGP Colony under Mancheswar police limits. Barik was alone Saturday night as his roommate had gone to attend a party. "I found the room was bolted from in-

side when I returned home Sunday morning. I knocked at the door and tried to contact Barik over phone several times but he did not respond. I immediately informed the owner of the shopping mall and the police, who reached the spot in some time. Police found Barik hanging from the ceiling fan with a towel," said the roommate

The police, in the presence of Barik's elder brother, seized the body and sent it to Capital Hospital for post-mortem.

### Commercial LPG price up by ₹209

New Delhi, Oct 1: Commercial cooking gas (LPG) rates were Sunday raised by a steep ₹209 per 19-kg cylinder, in line with the firming up seen in international benchmarks.

Jet fuel or ATF price was also hiked by 5 per cent -- the fourth straight monthly increase since July.

However, the price of domestic LPG the one used in household kitchens for cooking purposes - remained unchanged at ₹903 per 14.2-kg cylinder.

A 19-kg commercial LPG cylinder will now cost ₹1,731.50 in the national capital and ₹1.684 in Mumbai.

The increase reverses most of the strained airlines.

₹157.5 per cylinder cut in commercial LPG price effected September 1 and ₹100 cut effected from August 1.

ATF price was increased by ₹5,779.84 per kilolitre, or 5.1 per cent, in the national capital to ₹118,199.17 per kl from ₹112,419.33, according to a price notification of state-owned fuel retailers. The increase comes on back of the steepest-ever 14.1 per cent increase (₹13,911.07 per kl) effected September 1, and a 8.5 per cent or ₹7,728.38 per kl increase August 1.

The fourth straight increase in prices of jet fuel, which makes up for 40 per cent of an airline's operating cost, will increase the burden on already financially

### Ghost faculty in most medical colleges

None of the institutes met the requirement of 50% attendance, NMC report says

New Delhi, Oct 1: A majority of the medical colleges assessed in 2022-23 were found to have ghost faculty and senior residents, and none of the institutes met the requirement of 50 per cent attendance, the National Medical Commission has said.

The NMC said it found that none of them visit the emergency department regularly "because there is no one in the emergency medicine department to interact with them other than the casualty medical officer.'

"The posting in the emergency medicine department is supposed to be a break period for the students," the Under-Graduate Medical Education Board (UGMEB) of the NMC said.

The NMC said this in a reply to the Associations of Emergency Physicians



of India (AEPI) over their grievance regarding the exclusion of emergency medicine specialty as a requirement for setting up new medical colleges.

In a recently notified regulation, the NMC excluded the requirement of an emergency department for setting up new medical colleges. Earlier, in its June 23 draft, emergency medi-

cine department was among the 14 departments that new medical colleges approved for undergraduate admissions must have.

In its reply to the AEPI dated September 22, the UGMEB said the real picture on emergency medicine departments is different from what it looks like on paper.

"While checking the Aadhaar Enabled Biometric Attendance of these colleges, we were shocked to note that there was 100 per cent failure in all colleges with respect to the faculty and senior resident doctors employed to fulfil the requirements as per the MSR (Minimum Standard Requirement) 2020. Majority of the colleges had ghost faculty and SRS (senior residents) or had not employed the required faculty at all," the commission said in the reply.

### 65-year-old man killed by nephew over black magic

Bhawanipatna, Oct 1: A 65year-old man was allegedly murdered by his nephew who suspected that he was doing black magic, targeting him and his family, police said

The incident happened in Sikerguda village in Bhawanipatna Sadar police station area of Kalahandi district, they said

The nephew, 35, was suspecting the man of doing black magic to harm his family. When the man was working in the field, the accused allegedly attacked him with an axe and he died on the spot. Police said they have detained the accused, his brother and his father for questioning. An investigation is underway, they said.

### **Playwright Tripurari** Sharma passes away

New Delhi, Oct 1: Well-known playwright and former National School of Drama professor Tripurari Sharma passed away Sunday after a prolonged illness, her friend and actor Amitabh Shrivastava said. She was 67.

According to Shrivastava, who was Sharma's batchmate at the National School of Drama. she was suffering from a lung-related ailment since 2017 and had gone to Secunderabad for treatment where she died Sunday morning. "She was not keeping well for the last couple of years now. One of her lungs was not functioning at all because of this her family took her to Secunderabad for a lung transplant. However, I believe that just could not happen and this morning she passed away," Shrivastava told PTI.

Bhubaneswar, Oct 1: The Special Task Force (STF) of state Crime Branch Sunday claimed to have arrested two drug peddlers who were on the run for

months now. The arrested were identified as Md Sadam of Pipli in Puri district and Chittaranjan Behera of Fategarh in Nayagarh district.

STF sources said Md Sadam, an accused in an NDPS case who had been on the run for the last 20 months, was apprehended by the sleuths during a raid in

Khurda, Friday. About the case, an official said over 3 kilogram of brown sugar worth Rs 3.10 crore, arms, ammunitions and Rs 65.32 lakh in cash was recovered from Md Sadam and his associates during a raid in Nayagarh district January 24, 2022. Md Sadam and

his aides, however, had man-

aged to give the cops a slip during the raid in 2022.

About Chittaranjan, STF sources said he was on the run for two years now. Chittaranjan was nabbed by the STF from his hideout in Bhubaneswar here Friday. He is involved in a case registered at the STF police station December 20, 2021.

Earlier, Chittaranjan and two of his aides were arrested from Bhapur area of Dhenkanal district after heroin worth over Rs 1 crore was recovered from them. Chittaranjan, however, had then

managed to flee. Md Sadam and Chittaranjan were Saturday produced before courts in Nayagarh and Dhenkanal respectively.

### COURT NAMES CHILD

Kochi: The Kerala High Court has named a three-year-old child, after the girl's estranged parents could not arrive at a consensus on what they should name her. Justice Bechu Kurian Thomas, in an order issued last month said the name suggested by the mother, with whom the child is presently residing, has to be given due importance, while the name of the father is also to be incorporated due to the absence of any dispute on paternity. The matter pertained to an estranged couple fighting over their daughter's name. As the birth certificate issued to the girl had no name on it, her mother attempted to register a name. However, the Registrar of births and deaths insisted on the presence of both parents before him to register the name. As the couple could not arrive at a consensus on the name, the mother approached the High Court. The child was born February 12, 2020 and the relationship between the parents turned sour. The court, in its September 5 order, observed that while invoking its parens patriae jurisdiction. the paramount consideration was the welfare of the child and not the rights of the parents.

While such immune memory erasure would be unwanted for infectious diseases, it can stop autoimmune reactions like those seen in multiple sclerosis, Type I diabetes, rheumatoid arthritis or Crohn's disease, in which the immune system attacks a person's healthy tissues.

The inverse vaccine, described in the journal Nature Biomedical Engineering, takes advantage of how the liver naturally marks molecules from broken-down cells with "do not attack" flags to prevent autoimmune reactions to cells that die by natural

processes "In the past, we showed that we could use this approach to prevent autoimmunity," said lead author Jeffrey Hubbell, Professor in Tissue Engineering from the varsity's Pritzker School of Molecular Engineering (PME).

"But what is so exciting about this work is that we have shown that we can treat diseases like multiple sclerosis after there is already ongoing inflammation, which is more useful in a real-

The human body has a mechanism for ensuring that immune reactions don't occur in response to every damaged cell in the body -- a phenomenon known as peripheral immune tolerance and carried out in the liver. The team discovered in recent years that tagging molecules with a sugar known as N-acetylgalactosamine (pGal) could mimic this process, sending the molecules to the liver where tolerance to them develops. "The idea is that we can attach any molecule we want to pGal and it will teach the immune system to tolerate it," explained Hubbell.

"Rather than rev up immunity as with a vaccine, we can tamp it down in a very specific way with an inverse vaccine.' In the new study, the re-

searchers focused on a multiplesclerosis-like disease in which the immune system attacks myelin, leading to weakness and numbness, loss of vision and, eventually, mobility problems and paralysis.

The team linked myelin proteins to pGal and tested the effect of the new inverse vaccine. The immune system, they found, stopped attacking myelin, allowing nerves to function correctly again and reversing symptoms of disease in animals.

In a series of other experiments, the scientists showed that the same approach worked to minimise other ongoing immune reactions. "These treatments can be very effective, but you're also blocking the immune responses necessary to fight off infections and so there are a lot of side effects," said Hubbell. "If we could treat patients with an inverse vaccine instead, it could be muchmore specific and lead to fewer side effects."

### ChatGPT shows promise for effective psychotherapy

pen AI's ChatGPT-4 can accurately generate individualised personal narratives based on stream-of-consciousness thoughts and demographic details, two


studies have suggested. Previous research has shown that personal narratives -- the stories we tell ourselves about our lives -- can play a critical role in identity and help us make sense of the past and present. It is also known that by helping people reinterpret narratives, therapists can guide patients toward healthier thoughts and behaviours

To explore, researchers from the Positive Psychology Center at the University of Pennsylvania

tested the ability of ChatGPT-4 to generate individualised personal narratives.

The study findings, published in the Journal of Positive Psychology, showed that 25 of the 26 participants rated the AIgenerated responses as completely or mostly accurate, 19 rated the narratives as very or somewhat surprising, and 19 indicated they learned something new about themselves 'This is a rare moment in the

history of scientific psychology: Artificial intelligence now promises much more effective psychotherapy and coaching," said Martin Seligman, Professor of Psychology, and director of the Positive Psychology Center.

fed five narratives rated "completely accurate" into ChatGPT-4, asked for specific interventions, and found that the chatbot generated highly plausible coaching strategies and interventions.

'Since coaching and therapy typically involve a great deal of initial time spent fleshing out such an identity, deriving this automatically from 50 thoughts represents a major savings," the researchers said.

The team found that ChatGPT was able to, with just 50 streamof-consciousness thoughts and very basic demographic information, come up with a highly accurate and detailed personal narrative.

"This could be a tool for helping people gain self-insight. We see this as something that can be used in the therapeutic context, not as something that would replace a therapist," the researchers said.

"This research is exploratory; there is absolutely a need to continue the research and deploy this with coaches," they added. IANS

Sambalpur, Oct 1: The academic landscape of Sambalpur University is set to expand as the institution is planning to launch three new Post Graduate (PG) programmes from the next academic session. The varsity authorities have submitted a proposal to the government to introduce PG programmes in Education, Commerce and Sanskrit.

from the government shortly Official sources said, there is an Education department in Sambalpur University but it does not offer PG in Education. Instead, the department offers three year integrated B.Ed and M.Ed programmes. Currently, the varsity, which was established in 1967, offers 35 science and arts courses from 26 departments.

"Due to the emergence of new universities, the catchment areas of Sambalpur University have reduced. Nevertheless, the institution continues to remain the most preferred destination for numerous students in the region.' said Sarat Banji, a former student of the varsity.

Keonihar. Oct 1: Newly inaugurated Dharanidhar Medical College and Hospital (DDMCH) at Kabitra near Keonjhar town has failed to be of any use to the patients as it is yet to become fully operational months after its inauguration.

Chief Minister Naveen Patanaik had inaugurated the newly-built medical college and hospital, February 13. The medical college and the 385-beded hospital were built at a cost of ₹400 crore on 44.40 acre of land at Kabitra.

Residents of Keonjhar town felt relieved after the establishment of DDMCH. However, it has failed to serve its purpose for which it was established, locals alleged. Patients and their attendants continue to throng the district headquarters hospital (DHH) premises as the newly inaugurated hospital is vet to become fully functional inside the medical college campus.

Patients are having a harrowing time as they continue to throng the DHH for treatment. Many of them unaware of the non-functioning of the DDMCH



have to take rounds of its campus before finally converging at the DHH.

Studies of the medical students are going on inside the campus while the hospital unit continues to function from the DHH premises in Keonihar town even as over seven months have passed after its inauguration.

Notably, thousands of patients from Keonjhar and neighbouring Mayurbhanj, Deogarh, and Bhadrak districts as well as from neighbouring Jharkhand are dependent on the DHH in Keonjhar town.

This has resulted in overcrowding of the DHH and pagate of the DHH often gets blocked due to rush of patients tients have to wait for hours to get treatment. Things have come and their kin. to such a pass that the main

on a daily basis. The hospital has 21 clinical and non-clinical departments where doctors of the DHH and the DDMCH, including super specialist doctors appointed under DMF funds provide treatment to the patients.

However, owing to lack of space and absence of a reception counter the patients have to wait for long hours for their turn by sitting or sleeping on the floor in unhealthy conditions.

Various outfits have demanded more ticket and medicine counters in the hospital and to make the DDMCH fully functional. Patients often complain of not getting free medicines and tests under Niramaya scheme. As a result, they have to buy medicines and get their tests done outside by spending more from their pockets.

Patients are subjected to exploitation while the medicine shop owners, private clinics and nursing home owners rake in

moolah fleecing the poor patients, social activist Dillip Sahu said. Moreover, the DHH has no ICU facility for emergency patients. People said that the buildings in the DDMCH will soon get damaged if they are not put to use for a long time.

A senior citizen Alekh Chandra Patra of Gambharia area in Keonjhar town said that he had been to the DHH for check up with a doctor but had to return home after witnessing a huge crowd outside the outdoor ward

An attendant Navin Palai said that he had been to the DHH to get one of his kin treated, Tuesday. He noticed people jostling and shoving each other to meet the doctor and informed the hospital authorities. The district administration and hospital authorities should intervene and shift the hospital unit of DDMCH to the newly built campus, he said.

When contacted, hospital superintendent Dr Mahendra Nayak said he is aware of the problems and efforts are being made to shift the hospital unit to the medical college campus by December. However, the shifting may get delayed as several employees are vet to be appointed and medical equipment are not yet available at the newly built medical college and hospital, he added.

### awarded 2 yrs jail in corruption case

An ex-WEO of Nuagaon block in Nayagarh was awarded 4-yr jail and a retired VLW of Angul district sentenced to 3 yrs in jail in separate corruption cases

Berhampur/Bhubaneswar. **Oct 1:** A government official and his wife were sentenced to two years in jail by a court in a 14-year-old corruption case.

The Special Vigilance Court sentenced N Prakash Patra and his wife N Santoshini Patra to two years in jail after convicting them in the corruption case.

It was alleged that the couple amassed assets worth ₹12.19 lakh when Prakash was posted as a junior clerk at the Patrapur **Community Health Centre** (CHC) in Ganjam district about 14 years ago. He is at present posted at the Patrapur Sub-Divisional Hospital.

Special Vigilance Judge Arun Kumar Sahoo also imposed a fine of ₹10,000 on each of the two. Delivering the verdict Saturday, the judge said that they will undergo imprisonment for another three months if they fail to pay the fine amount, according to public prosecutor Surendra Panda.

The court convicted the couple after examining 25 witnesses and analysing his properties found during raids at his houses, office quarter and chamber, he said.

The official was caught redhanded while accepting a bribe, following which the raids were



#### conducted, said Panda.

The wife was arrested as she allegedly abetted the offence committed by her husband, he said. A Vigilance court in Bhubaneswar sentenced Ludasini Nayak, an ex-welfare extension officer of Nuagaon block in Nayagarh district, to four years in jail in a different corruption case.

A fine of ₹5,000 was imposed on her and in case she fails to pay it, she will undergo imprisonment for another two months.

The court also sentenced Nayak to three years in jail in a separate corruption case, besides imposing a fine of ₹5,000. Both the sentences will run concurrently, the court said.

A retired village-level worker (VLW) of Angul district, Sarbeswar Pani, was sentenced to three years in jail in another such case.

The Special Vigilance Court in Angul also imposed a fine of ₹5.000 on him, and if fails to pay it, he will undergo imprisonment for another two months.

The state Vigilance department said it will take steps for the dismissal of Prakash and Ludasini from service, and stop the pension of the VLW who has retired.

### FOCUS GANDHI JAYANTI

## **ASHRAMS FOR EDUCATION**

n the spring of 1915, a group from the Phoenix experiment in South Africa, where Gandhiji had founded in 1904 an Ashram type of community called the "Tolstoy Farm," were welcomed at Santiniketan by Rabindranath Tagore. The link between Gandhi and Tagore was furthered by CF Andrews who had made Santiniketan his home, and had suggested that Gandhi and a group of his followers should come to this Ashram when returning to work in India. Both Gandhi and Tagore had

felt that an experiment in education should be the basis for rediscovering an authentic indigenous identity founded on the cultural experience of India. Tagore had initiated a type of schooling different from the Western model introduced by colonial institutions concerned to provide its local government with literate and motivated intellectuals. For Tagore his childhood experience of schooling had been a frustrating and crushing process, encaging his creative mind. He believed that a true way to broaden the horizons of a young person was to learn through a natural environment, and in harmony with the whole of creation. In 1901, he had initiated an Ashram school where children were liberated from a closed classroom, and allowed environment. She mentions that to play and learn in the open the celebration of festivals was

In 1863,Maharshi Devendranath Tagore, father of Rabindranath, purchased a property in the countryside which he called Santiniketan, where he started to live in accordance with ancient spiritual values. He gave shape to a new approach in spirituality based on the Vedas, by constructing a place for meditation under a Chhatim tree, and following a simple life close to nature. Rabindanath first visited this Ashram in 1878 when he was twelve years old, and later went to settle in the Ashram to pursue his literary vocation as a poet. He suggested that through traditional village crafts young people could learn to be innovative, while serving the local community. After attending a conference at Gandhigram on War Resister's International, Devi Prasad became involved with peace education. This conference introduced him to a pacifist approach to art and craft, very much in line with Gandhi's understanding of working with natural materials. In 1983, a major retrospective of Devi Prasad's art and craft was held in Delhi. As an artist and craftsperson, he embodied both the ideals of Gandhi and Tagore through his approach to art and craft which he learnt at Santiniketan, later devoting his creativity to peace education and non-violence.

As we think of the relevance of ashram ideals in the thought of both Tagore and Gandhi, we realise that they were ecologically inspired. Gandhi Jayanti, 2023 may help us consider the importance of an education engaging with our natural environment. The neo-Gandhian Sri Sunderlal Bahuguna transformed a folk ritual of embracing trees into socio-ecological activism that came to be known as the "Chipko movement." Increasingly young people are becoming conscious of climate change, brought about by the ecological crisis that will affect particularly the lives of those living close to the earth, such as farmers and the economically marginalised. We realise that education will play an important part in the liberation of people trapped in a consumerist culture, where the gap between those who have power and privilege, and those who are disempowered is increasing. A Gandhian approach to holistic education is now more necessary than ever before.

'Scandals' In China

THE MOTHER

omething is seriously wrong in China. Even as it goes on testing India's military mettle and teasing the political leadership ruling the country, sneaking into its borders or claiming a whole bordering state as its own, it seems to have huge problems in its own backyard. Ironically, it is more a reflection of the leadership of President Xi Jinping, who has recently got the status equivalent to that of Mao Zedong, than of individual leaders who have been made to play second fiddle to him. China is now experiencing what some would like to compare with the purge during the infamous Cultural Revolution during Mao's regime. The sudden disappearance from public life of two prominent leaders once handpicked by Xi himself - foreign minister Qin Gang and defence minister Li Shangfu – does have elements of the ruthlessness displayed during that previous dark chapter of China's history

The parallel is inevitable, though the stature of the two leaders is in no way comparable to Lin Biao whom Mao Zedong himself declared in 1971 to be his successor. But, he fell from grace, fled the country and was killed in an aircrash in Mongolia. True to the Chinese Communist Party's legacy of secrecy, Lin Biao's death was announced weeks after he had perished. The recent disappearances from China's top echelons are but a pale shadow of what happened during the Cultural Revolution's purge. These events show Beijing has not changed much so far as the character of the dictatorship of its supreme leader is concerned. What is worse is the fact that the conspicuous absence of the two leaders is now being explained in the state media as consequences of unpardonable moral turpitude and fraudulent acts as if to confirm the adage of giving a bad name to a dog before hanging it.

When Qin Gang, the foreign minister, could not be mysteriously seen in public in June, it created ripples in international politics because of his diplomatic role in world affairs. The authorities took nearly a month before confirming that he had been removed from his post. A few weeks later, he was followed by China's defence minister, Li Shangfu who failed to attend scheduled meetings with foreign officials. Soon it was given out by official sources that he was being investigated over corruption in military procurement. In fact, two most senior generals in charge of nuclear and conventional land-based missiles had already been replaced at the beginning of August. One of them was said to be facing corruption charges.

Corruption, it seems, has become almost a way of life in China for years which prompted Xi, during his first few years as President, to virtually launch a crusade against it. His actions were one of the reasons for his popularity as the average Chinese citizens were fed up with the corruption of party bosses and functionaries throughout the length and breadth of the country.

As is seen in many other countries, whatever form of government they embrace, corruption is always used by the powers that be as a tool for political vendetta. Xi is no exception and he used it to cut his rivals or potential threats to his leadership to size. Recently, he has stressed the need to tighten party control of the army which may explain the absence of the defence minister and actions against high profile army generals.

In the case of Qin, Xi has reasons to project him as a threat to national security. Reports suggested Qin had a child with a woman to whom he is not married via a surrogate mother in the US. The woman's social media posts, the fact that surrogacy is illegal in China, and the existence of a child with US citizenship might all be used by Xi as weighty reasons to fire him.

Yet, Xi cannot escape his share of blame for the supposed wrongdoings of the two. This is because they were his chosen men. His proven loyalists alone could occupy such high positions of power for the long periods they had. The question arises whether Xi's assessment and judgement of his own loyalists was faulty. It is most unlikely that he could err on this score since such appointments are made on the basis of performances for years and intelligence clearances.

This makes the world suspect whether there is much more in these developments than what meets the eye.


### THIS DAY IN HISTORY

**1836:** Naturalist Charles Darwin returned to England this day in 1836 after a five-year journey on the HMS Beagle, on which he gathered the specimens and observations that led to his theory of evolution by natural selection. Beagle sailed from Plymouth Sound on 27 December 1831 under the command of Captain Robert FitzRoy. While the expedition was originally planned to last two years, it lasted almost five-Beagle returned on 2 October 1836. Darwin spent most of this time exploring on land (three years and three months on land; 18 months at sea). "The Voyage of the Beagle" is the title most commonly given to the book written by Charles Darwin and published in 1839 as his Journal and Remarks, bringing him considerable fame and respect.

- **1935:** Ethiopian Emperor Haile Selassie ordered mobilisation upon learning that Italian forces had crossed the frontier to begin the Italo-Ethiopian War. The Second Italo-Ethiopian War, also referred to as the Second Italo-Abyssinian War, was a war of aggression which was fought between Italy and Ethiopia from October 1935 to February 1937. It is seen as an example of the expansionist policy that characterized the Axis powers and the ineffectiveness of the League of Nations before the outbreak of the Second World War.
- **1950:** Peanuts was published for the first time. Charles M. Schulz's comic strip was printed for the first time in 9 newspapers around the U.S. Peanuts is a syndicated daily and Sunday American comic strip written and illustrated by Charles M. Schulz. The strip's original run extended from 1950 to 2000, continuing in reruns afterward. Peanuts is among the most popular and influential in the history of comic strips, with 17,897 strips published in all, making it "arguably the longest story ever told by one human being."

### ISRO eyes exo-planets

Sir, After the success of the Moon mission, ISRO has set sight on unlocking the mysteries of dying stars and exo-planets some of which are known to have atmosphere and are considered habitable, Indian Space Research Organisation Chairman S Somanath has said. Delivering a lecture, he said the space agency was also planning a mission to study the planet Venus, two satellites to study space climate and its impact on the earth, and conceptualising a project to land a spacecraft on Mars. He said the XPoSat or the X-Ray Polarimeter Satellite, meant to study bright X-ray pulsars or stars that are in the process of death, was ready for launch in December this year. "We are also conceiving a satellite called ExoWorlds, a mission for looking at exo-solar planets or planets that are outside our solar system and orbiting other stars," Somanath said. He said there were more than 5,000 known exo-planets of which at least 100 were considered to have atmospheres. The ExoWorlds mission will study the atmosphere of exo-planets and whether they are livable or they host life. Somanath said the plans for a Mars Lander Mission too were at the conceptual stage. ISRO's continuous progress in space science will prove to be a millstone in the development of science. This mission of ISRO will provide knowledge about the world and information about the history of the Earth.

### RJD mavericks give BJP Hindutva ammunition to fire Bihar: 6,146 dengue

Patna, Oct 1: Bihar is a state known for its diversity in politics thanks to regional parties ruling here for the last 33 years.

And the diversity of politics reached to the micro level in Bihar with individual leaders going beyond party lines.

Leaders like education minister Professor Chandrashekher, RJD state president Jagadanand Singh, former agriculture minister Sudhakar Singh and RJD MLA Chetan Anand went beyond the party line with their stand by and large suiting the BJP.

Chandrashekher got the maximum headlines while batting on the bouncy pitch of Hindutva in Bihar by criticising the Ramcharitmanas and comparing it with potassium cyanide.

While addressing a gathering during an event to discuss Hindi Sahitya September 14, Chandrashekher said: "It is similar to how we serve 55 types of tasty cuisine and mix one potassium cyanide in it. When I point out such things, they blame me and say I am against Hindu and Sanatan Dharma but when Mohan Bhagwat says, no one has an objection to it.'

Patna, Oct 1: Bihar is witnessing an alarming rise in dengue cases, with 6,146 cases reported in September, the highest for the month in the last five years, according to the data.

The state had reported 6,421 cases this year, of which 6,146 were reported only in September, three times the 1,896 registered in September last year. As many as 416 cases were reported in the state Friday, with Patna recording the most at 177, followed by Munger at 33, Saran (28), Bhagalpur (27) and Begusarai (17).

According to the National Center for Vector Borne Disease Control of the Union Health Ministry, seven dengue deaths have been reported in Bihar till September 17 this year. As per the health department's data, a total of 13,972 cases were reported last year. As many as 295 people were undergoing treatment at 12 government hospitals till September 30, including 127 at Jawaharlal Nehru Medical College



and Hospital in Bhagalpur, 39 at VIMS in Pawapuri and 28 at Patna Medical College and Hospital.

Dr Manoj Kumar, a renowned medical practitioner in the state, told PTI, "There is no need to panic as dengue cases always increase during this season. Keeping homes and surroundings dry and clean and body covered helps curb the spread of the disease. Mosquito repellants and nets must be used and all possible breeding sites should be detected and eliminated.'

Patna District Magistrate Chandrasekhar Singh said the administration is keeping a close watch on a daily basis and spraying and fogging are being conducted, while awareness camps on vector borne diseases are also being organised.

# **Two yrs of Kheri violence but justice eludes victims**

Lakhimpur Kheri (UP), Oct 1: It will be two years Tuesday (October 3) since the Lakhimpur Kheri violence where eight persons, including four farmers were killed, under the Tikunia police station.

However, the case seems to be moving at a snail's pace and the victims wait endlessly for justice. Politicians have moved on and lost interest in the case.

Shockingly, so far, only four out of 171 witnesses have got their statements recorded before court in the case against Ashish Mishra, son of Union minister Akay Mishra Teni, who is one of the accused in the matter.

Ashish was arrested October 9. six days after violence broke out during a farmers' protest against three agri-reform laws (since repealed) and the then UP deputy chief minister Keshay

According to the UP Police FIR, four farmers were mowed down by an SUV in which Ashish Mishra was seated.

A directive issued by Special Secretary (Basic Education) Yatindra Kumar was sent to the Director of Basic Education, outlining changes to the terms and conditions for granting recognition to schools from class 1 to class 8 within the state, as stated by a senior official from the state's Basic Education

Department. According to the new guidelines, primary schools located

within urban areas must have a playground measuring at least 500 square meters, while upper primary schools within urban areas require a playground of 1000 square meters.

For schools situated in rural areas, the Basic Education Department will only grant recognition if the playground measures a minimum of 1,000 square meters for primary schools and 2,000 square meters for upper primary schools.

Previously, there were no stringent regulations concerning the size of sports fields required for granting recognition to primary and upper primary schools in the state, officials said.

Photos of their bodies surfaced on September 25 leading to violent protests mainly by students.

Another mob also vandalised the deputy commissioner's office in Imphal West district of the state which has been rocked by ethnic strife for nearly five months."In several international fora, the strife in Manipur was wrongly interpreted as a religious crisis or of majority community targeting minority community. This has confused the people of this nation and the state," he said.

Singh also asserted that the nearly five-month-long violence in the state is "not an ethnic strife" but caused by terrorist groups which are based in Bangladesh and Myanmar.



### Fresno to ban caste discrimination

Washington: Fresno in California has become the second US city to ban caste discrimination after the City Council unanimously passed a resolution by including two new protected categories in its municipal code, according to a media report. Earlier in February, Seattle outlawed caste discrimination, becoming the first US city to do so, followed by the US state of California, where a bill was passed in September by the state assembly for the same. In a speech at the opening of a new parliamentary session hours later, President Tayyip Erdogan called the morning attack "the latest attempt" to inflict terror on Turks.

The bomb on Ataturk Boulevard was the first in Ankara since 2016, when a spate of deadly attacks gripped the country. Video afterward showed a Renault cargo vehicle parked there, windows shattered and doors open, amid debris and surrounded by soldiers, ambulances, fire trucks and armoured vehicles.

A senior Turkish official told Reuters the attackers had hijacked the vehicle and killed its driver in Kayseri, a city 260 km (161 miles) southeast of Ankara, before carrying out the attack. One of the injured officers suffered shrapnel injuries, he added.

Washington, Oct 1: President Joe Biden said Sunday that American aid to Ukraine will keep flowing for now as he sought to reassure allies of continued US financial support for the war effort. But time is running out, the president said in a warning to Congress.

"We cannot under any circumstances allow American for Ukraine to be interrupted," Biden said in remarks from the Roosevelt Room after Congress voted late Saturday to avert a government shutdown by passing a shortterm funding package that

in the fight against Russia. "We have time, not much time and there's an overwhelming sense of urgency," he said, noting that the funding bill lasts only until mid-November. Biden urged Congress to negotiate an aid package as soon as possible. 'The vast majority of both parties Democrats and Republicans, Senate and House -support helping Ukraine and the brutal aggression that is being thrust upon them by Russia," Biden said. "Stop play-

ing games, get this done. But many lawmakers acknowledge that winning approval for Ukraine assistance in Congress is growing more dif-



ficult as the war grinds on. Republican resistance to the aid has been gaining momentum in the halls of Congress Voting in the House this past

week pointed to the potential trouble ahead. Nearly half of House Republicans voted to strip \$ 300 million from a defense spending bill to train Ukrainian soldiers and purchase weapons.

The money later was approved separately, but opponents of Ukraine support celebrated their growing numbers. Then, Saturday, House Speaker Kevin McCarthy, R-Calif., omitted additional Ukraine aid from a measure to keep the government running until November 17. In doing so, he closed the door on a Senate package that would have funnelled \$6 billion to Ukraine, roughly one-third of what has been requested by the White House. Both the House and Senate overwhelmingly approved the stopgap measure, with members of both parties abandoning the increased aid for Ukraine in favor of avoiding a costly government shutdown. Biden said that deal was made to keep the government running and he worked to reassure US allies the funding would be there.

"Look at me," he said turning his face to the cameras at the White House. "We're going to get it done. I can't believe those who voted for supporting Ukraine -- overwhelming maiority in the House and Senate, Democrat and Republican -- will for pure political reasons let more people die needlessly in Ukraine.

The latest actions in Congress signal a gradual shift in the unwavering support that the United States has so far pledged Ukraine in its fight against Russia, and it is one of the clearest examples yet of the Republican Party's movement toward a more isolationist stance. The US has approved four rounds of aid to -Ukraine in response to Russia's invasion, totaling about \$ 113 billion, with some of that money going toward replenishment of US military equipment that was sent to the frontlines. In August,-Biden called on Congress to provide for an additional \$24 billion.

# **Festive rush drives record PV sales**

Passenger vehicle despatches rose to record levels in September as the dealers prepare for the festive season which kicks in a big way from October 14

New Delhi, Oct 1: Passenger vehicle wholesales in India rose to record levels in September as automakers dispatched stocks to dealers in order to cater to the robust demand in the ongoing festive season.

The industry despatches stood at 3,63,733 units last month, the best ever in a month. The previous best was reported in August 2023 with dispatches of 3,60,700 units

"This is the highest ever September of course, in any year in the Indian passenger vehicle history. It is also the highest ever in any month so far," Maruti Suzuki India Senior **Executive Officer (Marketing** and Sales) Shashank Srivastava told reporters in a virtual press meet.

Last month also witnessed robust demand in western and southern states due to various festivals which see increase in car sales, Srivastava said. Another reason is better avail-

ability of cars due to chip supplies stabilising, he added. Last month Maruti Suzuki,

Hyundai and Toyota reported their best ever monthly wholesales as they ramped up sup-

MSI dispatched 10,50,085 units in the first half of the current fiscal as compared with 9,85,326 units in the same period of last fiscal. It is for the first time that the company surpassed the halfyearly sales mark of 1 million units, the automaker noted.

In September, the company said the sales of its entry level cars -- Alto and S-Presso -- stood at 10,351 units, down 65 per cent from 29,574 units in the yearago period.

India's share in global exports in labour-intensive sectors declining in last 5 years, says FIEO report

New Delhi, Oct 1: India's labourintensive export sectors such as apparels, marine products, plastics, and gems and jewellery are showing a "troubling pattern" as the country is experiencing a decline in global market share across these segments during the last five years, a FIEO report has said Apex exporters body Federation of Indian Export Organisations (FIEO) also said that a note of caution is warranted regarding a distinct spike in export growth of roughly \$40 billion as this particular surge is likely attributed to a rerouting of crude oil trade routes via India to Europe. This phenomenon may not be sustainable in the coming years, it said. It added that the most "pressing concern" regarding the negative export growth is the "poor" performance of labour-intensive sectors. In a country like India, these sectors hold immense significance not only for their job creation potential but also for their substantial contribution to net high-value addition.



"Addressing this challenge requires a proactive approach that delves into the underlying factors contributing to the loss of marcent in the past four years.

'Concerns arose due to criticism linked to cough syrup, underlining the need for an efficient trace and tracking system for quality assurance," it said.

Further, it said that an analysis of technology-driven sectors indicates a significant surge in global demand for machinery, auto components, electrical and electronics goods.

"These sectors collectively contribute to about one-third of the global trade, amounting to over \$7 trillion. However, India's current market share in these sectors stands at a mere 1 per cent. Intriguingly, India's imports of these goods are substantial, hovering around \$100-120 billion," it said.

year. In terms of sectors, FPIs were buyers of capital goods and selected financials.

However, the price of gas that is largely used for making CNG for fueling automobiles or piping to households kitchens for cooking purposes will remain unchanged due to a price cap that is set at 30 per cent less than market rates such as that paid to Reliance.

partner MS Mani, the September GST collections augur well for the coming months of the festive season and is in line with the other high frequency indicators which reflect an uptick in the economy

On the other hand, \$10 billion worth of exports of traditional sectors would have a net value addition of over \$9 billion, it added.

Notably, the global trade in knitted garments expanded by 6 per cent, whereas India's growth remained at a mere 2 per cent.

In woven garments, despite a global trade growth rate of about 2 per cent, India's export growth has consistently been below 1 per cent for years, while Bangladesh and Vietnam growing at 6 per cent and 4 per cent, respectively, impacting India's share.

Similarly, India's aspiration to be a global pharmacy leader faces challenges, it said, adding, despite the ambition, India's growth has not matched demand. lagging at 9 per cent while the global market grew by 12 per

The report added that a more nuanced consideration is warranted when it comes to labourintensive sectors.

The report added that on the basis of the export performances of the leading six competing countries (India, Bangladesh, China, Vietnam, South Korea, Malaysia and Indonesia) over the past six months (January-June 2023), it becomes evident that unfortunately both India and South Korea have consistently displayed a negative growth rate in their exports during this period.

In contrast, China, Malaysia, and Indonesia have shown positive growth rates in two out of the six months.

### Firms brace for impact as EU's carbon levy begins

### **EMISSION REPORTING PHASE OF EU'S CARBON TAX REGIME STARTS FROM OCTOBER 1**

New Delhi, Oct 1: Indian companies from seven sectors such as steel, cement, and hydrocarbons, which export to the European Union will have to start reporting their carbon emissions to comply with the provisions of EU's carbon tax regime. The compliance with the

Research Initiative (GTRI) said the emission data is to be reported quarterly and the deadline for submission for the first quarter (October-December 2023) by the EU-based importer (called declarant) is January 31, 2024.

Indian firms must share emission data in the format prescribed by the EU with the declarant much before this date, it said. The EU has proposed strict

penalties for non-submission or incomplete data, which may pose challenges for many medium and small-sized firms.

#### **GOVT INTERVENTION**

The government is holding consultations with the domestic industry to see their preparedness for complying with this regime.

CBAM would translate into a The transition phase of CBAM 20-35 per cent tax on select imstarts October 1, 2023, and runs



until December 31, 2025.

During this time, Indian firms must provide extensive production and emission data for products sent to the EU. The tax phase begins January 1, 2026, with more items being added, and by 2034, all items will be included in CBAM.

"Most Indian exporters are unprepared for CBAM. Many are hoping for a last-minute deal between the Indian government and the EU that allows them to continue business as usual. Only a few have undergone emission audits for their facilities," GTRI Co-Founder Ajay Srivastava said.

Small firms often purchase steel or aluminum from larger firms and use them to create export products. These small firms will require emission data from the large firms.

"However, it appears that many large Indian firms are reluctant

to share this emission data with smaller ones. This reluctance could lead the EU to calculate taxes based on default or maximum values. Additionally, the failure to submit data may result in penalties, which could be imposed starting now," he added.

To deal with this tax, GTRI suggested that the government designate existing import, excise, and GST duties as carbon taxes for steel and aluminum. "This can offset the tax liabil-

ity in the EU. If done properly, it

will reduce the final amount to be paid in the EU by the tax already paid in India," GTRI said.

It also asked for using a calibrated retaliation mechanism (CRM) to respond to EU actions with precise calculations, as previously done with the US tariffs on Indian steel and aluminum

In March 2018, when the US imposed import duties on steel and aluminium, India responded by increasing tariffs on 29 specific US products.

This retaliation involved precise calculations, ensuring that India collected equivalent revenue from US products as the US did from Indian steel and ২ aluminium.

"The CRM offers several advantages, including rapid implementation. India can easily adjust product lists and tariff levels to mirror the actions of the EUor any other partner country precisely," he said.

In the 1,500m for women, India's Harmilan Bains won a silver while Ajay Kumar Saroj and Jinson Johnson won silver and bronze respectively in the men's 1,500m. In men's long jump Murali Sreeshankar won silver while Jyothi Yarraji also emulated the feat by bagging a silver medal in the women's 100m hurdles. Initially Yarraji had won the bronze in her event. However, the Chinese athlete who finished second in the event was disqualified and Yarraji's medal was elevated to silver.

In the women's discuss throw, India's Seema Punia won the bronze medal to make it a memorable day for Indian athletes. In women's heptathlon, Nandini Agasara also finished with the bronze medal. Agasara's season-best 5.94m long jump helped her achieve a podium finish.

Earlier, the toast of the nation in the last edition, heptathlete Swapna Barman's one 'last shot' at glory at the Asian Games turned into a nightmare as she struggled with injuries to virtually go out of medal reckoning after the javelin throw event.

The defending champion, who boasted of a personal best of 52.55m in javelin throw, managed a throw of just 45.13 in the penultimate event of the gruelling two-day competition. It was clear that Barman was not in her elements



A day after the Indian men's squash team secured a thrilling victory against Pakistan to clinch the gold medal, the mixed doubles teams won their respective pool matches at the Asian Games. In Pool A, the pair of Dipika Pallikal and Harinder Pal Singh

Sandhu defeated the South Korean duo of Jaejin Yoo and Hwayeong Eum 2-0, recording an 11-2, 11-5 win in 22 minutes. On the other hand, the pair of Anahat Singh and Abhay Singh crushed the pair of David William Pelino and Yvonne Alyssa Dalida from the Philippines 2-0.

#### **Spikers beaten**
