### **Boost to mobility as CM launches LAccMI**

POST NEWS NETWORK

Malkangiri, Oct 12: Reaffirming his government's commitment for development of the state's remote areas, Chief Minister Naveen Patnaik Thursday launched the affordable bus service under the Location Accessible Multimodal Initiative (LAccMI) here besides initiating development projects worth ₹793 crore in the tribal-dominated district.

Patnaik, who undertook a oneday visit to Malkangiri, flagged off 36 buses under the scheme in the district which aims to connect all the 111 gram panchayats with the district headquarters and the state capital.

The state government will operate at least 1,000 buses in the rural areas with a budgetary allocation of ₹3,178 crore under the scheme.

In the first phase, LAccMI bus services will be introduced in rural areas of six tribal-dominated and 'inaccessible' districts of Malkangiri, Koraput, Nabarangpur, Rayagada, Kalahandi, and Gajapati. The buses will ply from panchayats to block headquarters and from block headquarters to district headquarters.

### Schoolgirl beaten to death over theft POST NEWS NETWORK

Udala, Oct 12: An 11-year-old girl was allegedly beaten to death by her aunt over theft of a marigold sapling at Bhaluhuruda village under Udala police limits in Mayurbhanj, police said Thursday.

Lakshmi Murmu later tried to cover up the child's death as suicide by hanging the body, police added. Lakshmi has been taken into custody on charges of killing Saraswati Hansda, daughter of Sita and Gunti Hansda of the village, an official of Udala police said, adding that the arrest was made on the basis of an FIR lodged by the girl's parents.

According to police sources, Saraswati was studying in Class VI at Laxmisagar High School in Bhubaneswar. Recently she had visited home when her parents decided to enrol her at a school in Udala. Accordingly, Saraswati's parents left for Bhubaneswar to bring her transfer and other certificates from the school, leaving the girl at home, the official added

"They left Saraswati under Lakshmi's care," said the official.

Wednesday afternoon, Lakshmi called Saraswati's mother Sita over phone informing that the girl had stolen a marigold sapling from their place. Sita, in return, told Lakshmi that she will talk to her daughter only after she comes back from Bhubaneswar, the official added.

Lakshmi again called Sita over phone in the night (Wednesday night) and informed her that Saraswati had died by hanging herself with her scarf, said the official, quoting the FIR.

Hearing this, the worried parents rushed back to the village only to find the lifeless body of their daughter hanging by a scarf. They found Saraswati's legs touching the ground with injury marks all over her body.

Preliminary inquiries indicated that Saraswati was beaten up with a stick, leading to her death. The body was hanged to pass it off as suicide, said the official.

Syria says Israeli missiles hit Damascus, Aleppo airports

Damascus (Syria), Oct 12: In what could signal the proliferation of the ongoing war between Israel and militant Palestinian group Hamas in Gaza, Syria Thursday claimed that Israeli airstrikes hit the international airports of Damascus and the northern city of Aleppo, damaging their runways and putting them out of service.

A Syrian military source cited by state news agency SANA said 'bursts of missiles' hit the two airports at the same time, in what he said, was a bid to distract the world's attention from Israel's war with Hamas militants in Gaza.

The Israeli military said it does not comment on such re-If reports are to be believed,

they would be the first Israeli strikes on Svria since Hamas carried out its deadly attacks in southern Israel Saturday. Israel has for years carried

out strikes against what it has described as Iran-linked targets in Syria, including against the Aleppo and Damascus airports. Sources have said strikes on

the airports are intended to disrupt Iranian supply lines to Syria, where Tehran's influence has grown since it began supporting President Bashar al-

The airstrikes came a day before Iran's foreign minister Hossein Amirabdollahian was scheduled to visit Syria to meet officials over the volatile situa tion in the region.

#### First batch of Indians to return home today **NEW DELHI:** The first batch of

around 230 Indians are expected to return to India from Israel on a flight under Operation Ajay Friday morning, the Ministry of External Affairs (MEA) said Thursday. India launched Operation Ajay to facilitate the return of those Indians who wish to come back home as a series of brazen attacks on Israeli towns by Hamas militants over the weekend triggered fresh tensions in the region. "The first flight will reach Tel Aviv later tonight to pick up Indian citizens and is likely to return to India tomorrow (Friday) morning," MEA spokesperson Arindam Bagchi said. He said around 18,000 Indians are currently residing in Israel.

### 'NO RELIEF UNLESS HOSTAGES FREED'

**ASHKELON:** Israel said Thursday there would be no humanitarian exceptions to its siege of the Gaza Strip until all its hostages were freed, after the Red Cross pleaded for fuel to be allowed in to prevent overwhelmed hospitals from 'turning into morgues'. Public broadcaster Kan said the Israeli death toll had risen to more than 1,300 since Saturday. Most were civilians gunned down in their homes, on the streets or at a dance party. Scores of Israeli and foreign hostages were taken back to Gaza; Israel says it has identified 97 of them. The full scale of the killings has emerged in recent days after Israeli forces reclaimed control of towns, finding homes strewn with bodies. They say they found women who had been raped and killed, and children who were shot and burned. Israel has responded so far by putting Gaza, home to 2.3 million people, under total siege and launching by far the most powerful bombing campaign in the 75-year history of the Israeli-Palestinian conflict, destroying whole neighbourhoods.

**Bilkis case: SC for** original records New Delhi: The Supreme Court

Thursday directed the Centre and the Gujarat government to submit by October 16 the original records related to the remission of sentence of 11 convicts in the Bilkis Bano gangrape case and murder of seven of her family members during the 2002 Gujarat riots. After an 11-day hearing that began in August, a Bench of Justices BV Nagarathna and Ujjal Bhuyan reserved its order on the pleas challenging the remission granted to the convicts. The Bench heard submissions by Bilkis Bano's counsel advocate Shobha Gupta, Additional Soliciitor General SV Raju, senior advocate Indira Jaising and advocates Vrinda Grover for PIL petitioners. and senior advocate Sidharth Luthra and Rishi Malhotra

New Delhi, Oct 12: With the highest child wasting rate of 18.7 per cent, India ranked 111th out of 125 countries in the Global Hunger Index (GHI) 2023 that was released Thursday even as the government rejected the report calling it a flawed measure of 'hunger' that does not reflect the country's true position.

With this, India slipped four places as it had ranked 107th out of 121 countries in 2022. The GHI is a tool for comprehensively measuring and tracking hunger at global, regional, and national levels. With a score of 28.7 in the GHI-2023, India has a level of hunger that is serious, according to a report based on the index.

India's neighbouring countries Pakistan (102th), Bangladesh (81st), Nepal (69th) and Sri Lanka (60th) have fared better than it in the index.

South Asia and Africa South of the Sahara are the world regions with the highest hunger levels, with a GHI score of 27 each. indicating serious hunger.

"India has the highest child wasting rate in the world, at 18.7 per cent, reflecting acute undernutrition," the report based on the index stated. Wasting is measured based on children's weight relative to their height.

According to the index, the rate of undernourishment in India stood at 16.6 per cent and under-five mortality at 3.1 per cent. The report also said that the prevalence of anaemia in women

The GHI 2023 shows that, after many years of advancement up to 2015, progress against hunger worldwide remains largely at a standstill. The GHI 2023 score for the world is 18.3, considered moderate and less than one point below the world's 2015 GHI score of 19.1.

Furthermore, since 2017 the prevalence of undernourishment, one of the indicators used in the calculation of GHI scores. has been on the rise, and the number of undernourished people has climbed from 572 million to about 735 million, the index said. The Women and Child Development Ministry said the index suffers from 'serious methodological issues and shows a malafide intent'.

Rejecting India's ranking at the index, the Women and Child Development Ministry said the Global Hunger Index continues to be a flawed measure of 'hunger' and does not reflect India's true position.

'The index is an erroneous measure of hunger and suffers from serious methodological issues. Three out of the four indicators used for calculation of the index are related to the health of children and cannot be representative of the entire population. The fourth and most important indicator 'Proportion of Undernourished (PoU) population' is based on an opinion poll conducted on a very small sample size of 3,000," it said.





### Govt directs massive palm tree, mangrove plantation

Bhubaneswar, Oct 12: The state government has asked its Agriculture and Forest departments to go for a massive mangrove and palm tree plantation drive in areas, which are vulnerable to natural calamities like cyclones, officials said

Chief Secretary Pradeep Kumar Jena issued a direction to officials of the Agriculture & Farmers' Empowerment (A&FE) and the Forest, Environment & Climate Change (FE&CC) departments to take such an initiative, they said.

During a meeting of the state executive committee on disaster management recently, he advised the two departments to take up more and more palm tree and mangrove plantations in all areas prone to cyclones and lightning.

At least 2,058 people were killed due to lightning in Odisha in the last five years from 2018-19, the officials said.

The Chief Secretary has advised the officials to plant mangroves to protect the coastline from cyclones.

Mangrove trees help build coastal resilience as it is an effective natural safeguard against

An amount of ₹159.02 crore has been released for procurement of search & rescue equipment, accessories and vehicles for Odisha fire & emergency services as against a proposal of ₹240.33 crore. The balance amount would be released as required

cyclones, he said.

Kalia was wanted in several cases of ganja trafficking in Odisha, West Bengal, Jharkhand and Bihar, he said.



### Doctors to get comp offs for working on holidays

Bhubaneswar, Oct 12: Odisha Medical and Health Service (OMHS) officers can now avail off-days in lieu of notified public holidays as Health and Family Welfare secretary Shalini Pandit Thursday issued guidelines to the heads of all medical institutions. As per the guidelines, an

OMHS officer, who attended to duty on a designated public holiday(s) notified by the state government, will be allowed to avail an equal number of off-days in the same month, subject to availability of adequate human resources at the health facility.

The superintendent or medical officer in-charge of the facility will have to make a roster for that month to ensure that all working hours are adequately covered, the guidelines said.

In case of non-availability of adequate staff in the facility, the medical officer in-charge can reduce the number of alternate offdays allowed to an officer, it said. In single-doctor medical in-

stitutions, the superintendent of the CHC will make arrangements to provide days off following the same principle taking into account the presence of Ayush medical officers and pharmacists. The doctors can neither merge alternate off-days with CL/EL, nor carry over the off days to the next month, except when the public holiday falls in the last week of a month. the notification said.

THE EXPERIMENT MAY ONE DAY DEVELOP TO BE A POTENTIAL SOLUTION TO THE GLOBAL SHORTAGE OF DONORS FOR PATIENTS WITH ORGAN FAILURE

Tn a medical breakthrough, a I monkey has survived for more than two years with a kidney transplanted from a genetically engineered pig.

The experiment, carried out by researchers at the US biotech company eGenesis and Harvard Medical School, may one day develop to be a potential solution to the global shortage of donors for patients with organ failure.

This is a major step forward for the field of transplantation," said Tatsuo Kawai, Professor of Surgery at Harvard Medical

Writing in the journal 'Nature', the scientists explained how they carried out 69 genomic edits into the pig kidneys which enhanced compatibility and reduced rejection by the recipient's immune system.

The donor kidneys carried three types of edits: (1) knock out of three genes involved in the synthesis of glycan antigens implicated in hyperacute rejection, (2) insertion of seven human transgenes involved in the regulation of several pathways that modulate rejection: inflammation, innate immunity, coagulation, and complement, and (3) inactivation of the endogenous retroviruses in the porcine genome.

Donor kidneys carrying human transgenes resulted in longer survival time when transplanted into NHPs. Donor kid-



neys containing only knock out of the three-glycan antigens experienced poor graft survival, whereas those harbouring the knockouts and human transgenes resulted in more than seven times longer duration - a median of 24 days versus 176 days, respectively. In the case of one recipient, survival of over two years (758 days) was achieved.

The results indicate the benefit of human transgene expression in porcine kidney grafts on long-term survival

One of the biggest hurdles has been long-term survival of the genetically engineered organ in the NHP (non-humanprimate) recipient, and this

dataset demonstrates remarkable progress in editing the porcine genome to minimise hyperacute rejection, improve recipient compatibility and address the risk of viral transmission from donor to host,' Kawai said

'We anticipate that transplant outcomes in humans will be even more favourable, as these gene edited organs are a hetter match for humans, as compared with NHPs," he added.

In vitro functional analysis showed that edited porcine kidney endothelial cells modulated inflammation in a manner that mirrored human endothelial cells, suggesting the edited cells acquired a high level of human Furthermore, the evaluation

of renal function biomarkers in recipients with stable grafts revealed that a single transplanted porcine kidney provided sufficient filtration of metabolites to compensate for the lack of two native kidneys. Organ failure is a life-threat-

ening condition for which transplantation is considered the gold standard treatment. However, the demand for organs far outstrips supply. In addition, the existing organ failure treatment paradigm is suboptimal for patients and the healthcare system due to organ incompatibility and variable donor organ quality. IANS

Mishra said all the 22 BJP MLAs will be part of the delegation, the date for which will be decided soon.

He said other than Prime Minister Narendra Modi and Union Home Minister Amit Shah, the delegation plans to meet the President, Election Commission of India and some Union ministers.

"We will meet the Election Commissioner and apprise him on the unconstitutional activities taking place in the state," said Mishra, who strongly objected to the use of BJD's conch symbol in state government advertisements during the launch of 'Ama Odisha Nabin Odisha' and Location Accessible Multi-modal Initiative (LAccMI) schemes.

Meanwhile, Odisha Pradesh Congress Committee (OPCC) president Sarat Pattanayak said, "The BJP and BJD are in handinglove. They (the BJP) are going to Delhi to deceive the people of Odisha. Even after their return from Delhi, neither the ED nor the CBI will visit the state. Why nothing has so far been done in the chit fund and mine scams."

Ruling BJD MLA Arabinda Dhali said, "The opposition MLAs may visit Delhi and make complaints. But, the fact remains that everything is right in Odisha and people are happy."

BJD spokesperson and MP Sasmit Patra suggested that the BJP delegation should raise people's issues during their visit to Delhi.

### State BJP to raise High temperature in Oct

Bhubaneswar, Oct 12: With temperature in Capital abnormally soaring to 36 degrees C Wednesday, which is four degrees above normal, weather watchers of the City have expressed concern over summerlike heat in October.

"The absence of dry cold wind

from the north and north-east due to movement of low pressure over Odisha September 29 and 30, towards North Jharkhand, West Bengal and Bihar and the consequent cloudburst over Sikkim in the first week of October, has triggered the rise in the day temperature," said Sarat Chandra Sahu, director of SOA's Centre for Environment and Climate.

The night temperature here Wednesday was 27.4 degrees C which was 3.5 degrees C above normal, Sahu said. Between 2019 and 2023, in October, the temperature recorded at CEC and at SOA's agriculture farm at Chhatabar on City outskirts indicated sharp rise in temperature, he added.

As Chhatabar is located away from the city in a rural setting, the day and night temperature at the farm indicated a difference of 1.5 degree C against the higher temperature recorded in City.

Sahu said strong southerly wind flow from the Bay of Bengal towards North of West Bengal and Sikkim was prominent between October 1 and October 5.

Odisha experienced light to moderate rainfall due to a cy-



clonic circulation and low pressure up to October 4 but moisture with 60 to 65 per cent humidity and cloud cover caused the day temperature to hover between 30 to 33 degrees C up to October 5, he said.

As rain stopped from October 4, 60 to 65 per cent humidity in the lower atmosphere and significantly less humidity in the upper atmosphere coupled with westerly wind flow favoured the rise of day and night temperature from October 6, Sahu said.

The day temperature remained 35 degrees C (or more) and night temperature was 27 degrees C (or more) from October 6, he said, adding that this trend is expected

to continue till October 18. He explained that the high humidity in the lower atmosphere did not favour rain in the absence of any circulation to push the moisture upwards for cloud formation and subsequent rainfall.

The moisture remained in the lower atmosphere while the clear sky allowed penetration of solar radiation towards earth's surface.

Models, however, indicate that wind patterns could change from October 18 due to formation of a cyclonic circulation over the south Bay of Bengal which is expected to favour decrease in day and night temperature,

### Working night shifts messes up appetite

cientists reveal how working night shifts interfere with appetite, hunger and food habits, sometimes resulting in weight gain.

The disruption in the body's biological clock, or circadian misalignment, brought about by working night shifts affects the hormones which regulating appetite, the team of scientists, led by the University of Bristol, UK, said.

Circadian misalignment is also commonly associated with the phenomenon of 'jet-lag'.

the phenomenon of 'jet-lag'.

The team focused on the adrenal gland, situated near the kidney, which produces hormones that control many physiological functions including metabolism and appetite, called glucocorticoid hormones.

A misalignment between light

and dark cues led to a disturbance in the functioning of these hormones that then affected the appetite of the jet-lagged group of animals, driving an increased desire to eat significantly more during the inactive phase of the day, the scientists said in their study published in the journal Communications

Biology.

They said that their findings reveal how circadian misalignment can profoundly alter food habits much to the detriment of metabolic health and that they could help the millions of people that work through

the night and struggle with weight gain. The glucocorticoid hormones in the adrenal glands directly regulate a group of brain peptides

petitive behaviour, with some increasing appetite (orexigenic) and some decreasing ap-

controlling ap-

petite (anorexi-

genic).

In this study, the jet-lagged group's orexigenic hypothalamic neuropeptides (NPY) became dysregulated, which the authors say may be promising targets for drug treatments

adapted to treat eating disor-

ders and obesity.

Further, the team discovered that while the control rats ate about 90 per cent of their daily intake during their active phase and only 11 per cent during their inactive phase, the jet-lagged rats consumed about 54 per cent of their daily calories during their inactive phase, with no increased physical activity in this time.

This was roughly five-times more than what the control rats consumed during the inactive phase, suggesting that it was the timing of calorie consumption that was affected, the scientists said.

"For those who are working night shifts long-term, we recommend they try to maintain daylight exposure, cardiovascular exercise and mealtimes at regulated hours."

### SC to decide Orissa Sales Tax Act case

New Delhi, Oct 12: A sevenjudge Constitution bench of the Supreme Court Thursday said that it will decide appeals from Odisha challenging the validity of Section 5A of Orissa Sales Tax Act, 1947 after 29 years.

The Constitution bench headed by Chief Justice of India DY Chandrachud said that it would keep the pleas for directions immediately to see if the matter survives. "If it doesn't then we will close it since it is now a legacy issue," the apex court said.

The bench comprising Justices SK Kaul, Sanjiv Khanna, BR Gavai, Surya Kant, JB Pardiwala and Manoj Misra also said that



it would appoint a nodal officer in the matter.

Significantly, the court was hearing a petition filed by Arjun Flour Mills in 1994 challenging the validity of Section 5A of the Orissa Sales Tax Act, 1947. The primary question to decide in the matter is whether a surcharge can be imposed on sales tax.

The SC in October 1999 had referred the case to a bench of seven judges for consideration.



### Child welfare body member murdered



Berhampur, Oct 12: In a shocking incident, a Child Welfare Committee (CWC) member was brutally hacked to death allegedly by her driver at her Bijipur, Nilakanthanagar residence under Gosaninuagaon police limits in the Silk City Wednesday night, police said Thursday.

The deceased CWC member was identified as social activist Soudamini Rath, 52. On being informed, Gosaninuagaon police reached the spot and launched an investigation.

A blood-stained billhook and a scooter left behind by the car driver were seized from the spot. Rath's mobile phone was seized from the pocket of the accused driver. Preliminary inquiry indicated the involvement of her

Police arrested the car driver Seemanchal Sahu, 25, and recreated the crime scene at the spot, Thursday afternoon.

Police said the deceased was the secretary of a voluntary outfit 'Aruna' and was appointed as a CWC member, July 12, 2023. She had been to Bhubaneswar to attend a three-day-long training programme October 10 with her only son and daughter-in-law staying at Bangalore.

She had informed her driver that she will return by Thursday but later cut-short her visit to Bhubaneswar and returned

Berhampur earlier around 10.30pm, Wednesday. She went inside her bedroom

and later came to another room. However, she was stunned to find her driver stealing inside the room. This led to an altercation between them and Rath called up one of her relatives and informed about the theft by the driver on the phone.

Apprehending that he might get caught, the driver picked up a billhook and repeatedly hacked Rath on her head. Later, he fled the scene leaving the profusely bleeding woman behind. The woman screamed for help before collapsing. Hearing the screech over the phone, her relative rushed to the spot and found her lying dead in a pool of blood. He informed the police and the deceased's son at

A scientific team was pressed into service Thursday morning and the body sent for postmortem. Her son and daughterin-law also arrived Thursday morning. A case was registered in this connection over a complaint filed by her sister Pushpanjali Acharya at Gosaninuagaon police station.

When contacted, SDPO Rajiv Lochan Panda said that the driver has admitted to the killing. He said a probe is on to ascertain

why the driver entered her house in her absence and what he was trying to steal. Police are trying to probe the murder from various angles.

### **OPID** court convicts Ponzi firm manager, awards 3 years RI

He first paid Rs 9.60 lakh to Pati which included cash worth Rs 7.40 lakh and Rs 2.20 lakh online transfer to Pati's bank account to buy his bus. Later, he paid Rs 6.70 lakh in Pati's



account towards the outstanding dues of bank finance for the bus and received a No Objection Certificate (NOC) from the bank, Later, bus owner Pati called Bisovi to Chhatrapur RTO office and made him sign on

some papers. However, he sold the bus permit to another person and assured him that the ownership of the bus will soon be transferred in his name within a few days.

The bus developed some technical snags in February, 2020 for which Bisoyi took it to a garage for repairing. However, the bus remained in garage as it could not be repaired due to closure during the Covid-19 pandemic.

The fraud came to fore when Bisoyi visited the garage in September 2020 to enquire about the status of the bus. He was stunned when the garage owner informed him that the bus has been taken away by Pati.

When he contacted Pati, he abused him and said that the bus had been sold to another person.

### Spiral Of Violence

famas' brazen and vicious attacks within Israel have rightly drawn condemnation from around the world. If this is a war, as both sides agree it is, then Hamas' deliberate targeting of civilians counts as a major war crime.

But the brutality demonstrated by Hamas did not emerge in a vacuum. The lesson of what is currently happening in Israel and Gaza is that violence breeds more violence

The last real chance of avoiding the tragic conflict being waged between Israel and Hamas was destroyed by a single killing: the assassination of Israeli Prime Minister Yitzhak Rabin in 1995. The assassin was not a Palestinian militant, but an Israeli extremist opposed to the Oslo Accords, by which Rabin sought a "land for peace" deal that was anathema to Israeli radicals, for whom Jewish sovereignty in the Holy Land is non-negotiable.

Rabin's assassination occurred at the end of a peace rally attended by more than 100,000 Israelis, hopeful of an end to hostilities between Israel and Palestinians. At the time, that hope seemed realistic.

The great beneficiaries of the assassination were Israeli nationalists, above all Binyamin Netanyahu, the leader of the right-wing Likud

party. Netanyahu had rejected the Oslo Accords, because they required Israel to withdraw from the territories it had occupied after the Six-Day War in 1967. In a protest against the Accords, and against Rabin, Netanyahu led a mock funeral procession, complete with a coffin and hangman's

In the years after Rabin's murder, and particularly following the failure to reach a settlement at Camp David in 2000, rightwing extremists gained power in Israel, and the prospect of achieving a viable Palestinian state in the occupied territories all but disappeared. At the same time, the failure of Palestinian leader Yasser Arafat's secular Fatah movement to deliver Palestinian statehood strengthened the Islamist Hamas. which, along with other Palestinian militant organisations, bases its legitimacy on killing Israelis (as well as accused collaborators with Israel).

With Hamas extending its influence (and exporting its violence) from Gaza, which it has controlled since 2007, to the Israeli-occupied West Bank, where the Fatah-con-

trolled Palestinian Authority is nominally in charge, a growing number of Israelis supported the repressive measures Netanyahu promised. And with the hapless PA unable to halt relentless expansion of Jewish settlements in the West Bank, the cycle of extremism and violence continued.

Netanyahu now leads the most fanatically nationalist government in Israel's history, a government that includes Finance Minister Bezalel Smotrich, whose responsibilities include administration of a large part of the occupied West Bank. Smotrich has repeatedly incited violence against Palestinians.

In February, after a Palestinian shot dead two Israeli settlers, hundreds of Israelis rampaged through Huwara, a nearby Palestinian village, in scenes reminiscent of Cossack pogroms against Jewish settlements in Russia more than a century earlier. The Israelis set fire to Huwara, leaving one villager dead and others injured. And, like the Russian police when a pogrom was underway, Israeli forces in the area did not intervene to protect the residents or arrest the perpetrators

None of this excuses the atrocities committed against Israeli civilians by Hamas terrorists who killed more than 1,000 Israelis, most of them defenseless civilians, including women and children. Horrific videos show Hamas gunmen shooting, in cold blood, young people at a music festival. As a proportion of the population, this attack killed ten times as many people as al-Qaeda's attacks on the World Trade Center and

the Pentagon on September 11, 2001. When Hamas attacks Israeli civilians, it knows that this will lead to Israeli counterattacks in Gaza that are bound to kill and injure many civilians. Hamas locates its military sites in residential areas, hoping that this tactic will restrain Israeli attacks, or at least lessen international support for Israel

Hamas reportedly holds roughly 150 hostages, and has said that it will kill one every time Israel bombs a Gazan home without warning. Hamas leaders surely remember that in 2011, Netanyahu, as prime minister, was willing to free over 1,000 Palestinian prisoners, some of them terrorists, in exchange for the release of a single captive Israeli soldier, Gilad Shalit. Against that background, they may believe that Israel will not be prepared to sacrifice the lives of the hostages in order to achieve

If that is what the leaders of Hamas believe, they may find that they have made a mistake. Whether Israel can eliminate Hamas as a military force remains to be seen, but it is clear that in the battle to achieve that objective, Israel will have to be prepared to lose many lives, prob-

ably of both soldiers and hostages. How far Israel will go with its declared intention to deny electricity, fuel, food, and water to the two million citizens of Gaza, many of them children, is hard to know. What is certain is that Hamas' brutal crimes do not entitle Israel to starve children.

In the eyes of many outside observers, the cause of Palestinian autonomy and statehood has long held the moral high ground. Now that cause has been stained by the gruesome murders and abductions - many of them captured on video - carried out in its name. Paradoxically, if Palestinians are ever to regain the moral high ground, they must hope for the destruction of Hamas. As long as Hamas can claim to represent them, the evil it has perpetrated will taint their cause.

The comprehensive caste survey (CCS) released by the Bihar government on Gandhi Jayanti has caused a flutter, reviving memories of the early 1990s which were characterised by the release of the Mandal Commission report and the Advani-led Rath Yatra to build the Ram Temple in Avodhva (culminating in the destruction of the Babri Masjid in December 1992). The first got linked to the epithet Mandal Kamandal which was used to describe the VP Singh government's efforts to implement the Mandal Commission report to give caste-based reservation to OBCs as against the BJP's emerging Hindutva phalanx to capture the popular imagination and vote.

The CCS is a prelude to a clamour from Opposition parties and even smaller caste-based groups in the ruling NDA coalition (like the Anupriya Patel-led Apna Dal) for a nation-wide caste census. It may be noted that the last caste census was conducted in 1931 and it would be the first time since India's Independence that a caste-based census would happen, which is a promise by the Congress if it came to power as part of the INDIA alliance at the Centre. It is also noteworthy that the last decadal census was conducted in 2011 and the next census due in 2021 has been held in abevance due to COVID-19 and subsequent apathy on part of the Modi government.

The BJP, since coming to power in 2014, has systematically increased its profile, membership and voting share by being able to consolidate the Hindu base and bring all caste groups of the Hindu hierarchy under one broad tent. A large chunk of the BJP vote share comes from projecting itself as a Hindu party, protecting the interests of Hindus. In this perspective, the party has supported a broad coalition of interests of upper castes, Brahmins, Banias, Kayasths as well as a broad chunk of OBCs and other extremely backward castes in an amorphous grouping where the lower castes have subjugated their interests to become part of

a rainbow coalition for powersharing. This strategy has been giving the party rich dividends in successive general elections of 2014 and 2019. With the next general elections coming up a few months after elections in five states (including three in the Hindi-Hindu belt), the Bihar caste survey has shown the OBCs and EBCs occupying 63% of the state's population with the SCs accounting for 19.65%. Thus, adding the SC and ST groups, as also belonging to the broad spectrum of Hinduism, the total percentage of lower caste groups moves up to over 83% of the population while relegating the upper castes to just about 15.5%.

This has not only upset the BJP's electoral calculations but also aimed at redrawing the caste configuration for the purpose of higher reservations, proportionate to their population share, in educational institutions and employment. Thus, Rahul Gandhi's slogan, "Jitni aabadi utna haq" has found an echo among Opposition groups.

The Supreme Court has ruled against a stay on the CCS, supporting the Patna High Court's order of Aug 1, which had allowed the state government to go ahead with its caste census despite the Centre's objections that only the Centre as per the 7th Schedule of Constitution. the Census Act, 1948 and Census Rules, 1990 was empowered to conduct a census, and that privacy of respondents could be breached in such surveys. While calling the exercise a "social survey," the Bihar government has committed to bring out the socio-economic dimensions of the survey in a month and half. in time for the next sitting of the state legislature, so that targets can be fixed for allocating governance benefits and marking reservations for the hitherto uncounted groups.

It may be noted that a day

after the survey was released, the Nitish government allocated a 10% quota for economically weaker sections in state judicial services and state-run law colleges and universities, thus stealing a march over the BJP which had introduced such a category to assuage upper castes fixing an income criterion with an annual ceiling of Rs 8 lakh. States such as Karnataka Odisha, MP, Maharashtra and Haryana have already completed their OBC surveys while Rajasthan has committed to bring it out after state elections.

Once the socio-economic status data of the state caste surveys are out, the states can identify the most vulnerable groups and plan policy measures and empowerment schemes accordingly. This will lead to greater empowerment of lowest rungs of society and the emergence of new caste leaders where new groups could vie for a greater share in the social pie. With caste configurations clearly demarcated, this will throw up a number of regional and subregional leaders and lead to

coalitions at the base and intermediary levels.

This is a situation rife for a Mandal 2.0 with the demand for greater bargaining power among lower castes pre-empting the BJP's move to gain dividends from the opening of the Ram Temple in Ayodhya scheduled for early next year and cut into the ruling party's vote bank in the Hindi-Hindu belt substantially. In this sense, Nitish, along with the RJD, has played an astute move to spoil the BJP's plans to secure a march over the Opposition in 2024 general elections while as piring for a major role within the Opposition alliance. No wonder the BJP leadership has been confounded with this master-

stroke of Bihar politics. Meanwhile PM Modi has made disjointed statements accusing the Opposition of playing the caste card while mentioning that poverty is the biggest caste, meaning that the state governments should be more mindful of addressing poverty instead of dividing society in the name of caste, this seems like a knee-jerk reaction. The ruling party may not be able to contain the rising tide of OBC and lower caste demands through their local and regional

Dr. Ambedkar in his iconic tract, The Annihilation of Caste, had called for a total de-identification of the Dalits with Hinduism in order to evolve a new language of protest, and a new voice and identity for real empowerment. That, alas, is not going to happen. Rather the obverse will come true, of further fragmentation of the OBC groups in a bid to regain their identity within the structure of recognised religion. However, in this quest for a new identity and aspiration to be equal stakeholders in societal development, the OBCs should be vigilant about not losing their demand for greater attention of the state for their security, prosperity and justice.

### Rising inequality to exacerbate poverty

overty, the condition of lacking sufficient income or essential material possessions like food, clothing, and shelter to meet basic needs, remains a formidable social and economic challenge in India, despite the country's economic growth. India employs the Tendulkar methodology, developed by the Planning Commission, to measure poverty. This method focuses on assessing poverty based on consumption or spending over a specific period, with each Indian state establishing its own poverty threshold to determine the population living below poverty line.

The pandemic delivered India's economy a severe blow, the worst since Independence. In 2017, the World Bank estimated that over 20% of India's population lived in extreme poverty, defined as subsisting on less than \$1.90 per dav. A significant portion of India's middle class has slipped below the poverty threshold. Simultaneously, those already living in poverty found themselves pushed into extreme poverty due to the economic downturn. In stark contrast, the wealthy grew wealthier, exac-

erbating India's existing inequality problem. There exists a correlation in India between increasing inequality, measured by the Gini coefficient, and economic development since Independence. However, this does not imply that development has not benefited the country despite growing inequality. Since 1990s, the number of people living below the poverty line has nearly halved, thanks to economic growth.

In 2021, India was projected to reach a GDP per capita of just over \$11,900, while the average national income per capita stood at approximately \$10,560. This represented a significant increase compared to 2010, with an average GDP of \$7,700 and an average national income of around \$6,600. In general, India's GDP and national income have been on a steady upward trajectory since 2010, except for 2020, which was likely impacted by COVID-19.

Extrapolating data from PLFS 2019-20 reveals that a monthly income of Rs 25,000 places an individual among the top 10% of earners, indicating some degree of income disparity. The top 1% of earners account for 6-7% of total income, while the top 10% collectively garner a third of all income. In 2019-20, self-employed workers comprised the largest percentage of employment categories at 45.78%, followed by regular salaried workers at 33.5% and casual workers at 20.71%. Interestingly, self-employed work ers dominate the lower income categories. The unemployment rate stood at 4.8% in 2019-20.

In terms of health infrastructure, significant strides have been made in expanding capacity, particularly in rural areas. From 172,608 total health centers in 2005, the count had risen to 185,505 by 2020. Data from NFHS-4 (2015-16) and NFHS-5 (2019-21) reveal promising trends. In 2015-16, 58.6% of women received antenatal checkups during the first trimester, a figure that increased to 70% by 2019-21. Postnatal care received a boost too, with 78% of women benefiting from postnatal care within two days of delivery, and 79.1% of children receiving timely postnatal care. However, nutritional concerns, including issues of overweight, underweight, and prevalence of

anaemia (especially in children, adolescent girls, and pregnant women), remain pressing problems requiring immediate attention. Furthermore, low health coverage resulting in high outof-pocket expenditure directly impacts poverty rates.

The report underscores significant improvements in education and household conditions in India, driven by targeted efforts through social protection schemes, especially those related to water availability and sanitation. These improvements have raised living standards and are seen as essential long-term measures for addressing inequality.

Mitigating inequality in access to education and skill development among SC/ST populations and minority communities is a critical priority. If the current trend of rising inequality is not addressed through appropriate policy measures, it could exacerbate existing

### **Sundarbans records highest drowning mortality rate among children**

Kolkata, Oct 12: West Bengal's Sundarbans region has recorded the world's highest drowning mortality rate of 243 per lakh population among children in the age group of one to four in three years prior to the COVID-19 pandemic, according to a study. The study, which was conducted from 2016 to 2019, also found that the region has a mortality rate of 38.8 per lakh population among children aged between five and nine.

The study was conducted in 19 blocks – 13 in South 24 Parganas district and six in North 24 Parganas – of the region on incidents reported from October 2016 to September 2019. It was recently published.

"There was no difference in the mortality rates among boys and girls. Most children drowned in ponds within 50 metres of their homes when they were unaccompanied by their primary



caretakers who were engaged in household work," it said.

The survey was carried out by non-governmental organisation Child in Need Institute (CINI), in partnership with global agencies Royal National Lifeboat Institution (RNLI) and The George Institute (TGI) to gauge the enormity of the problem of drowning among children in the coastal Sundarbans region.

Sundarbans is a mangrove region in southeastern part of West Bengal and southwestern region of Bangladesh. In the Indian part, Sundarbans is spread over 100 islands and has around 40 lakh inhabitants. Of the total population, around 15.9 per cent are children aged between one and nine.

Many settlements are remote and far away from medical establishments. Water level in the waterbodies of Sundarbans increase during monsoon, while the coastal region is also increasingly experiencing incidents of flooding over the last four to five years. West Bengal's Sundarbans Affairs Minister Bankim Chandra Hazra acknowledged the problem of drowning of children and said that the state government is trying to address the issue.

'We have no hesitation in admitting that there have been incidents of deaths of children by drowning. However, we do not have a detailed report," Hazra said. According to the minister, the call of the hour is to raise the level of awareness among the residents of Sundarbans on drowning like they were informed about dengue, malaria or child marriage.

"Every year, we are losing

ing. People need to be informed in this regard to address this problem," Hazra added. CINI's national advocacy officer Sujoy Roy said that the survey will help not only locals but also highlight the situation before policymakers.

"Drowning deaths, particularly among children, are heartwrenching and entirely preventable. It is imperative that governments take heightened responsibility to protect our children from this silent peril. This study will help the local people as well as the government to understand how critical the situation is and realise the need to frame a policy in this regard," Roy said.

He said that the first-ever national seminar on drowning prevention was jointly organised by the Ministry of Health and Family Welfare and the World Health Organisation (WHO) in Kerala's Thiruvananthapuram

'We are ecstatic that the Durga Puja festival has prorided a beautiful backdrop to this unique tram that will enthrall people," the statement quoted the WBTC managing director of Rajanvir Singh Kapur.

The makeover inside the bogies includes cane installations and 'Alpona', a highly stylised folk art form traditionally practised by women, besides mirroring the luxurious appeal of the city which is regarded as the country's cultural capital.



### **Batla House encounter: HC reduces Ariz Khan's** death sentence to life

New Delhi, Oct 12: The Delhi High Court Thursday commuted to life term the death penalty awarded to Ariz Khan following his conviction in the sensational 2008 Batla House encounter in which Inspector Mohan Chand Sharma lost his life, saying while it was conscious that the country lost a decorated police officer in the line of duty, the case did not fall in the "rarest of rare" category to merit capital punishment.

A bench of Justices Siddharth Mridul and Amit Sharma upheld a trial court order convicting Khan of the murder of the police official and said testimonies of the eyewitnesses and other material established his presence at the place of incident as well as his firing at the raiding party while fleeing from the spot.

Accordingly, this Court is of the considered view that the sentence of rigorous imprisonment for life would be an appropriate sentence." the court said as it refused to confirm the death penalty awarded to Khan who was a 23-year-old B.Tech student at the time of the incident.

"It is pertinent to note that there is nothing on record to attribute the fatal shot responsible for the death of late Inspector Mohan Chand Sharma to any particular accused... This court is conscious of the fact that during the incident, the country lost a decorated police officer who sacrificed his life in the line of duty. His contribution will never be forgotten by an eternally grateful nation," the court said.

Sharma, an officer of the Delhi Police's Special Cell, was killed in the encounter between police and terrorists in south Delhi's Jamia Nagar September 19, 2008. Two terrorists were also killed in the encounter that took place days after five synchronised bomb explosions rocked the national capital, killing 39 people and wounding 159

Sharma had raided the place while looking for the terrorists\_\_ responsible for the blasts.

### Govt bans circulation of violent visuals

The state government said that it will file cases against those sharing such images or videos

Imphal, Oct 12: The Manipur government has prohibited the circulation of videos or images depicting violence and damage to properties to restore normalcy in the ethnic strife-torn state.

Such dissemination will be dealt with severely and those responsible will be booked under the law, said the government order issued Wednesday night.

The order was given as videos and images of widespread violence went viral on social media platforms. One such video showed two youths being shot at point blank and then being buried in a pit by a group of people. The location of the incident and the place of the burial is, however, not known.



The order by the Manipur home department stated, "The state government views very seriously and with utmost sensitivity the reported spread of videos and images depicting violent activities, inflicting harm or injury to (any)body or damage to private and public properties through various social media platforms which may aggravate the law and order situation in the state.' "The state government after

thorough examination of the matter has decided to restrain the act of spreading such videos and images as a positive step towards bringing normalcy in the state," it said.

Anyone in possession of such videos or images can approach the nearest superintendent of police irrespective of jurisdiction and submit them for taking appropriate action, the order said.

Any person found violating the order will be booked and prosecuted under the law and provision of misuse of technology. They will be dealt with under the IPC and IT Act, it

### Global water cycle 'spinning out of balance': WMO report

New Delhi, Oct 12: More than 50 per cent of catchment areas globally witnessed deviations from normal river discharge conditions last year, posing a significant challenge in providing water to an increasingly vulnerable world grappling with climate change, according to a report by the World

Meteorological Organisation. The report titled "WMO State of Global Water Resources 2022 Report" provides an independent and consistent global-scale quantitative assessment of water resources in large river basins in comparison to the long-term average for various variables like river discharge, groundwater, evaporation, soil moisture and inflow to reservoirs. It stated that the hydrologi-

cal cycle was spinning out of balance as a result of climate change and human activities.

The consequences of this imbalance are devastating, with droughts and extreme rainfall events wreaking havoc on both lives and economies. The melting of snow, ice, and glaciers intensifies flood risks and jeopardises long-term water security for millions of people worldwide.

The report contends that still too little is known about the true state of the world's freshwater

El Nino and La Nina are the two main phases of ENSO, or El Niño-Southern Oscillation, a climate pattern in the tropical

## BLINKEN VOWS US SUPPORT FOR ISRAEL

*Israel captured the West* Bank, along with Gaza and east Ierusalem, in a 1967 war. The Palestinians want all three territories for their future state, but there have been no peace talks in over a decade

Jerusalem, Oct 12: US Secretary State Antony Blinken vowed American support to Israel Thursday as its military pulverised the Hamas-ruled Gaza Strip with airstrikes and prepared for a possible ground invasion.

As Palestinians tried to stock up on bread and groceries amid dwindling supplies. Israel said nothing would be allowed into Gaza until around 150 hostages taken captive by Hamas during a weekend attack are freed.

International aid groups warned of worsening humanitarian crisis after Israel stopped all deliveries of food, water, fuel and electricity to the tiny enclave of 2.3 million people and prevented entry of supplies from Egypt. The war has already claimed at least 2,700 lives on both sides.

"Not a single electricity switch will

be flipped on, not a single faucet will

be turned on, and not a single fuel truck will enter until the Israeli hostages are returned home," Israeli Energy Minister Israel Katz said on so-

cial media. Lt. Col. Richard Hecht, an Israeli



military spokesman, told reporters on Thursday that forces "are preparing for a ground maneuver" should political leaders order one. A ground offensive in Gaza, where the population is densely packed into a sliver of land only 40 kilometers (25 miles) long, would likely bring even higher casualties on both sides in brutal house-tohouse fighting.

As Israel pounds Gaza from the air. Hamas militants have fired thousands of rockets into Israel. Palestinians fleeing airstrikes in Gaza could be seen running through the streets, carrying their belongings and looking for a safe place. The number of people who fled their homes soared 30 per cent within 24 hours, reaching 340,000 people by Wednesday night. Most crowded into UN-run schools while others are staying with relatives or even strangers who let them in.

Lines formed outside bakeries and

grocery stores during the few hours they dared open, as people tried to stock up before shelves emptied. On Wednesday, Gaza's only power station ran out of fuel and shut down, leaving only lights powered by scattered private generators.

Hospitals, overwhelmed by a constant stream of wounded and running out of supplies, have only a few days worth of fuel before their power cuts off, aid officials say. The cut-off has also caused dire water shortage for over 650,000 peo-

ple, according to the UN. "Without electricity, hospitals risk turning into morgues," warned Fabrizio Carboni, regional director of the International Committee of the Red Cross. When power runs out, it puts "newborns in incubators and elderly patients on oxygen at risk. Kidney dialysis stops, and X-rays can't be taken", he said.

Gaza's densely populated terrain, its network of underground tunnels and the sheer numbers of men, women and children taken captive present Israel with the most complex hostage crisis that the country has ever faced. Mounting rescue operations in the midst of the massive Israeli bombardment of Gaza that followed the deadly Hamas rampage in southern Israel would only make an already difficult mission even more formidable.

"The situation is unprecedented," said Gershon Baskin, who helped to negotiate the 2011 release of Staff Sgt. Gilad Schalit after more than five years of Hamas captivity. "I think Hamas was surprised at the ease it was able to take hostages. Israel was completely bewildered by everything that's happened."

Images of hostages have become seared into Israel's collective consciousness. The panicked woman being dragged off by militants on a motorcycle, her boyfriend marched across the border on foot. The terrified mother, wrapped in a blanket, clasping her two young children. The company - which competes in the IT services market with TCS, Wipro, HCL Technologies and others saw its revenue rising 6.7 per cent to ₹38,994 crore for the just-ended September quarter. Infosys CEO and MD Salil Parekh said, "We had our highest large deals value at \$7.7 billion in O2 spread across all verticals and geographies". Infosys headcount fell by 7,530 to 3.28,764 as of September 30, 2023, against 3,36,294 in the June quarter.

### HCL Tech net up 9%

New Delhi: IT major HCL Technologies Thursday reported a 9.9 per cent increase in consolidated net profit to ₹3,833 crore for the second quarter ended September 30. The company had posted a net profit of ₹3,487 crore a year ago. Its consolidated revenue from operations during the reported quarter increased by 8 per cent to ₹26,672 crore from ₹24,686 crore in the September 2022 quarter, according to a BSE filing.

As many as 284 stocks hit their 52-week highs, while 20 stocks hit the year's low level.

Analysts said selling in IT shares following mixed results by IT heavyweights TCS and Infosys dragged the key indices from the day's high levels.

Infosys was the biggest loser among the Sensex stocks, falling 2.29 per cent ahead of its financial results to be announced after market hours. HCL Technologies also dropped 1.75 per cent ahead of its results. Profit taking in Bajaj Finance, Nestle, Kotak Bank, SBI, Bharti Airtel L&T and Asian Paints also weighed on the benchmark index.

New Delhi, Oct 12: India's retail inflation eased to a threemonth low in September on the back of softer vegetable prices, but remained above a target of 4% that the central bank has signalled would be key before easing rates.

Annual retail inflation rose 5.02% in September, down from 6.83% the previous month.

Food inflation, which accounts for nearly half of the overall consumer price basket, rose 6.56% in September as compared with 9.94% in August.

September inflation was below the Reserve Bank of India's (RBI) upper tolerance band of 2%-6% But the RBI earlier this month

kept its key lending rate steady for a fourth consecutive policy meeting, and emphatically reiterated that it was targeting inflation of 4% and a print of below 6% might not suffice as a condition for easing rates.

## Retail inflation eases IIP rises at fastest pace in over a year

New Delhi, Oct 12: India's industrial production growth rose to a 14-month high of 10.3 per cent in August, mainly due to good show by the manufacturing, mining and power sectors, according to the official data released Thursday.

The factory output growth measured in terms of the Index of Industrial Production (IIP) had contracted by 0.7 per cent in August 2022.

The previous high was recorded at 12.6 per cent growth in June 2022. The IIP growth for July has been revised to 6 per cent from 5.7 per cent provisional estimates released last month. During April-August 2023-24,

the IIP growth works out to be 6.1 per cent, down from 7.7 per cent in the corresponding period a year ago.

"The growth rates over the corresponding period of the previous year are to be interpreted, considering the unusual circumstances on account of the

Covid-19 pandemic since March 2020," an official statement said.

As per the IIP data released by the National Statistical Office (NSO), the manufacturing sector's output grew 9.3 per cent in August 2023 against a contraction of 0.5 per cent a year ago. Power generation rose 15.3 per cent in August 2023 compared to 1.4 per cent in the year-ago period. Mining output rose by 12.3 per cent during the month under review against a 3.9 per cent contraction a year ago.

As per use-based classification, the capital goods segment grew 12.6 per cent in August this year compared to 4.3 per cent.

Consumer durables output during the month declined by 5.7 per cent against a contraction of 4.4 per cent in the yearago period.

Consumer non-durable goods output increased by 9 per cent compared to a contraction of 9 per cent a year earlier. Infrastructure/construction goods posted a growth of 14.9 per cent against a three per cent expansion a year ago.

The data also showed that the output of primary goods logged 12.4 per cent growth in the month against 1.7 per cent in the year-ago period. The intermediate goods output in August rose 6.5 per cent from 1.3 per cent growth during the corresponding month last year.

### 'Vivo siphoned off ₹1.07tn'

New Delhi, Oct 12: Many emplovees of Chinese smartphone maker Vivo and its Indian affiliates concealed their employment when seeking visas, and some breached rules by visiting the 'sensitive" Himalayan region of Jammu and Kashmir, India's financial crime agency has said.

The accusations, detailed Tuesday in a court filing that is not public, follow the arrest this week of a Vivo executive, Guangwen Kuang, in a money laundering investigation launched in 2022 into India's second biggest smartphone player.

This week's court filing says ₹1.07 trillion was remitted outside India by Vivo to some trading companies controlled by its Chinese parent, in what the agency called a "masking layer" intended to escape government



'While no profits were shown from 2014-15 to 2019-20 in the statutory filings and no income taxes were paid ... huge sums were siphoned off out of India," the Enforcement Directorate added.



### 'Defending gold in Paris will be tough'

Gurugram, Oct 12: Neeraj Chopra has been in sizzling form in season 2023, winning almost everything on offer, but the star athlete has no qualms in admitting that defending his gold medal at Paris Olympics will be a huge challenge since maintaining top form on a consistent basis is not easy.

Chopra said it is not wise to write off two-time world champion (2019 and 2022) Anderson Peters of Grenada, who has endured a miserable season as he struggled to touch even 80m mark. Peters was one of the medal favourites, going into Tokyo Olympics but he could not even qualify for the finals.

"Defending my Olympic gold medal could be tough because there is pressure and expectations from the people. Maintaining top form for many years is challenging but my endeavour will be to prepare in the best possible way and give my best in Paris," Chopra told PTI in an interview.

"Peters was not in good form but we can't say anything for next year. One year is a long time and everybody will try to be in best of fitness and form. I was injured in 2019 and could not play the whole year.

"Every player faces injuries and downward turn in performance. Competition will be tough in Paris Olympics and



also in other competitions.'

The 25-year-old Chopra was Thursday inducted as the new and first non-cricket Laureus Goodwill Ambassador. He was joined by former India allrounder Yuvraj Singh who has been Laureus Goodwill Ambassador since 2017.

Chopra defended his Asian Games gold medal in Hangzhou earlier this month with a season's best throw of 88.88m, which was his fourth career-best effort. He emerged winner in an enticing battle with compatriot Kishore Jena who won the silver medal.

Asked if he can visualise two Indians standing on the podium to say, it will not be easy. But if we (him and Jena) keep on doing well and give our best, if not next year, it can happen in future competitions.'

Chopra said athletes looking for quick results must realise that there are no shortcuts to success and resorting to certain practices will only close the road for them. While he did not say it in as many words. Chopra's message could be for dope offenders.

"Give your 100 per cent in whatever field you are. If I speak on sports, the thing I can see currently as a little bit of a problem is lack of nationce in our athletes. Some of them want quick results and because of that they do certain training or take diets that closes their road ahead,"

On Chopra refusing to consider himself as the greatestever Indian track and field athlete, Yuvraj said, "For a great athlete, there is no need to say that he is great. When we play, we say let the bat talk. Neeraj's iavelin talks.

"The coming generation should learn from the greatness he has achieved. He has struggled, he has worked for many years. I am hoping that he will win many more medals and India will become number one in track

Pakistan were based in Hyderabad since their arrival in India after a gap of seven years, playing four games including two warm-up clashes and continued to receive a lot of attention from fans and the media.

The Babar Azam-led side felt being 'at home' in Hyderabad as a large crowd in support of the neighbours turned up at the airport September 27, and particularly for their last match at the stadium in Uppal against Sri

Lanka. Pakistan are coming into the match after a comprehensive win over Sri Lanka in which they pulled off the highest run chase in the history of World Cup. The hosts India, too, will enter the contest on the back of two comfortable victories against Australia and Afghanistan.

Chennai, Oct 12: Fortified by the return of inspirational captain and premier batter Kane Williamson, a high-flying New Zealand will believe that they can ward off a spin-heavy Bangladesh to consolidate their position on top of the table during their World Cup match here Friday.

The Kiwis (NRR: +1.958) have four points now, same as India (NRR: +1.5) and Pakistan (NRR: +0.92) but a better net run-rate (NRR) has kept them ahead, and a win here will free them from the chasing pack for the time being.

In that context, the arrival of Williamson, who has sufficiently recovered from a post ACL injury surgery, benefits them on two

Williamson is a shrewd captain who knows the ebb and flow of ODIs, and he is an excellent bat



ter against spin, a quality that he might have to conjure against a capable Bangladesh unit on a slow Chepauk pitch.

Williamson had missed the Kiwis' matches against England and Netherlands as Tom Latham had stood in as New Zealand captain in those games. But the Black Caps will continue to miss the services of senior pacer Tim Southee, who is still recovering from a procedure on his frac-

tured thumb. However, Williamson's come-

back will pose the Kiwis with a selection dilemma as well. Rachin Ravindra, who batted at No.3 in the absence of Williamson, has notched up a hundred and fifty in two World Cup outings, and the Kiwis management will have to think hard as to who to be benched to accommodate the returning 33-year-old.

The MA Chidambaram track could offer another turner like it did in the match between India and Australia the previous Sunday Despite a walloping at the hands of England in their last match, this could be Bangladesh's secret point of joy going against the Kiwis.

Their spin trio of captain Shakib 🔫 Al Hasan, Mahedi Hasan and Mehidy Hasan Miraz has taken 11 wickets among them from two matches. The Tigers will pin their hopes on those three to weave their magic on New Zealand to notch up a crucial victory.
