100 chess training centres soon: CM

Bhubaneswar, Oct 25: After promoting hockey, football and other games, Odisha government Wednesday said it will also encourage chess and set up 100 training centres.

This was informed by Chief Minister Naveen Patnaik after meeting Dana Reizniece-Ozola, Woman Grand Master, Deputy Chair of FIDE (International Chess Federation) Management Board and former Minister of Finance & Economics, Republic of Latvia.

Patnaik and Reizniece-Ozola emphasized the need to popularise chess as a mind-sport and its immense potential to empower the youth intellectually and emotionally. "We are committed to providing the best opportunities for our youth, and chess is a powerful avenue for their growth. Pandian gets cabinet min rank

Bhubaneswar, Oct 25: VK Pandian, the former aide to Odisha CM Naveen Patnaik, has been appointed Chairman 5T (Transformational Initiatives) with the rank of a cabinet minister, an official notification said.

The development comes less than 24 hours after the 2000-batch IAS officer took voluntary retirement from government service.

'Shri VK Pandian is hereby ap-



pointed as Chairman 5T (Transformational Initiatives) and Nabin Odisha in the rank of Cabinet Minister. Pandian shall

work directly under the Chief Minister," the General Administration and Public Grievance Department said.

Pandian joined the Chief Minister's Office (CMO) in 2011, and since then, he has been Patnaik's private secretary.

After Patnaik became the chief minister for the fifth time in 2019, Pandian was given additional responsibility of '5T secretary' to implement some transformational initiatives in government departments. P4

'Bharat' from schools

NCERT PANEL RECOMMENDS REPLACING 'INDIA' WITH 'BHARAT' IN TEXTBOOKS; NO DECISION YET, SAYS COUNCIL

New Delhi, Oct 25: In a move ostensibly aimed at familarising the new generation with a change in the country's nomenclature, a high-level committee for social sciences, formed by the National Council of Educational Research and Training (NCERT) to revise the school curriculum, has recommended replacing 'India' with 'Bharat' in the textbooks for all

According to committee chairperson C I Isaac, the panel has suggested replacing the name 'India' with 'Bharat' in the textbooks, introducing 'classical history', instead of 'ancient history', in the curriculum and including the Indian Knowledge System (IKS) in the syllabus for all subjects.

NCERT Chairman Dinesh Saklani, however, said no decision has been taken yet on the panel's recommendations

The council later said on X: "NCERT states that since the development of new syllabus and textbooks is in the process and for that purpose various Curricular Area Groups of domain experts are being notified by the NCERT. So, it is too premature to comment.'

"The committee has unanimously recommended that the name 'Bharat' should be used in the textbooks for students across classes. We have also recommended introducing classical history instead of ancient history in the textbooks," Isaac said.

"Bharat is an age-old name. The name Bharat has been used in ancient texts, such as Vishnu Purana, which is 7,000 years old,' the Padma Shree awardee said.

The name "Bharat" first appeared officially when the government sent out G20 invites in the name of "President of Bharat", instead of "President of India".

Later, the nameplate of Prime Minister Narendra Modi during the summit in New Delhi also read "Bharat", instead of India.

Isaac said the committee has also recommended highlighting "Hindu victories" in various battles in the textbooks.

'Our failures are presently mentioned in the textbooks. But our victories over the Mughals and sultans are not," said Isaac, who is also a member of the Indian Council of Historical Research (ICHR)

"The British had divided Indian history into three phases - ancient, medieval and modern - showing India in darkness, unaware of scientific knowledge and progress. Therefore, we have suggested that the classical period of Indian history be taught in schools, along with the medieval and modern periods," he added.

The NCERT is revising the curriculum of the school textbooks in line with the National Education Policy (NEP) 2020. The council recently constituted a 19-member National Syllabus and Teaching Learning Material Committee (NSTC) to finalise the curriculum, textbooks and learning material for these__ classes.

"The committee has also recommended the introduction of the Indian Knowledge System in the curriculum of all subiects," Isaac said.

Man gets job 28 yrs after application

New Delhi, Oct 25: Twenty-eight years after a man applied for a job in the postal department, the Supreme Court has ordered his appointment noting that there was an error in holding him ineligible for the post.

Ankur Gupta had applied for the post of postal assistant in 1995. After being selected for pre-induction training, he was later excluded from the merit list on the ground that he completed intermediate education from the "vocational stream"

Gupta along with other unsuccessful candidates moved the Central Administrative Tribunal which ruled in their favour in 1999.

The postal department challenged the tribunal's order and approached the Allahabad High Court in 2000.



The high court dismissed the petition in 2017 and upheld the CAT's order. A review was filed in the high court which was also dismissed in 2021, following which the department approached the apex court. In the top court, a bench of justices Bela M Trivedi and Dipankar Datta said a candidate cannot claim a vested right to appointment, once he is included in the merit list, he has a limited right of being accorded a fair treatment.

"However, if the candidature is not rejected at the threshold and the candidate is allowed to participate in the selection process and ultimately his name figures in the merit list though such candidate has no indefeasible right to claim appointment, he does have a limited right of being accorded fair and non-discriminatory treatment," the bench said.

The bench said if the department had declared Gupta as ineligible based on the appreciation of the educational qualification at the threshold, the situation would have entirely been different.

Invoking its extraordinary jurisdiction under Article 142 of the Constitution, the top court directed that Gupta be offered appointment, initially on probation, on a post of Postal Assistant (for which he was selected) within a month and if no post is vacant, a supernumerary post shall be created for him.







With VK Pandian appointed as Chairman 5T (and Nabin Odisha), having the rank of a cabinet minister, following his voluntary retirement from service, **Orissa POST** takes a sneak peek into the illustrious journey of the 2000-batch IAS officer

he 2000-batch IAS officer, who is also christened as the 'man with a mission' in the transformation and development of Odisha, has been with 'every success' in the state under the leadership of Chief Minister Naveen Patnaik.

Be it transforming the cities of cultural heritage or making the state a sports hub for international tournaments, Pandian has made his mark in all developmental works of Odisha. While he is known for his commitment to working for the state, another aspect of his social life is also interesting – his love for children especially the needy and special ones.

Sraddha Sanjeevani, a special home for the HIV infected orphans, in Gopalpur is an example of his compassion towards the children in need. It was set up in 2007, by the Ganjam district administration when Pandian was the Collector of the district. It lends vulnerable children a new lease of life. He was also instrumental in arranging a marriage of two of the inmates of Sraddha Sanjeevani who were blessed by CM Naveen Patnaik.

His tryst with Odisha began in 2000 when he became an Odisha-cadre civil servant and started his career in the development of the state. In 2002, he became the Sub-Collector of Dharmagarh where he left his mark by continuously improving the revenue sources for the government. His tough stance with the millers ensured full payment of MSP to the farmers and profits to cooperative societies. People still remember his action.

This had an impact on the revenues and helped the government to get highest-ever revenue collection during that time. This initiative got him the appreciation and felicitation from the CM. As ADM in Rourkela, he had a blazing tenure of seven months. He was instrumental in the eviction of Chhend Market and letting people getting back their hard earned money after 15 years.

Pandian was one of the youngest Collectors of the country when he took charge of Odisha's largest district – Mayurbhanj. His daily visits to the remote villages of the district helped accelerate the development process on the rehabilitation of Persons with Disabilities (PwDs). He set in place a mechanism whereby PwDs

This was later adopted as a state policy by the Odisha government. For his contribution to the upliftment of PwDs, Pandian was awarded with the prestigious Hellen Keller Award – a rare distinction in the state.

Pandian's pioneering and out of box interventions continued when he became the Collector of Ganjam. The district got the National Award for being the best district in the country in MGNREGS implementation. He was instrumental in bringing in groundbreaking innovations by undertaking payment of wages through bank accounts – well before it was adopted by the state or at the national level.

A record ₹100-crore was transferred in this manner into the bank accounts of thousands of labourers. His successful approach resulted in Ganjam getting the Presidents' Award twice for leading changes. The people-friendly approach helped maximise the mandays under NREGA and minimise the incidents of labour migration to other states.

The innovations implemented in Ganjam such as transfer of wages to bank accounts and

later adopted nationally. These steps showed a deep sensitivity and understanding of people and an intent to root out corruption in government functioning.

Pandian took the mantle as Chief Minister Naveen Patnaik's Private Secretary in the year 2011 and has been assisting the Chief Minister till date in all the developmental activities. Because of his sheer commitment to his duty, he became Naveen's choice for the post.

With his impeccable track record and successfully doing his duties, Naveen handed over to his an important task of transforming the governance by making him the Secretary of 5T Initiatives. This assignment was entrusted to him for his qualities as a team player. Those who have worked with him swear by his fierce lovalty and unimaginable support

loyalty and unimaginable support.
With Pandian at the helm of Naveen's trans-

formation agenda, a number of reforms have been undertaken in the state. Odisha is witnessing a visible change in all parameters of

development propelled by the 5T initiatives.

Bhubaneswar, Oct 25: The state government has formulated a scheme with a ₹385-crore budget for three years from the current fiscal to empower youths with the requisite skills for new-age technologies and emerging trade.

A notification issued by Skill Development and Technical Education department said the 'Nutana Unnata Abhilasha' (NUA) programme will cover all 30 districts of the state and prioritise aspirational, tribal and remote areas.

It will be implemented by the

directorates of employment, technical education & training and the World Skill Centre.

The scheme will leverage ex-

The scheme will leverage existing and new skilling institutions and partnerships with industries to deliver training, the notification said.

Skill Development and Technical Education department principal secretary Usha Padhee said in the notification that the programme will work towards "addressing the scarcity of skilled human resources in emerging trades by offering high-quality training, fostering industry linkage and enhancing employability skills".

It will also help bridge the skill gap in the utilisation of new-age technologies in traditional sectors like handicrafts, handloom, agriculture and others, she said.

The scheme has been designed to cater to a wide range of beneficiaries ranging from school dropouts and engineering graduates to postgraduates through various offerings, including "fresh skilling for youths, employability skills for students in various institutions", the official said.

Training offerings range from skilling courses for youths to digital and e-courses for higher education students, another official said, adding that the scheme includes establishing advanced labs, incentivising training providers, curriculum development and training of trainers.

2 bikers killed in road mishap

Dhenkikote, Oct 25: Two bikers were killed after an unknown iron ore laden truck ran over their vehicle near Pipilia Ghatimangala on National Highway-20 under Dhenkikote police beat house limits in Keonjhar district Tuesday night, police said Wednesday.

The deceased were identified as Chandra Mohan Nayak, 45, and Sadhu Charan Kashmalia, 48, of Jharbeda police limits under Pandapada police limits in Keonjhar district.

The mishap occurred when Chandra Mohan accompanied by Sadhu Charan was on his way to buy medicines from Pipilia, at 9pm Tuesday. They were on the Ghatimangala bridge when an iron ore laden truck hit them from rear and ran over their vehicle. Profusely bleeding, the two died on the spot.

The mishap triggered tension in the area as locals staged a road blockade. Ghatagaon police IIC Anjan Kumar Patra, Dhenkikote OIC reached the spot and tried to placate the villagers from withdrawing the blockade. The bodies were handed over to their family members after a post-mortem, Wednesday A case was registered in this connection and further investigations were on, sub-inspector Tapan Kumar Jena said. Nayagarh, Oct 25: With the festival of lights around the corner, illegal firecracker manufacturing units have mushroomed under various police station limits in Nayagarh district. Consequently, threat of cracker explosion looms large in the concerned areas, a report said Wednesday.

What is worrisome is that most of these cracker manufacturing units have been set up within human habitats sans valid license and these operate in a clandestine manner to avoid getting caught by others and police.

These units, mostly operating from residential houses, not only manufacture crackers illegally but also store them for sale at a later date. No government norm is followed during manuThis is likely to endanger peo-

ple's lives in case a mishap occurs in any of these units. Despite the threat involved to the life and property of the denizens, police are yet to take action against the cracker manufac-

Everything is happening under their nose, but police have been sitting pretty on the issue despite death of as many as 14 persons in cracker explosions during the last 11 years.

Similarly, illegal firecracker shops have also come up in this district headquarters town as well as various rural areas with Diwali drawing near. Locals have questioned who will be held responsible in case a major explosion takes place due to illegal manufacturing and reckless storage of crackers.

While the threat of cracker blast looms large, police have started conducting raids on cracker manufacturing units in their respective areas during the Dussehra festival.

Locals termed the raids being undertaken to be just eyewash by police officials. Except for arresting one or two persons, they never take any stringent action to stop mushrooming of illegal cracker manufacturing units.

Residents of the area alleged



that the arrests have failed to deter the cracker manufacturers as they carry on their business with impunity even after the

Reports said four persons died in cracker blast at Gobindpur village under Itamati police limits in 2012 while eight died in a similar blast at Tantisahi in Itamati in 2016. One person was killed at Godipada village in 2019 while another died at Tendabadi under Sarankul police limits in 2015.

All these blasts occurred at cracker manufacturing units based within and close to human habitats. The police action against cracker manufacturing units from 2012 to 2019 has not been satisfactory, locals alleged. It seems police have meekly surrendered before the illegal

cracker manufacturers, they lamented.

Police have failed to launch a crackdown against the illegal cracker manufacturers. However, no untoward incident has taken place in the past three years. Cracker manufacturing units have mushroomed even in villages and crackers are sold illegally by people without a valid

Nayagarh town, Godipada, Itamati, Jamusahi of Bhapur block and Korada village under Nuagaon block have turned into hubs of illegal cracker production and sale. Fear of a major mishap cannot be ruled out in future as the cracker manufacturers do not abide by the government norms establishing their units. This is also taking a toll on the manufacturers who are into the business with a valid license.

A cracker trader requesting anonymity said that police are fully aware about the illegal cracker manufacturing units set up in human settlements. These illegal businesses have thrived as the police and manufacturers are hand in gloves to run the units. The manufacturers run their business by greasing the palms of police and other government officials. Police feign ignorance about these units whenever any mishap occurs in the area under its jurisdiction.

When contacted, Nayagarh Sadar police station IIC Anita Sahu, her Itamati counterpart Dillip Swain and Sarankul counterpart Pushpalata Behera said they are keeping a close watch on these illegal activities and such units are being raided in frequent intervals.

Fategarh IIC Sujit Kumar Das said raids are being carried out for Durga Puja festival on the direction of the SP. Recently, they seized illegal firecrackers worth Rs 80,000 and arrested a person Bhagaban Nayak in this connection. Nuagaon police IIC Narayan Chandra Lenka also said that they recently arrested a person for his involvement in illegal cracker manufacturing and sale from Korada village.

Man bites off neighbour's nose

Kantipala: In a bizarre incident, a man bit off his neighbour's nose at Mathianendi village under Taratara panchayat under Anandapur police limits in Keonjhar district Wednesday. The injured man was shifted to a hospital at Cuttack in a critical condition. The accused was identified as Kanhu Naik of this village and the injured was identified as his neighbor Gatikrushna Naik. As per reports, Kanhu scolded Gatikrushna's sister-in-law Wednesday over some reason. However, the situation turned ugly when Gatikrushna opposed him and Kanhu also started abusing Gatikrushna. The matter escalated to a scuffle between the duo and Kanhu bit the nose of Gatikrushna off his face in a fit of rage.

Youth found hanging, murder suspected

Lecturer dies 8 months after student's assault

As per the centuries old tradition, the sanctum sanctorum of Panchubarahi shrine remains closed every Tuesday.

Keeping the tradition alive, the Panchubarahi shrine remained closed

yesterday though it was Dussehra. As per the legend, Maa Panchubarahi (the five sisters) observe 'Mangala brata' every Tuesday



to save the people of Satabhaya from

As Maa Panchubarahi is on fast, the temple of Panchubarahi remains closed Tuesday.

"Our predecessors used to skip the rites and rituals of the presiding deity Maa Panchubarahi Tuesday. Respecting the age old tradition, we close the sanctum sanctorum every Tuesday even if major Hindu festival falls on that day," says Banalata Dalei, one of the priests.

At Panchubarahi shrine, the Asthami puja, Tarini puja, Sandhi

puja, Navami puja and Maha Dashami puja are held on Durga Asthami day but not on three different days, said Sangram Keshari Sahani, the president of Maa Panchubarahi Puja Committee.

Another unique feature of the shrine is that women from Sabar community perform the rituals of the deities and males are debarred to enter into the sanctum sanctorum.

A temple priest said as per the legend, a priest turned stone after the deities cursed him as he made a sin while performing the bathing rituals of the deities.

The deities later directed the king in his dream to engage women from Sabar community to do the rituals.

From that day onwards, women from tribal community have been performing the daily rites of the Goddess.

The centuries old Panchubarahi temple, built during the dynasty of Bhaumakar, was shifted to Bagapatia Rehabilitation colony from Satabhaya in 2018 following the threat of sea erosion.

oland's populist-authoritarian ruling party, Law and Justice (PiS), was trounced in last Sunday's parliamentary elections, receiving just 35.4% of the vote compared to 53.5% for pro-democracy opposition parties. This marks the second important defeat for authoritarian politicians in the West since Joe Biden's victory over Donald Trump. The question now is what lessons it might offer for Poland, Europe, and other democracies.

As in the 2020 US presidential election, Poland's election generated record-breaking turnout of 74%, up from 62% in 2019 – the highest since the fall of communism in 1989. Not only did PiS fail to increase its total vote count from the previous election (something Trump managed to do), but the three democratic opposition parties (like Biden) increased their votes by more than three million.

Although the election was technically free (meaning the votes were properly counted), it definitely was not fair. The deck was stacked so much in PiS' favour that it would have made Hungary's authoritarian prime minister, Viktor Orbán, proud. Throughout the campaign, the state-controlled TV channel - which commands a viewership of around 3.5 million, accounting for around 40% of the

national news audience (of whom several million have no access to other TV channels) - pumped out PiS propaganda around the clock. Meanwhile, state-owned companies, including key utilities, spent as much on pro-PiS campaign ads as PiS

But, unlike in Hungary, Poland's large cable-news channel, TVN24 (which is owned by the US company Discovery), remained resolutely independent, and another mid-size channel (owned by a Polish billionaire) offered more diverse coverage despite its pro-government bias At the same time, most internet and print media remained free, though the state oil monopoly did buy up most of the local press to advocate for PiS.

So, what are the lessons? First, the longer that authoritarian rule lasts, the harder it is to end it, because those in power will gradually eliminate independent institutions and centers of influence such as independent media. The chances for a similar reversal in Hungary or Turkey, where autocratic rule has persisted for more than a decade, are much smaller than in Poland. Had PiS prevailed in this election, it could have consolidated its hold on power for many more

Second, electoral systems based on proportional representation (as in Poland) are harder for authoritarian parties to dominate than are "first-past-the-post" win-

ner-take-all systems (as in Hungary and Turkey). Proportional means proportional, after all, whereas first-past-the-post systems are more susceptible to gerrymandering. While there is still some scope for such manipulation in Poland - that is why PiS won 42% of the Sejm (lower parliament) with only 35% of the votes - it was not enough to guarantee victory. In Hungary, by contrast, Orbán has locked in a supermajority, large enough to amend the constitution, with only around

Moreover, first-past-the-post electoral systems tend to polarise voters and raise the stakes of elections, which increasingly come to seem existential to one or both sides. The implication is that if authoritarians gain control of a major party in such a system, they can pose a threat to the broader constitutional order for many decades, as now seems to be happening in the United States.

One key reason for PiS' defeat was that Third Way, a party caterng to democratically inclined moderate conservatives (the Polish equivalent of never-Trump Republicans), won 65 Seim seats. Just imagine how different US politics would be if a party led, for example, by Liz Cheney, the staunchly conservative former congresswoman from Wyoming who was ousted for her opposition to Trump, controlled 60 seats in the House of Representatives.

If we want to protect our democracies from the menace of authoritarianism, we need to make our electoral systems as proportional as possible, even if that leads to greater political fragmentation. When PiS won a majority of parliamentary seats in 2015 with only 38% of the vote, it was because threshold requirements had excluded parties that together had garnered some 16% of the vote.

In Weimar Germany at the height of the Great Depression, when unemployment was at 30%, the Nazis were stymied from winning a majority by the country's proportional-representation system. Only by staging a coup after the Reichstag fire were they able to consolidate absolute power. Looking ahead, pro-democratic forces in the US should advocate two-round voting systems (of the kind that Georgia has for US races) as a substitute for party primaries. Likewise, in Poland, thresholds for entering parliament should be radically reduced to 1%.

A third lesson is that pro-democracy forces not only must offer diversity to voters; they also must increase turnout. That is what former Polish Prime Minister and European Council President Donald Tusk did this year with a relentless eight-month campaign that involved holding 3-4 public meetings every week across PiS' rural strongholds. While Third Way offered a somewhat softer face to the disenchanted, Tusk offered red meat to all those Poles who favour

Finally, we must not forget that the populist-authoritarian threat pervades the West. That means the democratic response to it must be equally wide ranging. In Europe, the new Polish government needs to do away with the protective umbrella that PiS has been holding over Orbán by effectively vetoing key EU enforcement actions against rule-of-law violations in Hungary. Proceedings against Orbán under Article 7 of the Treaty on European Union should be revived without delay, and Hungary should be stripped of its EU voting rights until it reestablishes a properly functioning democratic order. Elections – even in other countries – must be seen to have consequences.

HOW TO FIGHT HUNGER

THE GHI REPORT **NOTES THAT INDIA HAS THE HIGHEST CHILD WASTING RATE IN** THE WORLD. AT 18.7%, REFLECTING **ACUTE** UNDERNUTRITION

The findings of the Global Hunger Index (GHI) 2023 in respect of India should not be allowed to be side-tracked by the remarks of the Union Minister of Women and Child Development Smriti Irani that have been heavily and rightly criticised by the Opposition as arrogant and making a mockery of an important issue like hunger. The Index has placed India at the bottom of the heap of nations, at rank 111 out of the 125 countries with sufficient data available to calculate 2023 GHI scores. The GHI report 2023 gives India a composite score of 28.7, indicating a level of hunger that the report has called "serious" (scores between 20 and 34.9). Scores 35 and above are categorised as alarming and above 50 as extremely alarming. The term "hunger" refers to the Index based on the four component indicators used to calculate the scores - undernourishment, child stunting, child wasting, and child mortality. Taken together, according to the GHI, the component indicators reflect deficiencies in calories as well as in micronutrients. The GHI sources data from internationally accepted sources, and has named the following in its appendix on sources: WHO, UNICEF, UN, FAO, and USAID's Demographic

& Health Surveys The report notes that India has the highest child wasting rate in the world, at 18.7%, reflecting acute undernutrition. It places India way below a neighbour like Bangladesh, which has a score of 19, a rank of 81. But the minister was drawn to another comparison: Pakistan, she noted, was reported ahead of India (rank 102, score 26.6) in the GHI 2023 report, as if that by itself proves that the report is not to be believed.

This is not the first year the government has officially come out to disregard the report and challenge its findings and question its sources. A similar dismissal came on last year's GHI data as well. In a statement issued earlier this month, the Ministry of Women and Child Development said child wasting

as tracked by its 'Poshan Tracker' app "has been consistently below 7.2%, monthon-month, as compared to the value of 18.7% used for child wasting in the GHI 2023." Yet, there are many reports that point out that the app isn't necessarily delivering as planned with reports of phones that would not work or have yet to arrive, issues related to training and a host of hurdles that are only to be expected when a mega change project is implemented. More significantly, data collected via the app isn't freely available in public domain. Moreover, India's extensive NFHS-5 reported that 36% of children under age five are stunted, only marginally changed from 38% seen in NFHS-4, signifying chronic undernutrition. Similarly, 19% of children under age five years are wasted, only slightly down from 21% seen in NHFS-4 – a sign of acute undernutrition. And 32% of children are underweight, down from 36% during NHFS-4.

A low-tech solution to track and record work and collect nutrition-related data on a real time basis and link payments to the Anganwadi workers isn't particularly revolutionary; its implementation and successful adoption by millions across the country is where the real worth of the work lies. This is hard and challenging work that requires nurturing, support, humility and the willingness to accept failure where it is seen.

Gung-ho statements of the kind that tend to appear from official accounts is precisely the way such a project cannot succeed or surmount the hurdles of being accepted enough to be embraced internally for data collection and externally as a credible source for data.

Consider that Parliamentary Standing Committee on Education, Women, Children, Youth and Sports in its report in March 2021 noted "gross underutilisation of funds under important schemes like Poshan Abhiyaan, Pradhan Mantri Matru Vandana Yojana, Beti Bachao Beti Padhao ... the benefits often do not reach the intended beneficiaries, and therefore, the ministry should utilise the funds allocated under various heads to the fullest extent and strive to achieve results at the grass-root level." It noted that the honorarium paid to Anganwadi works (about ₹3,500 per month plus incentives of ₹500 per month) should be enhanced

These and other issues it reported form a host of constructive suggestions that are an indicator of the challenge before the nation and the ministry in particular. This is best solved by working with teams to look for problems, to focus on the difficult, to allow the frustration to vent and to use the free airing of complaints and the free flow of data to get to the right picture and the do the work to change the ground reality.

Such an approach goes hand in-hand with opening a dialogue with the global development agencies and report writers, GHI included, to show how and why every effort is being made to improve the 'poshan tracker' data, and not use it as a weapon to say India is right and the world is wrong. Hunger is not a subject for scoring points; it cannot go away miraculously with the launch of an app or even the pouring of money. Change is a slow process after all. GHI numbers should be a trigger for faster change. They ought to stir the moral conscience of all citizens and lead us to ask questions on our idea of development, and how and why our children go to sleep without enough food while we celebrate high GDP growth.

Consider that one of the greatest achievements in health has been the eradication of smallpox. Dr. Edward Jenner discovered the vaccine in 1796 but smallpox was eradicated globally only as late as 1980. Why this long gap? Technology or medical prowess was only one end of the solution; its implementation in a complex environment, in the midst of the cold war and amid resistance to the very idea of vaccination required a leader like Dr. Donald A. Henderson, noted epidemiologist and educator who headed a ten-year long international drive against small pox. It required hard work, diplomacy, working with difficult partners and a willingness to change based on real data from the ground. It required listening, patience and diplomacy to walk a path that eventually eradicated a dangerous disease and created history. That was the success of modern medicine but no less the success of an attitude and an approach that reached out across difficult frontiers to learn and understand -- lessons that remain relevant for the India of today.

Don't get carried away with self-checkout

TECHNOLOGY HAS PROMOTED OUR OBSESSION WITH SELF-CHECKOUT

veryone, by now, is familiar self too long, you'd hear a yell ✓ with self-checkout. Self-✓ checkout is what happens when you go to a large store that carries various items, including clothing, furniture and mirrors, and you check yourself out in one of those mirrors

It seems to me that there's too much self-checkout going on. I blame technology for this. Technology has promoted our obsession with self-checkout.

About a century ago, people relied only on mirrors for selfcheckout. The glass mirrors we use today were invented in 1835. Before that, it was far less common for humans to fall in love with themselves. Sure, primitive mirrors existed for centuries, but people did not spend much time checking themselves out in puddles. Nor did they get carried away staring into silver

When the glass mirror was first invented, you had to go to a special exhibition and wait in a long line to look at yourself in this magical object. If you got carried away and stared at yourfrom behind: "Hey, give us a turn too. Don't use up all the magic on yourself.

Technology allowed glass mirrors to be mass-produced, and eventually they ended up in every household. This was a gamechanger for many people. They could now stare at themselves for as long as they wanted. Nobody would be checking them out while they were checking themselves out

Glass mirrors eventually made their way to every part of the world, sometimes in the possession of explorers who shocked people with this magical power of reflection. Some had never seen themselves before and found it terrifying. Who was this scary stranger who kept mimicking their gestures?

The invention of the modern $\,$ mirror was soon followed by the invention of photography. Wealthy people would go to studios and get their images captured and printed for eternity. Of course, before doing this, they would spend hours making themselves up, like a bride before a wedding. Studio photography was extremely popular in the 20th century, largely because the pictures turned out well. Professional photographers could not only take photos with superior equipment in perfect lighting, they could make pimples magically disappear. Touching up photos to erase blemishes was perfectly acceptable, as long as the photos were used for nonjournalistic purposes such as enticing a potential marriage partner. "But he looked so handsome in his photo" was a common thought, but rarely expressed.

Eventually cameras became household items and people could take as many pictures of themselves as they wanted. But it wasn't until the smartphone came along that self-checkout reached its peak. People could now take selfies, thousands of them, and share the very best on social media. They could take pictures of themselves in various settings. "This is me watching Manchester United; this is me visiting the Taj Mahal; this is me falling off a cliff.'

Considering the obsession with self-checkout, it didn't surprise me to see an article in 'Atlantic' magazine entitled "Selfcheckout is a failed experiment.

But when I read the article, it became apparent that the writer was referring to another form of self-checkout, in which stores get customers to serve as employees without paying them and without reducing prices.

Many stores around the world have introduced self-checkout. Customers initially get excited about it, especially when they see a large sign that says "Self-Checkout." But they soon realise that they're expected to do some work

Thankfully, some stores have installed cameras and a small screen at every self-checkout register, hoping to deter theft. This allows customers to look at themselves on the screen while they're scanning items.

Yes, self-checkout gives you an opportunity for more selfcheckout.

Appointments to the Commission have almost always been subsequent to intervention of courts. ICMR finds Nipah virus in bats in Kerala's Wayanad

A month after the Nipah scare abated in Kerala's Kozhikode, ICMR has found presence of Nipah virus among bat samples collected from Wayanad

Thiruvananthapuram, Oct 25: Citing an ICMR report, the Kerala government Wednesday said that there was a possibility of Nipah virus presence in bats in Wayanad district of the state.

State Health Minister Veena George said that the Indian Council of Medical Research gave this information based on its studies of the bat samples collected by it.

While interacting with media, George pointed out that the bat samples collected from Sulthan Bathery and Manathavady areas in Wayanad district have tested positive for the virus

The minister said that it does not mean there were fresh cases of the virus in that district and was only intended to caution and alert the state's health system and the general public.

She said that not only in Wayanad, there was a possibility of the virus' presence in bats in other districts also.

George was speaking to reporters about the current status of the Nipah outbreak in the state which had infected six people in Kozhikode district last month, of whom two had died.

The minister said that all those people who were on the contact list of those infected had completed their isolation and quarantine periods.

She also said that it was a matter of pride that the state was able to restrict Nipah's mortality rate, which is around 70-90 per

The minister also referred to



the various measures, like issuance of Kozhikode-specific standard operating protocols (SOPs), taken by the government to combat the virus.

Additionally, a Kerala One Health Centre for Nipah Research has also been created, she said.

Presently, there will be a consolidation of the field activities of all departments with regard to public health and will be a part of the Kozhikode Medical College, the minister said.

However, moving forward, the intention is to develop it as an independent research institute with its own infrastructure, she said.

Of the two deaths due to Nipah, the first person who died August 30 was found to be the index case, or patient zero, from whom others caught the infection. The outbreak of the virus this year was the fourth in the state since 2018.

Meanwhile, the monoclonal antibodies which are the only treatment against Nipah infection will be developed indigenously to combat the deadly virus. George said Wednesday. George revealed that a decision

treatment

developed

had been taken by two national and a Kerala government institute to develop monoclonal antibodies.

The Kerala government's Institute of Advanced Virology. the Rajiv Gandhi Centre for Biotechnology (RGCB) and the National Institute of Virology in Pune would be involved in the effort, she said.

The minister said it was being considered to develop the antibodies using the cells of patients who recovered from the virus. The minister said the monoclonal antibodies were presently being imported from Australia where they are made according to the Nipah variant present

"We need to manufacture it indigenously for the variant seen here," she said.

The virus strain seen in Kerala was the Bangladesh variant, which has a high mortality rate of around 70-90 per cent.

Several states want land in Ayodhya

Lucknow Oct 25: Several state governments have approached the Uttar Pradesh government for land in Ayodhya as the first phase of Ram temple construction nears completion and the new Ayodhya township project gathers momentum.

The Uttar Pradesh Housing Board has already allotted 6,000 square metres land to Gujarat for its state guest house in the new

Ayodhya township project. The township project will be executed by the Housing Board that will come up on 1,407-acre

land on Lucknow-Ayodhya NH-

27. Later, the project will be ex-

panded up to 1,800-acre. The states want the land in Ayodhya to open their guest houses.

According to the Ayodhya administration, Nepal, Sri Lanka and South Korea have also asked for five-acre land in Ayodhya which will be allotted in the new Ayodhya township project.

The new township will come up in two phases. In the first phase, 539 acre land will be required. The first phase of the project will be rolled out after Deepotsav celebration in Ayodhya November 11.

As per the Ayodhya administration, land for the project has been procured in several villages, including Manjha, Manjha Tirua, Manjha Barhata and Shahnawazpur. Neeraj Shukla, additional

housing commissioner, Housing Board, said, "The Housing Board has received applications from Madhya Pradesh, Maharashtra, Assam, Sikkim, Uttarakhand and Arunachal Pradesh for allotment of land. We have sent a reply asking them to visit the site in Ayodhya."

'Land will only be allotted to state governments after their representatives visit the site and give their consent." Shukla added.

According to Shukla, the state government will also construct its guest house in Ayodhya.

Now, a demand to rename Kanpur Dehat

"Around 100 mutts and ashrams have also applied for land in Ayodhya," he said.

"But due to paucity of land in Ayodhya, it will not be possible for the Housing Board to allot land to so many mutts. Therefore, we will adopt lottery system to allot land to mutts," he added.

After Ram temple, the new township project will be the next mega project to come up in Ayodhya. The state government has conceptualised the project to decongest the temple town as footfall of devotees in Ayodhya will rise manifold after Ram temple opens for devotees in January next.

Women pradhans in UP to get trained under Mission Shakti 4





New Delhi, Oct 25: Leaders of several opposition parties Wednesday opposed an NCERT panel's recommendation to replace "India" with "Bharat" in school textbooks, and alleged that the ruling BJP wanted to change history and was taking such "desperate steps" fearing its defeat at the hands of the opposition bloc INDIA.

Congress general secretary K C Venugopal said the word "India" evoked as much pride as "Bharat" but the ruling dispensation wants "to indoctrinate an entire generation into hating a word we grew up feeling a lot of pride towards."

A high-level committee constituted by the National Council of Educational Research and Training (NCERT) to revise social sciences curriculum has recommended that "India" should be replaced with "Bharat" in textbooks for all classes.

According to committee chairperson C I Isaac, the panel has also suggested introducing "classical history", instead of "ancient history", in the curriculum and including the Indian Knowledge System (IKS) in the syllabus for all subjects.

Reacting sharply to the recommendations, Congress leader Venugopal said, "Be it Team India on the field or the Indian Space Research Organisation the word India evokes pride just as much as Bharat. Their fear of a resounding defeat at the hands of INDIA is making them take such desperate steps." RJD MP Manoj Kumar Jha said it has been a hysterical reaction of the BJP regime ever since the INDIA bloc was formed.

AAP spokesperson Priyanka Kakkar said, "It shows the fear PM Modi has of the INDIA alliance. His alliance partners are leaving him. Instead of changing name, efforts should be made to focus on issues of joblessness, inflation, and corruption."

DMK spokesperson Saravanan Annadurai said the BJP is restoring to name-change politics in order "to divert the attention of people from its misdeeds and maladministration." Congress leader and Karnataka Deputy Chief Minister D K Shivakumar said the NCERT panel recommendation was "wrong" and alleged an NDA hand behind the move.

Shivakumar wondered why there is the Reserve Bank of India, Indian Administrative Services and Indian Foreign Services, hinting that the word "Bharat" was not used. "Why the Republic of India is written on Indian passport," he asked.

Alleging that the NDA government forced the NCERT to take the "decision", he said the move was "completely wrong" and urged the Centre not to accept the recommendation. Congress leader Salman Khurshid said, "Our perspective is far more profound when it comes to Bharat, whether it's India, Bharat, or Hindustan, they (BJP) won't understand. They only focus on their electoral gains in everything they do.

Congress leader Jignesh Mevani the move showed disrespect towards the Constitution in which "India, that is, Bharat" is written. "So, both words can be used interchangeably," he said.

New Delhi, Oct 25: The government Wednesday announced a Rs 22,303 crore subsidy on phosphatic and potassic (P&K) fertilisers for the current rabi season and said the farmers

Briefing reporters, I&B Minister Anurag Thakur said the Modi government is committed to ensuring adequate availability of fertilisers to farmers at affordable prices, Thakur said. In May, the Union Cabinet approved a subsidy of Rs 38,000 crore on P&K fertilisers for the Kharif season of 2023-24. The minister said that farmers will continue to get DAP (di-ammonium phosphate) at the old rate of Rs 1,350 per bag (50 kg each).

Similarly, the NPK will be available at the old rate of Rs 1,470 per bag and SSP (single super phosphate) at around Rs 500 per bag. "The MoP (Muriate of Potash) rates will come down to Rs 1,655 per bag from Rs 1,700 per bag," Thakur said.

Law Commission meets Kovind panel on simultaneous polls

New Delhi, Oct 25: The panel headed by former president Ram Nath Kovind to examine the issue of holding simultaneous elections in the country has been renamed as the High Level Committee on One Nation, One Election, according to an official statement Wednesday.

While the law ministry had asked the law panel to study the feasibility on holding Lok Sabha and assembly polls together, the Kovind panel on 'one nation, one election' has been mandated to examine the possibility of holding Lok Sabha, assembly and panchayat and municipality polls together. Sources said the report of the law panel on simultaneous polls is not yet finalised.

They said "some more things are required to be done", indicating that the law panel will be invited again by the high-level

committee. According to an official statement, the high-level committee "noted" the resignation of Adhir Ranjan Choudhury, leader of the single largest party in the Lok Sabha, from the membership of the committee. The day the panel was constituted, Chowdhury had declined to be a part of it. "Thave no hesitation whatsoever in declining to serve on the committee whose terms of reference have been prepared in a manner to guarantee its conclusions. It is, I am afraid, a total eyewash," he had said in his letter to Home Minister Amit Shah, a member of the panel.

Israel urges India to proscribe Hamas as terror organisation

New Delhi, Oct 25: Time has come for India to proscribe Hamas as a terrorist organisation like many other nations have done, Israeli ambassador Naor Gilon said Wednesday.

The Israeli envoy, at an interaction with journalists, also thanked India for its "100 per cent" support to Israel in its anti-terror operations against Hamas. Gilon said Israel conveved to relevant Indian authorities to declare Hamas as a terrorist organisation following its brutal attack on Israel October 7. At the same time, he indicated that the matter was taken up earlier as well.

"Prime Minister Narendra Modi was among first world leaders to condemn the terror attack... India is a very important moral voice in the world and the important countries for us are with us," Gilon said.

"It is time for India to declare Hamas as terrorist organisation in India," he said, adding many countries have al-

The Gujarat High Court October 19 sentenced four police officers and men to 14 days simple imprisonment for the public flogging of five Muslim men for their alleged involvement in stone pelting during Garba last year.

A benchmark judgment delivered by Justice AS Supehia and Justice Gita Gopi has been scathing in upholding the law and yet softly mindful in giving ample time to appeal. Published excerpts of the judgment sound a warning bell for the cops who play to the gallery with an eye to pleasing those in power.

The verdict took note of the fact that the accused cops "have defiled the human rights and dignity of the

conferred with the privilege to do so".

The Bench refused to accept the unconditional apology tendered by the accused cops terming it a 'barbarous act' wherein videography was done and widely circulated on social media. Even after the declaration of the guidelines by the

apex court, it has on numerous occasions emphasised on following them but it appears to have fallen on deaf ears", the court noted." The insensate act where they engaged themselves in committing an inhumane act with a horrific purpose to humiliate in full public view is violative of the apex court guidelines which seek to protect human dignity, values and rights guaranteed by the Constitution.

Earlier, counsel for the accused cops had informed the court that the accused had approached victims in the presence of their advocate and offered monetary compensation which was



rejected by the victims.

Five Muslim men were beaten by policemen in Undhela village of Matar Taluka in Kheda district of Gujarat in the presence of villagers and victim's family members in public, for their alleged role in pelting stones on Navratri Garba and disturbing communal harmony in the village. Police had arrested at least 40 persons on suspecting their role in the violence.

The victim's family members had moved to the High Court pleading for action against the policemen for contempt of court. As per the Supreme

Court order in the case of D K Basu Vs State of West Bengal, the court has laid down guidelines against custodial torture. During the case hearing, the Gujarat Government submitted before the court that five policemen including a police inspector were prima facie found guilty in the case of flogging.

Based on electronic pieces of evidence, Nadiad Chief Judicial Magistrate in his report to the High Court had submitted out of the 14 police personnel, four were identified as beating Muslim men.

This is not the sole case of cops taking the law into their hands, seeking to dispense summary justice, there are at least two more- both involving people from the minority community-awaiting judicial scrutiny.

Interestingly The Gujarat State Law Commission in its latest report released in July 2023 has stated "Custodial deaths in Gujarat is a matter of great

concern". The report is titled "Suggestions to have proper control on the law enforcing agency for the prevention of unwanted instances of custodial deaths". Citing the Commission report, Gujarat Congress media joint convenor Dr Manish Doshi said that Gujarat tops in custodial deaths with 80 people having died in police custody over the last four years.

The Supreme Court by an order of July 2015 mandated all state to install CCTV cameras in all police stations In Gujarat 130 police stations still remain without CCTV coverage while in many others though installed remain non-functional.



United Nations, Oct 25: Israel vowed again to destroy Hamas, rejecting calls from the UN chief. the Palestinians and many countries at a high-level UN meeting Tuesday for a cease-fire and declaring that the war in Gaza is not only its war but "the war of the free world.

Israel's Foreign Minister Eli Cohen also dismissed calls for 'proportionality" in the country's response to Hamas' surprise attacks on Israel October 7 that killed 1,400 people and has since led to more than 5,700 Palestinian deaths in Gaza according to its Health Ministry.

He told the UN Security Council that the proportionate response to the October 7 massacre is "a total destruction to the last one of the Hamas," calling the extremist group "the new Nazis." He stressed: "It is not only Israel's right to destroy Hamas. It's our duty.'

Cohen called the October 7 attacks "a wake-up call for the entire free world" against extremism, and he urged "the civilized world to stand united behind Israel to defeat Hamas.

And he warned that today it is Israel, and tomorrow Hamas and the attackers "will be at everyone's doorstep," starting with the West.

Russia withdraws from nuclear test ban treaty

■ Russia says it will not resume testing unless Washington does, but a test by either Russia or US could trigger a new arms race - and more testing by other countries - at a moment of acute tension, with wars raging in Ukraine and the Middle East

Moscow, Oct 25: Russia's parliament completed the passage of a law Wednesday withdrawing ratification of the global treaty banning nuclear weapons tests, evidence of the deep chill in relations with the United States as Moscow pursues its war in Ukraine.

Deputy Foreign Minister Sergei Ryabkov said Russia was not prepared to resume discussing nuclear issues with the US unless Washington dropped its "hostile" policy.

The bill to deratify the Comprehensive Nuclear Test Ban Treaty (CTBT) was approved by 156 votes to zero in the upper house after the lower house also passed it unanimously. It now goes to President Vladimir Putin for signing.

Putin had requested the change to "mirror" the position of the United States, which signed the CTBT in 1996 but never ratified it.

Though it has never formally come into force, the CTBT has made nuclear testing a taboo - no country except North Korea has conducted a test involving a nuclear explosion this century.

CNN published satellite images last month showing that Russia, the United States and China have all expanded their nuclear test sites in recent years.

The US Energy Department said last week it had conducted a chemical explosion at its test site in Nevada "to improve the United States' ability to detect low-yield nuclear explosions around the world"

Speaking to Russian lawmakers before Wednesdav's vote, deputy foreign minister Sergei Ryabkov said the Nevada blast was "undoubtedly a political signal". Russia says its monitoring stations will keep supplying data to the global network that detects nuclear blasts.

Tech Mahindra's net profit for the quarter fell 61.6%, its worst performance since March 2007. Consolidated revenue from operations fell 2.02% year-on-year, while expenses rose nearly 7%, led by a 30% jump in "other expenses." India's information technology (IT) industry has been grappling with delays in dealmaking, as businesses in the US and Europe, from where it draws the bulk of revenue, cut back investments amid fears of a recession.

Stating that financing of a lot more new infrastructure projects is under discussion for next year, AIIB South Asia Director General Rajat Misra said, "Lending to India will continue to grow as the bank balance sheet will also grow.

Misra was speaking to PTI on the sidelines of Singapore International Energy Week here. Formed in December 2015, the AIIB has to date funded sovereign



Indian infrastructure projects to the tune of \$10 billion.

This works out to more than 20 per cent of AIIB's total infrastructure project funding. For this year, the bank has lent more than \$1.3 billion to Indian projects, including \$438 million for the Chennai Metro Rail Phase 2 Project (Balance Corridor 5) and

\$250 million for the Second Dam Rehabilitation and Improvement Project.

He also pointed out that AIIB has "a very thorough due diligence and each project is evaluated on its viability."

After India, the bank has rated China, Turkey, Indonesia and Bangladesh as top borrowers.

New Delhi, Oct 25: Smuggled gold seizures have increased nearly 43 per cent to 2,000 kilogramme during April-September, with most of the vellow metal entering India through the land borders of Myanmar, Nepal and Bangladesh.

Central Board of Indirect Taxes and Customs (CBIC) Chairman Sanjay Kumar Agarwal said in April-September period of last year, 1,400 kg of gold was seized, while during the full fiscal 2022-23, around 3,800 kg was seized.

"There is no change in duty structure of gold vis-a-vis last year. But smuggling may be de-



There is no change in duty structure of gold vis-a-vis last year. But smuggling may be dependent on the prevailing prices of gold in international and domestic SANJAY KUMAR AGARWAL | CHAIRMAN CBIC

pendent on the prevailing prices of gold in international and domestic markets." Agarwal told reporters here.

Gold smuggling seizures this year from April till September 2023 is 2,000 kg vis-a-vis 1,400 kg in the same period last year.

'Gold has been smuggled mainly through land border Myanmar, Nepal and Bangladesh," Agarwal said.

The trend of gold smuggling into the country is dependent upon the prices prevailing in domestic market and international market. It cannot be solely linked with the customs duty prevailing on gold, the CBIC chief said.

The department is making concerted efforts to curb gold smuggling whether it is through land borders or through airports or any other routes. Agarwal said.

To deter the smuggling of gold, Customs field formations and the Directorate of Revenue Intelligence (DRI) keep constant vigil and take operational measures, such as passenger profiling, risk-based interdiction and targeting of cargo consignments, non-intrusive inspection, rummaging of aircraft and coordination with other agencies.

As per a DRI report for 2021-22, gold smuggling in India is fuelled by the huge demand for gold, combined with import duty on licit import of gold.

The basic Customs Duty rate on gold is 12.5 per cent. Along with the Agricultural Infrastructural Development Cess (AIDC) of 2.5 per cent and IGST rate of 3 per cent applicable to the imports of gold, the overall tax rate works out to 18.45 per cent.

India is a negligible producer of gold and the huge demand for gold in the country is met through imports. India importsgold dore bar as well as refined gold.

Antil throws off own WR Hardik likely to miss more World Cup ties



Hangzhou, Oct 25: Reigning Paralympics champion Sumit Antil Wednesday clinched a gold medal at the Hangzhou Asian Para Games javelin throw F64 event with a world record (WR) effort of 73.29m on the third day of competitions.

The 25-year-old broke his own previous WR of 70.83m which he had thrown while winning gold at the World Para Athletics Championships in Paris earlier this year. Another Indian, Pushpendra Singh won the bronze with a throw of 62.06m. Antil had won gold in the men's javelin F64 event at the Tokyo Paralympics with a then WR throw of 68.55m.

It was the most productive day for India, picking up a whopping 24 medals, with 17 of them and all the six gold coming from athletics. India's total medals stood at 58 (15 gold, 20 silver and 23 bronze).

Ankur Dhama became the first Indian to win two gold medals in a single edition of the Asian Para Games as he clinched the top spot in men's

The other silver was won by men's doubles compound pair of Rakesh Kumar and Suraj Singh after losing 150-155 to the Chinese duo of Ai Xinliang and He Zihao.

Harvinder Singh and Sahil won a bronze in men's doubles recurve event after beating the Thai pair of Hanreuchai Netsiri and Pornchai Phimthong 6-0. Harvinder had won a bronze medal in the Tokyo Paralympics and a gold in the 2018 Asian Para Games.

New Delhi, Oct 25: Star allrounder Hardik Pandya is likely to sit out of India's next two World Cup matches as he is yet to recover from his ankle injury that rendered him out of action last week.

Pandya had slipped in his follow-through while bowling against Bangladesh in Pune October 19 and missed the clash against New Zealand in Dharamsala October 22 due to the injury. The Bardoa player had reported to National Cricket Academy (NCA) Monday in Bangalore for his injury management.

"Hardik is still under medication. While the swelling on his left ankle has subsided considerably, he will start bowling only towards the weekend. Right now, important is to give him time to recover," an NCA source told PTI.

Since India are in a very strong position to make the semifinals, having won all five matches so far, Pandya could easily be rested for the next two matches that will allow him complete recovery before the knock-outs.

"Pandya has suffered a bad sprain but fortunately not a fracture. The BCCI medical team



wants to take maximum precaution. He is likely to miss next two to three matches. The team wants him fully fit for the knockout stage," added a BCCI source.

Pandya is likely to undergo a fitness test Thursday and BCCI's medical team will ascertain his comeback date depending on how smoothly he is able to bowl full tilt without any apparent discomfort or pressure on his left ankle,

India next play against defending champions England October 29 in Lucknow and take on Sri Lanka in Mumbai November 2. Pandya's absence had created space for Suryakumar Yadav and Mohammed Shami in the playing XI against New Zealand.

Maxwell show sets up record Oz win

New Delhi, Oct 25: Glenn Maxwell waltzed his way to the fastest World Cup century (106, 44b, 9x4, 8x6) after David Warner hit his second successive hundred (104, 93b, 11x4, 3x6) as Australia crushed the Netherlands by 309 runs - the biggest in tournament history – to continue their winning run here Wednesday.

After opener Warner laid the foundation, Maxwell went on a six-hitting spree as Australia displayed their batting might to amass a mammoth 399/8 after opting to bat. Steve Smith (71, 68b, 9x4, 1x6) and Marnus Labuschagne (62, 47b, 7x4, 2x6) also returned to form with resolute fifties but it was Maxwell who stole the show in the end.

Maxwell reached the hundred in 40 balls to surpass South African Aiden Markram's 49ball ton which also came at the same venue during this World Cup against Sri Lanka.

With a mountain to climb, the Netherlands folded for 90 in 21 overs with Vikramjit Singh top-scoring with a run-a-ball 25 at the top.

It was Australia's third win on the trot, consolidating their position in the top four with six points with New Zealand and England in line in their next matches. For the Netherlands, it was their fourth loss, leaving them at the bottom position in the 10-team event.

Earlier, Warner was involved in two big partnerships – 132 with Smith and 84 with Labuschagne – as Australia kept a steady run rate of 6-an-over throughout the innings.

Karttiki Singh Shaktawat and Parinaaz Dhaliwal shot 107 each to end in 17th and 18th positions respectively, while Darshna Rathore was 19th with a score of 106.
