Jaipur, Oct 26: Turning the heat on the ruling Congress in poll-bound Rajasthan, the Enforcement Directorate (ED) Thursday raided the premises of state Congress president Govind Singh Dotasra in Jaipur and Sikar as part of a money laundering probe into the alleged exam paper leak case and summoned Chief Minister Ashok Gehlot's son in a foreign exchange violation case. Besides the premises of Dotasra, a former minister for school education, the agency is also searching the premises of a party candidate from Mahua seat in Dausa. Omprakash Hudla. and some others, official sources said. The Congress slammed the Centre over the ED's action against its leaders in Rajasthan and accused the Prime Minister of taking the help of probe agencies in fighting polls, and said people would give the BJP a befitting reply. Chief Minister Gehlot flayed the ED action, saying terror has been unleashed in the country. He alleged the BJP was targeting him through ED raids as they could not topple his government. Elections for the 200-member Rajasthan Assembly will be held November 25. The results will be declared December 3. Dotasra is the party candi-

All of the former Navy officers had 'unblemished stints' of up to 20 years in the Indian Navy and had held important positions including that of instructors in the force, they said.

"We have initial information that the Court of First Instance of Qatar has today (Thursday) passed a judgement in the case involving eight Indian employees of Al Dahra company," the MEA said. "We are deeply shocked by the verdict of death penalty and are awaiting the detailed judgement. We are in touch with the family members and the legal team, and we are exploring all

India's ambassador to Qatar met the men in prison October 1 after being granted consular access. As part of Al Dahra security company, the Indians were imparting training to Qatari naval personnel for the last few years, the people cited above said.

It is learnt that the former Indian naval personnel were kept in solitary confinement for several months before they were transferred to 'two-person' cells.

5 LeT terrorists killed in Kupwara AGENCIES

A huge cache of arms and ammunition including five AK series rifles and other incriminating materials were recovered from the site of the gunfight in Machhil sector, officials said.

Alarming levels of lead, cadmium in chocolates

Long-term exposure to the metals can result in nervous system problems, immune system suppression and kidney damage, with greater danger to pregnant women and young children, according

to Consumer Reports

New York, Oct 26: Consumer Reports has claimed to have found 'concerning' levels of lead and cadmium in a new array of chocolate products, and renewed its call for Hershey to reduce the amounts of heavy metals its chocolate contains.

It said 16 of the 48 chocolate products from various makers

that its scientists tested recently in seven categories - dark chocolate, milk chocolate, cocoa powder, chocolate chips, and mixes for brownies, chocolate cake and hot chocolate - contained potentially harmful levels of lead, cadmium or both.

All 48 products contained detectable amounts of the metals, and milk chocolate bars, which have fewer cocoa solids, was the only category that did not contain excess amounts, the report found.

Consumer Reports has said long-term exposure to the metals can result in nervous system problems, immune system suppression and kidney damage, with greater danger to pregnant women and young children.

Among the products found to contain excessive metal content were a dark chocolate bar and hot



chocolate mix from Walmart, cocoa powder from Hershey's and Droste, semi-sweet chocolate chips from Target, and hot chocolate mixes from Trader Joe's, Nestle and Starbucks.

The Consumer Reports testing followed its findings last December that 23 of 28 tested dark chocolate bars contained excessive lead or cadmium, in-

cluding Hershey products sold under its own brand and the Lily's

and Scharffen Berger brands.

The Consumer Reports is again petitioning Hershey to reduce heavy metals in its chocolate. More than 75,000 consumers signed an earlier petition.

Consumer Reports food policy director Brian Ronholm said Hershey, as a 'leading and pop-

ular brand', should commit to eliminating 'dangerous levels' of heavy metals from its chocolate products, making them safer for consumers.

In March, Hershey Chief Financial Officer Steve Voskuil said his company was looking to reduce levels of lead and cadmium, a 'naturally occurring' ingredient that could vary based on which countries its chocolate came from.

"We would love to eradicate it completely," Voskuil said.

Hershey referred a request \rightarrow for comment to the National Confectioners Association.

Christopher Gindlesperger, a spokesman for the trade group, said, "Chocolate and cocoa are safe to eat and can be -(enjoyed as treats as they have been for centuries.'

Bhubaneswar, Oct 26: In a significant development, the National Green Tribunal (NGT) has finally given its go-ahead for the water supply project of Water Corporation of Odisha (WATCO) atop Sikharchandi Hills in the Capital city here.

The tribunal had earlier put the project in abeyance after Sachin Mohapatra, a resident

Bhubaneswar/New Delhi/ Maharashtra, Oct 26: The price of staple vegetable onion has witnessed a sharp increase across the country, including Odisha, burning a hole in the pocket of consumers already hit hard by the rising food costs.

A kilo of onion was sold at Rs 50 per kilogram in Bhubaneswar, while at markets on the city outskirts the veggie cost Rs 45 per kilo (for smaller varieties).

Just two weeks ago, the price of bulb stood in the range of Rs 30 to Rs 35 per kg. However, the recent increase has created concerns for households already struggling with the rising cost of living.

"Just when we were relieved after the drop in the prices of



tomato, the hike in the cost of onions came as a bolt from the blue," said Kartik Panda, a resident of Old Town. Kartik said he had to shell out Rs 10-15 more than what he spent on buying a kilo of onion from the weekly haat, Thursday.

Traders attributed the sud-

den surge in onion prices to a reduction in production. Citizens have expressed their concerns over the escalating prices of onions, a fundamental cooking ingredient, as it is likely to impact the household budget.

At the national level, Maharashtra, the primary onionproducing state in the country, is witnessing a substantial increase in onion prices. At Pimpalgaon market, the price of onions per quintal has surged from Rs 2,500 to Rs 5,000 over the past month.

In Delhi, the staple vegetable which was selling at Rs 35 to 40 per kg last week is touching Rs 50-80 across NCR at present.

The sharp rise of nearly 50 per cent is attributed by customers across Delhi and Noida to the end of Navratri week. <code>"I purchased onions at Rs 40</code>

Madhu Sharma, a resident of Yojana Vihar in east Delhi said onions are selling at Rs 60 per kg in her area Deepak Dogra a resident of Gagan Vihar said that he bought onions from a store at Rs 56 per

per kg last week. But, today l

bought them for Rs 80 per kg,'

said Shekhar, a resident of Noida.

kg. However, local vendors are selling onions for nearly at Rs 80 per kg in his locality.

Rajeev, a resident of Ghaziabad, said that he bought onions from the Mother Dairy near his house at Rs 65 per kg. In Safal stores across Delhi, onions were selling at up to Rs 56 per kg depending upon the quality.

The retailers are attributing the rise in price rise in local mandis and increased demand post Navratri.



two studies from Norway, one from Sweden and one from the United States. The studies included about 12,000 people aged 50 or older who wore wearable devices to track how active and sedentary they were during their daily routines.

Participants were followed up for at least two years (the median was 5.2 years) during the study period, which spanned 2003-2020. Analysts took several lifestyle

and health factors into account, such as education, alcohol intake, smoking status, and previous history of heart disease, cancer and diabetes. All this data was linked to national death registries.

A 22 minute threshold

A total of 805 participants



died during follow up. The researchers found people who were sedentary for more than 12 hours a day had the highest risk of death (a 38% higher risk than people who were sedentary for eight hours).

However, this was only ob-

served in those who did less than 22 minutes of moderate to vigorous physical activity daily. So for people who did more than 22 minutes of exercise, there was no longer a significantly heightened risk - that is, the risk became generally similar to

those who were sedentary for eight hours.

Higher daily duration of physical activity was consistently associated with lower risk of death, regardless of total sedentary time. For example, the team reported an additional ten minutes of moderate to vigorous physical activity each day could lower mortality risk by up to 15% for people who were sedentary less than 10.5 hours a day. For those considered highly sedentary (10.5 hours a day or more), an additional ten minutes lowered mortality risk by up to 35%

The study had some limitations The team couldn't assess how

changes in physical activity or sedentary time over several months or years may affect risk of death. And the study included only participants aged 50 and above, making results less applicable to younger age groups.

Further, cultural and lifestyle differences between countries may have influenced how data between studies was measured and analysed.

Ultimately, because this study was observational, it can't draw conclusions on cause and effect with certainty. But the results of this research align with a growing body of evidence exploring the relationship between physical activity, sedentary time, and death.

It's positive news

Routines such as desk jobs can foster a sedentary lifestyle that may be difficult to shift. But mixing short bursts of activity into our day can make a significant difference towards improving our health and longevity.

Whether it's a brisk walk during lunch, taking the stairs, or even a short at-home workout.this study is yet another to suggest that every minute counts.

Increased screen time may signal ADHD risk among kids

hildren with a genetic predisposition to autism spectrum disorder (ASD) were more likely to use screens for longer periods, according to a study.

While long periods of screen time in childhood have been suggested to be a cause of ASD/attention deficit hyperactivity disorder (ADHD), the results of this study suggest that some people may have a genetic disposition to use screens because of ASD.

The findings, published in the journal Psychiatry Research, showed that children with a higher genetic susceptibility to ASD used devices with screens longer (3 hours a day or 4+ hours a day) from early childhood. They also found that kids with a high genetic risk of attention deficit hyperactivity disorder (ADHD) gradually increased their screen time as they grew older, even if their initial screen use time was short.

"Overall, those with a genetic risk of ASD were 1.5 times more likely to be in the group with about three hours of screen time per day, and 2.1 times more likely to be in the group with more than four hours of screen time." said lead researcher Nagahide Takahashi of Nagoya University in Japan.

"Screen time may be an early sign of ASD, rather than a cause,



as children with ASD are often more attracted to objects than people. Physicians should know that it is not fair to conclude that prolonged screen time is a risk factor for the development of ASD," Takahashi said.

Researchers examined 6.5 million polymorphisms -- referring to the presence of two or more variant forms of a specific DNA sequence that can occur among different individuals or populations -- in 437 children's DNA

to determine genetic susceptibility to ASD and ADHD.

Next, they calculated a genetic risk index that considers the number and size of the effects of changes in genes associated with ASD/ADHD. This is known as a "polygenic risk score".

The researchers then compared it with the amount of time spent using screens devices among a sample of children aged 18, 32, and 40 months.

Takahashi also warned against overexposing children with ADHD to device screens.

"Our results suggest that children at risk of ADHD are at risk of having too much screen time, especially since gaming addiction is common. As screen time tends to be longer for children who are particularly susceptible to ADHD, parents and caregivers should be cautious about it and make a commitment before it becomes a problem," he noted. These results may also help

parents devise better child-rearing strategies.

"Parents of children with neurodevelopmental disorders may feel guilty or be criticised by others for allowing their children screen time," Takahashi said.

"However, we would recommend offering help to caregivers including offering alternative behavioural management strategies.

Athagarh, Oct 26: The decomposed carcass of a tusker has been recovered near a farmland close to a cashew forest at Kantapanhra Square near Anshupa lake under Athagarh forest limits in Cuttack district, Thursday.

The carcasses of a wild boar and a cow were also recovered near the farmland. The tusker within 15 years of age is suspected to have died three to four days back. According to reports, the carcass was recovered near the Jenapada Beat area on Anshupa road in Athagarh Forest Division Thursday.

"One wild boar and a cow were also found dead near the elephant carcass. Forest officials started an investigation after locals informed them about the stench emanating from the area," Athagarh DFO Jagnyadutta Pati said.

Forest officials also seized electrical implements for poaching and electric wires from the spot. It is suspected that the three animals might have been electrocuted after coming in contact with live wires laid for poach-

ing wild animals. However, the exact cause of the elephant's death is yet to be ascertained. Forest personnel said that the exact reason behind the animal deaths can be ascertained after the post-mortem report is available to them.

However, the noble gesture by the MLA Dr CS Raazen Ekka has spread cheers in the area as locals including the patients hailed his effort in attending to the patients in the absence of doctors.

Reports said that patients had lined up at the community health centre Thursday morning but were disheartened as doctors were absent. This led to chaos at the hospital. On getting information about the harrowing situation of the patients, Ekka, who holds a medical degree, arrived at the CHC and started attending to patients.

A video has gone viral on social media platforms where Ekka was seen stepping into the doctors' shoes and prescribing medicines to patients. He reportedly took each case one by one and offered services to nearly a hundred patients since 8am in the morning and prescribed medicines for them.

After reports surfaced, patients and locals thronged the hospital to get a glimpse of Ekka attending to the patients. When contacted, Ekka said that he had demanded in the state Assembly to fill up the vacant posts of doctors and appoint specialists in the hospital. However, the state government is yet to fulfil the demands.

Moreover, no step has been taken to meet the shortage of doctors in the hospital by utilising the funds available under **District Mineral Foundation** (DMF)

Notably, Ekka has prior medical experience as he was serving as a doctor in the Indian Army. The hospital is daily visited by people from 20 wards under Rajgangpur Municipality as well as 10 adjoining panchayats. However, it is an irony that the hospital lacks adequate number of doctors.

4 cops injured in attack by gamblers 360 degree kidney care in IGH, Rourkela

Berhampur, Oct 26: At least four police personnel were injured after they were pelted with stones by gamblers and villagers in Ganjam district, police said Thursday.

A seven-member police team was attacked Wednesday night when they went to conduct a raid on a gambling den at a community centre in Choudhury Tikarapara village under the Nuagaon police station limits, a senior officer said.

The police vehicle was also damaged in the attack, he said.



"We have registered a case against the villagers for attacking the police. No one has been arrested so far. An inquiry is on to identify the persons involved in the attack," Berhampur SP Saravana Vivek M said.

Acting on a tip-off, the police team went to the village to bust the gambling den and 15 people were gambling there at that time, the officer said.

Villagers, including several women, and gamblers hurled stones at the police team to evade legal action, he said.

In a separate case, three per-sons were arrested Wednesday for allegedly being involved in attacking the police at Pakalasandha under the Gangapur police station limits during raids on another gambling unit. A sword, over Rs 36,000 in cash

Rourkela, Oct 26: Rourkela has witnessed major development in the treatment of kidney diseases with successful renal biopsy and tunnel dialysis catheter implantation at Ispat General Hospital (IGH) of SAIL, Rourkela Steel Plant (RSP).

The Silent Pandemic

The overuse of antibiotics is now widely recognised as one of the main factors contributing to antimicrobial resistance (AMR) often called the "silent pandemic." But what is less well known is that shortages of antibiotics also play a role in fueling AMR.

Scarce supplies of paediatric amoxicillin, used to treat Strep A, made headlines in the United Kingdom late last year, as a surge of infections left at least 19 children dead. Far from being an outlier, however, such shortfalls are common and pervasive, affecting countries across the world, and their consequences for both individuals' health and AMR's spread can be dire. That is because shortages of first-line antibiotics often lead to overuse of those that are specialised or kept in reserve for emergencies. Not only may these substitutes be less effective, but reliance on them increases the risk of drug resistance developing and infections becoming more difficult to treat in the long run.

Already one of the world's biggest killers, AMR is on the rise. In 2019, it was directly responsible for an estimated 1.27 million deaths - more than HIV/AIDS and malaria combined - and associated with 4.95 million more. So far, the global response to this growing crisis has focused mainly on trying to outpace drug-resistant bacteria through

the development of new antibiotics. But in the short term, there is ample room to reduce the number of AMR deaths, as well as AMR's impact on health more broadly, by addressing some of the causes of shortages and improving access to appropriate treatments

The same market failures that triggered the global AMR crisis are also largely responsible for antibiotic shortages. Compared to other drugs, antibiotics are often more complex and more costly to manufacture. have stricter regulatory requirements, and are less profitable. As a result, many phar maceutical companies have significantly reduced or stopped antibiotic research and development over the last few decades

Not only are very few new antibiotics being developed, but it has also become less attractive to produce those already on the market, partly owing to supply-chain bottlenecks and volatility. All it takes is a disruption in the supply of an ingredient or a quality-control problem, or a supplier increasing prices or halting production entirely, to bring the global supply chain

of these medicines to a standstill. But just as important has been the equally volatile demand for antibiotics caused by sudden outbreaks of bacterial infections and poor management of national supplies, which contributes to stockouts. While shortages are not uncommon in the pharmaceutical industry, they are 42 per cent more likely

for antibiotics than they are for other drugs. Although precise numbers that would reveal the scale of the problem are difficult to obtain, much of this uncertainty could be avoided with better market intelligence. Even though antibiotics are less lucrative than other drugs, pharmaceutical companies can still turn a profit – if they have accurate data. Improved forecasting can thus reduce risks for manufacturers and provide a stronger incentive to scale up production and expand their markets.

There is also plenty of room for improvement in the way that countries - particularly lower-income countries - procure, register, and manage these vital drugs. By expanding the capacity of national regulatory authorities, for example, it would be easier to track and coordinate supplies and create stockpiles to build greater resilience. All of this would also help provide more certainty for drug makers.

SECURE, an initiative led by the World Health Organization and the Global Antibiotic Research and Development Partnership (of which I am executive director), aims to work with countries to improve access to essential antibiotics. That involves exploring how national regulatory authorities could serve as centralised hubs to help monitor, prevent, and respond to shortages. Eventually, SECURE intends to create more buoyant and competitive markets by encouraging countries to pool procurement, ensuring a more reliable supply. Shortages of antibiotics are a serious problem for all countries, but there is plenty that can – and should – be done to prevent them. Given the accelerating spread of AMR and the long lead-in time to develop antibiotics, we can't afford to continue overlooking the problem. Equally important, efforts to address scarce supplies could help ensure that, when new drugs become available, they reach the people who need them





A recent report rings the alarm, revealing that the infrastructure sector is responsible for a whopping 79% of all greenhouse gas emissions and an astonishing 88% of adaptation costs. Even the creation of construction materials for roads, buildings, and bridges accounts for a significant 11% of global energy consumption. Half of these emissions are tied to the way materials are manufactured and put together. This dire situation calls for the construction of robust and sustainable structures that can help address the climate crisis and reduce negative environmental impacts.

The frequent construction and demolition of infrastructure significantly contribute to air and water pollution, waste generation, and resource depletion. The production and transportation of building materials also pump out carbon emissions. Investing in infrastructure that can withstand the test of time is an effective way to combat such destructive processes.

Additionally, creating resilient infrastructure can help governments and private entities make more efficient use of resources. The World Economic Forum advocates for a rethink of infrastructure policies that can enhance the quality of life and stimulate long-term economic growth. Strong and enduring

infrastructure reduces costs linked to maintenance, repairs, and replacements, lightening the financial load on infrastructure owners and operators. Creating infrastructure that can endure and last is about integrating smart strategies. Climate-responsive design involves building structures that work harmoniously with local weather conditions. This can mean implementing passive cooling techniques, maximising the use of natural light and ventilation, and introducing green roofs to combat heat absorption. Furthermore, we should construct infrastructure with adaptability in mind, allowing for easy adjustments to cope with changing climate conditions. For example, building roads with permeable surfaces that absorb water during heavy rainfall and designing buildings with replaceable or upgradable parts can significantly enhance the longevity

of our projects. Using eco-friendly materials like bamboo, recycled steel, and robust cross-laminated timber can withstand climate challenges and reduce the overall carbon footprint of construction. Local sourcing of materials further reduces emissions caused by transportation.

Constructing buildings that can withstand extreme weather conditions like storms, floods, and wildfires is crucial. To achieve this, designers must consider future weather patterns instead of solely relying on past data. Implementing effective design solutions such as rain screen cladding systems that block rain, allow moisture to drain away and provide exterior insulation can make a significant difference. Hurricane-resistant win-

dows, moisture-resistant interior materials that require less frequent replacement, and simplified building systems with manual override functions in case of malfunctions can contribute to creating more resilient buildings. It is also highly recommended to use on-site renewable energy solutions, implement water conservation methods and utilise annually renewed water sources, such as rainwater harvesting, as the main or alternative water source.

The proof of the pudding is in the eating, and there are several real-world examples of infrastructure that have stood the test of time. Take, for instance. the Hoover Dam and Golden Gate Bridge in the United States. Both were constructed almost a century ago and are still operational today. Then there's the awe-inspiring Konark Temple, which has been standing for almost 800 years.

There are various methods to extend the life of infrastructure. Using high-performance concrete, renowned for its durability and resistance to corrosion, is an excellent choice for buildings, bridges, and other structures. Smart technology, such as wireless sensors and real-time monitoring, can detect structural issues early on, facilitating timely repairs and maintenance. Proactive inspection of structures not only reduces carbon footprints but also leads to long-term cost savings. By identifying issues before they escalate, preventive maintenance helps reduce energy costs, carbon emissions, and emergency repairs, thus minimising the waste generated from frequent construction and demolition. Retrofitting and

enhancing existing infrastruc ture can also be a game-changer. Retrofitting can be up to 80% cheaper than building new infrastructure, as per the National Institute of Standards and Technology. Upgrades to existing buildings can protect against earthquakes, corrosion, and other forms of decay. Furthermore adding modern insulation to buildings lowers energy consumption, and applying new technology to transportation systems reduces emissions.

The Hong Kong-Macau-Zhuhai Sea crossing, completed in 2018 for a staggering \$20 billion, stands as a remarkable engineering feat. It ranks as the world's longest sea crossing and was constructed to withstand earthquakes and typhoons, despite challenging conditions from a harsh marine environment that caused corrosion in its structures. The crossing has been designed to last an impressive 120 years, exceeding the usual lifespan of reinforced concrete buildings, which is typically 50 to 75 years.

Closer home, a lot of our modern infrastructure construction in Odisha has been affected by resource constraint on one hand and corrupt practices on the other hand. It has resulted in numerous accidents even during the construction as well as rapid degradation requiring frequent repair and high maintenance cost. Instead of assets, sometime these poor quality infrastructure prove to be a liability for the public exchequer besides being a climate-negative product.

To combat global heating, it is essential to prioritise the construction of long-lasting structures. Owners, policymakers, and businesses should encourage preservation of existing structures and advocate renovation and construction of new buildings that are built to last for centuries.

ne of the best balanced statements on Israel-Hamas war I heard was made by Prince Turki Al-Faisal at the Baker Institute of Public Policy, Huston, He is a Saudi Arabia former Intelligence Chief and its Ambassador to the UK and US. He said, "All militarily occupied people have right to resist their occupation. even militarily. But I do not support the military option for Palestine. I prefer the other option, civil insurrection and disobedience. It brought down the British empire in India and the Soviet empire in Eastern Europe." He qualified his suggestion by explaining that Israel had overwhelmingly military superiority. The world saw it in the past and can see it now as Israel dominates and controls Gaza and now pounds it to the pulp.

Unarguably, we should have added the fall of South African apartheid under the leadership of Nelson Mandela. Without any shred of doubt, Palestinian problem cannot be resolved by military action by either side. But the terrorists on either side would not let it happen. Let me hasten to elaborate when I say terror emanates from either side. In the past. Israelis have resorted to terrorism. The top court has asked the Centre to issue guidelines and directions to not allow humans into sewage at any cost by any contractors and authorities. Manual scavenging is the practice of removing waste, including human excreta, by hand from sewers and septic tanks. This inhuman activity is banned in India but still prevails in many forms. People from the lower strata of society are engaged in these activities. Every year cases of deaths are reported due to manual scavenging. \rightarrow This practice now requires complete eradication to save the dignity of human beings. The sewage work should now be shifted to machines which will help save many lives. The Central government should soon release a new set of rules and guidelines to completely ban this. The governments of states and Union territories should ensure that -(the rules are properly implemented.

Right to marry person of choice indelible: Delhi HC

New Delhi, Oct 26: Granting police protection to a couple facing threats from their family post marriage, the Delhi High Court has said the right to marry a person of one's own choice is indelible and constitutionally protected and not even family members can object to such matrimonial ties.

In a recent order, Justice Tushar Rao Gedela emphasised that the State is under a constitutional obligation to provide protection to its citizens and the high court, being a constitutional court, is expected to further the constitutional rights of the couple. to such relation or to the matrimonial ties between the petitioners," the court asserted while dealing with the couple's petition for police protection.

The petitioners submitted that 'The right of the petitioners to marry a person of their own they got married in April against choice is indelible and protected the wishes of their parents and under the Constitution, which were living together happily cannot be diluted in any manner since then amid threats from whatsoever," the court the family members, particusaid."There is no doubt about larly the mother of the woman. the factum of marriage between the petitioners and the fact that

"In case the petitioners have shifted to a place other than the one shown in the memo of parties, the I.O. Shall intimate the said SHO of the concerned police station having territorial jurisdiction over the residential address of the petitioners, who shall comply with the present order in letter and spirit," the court ordered.

Patna, Oct 26: The Nitish Kumar government in Bihar has drawn flak from allies as well as adversaries over the state Education department's move of striking off the names of more than 20 lakh students from government schools for remaining absent. Those whose names have been struck off also include 2.66 lakh

students who were supposed to appear for class 10 and 12 board exams. The Education department has so far struck off names of 20, 60,340 students (till October 19,

60,340 students (till October 19, 2023) from government schools after it began a drive to improve attendance since September 1, 2023, an official said.

The drive was initiated following instructions issued by KK Pathak, Additional Chief Secretary of the Education department. Pathak in a letter dated September 2, 2023, to all District Magistrates ordered drastic measures like expulsion of students who remain absent for 15 days at a stretch and "tracking" boys and girls studying in private schools, or in far-off places like Kota while remaining enrolled in government schools to avail benefits of the Direct Benefit Transfer (DBT) scheme for textbooks and uniforms.

CPI (ML) Liberation MLA Sandeep Saurav said, "This is simply a dictatorial decision taken by the department. The department has no right to play with the careers of students. The department must know that government schools are still facing an acute shortage of teach-

Patna, Oct 26: Majority of Durga Puja pandals in the state capital violated noise pollution norms during Dussehra festivities, according to data released by Bihar State Pollution Control Board (BPSCB).

The noise level was measured higher than 75 decibels (dB) at 521 locations in Patna, the BSPCB data released late on Wednesday night said. As per Noise Pollution (Regulation and Control) Rules, 2000, the noise level at market places between 6 am and 10 pm should be below 65 dB. However, a relaxation of 10 dB is given to allow the upper limit at 75d B for special occasions.



to measure the level of noise pollution before (October 12) and during the puja (October 21, 22 and 23).

"While the noise level was found between 80 dB to 90 dB at 329 locations, the level was found between 90 dB to 100 dB at 163 locations in Patna. The noise level at 29 locations was measured at more than 100 dB....Which is alarming", BSPCB Chairman Devendra Kumar Shukla told PTI. Shukla said, "The BSPCB had Maidan to Digha Ghat and Digha Ghat to Danapur. Officials monitored the sound level of the loudspeakers at pandals in all the four zones and compared it with the noise level monitored on October 12".

According to BSPCB data Shri Shri Bharat Mata Puja Samiti at New Khazoorbanna locality was found the loudest this Navaratra with sound level measuring up to 119.4 dB, followed by Shri Bal Mandali Durga Puja Samiti, Khazekala (Patna City) at 109.8 dB, Durga Puja Samiti, Students Club at 106.2 dB.

The sound level of Shri Shri Manoranjan Panchayat Bhavan Durga Sthan, Gai Tola was measured at 105.6 dB followed by Shri Shri Durga Puja Samiti, and Puja Samiti, Naya Gaon (Gai Nasriganj (Danapur) at 103.2 dB Ghat) at 103 dB.

Delhi's Dussehra air quality hits 3-year low

New Delhi, Oct 26: Delhi's air quality on Dussehra this year was worse compared to the previous two years, primarily due to the festival falling at the end of October, according to an analysis by the Centre for Research on Energy and Clean Air (CREA).

The analysis revealed that the average PM2.5 concentration in Delhi on Dussehra, which was celebrated Tuesday, stood at 101 micrograms per cubic metre, compared to 89 micrograms per cubic metre in 2022 and 93 micrograms per cubic metre in 2021.

Dussehra was celebrated October 5 in 2022 and October 15 in 2021. Several incidents of firecracker burn-



ing were reported in parts of Delhi Tuesday.

In keeping with the practice of the last three years, Delhi had last month announced a comprehensive ban on the manufacture, storage, sale, and use of firecrackers within the city. A public awareness campaign, 'Patakhe Nahi Diye Jalao,' will soon be reintroduced to discourage firecracker burning.

Unfavourable meteorological conditions and a combination of emissions from firecrackers, paddy straw burning and local sources of pollution contribute to hazardous air quality levels in Delhi-NCR around Diwali every year.

One of the primary factors responsible for Delhi's worse air quality on Dussehra this year is the festival's late timing in October, when meteorological conditions favour pollution build-up, said Sunil Dahiya, an analyst at CREA.

Chikkaballapur (Karnataka), **Oct 26:** Thirteen people were killed when the SUV they were travelling in crashed into a stationary tanker here Thursday morning, police said.

Mourning the deaths, Karnataka Chief Minister Siddaramaiah announced a compensation of ₹2lakh to the next of the kin of the deceased. He also sought details regarding the accident from the officials.

The accident occurred on the outskirts of the district headquarters town of Chikkaballapur at around 7 am, they said. The vehicle was plving from Anantapur district in Andhra Pradesh to Bengaluru and crashed into the stationary tanker on NH 44 killing 13 passengers, including four women.

A preliminary probe has stated that the victims, including the driver of the four wheeler, who also died in the accident, hailed from Anantapur district.

The exact cause of the accident is vet to be ascertained. However, low visibility due to fog is also suspected to be one of the reasons which needs to be verified, a senior police officer said.

The victims who hailed from Gorantla in Anantapur district do not belong to the same family, he said. "Twelve people died on the spot in the accident while one critically injured person who was being treated at a nearby hospital succumbed to injuries. All of them were travelling in the vehicle from Anantapur to Bengaluru and on the way, the vehicle collided with a stationary tanker," D L Nagesh, Superintendent of Police (Chikkaballapur) told PTI. "No government servant who has a wife living shall contract another marriage without first obtaining the permission of the government, notwithstanding that such subsequent marriage is permissible under the personal law for the time being applicable to him," it added.

Likewise, no female government servant shall marry any EPRESENTATION IMAGE

person who has a husband living without first obtaining the permission of the government, said the OM, which came into force with immediate effect. The notification was issued by personnel additional chief secretary Niraj Verma on October 20. but it came to light Thursday.

It said the guidelines have been issued as per the provisions of Rule 26 of The Assam Civil Services (Conduct) Rules 1965. "In the context of the above

provisions, the disciplinary authority may initiate immediate departmental proceeding...For imposition of major penalty, including compulsory retirement," the order stated.

It termed such a practice as a gross misconduct on the part of a government servant having "large bearings" on society. The OM further asked authorities to also take necessary legal steps whenever such cases are detected.

Titled "Interconnected Disaster Risks Report 2023" and published by the United Nations University – Institute for Environment and Human Security (UNU-EHS), the report highlights that the world is approaching six environmental tipping points: accelerating extinctions, groundwater depletion, mountain glacier melting,space debris, unbearable heat



United Nations: Russia and China vetoed a US push for the United Nations Security Council to act on the Israel-Hamas conflict by calling for pauses in fighting to allow humanitarian aid access, the protection of civilians and a stop to arming Hamas and other militants in the Gaza Strip. The United States put forward a draft resolution on Saturday as global outcry grew over a worsening humanitarian crisis and mounting civilian death toll in Gaza. It made the move just days after it vetoed a humanitarian focused draft from Brazil, arguing more time was needed for U.S.-led diplomacy. The initial U.S. text shocked many diplomats with its bluntness in stating Israel has a right to defend itself and demanding Iran stop exporting arms to militant groups. Sharif, accompanied by his younger brother and PML-N president Shehbaz Sharif, appeared before the Islamabad High Court (IHC) for the second time since his return to Pakistan from London on October 21 after a self-exile of about four years. A two-member division bench

comprising IHC Chief Justice Aamer Farooq and Justice Miangul Hassan Aurangzeb announced the verdict, which was reserved earlier today. The bench issued the verdict while hearing the 73-year-old three-time former prime minister's pleas seeking protective bail in the Al-Aziza steel mill and Avenfield corruption cases and for restoring his appeals against his conviction.

"Congratulations to all of Pakistan on the restoration of justice," his party said in a post on X, celebrating the restoration of appeals. A large number of his supporters gathered outside the court building and raised slogans in his favour.

At least 27 killed by Hurricane Otis

Acapulco (Mexico), Oct 26: Mexican authorities gave the first human toll for Hurricane Otis' destruction along the country's Pacific coast Thursday: at least 27 dead and four missing.

Tens of thousands of residents in damaged homes without electricity awaited help more than a day after Otis roared ashore in Acapulco. Federal Security Secretary Rosa Icela Rodríguez said there were 27 confirmed deaths and four disappearances.

Rodríguez's comments at



President Andrés Manuel López Obrador's morning news brief ing were echoed minutes later by Guerrero state Gov. Evelyn Salgado. López Obrador said the destruction was so complete that not a single power line pole remained standing in the impact zone.

Small farmers had their corn crops devastated by Otis' wind and pounding rain, he said. Restoring power to the area was a top priority, he said."We regret the 27 dead," López Obrador said. The president said Wednesday night he had been told the toll was 18, but it rose early Thursday.

"That's what hurts the most," he said of the deaths, noting material losses could be replaced. López Obrador shared details of only one death: He said one soldier was among the dead after a wall of his home collapsed on him.

Beijing, Oct 26: The youngestever crew of Chinese astronauts departed for China's space station Thursday, paving the way for a new generation of "taikonauts" to advance the country's space

ambitions in the future. The spacecraft Shenzhou-17, or "Divine Vessel" and its three passengers lifted off atop a Long March-2F rocket from the Jiuquan Satellite Launch Centre in northwest China. Leading the six-month mission was former air force pilot Tang Hongbo, 48, who was on the first crewed mission to the space station in 2021. His return to the orbiting out-

post Tiangong, or "Celestial Palace" in Chinese, also set a

new record for the shortest interval between two spaceflight missions by taikonauts - coined from the Chinese word for space - suggesting a faster rotation of taikonauts in coming years.

Tang, from China's second batch of astronauts in 2010, had to wait more than a decade before he was picked for his inaugural spaceflight in 2021.

By contrast, his fellow Shenzhou-17 crew members Tang Shengiie. 33. and Jiang Xinlin, 35, both travelling to space for the first time, joined China's third batch of astronauts in September 2020. China has already kickstarted the selection process for the fourth batch of astronauts. seeking candidates with doctoral degrees in disciplines from



biology, physics and chemistry to biomedical engineering and astronomy.

It is also opening the process to applicants from Hong Kong and Macau for the first time. The first and second batches of astronauts were all former air force pilots, like Tang, who joined the People's Liberation Army in 1995 at age 20.

The selection and training process will commence soon for foreign astronauts looking to participate in joint flights to Tiangong, a senior official on China's manned space program said this year.

But as much as China is showcasing its efforts to internationalise its space missions, its space program has distinct Chinese characteristics, at least on Tiangong. In a departure from the NASA-led International Space Station (ISS), where English is the working language, only Chinese is used on Tiangong, making Chinese-language skills a key criteria for foreign participants.

Tiangong has become a symbol of China's growing confi-

dence in its space endeavours after being shut out of the ISS program for decades. China is banned by U.S. law from any collaboration, direct or indirect, with NASA.

Tiangong, completed in late 2022. can house a maximum of three astronauts at an orbital altitude of up to 450 km (280 miles) and will have an operational lifespan of more than 15 vears

The Shenzhou-17 astronauts 🔶 will replace the Shenzhou-16 crew, who arrived at Tiangong at the end of May. The Shenzhou-16 crew, consisting of veteran astronaut Jing Haipeng, Zhu Yangzhu and Gui Haichao, isscheduled to return to earth on October 31.

Hangzhou, Oct 26: Indian para athletes Thursday created history by winning the highest number of medals in the Asian Para Games, taking country's tally to 80, including 18 gold medals.

India have now gone past the earlier best of 72 achieved in the 2018 edition in Indonesia. India's medal tally read 18 gold, 23 silver and 39 bonze, and the count will keep on increasing till the end of the fourth day of competitions.

With two more days left in the Games, the country is on

course to achieving its target of 100 medals in this Hangzhou edition. India had won 72 medals (15 gold, 24 silver, 33 bronze) in the last edition in Jakarta which was the best before this Hangzhou Games.

Sachin Sarjerao Khilari won the first gold of the day in men's F46 shot put with a Games record throw of 16.03m while Rohit Kumar took the bronze with 14.56m, Para shooter Sidhartha Babu then bagged another gold in R6 mixed 50m rifle prone SH1 event as he shot an Asian Para Games score of 247.7.

All three marksmen also made it to the eight-shooter finals, but Dhanush was disqualified and his qualification scores scrapped by the jury at the range followpost-qualification check on the trousers and found Dhanush's trouser not conforming to the ISSF rule," Dubey told PTI from Changwon. "As per the ISSF rules, the

jury should have checked the thickness of the trousers at five designated points, but they didn't do it as per the layout (diagram) of the apparel.

"Only one part stiffness was 2.9. It should be 3.0 as per ISSF rule. They should have checked at five designated points on the trouser and made three attempts. But they did checks only at two points and also made just two attempts," he elaborated.

Dubey also said that a "written protest had been made with the jury of appeal", adding: "The jury also did not show Dhanush the red card after completing the random check. We were all in the finals range preparing our shooters for the title showdown when we got the news,' he added.

After Thailand, India will play Malaysia (Oct 28), China (Oct 30), Japan (Oct 31) and Korea (Nov 2). The semifinals and final are scheduled for November 4 and

5. The tournament will also serve as a platform for India ahead of next year's Olympic qualifiers to be played here.

"In tournaments like these, no team can be taken lightly. We are looking forward to these matches as they will help us test our mettle against some of the most formidable teams in Asia," said skipper Savita.

"Of course, we want to win every match and perform well here. We are also looking to prepare for the Paris 2024 Olympics Qualifiers, which will also be hosted in Ranchi. This tournament serves as a vital preparatory test before the ultimate challenge of securing an Olympic berth," she added.

India's chief coach Schopman agreed with Savita. "Playing these matches ahead of the Olympics Qualifiers is a great opportunity. It allows us to study the other teams and assess how players perform their assigned roles. Our recent performances in the Asian Games were promising, and I am excited and eager to see our team in action," the Dutch said.

India will also be aiming to secure their second women's ২ ACT title after seven years. India had won the title once in 2016 and finished runners-up in the 2013 and 2018 editions, besides finishing third in 2010. The women's ACT is being hosted in India for the first time.
