### Entry of polluting trucks, CVs banned in Delhi

### AGENCIES

New Delhi, Nov 5: The Centre Sunday ordered a ban on construction work related to linear public projects in Delhi-NCR and the entry of polluting trucks and commercial vehicles (CVs) into the capital as an air quality crisis gripped the region.

These measures constitute the final stage, Stage IV, of the Centre's air pollution control plan, which is activated at least three days before the Air Quality Index surpasses the 450 mark in the capital.

However, proactive implementation could not happen this time.

The CAQM, a statutory body responsible for formulating strategies to combat pollution in the region, asked Delhi and NCR states to implement all emergency measures, which also include work-from-home directives for 50 per cent of staff in government and private offices. Under the final stage (Stage IV) of the Graded Response Action Plan, only CNG, electric, and BS VI-compliant vehicles from other states are allowed to enter Delhi, with exemptions granted to those involved in essential services.

Though Odisha is among the top 10 states with maximum number of cattle population in the country, yet it was at 18th spot as per the volume of milk production in 2021-22. The per capita availability of milk in the state is 144 gram per day against the national average of 444 gram. The dismal situation of the dairy sector in the state has been brought to the fore in an approach

note published by the National Bank for Agriculture and Rural Development (NABARD) recently. "Even the per-capita milk availability in the state is quite low compared to the national average (444 gm/day) as well as the ICMR recommendation of 300 gm/day from the basic nutritional requirement view point," NABARD

The apex development bank of India points out various issues plaguing the growth of dairy sector in the state. The major constraints narrated in the note include low production capacity of existing cattle stock, shortage of fodder, lack of veterinary services, absence of timely Artificial Insemination service delivery, large number of dormant/less functional milk cooperative societies. The report also exposes the lack of government support to the Odisha State Cooperative Milk Producers Federation (OMFED).

OMFED looks after the entire chain of milk procurement, chilling, processing, value addition Ra R

and marketing through the threetier cooperative structure of federation at state level, milk unions at district level and milk producers' cooperative societies at grassroots level.

The report throws light on the prevailing mismanagement at various levels in the organisation such as untimely payment of farmer dues, non-functional dairy cooperative societies (DCS) organised by milk unions/OMFED on regular intervals.

The report asserts, "Due to irregularity in payment of milk price to the farmers by OMFED through some milk unions, the milk pouring by the farmers in the DCS is getting reduced gradually and also not enabling the

chain. It also points out lower productivity of indigenous breeds which numbers 83.23 lakh of the 99.03 lakh cattle population in the state, as per the 20th Livestock Census. "One among the main reasons for the low productivity of our indigenous animal is the scarcity of feeds and fodder. The present shortfall in green and dry fodder was 48.4% and 23.5% of the demand respectively," NABARD points out.

NABARD also suggests that the state government should protect and preserve indigenous breeds of the state that are more resistant to diseases and adverse climatic conditions.

NABARD also recommends the state government to ensure quality semen production by improving the existing bull mother station, breeding farms through PPP mode.

## Beehives on Indo-Bangla fence to check border crimes

THE FIRST-OF-ITS KIND INITIATIVE HAS BEEN LAUNCHED BY THE BSF'S 32ND BATTALION WITH AN AIM OF ENSURING BORDER SECURITY AND HELPING THE LOCAL POPULACE THROUGH

New Delhi/Kolkata, Nov 5: Beehives, which have been used to ward off elephants, are now being installed on the India-Bangladesh border fence in West Bengal to stop instances of cutting the hedge for cattle smuggling and other crimes, besides generating livelihood for the locals.

The first-of-its kind initiative was launched recently by the Border Security Force's 32nd battalion in the border areas of Nadia district with an aim of ensuring border security and helping the local populace through apiculture, a senior officer said. India and Bangladesh share a 4,096-km frontier, with West Bengal accounting for about 2,217 km. The Ayush ministry has been

roped in by the BSF for the project. The ministry has provided the border-guarding force with the beehives and required expertise to fix those on the alloymade 'smart fence'.

Sujeet Kumar, Commandant of the 32nd BSF battalion who conceptualised the idea, told PTI that the force has undertaken the initiative under the Centre's



'Vibrant Village Programme' (VVP) and gone a step further by requesting the Ayush ministry to provide it with medicinal plants that bear flowers and can be planted around these bee boxes so that the bees can pollinate in abundance.

"The idea of tying beehives to the India-Bangladesh border fence was launched November 2. The BSF will ensure that these bee boxes are accessible to the locals engaged in apiculture and there has been a very warm response from the villagers to this initiative," he said.

Officials said the border areas under the South Bengal frontier of the BSF in Nadia district are prone to cross-border crimes like cattle, gold, silver and narcotics smuggling, and there have been instances in the past when miscreants and smugglers have either cut or attempted to cut the fence for their illegal activities.

The beehives on the fence will be a deterrent for the smugglers trying to cut the fence as any such attempt will disturb the bees and a swarm attack of the bees can seriously injure them, a BSF official explained.

While the exact numbers cannot be disclosed, the bee boxes are being put on the fence using a wooden support frame at regular intervals and in smugglingprone vulnerable areas, the official said, requesting anonymity. He said the Ayush ministry has

provided the BSF with saplings of medicinal plants like tulsi, ekangi, satmuli, ashwagandha, aloe vera and the force personnel, along with the locals, are planting those in the border areas. Mustard too is being planted and a public camp was recently held in Kadipur village of Nadia where the locals were informed that the honey that they extract from these beehives will be sold through the established setup and shops of the BSF Wives' Welfare Association. The profits made from the sale of the honey will go to the locals, the official said.

Ayush ministry officials have also told the BSF that the locals have informed them about the mango trees in the area not bearing good-quality fruits, but due to beekeeping in the border area, these plants could start producing good-quality fruits, which will help increase the income of the villagers.

Honeybees hover over flowers to collect food and as pollinators, play a vital role in the production of many crops that are needed to feed the world's population.

### Men more hesitant to share negative info about themselves

en are less eager and likely to share negative information about themselves than women, finds a study that showed little difference when it comes to positive news. Published in the Journal of Experimental Social Psychology.

the researchers suggest that this may be due to a greater concern among men over how other people will see them, resulting in a tendency to self-promote by sharing positive information about themselves and not revealing their negative experiences to others.

"The results from our studies revealed a consistent, and to

the best of our knowledge not previously identified, nuanced pattern, wherein the tendency for women to disclose more than men depends crucially on the nature of the information shared," said Erin Carbone, visiting Assistant Professor in the Department of Social and **Decision Sciences at Carnegie** Mellon University in the US. "These findings can help make

sense of the existing literature, as well as clarify some existing stereotypes, around gender differences in disclosure," Carbone added.

To explore gender differences in the sharing of different types of information, the researchers



carried out three different experiments with over 1,000 people. In the first study, people selfreported times when they felt

like they were "dying" to disclose information to others, then indicated whether they actually had shared the information.

Although men and women generated similar numbers of instances of wanting to share positive information (e.g., about a promotion), men were far less likely to report wanting to share negative information (e.g., a failure to receive a promotion).

Two further studies enabled the team to quantify the desire to disclose and aggregate participants' desire as well as their propensity to disclose positive or negative information about different topics and experiences.

The study also found that women reported greater satisfaction than men with their own level of disclosure, whereas most male participants reported a greater propensity to withhold information about their thoughts and feelings even when it might have been better to share it with others.

"Our results show that gender remains an important fault line when it comes to the desire and propensity to disclose negative information, and men may be differentially advantaged by, or vulnerable to, the consequences of information sharing compared to women," said Professor Irene Scopelliti, Professor of Marketing and Behavioural Science at Bayes Business School (formerly Cass) in the UK. IANS

## **Auction of Nayagarh** sugar mill starts row

Nayagarh, Nov 5: Payments to the tune of ₹35 crore to banks, sugarcane farmers and employees by Navagarh sugar mill at Panipoila area in this district are yet to be realised as its auction is caught in legal wrangles and administrative bottlenecks.

The sugar mill, established on 143 acre land at Panipoila in 1998, has been in lockdown since 2015. The district administration sealed it after making an estimate of its properties March 12, 2020. The sugar mill will become a thing of past as the district administration never thought of its security.

Later, the state government sold off the sugar mill at ₹5.22 crore to a private entrepreneur Trailokya Mishra under agreement of sale. Though Mishra has made one-time payment, the sugar mill land is yet to be registered in his name.

Reports said the sugar mill cannot be auctioned as an arbitration case of ₹840 crore is subjudice in the court. Meanwhile, a six-member team of National Company Law Tribunal (NCLT) visited Panipoila Friday and made an estimation of the sugar mill properties for the third time. However, there is no let-up in

get back their dues. Speaking to mediapersons, the cooperative minister said the authorities of the sugar factory have demanded a compensation of ₹1,471.68 crore from the state government. A case has been filed in the court but its fate is still unknown.

Trailokya Mishra, chairman of Nayagarh Sugar Complex, said that the sugar mill property was estimated thrice in his absence. He has filed an ₹840 crore arbitration case in the court demanding compensation. "I purchased the sugar mill

by making necessary payment following a cabinet decision but the sugar mill and the land are yet to be registered in my name,' he added.

An advocate Ranjit Dash said the sugar mill cannot be auctioned when the matter is subjudice in the court. Moreover, the banks will not get even half of their payment dues by auctioning whatever equipment is left in the sugar mill.

Further, the district administration has failed to check rampant theft of equipment from the mill. Lastly, only the forest land will be left which cannot be sold off, he added.

The minor boy was mauled to death by the leopard October 30 when he was playing at his village inside Sunabeda Wildlife Sanctuary

The wild animal also allegedly attacked another minor in Dharambandha area Saturday afternoon. The minor boy sustained an injury in the attack.

The forest officials informed that the government has initiated steps to pay compensation of ₹6 lakh to family members of each of the deceased.

On the Talcher and Bimlagarh rail link issue, Samal said, "The Central government is allocating funds every year but one fails to understand why there is such inordinate delay in land acquisition." Regarding the Rourkela Airport instrument landing sys-

tem issue, he said, "The state government should first transfer the land to AAI and then only the later will be in a position to install that.

He stated that the state government had written to the Centre for nine medical colleges for which the Central government has provided funds. Recently a big controversy erupted when a private party, Kuanrmunda dairy farm, was given the land which the state government had earmarked for setting up a medical college and hospital. Asked why his party kept quiet on this issue, he said, "I am not aware of this but definitely I am going to ask the local unit and do the needful."

Finally, Samal said that BJP will stage massive demonstrations from November 14 to 18. "We are going to protest at all levels beginning from panchayat, block, civic bodies and district headquarters highlighting the wrongdoings of this government," he said.

Nayagarh/Ranpur, Nov 5: A sharecropper committed suicide by hanging at Ostapada village under Chandpur police limits and Ranpur block of Nayagarh district allegedly due to crop loss resulting from drought like conditions and failure to pay back loans he had borrowed to raise the crops, Sunday.

The deceased identified as Gobinda Sahu, 65, ended his life owing to crop loss and loan burden, his wife Gelhi Sahu and son Bikram Sahu alleged. On being informed, a team of agri culture officials visited the spot and conducted a probe.

Gobinda had cultivated on half acre land which he had taken on lease from a co-villager and borrowed from local money lenders to raise his crops. However, he failed to repay the loan due to crop loss.

This pushed him into distress and he took the extreme step by hanging from a tree near the farmland, Sunday. On being in-

formed, family members recovered and cremated his body without informing the police.

When contacted, the chief district agriculture officer Bishnu Prasad Sahu said a team rushed to the spot and conducted a probe after learning about the sharecropper's suicide. Preliminary inquiries by the team indicated that Gobinda committed suicide over family dispute. However, the Agriculture department is continuing its probe in order to elicit more details on the death,

he added.

The cabin of the dumper was completely broken and the driver was crushed inside.

Informed, the fire brigade reached the spot and rescued the driver from the cabin using hydraulic cutting machine.

### Price of War

he helplessness of the US administration in reining in Israel wreaking havoc on the not so innocent Palestinians in Gaza in the name of uprooting Hamas is evident. The US has only started making some feeble noise intended as peace overtures by meekly appealing to Israeli Prime Minister Benjamin Netanyahu to order a 'pause' on its brutal, military attacks and incursions into Gaza Strip so that medical and other humanitarian aids can reach over two million displaced Palestinians. By such a response, the US has shown that it has no intention to seriously try to restrain Israel which is on a killing spree. Apart from it being globally insulted that all the big noise it made in the past about its constant preparedness for war was nothing in reality, Israel is unable to carry the psychological burden of hostages that it has been loaded with by the Hamas.

The US has too great a stake in the Middle East and its most trusted and dependable ally in the region, Israel, alone can safeguard its interests. Many liberal experts of America have categorically pointed out if the US administration decides not to supply arms and ammunition and other aids worth billions of dollars to Israel, the latter's belligerence would be immediately controlled. That is next to impossible due to America's geopolitical equations in the Arab world.

US secretary of state, Antony Blinken, met senior Jordanian and other Arab officials in Amman November 4 in the latest effort by Washington to avert a regional escalation of the war, ease the acute humanitarian crisis in Gaza and build support for planning a post-conflict future for the territory. The trip was his second to the Middle East since the conflict began almost a month ago. On that very day Palestinians reported a deadly Israeli strike on a UN-run school in northern Gaza serving as a shelter for refugees. Witnesses said the strike hit al-Fakhoura school in Jabalia, where thousands of evacuees were living. At least 15 people died and dozens were wounded. The confirmation of the bombardment by Juliette Touma, the director of communication for the UN Palestinian refugee agency (UNRWA), shows the incident did take place and was not a war propaganda to blacken Israel military actions.

The ineffectual intervention by the US makes it clear that there is no sign that Israel will ease its effort to "crush" Hamas in Gaza. The health ministry in Hamas-run Gaza says more than 9,220 people have, so far, been killed in Israeli bombardments, most of them children or women. Despite Netanyahu's statement that the offensive in Gaza would continue with full force, the US administration is continuing talks with Tel Aviv, though it does not inspire much hope of ending the retaliation any time soon.

On the contrary, Israel's planned ground offensive means ever deeper incursions into the narrow strip of land the objective of which is the encirclement of Gaza City, accompanied by massive strikes targeting Palestinian militia infrastructures. Debatably this is how Israel wants to exercise its right to defend itself after the massacre of innocent Israeli civilians on October 7. Israeli authorities assert their aim is to respond to terror not by seeking revenge at any price, but by setting a military objective which is the destruction of Hamas.

The objective may not be fulfilled as easily as Israel wants the world to believe. There are at least three obstacles in their way. The first is that Hamas' military infrastructure is so much interwoven into the urban fabric of Gaza - one of the most densely populated areas on the planetthat the goal cannot be achieved without carrying out total destruction of the city and of lives on an unprecedented scale. This could only help unite the Arab world against Israel the way never seen before. Experts say this way Israel is getting into the trap set by Hamas' strike in southern Israel.

The second obstacle is the survival conditions of Palestinians in a territory that has been under blockade since 2007. Humanitarian aid that is trickling through the Rafah crossing on the border between Gaza and Egypt is too meagre to meet the basic needs of a population of over 2 million. The third difficulty is the presence of at least 240 hostages captured on October 7 by Hamas. These hostages are believed to be held

in the tunnels that are the main target of the Israeli bombardments. All these factors coupled with the worldwide repercussions of the images of the suffering of Gaza's civilians are going against Israel. By insisting that it will not stop till the last Hamas foot soldier is alive, Israel is only helping the latter's cause. It is simple to ask for the military of fensive to stop immediately and both sides should return to the negotiation table as several Arab countries are urging Israel. That goal is extremely difficult to achieve. It is also a very tricky situation where it is impossible to claim either side as 'innocent' or 'culprit'. Both, Israel and Hamas, are equally responsible for the war and suffering that is taking place today.

## THE IDENTITY TRAP

ost people who have gone through a job interview will be familiar with the question. "Tell me about yourself" where the interviewee is expected to summarise why she/he is the perfect match for the position. When we meet people socially, we are trying to understand what kind of a person the other individual is so that we can decide whether we should socialise with her/him.

We have multiple ways in which we can identify ourselves; by religion, by caste, by nationality, by gender, by age, by profession, by education, by our political leanings; you get the idea. Some of these we inherit, like gender, religion, caste, while we acquire or develop others. Which of these identities do we feel strongest about? The effect these identities have on our choices of friends, careers, where we live, is something that has assumed very different dimensions today as compared to a few decades ago. Let me explain. I was born and grew up in

what was Bombay (now Mumbai), living in Delhi, male, Hindu by birth, engineer by training, educator by profession, amateur baker, cheesemaker, avid reader. How should I describe myself? It depends on the situation. If I am in a job interview. I would likely present my education and experience credentials. If I am at a party, I would be more inclined to let my interests define me. In what context should I let my religion or caste define me?

Strange as that question sounds, ethnicity, religion and nationality have become defining attributes of some people in today's world. We all belong to some ethnic and religious group, including atheists. This is a given. The difficulty arises when we let such group membership define our total persona. Political parties have tended to use ethnic/religious/national identities to polarise the population

with the sole purpose of winning elections. People find themselves in an identity trap that is not of their making, and which is not easy to escape. This is a global phenomenon and has been seen to assume greater currency in the last decade or so. In my opinion, when we state our identity using one or more defining attributes, we are expressing membership in a group, whether social, professional, or political. This membership can be fluid as in the case of groups representing a specific interest, such as a book club, or photography club. We may belong to such groups as long as our interest lasts, and typically we are not emotionally invested in such groups. On the other hand, belonging to certain groups based on religion, caste or region can, and sometimes does, evoke strong emotions including hatred for people who are not part of the group. It is the intensity of this emotion that is exploited by politicians for their own benefit. We see examples of this in conflicts throughout the world such as the Israeli-Hamas conflict in the Middle East.

I believe majority of the people do not feel strongly about their ethnic/religious identity

that it should lead to hatred and violence. However, if they are manipulated into believing that their group is under attack from people from other groups it can cause some people to react violently. Such people forget their multi-dimensional identity which includes their education, profession, interests, and focus on the identity that they have been led to believe is under attack. Once a person starts to believe that the core dimension of her/his identity is under attack, then other things become unimportant. Even if people in the "outgroup" may have a lot in common with us in terms of education, profession, interests, all these factors pale in comparison to the dominant identity. This is the identity trap that I refer to in the title of this article. It occurs when we let others define ourselves.

The dangers of such a trap are a polarised population, lack of meaningful political and civic discussion, and a general mistrust and animosity among otherwise peaceful people. I am not suggesting that people will not have differences with others in a democracy. In fact, a healthy democracy should encourage debates among people. When these debates are issue-based

they are good for society, but when there is no discussion but only acrimony, and sometimes, violence, the result can be a fractured society.

The solution for such polarisation will come from a realisation that we cannot, and should not, be defined by a limited set of identity attributes, least of all those that tend to evoke high emotions and prevent us from being able to reason through a situation. It is somewhat ironic that not many people are as actively involved with local issues, either at the level of the town, or city or community. The local issues have a much greater direct impact on most citizens and residents of an area as this may include civic services such as water education, roads, electricity, and transportation. However, these issues do not attract the same level of emotional investment as do broader, national level issues. Logically there should be more active participation of more people on local issues since the impact on our lives is more direct and visible. Getting people involved in local issues could also lead to a little better understanding of differences between people. These differences are not necessarily inherited differences, but differences that are the result of their life experiences, which include choices they have made. Perhaps this will promote a healthier appreciation of diversity among our fellow earth inhabitants. I am not naïve enough to think

that this will be easy. Citizens may not be ready to take interest in local politics with the same interest that they have shown in national politics. However, we will not know unless we try. And what we should ask is whether we are better off with people lacking a voice in their own governance or are we ready to try something different. I know where I stand in this matter. I would like to define my identity. What about you?

ble and democratic. Renewed interest in Niger's plight offers an opportunity to reflect on the key development challenges confronting a vast and troubled region. Chief among them is the stickiness of the colonial development model of resource extraction, which has led to intergenerational poverty and environmental degradation both of which fuel insecurity and migration - in other African countries as well.

Niger embodies Africa's development paradox. Despite its immense natural-resource wealth, including plentiful renewable and non-renewable energy sources and significant deposits of uranium and gold, it is one of the world's poorest countries, with more than ten million people (around 42% of population) living in extreme poverty. Almost half of Niger's children are not in school, owing largely to mass displacement and school

Development Index, ahead of only Chad and South Sudan.

The growing Islamist insurgency in the Sahel region has only made the situation worse. From June 2022 until June 2023, more than 22,000 Africans were killed in jihadist-related violence, a 50% increase from the preceding year. In recent years, terrorists have destroyed villages and massacred civilians in Niger. And these groups have continued to grow more powerful, despite the proliferation of foreign military bases and drone stations in the country. This rampant insecurity, coupled with stagnant economic growth, mismanagement of natural resources, intergenerational poverty, and climate disasters, has suffocated Niger's population.

Despite being the largest oil producer on the African continent. Nigeria is one of the world's most energy-poor countries in per capita terms: its citizens consume an average of 113 kilowatt hours of electric energy per capita annually, compared to a continental average of 317 kWh. Niger's uranium deposits have served its former colonial ruler, France, especially well, powering

ergy, which has enabled French citizens to consume more than 6,950 kWh of electric energy per capita annually-one of the highest rates in the world. Roughly 20% of France's total uranium imports came from Niger between 2012 and 2022, while the country accounts for one-fifth of the EU's total uranium imports.

Moreover, the extraction itself has caused significant harm to the environment and the health of its citizens. In 2010, a Greenpeace investigation revealed dangerous radiation levels among Nigeriens working in the mining sector, some of whom suffered from unexplained skin, liver, kidney, and lung diseases. The natural resources that were supposed to help improve the welfare of the population have failed to meet expectations. Worse still, in the absence of value addition for effective integration into global value chains, the persistence of the colonial development model has meant that Africa's resource endowment remains a blessing only for the former rulers doing the extracting and a curse for the country from which they are extracted, yield-

### Hacking alarm

Sir, The anger that erupted after several of the country's most prominent Opposition leaders received alert messages about attempts to hack their iPhones is not unexpected. Because the communication claimed government-sponsored assailants, the situation was elevated. In any democratic system, when such an instance of the government violating the privacy of Opposition leaders comes to light, the administration is automatically called to account. However, it is also critical to emphasise that in this case, it is merely a matter of doubt. Apple's iPhone texts were generated automatically, and the company is unsure of their legitimacy. It claims that some of these notifications may be false alarms. Despite this, the Opposition leaders' concerns are not without merit. If these alert texts are part of a false alarm, how did all of them end up on the phones of Opposition leaders? Memories of the Pegasus case, which surfaced two years ago, heightened the apprehensions. In this context, when the latest charge of hacking Opposition leaders' phones is made, it must be regarded seriously. The good news is that the government appears to be taking these charges seriously. Not only has a thorough inquiry into the entire situation been ordered, but the iPhone manufacturer has also been asked to participate in the investigation.

## brain, leads to anxiety'

New Delhi, Nov 5: As severelypolluted air has choked Delhi. doctors in the city have warned people, saying air pollution affects not just the lungs, but also other major organs, such as the heart and the brain, across all age groups.

There has been a sudden increase in cases of headache, anxiety, irritation, confusion and decrement of cognitive abilities, especially among the vulnerable populations such as the elderly, schoolgoing children and pregnant women, Dr Neeraj Gupta, head of the pulmonary medicine department at the Safdarjung Hospital, told PTI.

"Neurocognitive ability is directly linked to rising nitrogen dioxide, sulphur dioxide and carbon monoxide in the air as they impact the nervous system." "So gas chamber is a technically correct term to be used because of the rise of the concentration of harmful gases and not just particulate matter," he said.

Gupta further said a study conducted in North Carolina among schoolgoing children has shown that the Air Quality Index (AQI) has a direct impact on their mathematical abilities.

So the only way out is avoidance of exposure to this toxic air. Especially, vulnerable populations and patients with preexisting conditions like asthma, chronic obstructive pulmonary disease (COPD) and ischaemic heart disease should try to stay indoors and take preventive measures. "Because of the significant multi-organ health hazard pollution causes to humans, there is an urgent need to take sustainable actions to bring down the levels of air pollution in the Indo-gangetic plains," Guleria, who is currently the chairman of internal medicine, respiratory and sleep medicine at the Medanta hospital, said.

"Also, data suggests that throughout the year, in more than 50 per cent of days, the air quality continues to be in an unacceptable range, thereby exposing citizens to the harmful effects of air pollution on most days, which further aggravates during winter," Guleria said.

"Along with prolonged cough ing, breathing difficulty, throat infection and chest tightness, patients are complaining about anxiety, confusion and increased irritability. This air pollution is a major crisis that needs to be mitigated urgently," he told PTI.

## UP medical colleges to teach in Hindi too

Lucknow, Nov 5: Medical institutions in Uttar Pradesh will now start using Hindi as a medium of instruction, as per government directives.

"A government letter issued on October 31 has stated teaching in Hindi be started at colleges and universities under the medical education department.

This transition is expected to bring greater clarity to medical students, particularly those who have received their prior education in Hindi.

For example, consider the instruction, "Before measuring blood pressure ensure the unique preparation or the prerequisite are done

This sentence might pose challenges for MBBS students who are not well-versed in English. However, if explained in Hindi as, "Blood pressure napne se pehle sabhi jaruri taiyariyan puri kar leni chahiye," it can be easily understood even by those



who do not know the English language.

"Hindi books are now available for almost all MBBS subjects. Some are under review also," said Prof NS Verma, head of physiology department at the KGMU.

"Many countries such as Russia, China, Japan teach students in their own language,' he added.

The teachers, however, pointed out that Hindi has already been the language when it comes to explaining in detail any complex point in classroom. "Almost 60 per cent of our content is being explained in Hindi. This helps students understand what exactly we teach," said Prof Navneet Kumar, head of anatomy department at the KGMU. Prof Suryakant, from the pulmonary medicine department at KGMU, emphasised the need for teaching students English before they embark on their first year MBBS curriculum.

Lucknow, Nov 5: Around 200 women, mostly belonging to the Tharu tribe in Bahraich, about 128 km from here, are looking after the nutritional requirements of their families through organic farming which they also see as a potential source of extra income. "After Covid, a survey to assess

the damage caused by the pandemic to the most vulnerable women found that their nutritional levels were very low and it was felt that something required to be done for them. The idea of providing them with nutritional food through vegetables that can be grown in their kitchen gardens took root," World

Wildlife Fund-India senior project officer Dabeer Hasan, who is running the project, told PTI.

Orientation was done with the womenfolk repeatedly, stressing the importance of nutrition and they liked the idea of getting it in their own homes, without disturbing their day-to-day life.

"Starting with 75 people, the numbers gradually swelled with more women joining in and now after two seasons, these women have also started contributing to 25 per cent of the project cost. Earlier, the WWF was bearing the entire cost of the project," said Hasan of WWF, which is working in more than 60 countries in the areas related to forest, wildlife and climate change.

To check the impact of this project on the health of these women, Hasan said the Uttar Pradesh health department has been involved in conducting a door-to-door survey to collect latest data related to their nutritional requirement and compare it with the outcome of an earlier survey in the first season.

Training of health department workers at the level of ANMs, ASHA and Anganwadi workers was held recently to conduct the survey for collecting data on the nutritional level of these women and their family members, he said, adding that this will also help in guiding as to how to proceed further.

Meera Devi, a Tharu of Fakirpuri village, who is growing vegetables such as spinach, fenugreek, cauliflower, peas, coriander, radish, carrot, turnip around her house, said the yield is good.

### **Delhi Fire Services starts** spraying water at hotspots

New Delhi, Nov 5: To curb the rising pollution in the national capital, the Delhi Fire Services has joined hands with the Delhi government to spray water at several hotspots, officials said Sunday.

"A total of 12 fire engines have been pressed into service to curb pollution. These fire tenders have already started sprinkling water at different locations which have been identified as hotspots," Atul Garg, Director of Delhi Fire Services, said.

Garg said he was hopeful that sprinkling water might be able to bring some respite to citizens.

A toxic haze lingered over Delhi for the sixth consecutive day Sunday as pollution levels once again reached the 'severe plus category' due to unfavourable wind conditions, particularly calm winds during the night.

The air quality index deteriorated from 415 at 4 pm on Saturday to 460 at 7 am Sunday, which was later recorded at 461 at 11 am, according to the Central Pollution Control Board (CPCB).

Considering the high pollution levels, Delhi Education Minister Atishi Sunday announced that primary schools in Delhi will stay closed till November 10. Taking to social media platform 'X' Atishi wrote,



"As pollution levels continue to remain high, primary schools in Delhi will stay closed till November 10. For Grade 6-12. schools are being given the option of shifting to online classes.

Earlier, Chief Minister Arvind Kejriwal had announced November 2 that all government and private primary schools in Delhi will remain closed November 3 and November 4, in view of the rising pollution levels.

Under the Centre's air pollution control plan, all emergency measures, including a ban on polluting trucks, commercial four-wheelers, and all types of construction, are mandated to be initiated and enforced in the National Capital Region if the AQI crosses the 450-mark.

An AQI between 0-50 is considered 'good', 51-100 'satisfactory', 101-200 'moderate', 201-300 'poor', 301-400 'very poor' and 401-450 'severe'. An AQI above-450 falls in the 'severe plus' category.

New Delhi, Nov 5: The Lok Sabha's Ethics Committee will meet November 7 to consider and adopt its draft report in relation to the 'cash-for-query' allegations levelled against TMC MP Mahua Moitra by BJP's Nishikant Dubey. The meeting for adopting the

draft report means that the committee headed by BJP MP Vinod Kumar Sonkar has finished its enquiry and will now be making its recommendation after its members ranged along party lines in their last deliberations on November 2. The BJP members are in a

majority in the 15-member committee which is likely to take a grim view of the charges against Moitra, more so after she accused Sonkar of asking filthy and personal questions to her in the last meeting before walking out in a rage along with opposition member.

There are indications the committee may make a recommendation against her in its report to Speaker Om Birla amid a pos-



sibility of dissent notes from opposition members. All five opposition members had stormed out of the November 2 meeting, alleging that Sonkar asked per-

sonal and indecent questions to her regarding her travels, hotel stay and telephone calls.

She later alleged that she was subjected to a "proverbial vastraharan" in the meeting. The committee chairperson dismissed opposition members' claims as a case of unethical conduct aimed at shielding her. The decision of Moitra, who

appeared before the panel as a subject of enquiry and thus lacked the privileges bestowed on its members, to walk out of the meeting is likely to be taken up critically by the committee in its report.

## Principal held for sexual harassment Woman geologist

Chandigarh, Nov 5: A government school principal in Haryana's Jind district has been arrested for alleged sexual harassment of over 50 girl students, police said Sunday.

"The accused principal was arrested on Saturday," Deputy Superintendent of Police, Amit Kumar Bhatia, who heads a fivemember Special Investigation Team probing the case, said.

"He had been on the run for five days, but our teams arrested him. He will be produced before a court (in Jind) and we will be seeking his police remand to conduct further investigations,' he said. Over 50 female students of the government school in Jind district had accused the principal of sexual harassment, the Harvana State Commission for Women had said earlier.

The Harvana Police had Monday booked the school principal, days after he was suspended by the Jind administration over allegations of sexual harassment. The State Commission for Women's chairperson Renu Bhatia had earlier said in Panchkula, "We have received 60 written complaints against the principal from the girl students. Out of this, 50 are complaints from girls who stated physical abuse at the hands of the accused. Ten other girls, in their complaint, said they knew the principal was into such things."

Women in defence forces to get same leave as officers

New Delhi, Nov 5: Defence Minister Rajnath Singh has approved a proposal to grant maternity, child care and child adoption leave to women soldiers, sailors and air warriors on par with their officer counterparts.

The defence ministry Sunday said the decision is in line with Singh's vision of "inclusive participation" of all women in the armed forces, irrespective of their ranks. It said the measure is going to improve the work conditions for women in the military as it will help them balance their professional and familv lives in a better manner. Defence Minister Rajnath Singh has approved a proposal for extension of the rules for maternity, child care and child adoption leave for women soldiers, sailors and air warriors in the armed forces at par with their officer counterparts," it said. "With the issuing of the rules, the grant of such leave to all women in the military, whether one is an officer or any other rank, will be equally applicable," the ministry added. At present, the women officers get maternity leave of 180 days with

full pay for each child, subject to

a maximum of two children. Childcare leave of 360 days is granted in total service career (subject to the child being less than 18 years of age) to women officers, according to officials.

Child adoption leave of 180 days is granted after the date of the valid adoption of a child below one year of age, they said."The extension of leave rules will go a long way in dealing with women-specific family and social issues relevant to the armed forces," the ministry said in a statement.

The Nepal government also decided to provide free medical treatment to those injured in the earthquake. During the meeting, it was also decided to prepare an integrated action plan to construct earthquake-resistant housing within one year for the rehabilitation of those affected.

In the aftermath of the disaster, Nepal's immediate neighbours, India and China, and the United States have offered support with logistics and search for the victims by sending rescue teams to the country.

Since various countries have expressed willingness to extend assistance to the earthquake victims, the government will for-mulate standards for the type of aid it can accept, Basnet said.

Bank of Maharashtra top among PSU lenders in loan, deposit growth

New Delhi, Nov 5: State-owned Bank of Maharashtra (BoM) retained the top spot among public sector lenders in loan and deposit growth in percentage terms during the second quarter of the current financial year.

BoM was the top performer among PSBs in terms of deposit, advances, and total business with growth of about 25 per cent during the first quarter as well. The deposit and advances of

the Pune-based lender posted an over 20 per cent rise, the highest by any public sector bank during the July-September period

With a growth rate of 23.55 per cent, gross domestic advances of the bank rose to ₹1,83,122 crore at the end of September 2023, according to published quarterly numbers of public sector banks (PSBs). It was followed by Indian

Bank of Baroda was in second place with 12 per cent growth in deposits (Rs 10,74,114 crore), while SBI recorded an 11.80 per cent increase at ₹45,03,340 crore, according to the published data.

BoM retained the top position in terms of garnering low-cost Current Account and Savings Account (CASA) deposits at 50.71 per cent followed by Central Bank of India at 49.93 per cent.

Helped by high growth in loan and deposits, the bank's total business also recorded the highest growth of 22.77 per cent at ₹4,22,420 crore, followed by Bank of Baroda at 13.91 per cent growth (Rs 19.08.837 crore) at the end of September 2023.

New Delhi, Nov 5: The combined market valuation of nine of the top-10 most valued firms surged ₹97,463.46 crore last week, with Reliance Industries emerg-

ing as the biggest gainer, amid an overall positive trend in equities. Last week, the BSE benchmark jumped 580.98 points or

### Headline inflation under control: FinMin

New Delhi, Nov 5: While GDP growth remains on track in 2023-24, the declining trend in headline inflation was briefly interrupted in the second quarter due to a spike in the prices of certain food items, however, according to the Finance Ministry, it was a temporary phenomenon caused by the seasonal and weather-driven supply constraints in a few food items.

In a report released by the Finance Ministry recently, it was stated that headline inflation has moved to track (under control) on the back of vegetable price correction and the recent reduction in LPG prices.

"As per the latest release of the consumer price index (CPI), headline inflation was 5 per cent in September, within the upper tolerance limit of inflation tar-



geting. This indicates that the increase in inflation during July-August was only temporary, caused by the seasonal and weather-driven supply constraints in a few food items," it noted.

Among the 299 items in the CPI basket, only 11.4 per cent of food items with double-digit inflation in July caused a spike in headline inflation. However, this declined significantly to 7 per cent in September. Alongside softening food inflation, the fuel & and light group witnessed a de-

The RBI in its monetary policy committee meeting of October decided to remain focussed on the withdrawal of accommodation to ensure that inflation progressively aligns with the target while supporting growth, and hence, kept the policy repo rate unchanged at 6.5 per cent.

### Power usage grows 9.4% in April-Oct

New Delhi, Nov 5: India's power consumption grew 9.4 per cent to around 984.39 billion units in the April-October period this fiscal compared to a year ago mainly due to improvement in economic activities and weather conditions.

Power consumption in the April-October period in fiscal year 2022-23 was 899.95 billion units, according to power ministry data. Another indicator, peak power

demand, was also higher at nearly 241 GW during the April-October period this fiscal against

### 215.88 GW in the same period in 2022.

The country's power consumption grew nearly 22 per cent to 138.94 billion units (BU) in October, showing a surge in electricity demand due to festivities and increased economic activities.

In the same month a year ago, power consumption stood at + 113.94 BU, higher than 112.79 billion units recorded in October 2021, as per government data.

A spokesperson of Tata Power Delhi Distribution Ltd said, "In the last couple of months, elec-tricity consumption has gone up substantially.

### 'India unlikely to have hyperloop trains in near future'

Hyperloop is a high-speed train, running in vacuum in a tube. The technology is proposed by elon musk, founder of e-car firm tesla and commercial space transport company spacex

New Delhi, Nov 5: India is unlikely to go in for hyperloop technology for ultra high-speed trains in the near future as the technology is at a 'very low level' of maturity and may not be economically viable at the current juncture, NITI Aayog Member V K Saraswat said on Sunday.

Saraswat, who is heading a committee to explore the technological and commercial viability of the Virgin Hyperloop technology, further said some foreign companies have shown interest to bring the technology in India

"Hyperloop technology as far as we are concerned, we found



that the offer which came from foreign countries are not very viable options. They are at a very low level of maturity of technology," he told PTI in an interview.

'So we have not given much importance to that and as on today, it is only a study pro-

gramme. I don't expect hyperloop to enter into our transportation framework in the near future, he said

The Virgin Hyperloop test run was conducted November 9, 2020, on a 500-metre track in Las Vegas in the US with a pod, as the hyperloop vehicles are called, travelling with passengers, including an Indian, inside an enclosed tube at more than 161 km/hr. According to Saraswat, the offers which came are at a very low level of maturity and "we cannot make investment on that kind of a technology.

Virgin Hyperloop is among a handful of companies which are trying to build such a system for passenger travel

Maharashtra has deemed hyperloop a public infrastructure exercise and approved the Virgin Hyperloop-DP World Consortium as the original project proponent for the Mumbai-Pune hyperloop project.

### LITHIUM ION IMPORTS

Replying to a question on India's reliance on lithium imports from China, Saraswat said as on today, production of lithium ion battery in India is very low, so the dependence is on the import of batteries from China and other sources.

"But mostly it is from China because competition wise the Chinese batteries are

### cheaper," he said.

Pointing out that India has given incentives for setting up battery manufacturing facilities in the country, Saraswat said, "Hopefully, next year you will have couple of business houses going into production in a large scale for manufacturing of lithium-ion battery in the country." About 75 per cent of the lithium-ion imports come from China.

On reports of India talking to Chile and Bolivia for tapping into lithium mining, Saraswat said there was a suggestion that India should go for acquisition of certain mining facilities in Chile, Argentina and other places

"And what has happened is instead of the government directly going to these countries and acquiring mines, our private sector has already signed business to business agreement with some of the companies in these countries and they have already got supply chain agreement for getting lithium from these centres.

Kohli's Sachin praaji was quick to congratulate the former on 'X'. "It took me 365 days to score my 50th hundred after I got my 49th. I hope you break my record and get your 50th hundred in the next few days. Congratulations," Tendulkar wrote.

For a man, who burst on to the cricket scene by leading India to the World Cup under-19 title more than 15 years ago, Kohli has indeed come a long way. He definitely has set the benchmark for the next generation of cricketers like

Shubman Gills and the Yashasvi Jaiswals.

Kohli described his feat as 'it's stuff of dreams' as he touched the man he always idolised. "Every opportunity to play for India is big one for me. To be able to do that (49th hundred) on my birthday, in front of the whole crowd, it's stuff of dreams, something that as a child you wish had happened," Kohli said after the completion of the Indian innings. He couldn't have been closer

to the truth.

### **Rohit equals ABD's** 6-hitting record

Kolkata: Indian skipper Rohit Sharma has equalled South Africa's AB de Villiers record for hitting the most ODI sixes in a calendar year. Rohit achieved the feat when he hit Lungi Ngidi for two sixes while scoring 40 against South Africa during India's ODI World Cup game at the Eden Gardens here. The two sixes took Rohit's tally to 58 in 2023. He will definitely have a chance to go past the record set by De Villiers in the next few matches India play in November.

### Pakistan team fined for slow over rate

Bangalore: Pakistan players have been fined 10 per cent of their match fees for maintaining a slow over-rate against New Zealand in a World Cup league game which they won by 21 runs here Saturday. "Richie Richardson of the Emirates ICC Elite Panel of Match Referees imposed the sanction after Babar Adam's side was ruled to be two overs short of the target after time allowances were taken into consideration," an ICC media release stated Sunday. Pakistan skipper Babar pleaded guilty to the offence and accepted the proposed sanction, so there was no need for a formal hearing.

### Vinicius racial abuse incident condemned

Madrid: The Spanish league has denounced racist abuse targeting Vinícius Júnior at last weekend's 'clasico' match between Real Madrid and Barcelona. Madrid forward Vinícius, who is black, has been the victim of repeated racist verbal attacks from fans in the past two seasons. La Liga authorities have asked hosts Barcelona to investigate the incident and identify the culprits. It has also condemned the incident which took place October 28 in a report to the Spanish Soccer Federation and has said that the 'incident could have incited violence'. "Offenders must be identified and punished," the report stated.
