Odia classic Parinama re-released after 63 years

The prints of the movie, released in 1960, were lost in the 1969 floods and their recovery was impossible, said producer Krushnachandra Tripathy Sharma in 1989

Bhubaneswar: The Film Journalists' Forum (FJF), a group of passionate cinescribes, conducted the screening of the restored and digitised version of Odia classic movie Parinama here at Jaydev Bhawan.

After an exhaustive research, FJF managed to locate the longlost print of this cinematic gem, said Surya Deo, an active member of the Forum.



"Through meticulous cleaning, preservation, and digitization, the film has been brought back to its former glory and could be screened," added Deo, who bagged a National Film Award earlier this year for his book Kali Pain Kalira Cinema.

It may be recalled that Krushnachandra Tripathy Sharma, the producer of the movie, during an interview in 1989, regretted that he lost prints of all his films including Parinama, in the floods of 1969. After that, he stopped making films. So, there was no possibility of retrieving the movie.

"It's a long story about how and from where it was recovered. However, our painstaking efforts paid off, and we could restore the classic using advanced technology," said Deo.

Presented by Utkal Chalachitra Pratisthana and directed by Biswanath Nayak, the film had Pramod Panigrahi and Gitisudha in lead roles. Dukhiram Swain, Dhira Biswal, Master Mania, Purna Chand, Sundarmani, Kishori Devi, and Karik Ghosh played other key roles. Tushar Panigrahi, brother of former Odisha CM Nandini Satpathy, played the main antagonist in the movie.

Bhubaneswar Mishra scored the music, while Akshay Mohanty, Sandhya Mukherjee, and Nirmala Mishra lent voice to the songs.

The 90-minute movie was released in Capital Talkies (Cuttack), Srikrushna Talkies (Puri), and Utkal Talkies (Aska) November 3, 1960.





Life term for 8 villagers

BERHAMPUR: A local court here Tuesday sentenced eight persons to life imprisonment after convicting them for the murder of a co-villager over past enmity at Ambagada village under Berhampur Sadar police limits in Ganjam district in 2017. The convicts were identified as R Hari Patra, 30, R Lokanath Patra, 21 M Danda Patra, 45, K Bairi Patra, 55, K Bhima Patra, 47, M Somesh Patra, 20, B Noi Patra, 37, and B Bhaskar Patra, 21 - all residents of the same village. The eight thrashed Budu Patra of the village to death over past enmity September 17, 2017.

'Pralay' test fired

BALASORE: India Tuesday successfully test-fired its surface-tosurface short-range ballistic missile (SRBM) 'Pralay' from the Abdul Kalam Island off the Odisha coast, a Defence official said. The missile has been developed by the Defence Research and Development Organisation (DRDO) in view of the country's defence requirements along its borders with neighbouring China and Pakistan, he said. The missile, launched around 9.50 am, met all its mission objectives, the official said, adding that a battery of tracking instruments monitored its trajectory along the coastline. 'Pralay' is a 350-500 km short-range, surface-to-surface missile with a payload capacity of 500-1,000 kg. Pralay' has been developed for deployment along the Line of Actual Control and Line of Control, he said.

35-yr-old woman stabbed to death in City

FOUR MURDERS IN 24 HRS ROCK CAPITAL

Bhubaneswar, Nov 7: A 35year-old woman was stabbed to death by unknown miscreants at Gothapatna under Chandaka police station on the outskirts of the City here late Monday night.

The deceased identified as Sasmita Behera was living at Krishnapuri colony in Chandaka police station area here.

"Sasmita and her husband used to run a roadside eatery at the place. The husband had gone to fetch water from a nearby tap when some miscreants assaulted the woman leading to her death. The reason behind the fatal assault is yet to be established. However, circumstances suggest that she had been attacked over some previous enmity," said

A case (350/23) has been registered in this regard on the basis of the complaint lodged by the victim's brother. Sources in the police claimed that the assailants had used a long sharp weapon that almost pierced the

Significantly, hours before the incident, a 25-year-old married man killed a 5-year-old girl

by slitting her throat after allegedly raping her in a slum under Airfield police limits. The accused identified as Ghania Das, a daily wager, was on the run after committing the crime, said police.

"On being informed, police, along with the forensic team, reached the spot and started an investigation. Based on a complaint lodged by the victim's family, we have registered a case (274/23) against the accused for murder. However, we are waiting for the autopsy report and will slap rape charges against the

accused after confirmation,' said Ashok Kumar Nayak, IIC, Airfield police station.

Meanwhile, two more suspected murder cases were reported at different places in the Airfield police station area during the day

Maheswar Mohanty passes away

Bhubaneswar, Nov 7: Former Odisha Assembly speaker Maheswar Mohanty died at a private hospital here, Tuesday.

Mohanty, a BJD leader who was also a minister, was 67. He is survived by two sons and wife.

He was admitted to the hospital on November 1 after suffering a cerebral stroke, and the end came at 3.25 am Tuesday, officials said. His mortal remains

were consigned to flames at 'Swargadwar' in Puri with full state honours. His elder son Sunil lit the funeral pyre while thousands of people joined his funeral procession.

Popularly referred to as the "strongman" of Puri, Mohanty, an advocate by profession, was elected to the Assembly from the Holy town five times, as a Janata Dal candidate in 1995 and as a BJD nominee in



The apex court also advocated for community sensitisation to prevent bursting of firecrackers during the festive seasons

New Delhi, Nov 7: The Supreme Court Tuesday clarified that its earlier order for prohibiting manufacture and sale of firecrackers containing barium and banned chemicals is applicable to all the states and not just Delhi and National Capital Region. However, the sale of green crackers is permissible as per the apex court order of 2018.

A two-judge bench of Justices AS Bopanna and MM Sundresh asked all the states to comply with the apex court order banning firecrackers. The bench observed that no fresh order is required at this juncture as it had passed plethora of directions indicating steps to minimise air and noise pollution.

"Hence the said orders will bind every state in the country, including the state of Rajasthan," the bench said.

The bench said this while hearing an application seeking directions to the Rajasthan government to comply with the Supreme Court's directions regarding ban on crackers containing barium and minimising air and noise pollution during festive season. The apex court also advocated for community sensitisation to prevent bursting of firecrackers during the festive seasons. It said that sensitising common people about the harmful effects of firecrackers is the key.

"Ironically, nowadays children don't burst many firecrackers but elders do. It is a wrong perception that it is the duty

of the court when it comes to pollution and environment protection. People have to come forward. It is for everyone to manage air and sound pollution," the bench said.

Earlier in September, the apex court had rejected the plea of firecracker manufacturing association to permit manufacture and sale of firecrackers containing barium and joined fireworks (series crackers or laris) as per new stan-

Significantly, the Supreme Court had in October 2018 banned the manufacturing and sale of conventional crackers containing barium and other harmful chemicals. The apex court had allowed bursting of only green crackers, which have low emission of sound and harmful chemicals, during the festivals.

The top court had also banned the manufacture, sale and use of joined firecrackers (series crackers or laris) saying that they cause "huge air, noise and solid waste problems". The apex court had said that the noise and smoke emission limits on the crackers have to be approved by the Petroleum and Explosive Safety Organization (PESO), under the Department of Industrial Policy and Promotion, Ministry of Commerce and Industry. The court had also banned the fire-crackers generating noise level exceeding 125 dB(AI) of 145dB(C) at 4 metres distance from the point of bursting.

Four booked for stealing 'America'

London, Nov 7: Four men have been charged over the theft of an 18-carat gold toilet from Blenheim Palace, the sprawling English country mansion where British wartime leader Winston Churchill was born.

The toilet, valued at 4.8 million pounds (USD 5.95 million), was an artwork titled 'America' and intended as a pointed satire about excessive wealth by Italian conceptual artist Maurizio Cattelan. It was part of an art installation at Blenheim Palace, near the city of Oxford, a few days before it



vanished overnight in September 2019.

The Crown Prosecution Service said Monday it has authorised criminal charges against four men, ages 35-39, over the theft. They are accused of burglary and conspiracy to transfer criminal property. Seven people had been arrested over the heist. but no charges have been brought until Monday, four years after the toilet was stolen. The artwork has never been found.

The golden toilet was fully

functioning, and prior to the theft, visitors to the exhibition could book a three-minute appointment to use it. Police said that because the toilet had been connected to the palace's plumbing system, its removal caused 'significant damage and flooding' to the 18th-century building, a UN-ESCO World Heritage site filled with valuable art and

furniture that draws thou-


sands of visitors each year.

Guggenheim The Museum in New York, where the artwork was installed in a bathroom prior to it being shown at Blenheim Palace, described the toilet as 'cast in 18-carat gold'.

The museum said the artwork invited viewers to 'make use of the fixture individually and privately' to experience 'unprecedented intimacy with a work of art.

In 2021, the Thames Valley Police, the force investigating the theft, suggested that it would be a 'challenge' to recover the toilet. The four suspects will appear at Oxford Magistrates' Court November 28, prosecutors said.

New Delhi, Nov 7: The Supreme Court Tuesday asked the Centre to stop the selective 'pick and choose' approach in appointments to the top court, high courts and transfers between high courts, warning it of of "an unpalatable order" if the delay and selectivity continue while making appointments recommended by the SC col-

A bench of Justices Sanjay Kishan Kaul and Sudhanshu Dhulia expressed great concern over the delay by the Centre in clearing names proposed or reiterated by the collegium for appointment to the Supreme Court and high courts, or transfer between high courts.

Citing a recent example, Justice Kaul said that even when the SC collegium had recommended the elevation of five advocates as the Punjab and Haryana High Court judges, the Centre skipped first two and cleared the remaining three.

He added that this trend was reflected in several other appointments made by the Centre which disturbs inter-se senior-

"This pick-and-choose must stop," Justice Kaul told Attorney General R Venkataramani . spite the reiteration by the col-

Dictating the order the SC bench said, "We have expressed our concerns to the AG over the lack of progress since the last date. Pendency of transfer matter is an issue of great concern as it is being selectively done...AG submits that the issue is being taken up by him with the government.

"There are 14 pending recommendations to which there has been no response. In recommendations made recently, selective appointments have been made...This is hardly conducive to persuading successful lawyers to join the bench.

Justice Kaul asked the government to show some progress on the issue of transfers and selective appointments as the delays create huge anomalies in the system.

The court was hearing a plea seeking contempt action against the Centre over delays in notifying the appointment of judges after recommendations were forwarded by the Collegium. On October 20, the top court said that it will have to "unstuck" the collegium recommendations stuck with the Centre for appointment of judges. The case is listed for further hearing November 20.

Apex court upset over Dhenkanal lawyers' stir

New Delhi, Nov 7: The Supreme Court Tuesday sternly expressed disappointment over the abstention of work by advocates at a court in Dhenkanal district and asked them to "not make death a holiday for themselves.

A two-judge bench headed by Justice SK Kaul noted the submission of the Orissa High Court that there was no incident of strike except the one at Kamakhyanagar where bar association abstained from the work for the whole day after death of an advocate's clerk. Koraput, Nov 7: A factory manufacturing fake gutkha was busted in Koraput district and three persons were arrested in this connection, police said Tuesday. Acting on a tip-off, three police teams raided a building on the outskirts of the Lamtaput area Monday evening and seized seven gutkha packaging machines, a senior officer said.

A huge number of sacks containing gutkha pouches and raw materials used in making the tobacco product were recovered from there, the official informed.

We got information about the functioning of the illegal gutkha-making unit and accordingly, the raid was conducted. The arrested persons failed to provide any valid documents for running the unit," SDPO (Nandapur) Sanjaya Mahapatra said.

The unit was functioning at a rented house for the past few months and several people were involved in running the illegal



business, Mahapatra added. "After preparing the gutkha,

Earlier Forest department officials had informed about the presence of a Royal Bengal Tiger. They had been trying to track the movement of the animal. The roads passing through the Atei forest had been sealed

to protect the tiger, officials said.

Trapped Afghans

colossal humanitarian tragedy is unfolding close to India's border, but the world is too preoccupied with the Israel-Hamas war and the woes of Palestinians caught in the crossfire to take note of it. Hundreds of thousands of Afghan refugees are being forced to leave Pakistan as the country is carrying out an order from its interim government to remove undocumented people from within its borders. Of about 4 million Afghans living in Pakistan, nearly 1.7 million people are believed to be in the crosshairs of this forced eviction and repatriation plan. The Pakistan government set the deadline of November 1 for these people to remain in the country or leave or otherwise face arrest and deportation. A network of holding centres for detained migrants has been set up in Pakistan's mostly western provinces. There are reports of police high-handedness, harassment and abuse of Afghans living in the country. Nearly 200,000 Afghan refugees have already returned to their homeland which has become worse than prison as they face hostilities from the Taliban.

Human Rights Watch reveals refugees are now facing detentions, beatings and extortion by police. Others have been evicted by their landlords or fired from jobs. The UN High Commission for Refugees (UNHCR) has repeatedly appealed to the Pakistan government not to resort to forced repatriation of Afghan nationals. It warns that minorities, journalists and especially women and children are particularly in danger.

The Pakistan foreign ministry has responded by claiming that due precautions will be taken to ensure that those under greatest threat are not forced to return. But, this sounds like meaningless verbiage in the light of the abuses that are already taking place. The situation has come to such a pass because a caretaker government is now in place in Islamabad. It has little political accountability for a decision suspected to have been taken and imposed by the country's real rulers, the military.

Pakistan is seemingly using the Afghans to achieve two objectives. First, it wants the refugees to go so as not to impose further financial burden on its already tottering economy. But, more importantly the Afghans have turned out to be a sort of Pakistan's bargaining chip to protect the country against attacks and ravages being made by the Pakistan version of the Taliban. Islamabad wants to pressure the Taliban to check and curb the infiltration and plots of cross-border terrorists. In fact, the attacks have occurred even as Pakistan carries out its repatriation drive.

The acting interior minister, Sarfraz Bugti, has tried to justify this policy. The Taliban regime's defence minister has chided Pakistan with a proverb in Pashto which in English means – As you sow, so you rean

However, Bugti has a point when he said if the West were so concerned about the plight of these Afghans, it should have done more to relocate them. According to humanitarian groups, the \$613m regional refugee response plan to support 7.3 million Afghans hosted in neighbouring countries, as pledged by the West, only 15 per cent has, so far, been made available.

The failure of Western countries to fulfil their promises and their responsibilities appears to be in line with the abrupt US withdrawal of troops from Afghanistan leaving the native population to be slaughtered and enslaved by the Taliban. In such a situation Pakistan was the only option for hundreds of thousands of Afghans desperate to flee their country in 2021. The West has a pathetic record in this regard. The European Union has resettled only 271 Afghan refugees in 2022.

Pressure should be applied by the West on Pakistan not to drive out the Afghan refugees to Afghanistan. All these current disturbed zones across the world project just one simple image. Everywhere it is only the children and women who bear the brunt of torture, rape and eventual death. They are the only deprived lot everywhere and it is only they who need and deserve protection and empathy.



EXISTENTIAL IMPERATIVE

THE ALLURE OF SHORT-TERM PROFITS EVIDENTLY OUTWEIGHS POLICYMAKERS' FEAR OF IRREVERSIBLE PLANETARY COSTS

he world is barreling down a perilous path. Or, as United Nations Secretary-General António Guterres put it, "We are on a highway to climate hell with our foot on the accelerator."

are on a highway to climate hell with our foot on the accelerator." But global warming is not just another political issue: reducing greenhouse-gas (GHG) emissions is an existential imperative that must not be ignored.

The urgency of this crisis cannot be overstated. As countries confront the devastating consequences of climate change, it is crucial to act on the basis of the scientific consensus: limiting global warming to 1.5° Celsius above pre-industrial levels – the target set by the 2015 Paris climate agreement – requires halting new fossil-fuel investments.

But emissions are not being reduced at the speed and scale necessary to limit warming, as recent events, including the UN General Assembly and Climate Week NYC, have highlighted. Despite global leaders' frequent pledges of solidarity in support of climate action, a businessas-usual approach prevails in many countries. The United States, for example, has greenlit the Willow oil project in Alaska, while Brazil is flirting with oil exploration near the mouth of the Amazon River. The allure of short-term profits evidently outweighs policymakers' fear of irreversible planetary costs.

Ironically, many of the countries that are most vulnerable to – and least responsible for – global warming are doing more than their fair share to achieve the 1.5°C target. This year, in a historic referendum, the people of Ecuador voted to halt oil drilling in Yasuní National Park, which is part of the Amazon rainforest. In 2018, Belize became the first country to ban offshore oil exploration.

This disconnect is reflected in the Global Solidarity Report 2023, published by Global Nation with support from the Bill & Melinda Gates Foundation, Global Citizen, Glocalities, and Goals House. Analysing the strength and resilience of the international community, the report paints a sobering picture.

Most worryingly, a new scale to measure global solidarity shows that the world is in the "danger zone," scoring 39 points (with 100 representing the highest level of shared purpose). While solidarity among the global public is more widespread than many assume, the institutional response has so far failed to match the gravity of the moment.

Consider the United Kingdom.

Approximately 46 per cent of UK respondents agreed that the country "should leave oil and gas reserves in the ground," while only 17 per cent disagreed. Yet the UK government recently approved the exploration of a massive new oilfield in the North Sea. Such a counterproductive decision so soon after the UK rallied world leaders behind the Glasgow Climate Pact at the 2021 United Nations Climate Change Conference (COP26) underscores the ever-growing trust deficit between governments and their own citizens, as well as among countries.

Meanwhile, Bangladesh, despite accounting for only 0.46

per cent of current global emissions, has taken significant steps to move away from fossil fuels. The government decided to scrap plans for ten coal-fired power plants that had attracted \$12 billion in foreign investment. Prime Minister Sheikh Hasina has emerged as a beacon of inspiration, urging her citizens to become leaders in and champions of global climate action, rather than passive victims of the crisis.

Moreover, most of the nine countries currently considered "almost sufficient" in meeting the 1.5°C target (according to the Climate Action Tracker) are in the developing world. Costa Rica, which produces most of its electricity from renewable sources, falls into this category. Innovative policies and financing models have enabled the government to protect the country's forests and biodiversity.

Similarly, The Gambia has defied the odds in reaching "almost sufficient" status. For a short period in 2021, it was the only country compliant with

the Paris climate agreement. Despite facing droughts and food insecurity in recent years, the Gambian government has set out an ambitious strategy to reach net-zero emissions by 2050, by creating climate-resilient food systems, preserving biodiversity, investing in human capital, shifting to a lowemissions economy, and managing its coastal zones.

Sticking to the targets set out in the Paris climate agreement is not a far-fetched dream; as the example of Bangladesh and other developing countries shows, it demands leadership and moral investment. Notably, almost two-thirds of respondents surveyed in the Global Solidarity Report concur that international bodies should have the authority to enforce agreements related to certain pressing challenges, including environmental pollution.

The trust gap is the decisive obstacle to global solidarity. When pledges are repeatedly not honoured, suspicion grows, undermining the effectiveness of the UN Framework Convention on Climate Change. There is no solidarity without trust, and no multilateralism without solidarity.

Climate change is an emergency that requires an aggressive response. The international community must act quickly to keep fossil fuels in the ground, incentivise net-zero emissions, foster innovation, and achieve a just transition. But doing so requires embracing our collective moral responsibility, rather than allowing the temptation of political and financial gain to lead us into the abyss. With our planet's fate hanging in the balance, there is only one right

If you're a parent of teenagers, you've probably reprimanded them for telling lies or being deceptive. Teens are tempted to lie about all sorts of things, such as what they were watching on their phones, whether they completed their homework, or whom they were hanging out with after school.

I've had many conversations with my kids that revolved around honesty.

Me: "It's midnight. Shouldn't you be sleeping?" Teen: "Still working on my home-

work. Almost done."

Me: "Almost done? Isn't that what you said three hours ago?"

Teen: "Yes, I was almost done then, and I'm almost done now."

Me: "So you lied then, but you're telling the truth now?" Teen: "No, I exaggerated then, and I'm still exaggerating

Teaching children to be truthful is important. Telling lies can get them in trouble, especially if

now.'

they grow up to be pathological liars. Parents want their children to become honourable adults and tell only acceptable lies.

Acceptable lies are considered white lies and fall into three main categories:

1. Lies to avoid hurting other

people. When your friend gets a new hairstvle and asks you what you think, you say, "It really suits you. Perfect hairstyle for you." You don't say what you're really thinking: "Are you trying to scare away the neighbourhood dogs?" Another example of this is when someone invites you to a party and you say, "It sounds like a great time, but unfortunately I have a prior commitment." You don't tell the truth: "Sorry, but the last party you hosted was so boring, I wish I had stayed home and watched DD News.

2. Lies to get out of awkward situations. You run into an acquaintance at a store and he talks your head off. Finally, you look at your phone and

say, "I've got to go. My wife just texted me. Our house is on fire!" Okay, perhaps that's not a white lie. A white lie would be more like this: "I've got to go. I'm late for a dental appointment."

3. Lies to be polite. You and your wife meet another couple at a party and have an "okay" conversation. When you leave, you exchange phone numbers and say, "We'll have to have you over for tea sometime." What you don't say, of course, is that "sometime" means "sometime when we've run out of interesting people to invite."

Such lies are relatively harmless. They don't hurt anyone and are not self-serving. But in many other situations, lies are unacceptable and can get you in trouble. You could be fired from a job and even end up in prison. That's what happened to an Australian woman Veronica Hilda Theriault.

In 2019, she was given a 25month prison sentence after being convicted of deception, dishonesty, and abuse of public office. She had attained a position as chief information officer for South Australia's Department of the Premier and Cabinet by lying about her education and employment on her resume, and impersonating a former employer to give herself a glowing job reference. And if that isn't enough, she had used a photo of model Kate Upton in her LinkedIn profile. In other words, Theriault didn't just have a bachelor's degree in deception, she had a PhD (peak height decep-

Lying on a resume can get you in big trouble. Even so, in a recent survey conducted by ResumeLab, 70 per cent of job seekers admitted that they have lied on their resumes. That means that 30 per cent have told the truth.

But before we accept the findings of this survey, maybe we should conduct another survey to find out if they've ever lied in a survey

Unaccounted cash recovered

he Enforcement Directorate (ED) has so far recovered cash worth Rs 18.20 crore in connection with the multi-crore ration distribution case in West Bengal, sources informed. The maximum recovery has been from the two corporate entities based out of Bankura. namely AJ Agrotech and AJ Royal, where the total seized amount has been Rs 16.80 crore. The recovery was made through a massive raid and search operation conducted early this month, sources said. At the same time, the ED sleuths have recovered Rs 1.40 crore of unaccounted cash from the office of a packaged flour production and marketing entity Ankit India Limited. This corporate entity connects the ration distribution case in West Bengal with the ill-famous Bihar fodder scam.



'Kolkata's air quality not good for people

Pollution Control Board (WBPCB) told PTI that the city's annual average reading is 174 PM2.5 levels. He said Monday's reading is the combined effect of wintry conditions in the air which prevents fine particulate matters hanging in the air to rise above and creates smog in late afternoon and early morning hours. However, the Fort William air

monitoring station of WBPCB recorded an AQI of 186 PM2.5 while the station at Victoria Memorial recorded 164.

"At one point of time, the AQI was 200 PM2.5 in Maidan area," environmentalist Somendra Mohan Ghosh said quoting WBPCB figures.

On Saturday and Sunday, the Fort William and Victoria Memorial stations recorded AQI ranging between 232-248 PM2.5 as smog had enveloped the air at dawn and before dusk, the WBPCB official said.



New Delhi, Nov 7: Amid a spike in pollution levels in Delhi-NCR, the Supreme Court Tuesday directed Punjab, Haryana, Uttar Pradesh and Rajasthan to ensure crop residue burning was stopped "forthwith", saying it cannot let "people die" due to pollution.

Questioning the Delhi government's odd-even car rationing scheme, which is aimed at curbing pollution and is scheduled to be enforced in the city from November 13 to 20, the apex court asked about its effectiveness and termed it "all optics".

"I am sorry, this is complete murder of health of people, there is no other phrase I have," said Justice Sanjay Kishan Kaul, who was heading the bench which also comprised Justice Sudhanshu Dhulia. Another bench of the top court comprising Justices AS Bopanna and MM Sundresh, which was dealing with the firecrackers ban matter, clarified on Tuesday that the top court's order banning firecrackers containing barium binds every state and was not just



limited to Delhi-NCR.

The Justice Kaul-led bench also took a stern view of states trying to shift blame to one another for the pollution and observed there cannot be "political battle" all the time. While hearing a matter pertaining to the debilitating air pollution in the Delhi-National Capital Region (NCR), the bench flagged issues like crop residue burning, vehicular pollution and burning of waste in the open were the major contributors to pollution during this time of the year.

The top court is seized of a

burnt in the open in the city. On the issue of stubble burning, the counsel appearing for Punjab claimed incidents of crop residue burning have come down by 40 per cent since last year. "We want to stop all this. We

don't care how you do it. It is your business how to do it. It must stop," the bench told the counsel, adding, "You have to stop it, whether by forceful action, sometimes by incentives, some times by other actions, but you have to stop it." "We cannot let people die because of this (pollution)," the apex court said, while referring to the health related issues being faced by people due to alarming rise in pollution levels.

It said residents of Delhi have been grappling with health issues at this time of the year, year after year, because a solution to the problem has not been found. "We direct the state government of Punjab and for that matter, all other states adjacent to Delhi, which is Haryana, Rajasthan and UP ... to ensure that crop burning is stopped

Congress alleges poll code violation by PM

New Delhi, Nov 7: The Congress Tuesday claimed Prime Minister Narendra Modi's announcement of a five-year extension of the PM Garib Kalyan Anna Yojana was "blatant violation" of the model code of conduct and said the party would approach the Election Commission on the issue.

Congress general secretary Jairam Ramesh said they would be meeting the Election Commission on the issue and will seek its intervention, as the announcement was made by the prime minister during the Chhattisgarh election campaign even without the approval of the Union Cabinet.

Ramesh said the party has sought time from the Election Commission, but will also file an online complaint against the prime minister's announcement to the poll body, urging it to act against the PM. "This announcement of extension of PM Garib Kalyan Anna Yojana (PMGKAY) by five years is a



of conduct as it was made even without the approval of the Union Cabinet during the poll process," he said.

"We would certainly approach the Election Commission and have sought time from it," he said. He also clarified that the Congress was not against the scheme but was against the announcement during the poll process and in violation of the model code.

In a post on X, he also said the five-year extension is not only a recognition of the "Prime Minister's flailing image" but also of the deepening economic distress and financial pain. "A desperate Prime Minister announced a five-year extension of the PM Garib Kalyan Yojana in the midst of the Chhattisgarh election campaign. This is a blatant violation of the Model Code of Conduct. 71% turnout in first phase

Raipur, Nov 7: A high voter turnout of 71.48 per cent (provisional) was recorded in the phase 1 of Chhattisgarh Assembly elections for 20 seats Tuesday, polling for which was held in separate time slots due to security reasons amid Naxalite violence and call for a boycott, officials said.

Voting for 10 constituencies was held from 7 am to 3 pm and from 8 am to 5 pm in the remaining segments under a thick security blanket of police and paramilitary personnel in the Naxalite-hit Bastar division. The opposition BJP and ruling Congress are the main contenders for power in Chhattisgarh, where nearly 1 lakh security personnel were deployed on duty for the first phase of polls that covered 20 of the total 90 assembly

seats in the state. 'An average voter turnout of 71.48 per cent was recorded in the first phase of the Chhattisgarh elections on Tuesday. However, this figure may go up as the final data from several booths was yet to be received," a poll offi-

Of the 20 seats for which polling was held, 12 were reserved for Scheduled Tribes (STs). A total of 223 candidates, including 25 women, were in the fray and as per electoral rolls, 40, 78,681 voters were eligible to exercise their franchise in the first phase. After the end of voting, the electoral fate of former chief minister and BJP leader Raman Singh, Chhattisgarh Congress president and MP Deepak Baij, and at least three ministers in the Bhupesh Baghel cabinet was locked in Electronic Voting Machines (EVMs). Incidents of violence were reported from Sukma, Narayanpur, Bijapur and Kanker districts.

Four security personnel were injured in an encounter with Naxalites in the Chintagufa police station area of Sukma district, while a CRPF commando sustained injuries in an IED blast near Tondamarka camp in the same district during separate area domination operations to ensure security during

the polls, police said. Exchanges of fire also took place between Naxalites and security personnel -- one each in Narayanpur, Bijapur and

Kanker districts. However, no harm was reported to security personnel in those incidents, police said.

The Congress, which is seeking a second term in office, and the opposition BJP, which ruled the state for 15 years before it was voted out in 2018, are the main contenders for power. Women voters outnumbered men in the seats covered under the first phase of polling.

Bangalore, Nov 7: ISRO's maiden solar mission, Aditya L1, has captured its first highenergy X-ray glimpse of solar

During its first observation period from approximately October 29, the High Energy L1 Orbiting X-ray Spectrometer (HEL1OS) on board Aditva-L1 spacecraft has recorded the impulsive phase of solar flares, the space agency said in a statement Tuesday.

A solar flare is a sudden bright ening of solar atmosphere. The recorded data is consistent with the X-ray light curves provided by National Oceanic and Atmospheric Administration's Geostationary (NOAA) Operational Environmental Satellites (GOES).

"Commissioned on October 27. 2023. HEL1OS is currently undergoing fine-tuning of thresholds and calibration operations. The instrument is set to monitor the Sun's high-energy X-ray activity with fast timing and high-resolution spectra," it said.

HEL1OS data enables researchers to study explosive energy release and electron acceleration during impulsive phases of solar flares. HEL1OS was developed by the Space Astronomy Group of the UR Rao Satellite Centre, ISRO, Bengaluru, the

agency added. HEL1OS, the hard X-ray spectrometer on Aditya-L1 Solar Mission by ISRO, is the harbinger of flaring activities on the Sun, with the ability to capture the early impulsive phase of the

Patna, Nov 7: More than a third of families in Bihar are making do with an income of ₹200 or less a day, while the number of SC-ST families living on similar earnings is nearly 43 per cent, according to the Caste Survey report tabled in the state assembly Tuesday.

According to the report, the state is home to about 2.97 crore families out of which more than 94 lakh (34.13 per cent) live on an income of ₹6.000 or less a month. Parliamentary Affairs Minister Vijay Kumar Chaudhary who tabled the report said the literacy rate has risen from 69.8 per cent as per the 2011 census to 79.8 per cent.

The percentage of households who live on less than ₹6,000 a month or less than ₹200 a day among the Scheduled tribe households (42.91 per cent) was almost the same as among scheduled caste households (42.78 per cent). Chaudhary tabled the detailed

report, preliminary findings of which were made public on October 2, in presence of Chief Minister Nitish Kumar and Deputy CM Tejashwi Yadav, among others. Chaudhary termed the exercise as "historic" and vouched for the figures being "authentic", denying allegations levelled by the opposition BJP that numbers had been "manipulated" to politically suit the ruling Mahagathbandhan coalition.

'We must remember that a rise in the population percentage of a caste does not amount to an achievement. Similarly, a fall in the percentage does not mean a loss," said the minister, who also voiced displeasure over litigations trying to challenge the survey on various grounds, even though the Supreme Court had found the exercise to be "perfectly valid"

He also took the occasion to recall that the exercise followed

the Centre's reluctance to undertake a caste survey, notwithstanding two unanimous resolutions passed by the legislature to press the demand and an inperson request made to Prime Minister Narendra Modi, by an all-party delegation led by the

chief minister. The state has also improved its sex ratio from 918 to 953 women per 1,000 men, said the minister. The report has also come out with several other important findings like more than 50 lakh people of Bihar are living outside the state in search of livelihood or better education opportunities.

Those earning a living in other states numbered around 46 lakh, while another 2.17 lakh have found greener pastures abroad. Those pursuing studies in other states numbered about 5.52 lakh while about 27,000 were doing the same in foreign countries.

Supreme Court bats for press freedom

New Delhi, Nov 7: The Supreme Court Tuesday asked the Centre to put in place guidelines on seizure of electronic devices like phones and laptops of individuals, particularly media professionals, while terming it a serious matter.

A bench of Justices Sanjay Kishan Kaul and Sudhanshu Dhulia conveyed their concern to Additional Solicitor General (ASG) S V Raju, who was representing the Centre, about the sweeping powers of probe agen-

"Mr Raju, I find it very difficult to accept that some kind of an allwithin power which the agencies have, this is very, very dangerous I think," Justice Kaul observed. The bench was hearing two petitions, including the one filed by 'Foundation For Media Professionals', seeking comprehensive guidelines for search and seizure of digital devices by the investigating agencies.



The counsel, appearing for one of the petitioners, said the issue raised was of seminal importance as there were no guidelines with regard to when and how will the probe agencies seize electronic devices

Raju said complicated legal issues have been raised in the matter and he needed some time to prepare for it. He said there are individuals who are serial offenders or anti-national elements who may conceal material data and therefore, some balance was required.

"The problem is, these are media professionals. They will have their own sources and other aspects. This is a serious matter," the bench said, adding, "Now, if you just take everything away, there is a problem".

"There must be some guidelines," the court said. Raju said several legal issues involved in the matter and he would examine these aspects."I think it is time for vou people to do it vourself to ensure that it is not misused. It can't be a state which runs only through its agencies. It cannot be done," the bench said.

The bench told Raju the gov ernment must analyse what kind of guidelines are necessary to protect the interest of both sides and they cannot be adversarial in that sense. The petitioner's counsel raised the issue about the state's power and an individual's rights, including the right to privacy. He said nowadays, probe agencies can compel individuals to provide their biometric information, a practice adopted by all political dispensations. The bench noted that Raju has requested for some time to better examine the matter so he can make submissions.

"We have, however, put to the ASG that there has to be a balancing of interest and proper guidelines need to be in place to protect the interests of the media professionals. We would like the ASG to work on this and come back to us on this issue," the bench said, while posting the matter for further hearing in December.

Govt advisory to social media cos

New Delhi, Nov 7: The Centre has issued an advisory to major social media companies to identify misinformation, deepfakes and other content that violates rules and remove those within 36 hours after being reported to them, an official statement said Tuesday.

The development comes after a deepfake video of actress Rashmika Mandanna was found circulating on social media platforms earning criticism from several politicians and celebrities. Netizens claimed the video has been morphed and the actual video is of an Indian-origin person living in the UK.

"The Centre today issued an advisory to the significant social media intermediaries to ensure that due diligence is exercised and reasonable efforts are made to identify misinformation and deepfakes, and in particular, information that violates the pro-

visions of rules and regulations and/or user agreements," the Ministry of Electronics and IT

(Meity) said in a statement. Meity in the advisory has directed that social media companies expeditiously take action against the content that is in violation of the rules and regulations well within the timeframes stipulated under the IT Rules 2021, and users are caused not to host such information, content, deepfakes.

"Remove any such content when reported within 36 hours of such reporting and ensure expeditious action, well within the timeframes stipulated under the IT Rules 2021, and disable access to the content or information." the statement said. In case of impersonation in an electronic form, including artificially morphed images of an individual, social media companies have been advised to take action within 24 hours from the receipt of a complaint in relation to any content.

ing the disease when it has been detected in postmenopausal women and now we can use it to stop it developing at all in some women," he said.

Around 289,000 women at moderate or high risk of breast drug, and while not all will choose to take it, it is estimated that if 25 per cent do, around 2,000 cases of breast cancer could potentially be prevented in England, while saving the NHS around GBP 15 million in treatment costs. "This is the first drug to be repurposed though a world-leading new programme to help us realise the full potential of existing medicines in new uses to save and improve more lives on the NHS. Thanks to this initiative. we hope that greater access to anastrozole could enable more women to take risk-reducing

steps if they'd like to, helping them live without fear of breast cancer," said NHS chief executive Amanda Pritchard

The treatment is taken as a 1mg tablet, once a day for five years. Anastrozole is an aromatase inhibitor, which works by cutting down the amount of the hormone oestrogen that a patient's body makes by blocking an enzyme called "aromatase"

The most common side effects of the medicine are hot flushes, feeling weak, pain/stiff-

ness in the joints, arthritis, skin rash, nausea, headache, osteoporosis, and depression.

Israel gave civilians still trapped inside freshly encircled Gaza City a four-hour window to leave Tuesday and escaping residents said they passed tanks in position to storm it

Khan Younis (Gaza Strip), Nov 7: Israel will take "overall security responsibility" in Gaza indefinitely after its war with Hamas, Prime Minister Benjamin Netanyahu said, the clearest indication yet that Israel plans to maintain control over the coastal enclave one month into a conflict that has claimed thousands of lives and levelled whole swaths of the territory.

In an interview with ABC News that aired late Monday, Netanyahu expressed openness to "little pauses" in the fighting to facilitate the delivery of aid to Gaza or the release of some of the more than 240 hostages seized by Hamas in its Oct 7 attack into Israel that triggered the war. But he ruled out any general ceasefire without the release of all the hostages, and the White House said there was no agreement on US President Joe Biden's call for a broader humanitarian pause after a phone call between the leaders. The war has come at a

staggering cost. Airstrikes have reduced entire city blocks to rubble, and around 70% of Gaza's 2.3 million people have fled their homes, with many heeding Israeli orders to head to the southern

JAPAN AND UK **VOW DEEPER SECURITY TIES**

Tokyo, Nov 7: Japanese and British foreign and defense ministers met Tuesday and agreed to further deepen military cooperation under a new security pact that allows their militaries to enter each other's territory for joint exercises.

Japan and Britain have expanded their cooperation in recent years as concern has grown over China's increasing influence. Japan, whose only treaty ally is the United States, has signed Reciprocal Access Agreements with Australia and the UK, making them semi-allies.

The talks in Tokyo among Japanese Foreign Minister Yoko Kamikawa and Defense Minister Minoru Kihara and British Foreign Secretary James Cleverly and Defense Secretary Grant Shapps are the first since the RAA took effect in mid-October.

They met on the sidelines of a gathering of foreign ministers from the Group of Seven industrialized nations on Tuesday and Wednesday that is expected to focus on the Israel-Hamas war, the Russia-Ukraine war and tension in the Indo-Pacific region.

Later Tuesday, Shapps told several selected journalists, including from The Associated Press, that the reason for their meeting is to show in the Indo-Pacific "that despite what's going on in Europe, and despite what's going on in the Middle East, we are still here today, and that I think shows enduring strength of our relationship with Japan"

The four ministers agreed to expand their joint exercises. including the annual Japan-UK joint exercise, Vigilant Isles 23, starting later this month, according to a joint statement issued after their talks. They also agreed on using the RAA to realise an "even more ambitious programme of more frequent and complex exercises" than before.

NATO suspends key Cold War-Era treaty

Brussels, Nov 7: NATO member countries that signed a froze their participation in the pact Tuesday just hours after Russia pulled out, raising fresh questions about the future of arms control agreements in Europe.

Many of NATO's 31 allies are parties to the Treaty of Conventional Armed Forces in Europe, which was aimed at preventing Cold War rivals from massing forces at or near their mutual borders. The CFE was signed in November 1990 as the Soviet bloc was crumbling but was not fully ratified until two years later.

NATO said that Tuesday's action by its signatory members was required because "a situation whereby Allied State Parties abide by the Treaty, while Russia does not, would be unsustain-



able". Earlier in the day, Moscow said it had finalised its withdrawal from the treaty. The long-expected move, which the Kremlin blamed in part on NATO's continued expansion closer to Russia's borders, came after lawmakers in Moscow approved a bill proposed by President Vladimir Putin denouncing the CFE.

US National Security Adviser Jake Sullivan said suspending the obligations by Washington and its allies will strengthen NATO's "deterrence and defense capacity by removing restrictions that

impact planning, deployments, and exercises - restrictions that no longer bind Russia after Moscow's withdrawal". Russia's actions "further demonstrates Moscow's continued disregard for arms control," he added.

The German Foreign Ministry underscored that Berlin and its allies are not pulling out of the treaty.

"In the case of a fundamental change in Russia's behaviour, a renewed implementation of the

CFE remains possible," it said. The ministry said Germany intends to stick to the national limits for weapons systems in the treaty. It criticised Moscow's withdrawal, saying that "Russia is destroying another pillar of our European security and arms

control architecture. "Securing a balanced conventional potential of forces in Europe cannot be realised without the involvement of

It is thought to be the largest partnership of China's Belt and Road Initiative (BRI). It increased to over \$62 billion over time, and at least \$ 25 billion was invested in cash-strapped

With a 9.84-year maturity and a 3.74year grace period, the average interest rate on loans is 3.72 per cent, the AidData said.

Stating that "Pakistan and China have a long history of economic collaboration, and this year marks ten years of such ties and it has helped Pakistan through all of its tough economic downturns and crises," the report pointed out that "(But) it's worrying that Chinese lessthan-generous loans coupled with Pakistan's mismanagement have made Pakistan's debt load even higher."

AidData estimates that Pakistan's outstanding public and publicly guaranteed debt to China stands at \$67.22 billion, which is 19.6 per cent of the GDP, and \$ 21.2 billion more than what Pakistan has officially reported to the World Bank's Debtor Reporting System, the media report said.

Quoting Dr Ammar A. Malik, who is a senior research scientist at AidData, the newspaper said, "In terms of the composition of debt from China, since 2018 China has pivoted away from infrastructure lending toward emergency lending in Pakistan, ensuring that the earlier debts taken on by Pakistan for energy, transport, and other CPEC projects can be repaid on time and with interest.



Day without internet would cost \$43bn globally: Report

INDIA LOST \$184.3 MILLION AS A RESULT OF GOVERNMENT-IMPOSED BLACKOUTS **THAT PREVENTED MORE THAN 120 MILLION PEOPLE** FROM ACCESSING THE INTERNET

INDO-ASIAN NEWS SERVICE

New Delhi, Nov 7: If the internet goes down globally for even just a single day, it would cost \$43 billion, with the US and China making up almost half of the sum together, which is \$21 billion, a new report has said.

According to the VPN service provider AtlasVPN, if an internet outage occurs just for a single day, the US would alone face huge losses of around \$11 billion. China is estimated to lose nearly \$10 billion.

The UK would lose around \$3 billion, and Japan is expected to lose approximately \$2.7 billion. An internet outage in Germany will likely cost up to \$1.5 billion.

Countries with Oceanic islands like Tuvalu, Kiribati,



Marshall Islands, Nauru, and Micronesia would experience the least financial losses if the internet shut down for a day. Specifically, these countries would not lose more than \$50K. the report said.

Russia topped the list of losses in 2022, with an estimated \$21.59 billion in income lost over 7,407 hours of blackouts that affected more than three-quarters of the country's population, according to the report by Top10VPN.

India lost \$184.3 million as a result of government-imposed blackouts that prevented more than 120 million people from accessing the internet.

Iran, Kazakhstan, Myanmar, and Uzbekistan were among the other countries that suffered the biggest losses due to internet outages in 2022.

Overall, internet shutdowns by the government globally cost \$24.6 billion in 2022, up 337 per cent from 2021.

FMCG sector sees 9% growth on rural revival: NielsenIQ

New Delhi, Nov 7: The FMCG industry in India had an overall 8.6 per cent volume growth in September quarter, helped by higher consumption as the inflationary pressure eased, according to a report by data analytics firm NielsenIQ.

With correction in prices, the FMCG industry logged 9 per cent growth in value terms in July-September(Q3), reducing from the preceding quarters, it added.

When inflation was at a record high, the FMCG industry had a high price-led growth in the last 5-6 quarters, though the volume was under stress. However, the trend has started reversing with the cooling of commodity prices.

Besides, the rural market,



which has been facing a consumption slowdown for the last several quarters, is showing signs of recovery, while the urban market is maintaining a 'stable rate of growth', said the latest NielsenIQ's FMCG Quarterly snapshot.

Smaller-sized packs are having higher offtake in the rural market, while in urban markets average pack sizes turn positive, though there is a continued preference towards larger packs, it added.

"The FMCG industry has witnessed a further reduction in price growth from last quarter and has given a necessary impetus to the spending power of the consumer, this is evident in rural markets in particular where there is an uptick in consumption across categories," said NIQ India Managing Director Satish Pillai.

Overall, factors such as "cooling of inflation in the country fuelled by base effects; a recent decline in unemployment figures, and LPG prices" among others have contributed to the willingness of the consumer to spend, he added.

The consumption gr FMCG is led by both food and non-food sectors, though food baskets have a higher contri-

"In Q3 2023, the food sector growth was at a rate of 8.7 per cent compared to the same period last year, up from 8.5 per cent in Q2 2023. Similarly, the non-food sector exhibited growth at a rate of 8.7 per cent in Q3 2023 versus YA, a significant increase from the 5.4 per cent seen in Q2 2023," it said.

In food, the growth is primarily driven by products falling under the impulse category like salty snacks, chocolates and confectionery and habit-forming such as biscuits, tea, coffee. Within the non-food categories, this improvement can be attributed to an increase in rural consumption growth, with a growth rate of 6.7 per cent in

San Francisco, Nov 7: WeWork, the SoftBank Group-backed startup whose meteoric rise and fall reshaped the office sector globally, sought US bankruptcy protection Monday after its bets on companies using more of its office-sharing space soured.

The move represents an admission by SoftBank, the Japanese technology group that owns about 60% of WeWork and has invested billions of dollars in its turnaround, that the company cannot survive unless it renegotiates its pricey leases in bankruptcy.

A WeWork spokesperson said about 92% of the company's lenders had agreed to convert their secured debt into equity under a restructuring support agreement, wiping out about \$3 billion of debt.

The company, which also intends to file recognition proceedings in Canada, said it expected to have the financial liquidity to continue business normally and that its locations outside of the US and Canada. as well as its franchisees around

the world, were not affected by these proceedings. WeWork had office space avail-

able at 777 locations worldwide as of the end of June. SoftBank said it believed WeWork's restructuring support agreement was the appropriate action for the company to reorganize its business and emerge from Chapter 11 proceedings.

"SoftBank will continue to act in the best long-term interests of our investors," the Japanese company said in a statement

WeWork shares have fallen about 98.5% so far this year.

Profitability has remained elusive, as WeWork grapples with expensive leases and corporate clients cancelling because of a trend toward employees working from home. Paying for space consumed 74% of ŴeWork's revenue in the second quarter of 2023, the last time it reported financial results.

In a filing with the New Jersey bankruptcy court, WeWork listed assets of \$15.06 billion and liabilities of \$18.66 billion as of June 30.

"WeWork could use provisions of the US bankruptcy code to rid itself of onerous leases," law firm Cadwalader, Wickersham & Taft LLP said in a note to landlords on its website in August. Some landlords are bracing for a significant impact.

"As part of today's filing, WeWork is requesting the ability to reject the leases of certain locations, which are largely nonoperational, and all affected members have received advanced notice," the company said in a statement.

Under its founder Adam Neumann, WeWork grew to be the most valuable US startup worth \$47 billion. It attracted investments from blue-chip investors, including SoftBank and venture capital firm Benchmark, as well as the backing of major-Wall Street Banks, including JPMorgan Chase.

Cancun (Mexico), Nov 7: Right after relinquishing the No.1 ranking two months ago, Iga Swiatek couldn't help but worry about trying to regain it. "It's hard not to think about stuff like that," she explained.

And then Swiatek realized it was better to set that sort of thing aside and, instead, simply focus on playing her best tennis — and her best is better than anyone else's at the moment. Swiatek earned her first WTA Finals title and clinched the year-end No.1 ranking by overwhelming Jessica Pegula 6-1, 6-0 Monday in the latest in a series of dominant performances.

Swiatek, a 22-year-old from Poland, is now the youngest WTA Finals champion since Petra Kvitova was 21 in 2011. Swiatek went 5-0 at the tour's season-closing championship, winning all 10 sets she played and ceding a total of just 20 games. That's the fewest by the winner at the event for the top eight women in tennis since the roundrobin format returned in 2003.

Swiatek extended her winning streak to 11 matches and improved to 68-11 in 2023 with six trophies, including her fourth career Grand Slam title at the French Open in June

This victory allows Swiatek to return to No.1, a spot she held from April 2022 until this September, when Aryna Sabalenka overtook her after the US Open.

Swiatek claims WTA Jackson hat-trick ends Spurs' unbeaten run

London, Nov 7: Tottenham's players lost their heads and the remaining unbeaten record in the English Premier League. A late hat-trick by Nicolas Jackson sealed a 4-1 victory for Chelsea in a chaotic London derby Monday featuring two red cards—to Spurs defenders Cristian Romero and Destiny Udogie - five disallowed goals and a maverick tactical approach by Spurs manager Ange Postecoglou in his unlikely bid to survive with nine men.

Jackson broke the resistance of Tottenham with his three goals from the 75th minute, settling a frantic game that defied logic at times as hosts survived for a while despite playing a high defensive line following the sending-offs of Romero in

the 33rd and Udogie in the 55th. Dejan Kulusevski gave the hosts a flying start by scoring off a deflected shot in the sixth minute, only for the derby to turn fiery amid a blaze of wild challenges and crazy incidents.

DESPERATE LOOKS: Spurs goalie Guglielmo Vicario looks haplessly as Nicolas Jackson strikes into an empty net for his hat-trick, Monday Amidst all the madness, Cole Palmer equalised from the spot after Romero conceded a penalty - and earned a fourth red card in 21/2 years at Tottenham — for a dangerous lunge on Argentina teammate Enzo Fernandez. Postecoglou had no regrets regarding his tactics while his team were down to nine men, saving: "It is just who we are. It is who we are and who we will be for as long as I am here. If we go down to five men, we will have a crack.'

It left Manchester City, the defending champion, a point clear of second-placed Spurs after an 11th round of games that saw Liverpool and Arsenal, the other teams in the top four, also fail to win.

The first half, in particular, was mayhem. Aside from the two goals and the red card to Romero, there were four disallowed goals, game-ending injuries to Spurs lads James Maddison and Micky van de Ven, yellow cards to Postecoglou for complaining and Udogie for a flying two-footed lunge, a freefor-all sparked by a scuffle between Chelsea's Levi Colwill and Tottenham's Pape Sarr, and 12 minutes of stoppage time.
