## India appeals to Qatar

New Delhi, Nov 9: The Centre has already filed an appeal with Qatar over the death penalty to eight former Navy personnel. The eight were arrested in August last year for reasons still not known and sentenced last month. External Affairs Ministry spokesperson Arindam Bagchi said Thursday here that the government has 'already filed an appeal'.

The Qatari government has said that the eight were involved in 'espionage' and supplying in-

formation to Israel. The Indian government had earlier said it is 'deeply shocked by the verdict'.

Bagchi meanwhile said that the case details still remain unavailable. "The judgement is confidential... has only been shared with the legal team. We are now pursuing further legal steps," he was quoted as saying

by 'NDTV'.
"We are constantly in touch with the family (of the eight

Naval officers). We will continue to extend all possible legal and consular support," Bagchi stressed. He also cautioned the media against speculation in this sensitive matter as it could harm the Indians behind bars. "Consular access to the eight was last provided Tuesday, Bagchi added.

The eight ex-Navy officers include decorated individuals who once commanded major Indian warships. They were working for Dahra Global Technologies and Consultancy Services

## Fix netas' cases fast

PRIORITY SHOULD BE GIVEN TO DISPOSAL OF CRIMINAL CASES AGAINST MPS, MLAS PUNISHABLE WITH DEATH OR LIFE SENTENCES, SAYS SUPREME COURT

New Delhi, Nov 9: In a significant verdict aimed at fast-tracking trial in more than 5,000 criminal cases against lawmakers, the Supreme Court directed Thursday high courts to set up a special bench to monitor cases for their speedy disposal. It also asked these special courts not to adjourn proceedings in such matters except 'for rare and compelling reasons'.

Issuing a slew of directions to high courts, district judges and special courts designated to hear matters related to lawmakers, the top court directed that criminal cases against members of Parliament, Legislative Assemblies and Legislative Councils be given priority.

"The learned Chief Justice of the High Court shall register a suo motu case titled as 'In Re Designated Courts for MPs/MLAs' to monitor early disposal of criminal cases pending against the Members of Parliament and Legislative Assemblies," said one of the directions passed by the bench of Chief Justice DY Chandrachud and Justices JB Pardiwala and Manoj Misra.

Plea has sought life ban on politicians convicted in criminal cases

"Under Article 227 of the Constitution, the high courts are entrusted with the power of superintendence over the subordinate judiciary. We deem it appropriate to leave it to the high courts to evolve a method for effective monitoring of the subject cases," the bench added.

The suo motu (on its own) case may be heard by a special bench presided by the chief justice (of the high court) or judges assigned by him to the special bench that may list matters at regular intervals as felt necessary, the SC bench said.

"The designated court shall give priority, to criminal cases against MPs and MLAs punishable with death or life imprisonment, then to the cases punishable with imprisonment for five years or more. The special courts shall not adjourn the cases except 'for rare and compelling reasons'," the bench added in its directions.

Disposing of one of the aspects of the PIL relating to ensuring speedy trial of criminal cases against politicians, the bench kept the plea, filed by Ashwini Upadhyay through lawyer Ashwani Dubey, pending to deal with other aspects related to decriminalisation of polity in the country.

Besides seeking early disposal of criminal cases against politicians, the petition has sought a life term ban on politicians upon conviction in criminal cases and setting up of special courts for this purpose in the country.

### Mentally-challenged woman sexually assaulted, man held

Nayagarh, Nov 9: A 35-year-old mentally-challenged woman was allegedly raped by a man in an area under Itamati police limits in Navagarh district, late Wednesday night. The accused identified as Suryakant Mohanty, 24, alias Panda a resident of Baunshiapada village has been arrested, police said Thursday. Police began probing the incident after the mother of the victim lodged a written complaint at the Itamati police station.

The incident occurred Wednesday night when the survivor was sleeping on the balcony of a house in the village. Locals and family members spotted the victim writhing in agony and lying in a pool of blood. They rushed her to the district headquarters hospital here Wednesday night. Currently she is in stable condition after undergoing treatment, her mother said Thursday.

Sources stated that the woman had been stabbed also, but there was no official confirmation from the hospital or from the police officials. According to the victim's mother, her daughter was mentally stable when she got married. However, she lost her mental balance after being abandoned by her husband.

Locals pointed out that due to her mental imbalance, the victim rarely stayed at her parental place. She used to wander aimlessly around the village. Taking advantage of the fact that she was sleeping alone on the balcony of a house, the accused raped her. Police zeroed in on Panda after the victim went on repeating his name constantly after the assault.

IIC of Itamati police station, Dilip Swain said a medical examination was conducted on the survivor Thursday and the report confirmed she has been raped. Medical examination of the accused will be done Friday after which he will be produced in court, he added. Sources meanwhile said that Panda has confessed







# ₹2,500 crore shot in the arm for millet farmers

Bhubaneswar, Nov 9: Chief Minister Naveen Patnaik Thursday said his government is investing over ₹2,500 crore for providing income and livelihood support to millet farmers of the state.

The state government recently

launched the Odisha Millets Mission in 2017 with a focus on reviving an ecosystem of the cereal.

For the government, the promotion of millets is about justice and equity to rain-fed farmers of Odisha, Patnaik said.

The authorities have increased the direct benefit incentives for millet farmers and laid out assured procurement of ragi (millet), he said after inaugurating a two-day International Convention on Millets here.

Odisha is the "pioneer in designing a people-centric Millet Mission with focus on livelihood and nutrition of tribal communities", he said.

"My government will put all the efforts to make Odisha a centre of excellence on millet and contribute to economic growth, wellbeing and health of the people of Odisha." Patnaik said.

Noting that the United Nations has declared 2023 as the

International Year of Millets, he stressed that Odisha is the first state to organise such an international convention involving all the stakeholders. The Chief Minister praised

the role of Mission Shakti women self-help groups (SHGs) in the millet value chain. Under the brand of Millet

Shakti, these SHGs have shown the world how millet-based enterprises can play an important role in improving livelihoods. Patnaik hoped that a roadmap

for millets for the future would be prepared at the convention. On this occasion, he awarded Sundargarh, Koraput, Rayagada and Nuapada for best production district in millets. He also felicitated five millet farmers for achieving exceptional success in production.

Speaking on the occasion, Agriculture & Farmers' Empowerment Minister Ranendra Pratap Swain said millets are cultivated in 177 blocks of the state and Mission Shakti women are leading farming and processing of the cereal.

After the bumper production, the next big challenge was to market it, he said, adding that Odisha started a procurement regime to buy back millets at a minimum support price.

From a mere procurement of about 17,000 quintals in 2018-19, it has now increased to over 6 lakh quintals in just four years.

Officials were directed to include millet in the public distribution system and mid-day meal programme at Anganwadi centres. These steps increased the adaptability of millets as a diet by choice, the minister said, adding, "We are working with many schools, hospitals, health centres and hotels to include millet-based diet in their food."

Union Agriculture Secretary Manoj Ahuja said that Odisha Millets Mission is not just a success in Odisha and India, it has also created a buzz across the globe.

Indian Council of Agricultural Research (ICAR) Director General Himansu Pathak said ICAR has developed 125 varieties of nine millets in last five years and it will provide support for the growth of the cereal.

Food and Agriculture Organisation (FAO) representative in India, Takayuki Hagiwara said that India and Odisha are champions of millets.

### Yoga may help reduce frequency of seizures

YOGA MAY NOT ONLY
HELP REDUCE STIGMA
ASSOCIATED WITH
EPILEPSY, BUT ALSO
IMPROVE QUALITY
OF LIFE AND
MINDFULNESS

Ror people with epilepsy, doing yoga may help reduce feelings of stigma about the disease along with reducing seizure frequency and anxiety, claims new research.

The study, published in the journal Neurology, involved a small group of 160 people with epilepsy who had an average of one seizure per week and on average took at least two antiseizure medications and faced

"People with epilepsy often face a stigma that can cause them to feel different than others due to their own health condition and that can have a significant impact on their quality of life," said Manjari Tripathi, from the All India Institute of Medical Sciences (AIIMS) in New Delhi.

"This stigma can affect a person's life in many ways, including treatment, emergency department visits and poor mental health. Our study showed that doing yoga can alleviate the burden of epilepsy and improve the overall quality of life by reducing this perceived stigma," she added.


In the study, the researchers randomly assigned participants to receive yoga therapy or sham yoga therapy. Yoga therapy included exercises in loosening muscles, breathing, meditation and positive affirmations.

Sham yoga consisted of exercises that mimic the same yoga exercises, but participants were not given instructions on slow and synchronised breathing, and attention to the body move-

ments and sensations during

The results revealed that those who did yoga were more than four times as likely to have more than a 50 per cent reduction in their seizure frequency after six months than the people who did sham yoga.

In addition, people who did yoga were more than seven times more likely to no longer have



seizures than those who did Sham yoga. Researchers found when compared to people who did Sham yoga, people who did yoga were more likely to reduce their

perceived stigma of the disease.

There was also a significant decrease in anxiety symptoms for people who did yoga versus people who did not. They saw improvements in quality of life measures and mindfulness.

"These study findings elevate the need to consider alternative therapies and activities for people with epilepsy facing stigma," said Tripathi.

"Yoga may not only help reduce stigma, but also improve quality of life and mindfulness. Plus, yoga can be easily prerecorded and shared with patients online using minimal re-

sources and costs," she added.
However, a limitation of the study was that participants self-reported their seizure frequency and they may not have remembered all the information accurately, the team said. IANS

Allograft is a tissue that is transplanted from a donor of the same species as the recipient, but not genetically identical.

The two children - six-vearold Shravani Mallick of Kesura area here and seven-year-old Suryakant of Puri suffered severe burn injuries after they

a gap of a month. They were later released, an official of the hospital said. Shravani underwent long treat-

here and then at the SCB Medical College and Hospital in Cuttack but the doctors had lost all hopes of saving her. Her family then took her to the

Burns Centre at AIIMS, Bhubaneswar, where allograft was conducted and Shravani recovered.

Sharavani's mother Runulata Mallick said, "The doctors in Cuttack told us that it was difficult to save her. She was treated at AIIMS and recovered."

Similarly, Suryakant, who had sustained burn injuries all over his body except his face was admitted at the district headquarters hospital in Puri but the doctors could not assure him complete recovery. He too was taken to AIIMS, Bhubaneswar, where he

recovered after allograft. "I had lost all hope for my son. I left his fate to Lord Jagannath. He is now doing well. The AIIMS doctors are like Gods," said Pratima Swain, the mother of

## 1 in 3 deaths from skin cancer due to working under the sun

**7** orking under the sun is leading to nearly 1 in 3 deaths from nonmelanoma skin cancer, according to joint estimates by the World Health Organization (WHO) and the International Labour Organization (ILO).

The research released in the Environment International finds that outdoor workers carry a large and increasing burden of nonmelanoma skin cancer and calls for action to prevent this serious workplace hazard and the loss of workers' lives it causes

According to the joint estimates, 1.6 billion people of working age (15 years or older) were exposed to solar ultraviolet radiation while working outdoors in 2019, equivalent to 28 per cent of all working-age people.

In the same year, almost 18,960 people in 183 countries died from non-melanoma skin cancer due to having worked outdoors in the sun. The number increased by 88 per cent - from 10,088 deaths

The estimates establish occupational exposure to solar ultraviolet radiation as the third highest attributable burden of cancer deaths globally, behind only asbestos and silica dust.

"Unprotected exposure to solar ultraviolet radiation at work is a major cause of occupational skin cancer," said Dr Tedros Adhanom Ghebreyesus, WHO



Director-General, in a statement. "But there are effective solutions to protect workers from the sun's harmful rays, and prevent their deadly effects," he

The WHO called for more action to protect workers from hazardous outdoor work in the sunlight. As skin cancer develops after years or even decades of exposure, workers must be protected from solar ultraviolet radiation at work from young working age onwards.

Governments should establish, implement and enforce policies and regulations that protect outdoor workers from sun-induced skin cancer by providing shade, shifting working hours away from the solar noon. providing education and training, and equipping workers with sunscreen and personal protective clothing (such as broadbrimmed hat, long-sleeved shirts

and long trousers), the UN health body said.

"Death caused by unprotected exposure to solar ultraviolet radiation while working is largely preventable through cost-effective measures. ## Maize farmers at a loss as AP traders make hay

Pottangi, Nov 9: Scores of farmers in Pottangi block under Koraput district have taken up maize cultivation to earn a livelihood. However, they are not benefitting much from the crop. Due to lack of marketing facilities, the farmers are having a harrowing time to sell their produce.

The farmers' loss has proved to be a boon for the traders in neighbouring Andhra Pradesh as they cash in on their helplessness. In a hurry to dispose of their harvest, farmers are forced to sell off their produce at throwaway prices to the Andhra traders

Sources said that farmers in Ralegada, Sunki, Peturu, Ampabali, Sambai and Talagolur panchayats under Pottangi block are into maize cultivation. Like previous years, they have again cultivated maize this year. However, in the absence of marketing facilities in the area, the farmers are forced to resort to distress sale.

Taking advantage of the situation, Andhra traders are visiting the villages and buying the harvested maize from them at ₹10 to ₹15 per kg which is significantly lower than the Minimum Support Price (MSP) of ₹1,850 per quintal. Resultant losses have left the farmers unable to meet even their daily household expenses, let alone any

### Patrolling begins along Ganjam coast to safeguard Olive Ridleys

PNN & AGENCIES

Berhampur, Nov 9: Patrolling was started along the coast in Ganjam district to check illegal fishing after a seven-month ban was imposed to protect Olive Ridley turtles, ahead of their mating season, officials said Thursday.

The fishing ban was imposed November 1, and will continue till May 31, 2024,

they said. "We have started sea patrolling to check fishing activities in the prohibited areas." said Sunny Khokkar, the divisional forest officer (DFO) of Berhampur. The sea was being patrolled with four vessels, including two speed



boats, he said.

The Olive Ridley turtles usually visit the beaches during November, and start mating in December and January, before the mass nesting, which begins in the last week of February and continues till the sec-

ond week of March. The confluence of the Rushikulya river and the Bay of Bengal in Ganjam district is the second biggest rookery for Olive Ridley turtles after Gahirmatha

in Kendrapara district. A record 6.37 lakh turtles had laid eggs on a threekm-long stretch between Podampeta and Bateshwar in February-March this year.

The Forest department has decided to set up at least 11 camps for its personnel who will secure the beach, and clean it to facilitate the nesting,

officials said. "We are sensitising the fishermen about the ban

on fishing with the help of local volunteers," said Sidhartha Sahu, the range officer of Khallikote.

Additional Fisheries Officer (Marine) Subrat Patnaik said the government would provide ₹15,000 to the families of every fisherman affected by the ban.

A total of 3,638 families of nine villages depend on fishing for their livelihood, he said.

Odisha Traditional Fish Workers' Union general secretary K Alleya said women associated with fishing, such as selling and transportation, should also be compensated as they too were affected by the ban.

#### **Economic Nationalism**

ith the United States leading the way, the world seems to be entering a new era of economic nationalism, as many countries prioritise their domestic social, economic, and environmental agendas over free trade and multilateralism. While President Joe Biden's approach is more measured and open to international cooperation than Donald Trump's was, it nonetheless raises concerns among economic liberals, who see echoes of a 1930s-style return to protectionism

But "economic nationalism" is one of those scare terms that economic liberals use to discredit practices they don't like. As with any ideologically loaded label, it hides more than it reveals. After all, economic nationalism comes in many different forms, some harmful and some beneficial. Moreover, some of the leading theorists of economic nationalism, such as Alexander Hamilton and Friedrich List, were political liberals.

Though economic nationalism can backfire when taken to extremes, so can economic liberalism. When applied judiciously in pursuit of legitimate domestic goals - such as building economic strength and reinforcing a sense of national purpose – it can be beneficial without necessarily harming other countries

Economic nationalism frames the economy primarily in terms of the nation, much like political nationalism does with the polity. The economy exists primarily to serve the nation, just as the nation-state pursues the national interest.

Neither formulation has much content until we start to define what "serving the nation" or the "national interest" means. Focusing on the national economy can be perfectly benign, as well as compatible with significant degrees of openness to international trade and finance. According to conventional economic theory, it is in a country's own interest to adopt free trade. A government that pursues autarky will forsake the benefits of specialisation, miss out on frontier technologies, and lose access to foreign capital.

As the economic historian Marvin Suesse argues, economic nationalism therefore wavers between two somewhat contradictory impulses: the temptation to restrict economic exchange with other countries in order to advance national independence; and the desire to expand and leverage international links in the service of national economic

growth and development.

In recent times, no one has done a better job of combining these impulses than the "developmental" states of East Asia. Japan, South Korea, Taiwan, and, most spectacularly, China have all relied on a mix of policies that both encourage global economic integration and selectively protect key industries. Each shaped its own economic future through a wide range of industrial policies - directed credit, subsidies, tariff and non-tariff barriers, and local-content and other requirements for foreign investors – that helped it develop new areas of economic competence.

These were not just economic programmes. They were national projects of renewal, aimed at catching up with the West. As political scientist Elizabeth Thurbon of the University of New South Wales and her co-authors put it, policymakers with a developmental mindset "view local manufacturing capacity, technological autonomy, and export competitiveness as the essential foundations of domestic political legitimacy, national security, and international status and prestige, and embrace a central role for the state in advancing these goals through strategic interventions in the market.

No one can deny these countries' success. Their rapid economic growth lifted hundreds of millions of people from abject poverty, and elevated some of them to the status of advanced economies in less than two generations. China became not only an economic powerhouse but the West's main geopolitical rival.

Each country's dramatic rise met with charges that it was not being open enough, and not providing sufficient market access. Widesprea government subsidies – for steel, autos, solar cells, and so on – often undermined foreign firms' competitive positions and drew their governments' ire. Yet, on balance, East Asia's economic nationalism was a boon for the rest of the world. Even with trade barriers here and there, the booming markets that it created for trade partners were much larger than any alternative economic strategy would likely have produced. Moreover, the subsidies - according to economic liberals' own logic - were a gift to other countries, because they helped lower prices for their consumers.

To be sure, China's rapid expansion of exports did create some important difficulties for advanced economies. The "China shock" led to long-term job losses in the regions most exposed to competition from Chinese imports, thereby increasing political support for authoritarian, right-wing populists in both the US and Western Europe. But if anyone bears more of the blame, it is Western governments, for failing to manage trade with China appropriately (by not liberalising their trade more slowly, for example). While China was achieving exceptionally strong export performance, these governments were clinging to an excessive faith in economic liberalism.

Economic nationalism has not turned out well everywhere, of course. Too many governments have engaged in excessive dirigisme (state ownership or control), propped up inefficient firms for too long, and closed their economies off too indiscriminately. When governments make these mistakes, it is primarily their own people who pay the price. Economic nationalism gone wrong is a beggar-thyself policy, not a beggar-thy-neighbour one. East Asian developmentalism offers an important lesson for today's world. If economic nationalism in the US focuses on creating a strong, inclusive domestic economy, it will do much good – even when it violates some of the tenets of economic liberalism. In fact, such a strategy would revive an earlier tradition of developmentalism in US history. Other countries will ultimately benefit from a healthier US economy and more cohesive society, and should have little to complain about.

As Suesse shows, economic nationalism is typically a response to being left behind by other countries. Here, the current US experience is a bit different. Though others - China especially - have been catching up, the US remains technologically and militarily the world's most powerful country. The risk, then, is that American economic nationalism will go beyond building a better society and finding purpose at home. If the US acts like a bully, imposing its policy preferences on others and seeking to undermine its rivals' technological development, it will do much harm to the rest of the world and little good for itself.

## **LEARN FROM HISTORY**

POLICYMAKERS. **GOLDIN'S** RESEARCH **DEMONSTRATES** THAT FIXES FOR **GENDER INEQUALITY VARY DEPENDING ON TIME AND PLACE** 

he latest ILO data for India states that employment gender gap in India is 50.9%, with only 19.2% women in the workforce as compared to 70% men. There is precipitous drop from 32% in 2005 to 19.2% in 2021. The sharp decline in female workforce participation coincides with a period of rapid economic growth. According to data from CMIE, unemployment rate in rural areas has experienced a sharp increase of 9.2% The Oxfam Disparity Report 2022 highlights the gender pay gap in India, with women facing bias in recruitment and pay across the country. It is in this backdrop the pioneering work done by Claudia Golden in unravelling gender pay gaps over a period of 200 years in the USA assumes relevance and salience

Goldin has been awarded Nobel in Economics for work largely in economic history since Robert Fogel triumphed in 1993. Before her research, many academics considered questions about historical gender pay gaps to be unanswerable because of a paucity of data. Yet she has repeatedly demonstrated that digging through historical archives allows researchers to credibly answer big questions previously thought beyond their reach. Her comprehensive history of gender labour market inequality over the past 200 year has overturned many assumptions about both historical and gender relations and what is required to achieve greater equality in the present day

The first myth she busted was that economic growth leads to a more level playing field. She showed that industrial revolution drove married women out of the labour force as production moved from home to factory. It was only in the 20th century when service sector jobs proliferated and high school education developed that the more familiar pattern emerged. The relationship between the size of Western economies and

female labour force participation is U shaped - a classic Goldin find!

Her findings also showed that the gender gap narrowed in bursts. Women's wages relative to men's in 1820-1850 and then again in 1890-1930, before shooting up in 1980-2005. The initial two bursts came well before the equal pay movement and were caused by changes in the labour market; first during industrial revolution, and second during surge in white-collar employment for occupations like clerical work. For the most substantial drop in the late 20th century, Goldin emphasises the role of expectations. If a young woman has more say over when and whether she will have a child, and more confidence that she can work in a wide range of jobs, she may invest more in the future, such as staying in school for longer.

In a seminal work published in 2002, Goldin and Katz, her husband, showed how contraceptive pills approved in 1960 gave women more control over decisions about children. Since around 2005, the wage gap hardly budged. Here Goldin's work questions popular narratives that continue to blame wage discrimination. Instead in a book published in 2021, Goldin blames greedy jobs, such as being a consultant or lawyer, which offer increasing returns to long and uncertain hours.

For policymakers, Goldin's research demonstrates that fixes for gender inequality vary depending on time and place. In early 20th century America. companies barred married women from obtaining or retaining employment. A policy response came with the Civil Rights Act of 1964, which banned such behaviour. Today policy gaps persist because of greedy jobs and parental norms, rather than because of employer discrimination. Goldin has been suggesting that greater flexibility in workplace can be a solution to the problem. Similar monumental histor-

ical research has not been conducted in India. However, in a pioneering research paper on India for the ILO, Steven and Silberman bring out four factors that have contributed to the declining trend in female workforce participation. They bring out that during 1994-2010, the most buoyant period of economic growth after liberalisation, increase in education and household consumption levels have accounted for 38% of the decline, while diminishing employment opportunity has contributed the rest. Female employment could have increased

by 20.7 million had there been no occupational segregation. Due to a number of factors including societal norms, women have limited choice in terms of occupation. As they are disproportionately engaged in occupations like agriculture, which has experienced little to no employment growth this has limited their opportunity to find employment.

The authors highlight the structural barriers such as norms that inhibit women's labour market options, in conjunction with consistent decline in agricultural employ ment are likely factors in explaining long term stagnation in female workforce participation rates. The Constitution of India in Article 39(d) enjoins upon the states to ensure "equal pay for equal work for both men and women. Despite having an Equal Remuneration Act, the stark reality is prevalence of pay disparity for equal work between men and women. This is particularly manifest in unorganised sector like agriculture where female workforce participation is significantly higher than men. Sectors such as manufacturing present barriers to entry. As per the Niti Aayog Strategy for New India @75, in terms of imparting skill, there is a huge asymmetry between skilling male and female workforce and factoring in specific skill set training requirement of female workers. As inclusive growth is a major mandate of the government. It is high time that an in-depth historical study as was done by Goldin is made in India to look holistically and historically into the factors that bedevil female workforce participation, rather than making conjectures or rhetorical criticism. As Santayana wrote: "Those who cannot remember the past are condemned to repeat it.'

## India in a changing world

we find the humanity caught in a race for dominance, territorial aggrandisement, debt trap, wars and the consequent changing security environment. In particular, three wars have disrupted the international political system, to be precise equations and crippled the economies. I am referring to the on-going wars in Ukraine, Gaza, and COVID-19. The last one immobilised the whole world without a bullet fired. Where does India position herself in this turbulent world?

The struggle for dominance by a few countries over the others has been witnessed over the last 350 years. For three centuries. Europe was the home of hegemons. While each of them was constantly trying to establish its dominance over others in Europe through wars and conquests, together, they tried to spread their tentacles across the world for dominance, by building separate imperial structures under them. Through the process of colonialism, they had set up an exploitative world structure, whereby the resources from other parts of the world flowed into the European metropolises.

That kind of world are we living today in? After the Second World War, the hegemonic influence shifted out are unable to settle their disputes be the Indian imperatives? India, are unable to settle their disputes under Jawaharlal Nehru had its and the Soviet Union which became two super powers. Following the Second World War, the Cold War exhausted the Soviet Union, and eventually, the Soviet empire collapsed causing its components to break free. The fall was driven by two main reasons – the Soviet Union had siphoned off much of its resources for military purposes in the arms race against the US. Second, the communist dictatorship had suffocated its citizens, taking the country to a point of logjam. That condition called for introduction of glasnost and

perestroika. The rest is history. At the same time, during the Cold War, the West propped up China as a counterweight to the Soviet Union. Now China is flex $ing\ its\ muscles\ to\ replace\ Rusia$ as the second supreme power, or further, Beijing seeks to be the numero uno power in the world by reclaiming its old empire. It is a question of time, however, the Chinese autocratic state or its imperial ambitions would meet the same fate of as that of Soviet Union.

On territorial expansionism, a few countries suffer from an or reconcile the legitimate claims of others. China leads the pack on grabbing others' territories. Russia is trying perhaps to reconstitute the Soviet Union by annexing other countries' territories.

A sinister strategy was being quietly followed to coerce many countries to embrace globalisation, that was in a way, meant to slide them into a debt trap.

For four-and-a-half decades, the global security environment was marked by the Cold War and bloc-politics. A deterrent strategy, bipolarity and the arms race were its main features. Both the super powers avoided a direct military confrontation although they engaged in many proxy wars across the globe. With the collapse of one super power, the US assumed the role of the policeman and launched several assaults across the world. Even Russia, under Putin's dictatorship and design mentioned above, engaged in conflicts with its neighbours including unleashing a full-scale war against Ukraine. Moreover, the Chinese imperial ambitions make the security scenario precarious.

In view of these changing international relations what could

The manner in which he handled the Kashmir issue in 1948, the Chinese annexation of Tibet in 1958, the war with China in 1962, the utopian concept of non-alignment, UNSC membership, and nuclear issue. ## MP polls: 19% candidates have criminal cases

New Delhi, Nov 9: With almost a week left for the polling in the 230-member Madhya Pradesh Assembly, out of the 2,534 candidates analysed at least 19 per cent are facing criminal charges, as compared to 17 per cent out of the 2.716 candidates in the 2018 nolls, a report said Thursday.

The report has been prepared by the Association for Democratic Reforms (ADR) and Madhya Pradesh Election Watch which analysed the self-sworn affidavits of all 2,534 candidates, who are contesting in the Madhya Pradesh 2023 Assembly Elections.

It said, "Out of 2,534 candidates analysed, 711 are from national parties, 103 are from state parties, 553 are from registered unrecognised parties and 1,167 candidates are contesting independently."

The report stated, "Out of the 2,534 candidates analysed in the Assembly elections, 472 (19 per cent) candidates have declared criminal cases against themselves.'

It highlighted that in the 2018 Madhya Pradesh Assembly Elections, out of 2,716 candidates analysed, 464 (17 per cent) had declared criminal cases against themselves

The report further said that 291 (11 per cent) have declared serious criminal cases. In the 2018 Madhya Pradesh Assembly



Elections, 295 (11 per cent) candidates had declared serious criminal cases against them-

"Among the major parties, a maximum of 121 (53 per cent) out of 230 candidates analysed from Congress: 65 (28 per cent) out of 230 candidates analysed from the ruling BJP; 26 (39 per cent) out of 66 candidates analysed from AAP, and 22 (12 per cent) out of 181 candidates analysed from BSP have declared criminal cases against themselves in their affidavits," it said.

The report further said that among the major parties, 61 (27 per cent) out of 230 candidates analysed from Congress, 23 (10 per cent) out of 230 candidates analysed from BJP, 18 (27 per cent) out of 66 candidates analysed from AAP and 16 (9 per cent) out of 181 candidates analysed from BSP have declared serious criminal cases against themselves in their affidavits.

The report further stated that 24 candidates have declared cases related to crime against women and one candidate has declared case related to rape (IPC Section-

Meanwhile, 10 candidates have declared cases related to murder (IPC Section-302) against themselves while 17 candidates have declared cases related to attempt to murder (IPC Section-307) against themselves.

The report stated that 79 (34 per

cent) out of 230 constituencies are red alert constituencies.

Red alert constituencies are those where three or more contesting candidates have declared criminal cases against them

"At least 76 (33 per cent) constituencies in the 2018 Madhya Pradesh Assembly elections had three or more candidates with declared criminal cases," the report

The report highlighted that the directions of the Supreme Court have had no effect on the political parties in the selection of candidates in the 2023 Madhya Pradesh Assembly Elections as they have again followed their old practice of giving tickets to around 19 per cent candidates with criminal cases

All major parties contesting in Madhya Pradesh elections have given tickets from 12 per cent to 53 per cent candidates, who have declared criminal cases against themselves.

The Supreme Court in its directions dated February 13, 2020 had specifically instructed political parties to give reasons for such selection and why other individuals without criminal antecedents could not be selected as candidates.

Polling for the 230-member Assembly is scheduled November 17 and counting of votes will take place December 3.

### MANIPUR EXTENDS MOBILE **INTERNET BAN TILL NOV 13**

BARRING A FEW DAYS IN SEPTEMBER, MOBILE INTERNET HAS REMAI BANNED IN MANIPUR SINCE MAY 3 WHEN ETHNIC CLASHES BROKE OUT

Imphal, Nov 9: The Manipur government Thursday extended mobile internet ban across the state by five more days till November 13, officials said.

The ban, however, will not be enforced in the four hill district headquarters which have not been affected by ethnic strife, officials added.

The state government said the decision to extend the ban was taken "as there is apprehension that anti-social elements might use social media extensively for transmission of images, hate speeches and video messages inciting the passions of the public which might have serious repercussions for the law and order situation in the state."

A home department order said, "There is imminent danger of loss of life and/or damage to public private property and widespread disturbances to public tranquility and communal harmony, as a result of inflammatory material and rumours, which might be transmitted/circulated to the public through social media.'

"To thwart the designs of anti-



national and anti-social elements and to maintain peace and communal harmony, it has become necessary to take adequate measures to maintain law and order in public interest by stopping the spread of disinformation and false rumours through various social media platforms,' the order added.

The order also said, "The state government had already opened few mobile towers in few district headquarters which had not been affected by violence in the first instance and is considering to open and operationalise more mobile towers in other district headquarters on a trial

Tuesday, the Manipur government lifted mobile internet ban in the district headquarters of Ukhrul, Senapati, Chandel and Tamenglong, which are Naga-majority areas, on a temporary basis.

The step was taken after the Manipur High Court directed the state government to operationalise mobile towers, on a trial basis, in all those district headquarters which have not been affected by the ethnic clashes.

Barring a few days in September, mobile internet has remained banned in Manipur since May 3 when ethnic clashes

Alirajpur, Nov 9: For reaching the polling station at Jhandana village ahead of the November 17 Madhya Pradesh assembly elections, poll officials will have to first ride in a boat carrying the electronic voting machines (EVMs) with them, and then undertake a difficult journey on foot in a hilly area.

There are 763 registered voters among around a thousand residents of this remote village in Alirajpur assembly constituency, reserved for the Scheduled Tribes, but no candidate has bothered to visit the place, locals said Thursday.

The village is barely 60 km from the district headquarters of Alirajpur, but seems to be decades behind in terms of development and infrastructure.

The only sign of elections is the flags of political parties seen over a couple of houses.

Most of the people here speak `Bhili', local language. Vandana (23), a village resident, said, "There are no proper roads and we have to rely on boats to connect with the outside world.

Prem Singh Solanki, 35, a fisherman, said, "Political leaders had promised in the last elections to provide drinking water to homes, but so far the promise has not been fulfilled. Water is scarce for both humans and cattle."

The villagers tried to install a borewell some time ago, but it did not strike water due to the rocky terrain of the mountainous area.

Alirajpur collector Abhay Arvind Bedekar said there is an alternative land route to the village, but one has to walk for about five kilometers.

Villagers have been demanding a concrete road, but it will have to pass through forest land,

Transnational conspiracy case

#### India calls for immediate release of Israeli hostages

New Delhi, Nov 9: As the Israel-Hamas conflict continues, India Thursday urged both the sides to eschew violence, de-escalate the situation and create conditions for an early resumption of direct peace negotiations towards a two-state solution to the Palestine issue.

Without naming Hamas, India also called for "immediate and unconditional" release of hostages. Israel has been carrying out a massive military offensive in Gaza following the unprecedented and multipronged attacks on Israeli cities

by Hamas militants October 7. Hamas killed around 1,400 people in Israel and kidnapped more than 220.

At his weekly media briefing, Spokesperson in the Ministry of External Affairs (MEA) Arindam Bagchi said India has made its position clear on the Hamas-Israel conflict on multiple occasions including during the UN General Assembly debate October 27.

"We have strongly condemned the horrific attack on Israel, urged the need for zero tolerance for terrorism and called for immediate and unconditional release of hostages," he said.

Bagchi said India has also sent 38 tonnes of humanitarian relief material and emphasised the need for strict "observance of international humanitarian law." The relief materials were sent to the people of Gaza. Prime Minister Narendra Modi

held phone conversations with Israeli PM Benjamin Netanyahu and President of Palestinian Authority Mahmoud Abbas following escalation of the conflict. Asked about reports that the Israeli construction industry is looking at recruiting 100,000 Indian workers to replace the 90,000 Palestinians, he was not aware of any such requests from Tel Aviv. In a larger context, he said

India has been working towards giving its citizens access to the 'global work place'

"In this regard, we have been in discussion on trying to get into mobility agreements with a number of countries. Such frameworks and agreements ensure that our people are treated fairly, their rights are protected and they are not discriminated against," Bagchi said.

## **Ethics panel suggests** expulsion of Moitra

New Delhi, Nov 9: The Lok Sabha Ethics Committee Thursday recommended the expulsion of TMC MP Mahua Moitra from the House in the 'cash-for-query' matter, capping a fortnight of actions that included deposition of three persons over three sittings.

The committee, chaired by BJP Lok Sabha member Vinod Kumar Sonkar, met here and adopted its 479-page report which, according to sources, recommended Moitra's expulsion, possibly first such action against an MP by the panel.

Committee chairman Sonkar told reporters that six members of the panel supported adoption of the report and four opposed it. In her first reaction to PTI after the Lok Sabha panel recommendation, Moitra said this was a "pre-fixed match by a kangaroo court" and added, "Even if they expel me, I will be back in the next Lok Sabha with a bigger mandate.'

The ethics panel report will now be tabled in the Lok Sabha which will then vote on a motion to put the recommendation into action. According to sources, Preneet Kaur, a Congress MP, is believed to have voted in support of the report. Four Opposition members said the panel's recommendation was "prejudiced" and "incorrect", and said busi-

nessman Darshan Hiranandani, who is alleged to have given bribes to Moitra, should have been asked to depose before the panel. He has only filed an affidavit.

Former secretary general of the Lok Sabha P D T Achary said this is perhaps the first time the Lok Sabha Ethics Committee has recommended the expulsion of an MP. In 2005. eleven MPs were expelled from Parliament in another 'cashfor-query' case but those expulsions were recommended by

the Raiva Sabha Ethics Committee and a Lok Sabha Inquiry Committee.

The proceedings of the 'cash-for-query' issue in 2005 too was a fast-track one with the matter coming to light December 12 and leading to the expulsion of members December 23, 2005. Achary said the Lok Sabha Ethics Committee report will now be sent to Lok Sabha Speaker Om Birla. The speaker may order that it be published, he said.

During the next session of Parliament, the committee chairman will table the report in the House and thereafter there will be a debate on it, followed by a vote on a government motion for the member's expulsion, Achary said. The committee had earlier heard Moitra, BJP MP Dubey, who filed the complaint against her, and advocate Jai Anant Dehadrai.

Based on information shared by Dehadrai, the BJP MP accused Moitra of asking questions in the Lok Sabha to target the Adani Group and Prime Minister Modi at the behest of businessman Hiranandani in exchange for gifts. Moitra has denied the charge of receiving any pecuniary benefit.

BJP member Aparajita Sarangi said, "These are baseless claims. Darshan Hiranandani has given a sworn affidavit which is sufficient."

Special Judge (MP-MLA) Avanish Gautam had Wednesday issued NBW against Surjewala, a Rajya Sabha MP, directing him to appear November 21. Senior advocate Abhishek Singhvi, appearing for Surjewala, mentioned the matter before a three-judge bench headed by Chief Justice DY Chandrachud in the morning and sought an urgent hearing. The CJI fixed it for hearing later in the day.

## Three judges appointed to apex court

The three judges were sworn-in at a function in the Supreme Court complex in the presence of other judges, lawyers and their family members.

With the swearing-in of the three new judges, the top court will now function with its full strength of 34 judges. Earlier in the day, Sharma, the Delhi High

Court chief justice, Masih and Mehta, his counterparts in the Rajasthan and Gauhati high courts, respectively, were appointed as top court judges. Law Minister Arjun Ram

Meghwal announced their appointment on X. Their names were recom-

mended by the Supreme Court Collegium November 6. Justice Sharma was appointed as a judge of the Madhya Pradesh High Court on January 18, 2008

and was elevated as the Chief Justice of the High Court of Telangana October 11, 2021. He was thereafter transferred to the Delhi High Court June 28, 2022.



Justice A G Masih was appointed as a judge of the Punjab and Haryana High Court July 10, 2008 and was elevated as the Chief Justice of the Rajasthan High Court May 30, 2023.

About Justice Mehta, the resolution had said he was appointed as a judge of the Rajasthan High Court May 30, 2011, and having attained seniority in his parent high court, he was elevated as the chief justice of the Gauhati High Court and is serving there since February 15.

It added that before his elevation, Justice Mehta practised before trial courts, the high court and the Supreme Court, mainly in constitutional and criminal laws and the judgments authored by him dealing with issues in various branches of law stand testimony to his legal acumen and competence.

Patna, Nov 09: The Bihar assembly Thursday hiked the quota for deprived castes from 50 per cent to 65 per cent in government jobs and educational institutions, taking the overall reservation to 75 per cent.

Earlier during the day, the assembly unanimously hiked quotas for Scheduled Castes, Scheduled Tribes, Extremely Backward Classes (EBCs) and Other Backward Classes (OBCs) from the existing 50 per cent to 65 per cent. Bills providing for the same in educational insti-



tutions and government jobs, drafted in the backdrop of a

comprehensive caste survey conducted by the Nitish Kumar government, were passed unanimously, through voice vote.

As per the Bills, the quota for STs will be doubled, from one to two per cent, while for SCs it will be raised from 16 per cent to 20 per cent.

For EBCs, the quota will be 25 per cent, up from 18 per cent, while for the OBCs it will rise from 12 per cent to 15 per cent.

Kumar said, "the rise in quotas in Bihar follows the caste survey which was conducted after a consensus was reached among all the nine parties which have representation in this House". "The survey has

provided us with a comprehensive data. We will use it to introduce more measures for the uplift of socially, educationally and economically backward sections of society. I will be glad if the Centre, too, agrees to a caste census and hike reservations across the country," said Kumar.

The JD(U) leader also took the opportunity to raise a fresh demand for grant of special status to Bihar, saying, "our land was so advanced in ancient times. It stagnated because of historical factors. We need some help to recover our lost glory".



London, Nov 9: Russia is sending Ukrainian prisoners of war to the front lines of their homeland to fight on Moscow's side in the war, the Russian state news agency RIA Novosti reported.

The news agency said Tuesday the soldiers swore allegiance to Russia when they joined the battalion, which entered service last month.

Experts say such actions would be an apparent violation of the Geneva Conventions relating to the treatment of POWs, which forbids them from being exposed to combat or from working in unhealthy or dangerous conditions — coerced or not.

Nick Reynolds, research fellow for Land Warfare at the Royal United Services Institute in London, added that "the entire scenario is laced with the potential for coercion." A prisoner of war, he said, does not have "a huge amount of agency" and is in a "very difficult situation."

Video from RIA Novosti showed the Ukrainians swearing allegiance to Russia, holding rifles and dressed in military fatigues to fight in a battalion named for medieval nobleman Bogdan Khmelnitsky, seen as a national hero in Russia for bringing parts of Ukraine under Moscow's control in the 15th century.

The Institute for the Study of

War in Washington said there have been previous reports of Ukrainian POWs being asked to "volunteer" for the battalion. They were housed in the Olenivka prison, which was blown up in July 2022. Russia said Ukraine destroyed the prison in the country's east with a rocket, but Kyiv blamed the blast on Moscow to cover up what it alleged was abuse and killings of the POWs.

Russia also has used inmates from its own prisons to fight in Ukraine in exchange for a commuted sentence if they survive.

It is also trying to bolster its forces with a "conscription campaign in occupied Ukraine," said the ISW's Karolina Hird.

By mobilizing Ukrainian POWs, deploying Russian convicts and conscripting Ukrainians who live in occupied regions. Russia is increasing its combat force "without having to risk the social implications of conducting a general mobilization," Hird said.

RIA Novosti reported the Ukrainians will operate as part of another unit in eastern Ukraine, and the unit's website said it has about 7,000 fighters.

#### to UK safe states list PRESS TRUST OF INDIA London, Nov 9: The UK government has tabled plans to add India to an expanded list of safe states, which would speed up the process of returning Indians who travel from the country illegally and rule out their chance of seeking asylum in Britain.

Draft legislation laid in the House of Commons Wednesday includes India and Georgia as the countries to be added to the list. The UK Home Office said the move is aimed at strengthening the country's immigration system and help prevent abuse by people making unfounded protection claims.

"We must stop people making dangerous and illegal journeys to the UK from fundamentally safe countries," said UK Home Secretary Suella Braverman

The move is in line with measures to meet British Prime Minister Rishi Sunak's pledge to "stop the boats" of migrants landing on the country's shores illegally after making precarious journeys across the English Channel. The Home Office said that Indian and Georgian small boat arrivals have increased over the last year, despite individuals from these countries not being at obvious risk of perse-

## Indian-Americans take over state, local US polls

Washington, Nov 9: At least 10 Indian-Americans, almost all of them Democrats, have won local and state level elections held in several parts of the country reflecting the growing political empowerment of the ethnic community that constitutes a little over one percent of the US' population.

În Virginia, Hyderabad-born Ghazala Hashmi was re-elected to the State Senate for a third consecutive term. She was the first-

ever Indian-American woman and a Muslim to be elected to the Virginia State legislation.

Suhas Subramanyam was reelected to the Virginia State Senate. He was elected to the House of Delegates for two terms in 2019 and 2021. A former technology policy advisor in the White House during the Obama Administration, Houston-born Subramanian is the first Hindu to be elected to the Virginia

## Transgender Catholics can be baptized: Vatican

In a major step towards transgender inclusion, Vatican allows trans Catholics to be baptized and serve as godparents

Vatican City, Nov 9: Transgender people can be godparents at Roman Catholic baptisms, witnesses at religious weddings and receive baptism themselves, the Vatican's doctrinal office said Wednesday, responding to questions from a bishop.

The department, known as the Dicastery of the Doctrine of the Faith, was vague however, in response to a question of whether a same-sex couple could have a Church baptism for an adopted child or one obtained through a surrogate mother.

Bishop Jose Negri of Santo Amaro in Brazil sent the doctrinal office six questions in July regarding LGBT people and their participation in the sacraments of baptism and matrimony.

The three pages of questions and answers were signed by the

department's head, Argentine Cardinal Víctor Manuel Fernández, and approved by Pope Francis October 31. They were posted on the department's website Wednesday using the Italian word for "transsexuals".

Francis, 86, has tried to make the Church more welcoming to the LGBT community without changing Church teachings, including one saying that samesex attraction is not sinful but same-sex acts are.

In response to a question of whether transgender people can be baptized, the doctrinal office said they could with some con-



risk of causing a public scandal or disorientation among the faithful"

It said transgender people could be godparents at a baptism at the discretion of the local priest as well as a witness at a Church wedding, but the local priest should exercise "pastoral prudence" in his decision.

Francis has met with transgender people and in July, he told a transgender person: "Even if we are sinners, he (God) draws near to help us. The Lord loves us as we are, this is God's crazy

The document said a person in a same-sex relationship could also be a witness at a Catholic wedding, the office said, citing current Church canonical legislation which contained no prohibition against it.

The response was less clear regarding persons in same-sex relationships and their role in baptism, which is the initiation into the Church for infants, children or adults.

The Brazilian bishop sought guidance on whether a same-sex couple who had adopted a child or obtained it from a surrogate mother could have that child baptized in a Catholic ceremony.

The response said that for the child of a same-sex couple to be baptized, there had to be "a wellfounded hope that it would be educated in the Catholic religion"

There was a similarly nuanced response to a question whether a person in a same-sex relationship could be a godparent at a Church baptism. It said the person had to "lead a life that conforms to the faith".

## Subdued exports bitter sugar rates

New Delhi, Nov 9: The prices of sugar have surged past 28 cents per pound in the international market to touch a 12-year high as the sweetner is seen in short supply due to a sharp decline in Indian exports and logistics problems in Brazil.

Sugar prices have been steadily increasing in the international market to multi-vear highs and the 15-day average price estimated by the International Sugar Organisation has been above 26 cents in recent weeks. India has extended export

curbs on sugar as domestic prices had started firming up and the government is keen to keep prices in check, especially during the festive season when the demand shoots up.

The country had allowed mills to export only 6.2 million tons of sugar during the 2022-2023 season which ended on September 30, after letting them sell a record 11.1 million tons in the preceding 2021-2022 season.

The country has seen the weakest monsoon since 2018 this year and sugarcane production is expected to decline in the current season which gives rise to inflationary expectations that tend to push up prices. Sugar prices

stay ahead of the other contenders, and both Conway and Ravindra were aware of it. They exploited the struggles of Lankan bowlers to find the right line quite mercilessly.

However, Conway and Ravindra would repent missing a fifty that was there for the taking. At 88/2 in the 14th over, New Zealand were not in any trouble but they needed some quick runs to stay ahead in run rate mathematics. Mitchell did precisely that.

But the needless run out of Mark Chapman while the Kiwis were cruising stood as a sore point as he had to sacrifice his wicket for Mitchell, and the former was not entirely chuffed about it either. New Zealand, though, managed to move past the tape from that point without too many hiccups.

But for that smooth win, the Black Caps should thank Boult's riveting show in the noon, who was ably assisted by the skilful left-arm spin of Mitchell Santner (2/22). Their effort reduced a belligerent 51 off 28 balls by Lankan opener Kusal Perera, who was dropped on 1 by stumper Tom Latham off Tim Southee, to a mere footnote in an otherwise

shambolic batting effort. Boult was struggling for his rhythm in the last couple of matches, but the 35-year-old revealed his true colours with a bit of nip in the air, jagging the ball

After Southee jettisoned Pathum Nissanka, the left-arm pacer dismissed Lankan captain Kusal Mendis, whose mistimed pull ended with Ravindra near square leg, in the first ball of the fifth over.

Three balls later, Boult angled one across in-form Sadeera Samarawickrama, and the indecisive right-hander nibbled it to Latham. A couple of overs later, Boult trapped Charith Asalanka in front of the wicket with one that came wee bit in to reduce Lanka to 70/4 well inside the first 10 overs.

Angelo Matthews and Dhananjaya de Silva could not negate Santner's accuracy and the deliveries that spun away from them, perishing cheaply, which effectively ended the Lankan fight.

However, while the Lankan castle was crumbling around him Perera played a gem of an innings. Perera had not made the kind of impact expected of him while making just one fifty against Australia in the tournament and failing to reach double digits in five other innings.

However, the left-hander was in his elements here and creamed the Kiwi bowlers around the park. Perera made Southee suffer the most. He extracted 18 runs off the pacer's third over, innings' sixth, through a sequence of 6, 4, 4, 4. The pick-up six off his legs over long-on and the drive past the point fielder were the standout shots in that series.

Perera soon reached his 17th ODI fifty with another cracking cover drive off returning pacer Lockie Ferguson. But the fun ended soon as Ferguson had the last laugh - an attempted loft over the covers ended in the hands of Santner.

Ferguon, who pinged Theekshana on his arm, returned to rattle the late-order batsmen with his high pace, ensuring no letting off of pressure. Theekshana and Dilshan Madhushanke added 43 runs for the final wicket, the highest in the Lankan essay, but they could not find a total that can even stretch New Zealand.

A lot more is at stake for Afghanistan than South Africa, who have already made the semifinals alongside India and Australia. With eight points each, Afghanistan are battling for the fourth spot with Pakistan and New Zealand. Only a win over the Proteas will keep them in the

The Afghans also have an inferior net run rate compared to Pakistan and New Zealand, therefore, they need to win big and hope the other results go their way.

Irrespective of the result Friday, Afghanistan have earned tremendous respect with their mature play in the tournament, having racked up four wins from eight games.

They now have the belief to beat the best in the business on any given day. After humbling England and Pakistan, the Hasmatullah Shahidi-led side was on the cusp of a famous win over five-time champions Australia before Glenn Maxwell came up with a superhuman knock.

The improbable defeat left Afghans heartbroken and they now need to pick themselves up to give their best shot at a semifinal berth.

Batting first, South Africa have been the best batting unit in the tournament. Therefore, Shahidi will be hoping to win the toss, put runs on the board and choke South Africa in their chase.



South Africa's flamboyance has made way for tentativeness while chasing in the competition. Afghanistan's match-winning spinners will back themselves to exploit that apparent weakness.

Spin has been the team's strength over the years but now it can also expect breakthroughs from the pacers. With a little help on offer, Naveen Ul Haq and all-rounder Azmatullah Omarzai delivered with the new ball against Australia to rattle the opposition.

Afghanistan batting, which has been its weak link, has come of age in the tournament. Batters like Ibrahim Zadran, Rahmat Shah and captain Shahidi himself know how to play the situations, while batting first or

The team, however, expects more from opener Rahmanullah Gurbaz, who has not been consistent enough, and veteran Mohammd Nabi, who has not yet made an impact with the bat. Pressure on Bavuma

While Quinton de Kock has piled on the runs in his swansong, South Africa skipper Temba Bavuma has not led from the front at the top of the order. Dropping the skipper in the middle of the tournament is highly unlikely but Bavuma must be feeling the pressure.

Geneva, Nov 9: On a royally good evening for standout Spanish teams, Manchester United fell in another wild loss in the Champions League, Real Madrid and Real Sociedad advanced to the round of 16 with two games to spare after impressive home wins over Portuguese opponents, respectively 3-0 against Braga and 3-1 over Benfica

Bayern Munich and Inter Milan also won and will be in the knockout phase after getting key late goals from their talismanic strikers, Harry Kane and Lautaro Martinez. Kane scored in the 80th and 86th minutes in a 2-1 win over Galatasaray and Inter's 1-0 win at Salzburg was sealed by Martinez's penalty in the 85th.

Man United almost never has straightforward games in the English giant's drama-filled season on and off the field. A 3-4 loss at Copenhagen — the same result as United's opening game at Bayern — after twice letting leads slip left coach Erik ten Hag's team last in Group A.

The three-time European champions seemed in total control with a two-goal lead after 28 minutes earned by Rasmus Hojlund, returning to face his for-

A red card for United forward Marcus Rashford in the 42th sparked the chaos to follow, which saw Copenhagen level the score

in 13 minutes of first-half stoppage time because of two pauses in play, including a protester on United led again when Bruno

Fernandes scored from the penalty spot in the 69th but they could not hang on. Lukas Lerager levelled in the 83rd before 17year-old substitute Roony Bardghji won it in the 87th.

Arsenal took a four-point lead in Group B by comfortably beating Sevilla 2-0 while PSV Eindhoven rose from last place to second with its first win, 1-0 at home to Lens.

#### **REAL IMPRESSIVE**

Ukraine goalkeeper Andriy Lunin, who got a late call when first choice Kepa Arrizabalaga was unable to warm up because of a leg muscle injury, saved a penalty from Braga's Alvaro Djalo just six minutes into his third game of the season.

Brahim Diaz gave Real a firsthalf lead and Brazil teammates Vinicius Junior and Rodrygo added goals in a three-minute spell around the hour mark.

Real Sociedad threatened to sweep aside Benfica in the first half of a 3-1 win that saw its three goals all scored by the 21st and a penalty missed minutes later.

In their first Champions League campaign for 10 years, Real Sociedad and long-serving coach Imanol Aguacil are impressing with a largely homegrown group of players from the Basque region.

## Spanish sides advance, Parneet stuns Jyothi for individual gold

Bangkok, Nov 9: Teenager Parneet Kaur secured the biggest win of her career when she pipped ace Indian compound archer Jyothi Surekha Vennam to clinch the individual crown at the Asian Championships here Thursday.

Compound archers once again overshadowed their recurve teammates as India bagged three gold, one silver, and three bronze medals. Of the seven medals, only a solitary bronze came from the recurve section (women's team).

In an all-Indian women's compound individual final, Parneet trailed by two points till the halfway mark but the bespectacled 18-year-old produced two perfect last rounds to level the score 145-145 and force a tiebreaker.

Fresh from winning a hattrick of gold at the Asian Games last month, Jyothi was not at



her best and lost the shoot-off 8-9 as Parneet won her maiden individual gold medal at the International level

Indian compound mixed team of Aditi Swami and Priyansh earned India a second gold, defeating Thailand 156-151 in a lopsided final. Indian compound women's team of Jyothi, Parneet and Aditi. which also bagged the Asian Games gold last month, did an encore, winning the title with a 234-233 win over Chinese

Taipei. India also won their third bronze which came in the compound men's individual section

courtesy Abhishek Verma. The veteran Indian archer pipped Joo Jaehoon of South Korea 147-146.

#### **RECURVE FLOP SHOW**

None of the recurve archers managed to progress beyond the quarterfinals. Dhirai Bommadevara was eliminated by Tang Chih-Chun 3-7, while his senior Army colleague Tarundeep Rai was blanked 0-6 (27-29, 28-29 29-30) by Kim Je Deok of South Korea.

Both archers shot consistently but the Tokyo Olympics team gold medalist Deok was far superior and dropped just two points in nine arrows.

In the women's section, the archers failed to advance beyond the pre-quarterfinals. Bhajan Kaur lost to World No.1 Lim Sihyeon of South Korea 0-6 (28-29, 26-30, 26-29), while Tisha Punia managed one point before going down 1-7 (24-29, 27-27, 28-29, 27-28) to China's Hai Ligan in two lopsided last-16 matches.

in 241 games (six Tests, 103 ODIs, 132 T20s). Lanning, however, will

continue to play in T20 leagues

around the world. "The decision to step away from international cricket was a difficult one to make, but I feel now is the right time for me,' Lanning said in a statement. 'I've been incredibly fortunate to enjoy a 13-year international career, but I know now is the right time for me to move on to something new.

'Team success is why you play

the game, I'm proud of what I have been able to achieve and will cherish the moments shared with teammates along the way.'

The success of Australia under a decade of Lanning's leadership mirrors the invincible run of the men's team in early 2000s. Alyssa Healy, who captained the side in Lanning's absence, could lead the side on the multi format tour of India next month.

'On behalf of Australian Cricket, I would like to congratulate Meg on her incredible career as an Australian cricketer and all she has achieved as captain of the Australian women's cricket team," Cricket Australia CEO Nick Hockley said.

"One of the finest cricketers Australia has produced, Meg's supreme achievements with the bat have been matched by her inspiring leadership. As one of the best players in the world over a long period of time, Meg has made an immeasurable impact and led a generation which has helped revolutionise the game.

#### Netherlands can pull off shock win against India, believes Teja
