# **10 devotees faint** in Srimandir rush

Puri, Nov 10: An unprecedented rush of devotees at Srimandir soon after the Mangala Aarati triggered a stampede-like situation early Friday, leaving over 20 people, mostly elderly, ill, with 10 of them losing consciousness. The devotees, who fell ill, were taken to the district headquarters hospital (DHH) for treatment, police said, adding that most of the ill persons were discharged after treatment. Shree Jagannath Temple Administration (SJTA) chief administrator Ranjan Kumar Das said the heavy rush of devotees was responsible for the incident A DEVOTEE that took place in the early hours of the day. The Indian traditional month of Kartika is considered holy and large number of devotees flock the 12th century shrine to pay their obeisance to the sibling deities. "Those who fell ill were mostly elderly persons. We are augmenting the arrangement to ensure smooth darshan of devotees inside the temple," Das said. The injured were taken to a nearby hospital where they were administered first aid. Sarkar said, "We are trying to arrange a vehicle to send them to their destinations.

New Delhi, Nov 10: Exasperated with his inaction, the Supreme Court Friday pulled up Puniab

the bills passed by the Assembly are invalid because the session was irregular? These are bills passed by the elected members. This is a very serious matter. You're playing with the fire,' the Supreme Court bench headed by Chief Justice DY Chandrachud said while hearing a petition filed by the AAP-led Punjab government against the governor alleging delay in giving assent to bills passed by the Assembly. The Supreme Court said the Governor cannot cast doubt on the validity of a two-day Assembly session held in June and can't sit on the bills citing this as a reason. The bench observed that convening of the house in June was within the ambit of the rules and procedure of business and conduct of Vidhan Sabha. "Any attempt to cast doubt on the session of the legislature would be fraught with great perils to democracy. Casting doubt on the validity of the session of the house is not a constitutional option open to the governor," the Supreme Court said.

10 of them fainted soon after Mangala Aarati in the temple. They fell down as the crowd of devotees surged inside. They were given preliminary treatment in the temple and then shifted to the DHH.

Das said Jagannath Temple Police (JTP) helped the devotees who fell down.

Puri superintendent of police (SP) Kanwar Vishal Singh said, "There was rush in the temple but no stampede. A total 15 platoons (450 personnel) of the police were deployed to control the crowd. Their number will be increased keeping in view the rush of devotees.

One of the devotees said that those who went for darshan of the deities were allowed to enter the temple after the morning Mangala Aarti. As the gates opened, many of them scrambled towards the deities and some of them fell down and became unconscious near Ghanti Dwara and Sata Pahacha of the temple.

Governor Banwarilal Purohit over withholding assent to bills passed by the state assembly and cautioned him by saying, 'you are playing with the fire."

# **US FDA NOD TO 1ST** CHIKUNGUNYA VAX

New Delhi, Nov 10: Ixchiq, the first chikungunva vaccine, has been approved by the US Food and Drug Administration (FDA) for individuals 18 years of age and older who are at increased risk of exposure to mosquitoborne virus.

Containing a live, weakened version of the chikungunyacausing virus, Ixchiq is administered as a single dose by injection into the muscle and may cause symptoms in the recipient similar to those experienced by people having the viral disease, the FDA said in a statement.

"Infection with chikungunya virus can lead to severe disease and prolonged health problems, particularly for older adults and individuals with underlying medical

conditions," said Peter Marks, director of the FDA's Center for Biologics Evaluation and Research. The effectiveness of the vaccine was determined through a clinical study in individuals 18 years of age and older in the US, the agency's statement said.

The level of antibody generated in the 266 vaccinated participants was 'based on a level shown to be protective in nonhuman primates that had received blood from people who had been vaccinated', it said.

The study had compared the immune response of these individuals with that of 96 participants receiving placebo.

The most commonly reported side effects were headache, fatigue, muscle pain, joint pain, fever. nausea and tenderness at the injection site, it said.

New York, Nov 10: The justunveiled Michelin Guide for Washington, D.C., New York and Chicago for 2023 has brought Diwali cheer to three Indian restaurants, two of which got their coveted first star from the guide regarded as the final word on gastronomy. Last year, the number was just one.

The restaurants are Semma in New York City, Rania in Washington, D.C., and Indienne in Chicago. They represent three distinctive styles of Progressive Indian Cuisine, their chefs bringing their own unique touches to the table.

Semma's Vijay Kumar, who grew up in rural Madurai and has worked up the ranks, which included being a line cook on a

cruise ship, brings the flavours of his memory to the secondtime Michelin star-winning restaurant, which gets its name from the colloquial equivalent of 'super' or 'fantastic' in Tamil.

Kumar, who was previously with Rasa, San Francisco, has partnered with Roni Mazumdar and Chintan Pandya. Their company is called Unapologetic Foods, which is an appropriate name for a food philosophy to work in the Big Apple, one of the most competitive dining out markets in the world

To quote from the Guide: "This is authentic Indian cooking that doesn't pander to American expectations, and if some of the dishes are unfamiliar, lean on the staff who know their stuff and are eager to share. One bite in and you'll quickly learn that this



cooking is all heart."

In the U.S. capital, Washington, D.C., not far from the White House, local restaurateur Karan Singh tied up with Amit Burman and Rohit Aggarwal's Lite Bite Foods to open Punjab Grill, but as Aggarwal puts it, the place wasn't doing well and Covid hit it badly

So, from a mid-market Punjab Grill, under the flowing salt-andpepper-maned Chef Chetan Shetty (a long-time Indian Accent hand), the restaurant got a new name, Rania, a menu upgrade and a complete makeover with

Avush Kasliwal shipping the grand ready-to-fit interiors from Jaipur to D.C. In the words of the Guide: "Dishes like shiso leaf chaat balance a playful spirit with elegant overtones, while ghee-roasted lamb folded inside a delicate lentil cheela has a spicy kick that is tempered with a buttermilk mousse. Finally, a slightly sweet strained yogurt mousse with a hint of pistachio and cardamom is the perfect finale."

Indienne in Chicago, located in a reconverted 19th-century printing press warehouse, may be a newbie in the Windy City's dining scene, but the man behind it, Sujan Sarkar, is no stranger to presenting Indian food with French cuisine nouvelle finesse an art he perfected during his stint at Rooh, also in Chicago, an outlet of which he opened opposite the Qutub Minar in Mehrauli, New Delhi.

Guide savs about Sarkar: "In a city where kitchens break moulds and defy expectations, Sujan Sarkar makes a splash of his own on this quiet strip of River North. A la carte is available, but first-timers should start with the tasting menu, where Sarkar delivers an original, modern vision of Indian cuisine. His food may look like pieces of art but taste like familiar fa-vorites pulled from across his

vibrant homeland.'

# **Monitor services under BSKY: Pandit**

Bhubaneswar, Nov 10: Health and Family Welfare secretary Shalini Pandit directed officials of the State Health Assurance Society (SHAS) Friday to monitor services and facilities available to patients at the private hospitals empanelled under the Biju Swasthya Kalyan Yojana (BSKY).

Altogether 765 super-speciality private hospitals have partnered with the government to deliver clinical services under BSKY. a scheme that aims to make healthcare accessible for all, said Pandit after a review Friday

Looking into the progress made in extension of cashless treatment to people at private hospitals inside and outside the state, Pandit directed the nodal officers to scrutinize on a daily basis claims raised at these hospitals against the treatment provided



for payment clearance within scheduled time.

The review showed that 155 super speciality hospitals from 16 states—Andhra Pradesh, Assam, Telangana, Karnataka, Delhi, Gujurat, Maharashtra, West Bengal, Chhattisgarh, Jharkhand, Punjab, Haryana, Rajasthan, Tamil Nadu, Uttar Pradesh, Uttarakhand—have partnered with the state for implementation of BSKY. Similarly, 610 hospitals from different districts of the state have now been included in the scheme.

Major empanelled hospitals in other states include the Christian Medical College, Vellore; Sri Shankara cancer foundation, Bangalore; Tata medical centre, Kolkata; Homi Bhaba (HB) cancer hospital, Vizag and Sangur; Bhubaneswar Borooah cancer Institute (BBCI), Guwahati; HB cancer hospital, Varanasi; Mahamana Pandit Madan Mohan Malaviya cancer

Altogether 765 super speciality private hospitals have partnered with the government to deliver clinical services under BSKY

centre, Varanasi: Advanced centre for treatment, research and education in cancer, Mumbai; and Tata Memorial, Mumbai.

"At district level, 54 coordinators are visiting the empanelled hospitals regularly to keep watch over patient-centric services. At the hospital level, 773 Swasthya Mitras are engaged to provide necessary assistance to patients. Some 140 doctors are looking into treatment provided to patients on daily basis and scrutinizing the claims raised by private hospitals," informed a department official.

# ASSEMBLY SEGMENT PORT IN FOCUS AS PARLEYS ON FOR TICKETS

Balasore, Nov 10: With the 2024 elections drawing near, hectic parleys have begun in various political parties for the nomination of candidates to Basta Assembly segment situated on the coast of Bay of Bengal in Balasore district.

Keonjhar, Nov 10: Forest department officials here recovered the body of a wild tusker from a farmland near Saleikena village under Telkoi range of Keonjhar forest division, Friday.

According to forest officials the elephant's age was around 40 years. After post-mortem, it was confirmed that the pachyderm died due to electrocution. The Forest department has arrested Raju Munda and Khajari Munda, the owners of the farmland where the carcass was found, and their two other brothers are also being interrogated in this regard.

According to reports, a villager spotted the carcass of the tusker and informed others. Informed, Telkoi forest range officer Shibaji Mohan Rao along with others reached the spot and started an investigation into the elephant's death.

The Forest department alleged that the owners of the farmland had installed live electric wires across the field to protect the crops from elephants. The tusker died of electrocution after coming in contact with electric wire. After the incident, the persons involved tried to suppress the matter by hiding the live wires. A post-mortem of the carcass

was conducted in the presence of the local representatives. Later the owners of the farmland were arrested and two more were detained for interrogation.

However, the villagers expressed their disappointment alleging that the Forest department arrested the owners of the farmland without any proper probe.

Aspirants in various political parties have started knocking the doors of their leaders to get the party tickets for the Assembly segment. Several hopefuls from the ruling Biju Janata Dal (BJD) are vying for ticket from this seat which has remained a non-Congress stronghold for the last 35 years.

However, amidst the hullabaloo, all eyes are on the Subarnarekha port which is under construction at Choumukh panchayat under Baliapal block of the Assembly segment. The

port is being built at a brisk pace after the Centre and the state government gave their approvals.

In view of the possibility that a township may come up after the construction of the port, leaders of various political parties have started exercising their influence in the Assembly segment. Basta Assembly constituency, comprising 45 panchayats of Basta and adjoining Baliapal

blocks, has remained a non-Congress bastion for the last 35 years. The erstwhile Janata Dal was the first to win from this constituency, which later went to the kitty of the ruling BJD. Former minister Raghunath

Mohanty was elected for five times from this segment while Nityananda Sahu won twice by defeating their nearest Congress rivals each time. Chatters are abuzz that the

incumbent MLA Nitvananda

Sahu may not get the party ticket this time owing to old age and related health complications.

As a result, the BJD state leadership is looking for a successor in this constituency. Sources said Nityananda has launched allout preparations to get the party ticket for his son Anjan and field him from this constituency.

On the other hand, the name

of entrepreneur Rabindranath Andia is also doing the rounds. He has been with the ruling party for long and helped build the party organisation from the grassroots level. He has stood with people during natural calamities and extended them all help.

Subasini Jena, wife of former Balasore MP Rabindra Jena and the state executive committee president of Biju Mahila Janata Dal (BMJD), has also thrown her weight for the party ticket. She is aspiring for the ticket by claiming herself as the daughter of Baliapal and daughter-inlaw of Basta block.

Senior party leaders Mahadev Das and Lakshmidhar Das are also vying for the ticket on the basis of their successful performance while working in various posts of the party for long years.

Notably, former MLA Raghunath Mohanty, a senior politician and experienced leader, has remained silent all along these years. He joined Bharatiya Janata Party (BJP) after he was sacked from the ruling party before the 2014 elections.

He contested on a BJP ticket in 2019 polls and lost the seat to ruling BJD. Thereafter, he has been absent in BJP programmes or meetings in an apparent sign that he has distanced himself from the saffron party. Speculations are also rife that he may make a comeback to BJD and get the party candidate.

The opposition party Congress has also taken up various programmes in the constituency with an eye on the elections. Congress leader and Balasore MP candidate Navajyoti Patnaik is frequently visiting the constituency and attending various programmes in his effort to strengthen the party unit with the help of Basta's MLA candidate from Congress Bijan Nayak.

The party workers, having united under the leadership of Bijan Nayak, are working to strengthen the party organisation. Congress leaders are trying to connect with the people by organising protests, strikes and meetings on a plethora of issues such as communication facilities, healthcare services, electrification, drinking water facilities, and farmers' problem. Bijan is the only face in the crowd being seen as the Congress candidate.

Similarly, the saffron party is yet to make it clear whether it will field Raghunath or a new face as its Basta candidate in the elections. However, BJP leader Rabindra Jain is the leading aspirant for the saffron ticket.

### Man awarded life term for murder POST NEWS NETWORK Berhampur, Nov 10: Berhampur Additional District and Sessions Court Judge Indu Sharma sen-

way and decamped with the vehicle to Jajpur.

There the accused sold the vehicle for ₹20,000. When Sunil did not return home that night, his family members tried to contact him in vain.

Ganjam police recovered a body near Nuagaon bridge February 7, 2016 and registered a case of unnatural death. Informed, family members of Sunil reached the spot, identified the body and lodged a complaint at Digapahandi PS.

The post-mortem report revealed that Sunil had been murdered and a murder case was subsequently registered. Acting on the complaint, Digapahandi police arrested Lokanath from Angul and during interrogation he confessed to his crime.

During the trial, Lokanath was lodged in the Berhampur Circle Jail. The judge pronounced the verdict after hearing 18 witnesses and going through the chargesheet.

The market is always very volatile. Only the quantity and price of procurement give you the actual price for the day." Adding to Samal, another seller Viki Kumar said, "Don't forget to add ₹6 per kg as storage charge.'

On a normal day, the city generally requires four trucks of flowers. However, to meet the demand during the festival, more than fifty truckloads of flowers will be put into the market, they said.

The demand is met by importing flowers from Bangalore and Kolkata apart from what is produced locally. "The tribals have become aware of the demand during this season and they are also producing marigolds in good quantity," said Samal. "This year, marigold garlands' prices will definitely go up during these two days. We can smell that looking at the query from the retailers," said Bijaya Samant, another merchant.

Meanwhile, special arrangements have been made like every year, for the fire cracker sales. Shops have been erected in open grounds, at Melana Padia and other areas like at Plant Site and Power House Road. "This is being done as per the order of the administration," said K Ramesh Rao, a cracker seller. This arrangement is being made because of the fire tragedy that struck Rajgangpur a couple of years back. "We have asked for stationing a fire tender at every selling point," said another seller.

# Puzzling U-turn

n a startling reversal, the Modi sarkar has disavowed its own 360degree appraisal system for senior civil servants, specifically for those Lat the level of joint secretary and above. This abrupt change in stance, now asserting that "no such system exists in the Government of India", raises some troubling questions about the Modi sarkar's accountability and its commitment to a transparent and merit-based selection process.

At the time it was introduced in 2015, the government had gone to great lengths to extol the virtues of the 360-degree appraisal system. It stated that the new system was a comprehensive response to the shortcomings of the previous process, which fell short of capturing the "essential" qualities of integrity and capability during the evaluation. In fact, the Delhi High Court upheld the new system in 2017, un-

derscoring its legitimacy. So, why this volte-face? The government's new-found denial of the system is a puzzling and concerning development and will be seen as signifying a lack of consistency and a willingness to change fundamental procedures without clear rationale. Why would the Department of Personnel and Training (DoPT) file such an affidavit before the Central Administrative Tribunal (CAT) circuit bench?

Sources have informed DKB that this was done in response to a petition filed by Indian Forest Service (IFS) officer Sanjiv Chaturvedi of the Uttarakhand cadre who approached the tribunal claiming that he was not being empanelled as a joint secretary at the Union level. To junk an entire system to snub an individual officer, even if he has been a bugbear for the government due to his whistleblower image, definitely sounds like overkill!

#### UPSC overhauls DGP appointment criteria

The Union Public Service Commission (UPSC) has updated its guidelines for the selection of state director-general of police (DGPs). According to these amendments issued last month, only police officers with at least six months left before retirement will be eligible for consideration for the position. Moreover, IPS officers on Central deputation will not be assessed for a state DGP's role if the Ministry of Home Affairs (MHA) informs the state government that they cannot be relieved.

These changes were made to clarify existing unwritten norms and discourage states from appointing DGPs on the brink of retirement or using acting DGPs to bypass the UPSC process and extend their tenure, as some



states, including BJP-ruled states, have done. Sources say that states such as Uttar Pradesh, Punjab, Andhra Pradesh and Telangana have all appointed "in-charge" DGPs or DGPs with "full additional charge". For instance, Uttar Pradesh has not had a full-time DGP since 2022.

Notably, former Punjab DGP V.K. Bhawra has gone to court against the appointment of Gaurav Yadav as acting DGP by the Aam Aadmi Party government of Bhagwant Mann. Bhawra's transfer in the middle of his term, despite UPSC rules stipulating a fixed two-year tenure for a state DGP, prompted this challenge. Earlier this year in June, Punjab passed legislation to independently appoint the state DGP. However, the Punjab Police (Amendment) Bill, 2023, is still pending the Governor's assent to become law.

Interestingly, in 2021, the Centre had proposed to amend the IAS cadre rules to depute IAS, IPS and IFS officers to the Centre without necessarily taking the state government's nod. At the time there were massive protests from the states, and the proposal was shelved. Wonder how the states will take to these new guidelines.

#### Railways' shake-up raises eyebrows

The upper echelons of the Railways underwent a transformative rearrangement. Ten senior railway officers from the Indian Railway Management Service (IRMS) have been cleared for appointment as General Manager.

What's particularly intriguing is the reshuffling of two general managers, who held pivotal positions, into relatively low-key roles. This unexpected development has set tongues wagging within the close-knit railway circles. Rumours suggest that the roots of these decisions may perhaps be traced back to certain significant developments last month. In a noteworthy departure from the established guidelines, S.K. Jha, previously the general manager of Northeast Frontier Railways Construction division, was laterally appointed as the Director General of the Indian Railway Institute of Civil Engineering in Pune, displacing Ram Karan Yadav, who assumed Jha's role. A similar deviation from the norm occurred as C.V. Raman, the general manager of North Eastern Railway, was transferred to the Office of the Secretary to the Divisional Personnel Officer (Railway Stores), Railway Board. This move involved a temporary upgrade of the Level 15 post to Level 16, set to last until September 30, 2025. Sources who are close to the situation have informed DKB that the decisions might be influenced by feedback from investigative agencies and undisclosed information. These undercurrents have, therefore, cast an enigmatic veil over the possible motives behind these lateral shifts.

# **CLEAN ENERGY SOLUTIONS**

The Paris climate agreement, concluded in 2015, has been instrumental in rallying countries around the world to commit to reducing greenhouse gas (GHG) emissions. But setting ambitious climate targets has not always resulted in meaningful action. The United Nations' recent "global stock take" report shows that we are falling short of the drastic cuts needed to achieve climate stability, underscoring the urgent need for governments to act swiftly and decisively to keep global warming within safe limits.

As former regulators, we are confident that developing effective solutions is still feasible. While four economic sectors-industry, transportation, electricity, and buildings -account for 75% of global GHG emissions, well-designed public policies could effectively reduce pollution from these sectors, promote consumer savings, safeguard public health, and stimulate sustainable economic growth

But crafting effective policies to transform our fossil-fuelbased economies in time to avert climate catastrophe and meet humanity's energy needs is a daunting task. Tackling it head-on requires a combination of technical, economic, and political expertise, along with significant financial resources and labour, but the agencies charged with devising and implementing these critical policies are understaffed and underfunded. Too often, regulators have no choice but to rely on the information provided to them by the very industries they are charged with overseeing. This dynamic can result in weak regulation and missed policy objectives.

Crucially, independent NGOs can diminish this power imbalance by providing policymakers with the information and technical know-how they need to design robust regulations that reduce harmful emissions effectively.

The US Environmental Protection Agency's efforts to reduce truck pollution are a case in point. In 2016, when the EPA was drafting rules to limit GHG emissions from heavy-duty vehicles, like commercial trucks. various industry bodies provided policymakers with contradictory data. The International Council on Clean Transportation (ICCT), an independent think tank, undertook its own comprehensive study, which included detailed cost projections for the proposed regulations.

The ICCT's impartial analysis provided the EPA with data demonstrating the cost-effectiveness of a stringent pollution standard. Consequently, these regulations are expected to result in emission cuts equivalent to 294 coal plants, save truck owners \$170 billion in fuel costs, and prevent up to \$209 billion in damages over the next 30 years, positioning the United States as a world leader in truck efficiency.

Since then, the ICCT has assisted several governments in crafting regulations to improve commercial-truck efficiency. Using the organization's research, the European Commission drafted its firstever rule targeting pollution

from commercial trucks, which is projected to reduce truck emissions by 150 million tonnes by 2035.

Specialized NGOs can also assist emerging economies, particularly those with fewer resources, in kickstarting transformative climate programmes. By facilitating the rapid adoption of clean-energy solutions, such organizations can increase access to affordable, pollutionfree electricity. Moreover, rules that promote the use of cuttingedge technologies can foster innovation, enhance competitiveness, and help countries position themselves as climate leaders, benefiting their people and the planet.

In 2006, for example, India launched a nationwide appliance-efficiency programme. Through a dedicated division of the Bureau of Energy Efficiency (BEE), officials collaborated with NGOs such as CLASP (formerly known as the Collaborative Labeling and Standards Appliance Programme) to adapt key features from successful efficiencylabeling programmes to the Indian market. CLASP's indepth analysis also helped the BEE identify which appliances it should focus on.

These insights enabled the

BEE to launch its star labeling programme rapidly. The agency then collaborated with another NGO. The Energy and Resources Institute (TERI), to develop an efficiency programme tailored for small businesses. By facilitating cooperation with business leaders, TERI played a piv otal role in creating robust and cost-effective efficiency rules.

Since its launch, India's appliance-labeling programme has offset 400 million tonnes of GHG emissions—roughly equivalent to the annual emissions from India's transportation sector – and is projected to account for 30% of the country's emissions reduction by 2030. In addition, India has established itself as a leading manufacturer of energy-efficient air conditioners, owing to the growing demand for sustainable cooling solutions amid rising global temperatures. With efficiency programmes cutting corporate emissions by 105 million tonnes annually, Indian industry now ranks among the world's most

energy-efficient. Although such activities rarely attract significant attention, unbiased research provides regulators with the data they need to devise transparent and effective environmental policies. Technical assistance from independent NGOs can lay the groundwork for the policy successes needed to overcome the climate crisis.

As developing and developed economies enhance their state capacities, they will grow more confident in setting ambitious targets, creating a virtuous cycle Given the right support, we can ensure that the world's next climate-action report card features grades that make future generations proud.

The talk of India emerging big has been in the air for the last five-six years or perhaps more, but the specific target of reaching \$30 trillion has gained momentum, especially after the pandemic.

In this connection, it is also pertinent to refer to the fact that the financial liabilities have risen from 4.1 percent to 5.8 percent.

As a consequence, the net financial assets of households in 2022-23 were 5.1 percent of GDP, considerably lower than the historical average of 7.5 percent. These are quotes reflective of the inability of people to save as their earnings have not kept pace with market trends while borrowings have increased, not just from banks but also from private money nomic scenario is a recent report indicating that unemployment in the country crossed 10 per cent in October, as per figures released by the Centre for Monitoring Indian Economy (CMIE). In such a scenario, with the present supplementary grant of ₹28,000 crore, the allocation for the NREGA programmes is the lowest in the last four years.

The problems facing the country as also the external scenario are not at all congenial to high growth. Though entrepreneurship has grown, this is mainly concentred in cities.

The potential of agriculture has not been explored fully and though value addition has taken place, to some extent, this could have increased several times more

The labour-intensive sectors have not been given the push and subsidies are not forthcoming. There is no government plan to identify these sectors and promote India's handloom and handicrafts in a big way globally. It is only the big businesses, the big agricultural farmers, and the organised sector employees who have benefited from the policies

Shimla. Nov 10: As many as 140 missing persons, including 118 women and 22 children, were traced by the Himachal Pradesh Police during a special campaign in October, police said.

Special teams were constituted for the campaign. Twenty women -- the highest -- were traced in Solan district followed by 18 in Sirmaur and 16 in Baddi, according to a statement issued here.

The highest number of children -- five -- were found in Hamirpur district, followed by four in Kinnaur and three in Mandi, it said

# Won't issue direction on odd-even scheme: SC

New Delhi, Nov 10: The Supreme Court Friday made it clear that the decision on introducing the odd-even car rationing scheme in the national capital has to be taken by the city government and pulled it up for shifting the burden onto the court.

After the day's proceedings in the apex court, which is hearing a matter on the worsening air quality in the Delhi-National Capital Region, Environment Minister Gopal Rai said the Delhi government has postponed the implementation of the oddeven car rationing scheme as there has been a notable improvement in the air quality due to rain.

Addressing a press confer-ence here, Rai said the government will review the air quality situation after Diwali and a call on the odd-even scheme may be taken if there's a sharp increase in pollution levels. The Delhi government had earlier announced it will implement the odd-even scheme a day after Diwali from November 13 to 20, when air pollution is likely to peak.

During the hearing in the top pollution. court on Friday, a bench headed by Justice Sanjay Kishan Kaul said the court had nothing to do with the odd-even scheme and it had never said that it should also apply to taxis entering Delhi from the adjoining



While hearing the matter on November 7, the apex court had questioned the effectiveness of

the scheme following which the city's environment minister had said it will be implemented only after the top court has heard the matter on Friday and issued an order. The top court is seized of a

plea filed in 1985 by environmentalist M C Mehta on air pollution. Several issues concerning pollution have arisen during the hearing of the matter. On Friday, the apex court said it had flagged the odd-even issue at the last hearing after an advocate, assisting it as an amicus curiae, said the odd-even plan does not actually help reduce air

The counsel representing the Delhi government said taxis from adjoining states were required to be allowed into Delhi as commuting will become a major problem otherwise. Lakhs of people working in Delhi live in cities like Noida and

Gurugram in Uttar Pradesh and Haryana.

"I am agreeing with you. We never said that. Don't try to nonperform and shift the burden onto the court. This is what is happening," Justice Kaul observed."All we flagged was an issue that the amicus was saying that really this odd-even does not help. It has not proved to help. But you say now, we will implement odd-even and also implement odd-even on taxis. Did we ask you to implement odd-even on taxis? We did not ask you to implement it," the bench said.

The counsel argued that the odd-even plan may not have very large mitigating effect on pollution, but even if it has a small impact, it will count.

The lawyer said one of the major causes of pollution, as observed in studies, was traffic congestion on roads and oddeven helps decongest them."What you have to do, you have to do. We are not here to tell you what to do," the bench told the lawyer.

## Vijayendra appointed Karnataka BJP chief

New Delhi, Nov 10: The BJP Friday appointed Vijayendra Yediyurappa, the son of former Karnataka chief minister BS Yediyurappa, its state unit president, a decision that underscores the party leadership's acknowledgement of the veteran Lingayat leader's enduring influence on its fortunes despite its avowed stand against promoting family politics.

Vijayendra, a first-time MLA, is seen as a deft organisational leader and has impressed the party leadership with his abilities in various roles assigned to him, party sources said. He replaces Nalinkumar Kateel, who belongs to an OBC caste.

The appointment of the 47-year-old leader, seen as the political heir to Yediyurappa, ends months of speculation as a change of guard in the state was widely expected since the BJP suffered a big defeat to the Congress in the assembly polls held in May this year.

Though it was always a strong probability that the BJP will pick a Lingayat leader but its choice of Vijayendra ignoring the dynastic plank, something it has used to target rivals, is as much an acknowledgement to his potential as to the political importance his father continues to wield despite being eased out of electoral politics by the party.

Yediyurappa is also a member of the BJP's apex organisational body, Parliamentary Board. His elder son B Y Raghavendra is a Lok Sabha MP and the BJP has often tried to ensure that it is not seen encouraging more than one member of a family in politics.

The party is now expected to appoint a Leader of Opposition in the state assembly, a post which is likely to go to a non-Lingayat MLA, and thereby ruling out Basavaraj Bommai, a fellow Lingayat who had replaced Yediyurappa in July 2021 as Chief Minister.

# India, US decide to expand strategic ties

New Delhi, Nov 10: India and the US Friday vowed to deepen their strategic partnership by shoring defence and security ties and boosting cooperation in the Indo-Pacific in the face of China's increasing military muscle-flexing even as they rolled out plans to jointly manufacture an armoured infantry vehicle. In the fifth annual '2+2' min-

isterial dialogue, Defence Minister Rajnath Singh, External Affairs Minister S Jaishankar and their American counterparts Lloyd Austin and Antony Blinken explored ways to support India's goal of becoming a global hub of defence manufacturing and develop cutting-edge tech-nology to address critical security needs.

East in view of the Hamas-Israel conflict, the Russia-Ukraine war, China's aggressive behaviour in the Indo-Pacific and the overall regional security challenges figured prominently at the talks.

At a media briefing, Austin said both sides talked about the increasing security challenges posed by China and that India and the US have a common goal of a free and open Indo-Pacific."Today, we agreed to move forward with the co-production of armoured infantry vehicles. We also discussed steps that we can take to strengthen our supply chain security and integrate the provision of goods and services from US and Indian firms," he said. The US Defence Secretary said efforts are underway to ensure that India gets 31 MQ-9B drones from the US as quickly as possible.

AGENCIES London, Nov 10: British Prime Minister Rishi Sunak is under pressure to sack his Home Secretary, Suella Braverman, as the row surrounding her controversial newspaper article at-

tacking the Metropolitan Police over its handling of Israel-Hamas protests in London continues to gain momentum Friday. While Sunak's official

spokesperson at 10 Downing Street has said that he has "full confidence" in the Home Secretary, they did confirm that the contents of 'The Times' Op-Ed did not have the full clearance of her boss.

The harshly worded piece on Wednesday attacked the Met Police for having "double standards" and "playing favourites" by not taking tougher action against pro-Palestinian protesters when they turned aggressive."The words that she used are not words that I myself would have used," UK Chancellor Jeremy Hunt told broadcasters when asked about the row. While clearly distancing himself from her stance, the senior Cabinet minister stressed that he has a "productive relationship with her as a colleague" and reiterated that Sunak "has full confidence in her".

It comes as the Opposition Labour Party and the Liberal Democrats and even some sections of Braverman's own Conservative Party are calling for her removal from office over her actions, which could be a breach of the ministerial code for ignoring prime ministerial approval before publication of an article.

"Suella Braverman... Is entitled to her views but she should make them privately within the Cabinet meeting and the government should come to a clear position, said Darren Jones.

The Labour MP said the position she put forward in her Times article is "fundamentally in breach of her responsibility of being the Home Secretary because it is for the police to decide "operationally how to maintain order on our streets".

# China says Dalai Lama's successor needs its approval

All "reincarnated Tibetan living Buddhas, including Dalai Lamas and Panchen Rinpoches, must be looked for within the country, decided through the practice

Beijing, Nov 10: China Fridav asserted that any successor to 88year-old Dalai Lama should be from within the country and his heir needs to have its approval, as it projected the strategically located Tibet region as the gateway to South Asia by highlighting the infrastructure development close to the Indian border.

China, which refers to Tibet as Xizang, is increasingly anxious as the octogenarian Dalai Lama, who lives in exile in Dharamsala in India, will take the lead in appointing his successor, which could have a profound spiritual impact in the Himalayan region as his legacy is ingrained in the minds of Tibetan masses.

Though Beijing asserts the Dalai Lama's successor needs its approval, observers say it remains concerned as the present Panchen Lama, the number two spiritual leader who was appointed by it after unseating the boy nominated by the Dalai Lama, has not gained much traction in Tibet.



The white paper titled "Communist Party of China (CPC) Policies on the Governance of Xizang (Tibet) in the New Era: Approach and

Achievements" also highlighted the crackdown to combat separatism in Tibet.

"The fight against infiltration, subversion and secession continues... Xizang, adopts a proactive approach to combat secessionism," it said.

'The reactionary nature of the Dalai Group has been exposed and denounced, and the regional government relies closely on the people of all ethnicities to resist all forms.

"It is now deeply rooted in the people's minds across the region that unity and stability are a blessing, while division and unrest lead to disaster. They are ever more determined to safeguard the country's unity, national sovereignty, and ethnic solidarity," it said.

China has also expressed its strong opposition to the United States appointing a "Special Coordinator for Tibet Issues" and criticised Washington's assertion that Beijing should not interfere in the selection of the

Dalai Lama's successor.

On the present Dalai Lama, who is 14th in the long line of succession, China reiterated he is "by no means just a religious figure, but rather a political exile, who has long been engaging in anti-China separatist activities, and attempting to split Tibet from China." The white paper denies any crackdown on Tibetan Buddhism in Tibet, saying China fully guarantees the freedom of religious belief and promotes Tibetan language along with Mandarin.

It also highlighted infrastructure in Tibet and the border areas in Arunachal Pradesh, which it claims as part of Southern Tibet. China has built high-speed trains in Tibet near the Indian border areas, which enables it to speed ily move troops.

### **Poland's Oppn parties** sign coalition pact

Warsaw: The leaders of the Polish opposition parties that together won the most votes in last month's election signed a coalition agreement Friday that vows to restore the nation's legal order and strengthen its international position and security in light of Russian aggression against neighbouring Ukraine. The parties collectively won the Oct. 15 vote, but still will not have an immediate chance to try to form a government. The current governing Law and Justice party received more votes than any other single party but fell far short of a majority. Still, it will get the first chance to form the next government - something widely viewed as doomed to fail. The opposition groups called themselves the "democratic opposition" as they ran on separate party lists but vowed to cooperate to restore democracy after eight years of rule by Law and Justice, which has been accused by the EU of eroding the rule of law.

New Delhi, Nov 10: Burman family -- the promoters of Dabur -- has filed a complaint with regulatory authorities seeking a probe into sale of shares by Religare Enterprises Ltd's Chairman Rashmi Saluja.

As per the complaint, Saluja sold her share in Religare Enterprises Ltd (REL) immediately after the Burman family disclosed to her that they intend to make an open offer for the financial services firm.

Entities controlled by the Burman family -- promoters of FMCG major Dabur -- have written to the Securities and Exchange Board of India (Sebi) and stock exchanges that Saluja sold a portion of her personal holdings in Religare Enterprises Ltd a day after meeting a representative of the Burmans

September 20. Saluja at the meeting was in-

formed about the intentions of Burmans, who held a 20.15 per cent stake in REL and had bought another 5 per cent, to make an open offer to buy another 26 per cent stake from open market to take a controlling stake in the financial services firm, Dabur India Chairman Mohit Burman told PTI in an interview.

**REL** management September 25 welcomed the open offer but later said the offer price of ₹235 per share is undervalued. REL shares were trading at ₹221.85 on the BSE Friday.

Burman family head Mohit Burman told PTI he was surprised at the change of stance. "Maybe some of the people do not want to let go of the control." he said.

Religare, however, refuted the



allegation of Saluja selling shares after being made aware of the open offer, saying the chairperson had sold ESOPs after a long process that was triggered several days prior to the September 20 meeting.

The process for ESOP exercise through financing and sales by Saluja and other 12 employees was set in motion several days earlier, a spokesperson of REL said.

Four entities of the Burman family -- MB Finmart, Puran Associates, VIC Enterprises and Milky Investment and Trading Co -- have written an e-mail to Sebi, a copy of which was seen by PTI, in which they have alleged serious lapses on sale of personal share by REL Chairperson Rashmi Saluja.

Their representatives in a 45minute meeting September 20 had informed about their intention to bring an open offer and this was communicated to the chairperson in her professional capacity.

However, much to their "surprise", the chairperson sold 12.93 lakh shares September 21 and 22, representing 0.4 per cent share capital of REL.

Burman family entities, which collectively hold 21.24 per cent in REL, wrote this to the board of the company and approached Sebi and also to the NSE and the BSE, informing them about this sale after they failed to get any response from the company.

"Rashmi Saluja categorically denies the fact that the representative of the Burman family informed her of the proposed open offer during the meeting... As per standard corporate governance, exercising of listed stock options by employees requires requisite approvals which span across several months before the actual sale...In the said allegation, the approvals for the sale were already in place months before the said meeting," REL spokesperson said while replying to a query. Burman family, a promoter

of Dabur India and other entities such as Eveready Industries, through its entities, had in September announced a ₹2,116 crore open offer to the shareholders of REL to acquire up to 26 per cent stake in the company

However, the independent directors of the REL have raised red flags alleging fraud and other breaches by Burman family entities and had regulators including Sebi, the Reserve Bank of India and the Insurance-Regulatory and Development Authority.

# **SA edge past spirited Afghans**

Ahmedabad, Nov 10: Calmness of Rassie van der Dussen and the fire of Gerald Coetzee helped experienced South Africa overcome a spirited resistance from Afghanistan to carve out a fivewicket win in their last league game of the World Cup here Friday.

Set a target of 245, South Africa, who are already assured of a place in semifinals, completed the task with Van der Dussen remaining unbeaten (76 n o, 95b, 6x4, 1x6). Andile Phehlukwayo was unbeaten on a 37-ball 39 (1x4, 3x6) after a match-winning partnership of 65 runs with Van der Dussen.

Earlier, pacer Gerald Coetzee (4/44) was excellent with the ball as Afghanistan were limited to 244 despite Azmatullah Omarzai's impressive unbeaten 97 (107b, 7x4, 3x6), Omarzai's knock, however, helped the Afghans to recover from 116/6.

The defeat notwithstanding, Afghanistan, who shocked defending champions England and Pakistan during a very promising campaign, would go home with their heads held high.

Despite continuing his good run in the tournament, Omarzai unfortunately could not record his maiden ODI hundred after failing to score off the last three balls of the final over.

On a pitch without any demons, South Africa started their chase confidently. But, as the match progressed, things didn't pan out the way South Africa would have liked them to. In the end, they achieved it



with 15 balls remaining after a mighty scrap.

Quinton de Kock (41) made his intentions clear quite as the dashing left-handed batter went past New Zealand's Rachin Ravindra to become the leading scorer of this tournament. However, he couldn't convert his start.

Meanwhile, skipper Temba Bavuma's (23) poor run continued. Aiden Markram (25) and

David Miller (24) also gave their wickets away after getting starts while Heinrich Klaasen failed to make a mark. Earlier, Afghanistan were off

## ICC SUSPENDS SLC FOR **GOVT INTERFERENCE**

Dubai, Nov 10: The International Cricket Council (ICC) Friday suspended Sri Lanka Cricket (SLC) due to government interference. The Sri Lanka government had sacked the SLC following the team's disastrous show at the World Cup, where they lost seven of the nine games.

SLC was reinstated by the court of appeal, thus further deepening the crisis in the country's cricket governing body. A joint government and opposition resolution in parliament demanded the resignation of the SLC's management, Thursday.

"International Cricket Council Board has suspended Sri Lanka Cricket's membership of the ICC with immediate effect," ICC said in a statement.

'The ICC Board met today and determined that Sri Lanka Cricket is in serious breach of its obligations as a Member, in particular, the requirement to manage its affairs autonomously and ensure that there is no government interference in the governance, regulation and/or administration of cricket in Sri Lanka," the statement said. "The conditions of the suspension will be decided by the ICC Board in due course," it added.

The government, which is split over the minister's decision to sack the SLC board of management, came out with a report, recommending a brand new constitution for the governing body with a new voting structure to appoint office bearers.

#### Osaka all set to make comeback

BISBANE: Four-time Grand Slam singles champion Naomi Osaka will make her comeback to tennis at the Brisbane International warm-up tournament ahead of the Australian Open. Tournament officials Friday confirmed Osaka will contest the December 31-January 7 event to start her 2024 season. A two-time Australian and US Open winner, Osaka was a surprise withdrawal from last year's Australian Open before later revealing she was pregnant. The former tennis No.1 announced the birth of her daughter Shai in July.
