### 32 Palestinians killed

in Israeli bombardment

Gaza: Close on the heels of a fresh warning issued by Israel to the residents of Khan Younis to relocate, at least 32 Palestinians, mostly children, were killed due to an Israeli bombardment of Khan Younis city in south Gaza Saturday, state media reported. According to the Palestinian WAFA news agency, the Israeli aircraft launched several raids on apartments in Khan Younis, which also injured some dozens others. The Israeli army has not commented on the development, reports Xinhua news agency. The latest killings come as Israel issued a new warning to the residents of Khan Younis to relocate. On Friday night, Mark Regev, an advisor to Israeli Prime Minister Benjamin Netanyahu, told US media: "I know it's not easy for them, but we don't want to see civilians caught up in the crossfire."

#### **Open AI CEO Sam Altman sacked**

San Francisco: The board of ChatGPT-maker Open AI said it has pushed out its Chief Executive Officer (CEO) Sam Altman after a review found he was "not consistently candid in his communications" with the board. "The board no longer has confidence in his ability to continue leading OpenAI," the company said in a statement Friday. It has appointed Mira

Murati, OpenAI's chief technology officer, to an interim CEO role effective immediately. #### 41, not 40, trapped in U'khand tunnel

Uttarkashi, Nov 18: As the rescue operation in the partially-collapsed Silkyara tunnel in Uttarakhand came to a grinding halt owing to a technical snag in the US-made auger machine that was deployed to drill and push in pipes through the rubble, the number of workers trapped inside the tunnel was revised to 41 from 40 Saturday.

The 41st person stuck in the tunnel was identified as Deepak Kumar from Muzaffarpur district in Bihar. The NHIDCL, which is constructing the tunnel through Navayuga Engineering Company Ltd, came to know about this discrepancy Friday.

According to an earlier list issued by the NHIDCL, 40 workers were trapped inside the tunnel after a part of it collapsed at around 5:30am Sunday.

The massive operation to rescue labourers stuck in Silkyara tunnel is on hold since Friday when a US-made auger machine deployed developed a snag.

With time running out, officials Saturday began preparations to drill a vertical hole from the top of the hill under which the workers have been trapped.

Meanwhile, another high-performance drilling machine airlifted from Indore in Madhya Pradesh arrived in Silkyara Saturday where its three parts will be assembled before it is deployed for drilling, officials

## Bandh total in 5 dists INDIA READY FOR TITLE SHOWDOWN

LUKEWARM RESPONSE TO SEPARATE KOSHAL STATE DEMAND IN JHARSUGUDA, DEOGARH AND SUNDARGARH

Sambalpur, Nov 18: The 12hour bandh called by Koshal Committee in Western Odisha Saturday over the demand for formation of a separate Koshal state was successful in five districts while it evoked lukewarm response in three other districts. According to reports, the

bandh was total in Bargarh, Bolangir, Subarnapur, Nuapada and Kalahandi districts where government and private offices, educational institutions, banks and financial institutions, shops and markets remained closed while passenger buses remained off roads.

The impact of the bandh was, however, negligible in Jharsuguda and Sundargarh districts. There was no impact of the bandh in Deogarh district too.

The bandh affected normal life in Kuchinda and Rirakhol areas of Sambalpur district but



the district headquarters town of Sambalpur remained largely unaffected. Some supporters of the bandh staged a road blockade at Ainthapali in Sambalpur but police removed them from the spot.

'The bandh passed peacefully and no untoward incident was reported in any parts of western Odisha," ADG (Law and Order) Sanjay Kumar said.

Milita Koshal Rajya Kriyanusthan Committee leader Pramod Mishra claimed that the bandh was successful. "People

from all walks of life including some political groups also extended support to the bandh. We will continue such agitation till the formation of a new state," he said.

President of Koshla Mukti Morcha Sagar Charan Das al leged that the state government has always ignored the western Odisha region.







Bhubaneswar, Nov 18: Chief Minister Naveen Patnaik Saturday dedicated 349 ambulances to the people of the state for better patient care.

Patnaik flagged off the ambulances at Kalinga Stadium here. Out of the 349 ambulances 279 will be managed under 108 emergency ambulance service. The rest 70 will be deployed at the medical colleges and hospitals and district headquarters hospitals (DHHs) to facilitate emergency transportation of patients receiving treatment under the Biju Swasthya Kalyan Yojana (BSKY) to private hospitals, a statement issued by the Chief Minister's Office (CMO), said.

Out of the 70, 30 are Advanced Life Support (ALS) and 40 are Basic Life Support (BLS) ambulances.

The government has spent Rs 148.45 crore for launching the new fleet of ambulances in the state, it said.

With the addition of new ambulances, the total strength of 108 ambulances in the state has gone up to 1,366. At present, more than 4,000 patients are provided 108 ambulance services across the state on a daily basis. Therefore, the inclusion of new ambulances will further boost the reach and scale of the emergency patient transportation.

Bhubaneswar, Nov 18: When Sujata was 21, her father married her o after her mother's unfortunate death. The eldest among three children. Sujata, before marriage, would attend to household chores while taking care of her ailing mother. Now, three years later, she works as a labourer at con-

But Sujata is not the only one who has started working in recent years. As per 2022-23 annual report of the Periodic Labour Force Survey (PLFS) conducted by the National Sample Survey Organisation (NSSO), the female labour force participation rate (FLFPR) for Odisha now stands at a fiveyear high of 44.7 per cent. In other words, 45 out of 100 women, 15 years or above, are now either working or looking for employment.

In 2017-18, when the survey was first conducted, the FLFPR in the state was around 19 per cent (Chart 1), below the all-India rate of 23.3. But after three years of possible Covid-induced stagnation, it has now gone above the national rate of 37.

This increase in female labour force participation suggests that more women are now actively taking part in public life, a sign of development for the state. But there remain deep urban-rural divides.

A closer look at the data shows that the labour force participation for women in rural areas remains higher than urban areas, a pattern that could be attributed partly to the Mahatma Gandhi National Rural Employment Guarantee Act (MGN-REGA), which mandates one third of in opportunities in the rural non-farm sector," says Narayan Chandra Nayak, an author of the article and a profes-Seeking security in self



FLFPR could be the state government's promotion of self-help groups (SHGs) which enable women to start enterprises and market their products.

Data shows, among women participating in the labour force, a large number in Odisha are self-employed, either running their own businesses or helping in household enterprises. Between 2018-19 and 2022-23, the share of self-employed women has grown significantly both in urban and rural areas (Chart 2) as the share of salaried women has fallen along with that of casual labourers.

"Improvement in education among women helps them fetch formal employment as well as get self-employed," says Nayak emphasising the role of lit-



he 'hidden hunger' of micronutrient deficiencies could be an important factor for the global rise in antibiotic resistance, which is often attributed to overuse and misuse of antibiotics, according to an alarming study.

Researchers at the University of British Columbia have in a mice study uncovered startling connections between micronutrient deficiencies and the composition of gut microbiomes in early life that could help explain why resistance to antibiotics has been rising across the globe. 'Globally, around 340 million

children under five suffer from multiple micronutrient deficiencies, which not only affect their growth but also significantly alter their gut microbiomes," said Dr Paula Littlejohn, a postdoctoral research fellow with UBC's department of medical genetics and department of

paediatrics "Our findings are particularly concerning as these children are often prescribed antibiotics for malnutrition-related illnesses. Ironically, their gut microbiome may be primed for antibiotic resistance due to the underlying micronutrient deficiencies," she



added.

The study, published in the journal Nature Microbiology, investigated how deficiencies in crucial micronutrients such as vitamin A. B12, folate, iron, and zinc affected the community of bacteria, viruses, fungi and other microbes that live in the diges-

The team discovered that these deficiencies led to significant shifts in the gut microbiome of mice -- most notably an alarming expansion of bacteria and fungi known to be opportunistic pathogens

Importantly, mice with micronutrient deficiencies also exhibited a higher enrichment of

## Merger of schools misfires, forces students to drop out

Jajpur, Nov 18: The state government's move to merge schools in proximity has backfired and consequent closure of several of them has forced students to drop out from studies

Notably, the per-capita expense made on students studying in government primary schools of the state has reached ₹25.041 in 2021-22 FY.

However, guardians are unable to repose faith on the staterun schools and hesitate to admit their wards for studies. Several schools have been shut down in past owing to merger of schools, an initiative undertaken by the state government.

As a result, many students have been deprived of their educational rights and forced to abandon their studies. This has led to an increase in number of dropouts instead, a report said Saturday.

As many as six schools have been shut in this district due to the mergers while the concerned guardians have written to the authorities of Sarva Shiksha Abhiyan (SSA) demanding reopening of the closed schools.

According to Unified District Information System for Education (UDISE) plus report, dropout rate is on an increase among students from Class-III to Class-X in Jajpur district.

As many as 31,836 students were admitted to Class-II in 2021-22 FY. However, out of them 202 students (0.63 per cent) dropped out in Class-III. Similarly, 567 students in Class-IV, 443 students in Class-V, 772 students in Class-VI, 715 in Class-VII, 991 in Class-VIII, 1.371 in Class-IX and 2,207 students in Class-X left their studies

Observers said the reason behind the rising dropout rate is the merger of some primary and upper primary schools with their nearest schools in rural areas.

Sources said that the primary school in Sabo village under Barchana block is lying closed following its merger with its nearest school in the neighbouring village situated six to seven km away. With two rivers flowing on both sides of the village, more than 35 students are faced a harrowing time to turn up at the school and have been deprived of primary education.

Villagers Chimanaya Kumar Dalai and others demanded to reopen the school and start classes in their village which will be of benefit to scores of students.

Similarly, the school in



## **Polishing Coinage**

hen Congressman Shashi Tharoor complained in a tweet once that the BJP had merely changed the names of 23 Congress schemes, and said that Modi's was a "name-changing" government and not a "game-changing one", his claim was put to the test. It was found that he was right about 19 schemes. It turned out that the Pradhan Mantri Jan Dhan Yojana was the UPA's Basic Sayings Bank Deposit Account; Beti Bachao, Beti Padhao Yojana was the same as the National Girl Child Day programme; Deen Dayal Upadhyay Gram Jyoti Yojana was the Rajiv Grameen Vidyutikaran Yojana; Atal Mission for Rejuvenation and Urban Transformation was the Jawaharlal Nehru National Urban Renewal Mission renamed; the BJP's neem-coated urea was the same as Congress's neem-coated urea; the Soil Health Card scheme was the National Project on Management of Soil Health and Fertility; the Atal Pension Yojana was the Swavalamban Yojana; and even Modi's flagship Make in India was merely the National Manufacturing Policy (NMP) under a new name.

And it was not mere renaming; the entire policy framework in many cases was also a copy-paste job, as a comparison of the Department for Promotion of Industry and Internal Trade's Press Note (2011) and the

Make in India website page on national manufacturing showed. The UPA's NMP scheme spoke of "enhancing the share of manufacturing in GDP to 25 per cent within a decade and creating 100 million jobs.

Make in India seeks "an increase in the share of manufacturing in the country's GDP to 25 per cent" and to "create 100 million additional jobs by 2022 in manufacturing." The UPA's NMP says it will "increase manufacturing sector growth to 12-14 per cent over the medium term." Make in India says it will "increase in manufacturing sector growth to 12–14 per cent over the medium term." The NMP says the policy needs "creation of appropriate skill sets among the rural migrant and urban poor to make growth inclusive." Make in India says it needs "creation of appropriate skill sets among rural migrants and the urban poor for inclusive growth.'

The UPA NMP policy says it will "increase domestic value addition and technological depth in manufacturing." Make in India says it will "increase domestic value addition and technological depth. In fact, the Make in India website not only reflected the Congress scheme but a broken download link also unsuccessfully directed readers to a 2011 document of the older policy.

Elsewhere, Digital India was the same as the earlier National eGovernance Plan;

Skill India the same as the National Skill Development Programme; Mission Indradhanush was the Universal Immunisation Programme: and PAHAL the earlier Direct Benefits Transfer for LPG. BharatNet was the National Optic Fibre Network approved on 25 October 2011, aiming to provide broadband connectivity to all panchayats. When the Rajiv Awaas Yojana was renamed the Sardar Patel National Urban Housing Mission, it came with a claim from the then minister of Housing and Urban Poverty Alleviation, Venkaiah Naidu, that housing for all would come by 2022. A parliamentary committee, headed by Biju Janata Dal member Pinaki Mishra, asked the government how merely changing the name could accelerate implementation. This went largely unreported.

The reality is that the UPA's schemes had anodyne and unmemorable names even though they may have had the same aims. Modi's schemes have catchier names because he spends so much effort personally pol-

A friend observed that Modi's schemes targeted at the wealthy had English names — Digital India, Skill India, Start-up India, Make in India - signalling aspiration. However the schemes for the poor were in Hindi - Ujjwala Yojana, Swachh Bharat Abhiyan, Beti Padhao Beti Bachao, Jan Dhan, Garib Kalyan, PM Kisan, Mudra Yojana — reflecting the branding priority.

Not as much effort on implementation though: Make in India's target was shifted from 2022 to 2025 as manufacturing collapsed in India, and instead of going from 16 per cent in 2014 to 25 per cent in 2022 in fact dropped to  $\overline{13}$  per cent and remaining at 13 per cent in 2023. Make in India has a nice logo though.

Tharoor's good-natured acceptance that such things represented continuity (Manmohan Singh did not say a thing about the renaming) sat in contrast with the BJP's contempt for the very schemes they appropriated. Particular hostility was reserved for the UPA's unique identity scheme, Aadhaar. During the 2014 election campaign, The Times of India ran a headline on 12 March 2014: "Aadhaar a 'fraud', will review it if voted to power: BJP". The party alleged that Aadhaar was a criminal programme and that it would have the CBI investigate it. "This is a dangerous programme to regularise the stay of illegal immigrants in the country. Is Bharat Mata so open to illegal immigrants? The Aadhaar is also in contravention of Supreme Court directives,' Meenakshi Lekhi said in Bangalore while campaigning against the Congressman and Aadhaar architect Nandan Nilekani. "The entire biometric data of people enrolled has been stored outside the country," she added. Nilekani's opponent, Ananth Kumar (who would eventually win), said: "Aadhaar is the biggest fraud on the country."

The next month, Ananth Kumar said the BJP would scrap Aadhaar. Modi himself weighed in against Aadhaar, saying that the money spent on it was wasted, that the NREGA was meant to line the pockets of the Congress and that the Right to Information Act (RTI) was useless.

As it turned out, the BJP under Modi would not only embrace Aadhaar, it would also force it upon all Indians, willing or unwilling, as the NDA expanded India's social welfare schemes, many of which they had inherited and renamed to pretend they were their own.



latest Lancet Countdown report on climate change and health, authored by a group of leading health and climate scientists that I led. Undoubtedly, this grim conclusion will not come as a shock to the millions of people suffering from climaterelated health issues and their loved ones. Most of us, wher-

Our research finds that, compared with 1981-2010, the increasing frequency of heatwaves and droughts over the past few years has exposed 127 million more people to moderate or severe food insecurity in 2021. Meanwhile, outdoor air pollution from the combustion of dirty fuels claims 1.9 million lives annually, and infectious diseases like dengue are expanding to new regions.

Yet, despite 27 years of annual climate-change negotiations, world leaders still refuse to acknowledge the urgent need to phase out fossil fuels. Despite overwhelming evidence that fossil-fuel combustion is the primary driver of the current health crisis, a draft statement on climate change and health, set to be released during the upcoming United Nations Climate Change Conference (COP28) in Dubai, omits any reference to the issue.

With many countries and com-

panies backtracking on their climate commitments, the world is moving in the wrong direction. At the current rate of GHG emissions, we are heading for a global temperature increase of nearly 3 degree Celsius by 2100, far above the 1.5°C target established by the 2015 Paris climate agreement.

The consequences could be catastrophic. Even with a global mean temperature increase of deaths are projected to increase by 370% by mid-century. The most vulnerable groups, the elderly and children, are now exposed to twice as many heatwave days as they were 30 years ago. And with heatwaves becoming increasingly frequent, the number of people suffering from moderate or severe food insecurity could increase by roughly 525 million by mid-century

Beyond these direct effects, the climate crisis undermines individual well-being and the socioeconomic conditions necessary for a healthy population. In 2022, extreme heatwaves resulted in a loss of 490 billion working hours worldwide. Even if we manage to limit global warming to just below 2°C, heatrelated labour loss is projected to increase by 50%. The regions that have contributed the least to climate change – Africa, South and Central America, Asia, and small island developing states

often bear the brunt of climate-related health risks.

Given the urgency of the threat we face, the current pace of global efforts to reduce emissions is insufficient, falling far short of the Paris agreement's targets. Energy-based emissions hit an all-time high in 2022, while renewables still account for only 9.5% of the world's electricity. Households around the world still rely on dirty fuels. In the world's most climate-vulnerable countries, families rely on polluting fuels for 92% of their domestic energy, subjecting residents to toxic air inside their own homes. While policymakers are tempted to address this crisis incrementally, solving one problem at a time or focusing on adaptation alone is insufficient. Without significant emissions reductions, adaptation will be futile. The climate-fueled health crisis cannot be solved without urgently shifting away from fossil fuels. By focusing on climate policies that enhance public health and wellbeing, governments could prevent premature deaths, build a more resilient population and a stronger workforce, and bolster their domestic economies.

How can this be achieved? Our report outlines 11 concrete measures across five priority areas. First and foremost, to ensure that climate hazards re-

main within the adaptive capacity of our health systems, we must reduce GHG emissions in accordance with the Paris agreement. This requires a concerted effort to phase out fossil fuels through a just energy transition that mitigates the health effects of air pollution and expands access to clean, renew able energy, especially in the world's most underserved regions, where energy poverty remains a challenge.

At the same time, we must accelerate adaptation efforts to protect communities already suffering from the health consequences of climate change by bolstering cooperation between the health sector, environmental organisations, and meteorological services. And by eliminating all subsidies, lending, and investment in fossil fuels, we can create space for climate financing and resource allocation to support adaptation ef-

forts in vulnerable countries. The health sector must lead this transition. Strengthening health adaptation is critical to ensuring that our health systems can protect us amid escalating climate disruptions. Crucially, we must implement public-health measures that reduce air pollution, advocate healthier low-carbon diets, encourage active lifestyles, and enforce regulations on polluting industries.

COP28 is a test of world lead ers' commitment to tackle this crisis. A genuine focus on health could catalyse a rapid and sustained shift away from fossil fuels and facilitate adaptation efforts. Failing to do so will result in a conference that does little more than pay lip service to health concerns and validate our collective inaction. Climaterelated deaths will continue to increase, and a livable future will drift further beyond reach.

Moreover, the susceptibility of AI systems to cyber threats introduces the possibility of unauthorised access or manipulation, adding an element of vulnerability to these highly sensitive technologies. To address these challenges, it is imperative for policymakers to recognise the unique risks associated with the intersection of AI and nuclear weapons. Strict regulations, international agreements, and transparency measures are essential to govern the development and deployment of AI in this context. Establishing clear guidelines for responsible AI use in nuclear systems is paramount to prevent unintended consequences and maintain control over decision-making processes. # Corruption in NRC: Hajela skips court summons

A report by the CAG of India hinted at large-scale anomalies over the NRC exercise when Hajela was the coordinator

Guwahati, Nov 18: Former Assam National Register of Citizens (NRC) coordinator Prateek Hajela skipped court summons in a case related to corruption in NRC updation process in the state.

Haiela was directed by a court in Guwahati to appear Friday. However, he claimed not to have received the summons letter.

The magistrate has ordered to publish the court summons order in the newspapers of Assam and Madhya Pradesh.

The 1995-batch IAS officer Prateek Hajela was transferred to Madhya Pradesh through a Supreme Court order in 2019 following threats to his life for the corruption allegation against him during the NRC updating ex-

However, after the completion of three years of deputation, he



was again transferred to Assam, but Hajela applied for VRS instead of returning to the state.

The IAS officer was given VRS by the Assam government on some conditions, and his pension benefits are kept in abevance.

Also, as an investigation is going on against Hajela, at any time, departmental procedures may be initiated against him depending on the outcome of the A report by the Comptroller and Auditor General (CAG) of India hinted at large-scale anomalies over the NRC exercise when Hajela was the coordinator.

His successor Hitesh Dev Sarma alleged that Hajela included the names of illegal Bangladeshi immigrants in the

"Prateek Hajela is a traitor, and he included the names of illegal Bangladeshi immigrants in the NRC through wrongful means, which is a huge crime. It is a threat to national security,"

Meanwhile, one Luit Kumar Barman filed a case in Guwahati alleging that the state government has not taken any action against Hajela even after the CAG report hinted about anomalies. His advocate told reporters Saturday that if the former NRC coordinator does not appear in court even after the publication of the advertisement in the newspaper, the hearing of the case against him will continue unilaterally.

### Drug abuse takes centre stage in Ganganagar

*In the Rajasthan district,* many throng the deaddiction centres in the hope of recovery, having fallen prey to the drugs being brought into the district from across the border

Ganganagar, Nov 18: Ramesh Kumar started injecting heroin while working in Bikaner and remained hooked to the needle for five years, before he decided to go cold turkey.

He battled the worst of pangs when he could not get his fix, at times spiralling into a debilitating despondence. Kumar is now on a steady yet precarious road to sobriety having seen the abysmal depths of heroin addiction. In Ganganagar, there are many like Kumar, who throng its deaddiction centres in the hope of recovery, having fallen prey to the drugs being brought into the district from across the border.

With Assembly poll in the offing, locals in Ganganagar district, situated close to the India-Pakistan border, are pressing for a permanent solution to the drug menace. Kumar, who is



undergoing treatment at a rehabilitation centre, urged the government to proactively work to end the drug abuse in the district. "I was addicted to heroin. I used to do job in Bikaner and my friends made me try it there. Initially, I tried out of curiosity but later I got addicted. I couldn't stop myself and when I did, I used to get headache, stomach pain, nausea. There was no urge to go to work or do anything else, and ultimately. I quit my job," Kumar told PTI.

"Just like the doctors here set up awareness camps for educating people about the drug issues in this area, government too should contribute in that,' said Kumar, who is on the verge of completing his treatment.

Sindhu, 26, recently admit-

ted her husband to a rehabilitation centre. The rampant drug use in the district doesn't surprise her anymore. "The drug issue is huge in this area. From children to youngsters to aged people, I have seen everyone becoming an addict. We want the government to resolve this problem permanently. It's breaking families," Sindhu told PTI.

She said every election, politicians visit door-to-door with the promise to end drug menace in the region but "never pay attention" to it once voted to power.

"Once we elect them, they forget about us. Cases of addiction are only rising, nothing else," she said. While the Congress candidate from the Ganganagar assembly constituency refused to speak on the matter, the BJP and Independent candidates vowed to fix the ssue once and for all.

Manish Bagla, a doctor at a government-licensed rehabilitation centre in Ganganagar, said 250 to 300 patients visit his centre in a month but only 15 of them are admitted at a time due to limited number of beds.

He said that though many addicts come from the neighbouring states, a majority of them are from Rajasthan's Ganganagar and Hanumangarh districts - particularly from the Indo-Pak border areas.

'We receive 8 to 10 patients every day and around 250 to 300 patients in a month. But we only prioritise those patients who have the will to quit,' Bagla, a psychologist and the incharge of Jan Sewa hospital's

rehabilitation centre, told PTI While Congress candidate Ankur Manglani refused to speak on the matter, Naresh Sethia, a local party leader, claimed that drug menace in

Ganganagar is a "national issue." "This is a national issue involving cross-border smuggling. This matter should be looked into by the Centre and the Indian Army. However, we are completely against those who are involved in this. Political parties are distributing liquor ahead of elections and taking advantage of this issue as well, Sethia claimed.

## 40 police shootout cases in Assam in 5 yrs: NHRC

Guwahati, Nov 18: The National **Human Rights Commission** (NHRC) has received over 40 cases of police shootouts of accused persons in custody in Assam over the last five years, its chairperson Justice Arun Kumar Mishra said here Friday.

Addressing a press conference after concluding a two-day camp here to hear cases from the northeastern region. Justice Mishra said a total of 56 cases were heard from the eight states.

'We have received more than 40 cases in the last five years," he said when asked about the large number of police shootouts of accused persons in custody in Assam during the last two-anda-half years. According to the law, every such incident has to be reported to the NHRC, Justice Mishra said. "We are examining each and every case. Wherever we find violation of guidelines, we order compensation to victims or the families," he added.

Justice Mishra, however, did not provide any details on the number of cases that have been disposed of by ordering to pay compensation to the victims.

Along with Justice Mishra. NHRC Members Dr Dnvaneshwar

"The commission heard 56 cases in the presence of officers concerned from the northeastern states and the complainants. With the intervention of the commission, a compensation of ₹3.56 crore has been asked to be paid by the states," the chairperson said.

leged arbitrary and unlawful division or partition of land of the Chakmas in Changlang district of Arunachal Pradesh and alleged rape of a 16-year-old tribal girl in Kokrajhar of Assam, he added. "We also took up the case of erosion of two backward tribal Buddhist villages along Burhi Dihing river in Assam's Tinsukia district. We ordered the government to pay compensation and asked them to take steps to prevent erosion in future," Justice Mishra said.

The commission also held a meeting with the chief secretaries and DGPs of eight states and asked them to submit action-taken reports on various advisories by the NHRC.

#### No alliance for 2024 between BJP, Bodo People's Front: CM

Guwahati, Nov 18: Assam Chief Minister Himanta Biswa Sarma said the state's ruling BJP will not forge an alliance with the Bodo People's Front (BPF) for the 2024 Lok Sabha elections.

Thursday, a day after holding a meeting with BJP allies Asom Gana Parishad (AGP) and United People's Party Liberal (UPPL), the Chief Minister told reporters: "Although (BPF chief) Hagrama Mohilary supported us in the Rajya Sabha polls, the BPF is not included in our alliance."

In the 2021 state Assembly polls, the BJP had teamed up with the UPPL in Bodoland to fight the polls.

At the time, the BPF was in an alliance with the Congress and had struggled to get a good number of seats in Bodoland

This resulted in Mohilary abandoning the alliance with Congress. In recent days, he held meetings with some key RSS members and speculations were rife that he may join the BJP.

Assam BJP president Bhabesh Kalita had also hinted that the BPF may find a place in the BJPled NDA. In the past, Mohilary and Sarma had shared a good equation, with the latter beingthe key person when the BPF first forged an alliance with the Congress in the run-up to the 2006 Assembly polls.

Jaipur. Nov 18: Numerous members of erstwhile royal families have embraced politics ever since India achieved Independence.

After being forced to relinquish their thrones, the princes were clueless about how to stay in public domain, and hence, a few of them got attached to the country's new political system. In fact, even in the forthcoming polls, many erstwhile members of the roval families from Rajasthan are in the fray. Among these are Diya Kumar, Rajsamand MP who has now been fielded from

Vidhyanagar Assembly in Jaipur. Diva Kumari is a sitting member of the Lok Sabha from Rajsamand who first won the 2013 Assembly election from Sawai Madhopur and was part of the Opposition when the Congress

was ruling the state. She is one of the seven MPs to have been fielded by the BJP this



time. Her father, the late Brig Bhawani Singh, a decorated hero of the 1971 war, contested the Lok Sabha polls from Jaipur in 1987 on a Congress ticket but lost to Girdhari Lal Bhargav of the BJP.

'Being a disciplined soldier of the BJP, I am contesting Assembly election on the party's directions. The orders of the BJP are supreme for me and the development of Vidyadhar Nagar, which is a new township in Jaipur, will be my first priority.'

Mahendra Singh, the eldest son of Bhagwat Singh, who in fact is son of the former ruler of Udaipur, won the Lok Sabha elections from Chittorgarh in 1989, though he lost when he contested for the second time. This time, his son Vishvaraj Singh is contesting from the holy city of Nathdwara against veteran congress leader and Assembly speaker Dr C.P.



Joshi, who was a Cabinet minister in the Manmohan Singh government. "I have blessings of my people and my father, who is the head of the erstwhile Mewar royals. I have joined politics after much thought. If elected, I shall work for the development of the holy city of Nathdwara, which has been attracting lakhs of pilgrims," Vishvaraj says.

Another scion of Bharatpur royal family, Vishvendra Singh has been in Janata Dal and BJP as a Lok Sabha MP, who switched to the Congress after Bharatpur became a reserved Lok Sabha constituency. Currently, the state's tourism minister, his political lineage also includes his uncles raja Man Singh and his younger brother Raia Bachhu Singh, MLA and MP respectively.

Man Singh, a seven-time independent MLA from Deeg from

1952-84, died in 1985 in police firing along with two of his supporters when he attempted to damage the helicopter of chief

minister Shiv Charan Mathur. This incident led to the resignation of Mathur in the midst of Assembly elections, and Heera Lal Deopura was made chief minister. The case was investigated by the CBI, and 11 persons were

convicted. Man Singh's daughter Krishnendra Kaur Deepa, 66, was later elected from Nadbai, and she is again contesting as a BJP nominee from the same constituency. She was also a minister in Vasundhara Raje's cabinet from 2013-18.

Siddhi Kumari, scion of the Bikaner royal family and granddaughter of late Dr. Karni Singh. is a three-time MLA from Bikaner who was first elected from Bikaner East in 2003 and is contesting again from her old domain as a BJP candidate.

Another member of the Roval family, Kalpana Devi, a scion of the Kota royal family, was elected from Ladpura in Kota district in 2018, and she has now been fielded once again by the BJP.

Her husband Ijyaraj Singh is a former member of the Lok Sabha who won on a Congress ticket

Incidentally, Kalpana Devi's father Brijraj Singh, a former ruler of Kota, was thrice a member of the Lok Sabha from Jhalawar as a nominee of Jan Singh.

While hearing the matter on Saturday, District Judge A K Vishvesh asked the ASI to submit its report by November 28.

Bhuj: A 'Garud Commando' of the Indian Air Force (IAF) allegedly committed suicide by shooting himself with his service pistol while on duty at the Air Force Station near Bhuj in Gujarat's Kutch district, police said Saturday. The incident occurred in the early hours of November 16 when the deceased was posted on night duty, they said.

#### Woman beaten up

Thane: Police have registered an offence against a man and his two relatives at Digha in Navi Mumbai for allegedly beating up his wife as they were against bangles, an official said Saturday. The Rabale MIDC police filed the case based on a complaint lodged by the 23year-old woman, he said. As per the complaint, the victim's husband Pradeep Arkade (30) was against her wearing fashionable bangles and argued with her over the issue.

# TN Assembly re-adopts 10 Bills returned by Guv

Chennai, Nov 18: Days after Tamil Nadu Governor RN Ravi returned 10 Bills passed by the State Assembly, the House Saturday met for a special sitting and re-adopted all of them, even as Chief Minister M K Stalin slammed the Governor for withholding the Bills due to his whims and fancies.

Opposition AIADMK, which staged a walkout, asked why a special meeting to readopt the Bills was being held when the government has already taken the matter to the Supreme Court. The BJP, which has 4 MLAs, also walked out.

The Bills, covering different departments including Law, Agriculture and Higher Education, were passed in the wake of Ravi returning them on November 13. The re-adopted Bills were later sent to the Governor for his assent.

Earlier, Stalin moved a resolution to take up for reconsideration, the 10 bills. While 2 bills each were adopted by the House in 2020 and 2023, six others were passed last year. Without giving any reasons, Ravi had returned the Bills, mentioning "I withhold Assent" to them. Stalin said.

Under the proviso to Article 200 of the Constitution, if they were passed again and presented to the Governor for assent, he "shall not withhold assent therefrom." The CM also made a stinging attack on Ravi, alleging the Governor was keen to block the govern-

ment's initiatives.

He alleged non-BJP ruled states were being targeted through Governors, apparently by the Centre. Stalin said if a "power" that can stop the House from enacting a legislation emerges, it will severely hamper democracy and that this was his apprehension.

It was the duty of a Governor to give assent to Bills passed by a House that has an elected government. "He can seek legal

from the government if required and the government has to give it," he said, adding such clarifications have been given

"At no instances have such clarifications been not given. In such a situation, him (governor) not giving assent to the Bills passed by the Assembly due to his whims and fancies and returning them amounts to insulting the people of Tamil Nadu and this House," Stalin said. Those who could not stomach his government coming out with pioneering initiatives were trying to "scuttle the administration" and "want to do politics using the high post of Governor," he al-

The government has taken up with the President and Prime Minister, the issues regarding the Governor, seeking solution, 'and we had to knock on the doors of the Supreme Court only after these efforts bore no fruit," Stalin added

## Mumbai cops book Aaditya

Mumbai, Nov 18: Mumbai Police registered a case against Shiv Sena (UBT) MLA Aaditya Thackeray and a few others Saturday for allegedly `inaugurating a part of a bridge in Lower Parel area of the city without the civic body's permission, an of-

Thackeray, a former Maharashtra minister, claimed that the construction of the bridge was completed two weeks ago but it was not opened to the public as Maharashtra Chief Minister Eknath Shinde had no time to inaugurate it. A First Information Report (FIR) was registered against Thackeray based on a complaint lodged by a Brihanmumbai Municipal Corporation (BMC) official.

A police official said that as per the complaint, Aaditya Thackeray, Sena (UBT)'s members of legislative council Sachin Ahir and Sunil Shinde, former mayors Kishori Pednekar and Snehal Ambekar, and 15 to 20 others inaugurated the second carriageway of Delisle Bridge on Thursday night without the BMC administrator's permission.

The bridge is located in Thackeray's Worli constituency. The Mumbai municipal commissioner currently acts as a state government-appointed administrator as the term of the BMC's general body has expired.



### Deepfake: Govt to meet social media platforms

Deepfakes refer to synthetic or doctored media that is digitally manipulated and altered to convincingly misrepresent or impersonate someone, using a form of artificial intelligence

New Delhi, Nov 18: Amid serious concerns over 'deepfake' videos, the government is all set to meet social media platforms on the issue, with IT Minister Ashwini Vaishnaw Saturday asserting that safe harbour immunity clause will not apply if platforms do not take adequate steps to remove deepfakes.

Vaishnaw told reporters that the government had recently issued notices to companies on the deepfake issue, and while the platforms have responded, companies will have to be "more aggressive" in taking action on such content.

'They are taking steps...But we think that many more steps will have to be taken. And we are very soon going to have a meeting of all the platforms... "Maybe in the next 3-4 days, we'll call them for brainstorming on that and make sure that platforms make adequate efforts for preventing it (deepfakes), and for cleaning up their platforms," Vaishnaw said on the sidelines of a conference.

Asked if big platforms like Meta and Google would be called for the meeting, the minister



replied in the affirmative. Vaishnaw also made it clear that the 'safe harbour immunity' which platforms currently enjoy under the Information Technology (IT) Act will not be applicable unless they move swiftly to take firm action.

"The safe harbour clause, which most social media platforms have been enjoying...That does not apply if they do not take adequate steps for removing deepfakes from their platforms," he said. Internet platforms and social media platforms - the likes of Google, Facebook, X (formerly Twitter) and others - fall within the ambit of an intermediary. The safe harbour clause - under India's Information Technology framework - protects intermediaries from legal action on them for content posted online by their users.

Recently, several 'deepfake' videos targeting leading actors went viral, sparking public outrage and raising concerns over the misuse of technology and tools for creating doctored content and fake narratives

### Air pollution in Delhi: Stringent curbs revoked

New Delhi, Nov 18: The Centre Saturday removed stringent curbs, including a ban on construction work related to linear projects and the entry of polluting trucks into Delhi, following an improvement in air quality due to an increase in the wind speed and a change in the wind direction.

These measures constitute the final stage, Stage IV, of the Centre's air pollution control plan called the Graded Response Action Plan (GRAP). The Commission for Air Quality Management in National Capital Region and Adjoining Areas (CAQM), a statutory body responsible for formulating strategies to combat pollution in the region, asked Delhi and NCR states to revoke all emergency measures, under which only CNG, electric and BS VI-compliant vehicles from other states are allowed to enter Delhi, with

exemptions granted to those involved in essential services.

All medium and heavy goods vehicles not engaged in essential services were also banned in the capital under Stage IV of GRAP, according to the latest CAQM order. The pollution control body said all other curbs under stages I. II and III of GRAP. including a ban on non-essential construction work, mining, stone crushers and diesel generators will continue.

The city's 24-hour average AQI, recorded at 4 pm every day, improved from 405 on Friday to 319 on Saturday, It was 419 on Thursday, 401 on Wednesday, 397 on Tuesday, 358 on Monday, 218 on Sunday, 220 on Saturday and 279 on Friday.

Neighbouring Ghaziabad (276), Gurugram (322), Greater Noida (228), Noida (265) and Faridabad (309) also recorded "very poor" air quality. An AQI between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", 401 and 450 "severe"

and above 450 "severe plus". The air quality forecasts by the Meteorological Department/Indian Institute of Tropical Meteorology do not indicate any steep degradation in the overall air quality of Delhi-NCR in the coming days, the

### MALDIVES ASKS INDIA TO WITHDRAW TROOPS

Male, Nov 18: Less than 24 hours after taking oath as the President of Maldives, Mohamed Muizzu Saturday formally requested the Government of India to "withdraw" its military personnel from his country, saying the Maldivian people have given a "strong mandate" to make this request to New Delhi.

Engineer-turned-politician, Muizzu, 45, took oath Friday as the eighth president of the strate-

gically-located archipelago nation in the Indian Ocean. Underscoring 'Neighbourhood First Policy', Rijiju represented the country at Muizzu's inauguration ceremony. A close associate of former Maldives President Abdulla Yameen, who forged close ties with China during his Presidency from 2013 to 2018, Muizzu defeated India-friendly incumbent Ibrahim Mohamed Solih in the presidential runoff held in September. Muizzu had



indicated during the election campaign that the withdrawal of Indian military troops from the island nation is among the issues that need to be resolved by the two countries.

Soon after the oath-taking Friday. Muizzu asserted that he was firmly committed to ensuring that his country remains "free" of any "foreign military presence" to preserve its independence and sovereignty. However, he did not name any country in his inaugural address. "At the meeting, President Muizzu formally requested the Government of India to withdraw its military personnel from the Maldives.

'The President noted that at the Presidential Election held in September, the Maldivian people had given him a strong mandate to make the request to India and expressed the hope that India will honour the democratic will of the people of the Maldives," the statement from the President's Office said here.

#### **Canadian security** forum honours people of Israel

Halifax (Nova Scotia), Nov 18: A Canadian security forum on Saturday presented an award to the people of Israel for 75 years of democracy, following the Hamas incursion into the country that left some 1,200 people dead and 240 abducted.

The Halifax International Security Forum presents the award annually in honor of U.S. Sen. John McCain, who died in 2018, to "individuals from any country who have demonstrated uncommon leadership in the pursuit of human justice.'

The forum attracts military officials, United States senators, diplomats and scholars.

'On the 75th anniversary of Israel's creation, and in the aftermath of the October 7 attack that resulted in the greatest loss of life to the Jewish people since the Holocaust, it is fitting to present an award that bears Senator McCain's name to: The People of Israel,' the statement read.

McCain was a regular at the forum and his wife, Cindy, was present this year and sat in the front row. Peter Van Praagh, President of the Halifax International Security Forum, presented the award to Lital Leshem, a representative of Brothers in Arms.

The group started as a protest movement of military veterans who opposed Prime Minister Benjamin Netanyahu's judicial overhaul, but transformed itself into the largest nongovernmental aid agency in Israel to help those affected by the latest Israel-Hamas war. It now organises volunteer activities to assist victims and families who were evacuated from border communities. It provides counseling and transportation and arranges volunteers to work on farms where the former workers either fled or were killed or kidnapped.

Leaders from democratic nations — including former Israeli Prime Minister Ehud Barak participated in a discussion Saturday on global security.

#### **White House slams Elon Musk**

San Francisco: The White House has slammed tech entrepreneur and billionaire Elon Musk for his "abhorrent" promotion of antisemitism and racist hate, while several top American companies like Apple have pulled out ads from his social media platform X. Musk, 52, Wednesday endorsed a post on X that falsely claimed Jewish people were stoking hatred against white people, saying the user who referenced the "Great Replacement" conspiracy theory was speaking "the actual truth." The antisemitic conspiracy theory - which posits that Jews want to bring undocumented minority populations into Western countries to reduce White majorities in those nations - is often espoused by hate groups.

#### **IMF revises Pak's foreign loan** requirement to \$25 bn: Report

Islamabad: The IMF has revised down Pakistan's foreign loan requirements to \$25 billion for the ongoing fiscal year -- reducing it by \$3.4 billion in a big relief for its cash-starved economy, according to a media report Saturday. The Washington-based global lender also lowered the economic growth projection to just 2 per cent, turning down the government's external as well as macroeconomic forecasts, The Express Tribune newspaper reported.

#### **Biggest protest in Spain**

Madrid: Waving Spanish flags, about 1,70,000 people marched through Madrid Saturday in the largest protest yet against an amnesty law which Spain's Socialists agreed over Catalonia's 2017 separatist bid in order to form a government. The demonstration, the latest in a series of protests in cities across Spain against the amnesty, took place two days after Spain's Socialist Prime Minister Pedro Sanchez won a four-year term with the backing of Catalan and Basque nationalist parties in return for agreeing to the law. Holding signs that read "Sanchez traitor" and "Don't sell Spain", protesters demonstrated against the law which four judicial associations, opposition political parties and business leaders said threatens the rule of law and the separation of powers. Authorities put the number of demonstrators at 1,70,000.

## SpaceX Starship launch failed minutes after reaching space

Washington, Nov 18: SpaceX's uncrewed spacecraft Starship, developed to carry astronauts to the Moon and beyond, was presumed to have failed in space minutes after lifting off on Saturday during its second test, after its first attempt ended in an explosion.

The two-stage rocketship blasted off from the Elon Musk-owned company's Starbase launch site near Boca Chica in Texas, boosting the Starship spacecraft roughly 55 miles (90 km) above ground on a planned 90-minte flight into space.

But the rocket's Super Heavy first stage booster, though it appeared to achieve a crucial maneuver to separate with its core Starship stage, exploded over the Gulf of Mexico shortly after detaching, a SpaceX webcast showed.

Meanwhile, the core Starship booster carried further toward space, but a few minutes later a company broadcaster said that SpaceX mission control suddenly lost contact with the vehicle. "We have lost the data from the second stage... we think we may have lost the second stage," SpaceX's livestream host John Insprucker said. About eight minutes into the test mission, a camera view tracking the Starship booster appeared to show an explosion that would suggest the vehicle failed at that time. The rocket's altitude was 91 miles (148 km).

The launch was the second attempt to fly Starship mounted atop its towering Super Heavy rocket booster, following an April attempt that ended in explosive failure about four minutes after lift-off. The US Federal Aviation Administration, which oversees commercial launch sites. confirmed a mishap occurred that "resulted in a loss of the vehicle," adding no injuries or property damage have been reported. The agency said it will oversee a SpaceX-led investigation into the testing failure and will need to approve SpaceX's plan to prevent it from happening again. The mission's objective was to get Starship off the ground in Texas and into space just shy of reaching orbit, then plunge through Earth's atmosphere for a splashdown off Hawaii's coast.

The launch had been scheduled for Friday but was pushed backby a day for a last-minute swap of flight-control hardware.

## Spain's new museum of forbidden art

These pieces and dozens more that were subjected to some sort of censorship have found a home in Spain at Barcelona's Museum of Forbidden Art, or "Museu de l'Art Prohibit" in Catalan. The collection of over 200 works, including ones by well-known creators such as American photographer Robert Mapplethorpe and Spain's own Pablo Picasso, is intended to challenge visitors and question the limits imposed on artists in

Goya had to sell his late-1790s "Los Caprichos" prints to the Spanish crown when he feared they could come under the scrutiny of the Inquisition, while Picasso saw his "Suite 347" of erotic drawings displayed in a private room in 1960s Paris.

Although censorship has taken many forms, the museum shows that the drive to silence artists who make challenging works is alive and kicking.



#### Al focus: Amazon lays off in India

New Delhi: Amazon has announced to lay off "several hundred employees" from its Alexa division, including in India, amid a renewed focus on artificial intelligence (AI). #### **Qatar slaps tax** penalty on L&T

Washington, Nov 18: The board of the company behind ChatGPT Friday fired OpenAI CEO Sam Altman - to many, the human face of generative AI - sending shock waves across the tech in-

OpenAI's Chief Technology Officer Mira Murati will serve as interim CEO, the company said, adding that it will conduct a formal search for a permanent CEO.

"Altman's departure follows a deliberative review process by the board, which concluded that he was not consistently candid in his communications with the board, hindering its ability to exercise its responsibilities," OpenAI said in the blog without elaborating

"The board no longer has confidence in his ability to continue leading OpenAI," it added.

Greg Brockman, OpenAI president and co-founder, who stepped down from the board as chairman as part of the management shuffle, quit the company, he announced on messaging platform

"Based on today's news, I quit,"

#### **BANKRUPTCY FEARS**

OpenAI is also not doing well financially, and is burning a lot of cash. Reports surfaced earlier this year that the ChatGPT maker is likely to go bankrupt by the end of 2024 if it doesn't get more funding soon. ChatGPT reportedly costs a whopping \$700,000 (Rs 5.80 crore) per day to operate. Even Altman had admitted in a tweet that "compute costs are eye-watering

Levie, a long-time friend of Sam Altman, said it was nearly impossible to picture OpenAI without Sam (Altman) and Greg (Brockman). "They made AI finally go mainstream after years of it never happening. Can't imagine what happens next.' said Levie. "What happened at OpenAI today is a board coup that we have not seen the likes of since 1985 when the then-Apple board pushed out Steve Jobs. It is shocking; it is irresponsible; and it does not do right by Sam & Greg or all the builders in OpenAI," said Ron Conway, a prominent US venture capitalist, who was an early investor in tech giants such as Google, Facebook (now Meta), Reddit and Pinterest.

New Delhi, Nov 18: The government Saturday said 27 companies, including Dell, HP, Flextronics, and Foxconn, have been granted approval under the production-linked incentive (PLI) scheme for IT hardware.

The scheme, which covers laptops, tablets, PCs, servers and ultra-small form factor devices, is expected to fuel incremental investments of about ₹3,000 crore.

The nod to the applicants comes at a time when India is wooing IT hardware players with policy sweeteners and incentive schemes, making a determined push to position itself as a global powerhouse for hi-tech manu-

New Delhi, Nov 18: Maruti Suzuki India Saturday said its shareholders have approved the proposal to issue shares on a preferential basis to Suzuki Motor Corporation (SMC) as consideration for a related party transaction for the acquisition of 100 per cent stake in Suzuki Motor Gujarat.

The company had sought approval from its shareholders through a postal ballot on two special resolutions for the purpose of fully acquiring Suzuki Motor Gujarat (SMG) last month.

Resolutions as set out in the ostal ballot pertaining to approval of related party transaction, and create, offer, issue and allot equity shares on a preferential basis for consideration other than cash have been approved by the members of the company with requisite majority, Maruti Suzuki India said in a regulatory filing.

The first special resolution of related party transaction was approved with 98.21 per cent in favour and 1.79 per cent against.

The second special resolution to create, offer, and allot equity shares on a preferential basis other than cash consideration to SMC received 98.91 per cent votes in favour and 1.09 per cent against, it added. Last month, the company's board approved the acquisition of SMG for a total purchase con-

sideration of ₹12,841.1 crore. It was envisaged to be discharged by way of issue and allotment of over 1.23 crore equity shares of the company having a face value of ₹5 each to SMC, at a price of ₹10,420.85 per equity share. In August this year, Mary

Suzuki India's board approved the issue of shares on a preferential basis to SMC as consideration for the acquisition of a 100 per cent stake in SMG.

The transaction will enhance SMC's stake in the company to 58.28 per cent from 56.4 per cent currently. Post the acquisition, SMG will become a wholly-owned subsidiary of Maruti Suzuki India.

MSI board, in its meeting held July 31, 2023, had approved the termination of the contract manufacturing agreement with SMG and the acquisition of its shares by SMC at a price to be determined in accordance with all applicable laws and regulations.

### X warns suit against media watchdog

Washington, Nov 18: X Corp, formerly known as Twitter, will file a lawsuit against Media Matters and those who attacked social media platform X, Elon Musk said Saturday in a post on the platform, soon after major US companies paused their advertisements on the site.

"The split second court opens on Monday, X Corp will be filing a thermonuclear lawsuit against Media Matters and all those who colluded in this fraudulent attack on our company," Musk wrote in a post on X, without naming any other parties.

Liberal media watchdog group Media Matters for America earlier this week said it found that corporate advertisements by IBM, Apple, Oracle and Comcast's Xfinity were being placed alongside antisemitic content.

IBM Thursday said it immediately suspended all advertising on Musk-owned X after the watchdog found its ads were placed



next to content promoting Adolf Hitler and the Nazi Party.

Apple, Disney, Warner Bros Discovery and Comcast, Lions Gate **Entertainment and Paramount** Global said Friday they were also

pausing their ads on X. Musk Wednesday endorsed an antisemitic post on X that falsely claimed members of the Jewish community were stoking hatred against white people.

'This week Media Matters for America posted a story that completely misrepresented the real

experience on X, in another attempt to undermine freedom of speech and mislead advertisers, a statement posted by Musk said. "Media Matters created an alternate account and curated the posts and advertising appear-

ing on the account's timeline to

misinform advertisers about the

placement of their posts. Non-profit organisation Media Matters drew attention to the subject, saying as Musk continues his descent into white nationalist and antisemitic conspiracy theories, his social media platform has been placing ads for major brands like Apple, Bravo (NBCUniversal), IBM, Oracle, and Xfinity (Comcast) next to content that supports Adolf

Hitler and his Nazi Party. "X has also reinstated numerous accounts of bigots and paid far-right extremists, apparently including a pro-Hitler and Holocaust denier account, as part of its creator ad revenuesharing programme," Media

New Delhi, Nov 18: The Video Assistant Referee (VAR) is set to become a reality in domestic club competitions from the 2025-26 season, heralding a gamechanging advantage for both Indian Super League (ISL) and I-League teams, All India Football Federation (AIFF) acting secretary general M Satyanarayan said Saturday.

The VAR technology, which was first used in FIFA events in 2016-17, supports the decisionmaking process of the referee in four game-changing situations: goals and offences leading up to a goal, penalty decisions and offences leading up to a penalty, direct red card incidents, and mistaken identity.

Many countries across the globe used VAR in their domestic club competitions after it was first introduced in Australia and the United States

"There will be a big decision on the introduction of VAR very soon. We are doing a study on that," AIFF acting secretary general M Satyanarayan told this agency in an interview.

"Introducing it next season might be difficult for the simple reason that FIFA has to approve the technology, there is a process. More than just getting

the equipment, training of personnel takes a lot of time. "It can be 2025-2026 season, but

you never know. Even if we start now (the process), it will take a minimum of 18 to 20 months (to complete it)," added Satyanarayan, who became the acting secretary general on November 9 after the removal of Shaji Prabhakaran on "breach of trust"

Implementing VAR technology will incur significant costs for the AIFF, but Satyanarayan emphasised the potential benefits for the Indian clubs. "We have to see where the money is going to come from. But ultimately, it's the clubs of the ISL and I-League (which are going to benefit). The margins of victory or loss are sometimes 5 to 8 per cent, so we can get better results

(with the use of VAR)," he said. Technically, the VAR has made its debut in a domestic tournament in March this year during the Santosh Trophy third-place classification match between Services and Punjab at the King Fahd International Stadium in

Rivadh, Saudi Arabia. The VAR technology was used on Indian soil on two occasions earlier – during the AFC Women's Asian Cup in January-February 2022 from the quarterfinal stage and the FIFA U-17 Women's World Cup in October last year.

## VAR likely in 2025-26 Neeraj fails dope test, may lose Para Asiad gold medals

New Delhi, Nov 18: India stares at the unpleasant possibility of losing two gold medals it won during the recent Hangzhou Asian Para Games as Neeraj Yadav failed a dope test conducted by the National Anti-Doping Agency (NADA) a few days before the continental showpiece.

It is learnt that Yadav has tested positive for anabolic steroids in an out-of-competition test conducted in Bengaluru just "six days" before his departure for Hangzhou.

If he is found to have committed a doping offence by the NADA panel, India is expected to lose the two gold medals Yadav won in the F55 javelin and discus throw events in the October

It could also see India dropping one place down to sixth from

the original fifth. In that case, Indonesia, which had won 29 gold, 30 silver and 36 bronze. will rise one place to fifth. India had won 29 gold, 31 silver and 51 bronze but its yellow metal count may now be reduced to 27 if Yadav is found guilty of doping.

"We have written to the NADA that the sample in question might not have been his. Or otherwise, the sample could have been contaminated," Paralympic Committee of India's (PCI) athhead coach S letics Satyanarayana told PTI from

"We got to know of the ADRV (Anti-Doping Rule Violation) November 13 and he has seven days to represent his case. So, his case will be heard November 21," he added.

The 39-year-old Yadav could not be reached despite repeated attempts as he did not respond to calls. Satyanarayana, how-



ever, admitted that India will lose the two gold medals Yadav won in Hangzhou if the para athlete is found guilty of doping by the NADA panel.

'Yes, we will lose the two gold

medals if the NADA panel does not accept our contention. It does not matter whether it is an ADRV in a domestic sample or collected by an international agency or body, his results will

be annulled since the test was done prior to the Asian Para Games," he said.

"But why we are saying his sample could have been misplaced or contaminated is that he was tested twice in Hangzhou and so far we have not heard of any doping offence from the Asian Para Games samples."

Satyanarayana said the PCI will wait for results from the two dope samples given by Yadav in Hangzhou. "If he returns positive in Hangzhou tests, then he is guilty of doping and we have no case. If he comes clean in the two tests in Hangzhou, there is no way he will have an ADRV in the NADA sample because steroids remain for a long time in the body system," he added.

According to Satyanarayan, the NADA has not provisionally suspended Yadav even though he has returned positive for an-

Substitute Jani Atanasov pulled one back for North Macedonia with a header early in the second half and then scored again with a shot that deflected in off Italy defender Francesco Acerbi.

But Giacomo Raspadori finished off a counterattack for Italy in the 81st and Stephan El Shaarawy added another in stoppage time to restore the three-goal advantage.

Italy and Ukraine now each have 13 points but Italy hold the advantage after beating Ukraine 2-1 in September. England, who beat Malta 2-0 and have 19 points, won the group. North Macedonia trail in fourth place with seven points and Malta has zero.

### Bhullar zooms ahead to 7-shot lead in Indonesia

Jakarta (Indonesia), Nov 18: Gaganjeet Bhullar strung together his second card of 63 in three days despite a late bogey to take a considerable sevenshot lead with one more round left in the Indonesian Masters, here Saturday.

Bhullar began the day with a three-shot lead, carded 8-under 63 and moved to 20-under and seven shots ahead of the young Spaniard David Puig (62), who moved to 13-under with his amazing effort. A four-time winner in Indonesia, the 35-year-old Bhullar took a decisive step towards his fifth win in the country.

Bhullar has always been a strong front-runner — three of his



wins in Indonesia, three have been in the country's national open, in 2013, 2016 and in August last year, which was Bhullar's most recent win on the Asian Tour. Bhullar first tasted victory on Indonesian soil at the President — Invitational, 14 years ago.
