Death row: Qatar court admits appeal

New Delhi: A Qatari court has admitted the Indian government's appeal against the death penalty handed down to eight former Indian Navy personnel in that country, according to media reports, even as there was no official word from the Ministry of External Affairs here Friday. The Qatari court Thursday admitted the appeal filed by the Indian government and the next hearing is to be held soon, the reports said. Last week, India said the appeal process against the death sentence given to the eight former Indian Navy personnel by a Oatari court is under process and it was hopeful of a positive outcome from it.

Tunnel rescue ops hit fresh hurdle

Uttarkashi: Drilling at the collapsed Silkyara tunnel to rescue 41 men trapped inside for 12 days was halted again Friday, officials said. Officials said the auger drilling machine faced a hurdle, apparently a metal object, soon after drilling resumed Friday, a day after officials had put the operation on hold following a technical snag. That snag was set right earlier in the day and the 25tonne auger machine was restarted.

Bhubaneswar, Nov 24: Amid protests and walkout by Opposition BJP and Congress members, Speaker Pramila Mallik adjourned Assembly sine die Friday, at least 26 business days ahead of its schedule.

The Winter Session of the House, which commenced November 21, was scheduled to conclude December 30. The Assembly secretariat had notified about 30 business days during this session. Government chief whip in Assembly Prashanta Muduli brought a motion to adjourn the House sine die for the remaining period. The proposal was supported by treasury bench members Shashi Bhusan Behera and Bhupinder Singh. The House could transact for only four days of which two days were wasted.

Hamas frees 24 hostages

Gaza/Israel-Gaza Border, Nov 24: Hamas fighters released 24 hostages Friday during the first day of the war's first truce, the Red Cross said, including Israeli women and children and Thai farm workers.

Nine hours after guns fell silent for the first time in seven weeks, the Red Cross said it had begun an operation to facilitate the transfer of hostages in Gaza to Israel in return for Palestinians held in Israeli jails.

Twenty-four hostages were transferred out of Gaza and handed over to Egyptian au-

thorities at the Rafah border crossing, accompanied by eight staff members of the International Committee of the Red Cross (ICRC) in a four-car convoy, the ICRC said.

Qatar, which acted as mediator for the truce deal, said 13 Israelis had been released, some with dual nationalities, plus 10 Thais and a Filipino. Thirty-nine Palestinian women and children were released from Israeli jails in return for the 13 Israelis, Qatar said.

The deep pain that family members separated from their loved ones feel is indescribable. We are relieved that some will be reunited after long agony," said Fabrizio Carboni, the ICRC's regional director for the Near and Middle East. The Israeli military said the freed hostages had already been brought to Israel.

"The released hostages underwent an initial medical assessment inside Israeli territory. They will continue to be accompanied by IDF soldiers as they make their way to Israeli hospitals, where they will be reunited with their families," the military said.

Under the terms of the four-day Israel-Hamas truce, 50 women and children hostages are to be released over four days, in return for 150 Palestinian women and children among thousands of detainees in Israeli jails. Israel says the truce could be extended if more hostages are released at a rate of 10 per day. The first 13 released Friday were to be exchanged for 24 Palestinian women and 15 teenagers.

A source briefed on the negotiations said the release of the Thai workers, who were all men. was unrelated to the truce negotiations and followed a separate track of talks with Hamas mediated by Egypt and Qatar.

Thai and Filipino farmworkers employed in southern Israel were among around 240 hostages dragged back to Gaza by gunmen when Hamas fighters launched a killing spree Oct. 7.

Nod to projects worth ₹84,918cr

Bhubaneswar, Nov 24: The High-Level Clearance Authority (HLCA), chaired by Chief Minister Naveen Patnaik, Friday approved 12 key industrial projects, including those of Welspun Group, with a cumulative investment of ₹84,918.75 crore.

These projects are poised to create employment opportunities for 42,281 people across various sectors, an official said.

The HLCA approved the proposal of Welspun Living Limited to establish an integrated textile and logistics facility at Choudwar in Cuttack, with an investment of ₹3,050 crore. The project would provide employment opportunities to 20,210 people.

Welspun New Energy Limited's proposal to set up a 0.70 MMTPA Green Ammonia manufacturing unit in Kendrapara with an investment of ₹13,860 crore also got a go-ahead from the state government. The unit will provide jobs to 1,000 individuals.

Welspun Corp Limited will invest ₹3,137 crore to set up 1,00,000 MT ERW pipes, 3,00,000 MT DI pipes, 1,00,000 MT HSAW pipes and 10,00,000 Square Metre Pipe Coating plant in Sambalpur. It would provide jobs to 3,830 persons.

Among others, Tata Steel's plan to establish a HR and CR Coil plant in Dhenkanal also received HLCA's nod. With an investment of ₹10,351.11 crore, the project would create employment opportunities for 3,725 persons.



She added, "So, we decided to postpone the transfer and withdrew the team that had been deployed. Dutt was counselled against making his shift to Yerawada an issue and it was impresse upon him that his apprehension about an 'encounter' was misplaced. Sometime later we were able to quietly







The BJD's reaction came after two statements of Harichandan during his recent Odisha visit. The Chhattisgarh governor had expressed displeasure over crowd mismanagement and plight of devotees at Srimandir in Puri. Referring to the ongoing controversy on ST people being allowed to transfer their land to non-tribals, Harichandan, who was earlier the revenue and disaster management minister in Odisha in the BJD-BJP coalition government from 2000 to 2009, had said tribal people's rights should be protected. "We hope Governor Biswabhusan Harichandan will refrain from making such statements which is not expected of him and his office. His responsibility is to stay nonpolitical," BJD spokesperson Sasmit Patra and Priyabrata Majhi told reporters at a joint press conference. They also described Harichandan's statement as "unwarranted" and suggested the Chhattisgarh governor to maintain sanctity and dignity of his office. Over the past few days Harichandan expressed views on various subjects on Odisha which is not expected of him, the BJD leaders said.

Cabinet sends tribal land transfer decision for review

Bhubaneswar, Nov 24: Faced with criticism of the move to allow transfer of land belonging to ST people to non-tribals. the government Friday informed the Assembly that it has sought reconsideration of the recommendations based on which the decision was taken.

The Cabinet had November 14 decided to amend a law to allow the Scheduled Tribe people to sell their land to non-tribals in scheduled areas, with permission from the state government However, the decision was put on hold three days later.

Opposition parties have created a ruckus in the Assembly demanding that the decision Wednesday and Thursday, taken following recommendations from the Tribes Advisory Council (TAC), be withdrawn.

Parliamentary Affairs Minister Niranjan Pujari informed the Assembly that a Cabinet meeting chaired by Chief Minister Naveen Patnaik Friday urged the TAC to reconsider its earlier decision of allowing the ST people to transfer their land

to non-tribals.

"Based on the recommendation of the TAC's meeting July 11, 2023, the state Cabinet had approved a proposal to amend the Odisha Scheduled Areas Transfer of Immoveable Property (By Scheduled Tribes) Regulation, 1956," Pujari informed the House.

Both the BJP and Congress members demanded that the state government totally withdraw its November 14 decision instead of referring it to the TAC for reconsideration.

Congress Legislature Party (CLP) leader Narasingha Mishra

said, "The state Cabinet itself could have withdrawn such a decision. But things became further suspicious as it recommended the TAC to reconsider its

BJP Chief Whip Mohan Majhi said, "Friday's Cabinet decision indicated that the state government has been forced to eat its own words. The actual intention of the state government is now exposed. They were working against the interest of tribals and now put in a fix."

BJP MLA Nityananda Gond alleged that the state government was lying in the name of the TAC. "I am a member of the TAC and the issue of tribal land transfer to non-tribals was never discussed in the meeting. Now. the government was claiming that it had decided to amend the law allowing transfer of ST land to non-tribals," Gond said in the Assembly challenging the state

government to prove him wrong. Revenue and Disaster Management Minister Sudam Marndi, however, said that the state cabinet had taken the decision based on the recommendation of

TAC at its meeting June 28, 2018.

Foundation stone laid for NSTI Plus

said. "The NSTI Plus will emerge as a modern gurukul to equip candidates as well as trainers with industry and future-ready skills," Pradhan said.

Pradhan said the ministry of skill development and entrepreneurship is introducing several fresh and innovative initiatives and NSTI Plus is a robust step in this direction.

The selection of courses and training programmes will be de-

signed in association with industries to meet the needs of

the local community. On completion of training, the ministry will provide certificates to students in collaboration with Indira Gandhi National Open University (IGNOU), National Institute of Open Schooling and NIESBUD to propel vertical and horizontal mobility of the candidates, the official said.

Paradip, Nov 24: The first phase of the dry bulk cargo terminal at the western dock of Paradip Port is expected to be operational in early 2025, an official said. Last year, a JSPL-led consortium won the bid to build the cargo terminal with a 25 million-tonne capacity.

A special purpose vehicle, Jindal Paradip Port Limited (JPPL), has been formed by the leading steel major Jindal Steel & Power and Jindal Port Private Ltd for the project. JPPL will invest about Rs 3,392 crore for development of the western dock of the Paradip Port, the official said.

"The first phase of the project with a capacity of 12.5 million tonne per annum is expected to be operational in early 2025, the company official said. Jindal Steel & Power Ltd chairman Naveen Jindal Thursday performed Bhoomi Puja for the construction of the 25-MT capacity dry bulk cargo terminal.

'Karuna Silk' showing mercy to silkworms

Bhubaneswar, Nov 24: Odisha has adopted a new method where silk is extracted without killing silkworms for making traditional 'Patta' sarees, a senior official of the Handloom department said.

The new silk is named 'Karuna Silk' as compassion is involved in the procedure instead of killing silkworms, the official said.

As per trade information, a typical mulberry silk saree is produced by killing 10-20 thousand silkworms. Similarly in the traditional process, 5-7 thousand silkworms lose their life in the making of a tasar silk saree.

Handlooms, Textiles and Handicrafts Department Director Shovan Krishna Sahu said, "Our Chief Minister Naveen Patnaik always promotes the idea of nonviolence and desires that all production processes follow the same. So we wanted to promote compassion by breaking the traditional method of 'Filament Silk' which kills the silkworms. In the new process, we let go of the moth honouring its life cycle".

"When the moth flies away from the cocoon it ruptures the fibre. Through the 'worsted spinning process' we develop the silk fibre ready for dyeing and weaving. This humane process adopted by Odisha is being appreciated in

20 mins workout can boost brain after a bad night's sleep

he study, led by the University of Portsmouth researchers explored how sleep, oxygen levels, and exercise affect our ability to perform mental tasks

The team found that cognitive performance improves during a bout of moderate intensity exercise, regardless of a person's sleep status or oxygen

"We know from existing research that exercise improves or maintains our cognitive performance, even when oxygen levels are reduced. But this is the first study to suggest it also improves cognitive performance after both full and partial sleep deprivation, and when combined with hypoxia," said Joe Costello, from the University's School of Sport, Health & Exercise Science

"The findings significantly add to what we know about the relationship between exercise and these stressors, and help to reinforce the message that movement is medicine for the body and the brain," he added.

The study, published in Physiology and Behaviour, involved two experiments, each with 12 participants (24 in total).

The first looked at the impact of partial sleep deprivation on a person's cognitive performance, and the second examined the impact of total sleep deprivation and hypoxia.

In both, all participants experienced an improvement in cognitive performance after a

bout of 20 minutes of cycling. "Because we were looking at exercise as a positive interven-



tion, we decided to use a moderate intensity programme as recommended in existing literature," added Costello.

"If the exercise was any longer or harder it may have amplified the negative results and became a stressor itself.

In the first experiment, individuals were only allowed five hours of sleep a night, over three

Each morning they would be given seven tasks to perform at rest, and then while cycling. They were also asked to rate

their sleepiness and mood before completing the tasks. The results showed the effects

of three nights of partial sleep

on executive functions were in-The paper says an explanation for this could be that some people are more resilient to a

mild or moderate sleep deficit. However, regardless of sleep status, moderate-intensity exercise improved performance

across all the tasks. In the second experiment, participants went an entire night without sleep and were then put in a hypoxic (low levels of oxygen) environment at the University's Extreme Environment Labs.

Despite oxygen levels being lowered, exercise continued to improve cognitive performance. IANS

Enigmatic move

n Maharashtra's intricate administrative landscape, where the ebb and flow of power is often measured by the stability of key personnel, the recent and somewhat enigmatic removal of Ashish Sharma, Principal Secretary attached to the office of Deputy Chief Minister Ajit Pawar, has sent ripples through the babu corridors of the state.

Clearly, it is not merely a routine administrative shuffle, most observers state. Given the current complexity of the politics in the state, it's a view that is not unfeasible. It is highly unusual for an IAS officer, especially one posted in either the CM or Deputy CM's office, to be unceremoniously shunted out before completing a normal tenure. Sharma's abrupt transfer not only marks the premature end of his first stint in the prestigious Mantralaya but also marks his third relocation in just six months – a puzzling pattern that has now invited scrutiny.

With Ajit Pawar conspicuously absent from the Mantralaya, recovering from a bout of dengue, the transfer of his Principal Secretary has left the office in a state of inertia. Pawar's silence has further fuelled the speculation. In the absence of official statements clarifying the rationale behind the move, the vacuum is filled with conjecture and whispers of power play behind the scenes. Ajit Pawar, so far, is still trying to find his feet after joining the BJP-led alliance government in Maharashtra. Though he was made deputy chief minister and his NCP faction bagged crucial portfolios, the deputy CM is still No. 3 in the pecking order. And Sharma's exit seems to indicate that the current hierarchy is unlikely to change.

MEA to take a maritime call

The entry of a Chinese "spy" ship into Sri Lankan waters a while ago, despite attempts by the Ministry of External Affairs (MEA) to prevent it, has already



of diplomacy in the Indian Ocean region. Now a new challenge has emerged, demanding a strategic response from the MEA.

The looming arrival of three oil tankers carrying Russian crude, allegedly sanctioned by the US, has created a piquant situation for the ministry. Although the transactions did not occur at major Indian ports overseen by the Shipping Ministry, sources have informed DKB that the potential of these ships docking at a state port raises questions about the MEA's role in shaping India's maritime policies. In the event of sanctions and a lapse in shipping insurance, the MEA is entrusted with the critical decision of whether to allow these ships into Indian waters, especially when dealing with non-major ports.

While the protocols outlined by senior Shipping Ministry babus shed light on the procedural intricacies involved in vessel entry, the decision to greenlight or deny entry ultimately lies with the MEA. India has, so far, played neutral in the Russia-Ukraine conflict despite attempts by the US to wean it away from its old ties with Russia. This is a test case for the MEA to walk the tightrope and find a solution that does not tilt the delicate balance.

IAS officers unite against Kerala govt

This is perhaps the first time that IAS officers in Kerala have jointly sought action against a government. The Central Administrative Tribunal (CAT) has taken a firm stance against what it perceived as a lack of due process in the appointment, transfer and posting of IAS officers within the state government. An interim order issued by a CAT bench has directed the Pinarayi Vijayan government to refrain from making such decisions, without the prior convening of the Civil Services Board's meeting.

The CAT directive comes in response to a petition filed by the Kerala $\,$ IAS Officers' Association, alleging a pattern of frequent transfer and posting orders being issued without the necessary recommendations from the Civil Services Board.

The petition highlights a concerning trend: the average tenure of cadre officers is well below the prescribed minimum period of two years. Even in key roles such as district collector, secretary to the government, and head of critical departments, the average tenure has dwindled to less

The tribunal observed that the Kerala government neither obeyed the Supreme Court directions nor adhered to the rules and notifications issued by the Centre in the wake of the Supreme Court verdict. It also noted that no explanation was offered as to why the Civil Services Board's meeting was not convened. The IAS officers claim that the board has become dysfunctional after only two meetings, the last of which occurred in 2015.

While the tribunal has set the next hearing on January 10, the interim order has focused the spotlight on the need to adhere to established norms and procedures. The outcome of this case is being watched keenly by



GREEN INDUSTRIAL POLICY

ECONOMIC STAGNATION CAN HAVE A DESTABILISING IMPACT ON DOMESTIC POLITICS, **IMPELLING GOVERNMENTS** TO AIM FOR A HIGHER GROWTH **RATE REGARDLESS OF ENVIRONMENTAL**

rom the European Union's Green Deal Industrial Plan and the United States' Inflation Reduction Act (IRA) to Japan's Green Growth Strategy and the Korean New Deal, industrial policies aimed at accelerating the energy transition are proliferating in wealthy, technologically advanced economies. Many developing economies are also designing and deploying stateled projects to foster green industrialisation, as competition intensifies for electric vehicles (EVs), so-called transition minerals, and clean energy.

For example, several African countries, including South Africa, Kenya, Mauritania, Egypt, Djibouti, Tunisia, Morocco, and Namibia, have enacted state-led initiatives to support the development of green hydrogen. Others, including Indonesia, Bolivia, and Chile, are implementing national strategies to stimulate industrialisation based on the extraction and processing of nickel, cobalt, copper, lithium, and other transition minerals and metals.

These policies use a broad range of instruments - including subsidies, regulations, incentives, and diverse state-business arrangements - and differ widely in terms of the public and private resources at their disposal. But they all seek to tackle three crises simultaneously: economic stagnation, polarised and precarious employment, and intensifying climate change.

The revival of industrial policy is based on the logic that addressing all three crises will create a virtuous cycle: targeted investment in green manufacturing and energy will boost economic activity, create wellpaying jobs, and usher in a lowcarbon economy. The Biden administration's "modern American industrial strategy," comprising the Bipartisan Infrastructure Law, the CHIPS and Science Act, and the IRA, exemplifies this approach. What has been called the "Biden threefer" is designed to boost US competitiveness in key industries visà-vis China, provide better economic opportunities for American workers, and accelerate decarbonisation.

But the win-win narrative undergirding these new industrial strategies tends to obfuscate

the risk that solving one problem may exacerbate another. In fact, the tensions between these policy objectives are already visible. For example, the decarbonisation of the economy may not create as many decent jobs as initially expected. In the US, both car companies and the United Auto Workers union have warned that the shift to manufacturing EVs, which require fewer parts, could lead to job losses. Some of these jobs will be redistributed to battery production, but this may be cold comfort for American and European auto workers, given China's dominance over the global battery supply chain.

At the same time, the growth of green industries can result in other environmental harms. Despite aiming to generate employment and value through the production of transition minerals, the industrialisation strategies of several Global South countries tend to entrench extractive practices. For example, Argentina, Bolivia, and Chile-South America's "lithium triangle" – are seeking to capture various stages of the lithium supply chain, from mineral extraction to processing to battery assembly. But the growth of this industry threatens to deplete water supplies, degrade soil, and disrupt habitats, often in zones inhabited by indigenous Andean peoples. Similarly, the production of semiconductors, which are at the heart of clean tech, is energy-, water-, and land-intensive and releases perfluorocarbons and other potent greenhouse gases into the

atmosphere. Finally, economic stagnation can have a destabilising impact on domestic politics, impelling governments to aim for a higher growth rate regardless of the environmental costs. For example, British Prime Minister Rishi Sunak recently announced a series of U-turns on the government's net-zero pledges. Shedding burdensome climate commitments may seem like a politically attractive strategy to boost immediate growth prospects. But - and herein lies the contradiction – longer-term growth will at least partly depend on governments ensuring that their economies are competitive in the green industries of the future.

As these examples show, industrial policy is not a silver bullet for the intersecting crises of our times. The policy objectives of environmental sustainability, industrial dynamism, and full employment are difficult to reconcile and require hard political choices about resource allocation, strategic priorities, and, crucially, the distribution of economic and social costs. Moreover, the trade-offs will grow more complex and challenging as global warming worsens and growth continues to sputter. What we call the 'wicked trinity" of contemporary governance - climate catastrophe, economic stagnation, and surplus humanity - will not go away anytime soon. In fact, it will likely shape the trajectories of public policymaking

long into the future.

This is not to say that policymakers should give up on designing ambitious strategies to address these crises. On the contrary, swift and effective action is an absolute necessity. Yet packaging these plans in winwin narratives that paper over the difficult trade-offs they involve significantly raises the risk that governments will lose popular support. The complex and conflicting nature of these policy objectives means that even the best-designed strategies will fall short, at least in some respects. This is unavoidable and an important component of learning-by-doing.

To avoid being seen as breaking promises, policymakers must embrace, rather than dismiss, the tensions and trade offs at the heart of green industrial policies and subject them to public deliberation. This is essential to securing broad support for state-led decarbonisation projects. Such an approach would help build robust, transparent governance structures rooted in the principles of democratic deliberation and public oversight and control. As matters stand now, many industrial strategies are the product of top-down, technocratic policymaking processes, despite all the talk of "leaving no community behind" and a "just green transition.'

Subjecting the economy to democratic decision-making in this way would, admittedly, constitute a radical challenge to the current system of private ownership and market coordination. But it is essential to secure and maintain popular legitimacy for green industrial policies, as well as to facilitate collective and efficient decisionmaking and minimise mismanagement. Otherwise, we risk a public backlash that impedes the collective action needed to safeguard our future on this planet.



Calcutta High Court allows BJP meeting

A day before Ballygunge had recorded AQI of 296, Bidhannagar (284) and Jadavpur (252) and Rabindra Sarobar (254). Till a week ago, the AQI hovered between 100-200 (moderate) while on

Tuesday, the average air quality ranged between 160-220 in the city. An AQI between 0-50 is considered good, 51 and 100 satisfactory, 101-200 moderate, 201-300 poor, 301 and 400 very poor and 401-500 'severe'.

During the Kali Puja and Diwali festivals, the AQI ranged between 189 and 255 across the city. The official said as the wintry conditions set in and the temperature dipped below 20 degrees celsius on Friday morning, cases of respiratory problems have started to spiral.

"An AQI between 201 and 300 causes health alert, over 300 triggers health warnings of emergency conditions," he said. Environmentalist Somendra Mohan Ghosh said, "The entire population is likely to be affected by serious health effects if there is no rain caused by depression or other weather disturbances in

Tiger census in Sundarbans starts from November 27

Kolkata, Nov 24: The annual tiger census in West Bengal's Sundarbans will begin November 27, a senior Forest department official said Friday

The tiger census is part of the nationwide census by different states having big cat popula tions, the official said. The camera trap exercise will be in the forests for over a month in the Sundarban Tiger Reserve (STR) along with some contiguous parts of South 24-Parganas district in the first phase.

Some other adjacent parts of the district will be covered in the second phase of the camera trap exercise, he added. Over 40 forest personnel and some locals will be involved in the census and they have been trained in the use of the camera technology and how to retrieve data from them.

Around 1,500 cameras have been set up in 720 strategic points to record the movement of big cats. According to the last count, there are 101 tigers in the



Sundarbans, 20 of them in contiguous areas of Sunderban

Tiger Reserve outside STR. The official said the forest department has taken steps like prevention of poaching, sensitising villagers about protecting tigers when the big cats stray into localities at times to avert man-animal conflict situations, and beefing up networks about poaching activities in their respective areas

Also, there had been regular release of deer in the forest area as tiger fodder. All these steps have borne fruit with the rise of tigers from 96 in 2020-21 to 101 till the last census.

The West Bengal part of Sundarbans is split between the STR and the South 24-Parganas forest division.

Mumbai-Ahmedabad bullet train: 100 km of viaducts completed

Mumbai, Nov 24: The National High Speed Rail Corporation Limited (NHSRCL), which is building the Mumbai-Ahmedabad bullet train corridor, has said that 100 kilometres of viaducts and 230 kilometres of pier work had been completed for the ambitious

The milestone of construction of 100 km of viaducts has been achieved through launching of 40-metre long 'full span box girders' and 'segmental girders', the NHSRCL said. Railway Minister Ashwini Vaishnaw uploaded a video on X to give information about the feat.

According to the NHSRCL, the viaducts include bridges over six Gujarat rivers, namely Par and Auranga in Valsad district, as well as Purna, Mindhola, Ambika and Venganiya in Navsari district.

"The first girder of the project was launched on November 25, 2021, while the first kilometre of



viaduct was ready in six months on June 30, 2022. It achieved construction of 50 kilometres of viaduct on April 22, 2023 and, thereafter, in six months 100 kilometres of viaduct were completed," the NHSRCL said.

"The Full Span Launching technique (FSLM), where 40-metre long box girders are launched by state-of-the-art equipment, is being used along with span-by-span launching of segments. FSLM is 10 times faster than the span-byspan method, which is normally used to build metro viaducts,'

According to the NHSRCL, apart from the viaduct work, 250 kilo-

metres of pier work has also been completed for the project, while installation of noise barriers has begun along the constructed viaduct. "Besides this, the laying of the

first reinforced concrete (RC) track bed for the Mumbai Ahmedabad high speed rail corridor track system as used in the Japanese Shinkansen has also started in Surat," the NHSRCL said.

The total cost of the Mumbai-Ahmedabad High Speed Rail Corridor project is pegged at ₹1.08 lakh crore. As per the shareholding pattern, the Union government will pay ₹10,000 crore to the NHSRCL, while Gujarat and Maharashtra are to pay ₹5,000

The rest of the cost is by way of a loan at 0.1 per cent interest from Japan. The foundation of the bullet train project was laid in Ahmedabad in September 2017. The train is expected to cover a distance of more than 500 km in around two hours.

TMC hails Supreme Court's judgement on Governors

Kolkata, Nov 24: Commending the recent Supreme Court judgment that Governors cannot indefinitely withhold Bills without action, the TMC labelled it a "lesson for the BJP-appointed Governors" and called for the abolition of the post, asserting that it is time to terminate its exis-

Governors cannot be at liberty to keep Bills pending indefinitely without any action, the Supreme Court has said while emphasising that the unelected head of the state is entrusted with constitutional powers that cannot be used to thwart the normal course of lawmaking by state legislatures.

Observing that unbridled discretion to the Governor would "virtually veto the functioning of the legislative domain by a duly elected legislature, a bench comprising Chief Justice of India D Y Chandrachud, Justice J B Pardiwala and Justice Manoj Misra said such a course of action would be contrary to fundamental principles of a constitutional democracy based on a Parliamentary pattern of


'Lord Wellesley defeated Napoleon by adopting strategy of Marathas'

Akola, Nov 24: The forces led by Lord Arthur Wellesley defeated French emperor Napoleon Bonaparte in the decisive Battle of Waterloo in 1815 by adopting the strategy of Marathas that he had earlier witnessed in a battle fought in Maharashtra, a former British army officer has said.

Retired British army officer Major Gordon Corrigan, 81, along with a group of citizens from his country Thursday visited Sirsoli village in Akola district of Maharashtra, where a battle was



the British forces in 1803.

fought between the Marathas and The group visited the battlefield site to study various as

pects related to it and to pay homage to the British soldiers who laid down their lives during the battle.

The battle fought at Sirsoli is also known as the Battle of Under the leadership of

Captain Kane and in the presence of Lord Wellesley, the British forces fought against the Marathas for seven days from November 23 to 29, 1803.

The Maratha soldiers fought with traditional weapons against the British. The Maratha forces

were led by Nagpurkar Bhosle. From the Marathas, Kartajirao Jayle killed Captain Kane, but sacrificed his own life. However, the British forces defeated the Marathas.

Speaking during his visit, Major Corrigan said, "After this battle, Lord Wellesley was sent back to England. In the Battle of Waterloo, Wellesley used the tactics as used by the Marathas in the Sirsoli battle and defeated Napoleon.'

According to him, the Sirsoli battle and the strategy adopted by Marathas are mentioned in the books written by Lord Welleslev. For the past 220 years, British citizens have been visiting Sirsoli every November.

New Delhi: Prime Minister Narendra Modi will attend the UN climate talks in Dubai on December 1 and deliver a national statement highlighting India's climate action, sources said Friday. The prime minister will reach the UAE on November 30, deliver India's national statement during the United Nations' World Climate **Action Summit on December** 1 and return the same day, a source said.

India monitoring outbreak of H9N2 in China

New Delhi, Nov 24: India is prepared for any kind of exigency that may emerge from the current influenza situation in China, the government said Friday, highlighting that it is monitoring the outbreak of H9N2 and clusters of respiratory illness in children in that country.

There is a low risk to India from both the avian influenza - H9N2-- case reported in China as well as the clusters of respiratory illness, the Union health ministry said.

Some media reports have indicated clustering of cases of respiratory illness in children in northern China for which the World Health Organization (WHO) has also issued a statement, it said.

Based on available information, an increase in incidence of respiratory diseases in China has been reported in the last few weeks. "The usual causes of respiratory illness in children have been implicated and there has been no identification of an unusual pathogen or any unexpected clinical manifestations," the ministry said.

Recently, a meeting was held under the Directorate General of Health Services to discuss the preparedness measures against human cases of avian influenza in the country against the backdrop of a human case of H9N2 (avian influenza virus) in October in China that was reported to the WHO. it said.

The need for strengthening surveillance among human, animal husbandry and wildlife sectors and improving coordination was recognised. India is prepared for any kind of public health exigency," the ministry added.

The WHO on Thursday said it has made an official request to China for detailed information nesses after Chinese health authorities reported multiple infectious respiratory diseases with surging cases of mycoplasma pneumonia and influenza flu among children.

The ministry said India is embarking on a 'One Health' approach to adopt a holistic and integrated roadmap towards addressing such public health issues. There has also been a significant strengthening of health infrastructure especially since the Covid pandemic, it said. The PM-Ayushman Bharat

Health Infrastructure Mission (PM-ABHIM) was launched by the prime minister and it is developing capacities of health systems and institutions across the continuum of care at all levels, primary, secondary and tertiary, to prepare health systems in responding effectively to the current and future pandemics and disasters, the ministry said. In addition, India's surveillance and detection networks under Integrated Disease Surveillance Programme (IDSP) have rich experience of dealing with challenging health situations during the Covid pandemic, the ministry said.

Afghanistan shuts embassy in Delhi PRESS TRUST OF INDIA resources. In a statement, the

New Delhi, Nov 24: Afghanistan's Embassy in India Friday announced its permanent closure, citing "persistent challenges from the Indian government"

This comes after the Afghanistan Embassy had announced on September 30 that it is ceasing its operations from October 1. The mission had back then cited a lack of support from the host government, failure to meet expectations in serving Afghanistan's interests and reduction in personnel and nouncing the permanent closure of its diplomatic mission in New Delhi, effective from November 23, "owing to persistent challenges from the Indian government". "This decision follows the em-

bassy's earlier cessation of operations on 30th September 2023, a move made in the hope that the Indian government's stance would evolve favourably for the normal continuation of the Embassy of the Islamic Republic of Afghanistan in New Delhi," the statement said.

Colombo: The Central Bank of Sri Lanka on Friday announced its decision to reduce its Standing Deposit Facility Rate (SDFR) and the Standing Lending Facility Rate (SLFR) by 100 basis points to 9.00 per cent and 10.00 per cent, respectively. The central bank said its monetary policy board arrived at this decision following a careful analysis of the current and expected developments in the domestic and global economy, with the aim of achieving and maintaining inflation at the targeted level of 5 per cent over the medium term, while enabling the economy to reach and stabilise at the potential level, reports Xinhua news agency.

Thousands march

Havana: Thousands of people led by Cuban President Miguel Díaz-Canel marched along Havana's iconic boardwalk Thursday in a show of solidarity with the Palestinian people and demanding an end to the war between Israel and Hamas. Wearing a black-andwhite Palestinian keffiyeh scarf, Díaz-Canel was accompanied by Cuban's main leaders, including Prime Minister Manuel Marrero and Foreign Minister Bruno Rodríguez.

Russia annexed the peninsula from Ukraine in 2014, a move that most of the world considered illegal, and has used it as a staging and supply point during the war

Kyiv, Nov 24: Ukraine launched one of the biggest drone attacks on the Moscow-annexed Crimean Peninsula since the full-scale war that started with Russia's invasion 21 months ago, Russian officials said Friday.

They did not mention any casualties or damage.

At the same time, Ukrainian officials reported that the Kremlin's forces escalated their weekslong and costly attempt to storm Avdiivka, a strategically important city in eastern

The stepped-up efforts came as both sides are keen to show they are not deadlocked as the fighting approaches 2024. Neither side has gained much ground despite a Ukrainian counteroffensive that began in June, and analysts predict the war will be a long one.

With winter weather setting in, bringing snow and freezing temperatures to the battlefield, Ukraine and Russia are looking to take ground that could provide platforms for future advances.

The Moscow-appointed governor for the Russian-occupied part of southern Ukraine's Kherson region, Vladimir Saldo, said Ukraine launched a major drone attack on Crimea early Friday. He claimed that dozens of drones were shot down over the province and the northern part of Crimea. Russia annexed

World Hindu Congress renounces 'Hinduism'

Bangkok, Nov 24: The World Hindu Congress Friday renounced the word Hinduism, contending that the term reflected oppressive and discriminatory and embraced Hindutva and Hindu Dharma to refer to the "eternal" religion.

The third World Hindu Congress (WHC) adopted a declaration here asserting that the word Hindutya was more accurate as it includes the gamut of all that the word 'Hindu' implies.

"In the term "Hindu Dharma" the first word, i.E, 'Hindu' is an unbounded word. It signifies all that is Sanatan or Eternal. And then there is Dharma, which means 'That, which sustains', read the declaration adopted at the end of the first day of deliberations of the WHC.

It said that in contrast. Hinduism is totally different because it is suffixed with an "ism", which is a term defined as an oppressive and discriminatory attitude or belief. "It is for such reasons that many of our elders preferred the term "Hindutva" over Hinduism as the former is a more accurate term since it includes the gamut (spectrum) of all that the word "Hindu" implies. 

Irish PM after 34 held

Dublin, Nov 24: Irish Prime Minister Leo Varadkar said Friday it was safe to return to Dublin city centre after police made 34 arrests following overnight rioting that was triggered by the stabbing of three young children in the

street. Irish police have warned that further violence could follow after rioters smashed shop windows, set fire to police cars, buses and a tram, and clashed with officers in violence rarely seen in

the Irish capital. Shoppers and tourists returned on Black Friday morning, walking past police officers guarding looted stores and patrolling the area in large numbers. Burnt out vehicles were removed.

Those involved brought shame on Dublin, brought shame on Ireland and brought shame on their families and themselves,' Varadkar told a news conference. A five-year-old girl remained in a critical condition on Friday following emergency treatment for serious injuries sustained in the stabbing, which happened near a school and beside the main thoroughfare of O'Connell Street

Police, who say they have not ruled out any motive including whether it was terror-related, have not commented on the nationality of a man detained in connection with the stabbings but there was immediate speculation online that he was foreign.

Police blamed far-right agitators for starting the violence after a small group of anti-immigrant protesters arrived at the scene of the stabbing and clashed with police.

Varadkar said his government would take immediate steps to tighten anti-hate legislation he said was unfit for the social media age.

World's largest iceberg breaks free, heading towards Southern Ocean

United Nations, Nov 24: The world's largest iceberg is on the move for the first time in more than three decades, scientists said Friday.

At almost 4,000 square km (1,500 square miles), the Antarctic iceberg called A23a is roughly three times the size of New York City. Since calving off West Antarctica's Filchner-Ronne Ice Shelf in 1986, the iceberg — which once hosted a Soviet research station — has largely been stranded after its base became stuck on the floor of the Weddell Sea. Not anymore. Recent satellite images reveal that the berg, weighing nearly a trillion metric tonnes, is now drifting quickly past the northern tip of the Antarctic Peninsula, aided by strong winds and cur-

It's rare to see an iceberg of this size on the move, said British Antarctic Survey glaciologist Oliver Marsh, so scientists will be watching its trajectory closely.

As it gains steam, the colos-

sal berg will likely be launched into the Antarctic Circumpolar Current. This will funnel it toward the Southern Ocean on a path known as "iceberg alley" where others of its kind can be found bobbing in dark waters. China allows visa-free travel for 6 countries

Starting December 1, citizens of France, Germany, Italy, the Netherlands, Spain and Malaysia will be allowed to enter China for up to 15 days without a visa. The trial program will be in effect for one year.

Beijing/Geneva, Nov 24: Claiming no unusual or novel pathogens other than the seasonal ones were detected, China has sought to play down the global concerns amid surging cases of mycoplasma pneumonia and influenza flu, especially among children, in its southern

and northern provinces. Even when China's widelypublicised exchange with the World Health Organisation (WHO) in response to the queries over the reports of surging cases of mycoplasma pneumonia and influenza flu triggered the worldwide alert, including in India, China said the spike in respiratory diseases was due to an

'immunity gap.' Both WHO and China have received global criticism for their non-transparent data/information sharing about Covid-19 and the world still has apprehensions over the emergence of the deadly virus in the Chinese city of Wuhan in 2019 which later spiralled into a massive pandemic resulting in deaths of and ill-health to millions of people across countries

In response to the media reports in China about a spike in children's hospitalisation, the WHO Thursday made an official request to China for detailed information.

On Friday, a WHO statement issued in Geneva, quoting information it received from the Chinese health officials, said: "There has been no detection of any unusual or novel pathogens or unusual clinical presenta-



tions but only the aforementioned general increase in respiratory illnesses due to multiple known pathogens.

The WHO statement said that the requested data was provided (by China) when its officials held a teleconference with health authorities from the Chinese Centre for Disease Control and Prevention and the Beijing Children's Hospital, facilitated by the National Health Commission and the National Administration of Disease Control and Prevention on November 23.

After reviewing the Chinese response, the WHO said, it does not recommend any specific measures for travellers to China and advises against the application of any travel or trade restrictions based on the current information available on this

However, the WHO also quoted the Chinese response that said: "Some of these increases are earlier in the season than historically experienced, but not unexpected given the lifting of Covid-19 restrictions, as similarly experienced in other countries.

Chinese health officials, as quoted by the WHO, further stated that the rise in respiratory illness has not resulted in patient loads exceeding hospital capacities. But local media reports suggested otherwise.

State-run Global Times quoted China's National Influenza Centre as saying that in the week of November 13-19, "the positive rate of influenza virus detection continued to rise in the southern and northern provinces, with the A (H3N2) subtype predominating, followed by B (Victoria).

The newspaper quoted a parent who had brought her sick child to the Beijing Children's Hospital saying that the hospital was fully packed with over 300 people and that she had to wait for four hours to see a doctor.

To be sure, some retailers hold their biggest markdowns for the Thanksgiving holiday weekend, and big-box players including Walmart, Lowe's and Home Depot maintained or deepened their advertised discounts.

Djokovic leads Serbia into Davis Cup semis

Malaga (Spain), Nov 24: Novak Djokovic became the outright most successful Serbian player in the history of the Davis Cup as he took his nation to the semifinals for the second time in three years with his 21st straight singles victory Thursday.

The top-ranked Djokovic beat Cameron Norrie 6-4, 6-4 to give Serbia a 2-0 victory over Great Britain and set up a last-four encounter with Jannik Sinner's Italy Saturday in the top team event in men's tennis.

It was a record 44th Davis Cup match win overall for Djokovic, moving him one ahead of Nenad Zimonjic. Djokovic now has 40 singles wins for his country.

The Italians beat the Netherlands 2-1 in the other quarterfinal match Thursday to reach the semifinals for the second straight season. Sinner kept Italy alive by winning his singles match and he then successfully teamed up with Lorenzo Sonego in the doubles.

He is finishing the season in impressive form, having won a record-breaking seventh ATP Finals title in a final against Sinner. The 36-year-old Djokovic won three Grand Slam titles this year to take his record tally to 24 He never struggled against

Norrie, the top-ranked British player, breaking serve once in each set at the Martin Carpena arena. He didn't face a break point in the entire match.

Djokovic, who now has a 44-14 Davis Cup record, appeared annoved by the behavior of a section of the nearly 5,000 British fans. After the match, he told them to "shut up" and "be quiet" as they began drumming during his on-court interview. "Learn how to respect players, learn how to behave yourself," he said.

In the first singles match, Miomir Kecmanovic beat Jack Draper 7-6(7-2), 7-6(8-6). Britain, a 10-time Davis Cup champion, was seeking its first semifinal appearance in four years. It was depleted by the injuries of Andy Murray and Dan Evans.

Without Djokovic, Serbia did not make it past the quarterfinal stage last year. It lost to Croatia in the 2021 semifinals. Serbia's lone Davis Cup title came with a squad led by Djokovic in 2010.

Satwik-Chirag marches into semifinals

Shenzhen, Nov 24: Asian Games champions Satwiksairaj Rankireddy and Chirag Shetty stormed into the men's doubles semifinal with a straight-game win over Indonesia's Leo Rolly Carnando and Daniel Marthin at the China Masters Super 750 badminton tournament here The top seeded Indian pair

dished out an attacking game to outwit the World No.13 Indonesian combination 21-16, 21-14 in 46 minutes. However, World No.8 Prannoy had a bad day in office as he struggled to curb his errors and went down 9-21, 14-21 against Japan's World Championships silver medallist Kodai Naraoka in a lopsided contest later in the day.

Satwik and Chirag, who won the Indonesia Super 1000, Korea Super 500 and Swiss Super 300 this year, will face the winner of the other quarterfinal match between two Chinese pairs - He Ji Ting and Ren Xiang Yu and eighth seeds Liu Yu Chen and Ou Xuan Yi.

The former World No.1 Indian duo showed great coordination as they interchanged their positions frequently, also altered the direction of their stinging attack which made life difficult for their Indonesian rivals, who wilted under pressure.

The match started on an even keel with both the pairs fighting



tooth and nail. But the Indian combination soon started dominating the proceedings with an onslaught of attacking shots to break off at 14-14.

Chirag made some right judgements as they were 19-16 up soon and then the Mumbaikar displayed his attacking intent once again, coming to the front court after serving to quickly close out the issue with a quick return.

The Indians kept up the tempo to surge to a 5-2 lead early in the second game. A few taps went to the net from but they ensured a two-point lead at 7-5 with Satwik unleashing a stiff return. A flurry of smashes took the Indians to a healthy 11-6 ad-

vantage at the interval. The Indonesians couldn't match the attack of their rivals, who were relentless from the

first point. The Indians quickly moved to 17-10. The longest rally of the match with 48 shots ensued next with Marthin producing a precise smash.

A lucky net chord put the Indians three points away and Marthin next went to the net as they grabbed seven match points. Satwik and Chirag squandered one before winning a video referral to seal their last four place.

WPL '24 auction to take place in Mumbai Dec 9

'We have had a fantastic preparatory camp. We identified chinks in our armour and worked on them to cover all aspects of our game.

"Each and every one of us has worked extremely hard and there's great camaraderie in the camp. I will give this tournament my all and hopefully contribute significantly to winning the Junior World Cup," the Sundargarh lad said in a Hockey

Lakra said the senior men's team's bronze medal-winning outing at the Tokyo Olympics



motivated him to establish himself in the sport and aim for glory. The bronze ended India's

41-year-long wait for a medal in hockey at the Olympics. "I started dreaming about

achieving the same milestone and upon sharing the same with my father, he said that hard work was the only way I would get there," Lakra said

He said he was also driven to do well in the sport after watching Hockey India president Dilip Tirkey go about his job during his playing days with the national team, of which he is the most capped player. "As an aspiring player, I had the opportunity to meet the legendary Dilip Tirkey, who told me that he used to work out for four hours a day," he said.

"He also advised us to be hardworking and focused in our efforts to become good players. His words inspired me, and I began making similar efforts. I started out at Panposh Sports Academy, but after my father was transferred, I had to stop playing.'

He also stated that he is impressed by the drag-flicking abilities of current India captain Harmanpreet Singh. "Watching him train closely here in SAI Bangalore, I get to learn a lot

from him and his on-field focus and style," Lakra said.

Recalling the challenges he faced in his early days in the sport, he added, "I faced a little bit of difficulty finding places to train, so I started training on grass with my father.

"Then I received a call informing me that I had been invited to join the SAI Centre in Bhopal as part of the Khelo India scheme in 2020. Later, I returned to play in Nationals for Odisha and was chosen for the national camp based on my performance.' Lakra played sub-junior

Nationals in 2015 in Delhi and in 2016 in Manipur and made his junior Nationals debut for Odisha in 2021 at the Junior Men's National Championship in Kovilpatti, Tamil Nadu, where he helped his side win the bronze medal.

In 2021, Lakra received a call to the junior men's national camp and he made his debut for the Indian team at the 2022 Sultan of Johor Cup, where India won (the gold medal.
