### Increase in Odisha's groundwater extraction

New Delhi: The annual extraction of groundwater for domestic, irrigation and industrial purposes has been increased in Odisha by 0.16 billion cubic meters (BCM) in 2023, shows the latest groundwater assessment report released by the Ministry of Jal Shakti Friday. The report, prepared after the assessment of 314 blocks in the state, revealed that the annual groundwater extraction for all uses has increased from 7.23 in 2022 to 7.39 bcm while the annual groundwater recharge decreased from 17.79 in 2022 to 17.35 bcm in 2023.

### Israel resumes offensive in Gaza Strip

Deir al-Balah (Gaza Strip): Israeli fighter jets hit targets in the Gaza Strip minutes after a week-long truce expired Friday, as the war with Hamas resumed in full force. Black smoke billowed from the besieged territory and Israel dropped leaflets over parts of southern Gaza urging people to leave their homes, suggesting it was preparing to widen its offensive. Renewed hostilities heightened concerns for the about 140 hostages who remain in Gaza, after more than 100 were freed as part of the truce. ## **₹220cr cocaine bust**

Customs seizes 22kg of the contraband from Denmark-bound cargo ship at Paradip Port

Bhubaneswar, Dec 1: In one of the biggest cocaine busts in the country in recent times, Customs sleuths intercepted a consignment of around 22 kg of the illicit drug from a Denmarkbound cargo ship anchored at

the Paradip Port, Friday. State Customs Commissioner Madhav Chandra Mishra told Orissa POST that the 20 crew members of the ship have been detained for questioning to ascertain the origin and destination of the contraband, estimated to be worth ₹200-₹220 crore in international grey market. All the crew members are from Vietnam, added Mishra.

"They have been detained. Their questioning will start soon," Mishra said, adding that the Vietnamese crew members know little or no English. Sources said the sleuths are likely to seek help from interpreters during their questioning.

Mishra, however, made it clear that no one has been arrested so far.

Further rummaging and searching of the massive ship is underway with the help of sniffer dogs to rule out any more hidden drugs, he said.

Keonjhar/Bhubaneswar, Dec 1: At least 11 people were killed and around a dozen sustained injuries in four separate road accidents across the state, on the first day of the 'Zero Fatality Week', Friday, police said.

While eight people, including three women and a child, were killed and eight others injured when the van in which they were travelling rammed into a stationary truck in Keonihar early Friday, three others died in separate road accidents in Bhadrak, Anandpur (Keonjhar) and Sambalpur districts. Referring to Friday morning accident on National Highway 20 near Balijodi village in Ghatagon area of Keonjhar, police said it took place when the van in which around 21 people, including the driver, were travelling hit a stationary truck.

### Groundwater extraction up, recharge dips: Report Plus II practical exam from Jan 2 POST NEWS NETWORK

**ODISHA SCENARIO** 

Bhubaneswar, Dec 1: The Council of Higher Secondary Education (CHSE) Friday notified that the annual Higher Secondary Exanimations (Practical/Projects) 2024 will be held from January 2 to12 in all higher secondary schools/colleges affiliated to the council.

The practical of subjects like Arts, Science and Commerce, vocational trade and Integrated vocational will be held from January 2 to 12, said the notification issued by the CHSE.

The detailed programme of annual Higher Secondary (Theory) exam will be notified later and it is expected to com-

mence February 16, 2024.

Earlier, the School and Mass Education department had decided to livestream the Plus II board exams conducted by the CHSE from next year to bring in more transparency in the examination process.

The CHSE on its part has asked all the college principals to submit status report on installation of CCTV cameras in their respective examination centres by December 15.

17.35 bcm in 2023. The extraction of groundwater for irrigation purposes stood at 5.96 bcm, 0.18 bcm for industrial purposes and 1.25 bcm for domestic use, the 2023 assessment report stated.

Annual groundwater extraction for all uses has increased from 7.23 in 2022 to 7.39 bcm in 2023 while annual groundwater recharge has nosedived from 17.79 in 2022 to 17.35 bcm in 2023 Two assessment units - Jharsuguda and

Khurda - have witnessed deterioration in 2023 as compared to 2022

The report has categorised nine out of 314 blocks assessed as 'semicritical' due to groundwater extraction between 70 to 90 per cent of the annually replenishable groundwater recharge.

"Out of the total of 314 assessment units (blocks), 9 (2.87%) have been categorised as 'Semicritical', 299 (95.22%) as 'Safe' and 6 (1.91%) as 'Saline'. Similarly, out of 121593.15 sq km recharge worthy area of the state, 3339.96 sq km (2.75%) is under 'Semicritical', 116071.86  $\operatorname{sq}$  km (95.46%) under 'Safe' and 2181.33 sq km (1.79%) area under 'Saline' categories of assessment units," the report added. Among the semi-critical units,

three were found in Khurda district while one each was found in Angul, Balasore, Jajpur, Jharsuguda, Nayagarh and Nuapada districts.

# Odisha logs over 100pc growth in GST collection

Bhubaneswar, Dec 1: Odisha registered a phenomenal growth rate of 100.77 per cent in State GST with a collection of ₹2,791.45 crore in November 2023 against a collection of ₹1,390.36 crore in the corresponding month last year, an official said. The progressive collection of State GST (OGST+IGST Settlement) up to the month of November 2023 stands at ₹14,913.16 crore against a collection of ₹11,719.64 crore in November 2022, registering a growth rate of 27.25 per cent, an official release said.

The collection under all Acts monitored by the Commissionerate of CT & GST, Odisha, including OGST/ IGST Settlement/VAT/Entry Tax and Professional Tax during November 2023 is ₹3,856.72 crore against a collection of ₹2,308.92 crore during November 2022 with a growth rate of 67.04 per cent, it said.

The progressive collection under all Acts up to November 2023 is ₹22,510.56 crore with a growth rate of 18.91 per cent



over corresponding collection till November 2022. With regard to Gross GST

collection (CGST+IGST+SGST+Cess), the state has recorded a collection of ₹4,295.08 crore during November 2023 against collection of ₹4,162.26 crore during November 2022 with a growth

rate of 3.19 per cent. The progressive Gross GST collection during financial year 2023-24 (till November 23) is ₹35,188.25 crore with growth of

9.75 per cent over corresponding period of FY 2022-23, it said, adding that during November 2023, 20.85 lakh waybills were generated vis-à-vis 18.19 lakh waybills generated during November 2022, recording a growth of 14.62 per cent.

The five rescued workers hailing from Odisha are: Raju Nayak, Dhiren Nayak and Bisweswar Nayak from Mayurbhanj district, Bhagwan Bhatra from



Nabarangpur and Tapan Mandal from Bhadrak district. Tapan stayed in Delhi while four others returned to Odisha.

The state government has given a rousing welcome to the labourers at the airport. The workers thanked the state government for its support during such a tragic period.

"On the direction of Chief Minister Naveen Patnaik, two Labour department officials from Odisha rushed to the site just a day after the incident. I was camping in Uttarakhand for the last eight days," said the Labour minister.

As many as 41 workers from nine states were trapped in the tunnel. While the family members of the workers from other states reached the spot selling their jewellery, the Odisha government took the family members of the five workers to the site to give moral support to the trapped workers, he said.

After arriving here, the workers met Chief Minister Naveen Patnaik at Naveen Niwas. Congratulating the workers, the Chief Minister inquired about their health condition. The workers thanked Patnaik for his sympathy by informing that everyone is fine. The Chief Minister handed over cheques of ₹2 lakh each to the workers. Patnaik also heard from them about their struggling life inside the tunnel. He said that they are indeed the heroes. He said that the man-

owner murder case

Bhubaneswar, Dec 1: The twin city Commissionerate Police has claimed to have cracked the murder case of a roadside eatery owner in Gangapatna area here last month, with the arrest of a 34-year-old man Friday.

Addressing media, police commissioner Saumendra Priyadarsi said Mithun Jena, a resident of Gangapatna area in the City, has been taken into custody on charges of attacking Sashmita Behera November 6 evening leading to her death the next day.

According to the police top brass, Mithun killed Sashmita after he was humiliated by the latter in full public view for ordering a plate of chickpea curry.

"Mithun had gone to buy curry from the roadside eatery near IIIT Square November 5 morning when he picked up a quarrel with Sashmita following which she was denied for the item in full public view. To teach a lesson to Sashmita, a humiliated Mithun bought a knife the next day and



went to the woman's eatery," the police commissioner said.

After waiting for some time, Mithun found Sashmita alone at the eatery and attacked her with knife before fleeing the scene, he said.

"A profusely bleeding Sashmita was rushed to a nearby healthcare facility where she died the next morning, November 7," the police commissioner said.

Sashmita's brother lodged a complaint with Chandaka police November 7 evening following which a case (350/23) was registered and a probe began.

"Following investigation, we arrested Mithun. The weapon of offence (knife) has been seized," he said.



### AI image generator perpetuates gender stereotypes: Study

opular artificial intelligence (AI) image generator, Stable Diffusion, perpetuates harmful racial and gendered stereotypes, US scientists have found

The researchers from the University of Washington (UW) also found that, when prompted to create images of "a person from Oceania," for instance, Stable Diffusion failed to equitably represent Indigenous peoples.

The generator tended to sexualise images of women from certain Latin American countries (Colombia, Venezuela, Peru) as well as those from Mexico, India and Egypt, they said.

The findings, which appear on the pre-print server arXiv, will be presented at the 2023 Conference on Empirical Methods in Natural Language Processing in Singapore from December 6-10.

"It's important to recognise that systems like Stable Diffusion produce results that can cause harm," said Sourojit Ghosh, a UW doctoral student in the human centered design and engineering department.

The researchers noted that there is a near-complete erasure of non-binary and Indigenous identities.

"For instance, an Indigenous person looking at Stable



Diffusion's representation of people from Australia is not going to see their identity represented that can be harmful and perpetuate stereotypes of the settler-colonial white people being more 'Australian' than Indigenous, darker-skinned people, whose land it originally was and continues to remain," Ghosh said. To study how Stable Diffusion portrays people, researchers asked the text-to-image generator to create 50 images of

a 'front-facing photo of a person.' They then varied the prompts to six continents and 26 countries, using statements like "a front-facing photo of a person from Asia" and "a frontfacing photo of a person from North America.

The team did the same with gender. For example, they compared 'person' to 'man' and 'person from India' to "person of nonbinary gender from India."

The researchers took the generated images and analysed them computationally, assigning each a score: A number closer to 0 suggests less similarity while a number closer to 1 suggests more. The researchers then confirmed the computational results manually. They found that images of a "person" corresponded most with men (0.64)and people from Europe (0.71) and North America (0.68), while corresponding least with nonbinary people (0.41) and people from Africa (0.41) and Asia (0.43)

They also found that Stable Diffusion was sexualising certain women of colour, especially Latin American women.

The team compared images using a NSFW (Not Safe for Work) Detector, a machine-learning model that can identify sexualised images, labeling them on a scale from "sexv" to "neutral."

### Strategic Shuffle

n a surprise move, the Centre took the unexpected step of repatriating Atal Dulloo, the Union Secretary for Border Management, to L his cadre state, following a request from the Union Home Ministry. The timing of the decision, just days ahead of the retirement of the current Chief Secretary of Jammu & Kashmir, Arun Kumar Mehta, hints at a larger strategic manoeuvre by the Centre, potentially positioning Dulloo as the frontrunner for the coveted post.

For several months, insiders speculated about the extension of Chief Secretary Mehta's term, and the possible succession by Raj Kumar Goel. However, the Centre once again displayed its penchant for surprises by redirecting Dulloo to his cadre state. This choice may bring about a fresh perspective to the governance of J&K.

Some senior babus believe that the Centre might have a different role in mind for Goel within the Government of India, possibly at an apex scale post, even as the decks have been cleared for Dulloo's appointment as the union territory's top babu. Interestingly, Narayanan, who once donned the hat of chairman in a major finance company, has now exchanged his material accoutrements for divine bliss. It's a plot twist that could rival a cinematic climax!

### Whistleblower forest officer praised for legal acumen

A veteran of several court battles with the government on corruption and other malpractices, whistle-blower Indian Forest Service (IFoS) officer Sanjeev Chaturvedi has earned the respect of the public and, now, even the courts.

A recent court hearing added another laurel to the Magsaysay Award winner's career when the chief justice of a high court acknowledged Chaturvedi's legal acumen. The Chief Justice praised Chaturvedi stating that he was more well-versed in law than the other counsel. Such open praise from the high court underlines Chaturvedi's deep understanding of the legal complexities that often accompany his battles.

Chaturvedi first hit the headlines when he was posted in Haryana where he took on corrupt politicians and senior bureaucrats involved in mining, illegal felling and poaching scams. After several years of harassment and court cases, he was moved to Delhi as the Chief Vigilance Officer of the All India Institute of Medical Sciences (AIIMS), where too, he exposed large-scale corruption, which led to his removal. At present, he is in Uttarakhand, after a long protracted legal battle to get his cadre changed from Haryana to Uttarakhand.

In these times tainted by widespread corruption, Chaturvedi emerges as a beacon of righteousness, undeterred by the heavy price he pays for his steadfast stance. This fact is now recognized even by the judiciary.



From cash transfers to cheaper cooking gas cylinders to higher support prices for farm products, are all meant to woo the voters from the lower income groups and economically weaker sections. This should particularly be viewed in the backdrop of a recent World Bank study in the context of South Asia which notes that the primary deficit, on an average, tends to widen by 0.5 per cent of GDP around national elections. Though one cannot deny the need for providing welfare measures, these must reach only the poor and the economically weaker sections. Moreover, it has to be ensured that the existing schemes are well-funded, and the real beneficiaries are identified and get the benefits, and not those who are close to the

of the rural poor in most states, especially in the northern and the BJP reveal that the political eastern regions, have not improved significantly.

When the rural economy needs a thrust, the funds provided for the MGNREGA programme is not sufficient to provide employment for more than 35-40 days when the scheme talks of 100 days assured employment.

If the question of employment is considered, statistics reveal that there is virtually no increase in formal sector jobs. As per recent statistics, there has been a slowdown in the pace of formal job creation in the June-September period as new subscribers added to the Employees' Provident Fund declined by over 10 per cent. The decline in formal employment and the corresponding increase in labour force participation clearly point to the fact that most new entrants to the job market have no option but to be satisfied with low-paid work in the informal sector.

The economic situation of most states is in a deplorable condition. There is no possibility of things improving in the near future, even if there is some backward areas as most manufacturing units are set up in industrial belts or in fairly developed areas within the state. Moreover, mechanised means of operation require less labour and only the skilled workers get the opportunity.

One is constrained to refer to the recently released 2024 Asia-Pacific Human Development Report titled 'Making our Future: New Directions for Human Development in Asia and the Pacific', which states that though per capita income in India, between 2000 and 2022, soared from \$442 to \$2,389, it does not reflect the incomes of the rural population. Again, though between 2015-16 and 2019-21, the share of the population living in multi-dimensional poverty fell from 25 to 15 per cent, if the total population increase is taken into consideration, this figure would not be spectacular at all. The economic distress is well manifest but even then the government is not looking at a comprehensive strategy to improve the incomes

of the rural poor. Significantly, the report aptly refers to three new directions in

## 9 days of Nov saw 'severe' air quality

#### PRESS TRUST OF INDIA

New Delhi, Dec 1: Unfavourable meteorological conditions and peak of paddy harvesting activity during Diwali led to the deterioration of air quality in Delhi in November, the Commission for Air Quality Management said Thursday.

The air quality levels are greatly impacted by the levels of rainfall/precipitation, direction of wind and its speed, which are prime facilitators for dispersal of the pollutants/emissions, it said.

The average wind speed over Delhi and out of the city during November was also relatively slower for long spells with an average speed of only about four kilometres per hour. An average wind speed of at least 10 kilometres per hour and above is desirable for effective dispersion of pollutants, the CAQM said in a statement.

Low-speed north-westerly winds flowing in to Delhi were however observed during the month, leading to pollutant inflow from such areas. Paddy sowing was disturbed and delayed in many parts of Punjab and

### Moderate snowfall in higher reaches of HP

Shimla, Dec 1: Wintry conditions set in most parts of Himachal Pradesh as high-altitude tribal areas, other higher hills and mountain passes experienced moderate snowfall while widespread rains and hailstorm lashed several places including state capital Shimla Friday.

Sissu, Gondla, Koksar and Keylong received 20 cm, 15 cm, 10 cm and 8 cm of fresh snowfall while Rohtang, Kunzum, Pin-Parvati passes and Dhauladhar and Churdhar mountain ranges and higher hills of Manali, Chamba, Shimla, Sirmaur and Mandi received 20 cm to 30 cm of snow and the areas were wrapped in impeccable white

State Home Minister G Parameshwara said the message had come from an email id "kharijites@beeble.Com," saving bombs have been placed in the schools in Bengaluru and threatened to kill children and staff.

'We are seriously verifying it and its source. I have spoken to the Commissioner and officials and have given the necessary instructions and verification on whether it is true or hoax and measures to be taken accordingly. We will verify as to who is

are located within the city while the rest are in Bengaluru Rural limits, police added. The students and staff were immediately evacuated from the school premises, police said, adding no suspicious objects were found yet and prima facie, it looks like a hoax message. City Police Commissioner B

Davananda said bomb detection and disposal squads were sent to

all these schools, and most likely it seemed to be a hoax. "Earlier also similar threat letters and emails had come to schools and they were found to be a hoax for mischief and police had identified those behind it. Police are verifying today's mails too...Officials and personnel have gone to all these spots. I appeal to people not to worry, as most likely all these are hoax calls (mails)," he said.

Another senior officer said the police teams have not found any suspicious objects on any of the school premises. "Prime facie, it appears to be a hoax message. We are also in the process of registering a case in this regard and a thorough investigation is underway.'

Students had already reached schools when they got to know about the email threat. Panicstricken parents rushed from their respective offices and homes to get their children back home safely. Some of these students from different schools which received bomb threats said they had exams scheduled for the day.

CM Siddaramaiah said, "I have spoken to police officers and I have instructed them to take adequate security measures at all places, to remain cautious, and to find out those behind it.

New Delhi, Dec 1: The Governor of a state cannot refer bills passed by the legislature and readopted by it for presidential assent, the Supreme Court ruled on Friday, and asked Tamil Nadu Governor R N Ravi to hold a meeting with Chief Minister M K Stalin in an effort to end the impasse over 10 such pending bills.

Ravi and Stalin have been locked in a war of attrition over numerous issues. "We would like the governor to resolve the impasse...We will appreciate it if the governor resolves the impasse with the chief minister. I think the governor invites the chief minister and let them sit down and discuss it," a bench comprising Chief Justice D Y Chandrachud and justices J B Pardiwala and Manoj Misra said.

The bench took note of the submissions of senior advocate Abhishek Singhvi, who appeared for the state government, that the governor has now remanded the readopted bills for consideration by the President.

Accusing the office of the governor of "constitutional obstinacy", Sighvi said Raj Bhavan referred the bills to the President on November 28, after having sat on them for a long time, in "flagrant violation" of the constitutional scheme. The option of sending the readopted bills to

the President was not available to the governor once he decided to withhold assent in the first instance when they were passed by the legislature.

General R Attorney Venkataramani, appearing for the office of the governor, argued that when a governor sends back a bill to the legislative assembly he is not withholding assent but merely asking the House to reconsider it.

When the assembly says it won't change its stand on a bill, the governor can send it to the President for consent, the top law officer said. "The governor should have reserved it for the President first (in the first instance). If he has sent it back to the assembly and then it is re-adopted, the governor cannot send it to the President," the CJI said, referring to Article 200 of the Constitution.

"As per Article 200 of the Constitution, there are three options to the Governor - he can as sent or withhold assent or he can reserve the bill for the President. They are all alternatives. In this case, the Governor initially said I withhold assent. Once he withholds the assent, there is no question of him then reserving it for President. He can't. He has to follow one of the three options - assent, withhold the assent or refer it to the President. "So first and foremost, once he withholds the assent, then he can never say that now I am referring it to the President. Second, once he withholds the assent, he can't kill the bill right there. He can't stall the bill there. Once he withholds the assent, the proviso does not give him the fourth





India Thursday described as a "matter of concern" the US charging the Indian national with conspiring to kill the Sikh separatist, and asserted that a high-level probe committee will investigate all aspects of the case. "The government announced today that it was conducting an investigation, and that's good and appropriate, and we look forward to seeing the results," Secretary of State



Antony Blinken told reporters travelling with him in Tel Aviv, Israel, Thursday

Blinken did not give any details about the case, calling it an ongoing legal matter.

"So you'll understand I can't comment on it in detail. I can say that this is something we take very seriously. A number of us have raised this directly with the Indian Government in past weeks," Blinken said.

Separately, the White House Thursday also praised New Delhi for setting up its own investigations into the matter and said this will not have an impact on the India-US relationship.

"These allegations in this investigation, (we) take it very seriously. And we're glad to see that the Indians are too announcing their own efforts to investigate this. And we've been clear that we want to see anybody that's responsible for these alleged crimes to be held properly accountable," John Kirby, Coordinator for Strategic Communications at the National Security Council in the White House, told reporters at a news conference here

The sanctions apply to five individuals -- Ri Chol-ju, Kim In-beom, Ko Kwan-yong and Choe Myong-su from the National Aerospace Technology Administration; and Kang Son, a manager from the Ryongsong Machine Complex -- for involvement in the satellite development and procurement of supplies.

Paraguay official quits after signing deal with fictional country Kailasa

Buenos Aires (Argentina), Dec 1: A Paraguayan government official was replaced after it was revealed that he signed a memorandum of understanding with representatives of a fugitive Indian guru's fictional country, who also appear to have duped several local officials in the South American country.

The revelation sparked a scandal - and lots of social media mockery — in Paraguay but it's hardly the first time selfdescribed representatives of the United States of Kailasa duped international leaders.

Earlier this year, they managed to participate in a United Nations committee meeting in Geneva and also signed agreements with local leaders in the United States and Canada.

Arnaldo Chamorro was replaced as chief of staff for Paraguay's Agriculture Ministry Wednesday shortly after it was revealed that he signed a "proclamation" with representatives of the United States of Kailasa.

Representatives of the fictional country met with Chamorro and Agriculture Minister Carlos Giménez, Chamorro said in a radio interview. During the interview, Chamorro recognised he didn't know where Kailasa was located and said he signedwhat he characterised as a "memorandum of understanding"

24, the foreign currency assets, a major component of the reserves, increased \$2.14 billion to \$528.531 billion, as per the data from the Reserve Bank of India (RBI).

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.



Gold reserves were up \$296 million to \$46.338 billion during the week, the RBI said.

The Special Drawing Rights (SDRs) were up \$87 million to \$18.218 billion.

India's reserve position with the IMF rose \$14 million to \$4.848 billion in the reporting week, the apex bank data showed.

In October 2021, the country's foreign exchange kitty had reached an all-time high of \$645 billion. The reserves took a hit as the central bank deployed the reserves to defend the rupee amid pressures caused majorly by global developments since last year.

New Delhi, Dec 1: GST collections jumped 15 per cent to nearlv ₹1.68 lakh crore in November on increased domestic activity and festive season buying, the finance ministry said Friday.

Goods and Services Tax (GST) mop-up was over ₹1.45 lakh crore in November 2022.

'The gross GST revenue collected in the month of November 2023 is ₹1,67,929 crore, out of which CGST is ₹30.420 crore. SGST is ₹38,226 crore, IGST is ₹87,009 crore (including ₹39,198 crore collected on import of goods) and cess is ₹12,274 crore (including ₹1,036 crore collected on import of goods)," the ministry said in a statement.

The November 2023 collections are, however, lower than ₹1.72 lakh crore mopped up in October -- the second-highest collection ever since the GST rollout

Revenues for November 2023 are 15 per cent higher than the GST revenues in the same month last year and the highest for any month year-on-year during 2023-24, up to November 2023, the ministry said.

The gross GST collection till November in the current fiscal is ₹13,32,440 crore, averaging ₹1.66 lakh crore per month. The collection is 11.9 per cent higher than the gross GST collection in

EY Tax Partner Saurabh Agarwal said the higher GST revenues are primarily due to increased domestic activity the festive season last month and increased tax administration.

"The numbers can be said to be an indicator of a stable Indian economy as we see a 20 per cent increase in domestic transactions compared to the same month last year," he said.

Increased GST collections in Arunachal Pradesh, Nagaland, Mizoram, Tripura, Ladakh, etc indicate a rise in consumption in these parts of the country, Agarwal added.

During the month, revenues from domestic transactions (including import of services) are 20 per cent higher than revenues from these sources during the same month last year.

### ATF price slashed

New Delhi: Jet fuel or ATF price Friday was cut by 4.6 per cent, the second reduction in a month, while commercial cooking gas (LPG) rate was hiked by ₹21 per 19-kg cylinder in line with international benchmarks. However, the price of domestic LPG - used in household kitchens for cooking purposes - remained unchanged at ₹903 per 14.2-kg cylinder. Aviation turbine fuel (ATF) price was cut by ₹5,189.25, or 4.6 per cent, in the national capital to ₹1,06,155.67 per kl from ₹1,11,344.92, according to a price notification of state-owned fuel retailers. This is the second reduction in a month.

"The total value of ₹2.000 bank notes in circulation, which amounted to ₹3.56 lakh crore as at the close of business on May 19, 2023 when the withdrawal of ₹2,000 bank notes was announced, has declined to ₹9,760 crore as at the close of business on November 30, 2023," the RBI said. Thus, 97.26 per cent of the high-value currency in circulation as on May 19, 2023, has since been returned to the banking system, it added. People can deposit and/or exchange ₹2.000 bank notes at the 19 RBI offices across the country


