# 3 FOR BJP, 1 FOR CONG

Saffron party sweeps MP, Rajasthan & Chhattisgarh; Congress ousts BRS in Telangana

New Delhi, Dec 3: The BJP swept Madhya Pradesh. Rajasthan and Chhattisgarh Sunday inflicting a resounding defeat on the Congress to tighten its stranglehold in the Hindi heartland, in a big boost for Prime Minister Narendra Modi and setting the tone for the 2024 Lok Sabha elections.

In some consolation for the Congress in the face of the saffron wave after it lost Rajasthan and Chhattisgarh. the party ousted the BRS in Telangana to make it 3-1 for the BJP in the latest round of Assembly elections billed as a semi-final before next vear's poll showdown.

Ruling MP for 18 years, a well entrenched BJP managed to stave off anti-incumbency in a shot in the arm for four-time CM Shivraj Singh Chouhan and dashing the hopes of a resurgent Congress helmed by veteran and former CM Kamal Nath. Winning 141 seats and leading in 24, the BJP got a simple majority and could get two-thirds majority in a House of 230.

Congress bagged 45 and was

leading in 19.

With BJP dislodging the Congress hit by factionalism in Rajasthan, the desert state stuck to a nearly 30year-old 'rivaz' (tradition) of not voting an incumbent party back to power. The BJP got a majority bagging 115 seats after voting was held for 199 constituencies. The

Congress notched 69 seats The Chhattisgarh outcome was a surprise for many Congress leaders who were hoping for another stint in power in the state by fending off the BJP challenge. The day began with

both parties neck and neck but, as counting continued, the BJP consolidated its lead and won or was ahead in 54 seats. The Congress won or was ahead in 35 seats in the 90-member house.

The KCR-led BRS hoped for a hat-trick in Telangana but was dethroned by the Congress. The Congress won 61 seats and was leading in three in the 119-member House. The BRS bagged 33 and was ahead in six. The BJP put up a good showing and increased its tally in the southern state with the victory of its candidate K Venkata Ramana Reddy in Kamareddy against both the outgoing chief minister KCR and Revanth Reddy, who is the TPCC chief, being the highlight. BJP won 8 seats, up from one seat, and doubled its vote share from the 2018 polls to nearly 14 per

The BJP amplified its pitch around the Prime Minister during the Assembly polls as its manifestoes featured his guarantees, with Prime Minister Modi crisscrossing the pollbound states, except for Mizoram, to seek popular support to deliver on his welfare and development

# **MIZORAM POLL RESULTS TODAY**

Aizawl, Dec 3: Elaborate arrangements have been made for the counting of votes for the Assembly elections in Mizoram, which saw a three-way fight between the ruling MNF, the ZPM and the Congress, Monday.

The counting was supposed to happen Sunday along with Madhya Pradesh, Rajasthan, Chhattisgarh and Telangana. However, it was deferred by the **Election Commission following** appeals by political parties, NGOs, churches and students' bodies as Sunday holds a special significance for the people of Mizoram, a Christian-majority state.

The state's Additional Chief Electoral Officer H Lianzela told PTI that the counting will begin in all 13 centres at 8 am amid tight security. One counting hall has been set up for each of the 40 Assembly seats at these 13 centres, he said.

Postal ballots will be counted first, and from 8.30 am, the votes polled in the EVMs will be counted, he added.

Besides three counting centres in the Aizawl district, which has 12 Assembly constituencies, one centre each has been set up in the 10 other districts. Lianzela said.

In some of the seats that have a lesser number of voters, only two rounds of counting will be held, but in most of the constituencies, five rounds will be counted, he said

More than 4,000 personnel will be involved in the counting

# **IMA objects to NMC logo** depicting Hindu deity $\ \ +$

New Delhi, Dec 3: The Indian Medical Association (IMA) Sunday raised its objection to National Medical Commission (NMC) logo depicting the Hindu deity Dhanwantari and urged it to

adopt a religion-neutral emblem. According to Hindu mythology, Dhanwantari is the physician of the gods. The NMC Thursday drew ire from the IMA's Kerala chapter, which said the recent change in the logo was not acceptable. It also drew ire for replacing 'India' with 'Bharat' in the logo. The commission, however, stated that the logo has been in use for over a year.

The IMA said Sunday, "The NMC has adopted a new logo with religious depiction contained therein. The new logo of the NMC is in contradiction with our fundamental values as doctors.'

"It is not in conformity with the oath and duty of doctors, which is not towards any particular religion. Such a logo is also inconsistent with the dignity and decorum of an institution such as the NMC," it further said. The logo of any national institution ought to capture the aspirations of all citizens in an equal manner and, by remaining neutral in all respects thereby, eliminating any possibility of any part/section of society feeling aggrieved, the IMA said.

The association called on NMC to adopt a logo that does not contradict the oath and the duty of doctors "towards all our citizens with complete neutrality, especially in shunning any attemptto connect and/or identify the institution with any religion.'

Under a brown haze over Dubai, the COP28 summit moved past two days of lofty rhetoric and calls for unity from top leaders to concerns on health issues like the deaths of at least 7 million people globally from air pollution each year and the spread of diseases like cholera and malaria as global warming upends weather systems.

World Health Organisation Director-General Tedros Adhanom Ghebreyesus said it was high time for the UN Conference of Parties on climate to hold its first health day in its 28th edition, saying the threats to health from climate change were "immediate and present."

"Although the climate crisis is a health crisis, it's well overdue that 27 COPs have been and gone without a serious discussion of health," he said. "Undoubtedly, health stands as the most compelling reason for taking climate

After two days of speeches by dozens of presidents, prime ministers, royals and other top leaders — in the background and offstage — participants were also turning attention to tough negotiations over the next nine days to push for more agreement on



ways to cap global warming at 1.5 degrees Celsius (2.7 Fahrenheit) since pre-industrial times.

Temperature rises have worsened natural disasters like floods, heatwaves and droughts, and caused many people to migrate to more temperate zones — in addition to the negative knock-on effects for human health.

John Kerry, the US Climate envoy, said it was "astonishing" to him that it's taken so long for health to become a centerpiece of the climate discussion.

"Our bodies are ecosystems. and the world is an ecosystem. Kerry said. "If you poison our land and you poison our water and you poison our air, you poison our bodies.

He said his daughter Vanessa, who works with Tedros, "repeats to me frequently that we should not measure progress on the climate crisis just by the degrees averted, but by the lives saved."

A COP28 declaration backed by some 120 countries stressed the link between health and climate change. It made no mention of phasing out planet-warming fossil fuels, but pledged to support efforts to curb health care sector pollution, which accounts for 5% of global emissions, according to the WHO head.

Diarmid Campbell-Lendrum, head of climate and health at WHO, said heat alone has put pressure on the body and led to higher rates of infectious disease. "Climate change doesn't need to be on a death certificate for us to be confident that climate change is causing deaths,' Diarmid Campbell-Lendrum, WHO's head of climate and health, said.

Dubai, the largest city in oil-rich United Arab Emirates, often faces higher levels of air pollution than other places on Earth due to its location - and haze is common. The city sits on the coast of the Persian Gulf, but further inland begins the Empty Quarter, the massive desert that takes up

a third of the Arabian Peninsula. The city's boom has led to rapid construction, industrial areas and pollution from automobiles, adding to the impacts of sand and particulate churned by the desert winds. Some 3.5 million people now live in Dubai, up from 183,000 less than 50 years ago, and estimates suggest another million commute into the city-state each day for work.

The Dubai government, on its web site devoted to the environment, listed its Air Quality Index level mostly at "good" on Sunday. Switzerland-based IQAir, a technology company that sells airquality monitoring products, listed Dubai as the city with the 18th-worst air quality in the world with "moderate" air quality levels as of noon local time on Sunday.

It cited high levels of two types of particulate matter in the air. and recommended mask-wearing for "sensitive groups" and a reduction of outdoor exercise.

# I t seems like we have free will. Most of the time, we are the ones who choose what we

eat, how we tie our shoelaces and what articles we read on The Conversation. However, the latest book by Stanford neurobiologist Robert Sapolsky 'Determined: A Science of Life without Free Will', has been receiving a lot of media attention for arguing science shows this is an illusion. Sapolsky summarises the latest scientific research relevant to determinism: the idea that we're causally "determined" to act as we do because of our histories - and couldn't possibly

act any other way.

According to determinism, just as a rock that is dropped is determined to fall due to gravity, your neurons are determined

to fire a certain way as a direct result of your environment, upbringing, hormones, genes, culture and myriad other factors outside your control. And this is true regardless of how "free" your choices seem to you.

Sapolsky also says that because our behaviour is determined in this way, nobody is morally responsible for what they do. He believes while we can lock up murderers to keep others safe, they technically

don't deserve to be punished.

This is quite a radical position. It's worth asking why only 11 per cent of philosophers agree with Sapolsky, compared with the 60 per cent who think being causally determined is compatible with having free will and

being morally responsible.

Is determinism incompatible



with free will?

"Free will" and "responsibility" can mean a variety of different things depending on how you approach them.

Many people think of free will as having the ability to choose between alternatives.

Determinism might seem to threaten this, because if we are causally determined then we lack any real choice between alternatives; we only ever make the choice we were always going to

Scientist propounds theory of 'no free will for humans'

But there are counterexamples to this way of thinking. For instance, suppose when you started reading this article someone secretly locked your door for 10 seconds, preventing you from leaving the room during that time. You, however, had no desire to leave anyway because you wanted to keep reading – so you stayed where you are. Was your choice free?

Many would argue even though you lacked the option to leave the room, this didn't make your choice to stay unfree. Therefore, lacking alternatives isn't what decides whether you lack free will. What matters instead is how the decision came about.

The trouble with Sapolsky's arguments, as free will expert John

Martin Fischer explains, is he doesn't actually present any argument for why his conception of free will is correct.

He simply defines free will as being incompatible with determinism, assumes this absolves people of moral responsibility, and spends much of the book describing the many ways our behaviours are determined. His arguments can all be traced back to his definition of "free will".

to his definition of "free will". Compatibilists believe humans are agents. We live lives with "meaning", have an understanding of right and wrong, and act for moral reasons. This is enough to suggest most of us, most of the time, have a certain type of freedom and are responsible for our actions (and deserving of blame) – even if our behaviours are "determined".

Incompatibilists must defend

Some readers sympathetic to Sapolsky might feel unconvinced. They might say your decision to stay in the room, or ignore the child, was still caused by influences in your history that you didn't control—and therefore you weren't truly free to choose.

themselves better

However, this doesn't prove that having alternatives or being "undetermined" is the only way we can count as having free will. Instead, it assumes they are. From the compatibilists' point of view, this is cheating.

Compatibilists and incompatibilists both agree that, given determinism is true, there is a sense in which you lack alternatives and could not do otherwise.

# Illegal parking on highways spells doom for commuters

Keonjhar, Dec 3: Illegal park ing on highways has been causing lethal accidents and claiming precious lives as observation of 'Zero Fatality Week' by the state government went for a toss with as many as 17 lives lost on roads on the very first day of the programme.

Eight people were killed when a van they were travelling in rammed into a stationary truck near Balijodi under Ghatagaon police limits in Keonjhar district Friday morning raising concern among the road users, district officials and people from various walks of life.

Similarly, three people died in three separate road mishaps at Gelpur in Bhadrak. Chinimahula in Sambalpur, and Anandapur in Keonjhar districts. Later in the evening, six more lost their lives in separate road mishaps across the state. Notably, 186 people were killed

and 479 rendered critical in 576 road accidents within nine months this year in Keonjhar district. The accidents occurred in between January and September this year while figures of the rest four months are yet

to be available. Road deaths have witnessed a spurt in this district this year as 272 people had died and 368 sustained critical injuries in 487 road accidents in 2022.

The National Highways Authority of India (NHAI) has provision for patrolling on the highways to check over-speeding, drunken driving and illegal parking on roadsides by the errant drivers

However, due to lack of proper enforcement of rules and curbs, drivers are parking on highways illegally with impunity and the menace has increased through the times. As a result, accidents often take place on the busy highway leading to loss of life and properties as hun-

# Notice to patrolling in-charge of NHAI

KEONJHAR: Ghatagaon police issued notice to the patrolling in-charge of National Highways Authority of India (NHAI) after it registered a case following the death of eight persons in a road accident on NH-20 near Balijodi village in this district, Sunday. Eight persons were killed and 12 sustained critical injuries on NH-20 near Balijodi village when a van on its way to Maa Tarini temple in Ghatagaon rammed into a stationary truck, Friday. The accident occurring on the first day of 'Zero Fatality Week' shook the state government and authorities of state Transport department. Aggrieved over the development, the regional transport department lodged a complaint against the NHAI authorities. After registration of a case, police summoned two persons including the incharge and another employee of the private patrolling agency of NHAI to the police station and questioned them in this connection, Saturday. It also issued a notice to the patrolling in-charge Sunday asking him to cooperate in the investigation. Sources said it is the duty of the NHAI to pick up and relocate vehicles elsewhere in cases of breakdown or accident. The NHAI has signed a contract with a private agency to do the work. Police have also registered a case against the NHAI head and conducting a probe. SDPO Sudarshan Gangei confirmed the development stating that the private agency in-charge has been asked to cooperate in the probe and any violation will invite action from their side.

ing minerals pass through this district on a daily basis.

The deadly accident that occurred Friday could have been averted had patrolling been undertaken on the national highway. The truck which was parked on the roadside owing to a breakdown could have been relocated to a safe place. Moreover, the NHAI officials could have barricaded the area and put up a warning signage to keep approaching vehicles away.

Sources said awareness programmes and raids are being conducted on a large scale in the district to check accidents on roads and highways. However, hardly any action is being taken against rash driving, over-speeding, drunken driving and illegal parking on the highways.

Moreover, dhabas and roadside hotels are mushrooming on the roadside along national highways sans provision for parking. As a result, drivers park their vehicles on the roadside in order to visit the hotels and dhabas for food.

Large number of trucks and other cargo vehicles parked on roadsides is a usual sight on National Highway-20 in areas under Ghatagaon, Sadar, Town and Jhumpura police limits in the district. The NHAI officials have closed their eyes to such wrongdoings and are not doing enough to crackdown on such illegal parking. As a result, approaching vehicles ram into stationery vehicles parked on the highways leading to loss of life and properties.

When contacted, RTO Gopalkrushna Das said action will be taken against the owners and drivers of the vehicles parked on highways while steps will be taken to relocate the vehicles in

case of a breakdown. Ghatagaon SDPO Sudarshan Gangei said no patrolling was conducted Friday due to strike by the patrolling staff while the NHAI patrolling staff assisted in the rescue operation after the accident. Meanwhile, all eyes are on the district administration and its action after this gruesome mishap.

Banamali was sleeping inside a temporary tent at the paddy threshing ground Saturday night when two tuskers came around 1am at night and trampled Banamali to death. Informed by the Gaja Sathi, Forest department officials reached the spot and sent the body to


Keonjhar DHH for a post-mortem. Reportedly, the two tuskers were separated from a 20-member herd at Nayakote beat area under Bhuyan-Juanga-Pidha forest range and wrecked havoc in the adjacent villages of the forest in search of food.

# **Lotus Blooms**

The BJP's emphatic win in the Assembly elections to Madhya Pradesh, Rajasthan and Chhattisgarh has come when the party needs it most. The Congress' dream of retaining Rajasthan and Chhattisgarh and wresting MP from the BJP is shattered and its ability to oust the K Chandrasekhar Rao-led BRS government in Telangana is a poor consolation, especially when everyone knows these Assembly elections are going to decide whether the BJP or the Congress-led INDIA would be in the saddle of power in Delhi a few months away. Prime Minister Narendra Modi will now breathe easy as he remains unassailable and still retains his charisma despite his government's shoddy management of the country's economy. Not surprisingly, he has celebrated the sweet victory with the rhetorical outburst he is adept at. The results, he has said, indicate the people of the country are "firmly with politics of good governance and development which the BJP stands for.' Some may say this is more froth than substance. But, Modi's leadership and the sound and fury he makes have won the day.

The results are in a way unexpected as the Congress became euphoric after its victory in Karnataka and the BJP appeared to be defensive, less confident and desperate to win the three states in the Hindi heartland which alone can pave the way to victory in the Lok Sabha election

The outcome has once again brought to the fore the weakness of the Congress' electoral strategy and leadership. It has once again proved soft-Hindutva of the Congress cannot be an answer to the BJP's brand of religious politics. For one thing, the people all over the world rally behind the original rather than the copy. Rather the Congress probably could have done better if it would have made the country's economic management its main electoral plank.

The BJP could sway the electorate in MP despite the incumbent Chief Minister Shivraj Singh Chouhan's bad image. Its promise of presenting a new leadership may have tipped the balance in its favour. On the other hand, the Congress has failed to inspire the people's confidence by projecting an old politician like Kamal Nath with dubious records as its main leader.

The Shivraj Singh Chouhan-led government successfully showcased its significant agricultural achievement such as providing water, power connections for irrigation tubewells soaring from 13.2 lakh to 32.5 lakh between 2010-11 and 2020-21 alone. Net area irrigated under canals, too, has nearly doubled during Chouhan's tenure. That has been partly due to new investments, but also the focus on completing unfinished lastmile projects and improving utilisation of existing irrigation potential, through concrete lining of canals and timely desilting, cleaning and fixing breaches before the cropping season have all contributed

Again what worked in BJP's favour in Madhya Pradesh and Chhattisgarh is the women voters' support. With this demography in mind the party announced special schemes in the manifesto.

MP has 26 million women voters, while the number of women who voted in this election has gone up by 2 per cent in the state. Evidently, this could have been a great contributing factor for the BJP's victory

The results in Rajasthan were more or less predictable. The state has the history of throwing out the incumbent government every five years for the past nearly thirty years and the pattern has been repeated. But, more than that it is the internecine war in the Congress between CM Ashok Gehlot and CM-aspirant Sachin Pilot that became so sickening and nauseating that the people decided to dump the

The situation in Chhattisgarh was no better for the Congress despite the hype of tribal welfare that the party's central leadership promised. For, Bhupesh Baghel's record was besmirched with corruption charges. The BJP has been able to consolidate the support base, transcending caste and class lines. In Chhattisgarh in particular, it has managed to secure lead in 20 of the 34 tribal seats, which matters in a state where nearly 1/3rd of the population is tribal.

The BJP in Chhattisgarh also promised a slew of schemes just four days ahead of the first phase of polling on November 7. These included cooking gas cylinders at Rs 500 for poor families and Rs 12,000 per year financial assistance to married women. The strategy has paid dividends and countered the Congress campaign on welfare

Finally, the Congress' appeasement politics has obviously not cut much

ice with the people sealing its fate in the states.

The upshot of the results of the four states is that the Congress is left to eat dust. Its position in INDIA bloc as the big brother gets weakened. The BJP is poised to make its bid for the third time rule of the Narendra Modi-led BJP government at the Centre with tremendous con-

e must separate the Jews into two categories, the Zionists and the partisans of assimilation," wrote Reinhard Heydrich, one of the architects of the Holocaust, in 1935. "The Zionists profess a strictly racial concept and, through emigration to Palestine, they help to build their own Jewish State....[O]ur good wishes and our official goodwill go with them.

In Heydrich's terms, the creation of the State of Israel thus represented the triumph of Zionism over assimilationism. But it also complicated the traditional anti-Semitic perception of Jews as a deracinated, rootless people. This was Martin Heidegger's view, in 1939, when he called for an examination of "Jewry's predisposition to planetary criminality": "With their marked gift for calculation, the Jews 'live' according to the principle of race, and indeed have done so for the longest time, for which reason they themselves most vigorously resist its unrestricted application. The arrangement of racial breeding stems not from 'life' itself, but from the hyperempowerment of life by machination (Machenschaft). What this brings about with such planning is a complete deracination of peoples by harnessing them in a uniformly constructed and streamlined arrangement of all entities. Along with deracination goes a self-alienation of peoples - the loss of history - i.e., of the regions of decision for being (Seyn)."

Underpinning these lines is the philosophical opposition between fully living in a concrete world and denying such spiritualhistorical roots by viewing all "external reality" as merely something to be manipulated and exploited. But what happens when a supposedly rootless cosmopolitan race begins to put down roots? With Zionism, the French philosopher Alain Finkielkraut wrote in 2015, "The Jews, they have today chosen the path of rooting.'

It is easy to discern in this claim an echo of Heidegger's

belief that all essential and great things require a "blood and soil" homeland. The irony is that anti-Semitic clichés about rootlessness are invoked to legitimiSe Zionism. Whereas anti-Semitism reproaches Jews for being rootless, Zionism tries to correct this supposed failure. No wonder so many conservative anti-Semites ferociously support Israel's expansion to this day. The problem, of course, is that expansion, under Israeli Prime Minister Binyamin Netanyahu's government, now means settling and annexing the West Bank – seeking roots in a place that was for centuries inhabited by other people.

We encounter a similar issue  $with \, differing \, interpretations \, of \,$ the traditional Jewish saying 'Next year in Jerusalem," pronounced at the end of the Seder (the ritual meal marking the start of the Passover holiday). As Dara Lind of Vox explains: "Many Jews who believe strongly in the importance of a Jewish state see 'next year in Jerusalem' as an expression of the need to protect Jerusalem and Israel as they exist today. Others think of the 'Jerusalem' mentioned in the Seder more of an ideal of what Jerusalem and Israel could be – for them, 'next year in Jerusalem' is a prayer that Israel will move closer to that ideal. Or 'Jerusalem' could just be a symbol of utopia more generally, and 'next year in Jerusalem' could be a resolution to bring peace to Earth in the

These versions reproduce the duality of the transcendental and the empirical. "Jerusalem" is either an abstract spiritual site of deliverance or an actual city with real people, buildings, and religious monuments. Not surprisingly, some Muslim fundamentalists are quite sympathetic to the "transcendentalists" who regard exaltation of the actual city as blasphemy. In the mid-2000s, when then-Iranian President Mahmoud Ahmadinejad organised a conference calling for the State of Israel's obliteration, he hosted a few friendly "transcendentalist" rabbis. It was an inversion of Heydrich's view: Having Jews in our midst is okay; it is the Jewish state that is unacceptable.

But there is a third, profoundly dangerous version of "Next year in Jerusalem" that offers a synthesis of the two. Those who espouse it say: "Now that we have Jerusalem, we can use next year to demolish the Palestinian buildings and rebuild the biblical Temple on the site where the Al-Aqsa Mosque currently stands." The struggle for Jerusalem thus becomes a sacred undertaking. Even if a crime is committed, the perpetrators will bear no guilt (in their eyes) because they are founding a new legitimate order. It is like the old joke in which the villagers boast of having no cannibals: "We ate the last one yesterday."

But let's be clear about what is really going on. By using Jewish victimhood to justify an

expansionist agenda, pro-annexation Israelis are cynically exploiting the memory of the Holocaust. Those offering unconditional support for Israel thus are also supporting the current Israeli government against the liberal opposition that opposes settlements and expansion. Yet that expansionism is a leading source of anti-Semitism in the world today.

Among the countries offering full support for Israel is Germany, where many on the right warn of "imported anti-Semitism" (importierter Antisemitismus). The implication is that any new wave of anti-Semitism in Germany is not a German phenomenon, but rather a result of Muslim immigration. But why, then, have so many young leftists in the West also refused to express solidarity with Israel following Hamas' attack on October 7? Why are young Americans circulating Osama bin Laden's

"Letter to America" on TikTok? It is too easy to say that they simply sympathise with Hamas. Rather, what unites many of those joining pro-Palestinian protests is the broader view that the foreign policies and military apparatuses of the United States and its Western allies are beholden to Big Capital and its exploitation of the rest of the world. Sometimes, there is a very thin line separating genuine discontent with capitalism from the kind of "anti-capitalist" populism found in Bin Laden's letter.

Many liberals have expressed their support for Israel while simultaneously voicing concerns about the number of civilians-especially children-being killed in Gaza. There is growing sympathy for Palestinians as victims, as well as a recognition of their right to resist expansionist encroachment. But how they can resist without becoming anti-Semites? It is a question that so far has elicited only silence and embarrassment.

# Not necessarily by accident

The nation celebrated the rescue of 41 workers from the Silkvara Bend–Barkot tunnel in Uttarkashi district of Uttarakhand. Once the euphoria of successful effort settles, it will be time to ask whether the tunnel collapse was preventable. The utility and impact of the answers will depend on the questions we ask. Our conduct of post-accident inquiries into causes has been less than satisfactory. A discussion of how we have dealt with railway accidents will illustrate this.

On October 29, 2023, there was a terrible accident involving a collision between two trains in Andhra Pradesh which resulted in the death of 14 and several more injured. On June 02, 2023, over 290 passengers lost their lives while around 1000 were injured in a crash involving three trains in Odisha. Such accidents are published on front pages in newspapers and are on national television news for a few days and then lapse into a collective national apathy until the next catastrophe. The process has become a ritual where politicians at local and national levels announce payments to families of the deceased and injured. This is followed by a decision to initiate an enquiry into the causes of the accident. And then we happily move on with our lives.

There has been significant amount of research analysing human errors that result in accidents in a variety of situations from healthcare, to aviation, and nuclear power plants. Some of the most respected work has been done by James Reason and Charles Perrow. They have suggested that errors are of two types: active errors and latent errors. Active errors occur at the level of frontline operators, and their effects are felt almost immediately. Active errors are related to the act of omission or commission that may have been occurred when and where the accident happened. They do not tend to affect any other area of the system at any other point in time. Latent errors are prevalent throughout the system. They can, and do, lead to errors in different parts of the system at different points in time and hence are more consequential than active errors. In general, any inquiry that is constituted after an accident tends to focus on active errors and not on latent or systemic errors

There could be a variety of reasons for this. Latent errors are not easily discernible. They typically involve the acts of omission and or commission by higher level officials, and there could be a tendency to avoid confrontation with powerful officials. It is much easier to pick an operator's mistake than to question policy makers of the organisation.

An audit report by the CAG on Derailment of Trains in India for the years 2017-2021 makes for some very interesting, as well as alarming, reading. The report looked at several aspects of the operation and maintenance of the rail system. One aspect deals with the inspection of tracks with the help of Track Recording Cars (TRCs). The Indian Railway Permanent Way Manual provides that broad gauge routes should be monitored by TRCs as per prescribed frequencies dependent on the type of track. The audit found that the shortfall in conducting the inspections varied from 30 to 100%

across different zonal divisions. The best performing zonal division could only perform 70% of prescribed inspections. In 14 out of 18 divisions the inspections performed were half or less than half the prescribed requirements, and in four divisions no inspections were carried out at all.

The government is moving ahead with ambitious plans for high-speed rail connecting the cities. While we should be celebrating these plans, nevertheless there is sufficient cause for concern regarding our ability to maintain the existing railway assets, let alone the newer, more sophisticated systems. We should not fall into the trap of thinking that we can automate ourselves out of this mess. What is needed is better management at ground level and a real commitment to passenger safety from the government and top management of railways. Until that happens, perhaps it might be better to slow down. And it may be instructive to repeat the audit after a few years to see to what extent the railways have heeded the suggestions.

# **CASH-FOR-JOB SCAM** 21 govt officials suspended in Assam

Guwahati, Dec 3: At least 21 high-ranked government officers including senior police personnel were suspended by Assam Governor Gulab Chand Kataria for their alleged involvement in a cash-for-job scam in the recruitment examinations conducted by the Assam Public Service Commission, an official said.

Ten officers of the Assam Civil Service (ACS) and 11 officers of the Assam Police Service (APS) are among the suspended officials. When the previous APSC chairman Rakesh Paul was taken into custody by the police in the Dibrugarh in November 2016, it became apparent that there were alleged irregularities with the Combined Competitive Examination (CCE) that the APSC conducted in 2013, 2015, and 2016. In March this year, he was released on bail.

At least 57 more government officials were detained for their alleged involvement after he was apprehended. After assuming the chair of Chief Minister, Himanta Biswa Sarma restarted the investigation and established an inquiry panel led by Justice (retd) Biplab Kumar Sharma of the Guwahati High Court in 2021. Sarma gave the go-ahead to establish a special investigation team (SIT) last month in order to look into the allegations more thoroughly

The Gauhati High Court will receive the report from the SIT headed by Additional Director General of Police (DGP) (CID) Munna Prasad Gupta in six

"As many as 1,052 persons have died due to heart attack during the last six months in Gujarat. Nearly 80 per cent of them were in the age-group of 11 to 25 years and these students and youngsters were not even obese. The 108 ambulance service receives 173 cardiac emergency calls per day," said Dindor while addressing the media in Gandhinagar.

Youngsters are living in fear because a majority of the heart attack victims were in their age group, he claimed.



The Congress was poised to oust the BRS in Telangana.

"In the three states, it is more of a Congress failure than a success story of the BJP," TMC spokesperson Kunal Ghosh said in a social media message.

Asserting that TMC supremo Mamata Baneriee should be made the face of the opposition bloc, Ghosh later said her welfare policies have been a huge success and borne electoral fruits in West Bengal. Leaders of the opposition INDIA bloc are scheduled to meet in Delhi December 6 to chalk out a strategy for the 2024 Lok Sabha elections.

Ghosh claimed that Rajasthan, Madhya Pradesh and Chhattisgarh polls results will not have any impact on the Lok Sabha polls next year.

The TMC leader claimed that to win the elections in these states, other parties have imbibed the welfare schemes of Banerjee. Batting for the



bacle in the three states, CPI(M) central committee member Sujan Chakraborty said it will not be right to suggest that Rahul Gandhi's 'Bharat Jodo Yatra' did not have a positive impact.

The CPI(M) leader said soon after the yatra, elections were held in Karnataka, Punjab and Himachal Pradesh, where the Congress fared well.

"Congress had snatched Karnataka from the BJP and also won in Himachal," he said in a statement. Claiming it is wrong to suggest a saffron wave because the BJP was winning in the three states, Chakraborty said it will be a different ball game in the 2024 Lok Sabha elections.

Refusing to accept that the Congress is confined to southern India, he said the grand old party has secured a significant percentage of votes in all the four states. Stating that there is space for both the ruling and opposition camps in politics, Chakraborty said losing the elections in Rajasthan, Madhya Pradesh and Chhattisgarh does not mean that the Congress has been annihilated.

# Stage set for stormy Winter Session of Parl

New Delhi, Dec 3: Buoyed by its victory in the assembly elections, an aggressive BJP will seek to corner the Congress-led Opposition in the Winter Session of Parliament beginning Monday when a report recommending TMC MP Mahua Moitra's expulsion is expected to be tabled in the Lok Sabha.

The leaders of the Opposition INDIA bloc are meeting Monday morning ostensibly to redraw their strategies to take on Prime Minister Narendra Modi-led BJP both inside the Parliament and in the electoral arena. The Congress, which was hop-

ing to score a big win in Madhya Pradesh and retain Chhattisgarh and Rajasthan, had to taste a resounding defeat. However, the grand old party did manage to oust the BRS from Telangana.

"If the Opposition disrupts the Parliament, it will face worse

results than what has come today (Sunday)," Parliamentary Affairs Minister Pralhad Joshi told reporters here when asked about the Winter Session beginning Monday.

The government has presented a heavy legislative agenda for the 15 sittings of the Winter Session with key bills to replace the colonial era criminal laws, a draft legislation to provide for a framework for appointment of the election commissioners.

The report of the Lok Sabha Ethics Committee recommending Moitra's expulsion from the Lower House over a "cash-for-query" complaint is also listed for tabling in the House Monday . The government is also expected to move a motion in the Lok Sabha to adopt the recommendation of the Ethics Committee, which would lead to Moitra's expulsion from the Lower House.

# Gangster shot dead inside Dhanbad jail

Dhanbad, Dec 3: Gangster Aman Singh, an accused in former Dhanbad Deputy Mayor Neeraj Singh's murder case, was shot dead inside Dhanbad Jail in Jharkhand Sunday, police said.

After six to seven bullets were pumped into Aman Singh inside the jail, he was rushed to the Medical College in Dhanbad, where doctors declared him dead. Senior officials, including Dhanbad Deputy Commissioner and Senior

Superintendent of Police, rushed to the prison and the state police headquarters dispatched a three-member team to investigate the

A probe is underway to determine who shot Aman Singh and how the weapon reached the prison. The gangster is the main accused in more than a dozen cases, including the murder of former Deputy Mayor of Dhanbad, Neeraj Singh, contract killings, extortion, threat calls, and recovery of dues

In the Neeraj Singh murder case, Singh was arrested by the Uttar Pradesh Special Task Force outside Mirzapur Jail in May 2021 and handed over to Dhanbad Police. Upon his arrival in Dhanbad Jail, Singh's gang extended its influence not only within the prison but also across the coal belt of Dhanbad.

His gang extorted money from businessmen and doctors in Dhanbad and Bokaro and was also responsible for the murder of BJP leader Shailesh Patel in Valsad, Gujarat.



### Film stars to be fielded by the BJP

The Lok Sabha polls may be 6 months away. But the BJP leadership is busy selecting winnable candidates along with elections in five states. Reports emanating from the BJP headquarters suggest that it is looking for new faces from the film industry to be fielded in the Lok Sabha polls. ## **Earthquake shakes Philippines**; 1 dead

Manila: Philippines residents were allowed to return to their homes Sunday after a magnitude 7.4 earthquake struck the country's south, killing at least one person, with disaster officials reporting minor damage to some infrastructure. The Saturday night quake shook parts of Surigao Del Sur and Davao Oriental provinces, triggering coastal evacuations and tsunami alerts in the country and in Japan. A woman was killed when a wall collapsed as she and her family was fleeing their home in search of safety in Tagum city in Davao del Norte province. said disaster official Mon Cabonilas.

### Pak sees 34% rise in militant attacks

Islamabad: Anti-state violence in Pakistan surged with 63 militant attacks recorded in the country during the month, a thinktank report said Sunday. The 63 militant attacks in November resulted in 83 deaths, including that of 37 security forces personnel and 33 civilians, the Dawn newspaper reported, citing data by the Pakistan Institute for Conflict and Security Studies (PICSS) think tank. Additionally, 89 individuals, including 53 civilians and 36 security forces personnel, sustained injuries, according to the Islamabad-based

# ISRAEL UPS THE ANTE NOWhere safe in Gaza Russian forces killing

Palestinians in Gaza are running out of places to go as Israel raises its offensive to the southern half of the territory where it claims that Hamas leaders are hiding

Gaza/Cairo, Dec 3: Israeli forces bombed wide areas of the Gaza Strip Sunday, killing and wounding dozens of Palestinians, as civilians in the besieged territory sought shelter in an ever-shrinking area of the south.

The Jabalia refugee camp in the north of the Hamas-ruled enclave was among the sites hit. A Gazan health ministry spokesperson said several people were killed by an Israeli air strike

Footage obtained by Reuters of the aftermath of the strike showed a boy covered in grey dust, sitting weeping amid crumbled cement and rubble from collapsed buildings. "My father was martyred (killed)," he cried in a

Bombardments from war planes and artillery also concentrated on the cities of Khan Younis and Rafah in Gaza's south. residents said, and hospitals were struggling to cope with the flow of wounded.

The renewed warfare followed the end Friday of a seven-day pause in the fighting between Israeli forces and Hamas militants which had allowed an exchange of Israeli hostages and Palestinian prisoners.

The violence took place despite calls from the United States Israel's closest ally - for Israel to avoid further harm to Palestinian civilians.

More than 15,523 have been killed, according to Gaza's health



ministry, in nearly two months of warfare that broke out after a Hamas cross-border raid on southern Israel October 7 in which 1,200 Israelis were killed and more than 200 taken hostage.

Israel says it is acting to annihilate Hamas, saying it poses a mortal threat to the Jewish state's very existence. The initial Hamas attack and the ensuing war amount to the bloodiest episode in the decades-old wider Israel-Palestinian conflict.

### **GROUND OFFENSIVE FEARED**

Gaza residents said Sunday they feared an Israeli ground offensive on the southern areas was imminent. Tanks had cut off the road between Khan Younis and Deir Al-Balah in central Gaza, effectively dividing the Gaza Strip into three areas, they

# surrendering Ukraine soldiers, blames Kyiv

Russia denies committing war crimes during its 21-month-old war in Ukraine

Kviv. Dec 3: Kviv officials accused Moscow of committing a war crime after a grainy video on social media appeared to show several soldiers shooting two surrendering military personnel who emerged from a dugout at gunpoint.

The unverified video shows one soldier coming out of a foxhole on the battlefield with his hands up and then lying on the ground. A second soldier stumbles out and also lies down. The Russian troops then appear to open fire and the video ends.

The Ukrainian General Prosecutor's Office said: "The video shows a group of people in Russian uniforms shooting, at point-blank range, two unarmed servicemen in the uniform of the Armed Forces of Ukraine who were surrendering.'

Deepstate, a popular Ukrainian war blog which posted the video clip, said the footage was filmed near Stepove on the Avdiivka front line in Donetsk region.

The General Prosecutor's Office said the incident took place in Pokrovsk district, a

# India to pull back troops from Maldives: Prez

New Delhi: India's government has agreed to withdraw its soldiers from the Maldives, the Indian Ocean archipelago's President Mohamed Muizzu said Sunday. Muizzu won the presidential election in September, having campaigned to alter the Maldives's "India first" policy and promising removal of a small Indian military presence of some 75 personnel. "In the discussions we had, the Indian

government has agreed to remove Indian soldiers," Muizzu told reporters. "We also agreed to set up a high level committee to solve issues related to development projects." India and China have been vying for influence in the region, with the coalition that supports Muizzu

considered to have a leaning more towards China.

## S'pore shoplifting: 2 more Indian students held



Singapore: Two more Indian students nave been jailed in Singapore for conspiring to steal apparel worth over SG\$1.700 (over Rs 1 lakh) from a retail store by removing the items' price ags. Brahmbhatt Komal Chetankumai and Christian Arpita Arvindbhai, both 27-years-old, pleaded quilty December 1 to shoplifting offences and were sentenced to 40 and 45 days

jail respectively, The Straits Times newspaper reported. In a court ruling last month, the two who were on student passes in Singapore, had initially stated that they had no intention to steal, District Judge Eugene Teo called their acts "disgraceful" and told them not to commit such offences again. Komal and Arpita lived together in the same flat with four other Indians who were part of a group that stole apparel from the Uniglo store. The court documents identified three more Indian nationals -- Bhavik, 24, Vishal, 23, and Darshan, 22 -- in the conspiracy.

# **Philippine bombing:** 'Foreign terrorists' behind explosion

Manila, Dec 3: Philippines President Ferdinand Marcos Jr condemned a deadly bombing Sunday, blaming "foreign terrorists", as police and the military strengthened security in the country's south and around the capital Manila.

At least four people were killed and at least 50 injured after a bomb exploded during a morning Catholic Mass in a university gymnasium in Marawi, a city in the south of the country besieged by Islamist militants for five months in 2017.

"I condemn in the strongest possible terms the senseless and most heinous acts perpetrated by foreign terrorists," Marcos said in a statement. "Extremists who wield violence against the innocent will always be regarded as enemies to our society."

Law enforcement operations to bring to justice the perpetrators of the "terrorist activity" will "continue unabated", Defense Secretary Gilberto Teodoro told a press conference.

bombing, Teodoro said, refus-

ing to elaborate so as not to com-

promise ongoing investigation. Fragments of a 16-mm mortar were recovered at the scene, senior police official Emmanuel

Dubai, Dec 3: India Sunday refrained from signing the COP28 Declaration on Climate and Health, with sources pointing out that curbing greenhouse gas use for cooling in the health sector, which is one of the points in the document, may not be practical or achievable within the country's healthcare infrastructure in the short term.

The declaration calls for climate action to achieve "benefits for health from deep, rapid, and sustained reductions in greenhouse gas emissions, including from just transitions, lower air pollution, active mobility, and shifts to sustainable healthy diets'

On the occasion of the first Health Day at the 28th UN Climate Change Conference (COP28) Sunday, the declaration expressed grave concern about the negative impacts of



climate change on health.

The declaration is signed by 124 countries till now with the US and India, which are among the top greenhouse gas emitters, absent from the list of sig-

The report also said India's GDP grew at a cumulative annual growth rate of 7 per cent but its emissions rose by only 4 per cent per year during this period, suggesting that the country has been successful in decoupling its economic growth from planet-warming greenhouse gas emissions. Environment Minister Bhupender Yadav said that India reduced its GDP emission intensity by 33 per cent between 2005 and 2019, achieving the target 11 years in advance. India created an additional carbon sink of 1.97 billion tonne of CO2 equivalent during this period. However, the country's total emissions (including the Land Use, Land-Use Change and Forestry sector) have increased by 4.56 per cent with respect to 2016. The emission intensity of the economy refers to the total amount of greenhouse gases emitted for every unit increase of gross domestic product (GDP). It is different from absolute emissions.

### Top firms shine

New Delhi: The combined market valuation of nine of the top-10 most valued firms climbed ₹1.30.391.96 crore last week, with Bharti Airtel and **Tata Consultancy Services** (TCS) emerging as the biggest gainers, amid an overall optimistic trend in equities. Last week, the BSE benchmark jumped 1,511.15 points or 2.29 per cent. Barring Reliance Industries, nine other companies including HDFC Bank, ICICI Bank, Infosys and Hindustan Unilever witnessed addition in their market valuation. In the ranking of top-10 firms, Reliance Industries retained the title of the most valued firm, followed by TCS, HDFC Bank, ICICI Bank Infosys, Hindustan Unilever, Bharti Airtel, ITC, State Bank of India and Bajaj Finance.

## Honda to up rates

New Delhi: Honda Cars India plans to increase prices of its vehicles from January in order to partially offset the impact of riding input costs, according to a senior company official. The Japanese carmaker sells three models -- Elevate, City and Amaze -- in the Indian market. In an interaction with PTI, Honda Cars India VP Kunal Behl said the company will increase the prices of its models from next month due to pressure on input costs. Maruti Suzuki, Mahindra & Mahindra and Audi India have also announced plans to hike prices of their passenger vehicles in January 2024 citing reasons, including cost pressure driven by overall inflation and increased commodity rates. Besides, Tata Motors and Mercedes-Benz India are mulling increasing the prices of their models from January.

# NSE firms cross \$4tn feat FPIs again making

*In a first, NSE listed companies' market capitalisation surpasses \$4 trillion* milestone just days after BSE touched the mark amid unprecedented bull run

New Delhi, Dec 3: The market capitalisation of listed companies on the NSE has surpassed the \$4 trillion (Rs 334.72 trillion) mark for the first time ever, with the benchmark Nifty hitting its alltime high of 20,291.55 last Friday.

The benchmark Nifty climbed 134.75 points or 0.67 per cent to settle at an all-time high of 20,267.90 Friday. During the day, the benchmark reached its intraday record high of 20,291.55.

The Nifty-500 index also touched an all-time high of 18,141.65 on the same day, indicating that the equity market rally is not restricted to only the large-cap stocks.

"The achievement of this milestone is a testament of the vision outlined for the Amrit Kaal which includes a technologydriven and knowledge-based economy with strong public finances, and a robust financial sector," NSE said in a statement on

The journey of market capitalisation of listed companies rising from to \$2 trillion (in July 2017) to \$3 trillion (in May 2021) took about 46 months, whereas the last \$1 trillion i.e., from \$3 trillion to \$4 trillion took only about 30 months, it said

The combined market valuation of all listed companies on the BSE also reached the USD 4 tril-

The market cap of listed companies increased at a compounded annual growth rate (CAGR) of 17.5 per cent in the last 10 years, the exchange said.

The top three companies by market valuation - Reliance Industries Limited, Tata Consultancy Services and HDFC Bank - retained their positions when NSE's valuation hit the \$2 trillion, \$3 trillion, and \$4 trillion mark, it added.

'Whie India ranks amongst the top five nations based on market capitalisation, the mar-

ket cap of listed companies on the NSE to India's GDP stood at 1.18 or 118 per cent, which is lower as compared to developed markets such as the United States of America or Japan," NSE said in the statement.

The share turnover velocity at NSE for the year 2023 as on date stood at 47 per cent, which is way below some of the global markets such as the US, Japan, South Korea, China and Brazil, it noted.

A very low percentage of companies listed on the exchange and comparative lower share turnover velocity, indicates an immense growth potential for deepening of the Indian market in the years to come, the NSE added.

While the \$4 trillion market capitalisation is an important milestone, data suggests that only 0.35 per cent of the total private companies registered with the Ministry of Corporate Affairs, are listed on the exchanges indicating an enormous number of companies which can tap the equity market for their funding needs, it noted.

The daily average turnover has seen a year-on-year growth of 27 per cent in the equity segment and 5 per cent in equity derivatives in this financial year as compared to the previous financial year.

In the last 10 years, the equity segment's daily average turnover has increased by over 6 times and that of equity derivatives daily average turnover has increased by over 5 times, the exchange said.

The resource mobilisation by corporates including the small and medium enterprise in the primary market has been encouraging and has provided an effective alternative mechanism in addition to the traditional methods of fundraising.

"In the current financial year as of October 2023, more than ₹5,00,000 crore have been mobilized through primary markets across equity and corporate bonds," it added.

# Sharp dip in FDI into India from Cayman Islands, Cyprus in H1

FDI into India declined 24 per cent to USD 20.48 billion in April-September 2023-24, dragged by lower inflows in computer hardware and software, telecom, auto and pharma

New Delhi, Dec 3: Foreign direct investment (FDI) into India from Cayman Islands and Cyprus contracted significantly during April-September this fiscal as the overall inflows declined by 24 per cent, according to the government data

FDI from Cayman Islands dipped 75 per cent to \$145 million during April-September from \$582 million in the same period last fiscal, the data showed.

Similarly, inflows from Cyprus contracted by over 95 per cent to \$35 million during the six-month period as against \$764 million in April-September 2022-23.

Experts have attributed the sharp fall in FDI from Cyprus and Cayman Islands to a hightened scrutiny of applications.

Anjali Malhotra, Partner -Regulatory, Nangia Andersen India said FDI inflows from other tax havens such as Singapore, and the UAE have also lost their sheen along with Cayman Islands and Cyprus during first half of



...The recent decline in investment from Cayman Islands and Cyprus may be attributed to enhanced scrutiny of these investments." Malhotra said adding the recent decline in investment from tax havens is also in line with an overall fall in FDI during first half of 2023-24

The reason for overall decline may be attributed to increased interest rates owing to high inflation in the US and other western nations exacerbated by geopolitical situations in Eastern Europe and West Asia, she said.

Sanjay Kumar, Partner, Deloitte India, said it is worth noting that the overall FDI outflow from Cyprus to the world has been declining at a CAGR (compound annual growth rate) of 62 per cent.

For Cayman Islands, Kumar said that in October this year, the region was removed from the grey list by FATF (Financial Action Task Force) and this may result into positive FDI flow from Cayman Islands in coming times.

New Delhi, Dec 3: The Sports Authority of India (SAI) has approved Olympic and World Champion javelin thrower Neeraj Chopra's proposal to train in South Africa as part of his preparations for the upcoming Paris Games seven-and-half-months from now, sources said here Sunday. The Tokyo Olympic champion will head to Potchefstroom in South Africa later this month to train for his Olympic title defence.

Neeraj had submitted a proposal to SAI under the 'Target Olympic Podium Scheme' (TOPS). He sought permission and also allocation of funds to train at the North-West University at Potchefstroom in South Africa.

Neerai's proposal has been approved, sources informed. He



will be training in South Africa for a period of 85 days. His training is set to begin December 5 and will continue till February 29, 2024. He will then be shifting his base to Europe and also take part in some tournaments as a build-

up for the Olympics. The Mission Olympic Cell (MOC) approved Neeraj's proposal worth ₹27.67 lakh earlier this week. He will be accompanied

> by coach, Dr Klaus Bartonietz and physiotherapist Ishaan Marwaha.

Other than defending his gold medal at the Olympics, Neeraj has also repeatedly talked about breaching the 90metre mark. He achieved his best-ever throw of 89.94m at the Stockholm Diamond League in 2022. There can be no doubt that he will lay special emphasis on going past the 90-metre mark. The current world record of 98.48m stands in the name of Jan Zelezny, the legendary thrower from the Cezch Republic. Neeraj enjoyed a

terrific season in 2023. The 🎉 year saw him become the first Indian athlete to win the gold medal at the World Athletics Championships. He also

defended his Asian Games gold. In the Diamond League Final, he ended up as the runnerup after winning the Doha and Lausanne legs earlier in the vear.

SAI has also approved a sum of ₹73 lakh for the training of the badminton doubles duo Chirag Shetty and Satwik Rankireddy. The two are currently coached by Danish doubles expert Mathias Boe. He takes a salary of ₹7 lakh per month to train the Indian pair. Boe will now be training them till the Paris Olympics as the Indians are also medal contenders.

Bangalore, Dec 3: Bowlers came to the party as India defeated Australia by a narrow margin of six runs to wrap up the five-game T20I series 4-1 here Sunday. Defending a below par 160 for eight, the Indian bowlers restricted Australia to 154 for eight to assert their supremacy on the proceedings.

Pacer Mukesh Kumar (3/32) was the pick of the Indian bowlers. He was well-supported by fellow paceman Arshdeep Singh (2/40) and spinners Ravi Bishnoi (2/29) and Axar Patel (1/14). In fact, the spinners restricted the run rate to build pressure on the Australian bat-



ters and the pacers exploited the situation beautifully.

Ben McDermot (54, 36b, 5x6) defied the Indian bowlers to some extent, However, players like Travis Head (28) and Matthew Wade (22) failed to complete the job against some accurate Indian bowling.

Earlier Shreyas Iyer (53, 37b, 5x4, 2x6) held the Indian innings together after the hosts lost early wickets. Riding on Iyer's knock and some useful lower-order contributions from Axar Patel (31,

21b, 2x4, 1x6) and Jitesh Sharma (24, 16b, 3x4, 1x6), India posted a competitive 160 for the loss of eight wickets after being put in by the visitors.

At 55 for the loss of four wickets, India looked set to finish with a below par total. However, a fifth wicket stand of 42 runs between Iyer and Jitesh and then another 46 runs for the sixth between him and Axar took India past the 150-run mark.

The Indian top-order for once failed to get going as Yashasvi Jaiswal (21), Ruturaj Gaikwad (10), skipper Survakumar Yaday (5) and Rinku Singh (6) fell cheaply. However from then on, it was Iyer who held the innings
