#### **Naik appointed Addl CEO of state**

Bhubaneswar: The Odisha government appointed Wednesday IAS officer, Dr Noonsavath Thirumala Naik as the additional chief electoral officer of the state. "The post of additional chief electoral officer. Odisha is declared equivalent in status and responsibility to the post of additional secretary provided in the IAS cadre of the state," the Odisha government said in a notification. The 2009 batch officer had been serving as Labour Commissioner, Odisha with additional charge of State Mission Director, Odisha Livelihoods Mission in the past.

#### **Odisha govt bans** strike by health staff

Bhubaneswar: The Odisha government has banned any kind of strike or ceasework by staff of the Health department in the state for a period of six months. Strikes by nurses, paramedics, technicians and other Class-III and Class-IV employees of Health department including the contractual employees have been banned for a period of six months by exercising the power conferred by the Odisha Essential Services (Maintenance) Act 1988, the state Home department said in a notification Wednesday. This has been done to ensure uninterrupted health services at government-run medical colleges and hospitals, district headquarters hospitals, community and primary health centres and all other state-run health facilities including police hospitals.

# 100 job sites blocked Man dies during

ALL THESE WEBSITES WERE USING SOCIAL MEDIA PLATFORMS TO DUPE VICTIMS

New Delhi, Dec 6: The Union Home Ministry said Wednesday that more than 100 websites that were being operated from overseas and involved in organised illegal investments and parttime job frauds have been blocked and banned.

These websites were identified and recommended for blocking by the Indian Cybercrime Coordination Centre (I4C), an initiative of the Home Ministry aimed at addressing cybercrimes in a coordinated and comprehensive manner through its National Cybercrime Threat Analytics Unit (NCTAU), an official spokesperson said here.

Most of these websites were involved in fraud job-related schemes. They used reputed social media platforms for their digital advertisements using keywords like 'ghar baithe job' (Do jobs sitting at home) and 'ghar baithe kamai kaise karen' (how to earn while sitting at home) in multiple languages luring victims.

The targets were often retired employees, women and unemployed youths seeking part-time iobs with whom the fraudsters engaged through WhatsApp or Telegram. The websites then convinced the victims to perform tasks such as liking and subscribing to videos or rating maps.

Victims were initially given a commission and then persuaded to invest more for higher returns. Once the victims deposited larger sums of money, those were frozen, resulting in them being deceived, the spokesperson said.



also said that detecting such websites and taking action against those can only happen with public cooperation. To combat cybercrime and protect citizens from threat actors, the Home Ministry urged people to promptly report phone numbers and social media handles used by fraudsters to the National Cybercrime Reporting Portal (NCRP).

The Ministry of Electronics and Information Technology (MeitY) invoked its power under the Information Technology Act, 2000 to block these websites, who facilitated organised illegal investments and parttime job frauds, and they were found to be using digital advertisements, chat messengers and rented accounts.

The proceeds from these economic frauds were being laundered out of India through methods such as card networks, cryptocurrency, overseas ATM withdrawals and international Fintech companies, the

#### 72% INDIANS **DUPED ONLINE**

New Delhi: A whopping 72 per cent of all Indians have fallen prev to various kinds of online scams/frauds in the last two months, according to an esurvey conducted by 'YouGoy', the details of which were released Wednesday. While 20 per cent of those surveyed admitted to losing money in online frauds, 47 per cent said a family member or friend had been gypped. The scams were of a varied nature - fake job rackets. online shopping, investment scams, bank/card phishing frauds, lottery or fake rewards offers, government or social media deceptions, fraudulent loans, dating/romance lures and fake charities, etc.

"Avoid transactions with unknown accounts as they may be involved in money laundering or even terror financing, potentially leading to account blocking by the police and legal action," the spokesperson advised people.

He was walking towards the crematorium when a branch of the tree situated on the premises came crashing down on him and he subsequently died due to the injuries he sustained," the police official stated.

### Odisha tops list in fire-related deaths

Bhubaneswar, Dec 6: Odisha topped the list of states registering the highest number of deaths due to fire-related accidents in India according to the latest report of the National Crime Records Bureau (NCRB). The report on 'Accidental Deaths & Suicides in India' has revealed that 1,219 persons including 906 males and 313 females died in fire accidents in Odisha during 2022. This is a slight decrease in comparison to the number of deaths reported in 2022 (1,248).

Odisha also recorded 1,222 fire mishaps which were highest among Indian states in 2022. As per the report, the country witnessed a total of 7,566 cases of fire accidents during 2022. Odisha accounted for 16.2 per cent of the total fire mishaps that occurred in India.

A total of 446 persons including 403 males and 43 females died in 449 fire mishaps which occurred due to electric short circuit during 2022 in Odisha.

The NCRB report also said that Odisha witnessed the maximum number of accidental deaths due to the forces of nature such as lightning, heat or sun strokes, exposure to cold, drowning, falls, poisoning and accidental fires. A total of 2,445 persons died due to these causes last year.

Odisha with 316 deaths, held the third spot among the states with highest number of deaths due to lightning in 2022. The state also witnessed the second highest snakebite deaths in the country in 2022. A total of 1,052 persons including 932 males and 120 females died due to snake bite in Odisha during 2022.

#### Family cries foul after prisoner dies by suicide

Jajpur, Dec 6: An under-trial ing himself at the Jajpur Road sub-jail in Ragadi under Korei block of Jajpur district, Wednesday. Officials however, failed to ascertain the cause for which the deceased took the drastic step.

The deceased was identified as Balaram Behera, 29, a resident of Mangalpatna village under Panikoili police limits in the district. He died by suicide by hanging himself from the ceiling of an under-construction room inside the prison. Police said that Behera had been in prison for 49 days after being arrested on charges of molesting and assaulting a widow.

This is the second suicide case within the jail premises in the last two years while another's attempted suicide failed. This has raised a question mark on the security of the prisoners lodged inside the sub-jail.

The deceased's brother Dilip Kumar Behera however, alleged foul play. He alleged that Balaram has been tortured and murdered as he protested against the food being provided in the prison and had complained to the magistrate.

## Rahul politically immature: Pranab's biography

BOOK WRITTEN BY FORMER PRESIDENT'S DAUGHTER DWELLS ON THE UNEASY RELATIONSHIP BETWEEN THE GANDHI FAMILY AND MUKHERJEE

New Delhi, Dec 6: Sharmistha Mukheriee, the daughter of late former President and Congress veteran Pranab Mukherjee, said Wednesday that her dad was upset about the way party leader Rahul Gandhi trashed an ordinance that was brought in by the then UPA government in 2013 to save convicted leaders like RJD supremo Lalu Yadav from disqualification.

Sharmistha also goes on to add in the book titled Pranab, My Father: A Daughter Remembers that the former President referred to Rahul as 'politically immature'.

The book has been written on the basis of a diary that the former President maintained. The book quotes Pranab describing Rahul as 'Has Gandhi-Nehru lineage without political acumen'. In the book Pranab has also described Rahul as 'courteous and full of questions but not yet politically mature'.

More importantly however, the book states that Rahul's public tearing of a proposed ordinance on convicted netas in public did not please Pranab at all. He thought that it was the final nail in the UPA coffin.

Sharmistha writes, "He (Pranab) was angry and red-faced. 'Who



does he (Rahul) think he is? He is not a member of the Cabinet. Who is he to publicly trash a decision of the Cabinet? The Prime Minister is abroad. Does he not even realise the implication of his actions and the effect it will have on the PM and government? What right does he have to humiliate the Prime Minister like this'?" Pranab had asked.

In the book Sharmistha has said the former Prez was also unhappy about Rahul's frequent absence from Parliament after the party's dismal performance in the 2014 Lok Sabha polls.

'Baba (Pranab Mukherjee) said he (Rahul Gandhi) should put his thoughts coherently. Rahul said he would meet him, but there was not much interaction between both leaders during the UPA regime from 2004 to 2014,' Sharmistha tells in the book.

In the book, Sharmistha has also recalled an incident where her father took a sarcastic dig at Rahul over his prime ministerial ambitions. "Rahul Gandhi came to see Baba (father) while he was walking in the Mughal Gardens in the morning. He disliked being disturbed while walking or doing puja. But still, he met him. Later, I came to know that Rahul Gandhi was supposed to meet him in the evening," she wrote.

"When I asked Baba about this, he was not amused. He sarcastically said if 'Rahul Gandhi's office cannot differentiate between AM and PM. how can he become the Prime Minister? she states in the book.

focuses more on drama. Several netizens took to Twitter and expressed disappointment at the trailer.





## Michaung: Govt seeks crop damage reports

Bhubaneswar, Dec 6: Though severe cyclonic storm 'Michaung' made a landfall in neighbouring Andhra Pradesh coast, widespread rain due to its impact caused damage to standing crops in southern Odisha forcing the state government to seek damage assessment reports from district Collectors.

The storm has now weakened into a well marked low pressure area. The system is likely to continue to move north-northeastwards and weaken further into a low pressure area, IMD said.

Meanwhile, the IMD has withdrawn the warning on fishermen's entry into the sea and also distance cautionary warnings on ports as the cyclone has fully entered into the land mass.

Under the system's influence. light to moderate rainfall occurred at most places over south Odisha districts and at a few places in north interior part of

Pottangi (Koraput) recorded 11cm rain followed by Similiguda (Koraput) 9cm, Koraput 7cm, Chitrakunda K Guma (Malkangiri) 6cm, Padia (Malkangiri) 5cm, Nandapur (Koraput) 5cm, Lamataput (Koraput) 4cm, Kotpad (Koraput) 4cm, Jeypore (Koraput) 4cm, Korukunda (Malkangiri) 4cm, Borigumma (Koraput) 4cm, and other places.

The Regional Meteorological Centre, Bhubaneswar, said as much as 42mm rainfall was recorded at Gopalpur between 8:30am and 5:30pm of Wednesday followed by 40.3 mm at Chhatrapur, Nuapada (22.2mm), Khurda (22mm) Bhubaneswar (21.4mm)

Though there is no more cyclone threat for Odisha, Michaung's remnants will cause widespread rains in Koraput, Nabarangpur and Nuapada districts where yellow warning has been issued up to 8:30am of Thursday, Met office said.

Reports from Ganjam, Gajapati, Koraput, Malkangiri, Rayagada, Nabarangpur and Kalahandi said normal life was severely hit because of rainfall.

To ameliorate the sufferings of the affected farmers, Agricultural Input Subsidy, as per norms of the State Disaster Response Fund, will be provided to farmers sustaining crop loss of 33% and above," SRC wrote to district

## Satabhaya, Pentha worst hit by coastal erosion Work for betterment

Bhubaneswar, Dec 6: Kendrapara's Satabhaya and Pentha sea beaches have expe rienced the highest level of coastal erosion in Odisha, according to data shared by the Union Environment, Forest and Climate Change Minister (of State) Ashwini Kumar Choubey in Lok Sabha, recently.

With a total erosion of 44,94,576.08 square metre, the Satabhaya beach has lost the most amount of land to sea, while the Pentha beach has lost a total of 36,45,514.06 square metre. Similarly, Aryapalli beach in Ganjam has suffered erosion of 6.76.471.18 square metre and the Golden Beach in Puri lost 3,78,979.57 square metre.

"Some stretches of India's shoreline are subject to varying degrees of erosion due to natural causes or anthropogenic activities. The erosion does impact communities residing in the vulnerable areas, including fishermen," said Choubey in a reply to Sundargarh MP Jual Oram's queries about coastal erosion and the government's response in this regard.

The minister informed that the National Centre for Coastal Research (NCCR) under the Union Ministry of Earth Sciences

has monitored shoreline changes in the country and observed that 33.6 per cent of India's coastline is vulnerable to erosion, while 26.9 per cent is under accretion and 39.6 per cent is in stable condition.

As per the data, out of the 21 beaches monitored by NCCR, while seven beaches have seen erosion over time, 14 have experienced accretion (deposition driven by tides).

Hukitola beach in Kendrapara has seen the highest level of accretion (deposition driven by

The convict, Rabinarayan Behera, formerly worked as a manager at the Kalarahanga unit of the Odisha Mining Corporation (OMC)

The Cuttack district Vigilance court heard the case and pronounced its judgment subsequent to the filing of a case by the Odisha Vigilance Rabinarayan under Sections 13 (2), 13 (1) (e) of the Prevention of Corruption Act, 1988, following the discovery of assets disproportionate to the government servant's known sources of income.

Furthermore, the court also slapped a fine amount of ₹50,000 on Rabinarayan, and in default of payment, he will have to face an additional imprisonment for a period of 6 months, Vigilance sources

Meanwhile, the Vigilance department officials said they will be approaching the competent authority for stoppage of Rabinarayan's pension following his conviction in the corruption case.

"One set of sample question papers prepared in tune with the existing examination pattern of the annual High School Certificate Examination 2024 in all subjects, i.e. Odia, English, Hindi, Sanskrit, Mathematics, Science and Social Sciences have been sent. The sample question papers will facilitate students of Class X to understand the question pattern and will enable them for preparing the ensuing annual HSC examination 2024," Secondary **Education Director Susanta** Kumar Dash told the DEOs.

The DEOs have been asked to share the sample question patterns with all headmasters of



secondary schools in their districts and ensure that the sample papers reach all the students.

The director further instructed the education officials to prepare multiple sets of question papers for the HSC examination 2024 utilising the resource teachers available at the district level and share the same to the directorate

for further dissemination in the form of a digital repository of question bank Class X students and teach-

ers welcomed the decision of the government and said it would help the students to acquaint themselves with the pattern of examination before appearing

The annual High School Certificate, Madhyama, and State Open School Certificate Examinations for 2024 are scheduled to be conducted simultaneously from February 20 to March 4, 2024. However, the timetable of the examination is yet to be announced by the BSE.

## Crops like corn tolerate ozone pollution better than others

ertain crops are less prone to harm caused by groundlevel ozone pollution, according to a study that opens the door to better models for predicting crop responses to the effects of climate change.

The findings, published in the journal Proceedings of the National Academy of Sciences, also pave the way for developing more resilient varieties that can sustain humanity's increasing demand for food, feed, fibre and

A team of scientists at Agricultural Research Service (ARS) and University of Illinois Urbana-Champaign (UIUC), US found that the so-called 'C4' crops like corn and sorghum tolerate increased ozone levels better than 'C3' crops, like rice or snap beans. A crop is designated as C3 or C4 depending on whether the CO2 it captures from the air is initially converted into a 3-carbon or 4-carbon compound, they

The general ability of C4 crops to tolerate increases in groundlevel (or tropospheric) ozone better than C3 crops has long been suspected but not widely tested under actual field conditions, said Lisa Ainsworth, a research molecular biologist at ARS. Together with ARS research



plant physiologist Christopher Montes and a UIUC team led by Shuai Li—Ainsworth conducted

an extensive analysis of both

published and unpublished data. They culled the first dataset from 46 journal papers and the second set from 20 years' worth of open-air experiments conducted in the US, India and

Their analysis focused on the responses of five C3 crops (chickpea, rice, snap bean, soybean and wheat) and four C4 crops (sorghum, corn, giant miscanthus and switchgrass) to both ambient levels of ozone and increased concentrations of the gas, ranging from 40 to 100 parts per billion.

Of particular interest were

changes in the crops' photosynthetic capacity, chlorophyll content and fluorescence (a form of measurement for the pigment), antioxidant leaf activity, biomass material and seed vield

C3 and C4 crops differ in how their leaves capture carbon dioxide from the air as a key com-

ponent of photosynthesis. While both C3 and C4 crops use the enzyme called rubisco to convert carbon dioxide into sugars, C4 crops isolate rubisco in specialised cells where the concentration of carbon dioxide is

very high. This enables higher rates of photosynthesis and greater efficiency of water use. Thus, C4 plants have lower stomatal conductance, resulting in less diffusion of carbon dioxide and ozone into leaves

The team found that exposure to increased ozone levels correlated with reduced chlorophyl content, fluorescence and seed yield in C3 crops more than the C4 group.

But there were differences within the two categories of crops as well, with snap bean, rice, wheat, chickpea, soybean, maize, giant miscanthus. sorghum and switchgrass being ranked the most to least ozone sensitive.

## Menstrual cycle before 13yrs may up diabetes, stroke risk

irls who start their menstrual cycles early at a young age -- before the age of 13 -- could be at an increased risk of developing type 2 diabetes and stroke in midlife. a US research published in the British Medical Journal (BMJ) Nutrition Prevention & Health

has found. Further, having periods early in life, especially before 10 years of age, is also associated with an increased risk of getting a stroke before the age of 65 in those having diabetes, researchers found after analysing data of more than 17,000 women aged between

The researchers from Tulane University and Brigham and Women's Hospital in the US said that being an observational study, they couldn't establish the causes behind these associations.

"Earlier age at [first menstrual cyclel may be one of early life indicators of the cardio metabolic disease trajectory in women,' they suggested in their study.

The women included in the study came from the nationally representative cross-sectional National Health and Nutrition Examination Survey 1999-2018. The women had specified the age at which they had had their first menstrual cycle.

Of the women studied, about 10 per cent, or 1773, reported a diagnosis of type 2 diabetes. Further, 11.5 per cent of these, or 203, reported some type of cardiovascular disease, the researchers found.

They quantified the increased



risk of type 2 diabetes due to beginning to menstruate early in life as 32 per cent (periods at age

10 or before) through 14 per cent (age 11) to 29 per cent (age 12). They also found that men-

struating before turning 10 was linked with a more than doubling in stroke risk among women below the age of 65 with diabetes. Specifically, they calculated the risk to be 81 per cent among those having their first period at the age of 11, 32 per cent at 12, and 15 per cent

"One potential pathway explanation may be that [such] women are exposed to oestrogen for longer periods of time, and early [menstruation] has been associated with higher oestrogen levels," the researchers explained.

They also said weight could be another important factor influencing the results, as when they adjusted the data for weight, the observed associations between

age at first menstrual cycle and stroke complications weakened slightly, albeit remaining significant.

The researchers said that these findings supported the possibility that age of getting the first period may be incorporated into early-life strategies for preventing diabetes and progression of diabetes complications.

"These findings add another dimension to the potentially less well understood determinants of cardio metabolic risk, particularly in women who have been relatively underrepresented in this area of research," said Sumantra Ray, Executive Director of the NNEdPro Global Centre for Nutrition & Health, which co-owns BMJ Nutrition Prevention & Health

Keonjhar, Dec 6: After a brief lull, laying of slurry pipelines for supply of minerals has started in Keonjhar district. The district administration's move to allow the industrial and mining firms again to lay down slurry pipelines has kicked up a row with the project threatening to deprive thousands of truck owners and lakhs of this district's residents of their liveli-

hoods, a report said Wednesday. With large volume of water required to wash iron ores and supply slurry through the pipelines, the project threatens to dry up the river and eventually result in a severe water crisis.

The development has sparked fear and resentment among the truck owners and youths in the mineral-rich district. They apprehend that supply of minerals through slurry pipelines will render them jobless and drive them to penury.

Moreover, use of large volume of water to wash the ores will lead to water shortage in rivers and may even force the water bodies to change their

Mineral extraction is the major source of revenue in Keonjhar district and its economy is highly dependent on the mines. Earlier. the transportation of minerals was mostly done by trucks. This

He alleged that the firms have established beneficiation plants to wash the iron ores and supply those through slurry pipelines. The dirt and waste from iron ores are washed in these beneficiation plants and later supplied through the slurry pipelines, which will also deposit waste in the area, he said.

Pradip Barik, former general secretary of truck owners' as-

The iron ores mined here will help in development of other districts but will lead to impoverishment of Keonjhar residents. The youths will go astray after being deprived of a livelihood,

Ajay Sahoo, working president of Keonjhar Nagarik Manch said the district is witnessing a decline in water level for various reasons. In this situation, supply of large volume of iron ores along with water through the slurry pipelines will result in severe water crisis in the district. It will also adversely impact the state government's piped water supply project, he alleged.

Now, several companies are supplying minerals through slurry pipelines by digging up the ground, Ayaskant Pattnaik, a truck owner alleged. This has become a cause of concern for many youths who eke out a living by buying truck on loans for the job. The truck business will completely collapse if this situation persists, he said.

Former MLAs Pranaballav Nayak, Subarna Nayak, Hrushikesh Nayak expressed concern over the development. They questioned the silence of ruling and opposition parties on the issue and demanded them to protect the interests of residents and the district instead of the industrial and mining firms.

magine a scenario where a private company effectively creates and controls its own jurisdiction within a sovereign country. This company introduces its own currency, enacts laws, and establishes courts, prisons, police forces, and even intelligence services. It formulates its own tax, labour, and environmental regulations (or lack thereof), regardless of their compatibility with national laws.

Now imagine that this company adopts bitcoin as its official currency and announces plans to privatise public services. It replaces the existing judicial system with an "arbitration center" and even introduces a feebased citizenship model that requires signing a "social contract" designed to encourage good behaviour. Eventually, the country's democratically elected government steps in to stop this nonsense and affirms that national laws apply equally to this jurisdiction. But instead of complying, the company sues the government for billions of dollars, citing its projected financial losses.

This scenario, seemingly lifted straight out of a dystopian novel, is precisely what is happening today in Honduras. The Honduran government is currently contending with seven international investor-state dispute settlement (ISDS) claims filed by various private corporations. One US company based in Delaware, Honduras Próspera, is suing the country

for a staggering \$10.7 billion, which represents two-thirds of the government's projected budget for 2023

The story  $\bar{\text{begins}}$  with the 2009 military coup that ousted the democratically elected Honduran President, Manuel Zelaya. Following the coup, the new government quickly enacted a law to establish Special Development Regions with the characteristics described above. In 2012, Honduras Supreme Court struck down the law, owing to its blatant infringement on Honduran sovereignty. In response, the National Congress impeached several of the justices and replaced them with more amenable appointees. This judicial overhaul set the stage for the introduction of the similar Zones for Employment and Economic Development (ZEDE) law in 2013.

There are currently three ZEDEs in Honduras: Próspera, Orquídea, and Ciudad Morazán. These entities operate as independent city-states, inspired by the libertarian fantasies of billionaire investors like Peter Thiel and Marc Andreessen, who have long dreamed of crypto-based tax havens that flout basic democratic norms. Laws permitting unlimited expansion have facilitated the expropriation of land belonging to local residents. In the Próspera ZEDE, 44% of the governing authority's members are directly appointed by the corporate owner, and an additional 22% are elected by landowners whose votes are proportional to the size of their property.

These developments triggered widespread public outrage both within Honduras and around the world. After the leftist Libre party, led by President Xiomara Castro, won the 2021 election, the new administration quickly fulfilled its campaign promise to repeal the ZEDE law, a move that was widely supported by the Honduran public.

But Próspera pushed back, claiming that its agreement with the previous government guaranteed a 50-year period of legal stability, acknowledged the supremacy of investor rights and privileges, and included "safeguards" under international investment law through the Dominican Republic-Central America Free Trade Agreement (CAFTA-DR) and the United States-Honduras bilateral investment treaty. While Próspera continues to operate St. John's Bay, its "flagship city," the company is seeking compensation from the Honduran government for daring to enforce its own national laws.

Governments, especially in low- and middle-income countries, are understandably wary of ISDS mechanisms that allow foreign investors to seek compensation for policy changes that affect their business. Originally, ISDS was meant to prevent the expropriation of private assets through nationalisation. But the definition of expropriation has been expanded to such an extent that it can now include any government action that investors believe could negatively affect their profits, such as new regulations and taxes.

When disputes arise, they are resolved through international arbitration tribunals. There are now several such tribunals, including public ones, such as the World Bank's International Center for the Settlement of Investment Disputes (ICSID) and the United Nations Commission on International Trade Law, and private bodies like the London Court of International Arbitration and the Singapore International Arbitration Center, But these tribunals overwhelmingly favour investors. Arbitrators can force governments to pay huge damages, with no legal recourse to appeal decisions. Moreover, the system is designed to allow corporations to bring claims against states while preventing governments from suing private companies. This apparent bias has prompted some developing countries to withdraw from the ICSID.

The US has played a pivotal (and regrettable) role in establishing this system. In 2020, then-presidential candidate Joe Biden strongly criticized ISDS, writing, "I don't believe that corporations should get special tribunals that are not available to other organizations." Biden went on to say that he opposed "the ability of private corporations to attack labor, health, and environmental policies" through the ISDS process. as well as the "inclusion of such provisions in future trade agreements." Since then, Biden has honoured his promise to exclude ISDS clauses from future trade agreements. But they still apply to existing treaties like the one currently affecting Honduras.

In May, more than 33 members of Congress, led by Senator Elizabeth Warren and Representative Lloyd Doggett, sent a letter to US Trade Representative Katherine Tai and Secretary of State Antony Blinken, urging them to support Honduras in the ISDS case. But the Biden administration has allowed this obscene process to unfold in US courts, even though it contradicts the president's stated position regarding the unjust and undemocratic nature of the ISDS process.

The Honduras ISDS case represents a crucial test for the Biden administration. Allowing such extreme double standards to prevail, particularly in a matter as clear-cut as this, would irreparably damage any remaining US claim to global leadership.

uring celebration of Constitution Day 26th November this year in the Supreme Court, President Droupadi Murmu has advocated the initiation of All India Judicial Service (AIJS) for the selection of district judges from across the country. The President has noted that this process would ensure opportunities to talented candidates from diverse backgrounds throughout the country to enter the judicial service. At present district judges are being appointed by respective High Courts (HCs) through open recruitment-examinations where Advocates of the Bar with the age-group of 35-45 years

and having a minimum of 7years' experience can appear. The recruitment process now is thus confined to candidates of respective states only. Article 233 (1) mentions that a person can be appointed or promoted to the post of district judge in a state by Governor in consultation with the concerned HC. Creation of AIJS is expected to remove this narrowness and broaden the arena for the entire nation, thus attracting the best

talents into the judiciary. The idea for creation of an AIJS is not new. It was first propounded by the Law Commission of India through its 14th Report submitted in 1958. The Swaran Singh Committee in 1976 recommended for the formation of AIJS and later this provision was inserted into Article 312 through the 42nd Amendment in 1976. Article 312 mentions after the said amendment, inter alia, "Parliament may by law provide for the creation of one or more all-India services including an all-India judicial service common to Union and the States, and subject to the other provisions of this Chapter, regulate the recruitment, and conditions of service of persons appointed, to any such service." Clause (3) of this Article mentions, "The all-India judicial service referred to in Clause (1) shall not include any post inferior to that of a dis-

trict judge as defined in Article 236." The Law Commission, in its 116th Report on formation of AIJS, submitted in 1986, has made a meticulous examination of all aspects and has in the best possible manner dispelled all doubts and apprehensions on

As per the Constitutional provision AIJS can be created by passing only a resolution in Rajya Sabha (RS) supported by two-third members present and voting. Article 312, Clause (4) makes it clear that creation of AIJS will not be considered as an amendment to the Constitution as per Article 368. Despite this simple process of introducing AIJS, it has not been created for the last six decades, only because no unanimity on this issue could be reached among state governments and HC as they apprehend it would tell upon independence of judiciary and federal structure.

The present Union government seems to be seriously contemplating for quite some time for creating AIJS. It will empower the UPSC to conduct entrance examinations for the post of district judges.

Most of the states and HC are, however, opposing the idea for creation of AIJS. On a previous occasion, out of 24 HCs, only 2 supported it, 6 wanted amendments and 11 opposed it. The rest 5 did not respond. Similarly out of 29 states, only 2 states supported it, 8 opposed it, 5 expressed reservations on some points, and 14 did not respond. This obstinacy persists despite the fact that the existing entrance and appointment process have miserably failed to address three major problems – filling up the large number of vacant posts in time, bringing merit and talent into the institution, and bringing social jus-

tice and equity into the process. We can understand the seriousness of the issue if we take few examples from Odisha. In 2019 the Orissa HC notified inviting applications from both advocates and judges for 22 posts of district judge (8 for Bar and 14 for judges). 335 lawyers and 17 judges appeared in the written examination. Only 3 lawyers and 1 judge qualified the written test. After interview, only 2 lawyers finally qualified to be district judge, and the only one from the judiciary failed. 20 vacancies still persisted. The predicament was more precarious in the previous year -2018. Entrance examination was held by Orissa HC for 18 DJposts (6 from Bar and 12 from inservice). 270 lawyers and 17 judges appeared in the exami-

nation, but none of them could qualify for the post in the written test. Thus 18 posts of DJ remained vacant in the state unto the next year. The condition in other states is no better. The crisis became more serious after a 3-Judge Bench of SC, after interpreting Article 233 (2), gave the landmark verdict in 2020 that no judicial officer will be eligible for appointment as district judge by way of direct appointment.

The setting up of the AIJS may not be panacea to all ills of judicial recruitment, but it will certainly be far better than the present system on several aspects. National-level recruitment-procedure will certainly attract far better talents to the judiciary than the present system which confines the competition to a particular state. Quality and speed of justice will certainly improve. The competitive-examinations held by UPSC will be certainly more regular, systematic and transparent. The Commission has proved its integrity, credibility and efficiency beyond any doubt in past several decades Contrarily, there have been substantial allegations of nepotism and favoritism against the present system of appointment.

The apprehension that AIJS will curtail the power of the HCs and state governments and that'll tell upon our federal structure, is unfounded as the HCs will never lose the power of appointment of and control over district judges. Also without consent of Governors, i.e. the state government, no such appointments can be made. Another apprehension is that appointment of persons of other states having no knowledge of local language will hamper justice. If the IAS and IPS officers can learn languages other than their mother-tongues, why not IJS judges can? AIJS is long overdue, and has become indispensable. There must be no further delay for its creation.

## Open to advice, not pressure: Kerala Guv



Thiruvananthapuram, Dec 6: Kerala Governor Arif Mohammed Khan Wednesday said he was open to advice from the state government, but not pressure from them.

Khan's statement assumes significance as he has admitted that he succumbed to the pressure from the state government with regard to the re-appointment of Gopinath Ravindran as vice-chancellor (VC) of Kannur University, a decision that has been quashed by the Supreme Court.

The Governor, speaking to reporters here, said he succumbed to the government pressure only because there was a legal opinion from the Advocate General (AG), the highest law officer in the state, in favour of the re-appointment.



"I have said before the whole of the media that what I did was wrong. But, I succumbed to that pressure only because there was a legal opinion from the AG. Otherwise, the political pressure I would have resisted.'

"If I have some confusion about the legality of something, to whom would I go? The AG. He is the highest legal officer in the state," Khan said.

He claimed that while agreeing to the re-appointment he had said that the AG's opinion was illegal and he wrote the same on the file.

Asked, whether he would seek the government's advice with regard to the appointments, Khan said, "I am open to advice from them, but I am not open to pressure from them.

The Supreme Court, while quashing Ravindran's reappointment, had berated the Left government for its unwarranted intervention in the matter.

The apex court had found fault with Khan's order reappointing Ravindran to the post, saying the Governor had earlier abdicated or surrendered the statutory powers for reappointing the VC.

It also said it is the Chancellor who is conferred with competence under law to appoint or reappoint VCs. No other person, even the prochancellor or any superior authority can interfere with the functioning of the statutory authority, it had held.

Following the verdict, Khan had said that state Higher Education Minister R Bindu was not to be blamed as the CM had used her for seeking the reappointment of Ravindran.

He had accused Chief Minister Pinarayi Vijayan of having exerted pressure on him

### K'taka sees 86% increase in crimes against senior citizens in 2020-22

Bangalore, Dec 6: Crimes against senior citizens in Karnataka increased by 86 per cent from 2020 to 2022, latest data released by the National Crime Records Bureau a few days ago showed.

According to the statistics, the number of such cases increased from 853 in 2020 to 1.583 in 2022. The corresponding figure in 2021 was 1,442. Many of the senior citizens were victims of forgery, cheating and theft, the report said.

An analysis of the NCRB 2022 data shows that among 28 states in India, Karnataka recorded the seventh highest number of crimes against senior citizens. Madhya Pradesh was at the top of the list with 6,187 cases followed by Maharashtra with 5,059 and Tamil Nadu with 2,376.

The rate of such cases in Karnataka stood at 27.3 per lakh population while the rate of charge-sheeting in such cases was at 77.8, according to the NCRB data.

Out of the total number of FIRs filed in such cases, the maximum - 367 -- were registered under simple hurt (under IPC sections of voluntarily causing hurt and voluntarily causing hurt by

Six cases related to crimes against senior citizens were transferred to another state or agency last year. It was observed that in 147 FIRs, the cases were true, but there was either in-

#### **CRIMES AGAINST CHILDREN UP 46%. 8K CASES IN 2022**

Karnataka recorded a 46 per cent increase in crimes against children over the last two years, official statistics in the latest NCRB report released a few days ago show. Police registered 7988 cases in 2022 in comparison to 5471 in 2020 and 7261 the next year. Many of these cases were under the Protection of Children from Sexual Offences Act (POCS). the report said. An analysis of the 2022 NCRB data shows that among 28 Indian states. Karnataka recorded the eighth highest number of crimes against children. Maharashtra was first on that list with 20,762 cases followed by Madhya Pradesh (20,415) and Uttar Pradesh (18,682). The rate of cases related to crimes against children in Karnataka stood at 41.3 per lakh population while chargsheeting in such cases was at 58.5, according to the 2022 NCRB data.

### HC no to abort 30-week pregnancy of minor rape survivor

Kochi, Dec 6: The Kerala High Court has rejected a plea for abortion by the mother of a 14year-old rape survivor presently in the 30th week of her pregnancy.

Justice Devan Ramachandran nixed the plea after observing the Medical Board's opinion that an abortion was no longer possible and that, at this stage, the baby would have to be delivered

Apodictically, this is not a case where the victim child's health is a risk on account of the pregnancy: nor are there any lethal foetal abnormalities detected. The pregnancy is almost in its 9th month and the fetus is gaining weight and fat, getting closer to its eventual birth weight. Its vital organs, like the brain and lungs, are almost fully developed, preparing for life outside the womb, the court pointed out.

That said, no doubt, the child

is still very young - just 13 to 14 years in age, and what happened to her is certainly statutory rape, the court clarified.

The judge, however, made it clear that these observations were only made with reference to the present case and must not be construed to favour the accused, who is facing proceedings under the Protection of Children from Sexual Offences Act, 2012 (POCSO Act).

The judge proceeded to reject permission for the victim child's abortion since the pregnancy was at an advanced stage.

This court is saying as afore only for one reason, namely that the pregnancy is now very advanced, with the Medical Board speaking with unanimity that the "uterus corresponded to 30 weeks of gestation with good foetal heart. The fetus has, in fact, life with heart rate; and hence, termination of the pregnancy at this stage is impossible, as also untenable,"

the court added. The court concluded that the provisions of the Medical Termination of Pregnancy Act cannot be invoked in this case to abort the pregnancy. However, the Court assured the petitioner that her daughter will receive legal protection.

With these observations, the court closed the petition after directing the Child Protection Officer to provide regular support to the petitioner and her family.

Bangalore, Dec 6: Karnataka Chief Minister Siddaramaiah Wednesday announced a memorial for the 63-year-old elephant 'Arjuna', the centrepiece jumbo of the famous Mysuru Dasara procession, which died during an operation in a forest to capture a wild tusker, December 1.

Arjuna carried the golden 'howdah' of Goddess Chamundeshwari during the historical Mysuru Dasara celebrations.

Speaking to reporters, CM Siddaramaiah stated that the memorial will be built by the government and will come up at the site in the forest and also at HD Kote town in Mysuru district.

"I have sought all information in connection with the death of the Arjuna elephant. We have asked to build a memorial in the forest in Sakleshpur, where it died and we have also given directions to build a memorial in HD Kote", CM reiterated.

Arjuna had carried the Golden Howdah during Dasara for eight times. He died accidently. The elephant should have lived for a longer time. It died as the elephant was used in wild elephant capture operation, CM Siddaramaiah

Mahut Vinu, who looked



after Arjuna, recounted that, during the operation Arjuna got hurt in the leg and started bleeding. In spite of this, he fought with a wild elephant. After that his leg was hit by a bullet in a misfire. Arjuna would have fought and won single-handedly. But, he could not win due to in-

jury in the leg. The wild ele-

phant killed it. Arjuna had saved the lives of 10 persons and gave away his life, he said.

Minister Chief Siddaramaiah expressing sorrow earlier stated that Arjuna had participated in the Jamboo Savari eight times, becoming a beloved figure, and calmly carried the 750-kilogram golden

sion. Arjuna lost his life in a fight with a wild tusker. CM Siddaramaiah remembered Arjuna's sig-

nificant service to Goddess Chamundeshwari and the lasting image of his majestic walk amid lakhs of people during the procession. Former CM Basavaraja

Bommai had also expressed condolences, stating that Gajaraja Arjuna who carried the Golden Howdah eight times during Dasara, lost his life in an operation to capture a wild elephant. Bommai prayed for the soul of Arjuna to rest in peace.

Arjuna died Monday after being fatally injured by a wild elephant in Sakaleshpur of Hassan district. Arjuna was brought to Hassan for an operation to capture the disruptive wild elephant in Yeslur. During the operation, sharpshooters

The government said power was kept suspended in some areas as a "preventive measure" as the cables were under water, while asserting all efforts were being taken to restore normalcy.

The cyclone-triggered heavy rainfall had led to inundation in localities including Velachery

### Rajnath Singh to visit TN today

New Delhi: Defence Minister Rajnath Singh will visit Tamil Nadu Thursday to assess the flood situation in the state and hold a meeting with Chief Minister M K Stalin, sources said, Singh, who will travel to Tamil Nadu as a representative of the central government, will conduct an aeria survey of the flood-hit areas. The defence minister will visit Tamil Nadu to see the damage caused by the recent floods besides holding a meeting with the chief minister, the sources said Officials from the Union Home Ministry will accompany the defence minister during his trip

and Tambaram. On Wednesday too, people were seen leaving their homes in the areas surrounded with water to safer zones, carrying their children and wading through the stagnant water. They called for help, including pressing more boats to

ferry people to higher ground. Chief Minister MK Stalin visited some of the affected areas and distributed food and essential commodities to people put up at a relief centre in the city. He inspected activities undertaken by the city civic body to drain water. He also wrote to the Centre seeking an interim flood relief of Rs 5,060 crore to tide over the

Many users on social media site 'X' shared videos of residential localities still being surrounded by stagnant water, claiming many residents were stuck inside. The hashtag #Velachery was trending on the microblogging site. Power supply had not resumed in parts of the city including Kilpauk Kattupakkam.

There were no disruptions in operations at the airport while the Southern Railway announced cancelling a number of services and diversion of many others.

However, it announced resumption of the suburban services on the Chennai Egmore-Chengalpet and Chennai Beach-Arakkonam routes with frequency of 30 and 45 minutes, respectively. Services on the Tiruvottiyur-Sullurpeta line will be operated in a hourly frequency, it said in an update.

State Chief Secretary Shiv Das Meena told reporters that water was draining in many parts of the city. Over 200 boats have been pressed into service in different areas.

Food packets were also being airdropped in certain areas in north and south Chennai, he added. While the usual daily supply of milk to Chennai and its surrounding areas was 19 lakh litres, a supply of 14 lakh litres was ensured on Wednesday. Of this, staterun Aaavin contributed 10 lakh litres. The usual quantum of supply was will be restored from Thursday onwards, Meena said.

#### **BJP MPs, including Union Ministers, elected** to Assemblies quit Parl

New Delhi, Dec 6: Union ministers Narendra Singh Tomar and Prahlad Singh Patel resigned from Lok Sabha on Wednesday as the BJP decided that all of its 12 MPs recently elected to state assemblies will quit Parliament, amid strong indications that they may join the new governments in Madhya Pardesh, Chhattisgarh and Rajasthan.

The move has given rise to the view that the party leadership may bring in new faces at the helm in all the three states. Senior leaders, however, declined to comment on such a development. BJP president JP Nadda accompanied 10 of them as they tendered their resignations from Parliament. Two others, Union minister Renuka Singh and Mahant Balaknath, will also be quitting, party leaders said.

Other MPs who quit are Rakesh Singh, Udya Pratap Singh and Riti Pathak from Madhya Pradesh; Kirodi Lal Meena, Diya Kumari and Rajyavardhan Singh Rathore from Rajasthan and Gomati Sai and Arun Sao from Chhattisgarh, All except Meena are Lok Sabha members. Meena is a Rajya Sabha member.

Patel said the 10 MPs took Prime Minister Narendra Modi's blessings before tendering their resignations. All three Union ministers will also be quitting the Modi government as a procedural formality.

Tomar is a Cabinet minister handling the crucial agriculture portfolio, and their departure have sparked a fresh buzz within the party on whether Modi will induct new members in his council of ministers ahead of the 2024 Lok Sabha elections



### LS passes J&K Reorganisation, Reservation (Amendment) Bills

New Delhi, Dec 6: The Lok Sabha Wednesday passed the Jammu and Kashmir Reorganisation (Amendment) Bill, which seeks to nominate two members from the Kashmiri migrant community and one representing the displaced persons from Pakistan-occupied Kashmir (PoK) to the legislative Assembly.

The House also passed the Jammu and Kashmir Reservation (Amendment) Bill, which seeks to change the nomenclature of a section of people who are eligible for quota in appointment and ad-

The Bills were passed after more than six hours of debate spanning over two days and a spirited reply by Union Home Minister Amit Shah. The Home Minister said the two bills re-



lated to Jammu and Kashmir brought by the government will give justice to those deprived of their rights for the last 70 years and asserted that reservation to the displaced people will give them a voice in the legislature.

He said that Jammu and Kashmir has suffered due to two blunders committed by the country's first Prime Minister Jawaharlal Nehru - first announcing ceasefire and then taking the Kashmir issue to the United Nations. "Had Jawaharlal

Nehru taken right steps, PoK would have been part of India now. It was a historic blunder," he

The Home Minister said a plan to have zero terror incident in Jammu and Kashmir has been in force for the last three years and it will be successful by 2026 when

there will be no violence. Meanwhile, Union Home Minister Amit Shah Wednesday blamed India's first Prime Minister Jawaharlal Nehru's "two major blunders" -- declaring a ceasefire without winning the entire Kashmir and taking the issue to the United Nations -- for the sufferings of the people of Jammu and Kashmir. In his speech, Shah said if Nehru had taken the right steps, a large chunk of territory would not have been ceded and Pakistan-occupied Kashmir would have been part of India.

New Delhi: More than 1,500 cases were registered under IPC section 153A that penalises promoting enmity between different groups, including offences of hate speech, across India in 2022, a 31,25 per cent



increase from 2021 but a 15.57 per cent decline from 2020, according to the NCRB. Last year, the maximum of these 1,523 cases were lodged in Uttar Pradesh (217) followed by Rajasthan (191), Maharashtra (178) Tamil Nadu (146), Telangana (119), Andhra Pradesh (109), and Madhya Pradesh (108), the data showed.





#### **Partygate: Ex-UK** PM apologises

London: Former British Prime Minister Boris Johnson defended his handling of Covid-19 Wednesday at a public inquiry into the pandemic, saying the government "got some things wrong" but did its best. Johnson began two days of being grilled under oath by lawyers for the judge-led inquiry about his initial reluctance to impose a national lockdown in early 2020 and other fateful decisions. Johnson opened his testimony with an apology "for the pain and the loss and the suffering of the Covid victims," though not for any of his own actions. Four people stood up in court as he spoke, holding signs saying: "The Dead can't hear your apologies," before being escorted out by security staff. Another sign said: "Johnson partied while people died."

#### Khan's appeal junked by court

Islamabad: A Pakistani high court Wednesday rejected jailed former prime minister Imran Khan's plea seeking the withdrawal of his appeal against his disqualification in the Toshakhana corruption case. Khan, 71, has been in jail since August 5, when he was arrested after a conviction in the Toshakhana case. He was disqualified by the Election Commission of Pakistan (ECP) in the case for failing to disclose the proceeds from the sale of gifts he got from the Toshakhana (state repository).

## CLIMATE 2023 to smash all heat records

#### MONTH TO SET HEAT RECORD THIS YEAR **NOVEMBER BECOMES 6TH STRAIGHT**

Dubai, Dec 6: For the sixth month in a row, Earth set a new monthly record for heat, and also added the hottest autumn to the litany of record-breaking heat this year, the European climate agency calculated

And with only one month left, 2023 is on the way to smashing the record for hottest year.

November was nearly a third of a degree Celsius (0.57 degrees Fahrenheit) hotter than the previous hottest November, the European Space Agency's Copernicus Climate Change Service announced early Wednesday.

November was 1.75 degrees Celsius (3.15 degrees Fahrenheit) warmer than pre-industrial times, tying October and behind September, for the hottest above average for any month, the scientists said.

The last half year has truly been shocking," said Copernicus Deputy Director Samantha Burgess. "Scientists are running out of adjectives to describe

November averaged 14.22 degrees Celsius (57.6 degrees Fahrenheit), which is 0.85 degrees Celsius (1.5 degrees Fahrenheit) warmer than the average the last 30 years. Two days during the month were 2 degrees Celsius (3.6 degrees Fahrenheit) warmer than pre-industrial times, something that hadn't happened before, according to Burgess

So far this year is 1.46 degrees Celsius (2.6 degrees Fahrenheit) warmer than pre-industrial times, about a seventh of a degree warmer than the previous

warmest year of 2016, Copernicus scientists calculated. That's very close to the international threshold the world set for climate

change. The 2015 Paris climate agreement set a goal of limiting global warming to 1.5 degrees (2.7 degrees Fahrenheit) above pre-industrial times over the long term and failing that at least 2 de

#### Putin talks oil, Gaza, Ukraine on ME visit

Moscow, Dec 6: Russian President Vladimir Putin will meet Crown Prince Mohammed bin Salman in Saudi Arabia Wednesday, during a rare trip abroad, to discuss oil production, OPEC+ and the wars in the Gaza Strip and Ukraine.

Putin's meeting with the prince, known as MbS, comes after oil prices fell despite a pledge by OPEC+, which groups the Organization of the Petroleum Exporting Countries and allies led by Russia, to further cut output.


Putin arrived in Abu Dhabi for talks with President Sheikh Mohammed Bin Zayed Al Nahyan who called Putin his "dear friend". He is due to then travel to Saudi Arabia for his first face-to-face meeting with MbS since October 2019.

The Kremlin said they would discuss energy cooperation, including as part of OPEC+, whose members pump more than 40% of the world's oil.

"Our relations, largely due to your position, have reached an unprecedentedly high level,' Putin told Sheikh Mohammed, known as MbZ, at the presidential palace. "The UAE is Russia's main trading partner in the Arab

Putin said Russia and the UAE cooperated as part of OPEC+, adding that they would talk about the Israeli-Hamas conflict and the situation in Ukraine.

The Kremlin chief's last visit to the region was in July 2022, when he met Supreme Leader Ayatollah Ali Khamenei in Iran.



It was not immediately clear what Putin, who has rarely left Russia since the start of the Ukraine war, specifically intends to raise about oil markets with the crown prince of Saudi Arabia, the world's largest crude exporter, just days after disagreements delayed a key OPEC+

meeting. As well as oil, they will talk about the war between Israel and Hamas militants, the situation in Syria and Yemen, and broader issues such as ensuring stability in the Gulf, the Kremlin said. A Kremlin aide said Ukraine would also be dis-

### Italy pulls out of China's Belt and Road Initiative

**OVER 100 COUNTRIES HAVE SIGNED PACTS WITH CHINA TO COOPERATE ON BRI INFRA AND PROJECTS SINCE THE SCHEME WAS LAUNCHED IN 2013**

Rome, Dec 6: Italy has officially informed China that it is quitting the Belt and Road Initiative (BRI), dismissing fears the move might sour relations and damage the Italian economy, government sources said Wednesday.

Italy in 2019 became the first and so far only major Western nation to join the trade and investment programme, ignoring warnings from the United States that it might let China take control of sensitive technologies and vital infrastructure.

However, when Prime Minister Giorgia Meloni took office last year, she said she wanted to withdraw from the deal, which was championed by President Xi Jinping, saying it had brought no significant gains to Italy.

The 2019 accord expires in March 2024 and an Italian government source said Rome had sent Beijing a letter "in recent days" informing China that it would not be renewing the pact.

"We have every intention of maintaining excellent relations with China even if we are no longer part of the Belt and Road Initiative," a second government source said.

"Other G7 nations have closer relations with China than we do, despite the fact they were

More than 100 countries have signed agreements with China to cooperate on BRI infrastructure and building projects since the scheme was launched in 2013. The then Italian Prime Minister Giuseppe Conte hoped for a trade bonanza when he signed up in 2019, but Chinese firms seemed to be the main beneficiaries.

Italian exports to China totalled 16.4 billion euros (\$17.7 billion) last year from 13 billion euros in 2019. By contrast, Chinese exports to Italy rose to 57.5 billion from 31.7 billion over the same period, according to Italian data.

Italy's main euro zone trading partners France and Germany exported significantly more to China last year, despite not being part of the BRI, which is modelled on the old Silk Road that linked China to the West.

Meloni, who heads a conservative coalition, has been keen to burnish her credentials as a committed pro-NATO leader and a government source said that she had assured US President Joe Biden earlier this year that Italy would quit the BRI.

# **US aid killing Gazans**

Despite Gaza death toll soaring, US unlikely to rethink weapons supplies to Israel

Washington, Dec 6: Facing a soaring death toll from Israel's renewed offensive in southern Gaza, the Biden administration is trying to pressure its ally to minimize civilian deaths while stopping well short of the kind of measures that might force it to listen, such as threatening to restrict military aid.

Top US officials, including Vice President Kamala Harris and Secretary of State Antony Blinken, have urged Israel publicly to conduct a more surgical offensive in the south to avoid the heavy civilian casualties inflicted by its attacks in the north.

About 900 people in Gaza were killed in Israeli airstrikes between Friday when a truce ended and Monday, according to Gaza's Health Ministry, about the same number killed in strikes in Gaza over the four days following the Hamas cross-border raid on Israel October 7, though fewer than the 1,199 who died in the four days following the start of Israel's ground offensive on northern Gaza Oct 28.

Washington is for now ruling out withholding delivery of weapons or harshly criticizing Israel as a means of changing its tactics because the US believes the existing strategy of privately negotiating is effective, according to two US officials.

"We think what we're doing is moving them" a senior US official said, citing how Israeli Prime Minister Benjamin Netanyahu shifted from refusing to allow aid into Gaza to allowing nearly 200 trucks of assistance a day, saying those improvements were the result of intense diplomacy, not threats.

But the US official said re-

ducing military support to Israel would carry major risks.

"You start lessening aid to Israel, you start encouraging other parties to come into the conflict, you weaken the deterrence effect and you encourage Israel's other enemies," the official said.

The United States has called its support unwavering. The Israeli government appears unmoved by international demands to change its strategy.

"I must admit I sense that the prime minister feels zero pressure, and that we will do whatever it takes to achieve our military goals." Netanyahu's foreign policy adviser Ophir Falk told Reuters last week when asked about the international pressure on Israel.

#### **SIGNIFICANT US LEVERAGE**

The United States gives Israel \$3.8 billion in military aid annually, ranging from fighter jets to powerful bombs that could destroy Hamas tunnels, and the Biden administration has asked Congress to approve an additional \$14 billion.

Such support Washington "significant leverage" over how the war against Hamas is conducted, said Seth Binder, director of advocacy at The Project on Middle East 'Withholding certain types of

equipment or delaying refilling stockpiles of various arms would force the Israeli government to adjust strategies and tactics because they would not be guaranteed to have more in the pipeline," said Binder. "To date, the administration has demonstrated an unwillingness to use that leverage.

Weighing on Biden is the 2024 presidential election, even as senior aides have stepped up calls for Israeli restraint. Any attempt to cut aid could hurt the Democratic president with pro-Israel independent voters as he seeks re-election. Biden also faces pressure from

be conferred the award since Ho Minfong in 1997. Chand is an award-winning novelist known for her depiction of multicultural societies. Her 'The Painted Cage' (1986) was longlisted for the prestigious Booker Prize, the report said.



### Sikh separatist murder bid: US waits on India probe

Washington: The United States has said it will wait to see the results of the investigation announced by India concerning allegations of the involvement of an Indian official in a plot to assassinate a separatist Sikh leader in the US. "We have noted at the most senior levels of this government - the secretary of state has raised this directly with his foreign counterpart that we take this issue very seriously. They told us they would conduct an investigation." State Department spokesperson Matthew Miller told reporters at his daily news conference Tuesday. "They have publicly announced an investigation. Now, we will wait to see the results of the investigation...," Miller said in response to a question. American prosecutors have linked an Indian official to a man charged with conspiring to assassinate Sikh separatist Gurpatwant Singh Pannun on US soil.

He told state TV that Iran plans to send astronauts into space by 2029 after further tests involving animals State TV showed footage of a

rocket named Salman carrying the capsule. Iran occasionally announces

successful launches of satellites





and other spacecrafts. In September. Iran said it sent a data-collecting satellite into space. In 2013, Iran said it sent a monkey into space and returned it successfully.

Reports said the country's Defense Ministry built and launched the Salman rocket while the capsule was built by the Iranian civil space agency. Media reports did not say where the launch took place. Iran usually makes launches from Imam Khomenei Space Centre in northern Semnan province.

It says its satellite program is for scientific research and other civilian applications. The US and other Western countries have long been suspicious of the program because the same technology can be used to develop long-range missiles.

In 2020, Iran's Revolutionary Guard said it put the Islamic Republic's first military satellite into orbit, unveiling what experts described as a secret space programme.

### I won't be dictator again, says Trump



# EVs accelerating end of the oil age

**GLOBAL EV SALES NOW MAKE UP ABOUT 13% OF ALL VEHICLE SALES AND ARE LIKELY TO RISE** TO BETWEEN 40%-45% OF THE MARKET BY THE END OF THE DECADE, ACCORDING TO THE IEA

Dubai, Dec 6: There is plenty of hand-wringing on display at the COP28 climate conference in Dubai about the slow pace of reducing the consumption of fossil fuels to fight climate change. But one positive that delegates can point to is the growing fleet of electric vehicles (EVs) worldwide that is already making a surprisingly big dent in demand.

Growing sales of EVs in recent years have led forecasters to speed their projections for when global oil use will peak, as public subsidies and improved technology help consumers overcome the sometimes eye-popping sticker prices for battery-powered cars, according to industry experts.

The Paris-based International Energy Agency (IEA), a grouping of 29 industrialised nations. expects world oil consumption to hit its zenith at the end of this decade at 103 million barrels per day, after making regular adjustments from its 2017 forecast of a nearly 105 million bpd peak in 2040.

The game-changer has been the policy support for the shift to electrification quite substantially reducing oil demand from transportation sector, which has been the key driver of global oil demand growth," said Apostolos Petropoulos, an energy modeler at the IEA.

Oil giant BP has pushed forward its global peak oil demand projections, while the governments of both the United States and China - the world's two biggest oil users - have ratcheted back their domestic consumption forecasts.



Transportation is responsible for about 60% of world oil demand, with the United States alone accounting for around 10%, according to the IEA. That share should fall, as the IEA expects EVs will have erased some 5 million barrels per day of world oil demand by 2030.

Global EV sales now make up about 13% of all vehicle sales and are likely to rise to between 40%-45% of the market by the end of the decade, according to the IEA. That is thanks to a blend of increasingly stringent efficiency standards and subsidies introduced by various governments about the world since the 2015 Paris Agreement to hold global warming to within 1.5 degrees Celsius above pre-industrial

The latest subsidy measures include the US Inflation Reduction Act's \$7,500 tax credit for purchasing a new EV, passed last year and intended to help offset high sticker prices.

While those numbers are big, the IEA has said EV sales would need to be even higher - on the order of 70% of the market by 2030 - to keep to the Paris Agreement target for limiting warming. Whether sales can scale those heights is uncertain.

EV makers including General Motors, Ford and Stellantis in recent weeks have delayed or scrapped plans to accelerate production amid rising labour costs and signs that higher interest rates are slowing growth in the

In the longer term, though,

falling costs for EV batteries have some researchers feeling op-

The rate of future EV adoption is going to depend heavily on EV pricing and the availability of charging stations, according to industry experts. China has the advantage on both counts.

The average EV in China cost 31,165 euros (\$33,964) in mid-2023, according to UK research firm JATO Dynamics. The cheapest EV in China was 8% less expensive than the cheapest gasoline-powered equivalent car, JATO found. That is thanks to massive government subsidies and easy availability of rare earths that are crucial in EV production.

EVs have about a quarter of the market in China, and the country is expected to lead global growth.

In the United States, by contrast, the average price for an EV is more than \$53,000, according to automotive research company Kelley Blue Book, around \$5,000 more than a gasoline-powered car.

The United States also lags well behind China in total number of public charging stations. An industry-funded white paper released in October by the Electrification Institute noted that the United States has about 52,000 public charging stations, Europe about 400,000 and China about 1.2 million.

Even so, EVs are expected to grow to up to 50% of new U.S. car registrations by 2030, according to the IEA, as drivers are drawn to the improving technology, falling prices and the prospect of sidestepping volatile prices at

Sustainable aviation fuel output

Auto retail sales soar to record high

New Delhi, Dec 6: Automobile retail sales in India rose to a record high in November, aided by the best ever monthly performance across passenger vehicle and two-wheeler segments, dealers' body FADA said Wednesday.

The overall retail sales stood at 28,54,242 units last month, 18 per cent higher over 24,09,535 units in November 2022.

Passenger vehicle (PV) retail sales rose to 3.60.431 units as compared to 3.07.550 units in the year-ago period, registering a growth of 17 per cent.

Similarly, two-wheeler registrations rose by 21 per cent last month to 22.47.366 units from 18,56,108 units in November last year.

"November '23 has become a historic month for the Indian auto retail industry as 28.54 lakh vehicles were sold, thus overtaking the previous high of March '20 when the industry sold 25.69 lakh vehicles, Federation of Automobile Dealers Associations (FADA) President Manish Raj Singhania said in a statement.

Two-wheeler and passenger vehicle segments created new records last month, he added. The two-wheeler segment

saw sales of 22.47 lakh vehi-

cles, an increase of 1.77 lakh vehicles compared to the previous high of March 2020, while the passenger vehicle category also sold 3.6 lakh units, over 4.000 units more when compared to the previous high of October 2022, Singhania said.

He noted that PV sales last month were fuelled by Deepawali and the launch of new and appealing models. The improved supply chains,

coupled with new launches, effectively catered to the festive demand, marking the peak point in sales, Singhania said. However, the period follow-

ing the festivities saw a noticeable slowdown, coupled with a critical challenge of slow-moving inventory due to a mismatch in demand and supply, which is still not resolved, he added. "This issue casts a shadow

over the otherwise positive trends, highlighting the need for strategic adjustments in inventory management,' Singhania said. Two-wheeler sales were aided

by enhanced demand in rural areas, new product launches, and better model supply, he added. Three-wheeler retail sales

rose to 99,890 units last month, registering a growth of 23 per cent from November 2022

### 'RBI UNLIKELY TO CUT **RATES BEFORE JUNE'**

Mumbai. Dec 6: The Reserve Bank-led Monetary Policy Committee (MPC) is unlikely to tweak repo rates till June next year, according to a foreign brokerage report. The bi-monthly MPC meeting

started Wednesday and the decision on rates will be announced Friday. According to the report by Deutsche Bank, the interest rate cycle appears to have peaked and the Reserve Bank of India (RBI) is unlikely to go for further hikes, unless absolutely necessary. The rate is likely to be cut in June, it said. The RBI hiked the repo rate

last February 23, when it was raised to 6.5 per cent.

With the RBI continuing to maintain tight liquidity, shortterm rates are hovering around 6.85-6.9 per cent, which is 35-40 bps higher than the repo rate.

We see the central bank cutting the policy repo rate by 75 bps in 2024 and another 25 bps in early 2025. Earlier, we were expecting a 100 bps of reporate cut in 2024 itself, starting from April 2024, but given that the Fed is likely to start cutting rates from June 2024, we have pushed back the start of the rate cut cycle to June 2024," the analysts said.

We now expect 25 bps rate



cuts in each of the quarters beginning from Q2 of 2024 totalling 100bps of easing in FY25, which will likely bring down the repo rate to 5.50 per cent by early 2025," they said.

However, the analysts said the RBI's final decision will depend on the Fed's move on rates. If Fed goes for a rate hike in early 2024, or does not go for a rate cut in the whole of next year, it could delay the RBI's rate cut cycle. The report said India's economy will double in size to USD 7 trillion by the end of the decade with per capita income also nearly doubling to USD 4,500

And even before the end of this decade, India is likely to become the third largest economy after the US and China, overtaking Japan and Germany, the analysts said. However, Deutsche Bank cut their forecast for the next two years, citing the current tight interest regime.

### to rise to 1.9bn litres in 2024 PRESS TRUST OF INDIA

Geneva, Dec 6: The production of sustainable aviation fuel will double to more than 600 million litres this year and rise further to 1.875 billion litres in 2024, according to the global airlines' grouping IATA.

As the global aviation industry works on decarbonisation ways, sustainable aviation fuel (SAF) will play a major role.

At a recent conference hosted by the International Civil Aviation Organization (ICAO), stakeholders agreed to a global framework to promote SAF production in all geographies for fuels used in international aviation to be 5 per cent less carbonintensive by 2030. Around 17.5 billion litres of SAF need to be

produced to reach that level. Wednesday, the International Air Transport Association (IATA) said that in 2023, SAF volumes will reach over 600 million litres (0.5 million tonnes), which is double the amount of 300 million litres (0.25 million tonnes) produced in 2022.

While making a presentation on SAF here, IATA's Director for Net Zero Transaction Hemant Mistry said that globally, 43 airlines have voluntary commit-



ments and agreements related to SAF, which corresponds to around 13 million tonnes of fuel use by 2030.

Global SAF accounting framework and regional feedstock value chains, among other factors, will help in ramping up production of SAF, he noted.

Around 85 per cent of SAF facilities coming online over the next five years will use Hydrotreatment (HEFA) production technology, which relies on inedible animal fats (tallow), used cooking oil and industrial grease as feedstock.

"In 2024, SAF production is expected to triple to 1.875 billion litres (1.5 million tonnes), accounting for 0.53 per cent of aviation's fuel need, and 6 per cent of renewable fuel capacity.

"The small percentage of SAF output as a proportion of overall renewable fuel is primarily due to the new capacity coming online in 2023 being allocated to other renewable fuels,'

IATA said.

IATA Director General Willie Walsh said that even though SAF production was encouraging, the fuel as a portion of all renewable fuel production will only grow from 3 per cent this

year to 6 per cent in 2024. "This allocation limits SAF supply and keeps prices high. Aviation needs between 25 per cent and 30 per cent of renewable fuel production capacity for SAF. At those levels, aviation will be on the trajectory needed to reach net zero carbon emissions by 2050," he added.

# Meals got costlier in Nov amid soaring prices: Report

The rise in onion and tomato prices was prompted by festive demand and lower output in the Kharif season due to erratic rainfall conditions

Mumbai, Dec 6: There has been a month-on-month rise in cost of a typical veg as well as non-veg thali or a meal in November largely due to soaring onion and tomato prices, a domestic rating agency said in a report Wednesday.

The uptick was attributable to a substantial 58 per cent and 35 per cent on-month increase in onion and tomato prices, respectively, Crisil MI&A Research said in its report.

The rise in onion and tomato prices was prompted by festive



demand and lower output in the Kharif season due to erratic

rainfall conditions. In November, the cost of rep-

resentative home-cooked veg and non-veg thalis increased 10 per cent and 5 per cent on a month-on-month basis, respectively, the report said.

On a month-on-month basis, the cost of the non-veg thali increased at a slower pace than that of the veg thali because of a marginal 1-3 per cent decline in prices of broilers, which account for 50 per cent of the nonveg thali cost, it stated.

The cost of the veg thali rose 9 per year-on-year, driven by a 93 per cent and 15per cent increase in onion and tomato prices, respectively.


Prices of pulses, which account for 9 per cent of the veg thali cost, also increased 21 per cent year-on-year, the report added. The average cost of prepar-

ing a thali at home is calculated based on input prices prevailing in North, South, East and West India.

The monthly change reflects the impact on the common man's expenditure. The data also reveals the ingredients (cereals, pulses, broilers, vegetables, spices, edible oil and cooking gas) driving the change in the cost of the thali.

hockey World Cup here Thursday. Vice-captain Araijeet Singh Hundal came out to be India's saviour, scoring a hat-trick as India overcame some anxious moments to beat Korea 4-2 in their opener Tuesday.

But India's coach CR Kumar was not too satisfied with the performance and said his side needs to be more clinical and avoid conceding unnecessary

penalty corners. India conceded six penalty corners, while earned just two against Korea.

'We are very happy that we got the three points and that's the positive side. But we have to more clinical in both circles. We conceded two goals in penalty corners which we need to pay attention to," Kumar said after the Korea match.

"We gave away too many penalty corners, six in the whole game where we had just two. We need to be more cautious."

Skipper Uttam Singh and his deputy Hundal are the only two players who have experience of the big event, having featured in the last edition of the tournament, where India finished fourth in Bhubaneswar, losing to France in the bronze medal playoff match.

The Spaniards, who have a bronze medal in their kitty at the 2005 edition in Rotterdam, are India's toughest opponent in the pool, comprising Canada as the other side. But going by form, India will start as favourites against Spain Thursday.

India's last pool match is gainst Canada Saturday

Pool A consists of defending champions Argentina, Australia, Chile, and Malaysia, while Pool B has Egypt, France, Germany and South Africa. Pool D is the toughest of the lot as Belgium, Netherlands, New Zealand and Pakistan will be vying for a quarterfinal berth. The top two teams from each pool will qualify for the quarterfinals.

The Indians played an attacking game from the onset Tuesday and would look to continue in the same vein but their defence will have to be cautious against counter-attacks which the Koreans used to great effect to earn penalty corners.

Spain too would be looking to exploit that weakness against the Indians.

### Will play IPL until I can't walk anymore: Maxwell

Melbourne, Dec 6: Star Australia all-rounder Glenn Maxwell has vowed to play in the world's biggest cricket the IPL "until he can't walk anymore"

The 35-year-old, who played a massive role in Australia's ODI World Cup-winning campaign in India recently, will once again don the colours of Royal Challengers Bangalore in the IPL next vear.

"The IPL will probably be the last tournament I ever play, as I will play the IPL until I can't walk anymore," Maxwell was quoted as saying by Australian Associated Press (AAP) at the

Melbourne Airport Wednesday. "I was talking about how good the IPL has been to me throughout my career, the people I've met, the coaches I have played under, the international players that you get to rub shoulders with, how beneficial to my whole career that tournament has been," he said.

Maxwell feels Australian cricketers should play in the IPL for experience ahead of the T20 World Cup in the United States and the West Indies in June.

"Hopefully, a lot of our Australian players can get over to the IPL and get to work in slightly similar conditions to the West Indies, where it is a little bit drier, it will spin.'

Maxwell will return to action as captain of Melbourne Stars in the Big Bash League opener against Brisbane Heat in the opener at the Gabba Thursday.

Vancouver, Dec 6: Christine Sinclair, the world's top international goal scorer among both women and men, played her final match with the Canadian national team.

Sinclair, 40, ended her 23-year national team career with a 1-0 victory against Australia Tuesday at Vancouver's BC Place renamed Christine Sinclair Place for the occasion.

Sinclair has scored 190 goals since she made her national team debut in 2000. Portugal's Cristiano Ronaldo, the game's top scorer among men, has 128 international goals.

It was Sinclair's 331st appearance for Canada, second

only in international soccer to retired US star Kristine Lilly, who played in 354 games.

"To see the growth of the game, see where it's at now, and the opportunities that are available, whether it's in the national team or playing pro. Honestly I never thought in my career that this was going to happen. And I just feel fortunate to be a part of that growth and it's incredible to experience the change," she said before the match. More than 45,000 fans were

on hand for the game. In addition


Sinclair is also among just five players to appear in six Women's
