BJD MLA Satyanarayan Pradhan, however, rejected BJP's allegation and claimed that CM Naveen Patnaik hates corruption and believes in transparency. "People found guilty will certainly be punished as our CM always says law will take its own course," Pradhan said.

In a statement, the BJD welcomed the I-T raids and said, "Jharkhand BJP leaders are saying the seized money belongs to Congress leaders. On the other hand, Congress leaders are say-

ing it belongs to BJP leaders. Both are blaming each other. It seems like both BJP and Congress leaders had stashed their money with this businessman." "We welcome the raids conducted by the I-T department. It seems some BJP leaders of western Odisha are connected with the recovered money and the businessman. Therefore, they panicked and held a press meet. All the facts will come out after investigation," the BJD said.

Continuing its raids, the I-T department Friday found 156 bags of cash during search on the third day at Sudapada in Bolangir, also linked to the distillery group. From the bags, Rs 25 crore were counted till Friday afternoon, taking the total amount recovered so far to Rs 225 crore.

The raids were carried out at Sambalpur, Bolangir, Titilagarh, Boudh, Sundargarh, Rourkela and Bhubaneswar. Meanwhile, torn currency notes of Rs 500 denomination were found dumped near the Boudh Distillery Private Limited at Titirikata.

Former I-T commissioner Sarat Chandra Dash said this could be the largest cash seizure by the I-T department in Odisha so far.

Jr Mehmood no more

Mumbai, Dec 8: Junior Mehmood, the child star remembered for his endearing performances in films such as 'Caravan', 'Brahmachari' and 'Mera Naam Joker' in the late 1960s and early 1970s, died in the early hours of Friday following a battle with cancer. He was 68.

The actor, who was born Naeem Sayyed and got his pen name from his idol Mehmood, was laid to rest at the Santa Cruz cemetery in the presence of family and associates from the film industry in the evening.

"My father passed away at 2 am following his battle with stomach cancer. He was in a critical condition for the last 17 days. He had lost 35-40 kg in a month," Junior Mehmood's younger son Hasnain Sayyed said.

Junior Mehmood began as a child artist with 'Mohabbat Zindagi Hai' (1966) and 'Naunihal' (1967). He was given the name Junior Mehmood by late comedy icon Mehmood after they starred together in the 1968 film 'Suhaag Raat'. **P2**

to further his interest. After a heated debate over the Panel report during which Moitra was not allowed to speak, Parliamentary Affairs Minister Pralhad Joshi moved a motion to expel the Trinamool member for 'unethical conduct', which was adopted by a voice vote. Reacting sharply to her ex-

pulsion, Moitra equated the action with hanging by a 'kangaroo court' and alleged that a parliamentary panel was being weaponised by the government to force the Opposition into submission.

She told reporters that she has been found guilty of breaching a code of ethics that does not exist and that there was no evidence of cash or gift given to her.

The Ethics Committee report found Moitra guilty of 'unethical conduct' and contempt of the House by sharing her Lok Sabha credentials - User ID and Password of Lok Sabha Member's Portal, with unauthorised persons which had an irrepressible impact on national security, Joshi said. The Committee also recommended that in view of the 'highly objection-



able, unethical, heinous and criminal conduct' of Moitra, an intense, legal and institutional inquiry be initiated by the government in a time-bound manner.

The motion moved by Joshi said that Moitra's 'conduct has further been found to be unbecoming as an MP for accepting gifts and illegal gratification from a businessman to further his interest which is a serious misdemeanour and highly deplorable conduct' on her part.

Joshi urged the House to accept the recommendation and finding of the committee and 'resolve that continuance of Moitra as member of Lok Sabha is untenable and she may be expelled from the membership of the Lok Sabha'.

TMC and other Opposition members demanded that Moitra be allowed to put her views in the House, which was turned down by Speaker Om Birla citing past precedence

Star Betelgeuse to blink Tuesday

Cape Canaveral, Dec 8: One of the biggest and brightest stars in the night sky will momentarily vanish as an asteroid passes in front of it to produce a oneof-a-kind eclipse.

The rare and fleeting spectacle, late Monday into early Tuesday, should be visible to millions of people along a narrow path stretching from central Asia's Tajikistan and Armenia, across Turkey, Greece, Italy and Spain, to Miami and the Florida Kevs and finally, to parts of Mexico. The star is Betelgeuse, a red supergiant in the con-

stellation Orion. The asteroid is Leona, a slowly rotating, oblong space rock in the main asteroid belt between Mars and Jupiter.

An estimated 700 light-years away, Betelgeuse is visible with the naked eye. Binoculars and small telescopes will enhance the view. A light-year is 5.8 trillion miles.

Betelgeuse is thousands of times brighter than our Sun and some 700 times bigger. It's so huge that if it replaced our sun, it would stretch beyond Jupiter, according to NASA. At just 10 million years old,

Betelgeuse is considerably younger than the 4.6 billionyear-old sun. Scientists expect Betelgeuse to be shortlived, given its mass and the speed at which it's burning through its material.





Bhubaneswar, Dec 8: Chief Minister Naveen Patnaik Friday inaugurated Pabitra Mohan Pradhan Government Hospital at Talcher in Angul district in presence of Union ministers Dharmendra Pradhan and Pralhad Venkatesh Joshi.

The hospital named after renowned freedom fighter Pabitra Mohan Pradhan was built at a cost of Rs 492 crore using CSR funds of Mahanadi Coalfields Limited (MCL). The 330-bed hospital will be later upgraded into a medical college.

Inaugurating the facility through virtual mode, Patnaik thanked Prime Minister Narendra Modi for Centre's cooperation for the project. The hospital will be converted into a medical college in future, he said. Paying his respects to freedom fighter Pradhan, who was born in Talcher, the Chief Minister said the area has contributed immensely to the development of the state with its rich mineral resources.

Noting that his government has been stressing on high-quality health services to the people, Patnaik said the new hospital will serve the needs of the local residents.

Coal Minister Pralhad V Joshi said Coal India, which has contributed towards construction of the hospital, would also support to upgrade the hospital into a medical college. He said the Coal India subsidiary MCL will provide Rs 628 crore for the management of the hospital for the

Belgium and Germany, have identified companies operating in economic sectors associated with increased risks of emerging and re-emerging infectious diseases.

These companies are known to operate in regional hotspots for these zoonotic diseases, they said in their study.

The researchers then analysed the financial entities with ownership and investments in these companies

They found that a handful of largely US-based private financial entities, including Vanguard,

vestments in these companies. Further, even public investors such as the state of California. Norway through its Sovereign Wealth Fund, and Sweden through its pension funds, hold shares in these companies operating in potential pandemic epicentres. "Financial actors have an im-

portant, but often ignored, role to help prevent the emergence of infectious diseases. Their investments enable economic activities in known zoonotic disease hotspots globally," said Victor Galaz, lead author of the study and senior researcher at the Stockholm Resilience Centre at Stockholm University

The researchers also pointed out countries such as France, the US, Protugal, Norway and Sweden either invest themselves or host headquarters of com-

panies with investments in zoonotic diseases hotspots.

They said that these countries could work together to use financial influence to address the risks of animal-to-human outbreaks and pandemics.

The authors said that efforts

which investors could push for, which included ecological restoration measures and the creation of pathogen surveillance systems.

Other measures they suggested included improvements in the health and economic security of communities living in geographical hotspots of emerging and re-emerging infectious diseases.

Corporate policies focussing only on deforestation and landuse change fail to consider the enhanced risks of spillover events through agricultural expansion and deforestation, according to co-author Paula A. Sánchez, researcher at the Stockholm Resilience Centre.

"There is a need for policies to reduce the edge effect, create pathogen surveillance systems and improve the health care systems of communities living in areas that are emerging infectious hotspots," said Sánchez.

The researchers further warned of climate change's impacts on the risk of spillover events.

"Climate change will increase the risks of new zoonotic outbreaks. Financial actors should make sure that their investments help to mitigate and adapt to those risks," said Peter Søgaard Jørgensen, another co-author associated with the Stockholm Resilience Centre.

"Large investors hold potential influence over companies operating in these hotspots, and this influence could be leveraged to mitigate risks of new pandemics," said Galaz.

The researchers acknowl edged that data availability continued to be a limitation for identifying potential alliances among investors and corporate actors.

Rains struck during the peak coffee harvesting season and affected the quality and texture of the ripened fruits

Koraput, Dec 8: A body of coffee growers demanded government intervention and subsidies in the wake of unseasonal rain triggered by cyclone Michaung wreaking havoc on harvest of the crop.

Odisha Coffee Growers Association (OCGA) urged the government to provide subsidies to facilitate the adoption of modern drying techniques.

According to the farmers' body, the rain battered Koraput district, known for coffee gardens, Tuesday and Wednesday and damaged the crops.

The calamity struck during the peak harvesting season and affected the quality and texture of the ripened coffee fruits.

"It's the peak ripening season for coffee fruits. The cyclonic storm has significantly impacted growers. Drying the harvested coffee has become problematic after the unseasonal rain which we face almost every year. Also, the quality is affected," OCGA Vice-President Sujoy Pradhan said.

Cultivators in the district keep the harvested coffee fruits under sunlight to dry the crop.

"This practice becomes challenging during adverse weather conditions, leading to quality issues. Additionally, several substances may inadvertently mix with the coffee during the open drying process," he said.

ED files charge-sheet against 3 for trading leopard skin, organs

New Delhi, Dec 8: The Enforcement Directorate (ED) has filed a charge-sheet against three alleged wildlife poachers namely Satyaban Sahu, Mahit Bhue and Souki Thethua in connection with the alleged trading of leopard skin and organs, official sources said.

The ED said that the agency filed the charge-sheet under the provisions of Prevention of Money Laundering Act (PMLA), 2002



ED filed the charge-sheet against Sahu, Bhue and Thethua of Bargarh district, in the Court of the Sessions Judge, Khurda at Bhubaneswar-cum-Special Court (PMLA) with prayer for conviction and punishment of the accused persons and also confiscation of proceeds of crime.

The court took cognizance of the charge-sheet filed by ED in this case December 4, the agency said

The ED case is based on the FIR and charge sheet filed against the accused persons, by the Special Task Force of state Crime Branch under various sections of the IPC, 1860 and Wildlife Protection Act, 1972.

ED investigation revealed that the accused persons were allegedly involved in trading of leopard skin and wildlife articles or organs or trophies since long and one leopard skin, 11 numbers of its nail and four numbers of its teeth valued at Rs 6.30 lakh were identified as proceeds of crime, the agency added.

Mayurbhanj sees most cases of crimes against women

Bhubaneswar: Dec 8: There has been rise in the incidents of crime against women in Odisha, with Mayurbhanj district witnessing registration of the maximum number of cases, according to a latest report of the National Crime Records Bureau (NCRB).

The report on 'Crime in India, 2022' also presents a detailed district level account of various crime incidents that occurred in different states including Odisha, last year.

As per the NCRB report, Mayurbhanj district bore the undesirable distinction of being the first in crime cases committed against women.

The tribal dominated district reported 1,788 criminal offences such as assault, murder, rape, kidnapping and abduction of women in the state in 2022.

Ganjam is not far behind Mayurbhanj in cases related to crime against women. As many as 1,532 cases were registered in the district. Kendrapara district stood third with 1.476 cases Mayurbhanj recorded 394 kid-

napping and abduction cases



of women in 2022 which was the highest among districts. Balasore closely followed Mayurbhanj with 387 cases of kidnapping in 2022.

Mayurbhanj recorded the maximum number of cases related to cyber offences against women registered under the Information Technology Act. The district recorded as many as 45 cases under the IT Act for cyber crime offences against women in the state.

As many as 37 cyber crime offences against women were reported in Cuttack in 2022.

The report also brought to fore the fact that Mayurbhanj registered third highest assault incidents against women while Kendrapara topped the list in

the state. Kendrapara, Khurda and Mayurbhanj registered 792, 639



Previous enmity between two groups in the village was said to be the reason for the incident, Ganjam SP Jagmohan Meena said. Meena said there was a quarrel between two groups in the village during the immersion procession of Lord Ganesh a few months ago.

Wild tusker tramples 2 to death

Bhubaneswar: Two persons were trampled to death by a wild elephant at separate locations in Angul district, a forest official said Friday. The deceased were identified as Guru Nayak of Saradhapur village and Ainthu Sahu of Cheliapada village in the district. Police recovered their bodies Thursday night, the official said. The elephant first attacked Nayak in Saradhapur when he was out for a walk, and then attacked Sahu in Cheliapada, said Vivek Kumar, Divisional Forest Officer (DFO), Angul. "We are investigating under which circumstances the wild tusker trampled the two persons to death. Usually, tuskers exhibit violent behaviour due to hormonal changes. We are studying the elephant's behaviour and action will be taken accordingly," he said.

OMANJI Man gets 20-year jail for raping, impregnating girl

Berhampur, Dec 8: A court in Ganjam district has sentenced a man to 20 years of rigorous imprisonment for raping and impregnating a 16-year-old girl three years ago, an official said Friday.

The special court under the Protection of Children from Sexual Offences (POCSO) Act in Berhampur convicted 27-year-old Ranjit Nayak of Aska area Thursday after examining the statements of 17 witnesses, including the police and a doctor, and the medical reports, special public prosecutor Narayan Panda said.

Pravat Kumar Rajguru, the judge of the court, has also imposed a fine of Rs 13,000 on the convicted person. Nayak

will have to serve an additional jail term of 14 months if he fails to pay the fine, the special public prosecutor said.

The court has recommended the district legal service authorities (DLSA) to pay Rs 8 lakh to the survivor as compensation, he said.

Sources said the police had registered a case against the accused person under different sections of the Indian Penal Court and POCSO Act in September 2020 after an FIR was lodged by the girl's mother.

The complainant claimed that the man had a sexual relationship with the girl against her will and left her when she became pregnant. A police team from Buguda arrested the accused from Chennai.

Sec-144 imposed at Madina Maidan

ED's Future Actions

The recent empanelling of IRS officer Rahul Navin as the interim chief of the Enforcement Directorate (ED) and conferring upon him the additional secretary rank was not merely anticipated but deemed inevitable, according to several senior babus. Navin assumed the role in September 2023, succeeding SK Mishra, following a pattern where the position is often temporarily elevated to the rank and pay of Secretary.

This move is seen by some as a potential signal from the Centre to regularise Navin as the full-fledged Director of the ED. The central probe agency, responsible for investigating financial crimes under key legislations, is witnessing a strategic transition in leadership. Certainly, its role has gained prominence in recent times as the Modi sarkar.

There has been a five-fold increase in the number of cases registered by ED since 2014, especially after 2019. The Opposition parties often accuse the BJP government of misusing central agencies, especially ED to target opposition leaders. And now, flush from the poll victories in Madhya Pradesh, Rajasthan and Chhattisgarh, the ED is widely expected to continue its investigations with even greater vigour.

As Navin takes charge, the agency's future operational continuity will be followed with great interest. The development underscores the intersection of bureaucratic reshuffles, specialized financial investigations, and the leadership required of the agency.

CCPA's crackdown on coaching institutes

The Central Consumer Protection Authority (CCPA) has taken a stance regarding a practice that is widely observed: the cooperation between successful UPSC candidates and coaching classes. Sources have informed DKB that the CCPA views these arrangements as deceptive and in violation of fair trade practices.

The matter concerns the use of UPSC toppers' images by coaching institutes in their advertisements, which the CCPA claims fall under

the definition of 'misleading advertisement' and 'unfair trade practices', as specified in the Consumer Protection Act of 2019. The Central Civil Services

(Conduct) Rules, 1964, should be enforced, the CCPA reportedly

wrote to the Department of Personnel and Training (DoPT), which is the controlling authority for officers chosen through the UPSC examination. This recommendation applies to all candidates who are still featured in advertisements for coaching classes, essentially serving as their brand ambassadors throughout the year.

Following the decision, the CCPA has reportedly taken decisive action by issuing notices to 20 prominent IAS coaching institutes. The institutes, in turn, are arguing that the successful candidates were part of the interview guidance programme and not the more expensive foundation courses

This crackdown by the CCPA reflects a growing concern about the ethics of such advertising practices. Many UPSC candidates heavily rely on these coaching institutes for guidance in their pursuit of a career in the civil service. It has prompted a larger conversation about the responsibilities of both coaching institutes and UPSC toppers in pursuit of creating a level playing field.

Karnataka HC calls for clarity

A recent directive from the Karnataka High Court requires the state government to outline guidelines for appointing lower cadre individuals to higher cadre positions. Against the backdrop of a legal dispute between two Karnataka Administrative Service (KAS) officers, the court order sheds light on the intricate dynamics of cadre promotions.

The petitioner, Prajna Ammembala, challenged a transfer order placing her in the role of Additional Director in the Department of Food, Civil Supplies and Consumer Affairs, Bengaluru, a post traditionally reserved for an IAS cadre officer or, in their absence, a KAS officer in the super-time scale. However, the incumbent babu, Potharaju, challenged the transfer, citing its premature nature and the lack of chief minis-

terial approval. The Karnataka State Administrative Tribunal (KSAT) ruled in favour of Potharaju, but now this recent directive of the High Court stresses the importance of scrutinizing the eligibility of both officers and questions Potharaju's standing to contest the appointment. Observers have noted that the court's nuanced interpretation broadens the definition of promotion beyond mere pay scale and rank elevation, and encompasses the significance of advancements in honour, dignity and grade.

foreign affairs minister S Jaishankar has of late been stressing the multi-polarity in world politics that requires a multi-alignment approach. Probably he means that configuration of world powers has drastically changed causing a few global powers emerging on the scene. So non-alignment between two blocks in a bipolar world as it was, should give way to engaging with various power centres. This certainly merits a

deeper evaluation. Foreign policy of any country is essentially a manifestation of its national imperatives. They are defined by international political observers, commentators, academics and diplomats as determinants, objectives, principles and national interests. India's foreign policy, likewise, has been shaped by and has evolved as reflection of such priorities, and more important, in response to the prevalent world order.

The evolution of India's foreign policy since 1947 till date could be divided into several phases in various ways. The first phase (1947-62) could be described as op-

independence in 1947, two years after the end of Second World War when international politics got divided into two camps - one led by the US and the other by the former Soviet Union. India was wary of the Western powers which were colonisers and wanted to stay away from them. Thus, India founded the Non-Alignment Movement (NAM) in 1961, which, in a way, was the zenith of solidarity in the Third World which was getting decolonised.

However, The unexpected war with China and its consequence led to the second phase of Realism and Reorganising (1962-71). New Delhi had to look beyond Non-Alignment in the interest of national security.

The third phase (1971-91) consisted of India's assertion as a regional power based on self-reliance. India showed remarkable strategic autonomy and use of hard power in liberating East Pakistan (Bangladesh) in 1971 war against Pakistan. The emergence of US-China-Pakistan axis posed multiple challenges for India. Recognising the security risks, New Delhi signed a Peace

Union. Geo-political and domestic upheavals in 1990s necessitated a strategic shift in India's foreign policy. The Gulf War (1991-91), the collapse of the Soviet Union (1991) and the economic stagnation at home causing a balance of payment crisis led India to rethink its foreign policy.

The fourth phase, safeguarding the strategic autonomy (1991-98) came into play. The strategic autonomy manifested conspicuously in exercising its nuclear option (Pokhran-II) in 1998. The emergence of the US as a sole super power also prompted India to change its course. India reached out to engage with the US, Israel and Asean countries.

In the fifth phase (1998-2013), India acquired the attributes of a balancing power and began to be seen as the counterweight to China, a new economic power. This recognition could be reflected in India-US Nuclear Agreement in 2008. At the same time, India maintained its traditional ties with Russia and made 'common cause' with China in BRICS and SCO.

This current strategy emanates from India's self-realisation of its capabilities and geo-political significance in the existing world politics influenced largely by rise and threat of China. To name a few of India's power-indicators; it is one of the major world economies (fifth largest). a big technology power (soft-

ware), global player in certain major issues like climate change (Paris Agreement), anti-terrorism (peace-broker) and a regional power-SAGAR, Act East, BIM-STEC, QUAD, and so on.

Multi-alignment is stating the obvious. No country can function in isolation. Politics is global although strategies in actions are national. Multi-alignment as a strategy seems nebulous; it needs to be clearly defined. Going with everyone conceptually appears to be confusing two potential allies, actual friends and partners. What is therefore needed is realignment in India's foreign policy in keeping with its long-term national interests.

Over 1cr people visited Delhi zoo in 5 years: Data

New Delhi, Dec 8: Over one crore people have visited the National Zoological Park here in the last five years, according to official data.

The data shared by the zoo stated that 20.46 lakh people visited the park in 2022-2023, leading to a revenue generation of Rs 15.34 crore. In 2017-18, more than 27 lakh people visited the zoo, the footfall was 27.12 lakh in 2018-19, 21.47 lakh in 2019-20, and 5.66 lakh in 2021-22, the statement said.

During a revision of the entry fee in 2021-22, the fare for all categories was increased by 100 per cent.

Decline in Delhi's sex ratio, rise in birth rate in 2022

New Delhi, Dec 8: The sex ratio in the national capital dropped to 929 in 2022 from 932 a year back, according to a report published by the Delhi government.

The 'Annual report on registration of births and deaths in Delhi, 2022' showed that the birth rate in Delhi increased to 14.24 per thousand of population during 2022 from 13.13 in 2021. The death rate declined to 6.07 per cent in 2022 from 8.28 per cent in 2021. It also revealed a significant jump in the average number of births per day in Delhi i.E. Up from 745 in 2021 to 823 in 2022. The sex ratio declined to 929 per thousand males in 2022 from 932 in 2021, the report said.

The report said 1,55,670 (51.83 per cent) of the total births registered were males and 1.44.581 (48.14 per cent) were females and 99 (0.03 per cent) belonged to the "others" category.

Out of the total births, 2,82,389 (94.02 per cent) were institutional -- 1,86,905 (66.19 per cent) of them in government hospitals -- and 17,961 (5.98 per cent) were domiciliary in nature. A majority of births (89.15 per

cent) were in urban areas while births in rural areas accounted for 10.85 per cent of the total, the report said. An analysis of age-group of mothers at the time of delivery showed that 37.52 per cent were in the 25-29 age bracket while 30.55 per cent were in the 20-24 age group, the report stated. Also, in 29.71 per cent cases, the age of the mother

The visitors now can take their still cameras for free which earlier cost them Rs 50. Earlier, amateurs with video cameras used to pay Rs 200 but now it is free for them.

The zoo did not change its fee of Rs 2,000 for documentaries, while it has gone up from Rs 20,000 to Rs 50,000 for feature films, it stated.

The zoo had recently said it will have the facility to accept international Master and Visa cards for foreign tourists.

Akanksha Mahajan, director of the National Zoological Park, had said this facility will attract more foreigners to come to the Z00.

"We have seen that the foreign nationals who visit the zoo without tourist guides face difficulty while making payment at the ticket counters and later turn back. Most of the foreign tourists come to the national capital during winter and we want them to visit the zoo as well. So we have asked the bank officials concerned to update the facility so that tourists having international Visa or Master cards can use it to buy the tickets," Mahajan had said.

'More than 70 per cent rape victims in Delhi between age 18 & 30'

New Delhi, Dec 8: The highest number of women rape victims in Delhi in 2021 were in the 18-30 age group, accounting for more than 72 per cent of all such cases, a state government report released Friday said

The Directorate of Economics and Statistics in its report stated that in 2021, of a total of 1.251 rape victims in Delhi, the most, at 905, were in the age bracket 18-30, followed by 328 in the 30-45 age group.

The pattern bears out at national level too, with 20,065 rape victims, the highest, coming from those between age 18 and 30, followed by 7,627 in the age group 30-45.

There were a total of 31,878 rape victims across the country in 2021, the report said. The report revealed there were more male victims of suicides than female over the years.

In 2021, out of 2,840 victims of suicide in Delhi, 2,093 were men and 746 women. In 2020, of 3,142 such acts, 2,247 were committed by men and 895 by women, it said.

According to the data, during 2017-2021, unemployed and married men were more susceptible to die by suicide, and in case of women, housewives constituted the highest of the lot.

In 2021, a total of 73,715 cases of crime against women went to trial, out of which, 274 cases resulted in conviction and 355 in acquittal.

In 2020, 403 such cases resulted in conviction and 388 in acquittal out of 65.437 cases that went to trial. the report said.



'FCI to be upgraded to IHM in Jammu soon'

Jammu: The Food Craft Institute (FCI) will soon be upgraded as the Institute of Hotel Management (IHM) to cater to the requirement of skilled manpower for the industry in the Jammu region, an official said. This was informed during the 18th governing body meeting of Food Craft Institution (FCI) held under the chairmanship of Commissioner Secretary, Skill Development Department (SDD), Saurabh Bhagat here. The proposal, in this regard, has been submitted to the Union Ministry of Tourism for approval, he said. The meeting accorded approval to purchase a bus for the institute, installation of rooftop panels and creation of hostel facility within the campus. The Commissioner Secretary appreciated the efforts of the institute, which has tied up with J&K Police for training their jail inmates and kins of martyrs to make them employable.

Cyber crimes soar in Delhi

According to the Cyber Crime Unit, of the Delhi Police, these crime methods are "fake TRAI or FedEx courier company callers", "home job or Telegram fraud", "sextortion", "fake family member or friend in distress", and "OTP or link-based cheating"

New Delhi, Dec 8: With the national capital witnessing a sharp increase in cybercrime cases over the years, the Delhi Police has identified top five methods adopted by cyber criminals and cautioned people against them. Here are brief details of modus

operandi followed by cyber criminals: (1) Fake TRAI (Telecom Regulatory

Authority of India) or FedEx (courier) company callers

Under this modus operandi, a person gets a recorded call from an unknown number and is told by the caller that his or her mobile number will be soon discarded. The caller will then ask the person to click '9', that will be linked to a fake call centre which is set up by the fraudsters in a room.

The potential victim is then told that the mobile number has been detected to have terror links and some money has been deposited into the person's account via hawala operators.

When questioned for authenticity, the caller asks the target to come on a Skype call and informs that he or she will be digitally arrested. Soon after, the target receives a fake notice from security agencies such as the CBI and the Income Tax.

Thereafter, the fraudsters show sympathy towards the target and promise help. If the target seeks their help, they take bank details in the garb of verification and ask the person to put some money into a fake government account number shared by them with the promise of returning the amount in two-three days. According to police, a similar modus operandi is used by fraudsters posing as courier company agents from FedEx.



This kind of cases of cheating is being reported for the past six months, an official said.

In these cases, a fake courier company agent usually tells a potential target that the parcel sent to them contains drugs. The agent then offers help to protect the person from any potential action by a security agency and take money.

(2) Home job or Telegram fraud In this, the potential target

will get a message on his or her WhatsApp number with a parttime job offer. The target is told to open an account in Telegram and an organiser then adds the number in a group. The organiser then give some tasks, usually to follow certain social media accounts or like videos on social media platforms.

The potential target is promised thousands of rupees for a day's work. Initially, the person gets the promised money, starting from Rs 150 to Rs 300, for just clicks. Once a person starts working on a daily basis, he or she is asked deposit some money for certain tasks. Though initially a person gets some refund, once the prepaid amount is high, the fraudsters dupe the person. In this method, an official said, other members in the group usually encourage the potential target to invest more by stating that they have already done so. According to the officials, the

accounts of other members in the group are actually handled by one person. (3) Sextortion

Under this modus operandi, the potential target gets a random video call on mobile phone. When the person attends the video call, he finds a woman engaging in obscene act. By the time the person disconnects the call, the fraudsters either record the video or take a screenshot of the video chat. (4) Fake family member or friend in distress

In this method, a potential target receives a call from an anonymous number and the caller claims to be an old friend or relative. The fraudsters may even use artificial intelligence (AI) to emulate the voice of someone known to the person. The caller will tell the other person that he is in distress and needs monev.

The caller will ask the target to send the money to his account but the sender will find out later that the caller was lying. In this category, the fraudsters dupe women by creating profiles on matrimonial websites and once they gain a woman's trust, they ask her to deposit money on some pretext. The fraudsters stop taking calls after getting the money.

(5) OTP or link-based cheating This the most commonly used modus operandi by cyber crim-

inals for years. Under this, a per-

People who are less tech savvy still get trapped in such operations. The fraudsters also send message about a courier and asks the potential target to deposit money in the account number shared by them.

Cold wave sweeps Kashmir

Srinagar, Dec 8: The minimum temperature dropped at most places in Kashmir Friday as the valley continued to experience sub-zero nights, IMD said.

Srinagar, the summer capital of Jammu and Kashmir, recorded a low of minus 2.4 degrees Celsius, slightly up from minus 2.6 degrees Celsius noted the previous night, the India Meteorological Department (IMD) said in its bulletin. Pahalgam in south Kashmir's Anantnag district, which serves as one of the base camps for the annual Amarnath yatra, saw the minimum temperature settling at minus 4.8 degrees Celsius. The resort was the coldest recorded place in the Valley. The famous ski resort

of Gulmarg in Baramulla district recorded a low of minus 3.0 degrees Celsius - down from minus 2.5 degrees Celsius the previous night, the IMD bulletin said.

Qazigund recorded a low of minus 2.4 degrees Celsius. Kokernag town in south Kashmir registered a minimum temperature of minus 2.0 degrees Celsius, while Kupwara recorded a low of minus 2.5 degrees Celsius.

The meteorological office said the weather would remain generally cloudy but mainly dry till December 11. It also predicted a dip in the night temperature by a few degrees. From December 12 to 15, there is a possibility of light rain or snowfall at isolated places in the higher reaches of Jammu and Kashmir, the MeT office said.







New Delhi, Dec 8: The BJP Friday appointed Defence Minister Rajnath Singh, Haryana Chief Minister Manohar Lal Khattar and Tribal Affairs Minister Arjun Munda as central observers for the election of its legislature party leaders in Rajasthan, Madhya Pradesh and Chhattisgarh respectively.

The legislature party leaders will become Chief Ministers of the three states and the meetings to elect them may take place over the weekend. There is a view within the party that its leadership may usher in fresh faces at the helm of these states. Singh will be joined by the

She accused the BJP of preventing Moitra from presenting her defence. Banerjee highlighted the submission of the nearly-500-page report in Parliament, followed by a mere 30-minute window for all parties to discuss the matter.

Expressing disappointment that Prime Minister Narendra Modi did not intervene, Banerjee

said, "This is unfortunate and unacceptable. Moitra will emerge victorious in the next battle and people will deliver a resounding response and justice. They (BJP) will face defeat in the upcoming election. I am fully convinced of this.'

The BJP said the expulsion was "apt" and there was no ground left for the TMC leader to remain as an MP as there was proof of the allegations levelled against her. Congress's whip in the Lok Sabha Manickam Tagore slammed the Centre over Moitra's expulsion. saying it was an attack on the parliamentary system itself.

New Delhi, Dec 8: Judges are not expected to express their personal views or preach, the Supreme Court remarked on Friday, strongly criticising a Calcutta High Court judgement which advised young girls to "control sexual urges" and adolescent boys to train themselves to respect women.

Terming the High Court observations as "highly objectionable and unwarranted", a bench of Justices Abhay S Oka and Pankai Mithal said the observations are completely in violation of the rights of adolescents under Article 21 of the Constitution.

In its October 18 judgement, a division bench of Justices Chitta Ranjan Dash and Partha Sarathi Sen of the Calcutta High

Court said that adolescent girls should "control sexual urges" and "not give into two minutes of pleasure".

The apex court said the issue before the High Court was legality and validity of order and judgement dated September 19/20, 2022 by which a man was convicted for offences under sections 363 (kidnapping) and 366 (kidnapping, abducting or inducing woman to compel her marriage) as well as Section 6 of the Protection of Children from Sexual Offences (POCSO) Act.

"As per the order of the CJI. suo motu writ petition has been initiated mainly due to sweeping observations/findings recorded by the division bench of the High Court."In an appeal against conviction, the High Court was called upon to decide only the merits of the appeal



and nothing else. Prima facie, we are of the view that in such a case, the Hon'ble judges are not expected to either express their personal views or preach."After having carefully perused the judgement, we find that many

parts thereof, including paragraph 30.3, are highly objectionable and completely unwarranted. Prima facie, the said observations are completely in violation of rights of adolescents under Article 21 of the Constitution," the bench said. "Prima facie, we are of the

view that the judges are not expected to express personal views or preach," the bench said while issuing notice to the West Bengal government and other parties in the case.

The top court appointed senior advocate Madhavi Divan as amicus curiae to assist the court and advocate Liz Mathew to assist the amicus. The matter has now been posted for hearing on January 4, 2024.

The High Court had made the observations while hearing an appeal by a boy who was sentenced to 20 years in prison for the offence of sexual assault. The High Court had acquitted the boy stating that this was a case of "nonexploitative consensual sexual relationship between two consenting adolescents, though consent in view of the age of the victim is immaterial".

The High Court had also said it is the duty/obligation of every female adolescent to "protect her right to integrity of her body; protect her dignity and self-worth; thrive for overall development of her self transcending gender barriers; control sexual urge/urges as in the eyes of the society she is the loser when she gives in to enjoy the sexual pleasure of hardly two minutes; protect her right to autonomy of her body and her

privacy" "It is the duty of a male adolescent to respect the aforesaid

duties of a young girl or woman and he should train his mind to respect a woman. her self-worth. her dignity and privacy, and her right to autonomy of her body,' the High Court had said.

The bank's announcement comes as Sri Lanka is awaiting International Monetary Fund approval for the second

Salvoes of rockets fired at US Embassy

In Baghdad Baghdad: A rocket attack on the sprawling US Embassy in Baghdad caused minor damage but no casualties Friday morning, US and Iraqi officials said. The attack is the first on the embassy located in the heavily fortified Green Zone of Iraq's capital to be confirmed since the beginning of the Israel-Hamas war. The Green Zone houses Iraqi government buildings and embassies on the west bank of the Tigris River. Iranbacked militias in Iraq have claimed responsibility for dozens of attacks that targeted bases housing US troops in Iraq and Syria since Israel declared war on Hamas two months ago.

UK paid Rwanda \$300mn for a blocked asylum deal

London: Prime Minister Rishi Sunak was under pressure Friday to explain why Britain has paid Rwanda 240 million pounds (USD 300 million) as part of a blocked asylum plan, without a single person being sent to the East African country. The total is almost twice the 140 million pounds that Britain previously said it had handed to the Rwandan government under a deal struck in April 2022. Under the agreement, migrants who reach Britain across the English Channel would be sent to Rwanda, where their asylum claims would be processed and, if successful, they would stay. The plan was challenged in UK courts, and no flights to Rwanda have taken off. Last month, Britain's Supreme Court ruled the policy was illegal because Rwanda isn't a safe country for refugees.

Chinese military balloon spotted in Taiwan Strait

Taipei (Taiwan): Taiwan's Defence Ministry says a Chinese military surveillance balloon was spotted in the Taiwan Strait, as well as a large-scale movement of military aircraft and ships. The ministry said the balloon passed southwest of the northern port city of Keelung on Thursday night then continued east before disappearing, possibly into the Pacific Ocean. However, there seemed to some uncertainty about whether the balloon was operated directly by the People's Liberation Army, the military branch of China's ruling Communist Party. The ministry referred to it both as a "PLA surveillance balloon" and as "1 PRC's balloon", using the acronym for the People's Republic of China, China's official name.

Putin to run for Prez again

Moscow, Dec 8: Vladimir Putin on Friday moved to prolong his repressive and unyielding grip on Russia for at least another six years, announcing his candidacy in the presidential election next March that he is all but certain to win.

Putin still commands wide support after nearly a quartercentury in power, despite starting an immensely costly war in Ukraine that has taken thousands of his countrymen's lives, provoked repeated attacks inside Russia — including one on the Kremlin itself — and corroded its aura of invincibility. A short-lived rebellion in June

by mercenary leader Yevgeny Prigozhin raised widespread speculation that Putin could be losing his grip, but he emerged with no permanent scars. Prigozhin's death in a mysterious plane crash two months later reinforced the view that Putin was in absolute control.

'I won't hide it from vou — I had various thoughts about it over time, but now, you're right. it's necessary to make a decision." Putin said in a video re-

Negotiations at COP28 climate talks ramp up

Dubai, Dec 8: The United Nations climate conference on Friday began its final week with negotiators expected to zoom in on the future of fossil fuels on a dangerously warming planet.

"It's go-time for governments at COP28 this week," UN Climate Chief Simon Stiell said at a press event Friday.

Discussions after a first week of pageantry and official visits now become more difficult, particularly when it comes to language calling for the potential phase-out of the use of emission-spewing fossil fuels.

Any language along those lines likely will draw the ire of Saudi Arabia, a major oil producer just next door to the United Arab Emirates. The UAE itself also is planning to boost its oil production from 4 million to 5 million barrels of crude oil a day to take advantage of the fossil fuel market before countries potentially shift away from its use.

Stiell underlined the challenge ahead if the world doesn't limit emissions, describing ice shelves melting causing catastrophic flooding in coastal cities around the globe. Negotiators this week are

working to finalise a key document called the Global Stocktake. It evaluates the world's climate change progress since the 2015 Paris agreement and what needs to be done now to avoid blowing past its goal of limiting warming to 1.5 degrees Celsius (2.7 Fahrenheit) compared to preindustrial times. Professional negotiators who

have been working on getting options into shape will turn over their work to senior national officials, many at minister levels, who will have to make the tough political choices.

COP28 President Sultan al-Jaber said he was "quite positive, hopeful and optimistic" that the summit could bring a "paradigm shift centred around and based on the science.'

EU countries, along with small island countries - oft-victimized by climate change - and some progressive Latin American countries are aligned on calling for a phase-out of fossil fuels, negotiators said.

While there will be strong resistance to this measure, officials are confident references to fossil fuels will appear in the final text for the first time and within a timeline compatible with UN science reports.

Israel's failed bombing campaign in Gaza

ince October 7, Israel has invaded northern Gaza with some 40,000 combat troops and pummeled the small area with one of the most intense bombing campaigns in history. Violence against Palestinians by Israeli settlers in the territory has also reached record highs, according to the United Nations.

Even now, as Israeli forces push deeper into southern Gaza, the exact purpose of Israel's approach is far from clear.

Although Israeli leaders claim to be targeting Hamas alone, the evident lack of discrimination raises real questions about what the government is actually up to. Is wrecking northern Gaza and now southern Gaza a prelude to sending the territory's entire population to Egypt, as proposed in a "concept paper" produced by

the Israeli Intelligence Ministry? Whatever the ultimate goal, Israel's collective devastation of Gaza raises deep moral problems. To the contrary, it has only heightened resentment among Palestinians

Nor has the campaign succeeded in dismantling the group ostensibly being targeted. LOSING HEARTS AND MINDS

Since the dawn of airpower, countries have sought to bomb

enemies into submission and shatter civilian morale. This strategy of coercive punishment reached its apogee in World War II. History remembers the indiscriminate bombing of cities in that war simply by the place names of the targets: Hamburg (40,000 dead), Darmstadt (12,000), and Dresden (25,000)

Now Gaza can be added to this infamous list. Israeli Prime Minister Benjamin Netanvahu has himself likened the current campaign to the Allies' fight in World War II. While denying that Israel was

engaging in collective punishment today, he pointed out that a Royal Air Force strike targeting Gestapo headquarters in Copenhagen killed scores of schoolchildren. In fact, never in history has a

bombing campaign caused the targeted population to revolt against its own government. The United States has tried the tactic numerous times, to no avail. The war in Ukraine is the

most recent case in point. For nearly two years, Russia has sought to coerce Ukraine through wave after wave of devasting air assaults on cities across the country, killing more than 10.000 civilians, destroying more than

1.5 million homes, and displacing some eight million Ukrainians. Russia is clearly shattering Ukraine. But far from crushing Ukraine's fighting spirit, this massive civilian pun ishment has only convinced Ukrainians to fight Russia more intensely than ever.

A COUNTERPRODUCTIVE CAMPAIGN

This historical pattern is repeating itself in Gaza. Despite nearly two months of heavy military operations-virtually unrestrained by the United States and the rest of the world—Israel has achieved only marginal results. By any meaningful met-

he Israeli military said Friday it had struck more than 450 targets in Gaza from land, sea and air over the past 24 hours - the most since a truce collapsed last week

ric, the campaign has not led to Hamas's even partial defeat. Israel's air and ground operations have killed as many as 5,000 Hamas fighters (according to Israeli officials), out of a total of about 30,000. But these losses will not significantly reduce the threat to Israeli civilians, since, as the October 7 attacks proved, it takes only a few hundred Hamas fighters to wreak havoc on Israeli communities. Worse, Israeli officials also admit that the military campaign is killing twice as many civilians as Hamas fighters.

LAND FOR PEACE

The only way to deal a lasting

defeat to Hamas is to attack its leaders and fighters while separating them from the surrounding population.

That is easier said than done, however, especially since Hamas draws its ranks directly from the local population rather than from abroad

Indeed, survey evidence shows the extent to which Israel's military operations are now producing more terrorists than they are killing. Compare that with the 27 percent of respondents in both territories who told different pollsters in September that Hamas was "the most deserving of representing the Palestinian people.

This result also reinforces the lessons of history. Contrary to conventional wisdom, most terrorists do not choose their vocation owing to religion or ideology, although some certainly do. Rather, most people who become terrorists do so because their land is being taken away. A LASTING PEACE Only a two-state solution will

lead to lasting security for Israelis and Palestinians alike. That is the only viable approach that will truly undermine Hamas, and Israel can and should unilaterally press forward with a plan, taking steps on its own before negotiating with the Palestinians. The goal should be to revive a process that has been dormant since the last negotiations failed in 2008, 15 years ago.

To be clear, Israel should couple this political approach with a military one, engaging in limited, sustained operations against the Hamas leaders and fighters responsible for the atrocities of October 7. But the country must adopt the political element of the strategy now, not later. Israel cannot wait until after some mythical time when Hamas is defeated by military might alone.

Those who doubt that a two-state solution can ever be reached are right that immediately resuming negotiations with the Palestinians would not reduce Hamas's will to fight.

For one thing, the group is an avowed proponent of eliminating Israel.

For another, it would be one of the biggest losers in a two-state solution, since a peace deal would almost certainly involve the prohibition of armed Palestinian groups aside from Hamas's main internal rival, the Palestinian Authority, which would likely eniov renewed support and legitimacy if it secured an agreement that the majority of Palestinians supported. Mumbai, Dec 8: India's foreign exchange reserves increased to \$604 billion as December 1, surpassing the \$600 billion mark after a gap of about four months. The forex reserves were last

above the \$600 billion mark August 11 this year.

"India's foreign exchange reserves stood at \$604 billion as December 1, 2023. We remain confident of meeting our external financing requirements comfortably," Reserve Bank Governor Shaktikanta Das said, while unveiling the December bi-monthly monetary policy Friday.

The reserves were \$597.935 billion in the preceding week ended November 24.

In October 2021, the country's foreign exchange kitty had reached an all-time high of \$642 billion. The reserves took a hit as the central bank deployed the reserves to defend the rupee amid pressures caused majorly by global developments since last year.

The governor further said the Indian rupee has exhibited low volatility compared to emerging market economy (EME) peers in the calendar year 2023, despite elevated US treasury yields and a stronger US dollar.

"The relative stability of the Indian rupee reflects the improving macroeconomic fundamentals of the Indian economy and its resilience in the face of formidable global tsunamis," he said.

The coefficient of variation for the daily INR exchange rate vis-à-vis the US dollar was 0.66 (CY 2023), which is the lowest among peer emerging economies, including China, Malaysia, Russia, Turkey, Vietnam, South Africa and Thailand.

On the financing side, Das said foreign portfolio investment (FPI) flows have seen a significant turnaround in 2023-24 with net FPI inflows of \$24.9 billion (up to December 6) as against net outflows in the preceding two years

Net foreign direct investment (FDI), on the other hand, moderated to \$10.4 billion in April-October 2023, from \$20.8 billion



New Delhi, Dec 8: India will address the issue of the European Union's plan to impose a carbon tax on certain imported goods, Commerce and Industry Minister Piyush Goyal Friday said, adding that "I will retaliate" if required.

The CBAM (Carbon Border Adjustment Mechanism) or carbon tax (a kind of import duty) will come into effect from January 1, 2026. However, from October 1

this year, domestic companies from seven carbon-intensive sectors, including steel, cement, fertiliser, aluminium and hydrocarbon products, will have to share data with regard to carbon emissions with the EU.

India's 26.6 per cent of exports of iron ore pellets, iron, steel, and aluminium products go to the EU. These products would be hit by CBAM. India exported these goods worth \$7.4 billion in 2023

to the EU. He also said that India retaliated against the US after it imposed additional customs duties on certain steel and aluminium products.



Same rating for most India match pitches

New Delhi, Dec 8: The pitch at the Narendra Modi Stadium in Ahmedabad, which hosted November 19 the ODI World Cup final between India and Australia, has been rated 'average' by the International Cricket Council (ICC). ICC match referee and former Zimbabwe batter Andy Pycroft, however, rated the out-

field as 'very good'. Australia won the World Cup beating India by six wickets on a pitch which was slow and sluggish. After the match, the Indians had allegedly said that the pitch did not behave as they expected it to do so in the second session. Most Indian players complained

that batting had become easy

on the Ahmedabad pitch in the second session.

The pitches used in India's league matches against South Africa, England, Pakistan and Australia in Kolkata, Lucknow, Ahmedabad and Chennai respectively were also rated as 'average' by the ICC.

However, the Wankhede Stadium pitch on which India faced New Zealand in the semifinals received a 'good' rating. There were media reports ahead of that match suggesting that the hosts had switched pitch, offering a used surface instead of a fresh one.

The ICC also gave an 'average' rating to the Eden Gardens pitch in Kolkata which hosted the second semifinal
