# **Justice eludes POCSO victims**

Over 2.43L child sexual abuse cases pending for trial in fast-track courts across India & 11,940 in Odisha

New Delhi/Bhubaneswar, Dec 9: Speedy justice continues to elude lakhs of child sexual abuse victims as more than 2.43 lakh such cases in India and nearly 12,000 cases in Odisha (ranking fifth in the country) were pending in various fast-track special courts (FTSCs) till January 31 this year. This dismal justice delivery comes in the backdrop of the much touted claims of the Centre's robust policy and financial commitment, claims a research paper published by a non-profit.

As per the data, Uttar Pradesh tops the list of pending cases under Protection of Children from Sexual Offences (POCSO) with 67,153 cases while Maharashtra comes a distant second by registering 33,072 cases pending in different FTSCs. Likewise, West Bengal, Bihar and Odisha have 22,164, 15,594 and 11,940 pending POCSO cases, respectively. Sahu's staff expressed their inability to get a comment from the MP when PTI called on his phone for a reaction to the I-T department's action.

The tax sleuths are now recording the statements of various company officials and others, the sources said, adding that the counting of cash is expected to be over by Saturday. The total seizure of unaccounted cash is expected to be about ₹290 crore, they told PTI.

rank officer with surname 'Tiwari' was serving in the Excise department a few years ago. However, he has been transferred to somewhere else. This apart, a police official bearing the surname 'Tiwari' is also embroiled in controversy. PNN

Cash amounting to more than ₹250 crore has been seized till now and the money is continuously being deposited in government bank branches in Odisha, the sources said. Most of the currency notes are of ₹500 denomination.

This is the highest-ever cash seizure made by an agency in the country as part of an action against a single group and its linked entities, the sources said.

Some of the high-value seizures in the past include one from 2019 when the GST Intelligence raided a Kanpur-based businessman and seized cash amounting to ₹257 crore and another instance where cash amounting to ₹163 crore was unearthed by the I-T department during searches against a road construction firm in Tamil Nadu in July 2018.

# Apps for 'undressing women' gain traction

Washington, Dec 9: A whopping 24 million people visited undressing websites and apps that use artificial intelligence (AI) to undress women in photos in September alone, indicating the soaring popularity of such platforms. a report by Bloomberg said quoting social network analysis company Graphika.

According to the report, many of these undressing or 'nudify' services use popular social networks for marketing. For instance, since beginning of this year, the number of links advertising undressing apps increased more than 2,400 per cent on social media, including on X and Reddit, the researchers said. The services use AI to recreate an image so that the person is nude. Many of the services only work on women, said the report.

These apps are part of a worrying trend of non-consensual pornography being developed and distributed because of advances in AI - a type of fabricated media known as deepfake

images are often taken from social media and distributed without the con-

sent, control or knowledge of the subject.

The soaring popularity corresponds to the release of several open source diffusion models, or AI that can create images that are far superior to those created just a few years ago, Graphika said. Because they are open source, the models that the app developers use are available for free.

"You can create something that actually looks realistic," said Santiago Lakatos, an analyst at Graphika, noting that previous deepfakes were often blurry

One image posted to X advertising an undressing app used language that suggests customers could create

nude images and then send them to the person whose image

was digitally undressed, inciting harassment. One of the apps, meanwhile, has paid for sponsored content on Google's YouTube, and appears first when searching with the word 'nudify'. While searching with key word 'nudifv' top six apps/websites that pop up are: DeepNude, Nudify.online, SoulGen, Promptchan AI Image Generator, Candy.AI and Undress.vip.

A Google spokesperson said the company doesn't allow ads "that contain sexually explicit content".

'We've reviewed the ads in question and are removing those that violate our policies," the company said.

# **I-T RAIDS: SLUGFEST INTENSIFIES**

BJP urges CM for CBI probe; BJD accuses Oppn of 'dirty politics'; Congress distances itself from Jharkhand MP Dheeraj Sahu

#### PNN & AGENCIES

Bhubaneswar, Dec 9: With the Income Tax (I-T) department recovering over Rs 250 crore during raids at multiple locations linked to Congress MP Dheeraj Prasad Sahu-owned Boudh Distillery Pvt Ltd and its entities in Odisha, the BJP demanded a CBI probe into, what they alleged, the collusion of state apparatus in the scam.

The BJD, meanwhile, accused the Opposition of doing 'nasty politics' by dragging name of the regional party in the incident.

Odisha BJP president Manmohan Samal said, "How can Chief Minister Naveen Patnaik remain silent over such a shameful event taking place in Odisha? The I-T officials have seized huge amounts of black money just under the nose of the CM.

Targeting the BJD government, the BJP state president alleged that the leaders of the regional party in Odisha were providing protection to the Congress Rajya Sabha MP from Jharkhand whose family was involved in the liquor trade and stashing black money.

"If a central agency (I-T department) could get clue regarding the black money in Odisha, what was the state police, Excise department, Intelligence and the Economic Offences Wing



doing all along?," he asked.

The BJP leader also asked Patnaik to order a CBI probe into the matter. "The relationship between Sahu brothers and BJD leaders are subject of an investigation," he said, adding that the state government had not conducted re-auction or re-tendering of the Out Still Shops for the last 24 years

"While the BJP national leaders target the Congress MP in Jharkhand over the recovery of black money, the BJP leaders in Odisha unnecessarily drag the BJD. They will not succeed in their evil designs," a fresh statement issued by the BJD said, adding, "The Odisha BJP leaders should carefully read the X post of Prime Minister."

BJD MLA Satyanarayan Pradhan rejected Samal's allegations and claimed that no BJD minister or MLA was ever linked with the liquor traders whose black money have been seized by the I-T department.

'We welcome the raids conducted by the I-T department. It seems some BJP leaders of western Odisha are connected with the recovered money and the businessman. All the facts will come out after investigation." he said. Congress spokesman Rajani

Mohanty said his party demands a judicial investigation into the incident or a court-monitored SIT probe to ascertain the truth.

Meanwhile, the Congress distanced itself from its Jharkhand Rajya Sabha MP Dheeraj Sahu after the recovery of a huge amount of cash from a liquor company linked to him.

"The Indian National Congress is in no way connected with the businesses of Dheeraj Sahu, MP. Only he can explain, and should explain, how huge amounts of cash have been reportedly unearthed by the income-tax authorities from his properties,"AICC general secretary Communications Jairam Ramesh said in a post on X.

Union Minister Dharmendra Pradhan sought to know the source of 'benami wealth' seized from the liquor traders. He said it was a matter of concern that such a large amount of benami money was recovered.

# -1.14 lakh fake job cards in Odisha junked

**UP ACCOUNTS FOR HIGHEST NUMBER OF DELETIONS OF 2.96.464 CARDS OUT OF THE TOTAL 7,43,457**

New Delhi/Bhubaneswar, Dec 9: More than 7.43 lakh fake job cards under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) were deleted in 2022-23, of which over 1.14 lakh were in Odisha, according to Minister of State (MoS) for Rural Development Sadhvi Niranian Jvoti.

In a written response to a question this week, Jyoti shared data on fake job cards. The data showed 7.43.457 fake job cards were deleted in 2022-23 and 3,06,944 in 2021-22.

Uttar Pradesh accounted for the highest number of deletions (2.96.464) on account of job cards being fake in 2022-23. In 2021-22, 67,937 fake job cards were deleted in the state.

other question, Jyoti informed the Lok Sabha that 6,47,8345 new job cards were issued in 2022-23. "In 2021-22, 1,20,63,967 new job cards were issued, while in 2020-21, the year that saw COVID-19-induced lockdown, 1,91,05,369 new job cards were issued," the MoS said.

According to a reply given by Rural Development Minister Giriraj Singh in the Lok Sabha during the Monsoon Session, job cards entailing over 5.18 crore workers were deleted in 2022-23, which was an increase of 247.06 per cent compared to 2021-22, when the figure stood at more than 1.49 crore. Jobs cards are deleted for various reasons, including these being fake or duplicate and when a beneficiary move out of a panchayat area or dies.

## **'Restrict missile testing** during turtle nesting'

New York, Dec 9: A team of US engineers, led by one of an Indian-origin, has developed a robotic replica of the heart's right ventricle, which mimics the beating and blood-pumping action of live hearts.

The realistic model developed by a team at Massachusetts Institute of Technology (MIT) can aid the development of better heart implants and shed light on understudied heart disor-

The right ventricle is one of the heart's four chambers, along with the left ventricle and the left and right atria. Of the four chambers, the left ventricle is the

journal Nature Cardiovascular Research, the team described a model that includes real heart tissue, explanted from a pig's right ventricle which was treated. The team then fit a silicone wrapping around it, which acted as a soft, synthetic myocardium, or muscular lining.

Within this lining, the team embedded several long, balloonlike tubes, which encircled the real heart tissue, in positions that the team determined through computational modelling to be optimal for reproducing the ventricle's contractions.

The researchers connected each tube to a control system, which they then set to inflate and deflate each tube at rates that mimicked the heart's real rhythm and motion.

"Conventional tools often fail to capture the intricate mechanics and dynamics of the right ventricle, leading to potential misdiagnoses and inadequate treatment strategies,<sup>3</sup> Singh said.

The artificial ventricle can be tuned to mimic healthy and diseased states. The team manipulated the model to simulate conditions of right ventricular dysfunction, including pulmonary hypertension and myocardial infarction. They also used the model to test cardiac devices.

Bhubaneswar, Dec 9: The state government has urged the DRDO to restrict missile testing off the Odisha coast in February and March -- the mass nesting season of the endangered Olive Ridley sea turtles, an official said Saturday.

The Defence Research and Development Organisation (DRDO) has two major missile testing ranges in the state - Chandipur in Balasore district and the APJ Abdul Kalam Island, formerly Wheeler Island, in Bhadrak district, he said.

"It is an annual practice to request the DRDO to restrict testing during this time as these locations are close to the famed Gahirmatha sanctuary, which is considered the cradle of Olive Ridley turtles,' the senior official of the state Forest department said. The DRDO adheres to the state's request every year, he said.

At a meeting chaired by Chief Secretary PK Jena December 7, it was also decided to request the DRDO to appoint a nodal officer who will coordinate with the Fisheries department for protecting the turtles.

Lakhs of Olive Ridley turtles visit the state's coast every year for mating and laying eggs. While mating starts in January, the mass nesting begins in February at Gahirmatha beach in Kendrapara district, Rushikulya beach in Ganjam and the confluence of the Devi river and Bay of Bengal in Puri district.

These turtles are sensitive and it is feared that missile testing might have an adverse impact on their mating and mass nesting, the official said.

During the last season, a record 6.56 lakh turtles had laid eggs at Rushikulya rookery and 5.12 lakh turtles turned up for mass nesting at Gahirmatha beach, he said.

# SC debars defaulter mining firms from tender process

Keonjhar, Dec 9: The Supreme Court has debarred the mining firms from participating in tender processes until and unless they clear their outstanding penalties, a report said Saturday Acting on the order. Soudamini

Sethy, additional secretary of Steel and Mines department, issued a letter-9937, dated October

3, 2023 to the Director of Mines. The apex court passed the order August 14 this year while hearing a writ petition filed by a social outfit 'Common Cause' against the Union government and others. The letter follows this order of the apex court.

Many mining firms are al leged to have extracted minerals beyond the permissible limits and transported those to various destinations without having environmental clearance. As a result. roads in the mining areas and elsewhere in Keonjhar district have been severely damaged. Excessive mining has also resulted in air and water pollution and severely contaminated

After large scale protests ensued, the Supreme Court intervened in the matter. It formed a commission under Justice MB Shah and directed to probe the matter and submit a report before it. During its probe, the

Shah Commission found out how various mining firms have mined minerals in complete violation of norms. These firms were found to have extracted minerals in excess sans environmental clearance. The owners and lessees raked in the mullah by transporting the minerals

to various destinations The commission also found out how firms extracted and transported minerals by violating mineral concession rules,

while another firm had earned big bucks by engaging in other mining works. In his report, Justice Shah also pointed out that lack of proper disposal of waste in the mines has resulted in environmental pollution adversely impacting common people in the mineral bearing district.

He directed to make an assessment of environmental pollution arising out of excess mining and decided to impose penalty on the mining firms. While some firms paid the penalty, others dilly-dallied in payment of fines. As a result, the state government filed certificate cases against the defaulting firms and launched process to confiscate their properties.

Some of the defaulting firms paid their fine when the matter was sub-judice in the court while rest of the defaulting firms went on buying time on various pretexts and filed cases in the tri-

bunals and courts. Meanwhile, the state government has failed to attach the properties of defaulting firms as the certificate cases are pending in the court. This has proved a blessing in disguise for the defaulting firms as they continue

to buy time. A social activist Mukhtar Ahmed said that it is unfortunate how the defaulting firms have managed to approach other judicial forums when the Supreme Court has directed to collect penalty from them. Observers have demanded not to further assign lease of any mine to the tainted firms or individuals involved in mining scam.

# **NHRC summons Keonjhar Collector**

Keonjhar, Dec 9: The National Human Rights Commission (NHRC) has issued summons to the District Collector, Keonjhar directing him to personally appear before it January 19, 2024 over delay in submission of report regarding allotment of houses under Central and state schemes to members of scheduled caste and scheduled tribe communities in Hatadihi block

This was stated here by human rights activist and senior advocate of Supreme Court Radhakanta Tripathy to mediapersons, Saturday,

The commission pulled up the lackadaisical attitude of the Collector in submission of replies and his own contradictions in verbal submissions and written

During the hearing, the District Collector verbally submitted that case no-464/18/7/2023, was related to 140 households, out of which 45 beneficiaries had been granted the benefit of PMAY and another 45 in rural housing waiting list (RHWL). Tripathy countered him stating the latches in the verbal and written submission by the Collector

The NHRC directed the District Collector to submit a detailed re port mentioning the details of the beneficiaries and the benefit granted to them, within four weeks for perusal of the commission.

Later, in a hearing August 18 this year, the NHRC had directed the Collector for submission of a report clarifying the contradiction in the written reports and verbal submission within four weeks. However, no report had been re ceived from the authority.

Later, the NHRC issued summons exercising its coercive power under the Protection of Human Rights Act, 1993. The NHRC also marked a copy of the order to the Chief Secretary of the state for information.

When contacted, the Collector said that he has already submitted all the information. The commission required more information that we will submit soon, he added.

# Pre-activated SIM biz busted; 1 held

Basudevpur, Dec 9: Police here have busted an illegal pre-activated SIM card business and arrested a person under this police limit in this connection, Friday.

The accused was identified as Bidyadhar Sahu from Bhagapur village under Aruha panchayat and Basudevpur block in Bhadrak district. According to the reports, Bidyadhar was a wholesaler of SIM cards and used to sell those to various retailers. He was involved in activating SIM cards illegally by using IDs and biometrics of customers multiple times to achieve his sales target set by the service providers.

The incident came to the fore after the Ministry of Telecommunications, flagged concern about a duplicate SIM card activation racket in Odisha, and updated the same to the state Crime Branch.

As per the instruction of Bhadrak SP Varun Guntupalli, a case (720/23) was registered at Basudevpur police station and an investigation launched in this regard.

Police then arrested the accused and seized pre-activated SIMs from his possession.

# Blind to Condition

ast week, I wrote about South Asia remaining poor compared to nations in Asia, which have done something different from ⊿us. The task is to figure out what we are doing wrong or differently and what is undeniably different about us and them. It cannot only be, as is argued, that it is the form of economic system that is to blame. We have tried managing the economy through central planning (India in the 1950s and 1960s), through license raj (India through to the 1980s), through 'liberalisation' (Pakistan beginning in the 1960s and India from 1991). We have returned to the same things we were doing before (import substitution in India in the 1970s and today). We have had some success and created sectors where we are leaders (India for a quarter century or so in information technology enabled services and Bangladesh today in garments).

It cannot be that we do not have, or have not tried to have, hard power. We have developed nuclear weapons, we have spent large sums on our militaries. Pakistan sends 17% of all government spending to the army, India and Bangladesh send 9%. We have tried to be strong — the misguided word used here is 'muscular', and run large parts of the subcontinent through the military (Kashmir and the North East in

India, Balochistan in Pakistan). We have tried to remain defiant. We have joined Western alliances (Pakistan in the 1960s), we have remained non-aligned (India in the 1950s) and we have tried a patchwork of things in between.

But the end result is the numbers we looked at in the previous column. The world's GDP per capita per year is an average of \$12,262. China is slightly ahead of the world average and Bangladesh, India and Pakistan are one fifth. We were five times less than the global average in 1960 also, when the globe was at \$459 and India at \$82. Note that this is per person income and of the world's 7.7 billion people, South Asia contributes a full 23%. Meaning we are a drag on the world's economy and productivity and have been for 60 years, at more or less the same rate.

There must be something we are miss ing. What is it? The World Bank says that intra-regional trade between Bangladesh. India and Pakistan accounts for 5% of our total trade, compared to South East Asia where the number is five times higher. Trade annually here is \$23 billion though it should really be over \$100 billion. Why? The problem is purely

man-made. The World Bank says that "border challenges mean it is about 20 percent cheaper for a company in India to trade with Brazil instead of a neighbouring South Asian country" and that the main problem is "a broad trust deficit throughout the region.

It adds that South Asia is "one of the least integrated regions in the world in terms of trade and people-to-people contact. Putting aside traditional concerns and taking joint action can develop cross-border solutions to shared issues, strengthen regional institutions, improve infrastructure and connectivity, and advance trade policy."

Why should it take outsiders to tell us what is obvious? But unfortunately it does. The World Bank adds that regional cooperation has the potential to produce significant gains across all countries of South Asia because the gap in trade is \$44 billion annually. We have the space to reduce the 50% higher cost for container shipments in South Asia compared to developed nations. But it can happen only if we are less hostile and more open to each other than we are and have been. This is the one thing we have not tried. We have not opened ourselves to each other and returned to the sort of geography and economy that we had before 1947. Indeed, we have not devolved internally power from the Union to the states and further along either.

In his book 'The 10 rules of successful nations' Ruchir Sharma writes

mid record heatwayes. intensifying and costly extreme weather events, and increasingly dire warnings that climate change is literally killing us, calls to abandon fossil fuels grow louder. But the fossil-fuel industry is doubling down with investments in new oil and gas projects and major corporate mergers, walking back climate pledges, and making false promises that they can keep pumping without polluting. We need to ditch fossil fuels. But how?

The answer is unlikely to emerge from this year's petrostate-hosted United Nations **Climate Change Conference** (COP28) in Dubai, which could deliver a political commitment to phase out fossil fuels but won't chart the pathway to a fossil-free future. To address what UN Secretary-General António Guterres has called "the poisoned root of the climate crisis," we must look beyond the UN Framework Convention on Climate Change (UNFCCC) to forge new forums fit for this purpose.

The good news is that the Guterres, the pope, numerous national governments, and bodies like the International Energy Agency have joined the growing global call for a phaseout of coal, oil, and gas. At the UN Climate Ambition Summit in September, governments acknowledged that the climate crisis is a fossil-fuel crisis. The question is not whether to move beyond oil and gas, but how.

The bad news is that the fossil-fuel industry, buoyed by record-breaking profits in the wake of Russia's invasion of Ukraine, seems impervious to such pressure. Worse, these colossal profits are being reinvested in more oil and gas development. As climate disasters intensify before our eyes, the industry responsible for nearly 90% of carbon dioxide emissions is betting that its dirty products will be a mainstay of the global economy for decades to come

To force a change, we must expose the economic fragility that

fossil-fuel dependence creates and its broader toll on human rights. Reliance on oil, gas, and coal makes communities more vulnerable to supply disruptions, affecting everything from heating and transportation to food prices. Such disruptions fall hardest on the most impoverished populations while boosting the industry's profits. It is worth recalling that fos-

sil-fuel companies underperformed the market for the ten vears preceding the war in Ukraine. That decade of decline reflected long-term energy-transition trends that the recent uptick in earnings has not changed. With fossil-fuel demand projected to peak globally by 2030, oil and gas remain a bad bet.

Part of the problem is that governments have responded to price volatility by increasing fossil-fuel subsidies, rather than imposing windfall taxes. They also have continued to approve new oil and gas projects, including offshore in protected ocean areas. Planned production is double what's compatible with the target of limiting global warming to 1.5° Celsius above pre-industrial levels; there is simply no room for new oil and gas supply if the world is to avoid climate catastrophe.

Fossil fuels appear competitive with ever-cheaper renewables only because their production has been subsidised and their producers insulated from the costs associated with the damage they cause. The industry's negative externalities, long borne by frontline communities, are now being imposed on people around the world in the form of wildfires, hurricanes, floods, and droughts. If we compelled fossil-fuel companies to shoulder the losses they long saw coming, and redirected public funds to renewable solutions, oil and gas assets would be exposed as the liabilities they are.

This points to another big problem: corporate capture. Although climate litigation is key to holding the industry accountable, the challenge is not just to make polluters pay for the harms they cause. We also must diminish their outsize influence on climate policy. Despite the best efforts of movements like Kick Big Polluters Out, the fossil-fuel industry not only has a seat at this year's climate talks; it is at the head of the table.

There sits Sultan Al Jaber, the CEO of the United Arab Emirates' national oil company, which is currently pursuing its own expansion plans. Al Jaber, COP28 president, is intent on portraying the fossil-fuel industry as the hero, not the villain, in the fight against climate change. Yet this is a well-known survival strategy for an industry in long-term decline. So, too, is the UAE's advocacy of an "all of the above" approach that promotes renewables as a comple-

ment to fossil fuels, rather than a replacement for them, and that champions carbon capture and offsets, despite abundant evidence that neither leads to significant emissions reductions Contrary to what Al Jaber suggested earlier this year, the problem is not just with fossil-fuel emissions; it is with fossil fuels themselves. Focusing only on carbon ignores all the other negative effects of fossil fuels, including their impact on health, such as the eight million premature deaths from air pollution annually.

Though fossil fuels are overwhelmingly to blame for climate change, our UNFCCC-led climate regime has failed to address them, even before the industry was handed the gavel. For decades, the international body that should be leading the fossil-fuel phaseout has conspicuously avoided the issue. Neither the 1992 UN Climate Convention nor the 2015 Paris climate agreement mentions oil, gas, or coal.

This omission was not some casual oversight. It is a symptom of a deeper crisis in global climate governance. Because UN-FCCC decisions require a consensus among 198 members, powerful countries can block progress and assure lowest-common-denominator outcomes, or none at all. COP28 further underscores the need for alternative processes to manage the decline of fossil fuels, free from the influence of those who profit from them. Every day provides new reminders of why we need to phase out oil, gas, and coal. Fortunately, initiatives like the Fossil Fuel Non-Proliferation Treaty, the Beyond Oil and Gas Alliance, and the Global Parliamentarians' Inquiry offer new ideas about how to do it. Governments must commit to a forum dedicated to fossil-fuel phaseout so the real work of ending the fossil-fuel era can begin

that "among the largest emerging nations, trade amounts to 60% of GDP on average, and countries well above that average tend to be major export manufacturers, led by the Czech Republic (142), Vietnam (210), Malaysia (131), and Thailand (117)." He adds something that will not surprise us: "Meanwhile, South Asia remains fenced off. Isolation, lawlessness, and the lingering bitterness produced by regional wars have made it difficult for India, Pakistan, Bangladesh, and Sri Lanka to open borders, and so far, no leader has stepped forward to ease hostilities.

India's trade to GDP has in fact fallen from 58% of GDP in 2014 to 44% today, with Pakistan at 30% and Bangladesh at 28%

Is it possible that we can open ourselves to each other? If so, in what realistic way, given all the difficulties and ingrained historical resistance? And if achieved, what are the effects this can have on our societies? I do not know if by doing this we can repeat what Taiwan and Japan and South Korea did, but I do know that it removes the one restraint that we have deliberately put on ourselves and can eliminate ourselves. The fact that it is not even discussed widely today in the region, despite all three states being democracies, tells us something about how blind we have become to our condition. And how satisfied and unambitious our political parties are with the way things continue to remain in the South Asia as we enter the second quarter of the 21st century. he Electoral Bond Scheme (EBS) was introduced as a money bill in Budget 2017-18, with the ostensible objective of cleansing the system of political funding. It has been challenged by civil society organisations like ADR as opaque with serious implications for conducting free and fair elections. After prevaricating for over five years, during which time 29 tranches of electoral bonds have been funded by anonymous corporates, the Supreme Court is expected to give its verdict on the validity of this opaque process. The Solicitor General has argued that the donor's privacy trumps over right to know of a voter and that 'more contribution going to party in power is the norm'. Such outlandish arguments fly in the face of a liberal democracy which puts a premium on transparent conduct of public affairs, effective opposition to majoritarian trends and accountability to citizenry and constitutional morality.

Apart from fraudulent misuse of money bill provision, the EBS has scheme has arm twisted every possible act and provision to run its course. Section 29C of the

RPOP Act has been amended so that the candidates do not have to render a statement of funds received under EBS to the ECI Section 13A of IT Act 1961 was amended exempting candidates from keeping account of money received through EBS. It also removes the cap of 7.5% of average of net profit during the last three years. The FCRA (2010) has been amended allowing foreign companies to provide funds even if their share in the Indian company exceeds 50%. In a nutshell, the entire scheme was legally firewalled to be unlimited, unaccounted, and unidentified political funding by the corporates!

The major trigger came for this when the government promulgated the Right to Information Act. It may be recalled that the SC came out of its cocoon of orthodoxy and examining the procedural aspects only to the importance of an open government that is responsible and accountable to its citizens in the SP Gupta Vs UoI case (1981). It served as a milestone for a spate of PIL which were filed by civil society watchdog organisations like PUCL, ADR & Common Cause. By keeping

the information regarding donations received by political parties from corporates by the citizenry, the EBS clearly goes against the fundamental pillar of democracy -- freedom of speech and expression under Article 19(1). The most definitive ruling in the context of election was given in ADR Vs UoI (2002) when it made it mandatory for candidates to reveal their fi nancial and criminal antecedents. The court also struck down S33A & 33B of the RPOP Act which tried to ban providing information. In PUCL vs UoI (2003) the court decreed that the State is under obligation to create conditions so that rights under Art 19(1)(a). like the right to receive information, can be effectively enjoyed by citizens.

Democracy envisages conducting free and fair elections and the right to information is a basic feature of democracy. The present EBS is a retrograde measure that legitimises crony capitalism, militates against transparency, incentivises corrupt practices, and bolsters the nexus between politicians and big business. Recourse to a money bill for amending the law to relate electoral funding to pre-empt a debate in the Raiva Sabha has subverted the legislative scheme. As things stand the present scheme has not only emasculated the authority of the ECI but also impaired its ability to conduct free and fair elections by not providing a level playing field to all political parties. It has also constrained its powers of supervising funds of parties.

When the 29th tranche was released in November 4 on the eve of election to five assemblies, it was widely believed that it will benefit the BJP immensely. This has proved to be prophetic. Now that the general election is due in five months' time, the SC should rise to the occasion and establish credibility of an independent institution and bust the contemptible contention that privacy of a corporate donor will override right to informed voting. Jurist Fali Nariman wrote in his eminently readable autobiography Before Memory Fades: "Judiciary is like oxygen in the air. It is not enough that the judges are independent of executive. They must have courage." That moment of reckoning for the SC has come in the EBS petition.

### Cautious approach

This move bears testimony to India's impressive show as the world's fastest-growing major economy. With the manufacturing sector back on track, Indian economy will hopefully remain resilient amid global headwinds. Robust growth can also help it withstand inflationary pressures more effectively.

# **Controversy around T'gana CM's residence**

For then-ruling BRS, Pragathi Bhavan symbolised the development and pride of Telangana while for Congress and other opposition parties it was a sign of "autocratic" rule

Hyderabad, Dec 9: Ever since the Congress government assumed office in Telangana Thursday, the Chief Minister's official residence at Begumpet in the heart of the city has been the centre of action

From dismantling of the iron fencing in front of the premises to change of its name, conduct of Praja Darbar and entry of curious citizens to smudging the name of former Chief Minister K Chandrasekhar Rao on the inauguration plaque, the events of the last two days reflect the change of guard.

Day after taking oath, Chief Minister A Revanth Reddy made his first visit to Pragathi Bhavan, which had been a key point of contention between ruling and opposition parties for the last seven years

Still residing at his personal residence in Jubilee Hills, Revanth Reddy stayed at the official residence for an hour, receiving representations from citizens who had turned up for Praja Darbar.

Till December 3, when the results of Assembly elections were announced, Pragathi Bhavan was the hub of power. For thenruling BRS, it symbolised the development and pride of Telangana while for Congress and other opposition parties it was a sign of "autocratic" rule. They often used to describe it as a fort or a palace which is out of bounds for citizens.

No wonder that immediately after coming to power, Revanth Reddy renamed Pragathi Bhavan as Jyothirao Phule Praja Bhavan.

After taking oath as the Chief Minister December 7, he had declared that Praja Darbar will be held there the next day.

He had also mentioned in the speech at the swearing-in ceremony that soon after taking over the Congress government dismantled the iron fencing at Pragathi Bhavan to give people unrestricted access to the place. The authorities used bulldozers and gas cutters to remove

the huge iron fencing which had eaten away a part of the busy road and was seen as a hurdle in free flow of vehicular traffic. Hundreds of people had

queued up at the Chief Minister's official residence since Friday morning for Praja Darbar and submitted their representations on their problems to the Chief Minister.



Some of them, who could get a chance to meet him, said till a day ago they could not have even imagined entering the premises. However, many people who were waiting in queues since early

morning and those who came later, had to return disappointed. With the dismantling of iron fencing and by holding Praja

Darbar, Revanth Reddy has tried to make a strong statement. In February, BRS leaders had lodged police complaints against Revanth Reddy for allegedly call-

ing on the Maoists to blow up the Pragathi Bhavan. The state Congress chief had made the controversial remarks while addressing the gathering in Maoistaffected parts of Mulugu district during his 'Hath se Haath Jodo' padayatra.

"Like the Navalites had set blasts in the forts earlier, what if they blast Pragathi Bhavan with dynamite? Pragathi Bhavan is like a fort, there is no entry for the poor," he had said.

When the gates of Praja Bhavan were opened for people Friday, there were many curious citizens taking selfies or sitting in the open spaces.

Dramatic scenes were witnessed at the building, which was the hub of power and a high security place till a couple of days ago. A Congress supporter smudged KCR's name on the inauguration plaque.

The campus was inaugurated November 24, 2016 during the first term of the BRS. There have been many controversies surrounding its construction. It was in 2004 that then Chief

Minister of undivided Andhra Pradesh YS Rajasekhara Reddy (YSR) had built a CM camp office at a cost of Rs 810 crore.

After KCR became the first Chief Minister of newly-created Telangana, he did not occupy the CM camp office on the advice of Vaastu experts. It was considered "inauspicious" as YSR had reportedly moved in without

performing rituals and he had died in a helicopter crash in 2009, a few months after leading Congress back to power for a second term.

His successor K Rosaiah had to resign on health grounds while N Kiran Kumar Reddy, the last Chief Minister of undivided Andhra Pradesh, had to face a crisis leading to bifurcation of the state.

KCR moved in only after a completely new complex was built. KCR and his wife Shobha Rao had participated in elaborate rituals for Gruhapravesham (housewarming) performed by his spiritual guru, Chinna Jeeyar Swamy.

Since then, KCR had been under attack from opposition for his alleged superstitious beliefs and huge public money spent on constructing the palatial complex, at cost of hundreds of crores and which was of no use to people. They targeted him for remaining confined to four walls and denying people access to it.

KCR, however, had defended building Pragathi Bhavan saying it is a public property and will serve as the official residence of Chief Ministers who occupy the post after him. The government has been spending Rs 1 crore every year on its maintenance.

After losing power, KCR and his family quietly left the premises but it is still not known if Revanth Reddy will shift there with his family or use the facility only as an office.

# Sarma, Saikia flay Sibal over Myanmar remark

Myanmar. It is true that people from there (Myanmar) had clashed with our people during Ahom rule. And for a brief period of around one-two months, we were under an occupation-like situation of Myanmar," the chief minister said.

Saikia, in a letter to Sibal Saturday, claimed that this incorrect representation of Assam history is very unfortunate and it has hurt the pride and prestige of Assam.

It seems the Jamiat Ulema-e-Hind and AAMSU might have provided you with incorrect information about Assam history and your team has failed to cross check the data before presentation, he said.

The Congress leader said the history of Assam is that of a confluence of the Austroasiatic, Tibeto-Burman (Sino-Tibetan), Tai and Indo-Aryan cultures.

Assam was ruled by the Ahom for six centuries and though invaded over time, it was never a vassal or a colony to an external power until the third Burmese invasion in 1821, and subsequently the British ingress into Assam in 1824 during the First Anglo-Burmese War, he said.

Saikia has urged Sibal to withdraw the statement and render a public apology before the public of Assam for mis-representation of Assam's glorious history.

"Pursuing the path of violent jihad (holy war), Khilafat, ISIS etc., the accused had aimed to disturb the peace and communal harmony of the country and to wage a war against the Government of India," the spokesperson said. The official said initial investigations have revealed that the arrested accused had self-declared the village of Padgha in rural Thane as a "liberated zone" and as "Al Sham".

They were motivating impressionable Muslim youths to relocate from their place of residence for strengthening the Padgha base, the spokesperson said. The official said Saqib Nachan, the main accused and the leader of the ISIS module, was also administering 'bayath' (oath of allegiance to the Khalifa of ISIS) to the persons joining the proscribed organisation.

The ISIS has been spreading its terror network in India by putting in place localised ISIS modules and cells in various states of the country, the spokesperson said.

## Mamata seeks meet with PM over GST dues

Kolkata. Dec 9: West Bengal Chief Minister Mamata Banerjee Saturday said she has sought an audience with Prime Minister Narendra Modi to press the demands for the financial dues which the Centre owes to the state.

Banerjee told reporters at Bagdogra near Siliguri in north Bengal that she will be visiting the national capital and sought an appointment in any of the three days between December 18 and 20.

"I will go to Delhi accompanied by few MPs of the party this month and have sought an audience with the prime minister to press for the state's dues which the Centre owes to us," she said."I have sought an appointment with the prime minister in any of the days on 18, 19 and 20th of this month," she added.

Banerjee alleged that the Centre is collecting GST from the state but "not sharing" the proceeds. "Many of the funds which the state is eligible for getting under various central schemes like MGNREGA are also not forthcoming. The state is being deprived of its financial dues from the Centre," the Chief Minister said.

# **BSP** suspends Danish for 'anti-party' activities

Muslim woman beaten up for voting for BJP

Sehore/ Bhopal, Dec 9: A 30year-old Muslim woman has claimed that she was beaten up by her brother-in-law for voting in favour of BJP in Madhya Pradesh assembly polls and celebrating the party victory, an incident prompting chief minister Shivraj Singh Chouhan to reach out to the victim.

nal has found. Researchers found that the symptom of experiencing pain during sexual intercourse, or dyspareunia, affected more than a third of such postpartum women (35 per cent), while 32 per cent of these women experienced low back pain.

Other symptoms affecting postnatal women included involuntary urination (8-31 per cent), anxiety (9-24 per cent), depression (11-17 per cent) and perineal pain (11 per cent), which refers to pain in the general re-

gion between the anus and the genital organs, the international team of researchers including those from the World Health Organization (WHO) said in their study.

Their study showed that a high burden of postnatal conditions persisted in the months or even years after giving birth. However, many of these occur beyond the point where women typically have access to postnatal services.

The authors thus called for a greater recognition within the healthcare system of these common problems. Effective care throughout pregnancy and childbirth is also a critical preventive factor to detect risks and avert complications that can lead to lasting health issues after birth, they said.



During a literature review spanning the last 12 years, the authors identified no recent high-quality guidelines to support effective treatment for 40 per cent of the 32 priority conditions analysed in their study, and found not a single high-quality guideline from a low-or middle-income country. Even in countries where re-

sources are channelled to meet the global targets for the 2030 Sustainable Development Goals (SDGs) agenda, these long-term conditions are often overlooked, they said. Further, they added that data gaps were significant, as there were no nationally representative or global studies for any of the conditions identified through the research.

"Many postpartum conditions cause considerable suffering in women's daily life long after birth, both emotionally and physically, and yet they are largely underappreciated, underrecognized, and underreported," said Dr Pascale Allotey, Director of Sexual and Reproductive Health and Research at WHO.

"Throughout their lives, and beyond motherhood, women need access to a range of services from health-care providers who listen to their concerns and meet their needs - so they not only survive childbirth but can enjoy good health and quality of life," said Allotey. The study is one of the four forming The Lancet Series titled "Maternal health in the perinatal period and beyond", which calls for greater attention to the long-term health of womenand girls - after and also be-

fore pregnancy.



The situation can be worse in many low-income and middle-income countries (LMICs), particularly those with a persist-

ently high burden of maternal mortality, than in high-income countries (HICs), the researchers said in their study.

## Pak admits link between some political dissidents, terrorists

Pakistan has acknowledged that some of the political dissidents, who have sought asylum in the United Kingdom and other countries, had links with terrorist entities inside the country. When asked about the incident, the Foreign Office spokesperson rejected any insinuations of Pakistan's involvement and that of Pakistani agencies in the attack, saying it is not "our policy to target our own nationals abroad." She, how ever, said that many political dissidents have sought political asylum and have been living in the UK and other countries around the world for several decades. "Many of them have had links with terrorist entities inside Pakistan." she said. She asserted that Pakistan has not engaged in any extra-territorial attacks against such individuals.

**UKRAINE CONDEMNS RUSSIAN POLL PLANS** FOR OCCUPIED AREA

Kyiv, Dec 9: Ukraine Saturday strongly condemned Russian plans to hold presidential elections next spring on occupied territory, declaring them "null and void" and pledging to prosecute any observers sent to monitor them



Russia's upper house set the country's presidential election this week for next March, and chairwoman Valentina Matviyenko said residents in four occupied Ukrainian regions would be able to vote for the first time.

Russia claims to have annexed the Donetsk. Luhansk. Zaporizhzhya and Kherson regions in the east and south of Ukraine during referenda last year dismissed by Kyiv and the West as a sham, but does not fully control any of them.

It also seized the Black Sea peninsula of Crimea from Ukraine in 2014.

"We call on the international community to resolutely condemn Russia's intention to hold presidential elections in the occupied Ukrainian territories, and to impose sanctions on those involved in their organization and conduct," Ukraine's foreign

ministry said in a statement. It also warned countries against sending observers to the "pseudo-elections", saying offenders would "face criminal responsibility"

"Any election in Russia has nothing to do with democracy. They serve only as a tool to keep the Russian regime in power," the ministry said.

Russian President Vladimir Putin said Friday he would run for president again, a move expected to keep him in power until at least 2030

# Philippines condemns China's actions in SCS

Manila, Dec 9: The Philippines condemned China's "illegal and aggressive actions" in the South

In a statement to Reuters, **OPEC** Secretary General Haitham Al Ghais declined to comment on the letter, but said OPEC wanted to keep the summit's focus on reducing climatewarming emissions, and away from their main sources like oil and gas.

It was the first time OPEC's Secretariat has intervened in the UN climate talks with such a letter. "It indicates a whiff of panic," said Alden Meyer of think-tank E3G.

## Blackout in Lanka

Colombo: Sri Lanka is experiencing a countrywide power outage due to a system failure, a government official said. Ceylon Electricity Board (CEB), the country's power monopoly, is working to restore power. CEB spokesperson Noel Privantha said as per news agency Reuters. In 2022, Sri Lankans faced 10-hour power cuts amid a deepening economic crisis that roiled markets. Toronto, Dec 9: The dream of making it big in Canada is turning into a battle for survival for many immigrants due to the high cost of living and rental shortages, as rising emigration numbers hints to newcomers being forced to turn their back on a country that they chose to make their adopted home.

Prime Minister Justin Trudeau has made immigration his main weapon to blunt Canada's big challenge of an aging and slowing population, and it has also helped fuel economic growth. That drove

Canada's population up at its fastest clip in more than six decades this year, Statistics Canada said.

But now a reversal of that trend is gradually taking hold. In the first six months of 2023 some 42,000 individuals departed Canada, adding to 93,818 people who left in 2022 and 85,927 exits in 2021, official data show.

The rate of immigrants leaving Canada hit a two-decade high in 2019, according to a recent report from the Institute for Canadian Citizenship (ICC), an immigration advocacy group. While the numbers went down during pandemic lockdowns,



Canada cost of living crisis fuels reverse immigration

Statistics Canada data shows it is once again rising.

While that is a fraction of the 263,000 who came to the country over the same period, a steady rise in emigration is making some observers wary.

Reuters spoke with a half a dozen people who have either left the country or are preparing to do so, because of the high cost of living.

Cara, 25, who came to Canada in 2022 as a refugee from Hong Kong, now pays C\$650 (\$474) in monthly rent for a single-room basement apartment in Scarborough, north of Toronto, which is about 30% of her monthly take-home salary.

"I never realized that living in a Western country, you can only afford renting a room in the basement." she said. She declined to give her real name because she fled Hong Kong after participating in the 2019 protests triggered by a now-abandoned extradition bill.

Cara works three part-time jobs, making Ontario's minimum wage of C\$16.55 per

hour, and goes to an adult learning school to earn university credits.

"I almost use every single penny," she said, while in Hong Kong she was able to save about a third of her monthly salary.

To be sure, emigration as a percentage of Canada's overall population touched a high of 0.2% in the mid 1990s, and currently stands at about 0.09%, according to official government data.

While the numbers are small now, lawyers and immigration consultants warn that a pick-

up could cast a shroud over Canada's appeal as the one of the favoured destinations for newcomers.

"There's a real importance in creating positive experiences in those early years" so that people decide to stay, said Daniel Bernhard, CEO of ICC.

Immigrants blame the skyrocketing housing costs as the biggest reason for their decision to consider a new country.

On average in Canada about 60% of household income would be needed to cover home ownership costs, a figure that rises to about 98% for Vancouver and 80% for Toronto, RBC said in a September report.

Myo Maung, 55, migrated to Canada from Myanmar over three decades ago and made a successful career as a real estate agent and a restaurateur. But he plans to retire in a country like Thailand since he cannot see himself maintaining his -( living standard in Canada on his retirement income.

## **Office space** demand may fall

New Delhi: Demand for office space across six major cities is likely to decline 18-22 per cent this year on higher base effect and delays in decision making by corporates related to their expansion plans, according to CREDAI and CRE-Matrix. In their joint report, real estate developers' apex body CREDAI and data analytic firm CRE Matrix have estimated that the fresh leasing of Grade A premium office space stood at 55-57 million square feet in the 2023 calendar year. The data excludes renewals. The absorption of office space was 70 million square feet during 2022. # **Europe agrees landmark AI regulation deal**

EU moves toward becoming the first major world power to enact laws governing AI

Brussels/London/Stockholm Dec 9: Europe Friday reached a provisional deal on landmark European Union rules governing the use of artificial intelligence including governments' use of AI in biometric surveillance and how to regulate AI systems such as ChatGPT.

With the political agreement, the EU moves toward becoming the first major world power to enact laws governing AI. Friday's deal between EU countries and European Parliament members came after nearly 15 hours of negotiations that followed an almost 24-hour debate the previous

day. The two sides are set to hash out details in the coming days, which could change the shape of the final legislation.

"Europe has positioned itself as a pioneer, understanding the importance of its role as a global standard setter. This is yes, I believe, a historical day," European **Commissioner Thierry Breton** told a press conference.

The agreement bans cognitive behavioural manipulation, the untargeted scrapping of facial images from the internet or CCTV footage, social scoring and biometric categorisation systems to infer political, religious, philosophical beliefs, sexual orientation and race.

Consumers would have the right to launch complaints and receive meaningful explanations while fines for violations would range from 7.5 million euros (\$8.1 million) or 1.5% of turnover to 35 million euros or 7% of global turnover.

Business group DigitalEurope criticised the rules as yet another burden for companies, on top of other recent legislation.

"We have a deal but at what cost? We fully supported a riskbased approach based on the uses of AI, not the technology itself, but the last-minute attempt to regulate foundation models has turned this on its head," its Director General Cecilia Bonefeld-Dahl said

Privacy rights group European Digital Rights was equally critical

"It's hard to be excited about a law which has, for the first time in the EU, taken steps to legalise live public facial recognition across the bloc," its senior policy advisor Ella Jakubowska said.

'Whilst the Parliament fought hard to limit the damage, the overall package on biometric surveillance and profiling is at best lukewarm.'

The legislation is expected to enter into force early next year once both sides formally ratify it and should apply two years after that.

Governments around the world are seeking to balance the advantages of the technology which can engage in humanlike conversations, answer questions and write computer code, against the need to put guardrails in place.

**Europe's** ambitious AI rules come as companies like OpenAI, in which Microsoft is an investor, continue to discover new uses for their technology, triggering both plaudits and concerns. Google owner Alphabet Thursday launched a new AI model, Gemini, to rival OpenAI.

The EU law could become the blueprint for other governments and an alternative to the United States' light-touch approach and China's interim rules.

"In FY22, Zerodha's board passed a resolution approving a remuneration of up to ₹100 crore each to three of its directors," the report mentioned.

During FY23, the empl benefits cost for Zerodha surged 35.7 per cent to ₹623 crore from ₹459 crore in FY22. The company gave a total salary of ₹380 crore to employees including directors. The company is now valued at \$3.6 billion. Nikhil Kamath recently became India's youngest billionaire at the age of 37. According to Forbes' latest list of India's 100 richest people, brothers Nithin and Nikhil Kamath were ranked 40th among the country's wealthiest people, with a combined net worth of \$5.5 billion. The Kamath brothers founded Zerodha in 2010, which revolutionised zero-cost equity investing. Zerodha reported a revenue of ₹6,875 crore and a profit at ₹2,907 crore for the financial year 2022-23 (FY23), representing a 38.5 per cent and 39 per cent growth in revenue and profit, respectively, as compared to the previous financial year.

Association of India (HAI) projecting the hotel industry's direct contribution to India's GDP to reach USD 1 trillion by 2047, experts believe there will be a minimum of 25 per cent rise in the need for workforce, with the adjacent industries like travel, aviation, ticket booking, travel guides, and consultants to be increasingly in demand.

'The hotel industry's direct contribution to India's GDP reaching USD 1 trillion by 2047 is a significant milestone. This substantial growth will undoubtedly bolster job creation within the sector, providing employment to millions of individuals across diverse skill sets," HAI Vice President KB Kachru told PTI.

Kachru, who is also Chairman Emeritus & Principal Advisor, South Asia Radisson Hotel Group, further said following the pandemic, the hospitality sector has undergone a huge transformation, entirely re-



shaping the employment land-

scape. "We have witnessed a paradigm shift in how we operate, with more emphasis being put on adaptability, digital innovation, and a heightened focus on guest safety and well-being," he added

Expressing similar views, Chalet Hotels Chief Human Resources Officer (CHRO) Urvi Aradhya said, "Post-pandemic employment landscape in the

hospitality sector reflects a blend of technological integration, an increased emphasis on health and safety, a focus on local tourism, and a shift towards more flexible work arrangements." In terms of the expected hiring trend, recruitment agency Gi Group Vice President Sudeep Sen said, "With the world of work specific to the hospitality industry, along with allied ones, looking extremely bright, we are going to witness a minimum influx of 25 per cent increase in the need of workforce. He further said adjacent in-

dustries like travel, aviation, ticket booking, travel guides/consultants will be increasingly in demand and it is estimated that the increase will also be in the range of 15-18 per cent, depending on the seasonality of the travel destinations.

"There will be increasing de mand for digital content creators, social media managers, sustainability consultants for hotels and resorts, vegan — food & beverage specialists, spa & healthcare specialists," Sen added.Royal Orchid Hotels Chairman and Managing Director Chander K Baljee said there is a significant surge in domestic travel across India, leading to an increase in the availability of accommodations across various categories, including 3-, 4-, and 5-star establishments.

"With this expansion, there is also a corresponding addition to the workforce... We have proac-tively undertaken recruitment of fresh staff," he said.
