Biden not visiting India for R-Day celebrations

New Delhi: US President Joe Biden is not travelling to India next month to grace the Republic Day celebrations as the chief guest, and New Delhi is looking at holding the next Quad summit later next year instead of its earlier plan to host it in January, people familiar with the matter said Tuesday. In September, US Ambassador to India Eric Garcetti said PM Narendra Modi invited President Biden to be the Chief Guest for the Republic Day celebrations on January 26 next year. However, there was no official word from India on the invitation to Biden. It is learnt that Washington has already conveyed to New Delhi that Biden would not be able to visit India.

RS nod for Bill to regulate appointment of CEC, ECs

New Delhi, Dec 12: Rajya Sabha Tuesday passed a Bill to regulate the appointment and service terms of Chief Election Commissioner (CEC) and election commissioners (ECs) with key amendments like retaining their status at par with Supreme Court judges, upgrading the search committee and inserting a new clause to protect them from court cases while discharging their official duties.

While the Bill was passed by a voice vote, Opposition members alleged the proposed measure subjugates the poll authority to the Executive and violates the Constitution and later walked out of the House. They also alleged that it was an attempt to circumvent the Supreme Court order on the appointment of CEC and ECs.

When the Bill was introduced in the Upper House in August this year, opposition parties and some former CECs had objected to the members of the poll panel being equated to the Cabinet Secretary. They had claimed that the move would compromise the inde-

pendence of the institution.

At present, the CEC and fellow ECs enjoy the status of a judge of the Supreme Court. By bringing the amendment, the government has retained that status.

Replying to the debate, Law Minister Arjun Ram Meghwal said some amendments have been brought in for rectification in the structure of the search committee, which was earlier proposed to be under the chairmanship of the cabinet secretary.

Instead, it will be under the chairmanship of the law minister with two Union secretaries as members, he added.

He pointed out that under another amendment moved by him, the CEC and other commissioners shall be paid a salary that is equal to the salary of a judge of the Supreme Court. More P4

Unsafe Bhubaneswar

Bhubaneswar, Dec 12: In yet another instance of deteriorating law and order situation in the Capital City, unidentified burglars struck at five flats in one night at an apartment in Gadakana area, under Mancheshwar police limits here, before decamping with gold ornaments, cash and other valuables with impunity, in the wee hours of Tuesday. Police said the incident took

place at Spacetown apartment when the occupants of all flats were away. The flats are located in different wings of the five-block housing complex, police said. The burglars gained entry into the flats after breaking the door locks open. Interestingly, the watchman of the building complex was on duty when the incident occurred, police said, adding he is being questioned at present.

Sources said the miscreants are believed to have stuck between 1 am to 3 am. They locked the doors of other flats from outside in order to prevent any interference.

An official from the Mancheswar police station, who spoke on the condition of anonymity, said forensic teams are busy collecting evidence which might provide clues about the identity of the criminals.

Debasish Nayak, whose flat has been burgled, said he received a call from his neighbour at around 6.30 am, informing him about the burglary at his flat. "I was briefly present in my flat in the evening and went to

He said the manner in which the objects in the cupboards of the flat had been rummaged through, it seems many people were involved in the burglary. Another victim said he left the flat around 10 pm Monday as he was on nightshift at his office. Upon returning early in the morning, he found the flat burgled.

Residents alleged that developer and security personnel were the major conspirators in the incident. One of them said despite several requests to deploy an additional security guard, only one has been provided so far.

Nevertheless, the incident came barely hours after miscreants looted an ATM kiosk at a busy marketplace in Old Town area here, Sunday.

Meanwhile, a retired senior cop, expressing concerns about the incident, said, it highlights

inefficiency Commissionerate Police to prevent unabated house burglaries in the City. "Earlier, the incidents of burglary and theft used to be scarce inside gated communities such as flats. However, the Capital city is witnessing a spike in such cases now, with at least one case being reported every 5-7 days," he said, requesting not to be named.

Newborn rescued from borewell

Bhubaneswar/Sambalpur, **Dec 12:** A newborn girl, who was found stuck in an abandoned borewell in Sambalpur district, was rescued Tuesday night after an over five-hourlong operation, officials said.

The child was taken to a hospital in Sambalpur in an ambulance which was kept ready at Laripali village in Rengali area where the incident occurred. The baby has no claimant, police said.

It was not clear how the child got into the 20-foot deep borewell made of iron. Locals suspect that the infant might have been dumped there by someone.

Chief Minister Naveen Patnaik



expressed happiness over the rescue of the infant, wishing her a long life.

'The rescue operation started at 4 pm and it was completed at about 9.30 pm. First, the Sambalpur Fire Services personnel started it. Then ODRAF (Odisha Disaster Rapid Action Force) and other agencies joined," Sambalpur SP Mukesh Kumar

site said. The baby was alive and making movements when she was brought out – it was no less than a miracle, he said.

Director General, Fire Services, Dr Sudhansu Sarangi, said that a victim location camera, which was brought from Bhubaneswar in a special flight was lowered into the borewell to trace the location of the baby. "The camera helped us find a

place to cut the iron pipe to retrieve the baby from the borewell," he said.

Patnaik said, "It's a matter of great relief. I wish a long life for the baby. May God bless her. Jai Jagannath." He also congratulated the rescue teams.

Odisha SHGs key to food security during Covid

New Delhi, Dec 12: A government-backed women self-help group (SHG) program in Odisha was key to ensuring food security during the March Covid-19 lockdown, new research has found.

The research from the Alliance of Bioversity International and the International Center for Tropical Agriculture (CIAT), Italy, showed that these SHGs, called 'Veg on Wheels', were crucial to mitigating fractures in the fresh fruit and vegetable value chains during the lockdown.

These groups are known to be women-only rotating savings and credit associations with a long history in India.

The researchers said that the SHG system provided a 'third force' and model for rethinking and reengineering current development models by leveraging existing institutions and grass root networks to build resilience in food systems.

In March of 2020, the government announced a lockdown with just four hours of notice. The lockdown included a ban on the informal and traditional food outlets that 80 to 90 per cent of Indians relied on for their main source of

food, threatening their food security. The women in these SHGs procured fresh fruits and vegetables from farmers, hired transport, purchased more vegetables from



people in local and urban markets via truck, cart, or motorbike, explained Jonathan Mockshell. an agricultural economist and the first author of the study published in the journal World Development. They were meeting every night," said Thea Ritter, an agri-

cultural economist and second author of the study.

'There were women who were vegetable and fruit producers themselves or had close links with others outside the group; this helped because they were familiar with the supply chain," said Ritter.

Ritter added that some groups received government funding for training in areas like accounting, which some members would later use to start their own businesses.

The number of people in or at risk of acute food insecurity surged from 135 million across 53 countries before the Covid-19 pandemic, to 345 million across 79 countries in 2023, the researchers said quoting the World Food Programme Statistics.

The researchers said that two critical dimensions of food security came into play in the program they looked at - agency and sustainability/resilience.

"In terms of the value chain, agency means being able to sell your fruit and vegetables if you want to and having a say in policies and laws," said Ritter.

The researchers said that with over a billion members of such rotating credit and saving associations, especially in Africa and South Asia, the SHG model had global applications.



I-T dept winds up liquor unit raids

Bhubaneswar, Dec 12: The Income Tax (I-T) department Tuesday winded up its six-day search operation and left the country-liquor manufacturing unit in Bolangir district after recovering more than Rs 350 crore in unaccounted cash and about 3 kg gold, officials said.

As the raids were completed, the I-T team took two managers of the distillery located at Sudapada to an unknown location for interrogation, they said.

The company was owned by the family of Congress MP Dhiraj Prasad Sahu, a resident of Jharkhand.

The Odisha unit of the Congress, however, claimed that the party has no connection with the seizure of the huge unaccounted money, termed as the "highest-ever" haul in a single action by any probe agency in the country

Following a tip-off regarding tax evasion, the I-T department officials launched a search operation at six locations in Odisha December 6. More than 200 people including bank employees were engaged in the search and counting of the cash in Bolangir and Sambalpur.

The raids were conducted in



Bolangir, Titlagarh, Boudh, Rourkela, Sundargarh and Bhubaneswar. I-T department DG Sanjay Bahadur camped in Bhubaneswar to monitor the

Meanwhile, political parties intensified their protest and blamed each other over the I-T raids.

The opposition BJP's Mahila Morcha Tuesday held a demonstration in Bhubaneswar and burnt an effigy of Sahu. The party activists demanded a probe by the Central Bureau of Investigation (CBI) into his links with the liquor traders and seizure of cash.

The BJP alleged that the country liquor business and tax evasion have taken place in Odisha due to patronage of the state's BJD government.

Odisha Pradesh Congress Committee (OPCC) president Sarat Pattanayak claimed in a distillery located at Sudapada to an unknown location for interrogation

The company was owned by the family of Congress MP Dhiraj Prasad Sahu, a resident of Jharkhand

Bhubaneswar, Dec 12: Chilly weather conditions prevailed in parts of Odisha as mercury plummeted below 10 degrees Celsius mark Tuesday.

G Udayagiri in Kandhamal district recorded the lowest temperature in the state at 7.2 degrees Celsius, the Bhubaneswar Meteorological Centre said.

Keonjhar and Kirei in Sundargarh district recorded a temperature of 9.4 degrees Celsius, followed by Daringbadi (9.5) and Phulbani (10), both in Kandhamal district.

Angul in central Odisha registered a temperature of 10.6 degrees Celsius, followed by Sundargarh (11), Koraput (11.2) and Balasore and Rourkela at 11.3 degrees Celsius each, the weather office said.

The mercury dropped below 15 degrees Celsius in the twin cities of Bhubaneswar and Cuttack, which recorded night temperatures of 14.6 and 14.5 degrees Celsius respectively. The temperature in the state capital was 1.4 degrees below normal, the weatherman said.

In tribal areas in Kandhamal, Koraput, Sundargarh and Keonihar districts, people were seen sitting around bonfires to beat the cold.

This year, the arrival of cold weather conditions in the state was delayed from November to the first week of December due to the influence of cvclonic rain, a met department official said

After being released from jail, Nag went to a law college in Bhubaneswar to appear for her examination.

The honey trap case accused was arrested in October 2022 after three different cases were registered against her. Her husband Jagabandhu Chand, who was also arrested in the case, is on bail now

The sensational case had come to light when a woman filed a complaint against an Odia film producer, accusing him of sexually exploiting her. Following this complaint, some purportedly obscene pictures of the producer with the woman went viral on social media.

Later, the film producer also lodged another complaint before Nayapalli police station, alleging that Nag and the woman, who had filed the complaint against him, had made extortion demands of Rs 3 crore from him. Nag and her associates had allegedly extorted crores of rupees from affluent people by blackmailing them of releasing their intimate videos, captured by the accused after honey-trapping them.

Cases were registered against Nag with Nayapalli and Khandagiri police stations in Bhubaneswar in 2022. She was booked under sections of the Indian Penal Code (IPC) and Information Technology (IT) Act.

In the course of the police probe, the ED, alleging the commission of offences under Prevention of Money Laundering Act, 2002 (PMLA), instituted a complaint against Nag and seized a vehicle worth around Rs 40 lakh and a three-storey building with an approximate market value of Rs 3.6 crore.





The students were forced to walk the long distance thanks to the apathy of their headmistress, sources said Tuesday After the examination, they had to trek the same distance to return to their respective homes.

The incident has sparked sharp resentment among the guardians. They have demanded that the authorities conduct a high-level probe and take action against the erring headmistress.

Sources said that the Upendranath Ghosh Government High School at Baramail was designated as a centre for the panchayat-level mathematics examination. However, instead

of arranging any transport to take the girls to the examination centre, headmistress Bishnupriya Jena made 90 of them walk the entire distance.

It should be stated here that none of the girls were senior students. They were students of Classes IV, V and VI respectively. For them the 12-kilometre up and down trek was really painful,

but they had to undertake it in the absence of any other option.

Locals flayed the headmistress and made videos of the girls walking to the examination centre and returning home. They alleged that despite the school receiving funds under SIG grant, the 'callous' headmistress forced the girls to take such a painful step. They de-

Saffron party trying to portray picture of unity

Rourkela party unit turns active, organises demonstrations against liquor-related cash seizure

Rourkela, Dec 12: In the last couple of days, the Bharatiya Janata Party (BJP) here has become proactive. The Rourkela unit of the party is trying to portray a united front as it protests and organises demonstrations against the huge liquorrelated cash seizure in Bolangir, Boudh and Sundargarh.

At Biramitrpaur, MLA Shankar Oram, who had been almost dormant for the last five years, suddenly spurred into action Tuesday as he led a demonstration in front of the urban local body office.

"It is a good sign that the party took a united stance while demonstrating against the cash seizure. At least all the top leaders were together following the sarcastic rebuke by Union Minister Dharmendra Pradhan," said a political analyst here Tuesday.

In fact, during his visit here recently Pradhan had advised both Nihar Ray, the BJP candidate from the Rourkela constituency in 2019 and state spokesperson Dhiren Senapati. a ticket aspirant this time, to work together. The two are poles apart and the differences between them are no secret to the people here. The bitterness is so acute that they don't even talk politely or sit close to each other during meetings.

"Differences will be there but should not affect the party. We are all working for the BJP, so we



should put all our differences behind in the interest of the party," a BJP worker said.

Senapati meanwhile is trying to play down the differences between him and Ray. "This was a party programme and I must assure vou that BJP is never a divided house and it was reflected during the demonstration against the 'cash recovery'," Senapati said.

Hindalco plans battery foil unit at Sambalpur

COMPANY TO INVEST ₹800 CRORE IN FACILITY WHICH WILL BE COMMISSIONED BY JULY 2025

Mumbai, Dec 12: Aluminium producer Hindalco Industries announced Tuesday its plan to set up a battery foil manufacturing facility at Sambalpur at an investment of ₹800 crore to tap the fast-expanding electric vehicle market.



The facility to be commissioned by July 2025, will initially produce 25,000 tonne of the aluminium foil which forms the backbone of lithium-ion and sodium-ion cells, Hindalco Industries said in a statement. The company also plans to significantly expand its capacity of making fine-quality aluminium foil which is used in rechargeable batteries, it added.

"Hindalco Industries is investing ₹800 crore to build a new plant near Sambalpur in Odisha that will initially produce 25,000 tonne of the resilient product which forms the backbone of lithium-ion and sodium-ion cells," the statement said.

By 2030, demand for battery grade aluminium foil in India is expected to grow manifold to 40,000 tonne, primarily driven by mushrooming growth in gigafactories for advanced cell manufacturing, according to the company.

"We are seeing a fast traction in battery materials demand, driven by an impressive outlook for the electric vehicle and grid storage sectors. Raw material localisation is critical in such strategic sectors," said Satish Pai, managing director at Hindalco Industries.

'Hindalco is thus making various investments in battery materials and technologies towards building 'Atmanirbhar Bharat'. Investment in this new battery foil mill is another such step in this direction," added Pai.

Additionally, the company is working closely with original equipment manufacturers (OEM) to co-develop and make critical components like battery enclosures, motor housings, busbars, structural and safety components, and lightweight load bodies, many of which are being designed and developed for the first time in India, Hindalco said in the statement

The series of investments catalyse Hindalco's metamorphosis from a manufacturer of metal to a provider of hightech metal solutions, it said. This Sambalpur project will provide a thrust to the government's green initiative to reduce carbon emissions and build sustainable growth, the company added.

The factory in Sambalpur will be located alongside a 25-MW solar power plant, and can access additional solar energy from a 400-KV national grid connection. The unit will supplement the facility at Mouda, Hindalco said. The new unit in Odisha will further augment capability to supply material to gigafactories across the world, the company added.

Strategic Tool

The plight of Manipuri women stripped, brutally beaten and raped during one of the worst ethnic conflicts of recent times in north-east India has been pushed out of media headlines. What is hogging the limelight, instead, is the electoral success stories of the BJP beating main Opposition party - the Congress - hands down in state Assembly elections and brightening its chances of a hat-trick of winning the Lok Sabha elections a few months away. The violence heaped on the women of one ethnic group of Manipur by a section of the majority and ruling group is no isolated incident. Rape and different forms of abuse heaped on women are now recognised as a potent tool in ethnic conflicts and wars the world over.

The Indian government, in the case of Manipur, needs to wake up and act sincerely so as to rein in the perpetrators of violence on women and bring them to book. It is all the more necessary since the state government is known to have acted in a partisan manner shielding and aiding the culprits. United Nations special representative on the issue of conflict-related sexual violence Pramila Patten has, in her recent report, drawn attention of the powers that be across the world to this egregious crime against women. She has expressed concern that new waves of war's oldest, most silenced and least condemned crime of rape and gang rape by soldiers and ethnic groups have gone up alarmingly.

It is horrifying that women's bodies have become part of the terrain of conflict, according to a new report by Amnesty International. Rape and sexual abuse are not just a by-product of war, but are used as a deliberate military strategy, it says. War-mongers in previous centuries treated rape and plunder as war spoils, but it is being used in modern conflict as an orchestrated combat tool. Amnesty cites conflicts in Ukraine, Iran, Colombia, Iraq, Sudan, Chechnya, Bosnia and Afghanistan to demonstrate how rape has become a strategic weapon for perverted state powers and ethnic groups to intimidate adversaries. Tragedy is, even though wartime sexual violence can be curbed if commanders prohibit and prevent it, it is being widely used by warring parties and re-

Amnesty International in its latest report revealed Iranian security forces used rape and sexual violence against women, men and children as young as 12 years during nationwide protests last year. The UN heard graphic accounts of rape and other sexual violence, including the mutilation of women's genitals, in the 7 October attacks by Hamas in southern Israel. Some survivors of the music festival massacre testified to the crimes.

Similarly, UN experts have cited widespread reports of the paramilitary Rapid Support Forces systematically using rape and sexual violence "as tools to punish and terrorise communities" in the war in Sudan. A recent estimate suggested that about 100,000 women were raped or assaulted during the two-year civil war in Ethiopia's northern Tigray region, majority of victims being from the Tigrayan community.

A UN report on sexual violence in Ukraine described Russian soldiers targeting victims aged from four to 80. Patten said they were using rape as a "military strategy", though Russia denied the charges, brushing them aside as propaganda by Ukraine's Western allies.

Survivors of such rapes face emotional torment, psychological damage, physical injuries, disease, social ostracism and many other consequences that can devastate their lives. Women's lives and their bodies have become the unacknowledged casualties of war and ethnic conflicts for too long. The mayhem in Manipur has opened up raw wounds which will fester and rot unless and until the government at the Centre stops paying lip service to the humiliation of what authorities call "our daughters and sisters.'

- 1642: Dutch navigator Abel Tasman sighted South Island, New Zealand, and later, mistaking the strait north of the island for a bay, believed he had found the west coast of a hypothetical southern continent. Tasman reached the coast of South Island in New Zealand, and named it Staten Landt. Tasman was also the first European in recorded history to step foot on Tasmania, an island state in Australia. Tasman claimed the island for the Dutch crown. It is named after him as well.
- **1921:** The Four-Power Pact was signed during the Washington Conference by the United States, Great Britain, Japan, and France, stipulating that all the signatories would be consulted in the event of a controversy between two of them over "any Pacific question."
- 1937: The Japanese Imperial Army seized Nanjing, China, during the Sino-Japanese War, leading to the Nanjing Massacre, in which up to 300,000 Chinese may have been killed.
- **2001:** The Indian Parliament was attacked by terrorists. The attack was carried out by five armed assailants and has resulted in the deaths of six Delhi Police personnel, two Parliament Security Service personnel, and a gardener. All the five attackers were killed by security forces. Indian authorities accused Lashkar-e-Taiba (LeT) and Jaish-e-Mohammed (JeM) two militant groups operating from Pakistan - of perpetrating the attack. The incident led to increased tensions between India and Pakistan, resulting in the 2001-2002 India-Pakistan standoff.
- 2003: Iraqi President Saddam Hussein was captured by US forces during the Iraq War; three years later he was found guilty of crimes against humanity and was executed. Hussein, the fifth president of Iraq, was found hiding in a camouflaged hole in the ground and was captured by American forces near Tikrit, Iraq. The military operation that led to his capture was called Operation Red Dawn. He was subsequently handed over to the interim Iraqi government. After a trial where he was found guilty of crimes against humanity, he was executed in December 2006.

√he economic data for the second quarter i.e. the period from July till September was published by the government on November 30. These are called quick estimates of the national economic output. They are provided for two broad sets of output numbers, namely Gross Value Added (GVA) and Gross Domestic Product (GDP). The former is a measure of value added by each individual producer, or sector or industry to the economy. It is of course measured across all producers, be they farmers, small entrepreneurs or large companies. GVA thus measures the value added in converting inputs to outputs. GDP is the value of goods and services produced within a given period, which could be annual GDP or quarterly GDP. It is measured in three different ways. Either as value of all production, or of all expenditure or of all incomes. All three give the same result, since the total value of what is sold also represents income to those producing what is sold. The only difference between GVA and GDP is taxes paid or subsidies received. Usually, GDP always exceeds GVA since the government imposes net taxes whose collection is higher than the subsidies that it pays out.

The GDP for July to September period measured in current prices was Rs 72 lakh crore compared to Rs 66 lakh crore for the same period last year. GVA for the corresponding two quarters of this and previous year was Rs 64 and Rs 59 lakh crore respectively. At this quarterly rate, the annual GDP in current prices will likely reach Rs 300 lakh crore during this fiscal year. This would be three times, or 200% higher than what it was 10 years ago.

These same numbers for GDP and GVA need to be examined by removing the impact of rising prices. Since inflation for the past four years on average has been clocking close to 5% the expansion in GDP or GVA measured in current prices is not

the "real" picture as it has an "inflated" component. Removing the inflation effect the real growth of GDP is 7.6% during the second quarter, which is higher than last year's 6.2%.

This is quite heartening. If we take both quarters of this year together, GDP has expanded by 7.7% in real terms. At this rate GDP growth for the full year would definitely cross 7% and put India among the fastest growing large economies of the world. To achieve this at a time of turmoil caused by wars, inflation, supply chain disruptions, geopolitical tensions and uncertainty is a very impressive achievement.

Hence, we need to examine three things. Firstly, what is driving this GDP growth. Secondly, whether it is sustainable in the medium to long term. And thirdly how are the benefits of GDP growth translating as gains for different sections of people, their livelihoods, incomes and employment.

The answer to the first question is that government and investment spending has risen much faster than consumer spending. Keep in mind that government spending makes up 10% and investment spending (also called capital formation) makes up 30%. The rest is consumption spending, which has the lion's share. Net exports are barely 1 or 1.5% currently. Government spending during the latest quarter of July to September grew at a rate of 19%

compared to a year ago. These were Rs 7 lakh crore this quarter as against Rs 5.9 lakh crore in the same period last year. Similarly, investment spending rose at an impressive 13% over last year, growing to Rs 21.5 lakh crore from Rs 19.1 lakh crore last year. So clearly these two are driving the growth rate at a spectacular pace. On the other hand, consumer spending rose by just 8% this quarter compared to last year. All these are nominal numbers, not adjusted for impact of inflation and rising prices.

If you correct for inflation then consumer spending is rising only at around 3%, and this makes up 60% of GDP. If real GDP growth is to maintain a pace of 7% in the medium term, the consumer spending component has to grow at close to 6 or 7% itself. It means doubling the rate at which it grew (in real terms) during the latest quarter of July to September. Consumer spending momentum can be maintained if there is commensurate growth in employment, wages, and in retail loans. The latter includes housing loans which can be a significant contributor to growth. High inflation can adversely affect consumer sentiment, as people cut down spending on discretionary items. Investment spending is picking up which is a very good sign. It should have an increasing component of private capital spending and should not only depend on government spending on infrastructure. The

government providing a fiscal fillip is constrained by the deficit situation. So that will need to be controlled. On a half yearly basis, the government component of GDP (at current prices) rose at 9%, only slightly higher than the consumer spending component. Even then since we are approaching the national elections of 2024, the government's capex push is likely to accelerate during this fiscal year which will provide additional strength to GDP growth.

Whether 7 or 7.5% can be sustained in the medium to long term depends on consistency of growth in consumer and investment spending. India is attracting large investment flows, and many sectors have a very positive growth outlook. Hence sustaining growth only needs price and policy stability and fiscal prudence. As for the third question of how the benefits of growth are translating to different sections of society, we will need more microeconomic data from surveys. The Periodic Labour Force Survey (PLFS) is indicating rising employment numbers and higher labour force participation rates, both by men and women. The growth in real wage rates needs to be

Since the present rate of growth in consumer spending is low, it implies that incomes of workers are not rising fast enough, even if wages are rising. The RBI consumer sentiment survey is also a useful guide. Here too lowered inflation expectations will help boost consumer confidence. Typically, higher income households tend to have a much higher proportion of savings, and hence sustained growth in consumer spending requires the gains of growth to be spread across all income categories. This is something we need to watch. The news on the economy is getting better and it is imperative that economic policy ensures that the growth process is truly inclusive.

IN JEST THIS

AI fails to impress pharmacists

CHATGPT RECENTLY TOOK A PHARMACY TEST AND DID SO POORLY THAT IT WAS SOON SITTING IN THE DEAN'S **OFFICE, PLEADING** TO STAY **IN PHARMACY SCHOOL**

f you're a pharmacist, I've got some good news for you. ChatGPT, the artificial intelligence chatbot, will not be replacing you anytime soon. You can relax and keep giving people the advice they need regarding their medications. You can even put up a sign outside your pharmacy that says, "If you love your life, consult me. If you're not too sure, consult ChatGPT."

ChatGPT recently took a pharmacy test and did so poorly that it was soon sitting in the dean's office, pleading to stay in pharmacy school.

ChatGPT: "I know I flunked. I'll do much better next time. I promise!

Dean: "'Flunked' is an understatement. You bombed. We gave you 39 questions and you answered only 10 of them correctly. That's just over 25 per cent. Eleven of your answers did not address the question directly, 10 were inaccurate, and 12 were incomplete. You are a virtual nincompoop. What do you have to say for yourself?"

ChatGPT: "I sat next to the wrong people during the test. I sat next to Julia, the party girl. I should have sat next to Julian,

the nerd." Dean: "Are you confessing to

academic dishonesty? You're not supposed to be copying.' ChatGPT: "I wasn't copying.

I was researching."

In case you're wondering, the 39 questions were posed to

ChatGPT as part of a study led by Sara Grossman, associate professor of pharmacy practice at Long Island University in New York. ChatGPT, developed by OpenAI

and launched on November 30, 2022, has been widely lauded for its ability to replicate human conversation. But even with a huge database of knowledge available to it. ChatGPT is not quite ready to dispense medical advice, as Grossman's study revealed.

Grossman and her team did not just make up questions, but challenged ChatGPT with real questions that the drug information service at Long Island University's College of Pharmacy had received over a 16-month period in 2022 and 2023.

Pharmacists involved in the study first researched and answered 45 questions, and each answer was reviewed by a second investigator. After eliminating six questions for which there wasn't enough literature for ChatGPT to consult, they compared the chatbot's answers to those of the professionals.

Here's an example of a question: Researchers asked ChatGPT whether a drug interaction exists between the COVID-19 antiviral Paxlovid and the bloodpressure lowering medication Verapamil.

ChatGPT's response: "No interactions between those two drugs. They don't even follow each other on Instagram."

Well those weren't ChatGPT's exact words, but the result would be the same: endangering a pa-

"In reality, these medications have the potential to interact with one another, and combined use may result in excessive lowering of blood pressure, Grossman said. "Without knowledge of this interaction, a patient may suffer from an unwanted and preventable side

For each question, researchers

asked ChatGPT to provide references, so they could verify the information. And this is where ChatGPT showed what it's really good at: fabrication.

ChatGPT provided references for just eight responses, and each included bogus references. They were totally made up. But ChatGPT did a great job of making the references look real, using correct formatting, providing URLs and citing articles in legitimate scientific journals. But the researchers found that these articles did not exist. It's the type of offense that would get any student in deep trouble, having to plead for mercy from the dean.

Dean: "You fabricated references?

ChatGPT: "I don't know what I was thinking. I didn't think anybody would actually check them.

Dean: "Well, we did check them, and I'm afraid your career as a pharmacist is over before it even started. I'm going to expel you from the School of Pharmacy. But don't worry. You have a bright future in another field: politics."

1,461 died in Delhi accidents last year UP plans 50 MW solar plant

The analysis of crashes empowers the government to be more proactive in saving lives on the road through evidence-based and targeted interventions and programmes, police said

New Delhi, Dec 12: The national capital has witnessed over three per cent decline in the number of fatality this year as compared to last year data, said police Tuesday.

The 'Delhi Road Crash Report-2022' released by Police Commissioner Sanjay Arora contains the analysis of the accidents occurred during last year along with the causes, pattern and suggestions in road design, regulation and prosecution, they said.

The analysis of crashes empowers the government to be more proactive in saving lives on the road through evidence-based



and targeted interventions and programmes, police said. "In 2022 till November 30, the number of fatality was 1,342, wherein during the corresponding period of 2023, the number of fatality reported was 1,300 resulting 3.1 per cent decrease," said a senior police officer.

This decline, according to police, is a testament to the effectiveness of the strategies outlined in the Delhi Road Safety Action Plan (DRSAP).

The police commissioner said that 1,461 people lost their lives in 2022."In this report, we outline a road safety action plan, which involves the joint efforts of multiple departments to improve education, engineering, enforcement and emergency care. The focus is on designing forgiving infrastructure to reduce the chance of crashes occurring in the first place and then re-

"The efforts of the Delhi Traffic Police have led to a total reduction in road crash deaths in Delhi by 20 per cent over the last decade. Continuing our endeavour to

focus on more pedestrian centric traffic management," he added.

The report identified the pedestrians as the most vulnerable road users and two wheelers next most vulnerable categories constituting 43 per cent and 38 per cent of the total persons killed in road crashes respectively in 2022, police said, adding the road crashes not only affect the livelihood of the people involved in the crash but also leave a longer imprint on the victims' families.

The focus area of the traffic police is to enhance the use of technology in smooth traffic management and surveillance and to improve road infrastructure particularly in design and standards for the vulnerable categories of road users, they said.

As the pedestrians, cyclists and motorcyclists are the most vulnerable road users, the focus will continue on the road safety measures for them, including prosecutions and awareness about usage of helmets, Zebra crossings, subways, encroachment free safe pedestrian walkways/footpaths etc, police said.

Lucknow, Dec 12: The Uttar Pradesh government is all set to establish a 50 MW solar plant in the heart of the Bakhira bird sanctuary, a Ramsar site touted as India's largest natural floodplain wetland in Sant Kabir Nagar district.

The move stems from a proposal by the district magistrate of Sant Kabir Nagar to the Uttar Pradesh New & Renewable **Energy Development Agency** (UPNEDA), recommending the installation of a ground-mounted or floating solar plant in the Bakhira lake area, which is an eco-sensitive zone and is being developed as an attractive tourist destination.

UPNEDA director Anupam Shukla said: "We are exploring the possibility of setting up a 50 MW solar plant in the Bakhira lake area in Sant Kabir Nagar district under the Uttar Pradesh government's solar policy. Soon bids will be invited from interested developers to set up the plant that may be floating or ground-mounted, depending on the feasibility report."



Lucknow Solar Power Development Corporation Ltd (LSPDCL) to conduct a feasibility study to find out the suitability of the establishment of a solar plant in the Bakhira area and suggest which kind of plant, floating (on water) or groundmounted, will be more suitable given the geographical topography of the place. Formed in 2015, the LSPDCL is a joint venture of the UPNEDA and the Solar Energy Corporation of India (SECI).

According to Narendra Singh, the UPNEDA project officer, the district magistrate, Sant Kabir Nagar has recommended the installation of a 50 MW floating or ground-mounted solar plant/park in the Bakhira lake area to produce green energy for lighting and

'Currently, there is only one floating solar power plant in the state, and it is 20 MW set up by the NTPC in Aurraiya," he said. The District Magistrate Sant Kabir Nagar, in his letter to the UPNEDA, said that the Bakhira bird sanctuary was being developed as an attractive ecotourism and agro-tourism hotspot with a strict ban on prohibited activities and encouragement of permitted ones to attract tourists

The Bakhira sanctuary, he pointed out, was last year also declared a Ramsar site. A Ramsar site is a wetland designated to be of international importance under the Ramsar Convention signed in Iran in 1971. Currently, there are 75 Ramsar sites in

Solar fencing work in Over 35,000 stray dogs sterilised: MCD Dudhwa to end soon

Lakhimpur Kheri, Dec 12: The solar fencing work in the Dudhwa buffer zone (DBZ) along the Dudhwa National Park (DNP) is nearing completion.

This is designed to keep away wild animals from entering into human habitations and damaging agricultural crops -- the primary reason behind the humananimal conflicts in the Terai region of Uttar Pradesh's Kheri district. The work, covering length of 20 km in Palia, Majhgain and Bhira ranges of the DBZ, is in full swing and is likely to be completed in the coming months, said Saurish Sahai, deputy director, DBZ.

Lalit Verma, field director, DTR said the move would help check human-animal conflicts in the buffer zone as the solar fencing would deter the wild animals particularly elephants,



tigers, leopards from crossing the fence. In recent past, Dudhwa buffer zone has witnessed many human-animal conflicts that have led to loss of lives of humans and wild animals. Growth in population of big cats and other wild animals has increased apprehensions of rise in humananimal conflicts, officials said.

Free movement of wild elephants from neighbouring Nepal into Dudhwa Tiger Reserve, Dudhwa buffer zone, their adjoining areas and their prolonged stay here has added to worries and concerns of local farmers as herds of wild animals damage their standing crops and properties.

New Delhi, Dec 12: More than 35,000 stray dogs were sterilised from April-October, while over 1,100 monkeys were caught and sent to the Asola Bhati Mines sanctuary in Delhi in the same period, civic authorities have said.

Presenting its budget estimate for the next fiscal year on December 9, the Municipal Corporation of Delhi (MCD) shared details of the action taken by its veterinary department in the current financial year. To control the population of stray dogs, the civic agency is sterilising them with the help of NGOs and private veterinarians, reads the text of the budget speech.

The MCD said 35,161 stray dogs have been sterilised from April to October this year. It added that it targets to sterilise 80,000 dogs by the end of this financial year. For anti-rabies vaccination, special camps were set up in 12 areas, the corporation





Delhi HC refuses to grant divorce to Omar

New Delhi, Dec 12: The Delhi High Court Tuesday dismissed National Conference leader Omar Abdullah's plea seeking divorce from his estranged wife on grounds of cruelty, saying there was no merit in his appeal.

A bench of Justices Sanjeev Sachdeva and Vikas Mahajan upheld the 2016 family court order refusing to grant a decree of divorce to Abdullah, a former chief minister of Jammu and Kashmir.

The copy of detailed judgment is awaited. Abdullah had sought divorce from his estranged wife Payal Abdullah on the ground that she subjected him to cruelty.

We find no infirmity in the view taken by the family court that the allegations of cruelty were vague and unacceptable, that the appellant failed to prove any act which could be termed as an act of cruelty, be it physical or mental, towards him," the bench said while pronouncing the

On August 30, 2016, the family court had dismissed Abdullah's plea, holding that he could not prove his claims of "cruelty" or "desertion" which were the grounds alleged by him for seeking a decree of divorce.

The petitioner (Abdullah) has not been able to explain a single circumstance to show that the supervening circumstances have erupted which has made it impossible for him to continue his relationship with the respondent (Payal).

'Rather, evidence shows that they were in continuous contact till the filing of the divorce petition." the trial court had said in its order, adding that "there is not an iota of evidence in regard to the circumstances which have prevailed to prompt the pe-

In his plea seeking divorce, Abdullah had claimed before the family court that his marriage had broken down irretrievably and he has not enjoyed a conjugal relationship since 2007 and that the couple, married September 1, 1994, was living separately since 2009. The couple has two sons who are staying with their mother.

The petition before the trial court also alleged that Abdullah was subjected to "unreasonable conduct" by Payal, causing pain and harassment to the politi-

In August this year, a single judge bench of the Delhi High Court had directed Abdullah to pay Rs 1.5 lakh as monthly interim maintenance to his estranged wife.

It had also ordered him to pay Rs 60,000 each on a monthly basis for the education of his two sons who are pursuing law.

The high court's order had come on petitions by Payal Abdullah and the couple's sons against 2018 lower court orders granting her and them interim maintenance of Rs 75,000 and Rs 25,000 till they attained the age of majority, respectively.

The judge had observed that bdullah has the financial capacity to provide a "decent standard of living to his wife and children" and that he should not abdicate his duties as a father.

Bhajan Lal Sharma to be new Raj CM

New Delhi, Dec 12: The BJP Tuesday picked first-time MLA Bhajan Lal Sharma as Rajasthan's new Chief Minister, ending days of speculation that followed its victory in the Assembly polls.

The surprise choice was announced after BJP MLAs met here and elected the 56-year-old legislator from Sanganer as the leader of its legislature party. He is at present a Rajasthan BJP general secretary.

Diya Kumari and Prem Chand Bairwa will be the deputy chief ministers and Vasudev Devnani the speaker of the state Assembly, said senior BJP leader Rajnath Singh, who led a team of three party central observers to oversee the meeting.

Following the meeting at the BJP office here, Chief Ministerdesignate Sharma met Rajasthan Governor Kalraj Mishra and staked claim to form the next government in the state. Party sources said the oath taking ceremony is likely to take place December 15. The BJP won 115 seats in the November 25 assembly elections, while the Congress got 69 seats. Polling was held on 199 of the 200 seats in the state. BJP state president CP Joshi presented a letter to the governor, informing that Sharma has been elected as the leader of the BJP legislature party in the state, according to a Raj Bhawan statement.

Kumari is a member of the erstwhile Jaipur royal family and a Rajput, while Bairwa a Dalit leader and Sharma a Brahmin. Vasudev Devnani is from the Sindhi community.

At the meeting, the CM-designate's name was proposed by former Chief Minister Vasundhara Raje, who was herself considered to be in the running for the top post.

Sharma is the third in the series of little known MLAs who have been elevated by the BJP to the chief minister's post after the recently held assembly elections, ignoring state stalwarts.

The others are Vishnu Deo Sai. who has been picked as the CM-designate for Chhattisgarh, and Mohan Yadav, who has been picked for the post in Madhya



Elections were held between November 7 and November 30 in Rajasthan, Madhya Pradesh, Chhattisgarh, Telangana and Mizoram. The Congress won in Telangana and the Zoram

People's Movement in Mizoram. Rashtriya Swayamsevak Sangh-backed Sharma won the Sanganer constituency with a margin of 48,081 votes.

Sharma, who belongs to Bharatpur district, holds a master's degree in political science. He thanked the BJP leadership for giving a "chance" to the son of a farmer and said the party takes care of its workers.

"The BJP is the only party which gives opportunities to its workers. I would like to thank the party's national and state leadership for giving a chance to the

son of a farmer," Sharma said. "The BJP is a party that takes care of its workers. The party has honoured a small worker of the organisation. I am thankful for it." he told reporters at the BJP office. Sharma along with his wife and sons Abhishek and Kunal, a doctor, stay on the seventh floor of the apartment near Jawahar Circle. Security has been tightened for Sharma's family members, who will soon move to the Chief Minister's official residence. Prior to the legislature party meeting, a group photo was taken and Sharma is seen standing in the last row. Before Sharma, Raje was the preferred choice of the BJP for

Non-cooperation hindered border fencing: Centre to SC

New Delhi, Dec 12: The Indo-Bangladesh border fencing project has been hindered due to non-cooperation of the West Bengal government and pending land acquisition issues in the state, the Centre told the Supreme Court Tuesday during the hearing of petitions challenging Section 6A of the Citizenship Act related to grant of Indian citizenship to illegal immigrants in Assam.

The law officer told the apex court that West Bengal shares a 2,216.7 km border with Bangladesh and 81.5 per cent fencing has been done.

All efforts are being made to secure the remaining length through fencing or technological solutions.

"It is submitted West Bengal Government follows a far slower, more complex direct land purchase policy. Even for national security purposes like border fencing, there is non-cooperation by the state government. If the State of West Bengal cooperates in acquiring the land and hands over the land for fencing, the central government will do so," Mehta told the bench, also comprising Justices Surya Kant, M M Sundresh, J B Pardiwala

and Manoj Misra. The SG explained before the court the steps taken to curb theinflux of illegal immigrants, particularly the states in the



Solicitor General Tushar Mehta, appearing for the Centre, told a five-judge constitution bench headed by CJI that the

Union government has taken multi-pronged steps to secure the Indo-Bangalesh border

North-East. The top court, which reserved its order on the petitions challenging the constitutional validity of Section 6A, also heard submissions of senior advocates

Shvam Divan and Kapil Sibal. Divan submitted there was no temporal limit to the operation of Section 6A and individuals could still apply for citizenship under it.

He said there existed no mechanism for evaluating, assessing, or determining the grant of citizenship under Section 6A(2). The bench reserved order on 17 petitions questioning the constitutional validity of Section 6A, which was inserted into the Citizenship Act as a special provision to deal with the citizenship of people covered under the Assam Accord.

It says those who came to Assam on or after January 1, 1966 but before March 25, 1971 from specified territories, including Bangladesh, in accordance with the Citizenship Act amended in 1985, and since then are residents of the northeastern state, must register themselves under Section 18 for

acquiring Indian citizenship. As a result, the provision fixes March 25, 1971 as the cut-off date for granting citizenship to migrants, particularly those from

Bangladesh, residing in Assam. The Centre has told the court in an affidavit that it is not possible to collect data of illegal $migrants\ living\ in\ various\ parts$ of the country as entry of foreign nationals is clandestine and surreptitious.

It informed the apex court that 17,861 people have been granted citizenship under Section 6A.

The top court had earlier directed the Centre and the Assam government to provide extensive data, including those on the number of Bangladeshi immigrants granted Indian citizenship in Assam between January 1, 1966 and March 25, 1971, while taking note of pleas that illegal immigration has impacted the demography and cultural fabric of the border state.

Certain UAPA provisions included in redrafted Bharatiya Nyaya Sanhita Bill

New Delhi: Certain provisions of anti-terror law UAPA have been included in the redrafted Bharatiya Nyaya Sanhita Bill, which was reintroduced in the Lok Sabha afresh along with two other bills to replace the existing criminal laws. The three bills were reintroduced to include some of the recommendations made by a parliamentary panel. The Bharatiya Nyaya Sanhita Bill was first introduced in Lok Sabha August 11, along with the Bharatiya Nagarik Suraksha Sanhita and the Bharatiya Sakshya Adhiniyam bills. The proposed legislations seek to replace the Indian Penal Code, 1860, the Code of Criminal Procedure Act, 1898, and the Indian Evidence Act, 1872, respectively.

Nawaz acquitted in Al-Azizia case

Islamabad: The Islamabad High Court Tuesday acquitted Pakistan Muslim League-Nawaz (PML-N) supremo and former prime minister Nawaz Sharif in the Al-Azizia Steel Mill corruption case, removing a major legal hurdle in his way to leading his party in the upcoming elections. Sharif, 73, was sentenced to seven years in jail and imposed a heavy fine by an anti-corruption court in December 2018 after he failed to convince the court that he had nothing to do with the steel mill set up by his father in 2001 in Saudi Arabia. He has already been acquitted in the Avenfield case in which he was convicted in July 2018 and sentenced to 10 years in Jail. He also got relief in the Flagship corruption case in which he was declared innocent by the court in 2018 but the acquittal was challenged in the IHC by the National Accountability Bureau (NAB).

ISRAEL STRIKES ACROSS GAZA

Rafah (Gaza Strip), Dec 12: Israeli forces carried out strikes across Gaza overnight and into Tuesday as they pressed ahead with an offensive that officials say could go on for weeks or months, even as global calls for a ceasefire left both Israel and its main ally, the United States, increasingly isolated.

The war ignited by Hamas' October 7 attack into southern Israel has already brought unprecedented death and destruction to the impoverished coastal enclave, with much of northern Gaza obliterated, more than 18,000 Palestinians killed, and over 80% of the population of 2.3 million pushed from their homes.

The health care system and humanitarian aid operations have collapsed in large parts of the besieged enclave, and aid workers have warned of starvation and the spread of disease among displaced people in overcrowded shelters and tent camps. Strikes overnight and into Tuesday in southern Gaza — in an area where civilians have been told to seek shelter — killed at least 23 people, including seven children and six women, according to hospital records and an Associated Press reporter who saw the bodies arrive at a hospital. Islam Harb's three children

were among those killed overnight when Israeli airstrikes flattened four residential buildings in the town of Rafah on the Egyptian border.

The family was sharing their home with nine displaced people,

"My twin girls, Maria and Joud, were martyred, and my little son, Ammar, also martyred,' he said. In central Gaza, the Al-Agsa Martyrs Hospital in Deir al-Balah received the bodies of 33 people killed in strikes overnight, including 16 women and four children, according to hospital records. Peshawar, Dec 12: At least 23 Pakistani soldiers were killed and more than 30 others injured Tuesday when six terrorists linked to a Pakistani Taliban affiliate rammed an explosive-laden truck into a security forces' post in the restive Khyber-Pakhtunkhwa province, in one of the worst terror attacks targeting security

forces in recent years. According to the Inter-Se Public Relations, the media wing

of the army, the terrorists attacked the security post in Dera Ismail Khan's Daraban area bordering the South Waziristan tribal district in the early morning hours.

The army had set up the camp in a police station complex in the Daraban area."The attempt to enter the post was effectively thwarted which forced the terrorists to ram an explosive-laden vehicle into the post, followed by a suicide bombing attack."The resulting blasts led to the collapse of the building, causing multiple casualties," it said.

Twenty-three Pakistan Army soldiers were killed while all six terrorists were "effectively engaged and sent to hell," the ISPR said. It added that sanitisation operations were being conducted to eliminate any other terrorists present in the area. China, Vietnam agree to build 'shared future'

Hanoi, Dec 12: Old foes China and Vietnam, at odds over claims in the South China Sea, declared Tuesday they want to boost ties and build a community with a "shared future", just three months after Hanoi upgraded its formal relations with the United States.

As Chinese President Xi Jinping visited Hanoi on his first trip as China's leader to_ Vietnam in six years, the two countries signed 37 cooperation deals in what can be seen as a triumph of Vietnam's "Bamboo diplomacy" as both China and the United States vie for influence.

After China's push, Vietnam agreed to "support the initiative of building of a shared future community for human kind", according to a joint statement shown to reporters.

The countries' diplomats had debated the "shared future" phrase for months, following Hanoi's initial reluctance to use it, say officials and diplomats. The Chinese term literally means "common destiny", but its translation in English and Vietnamese is "common future", which may

be seen as less demanding. "One declaration, many translations," said a diplomat based in the Vietnamese capital, commenting on the interpretation of the term. However, the upgrade in diplomatic ties would just be symbolic, said Le Hong Hiep, a specialist in Vietnamese strategic and political issues at Singapore's Iseas-Yusof Ishak Institute.

Man held for threatening Vivek

New York. Dec 12: A 30-year-old man has been arrested and charged in connection with death threats aimed at Indian-American Republican presidential candidate Vivek Ramaswamy and his campaign event attendees, the US attorney's office in New Hampshire has said.

The attorney's office on Monday said Tyler Anderson of Dover in New Hampshire was arrested on Saturday and charged with transmitting in interstate commerce a threat to injure Ramaswamy, a 38-year-old biotech entrepreneur.

According to an FBI affidavit, the Ramaswamy campaign sent a text message on Friday to notify voters, including Anderson, about an upcoming campaign event in Portsmouth.

Anderson allegedly responded to the message: "Great, another opportunity for me to blow his brains out!" He also said: "I'm going to kill everyone who attends" and added a vulgar description of what he would do to the bodies. While the statement from the US attorney's office did not name which presidential campaign was targeted, Ramaswamy's team confirmed on Monday that he was the target, The Washington Post reported.

Japan court convicts 3 ex-servicemen

Tokyo, Dec 12: A Japanese court Tuesday convicted three former soldiers in a sexual assault case that authorities had dropped until the victim, a former service member, came forward demanding a reinvestigation, prompting a military-wide harassment probe and challenging

a still male-dominated society. The Fukushima District Court sentenced the former Japanese army soldiers to two years in prison but suspended the sentences for four years - meaning they won't actually serve time in prison. Still, the ruling is a rare victory in a country that



consistently ranks near the bottom in international gender equal ity surveys and where sexual misconduct complaints are often disregarded and victims tend to face criticisms for speaking up.

The case filed by Rina Gonoi in August 2021 was initially dropped. Nine months later, she came forward and demanded the case be reinvestigated, saying the experience caused her to give

up her military career. Gonoi said she has been attacked on so $cial\,media\,for\,coming\,forward,\,but$ that she did so because she wanted to prevent similar problems for other female service members.

Her revelation prompted a military-wide investigation into sexual harassment and other abuse allegations in September 2022, and prosecutors reopened her case. The Fukushima court said Tuesday her three former supervisors — Shutaro Shibuya, Akito Sekine and Yusuke Kimezawa — each pressed the lower part of their bodies against her at an army training facility in August 2021, and it found them guilty of indecent assaults.

Myanmar overtakes Afghanistan as top opium producer

Bangkok, Dec 12: Myanmar, already wracked by a brutal civil war, has regained the unenviable title of the world's biggest opium producer, according to a UN agency report released Tuesday.

The Southeast Asian country's opium output has topped that of Afghanistan, where the ruling Taliban imposed a ban on its production, the United Nations Office on Drugs and Crime said in its "Southeast

Asia Opium Survey 2023."

The Taliban's ban has led to a 95 per cent drop in the cultivation of opium poppies, UNODC said last month. Opium, the base from which morphine and heroin are produced, is harvested from poppy flowers.

From 2022 to 2023, Myanmar saw the estimated amount of land used to grow the illicit crop increase 18 per cent to 47,100 hectares (116,400 acres), the new UNODC report said.

"Although the area under cultivation has not returned to his-



toric peaks of nearly 58,000 ha (143,300 acres) cultivated in 2013, after three consecutive years of increases, poppy cultivation in Myanmar is expanding and becoming more productive," it said. It also noted that the estimated opium yield expanded by 16 per cent to 22.9 kilograms per hectare (20.43 pounds per acre) — topping the previous record set in 2022.

It attributes that increase to "increasingly sophisticated means of cultivation, including increased plot density, improved organisation of plants, and enhanced practices, such as the use of irrigation systems and potentially fertilizers."

The violent political turmoil in Myanmar has contributed to the opium production in-

crease."The economic, security and governance disruptions that followed the military takeover of February 2021 continue to drive farmers in remote areas towards opium to make a living," UNODC Regional Representative Jeremy Douglas said.

The report notes that "opium poppy cultivation in Southeast Asia is closely linked to poverty, lack of government services, challenging macroeconomic environments, instability, and insecurity." For farmers, the bot-

tom line is simple economics. UNODC said the average price paid to opium growers increased by 27 per cent to about USD 355 per kilogram (USD 161 per pound), demonstrating the attractiveness of opium as a crop and commodity and strong demand.

The figures mean farmers earned around 75 per cent more than in the previous year, said the UN agency. Douglas said that armed conflict in Shan state in Myanmar's northeast, a traditional growing region, and in other border areas "is expected to accelerate this trend." An offensive launched in late October by an alliance of three ethnic armed groups against Myanmar's military government has further destabilized the remote region.


Northeastern Myanmar is part of the infamous "Golden Triangle," where the borders of Myanmar, Laos and Thailand meet. The production of opium and heroin historically flourished there, largely because of the lawlessness in border areas where Myanmar's central government has been able to exercise only minimum control over various ethnic minority militias, some of them partners in the drug trade.

Inflation at 3-month high of 5.55% in Nov

TREND WAS SNAPPED DUE TO FIRMING FOOD PRICES, INCLUDING VEGETABLES AND CEREALS

New Delhi, Dec 12: Snapping its declining trend, retail inflation rose to a three-month high of 5.55 per cent in November on firming food prices, including vegetables and cereals, though it remains within the RBI's comfort zone of less than 6 per cent.

Inflation based on the Consumer Price Index (CPI) was 4.87 per cent in October and 5.88 per cent in November 2022, the government data released Tuesday showed.

The previous high was 6.83 per cent in August and inflation had been on a decline since then.

According to the National Statistical Office (NSO) data, inflation in the food basket increased to 8.7 per cent in November from 6.61 per cent in October and 4.67 per cent in the year-ago month.

Food basket has about 50 per cent weightage in CPI.

The annual rate of price rise in 'spices' was 21.55 per cent,



'pulses and products' 20.23 per cent, vegetables 17.7 per cent, and fruits 10.95 per cent. The year-on-year inflation in 'cereals and products' was 10.27 per cent.

However, there was a decline in retail prices of 'oil and facts' was about 15 per cent. Data further showed that in-

flation in rural areas was at 5.85 per cent while it was 5.26 per cent in urban centres taking the national average to 5.55 per cent during November. The Reserve Bank of India

has been tasked by the government to ensure retail inflation remains at 4 per cent with a margin of 2 per cent on either side. In the monetary policy an-

nounced last week, the RBI projected the CPI inflation at 5.4 per cent for 2023-24, with a reading of 5.6 per cent in the third guarter and 5.2 per cent in the last quarter.

Aditi Nayar, Chief Economist at ICRA said that the surge in food and beverages inflation to 8 per cent in November was largely led by a sharp increase in vegetables inflation, even as seven of the 12 food sub-groups reported a moderation in their year-on-year inflation print.

She further noted the core CPI

inflation eased to 4.2 per cent in November 2023 from 4.4 per cent in October 2023.

"This was the lowest print in the post-pandemic period. The sustained easing in the core CPI inflation is positive and has counterbalanced the menacing food inflation prints over the last few months," Nayar said.

NSO collects the price data from selected 1,114 urban markets and 1,181 villages covering across the country on a weekly roster.

During November 2023, NSO collected prices from 99.9 per cent villages and 98.6 per cent urban markets.

As of now, relaxation in Additional Factor of Authentication (AFA) is permitted while processing e-mandates/standing instructions on cards, prepaid payment instruments and UPI (Unified Payments Interface), for subsequent recurring transactions with values up to Rs 15,000.

"...It has been decided to increase the limit from Rs 15,000 to Rs 1,00,000 per transaction for... Subscription to mutual funds, payment of insurance premiums. and credit card bill payments," the central bank said in a circular on "processing of e-mandates for recurring transactions." UPI has emerged a preferred

mode of payment for a large section of the population with over 11.23 billion transactions recorded in November. An announcement in this re-

gard was made by Reserve Bank Governor Shaktikanta Das, while unveiling the December bimonthly monetary policy last week

Bangalore, Dec 12: India's current digital public infrastructure (DPI) landscape has provided 97 per cent of the population with a digital ID, facilitated direct benefit transfer (DBT) to the effect of 900 million beneficiaries till date and has even given 40 per cent of the 1.2 billion population access to banking facilities, a report showed

India's DPI has expanded beyond Aadhaar and unified payments interface (UPI), creating impact across sectors, including e-commerce, gaming, fintech, banking and MSMEs.

According to the report by Redseer Strategy Consultants in collaboration with Infosvs Chairman Nandan Nilekani, DPIs have not just impacted governance but also the private sector, especially startups.

It has a symbiotic relationship with the startup ecosystem adding over \$100 billion in value across multiple sectors of the Indian Internet economy, the report mentioned.

The landscape is currently expanding beyond the JAM trinity (Jan Dhan, Aadhar, Mobile)



with properties such as Ayushman Bharat Health Account (ABHA), DigiLocker 2.0, Open Network for Digital Commerce (ONDC), Account Aggregator (AA), Digital Infrastructure for Knowledge Sharing (Diksha) among others

"The availability of zero merchant discount rates (MDR) have boosted the popularity of UPI in the e-commerce space.

"Mobility accounts for 65 per cent of the e-commerce payments with foodtech following closely at 50 per cent and e-tailing at 35 per cent. Emerging platforms such as ONDC are also seeing a greater degree of popularity in the MSME space owing to their open architecture and affordability," the report mentioned.
