Bill for control of telecom tabled 78 MPs suspended

New Delhi, Dec 18: The Centre tabled Monday the new telecom bill in the Lok Sabha. The Telecommunications Bill, 2023, proposes that the Centre will take temporary possession of telecom networks in case of any public emergency or in the interest of public safety. The Bill was tabled by Union Minister Ashwini Vaishnaw.

The new version of the Bill excludes OTT services, such as online messaging players like WhatsApp, video-streaming platform Skype, streaming services and digital payments from its purview.

78 Opposition MPs were suspended Monday from the Lok Sabha and Rajya Sabha for raising slogans and demanding a statement from Home Minister Amit Shah on the security breach in Lok Sabha, December 13. While 64 opposition MPs were

suspended for the remainder of Winter Session in both the houses, 14 MPs (Rajya Sabha-11, Lok Sabha-3) were suspended till the submission of the report of the Privileges Committee. The Lok Sabha suspended 33 MPs - 11 from Congress, including its leader Adhir Ranjan Chowdhury, nine each from DMK and TMC, two from IUML and one each from JD(U) and RSP.

On the other hand, 45 Rajya Sabha MPs, including 18 from the Congress, seven from TMC, five from DMK were suspended. With the suspensions Monday, the total number of lawmakers suspended reached 92 (46 Lok Sabha and the same number from RS). This marks the highest number of suspended MPs since March 1989 when 63 members were suspended in the Lok Sabha for a week under the Rajiv Gandhi regime after they protested against the report of the Thakkar Commission which looked into the assassination of former Prime Minister Indira Gandhi.

Congress MP from Koraput, Saptagiri Ulaka called the BJP government arrogant and said that Opposition will continue to voice its protest.

TMC MP Sudip Bandyopadhyay said that BJP wants to suppress the Opposition in Parliamentary democracy. "The BJP government is trying to gag the voice of the opposition," Sudip said. Congress lawmaker KC Venugopal said the House is functioning with only one purpose and that is to suppress the entire voice of the Opposition.

Biju Janata Dal (BJD) MP Bhartruhari Mahtab said that the suspension is the end result of the disruptions caused by the opposition MPs since last week.

Odia youth dies by suicide in Kolkata

Kolkata, Dec 18: The body of a youth was found hanging from one of the galleries of Eden Gardens here Monday police said. The deceased was identified as 21-year-old Dhananjay Barik, son of a groundsman, they informed. Police said that the deceased was a resident of Bhadrak district.

"The deceased was possibly suffering from depression because he was not getting employed as a ground staff at the Eden Gardens. He wanted to do the same work as his father and uncle. However, with the passage of time, Dhananjay became disillusioned and took the drastic step," a police officer said. "We are investigating whether it is a case of suicide or something else. The body has been sent for post-mortem," the officer added.

The youth's family members had filed a missing complaint with the Maidan police station here Sunday, the official said. He added that the deceased was staying with his father and uncle at the staff quarters inside the

Eden Gardens. Sources meanwhile informed that the youth had come to this city to pursue a career. He had seen the attention that his father and uncle got during the ODI World Cup matches. Since then Dhananjoy had been pestering his father to talk to the Cricket Association of Bengal (CAB) officials regarding a job. However with the passage of time, the deceased lost hope of getting a job at the 'Mecca of Cricket' and took the drastic step, they added.

The family members told the cops, as uncertainties prevailed over him getting the desired job, the deceased started going into acute depression. The family members told the cops that the deceased went missing since Sunday afternoon following which they filed a missing complaint ultimately late Sunday evening with the police. They added that Dhananjay in thepast had also left home for lengthy durations.

Tight security for 'poisoned' Dawood

New Delhi, Dec 18: Underworld don Dawood Ibrahim has been hospitalised in Pakistan's Karachi due to a serious health complication, sources and a section of the Pakistan media stated Monday. There were several reports on various social media platforms that Dawood has been 'poisoned'. However, there was no information forthcoming on this aspect.

Sources close to the UNdesignated terrorist have said that Dawood had been hospitalised two days back. However. they did not give reasons. They added that he is being 'treated' at a facility amid huge security. The floor in which he is residing has been completely vacated. Except for doctors, his family members and security personnel, no one is being allowed on

Sources also informed that Mumbai police are trying to gain more information on the hospitalisation of the underworld don from his relatives Alishah Parkar and Sajid Wagle living in India's financial capital.

The life of Dawood, the mastermind of the 1993 Mumbai blasts and who is the mostwanted gangster in India, has been shrouded in secrecy for the past many years. India has said it has irrefutable evidence that Dawood is based in Karachi.

Senior Pakistani journalist Arzoo Kazmi has been quoted as saying in a number of national news websites that there has been an alleged communication blackout, in and around the hospital where Dawood is staying. The internet and social media platforms have been shut down making it very difficult to get proper information.

Some sources informed that there is a possibility that the 67year-old Dawood may have breathed his last. That is the main reason why Pakistan has been keeping quiet on the matter. However, in the past, there have been a number of occasions when Dawood has 'died'. However, all those turned out

to be rumours There have been previous reports claiming that the underworld don contracted Covid-19 and suffered a heart attack and died. However, on both occasions, his gang members rejected such claims and asserted that their boss was alive and

Cloud of uncertainty hangs over free IAS coaching plan

Bhubaneswar, Dec 18: Questions are now being raised on the success of free civil services coaching initiative in degree colleges across the state which is going to be operational from next academic year. The state government had recently announced the programme with a view to increasing the success rate of Odia students in all-India administrative services exams which has been on the decline,

The skepticism stems from two grounds - the failure of the free coaching programmes launched earlier, and the large number of vacancies in teachers posts across colleges, the latter being the biggest impediment in imparting coaching to stu-

As per the announcement, it was decided to impart coaching to students in degree colleges and universities. The Higher Education department had decided that these institutions will support the initiative from their own funds. In a review meeting chaired by Higher Education secretary Aravind Agrawal held last month it was decided that changes will be introduced in the syllabus keeping in mind

Brown sugar worth ₹66L seized; 2 held

Bhubaneswar: The Special Crime Unit (SCU) of Commissionerate Police arrested two drug peddlers and seized drugs valued at around Rs 66 lakh from CRP Square area in Bhubaneswar, Police Commissioner Saumendra Priyadarshi said. Police sources said acting on credible intelligence regarding the transportation of a substantial quantity of brown sugar in a Bolero pick-up from Jaleswar in Balasore district to Khurda, passing through Bhubaneswar, the team successfully intercepted the vehicle on National Sunday. They said the two suspects

were apprehended and found in possession of 660 gm brown sugar, valued approximately at Rs 66 lakh. The accused carriers were identified as SK Sadiruddin of Basta and Ajmer Khan of Jaleswar area in Balasore district. They are suspected to be part of a network involved in transporting narcotics for financial gains - from Jaleswar to Khurda area. The SCU has reportedly sought the court's permission to take the accused duo on remand to further

It is worth mentioning that 200 students had enrolled themselves in the free coaching scheme earlier launched by the department. They expected that the success rate would increase in all-India administrative services, especially of poor and meritorious students, if they are given coaching at college level.

However, success eludes the students as well as the state government even as crores have been spent on the earlier schemes to provide free coaching to aspiring students. This is primarily on account of lack of infrastructure and paucity of teachers. As per data tabled in the Assembly, as many as 906 posts of teaching staff are lying vacant in government degree colleges.

Golak Nayak, president of 662category teachers' association, said that although the initiative of the state government is welcoming, emphasis should be laid on making it operational as soon as possible. "The announcement was made though no guidelines were set. The Nua-Odisha programme is in progress while the election is round the corner in which the government will be busy. I'm doubtful if the scheme could be implemented from the next academic year.

Nayak added that the most important factor is over 50 per cent vacancies in teachers posts across degree colleges in the state. "They should rather focus on filling these vacancies," he said. Meanwhile, efforts to elicit response from the Higher Education secretary yielded no

Class X dropout rate highest in state: Minister

New Delhi, Dec 18: With almost 50 per cent of Class X students dropping out in Odisha, the state recorded the highest dropout rate for 10th standard in the country as per data for the Sabha Monday.

2021-22 academic year shared by the Union Education Minister Dharmendra Pradhan in Lok For 2021-22, while the dropout rate for Class X nationally stood at 20.6 per cent, Odisha performed the worst among states

with a dropout rate of 49.9 per

cent, followed by Bihar, which had a dropout rate of 42.1 per cent, informed Pradhan in a written reply.

The minister was responding to a question by DMK MP Kalanidhi Veeraswamy on whether the government is cognizant of the analysis based on the recent exercise carried out by the Ministry of Education that about 3.5 million students stop their education in Class 10.

Pradhan informed that 1,89,90,809 students appeared for Class X examination in 2022, of which 29.56.138 students failed to



progress further.

In a positive development for Odisha, number of students failing in Class X board exams has fallen from 1,38,462 in 2019 to only 8.944 in 2022.

"The reasons for failure of students in examination depends on various factors namely, not attending the schools, difficulty

in following the instruction in schools, lack of interest in the studies, level of difficulty of question paper, lack of quality teachers, lack of support from parents, teachers and schools,' said the minister.

"Further, education is in the concurrent list of the Constitution and majority of the schools are under the domain of respective State and UT Governments," he added.

The ministry also shared details of students' dropout rate at Class X for the last four years (2018-19 to 2021-22) state-wise.

Apart from Odisha and Bihar, the other states with high dropouts are Meghalaya (33.5 per cent), Karnataka (28.5 per cent), Andhra Pradesh and Assam with 28.3 per cent each. Gujarat (28.2 per cent) and

Telangana (27.4 per cent). The states with dropout rate less than 10 per cent are Uttar Pradesh (9.2 per cent), Tripura (3.8 per cent), Tamil Nadu (9 per cent), no dropout in Manipur, Madhya Pradesh (9.8 per cent), Himachal Pradesh (2.5 per cent), Haryana (7.4 per cent) and Delhi (1.3 per cent).

According to farmers, the cotton seed available in Rayagada district is high-yielding and resistant to pesticides used for de-weeding. Left with no option, farmers in Ganjam district are buying the seeds available in Rayagada district for cultivation of cotton on their

Farmers in Ganjam district have suffered losses in cultivation of paddy during the last kharif season due to inadequate rainfall. Cotton cultivation was also affected in the district but managed to scrape through. The harvest has been more this year than the previous year.

Cotton is usually cultivated on black soil where it grows best. It is cultivated more in areas under Sanakhemundi, Sorada, Sheragada, Jagannathprasad and Patrapur blocks.

The seeds germinate in four to five days after they are sown. The germinated seeds then grow into cotton plants and it takes six to seven months for the cotton

flowers to bloom. According to details available

tually cultivated on 3,017 hectare.

Farmers, however, have alleged that the seeds provided by the agriculture department are low-yielding, adding that the cotton plants grown using the seeds are withering after they spray pesticides for de-weeding. The sub-standard seeds are also resulting in stunted growth of the cotton plants. Left with no option, they have to travel to Rayagada district and buy the cotton seeds from there for their cultivation.

The cotton plants wither when they spray pesticides for deweeding. As a result, they are forced to use the seeds available in Rayagada for cultivation instead of the seeds supplied by the district agriculture department, a farmer Dibakar Goud alleged

When contacted, Assistant Agriculture Officer Pranati Panda said the agriculture department is not supplying the seeds but a private agency is selling the seeds at Digapahandi for which farmers are provided with incentives.

However, the agriculture department has fixed separate minimum support prices (MSPs) for the harvested cotton at the mandis.

The MSP for a quintal of cotton which is more in length has been fixed at ₹7022 while the MSP for the medium range of cotton is $\stackrel{7}{\sim}6620$ per quintal. The regulated market committee (RMC) at Digapahandi will open the mandi after the harvest where farmers can sell their harvest and get their money.

Later, the harvested cotton will be procured by the Cotton Corporation of India which will prepared threads at its ginning mill, district agriculture officer Subrat Kumar Sahu said.

Farmers have demanded to ensure proper marketing facilities for their harvest and quality check of the cotton as the harvest is increasing in

Upon asking GRP DSP Debendra Pingua said Harishankar fell on the track while jumping from the running train and the train ran over him leading to his death. The actual reason behind his death will be ascertained after getting the post-mortem report, he added.

Judges on Judgements

hen highly respected former judges of the Supreme Court open their mouths to find fault with some crucial apex court judgements on Central decisions and legislative actions with farreaching consequences for the country's democratic system, it is cause for both hope and alarm. For, in recent times the country has experienced with great consternation how the apex court put its seal of approval on controversial government actions which seem obviously detrimental to the social fabric and democratic rights of the people. Yet, not much could be said on such rulings of grave import by laymen since the apex court is always held with awe and respect and any criticism of its judgements is discouraged in various ways. But, when eminent judges sit on judgement of judicial verdicts, which is a rather rare phenomenon, it infuses courage and hope into votaries of civil liberty. This is exactly what former SC judges - Justice Rohinton F Nariman and Justice Madan Lokur - have done lately. Pointing out how the Supreme Court's five-judge Bench erred in validating the abrogation of Article 370 of the Constitution and consequential reorganisation of the state of Jammu & Kashmir, the opinions expressed by former judges are in-

Justice Nariman said the Centre's decision to bifurcate J&K when there was already President's rule imposed on the state had an ulterior motive. It was to bypass the clause in Article 356 which stipulates such a rule cannot exceed one year unless there is a national emergency or the Election Commission says elections are not possible to be held. Justice Lokur also questioned the imposition of President's rule in the first place since the Assembly was not dissolved while political parties were pleading with the Governor to be offered a chance to form government. Under Article 356 of the Constitution, if a state government is unable to function according to constitutional provisions, the Union government can take direct control of the state machinery. That may not have been the case in J&K.

The SC validated the abrogation of Article 370 even after declaring that the method in which it had been done was not legally tenable. Justice Nariman also questioned how the Supreme Court could accept an assurance given by the Solicitor General (SG) that statehood will be restored since the SG does not have any authority to bind the successor government. This only would give an excuse to the Centre to delay granting statehood dealing a body blow to federalism in the country.

Justice Nariman went further to examine and explain the threats to democracy posed by the government's legislation replacing the Chief Justice of India with a Prime Minister-appointed minister in the panel that selects the Chief Election Commissioner and other Election Commissioners. He also pointed out how the functions of a state government are being paralysed and virtually taken away by the Governor, a Central government appointee, with the help of the President.

Justice Nariman chose the occasion of delivering a lecture on 'Constitution: Checks and Balances" to articulate how he is feeling "disturbed" by four instances of government-judicial actions from the beginning of the year culminating in the recent judgement on the repeal of Article 370. For the first time the country heard coruscating criticism of four such disturbing actions by a legal luminary. Retired Justice Nariman first lambasted the attack on the media by the government when the latter had banned the telecast of two BBC documentaries on PM Modi's role as the then Chief Minister in the 2002 Gujarat riots and then ordered tax raids on the media outlet. Strongly defending the media's role as a "watch dog" of democracy, Justice Nariman has so cogently stated that whenever there is a tax raid on a media organisation following some expose of government actions by the former, the court should immediately declare such raids as illegal and unconstitutional and stop them. If the media is not defended for its criticism of the government's acts of omission and commission, it would spell danger for democracy, the judge said. His words are memorable for the survival of democracy: "If our watchdog - media - is killed, then nothing re-

Justice Nariman minced no words in slamming the introduction of the Election Commission Bill in the Parliament and passed by the Rajya Sabha. The process has followed a disturbing trajectory. The SC ordered that the Chief Election Commissioner and the ECs should be selected by a panel comprising the PM, CJI and the Leader of Opposition, until the Parliament enacted a law. As if taking a cue from the apex court, the government moved a Bill to replace the CJI by a selected cabinet minister. This, according to Justice Nariman, is "most unfortunate." The composition of the resulting committee means the government's view will always prevail and the Opposition's opinion against the government nominee would be rejected, the voting result being two against one. Already, the EC has been accused by commentators and politicians of acting blatantly in favour of the ruling party at the Centre.

The actions of the Governor of Kerala have come in for criticism for sitting on Bills for months and then referring them to the President. Justice Nariman warned "wholesale reference to the President," of Bills by the Kerala Governor has the potential to bring the legislative activity of the state to a standstill.

The utterances of the two judges in defence of democracy and federalism are indeed sagacious and welcome.

QUEST FOR SWADESHI

he first-ever comprehensive showcase of commissioned by Mahatma Gandhi for what turned out to be a significant session of the Congress at Haripura, Gujarat, in 1938 are now on display at the prestigious National Gallery of Modern Art, Bangalore. The so-named "Haripura panels," considered a national treasure, are the work of the Indian painter and teacher Nandalal Bose (1882-1966). The renewed interest and discussions occasioned by the exhibition bring up important questions on ideas of swadeshi, nationalism and the role of cultural diversity in rediscovering our own roots.

Visiting this exhibition, I have been struck by the political impact of the freedom struggle on the imagination of artists. The exhibition explores the nationalism of Nandalal Bose, as well as the fact that he represents the source of a uniquely Indian modernism. Was the underlying impulse within the artistic genius of Nandalal Bose just a return to the past, inspired by his youthful participation in the 'Swadeshi' movement? Or is his art something quite new in the Indian tradition, and in that sense a sign of a modern vision in Indian culture?

The relation of art to nation alism raises larger questions concerning the roots of modern Indian art. In the Indian context, nationalism, art and political imaginations are closely linked. Modern Indian art had its beginnings in the freedom struggle that broke free of the cultural dependency that drained away Indian creativity during the colonial period. The driving impulse behind this effort was to rediscover an authentic selfimage, the identity that was called 'Swadeshi' or "of our own land." 'Swadeshi' implies self-sufficiency, acknowledging that every community receives what is needed for life from its natural and cultural environment. Every authentic culture evolves out of a relationship between the human person and com-

munity, and the physical body of the land that provides a nurturing environment for a nation. However, 'self-sufficiency' is not simply about a national identity. Creative art addresses the relation of culture to its natural environment. Culture cannot grow through self-dependence alone. Growth arises from the interplay between different, though complementary, forces. The image of a tree represents the link between sky and earth. It symbolises the coming together of what is above, and what is below; what is seen, and what remains hidden. A seed, in order to sprout, needs both earth and water. A living plant grows naturally towards the light and warmth that comes from above the soil. Organic growth is the consequence of inner and outer energies working together. In that sense, nothing is sufficient in itself, as every living process implies moving outwards, reaching towards what is the 'other'. In the same way, a living culture responds to outer influences that enhance the potentiality within a local culture.

Nandalal Bose had been deeply impacted by the study of Ajanta frescoes, influenced by his teacher Abanindranath Tagore. These murals incorporate scenes from everyday life, executed in the second century before our common era. These scenes have shaped the imagination of many artists through the millennia. However, though Indian art is profoundly indebted to this vision of life, it is not possible for artists

today to repeat the art coming from some 22 centuries in the past. Though Bose encouraged his students to explore the everyday life in the countryside around Kala Bhayan in Santiniketan. that offered a source for their imaginative growth, he never insisted that students copy past artistic styles. His own art was very much an approach to natural materials which he learnt from exchanging techniques with contemporary artists coming from China and Japan, who were attracted by the universal vision of the 'Viswa Bharathi' ex-

periment of Tagore. The series of 'Haripura' panels using natural art materials depicted the everyday life to be observed in village India. The themes painted with a simple directness, and spontaneous brush strokes, are unique in that they derive their strength from a synthesis of Indian and Far Eastern art traditions. As a student of Abanindranath Tagore, Nandalal Bose was influenced by the Swadeshi movement which began in 1905 when Bose was in his early twenties. The Bengal School of Art style that tried to return to the achievements of Indian art in the past, remind one of the spirits that infused the pre-Raphaelite revivalist art of England that reacted against the Industrial Revolution. John Ruskin along with Edward Burne-Jones and William Morris, developed a which they believed expressed the spirit of Gothic art. The

problem of this romantic effort to go back in time to recover a lost pre-industrial culture in harmony with nature was that it lacked a real engagement with the present and future of British culture. The Bengal School of Art, though preparing the ground for an Indian style, seems to lack the vigour and spontaneous energy which can be seen in the art of Nandalal Bose.

The work of Bose, like that of his contemporary, Jamini Roy, who also studied under Abanindranath Tagore, was a break away from an imitation of the past. These artists tried to find an Indian identity in a contemporary folk art. The way that the Haripur panels show the life of everyday village culture, is reminiscent of the art of Jean Francois Millet (1814-1875) who broke from the historical themes of the Paris academic art of his day, rediscovering his native rural culture which he painted, celebrating everyday peasant life. This approach to the immediate present deeply influenced the art of Van Gogh.

A democratisation of art, draw ing from folk culture that is in direct contact with the realities of those who live close to the cy cles of nature, represents a modern outlook that draws inspiration from contemporary reality. Such an art, by being more accessible for those involved with today's political concerns, has an energy that is the source of a socially engaged vision. It is in this sense that one can see in the art of Nandalal Bose what Ananda Coomaraswamy termed a "true Swadeshi," as opposed to the "false Swadeshi" that draws from an imagined past. That is the significance of Nandlal Bose, and it carries deep messages for today's social, cultural and political environment

The Bangalore exhibition was inaugurated last month and will remain open till April 2024.

Fight against gender persecution

It has now been over two years since the US military ended its decades-long war in Afghanistan, and the world's attention has predictably shifted to the horrific conflicts in Gaza and Ukraine. But the mess left behind by the chaotic US withdrawal has not been cleaned up far from it. Since the Taliban returned to power in August 2021, the country's economic and humanitarian crises have deepened and sharpened.

Conditions for Afghan girls and women, in particular, have deteriorated rapidly, shattering their hopes for their personal and professional lives. In edict after edict, the new theocratic government has systematically stripped them of their fundamental human rights, including to an education. As a result, Afghanistan has become the only country in the world where girls are prohibited from attending school beyond the age of 11.

Millions of Afghan girls are being denied a chance to develop their talents and fulfill their dreams, putting a generation at risk of lasting damage and jeopardising the country's economic future. Worse, those girls and women who fled to Pakistan to continue their education will once again be denied schooling. Pakistani government recently ordered the expulsion of 1.7 million undocumented Afghans, around 700,000 of whom sought refuge in the country after the Taliban's takeover. But the Taliban is not a monolith: some government officials seemingly recognise the critical importance of their daughters returning to school. In November, Rangina Hamidi, an education minister before the Taliban's return to power who had just visited Afghanistan, suggested that the Taliban could be convinced to reopen girls' secondary schools.

For that to happen, however, the international community would need to engage much more actively with the Taliban, and help its more moderate voices prevail over the hardliners. Hamidi's experience, and that of others, suggests that there are increasingly apparent internal divisions within the Taliban regime over the education of girls and women. In this context, Muslimled delegations should visit

Afghanistan and meet with both the Taliban's formal governing cabinet in Kabul and its leadership council. The dire situation in Afghanistan demands urgent action. The UNFP has warned that acute malnutrition is above emergency thresholds in 25 of 34 provinces and is expected to worsen. Despite these stark figures, the Taliban's religious leadership has continued to hack away at the rights of girls and women, often to the exclusion of other policy objectives. This systematic discrimination includes not only denying girls and women access to secondary and tertiary education, but also restricting their freedom of movement, expression, and association, and prohibiting them from almost all forms of employment.

The participation of women in public life is heavily constrained, as they often cannot leave their homes without a male relative. Moreover, the Taliban has effectively removed any possibility for women to seek justice through the judicial system. After UN experts visited Afghanistan earlier this year, the Office of High Commissioner for

Human Rights concluded in a report that Taliban's discriminatory and misogynistic policies and harsh enforcement methods constitute "gender persecution and an institutionalized framework of gender apartheid."

Diplomatic recognition of the Taliban government, let alone fully normalised relations, is certainly out of the question as long as religious edicts deprive girls and women of their basic human rights. But that does not preclude the international community from taking steps to promote gender equality. One such step would be developing new channels of communication with officials who understand that Afghanistan needs to educate all young people. The internal divisions within the regime have opened a window, albeit a small one. We must seize this chance to help give the world's most oppressed girls and women the opportunity to realise their potential.

Demand for deputies

Sir, The position of Deputy Chief Minister is not mentioned in the Constitution. Despite this, the demand for this position has skyrocketed in recent years. Seven Deputy CMs have recently been appointed in freshly constituted governments in four states. As a result, the country presently has 24 Deputy CMs spread throughout 14 states. This is the most Deputy CMs ever appointed in India's political history. Although the position of Deputy CM is comparable to that of a cabinet minister in a state government, it denotes that the individual is second in command to the CM. However, the motivations for this experiment and the reasons for its technique vary in each state. Even under a coalition government, the Deputy CM formula works well. When two parties establish a government, only one of them will be appointed as CM. As a result, the deputy is picked from the other party to demonstrate that all parties are equal partners in the government. This strategy is quite effective in several states. Following the recent assembly elections, both the BJP and the Congress pursued a similar tactic. In Madhya Pradesh, Chhattisgarh, and Rajasthan, the BJP has named two Deputy CMs each. In MP, one Brahmin and one member of the SC community were appointed as Deputy CMs, while the CM was from the OBC community. Similarly, the BJP appointed a Brahmin as CM and a Rajput and a Dalit as Deputy CMs in Rajasthan. In Chhattisgarh, the BJP appointed a tribal CM and two deputies OBC and Brahmin communities. In Telangana, the Congress appointed a CM the Reddy community and a deputy from the SC community. *Abhijit Roy*, JAMSHEDPUR

Revival of political activity to rekindle regional priorities

The inherent political clash of interest owes itself to the days of the autocratic Dogra rule in the erstwhile state

Srinagar, Dec 18: Politics in Jammu and Kashmir has been driven by regional interests and challenges since 1947

Till August 5, 2019, when J&K was a state, it was whether you stood for the interests of the Valley or Ladakh and Jammu

After Ladakh became a Union Territory, it is now directly between those who claim to represent the interests of the predominantly Muslim majority Valley or the Hindu dominated

Even within the Jammu division, districts like Rajouri, Poonch and Doda with a large number of the Muslim electorate, have more affinity with the Valley rather with other districts of Jammu division like Jammu, Samba, Kathua, Reasi Udhampur and even Ramban.

Out of the 87 assembly seats in the erstwhile J&K legislative assembly, the Valley had 47 and Jammu division had 36 (Ladakh region had 4).

Given this electoral arithmetic, those who won the majority of seats in the Valley dictated the terms.

After delimitation, this disparity has been addressed by giving 46 seats to the Valley and 44 seats to Jammu division out of 90 seats for which elections would be held.

Three assembly seats, two for



the migrant Kashmiri Pandit community and one for the refugees from Pakistan occupied Jammu and Kashmir (POJK) would be directly nom-

inated by the Lt Governor. Interestingly, in contrast to the erstwhile assembly, the nominated members would have the right to vote during government

Even after the delimitation commission tried to address the disparity in representation between the two regions, political dynamics in J&K is still based on whether you stand for the wishes and aspirations of the Valley or the Jammu division.

This inherent political clash of interest owes itself to the days of the autocratic Dogra rule in the state

The Dogra rulers were Hindu Rajputs belonging to Jammu and the political movement against the last Dogra king, Maharaja Hari Singh was started by Sheikh Mohammad Abdullah, who was believed to be a devout Muslim.

The Maharaja's rule was replaced by the rule of Sheikh Mohammad Abdullah who became the chief administrator when the Maharaja fled to Jammu from Srinagar after the tribal in-

vasion of the state in 1947. The Sheikh later became the 'Wazir-e-Azam' (Prime Minister) of J&K with Maharaja Hari Singh's son, Karan Singh as the Sadr-e-Riyasat' (Head of State).

While Sheikh ruled the state, Karan Singh was just a 16-year old boy who was made the titu lar head to satisfy some constitutional legality after the accession of the state to India.

How much authority the socalled 'Sadr-e-Riyasat' wielded during the rule of the late Sheikh should become amply clear from the fact that Karan Singh donated 247 acres of land for establishing the present cam-

pus of Kashmir University, but he could not get the 'luxury' of naming even a path in the large campus after his father. Maharaja Hari Singh.

Thus since 1947, it has been politically relevant whether you stood to represent the Valley's interest or that of the Jammu di

The Valley centric parties have always ruled the state with their chief ministers heading all governments which belonged to the Valley based Muslim community.

Be it the late Sheikh or Bakshi Ghulam Mohammad, Khwaja Ghulam Mohammad Sadiq, Syed Mir Qasim, Farooq Abdullah, Omar Abdullah, Mufti Mohammad Sayeed, Ghulam Nabi Azad or Mehbooba Mufti, all chief ministers were Valley based Muslims except Ghulam Nabi Azad who though a Kashmiri speaking Muslim belonged to Doda district of Jammu

The ruling Valley centric political parties like the National Conference (NC) and the Peoples Democratic Party (PDP) had the predominant majority of seats in the assembly which belonged to the Valley with marginal presence in the Jammu division and that too in Muslim dominated districts of the division.

Today also, the Valley based political parties demand restoration of Article 370 and grant of statehood.

J&K parties demand statehood restoration

Jammu, Dec 18: The leaders of various political parties held a meeting here Monday and later staged a demonstration, demanding immediate restoration of statehood, assembly elections and extension of Article 371 to Jammu and Kashmir.

The political parties, including the Shiv Sena (UBT), National Panthers Party (NPP) and Dogra Swabhiman Sangathan Party (DSSP), also highlighted their demand for deportation of illegally settled immigrants, early return and settlement of the Kashmiri migrant Pandits and regularisation of the daily wagers.

This was the first such meeting in Jammu after the Supreme Court December 11 upheld the abrogation of Article 370 by the Centre in August 2019.

"We have taken part in the 'allparty meet' organised by the Shiv Sena and Sainik Samaj Party and highlighted our demand for immediate restoration of statehood and democratically elected government in Jammu and Kashmir." NPP chairman and former minister Harsh Dev Singh told PTI after the meeting.

The NPP chairman accused the BJP of ruling Jammu and Kashmir by a remote control over the past many years.



"Almost all the bureaucrats posted in J&K are from outside and do not know anything about the region as a result of which the alienation among the local populace is increasing with each passing day," he said.

"The democratically elected government is also an antidote against militancy, extremism and violence," Singh said, adding his party will always remain in the forefront to safeguard the interests of the people of Jammu

Manish Sahni, the president of Shiv Sena (UBT) Jammu and Kashmir, said that the meeting was organised to discuss various "burning issues" pertaining to Jammu and Kashmir, especially the Jammu region.







CT scans can increase risk of blood cancer: Study

New Delhi, Dec 18: Computed tomography (CT) scans are associated with an increased risk of blood cancers in children and young adults, according to a study published in the Nature Medicine journal.

The European Pediatric CT (EPI-CT) study, involving nearly a million patients, reveals that the radiation from these scans, which use X-rays and a computer to create detailed images of the inside of the body, might be putting youngsters at risk.

A team led by researchers at Pompeu Fabra University,

Barcelona, Spain found that there is a clear link between the radiation doses from CT scans and a higher risk of blood cancers, both lymphoid and myeloid.

The risk starts at doses as low as 10–15 units. That's a wake-up call for anyone who thought those CT scans were harmless, the researchers said.

Contrary to previous beliefs, the EPI-CT study found an increased risk of Hodgkin's lymphoma (HL), especially in the younger age groups. This demands more attention and deeper dives into the data on CT scans, the researchers said. "The risk associated with CT scans isn't negligible, and it's not



just for rare cases - we're talking about a 16 per cent increased risk for these blood cancers per scan. That's not a number to be brushed off lightly," the authors of the study said.

"In terms of absolute risk, among 10,000 children who receive such an examination today, we expect about 1.4 cases due to CT radiation during the 12 years after the examination,' they said. The study acknowledged the benefits of CT imaging in patient management, for diagnostic efficacy, treatment planning and follow-up, are undisputed. The research doesn't just point

fingers, it urges action, the researchers said. From rethinking the necessity of CT scans to ensuring that radiation exposure is kept as low as possible, the implications are clear, they said.

'The EPI-CT study, encompassing over one million European children, reveals a concerning association between cumulative CT scan radiation exposure and childhood hematological malignancies," said Dr. Ravinder Singh, Consultant Radiology, Ujala Cygnus Group of Hospitals, New Delhi.







Cyberattack hits Iran's gas stations

Tehran: Nearly 70% of Iran's service Monday following possible sabotage - a reference to cyberattacks, Iranian state TV reported. The report said a "software problem" caused the irregularity in the gas stations. It urged people not to rush to the stations that were still operational. Israeli media, including the Times of Israel, blamed the problem on an attack by a hacker group dubbed "Gonjeshke Darande" or predatory sparrow. State TV quoted a statement by the Oil Ministry as saying more than 30% of gas stations remain in service. The country has some 33,000 gas stations.

The attack took place at dawn in the town of Salvatierra when an armed group opened fire on partygoers attending a posada, a traditional Mexican party held in the days leading up to Christmas.

BP pauses all Red Sea shipments after attacks

In the past few days, four of the five world's largest container shipping companies have paused or rerouted movements through the Red Sea

London, Dec 18: Oil and natural gas giant BP has joined the growing list of companies that have halted their shipments through the Red Sea because of the risk of attack from Yemen's Houthi rebels, threatening a major trade route in what is expected to have global effects.

London-based BP said Monday that it has "decided to temporarily pause all transits through the Red Sea," including shipments of oil, liquid natural gas and other energy supplies. Describing it as a "precautionary pause," the company said the decision was under ongoing review but that it was prioritizing crew safety.

Oil prices rose Monday partly over market nerves about attacks by the Iranian-backed Houthis, which have targeted container ships and oil tankers passing through a narrow waterway that separates Yemen from East Africa and leads north to the Red Sea and Suez Canal, where an estimated 10% of the world's trade passes through.

The Houthis have targeted Israeli-linked vessels during Israel's war with Hamas but escalated their attacks last week, hitting or just missing ships without clear ties. In the past few days, four of the

Food is running scarce for the territory's 2.3 million people, basic services have collapsed, and most people are homeless.

In its report, HRW accused Israeli forces of deliberately blocking delivery of water, food and fuel, razing agricultural areas and depriving people of items needed for survival.

The big one: Preparing for a long war with China

ver the past decade, the prospect of Chinese military aggression in the Indo-Pacific has moved from the realm of the hypothetical to the war rooms of US defence planners. Xi Jinping has accelerated his country's military buildup, now in its third decade. China has become increasingly assertive across a wide swath of the Pacific, advancing its expansionist maritime claims and encroaching on the waters of key US allies and important security partners, including Japan, the Philippines, and Taiwan. Xi has asserted, with growing frequency, that Taiwan must be reunited with China, and he has refused to renounce the use of force to achieve that end. With the US distracted by major wars in Europe and the Middle East, some in Washington fear that Beijing may see an opportunity to realize some of these revisionist ambitions by launching a military operation before the West can react.

A military confrontation between China and the United States would be the first greatpower war since World War II and the first ever between two great nuclear powers. Given the concentration of economic might and cutting-edge technological prowess in Japan, South Korea, and Taiwan-all three advanced democracies that are either close allies or partners of the United States—such a war would be fought for very high stakes.

As was the case with the Soviet Union and the United States in the late twentieth century, both China and the United States possess the ability to destroy the other as a functioning society in a matter of hours. But they can do so only by running a high risk of incurring their own destruction by provoking a nuclear counterattack, or second strike. This condition is known as "mutually assured destruction," or MAD. Of course, Beijing's nuclear

balance of power with Washington is significantly different from that of Moscow during the Cold War, when the United States and the Soviet Union achieved a rough parity in forces. China's nuclear arsenal is a fraction of the size of the United States', although Beijing is pursuing a dramatic expansion with the goal of matching the U.S. strategic arsenal within the next decade. Nevertheless, even now the Chinese arsenal is large enough that if China were attacked, it would have sufficient



nuclear forces left to execute a retaliatory strike on the United States—thus bringing about

There are many ways that a war between China and the United States could start. Given China's ambition to dominate the Indo-Pacific. such a war would very likely involve the socalled first island chain, the long arc of Pacific archipelagoes extending from the Kuril Islands north of Japan, down the Ryukyu Islands, through Taiwan, the Philippines, and parts of Indonesia. As many in

Washington have argued, Taiwan is the most obvious target, given the island's strategic location between Japan and the Philippines, its key role in the global economy, and its status as the principal object of Beijing's expansionist aims. China's military has been increasingly active in the Taiwan Strait, and the PLA has massed its greatest concentration of forces across from the island. In the event of a Chinese attack on Taiwan, the United States would be compelled to defend the island or risk having key neutral countries and even allies drift toward an accommodation with Beijing.

Yet the Taiwan Strait is not the only place a war could begin. China has continued its incursions into Japan's airspace and its provocative actions in the exclusive economic zones of the Philippines and Vietnam, raising the possibility of a war-provoking incident. Moreover, tensions between North Korea and South Korea remain high. If fighting broke out on the Korean Peninsula, the United States might dispatch reinforcements there, causing Beijing to see an opportunity to settle scores at other points along the first island chain.

Once a war has broken out, both China and the United States would have to confront the dangers posed by their nuclear arsenals. As in peacetime, the two sides would retain a strong interest in avoiding catastrophic escalation. Even so, in the heat of war, such a possibility cannot be eliminated. Both would confront the challenge of finding the sweet spot in which they could employ force to gain an advantage without causing total war. Consequently, leaders of both great powers would need to exercise a high degree of self-control.

To keep the war limited, both Washington and Beijing would need to recognize each other's redlines-specific actions viewed as escalatory and that could trigger counter escalations. Efforts toward this end can be enhanced if both sides can clearly and credibly communicate what their redlines are and the consequences that would be incurred for crossing them.

Given the potential for uncontainable nuclear escalation, it is not unreasonable to assume that both China and the United States would err on the side of caution when considering how and where to intensify military operations. But the imperative on both sides to avoid nuclear escalation would not only create parameters for the objectives sought and the means employed to achieve them. It would also set the stage for a conflict that could likely be prolonged since both sides would have very significant resources to draw on to keep fighting. In this way, the war's containment in one respect would also facilitate its broadening in others.

To prevail in a war with China, then, the United States and its coalition partners will need to have a strategy not only for denying Beijing a quick victory but also for sustaining their own defences in a long war.

ACL going green

New Delhi: Ambuja Cements Ltd, owned by Adani Group, on Monday said it will invest Rs 6,000 crore in 1,000 MW renewable power projects by FY26. In a statement, the Indian Sugar Mills Association (ISMA) said that the sugar production till December 15 in the current 2023-24 marketing year reached 74.05 lakh tonnes against 82.95 lakh tonnes in the corresponding period of the previous year.

Siemens spin-off

New Delhi: Siemens Ltd board has approved the incorporation of a wholly-owned subsidiary in India to execute a proposed demerger process of its energy business, the company said in a regulatory filing Monday. Certain promoters -- namely Siemens Aktiengesellschaft, Germany, Siemens International Holding BV and Siemens Energy Holding BV, and also its ultimate parent company Siemens Energy Aktiengesellschaft -- have each requested the board of directors (BoD) of the Siemens Ltd to consider, evaluate and thereafter, start taking exploratory steps towards a potential demerger of its energy business into a separate entity, the BSE filing said.

ICRA REVISES GDP FORECAST TO 6.5%

Mumbai, Dec 18: Domestic rating agency Icra Monday revised its FY24 GDP growth forecast to 6.5 per cent from 6.2 per cent earlier. However, the revised forecast is still much lower than the Reserve Bank of India's (RBI) 7 per cent real Gross Domestic Product (GDP) growth estimate for the ongoing fiscal.

Earlier this month, the RBI had revised upwards its GDP estimate to 7 per cent from 6.5 per cent, calling the revised number a "conservative" one.

The rating agency did not specify reasons for the lower growth estimate made in its business activity monitor.

The revision is being done because Icra feels the deflation in commodity prices will be sustained and there are expectations of better growth in the October-December period than previous estimates, it said.

"The festive-led uptick in volume growth in high frequency non-agri indicators as evinced by ICRA Business Activity Monitor in October-November 2023 (11.3 per cent versus the 9.5 per cent in Q2FY24) leads us to believe that the GDP growth is likely to fare better in Q3 FY2024 than what we had penciled in," it said.

It added that the global commodity prices have remained benign in the ongoing quarter, partly owing to growing demand concerns from China, adequate supplies for commodities like crude oil. and normalisation of supply chains.

While October and November have seen higher activity, the early trends for December are mixed, the agency said, pointing to a moderation in electricity demand growth, a rise in daily vehicle registrations, and a contraction in diesel sales.

The diminutive left-hander has shown that he has the technique and temperament to succeed on South African tracks that offer way more bounce compared to the sub-continent pitches.

However, the Indore-based right-hander Patidar had made it to Indian ODI team back in 2022 itself but in the past one year had to struggle and underwent a heel surgery earlier

The Indian team management has very specific roles for players and while Rinku is being looked upon as a finisher at No.6, the 30-year-old Patidar is more of a specialist No.4 when he bats for his state team Madhya

Hence, with Iyer, a right-hander vacating a slot in the playing XI, his like-for-like replacement



No.6 slot currently has been given to Sanju Samson, who is playing as a specialist batter behind skipper KL Rahul, who is donning the big gloves.

As has been the template of national team managements, they would like to give Samson, who is senior to Rinku, a fair go at that slot before turning to the southpaw. However Rinku's brilliant List A record (near 50 average) will force the team management to give him a go.

In fact, both Rinku and Patidar could get a go but in that case, Tilak Varma, who got to face just a couple of deliveries in the opening game, will have to be dropped from the playing eleven. That doesn't seem very logical at the moment.

The opening game witnessed the debut of young left-handed opener B Sai Sudharsan, whose

New Delhi, Dec 18: India cricketer Sunil Gavaskar reckons that Hardik Pandya, as the new leader,

will bring in "fresh thinking" in the Mumbai Indians camp as Rohit Sharma appeared fatigued and has not contributed enough with the bat in the last few years.

The India T20 skipper was traded to Mumbai Indians ahead of the 2024 IPL auction, scheduled to take place in Dubai

Rohit and Chennai Super Kings skipper MS Dhoni are the most successful captains in the IPL, guiding their teams to five titles each in the lucrative league. However, Mumbai Indians have gone without a title since 2021, finishing last in the 2022 edi-

Gavaskar said that it could be because Rohit is "fatigued" since he has been playing continuously not only as IPL team skipper but also as the India

"See, we don't have to look at it (decision appoint Hardik as MI captain) as right or wrong. The decision they (MI) have taken has been for the benefit of the team. We can say that the contribution of Rohit, even with the bat, has become slightly lesser," Gavaskar told Star Sports.

"Earlier, there used to be a lot of contribution (with bat) from Rohit, but in the last few years. they have finished at No.9 or 10. And last year they qualified for the playoffs, but the 'josh' (enthusiasm) of Mumbai Indians was not there to be seen as we have seen in the past.

"Maybe because he has played cricket continuously he must have been fatigued, constantly captaining the Indian side and then Mumbai Indians," added Gavaskar.

Hardik, after leading Gujarat Titans to title triumph in the team's inaugural year in 2022 also led his side to runners-up fin-



ish this year. The cricketerturned-commentator felt Hardik has proved himself for the Gujarat franchise and his return to Mumbai Indians will infuse fresh ideas into the side.

"So, the decision that they have taken, he is a young player, young in terms of captaining a side, who has proven himself, taking Gujarat Titans to the finals twice and winning it once.

"So with the same thought process, they have made him captain. Because sometimes you need that fresh thinking, and he can bring that fresh thinking and I think the decision that has been taken, Mumbai Indians can benefit from it and won't damage them," he added.

Former India all-rounder Irfan Pathan said the biggest challenge for Hardik at Mumbai Indians would be to manage senior players like Rohit, Suryakumar Yadav and Jasprit ers themselves. "Hardik will have to learn to manage these guys and it will be his biggest challenge. And this won't be easy for him," said Pathan.

He compared Rohit's stature with that of Dhoni, saying the stalwart had built the Mumbai franchise with his hard work and commitment. "The stature that Rohit Sharma has in Mumbai Indians, I think it can be compared to the stature that Dhoni has in CSK. He has made this team with his own hard work and dedication

through his captaincy. "He's a great captain who has carried this team for years and last year, with the team they had, many people thought they could qualify for the playoffs. They qualified, even though they didn't have (pacer) Jofra Archer and their bowling was light.

"Even their form wasn't good. They didn't have the facilities of Bumrah (who was recovering from injury," said Pathan.

Man United frustrate Liverpool in 0-0 draw

Liverpool, Dec 18: Erik ten Hag needed this. A 0-0 draw at Liverpool in the Premier League Sunday won't win any beauty pageants, but a stubborn and battling performance at Anfield suggests Manchester United's players are up for the fight. On too many occasions this season, the opposite has looked to be the case.

United had folded at the home of their fiercest rival when routed 7-0 on their last visit in March. With Ten Hag facing speculation over his position and his team eliminated from the Champions League at the earliest stage, he upset the odds to end Liverpool's 100% 11-game winning run at Anfield this season and also put a dent in Jurgen Klopp's bid to win the Premier League title. A draw saw Liverpool knocked off the top of the table and into second place by Arsenal, which beat Brighton 2-0 and travels to Anfield Saturday.

Ten Hag will be more concerned about United's fortunes and, while a gutsy display will not totally shut out talk of a crisis at Old Trafford, it gives the Dutch coach something to build on.

It was a frustrating day for Liverpool, which dominated the possession and chances, though Rasmus Hojlund's second-half effort from close range for United was arguably the best opening

created by either team. It was United's first draw in the league this season, having won nine and lost seven of its 16 games going into the match. The result leaves Ten Hag's team six points off fourth-place Manchester City. Second-place Liverpool is one point behind Arsenal and above third-place Aston Villa on goal difference.

Real thrash Villarreal, go to top

Madrid, Dec 18: Real Madrid lead the Spanish league after beating Villarreal 4-1 but lost defender David Alaba with a serious knee injury Sunday.

Jude Bellingham, Rodrygo, Brahim Diaz and Luka Modric scored for Madrid, which moved one point ahead of Girona ahead of the Catalan club's home game against Alaves Monday. Madrid are seven points ahead of thirdplaced Barcelona. The defending champions drew 1-1 at Valencia

Alaba had to be helped off the field at the Santiago Bernabeu before halftime when his left knee buckled while he tried to steal the ball from an opponent near midfield. The Austria defender fell and immediately called for help while grabbing his knee. He couldn't put weight on his left leg while being carried off the field in the 34th minute.

Madrid said after the match that Alaba ruptured the anterior cruciate ligament and will need to undergo surgery in the next few days. The club did not immediately say how long he is expected to be sidelined.

It was the latest serious knee injury for Madrid this season. The club is already without goalkeeper Thibaut Courtois and defender Eder Militao because of cruciate ligament injuries that are expected to keep them out of action for a long period. Eduardo Camavinga and Arda Guler also

Bellingham has seven goals in his last nine matches with the club.

Diaz scored the third goal after a beautiful run that started near the midfield line in the 64th. He cleared two defenders before finding the net from inside the area. Modric closed the scoring with another shot from inside the box in the 68th.

Jose Luis Morales scored in the 54th for Villarreal, who haven't won in three straight league matches and have dropped to

14th place. Villarreal have nine losses in 17 league matches so far, their worst run at this point of a season.

Villarreal had been the last team to beat Madrid in the league at the Bernabeu, winning 3-2 last season. That was Madrid's only loss in their last 31 league matches as a host. They lost both of their league matches against Villarreal last season.

Mansi and Murugesan, ranked second in World Para-Badminton, outwitted the Indonesian pair of Leani Ratri Oktila and Khalimatus Sadiyah 15-21, 21-14, 21-6 to secure the gold in women's doubles SL3-SU5 category.

Bhagat, also a Para Asian gold medallist, went down 17-21, 18-21 to England's Daniel Bethell in the SL3 final to finish second best. In mixed doubles SL3-SU5 category, Bhagat and Manisha Ramdass went down to Indonesia's Hikmat Ramdani and Leani Ratri Oktila 14-21, 11-21 in the final.

Team India also secured bronze medal in mixed doubles SL3 and SU5 with Kumar Nitesh and Thulasimathi Murugesan. In the men's SL 4 category, Tokyo silver medallist Suhas Yathiraj secured silver, while Sukant Kadam and Tarun won bronze medals. In the women's singles (SL4) Palak Kohli bagged a bronze.

In men's doubles SL3-SL4 category, Manoj Sarkar and his Korean partner Cho Nadan secured silver, while Kumar Nitesh and Tarun secured bronze.

New Delhi, Dec 18: Reigning champions Odisha FC were Monday clubbed with last edition runners-up Bengaluru FC (BFC) in the same group for the Super Cup football tournament to be played in Bhubaneswar from January 9 to 28.

Another Indian Super League side FC Goa and an I-League club (which will be known after qualifying play-off) will make up the four-team Group D, according to the group stage draw held here.

Odisha FC, which recently qualified for the AFC Cup interzone playoff semifinals, had beaten BFC in the 2023 Super Cup final in Kozhikode, Kerala. Kolkata rivals Mohun Bagan and East Bengal were also clubbed together in the same



The national team players from various clubs will, however, miss the whole or most part of Super Cup tournament as they will be playing in the AFC Asian Cup in Doha, beginning January 12.

Sixteen teams (12 from ISL and four from I-League) will take part in the tournament and they will be divided into four groups of four teams each.

The top-ranked team from each group will progress to the semifinals. The winner of the final, to be played January 28, will earn a ticket to the 2024-25 AFC

Champions League 2. Five I-League teams – Gokulam Kerala FC, Sreenidi Deccan FC, Shillong Lajong FC, Inter Kashi and Rajasthan United FC - confirmed their participation in the Super Cup. The top three of these four teams, as per the December 24 I-League standings, will qual-

ify directly for the tournament. The bottom two teams will play in a single-leg qualifying playoff January 9 to determine the fourth and final I-League team in the group stage.

The teams were divided into four pots, with the 12 ISL teams placed in pots 1-3, according to their points per match in the 2023-24 ISL as of December 17.
