Bukhari fleeced girls by taping them nude

Bhubaneswar, Dec 20: The investigation into the suspected terror-links of Kashmiri man Sayed Ishaan Bukhari who had been arrested for impersonating a PMO official and a doctor last week, has revealed that the imposter would entrap many girls by engaging them in nude video calls, and later extort them by threatening to make the tapes viral.

Bukhari has been booked for fraud, impersonation and a host of IPC Sections pertaining to breach of trust and criminal conspiracy.

A source privy to the interrogation of the accused, said that Bukhari, a native of Kupwara in J&K had been living in Neulpur area of Jajpur by masquerading as a doctor.

Though he was married to a woman in the locality, this didn't stop him from developing relationship with multiple women from across the country through a special app which he had developed for the purpose of trapping them. Sources said his diabolic plan involved pushing them into a honey-trap ring.

Sources said he would also extort these women after engaging them in disrobed video calls on the app by threatening to upload the contents on social media platforms.

Investigators of the Crime Branch Special Task Force, which obtained his five-day remand and brought him to custody from the Ragadi sub-jail in Jajpur to Bhubaneswar, Tuesday, have learnt that Bukhari has nine bank accounts and as many as two girls from Odisha were in touch with him.

Meanwhile, officials from multiple Central agencies are also interrogating Bukhari.



New Delhi, Dec 20: The Union government will introduce new technologies, including GPSbased toll collection systems, by March next year to replace ex-

isting highway toll plazas, Union

Minister Nitin Gadkari said

Wednesday. The move is aimed at reducing traffic congestion and charging motorists for the exact distance travelled on the highways.

"The government is looking at new technologies, including GPSbased toll systems to replace toll plazas in the country... We will start new GPS satellite-based toll collection across the country by March next year," he said.

Gadkari also said the road transport and highways ministry has conducted two pilot projects of automatic number plate recognition system (automatic number plate reader cameras) to enable automated toll collection without stopping the vehicles.

During 2018-19, the average waiting time for vehicles at toll plaza was eight minutes. With the introduction of FASTags during 2020-21 and 2021-22, the average waiting time of the vehicles was reduced to 47 seconds.

Although there is considerable improvement in waiting time at certain locations, especially near cities, in denselypopulated towns, there are still some delays at toll plazas during peak hours

Telecom Bill gets Lok Sabha nod

NEW DELHI: A Bill allowing the Centre to temporarily take control of telecom services in the interest of national security, and providing a non-auction route for allocation of satellite spectrum was approved by the Lok Sabha, Wednesday. The Telecommunications Bill, 2023, which was passed by a voice vote after a short debate, also allows the Centre to take possession of a telecom network in case of any public emergency or in the interest of public safety. Most of the opposition members did not attend the House following their suspension.

Colorado SC blow to Trump

WASHINGTON: In a stunning verdict, the Colorado Supreme Court has barred Donald Trump from running for president next year in the state citing his role in the unprecedented attack on the US Capitol in 2021 and ordered the exclusion of his name from the state's Republican presidential primary ballot. The disqualification of the 77-year-old former

president Tuesday was based on the Constitution's 14th Amendment, which says officials who take an oath to support the US Constitution are banned from future office if they "engaged in insurrection." The 4-3 ruling by the 7member Colorado Supreme Court does not apply outside of the state.

Odisha plans 11 new anti-Maoist camps

BHUBANESWAR: Odisha Police Wednesday said it would set up 11 new CRPF/BSF camps in remote areas of the state to take on the Maoists. This was revealed by Director General of Police (DGP) Sunil Kumar Bansal after inaugurating the strategy conference on Left-Wing Extremism (LWE) here. "We have plans to set up 11 new company operation bases of CRPF/BSF in remote areas as Maoists may unleash violence to make their presence felt," Bansal said.

21 cases of new Covid sub-variant JN.1 found

New Delhi, Dec 20: As many as 21 cases of Covid-19 sub-variant JN.1 have been detected across the country till now, NITI Aayog member (Health) VK Paul said Wednesday but asserted that there was no need to panic.

He said that the scientific community in India was closely investigating the new variant as he emphasised on the need for states to ramp up testing and strengthen their surveillance systems. Paul highlighted that about 91 to 92 per cent of those infected are opting for home-based treatment.

According to official sources, 19 cases of the sub-variant JN.1 have been traced in Goa while one each was found in Kerala and

Maharashtra. Over the past two weeks, 16 deaths related to Covid-19 were recorded with the victims having serious comorbidities. The Centre has asked states and Union territories to maintain a constant vigil amid an uptick in Covid-19 cases and the detection of the new JN.1 variant in the country.

Health Minister Mansukh Mandaviya Wednesday reviewed the preparedness of health facilities across the country and stressed on being alert against emerging strains of coronavirus.

Union Health Secretary Sudhansh Pant said even though cases are increasing, 92.8 per cent of the cases are in home isolation.



Bhubaneswar, Dec 20: The Commissionerate Police arrested a man for faking the kidnap of his 11-month-old son to get rid of his wife, DCP Prateek Singh said here, Wednesday.

The police have also apprehended three others, including the first husband of the victim's mother, for their involvement in the crime.

The accused were identified as Subrat Sethi of Marthapur, Bishnu Prusty of Bhuban area in Dhenkanal district, Braja Kishore Nath and Sarat Mohanty of Madhupatna area in Cuttack

Police Tuesday received a complaint from Subrat claiming some miscreants had snatched away his baby boy from near Patia Railway crossing. The City police soon swung into action and started searching for the baby by registering a case on the basis of Subrat's complaint.

However, later the police grew suspicious about Subrat when they found inconsistencies in his statements regarding the incident. During questioning, Subrat spilled the beans and revealed the kidnapping plot, said police.

"The boy's mother, Shantilata Maharana had married to one Bishnu around 10 years back. Following some marital disputes,

she eloped with Subrat around two years back. The boy was later born out of the relationship between Subrat and Shantilata,' said DCP Singh.

Singh further said that the relationship between Subrat and Shantilata was going through rough patches since the last two months. Subrat was trying to part ways with Shantilata while Bishnu was planning to mend ways with her.

Subrat and Bishnu teamed up and hatched a plan over telephone around 15 days back to get rid of the child. Accordingly, Subrat orchestrated the kidnapping drama and handed over the child to Bishnu who later give him to the former's friend Sarat who was childless. As per plans, Subrat would have pressurised Shantilata to return to Bishnu, police said.

Singh said after the accused confessed to the crime, a team of Mancheswar police rescued the child from Sarat's residence at Madhupatna in Cuttack. Police also arrested another friend of Bishnu, Braja Kishore who had arranged a vehicle that was used to transport the child.

Braja Kishore, Sarat and Bishnu work at the Forest Department saw mill in Khapuria area of Cuttack while Subrat is a house painter.

Man held after son's MUZZLING MEDIA, INTRUDING PRIVACY

Bhubaneswar, Dec 20: The Modi government's 46-page Telecommunications Bill, 2023 which was tabled in the Lok Sabha earlier this week - and passed with a voice vote amid almost empty Opposition benches Wednesday - has invited sharp criticisms from legal community, civil rights bodies and activists, though the industry has welcomed the legislation, quite expectedly.

While the concerns stem from the ground that the Bill allows the government to temporarily take control of telecom services in the interest of 'national security' and drops OTT in definition of telecom services, the non-auction route (through administrative assignment) for allocation of satellite spectrum is being dubbed by IAMAI as an initiative towards transparency.

Nevertheless, an impugned provision of the Bill that allows the government to intercept or detain communications (press

messages), by journalists meant for publication in India, for 'public emergency' has been viewed as an attempt to muzzle open speech and press freedom.

The fears are not unfounded given the government action against platforms like X or BBC even before the introduction of the Bill. Calling the definition of 'telecom service' in the Bill 'ambiguous', the internet freedom foundation (IFF) was quoted by The Quint as stating that it exacerbates privacy invading provisions such as the obligation of any authorised entity, as notified by the Union government, to identify the person to whom it provides telecom services, through use of any verifiable biometric-based identification 'as may be prescribed.

Tanu Banerjee, Partner at Khaitan & Co, told Orissa POST that while in the Telecom Bill 2022 internet- based communication services and OTTs were specifically included in the definition of 'telecommunication services', the 2023 Bill does not specifically include

such online platforms. "Many definitions in the Bill appear to be wide. In the event of inclusion of online platforms, these will be regulated at par with telecom companies, requiring authorisation from the government for operating in India; and being subject to the government's power to intercept, which in turn will dilute the benefits of encryption and raise concerns around user privacy,'

Noted lawyer and writer on democracy, Apar Gupta, termed the Bill as 'another action to cement authoritarian control over

the rights of ordinary citizens'. He said its impact will be felt directly as there is a clear power for the Union government to regulate and license services such as WhatsApp, Signal, and

Gmail, and may enable the gov-

ernment to weaken privacy and

increase snooping in future. He was apprehensive about the likelihood of KYC requirements for OTT applications like WhatsApp. "This may mean another attempt by the government to force people to use Aadhaar as the single point of sign-up (mandatory) despite the Supreme Court in KS Puttaswamy clearly stated this was impermissible," he said in a post on X.

Journalist and digital rights activists Nikhil Pahwa said the Bill is a pro-telco and anti-internet legislation.

He said a cursory glance at the Bill makes it clear that the definition of 'message' applies to email, cloud, SAAS and streaming. While messaging platform WhatsApp has challenged interception of online messaging and calling, the government has apparently sought to bypass the bar under IT rules by cleverly defining messaging, telecommunications and telecommunication services under the Bill.

On the provision authorising the government to take over an online service for 'national security, friendly relations with foreign States, or in the event of war', Pahwa, in a post on X said, "Reminds me of China's regressive intelligence law. Remember: national security is not defined in law, and even the SC doesn't want to go there...

State govt to promote non-violent silk production under 5T

Bhubaneswar, Dec 20: Silk is the strongest and fastest natural fiber in the world. In India, four types of silks are produced, namely Eri, Mulberry, Tasar and Muga. Eri and Tasar farming has been going on for many vears in our state. In a controlled climate and clean atmosphere, the above crop is cultivated by the farmer in his own house or paddy field.

Previously, in order to remove the thread from the cells produced by Eri Worm Farming, the cells had to be boiled in hot water, thereby killing the living insects that were dormant in the cells. So we had to sacrifice the lives of millions of innocent silkworms for growth of the garment industry through a violent process

Realizing the uncompassionate approach towards the silkworms, the state government decided to start a pilot project for production of nonviolent silk under 5Ts initiatives in the year 2022. In this endeavour, attempts were made to plant castor trees and cultivate Eri silk for the development and growth of the textile industry. In this, about 700 Eri farmers were adopted for promotion of Castor based Ericulture to allow the inno-



cent silkworms to complete their natural life cycle without being killed with hot water. Similarly, under the second year pilot project, more than 2,000 Eri farmers in 12 districts of the state have been engaged and their produced cocoons have been processed through nonviolent methods

The 4 basic cycles adopted in the above pilot process are, 1-Cultivation of high quality castor as the host plant, 2- Rearing of Eri silkworms, 3- Allowing the cocoons produced by the silkworms to complete their life cycle (butterflies) in the natural system, 4- Production for nonviolent sacred silk for clothing and cosmetics by using the silk shells left by the silk moth.

Today, in our fastest way to produce sacred silk, we have saved the lives of a millions of silkworms and the products produced are more popular in the form of 'Karuna Silk'. For the first time, Gita GobindPatta prepared by 'Karuna Silk' has been given to Shree Jagannath Temple, Puri. The government has decided to promote non-violent silk production and name this natural silk brand as

'Karuna Silk' in coming days. The above initiative of the government is expected to help the livelihood of sericulture farmers, spinners and weavers in the days to come and our state's 'Karuna Silk' is expected to hold its place in the world market.

S imilipal Tiger Reserve, the only place on earth where genetically mutated Royal Bengal tigers with distinctive dark stripe patterns are found, boasts of sheltering more than 10 such black big cats. Black tigers were first officially recorded in the forests of Similipal in 1975-76.

According to wildlife experts, the reserve, an isolated landscape as it does not have contiguity with other tiger reserves, offered little scope for tigers to mate with big cats of neighbouring reserve. This has led to in-breeding (mating among themselves) and thus the offspring developed genetic mutation in the form of black

pigmentation called 'melanism'. This has important implications for tiger conservation as such isolated and inbred populations are prone to extinction over even short periods of time.

After 3 decades, the death of a rare black tiger was reported this year in Odisha's Similipal tiger reserve. Carcass of the melanistic male big cat was found in the core areas of the reserve May 1. According to experts, death of a male tiger will definitely affect the breeding of tigers, thereby impacting population of the rare animals in their lone habitat in the whole world.

Forest department said the three-and-half-year-old tiger died due to a territorial fight with another male as indicated by the scars on its body.

Some wildlife experts also expressed doubt over infighting angle as the injuries were not clear enough to suggest even prima facie infighting. As the tiger was found dead close to a water source, there is every likelihood that it had been poisoned

King goes the extra mile to settle in Odisha

The incredible odyssey of a male

A Royal Bengal Tiger, which traversed an impressive 2,000 km, roaming across four states in over five months, in search of a home and a mate. left the forest officials and wildlife enthusiasts in awe. Word spread in November when it was sighted in the majestic Mahendragiri mountains of Gajapati district, where tiger sightings had never been recorded

before. The king was out to explore new territory. The clandestine expedition of the tiger unfolded in September when it was first captured by a trap cam-

era within the Parlakhemundi forest division. The image was sent to the Wildlife Institute of India (WII) for mapping, and they confirmed that the camera-trapped image matched with a tiger previously photographed in the Tadoba landscape under Bramhapuri forest di-

vision of Maharashtra's Vidarbha. The tiger likely journeyed through Chhattisgarh and Andhra Pradesh before arriving in Odisha. The road distance alone spans 700 km, implying that the tiger navigated through forested areas, venturing into new territories, and the actual distance covered might surpass 2,000 km. The initial report of the tiger's movement surfaced near

Gunupur in Rayagada district in July 2023. The tiger's route took it to Andhra through the Parvathipuram Manyam district in August, later proceeding to Srikakulam. In September, the tiger once more approached the bordering region of Odisha, re-entering the state. For two months, the tiger oscil-

This may perhaps be the second-longest

tiger dispersal in the country. It must have crossed many hurdles including water bodies, ravines, mines, agricultural fields, roads. and even human habitats. Yet, there is no record of the animal attacking humans. What makes this journey remarkable is that, this tiger was not radio-collared. The unique pattern in its stripes paved the apex predator also raised the prospect of Mahendragiri getting the biosphere reserve tag

eventy-five years ago, United Nations member states meeting in Paris adopted the Universal Declaration of Human Rights. It was not a binding law, only a statement of principle. But it was the first declaration to embed an ancient moral ideal of human equality into the new architecture of international law established in response to the genocidal nationalism that had left so much of the world in ruins after World War II.

This new moral universalism asked us to turn our backs on our instinctive partiality for members of our own tribe. It asked us to look past salient differences - race, creed, gender, class, national origin, language – and contemplate our shared humanity. But many at the time wondered whether we were capable of such a radical experiment. As Hannah Arendt observed in 1948, "It seems that a man who is nothing but a man has lost the very qualities which make it possible for other people to treat him as a fellow-man.'

The defenseless prisoners of Auschwitz-Birkenau had discovered that their claims as human beings - to pity and decency, let alone to rights - meant nothing to their tormentors. Only if such defenseless people had a state to protect them, Arendt argued, would they be safe. The uni-

versal human being in all of us would have "the right to have rights" only if we all enjoyed the protections of citizenship.

Until 1989, the declaration's utopian hopes were confined largely to the West. Former colonial peoples had never been part of the original negotiations that led to the declaration, and in the early decades of the Non-Aligned Movement, they generally resented Western criticism of their new regimes.

Meanwhile, nation-states across the Soviet empire contested the UN declaration's legitimacy outright. The USSR and its satellites had abstained from the original vote, believing that the socialist rights they advocated were superior to the individual rights enshrined in the declaration. Only after the Berlin Wall came down in 1989 did it become possible to believe that the whole world had at last embraced moral universalism.

Of course, such optimism seems hopelessly naive today, given the situation in Ukraine, the Middle East, Sudan, Myanmar, and elsewhere. The legal architecture built after 1945 to prevent the recurrence of our barbarous past appears to be in ruins. Russia's war on Ukraine violates the UN

Charter itself; Hamas' own founding charter explicitly calls for the elimination of the Jewish people; and Israel's bombardment of Gaza seems cruel and unwise - even if it skirts accusations of war crimes under the Geneva Conventions

But to blame this state of affairs on previous and current leaders may mask a larger truth: that the moral universalism of human rights asks more of most human beings than they can manage. Anyone who is not Palestinian, Jewish, or Israeli ought to find moral universalism a relatively easy discipline; yet consider how the world has divided into rigid camps as the Gaza catastrophe has unfolded

For those living through the current nightmare, exhibiting a universalist empathy seems like a non-starter. On one side, a people who live with the ancestral memory of the Holocaust cannot be expected to feel anything but dread after Hamas' atrocities October 7. To seek revenge – or at least to re-establish deterrence with an overwhelming military response – is only too human. On the other side, a people who are descendants of refugees driven out of Mandate Palestine in 1948, and who have now been under continuous bombardment for weeks, cannot be expected to relate to any pain or fury other than their own.

If there is a lesson in all this, it is not to jettison the moral intuition that underpins human rights. Look closely and you will find that compassion and empathy are as resilient as cruelty and vengeance, even among those trapped in the cauldron of war. You will see Israeli and Palestinian moral universalists still committed to peace with justice. They are the ones who vindicate the sentiment underlying the Universal Declaration

A remarkable feature of this catastrophic conflict, stretching back to 1948, is that there has never been a shortage of moral universalism on either side. The real problem is not the absence of empathy or compassion among those caught in the conflict (though recent events have certainly sapped these moral resources). Rather, it is the presence of malignant, murderous spoilers on both sides. The fate of two leaders who did make peace – Israel's Yitzhak Rabin, killed by a Jewish extremist: and Egypt's Anwar el-Sadat, killed by Islamist fanatics – has been a powerful deterrent even for those who know that peace is the only viable

Unless we concede that Rabin and Sadat's shared vision died with them, the moral writ of the Universal Declaration remains valid in its insistence that all human beings suffer alike. Peace can still be achieved through the mutual recognition of pain and loss, but not until the spoilers on both sides - the settlers rampaging the West Bank and driving Binyamin Netanyahu's government toward annexation and expropriation, and the jihadist militants who want nothing but to destroy Israel – are beaten.

By itself, moral universalism commits us simply to recognise the humanity of others and the reality of their suffering. The Universal Declaration tells us we should respect the rights of others and ensure that they are not violated. But it does not tell us how. For that, we must engage in politics, where hard choices impose themselves.

That brings us back to Arendt's critique of moral universalism – that in the absence of a state with the authority to recognise and uphold rights, a person is "nothing but" a human being. By this logic, the twostate solution in the Middle East is the only path to peace and justice, because statehood is the only guarantor of universal human rights. Only through two states can the spoilers be defeated - and the moral universalism of the UN declaration finally win out.

PSYCHOLOGY OF COLONIALISM

THE ENCOUNTER **BETWEEN THE COLONISER AND** THE NATIVE **POPULATION IS MEDIATED AND SUSTAINED THROUGH VIOLENCE**

uch has been written about the social, historical and economic effects of colonialism. Scholars have credibly argued that colonial subjugation has a prominent role to play in the degradation of stable economies of colonised societies. Capitalism came with the advent of the industrial revolution, which resulted in a devastating blow to colonised society while resulting in unprecedented growth on the imperial powers. Colonialism was not a passing historical fad. It cannot be reduced to a mere isolated historical event. Over half of the contemporary world bore the brunt of it, while its effects continue to percolate. Colonialism was, in fact, premised on an ideology. It was justified and rationalised through elaborate arguments. The fact that it's an ideology can be glimpsed through recent works of history coming out of Britain which argue that it was the British Empire which created a global economically robust community, including volumes of Niall Fergusson.

The encounter between the coloniser and the native population is mediated and sustained through violence. In descriptive terms, the state is defined by its monopoly on violence and since the imperial powers control the state, they have the methods of violence at their hands. Given the inherent illegitimacy of the colonial state, violence is used indiscriminately against the natives to oppose all forms of opposition. Unlike divisions in a capitalist society, which is practiced implicitly through institutions, the divisions in a colonised society are stark and clear. The colonial power doesn't merely exploit, it dehumanises the native population and attempts to deliberately destroy native culture. This is exemplified by the British

education system in India. The Whig politician Thomas Babington Macaulay was behind the introduction of English institutional education in India. Macaulay argued that "a single shelf of a good European library was worth the whole native literature of India and Arabia." Indian languages were dismissed as being crude without any literary merit. Thus, Indians were to be educated in the superior language of English. The ancient texts of India were denounced as being full of "monstrous superstition." The purpose of colonial education was to form a class of interpreters. These interpreters would be Indians in blood and colour but English in morals. opinions and tastes.

This seemed to be precisely what happened, as evidenced through the writings and letters of nationalist figures like Jawaharlal Nehru, MK Gandhi and Subhash Bose, all of whom wrote and read proficiently in the language of the coloniser. Indian social reformers like Raja Ram Rohan Roy uncritically accepted the colonial association of polytheism with superstition and argued instead that Hinduism was originally monotheistic. Such simplistic

cleavage was both a reaction to colonial stereotypes as well as an internalisation of Victorian morality. The criminalisation of homosexuality was a product of the institutionalisation of Anglican morality. Nevertheless, the natives continue to profess opposition to same sex marriage based on Victorian moral ity. Pre-colonial India was not only tolerant of queer relations but actively celebrated it. Contemporary debates on the Uniform Civil Code in India are also reflective of the lingering effects of colonialism. Before the advent of the British, India had a diversity of laws and rules regarding marriage and adoption. These were flexible and not fixed in stone. Before 1937, Indian Muslims were largely governed by laws that were not very different from their Hindu counterparts. This was changed through growing demands from the clergy and the feudal lords for an orthodoxy suitable to their economic and patriarchal interests. Thus, the Shariat Act was brought into existence through persistent demands from the Muslim League, which at this point was in no manner the representative of Indian Muslims. The Shariat was, however, not in concordance to the Islamic orthodoxy. Au contraire it recognised adoption, preserved the economic power in opposition to Islamic principles while creating a psychological division between the two communities. The British were happy to comply owing to their interest in dividing and standardising India's diverse communities.

Why does the colonised accept the ways of the coloniser? The philosopher Albert Memmi argues that the colonised has no choice but to accept the morals of the coloniser in a society profusely filled with colonial institutions. The need to belong is only human. While the coloniser no longer exists in explicit forms in post-colonial societies, their institutions, laws and schools continue to function. Thus, the colonised continues to believe implicitly in the inferiority of her culture and literature long after the coloniser has departed. The collective memory of native culture has been replaced by colonial norms.

Yet, as Frantz Fanon points out, this sentiment cannot last. The dehumanising and degrading psychological effects of colonialism eventually give way to liberation. It is merely a stage and the natives eventually realise that they've been indoctrinated, that they're human beings after all. It is only at this point that a truly national identity must be constructed, and native culture reclaimed while denouncing colonialism. This form of decolonisation will not be closed to European or Western influences. Instead, it will take what's valuable in the European mould while proclaiming and protecting the cultural rights of the natives.

SPECTRUM FOOD PRODUCTION

Quest for sustainable farming

WHILE **TECHNOLOGY IS IMPERATIVE IN BOOSTING** PRODUCTIVITY, THERE IS NEED TO **CONSIDER THE ENVIRONMENTAL ASPECT AND SYNERGY WITH NATURE**

ncreasing agricultural productivity is undoubtedly a national goal, more so as India is thinking of emerging as With the standard of living improving, the variety in food consumption is also showing a healthy trend. But with the increase in population, the need for higher productivity is critical keeping in view the future requirements. In fact, FAO estimated that by 2050, the world will need to produce almost 50% more food, feed and biofuel, than it did in 2012. It projected that to feed a world population of 9.3 billion in 2050 food production in developing countries must dou-

ble from that in 2005. Though this projection may change considering the ground reality and the availability of land and water, which are already stumbling blocks, production undoubtedly needs a big boost. Climate change may also add significantly to the pressure on availability of natural resources for farming. Additionally, is the crucial factor of reducing emissions and ensuring green strategies in farming, one of the key issues discussed in COP28, which wanted reduction "in methane emissions globally" by 2030. This has the potential to impact India severely with its increasing number of livestock and huge paddy cultivation.

A closer look suggests that the need for increasing yield in a major producer in this field. a populous country like India was realised long back by the renowned agricultural scientist, MS Swaminathan. Agricultural scientists since his time have suggested certain measures which include double cropping, better rotation of crops, fighting plant diseases and pests.

Though on the institutional front, the government has been trying in a limited manner to solve the problems of agriculture through land reforms and, on the technological front, a modest beginning has been made in motivating farmers to use improved implements, seeds, chemicals, manures, much more needs to be done. Small farmers at the grassroots need training and support, which regrettably is not forthcoming from the local

administration. The tenet of environmental sustainability inevitably necessitates the need for ensuring higher levels of food production without expansion in cropland through deforestation. Thus, resource use efficiency must be the focal point of attention in the coming years as it will be logically impossible to attain food as also nutrition security for a growing popula-

tion with a sustainable footprint. This has been well understood and, as per available figures, just around 11% of overall increase in crop production in the last half a century can be attributed to the expansion of cropland area.

Experts have opined that developments in biotechnology are increasingly being seen as essential to the cause of sustainability, whether in terms of climate change mitigation or the reduced use of nitrogenous fertilisers in growing cereal crops. Though the potential of technology cannot be doubted, the effect on soil fertility remains a big question.

Another crucial aspect is the nutritional aspect, more so because a considerable part of the Indian population is vegetarian. A recent study found that India's rice and wheat varieties have lost essential health-friendly minerals and accumulated toxic elements, showing a decline in grain nutrient make-up that they say remained largely neglected. According to the study the concentration of essential elements including calcium, iron and zinc in grains from present-day cultivated rice and wheat varieties are between 19 to 45% lower than in grains from the 1960s. However, present-day wheat grains have lower levels of arsenic and chromium than wheat from the 1960s, as per the study published in the journal Scientific Reports.

While technology is imperative in boosting productivity. there is need to consider the environmental aspect and synergy with nature. In India, there are innumerable small peasants who have a critical role to play in sustainable agricultural growth through use of natural fertilisers, local production-consumption cycles, energy and technological sovereignty. Indigenous knowledge can be equally effective though not as much as integrative science, but the former could be more sustainably superior if a harmonious relationship has to be developed with nature.

Farming can't be made high cost and capital intensive as a significant number of farmers are small and resort to traditional methods of cultivation. Alternative agriculture is no doubt the need of the day, and this must incorporate the country's traditional knowledge and practices, combined with appropriate low-cost technologies. Policymakers need to keep this in mind along with the backdrop of protecting nature, reducing emissions and ensuring sustainability. A holistic strategy will help in the long run.

Scholarships are being provided to the meritorious wards of fishermen for higher studies while women self-help group members are being urged to take up fish farming in biofloc method. It is monetarily rewarding as it gives them financial assistance under Mukhyamantri Matsyajivi Kalyan Yojana.

ONMEB revises schedule for postponed GNM exam **AS PER THE REVISED** PROGRAMME, THE **EXAMINATION WILL NOW BE HELD JANUARY 5 AND 6**

Hatadihi, Dec 20: The Odisha Nurses and Midwives Examination Board (ONMEB) has published a revised schedule for the GNM examination after the test scheduled for December 18 and 19 was postponed due to alleged leak of question papers.

The development came after Orissa POST published a report highlighting the abrupt postponement of the GNM examination and how the decision is affecting the students, December 18.

The examination had started from December 11 and was scheduled to end December 19. However, the board suddenly published a notice December 17 and postponed the GNM examination scheduled for December 18 and 19. The

abrupt postponement of the examination sparked outrage and concern among the students appearing in the examination.

Concerned over publication of the report, two days later, the ONMEB in a letter-959/NEB-03/2023, dated December 20 has published a revised programme to conduct the postponed examination of two days, Wednesday.

As per the revised programme, the examination will now be held January 5 and January 6 for two days. The board's move to publish the revised programme in such a short period has drawn appreciation from various quarters.

However, the board is yet to



take any action on the issue and is tight-lipped on how the question paper got leaked and who all are involved.

When contacted, ONMEB Secretary Basanti Behera said the examination for the GNM course had been postponed as the question papers prepared by the board and those leaked were found same during verification.

"We are trying to conduct the examination at an early date in view of the future of the students,' she said.

However, she remained silent when questioned about missing action on the ques-

tion paper leak. She said that the higher authorities will take a call on the issue. Retired teacher and senior cit-

izen Ganesh Prasad Karsharma in a post on 'X' has lodged a complaint with the Chief Minister and Chief Secretary demanding a probe on question paper leak and sought stringent action against the culprits. BJP state executive member

Alok Sethi alleged that attempts are being made to suppress the question paper leak issue and demanded a proper probe and action against the wrongdoers.

Diarrhoea cases will recede in 2 to 3 days: Shalini Pandit

Rourkela, Dec 20: Shalini Pandit, Commissioner-cum-Secretary, state Health and Family Welfare department and Director, Urban Health Mission. along with Director, Public Health. Niranian Mishra Wednesday made a whirlwind tour of Rourkela to take stock of the diarrhoea situation in the Steel City, which has already claimed 13 lives and left hundreds affected.

Speaking to the media here at Rourkela Government Hospital (RGH) she said cases are not increasing anymore. "The situation is improving gradually. Our IC activities have helped us. Besides, the water purification and food checking activities have been stepped up," Pandit said.

Regarding the new cases, she said, "New cases are arriving but those are not serious. They are getting stable through simple IV intervention and getting stable. The situation will be resolved within the next two to



three days."

"Diarrhoea cases occur either due to water or food. Now the cases are coming from scattered areas. For that, we have initiated epidemiology and microbiology studies. The community medical department of Sundargarh Medical College and Hospital has already started the study," she said.

A team from SCB Medical College and Hospital in Cuttack will arrive Wednesday to study the situation." Meanwhile, a team from Regional Medical and Research Centre (RMRC) from Bhubaneswar will also do the study to get to the root of the problem, she informed.

To meet the situation 10 PHCs have been made operational 24x7 from Wednesday. "We have adequate IVs, antibiotics and oxygen along with para-medic staff and doctors to man those PHCs all through the day and night," said the director.

She further informed that any

meeting at RGH where representatives of all hospitals including and private were present. Then she went around the wards to check the conditions there. Traces of cholera were found

Bhubaneswar, Dec 20: Paradip Port has proved its efficiency and achieved yet another 100 Million Metric Tonnes (MMT) of cargo handling in the shortest time in

its history. Port sources Wednesday said it has once again repeated the feat by crossing the 100 MMT mark, seventh year in succession and achieved cargo throughput of 100.28 MMT December 18 last in the current fiscal.

Notably, in FY 2022-23 the coveted mark of 100 MIMT was achieved January 9, 2023. The record was achieved in 22 days in advance -- in 262 days in current fiscal -- against 284 days in last financial year, by exhibiting 9.64 per cent growth in total cargo throughput.

The port is poised to set an all time record cargo handling of more than 145 MMT in the current fiscal.

Outbound iron ore and pellet has shown remarkable 69.03 percent growth in comparison to previous fiscal. Last fiscal, it amounted to 10.56 MMT over the same time period, whereas till December 18, it stands at 17.85 MMT in current fiscal.

Coastal Thermal Coal handling constitutes about 30.38 per cent of total cargo volume handled at the port. The port has also registered remarkable improvement in the key performance parameters.

Berth productivity stands at 32,689 MT per day per ship, which mal coal to west coast, for



is the highest among all major ports of the country.

The vessel turn-round-time is recorded as 42.01 hours as against 47.60 hours during the correspon-

ding period of the previous year. Similarly, Pre-Berthing Detention is 1.18 hours as against 1.73 hours. during the corresponding period

of the previous year. The port is emerging as a coastal shipping hub of the country and started coastal shipping of therMaharashtra based power plants for the first time in history. The port plans to expand coastal

shipping of thermal coal to other regions on the west coast. The port's commitment to oper-



Lok Sabha approves Dhankhar mimicry row takes centrestage Telecom Bill 2023

New Delhi, Dec 20: A Bill allowing the government to temporarily take control of telecom services in the interest of national security, and providing a non-auction route for the allocation of satellite spectrum was approved by the Lok Sabha Wednesday.

The Telecommunications Bill, 2023, which was passed by a voice vote after a short debate, also allows the Centre to take possession of a telecom network in case of any public emergency or in the interest of public safety.

Most of the opposition members did not attend the House following their suspension. The bill, piloted by Communications Minister Ashwini Vaishnaw, provides for stopping transmission and intercepting messages in case of public emergency, in the interest of the public, to prevent incitement for committing offence

According to the Bill, the press messages of correspondents accredited to the Centre or state governments shall not be intercepted or detained unless their transmission has been prohibited under rules applicable for public emergency, public order etc.

The bill provides for the allocation of spectrum to satellite communications companies through the administrative method, Vaishnaw said.

The provisions of the Bill, it may be mentioned, are in line with the demand of global satellite services companies and reject the argument made by domestic telecom players Jio and Vodafone Idea for allocation of spectrum for commercial use through the auction route.

As per the Bill, "the central government assign spectrum for telecommunication through auction except for entries listed in the First Schedule for which assignment shall be done by administrative process.

No insults can prevent me from doing so," Dhankhar posted on X The Vice President's Secretariat also put post on X. The BJP alleged that it is not just the vice president, the Constitution, farmers and Jat community, have been insulted through the act. While Tejashwi (34), has been asked to depose before the federal probe agency at its office in Delhi December 22, Prasad (75), has been asked to appear next week December 27 to record their statements under the Prevention of Money Laundering Act (PMLA).

The ED has once questioned Tejashwi for about eight hours



in this case April 11 but this is the first time it has summoned Prasad for joining the probe.

The summons comes following the questioning of an alleged "close associate" of the Lalu Prasad family, Amit Katyal. He was arrested by the ED in November.

The alleged scam pertains to the period when Prasad was the railway minister in the UPA-1 government. It is alleged that from 2004 to 2009, several people were appointed to Group "D" positions in various zones of the Indian Railways and in lieu, these people transferred their land to the family members of the then railway minister Prasad and a linked company named A K Infosystems Private Limited.

Katyal was the director of this company when it acquired land from candidates "on behalf" of Lalu Prasad, the ED had earlier claimed in a statement.

The ED case, filed under the criminal sections of the PMLA, stems from a complaint lodged by the Central Bureau of Investigation (CBI).

Speaking to the media after the meeting in the Parliament complex along with nine party MPs, Banerjee said 155 central teams have already visited West Bengal and the state government has given clarification on issues raised by the Centre.

The Centre and the West Bengal government have been involved in a tug-ofwar over the release of funds to the state, with the TMC even holding a protest led by its general secretary Abhishek Baneriee in the national capital in October: The BJP has accused the TMC government of siphoning off central funds meant for Pradhan Mantri Aawas Yojna and MGNREGA. Talking about the pending MGNREGA funds for the state. Baneriee said it is mandatory under the Constitution to pay the workers. "We didn't even get a penny for 100 days of work (under MGNREGA) in the budget for 2022-23." she added.

New Delhi, Dec 20: India Wednesday reported 21 cases of the JN.1 Covid variant, a development that is neither surprising nor particularly worrying, scientists said while allaying fears but also advising adherence to existing precautionary measures

The announcement about the increasing numbers of the new sub-variant, detected in three states, came with the Union Health Ministry reporting 614 new Covid infections, marking the highest daily count since May 21. "As it happens with most respiratory viruses, including the influenza viruses, the circulating viruses keep changing.

Therefore, a sub-variant of SARS CoV-2 is not a surprise at all," Chandrakant Lahariya, a senior consultant physician and public health expert, told PTI. The SARS-CoV-2 virus is circu-



lating in all settings, he said. According to official sources, 19 cases of JN.1 have been traced in Goa and one each in Kerala and Maharashtra. Over the past two weeks, 16 deaths related to Covid-19 were recorded with the victims having serious co-morbidities. Based on the available evidence, the additional global public health risk posed by JN.1 is currently evaluated as low, WHO said.

China earthquake toll rises to 131

Beijing: The death toll in the powerful 6.2-magnitude earthquake that jolted a mountainous region of northwestern China late Monday night has risen to 131, local authorities said Wednesday. A total of 113 people were killed in the Gansu, while the death toll in the neighbouring Qinghai province in the Himalayan region has risen to 18 from 14 Tuesday, with 16 others still missing in the quake, the deadliest in nine years. Over 700 hundred people were injured in both provinces. Qinghai province is adjacent to the Tibet Himalayan region, which is prone to frequent earthquakes due to the shifting of continental plates.

'Child bride' hanged in Iran

Tehran: Iran Wednesday hanged a woman convicted of murdering her husband, whom she married while still a child, a human rights group said, defying an international campaign for clemency. Samira Sabzian, who had been in prison for the past decade, was executed at dawn in Ghezel Hesar prison in the Tehran satellite city of Karaj, the Norway-based Iran Human Rights (IHR) group said. It said she was a "child bride" who had married her husband at the age of 15 and had been a victim of domestic violence. according to relatives.

Colorado SC bars Trump

RULING, COLORADO SC DISQUALIFIES EX-PREZ TRUMP FROM PRESIDENCY IN THE STATE OVER JAN 6 INSURRECTION

Washington, Dec 20: The Colorado Supreme Court has ruled that Donald Trump cannot run for president next year in the state because of his role in the attack on the US Capitol in 2021 and ordered the exclusion of his name from the state's Republican presidential primary ballot.

The disqualification of the 77-year-old former president Tuesday was based on the Constitution's 14th Amendment. which says officials who take an oath to support the US Constitution are banned from future office if they "engaged in insurrection.

Trump is currently the frontrunner in the Republican Party's nomination process for the race for the White House in 2024. Trump's campaign has vowed to appeal against the "flawed" ruling by the Supreme Court of Colorado in the US Supreme Court.

The Colorado Supreme Court upheld a trial judge's decision that Trump engaged in the January 6, 2021, insurrection and also overturned her conclusion that the ban does not apply to the presidency.

The landmark decision from the divided top state court marks the first time a court has found Trump ineligible to return to



The decision from a court whose justices were all appointed by Democratic governors marks the first time in history that Section 3 of the 14th Amendment has been used to disqualify a presidential candidate, which bars officials who have engaged in

"insurrection or rebellion" from holding office

the White House due to his conduct surrounding the January 6, 2021, attack on the US Capitol, CBS News reported.

Never before has a court determined that a presidential candidate is disqualified under the Civil War-era provision clause, it said.

The state high court stayed its ruling until January 4 — a day before the deadline for the state secretary to certify the candidates for Colorado's March 5 primary election.

The 4-3 ruling by the sevenmember Colorado Supreme Court does not apply outside of the state.

"President Trump's direct and express efforts, over several months, exhorting his supporters to march to the Capitol to prevent what he falsely characterised as an alleged fraud on the people of this country were indisputably overt and voluntary," the justices wrote.

"Moreover," they wrote, "the evidence amply showed that President Trump undertook all these actions to aid and further a common unlawful purpose that he himself conceived and set in motion: prevent Congress from certifying the 2020 presidential election and stop the peaceful transfer of power.'

"[W]e conclude that because President Trump is disqualified from holding the office of President under Section Three, it would be a wrongful act under the Election Code for the Secretary to list President Trump as a candidate on the presidential primary ballot," the ruling

Brussels, Dec 20: The European Union reached agreement early Wednesday on new rules designed to share out the cost and work of hosting migrants more evenly and to limit the numbers of people coming in.

Representatives of the European Parliament and of EU governments reached an accord after all-night talks on EU laws collectively called the New Pact on Migration and Asylum that should take effect next year.

The laws cover screening irregular migrants when they arrive in the European Union, procedures for handling asylum applications, rules on determining which EU country is responsible for handling applications and ways to handle crises.

Migrant arrivals in the European Union are way down from the 2015 peak of more than 1 million, but have steadily crept



Mediterranean from Africa to Italy or Malta.

Previous efforts to share out the responsibility of hosting migrants have foundered because eastern EU members in particular were unwilling to take in people who had arrived in Greece, Italy and other countries.

Under the new system, countries not at the border will have a choice between accepting refugees or paying into an EU fund.

The screening system envisaged will seek to distinguish between those in need of international protection and others who are not.

People whose asylum applications have a low chance of success, such as those from India. Tunisia or Turkey, can be prevented from entering the EU and detained at the border, as can people seen as representing a threat to security.

Refugee rights groups have said it will create what amounts to prison camps at the EU's borders.

Kyiv, Dec 20: Ukraine's President Volodymyr Zelenskyy said Tuesday the military had proposed mobilising 450,000-500,000 more Ukrainians into the armed forces in what would mark a dramatic step up of Kyiv's war with Russia.

The Ukrainian leader told his end-of-vear news conference it was a "highly sensitive" issue that the military and government would discuss before deciding whether to send the proposal to parliament.

Zelenskyy said he wanted to hear more arguments in favour of mobilising the additional people before backing such a move. "This is a very serious number,"

he said Ukraine has been at war with Russian troops since February 2022. Both sides treat their casualty numbers as a state secret, but US officials estimate that hundreds of thousands have been killed and wounded.

Ukraine's troop numbers are not known, but it has said in the



past it has around 1 million people under arms. Russia has been expanding its army during the war and said Tuesday it planned to boost its ranks to 1.5 million service members.

"I said I would need more arguments to support this move. Because first of all, it's a question of people, secondly, it's a question of fairness, it's a question of defence capability, and it's a question of finances," Zelenskyy said.

Ukraine, which initially saw tens of thousands of volunteer fighters queuing up to defend their country from Russia's invasion, is now trying to conscript more men to replace those currently at the front.

New Delhi, Dec 20: Equity investors became poorer by ₹8.91 lakh crore Wednesday as markets came under a bear attack, with the benchmark Sensex falling almost 931 points after hitting its fresh all-time high level.

Erasing all its early gains, the 30-share BSE Sensex crashed 930.88 points or 1.30 per cent to settle at 70,506.31 points. The index opened higher and later gained 475.88 points or 0.66 per cent to hit its all-time high of 71,913.07 points.

However, broad-based selling pulled down the benchmark to the day's low of 70,302.60 points.

The market capitalisation of BSE-listed companies eroded by ₹8,91,729.43 crore to ₹3.50.19.998.87 crore.

"Redemption was seen across the sectors, and even mid and small-cap stocks came under the grip of a strong bear hammering," Prashanth Tapse, Senior Vice President (Research) at Mehta Equities

Among the Sensex firms, Tata Steel fell the most by 4.21 per cent. NTPC, Tata Motors, HCL Technologies, Mahindra & Mahindra, State Bank of India, Power Grid, Tech Mahindra, Larsen & Toubro and JSW Steel also declined.

HDFC Bank emerged as the only gainer from the pack.

In the broader market, the BSE small-cap gauge fell 3.42 per cent and mid-cap index de-

RBI introduces card tokenisation facility

Mumbai, Dec 20: The RBI Wednesday introduced a Cardon-File (CoF) token facility at the level of banks and other institutions to provide convenience for cardholders to get tokens created and linked to their existing accounts with various e-commerce applications.

At present, a CoF token can only be created through the merchant's application or webpage.

For a CoF, a token is a 16-digit number unique for a combination of card, token requestor and merchant. Through tokenisation, the actual card details are replaced with token credentials that can be used only with the intended merchant.

"It has been decided to enable Card-on-File Tokenisation (CoFT) directly through card-issuing banks/institutions also. This will provide cardholders with an additional choice to tokenise their cards for multiple merchant sites through a single process," the RBI said in a circular.

Generation of CoF tokens for a card, through the card issuer, can be enabled through mobile banking and internet banking channels. In October, the RBI had said tokenisation has improved transaction security and transaction approval rate.

The $RB\bar{I}$ introduced CoFT in September 2021 and began implementation from October 1 last year. The circular further said CoFT generation should be done only on explicit customer consent, and with Additional Factor of Authentication (AFA) validation.

Aligning inflation with 4% target far from assured: RBI

Annual retail inflation rose to 5.55% in November from 4.87% in

Mumbai, Dec 20: The Indian central bank's objective of aligning inflation with its 4% target on a durable basis is far from assured and a failure to do so could risk economic growth, the bank said in its latest bulletin published Wednesday.

"On a real-time basis, inflation is hurting discretionary consumer spending and this, in turn, is holding back topline growth of manufacturing companies as well as their capex," the Reserve Bank of India (RBI) said in its 'State of the Economy' article.

"If inflation is not brought back to the target and tethered there, there is a strong likelihood that growth may falter.'

Annual retail inflation rose to 5.55% in November from 4.87% in the previous month due to higher food prices, the latest data showed. Projections indicated that in-

flation will go up further from the September-October 2023 average inflation rate of 4.9% before it can come down, the RBI said. The article also added that

softer inflation data has engendered a "hypermetropia" among some stakeholders - an irrational long-sightedness where inflation forecasts gravitating towards the 4% target in the distant future are clearly sighted while near-term spikes due to food price volatility are blurred.

The RBI reiterated the need to remain vigilant and ready to act as per the evolving outlook.

On the growth front, however, the central bank sounded a tone of cautious optimism and said internal models indicated that growth is likely to be sustained in H2:2023-24 and 2024-25 despite some moderation.

Evidence from high-frequency indicators points towards sustained strength in demand conditions, the central bank said.

Firms' \$ bond issuance hits 14-yr low

Mumbai, Dec 20: Indian companies' fundraising via dollar bonds hit a 14-year low in 2023. as elevated global yields discouraged borrowers who moved to securing foreign currency loans instead

Corporates have raised \$4.1 bln via six dollar bond issues so far in 2023, according to data shared by LSEG Workspace, marking the lowest since 2009, when annual fundraising totalled \$1.6 bln.

'Throughout 2023 global interest rate environment was not favourable and the cost of raising dollars hedged into rupees was comparatively higher than (accessing) domestic liquidity, so Indian issuers chose to borrow locally," said Sameer Gupta, head of India and South East Asia debt capital market at Deutsche Bank.

Instead, Indian companies leaned on foreign currency loans, which are benchmarked to floating interest rates. The total borrowings reached \$22.13 billion, the highest since 2014, according to data.

Apart from loans denominated in US dollars, Indian firms have availed \$2.15 billion in ven-denominated loans so far this year, up from \$643 million last year, Refinitiv data shows.

Corporates are happy to do a loan which is a floating rate instrument, said Shoaib Ahmed. director of debt capital markets

Reliance Industries was among the largest borrowers in the foreign currency loan market this year, having raised over \$8.5 billion as of October, data showed. Lenders, including REC, Canara Bank and Shriram

Finance raised foreign currency

debt, with others like the State Bank of India exploring plans to raise funds early next year, according to multiple bankers. Companies like Adani Ports and SEZ have sought to re-

duce their overseas debt by repurchasing their existing dollar notes. "We have also seen that com-

panies have bought back bonds, using money raised in INR market. effectively substituting some of the debt with cheaper or retiring debt," ANZ's Ahmed said.

Bankers expect an increase in dollar bond issuance in 2024 as global bond yields ease, with the volume of foreign currency loans likely declining.

INDIA'S TOTAL DEBT RISES TO ₹205L-CR **IN SEPT QUARTER**

Mumbai, Dec 20: The country's total debt, or the total outstanding bonds which are being traded in the market, rose to \$2.47 trillion (Rs 205 lakh crore) in the September quarter, according to a report.

The total debt amount in the March quarter was \$2.34 trillion (Rs 200 lakh crore).

The central government's debt stood at \$1.34 trillion, or Rs 161.1 lakh crore, in the September quarter, up from \$1.06 trillion, or Rs 150.4 lakh crore, in the March quarter, Vishal Goenka, Co-Founder of Indiabonds.Com. said, quoting data provided by the Reserve bank of India.

At Rs 161.1 lakh crore, the central government's debt constitutes the highest 46.04 per cent share of the total amount.

State governments' debt share was 24.4 per cent, or \$604 billion (Rs 50.18 lakh crore), the report said. Treasury bills were worth \$111 billion, or Rs 9.25 lakh crore, constituting 4.51 per cent of the total debt, it said. Corporate bonds had a 21.52 per cent share of the total debt at \$531 billion (Rs 44.16 lakh crore) in the second quarter of the current fiscal.

ways more profitable than the high investment costs associated with ramping up production of new systems, stronger demand will flow quickly to the corporate bottom line. Shares of the biggest defense

companies, which have handily

beat the benchmark S&P 500

stock index for the last two years,



are expected to keep rising, according to Wall Street estimates.

Lockheed Martin, General Dynamics and Northrop Grumman shares are forecast to rise between 5% and 7% over the next 12 months, while the S&P is seen making limited gains.

PATRIOTS AND ROCKET MOTORS

Patriot systems production can be broken down to show how sales of basic items will impact a range of companies. To start, RTX manufactures the

radars and ground systems, and Lockheed Martin manufactures the latest generation interceptor missiles. RTX boosted launcher and

control system production to 12 units a year. A launcher and radar together cost around \$400 million each.

Another strong demand signal can be seen in the backlog of solid rocket motors which are used by the vast array of arms in high demand since Russia's full scale invasion of Ukraine in February 2022.

The US has two main rocket motor makers, Northrop Grumman, and L3Harris Technologies, which both said they have seen demand increase.

Northrop said much of the increase is due to demand for its rocket motors and warheads in the Guided Multiple Launch Rocket Systems (GMLRS) which

are heavily used in Ukraine. GMLRS are GPS-guided rockets with 200-pound (90kg) warheads. Lockheed Martin makes 10,000 of the missiles per year and is increasing production to 14,000. They have an average cost of \$148,000 each according to Army documents and more than 6,100 have been sent to Ukraine so far, according to a Reuters analysis

An executive at a rocket motor maker said the administration of President Joe Biden prioritized munitions in its 2024 Pentagon budget request. He expected a boost to order backlogs once contracts came through following the passage of the \$886 billion defense policy bill known as the NDAA, or National Defense Authorization Act. It was approved by Congress lastweek and Biden is expected to sign it into law.



LONDON: Chelsea's faltering first season under Mauricio Pochettino could yet be saved by the English League Cup. The London club reached the semifinals by beating Newcastle 4-2 in a penalty shootout Tuesday, with the game only getting that far thanks to a goal by Chelsea winger Mykhailo Mudryk in the second minute of stoppage time that made it 1-1 at Stamford Bridge. Newcastle right back Kieran Trippier was at fault for that goal and he was one of two visiting players to fail to score his penalty. Chelsea are languishing in 10th place in the Premier League despite having spent more than USD 1 billion on players in the last three transfer windows and having no European competitions to disrupt their schedule. Fulham have reached that stage for the first time in its 144-year history. Fulham, another team from west London, also needed a penalty shootout to advance and this one lasted longer, with defender Tosin Adarabioyo eventually netting the clinching kick for a 7-6 win. The game finished 1-1 in regulation at Goodison Park, with Everton substitute Beto scoring in the 82nd to cancel out an own-goal by Michael Keane.

Griezmann writes name in Atletico's record books in draw with Getafe-

tied Luis Aragones as the club's all-time top scorer. Griezmann scored twice Tuesday to tie Aragones on 173 goals, but Atletico conceded a stoppagetime equaliser in a 3-3 draw with Getafe that ended the club's record-tying 20-game home winning streak.

Borja Mayoral converted a late penalty kick to help Getafe rally from two goals down against 10man Atletico, which was trying to win 21 in a row at home in all competitions for the first time ever. It had last won 20 consecutive matches as a host in 2013. Getafe had handed Diego Simeone's team their last setback at home in a 1-1 league draw in February.

Griezmann scored his 172nd goal with Atletico in the 44th minute and then tied Aragones' record by converting a 69thminute penalty kick.

Atletico's fans chanted Griezmann's and Aragones' names after the France forward hit the top corner with a rightfooted shot from the penalty spot at the Wanda Metropolitano stadium. Aragones reached his mark in 370 matches, while Griezmann needed 364 games with the club.

The draw lifted Atletico to third place in the league standings after 17 matches. It has the same 35 points as defending champion Barcelona. Girona remains the surprise leader with 44 points, two more than second-place Real Madrid.

Mayoral had evened the match for Getafe with a goal in the 53rd before Alvaro Morata put the hosts ahead again with a header in the 63rd. Oscar Rodriguez scored Getafe's second goal in 87th and Mayoral netted the equaliser by converting the penalty three minutes into stoppage time to keep Atletico from earning the milestone victory. Atletico played a man down from the 38th after Stefan Savic was sent-

off with consecutive yellow cards.
