Ship with 21 Indians hit by drone; no casualties

New Delhi, Dec 23: A suspected drone attack on a merchant vessel with 21 Indian crew in the Arabian Sea off India's west coast caused an explosion Saturday, but there was no report of any casualties in the incident, according to military sources and a maritime agency.

A P-8I maritime patrol aircraft, deployed by the Indian Navy after the United Kingdom Maritime Trade Operations, or UKMTO, reported the incident, ascertained the safety of the vessel and its crew, Indian military sources said. The 22-member crew and the vessel, Chem Pluto, are 'safe', the Coast Guard said

An attack by Uncrewed Aerial System (UAS) on a vessel 200 nautical miles South West of Veraval, India, caused 'an explosion and fire', the UKMTO said on its website. Sources said the vessel is now heading towards the nearest port. It was reportedly bringing crude oil from a port in Saudi Arabia to Mangalore port.

The Navy has dispatched a frontline warship, while the Coast Guard diverted ICGS Vikram to the area where the merchant ship is located.

DEATH OF 3 CIVILIANS DURING ANTI-TERROR OPERATIONS IN J&K TRIGGERS MASSIVE ROW; MOBILE INTERNET SERVICES SUSPENDED IN 2 DISTS; GOVT ANNOUNCES COMPENSATION

Jammu, Dec 23: Tension mounted in the border districts of Poonch and Rajouri Saturday after three men died allegedly during interrogation by the Army following the killing of five soldiers in a terrorist ambush, prompting the Jammu and Kashmir government to step in swiftly and announce compensation and jobs to the kin of these civilians.

Authorities suspended mobile Internet services in the two districts as a precautionary measure to check rumour-mongering and prevent any law and order problem, and senior administrative and police officers have been camping in the area to monitor the situation.

In a post on X, the Information and PR department of Jammu and Kashmir said, "The death of three civilians was reported yesterday in Baffliaz of Poonch District. The medico legal formalities were conducted and legal action in this matter has been initiated by the appropriate authority.

"Government has announced compensation for each of the

deceased. Further, Government has also announced compassionate appointments to the next of kin of each deceased," it stated. The three civilians, aged between 27 and 42, were found dead Friday. Their relatives and political leaders alleged that they died due to 'custodial torture' as they were among the eight people picked up by the Army for questioning during an ongoing search operation to track down the terrorists involved in the ambush of Thursday.

The Jammu and Kashmir Police are preparing an inquest report under Section 174 of the Code of Criminal Procedure, which gives powers to police to inquire and submit a report to executive magistrate when a person has died under circumstances raising a reasonable suspicion that some other person has committed an offence.

This may lead to the registration of a case in the matter, officials said.

The Army's public information wing tweeted Saturday saying it would extend all cooperation in the conduct of the investigation into the civilian deaths.

Jammu Divisional Commissioner Ramesh Kumar and Inspector General of Police Anand Jain have been camping in Poonch and are monitoring the situation, officials said. Additional police and paramilitary personnel have been deployed in sensitive pockets of the districts to maintain peace.

Videos of the alleged custodial torture surfaced Friday, after which the authorities suspended mobile Internet services in the two districts, the officials said.

Meanwhile, several political parties in Jammu and Kashmir Saturday staged protests and demanded an impartial probe into the death of three civilians.

"I will also return the Padma Shri for my sister and the country's daughter. Honourable Prime Minister Shri Narendra Modi ji, I am proud of your daughter and my sister Sakshi Malikkh," Virender wrote on X. He also urged the country's iconic sports personalities like Sachin Tendulkar and Neeraj Chopra to give their opinion on the issue.

"I would also request the top players of the country to also give their decision," Virender said in his post, tagging cricket legend Tendulkar and Olympic

No more comments," said Thakur at the SAI centre in Bangalore on the sidelines of a function to honour eminent athletes and Asian Games medal winners.

US WOMAN BORN WITH TWO UTERUSES BECAME PREGNANT IN BOTH

Double womb mom delivers 2 babies

Washington, Dec 23: In a rare incidence, a 32-year-old woman from Alabama who was born with two uteruses and became pregnant in both gave birth to twin girls on different days.

Kelsey Hatcher arrived at the University of Alabama at Birmingham Hospital December 19 for a scheduled induction for her fourth pregnancy. Many would assume Kelsey's fourth time giving birth would be a walk in the park, and some may consider her an expert since she had three prior typical, healthy pregnancies, said UAB News.

However, Kelsey walked into UAB with a pregnancy classified as truly one in a million: She has a rare double uterus and was pregnant with a baby on each side.

After 20 combined hours of labour, she gave birth to two girls. For Kelsey



and her family, this rarity meant double the uterus, double the labour, double the babies and double the birthdays. "Our miracle babies were born."

Kelsey, who is documenting her story on her Instagram account "doubleuhatchlings", wrote in a post. She added that the girls "decided







Fog alert: DMs asked to prevent mishaps

Bhubaneswar, Dec 23: With the India Meteorological Department (IMD) forecasting prevalence of dense fog in various parts of the state Sunday, Special Relief Commissioner (SRC) Satyabrata Sahu has asked all the district Collectors to heighten vigil and take measures to prevent road accidents in view of the prediction.

The SRC, in a letter to all the Collectors Friday night, asked police and transport officials of the districts to take necessary steps for controlled plying of vehicles on highways during foggy conditions to prevent any accident.

The weatherman said dense fog will prevail in Puri, Khurda, Nayagarh, Ganjam, Gajapati, Sundargarh, Keonjhar, Angul, Dhenkanal, Cuttack, Kandhamal, Kalahandi, Rayagada and Koraput districts Sunday.

Meanwhile, the state experienced a slight rise in minimum temperatures in the last 24 hours.

However, the mercury is likely to dip by 2 degrees Celsius over the next 24 hours with no significant change thereafter for a few days, the



Needless Change

If it ain't broke, don't fix it.' The dictionary says this is a proverbial saying whose popularity is attributed to an official in former LUS president Jimmy Carter's administration. It is 'used to say that one should not try to change something that is working well.' The Indian Penal Code is 150 years old. It has worked not only in India but also in the rest of South Asia. Though it calls itself an Islamic republic, almost all of post 1947 Pakistan's laws have remained the same that the British had left behind and are common to the subcontinent, going back to the Penal Code written by Thomas Macaulay in the 1830s and enforced from 1862 onwards. Even in 2023, the Indian Penal Code and the Pakistan Penal Code remain almost identical. The changes that came in after 1947 are few on either side. The natives of Lahore know what the number 144 (Section 144 which criminalises assembling of people under certain circumstances) means in law just as well as those of Chennai.

The laws were familiar and they were functional. Everyone from the thanedar and the constable to the citizen knew them. For Pakistanis, just as for Indians, the law that deals with punishing murder is called 302 and the one for cheating is 420. These are numbers of the Indian Penal Code that have been used on the subcontinent even after inde-

pendence in 1947. Why? Because the laws work. If there is a problem of courts clogged with cases it is not because the laws are flawed and the new laws will not change that (in fact the contrary, as we will see). If the issue is that colonial laws are unsuitable for a free nation and we need a more liberal order then also the Sanhita does not

There was no demand in India that the laws be changed. We are not referring to tinkering, meaning removing and adding that which becomes necessary with changing time. We are referring to changes brought about from whole cloth. Taking down an edifice fully and dismantling it without reason. The question is of course: Why change something that is working?

The answer to that we do not have and will not get. The script writers of Bollywood will need to change their dialogues and get their screen judges and cops to memorise some new numbers but deeper problems are anticipated

First that the new laws would likely increase litigation. Lawyer Sanjay Hegde has pointed out that after making bounced cheques a criminal offence, courts have

been flooded with new litigation on this. Lawyer Colin Gonsalves has asked why the police were being given more arbitrary power over the citizen than even in the colonial period. Lawyer and Congressman Abhishek Manu Singhvi has asked why the non-existent (according to the government itself) phenomenon of 'love jihad' was being added to offences with a 10 year sentence. Yet others have pointed out that sedition, under a new name, remains under the penal code.

The simplest way of understanding masterstrokes is to accept they are masterstrokes and not question their necessity or wisdom.

Former Army Chief MM Naravane has written his memoirs and if they are allowed to be published they contain the revelation that the Agniveer scheme was a 'bolt from the blue.' Something modest by way of a short service commission that the Army had proposed was first inverted. Instead of retaining three fourths of the inductees, only one fourth would be and the rest out to pasture, retired at ages as young as 22. And the plan was extended to the Navy and Air Force, which had no inclination toward or need for this 'reform.

Meaning it was a top-down and unexpected stroke of genius from the Prime Minister (since nobody else counts). This has changed the face of an Army that has been functioning competently since the 18th century meaning for over 200 years. Why agitate and disturb something that works?

That question could also be asked of the brilliant decision to abolish currency. Who was asking for ₹1000 and ₹500 notes to be banned? Not the Reserve Bank of India, which resisted and warned, correctly as it turned out, that this was a dumb move that would damage the economy. Not the economists and not the business community and certainly not the citizens. It came because of whim. The same mentality is at work with the new criminal laws.

They will not only require the judiciary, the police, the lawyers and the public to know new laws but it will also endanger settled jurisprudence on the old laws and open up all sorts of minor and major problems that currently do not exist. Precedents, the basis of Common Law, which we follow, will come undone. Whose then was asking for change? Not the judges or police or lawyers or citizens.

Lawyer Sanjay Hegde has warned that once introduced, our new Sanhita will be even more disruptive than demonetisation.

One hopes that this is not the case and hopes also, despite the evidence of the last decade, that adequate thought and preparation have gone into this introduction of change where none was really required. And for those who remain puzzled and still ask the question: Why are we doing this? the answer appears to lie in a mindset that believes 'it ain't broke then break it.

EXPECT THE UNEXPECTED

SHOCKS ARE HERE TO STAY, **AND OUR TASK IS NOT TO PREDICT THE NEXT ONE**

have been in the forecasting business for more than 50 years. Over that period, I have heard the constant refrain that the world is in the midst of "unprecedented changes." This popular trope frequently resulted in equally hyperbolic corollaries: breathless claims that we have never faced greater risks or such an uncertain future, that forecasting has never been harder. Repeat it enough, and it starts to become believable.

Confession: my crystal ball has been cracked so many times by purportedly unprecedented developments that I have lost count. The 1970s was a decade of extraordinary turmoil: the oil shock of 1973 was swiftly followed by the "Great Inflation" and a period of stagflation, setting the stage for the first seemingly unprecedented phase of the post-World War II era. The subsequent disinflation of the 1980s allowed the horror movie of the 1970s to run in reverse well into the 1990s, which came to an end with the Asian financial crisis, ushering in what was initially billed as the first crisis of globalisation.

But today, we look back on these episodes as mere tremors preceding the seismic shocks to come. The information-technology revolution and the dotcom bubble of the late 1990s and early 2000s hinted at the profusion of asset bubbles that afflicted global property markets and many financial instruments, from sub-prime mortgages to broader credit flows and equities. When the music stopped, the resulting cross-border and cross-instrument contagion fuelled the global financial crisis of 2008-09 – another extraordinary upheaval for what had become, at that point, a crisis-battered world.

Just when everyone thought global conditions couldn't get much worse, a once-in-a-century pandemic and extreme weather events fuelled by cli-

mate change turned conventional thinking on its head, as did the rising tide of protectionism, trade and tech wars, and a potential superpower collision between the United States and China. Add to that the outbreak of war in Eastern Europe and the Middle East, and the unprecedented has become the new norm. Books on the "permacrisis" and the "polycrisis' now make the bestseller list.

The cynic in me says, "Been there, done that." But just because I have plied my trade as a forecaster during a half-century of turmoil doesn't mean I have a unique understanding of what comes next. Bearing in mind Mark Twain's observa tion that history often rhymes. I offer three key lessons from my experience in attempting to make sense of what may lurk in the uncertain future:

First, learn to expect the unexpected. The human species is inherently autoregressive, always looking to the recent past as the best predictor of the future. Policymakers are especially prone to this myopic approach – repairing flaws in systems that led to the last crisis but never considering what could spark the next one. For example, in the late 1990s, Asian economies built up large reservoirs of foreign-exchange reserves - a move that would have helped prevent the next Asian financial crisis but did nothing to stop the one that actually occurred, which arose from the bursting of an equity bubble.

Second, there is an unmis-

takable continuum from one so-called unprecedented era to another. One crisis tends to beget the next. Led by the great Paul Volcker, the US Federal Reserve took tough measures to arrest the Great Inflation (as did other central banks). But despite winning the war, policymakers squandered the peace taking interest rates far too low to preserve financial stability.

Similarly, as global capital markets seized up during the Asian financial crisis, central banks discovered the miracle drug of near-zero policy interest rates. That, in turn, set the stage for the profusion of asset bubbles to come – not just equities but also bonds and credit - that culminated in the global financial crisis a decade later.

Third, crises and the "extraordinary" developments they spawn are now the rule, not the exception. In recent decades, there has been an average of one catastrophe every three or four years. The Latin American debt crisis in 1982 was followed

by the 1987 stock-market crash and the 1986-95 savings and loan crisis in the US; implosions in Japan (1990), Mexico (1995), and Asia (1997); the near-collapse of the hedge fund Long-Term Capital Management (1998); the collapse of the dot-com bubble (2000); Enron's accounting scandal (2001); the sub-prime mort gage disaster (2007); the eurozone's sovereign-debt crisis (2010). the "taper tantrum" spurred by fear of policy normalisation by the Fed (2013); a Chinese stockmarket crash (2015), a US-China trade war (2018), COVID-19 (2020), and deglobalisation (2023).

It is against this background that forecasters face the seemingly impossible task of predicting the future. Of course, public policymakers face an equally profound challenge: While another crisis is coming, probably sooner rather than later, aligning forward-looking policy with the pitfalls of a highly uncertain future is the functional equivalent of balancing a heavy weight on the head of a pin.

But that hardly justifies selfserving excuses for policy mistakes, or portraying asset-market mispricing and economic dislocations as unavoidable accidents arising from so-called unprecedented circumstances. I have run out of patience with policymakers, corporate decision-makers, and investors who collectively throw up their hands and say, "Don't blame me."

This is largely a cop-out. Shocks are here to stay, and our task is not to predict the next one – although someone always does - but to sharpen our focus on resilience. Staying the course of politically mandated policies while minimising the inevitable dislocations is easier said than done. But that is no excuse to fall for the myth of being victimised by the unprecedented.

In a historic and comprehensive document called the UAE consensus, around 70,000 delegates from 198 stakeholder countries joined together to identify for the first time that fossil fuels were indeed the major culprit for the current climate crisis and called for a transition away from the fossil fuels in an orderly, just and equitable manner with a goal to achieve the net zero status by 2050. This is despite the initial hesitation from some oil-producing countries including the UAE itself with the President of the Summit, Sultan Ahmed Al-Jaber, reportedly voicing concern over the scientific rationale of the fossil fuel link to the climate

However, most impossible to relinquish. which are clean and green and a commitment to totally move away from fossil fuels is not easy to accomplish as an estimated 80% of the world's total energy production is based on fossil fuel sources like coal, petroleum and natural gas. It is the fossil fuel that triggered the Industrial Revolution in the eighteenth century ushering in a world of rapid economic growth leading to a better quality of life. However, it is lamenting to note that the world has not done anything significant to find solutions to economically viable alternative green sources of energy. The harnessing of energy from solar sources using photovoltaic technology is too expensive due to very high investment costs. Similarly, other renewables like wind, tidal, hydel, geothermal, and biomass are quite difficult to harness and, hence, gather no steam. The nuclear option, although a clean one, also has its own limitations owing to the limited abundance of nuclear fuels like uranium in nature. The fossil fuels, on the other hand, are so easy to access and handle that they have gained wide popu-

A climate justice can be delivered only when developed nations extend adequate financing and technology transfer to developing ones to achieve a smooth transition from a fossil fuel economy to a non-fossil fuel status. This will ensure their long-term growth and sustainable development by strengthening their climate resilience. Moreover, the poor nations are to be adequately compensated for climate-induced disasters they have been battling for decades as a result of the vigorous industrialisation activities of their developed counterparts. For a developing country like India, it is not possible to abandon fossil fuel with immediate effect or as fast as the US could do for example, as most of the electricity production in our country is still coal-based thermal power. Hence, to be true to the word 'just' as envisaged in the consensus, an abandonment has to first come from developed nations which should be followed by developing ones in a reasonable timeframe. It is imperative that phasing

out fossil fuels will require the

also the use of energy-efficient devices for cutting down wastage. The UAE consensus encourages parties to triple their renewables and double energy efficiency by 2030. The agreement to set up a \$450 million 'Loss and Damage' fund to serve as a compensation measure to vulnerable communities of poor countries falling victims to the climate crisis was a move in the right direction.

The unprecedented consensus reflects a paradigm shift in climate action in terms of inclusivity, collaboration and empowerment. Under these circumstances, although the days of fossil fuels are numbered, the world is eagerly awaiting to see how fast the implementation can happen. With the beginning of the end of the fossil fuel reign, days are not far when we will see the lost spring coming back again with crickets dancing and the cuckoo's sound reverberating in a soothing afternoon breeze!

Cops crack cyber fraud; 6 held

Bhubaneswar, Dec 23: In a major haul, Commissionerate Police seized 450 credit and debit cards, along with a cash amount of Rs 7.8 lakh from a person, who allegedly impersonated hundreds of people and transacted from their bank accounts money to the tune of several crores.

The accused, Biju Tripathy, 58, a native of Pipili has been arrested, along with other accomplices, including Prasanjit Dash, Pradeep Kumar Samantara, Mukesh Mantri, Abdul Rahman and Rajesh Das.

Giving more details, Bhubaneswar DCP, Prateek Singh said Saturday, that a complainant, Rakesh Kumar had lodged a case last week, alleging that a fake credit card has been

issued in his name by a miscreant. The complainant came to know this when he approached the bank for a loan, and was surprised to learn that an amount of Rs 1,40,000 lakh was deducted in a newly issued credit card in his name, he added

As police swung into action, it found prima facie that the accused, Prasanjit Dash, regularly used to retrieve personal credentials of victims and shared them with another accused, Pradeep Kumar Samantara, who is also a bank employee at ICICI bank. Subsequently, Pradeep used to process these details for issuing a new credit card under several other individuals' name.

The primary investigation of the police has unveiled that, Biju Tripathy, the main conspirator, used to keep account of detailed **During raid at the** residence of accused, Biju Tripathy, police found 6 mobile phones, 450 credit cards. 50 cheque books, 78 passbooks, 3 bags of transacted money receipts and 6 cash swiping machines

DCP Singh also informed that the search raid at Biju's residence found 6 mobile phones. 450 credit cards, 50 cheque books, 78 passbooks, 3 bags of transacted money receipts and 6 cash swiping machines.

The Commissionerate Police has booked six accused individuals under sections 419, 420, 467, 468 and 34 of IPC provisions along with Section 66 (D) of IT act. The accused has been produced before a local court today, said an official.

ORISSA SALES TAX ACT SC to hear case Jan 9

New Delhi, Dec 23: A sevenjudge Constitution bench of the Supreme Court will decide appeals from Odisha challenging the validity of Section 5A of Orissa Sales Tax Act, 1947 after a period of 29 years, January 9,

The Constitution bench headed by Chief Justice of India DY Chandrachud will hear the case.

Earlier in October, the Supreme Court had said that it would keep the pleas for directions immediately to see if the matter survives. "We will keep it for directions immediately to see if the matter survives. If it doesn't then we will close it since it is now a legacy issue," the Constitution bench had said.

Significantly, the court was hearing a petition filed by Arjun Flour Mills in 1994 challenging the validity of section 5A of the Orissa Sales Tax Act, 1947. The primary question to decide in the matter is whether a surcharge can be imposed on sales tax.

The apex court in October 1999 had referred the case to a bench of seven judges for consideration. The papers and proceedings may be placed before the Chief Justice for appropriate directions, the court had said.







VFR facility soon at Rourkela Airport

Rourkela, Dec 23: The Airport Authority of India (AAI) has planned to train four air traffic control officers posted at Rourkela Airport and provide them with special visual flight rules (VFR) training so as enable them to handle approaching aircraft during landing in any weather conditions

The four ATC officials were identified as David Topno, Amit Tigga, N Muralidhar, and Akhilesh Kumar of the airport. All of them have undergone aerodrome controller (ADC) training at different domestic and international airports of

They will be provided with one day of training at Rourkela

by Saroj Kumar Sahu, AGM (ATC) December 26. After the practical training, they will go to Bhubaneswar for further verification, which will be over by

The VFR training will not cost much to the AAI and the persons will be able to land a plane with 1,500 meters of visibility. Jeypore and Utkela airports already have VFR-trained staff.


However, only the 19-seater plane can land in these airports as their runways are much smaller in comparison to Rourkela airport. At Rourkela. the capacity is much larger and in future with a 1,800-meter runway the airport will be able to handle the landing of more than 100-seater capacity flights.

The development has come

after Usha Padhee, principal secretary of state Commerce and Transport department wrote to Nibedita Dubey, Regional Director of AAI, Eastern Region December 14. The letter specially made request for establishment of an approach control unit at Rourkela Airport for the approval of a special VFR.

The benefit of the VFR is almost free of cost apart from the training. However, the Rourkela Airport requires an instrument landing system (ILS), so that larger planes can land during nighttime. The ILS, apart from its installation cost requires ₹2 crores for annual maintenance.

Reacting to this, Bimal Bisi, the president of the Sachetana Nagarika Mancha and former secretary of the Steel Executive Federation of India (SEFI) said, "We welcome this move. However, our fight will continue for installation of ILS at Rourkela Airport. Without the ILS Rourkela Airport will not be able to operate bigger flights. Our city is poised to become an IT hub in near future and the efforts will suffer due to lack of ILS.'

Mahakalapara, Dec 23: Hopes soared high for construction of a bridge on river Gobari connecting Chandiapali with Mahakalapara block in Kendrapara district after a diver went inside the crocodile infested river for soil examination.

The bridge between Chandiapalli and Mahakalapara block will connect 10 riparian panchayats and will be constructed at a plan outlay of ₹47 crore

The foundation stone for the bridge was laid by the Chief Minister Naveen Patnaik in 2016. The construction of the bridge got delayed as the consultancy agency dilly-dallied in starting the

Fed up with the delay, the Works



department floated a fresh tender. In the bid, a Noida based agency Naren Das Construction Pvt Ltd was awarded the contract at a cost of ₹47 crore. Later, the agency started the construction works.

scuba diver Rajendra Nayak went inside the crocodile infested river in a protective iron fence and examined the soil on the bottom of the river to further proceed on the bridge construction, Friday.

Provided with oxygen, he remained inside the river for over an hour and examined the soil in various parts of the riverbed. Notably, Rajendra has successfully performed scuba diving in Qatar, Dubai and other countries.

However, when important tests are being conducted for the bridge construction, senior officials' absence at the site has sparked resentment among the people. Efforts to contact the higher-ups of Works department over phone failed to yield any result.



'Fake' medicine row: Congress seeks probe

New Delhi, Dec 23: The Delhi BJP Saturday demanded the sacking of Health Minister Saurabh Bharadwaj after Lieutenant Governor V K Saxena recommended a CBI inquiry into the alleged supply of drugs that failed quality standard tests in Delhi government hospitals.

The Delhi Congress said it is a "serious matter" and action should be taken against the culprits after an investigation. Addressing a press conference, Delhi BJP president Virendra Sachdeva blamed the Aam Aadmi Party government for the situation.

"We have the lab and vigilance report. The samples of the medicines being provided in Delhi government hospitals have failed. We demand that Chief Minister Arvind Kejriwal immediately sack his health minister, Sachdeva said.

Assembly Ramvir Singh Bidhuri said that the investigation should be completed swiftly. He emphasised that the issue of substandard medicines is not just a matter of corruption as it puts people's lives at risk. "Those responsible for this should face strict action," he said.

Reacting to the development. Delhi Congress chief Arvinder Singh Lovely demanded the setting up of a medical board to look into the issue."It is a serious problem and a probe must be conducted... A medical board should be constituted by the government so that other medicines

In a note to Chief Secretary Naresh Kumar, the Lt Governor mentioned that it is concerning that these medicines are being given to lakhs of patients, they said.

"It is with a sense of deep concern that I have perused the file. I am, to say the least, anguished at the fact that lakhs of hapless people and patients are being supplied fake drugs that have failed quality standard tests,' read the note to Kumar.

These drugs, procured by the Central Procurement Agency (CPA) under the Delhi Health Services (DHS), were supplied to Delhi government hospitals and may also have been supplied to the 'Mohalla Clinics', the Lt Governor said in his note.

ED summons Tejashwi again

New Delhi, Dec 23: The Enforcement Directorate (ED) has issued fresh summons to Bihar Deputy Chief Minister and RJD leader Tejashwi Yadav in the railway land-for-jobs scam case, asking him to appear January 5, official sources said Saturday.

He was earlier called to appear December 22 but the 34year-old skipped the summons. He had called the ED notice a routine affair.

In the same case, his father and Rashtriya Janata Dal (RJD) chief Lalu Prasad Yadav has been asked to depose December 27 at the ED headquarters in Delhi.

The alleged scam pertains to the period when Prasad was the railway minister in the UPA-1 government. "There is nothing new in the

summons. All these agencies --ED, CBI and I-T department -have summoned me so many



times in the past and I have duly appeared every time. But now it seems to have become routine," the RJD leader said December 21 in Patna.

It is understood that the summons come following the questioning of an alleged "close associate" of the Lalu Prasad family, Amit Katyal.

He was arrested by the ED in November. It is alleged that from 2004 to 2009, several people were appointed to Group "D" positions in various zones of the Indian Railways in return for land they transferred to the family members of Prasad, the then railway minister, and a linked company named A K Infosystems Private Limited.

New Delhi, Dec 23: In a major organisational rejig ahead of the Lok Sabha polls, the Congress Saturday appointed Avinash Pande the general secretary in-charge of Uttar Pradesh, replacing Priyanka Gandhi Vadra while Sachin Pilot was made the general secretary in-charge of Chhattisgarh.

Priyanka Gandhi will now be a general secretary "without any assigned portfolio", according to a

statement issued by the party. Pilot, along with GA Mir, Dipak

Babaria, and Deepa Dasmunshi, was appointed as general secretaries, while Tariq Anwar was dropped from the list.

Pande was earlier AICC in-charge of Jharkhand. The appointments come two days after a meeting of the Congress Working Committee (CWC), the party's highest decisionmaking body, which was chaired by party president Mallikarjun Kharge and attended by senior leaders, including Sonia Gandhi and Rahul Gandhi.

Pilot, a former Deputy Chief Minister of Rajasthan, replaces Kumari Selja, who has now been given the role of general secretary in-charge of Uttarakhand, the statement said. Congress leader Mir is the general secretary in-charge of Jharkhand with the additional charge

of West Bengal, it said. Dasmunshi has been given the charge of Kerala and Lakshadweep with additional charge of Telangana. Senior leaders Jairam Ramesh, K C Venugopal, Mukul Wasnik, and Randeep Singh Surjewala remain the general secretaries in-charge of communication, organisation, Gujarat and Karnataka, respectively.

"Due to the head wound, she was feeling quite dizzy. She was being treated at Kailash Deepak Hospital in Delhi," he claimed. Kwatra also alleged that during the fight Bindra broke his sister's mobile phone. He urged the police to take strict action in

752 new Covid cases, 4 deaths reported in 24 hours

New Delhi: India saw a single-day rise of 752 coronavirus infections, the highest since May 21, 2023, while the active cases have increased to 3,420, according to Union health ministry data updated Saturday. The death toll was recorded at 5, 33,332 with four new deaths -- two from Kerala, one each in Rajasthan and Karnataka -- reported in a span of 24 hours, the data updated at 8 am stated. The country's Covid case tally stood at 4.50 crore (4, 50, 07,964).

Infiltration bid foiled; terrorist killed

Jammu: One terrorist was killed as army troops guarding the International Border (IB) scuttled an infiltration attempt here early Saturday, officials said. The operation happened when a group of four heavily-armed terrorists was noticed sneaking into this side from across the IB in the Khour sector of Akhnoor in the early hours, the officials said. Army's Jammu-based White Knight Corps said the suspected movement of terrorists was captured through surveillance devices during the intervening night of December 22 and 23. "Effective fire brought down. Terrorists seen dragging one body back across the IB," it posted on X.

ED arrests three Vivo-India executives

New Delhi: The Enforcement Directorate (ED) has arrested three Vivo-India executives in connection with its money laundering probe against the Chinese smartphone maker and some others, official sources said Saturday. Interim CEO of vivo-India Hong Xuquan alias Terry -- a Chinese national -- Chief Financial Officer (CFO) Harinder Dahiya and consultant Hemant Munjal have been taken into custody under the provisions of the Prevention of Money Laundering Act (PMLA), they said. They were presented before a court which sent them to ED custody for three days, the sources said.

Rat-hole miners not to encash cheques

Dehradun: The rat-hole miners who played a vital role in the evacuation of 41 workers trapped in the Silkyara tunnel have refused to encash the cheques of Rs 50,000 given to them recently by Uttarakhand Chief Minister Pushkar Singh Dhami. The rat-hole miners said the Chief Minister's gesture was "not commensurate" with the role they had played. "It was a desperate situation. We chipped in when the machines had failed to reach the trapped workers. We drilled manually through the debris risking our lives without putting any preconditions. We appreciate the gesture of the Chief Minister but are not satisfied with the amount that was given to us," Vakil Hassan, who headed the team of the rat-hole miners, said. "The role of rat-hole miners in the operation was heroic but what they got from the government was sadly not adequate," he said. The 12 rat-hole miners honoured by the state government have collectively decided not to encash the cheques, he said.

'Extreme cold raises risk of brain stroke'

New Delhi, Dec 23: As the winter settles in different regions, experts have expressed concern over the correlation between the cold weather and an elevated risk of brain haemorrhage, presenting a critical nexus between temperature and health issues.

Dr Manish Vaish, senior director, neurosurgery, at Max Super Speciality Hospital, Delhi, said that a series of pivotal studies published in esteemed medical journals, including ScienceDirect, American Heart Association Journals, and PubMed, have unearthed an alarming connection - cold weather significantly amplifies the vulnerability to brain haemorrhage, impacting individuals with hypertension and normotensive individuals alike.

In a compelling case-crossover analysis featured in ScienceDirect. researchers have revealed that cold



temperatures pose a heightened risk for haemorrhagic stroke compared to snowfall. "This study emphasises the potent role of cold weather as a risk factor for brain haemorrhage, suggesting a potential trigger for this," Dr Vaish said.

"Cold weather appears to act as a catalyst, particularly in individuals with hypertension, elevating the risk of brain haemorrhage. The correlation between cold weather and heightened risk demands proactive preventive measures, especially for those with existing health conditions." added Dr Vaish.

Furthermore, a study in the

American Heart Association Journal highlighted a disconcerting link between cold temperatures and increased blood pressure in normotensive individuals, said Dr Yashpal Singh Bundela, senior consultant, Sushrut Brain and Spine, Delhi.

He emphasised, "Even normotensive individuals face an increased risk of high blood pressure in colder temperatures, significantly heightening the risk of cerebral haemorrhage. This underscores the need for timely interventions to mitigate potential health hazards during cold weather."

The implications of these findings are clear and pressing. Timely intervention, including managing blood pressure levels and adopting protective measures against extreme cold, is crucial to minimise the potential risks associated with brain haemorrhage during colder seasons, he stated.



Russia buys 92 jets from foreign firms

Moscow: Russia has bought out another 92 planes from foreign leasing companies, airlines and aircraft leasing company AerCap said. The planes have been bought out using money from Russia's National Welfare Fund, 190 billion roubles (\$2.06 billion) of which has been allocated for the purpose. Ownership will now pass to Russia's state insurance company NLK-Finance, which will transfer them to the airlines. Airline S7 said 45 of its formerly foreignowned planes had been bought out, while national flag carrier Aeroflot said deals had been completed for 28 of its aircraft, with another 19 for Ural Airlines.

Quake toll rises

Beijing: The death toll from the 6.2-magnitude earthquake that iolted northwest China earlier this week has risen to 148, with as many as 117 persons dead in the worst-hit Gansu province, authorities said. The quake, the worst in nine years in the region, struck midnight on December 18 at a depth of 10 kilometres. In Qinghai province, which borders Gansu, 31 people were killed in the earthquake. As of Friday, the earthquake had injured 781 people in Gansu, according to the provincial earthquake relief headquarters, the state-run Xinhua news agency reported

Rafah, Dec 23: More than 90 Palestinians, including dozens from an extended family, were killed in Israeli airstrikes on two homes, rescuers and hospital officials said Saturday, a day after the UN chief warned again that nowhere is safe in Gaza and that Israel's offensive is creating "massive obstacles" to distribution of humanitarian aid.

Also Saturday, the Israeli military said troops arrested hundreds of alleged militants in Gaza over the past week and transferred more than 200 of them to Israel for further interrogation, providing rare details on a controversial policy of mass roundups of Palestinian men.

The army said more than 700 people with alleged ties to the militant groups Hamas and Islamic Jihad have so far been

sent to Israeli lockups.

Israel declared war after Hamas gunmen stormed across the border October 7, killing some 1,200 people and taking some 240 hostages.

Despite mounting international calls for a cease-fire, Israel has vowed to keep up the fight until Hamas is destroyed and removed from power in Gaza and all the hostages are freed.

The Biden administration has shielded Israel in the diplomatic arena. On Friday, the UN Security Council adopted a watered-down resolution that calls for immediately speeding up aid deliveries to desperate civilians in Gaza, but not for a cease-fire

The Health Ministry in Gaza Saturday evening said 201 people had been killed over the past

On Friday, airstrikes flattened two homes, one in Gaza City and the other in the urban refugee camp of Nuseirat in the center of the territory.

ISRAEL BLAMES HAMAS

Israel blames Hamas for the high civilian death toll, citing the militants' use of crowded residential areas and tunnels. Israel has launched thousands of airstrikes since October 7, and has largely refrained from commenting on specific attacks.

Israel's offensive has been one of the most devastating military campaigns in recent history, displacing nearly 85 per cent of Gaza's 2.3 million people and leveling wide swaths of the tiny a million people in Gaza — a quarter of the population — are starving, according to a report this week from the United Nations and other agencies.

The military spokesman, Rear Adm Daniel Hagari, said late Friday that forces are widening the ground offensive "to additional areas of the strip, with a focus on the south." He said operations were also continuing in the northern half of Gaza, the initial focus of Israel's ground offensive. The army said that it carried out airstrikes against Hamas fighters in several locations of Gaza City.

US BLOCKS GAZA AID

Following the UN resolution, it was not immediately clear how and when aid deliveries would accelerate. Currently, trucks enter through two crossings - Rafah on the border with Egypt and Kerem Shalom on the border with Israel. On Friday, fewer than 100 trucks entered the crossings, the UN said — far below the daily average of 500 before the war.

Both crossings were closed Saturday by mutual agreement among Israel, Egypt and the UN, Israeli officials said.

Ahead of the Security Council vote, the US negotiated the removal of language that would have given the UN authority to inspect aid going into Gaza, something Israel says it must continue to do itself to ensure material does not reach Hamas.

In an emailed statement to PTI, the City of Newark Police Department in Newark, California, said that Friday at approximately 8:35 am, Newark Police received a report of graffiti at the Shri Swaminarayan Mandir Hindu Temple.

Based on the content of the graffiti it is believed that the defacement was a targeted act, and the vandalism is being investigated as a possible hate crime,' the statement said.

The Consulate General of India in San Francisco strongly condemned the defacing of the temple. "We strongly condemn the defacing of SMVS Shri Swaminarayan Mandir at Newark, California with anti-India graffiti," the Consulate posted on X.

Biden signs \$886bn defence bill into law

Washington: President Joe Biden Friday signed into law the US defence policy bill that authorizes arecord \$886 billion in annual military spending and policies such as aid for Ukraine and push-back against China in the Indo-Pacific. The National Defense Authorization Act, or NDAA, passed Congress last week. The Democratic-controlled US Senate approved the legislation with a strong bipartisan majority of 87 to 13 while the House of Representatives voted in favor 310 to 118. The act, nearly 3,100 pages long, called for a 5.2% pay raise for service members and increased the nation's total national security budget by about 3% to \$886 billion. It also lists certain Chinese battery companies that it says are ineligible for Defense Department procurement. The bill extends one measure to help Ukraine, the Ukraine Security Assistance Initiative, through the end of 2026, authorizing \$300 million for the program in the fiscal year ending September 30, 2024, and the next one.

Japan approves record military budget Tokyo: Japan's Cabinet Friday approved a hefty 16% increase in military

spending next year and eased its postwar ban on lethal weapons exports, underscoring a shift away from the country's self-defence-only principle. The moves came as Japan accelerates the deployment of longrange cruise missiles that can hit targets in China or North Korea while Japanese troops increasingly work with allies and take on more offensive roles. In a latest step under a new security strategy that Japan adopted a year ago, Prime Minister Fumio Kishida's government also allowed the export of weapons and components made in Japan under foreign licenses to the licensing nations. The controversial move is the first major revision of Japan's arms export ban since an earlier easing in 2014. "In taking the action, we hope to contribute to defend a free and open international order based on the rule of law and to achieve the peace and stability in the Indo-Pacific region," Kishida told reporters. "There is no change to our principle as a pacifist nation.

ITR forms 1 and 4 for AY'25 notified

New York, Dec 23: The Federal Reserve's dovish December pivot has boosted the case for the weakening dollar to keep falling into 2024, though strength in the US economy could limit the greenback's decline.

After soaring to a two-decade high on the back of the Fed's rate hikes in 2022, the US currency has been largely rangebound this year on the back of resilient US growth and the central bank's vow to keep borrowing costs elevated. Last week's Fed meeting

marked an unexpected shift, after Chairman Jerome Powell said the historic monetary policy tightening that brought rates to their highest level

in decades was likely over, FOR 1% LOSS THIS YEAR AGAINST A BASKET thanks to cooling inflation. Policymakers now project 75 basis points of cuts next year.

AGAINST THE DOLLAR THIS YEAR Falling rates are generally seen as a headwind for the dollar, making assets in the US currency less attractive to vield-seeking investors. Though strategists had expected the dollar to weaken next year, a faster pace of rate cuts could accelerate the cur-

An early December Reuters poll of 71 FX strategists showed expectations for the dollar to fall against G10 currencies in 2024, with the greater part of its decline coming in the second half of the year.

Whether they're right may come down to how the US economy performs compared to its global peers next year and the pace at which central banks adjust monetary policy.

So far, it's been an uneven picture. In the eurozone, a downturn in business activity deepened in December, according to closely watched surveys that show the bloc's economy is almost certainly in recession. Still, the European Central Bank has pushed back against rate cut expectations as it remains focused on fighting inflation. The euro is up 2.4% against the dollar this year.

The "growth slowdown is more entrenched in other economies," said Thanos Bardas. senior portfolio manager at Neuberger Berman, who is bullish on the dollar over the next 12 months. "For the US it will take a while for growth to slow down.

Others, however, see areas of strength, particularly in Asian economies. Paresh Upadhyaya. director of fixed income and currency strategy at Amundi US, says he believes the market is "way too pessimistic" on the outlook for growth in China and India. Accelerating growth could raw materials, benefiting commodity currencies such as the Australian, New Zealand and Canadian dollars.

China will step up policy adjustments to support an economic recovery in 2024, according to state media reports.

Jack McIntyre, portfolio manager at Brandywine Global in Philadelphia, is counting on US growth slowing while Chinese growth picks up. He has been selling the dollar to fund the purchase of Asian currencies.

"The dollar's bull run is very mature," he said.

The International Monetary Fund in October forecast the US economy would grow by 1.5% in 2024, compared to 1.2% for the eurozone and 4.2% for China.

Of course, the dollar's trajectory could depend on how much Fed easing and falling inflation is already reflected in its price. Futures tied to the Fed's policy rate show investors factoring in more than 140 basis points in cuts next year, nearly twice as much as Fed policymakers have penciled in.

"If inflation stalls and does not continue to decline that's where the case grows for the Fed to hold off," said Matt Weller, head of market research at StoneX. "That would certainly be a bullish development for

Flexible airspace use can save ₹1K-crore annually for airlines

New Delhi, Dec 23: Airlines will have potential savings of ₹1,000 crore annually with the flexible use of airspace that helps in reducing flight time, fuel usage and carbon emissions, according to the civil aviation ministry.

In a review of the aviation sector released Saturday, the ministry also said that a record number of commercial pilot licences at 1,562 have been issued this year till December 18 by the Directorate General of Čivil Aviation (DGCA).

To address the issue of congestion at airports, the ministry said additional space has been created at various airports by restructuring the available terminal infrastructure to augment capacity at several passenger touch points.

Meanwhile, the ministry said that earlier about 40 per cent of the airspace was unavailable for civilian use, resulting in aircraft adopting circuitous routes to reach their destinations.

The Indian Air Force controls

30 per cent of the national airspace and out of that, 30 per cent has been released as upper airspace under flexible use of air-

space, the release said.

As part of Aatmanirbhar Bharat, IAF has agreed to release these portions of airspace for civilian use, the ministry said, adding that 129 conditional routes have been promulgated.

'This will lead to significant savings in flight time, fuel usage and reduction in carbon emission. The potential savings to the airlines will be to the tune of ₹1.000 crore per annum. Total savings so far from August 2020 ₹640.7 crore and total CO2 reduction is 1.37 lakh tonne," the release said.

During the year, domestic air passenger traffic rose significantly.

'On November 19 this year, airlines in India flew 4,56,910 domestic passengers. This was the highest single-day air traffic since the pandemic hit, marking a remarkable 7.4 per cent surge above pre-Covid averages," the release said.

It was Australia all the way on third day with their seamers unleashing a short-ball attack on the Indian tail, which folded in a little over half an hour into the day's play with 30 runs added for the loss of last three wickets.

Sutherland (2/41) was Australia's primary weapon as she claimed two wickets in the form of overnight batter Pooja Vastrakar (47, 126b, 7x4) and Renuka Singh (8), while Kim Garth accounted for Deepti Sharma (78, 171b, 9x4) but not before the Indians reset a couple of records.

India's first-innings total of 406 is now their highest ever in Test cricket against Australia. A 122-run stand for the eighth wicket between Deepti and Vastrakar is India's highest in the format and second best for any side in the world.

With 187 in deficit, Australia openers Beth Mooney and Phoebe Litchfield began well but both were guilty of throwing away their starts. Richa Ghosh deserved full credit for running out Mooney for 33 (37b, 7x4) after the batter carelessly ventured out of her crease after defending a delivery from Sneh Rana (2/54).

Ghosh, positioned at silly point, hurled the ball back at the wickets while Mooney seemed to have lacked awareness of getting back into the crease. Litchfield (18) was cleaned up by Rana when the batter attempted a reverse sweep but missed connecting completely.
