PANDIAN REVIEWS SRIMANDIR HERITAGE CORRIDOR PROJECT

Bhubaneswar, Dec 30: Ahead of the inauguration of the Shree Jagannath Temple Heritage Corridor project in Puri January 17, Chief Minister Naveen Patnaik's close aide VK Pandian Saturday reviewed the progress of pilgrim's holding area, queue management and traffic control in the holy town.

Pandian, the chairman of 5T (Transformational Initiatives) and 'Nabin' (new) Odisha, visited the ongoing project and facilities being created near the 12th-century shrine.

During his visit, he inspected the progress on landscaping works, mutt (monastery) restora tion, queue management system, two-wheeler parking areas, garbage chutes and facade painting and emphasized on timely completion, a release issued by the CMO said.

Pandian also inspected 'Shree Danda', 'Shree Jagannath Ballav Vihar' and 'Shree Setu'. He discussed with the Puri Collector. SP and managing director of Odisha Bridge Construction Corporation (OBCC) regarding the progress of the project with focus on parking and security measures.

Congress workers opposed the visit of Pandian to Puri and showed black flags to him Saturday. The protest happened when Pandian arrived in front of the Shree Jagannath Temple Administration (SJTA) office at Puri.

Arun Sarangi gets addl charge of DGP

Bhubaneswar: A day before Sunil Bansal retires as Odisha DGP, the state government Saturday said senior IPS officer Arun Kumar Sarangi will hold the post as additional charge till further notice. Sarangi, a 1990-batch Odisha cadre IPS officer, is at present the Special DG of Police, Training and Director of Biju Patnaik State Police Academy. "Shri Arun Kumar Sarangi... Is allowed to remain in additional charge of DG of Police, Odisha until regular DGP joins," a notification issued by the Home Department said. Meanwhile, sources said the Odisha government has sent a list of five IPS officers to the Central government for appointment of a regular DGP.

₹1,849cr irrigation projects

Bhubaneswar: Chief Minister Naveen Patnaik Saturday laid foundation stone for two major irrigation projects that would be developed at a cost of ₹1,849 crore in Nabarangpur district. While the Parvati Giri lift irrigation project will be constructed at an investment of ₹1,272 crore, around ₹577 crore will be spent on the Turi-Guntat project. About 70,000 acres of farmland in 120 villages in Nandahandi, Nabarangpur and Tentulikhunti blocks of the district will get irrigation facilities when the Parvati Giri P3 project is complete, an official statement said.

ODISHA CABINET OKAYS 13 PROPOSALS COVERING VARIOUS SECTORS

Bhubaneswar, Dec 30: Enhancement of upper age limit of candidates appearing for Odisha Civil Service (OCS) exams to 38, from the existing 32, for the 2024 recruitment calendar, and addition of 200 more electric buses to the Mo Bus fleet are among the 13 proposals that received a go-ahead from the state Cabinet, chaired by Chief Minister Naveen Patnaik, Saturday

Considering delay in recruitment process, the state government had earlier enhanced the upper age limit of OCS aspirants from 32 to 38 for advertisements made during calendar years 2021, 2022 and 2023, Chief Secretary PK Jena said after the Cabinet meet here.

In order to provide ample opportunity to candidates wishing to participate in the recruitment examinations for 2024 calendar year, the state has decided to amend the Orissa Civil Service (Fixation of Upper Age Limit) Rules, 1989, he said.

The Chief Secretary added, "Following the amendment, the upper age limit for OCS exam aspirants will be increased to 38 from 32 for advertisements in 2024 calendar year.

buses will be procured and added to Capital Region Urban Transport's (CRUT) Mo Bus fleet. CRUT began Mo Bus services in

Bhubaneswar with 200 diesel buses in November 2018, Soon after, 55 Midi buses and 50 electric buses were added to the fleet. Later, CRUT expended its services to Rourkela and its hinterlands with addition

of 100 midi buses, he said. "The Cabinet approved the bidding process taken up by CRUT and selected JBM Ecolife Mobility Private Limited as operator for procurement, operation and maintenance of 200 electric buses on gross contract basis for 10 years with a total cost of ₹933,26,40,000," Jena pointed out.

For the safety of commuters and reduction of carbon emission, the state Cabinet approved the 'Implementation of LED ies (ULBs) in Odisha," Jena said. The state Cabinet approved allotment of five acres of land in Bhubaneswar free of premium to the Public Health Foundation of India for establishment of a permanent campus of Indian Institute of Public Health (IIPH) that will create skilled human resource in public health system,

the Chief Secretary said. To promote Jagannath Culture at village level, the state government will collect betel nut and a handful of rice from all households in state for the inauguration ceremony of Shree Jagannath Heritage Corridor Project in Puri January 17, the Cabinet decided.

Addressing a public event in Ayodhya, Modi said, "December 30 has been a very historical date in the history of the country. On this day in 1943, Netaji

Subhash Chandra Bose hoisted the flag in Andaman and proclaimed the Independence of India.

He further said that if any country wants to reach new levels of development, it has to preserve its heritage.

Modi said that the India of today is an 'amalgam of the old and the new'

We are moving ahead in the digital age and are also preserving our heritage. Development must come with preservation of heritage and carry forward Viksit Bharat," he pointed out.

The prime minister added that the completion of the Ram temple is a moment that the world was waiting and the excitement is palpable on the streets of Ayodhya.

REPEAT WATCHING ENABLES IMMERSION INTO A MAKE-BELIEVE WORLD THAT PROVIDE COMFORT

o you find your children asking to watch the same TV shows and movies, or play the same video games over and over (and over again)? Perhaps you also find yourself thinking it would be better if they had a more varied screen-time diet.

Children learn through repetition

Children have a lot to learn about themselves and the world. A big part of the way they do this is through repetition.

This applies to learning to walk, talk and read. But it can also be said for TV shows, movies and video games with a storyline such as 'Stardew Valley

Children may start by learning about the plot. On subsequent viewings they may pick up more details about the characters, the songs, the context or even the subtle twists and turns of



the plot.

So this offers children insights into different characters, stories and ideas. These different perspectives offer valuable opportunities for learning about people and the world.

Repeat watching also enables immersion into a make-believe world that provides comfort. Just like adults might enjoy catching up on old episodes of Seinfeld or Friends, or watching Love, Actually each Christmas. A unique opportunity

When a child watches something

over and over, this also opens up unique learning opportunities because they get to know the story so well.

Once a child is very familiar with a storyline, they can have deep discussion to help them think critically about what they are watching, especially once they've reached primary-school age.

Together, you can share ideas and consider alternative viewpoints to those offered in the story. Together, you can also question the assumptions in the characters' actions and the storyline.

This will help your child's critical thinking and help them evaluate information in the rest of their lives. It can also help them weigh up positive and negative attributes of characters, plots and beliefs that form part of the storyline. Ultimately, this can help your child learn to reason and make judgements about controversial issues, and hopefully learn to do this in a respectful way.

may be incorporated in the amendment of the Ancient Monuments and Archaeological Sites and Remains Act.

The Union ministry of Culture has accepted the recommendation of the committee for the implementation.

The committee said that no proposal exists at present with ASI for empowering local bodies to provide security guards to the unprotected monuments.

The committee stated that given their proximity and cultural ties with local monuments, local bodies are best suited to look after the protection of historical monuments especially those which are not under the



list of Centrally Protected Monuments (CPMs). "Empowering local bodies to provide security guards at such monuments for their protection can go a long way in ensuring that these monuments are preserved in their present state for generations to come," the committee said. It recommended that provisions to empower local bodies for the protection of historical monuments and to make them accountable may be incorporated in the amendment of the AMASR Act.

The committee had also recommended formation of the State Level Co-ordination Committees for coordination between the ministry of Culture and respective state governments for resolving important issues such as removal of encroachment of monuments. The ministry informed the com-___ mittee that 11 states including Odisha have formed such committees.

efence Minister Rajnath Singh has visited the families of those Kashmiris killed in army custody and assured them justice. He told them, it was reported, that "nobody can bring those who have died back to life. But there will be justice." This was a good thing to have said in humane terms and we shall see if justice comes. We should however examine the past record of the government of India (all governments including previous ones) when it comes to justice for those wronged by our army.

Much of the focus is on AFSPA, the law that gives armed forces immunity in so called "disturbed areas" of India. We should try and understand it. In 2015, it was pointed out that the Disturbed Areas Act had lapsed in Kashmir in 1998 but AFSPA was still in force, apparently without sanction, but this was overlooked.

The key provision of AFSPA was the sweeping empowerment of individuals belonging to the police and the military and the paramilitary to open fire "if he is of opinion that it is necessary so to do for the maintenance of public order." The forces could use force "even to the causing of death" and would be immune from prosecution for their actions except with the sanction of the Centre.

They could destroy anything they thought was a hideout, a fortified position or shelter from which an attack could be made. And they could arrest and detain without a warrant anyone they wanted and could use force in effecting the arrest. What happens when you give armed men such freedom in a place that has been declared hostile by the State is not difficult to imagine. On 1 January 2018, the Rajya Sabha was informed by the government that the Defence Ministry had got 50 requests in 26 years from the Jammu and Kashmir government for permission to prosecute soldiers under AFSPA. It granted permission in zero cases. These include cases of soldiers accused of unlawful killings, torture and rape between 2001 and 2016

An Amnesty India report published in 2015 looked at over a hundred cases and met with 58 families and found that since 1990. no sanction had ever been given to prosecute those accused by the Kashmir government of crimes. A chargesheet is the document filed after an FIR is registered and on the basis of investigation, meaning the police had found evidence of a crime.

However, the Centre has approved none of the state's requests for justice. The army says it conducts its own justice system, the court martial. These are opaque processes where the survivor or victim does not have access and shouldn't be used for crime unrelated to military discipline. However, this parallel court system has been allowed to soldiers trying fellow soldiers of crimes against civilians.

An editorial in the Economic Times ('Pathribal fake encounter case: India's army's acquittal of accused soldiers a blot on democracy', 27 January 2014) describes what happens in these courts martial. The case discussed related to an attack in March 2000 during the then president Bill Clinton's visit to India. The army claimed it had attacked a hut which contained Lashkar-e-Taiba militants who had participated in a massacre of Sikhs in the village of Chattisingpora just before the Clinton visit. On 11 May 2006, after investigating the case the CBI filed murder charges against five serving army personnel from the 7 Rashtriya Rifles unit in the court of the Chief Judicial Magistrate of Srinagar. The CBI argued this was a case of 'cold blooded murder' and were not actions taken in the course of performing official duties, and so the perpetrators could not be protected. The Indian Army blocked the prosecution of five army personnel under Section 7 of the AFSPA. The Supreme Court of India upheld the army's action and asked it to decide whether it wanted to court martial them instead. In September 2012, over twelve years after the murder of the five civilians in Pathribal, the Indian Army chose to bring the case before the military justice system and began proceedings in a general court-martial. On 24 January 2014 the Indian Army said it was dismissing all charges against five of its personnel due to a lack of evidence. According to the closure report filed in the Srinagar Chief Magistrate's Court, the Indian Army did not conduct a trial but instead dismissed the charges through a pretrial procedure known as summary of evidence under Rule 24 of the Army Rules 1954. The Economic Times editorial said that "the army's self-acquittal of the Pathribal accused is a continuation of the cover ups of human rights violations in J&K and India's Northeast, where the military has a free hand in dealing out "justice" as it deems fit. This is a blot on our democracy. In another case, the paper reported on 11 July 2018 ('Machhil encounter: Life sentence of 5 army men suspended') soldiers were convicted of murdering three civilians but freed nonetheless by an army tribunal without explanation. Two years ago, on December 4, 2021, soldiers from the 21 Para Special Forces army unit shot and killed six coal miners in Nagaland's Mon district. The deaths led to violent clashes between local villagers and troops, and seven more civilians and a soldier were killed. A day later, soldiers killed another person after protesting villagers attacked their camp In June 2022, Nagaland police filed charges against 30 soldiers, including a major, after a special investigation team found the military had used "wrong positive identification without proper application of mind," and that the miners were shot "with a clear intention to kill." On April 14, 2023, the Indian government denied permission to pursue the prosecution.

nother year is passing. We await the New Year with hope as well as anxiety, as the world is going through turbulent times. Philosophically speaking, it is the order of life, full of ups and downs, happiness and sorrow, peace and war. The last cycle of international life (peace and war) is under interrogation as Prime Minister Narendra Modi profoundly said while mildly chiding the Russian President Vladimir Putin last year during Shanghai Cooperation Summit at Samarkand, that "it is no time for war.

The United Nations was created after the Second World War to prevent further wars. However, the world community has failed in preventing full-scale wars in addition to several armed skirmishes and clashes. The horrifying war in Ukraine continues unabated causing horrendous loss of lives, properties and resources. The war that started last year lingers on defying diplo macy and the political acuity of world leaders. Apparently, the Ukrainian war at present is stalemated as Russia seems to tire out and Ukraine running out of support from the West. Until there is some kind of truce, the war can intensify at any stage as the resources or resolve on either side are reinforced.

If Ukrainian war was not enough for the world community to address the disruptions in economy and politics, another violent war erupted in the Middle-East between Israel and Hamas. This was quite unexpected. Israel and Palestine were living in peace and some kind of co-existence since the conflict began over seven decades ago. However, terrorism as a method of conflict resolution is still lurking around. This is completely illegitimate and unacceptable. India, as a victim of cross-border terrorism has been raising the issue of eliminating the scourge of terrorism from world. But, because of dubious policies of quite a few

countries terrorism persists. According to reports, over 20,000 civilians in Palestine have been killed. Israel is facing assaults from Hezbollah in Lebanon and Houthis in Yemen. According to the Israel military, the war is likely to continue for months. Again, the world leaders have

miserably failed in bringing about a lasting ceasefire, let alone the end of the war. In dealing with the current war, the commentators are going back to the origin of conflict and are caught in victim-aggressor-victim cycle. In this war, both Israel and Hamas have become aggressors as well as victims.

Recalling the brighter side of India and its interactions with the world, we had an amazingly successful G20 Summit in Delhi. It came up roses inasmuch as there was a consensus statement by the world leaders despite a divided opinion on Ukrainian war. Indian leadership was credited with successful negotiation across the countries.

This year, India became the fifth largest economy in the world. That is some achievement to shout about as India's growth has been constantly low in the 70s and 80s at 3 per cent which was queerly called 'Hindu rate of growth' by an eminent economist, Prof. Raj Krishna. The economic planners resolved

to expedite the economic growth which is promised to be over \$5 trillion by the end of this decade to be the third largest in the world. However, the prosperity of the country is measured by per capita GDP not the country's GDP alone. In that sense, disappointingly, India has the lowest per capital GDP among all G20 members.

At the same time, India became the most populous country in the world surpassing China. This is again a distinction India could claim provided it uses the demographic dividend intelligently and strategically. Prime Minister Modi, in an article, articulated the strength of India in terms of four Ds – democracy, demography, development and diversity. So, India's population, mainly its large segment of youth population, could be harnessed in India and abroad. India's foreign policy could strategise on population redistribution, facilitating the migration of skilled manpower to various countries.

There were two unsavoury incidents involving India and Canada and India and the USA. In both the cases, two Sikhs of Indian origin having accepted the citizenship of Canada and USA, were plotting violent attacks on Indian agencies. One of them,

Hardeep Singh Nijjar with dual citizenship of India and Canada, was murdered in Canada. The Canadian Prime Minister accused Indian agencies being be hind his death. An avoidable diplomatic row erupted. Similarly, the US citizen Gurpatwant Pannu, who called for boycott and violence against Air India, was targeted causing the US to point a finger at Indian intelli gence agencies. The sharing of evidence is on between relevant authorities in India and the US.

On the side of caution, it is to be noted that once again the US Commission on International Religious Freedom has asked for 17 countries, including India, to be put as 'countries of particular concern'. This is about lack of religious freedom in those countries. This is certainly a matter of concern for a country like India, which has been famous across the world for religious tolerance and accommodation. Remember. Prime Minister Modi spoke in Israel with a great sense of pride that no Jew suffered from anti-Semitism in India. India is one of the few countries in the world with a secular Constitution.

Likewise. India ranked low in the ranking of three democracy watchdogs – Freedom House, V-Dem and Economist Intelligence Unit. One may quarrel with their process of measurement of democracies, but should we be completely dismissive of such concerns! When India is aspiring, may be rightly so, to be a Vishwa Guru because of its unique spirituality and culture, any blemish on India's pol itics and society should be addressed. The World Happiness Report 2023 shows India on 126th position out of 137 countries despite it being the fifth largest economy. Is this not something to address in 2024 and beyond?

A major reason is the disproportionate amount of abuse female politicians and candidates receive online, including threats of rape and violence, and the rise of artificial intelligence, which can be used to create sexually explicit deepfakes, is only compounding the problem.

And yet, over the past year, platforms such as Meta, X (formerly Twitter), and YouTube have de-emphasised content moderation and rolled back policies that previously kept hate, harassment, and lies in check. According to a new report, this has fuelled a "toxic online environment that is vulnerable to exploitation from anti-democracy forces, white supremacists, and other bad actors.'

Online attacks against women in politics are already on the rise. Four out of five female parliamentarians have been subjected to psychological violence such as bullying, intimidation, verbal abuse, or harassment, while more than 40% have been threatened with assault, sexual

analysis of congressional candidates found that female Democrats received ten times more abusive comments on Facebook than their male counterparts. And immediately after presidential candidate Joe Biden named Kamala Harris as his running mate, false claims about Harris were being shared at least 3,000 times per hour on Twitter.

Similar trends have been documented in India, UK, Ukraine, and Zimbabwe. Minority women face the worst abuse, together with those who are highly visible in the media or speak out on feminist issues. In India, one in every seven tweets about female politicians is problematic or abusive, with Muslim women and women belonging to marginalised castes bearing the brunt of the vitriol.

The disproportionate targeting of women discourages them from running for office, drives them out of politics, or leads them to disengage from online discourse in ways that harm their political effectiveness-all of which weaken democracy. In Italy, "threats of rape are used to intimidate women politicians and push them out of the public

Chamber of Deputies, adding that political leaders themselves often issue these menacing remarks.

Tech companies should take four steps to counter this trend. For starters, they should publish guidelines on what constitutes hate speech and threatening and intimidating harassment on their platforms.

Second, platforms need to reinvest in effective content moderation for all countries, not just the US and Europe. That means using a combination of human capital and improved automated systems. Equally important is training human moderators to identify online violence against women in politics and more equitable investment in effective content moderation.

Third, "safety by design" principles should be embedded in new products and tools. That could mean building mechanisms that "increase friction" for users and make it harder for gendered hate speech and disinformation to spread in the first place.

Lastly, independent monitoring by researchers or citizen groups would help societies keep track of the problem and how well tech

dered online abuse from undermining democracy. Tunisia and Bolivia have outlawed political violence and harassment against women, while Mexico recently enacted a law that punishes, with up to nine years in prison, those who create or disseminate intimate images or videos of women or attack women on social networks. But even when laws exist, female politicians speak of "virtually constant" abuse and report that law-enforcement officials do not take online threats and abuse seriously. In the UK, for example, less than 1% of cases reported to Scotland Yard's online-hate-crime unit have resulted in charges.

Tech companies and governments must act now to ensure that both men and women can participate equally in next year's elections. Unless they do, representative democracies will become less representative and less democratic.

SRI METHOD OF CULTIVATION IS BEING IMPLEMENTED IN THE DISTRICT WITH THE SUPPORT OF THE STATE GOVERNMENT, GREEN CLIMATE FUND AND UNDP

Berhampur, Dec 30: SRI (System of Rice Intensification) method of paddy cultivation can help check climate change and benefit the farmers as it consumes very less water in comparison to other methods of cultivation. This is because SRI method does not require continuous flooding for rice cultivation.

Taking up paddy cultivation in SRI method helps reduce the possibility of global warming by 29 per cent as it results in 25-70 per cent reduction in discharge of methane and carbon diox ide to the atmosphere. This method also produces more panicles during the harvest, reduces the crop harvest period by at least 10 days, requires mini mum amount of seed. water and chemical fertiliser for the crop. Moreover, the paddy cultivation is rain and storm tolerant and helps in increasing the fertility of the farmland.

As large volume of water is required for rice cultivation, farmers conventionally depend on rainfall to raise their crops.

However, due to a change in climatic conditions, it has become a difficult task for the farmers to supply enough water to their farmlands for growth of the paddy crops. Farmers have been failing to start their cultivation in time due to lack of water every year. Even if they manage to sow seeds, seedling death comes back to haunt them due to lack of irrigation facilities.

Lack of irrigation results in reduced output for farmers,

which is why they are withdrawing from rice cultivation in most cases. Distraught farmers look for financial assistance from the state government but they are often left high and dry.

As a result, in Ganjam district alone hundreds of acres are left uncultivated. Infant dies in MP

Shahdol: A one-and-halfmonth-old boy died after he was allegedly branded with a hot iron rod as part of a ritual to cure him of a respiratory ailment in Madhya Pradesh's Shahdol district, an official said Saturday. The infant died while undergoing treatment at the paediatric intensive care unit (PICU) of the district hospital on Friday, civil surgeon G S Parihar said.

Navlakha grilled

New Delhi: A team of Delhi Police has guestioned activist Gautam Navlakha in connection with probe into NewsClick's alleged foreign fundings and anti-India activities, an official said Saturday, Navlakha was questioned at his house in Navi Mumbai's Agroli for three hours by a team led by an assistant commissioner of police (ACP)-level officer. Navlakha was asked about his links with news portal's founder and Editor-in-C Prabir Purkayastha and about his share in the company, an official said. Navlakha, who was on house arrest, was granted bail on December 19 in the Elgar Parishad-Maoist links case.

New Delhi, Dec 30: Days after a low-intensity blast took place near the Israeli embassy here, Delhi Police have registered an FIR against "unknown" persons, officials said Saturday.

The FIR was registered Friday night under Section 3 (punishment for causing an explosion likely to endanger life or property) of the Explosive Substances Act and Section 427 (mischief causing damage to the amount of fifty rupees) of the Indian Penal Code at Tughlak Road police station based on a complaint lodged by a police officer, an official said.

The blast occurred Tuesday evening in the area between the boundary walls of a house on plot number 4 -- Nanda's House -- and the Central Hindi Training Institute on plot number 2A on Prithviraj Road. The area has bushes, plants and trees and no CCTV camera. It is behind the Israeli embassy on Dr APJ Abdul Kalam Road, running parallel to Prithviraj Road.

No one was injured in the blast. Police had found an "abusive" letter addressed to the Israeli ambassador near the blast site.

According to sources, the onepage letter written in English is suspected to be related to an organisation called Sir Allah Resistance and mentions words like "Zionists", "Palestine" and "Gaza".

Friday, police said that they were planning to register an FIR as they had found "crucial evidence" pointing to a conspiracy to threaten the Israeli envoy. Another official said Saturday that the

case might be handed over to the Special Cell to dig out the deeper conspiracy.

Delhi Police officials, who are investigating the case, have scanned footage of multiple CCTV cameras installed around the blast site and spotted a suspect who had come from Jamia Nagar in an autorickshaw.

Police have questioned multiple autorickshaw drivers, including the one who brought the suspect to the spot before the blast took place. However, police are yet to trace the accused.

The officials said police had recovered a broken dial of a watch and some steel bearings from the blast site but it was too early to say if they were used in the explosion. Investigating officials are awaiting reports from the National Security Guard's (NSG) laboratory, where samples collected from the spot have been sent to ascertain the components used in the explosion.

Police have recorded statements of a dozen people who claimed to have heard the loud noise of the blast. The statements reveal that the witnesses spotted a vehicle which broke down near the blast site.

Beijing: In a major purge of the Chinese military, nine senior generals of the People's Liberation Army (PLA), including senior officials of the country's Rocket Force, have been dismissed from China's Parliament, official media reported Saturday. Those dismissed from the National People's Congress (NPC), the country's Parliament, include five past or current top commanders of the PLA Rocket Force, which handles the missiles division and a key component of the country's nuclear arsenal besides a former Air Force commander, state-run Xinhua news agency reported. No reason for their disgualification has been mentioned. This is not the first time top generals of the PLA were dismissed for corruption as a number of them were summarily removed for graft and abuse of power after Xi came to power in 2012.

Gaza enters 12 weeks of war

Cairo, Dec 30: Israeli tanks pushed deeper into districts in central and southern Gaza overnight under heavy air and artillery fire, residents said, pressing a deadly offensive that has razed much of the enclave and that Israel has said may last months more.

Fighting late Friday and early Saturday was focused in al-Bureij, Nuseirat, Maghazi and Khan Younis, backed by intensive air strikes that filled hospitals with injured Palestinians. The bombardment has killed 100 Palestinians and injured 150 in the central Gaza Strip over the past 24 hours, a senior health official in central Gaza said.

Almost all of Gaza's 2.3 million residents have been forced from their homes by Israel's withering 12-week assault, triggered by the Hamas attack October 7 that killed 1,200 people and brought 240 hostages into the

group's grasp. The offensive has killed at least 21,500 Palestinians, according to health authorities in Hamas-run Gaza, and the conflict risks spreading across the region, drawing in Iran-aligned groups in Lebanon, Iraq, Syria and Yemen.

The State Department said Friday that Secretary of State Antony Blinken told Congress he approved a \$147.5 million sale for equipment, including fuses, charges and primers, that is needed for 155 mm shells Israel bought previously.

It marked the second time this month that the Biden administration is bypassing Congress to approve an emergency weapons sale to Israel. The department cited the "urgency of Israel's defensive needs" as a reason for the approval, and argued that "it is vital to US National interests to ensure Israel is able to defend

itself against the threats it

faces. The emergency determination means the purchase will bypass the congressional review requirement for foreign military sales. Such determinations are rare, but not unprecedented, when administrations see an urgent need for weapons to be delivered without waiting for lawmak-

ers' approval. Blinken made a similar decision December 9 to approve the sale to Israel of nearly 14,000

Genocide by Israel: **South Africa files** case at World Court

South Africa launched a case Friday at the United Nations' top court accusing Israel of genocide against Palestinians in Gaza and asking the court to order Israel to halt its attacks. Israel swiftly rejected the filing "with disgust." South Africa's submission to the International Court of Justice alleges that "acts and omissions by Israel . Are genocidal in character as they are committed with the intent "to destroy Palestinians in Gaza" as a part of the broader Palestinian national, racial and ethnic group. The Israeli government "rejected with disgust" the South African genocide accusations, calling it a "blood libel." A Foreign Ministry statement said the case lacks a legal foundation and constitutes a "vile exploitation and cheapening" of the court. Israel also accused South Africa of cooperating with Hamas. South Africa can bring the case under the Genocide Convention because both it and Israel are signatories to the convention.

Karachi, Dec 30: Pakistan's election body has rejected former Prime Minister Imran Khan's nomination to contest the 2024 national elections in two constituencies, officials and his party's media team said

Saturday. The 71-year-old former cricket star has been embroiled in a tangle of political and legal battles since he was ousted as prime minister in April 2022. He has not been seen in public since he was jailed for three years in August for unlawfully selling state gifts while in office from 2018 to 2022.

Khan has been disqualified from contesting the national elections scheduled for February 8 because of the corruption conviction, but he nevertheless filed nomination papers for the elections Friday, his media team said.

In a list of rejected candidates from Lahore, the Election Commission of Pakistan said Khan's nomination was rejected because he was not a registered voter of the constituency and because he is "convicted by the court of law and has been disqualified'

Khan, who is widely seen as the country's most popular leader, says he is being targeted by the powerful military, which wants to keep him out of the polls. The military denies the charge.

New York: Two Indian-origin men, who allegedly staged armed robberies across the US so that 'victims' could apply for immigration benefits, have been arrested on charges related to visa fraud, authorities have said. If the charges are proven, the duo can be sentenced to up to five years in prison, three years of supervised release, and a fine of \$2,50,000. Rambhai Patel, 36, and Balwinder Singh, 39, who have been charged with one count each of conspiracy to commit visa fraud, were arrested from Seattle and Queens in New York, respectively December 13, a press release from the US Attorney's Office, District of Massachusetts said here late Friday. Official documents suggested that starting in March 2023, Patel and his coconspirators, including at times Singh, set up and carried out staged armed robberies of at least eight convenience/liquor stores and fast food restaurants across the United States, including at least four in Massachusetts.

Flash floods kill 21

Johannesburg: Flash floods killed over a dozen people in the small town of Ladysmith in KwaZulu-Natal province, South African officials said Saturday. "As of Friday, 29 December 2023, a total of 21 bodies have been recovered,' said police spokesperson Colonel Robert Netshiunda. The floods hit the town on Christmas Day, destroying about 1400 homes, with the death toll expected to rise as an unconfirmed number of people are still missing, he said. Search and rescue teams have been scouring rivers to recover bodies, Netshiunda added. The operation is expected to continue throughout the weekend.

Dover is about 32 kilometres southwest of downtown Boston, the capital of Massachusetts. Teena and her husband, who

Can Trump run for 2024 US Prez despite bans?

THE REPUBLICAN FRONTRUNNER IS **TIPPING BACK TOWARDS CHAOS** AFTER COLORADO **AND MAINE DISQUALIFIED HIM** FROM 2024 BALLOT **OVER US CAPITOL RIOT INCITEMENT**

Washington, Dec 30: With multiple US states hearing challenges to Donald Trump's right to run in the 2024 election, his supporters claim his enemies are tearing up democracy to prevent his return to the White House. Rulings in Colorado and Maine

banning the ex-president from their primary nominating contests under the Constitution's "insurrection clause" set off a political earthquake that could upend the campaign. But do they pose a genuine threat to Trump's presidential ambitions?

Why Trump might be ineligible? The US House of Representatives impeached the Republican tycoon for inciting insurrection after he called on his supporters to march on the US Capitol ahead of a deadly riot that delayed the certification of the 2020 election.

A large, bipartisan majority of the Senate agreed with the lower chamber's finding, but the tally fell short of the two-thirds of members required for a conviction, which would have barred Trump from seeking office again.

Federal prosecutors have since charged Trump with conspiracy over the violence, and he is scheduled for trial in March.

Meanwhile, activists have brought court challenges nationwide to stop his name appearing on ballots for state primaries under the 14th Amendment, which bars people from office if they have taken an oath to defend the Constitution but subsequently "engage in in-

surrection." Where is Trump barred from running?

On December 19, the Colorado



Supreme Court ruled that Trump was ineligible for the state's primary under the 14th Amendment's 'insurrection clause.

Maine -- where the secretary of state, currently a Democrat, makes the initial eligibility determination -- followed suit Thursday.

Related challenges have been filed nationwide, with decisions pending in 14 states, according to national security website Lawfare's online disqualification tracker.

What happens next?

Both states put their bans on hold while the legal process plays out -- meaning Trump will almost certainly appear on both ballots for their March 5 primaries.

Grassroots Republicans have challenged the ruling in Colorado and the Trump campaign has indicated that it intends to appeal in both cases.

The Maine decision would go to the state's Superior Court first, while Colorado's ruling has already been through the state system and would be elevated directly to the US Supreme Court.

What can the US SC do?

The strongly conservativeleaning high court -- which includes three Trump appointees - can decline to review the Colorado case, meaning the Trump ban would stand.

In reality, most analysts believe that Maine joining with Colorado removes any doubt that the justices will act.

They would determine whether or not section three of the 14th Amendment -- the insurrection clause -- applies to a former president.

The court could also rule on whether the ban is automatic or would require an act of Congress, and whether the 2021 storming of the Capitol and Trump's role in it indeed qualify as insurrection.

The effect of the bans

Even if the Colorado and Maine bans stand, front-running Trump is expected to be able to secure the Republican nomination comfortably without those states, so his path to the White House would not necessarily be impeded.

But an adverse Supreme Court ruling that is binding on lower courts nationwide -rather than a narrow procedural ruling affecting only Colorado -- could torpedo the ex-president's primary challenge.

He would then have to decide whether to run for president as a third-party candidate.

But even if the high court doesn't weigh in on the state level rulings and the damage is limited to Colorado and Maine. the justices could leave the door open to challenges to Trump's eligibility for the general election.

So he could well find himself barred from challenging President Joe Biden in November, even if he wins the Republican nomination

Trade pact bolsters

New Delhi, Dec 30: India's exports to Australia have increased by 14 per cent to \$5.8 billion in April-November this fiscal on account of healthy growth in various sectors like engineering, pharma and electronics, a

senior official said Friday. Additional Secretary in the Department of Commerce Rajesh Agrawal said businesses of India and Australia are gaining from the interim free trade agreement, implemented December 29 last year.

He also said negotiations to widen the existing trade agreement into a comprehensive deal are "progressing well". "We expect to have some ne-

gotiations on rules of origin during January. That is one area where we have to work out detailed product-specific rules, and it takes time," Agrawal noted. Foreign direct investments

have risen too from Australia to India at an annual average of \$30-40 million to \$300 million this year, he added.

India's imports from Australia, however, dipped by 19 per cent to \$11.14 billion during April-November this fiscal. According to the data pro-

vided by the department, bilateral trade during the period fell 10 per cent to \$17 billion.

Mining lease means a lease granted for the purpose of undertaking mining operations, while, composite licence is a two-stage operating right granted for the purpose of undertaking exploration followed by production operation.

"During the Year 2023, 76 mineral blocks have been successfully auctioned till December. Out of

auctioned for Mining Lease (ML) and the remaining 46 were auctioned as Composite Licence (CL)," the mines ministry said in a statement.

Out of the total 335 blocks auctioned since 2015, 46 are operational and 43 are in production. During the year 2023, Madhva

Pradesh and Rajasthan have successfully auctioned the maximum number of blocks, i.e. 22 and 16, respectively.

In 2022 a total number of 33 Iron Ore minerals were auctioned which was the highest mineral blocks auctioned in 2022. Similarly, this year also a highest number of 24 Iron Ore minerals were auctioned followed by 20 limestone blocks.

Reports say that the world's richest man is set to arrive in India during the 'Vibrant Gujarat Global Summit' January 10-12 as Gujarat, with its strategic location and favourable business environment, has emerged as the "preferred destination for Tesla's manufacturing plans'

The announcement by Musk to manufacture in India is likely to be made in the presence of Prime Minister Narendra Modi at the flagship event, although the government or Musk are yet to

"This import duty can be eliminated by setting up local production, paving the way for a cheaper, affordable Tesla car," senior analyst Soumen Mandal from Counterpoint Research told IANS.

This cost reduction could also be achieved if Tesla models manufactured in India have fewer features compared to the ones available in the US

"For example, certain hardware required for Full Self-Driving (FSD) could be eliminated and, instead, Advanced Driver Assistance System (ADAS) Level 2 could be included," Mandal added.

The battery pack, imported from China, could have a capacity lower than 50kW and the electric motors could be of lower power.

Additionally, the in-vehicle

electronics could be reduced and a smaller centre display used. according to analysts.

According to reports, if the government has to consider giving incentives to Tesla, then it will be for all the EV makers and foreign entrants.

To resolve the deadlock, Tesla officials have had marathon meetings with the government officials and industry executives in India in recent months.

"The possibility of a Tesla in India at potentially around ₹20 lakh depends on an array of variables, including potentially attractive policy incentives, and Tesla's ability to accomplish efficiencies in supply chain and costs to effectively leverage local manufacturing. All said, pricing decisions will be driven by Tesla's business strategy," according to Prabhu Ram who heads the Industry Intelligence Group (IIG) at CyberMedia Research (CMR).

No second trial for FTX's Bankman-Fried

WASHINGTON: United States prosecutors have chosen not to pursue a second trial for FTX cryptocurrency exchange founder Sam Bankman-Fried, who has already been found guilty of fraud and money laundering, and proceed instead to sentencing. Prosecutors said in a letter filed in a New York court on Friday that pursuing a second trial for the disgraced tycoon would only serve to delay the case against him, which is already strong enough. "Given that practical reality, and the strong public interest in a prompt resolution of this matter, the Government intends to proceed to sentencing on the counts for which the defendant was convicted at trial," prosecutors said in the letter to Judge Lewis Kaplan, who presided over Bankman-Fried's first criminal trial last year. In November, a jury found Bankman-Fried guilty of seven counts of fraud, embezzlement and criminal conspiracy, among other charges. The 31year-old was accused of using billions of dollars from customer deposits on FTX to cover losses at his hedge fund, pay off loans and buy luxury real estate, among other large personal expenses.

X fails to block US content moderation law

SAN FRANCISCO: A judge in the US has ruled that Elon Musk-run X cannot avoid a California law that asks social media platforms to disclose their plans for moderating harmful content and misinformation. US District Judge William Shubb has denied X's request for a preliminary injunction of the law. "While the reporting requirement does appear to place a substantial compliance burden on social media companies, it does not appear that the requirement is unjustified or unduly burdensome within the context of First Amendment law," Shubb said in his decision. The AB 587 law requires large social media companies to share descriptions of how they moderate content that contains hate speech or racism, extremism or radicalisation, disinformation, harassment, and foreign political interference.

Centurion, Dec 30: The Indian team Saturday received an injury scare after seam bowling allrounder Shardul Thakur suffered a blow on his shoulder at nets while batting.

Saturday, she attempted to reach the prime minister's office to return her awards but the police prevented her from reaching the PMO. As a mark of protest, she left the awards at the Kartavya Path and they were later picked up by Delhi Police.

Phogat, along with Olympic medallists Sakshi Malik and



Bajrang Punia, had protested against the election of Sanjay Singh, a close aide of former Wrestling Federation of India (WFI) President Brij Bhushan Sharan Singh, who had been accused of sexual harassment by the three well-known grapplers. Sakshi had also announced her retirement from wrestling soon after Sanjay Singh's appointment as WFI Chief.

However, the Sports Ministry had later suspended the newlyelected panel for not following the provisions of its own constitu-

tion while taking decisions while asking the Indian Olympic Association (IOA) to constitute an ad-hoc panel to manage the affairs of the sports body.

In her letter posted on X (formerly Twitter), Phogat had said that their lives are not like those "fancy government advertisements" that talk about women's empowerment and upliftment.

Acting on the sports ministry directive, the IOA Wednesday constitued a three-member ad hoc committee to run the day-today affairs of the WFI.
