





Dhaka: Bangladesh will go to the polls Sunday in which Prime Minister Sheikh Hasina is expected to win a fourth straight term in the absence of the main Opposition BNP which Saturday began a 48hour nationwide strike against the "illegal government" amidst sporadic violence. The election commission said voting will start at 8am and will end at 5pm. The results are expected to start **P**8 flowing from early January 8.

ISRO puts country's first solar observatory in final destination

Bangalore, Jan 6: In yet another success for its space programme, India's first solar mission craft Aditya-L1 Saturday reached its destination, the L1 point, about 1.5 million kilometres from Earth from where it will orbit the Sun and study our star's wonders, uninterrupted by eclipses and occultations.

Prime Minister Narendra Modi made the announcement on ISRO's latest feat, which comes months after the success of Chandrayaan-3 where the space agency achieved the challenging soft landing of the craft on the lunar surface.

The Lagrange point 1 (L1) of the Sun-Earth system is about one per cent of the total distance between the Earth and the Sun.

A satellite in a halo orbit around the L1 point has the major advantage of continuously viewing the Sun without any occultations or eclipses, ISRO officials said, adding, this will provide a greater advantage in observing solar activities and their effect on space weather in real time.

"India creates yet another landmark. India's first solar observatory Aditya-L1 reaches its destination. It is a testament to the relentless dedication of our scientists in realising among the most complex and intricate space missions. I join the nation in applauding this extraordinary feat. Singh, who among others holds the Space portfolio, said, "From Moon walk to Sun Dance! What a glorious turn of year for

Bharat!" A Polar Satellite Launch Vehicle (PSLV-C57) launched the Aditya-L1 spacecraft from the second launch pad of Satish Dhawan Space Centre (SDSC), Sriharikota, September 2 last year.

After a flight duration of 63 minutes and 20 seconds, it was successfully injected into an elliptical orbit of 235x19500 km around the Earth then.

It underwent a series of maneuvers thereafter and headed to L1, having escaped the Earth's sphere of influence. The spacecraft carries seven

payloads to observe the photos-

phere, chromosphere and the outermost layers of the Sun (the corona) using electromagnetic and particle and magnetic field detectors

"Using the special vantage point L1, four payloads directly view the Sun and the remaining three carry out in-situ studies of particles and fields at the Lagrange point L1, thus providing important scientific studies of the propagatory effect of solar dynamics in the interplanetary medium," according to the space agency.

The suits of Aditya L1 payloads are expected to provide the "most crucial information" to understand the problem of coronal heating, coronal mass ejection, pre-flare and flare activities and their characteristics, dynamics of space weather, and propagation of particles and fields, officials said.

Cong will take in all who left party: Ajoy

Bhubaneswar, Jan 6: Senior Congress leader Ajoy Kumar, who has been given the responsibility of Odisha Congress recently, received a rousing welcome Saturday from the Congress leaders and workers here on his maiden visit to state after the appointment.

In a welcome ceremony at the Congress Bhawan here, Kumar said the Congress party is in a good position in at least 70 Assembly seats and 12-14 Lok Sabha seats in Odisha. The party will welcome back all leaders who have left the party for one reason or other ahead of the 2024 elections. The ticket will be given on the basis of winnability only Those who left the party and were not in contact with BJP or BJD will be welcomed back to the Congress, he added.

"I have asked the OPCC president to revoke the suspension of party leaders ahead of the polls," said the AICC in-charge.

HI-TECH IDENTITY GOOF-UP 'Dead' man found alive in hosp dies; kin cry foul

Bhubaneswar, Jan 6: In yet another twist in the Hi-Tech Hospital AC compressor blast and the subsequent major goofup in identification of the dead bodies, the man who was declared dead four days ago and found to be alive later, succumbed to his burn injuries Saturday, officials of the hospital said.

With the latest casualty, toll in the December 29 evening blast in the medical facility in City rose to three. They were Sritam Sahu (29), Dilip Samantaray (34) and Jyoti Ranjan Mallik (34). Only one person injured in the blast is currently undergoing treatment in the hospital.

Samantaray was initially declared dead December 30, but he was found under treatment Friday. The man, however, died

Saturday afternoon, the hospital's CEO Dr Smita Padhi said.

Samantaray's mother alleged that her son was killed by the hospital. On the cremation of the first body, she said, "The doctors gave us a different body. We believed them and cremated it. After the funeral was over, the hospital authorities Friday said Dilip was alive.'

"Subsequently, we reached the hospital and requested the doctors to allow me to meet my son. When I called him by his name, he responded by shaking his head," said Dilip's mother.

She said after her daughterin-law's death by suicide, the family found solace in the news that Samantray was alive. "But all our hopes were shattered again," she said. Dilip's brother alleged that he died of medical negligence.

Whisky bottles before SC judges


New Delhi, Jan 6: The Supreme Court witnessed an unusual sight in the legal battle over alleged infringement of trademark of whisky brands as liquor bottles were placed before the judges in the country's highest court.

A bench headed by Chief Justice DY Chandrachud was hearing a plea by liquor major Pernod Ricard India Pvt Ltd,


which manufactures and sells 'Blenders Pride' and 'Imperial Blue' whisky, against last November's verdict of the Madhya Pradesh HC. The firm had alleged infringement of their trade mark.

It had told the HC that they have registered trade mark in respect of 'Blenders Pride' and 'Imperial Blue' and also have such registered trade mark in respect of Seagram's which is their house mark and appears on their products sold under various brands. It alleged that JK Enterprises has imitated their trade mark and is manufacturing and selling its whisky under the trade mark 'London Pride'.

The matter came up for hearing Friday before the apex court. During the hearing, senior advocate Mukul Rohatgi, appearing for Pernod Ricard, showed the whisky bottles to the bench.



Vicious Falsehood

ometimes it is necessary to remind ourselves of the past to understand the present. Four years ago, in March 2020, the evangelical Muslim organisation, Tablighi Jamaat, held a meeting in Delhi from the 10th to 13th. This was scheduled before the onset of COVID-19 and they were congregating at a time when the Modi government was itself dismissive of the threat of the pandemic. A PTI report on 13 March 2020 read that 'COVID-19 is not health emergency, no need to panic: Health Ministry'

The Tablighi meeting was held before India issued guidelines on public gatherings. But as the cases in India began to rise towards the end of March, the government determined that it would scapegoat the Muslims and enlisted the media to do this, spreading the conspiracy of 'Corona Jihad'.

The Union made much of evacuating the area where the congregation was being held (Modi sent NSA Doval to 'reason' with the organisers, who had been asking for safe evacuation for days). The novelty of the virus and the first deaths reported from it coincided with the Tablighi Jamaat gathering and open season was declared on it.

'The main reason for increased number of cases is that members

of the Tablighi Jamaat have travelled across the country,' said Lav Agarwal, joint secretary of the health ministry at a press conference. Also on 1 April, the BJP's IT cell head Amit Malviya tweeted that the Tablighi gathering was akin to an 'Islamic insurrection'. Kapil Mishra accused the group of 'terrorism'. On 4 April, Maharashtra Navnirman Sena (MNS) chief Raj Thackeray suggested that the group's members be shot: "The meeting of Tablighis had taken place at Markaz in Delhi. Such people be killed by firing bullets at them. Why give them treatment? A separate section be created and their treatment be stopped." In Uttar Pradesh, the group's members were jailed and booked under the anti-terror National Security Act. On 5 April, Lav Agarwal said: "The doubling rate in India is 4.1 days, had the congregation at Nizamuddin not happened and additional cases not come, this would have been about 7.14 days." As later events proved, this was nonsense, but it was par for the course for this government. On 18 April, Agarwal made another claim, stating that the group was the dominant single cause of the pandemic. Thus the poisonous lie was spread and its effect began to take place in the citizenry as fast as COVID itself. Hindi 'Tablighi conspiracy' daily Amar Ujala reported that members of the Tablighi Jamaat quarantined in a facility in the western Uttar Pradesh town of

Saharanpur had 'demanded' non-vegetarian food and were defecating in the open inside the hospital. The Saharanpur police tweeted that no such thing had happened and the story was taken down.

During the months of active persecution, the group's members, including foreigners, were jailed and charged with attempted murder and the provisions of Section 269 ('whoever wilfully or negligently does any act which is likely to spread the infection of any disease dangerous to life'). The theories being promoted were that they were deliberately spreading the virus around India by getting themselves infected, spitting on fruit, refusing to wear masks, running around naked in their wards, harassing nurses and so on. None of this was true

The world noticed India's malice against Muslims and it was reported: "It was already dangerous to be Muslim in India. Then came the coronavirus" (Time magazine); "Coronavirus: Islamophobia concerns after India mosque outbreak" (BBC); "In India, coronavirus fans religious hatred" (New York Times). Without

being convicted and even without any evidence, Jamaat members were 'blacklisted' from receiving visas in the future. In June, the Modi government amended the policy for visa applications to India to introduce a Tabligh-specific clause: "Restriction on engaging in Tabligh activities — Foreign nationals granted any type of visa and OCI cardholders shall not be permitted to engage themselves in Tabligh work. There will be no restriction in visiting religious places and attending normal religious activities like attending religious discourses. However, preaching religious ideologies, making speeches in religious places, distribution of audio or visual display/pamphlets pertaining to religious ideologies, spreading conversion etc. will not be allowed.' This was the first time in India that a particular religious group had been mentioned in the list of visa guidelines. This was purely to fuel the fire that was already raging in the media, blaming the group for the deliberate spread of COVID in India and absolving the government from its responsibility, especially for the fallout of the disastrous and unplanned 2020 lockdown. It was only after it became generally accepted that the virus was an unstoppable global phenomenon which had spread through multiple ways that the 'Tablighi conspiracy' story faded. On 19 May, the foreign members of the Jamaat moved court to be released from institutional quarantine, where they had been held for over a month and a half, despite repeatedly testing negative for COVID. The government told the court that none of the visitors had been 'detained', they were merely 'asked to join the investigation'. But the passports of over 700 Jamaat members had been seized and they were not in fact free. On 6 July, before the chief metropolitan magistrate at Delhi's Saket court, 44 Tablighi Jamaat members refused to pay a fine of between Rs 4.000 to Rs 10.000 in exchange for closing of cases and bravely chose trial. By December, eight months after 11 states had filed 20 FIRs against more than 2,500 Tablighi Jamaat members, nobody was convicted. And courts fiercely criticised the actions of the government. Judges called the cases 'malicious', 'a virtual persecution', 'abuse of process', 'abuse of power', and said the Tablighi Jamaat members were 'scapegoats of a political government' who had acted against the group though having 'not an iota of evidence'.

The Times quoted Larry Lewis, a former US State Department senior adviser on civilian harm. as saying: "The willingness to accept this level of harm to civilians is far beyond what I have seen in operations in the past.

If Biari was central to the scenes I witnessed in the video he was capable of extraordinary evil and ought to be brought to justice. But that does not justify killing 126 civilians.

Alongside Israel's willingness to kill many civilians in order to achieve non-essential military goals, we must put its restriction of food, water, and fuel in Gaza. Human Rights Watch has accused Israel of using starvation as a weapon of war, which is a war crime. That makes plausible the startling claim made last month by Jordan's foreign minister, Ayman Safadi, that Israel is engaged in "a systematic effort to empty Gaza of its people," which he said would fall "within the legal definition of genocide."

That is a shocking allegation, especially for a nation-state founded in the aftermath of genocide. Israel's government could refute it by pausing hostilities and allowing into Gaza the essential supplies that its people need.

THE TRUE EXTENT OF THE EMPLOYMENT SCENARIO MAY ONLY BECOME APPARENT WITH THE RELEASE OF **COMPREHENSIVE ANNUAL DATA**

The recent attack on the Parliament brought the issue of unemployment in the country back into the spotlight, as the accused claimed to be driven by their frustration with joblessness. Government data suggests a decline in urban unemployment rates to multiquarter lows in the first half of the fiscal year 2023-24. Still, the Centre for Monitoring India's Economy (CMIE) data challenges this narrative.

According to the Periodic Labour Force Survey (PLFS), the urban unemployment rate in the first two quarters of FY24 was 6.6 per cent, the lowest since the series began in FY18. This reflects a significant drop from the pre-pandemic period when the urban unemployment rate fluctuated between 7.8 per cent and 9.7 per cent. Experts attribute this decline to robust economic growth, particularly in manufacturing and investment activities during H1 FY24, resulting in a 7.7 per cent GDP growth.

The S&P Global's Purchasing Managers' Index (PMI) surveys also indicate increased head-

counts in manufacturing and services firms. However, the tempo of employment growth in the services sector has slowed. The formal sector has witnessed a 3-5 per cent increase in employment, with variations across industries. However, the Information Technology (IT) sector has experienced layoffs despite the overall positive trend. In contrast, rural unemployment is not captured by the quarterly PLFS bulletins. Still, the annual survey from July 2022 to June 2023 revealed a decline in the rural unemployment rate to a six-year low of 4.4 per cent in 2022-23, down from 7.8 per cent in the previous fiscal year. Data from the Mahatma Gandhi Rural Employment Guarantee Act (MGNREGA) dashboard indicates a 4.4 per cent increase in household work demand in the current fiscal year, surpassing pre-pandemic

levels by 23.9 per cent. The actual employment scenario might only become apparent with the release of the annual PLFS data for July 2023 to June 2024. Professor Lekha Chakraborty of the National

Institute of Public Finance and Policy emphasises improving self-employment as a coping mechanism for livelihood crises. She calls for more robust government policies to guarantee employment through "employer of last resort" programmes, particularly in urban areas.

The annual PLFS survey for 2022-23 also reveals an overall unemployment rate of 5.1 per cent for both males and females. The CMIE data, however, paints a different picture, with an overall unemployment rate averaging 8.1 per cent in the first 11 months of 2023, lower only than the 10.3 per cent recorded in 2020.

Critics, including former Member of the Prime Minister's Economic Advisory Council Surjit Bhalla, label the CMIE data as unreliable, citing its volatility and month-tomonth fluctuations. They argue that the informal sector's inclusion, where employment is often temporary, contributes to this variability.

Economist Madan Sabnavis of the Bank of Baroda describes overall unemployment as "stable" but acknowledges the dif-

ficulty discerning trends due to high monthly variations. He points out challenges in gauging rural employment, especially with the possibility of disguised unemployment resulting from reverse migration from urban to rural regions.

The discrepancy in data collection methods is crucial to note. PLFS relies on respondents' job activity over the past seven days, reducing the margin of error. CMIE's reference period is just one day, potentially categorising individuals as unemployed if they have not engaged in any activity on the survey day or the previous day.

The complex nature of employment dynamics in India requires a nuanced understanding, considering divergent perspectives from different data sources. The true extent of the employment scenario may only become apparent with the release of comprehensive annual data.

Adhir on warpath with TMC

Three-cornered contest between the ruling TMC, the BJP and the Congress-Left Front alliance is a big possibility in Bengal

Kolkata, Jan 6: Since the beginning of the New Year, there are indications of the unity within the **Opposition INDIA Bloc in West** Bengal being under threat.

While any kind of understanding between the ruling Trinamool Congress and its arch rival the CPI(M)-led Left Front was always out of question, there was some speculation about a possible Congress-Trinamool Congress concord. However, this too was possible only if the Congress high command overruled the objections of the majority of its state leadership to any alliance with the ruling party in Bengal

According to the latest information, the Congress high command is keeping the door open for dialogues with both the Left Front and the Trinamool Congress till the very end.

However, during the last 10 days there have been enough indications from top leaders of the Trinamool and the state unit of the Congress that a three-cornered contest between the ruling party, the BJP and the Congress-Left Front alliance is a big possibility.

Significantly, both the Congress and CPI (M) have taken the preliminary decision not to contest from the Diamond Harbour Lok Sabha constituency in South 24 Parganas dis-



Front (AISF) representative Naushad Siddique to stand from there.

The move, according to political observers, will undoubtedly put Diamond Harbour's current Lok Sabha member and Trinamool general secretary Abhishek Banerjee in a fix. This is because of the twin factors of a sizeable minority population in that constituency that is enough to determine the fate of the candidates and the skyrocketing popularity of Siddique among Muslim voters, especially among the youth. Observers say that in case of a triangular contest between the Trinamool, BJP and AISF in Diamond Harbour, the sitting MP from there will to a great extent restrict himself to that constituency rather than concentrating on campaigning for the party in the entire state.

Chief Minister Mamata Banerjee herself sowed the seeds of discord when she gave a hint that while the INDIA Bloc will prevail at the national level, in the case of Bengal, the Trinamool Congress would take on

the BJP alone.

"Let the INDIA Bloc be there nationally, but in West Bengal, the Trinamool Congress will put up the fight. Remember, in West Bengal only Trinamool Congress can teach the BJP a lesson. The Trinamool Congress can show the path to the entire country from West Bengal. No other party is capable of doing that," Mamata Banerjee said.

The Chief Minister's observation was the trigger for state Congress president and five-time Lok Sabha member Adhir Ranjan Chowdhury to reiterate his old logic against any kind of compromise with the Trinamool. Chowdhury said that factionalism and corruption have led the state's ruling party to the final stage of cancer. Thursday evening he virtually closed all the doors on behalf of the West Bengal Pradesh Congress Committee (WBPCC) for any alliance with the Trinamool by directly challenging Mamata Banerjee to contest against him in the Lok Sabha polls this year.

He also described the Trinamool's

demands for seats in Assam, Meghalava and Goa, as against just two seats for the grand old party in Bengal as absurd propositions, particularly as the two seats already have sitting Congress

In no time, the CPI(M)'s central committee member Sujan Chakraborty expressed solidarity with Chowdhury on the issue.

"Although I should not speak about an internal policy matter of the Congress, I still want to say that the kind of political and administrative wrath that the Congress has been subjected to in West Bengal during the current Trinamool Congress regime, such a reaction from the state Congress president is quite natural,' Chakraborty said.

Political observers say that although everything is possible in politics, as of now it is quite evident that the concept of INDIA Bloc will be restricted to the Congress-Left Front and not the Congress-Trinamool combine.

Rhinos back in sanctuaries after 40 yrs

Golagahat/Tezpur, Jan 6: Rhinos have returned to Laokhowa and Burachapori wildlife sanctuaries of Assam, 40 years after the population of the pachyderms in the area was wiped out due to poaching, Chief Minister Himanta Biswa Sarma said.

These protected areas had also witnessed human encroachment over the years, which was cleared by the authorities last year, a forest official said.

"Happy to share that after 40 years our iconic rhinos have returned to Laokhowa and Burachapori. They have returned within 1 year of our successful anti-encroachment operation in the region," Sarma wrote on X.

A total of 51.7 sq km of forest cover has been retrieved through eviction drives in 2023, he said.

Kaziranga National Park (KNP) Director Sonali Ghosh said two rhinos have been spotted in the Laokhowa-Burachapori wildlife sanctuaries, which are part of 'Greater Kaziranga', after almost a gap of 40 years.

She said the Laokhowa-Burachapori forest in Nagaon dis-



trict had a population of 45-50 rhinos till 1983.

"They were poached and after that. there was degradation of grassland habitat due to anthropogenic pressure. Stray rhinos from the north bank (Orang National Park) and eastern side (Kaziranga) were known to enter through the Brahmaputra chapori areas but never stayed for long," she said.

Ghosh said rhinos have been "sighted in the first addition of Burachapori and Laokhowa wildlife sanctuaries since last November." Both the rhinos have entered prob-

ably "through the second addition

of Orang National Park and the recently restored (evicted areas) of Arimari," she said.

Other than rhinos, the protected area also has 10 tigers.

The eviction drive was carried out from February 13 to 15 last year, which led to a clearing of 1,282 hectares of forest land and 817 hectares of unsurveyed government land.

Ghosh said 75 frontline positions, including that of deputy ranger, have been filled up in the area, reaffirming the government's commitment to strengthen the landscape and restore the lost glory of the forest.



No hope, better to die

founder Naresh Goyal, an accused in the alleged fraud of ₹538 crore at Canara Bank, Saturday told a special court here with "folded hands" that he had "lost every hope of life' and it will be "better if he dies in jail" than living in his present condition.

The septuagenarian, who turned teary-eyed, submitted that he misses his wife Anita verv badly and said she is in the advanced stage of cancer, according to court records. The Enforcement Directorate (ED) arrested Goyal on September 1 last year in connection with the alleged bank fraud. He is currently in judicial custody at Arthur Road jail here.

Goyal had moved a bail application before special judge M G Desphande. He was produced before the court Saturday and during the proceedings Goyal requested for a few minutes of personal hearing, which the judge allowed. As per the court's 'roznama' (record of daily hearings), Goyal with folded hands and "continuous tremors in his whole body" submitted that "his health is very bad and precarious".

The businessman said that his wife is bedridden and their only daughter too is unwell. The jail staff has their limitations in helping him, said Goyal.

"I heard him patiently and also observed him when he made the submissions as such. I found that his whole body was trembling. He needs assistance even to stand," the judge noted. Goyal pointed to his knees and said they were swollen and painful and he was unable to fold his legs.

The Jet Airways founder brought to the court's notice that he has severe pain while urinating and sometimes blood is passed through urine, coupled with unsustainable pain. Most of the time, he hasn't been able to get assistance, he said.

New Delhi, Jan 6: The Congress is taking out the Bharat Jodo Nyay Yatra as the government did not give it a chance to raise people's issues in Parliament and the initiative is aimed at re-establishing the principles of justice, liberty, equality and fraternity enshrined in the Constitution, party chief Mallikarjun Kharge said Saturday.

But why did this 'mahapurush' did not go to Manipur where people are dying, women are being raped, people are dying of cold. Is it not part of the country?" Kharge asked.

Washington, Jan 6: Communications intercepts collected by the United States confirmed that Islamic State's (ISIS) Afghanistan-based branch carried out twin bombings in Iran that killed nearly 100 people, two sources familiar with the intelligence told Reuters Friday. The intelligence is clear-cut

and indisputable," a source said.

Wednesday's bombings, the deadliest of their kind in Iran since the 1979 Islamic Revolution, added to regional tensions over the Israel-Hamas war in Gaza and attacks by Yemen's Tehranaligned Houthi group on commercial shipping in the Red Sea.

ISIS Thursday claimed responsibility for the bombings, saving two operatives wearing explosive suicide belts staged the attack during a memorial service for Qassem Soleimani, a senior military commander assassinated in Iraq in a 2020 US drone strike. The Sunni Muslim militant group, however, did not specify that its Afghanistan-based affiliate, known as ISIS-Khorasan (ISIS-K), was responsible for the bombings in the southeastern

Iranian city of Kerman.



culminated in the January 6, 2021, attack on the US Capitol. Arguments will be held in early February.

The court will be considering for the first time the meaning and reach of a provision of the 14th Amendment barring some people who "engaged in insurrection" from holding public office. The amendment was adopted in 1868, following the Civil War. It has been so rarely used that the nation's highest court had no previous occasion to interpret it.

Colorado's Supreme Court, by a 4-3 vote, ruled last month that Trump should not be on the Republican primary ballot. The decision was the first time the 14th Amendment was used to bar a presidential contender from the ballot.

Trump is separately appealing to state court a ruling by Maine's Democratic secretary of state, Shenna Bellows, that he was ineligible to appear on that state's ballot over his role in the Capitol attack. Both the Colorado Supreme Court and the Maine secretary of state's rulings are on hold until the appeals play out.

Three of the nine Supreme Court justices were appointed by Trump, though they have repeatedly ruled against him in 2020 election-related lawsuits, as well as his efforts to keep documents related to January 6 and his tax returns from being turned over to congressional committees. At the same time, Justices

Amy Coney Barrett, Neil Gorsuch and Brett Kavanaugh have been in the majority of conservative-driven decisions that overturned the five-decade-old constitutional right to abortion. expanded gun rights and struck down affirmative action in college admissions.

Some Democratic lawmakers have called on another conservative justice, Clarence Thomas, to step aside from the case because of his wife's support for Trump's effort to overturn the results of the election, which he lost to Democrat Joe Biden. Thomas is unlikely to agree. He has recused himself from only one other case related to the 2020 election, involving former law clerk John Eastman, and so far the people trying to disqualify Trump haven't asked him to recuse. The 4-3 Colorado decision cites

a ruling by Gorsuch when he was a federal judge in that state. That Gorsuch decision upheld Colorado's move to strike a naturalized citizen from the state's presidential ballot because he was born in Guyana and didn't meet the constitutional reauirements to run for office. The court found that Trump like wise doesn't meet the qualifications due to his role in the US Capitol attack January 6, 2021. That day, the Republican president had held a rally outside the White House and exhorted his supporters to "fight like hell" before they walked to the Capitol.

The two-sentence provision in Section 3 of the 14th Amendment states that anyone who swore an oath to uphold the constitution and then "engaged in insurrection" against it is no longer eligible for state or federal office. After Congress passed an amnesty for most of the former confederates the measure targeted in 1872, the provision fell into disuse until dozens of suits were filed to keep Trump off the ballot this year. Only the one in Colorado was successful. The issue of whether Trump

can be on the ballot is not the only matter related to the former president or January 6 that has reached the high court. The justices last month declined a request from special counsel Jack Smith to swiftly take up and rule on Trump's claims that he is immune from prosecution in a case charging him with plotting to overturn the 2020 presidential election, though the issue could be back before the court soon depending on the ruling of a Washington-based appeals court. And the court has said that

it intends to hear an appeal that could upend hundreds of charges stemming from the Capitol riot, including against Trump.

IN A FIRST Russia fires NK missiles at Kyiv

Kyiv, Jan 6: Russia has hit Ukraine with missiles supplied by North Korea for the first time during its invasion, a senior Kyiv official said Friday, corroborating an earlier assertion by the US White House.

The statement on social media platform X came after the governor of the northeastern region of Kharkiv said that his region had been struck by missiles fired by Russia that were not Russian-made.

"There is no longer any disguise ... as part of its outright genocidal war, the Russian Federation for the first time struck at the territory of Ukraine with missiles received from ... North Korea," the senior Kyiv official. Mvkhailo Podolvak. said.

He did not provide evidence for the missiles being North Korean. In its statement Thursday, Washington cited declassified intelligence.

"(Russia) is attacking Ukrainians with missiles received from a state where citizens are tortured in concentration camps for having an unregistered radio, talking to a tourist, watching TV shows," Podolyak said.

Or would it be better to safeguard resources for Taiwan. even if the US takes a hit to its reputation for resolve? There are no perfect answers, but there are good reasons why policymakers should opt for the former course. First, it is at least possible to

devote additional resources to

shore up the US' defence industrial base, whose deficiencies are largely responsible for prospective shortfalls in weapons platforms and munitions of various kinds. To compensate further, Washington can enlist partners and allies. What no amount of money can buy is resolve.

Another reason why policymakers should prioritise resolve is that the US has global commitments and reputational stakes bevond China. Prematurely abandoning Ukraine to preserve resources for Taiwan could embolden other adversaries. It might, for example, signal to Iran and North Korea that the US does not have the appetite to support the victims of aggression once a conflict becomes protracted, or at the very least that it cannot defend more than one country in one region at a time. All this could encourage further adventurism. By continuing to help Ukraine resist Russian aggression, the US can send a powerful signal to a broader range of rivals: unprovoked aggression will not go unpunished.

He suggested steps such as diversifying crude oil imports from regions like West Africa, the Americas, and the mediterranean; relying on ports outside conflict zones, like Oman and Diibouti, for transshipment and regional trade; and offering financial support and insurance schemes to Indian companies affected by trade disruptions.

SEBI tightens short selling rules

Mumbai, Jan 6: Institutional investors will have to disclose upfront at the time of placement of an order whether the transaction is a short sale, according to a new circular issued by markets regulator SEBI

However, retail investors would be permitted to make a similar disclosure by the end of the trading hours on the transaction day, the order said.

"The brokers shall be man-

dated to collect the details on scrip-wise short sell positions, collate the data and upload it to the stock exchanges before the commencement of trading on the following trading day. The stock exchanges shall then consolidate such information and disseminate the same on their websites for the information of the public every week. The frequency

of such disclosure may be reviewed from time to time with the approval of SEB," it added.

While SEBI has allowed all classes of investors like retail and institutional investors to short sell, it has imposed certain conditions to curb foul play.

The decision comes close on the heels of the Supreme Court's judgement on petitions seeking a court-monitored investigation into alleged manipulation in Adani Group stocks, following the Hindenburg report.

E-way bill generation without B2B e-invoice details to be blocked

New Delhi, Jan 6: Businesses with turnover above ₹5 crore will not be able to generate eway bill without including e-invoice details for all B2B transaction from March 1.

Under the goods and services tax regime, e-way bills are required for inter-state transportation of goods valued over ₹50,000.

The National Informatics Centre (NIC) said on analysis it was found that some of the taxpavers, who are eligible for einvoicing, are generating e-way bills without linking with e-invoice for B2B (business to business) and B2E (business to exports) transactions.

In some of these cases, the invoice details entered separately under e-way bill and e-invoice are not matching with respect to the certain parameters. This is leading in mismatch in the e-way bill and e-invoice statements.

.. to avoid such situations. e way bill generation will not be allowed without e-invoice details from 1st March 2024. This is applicable for e-invoice enabled tax payers and for the transactions related to supplies under B2B and exports," the NIC informed GST taxpayers.

However, e-way bills for other transactions such as B2C and non-supplies will function asusual without any change, the NIC said.

E-comm platforms can't become haven for counterfeiters: Delhi HC

New Delhi, Jan 6: An e-commerce platform cannot become a haven for infringers of intellectual property and have such a system which provides an avenue to counterfeiters, the Delhi High Court has said.

The court observed that ecommerce websites are commercial ventures and are inherently profit oriented, which is not objectionable, but they have to protect intellectual property rights of others.

"An e-commerce platform cannot become a haven for in-

fringers. Men are not angels. not, with a view to further their Where easy money is visible, the conscience at times takes a nap," said Justice C Hari Shankar in a recent order. "E-commerce websites are commercial ventures, and are

inherently profit oriented. There is, of course, nothing objectionable in this; but, while ensuring their highest returns, such websites have also to sedulously protect intellectual property rights of others. They can-

financial gains, put in place a protocol by which infringers and counterfeiters are provided an avenue to infringe and counterfeit. Any such protocol has to meet with firm judicial disapproval," the judge stated. The court's observations came to its notice.

The platform submitted that it was not the originator of the information relating to the goods put up for sale on its website as it was merely a space-provider and would be willing to take down any listing put up by a counterfeiter when it is brought

In its interim order, the court observed that counterfeiting is a well-known commercial evil. even in the virtual world, and ecommerce platforms are statutorily required to make reasonable efforts to ensure that infringing content is not posted on its website and the platform is not used for selling counterfeit goods.

It said that prima facie, the ecommerce platform in the instant case aided the commission of the unlawful act of counterfeiting and infringement and it cannot claim the benefit of "safe harbour" from liability under the Information Technology Act.

"There is nothing inherently illegal in IIL (IndiaMART IndiaMESH Ltd) providing a drop down menu from which prospective sellers, on the Indiamart platform, can select the brand which they intend to sell. If, however, there are not, in place, sufficient checks and balances to prevent counterfeiters from misrepresenting themselves as genuine sellers, the

protocol cannot withstand judicial scrutiny," the court stated.

The court directed taking down of all infringing listings in relation to Puma on Indiamart while also asking the platform to not provide any of the registered Puma trademarks in respect of any goods as search options in the drop down menu presented to prospective sellers at the time of their registration.

"IIL can well seek modification. or even vacation, of the order, if it can demonstrate to the Court that it has put, in place, sufficient regulatory and protective measures to render impossible abuse of the Indiamart platform by counterfeiters. Till then, however, the present position, in which there is rampant counterfeiting or even the possibility of it on the Indiamart platform, cannot be allowed to continue,' the court said.

RoKo T20 selection⁻ dilemma continues

Cape Town, Jan 6: Their eyes trained on the big-ticket T20 World Cup in the Americas in June, the national selectors aren't finding it easy to pick just one among Rohit Sharma and Virat Kohli for the upcoming Afghanistan series.

As of now, there are chances that both the stalwarts, collectively called as 'RoKo', will be kept in the squad but possibly with a rider that form during the IPL will be the main parameter for selection in the T20 World Cup team. Another round of discussions could take place, and it could be the BCCI bigwigs taking the final call.

Chairman of selectors Ajit Agarkar had flown into South Africa during the second Test to talk to the two veterans, and both have made themselves available. But there are too many external factors, and eventually, the BCCI's all-powerful secretary Jay Shah might be required to take a decision.

There are only five days to go for the first T20I against the visiting Afghanistan and the BCCI is yet to announce the squad for the three-match series starting January 11. Agarkar has left for India and possibly the squad will be announced once he is back, in next 24 to 48 hours. It is understood that the team's bal-

ance could be an issue if both Rohit and Kohli are included in the playing XI.

"If you have Rohit, Shubman Gill, Virat, Suryakumar Yadav and Hardik constituting your top five then where is your lefthander? Now, let's assume you drop Kohli and play Gill at No.3 with Yashasvi Jaiswal opening with Rohit. Can Ajit take that bold call," a former national selector told PTI on the condition of anonymity.

If the selectors include both Rohit and Kohli, the two people who would miss out are Ruturaj Gaikwad and Ishan Kishan, the latter being a left-handed keeperbatter and a top-order batting option.

Having both Rohit and Kohli also means that the think tank plays Jitesh Sharma as the keeper besides including Rinku Singh. In that case, one can only fit in five bowlers with Hardik Pandya (after he is back from his injury layoff) needing to bowl four overs in each game.

'The flexibility will always be an issue but there would always be external factors that need to be countered. Did you see ICC promoting the tourney with Kohli's giant billboard video in New York. MI handle put that aerial advert of Rohit and Shaheen Shah Afridi. So there will be external pressure," a former BCCI office bearer said.

The President has suggested the AIFF Referee Department undertake the study to seek FIFA's suggestions and approval. Throughout a match, the VAR team constantly checks for clear and obvious errors related to

four match-changing situations. The VAR team communicates with the on-field referee only for clear and obvious mistakes or serious missed incidents. But it is ultimately the on-field referee who will take a call whether he needs help from the VAR.

Brisbane (Australia), Jan 6: Aryna Sabalenka overpowered two-time champion Victoria Azarenka in a 6-2, 6-4 win Saturday that earned her a spot in the Brisbane International final against Elena Rybakina, a rematch of last year's Australian Open championship decider.

The win extended top-seeded Sabalenka's streak to 15 on Australian soil, including a title run in Adelaide to start 2023 before her Grand Slam breakthrough at Melbourne Park and has given her momentum for the year's first major.

Her 4-6, 6-3, 6-4 win last January in the Australian Open final was the highlight of Sabalenka's five



wins over Rybakina in their seven career meetings.

Sabalenka fired 10 aces and hit 35 winners against Azarenka, who won back-to-back Australian Open titles in 2012 and '13 and is also a two-time champion in Brisbane. She broke her 34-yearold compatriot's serve three

times and saved all three break points she faced. Azarenka anpeared to hurt her right knee in her last service game but continued the match.

Sunday's final will be the first to feature the top two seeds in Brisbane since 2015 when No.1 Maria Sharapova held off No.2

Ana Ivanovic in three sets.

Rybakina, the 2022 Wimbledon champion, had 26 winners and committed just 10 unforced errors as she advanced 6-3, 6-2 over 19year-old Linda Noskova. She has conceded just 12 games across four straight-set wins and spent less than four hours on the court in the key tune-up event for the

Australian Open, which starts January 14. The men's final could also feature the top two seeds. No.1

Holger Rune advanced with a 6-4, 7-6 (0) win over Roman Safiullin. The No.8-ranked Rune will be aiming for a fifth title on the ATP tour when he faces either second-seeded Grigor Dimitrov or Jordan Thompson Sunday.
