#### ₹244.77 crore wagon workshop approved

Bhubaneswar: The Railway Board has approved ₹244.77 crore for establishing a wagon periodic overhauling (PoH) facility at Kantabanji in Odisha's Balangir district. The decision comes in response to the demands of the local people, including public representatives, East Coast Railway (ECoR) said in a statement, Wednesday. Recognising the need for such a workshop in the region, Railway Minister Ashwini Vaishnaw had assured local people that their demand would be met, it said. #### **₹10cr corpus fund** for Odia promotion

### **MYSTERY SHROUDS SINGER'S DEATH**

Keonjhar, Feb 7: Mystery shrouds the death of an orchestra artiste whose body was found adjacent to a road in Old Town here, Wednesday.

The deceased was identified as Prakash Padhi, 42, alias Daddy. He was the lead singer of an orchestra troupe, Daddy Mix, in the town and has some albums to his credit. He had been admitted to the district headquarters hospital (DHH) for treatment of his illness two days back.

The discovery of his body from the roadside near Baghuabeda bridge, about 2 km from the hospital, has created a sensation in the area.

Hospital authorities claimed that Prakash died after consuming poison. But a deep wound found on his head during postmortem has deepened the mystery. His younger brother Pradip Padhi cried foul over the death and claimed his brother had been murdered. The Town police has registered a case and launched an investigation, IIC Ramakant Soy said. Preliminary inquiries indicated that Prakash had died after consuming poison, he added. Pradip alleged that he admit-

ted Prakash to the hospital after the latter fell sick, two days back. He shared his phone number with hospital authorities to call him during emergencies as it was not possible for him to stay beside his ailing brother round the clock. However, he allegedly got a phone call from the hospital, informing about his brother's death, Wednesday. He wondered how his brother could leave the hospital and travelled for 2-km to end life without the knowledge of hospital staff and security guards, and demanded a thorough probe into the case.

Bhubaneswar. Feb 7: The Odisha Assembly proceedings Wednesday were stalled for several hours after Opposition BJP members created a ruckus in the House alleging that in a departure from practice, parboiled rice was mixed with Lord Jagannath's prasad in Srimandir. The saffron party legislators also demanded a reply from Chief Minister Naveen Patnaik on the issue, asserting that it has hurt the religious sentiment of lakhs



They alleged that the rice collected through 'Arpan Rath' from villages across Odisha during the inauguration of Srimandir Parikrama Prakalpa or Heritage Corridor Project was mixed with parboiled rice and offered to Lord Jagannath. Traditionally parboiled rice is not used in Lord's Prasad.

As soon as the House assembled for the day, BJP MLAs trooped into the well of the House and created uproarious scenes holding placards. They also demanded a statement from the Chief Minister over the matter. As pandemonium prevailed over the issue, Speaker Pramila

### Naveen slams BJP

Bhubaneswar: Amid a noisy walkout by BJP members from Assembly, **Chief Minister Naveen Patnaik** Wednesday came down heavily on the saffron party accusing it of politicising sensitive crimes and development works that affect the image of the state and its people. "In the past 24 years as a member of this House, I've never seen this kind of politicisation of sensitive issues. People won't forgive those who defame their own state for narrow political interests. People won't forgive those who tried to stop Srimandir and Lingaraj projects. People won't forgive those who block development of the state," Patnaik said. P3

Mallik initially adjourned the House for one hour till 11:30am and subsequently extended it till 4pm. When the House reassembled at 4pm, the saffron party members again trooped into the well and raised slogans demanding a statement from the CM.

Several of the agitating members also attempted to climb the Speaker's podium but they were stopped by marshals. The MLAs, however, snatched away mike from the Speaker. Unable to run the House, the Speaker again adjourned the House for one hour. Treasury bench members were also seen shouting from their seats and displaying placards. They accused the BJP members of politicising the Nayagarh minor girl rape and murder case. Both BJD and BJP members

shouted at the top of their voices for some time. After the House was adjourned, the BJP members staged a demonstration outside Assembly holding posters as a mark of protest. They lashed out at the government claiming that Mahaprasad was prepared in the Jagannath Temple using Arpan Rath rice which was mixed with par-boiled

rice and distributed to devotees. BJD MLA Bhagirathi Sethi, however, rejected the allegation made by BJP members and accused the saffron party lawmakers of politicising the matter. Proposals for 28 new dists P3

The Congress MP said this was also the situation in



Telangana where Bharat Rashtra Samithi (BRS) was supporting BJP and getting protection from the Centre. "We have defeated BRS in Telangana and are optimistic to repeat the show in Odisha," he said.

"It is actually the Congress which has been supporting the BJD in Odisha. We have seen Congress leaders coming to the rescue of the BJD government in the Assembly," BJP MLA Nauri Naik said.

BJD vice-president and MLA Debi Prasad Mishra said, "Rahul Gandhi is free to say whatever he thinks, but the fact remains different. In Odisha, people have trust in Naveen Patnaik for which he has been successively elected to power five times in a row.

# Burglars sweep clean railway official's house

Bhubaneswar, Feb 7: There is no let-up in housebreaking incidents in the Capital City as some unidentified miscreants raided a house at Bhotapada under Mancheswar police limits Tuesday night and decamped with gold ornaments worth ₹4 lakh and ₹10,000 in cash, raising the total number of such cases under this police station to two within a week.



The burglars looted 14 gold rings and three sets of anklets from the wardrobe locker of Purnananda Bhoi, an employee

of Indian Railways, a senior po-lice official at Mancheswar police station said.

Bhoi, along with his family members, had gone to one of his relatives' house and stayed there Tuesday night, said the cop, adding that Wednesday morning he received a call from one of his neighbours who said that his gate lock and door were broken. Bhoi then rushed to his residence and discovered articles in rummaged condition.

Bhoi came down heavily on night security in the City and alleged that lack of police patrolling had given a free hand to criminals to commit such acts. "Had there been proper police patrolling during night, such an incident would not have happened," he said.

Notably, last week unidentified men swept gold ornaments and other valuables estimated to around ₹25 lakh from two homes in Satyabadi apartment under Mancheswar police limits.



### Lightning claims 1,472 lives in 5 years

Bhubaneswar: Lightning strikes have claimed 1,472 lives and left 145 people injured in the state in the last five years, state Revenue & Disaster Management Minister Sudam Marndi told the Assembly Wednesday. Replying to a query by Congress MLA Tara Prasad Bahinipati, the minister said the state government had declared lightning as a disaster in June 2015. An ex gratia of `4 lakh each has been paid to the next of kin of those killed in lightning strikes in accordance with state disaster response fund guidelines, he said. Similarly, a compensation of `2.50 lakh is being provided to any person in case he or she loses an eye (s) or any other organ leading to a disability of more than 60 per cent due to a lightning strike, he added. If disability is between 40 per cent and 60 per cent, the compensation amount is `74,000, he said.

The government will provide a heritage grant of ₹1 crore in two phases to schools and colleges over 100 years old, and ₹2 crore to universities established before Independence.

A translation policy will be introduced, offering grant for translating Odia books into other

New Delhi, Feb 7: The Centre Wednesday supported in the Supreme Court the sub-classification of Scheduled Castes (SCs) and Scheduled Tribes (STs) for grant of quota inside quota, saying it is committed to the reservation policy as an affirmative action for those who suffered "hundreds of years of discrimination'

A seven-judge Constitution bench headed by Chief Justice DY Chandrachud is examining the validity of its 2004 judgement which had held that states do not have the power to further sub-classify SCs and STs for grant of quotas. Advancing the arguments,

Solicitor General Tushar Mehta, appearing for the Centre, opposed the EV Chinniah judgement and said, "The sub-classification furthers the actual purpose behind reservations."

"It is submitted that the legitimate state aim behind reservations is to support the backward classes who have had a history of discrimination of centuries and aiming to provide

equality of opportunity," the top law officer said. The Chinnaiah judgement had held that any 'sub-classification'

In apex court, Centre supports quota inside quota of reservation for backward classes as a measure of affirmative action to bring equality to those who have suffered hundreds of years of discrimination," he said. The solicitor general, in his

written submissions, referred to various judgements and provided several propositions for the court's considerations.

"The concept of Equality of opportunities operates at a dual level – between open category and backward classes - and secondly, it has to operate even within the backward classes inter-se.

"This bundling together of SC/STs by EV Chinnaiah Vs. State of AP... which disempowers the State to frame appropriate policy by subclassifying the zone of reservation appropriately, diminishes the constitutional guarantee of equality of opportunity.

"It is stated that the lack of sub-classification perpetuates the zone of inequality within

the reserved category and stops the State from framing appropriate policy in this regard," the Centre said.

The Union government said the Constitution permits reservations at the level of higher education, entry-level in the government service sector and promotion in the government services.

"It may also be noted that the reservation benefits available are limited in nature. The State can only provide for a limited number of seats in government higher education institutions and posts in the government services which are reserved. The said seats and the posts are even otherwise a scare commodity and therefore required  $\rightarrow$ to be re-distributed rationally," it said.

In order to achieve the actual objective behind reservations, the rationalisation is key and proliferation and deepening of the reservation benefits are necessary, it said.



# Prior zika infection may increase risk of severe dengue

eople who have had zika may be at a higher risk of developing severe dengue and being hospitalised, according to a study that has implications in the development of a vaccine.

Previous research has shown that a second infection by any of the four known dengue strains is known to be typically more severe than the first.

However, until now no correlation between this fact and the occurrence of other diseases had been investigated.

Dengue and zika are both transmitted by the same mosquito (Aedes aegypti), and have similar symptoms, often making diagnosis difficult.

Dengue is more serious be-

cause in addition to fever, headache, muscle and joint pain, rash and nausea, it can cause bleeding and even death, the researchers said.

The symptoms of zika are milder, but the virus can cause severe problems in pregnant women and in babies, such as microcephaly and possibly Guillain-Barre syndrome, a neurological disorder that leads to paralysis, they said.

The latest study, published in the journal PLOS Neglected Tropical Diseases, found the mechanism that exacerbates dengue infection following a case of zika differs from that of two consecutive infections by the dengue virus The viral load is higher in the



second dengue episode, with high levels of inflammatory cytokines not seen in zika, the researchers at Sao Jose do Rio

Preto Medical School (FAMERP) in Brazil said.

Cytokines are small proteins that are crucial in controlling the

growth and activity of other immune system cells and blood cells.

Detection of other markers suggested that the increase in severity may be due to activation of T cells - key parts of the immune system that help produce antibodies - in an immune response that has been termed the 'original antigenic sin'.

The process involves so-called T-cell memory, a response in which T cells produced during a previous infection stimulate the production of more T cells to combat a new infection, the researchers said.

Because these new cells are not specific to the virus, they trigger an excessive release of inflammatory cytokines, which attack

the organism's proteins and tissues, potentially leading to hemorrhage, they said.

The researchers analysed samples from 1,043 laboratory-confirmed dengue patients, identifying those with prior zika and dengue infections.

The cases occurred in 2019 in Sao Jose do Rio Preto, a large city in Sao Paulo, Brazil, considered hyper endemic for dengue since more than 70 per cent of the population has had the disease.

Its climate and geography favour the circulation of arboviruses throughout the year. Dengue epidemics occurred there in 2010, 2013, 2015, 2016 and 2019, with a record number of cases involving serotype 2, the researchers said.





## Lenin's Lessons

t is now a century since Vladimir Lenin's death, and more than three decades since his Bolshevik project collapsed. But while much of L his political life was highly problematic from today's perspective, his remorseless pragmatism, as one might call it, still has purchase.

Recall Lenin's well-known commitment to "concrete analysis of the concrete situation." One must avoid both dogmatic fidelity to the cause and unprincipled opportunism. Under quickly changing realworld conditions, the only way to remain truly faithful to a principle - to remain "orthodox" in the positive sense of the term – is to change one's own position. Thus, in 1922, having won the civil war against all odds, the Bolsheviks embraced the "New Economic Policy," allowing a much wider scope for private property and the market.

In explaining this decision, Lenin used the analogy of a mountain climber who must retreat "in order to leap further forward." After enumerating the new Soviet state's achievements and failures, he concluded: "Communists who have no illusions, who do not give way to despondency, and who preserve their strength and flexibility 'to begin from the beginning' over and over again in approaching an extremely dif-ficult task, are not doomed (and in all probability will not perish)."

One hears echoes of Søren Kierkegaard, the Danish theologist from whom Marxists can learn quite a lot. Any revolutionary process, Lenin believed, is not gradual but repetitive, a movement of repeating the beginning again and again.

How better to capture where we are today? After the "obscure disaster" of 1989, which put a definitive end to the epoch that began with the 1917 October Revolution, one can no longer impute any continuity to what "the left" has meant over the last two centuries. Although indelible moments like the Jacobin climax of the French Revolution and the October Revolution will remain in our memory those stories are over. Everything should be re-thought from a new starting point.

A fresh approach is more important than ever now that global capitalism has become the only true revolutionary force. What remains of the left is obsessed with protecting the old achievements of the welfare state, a project that largely ignores just how much capitalism has changed the texture of our societies over the last few decades.

There are exceptions, of course. Among the rare theorists and politicians who have recognised this process for what it is

has been Yanis Varoufakis. Capitalism, he argues, is morphing into techno-feudalism, which is why the traditional anti-capitalist rhetoric is losing its traction. The implication is that we should abandon social democracy and its central idea of a left-liberal welfare state.

In a properly Leninist way, Varoufakis sees that the object of our critical analysis (capitalism) has changed, and we must change with it. Otherwise, we will just be helping capitalism revitalise itself in a new form

Lenin's form of pragmatism is by no means available only to the left. Last month, Ami Ayalon, a former leader of Shin Bet (Israel's internal security service), called for a paradigm shift: "We Israelis will have security only when they, Palestinians, will have hope. This is the equation." Because Israel will not be secure until Palestinians have their own state, Israeli authorities should release Marwan Barghouti, the jailed leader of the Second Intifada, to lead negotiations to create one

"Look into the Palestinian polls," Ayalon says. "He is the only leader who can lead Palestinians to a state alongside Israel. First of all because he believes in the concept of two states, and secondly because he won his legitimacy by sitting in our jails." Indeed, many see Barghouti (who has been imprisoned for over two decades) as a kind

India generally is severely problematic. The distinction between arts and science, unlike in the rest of the world, becomes less about the fields themselves and more about a stratified status symbol reinforced through the prejudices of parents. Most parents in India prefer to, or rather force their kids into "science" because of its imagined benefits. They have no interest in the beauty of the subject itself. They are not inspired by the pioneering work on gene editing by Jennifer Doudna and Emmanuel Charpentier. Neither have they read the writings of Carl Sagan and Richard Feynman. Why Science, you ask? Well, a possible reason owes to the false relief they get through comparisons of their kids with that of

their friends. As absurd as this may sound to the outsider, this simple and shameful fact is a common occurrence in India. Science is thus reduced merely to a fad. A means to the end of becoming doctors and engineers. It is at times like these that one breathes a sigh of relief that luminaries like Dr BR Ambedkar are not alive to see the pathetic state of their country's denizens. Perhaps more than any of our other founding fathers, Ambedkar elucidated the value and meaning of true education in no uncertain terms. Critical thinking and reflection were inseparable from good education for Ambedkar. John Dewey, a philosopher and teacher who influenced Ambedkar enor-

mously, emphasised on the in-

separability of education from social environment. Thus, if we force kids to study "science" for utilitarian purposes, we'll end up manufacturing needless automatons whose contribution to the upliftment of human society will be minimum.

There is also the problem with those who let their kids pursue humanities for the sole purpose of clearing civil services. Notwithstanding the mediocrity and corruption of our bureaucracy, such an approach is just as problematic for precisely the same reason i.e. utilitarianism. First, it is gratuitous of parents to expect their kids to be grateful simply for having the basic decency to let their kids' study what they want. Second, it makes a mockery of everything that good education is supposed to be, presumably by "educated" people. Good education inculcates rationality, scepticism and paves the road for in-

dividual autonomy. The same individual autonomy that parents refuse to grant their kids.

It is obvious that many parents force their own failed dreams on their children. They are being oblivious to the fact that their kids are not extension of themselves but different beings with their own individual needs, desires and dreams. Sadly, this is not limited to the field of education. Deepa Bhatia's six-part docu-series "First Act" does a good job of illuminating the world of aspiring child actors. Throughout the series, we encounter clear instances of abuse by parents on kids as young as 5. These kids, of course, are in no position to deliberate on their future. Yet, their parents insist that their kids want to become actors. In both instances, it must be said that kids are not empty vessels for you to fill in your dreams.

hindsight. This, according to the common argument, makes them a better judge of their kids' future. This argument fails to account for the pluralities of experiences and pathways that exist. Had the great Nusrat Fateh Ali Khan heeded his fathers advise to become a doctor or engineer, the world would have remained oblivious to his sheer ingenuity and the potentiali ties of music. Every individual in this world makes mistakes. It is entirely possible for your kid to make a mistake while deciding on her future educational or career pathway. However, it is a mistake for them to make and later amend in whatever way they seem fit. Halfway through, if they find out that they're better suited to a different pathway, good for them! This is not a "mistake" that you have the ability or the right to identify. It is simply incomprehensible to me as to why any parent would want their kids to live the life of someone else while resenting every second of it. The responsibility of the parent is limited to letting their children pursue whichever pathway they seek, no matter how "low status" it may seem to the parent. We must strive to foster a culture that empowers and evangelises the value of individuality. Or consider an even more surprising example. Last week, the Ukrainian army chief, Valeriy Zaluzhnyi, following media reports that he may soon be dismissed from his post, published a commentary laying out his priorities for Ukraine and identifying the highest ones for the war effort. "The challenge for our armed forces cannot be un-derestimated," he wrote. "It is to create a completely new state system of technological rearmament."

What that means is a doubling down on "unmanned systems such as drones - along with other types of advanced weapons, that provide the best way for Ukraine to avoid being drawn into a positional war, where we do not possess the advantage." The "Iron General," as he is sometimes called, then acknowledged that, with key allies grappling with their own political tensions, Ukraine must prepare for a reduction in military support.

I see Zaluzhnyi's brief commentary as a Leninist (that is, principled-pragmatic) intervention. True, radical leftists and Zaluzhnyi himself will regard this characterisation as absurd, and I am no expert on the power struggles currently underway in Ukraine, nor on Zaluzhnyi's role in them, All I am saving is that Zaluzhnyi has deftly combined fidelity to the goal (maintaining Ukrainian independence and territorial integrity as a democratic state) with a concrete analysis of the situation on the battlefield.

To put it bluntly, we are past the heroic phase of popular resistance to the invader and close personal combat on the front lines. Ukraine must reorient itself by adopting new technologies appropriate to a prolonged war, and by getting ahead of Western countries' growing reluctance to deliver aid indefinitely. Ukraine will also need to get its own house in order, by acting more decisively against corruption and oligarchs, and by clearly articulating what it is fighting for.

Above all, Ukraine needs a shared vision that is not narrowly nationalist or defined by the suspicion that the Ukrainian left is pro-Russian. To withstand the effects of exhaustion from the war, Ukrainians must put themselves in the shoes of Lenin's mountain climber.





### Merit in demand for separate High Court for Nagaland: Panel



New Delhi, Feb 7: Presenting its report to both the Houses of Parliament, a Parliamentary Committee Wednesday said that there was merit in the demand for a separate High Court by the state of Nagaland.

The Department-related Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice in its 141st report 'Judicial Infrastructure in the North-Eastern States of India' noted that the State of Nagaland does not have its own High Court and has been under the jurisdiction of Gauhati High Court since 1963 During interactions, the President of the Kohima Bar Association informed the parliamentary panel that the states like Tripura, Meghalaya and Manipur which came under the jurisdiction of Gauhati High Court in 1971 have now established their own High Courts but the state of Nagaland does not have its own High Court. In its report, the Standing Committee, chaired by BJP Rajya Sabha MP Sushil Kumar Modi said that there is merit in the demand for a separate High Court by the State of Nagaland and the Union Ministry of Law and Justice must coordinate with the Ministry of Home Affairs to address the demand. Further, the Committee said that the status of judicial infrastructure in the northeastern states can at best be termed as work in progress and a lot of work still needs to be done to meet the requirement at the lower end of the spectrum. "Although, the Centrally Sponsored Scheme (CSS) for Development of Infrastructure Facilities for Judiciary is a ray of hope in otherwise gloomy scenario, it is imperative to enhance the share of North Eastern States under the Scheme," it said. The report added that it does not augur well for a vibrant and aspirational democracy to have Courts which are functioning from dilapidated rented premises with insufficient space and which lack basic amenities like toilets. water connection, proper electricity supply, etc The panel said "It is the duty of the State to provide access to justice to all its citizens and create judicial infrastructure to provide efficient, economic and timely delivery of justice.'

New Delhi/Aizawl, Feb 7: Amid objection from different northeastern states, including Mizoram and Nagaland, and many other organisa-tions, the Centre Tuesday reiterated that the Indian government is committed to fence the entire 1,643 km-long India-Myanmar border.

Commenting on the development, Union Home Minister Amit Shah said Tuesday, "It has been decided to construct a fence along the entire 1,643 km India-Myanmar border. To facilitate better surveillance, a patrol track along the border will also be paved." Shah also said the Narendra Modi government is committed to building impenetrable borders.

"Out of the total border length, a 10-km stretch in Moreh, Manipur, has already been fenced. Also, two pilot projects of fencing through a Hybrid Surveillance System (HSS) are under execution,' he said.

"They will fence a stretch of Mizoram's most influential 1 km each in Arunachal Pradesh civil society body, Young Mizo Association, and more than a and Manipur. Additionally. dozen organisations in Mizoram, Nagaland and Manipur are vehemently opposing both the proposed fencing and the scrapping of FMR. Manipur Chief Minister N Biren Singh, however, had earlier thanked the Home Minister for his announcements, saying that these assurances are the biggest gifts for the people of the state.

# Loktak's floating village a showcase of Manipuri heritage

Imphal, Feb 7: Champu Khangpok -- the floating village on Manipur's internationally famed Loktak Lake -and classified as a wetland of international significance by the Ramsar Convention, has always taken a centre stage in the Manipuri society.

The village assumes significance in preserving age-old traditions associated with Loktak Lake.

Champu Khangpok village in Loktak Lake is said to be the only natural floating village on earth with 500 huts and home to around 2,000 people.

The village is one of the floating biomasses called 'phumdis' in the middle of the Loktak Lake. Its unique cultural and ecological importance came into

focus during the World Wetland Day observation Friday last week, emphasising the need for collective efforts to ensure its sustainable future.

The Loktak Development Authority (LDA) and the fishing community commemorated World Wetlands Day on the theme 'Wetlands and Human Wellbeings', underscoring the critical role wetlands play in enhancing human lives.

LDA Chairman M Asnikumar Singh, a local of the lake area, along with renowned bamboo expert Kamesh Salam and state government officials, stressed on the collective commitment to preserve the Loktak Lake.

Famous for its floating islands and picturesque landscape, Loktak Lake in Manipur's Bishnupur district is one of the largest freshwater bodies in

northeast India. Solar lamps, water filters, generator set, and a fibre canoe were recently distributed among the villagers generously funded by the Minorities and Other Backward Class Department.

This initiative, tailored for Champu Khangpok, aimed to enhance the community's living conditions and promote sustainable practices in the heart of Loktak

Acknowledging Champu



Khangpok's deep roots in history, LDA Chairman M Asnikumar Singh said "The cultural and ecological importance of this floating village is crucial for Loktak's sustainable future, making collective efforts imperative.

The LDA director pledged support for the construction of a special floating school for Champu Khangpok, with funding allocated by the government of India through the state education department.

Plans also include the installation of bio-digester toilets for each khangpok shang (hut), contributing to improved sanitation facilities tailored for the unique lifestyle of Champu Khangpok.

LDA Chairman reiterated his appeal directly to the fishing community, urging responsible practices and a halt to illegal fishing and hunting of water birds in Loktak Lake, particularly through the use of electric current and lights.

This call aligns with ongoing efforts to protect the diverse ecosystem of the lake and uphold the sustainable practices championed by Champu Khangpok. As Loktak Lake faces an im-

minent threat of extinction with its natural life cycle disrupted by the Ithai barrage, the hydroelectric project, Champu, with its population of around two thousand settling on 500 circular floating huts comprising the village, is central to the collective commitment towards sustainable development, conservation, and the overall well-being of Loktak Lake and its associated wetlands.

The Loktak Lake covering an area of 287 sq km is considered the lifeline of the people of Manipur due to its importance in their socio-economic and cultural life.

The lake is oval-shaped with a maximum length and width of 32 km and 13 km respectively. The depth of the lake varies between 0.5 and 4.6 meters with an average recorded at 2.7 meter.

There are 14 hills located in the Lake varying in size and elevation and appear as islands in the southern part of the lake. The most prominent among these are Sendra, Ithing, and Thanga islands.

Three of northeast India's most important ecosystems -Rudrasagar Lake in Tripura. Deepor Beel in Assam and Loktak Lake in Manipur are categorised as wetlands of international importance under the Ramsar Convention.

Held in February 1971 at Ramsar in Iran, the Ramsar Convention provides the framework for national action and international cooperation for the use of wetlands and their resources.



# Karnataka govt stages protest against Centre

New Delhi, Feb 7: Top Congress leaders from Karnataka led by Chief Minister Siddaramaiah staged a protest at Jantar Mantar here Wednesday against the Centre alleging "injustice" meted out to the state in devolution of taxes. The protesters demanded that

the Centre set right the losses to the tune of Rs 1.87 lakh crore allegedly incurred by Karnataka under the 15th Finance Commission. Siddaramaiah said this protest is not against the BJP but the discrimination against Karnataka. Dismissing the BJP's allegation

that the protest was aimed at raking up the north-south divide, he said the Congress wants the country to be united but there should be no discrimination against the southern states. We are raising the issue of dis-

crimination meted out by the government of India to the state of Karnataka and other southern states," Siddaramaiah said while addressing the protesters. "This is why I had written a letter to all the MPs of the BJP and the JD(S) asking them to participate in this agitation,"he said. The chief minister said the formula used to devolve taxes to the states, especially

Finance Commission was changed by the 15th Finance Commission and called for reverting to the old formula to stop the loss of revenue for his state. He said they would also submit a representation to the new Finance Commission for adopting the formula used by the 14th Finance Commission. Shivakumar said Karnataka

ranks second in Goods and Services Tax (GST) collection and is the biggest contributor to the country's revenue. "We are asking for our rights, we are asking for our share. The Karnataka government had sought drought relief funds from the Centre but not even a single



The hill state's small tribal community is exempted from the proposed law, which also mandates registration of live-in relationships. Children born of live-in relationships will be considered legitimate and deserted women will be entitled to maintenance from their partners. The Bill effectively bans polygamy and 'halala' practised among a section of Muslims. Marriages, though, can be solemnised through separate rituals,

tomary rights are protected under the Part XXI of the Constitution of India," the Bill says.

Like marriages, live-in relationships must be registered. Live-in partners must not be under 18. But if any one of them is under 21, the registrar is bound to inform their parents or guardians.

The bill stipulates a penalty of up to a month in prison or a fine of Rs 10,000, or both, if the partners do not submit a statement on their relationship to the registrar within a month.

If a woman in a live-in relationship is deserted by her partner, she can approach the court for maintenance from him. There is also a provision to terminate a live-in relationship. The Bill makes it clear that a marriage between a man and a woman can be solemnised if "neither party has a spouse living at the time of marriage".

#### **Baroness Shreela** Flather no more

London: Prominent British-Indian peer Shreela Flather passed away after a short illness in the UK Tuesday, her sons Marcus and Paul Flather said in a statement. She was 89. Known for her elegant sarees in the House of Lords. the teacher and politician was a life peer as Baroness Flather of Windsor and Maidenhead in Berkshire. As the Lifetime President of the Memorial Gates Council, she was instrumental in the creation of the iconic Memorial Gates at Hyde Park Corner in London as a tribute to the war efforts made by some 5 million Commonwealth soldiers

during the World Wars. "Baroness Flather was a trailblazer, having been appointed as the first UK Asian Woman Justice of the Peace, Mayor and Baroness She worked tirelessly for women's and girls' rights, and served the South Asian community in the UK." reads a family statement.

### ATTACKS ON INDIAN STUDENTS IN US CONTINUES THE BACK-TO-BACK INCIDENTS SINCE SUNDAY WERE THE SIXTH IN THE US IN 2024 ALONE

New York, Feb 7: In a series of disturbing incidents, an Indian doctoral candidate was found dead at Purdue University in Indiana while another Indian IT student was brutally attacked near his house in Chicago.

According to The Purdue Exponent, a news agency independent of the university, Sameer Kamath, 23, a doctoral candidate in mechanical engineering, was found dead in Warren County Monday the mechanical engineering head Eckhard Groll announced Tuesday. Kamath's body was found at a nature preserve at Crow's Grove, the agency said, quoting a press release from Justin Brummett, the Warren County Coroner. In another incident, Indian IT student Syed Mazahir Ali was chased and brutally attacked by unidentified men near his house in the US city of Chicago Sunday, February 4.

There were videos posted on social media and in one video posted on X, Ali can be seen with a bloodied nose and face and blood stains on his clothes as he



describes his ordeal.

Ali, who moved to the US from Hyderabad about six months ago, told ABC7 Eyewitness News that one of the attackers pointed a gun at him.

Video surveillance shows Ali walking to his home at night with a packet in his hand when the three men chase him when he was punched by the men in the eye and hit on the face, ribs and back. The ABC7 report said he was taken to a local hospital where he was treated for several cuts and bruises.

"America has been my dream country and I came here to fulfil my dreams and pursue my Masters. The incident gave me trauma," he told the channel.

The report said that the police do not have any suspect in custody and the investigation is ongoing. The Consulate General of India in Chicago said on X that the "Consulate is in touch with Syed Mazahir Ali and his wife in India Syeda Ruquiya Fatima Razvi and assured all possible assistance. The consulate has also contacted the local authorities who are investigating the case.' Ali's wife Ruqiya Fatima reached out to External Affairs Minister S Jaishankar, requesting assistance to travel to the

US along with three minor children. Last week, 19-year-old Shreyas Reddy Beniger, a student at the Lindner School of Business in Ohio State was found dead. However, local authorities have ruled out foul play.

Another Indian student, identified as Neel Acharya at Purdue University, Indiana, was confirmed dead days after being reported missing January 28.

The incident comes just days after 25year-old Indian student Vivek Saini, who had recently earned an MBA degree in the US, was hammered to death by a homeless drug addict in Georgia state's Lithonia city January 16.

The horrifying incident was caught on camera when assailant Julian Faulkner, a homeless man, mercilessly struck Saini nearly 50 times on the head with a hammer. Akul B Dhawan, an 18-yearold at the University of Illinois Urbana-Champaign, was found dead last month with signs of hypothermia.

Putin's 1st interview

Moscow, Feb 7: President Vladimir Putin granted an interview to US television host Tucker Carlson Tuesday, the Kremlin said, his first to an American journalist since before Russia's invasion of Ukraine nearly two years ago.

Kremlin spokesman Dmitry Peskov said Putin had agreed to the Carlson interview because the approach of the former Fox News host differed from the "onesided" reporting of the Ukraine conflict by many Western news outlets.

"When it comes to the countries of the collective West, the large network media, TV channels, (and) large newspapers can in no way boast of even trying to at least look impartial in terms of coverage," Peskov told a regular news briefing Wednesday.

"These are all media outlets that take an exceptionally onesided position. Of course, there is no desire to communicate with such media, and it hardly makes sense, and it is unlikely that it will be useful.'

Asked directly why Carlson had landed an interview with Putin, Peskov said the American journalist's approach was "in no way pro-Russian, it is not pro-Ukrainian - it is pro-American".

The interview is likely to be aired Thursday, Russia's TASS news agency said, citing reports by the Wall Street Journal.

Carlson said in a post on X Tuesday that the interview would enable Americans to understand Russia's view of the war. "We are not here because we love Vladimir Putin....We are not encouraging you to agree with what Putin may say in this interview, but we are urging you to watch it. You should know as much as you can," he said.

### **50K drug traffickers** arrested in Lanka

Colombo, Feb 7: The Sri Lankan government has said that more than 50,000 criminals were nabbed and narcotics worth millions of rupees were seized during an ambitious operation against drugs in the island nation in 50 days. Conceptualised by Minister of Public Security Tiran Alles and overseen by acting Inspector General of Police (IGP) Deshabandu Tennakoon, the controversial Operation 'Yukthiva' (the Sinhala term for 'justice') was launched December 17 with a June 30 deadline to end the drug menace plaguing the country and arrest all the drug dealers. "It's been 50 days since the Yukthiya operation was launched. A total of 56,541 criminals throughout the island were arrested. Of them, 49,558 were drug abuse arrests while 6,958 more were those in the crime suspect lists," a release from the Ministry of Public Security said Tuesday.

Islamabad, Feb 7: Two blasts near electoral candidates' offices in Pakistan's southwestern province of Balochistan killed 30 people and more than 40 others injured, local officials said Wednesday, raising concerns over security on the eve of a general election.

Pakistan goes to the polls Thursday amid rising militant attacks in recent months and the jailing of Imran Khan, the winner of the last national election, who has been dominating the headlines despite an economic crisis and other woes threatening the nuclear-armed country.

Authorities have said they are boosting security at polling booths.

In the first incident, a powerful blast outside the office of independent candidate Asfandyar Khan Kakar in Pishin district killed 20 people and wounded 30 others.

#### **Russian strikes** kill 5 in Ukraine

Kyiv: Russia unleashed missile and drone strikes on Kyiv and other Ukrainian cities during Wednesday morning's rush hour, killing five people, wounding more than 30, and damaging residential buildings and energy infrastructure, Ukrainian officials said. Four people were killed when debris from a missile hit an 18-storey residential building in Golosiivskyi district in the southwest of Kyiv, causing a fire and smashing windows, officials said. One person was killed in Mykolayiv in the south. "Another massive attack against our state. Six regions were struck by the enemy. All our services are now working to cope with the consequences of this terror," President Volodymyr Zelenskyy said on the Telegram messaging app.

#### IN RACE FOR PRIME MINISTER

Islamabad: Pakistanis will vote Thursday to elect a new government to rule the cash-strapped country amid a spree of violence including deadly blasts on the eve of elections in which the front-runner former prime minister Nawaz Sharif is believed to have the backing of the powerful military. With former prime minister Imran Khan in jail, Sharif's Pakistan Muslim League-Nawaz (PML-N) is tipped to emerge as the single largest party in the elections. Khan's Pakistan Tehreek-e-Insaf (PTI) candidates are contesting the polls independently after the Supreme Court upheld the decision of the election commission to deprive his party of its iconic election symbol cricket 'bat'. Sharif, 74, will be eying the premiership for a record fourth time in Thursday's election. The contest also involves the Pakistan Peoples Party (PPP) of Bilawal Bhutto-Zardari, who has been declared as the party's prime minister face. Nearly 650,000 security personnel have been deployed across the country as authorities were busy setting up polling stations to enable more than 12.85 crore registered voters to cast their ballot in the general elections

### **Taiwan halts**

Taipei: Taiwan's Tourism Administration Wednesday told travel agents to stop organising new group tours to China since Beijing has yet to allow such trips to the island by Chinese tourists and has altered a flight path in the sensitive Taiwan Strait. Post pandemic, China has largely resumed permission for its nationals to visit a host of popular tourist destinations including Japan, but has yet to add Taiwan back on its approved list amid ongoing tensions between Beijing and Taipei. China claims democraticallygoverned Taiwan as its own territory despite the strong objections of the government in Taipei.

Gaza Strip ignited a volatile situation in the wider region, placing Middle Eastern stability at the forefront of US international policy. Following the October 7 offensive by Hamas, the Biden administration strategically relocated two aircraft carrier strike groups, and a nuclearpowered submarine to the Middle East. This move was accompanied by a continuous flow of high-ranking US officials, President Joe Biden included, embarking on significant visits to the area. As the conflict proved increasingly challenging to control, the US escalated its involvement. In early November, last year reacting to attacks on US military personnel in Iraq and Syria by groups supported by Iran, the US executed strikes on weapon facilities in Syria, utilised by Iran's Islamic Revolutionary Guard Corps. By the start of January, US forces had eliminated a high-ranking commander belonging to one of these Iranianbacked factions in Baghdad. Fast forward to mid-January, after enduring continuous attacks on commercial ships in the Red Sea by the Houthi movement, another Iran-backed group, the US, in collaboration with the UK, initiated a wave of strikes on Houthi fortresses in Yemen.

Despite this show of force, it would be unwise to bet on the US' committing major diplomatic and security resources to the Middle East over the longer term. Well before Hamas' October 7 attacks, successive US administrations had signaled their intent to shift away from the region to devote more attention to a rising China. The Biden administration has also been contending with Russia's war in Ukraine, further limiting its bandwidth for coping with the Middle East. By 2023, U.S. officials had largely given up on a revived nuclear agreement with Iran, seeking instead to reach informal de-escalation arrangements with their Iranian counterparts. At the same time, the administration was bolstering the military capacity of re-



gional partners such as Saudi Arabia in an effort to transfer some of the security burden from Washington. Despite Biden's early reluctance to do business with Riyadh-whose leadership U.S. intelligence believes was responsible for the 2018 killing of the Saudi journalist and Washington Post contributor Jamal Khashoggi-the president prioritised a deal to normalise relations between Saudi Arabia and Israel. In pursuing the deal, the US was willing to offer significant incentives to both sides while mostly ignoring the Palestinian issue.

October 7 upended this approach, underscoring the centrality of the Palestinian issue and forcing the US into more direct military engagement. Yet remarkably, the war in Gaza has not led to significant shifts in Washington's underlying policy orientation. The administration continues to push for Saudi normalisation despite Israeli opposition to a separate state for the Palestinians, which the Saudis have made a condition of any such agreement. And US officials seem unlikely to end their effort to disentangle the US from Middle East conflicts. If anything, the war's increasingly complicated dynamics may result in even less US appetite for engagement in the region. Doubling down on commitments in the Middle East is also not likely to be a winning strategy for either American political party in a crucial election year. Neither European nor Chinese lead-

ers have demonstrated much interest in or capacity for taking on the job, even as US influence wanes. Given this emerging reality, regional powersparticularly Israel's immediate Arab neighbours Egypt and Jordan, along with Qatar, Saudi Arabia, Turkey, and the UAE, which have been coordinating since the war began—urgently need to step up and define a collective way forward.

Finding common ground after Hamas's brutal October 7 attacks and Israel's devastating campaign in Gaza will be exceptionally difficult. And the longer the war continues, the greater the risk of broader fractures across the Middle East. But in the years preceding the attacks, both Arab and non-Arab states showed the potential for new forms of cooperation in what amounted to a major reset of relations across the region. Even after months of war, many of these ties have remained intact. Now, before this trend reverses, these governments must come together to build lasting mechanisms for conflict prevention and, ultimately, peace.

The Middle East is facing a moment of reckoning. If it becomes paralysed by the horrific bloodshed in Gaza, it could further descend into crisis and conflict. Or it can start building a different future.

Betul, Feb 7: State-owned fuel retailers are losing close to ₹3 per litre on selling diesel while the profit on petrol has trimmed due to recent firming up in international oil prices, industry officials said detailing reasons for continuing to hold retail prices

Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL), who control roughly 90 per cent of India's fuel market, 'voluntarily' have not changed petrol, diesel and cooking gas (LPG) prices for almost two years now, resulting in losses when input cost was higher and profits when raw material prices

were lower International oil prices, against which domestic rates are benchmarked as India is 85 per cent dependent on imports to meet its oil needs, had softened late last year but firmed up again in the second half of January.

They have resisted calls to revert to daily price revision and pass on softening in rates to consumers on grounds that prices continue to be extremely volatile - rising on one day and falling on the other - and that their past losses haven't been fully recouped.

'There are losses on diesel," an industry official said. "It had turned positive but now oil companies are losing close to ₹3 per litre." He said the profit margin on petrol has trimmed from low teens to around ₹3-4 a litre.

Asked about fuel price revision, Oil Minister Hardeep Singh Puri told reporters on the sidelines of the India Energy Week that the government does not dictate prices and the oil companies take their decision considering all economic aspects.

"They say there is still volatility (in the market)," he said. Asked about the bumper

The combined net profit of IOC, BPCL and HPCL in the April-December (first nine months of current fiscal year) was better than their annual earning of ₹39.356 crore in preoil crisis year, regulatory filings

by them showed. The firms had posted a combined net loss of ₹21,201.18 crore during the April-September 2022 despite accounting for ₹22,000 crore announced but not paid LPG subsidy for the previous two years. Subsequent softening of international prices and government giving out LPG subsidy helped IOC and BPCL post annualised profit for 2022-23 (April 2022 to March 2023 fiscal)

but HPCL was in the red. This fiscal year, things have changed dramatically. The three firms posted record quarterly earnings in the first two quarters (April-June and July-September) when international oil prices - against which domestic rates are benchmarked almost halved to \$72 a barrel from

a year ago. International prices rose again in the subsequent quarter to \$90, leading to moderation of their earnings.

But, on a year as a whole they had rich profits. The fuel price

freeze that began April 6, 2022, had a loss as high as ₹17.4 a litre on petrol and ₹27.7 per litre on diesel for the week

ended June 24, 2022. However, subsequent softening led to losses being eliminated. The three firms had a margin of ₹11 a litre on petrol and ₹6 on diesel last month.

But now things have changed, another industry official explained.

International oil prices have been turbulent in the last couple of years. It dipped into the negative zone at the start of the pandemic in 2020 and swung wildly in 2022 - climbing to a 14-year high of nearly \$140 per barrel in March 2022 after Russia invaded Ukraine, before sliding on weaker demand from top importer China and worries of an economic contraction.

But for a nation that is 85 per cent dependent on imports, the spike meant adding to already elevated levels of inflation and derailing the economic recovery from the pandemic.

So the three fuel retailers froze petrol and diesel prices for the longest duration in the last two decades. They stopped daily price revision in early November 2021 when rates across the country hit an all-time high, prompting the government to roll back a part of the excise duty hike it had effected during the pandemic to take advantage of low oil prices.

### **Vibhor Steel Tubes** opens unit in state

New Delhi, Feb 7: Vibhor Steel Tubes Ltd (VSTL) is setting up a new unit at Sundargarh in Odisha to scale up its total manufacturing capacity to 3.41 lakh tonne, a company official said Wednesday.

The Hisar-based steel maker presently has two plants -- one in Mahabubnagar, Telangana and one in Raigad, Maharashtra having a total installed capacity of 2.21 lakh tonne.

"With the commissioning of the third project in Odisha, our capacity will increase by 1,20,000 MT to 3,41,000 MT," its chairman Vijay Kaushik told reporters in an interaction.

Replying to a question related to the timeline of the project, he said the aim is to make the plant operational by the first guarter of financial year 2024-25.

On the expansion plan, Kaushik said the company has already acquired the land for the project, and orders for plant and machinery have been placed. It will be funded through internal accruals.

He did not disclose the investment details due to regulatory obligations as the company is in the process of listing on BSE and NSE

The Initial Public Offering (IPO) of Vibhor Steel Tubes will open February 13 and close February 15, he said.

The company has set a price range of ₹141-151 per share for its proposed IPO. The company's offering comprises a fresh issue of equity shares (having a face value of ₹10 each), aggregating to an issue size of up to ₹72.17 crore, through book-building route.

Khambatta Securities is the sole book-running lead manager to the offer and KFIN Technologies is the registrar.

The proceeds from the issue will be utilised for working capital requirements.

# Living up to name: Sachin lives his father's dream

New Delhi, Feb 7: His police officer mother didn't want cricket to be Sachin Dhas' focus in life but the father knew that he was destined to make it big on the 22vard strip despite spending a better part of his life training on 11-yard grass tracks that pass for infrastructure in his hometown Beed.

The 19-year-old Dhas is among the brightest prospects to emerge in the Indian team that is competing in the U-19 World Cup in South Africa. He has displayed superb game sense as the team's designated finisher with 294 runs at an above 100 strike rate.

"You only have half pitches over here (in Beed). Sachin came here with his father when he was four and a half years old and even before going to South Africa, he trained on half turfs,' said an ecstatic Sheikh Azhar, the

area's most famous coach who shaped Dhas' early years. For a country which produces phenomenal cricketing talent often not because of, but despite the system, Sachin's emergence as the next big thing from junior India stable shouldn't come as a surprise.

Named after the iconic Mumbaikar, who is synonymous with Indian cricket, Sachin is a fan of Virat Kohli, the modern great he has perhaps seen more closely although he wears the number 10 jersey which was sense of the word. "I named him after Sachin Tendulkar when he was born in 2005 because I was a huge fan but he also likes Virat Kohli a lot," declared his beaming father Sanjay when PTI reached out

"Uski mummy police mein hain toh discipline hai (His mom is in police and there is disci-

pline in him),' added the proud father, whose phone hasn't stopped ringing thanks to his son's achievements at the mega-event.

Asked about his practice hours, Dhas senior revealed, "Four hours in the morning and three and half hours in the evening, including gym work. It's seven and half hours per day. I must give credit to Azhar, his coach. Without him, we wouldn't have seen this day.

In between discussing his son's game, Sanjay also gushed about how close he is to him. "He still sleeps beside me and whether he wants to have a meal at a restaurant or watch a movie, I am his companion," he said.

Kohli unlikely for next 2 Tests, also doubtful for 5th tie

New Delhi, Feb 7: India's star batter Virat Kohli is likely to miss the third and fourth Tests against England due to personal reasons, which also kept him out of the first two matches of the series, a BCCI source said Wednesday.

Chances of Kohli playing the final Test of the series in Dharamsala (from March 7-11) are also remote but the board isn't looking that far ahead as that particular match is still a month away. The third Test will be held in Rajkot from February 15-19, while the fourth game is in Ranchi from February 23-27.

Recently Kohli's close friend and former South African skipper AB de Villiers had revealed on his YouTube show that the Indian batting ace is missing in action due to the impending arrival of his second child.

"The BCCI has time and again made it clear that when it comes to family matters, it stands firmly behind the cricketer and it will be Virat's call when he is ready to make a comeback. As of now, it looks unlikely that he will play in the series," a BCCI source told PTI on conditions of anonymity.

Among the imminent comebacks, KL Rahul and Mohammed Siraj are likely to return to the playing eleven in places of Rajat-Patidar and Mukesh Kumar.
