

CAA before polls: Shah

New Delhi, Feb 10: The rules for implementing the Citizenship Amendment Act (CAA) will be issued before the coming Lok Sabha polls and the process to grant Indian nationality to the beneficiaries will start soon after, Union Home Minister Amit Shah said here Saturday.

Under the CAA, the Modi government wants to grant Indian nationality to persecuted non-Muslim migrants - Hindus, Sikhs, Jains, Buddhists, Parsis Christians - from Bangladesh, Pakistan and Afghanistan who had come to India till December 31, 2014.

"The CAA is a law of the country and its notification will definitely be issued. It will be issued before the polls. The CAA will be implemented before the elections. No one should have any confusion about it," Shah said at the ET NOW Global Business Summit 2024

He said granting Indian citizenship to persecuted minorities of the neighbouring countries was a promise of the Congress leadership too.

"When the Partition happened - Hindus, Buddhists, Christians - all wanted to come to India after facing religious persecution there. They (Congress leaders) had promised to give citizenship to these people saying all of you are welcome. But the (Congress) leaders went back on their word," Shah said.

The Home Minister added that he wanted to make it clear that the CAA is not a law to snatch anyone's citizenship.

"Our Muslim brothers are being instigated on the issue of CAA. It can't snatch anyone's citizenship as the law does not have that provision. CAA has been enacted to give citizenship to those people who have come from Bangladesh and Pakistan after facing religious persecution. No one should oppose this law,"

and got the Presidential assent. Delayed by over four years, rules for the CAA are a must for its implementation. Officials said rules are ready and the online portal is also in place as the entire process will be online.

The applicants will have to declare the year when they entered India without travel documents. No document will be sought from the applicants.

According to the law, the benefits under the CAA will be given to the undocumented minorities from the three countries.

The promise of implementing the controversial CAA was a major poll plank of the BJP in the last Lok Sabha and Assembly polls in West Bengal.

The saffron party's leaders consider it a plausible factor that led to the rise of the BJP in

According to the Manual on Parliamentary Work, the rules for any legislation should have been framed within six months of presidential assent or seek an extension from the Committees on Subordinate Legislation in Lok Sabha and Rajya Sabha.

Since 2020, the Home Ministry has been taking extensions at regular intervals from the parliamentary committee for framing the rules.

Over a hundred people lost their lives during the protests or in police action after the parliament passed CAA.

3 choked to death in Dhenkanal brick kiln POST NEWS NETWORK

Dhenkanal, Feb 10: Three members of a family were choked to death at a brick kiln in Kamalanga village under Kantabania police limits here late Friday night, police said

The deceased were identified as Meghanad Bhoi, 50, his wife Nira Bhoi, 45, and their seven-year-old son Jitu Bhoi of Badatenari village under Sagra police limits in Mahasamund district of Chhattisgarh.

Their other son, who was also critical, has been undergoing treatment at Talcher Thermal Hospital, according to an official.

Hindol Sub-Divisional Police Officer (SDPO) Dipak Jena said brick kiln owner Binay Sahoo had engaged 15 migrant labourers, including the Bhois, from Chhattisgarh about two weeks

The family was sleeping atop the kiln to get respite from the



from it is suspected to have caused the deaths late Friday night, added Jena. The incident came to the

fore when a few others working at the kiln found the four in an unconscious state Saturday morning.

Later, they were rushed to a nearby healthcare facility, where doctors declared three of them dead. The couple's other son was shifted to Talcher Thermal Hospital.

"An unnatural death case has been registered and further investigation is underway," the SDPO added.

Assistant Labour Officer Haladhar Baral said that action will be taken as per norms.

10-time MLA Sugyan Deo passes away at 87

Bhubaneswar, Feb 10: Veteran BJD leader and 10-time Odisha MLA V Sugyan Kumari Deo died while undergoing treatment at a private hospital in Chennai Saturday, officials said. She was 87.

Deo breathed her last at about 1 am after Chief Minister Naveen Patnaik and other senior party lead ers met her at the hospital Friday night, they said. She belonged to the royal family of Khallikote.

Governor Raghubar Das, the Union Minister Dharmendra Pradhan and many other dignitaries expressed their condolence on the demise.

"Saddened to know about the demise of V Sugyan Kumari Deo. She was a very senior leader of BJD and she made a lot of contributions towards the party. She has left her mark in the pub-



lic service by representing both Khallikote and Kabisuryanagar. It is an irreparable loss. May her soul rest in peace and my deepest condolence to the bereaved family," Patnaik said in a post on X.

Rio de Janerio, Feb 10: Sound begins blasting ear drums and rattling bones even before the speakers — hauled by big rigs creeping their way through Brazil's thronging Carnival crowds — draw near.

The behemoth sound trucks known as electric trios are a Brazilian innovation that amplified music and effectively did away with front-row seats making Carnival more accessible. In the seven decades since the first one hit Brazil's streets, they have become a fixture of the country's annual pre-Lenten festivities and draw millions to the streets. Singer Caetano Veloso's ode to the earth-shaking vehicles proclaimed that the only people not following them must already

From Salvador, on Brazil's northeast coast, trios spread throughout the country and found more disciples; an



Instagram account that posts seemingly banal videos of the nation's rigs has about 150,000 followers, with fans praising each trio's merits. They've grown ever more sophisticated and ever larger — with lights, LED screens, dressing rooms and VIP areas.

Their appeal has never been just the novelty of amplification. Their steady, constant advance meant anyone, rich or poor, could get close enough to the music to feel it throb through their body, said Isaac Edington,

who coordinates Salvador's festivities as president of its tourism

Helen Salgado, a 31-year-old actress, traveled to Salvador from Rio to immerse herself in the oceans of people churning around trios in celebrations ahead of the official start of Carnival Saturday. She said she was driven to ecstasy without consuming so much as a drop of

But long before these walls of sound took Brazil by storm, there was a Ford. It was a 1929 Model A — the Model T's lesser-known successor — imported from the US to Salvador. For years, metalworker Osmar Macedo used the convertible to haul iron.

In 1950, Osmar, as he is universally known, and his friend Dodô, a radio technician and fellow amateur musician, outfitted the Ford with two speakers and connected their guitar and cavaquinho to the car's battery, Aroldo Macedo, Osmar's son, told Associated Press. They drove the car, with its dented fender and chipping maroon paint, through the streets playing music and delighting Carnival revelers who jumped and jived in their wake, said Macedo, 65.

The duo repeated the stunt the next year, this time with a third musician, and so called themselves the Trio Eletrico. The term stuck, and was applied to all mobile stages that rolled across Salvador, the capital of Bahia state. Soon enough, trios were the centerpiece of the city's Carnival.

They started featuring Bahia's top artists, like Veloso, who clambered aboard one built specially for him in 1972 that resembled a spaceship. They became launchpads for the careers of musicians, including Daniela Mercury, Ivete Sangalo and Margareth Menezes, Brazil's current culture minister, who called the trio "one of Brazil's great inventions.'



HC stay on Hindi teacher recruitment

Cuttack, Feb 10: The Orissa High Court has imposed an interim stay on the appointment of Hindi teachers in government and government-aided schools in the state

Hearing a petition filed by Netrananda Bagh and others objecting to the procedure followed in the recruitments, a single-iudge bench of Justice Biraja Prasanna Satpathy barred the State Selection Board (SSB) from publishing the final merit list of candidates without the court's order. The HC has also issued notices to the state government and the SSB seeking replies by February 26.

According to the petitioners, the School and Mass Education department had ap-

He said the youth of Odisha will significantly contribute to the development of India as it completes 100 years of Independence in 2047, and asserted IIT Bhubaneswar will play a critical role in anchoring the state's talent. "Our target is to mint 100 startups with 100 croreplus turnover by 2036. The 100 Cube event by IIT Bhubaneswar

is envisioned for this purpose. Together we will create a culture of entrepreneurship in India," Pradhan said.

In the 10 years of the Narendra Modi government, the start-up ecosystem in the country has boomed tremendously with tech latent stemming from all quarters, especially economically backward states. "Since 2014 there has been a paradigm shift in the startup ecosystem in India. In the last 10 years, the number of startups has increased from three-four thousands to over one lakh," he said.

India's talent pool resides in areas where hunger for resolution is the most, he said, adding the academia, startups and the industry are working together to fill the skill gap in the country.

Pradhan also asserted that the consecration ceremony at the Ram temple in Ayodhya was a unifying force for the country.

MDA launched to \perp eliminate filariasis

Bhubaneswar, Feb 10: Health and Family Welfare Minister of State SP Singh Baghel launched a Mass Drug Administration (MDA) campaign across 11 states, including Odisha, virtually Saturday to help eliminate the crippling disease lymphatic filariasis (LF) from the population.

Under the National Filariasis Elimination Programme (NFEP), the state Health and Family welfare department began its Mass Drug Administration campaign February 10, to continue till February 19, for elimination of lymphatic filariasis in seven endemic districts of the state: Bolangir, Kalahandi, Rayagada, Cuttack, Kandhamal, Khurda and Nayagarh.

On the occasion, Public Health director Niranjan Misra said, "During the MDA, It will be ensured that everyone except children below 2 years of age, pregnant women and seriously ill people consume the prescribed dosage in presence of trained volunteers or health workers.

Similarly, Shubhashisha Mohanty, joint director of health services said, "The condition affects livelihoods, opportunities and working capacity of those suffering, often making them victims to social stigma. The Mass Drug Administration (MDA) is key to addressing the disabling disease, where antifilaria drugs are administered to eligible populations by trained volunteers and health workers.

Notably, during this MDA health workers will reach around 46 lakh people through booth and house-to-house visits.

When Lok Sabha was constituted in 2019, BJP had 303 members as the single largest party. though it came down to 290 by the last sitting, largely due to resignations of some MPs after the recent Assembly polls that they fought and won.

Altogether 397 MPs were elected from national parties in 2019, including 52 from Congress, which now has 48 MPs. Trinamool Congress' (TMC's)

emolitions in Uttarakhand this month, after which six were killed in violence, follows a pattern we can see in BJP states. The pattern is of course that the government is used to go after citizens, especially Muslims. The demolitions are carried out as a form of extra-judicial punishment by municipal authorities and police, whether following episodes of communal violence or protests against discrimination. The pattern has been documented in reports like 'Routes of wrath: Weaponising religious processions' (April 2022). This text was by the Citizens and Lawyers Initiative. In his foreword, former Supreme Court justice Rohinton Nariman writes that "the report corroborates the findings (of decline in Indian democratic values)" and that "it finds that in nine States of this Country, during Ram Navami and Hanuman Jayanti celebrations in April 2022, there were widespread acts of hooliganism and violence." After this

A report by Amnesty International, of which I am India chair, has found similar patterns of people rendered homeless and deprived of their livelihoods. These individuals were subjected to forced evictions. intimidation and unlawful force by the police and collective and arbi-

trary punishment, which undermined their rights to non-discrimination, adequate housing, and a fair trial.

Muslim-concentrated localities were either chosen or Muslim-owned properties were selectively targeted in diverse areas for demolitions. Adjacent or nearby Hindu-owned properties that also allegedly encroached on public lands particularly in Gujarat and Madhya Pradesh, were left untouched.

The Indian State's rationalisation of carrying out arbitrary demolitions to remove illegal encroachment sits in contrast to the reality of the country where the implementation of building laws is fraught with a lack of enforcement, which has resulted in a lot of construction taking place without the requisite permissions. In 2017, a report submitted by a panel formed by the Delhi High Court to document "illegal constructions" in the capital region found that "90% [of the buildings] carry one kind of violation of the extant building bylaws

The emblematic case here is that of Sainik Farm in Delhi, a tiny enclave that is totally illegal and that has not seen JCBs come and demolish the bungalows of our wealthy. The headline of a news report from May 2023 illustrates this perfectly: "Expedite call on Delhi's Sainik Farms bid for regularisation: High Court". Of course, the poor and especially the Muslim poor are given no such leeway. They're

subjected to forced eviction, which is the permanent or temporary removal of people against their will from the homes or land they occupy, without legal protections and other safeguards. Forced evictions are a violation of human rights, including but not limited to the right to adequate housing.

Under international human rights law, states must ensure that evictions only occur in exceptional circumstances, require full justification and the provision of adequate legal safeguards. None of that here in New India, of course.

In fact, India's bulldozer demolitions are often instigated at the highest levels of government, with many state officials directly or indirectly calling for the use of bulldozers against Muslims. There is credible evidence to believe that these demolitions are discriminatory and targeted as part of a hate campaign against Muslims in India. Rather than prevent discrimination towards Muslims, senior political leaders and government officials have actively encouraged it.

During the April 2022 demolitions in Delhi, BJP spokesman GVL Narasimha defined JCB as "Jihadi Control Board," in a now-deleted tweet. The discrimination shows elsewhere also. A year-and-a-half since the demolitions that Amnesty documented, in spite of the financial hardships created by the loss of their homes and businesses, victims continue to wait for justice with legal cases pending in courts. To date, the courts have failed to address punitive demolitions with the scale and urgency required by the prevailing situation, enabling the Indian authorities to continue tearing down people's homes and busi-

nesses in other areas with widespread impunity. This must also be viewed in conjunction with the creation of quasijudicial tribunals in the states of Uttar Pradesh and Madhya Pradesh which have provided prompt relief to Hindus who suffered losses due to the preceding violence while Muslim victims of the violence and following demolitions continue to struggle for justice.

The Routes of Wrath report concludes that while there have been earlier phases of communal violence in India, which entrenched cycles of violence, segregation and generated lasting barriers to socio-economic mobility for Indian Muslims in particular, they did not undermine State control over society or its authority over institutions in the manner that is being seen today.

Coordination between Hindutva outfits, and the police and district administration, means combining an extreme ideological entity with the civil service. What can be observed is that the relationship between them has become institutionalised in many parts, sustaining a violently undemocratic model of governance that is anathema to the rule of law.

In a letter to the Prime Minister in April 2022, more than 100 retired senior civil servants stated that the administration of law has become the means by which the minorities, particularly the Muslim community, can be kept in a state of perpetual fear. They said facilitation and support for communal frenzy was being provided at all levels of the administration - from local police and administrative officials to the highest political levels in state and Central governments. "While the actual commission of violence may be outsourced to fringe groups, there is little doubt as to how the ground for their operations is made fertile, how each of them follows a master script and shares a common 'tool kit' and how the propaganda machinery of a party as well as the state is made available to them to defend their actions," the retired bureaucrats wrote.

Finally, the Citizens and Lawyers Initiative report concludes "the available evidence corroborates statements by civil society groups, lawyers, academics and activists, that India has reached a stage of perpetual violence.'

DOING THE MOST GOOD DOES PROVIDE A COMPETITIVE EDGE

t seems counterintuitive, but in a capitalist economy, doing the most good can provide a competitive edge. I am not referring to businesses that donate a tiny percentage of their profits to charities or tell you that they are reducing greenhouse-gas emissions. I am talking about businesses that donate 100% of their profits - or close to it – to effective charities that do a lot of good.

Newman's Own, the American food company founded in 1982 by the actor Paul Newman and author AE Hotchner (both now deceased), is an early example of a business donating 100% of its profits to charity. The profits go to the Newman's Own Foundation, which to date has distributed over \$600 million to charities working for disadvantaged children. Hugh Jackman cites Newman's Own as an inspiration for his own charitable foundation, Laughing Man Coffee.

Perhaps the most prominent company operating along these lines today is Patagonia, the American outdoor-clothing company founded by Yvon Chouinard in 1973. Nearly 50 vears later, when the company was valued at around \$3 billion, Chouinard gave it to a non-profit organisation, ensuring that all its profits will be used to protect the environment and fight climate change.

The arrangement commenced in September 2022. So far, profits amounting to \$71 million have been allocated for environmental initiatives that include stopping a proposed mine in Alaska and conserving land in South America, as well as for helping to elect pro-environment Democrats in the United States

Chouinard's decision, supported by his wife and two adult children, to give away his company, is especially laudable because, to enable the non-profit organisation to have the option of supporting political candidates, the family had to forego

substantial tax benefits from their huge donation.

Wonderful as it is that Patagonia's profits will always support the protection of the environment, the company's success does not prove that doing the most good provides a business with a competitive advantage. After all, although Patagonia is notable for many beneficial policies, including donating 1% of its total sales to environmental organisations and promoting the repair, exchange, and recycling of its clothing, these innovations largely came after the company was successful. Its initial success reflected, to a significant degree, the desirability of the goods it was selling.

Now that it is clear that all of Patagonia's profits will go toward protecting the environment, will the company do even better? Vincent van der Holst, an online marketer, believes that it will. He argues that companies that donate their profits to good causes "grow faster, live longer, and are more profitable." Accordingly, he has created BOAS, a platform for selling vintage jeans that has pledged to donate 90% of its

profits to effective charities saving the lives of children dying from preventable diseases in low-income countries. (Disclosure: I have invested 500, or \$537, in BOAS, with the expectation that the most significant return on my investment will be the knowledge that it has helped to save lives.)

BOAS is not yet earning enough to be cited as an example of a successful company that was founded for no other reason than to earn money for good causes. Humanitix, a ticketing agency founded by two Australians, Adam McCurdie and Joshua Ross, in 2016, is a better example of a business gaining a competitive edge by donating 100% of its profits to highly effective charities.

McCurdie and Ross went on a hiking trip through Sri Lanka shortly after the end of that country's tragic civil war in 2009. The poverty and hardship they witnessed made them resolve to work together to help children who had been less fortunate than they had been.

McCurdie was an engineer. and Ross a financial analyst. How might they work together to do the most good? The unex-

pected answer was to start a ticketing agency. Like most people who buy tickets for events online, they disliked seeing the price of their tickets go up when the ticketing agency added its fee, aware that their purchases were increasing the profits for a faceless group of owners. Yet the convenience of booking tickets online means that for most event organisers, there is no feasible alternative to using an agency, and no basis for choosing one agency rather than another.

But what if there were a ticketing agency that did not make profits for its (presumably rich) owners, but was wholly owned by a charitable foundation, so that, by law, all its profits would go to a cause that almost every one would endorse, like helping children in extreme poverty Ticket purchasers would feel more positive about that agency than they do about other agencies, and some of their positive feelings would flow toward the event itself, and its organisers, who would have a reason to prefer that ticket agency over others.

That was McCurdie and Ross theory, anyway. With support from the Atlassian Foundation and the government of New South Wales, they were able to test it. Humanitix has become the fastest-growing ticketing platform in Australia and New Zealand, and is now establishing itself in the United States. Despite the need to reinvest much of its profits to ensure future growth, Humanitix has already donated \$4 million to effective charities assisting children and is on track to donate an additional \$5 million in 2024.

The theory works for ticketing agencies. Doing the most good does provide a competitive edge. Further applications are waiting to be discovered.

Just honour to a rare reformer

FOR ALL HIS WARTS AND MOLES, RAO WAS AN INTELLECTUAL COLOSSUS LIKE NEHRU. **POLITICALLY ASTUTE LIKE** INDIRA, WHO **TRUSTED HIM**

y honouring PV Narasimha Rao with the Bharat Ratna, PM Modi has struck a rare combination -- of recognising his economic paradigm shift of Nehruvian socialism and his political sagacity of not allowing paramilitary forces from intervening during the demolition of Babri masjid. Dr MD Godbole, who was the Home Secretary at that time, writes in his book 'Unfinished Innings' (1996) how he repeatedly tried to contact the PM to exercise the Centre's power under Article 355, unsuccessfully, prompting him to resign prematurely. This momentous passivity and indecision, many believe, led to the successful campaign for a Ram mandir at the Babri masjid site by LK Advani, a recipient of Bharat Ratna now and Modi finally building the Ram temple. Quite clearly it cost the Congress dearly in terms of Muslim votes in UP, led to the rise of Mulayam Singh Yadav as savior of the minority community and Modi-Adityanath duo cementing the shrill cry of Hindu majoritarianism. Rao is ironically the unconscious hand of history that promoted and cemented Hindu

fundamentalism at the cost of upholding secularism as the basic structure of the Constitution. This dubious distinction, however, does not obliterate the pioneering role he played for ushering economic reforms in India in 1991, a process being carried forward by the BJP during the last decade of Modi's governance.

It is often debated as to whether it was Rao or Dr Manmohan Singh who was the real architect of the reforms of 1991. During a book release function in Delhi a few years after he stepped down as PM, Rao said: "Without the PM's backing the FM will be a zero. It is the PM's backing that puts a one before the zero making it a 10." It could not have been put more neatly. Rao deserves full credit for choosing Singh as FM because of his acknowledged expertise to manage the economy as Secretary in MoF and later as Governor of RBI. Rao was once asked by a journalist how he had managed to make a 180 degree turn on Nehruvian socialist policies. He replied cleverly: "I have not turned at all. I am facing the same direction. It is the world that

has turned 180 degrees under me." He was alluding to the fall of the Berlin wall in 1989, abandoning the statist policies in East Europe and disintegration of USSR by December 1991.

Rao's was clearly a strategy by stealth. You point in a broad direction without committing any particular pace of change and then take step forward whenever it is politically opportune to do so. Singh was a gradualist, who conceptualised a complex and multidimensional structure of reform. Rao did not want to hog the limelight as the architect of reforms. Neither did Singh go overboard about it; earning encomiums globally. They were like the famed jugalbandi of Bharat Ratna sitarist Pandit Ravishankar with tabla legend Ustad Allah Rakha. Rao and Singh connected India to the headwinds of globalisation and the prosperity that flows out of freeing markets out of asphyxiating state controls

Modi spares no effort to decry the legacy of Congress and Nehru in particular. The recent budget went a step further to show how the decade under BJP was far better governed and inclusive than alising that they are carrying on the economic pragmatism of Singh under the astute political leadership of Rao was PM. Modi had typically chosen Pranab Mukheriee earlier for Bharat Ratna as he had broken away from the Congress earlier and knew which side of the bread is to be buttered when there is change in political leadership. Rao was not a turncoat, but did not give in to the dictates of the political dynasty under Sonia, the way Singh gave in during his second term as PM. History as Marx said, repeats itself as tragedy first, then as farce. Political opportunism best demonstrates this adage. For all his warts and moles, Rao was an intellectual colossus like Nehru, politically astute like Indira, who trusted him. He could read both the political and economic currents wafting through the country, tad better than most, at the cost of sacrificing secularism, albeit inadvertently.

It was because of the trust (between the duo)," he said with a smile. Balagopal also accused the UDF MPs including Premachandran of raising questions in Parliament in a way that strengthens the arguments by the Centre against the state government.

Assam, Mizoram agree to resolve border dispute

Aizawl, Feb 10: Mizoram and Assam Friday agreed to make joint efforts to resolve the long pending inter-state border dispute, an official statement said.

Tourist footfall, revenue Rise in HIV cases in Assam due to injecting of drugs increase at Kaziranga

Guwahati, Feb 10: The Kaziranga National Park and Tiger Reserve (KNPTR) in Assam has registered around 4 per cent rise in tourist arrival and 2.2 per cent revenue increase during the current season, as compared to the same period of the previous year, officials said.

Officials at the KNPTR said that as many as 1,79,573 tourists, including foreigners, visited the park from October last year to January this year, while ₹4,58,776,39 was earned during this period. In comparison, 1,72,903 tourists visited the park and ₹4,48,75,100 was earned as revenue between October 2022 and January 2023.

Officials said the tourist flow was affected during the Covid-19 pandemic years (2020-2021). In the entire 2021-22, around 2,55,676 visitors had visited the park and the revenue generated stood at ₹5,49,78,055, while in 2022-23, around 3,26,924 visitors had visited the park while the estimated revenue earned was ₹7,76,07,566.

Officials said Kaziranga, nestled in the heart of Assam, continues to captivate travellers and wildlife enthusiasts, experiencing a significant upsurge in tourism, particularly during hol-

He affirmed in the Assembly that the government, with help from NGOs, has been working with HIV-positive persons.

However, the details were not disclosed to maintain the

anonymity of the patients.

Congress MLA Sibamoni Bora

raised the matter of the prevalence of HIV (human immunodeficiency virus) patients in the state during Question Hour, claiming that there has been a spike in fresh infections.

She claimed that around 50 per cent of the drug peddlers are themselves infected.

Bora alleged that the government has been less focused on spreading awareness of HIV since the outbreak of the COVID-19 pandemic.

Mahanta, in his reply, said that 31,729 HIV-AIDS cases were detected in the state from 89,84,519 tests conducted between 2002 and 2023. "In 2023, till December, 9,90,372 tests were conducted, of which 5,791 were found positive. Yes, there has been an increase and we are working to check it," he added.

The Minister said the government was working in close coordination with NGOs also, especially in providing care to infected people, and creating awareness among vulnerable

"But we cannot specify the work being done, we can only give you figures," he added, indicating the need to maintain confidentially in dealing with **HIV-AIDS** cases

He said transmission of the virus through injecting drugs accounts for the highest number of new cases currently. 'The state government has

already launched a drive against illegal drugs. But we have more to achieve to stop it altogether," he said.

Mahanta maintained that the state's position as a transit point for the rest of the northeast also makes its populace more vultients from other states in Assam further leads to an increase in the state's overall tally.

He said the state government has been providing all facilities for testing, counselling and treatment at different government-run and other health centres as well as in vulnerable places such as





CAA: A BRIEF HISTORY

Minister Amit Shah Saturday making it clear that the contentious Citizenship Amendment Act (CAA), that triggered wide spread protests across the country following its passage in the Parliament in 2019, will be notified and implemented before the upcoming Lok Sabha polls.

It may be recalled that protests had broken out across the country soon after the promulgation of the Act, with thousands of agitators, including students, taking to the streets with demonstrations at campuses of Jamia Millia Islamia, Aligarh Muslim University and Delhi University.

Protests snowballed into a major flashpoint in West Bengal with highways and railway lines blocked and incidents of arson and loot reported from many places and chief minister Mamata Banerjee declaring that CAA and NRC could be enforced in the state only on her 'dead body'.

The CPI(M)-led LDF and Opposition Congress headed UDF in Kerala held a joint protest against the amended Citizenship Act, with chief minister Pinarayi Vijayan slamming the move as an attempt to 'curb freedom', as per a report in the Times of India on December 17, 2019.

Shaheen Bagh

Soon after passage of the CAA, protesters gathered at Shaheen Bagh road in Delhi December 15, 2019 to oppose the Act, National Register of Citizen and National Population Register (NPR) calling them "anti-Muslim". The protesters also opposed the Delhi Police action against students of Jamia Millia Islamia. The protest began on a key stretch — Kalindi Kunj Road that links the densely populated Shaheen Bagh with the satellite township of Noida. Led mostly by women, the agitation drew as many as 1,00,000 protesters. The Shaheen Bagh protest became one of the longest protests of its magnitude in modern India. Carried out by women, the 'leaderless' Shaheen Bagh sit-in is often referred to by the supporters of the protest as a site of modernday Satyagraha. The protest ended March 24, 2020 amid nationwide lockdown over Covid-19 pandemic, as per a report in the Indian Express on March 24, 2020.

The Citizenship (Amendment) Act grants citizenship to Hindus, Christians, Sikhs, Buddhist, Jains and Parsis - from Afghanistan. Pakistan and Bangladesh who had arrived in India before December 31, 2014. The legislation applies to those who were 'forced or compelled to seek shelter in India due to persecution on the ground of religion'. It aims to protect such people from proceedings of illegal migration from the neighbouring countries.

The requirement to stay in India for those belonging to any of these six religions for at least 11 years before applying for Indian citizenship has been reduced to five years.

Why the agitation?

There are two distinct rallying points of protests against the Act. In the northeast, the protest is against the Act's implementation in their areas. Most of them fear that, if implemented, the Act will cause a rush of immigrants that may alter their demographic, linguistic and cultural uniqueness. In the rest of India, like in Kerala, West Bengal and in Delhi, people protested against the exclusion of Muslims, alleging it to be against the ethos of the Constitution, as per a report in the Times of India on December 17, 2019.

Not included

The CAA does not apply to tribal areas of Tripura, Mizoram, Assam and Meghalaya because of being included in the Sixth Schedule of the Constitution.

Also, areas that fall under the Inner Limit notified under the Bengal Eastern Frontier Regulation, 1873, will also be outside the Act's purview. This keeps almost entire Arunachal Pradesh, Mizoram, Manipur and Nagaland out of the ambit of the Act, the Times of India reported on December 17, 2019.

NRC link to CAA

The NRC, which identified illegal immigrants from Assam, had been a longstanding demand in Assam. But ever since its implementation, there has been a growing demand for its nationwide implementation.

After the updated final NRC in Assam was released August 31 2019, it excluded the names of over 19 lakh applicants, including Hindus (TOI report, December

NIA carries out raids at 15 locations in J&K

Jammu/Srinagar, Feb 10: National Investigation Agency (NIA) Saturday conducted raids at 15 locations across Jammu and Kashmir as part of its crackdown on the proscribed Jamaate-Islami (JeI) in a terror funding case, an official said.

The raids in the twin capitals of Srinagar and Jammu along with Budgam in central and Kulgam and Anantnag in south Kashmir led to the seizure of incriminating documents and digital devices connected with the activities of JeI and its related Trusts and more than ₹20 lakh, a spokesperson of the federal agency said.

However, official sources said two persons were also detained in Jammu for questioning during the raids targeting a private school and its functionaries including chairman at Gujjar

Nagar and Shaheedi chowk in Jammu. They said the residences of former Jamaat chief Sheikh Ghulam Hassan and another leader: Savar Ahmad Reshi. in Kulgam district were among those raided. The Jamaat-e-Islami Jammu and Kashmir was banned by the Centre for five years in February 2019.

The spokesperson said NIA teams swooped down on the premises of various suspects at five locations in Srinagar, three in Budgam, two in Kulgam, one in Anantnag, and four in Jammu."The investigations in the case, registered on February 5, 2021, have so far revealed that JeI and its members have continued to promote terrorist and secessionist activities in J&K even after the outfit was proscribed under Unlawful Activities (Prevention) Act in February 2019," the spokesperson said.

United Nations: UN experts say they are investigating 58 suspected North Korean cyberattacks between 2017 and 2023 valued at approximately \$3 billion, with the money reportedly being used to help fund its development of weapons of mass destruction. And the high volume of cyberattacks by North Korean hacking groups who report to the Reconnaissance General Bureau, North Korea's primary foreign intelligence organization, is reportedly continuing, the panel of experts said in the executive summary of a new report to the UN Security Council obtained Friday by The Associated Press. The report covering the period from July 2023 to January 2024 and reflecting contributions from unidentified UN member nations and other sources, was sent to the 15-membe council as North Korean leader Kim Jong Un has raised tensions in the region. He is threatening to annihilate South Korea if provoked and escalating weapons demonstrations. In response, the United States, South Korea and Japan have strengthened their combined military exercises.

Chinese balloons

Taipei: A record eight Chinese balloons have been detected around Taiwan, with two directly flying over the island, Taipei's defence ministry said Saturday. The ministry said the balloons were spotted Friday, the day before the start of the Lunar New Year holiday, at an altitude of 15.000 feet (4.572 metres) to 38,000 feet. It was the highest number detected since the ministry started regularly releasing data on balloon sightings in December.

Indian jailed

Singapore: A 47-year-old Indian-origin man was on Friday sentenced to five months in jail for having forced another man to strip and perform several exercises for not paying his inflated debt of about SGD6.000. A similar charge and a charge of voluntarily causing hurt were also taken into consideration for sentencing Nadeson Pillai Sockalingam Pillai. He also made the man dress up, head to a barber and shave his beard and head. The convict's two Indian-origin friends, Jav Shawn Fernandez and Jude Prabu Davias Pathy, have also been charged with criminal intimidation. One of Pillai's friends recorded the humiliating acts against the man, reported TODAY newspaper Friday.

Springing a surprise, independents backed by jailed former prime minister Imran Khan's party won the lion's share in the National Assembly election

Islamabad, Feb 10: Candidates backed by the party of jailed Pakistani opposition leader Imran Khan plan to form a government, a senior aide to the former prime minister said Saturday, urging supporters to peacefully protest if final election results are not re-

The South Asian nation of 241 million people voted Thursday in a general election, as the country struggles to recover from an economic crisis and battles militant violence in a deeply polarised political environment.

Both Khan and his main rival, three-time former Prime Minister Nawaz Sharif, declared victory Friday, increasing uncertainty over who will form the next government at a time when swift policy action is needed to address multiple challenges.

Gohar Khan, the chairman of Khan's Pakistan Tehreek-Insaf (PTI) party who also acts as the former prime minister's lawyer, called on "all institutions" in Pakistan to respect his party's

At a press conference, he said if complete results of the polls were not released by Saturday night, the party would hold peaceful protests Sunday outside government offices returning election results around the country.

Sharif said Friday his party had emerged as the single largest group and would talk to other groups to form a coalition gov-

Washington, Feb 10: A 41-yearold Indian-origin IT executive has died after suffering lifethreatening injuries during an assault outside a restaurant in the American capital here, the seventh death of an Indian or Indian-American in the country in recent months

The victim, identified as Vivek Taneja, a resident of Alexandria, a Virginia suburb of Washington DC, was attacked February 2 in the 1100 block of 15th Street NW, which is seven blocks away from the White House.

The police reached the assault scene at 2 am and found that he was suffering from life-threatening injuries as a result of the assault. He was transported to a trauma centre unconscious and



"On Wednesday, February 7, 2024, the victim succumbed to his injuries and was pronounced dead," said the Metropolitan Police, Washington DC in a statement Friday.

The picture of the suspect captured by a surveillance camera has been released by the police, which has offered an award of up to \$25,000 to anyone who provides information and leads to his arrest.

No arrest has been made so far. Taneja was the co-founder and president of Dynamo Technologies, a technology solutions and analytics product provider to the federal government. Earlier this week. Sved Mazahir Ali, an Indian student was attacked by robbers in Chicago. Earlier, 25-year-old Indian student Vivek Saini was fatally attacked in Georgia state's Lithonia

city by a homeless drug addict. Last week, a student at the Lindner School of Business in the US state of Ohio identified as 19-year-old Shreyas Reddy Beniger was found dead. However, local authorities have ruled out foul play. Sameer Kamath, a 23-year-old Indian-American student at Purdue University, was found dead in a nature preserve in Indiana February 5.

Another Indian student, identified as Neel Acharya at Purdue University, Indiana, was confirmed dead days after being reported missing January 28. Akul B Dhawan, an 18-year-old at the University of Illinois Urbana-Champaign, was found dead last month with signs of

Rafah. Feb 10: Israeli airstrikes killed at least 44 Palestinians in Rafah early Saturday, hours after Israel's prime minister said he asked the military to plan for the evacuation of hundreds of thousands of people from the southern Gaza city ahead of a ground invasion.

Benjamin Netanyahu did not provide details or a timeline, but the announcement set off widespread panic. More than half of Gaza's 2.3 million people are packed into Rafah, many after being uprooted repeatedly by Israeli evacuation orders that now cover two-thirds of Gaza's territory. It's not clear where they could run next.

Word of the invasion plans capped a week of increasingly public friction between Netanyahu and the Biden administration. US officials have said an invasion of Rafah without a plan for the civilian population would lead to disaster.



Israel has carried out airstrikes in Rafah almost daily, even after telling civilians in recent weeks to seek shelter there from ground combat in the city of Khan Younis, just to the north.

Angry Birds: First AI use

Israel's army has deployed some AI-enabled military technology in combat for the first time in Gaza, raising fears about the use of autonomous weapons in modern warfare.

The army has hinted at what the new tech is being used for, with spokesman Daniel Hagari saying last month that Israel's forces were operating "above and underground simultaneously".

In a first, the army has used an AI-enabled optic sight, made by Israeli startup Smart Shooter, which is attached to weapons such as rifles and machine guns.

"It helps our soldiers to intercept drones because Hamas uses a lot of drones," said a senior defence official. "It makes every regular soldier -- even a

blind soldier -- a sniper." Another system to neutralise drones involves deploying a friendly drone with a net that it can throw around the enemy craft to neutralise it. "It's drone versus drone -- we call it Angry Birds," the official said.

Russian drone strike on Kharkiv kills 7

Kviv. Feb 10: A Russian drone strike on Kharkiv, Ukraine's second largest city, killed at least seven people overnight, including three children, Kharkiv region governor Oleh Syniehubov reported Saturday.

He said the Iranian-made Shahed drone hit civilian infrastructure in the Nemyshlyan district on the city, causing a massive fire that burned down 15 private houses.

Interior Minister Ihor Klymenko said more than 50 people had been evacuated and that emergency workers had contained the blaze by Saturday morning.

The Ukrainian air force said air defense systems destroyed 23 out of 31 Iranian Shahed drones launched by Russia overnight. The drones prima-



rily targeted the northeastern Kharkiv region and the southern province of Odesa, the state-

The attacks came in three waves, he said. The first targeted the regional capital — the port city of Odesa. All nine drones were shot down, but the debris damaged port infrastructure and injured one person.

The second and the third waves targeted port infrastructure in the Danube river area, Kiper said. A total of 12 drones were shot down and three people were

"Some will try to block us, will make that passage difficult or put some kind of obstacles, some kind of argument in the way," he said, without naming any country. But I'm confident we will get there and I'm more confident today than I was five years ago or 10 years ago," the ex-



"As I go around the world, often I hear this from people that 'look, you can say things we can't say. We trust you to say this as we have our constraints',' he said, highlighting how India has already just naturally put across a position which is a collective position for all of them. He said that there were many issues where the interests of many were involved but the global

debate was dominated by a few. "It could be about the energy crisis, a lot of countries have a debt situation today. It could be about culture and heritage as everybody doesn't want to be overwhelmed by others' cultures. In a sense, today India is trusted and well-regarded. There are a lot of countries who want to see

us there," Jaishankar said. He said that in the many elections held in the different bod-

ies of the United Nations, India constantly does well in these elections.

"We often do better in those elections than the five who are already in the Security Council," the minister said.

LIC net shines 49%

New Delhi: State-owned insurer LIC Thursday reported a 49 per cent jump in net profit at ₹9,444 crore for the third quarter ended December 2023, helped by higher net premium. The country's biggest insurer had a net profit of ₹6.334 crore in the year-ago period. LIC said in a regulatory filing. Its net premium income rose to ₹1.17.017 crore in the third quarter of the current fiscal from ₹1.11.788 crore in the same period a year ago, LIC's total income increased to ₹2,12,447 crore in the latest December quarter compared to ₹1.96.891 crore in the year-ago period, it said.

NSE profit up 8%

New Delhi: The National Saturday reported an 8 per cent rise in consolidated net profit to ₹1,975 crore for three months ended December 2023. The consolidated income from operations stood at ₹3.517 crore for the October-December quarter of the current financial year (2023-24), a surge of 25 per cent year-on-year, NSE said in a statement. Apart from trading, the total revenue was also supported by other revenue lines, including listing, index services, data services and co-location facility, the exchange added. During the first nine months of FY24, NSE contributed ₹28,131 crore to the exchequer. which comprised STT (Securities Transaction Tax) of ₹23,137 crore, Income tax (Rs 1,490 crore), Stamp duty (Rs 1,456 crore), GST (Rs 1,257 crore) and Sebi charges (Rs 791 crore).

Matrimony.Com net remains flat

EPFO hikes interest rates

Employee provident fund interest hiked to 3-year high of 8.25%

New Delhi, Feb 10: Ahead of general elections, the interest rate paid on employee provident fund was Saturday hiked to 8.25 per cent for fiscal year ending March 31, the highest in three years.

The central board of trustees of the Employees' Provident Fund Organisation (EPFO) recommended to the finance ministry for raising the interest rate for nearly 8 crore contributing subscribers, the labour ministry said in a statement.

This will be the highest rate of interest for EPF subscribers in the last three years. The previous high was in 2019-20 when 8.5 per cent interest was paid. The rate of payout was maintained at the same level in 2020-21 but in the following year it was cut to 8.1 per cent, the lowest in four decades. (EPF interest rate was 8 per cent in 1977-78).

The interest rate was marginally hiked to 8.15 per cent in 2022-23 (April 2022 to March 2023).

The recommendation for 2023-24 fiscal will now go to the finance ministry and once it agrees to it, the EPFO will credit the rate of interest to the EPF sub-

India will go to the polls in April-May to elect a new government.

According to the labour ministry statement, the decision to hike interest rate for 2023-24 was taken at the 235th meeting of the Central Board of Trustees (CBT) of EPFO Saturday, under the chairmanship of Union Labour & Employment Minister Bhupender Yadav.

The CBT recommended an annual rate of interest of 8.25 per

Compared with the previous financial year, there has been a significant growth, the statement said, adding that the income grew by more than 17.39 per cent, while the principal amount increased by 17.97 per cent.

This suggests a healthy financial performance and potentially strong returns for the members, it stated.

The persons who were in the insurable employment for at least 5 years after April 1, 2012 and superannuated/voluntarily retired on or after April 1, 2017 with wages up to ₹30,000 per month will be benefitted under the new scheme.

S&P 500 CLOSES ABOVE 5K LEV

BULLISH SENTIMENT SPREADS ACROSS WALL STREET

New York, Feb 10: The S&P 500 closed above the 5,000 level Friday for the first time as bullish sentiment spreads across Wall Street and investors cheered fresh data showing progress on inflation, media reported.

The landmark moment comes during a period of strong economic growth, the artificial intelligence revolution, a betterthan-expected earnings season. and anticipation of a pivot from the Federal Reserve to start cutting rates, CNN reported.

The S&P 500 briefly topped 5,000 for the first time intraday Thursday.

It took almost 41 years for the S&P 500 to reach its first major milestone of 1,000, which it hit February 2, 1998, according to Howard Silverblatt, senior index analyst at S&P Dow Jones Indices.

The index reached its previous major milestone of 4,000 April 1, 2021, after the Fed slashed rates to almost zero, the government pumped stimulus funds into the economy and the Covid-19 vaccine fueled optimism of postpandemic economic growth.

On January 19, the benchmark index hit a new record for the first time in two years, closing at and besting its previous high of 4,796.56, reached January 3, 2022. The index went on to set six new highs in January alone,

Microsoft most valuable firm ever

Microsoft ended the week with a market capitalisation of \$3.125 trillion, the highest for any company ever, Barron's reported. The company's market value topped the previous record set by Apple, which reached \$3.09 trillion in July. Apple ended Friday with a market cap of \$2.916 trillion. Microsoft is also the first US company to close with a market cap greater than \$3.1 trillion, Barron's reported. Microsoft stock closed the week at \$420.55. Over the past 12 months, its shares have soared 60 per cent, largely thanks to the enthusiasm about its artificial intelligence software.

The S&P 500 is up about 5.4% so far this year. The index jumped 24% in 2023, with stocks rallying powerfully at year-end as optimism grew that the Fed could achieve a soft landing, or tamp down inflation without triggering an economic downturn.

The advance to new heights has been exceedingly narrow -most of the S&P 500's gains come from the so-called "Magnificent Seven" -- Nvidia, Microsoft, Meta Platforms, Amazon, Apple, Alphabet and Tesla, CNN re-

during the earnings, reports Reuters. Cisco last year issued layoff notices to and cut costs. The networking company had a total employee count of 84,900 as of its fiscal 2023, according to reports. In September last year Cisco laid off 350 employees in the Silicon Valley in the US in its latest job cut round. The company in November 2022 announced to slash about 5 per cent of its workforce, around 4,000 jobs.

The company's Ola S1 Pro and Ola S1 Air are now eligible for subsidies under the government's auto PLI scheme for five years from the



date of certification, sources added. In December, Ola Electric became the first Indian e-scooter (e2W) company to get eligible for the government's PLI scheme for its Ola S1 Air electric scooter. Ola Electric plans to expand its EV business and establish a lithium-ion cell

ONGC in talks to restart Libya ops, expand in Venezuela

Quitol, Feb 10: India's Oil and Natural Gas Corp is in talks to restart its operations in Libya and to increase production in Venezuela, a company executive said Friday. "Once it gets started for Oil

Despite downturn, India-Canada trade sees growth in 2023

New Delhi, Feb 10: India-Canada_ trade in goods was \$8.2 billion in the first 10 months of 2023 as against \$6.9 billion in 2022, registering a growth of 18.84 per cent, as per government data provided in Lok Sabha Friday.

India's exports to Canada in 2023 (January to October) was \$4.1 billion as against \$3.76 billion in 2022 and the growth was estimated at 9.04 per cent, showed the data furnished by Minister of State for External Affairs V Muraleedharan.

The statistics came amid a severe downturn in ties between the two countries.

India-Canada relations came under severe strain following Canadian Prime Minister Justin Trudeau's allegations in September last year of a "potential" involvement of Indian agents in the killing of Khalistani separatist Hardeep Singh Nijjar outside a gurdwara in Surrey city.

New Delhi rejected Trudeau's allegations as "absurd" and "motivated" and accused Canada of giving space to Khalistani extremists targeting India.



Kohli is currently abroad for pressing personal family matter.

The series is locked 1-1 with India bouncing back with win the second Test in Vizag after the visitors took the series-opener in Hyderabad. The third match is scheduled to start from February 15 in Rajkot.

The national selection committee included senior players Ravindra Jadeja and KL Rahul in the squad but their inclusion will be subject to clearance by the

BCCI's medical team.

After a rather sedate start that cost him a full point in the opener against Alireza Firouza of France, Gukesh was in full swing and ended the day with three points in all out of a possible four and is in joint second place in the rapid section behind Vincent Keymer of Germany who notched up 3.5 points.

Nodirbek Abdusattarov also matched Gukesh on points after remaining unbeaten on the opening day while the trio of biggies Carlsen, Firouza and Fabiano Caruana of the United States are in joint fourth spot with two points apiece in the USD 200,000 prize-money tournament. Levon Aronian of the United States, with a lone draw, is sole seventh while surprisingly Liren is at the bottom after losing all four

Against Liren, Gukesh was at his technical best as he unleashed a rook sacrifice for a minor piece early and Liren found his position to be crumbling soon afterwards. In the complications that ensued, Liren was outdone by Gukesh's precise calculation. The game lasted

With three rounds to come in the rapid, it remains to be seen who will play whom in the quarterfinals. Interestingly the quarters, semis and finale will be played under standard time control rules with 90 minutes to each player for forty moves and 30 minutes to finish the game with an increment of 30 seconds per move from move one.
