

Naveen lays stone for projects worth ₹87,500 crore

Paradip, Feb 16: Chief Minister Naveen Patnaik Friday laid the foundation stone for three major projects worth ₹87,500 crore, including a mega integrated steel facility by JSW Utkal Steel Limited.

The two other projects are Re-New E-Fuels Private Limited's ₹22,000 crore green ammonia plant and Silox India Private Limited's chemical factory worth ₹500 crore, according to a CMO statement.

The three projects together are expected to generate employment for 34,810 people.

While JSW Utkal Steel Ltd will set up a 13.2 MTPA integrated steel plant at Dhinkia (the earlier controversial site of South Korean steel major Posco) on the outskirts of the port township of Paradip in Jagatsinghpur, Re-New E-Fuels Private Limited has proposed to set up a 1.195 MTPA green ammonia plant and Silox India Private Limited to establish a 25,000 MTPA chemical factory.

The Sajjan Jindal-led company had in 2022 announced an investment of ₹65,000 crore in a greenfield mega steel project, which is likely to generate employment for 30,000 people in a phased manner.

"I am happy to lay the foundation stone for JSW's mega steel plant, the green ammonia plant and the chemical plant. The complex has brought an investment of about ₹90,000 crore for Odisha," Patnaik said while thanking the industrialists for making these investments.

Patnaik emphasised the government's commitment to leveraging such partnerships to create high-skill job opportunities for the youth of Odisha.

"Today, Paradip has emerged as one of the most attractive investment regions in the country. The cluster of industries



"All necessary resuscitation measures were carried out, which did not yield positive results. Doctors of the ambulance stated the death of the convict," the prison service said, adding that causes of death were being established. Putin has been told about Navalny's death, Kremlin spokesman Dmitry Peskov said. Putin, who is running for reelection in a month, was shown on a television clip visiting a factory in the Urals. Supporters of Navalny said

they could not confirm he was dead, but that if he was then they believed he had been killed.

"Russian authorities publish a confession that they killed Alexei Navalny in prison," Navalny aide Leonid Volkov

Navalny's lawyer was on his way to the 'Polar Wolf' prison in Kharp where Navalny died. Russian state television showed a press conference by the central bank. Russian newspaper editor and Nobel Peace Prize laureate Dmitry Muratov told Reuters Friday the death of jailed opposition leader Alexei Navalny was 'murder', and said that he believed harsh treatment had led to his demise

In an interview in Moscow in 2011, Navalny was asked by Reuters if he was afraid of challenging Putin's system.

"That's the difference between me and you: you are afraid and I am not afraid," he said. "I realize there is danger, but why should I be afraid?'

New Delhi, Feb 16: A 280-million-year-old fossil, classified as a member of the reptile group, that has baffled scientists for decades may have been partly forged, according to new examination of the remnants. The discovery, published in

the journal Palaeontology, has led the team to urge caution in how the fossil is used in future research. Tridentinosaurus antiquus was discovered in the Italian Alps in 1931 and was thought to be an important specimen for understanding early reptile evolution.

Its body outline, appearing dark against the surrounding rock, was initially interpreted as



preserved soft tissues. This led to its classification as a member of the reptile group Protorosauria.

However, the new research reveals that the fossil renowned for

its remarkable preservation is mostly just black paint on a carved lizard-shaped rock surface. The purported fossilised skin had been celebrated in articles and books but never studied in

detail. The somewhat strange preservation of the fossil had left many experts uncertain about what group of reptiles this strange lizard-like animal belonged to and more generally its geological history.

'Fossil soft tissues are rare, but when found in a fossil they can reveal important biological information, for instance, the external colouration, internal anatomy and physiology," said Valentina Rossi of University College Cork, Ireland (UCC).

"The answer to all our questions was right in front of us, we had to study this fossil specimen in details to reveal its secrets - even those that perhaps we did not want to know," Rossi said. The microscopic analysis showed that the texture and composition of the material did not match that of genuine fossilised soft tissues

Preliminary investigation using ultraviolet (UV) photography revealed that the entirety of the specimen was treated with some sort of coating material, the researchers said.

Coating fossils with varnishes or lacquers was the norm in the past and sometimes is still necessary to preserve a fossil spec- ২ imen in museum cabinets and exhibits, they said.

However, the fossil is not a complete fake. The bones of the hindlimbs, in particular, the femurs seem genuine, althoughpoorly preserved, the researchers said.







Mahanga double murder: **HC** judge recuses from hearing

Cuttack: In significant development, a Orissa High Court judge, hearing a criminal review petition filed by MLA Pratap Jena in connection with sensational Mahanga double murder, recused himself from the case, Friday. However, the court restored the interim protection granted to Jena. High Court sources said that following the development, the Chief Justice is likely to transfer the hearing to another division bench after scheduling the case. On October 31, Jena had filed a criminal revision petition in the High Court challenging the Salipur JMFC Court's summons for personal appearance in connection with the double murder case During hearing, the High Court had issued notices to the state government and Ranjit Baral, respondents to the petition, November 2. Along with that, the High Court had summoned records from the lower court while passing an interim order prohibiting any coercive action against the MLA. It may be recalled, BJP leader Kulamani Baral and his associate Dibyasingh Baral were brutally murdered in Mahanga January 2, 2021. Following the double murder, complaints of the involvement of Jena. a minister then, had been made. The local police had reportedly dropped Jena's name from the FIR. Jena had failed to appear before the lower court despite directions to that effect.

Bhubaneswar, Feb 16: State government's historic rural-tourban connectivity scheme. Location Accessible Multimodal Initiative (LAccMI), now covers 20 districts with Chief Minister Naveen Patnaik launching the affordable bus service in six more districts – Khurda, Puri, Kendrapara, Bhadrak, Jajpur and Nayagarh, Thursday.

As many as 238 buses will connect 1,363 gram panchayats of the six districts, benefitting over 60 lakh people.

In Khurda, a fleet of 28 buses (22 non-AC and six AC) will enhance connectivity across 154 gram panchayats. Over 15 lakh people of the region will be benefitted from the affordable bus service.

As many as 54 buses (44 non-AC and 10 AC) will improve connectivity across 433 gram panchayats of Puri – the abode of Lord Jagannath and one of the biggest tourist destinations of eastern India, benefitting over

14 lakh people of the region. In a boost to Kendrapara's connectivity, a fleet of 43 LAccMI buses (35 non-AC and eight AC) will improve road communication across 196 gram panchayats. The state government's move will benefit at least 11

lakh people of the region. In Bhadrak, a fleet of 31 buses (25 non-AC and six AC) will improve connectivity across 158 gram panchayats, benefitting over 15 lakh people of the district.

A fleet of 46 buses (37 non-AC and none AC) will boost the connectivity across 233 gram

panchayats in Jajpur. In Nayagarh, 29 non-AC buses and seven with AC will connect 189 gram panchayats. State government's affordable bus service will benefit over 20 lakh people in both the districts. On February 12, Patnaik

launched the affordable bus service in Mayurbhanj, Bolangir, Bargarh, Keonjhar and Sundargarh districts. As many as 425 buses will ply on different routes in 1,457 panchayats, benefitting more than 90 lakh people in these districts.

The affordable bus service was first launched in Malkangiri district on October 12, 2023. It was later extended to Gajapati district (October 20), Kalahandi district (November 1), Rayagada district (November 25), Nabarangpur district (November 30), Koraput dis district trict (December 14).

The services were further extended to Deogarh, Angul and Dhenkanal districts January 31

KHANDAGIRI TRIPLE MURDER CASE

Life term for Sneha Swakhyar POST NEWS NETWORK

Bhubaneswar, Feb 16: Ten years after the chilling triple murder of a doctor, his assistant and the latter's minor son in Khandagiri area sent shockwaves across the state, the

District and Sessions Court here Friday sentenced the solitary accused to rigorous imprisonment for life.

Judge Debasis Rout also slapped a fine of ₹10,000 on convict Sneha Swakhyar Samal who will have to undergo one year additional sentence on failure to furnish the amount.

The incident dates back to October 14, 2014, when Samal, a medicine representative by profession, walked into the house of the victim, Atulya Meher, an orthopedic surgeon, and stabbed him and two more including his caretaker Prashant Chandra Behera and the latter's minor son Munu, to death.

Bhubaneswar, Feb 16: The annual Plus-II examinations, conducted by Council of Higher Secondary Education (CHSE), Odisha commenced across the state Friday, an official said.

A total of 3,84,597 students in Arts, Science and Commerce streams are appearing for the exams, which began at 10am.

Docs treat man with 5 in 1mn heart disease

Mumbai, Feb 16: A team of doctors here achieved a remarkable breakthrough in treating a 35year-old man with an extremely rare heart disease that occurs in only 5 in 1,000,000 people in Asia.

The patient, Raj Gorsa, a bank employee, was brought to Jaslok Hospital & Research Centre in Mumbai after experiencing unusual symptoms such as chest pain, severe palpitations, and blackouts while working, November 10, last year.

After a series of tests, doctors identified that Raj had recurrent ventricular tachycardia -a potentially dangerous cardiac rhythm disorder.

As initial attempts with medications did not improve Raj's condition, the doctors resorted to automated implantable cardioverter defibrillator (AICD) implantation.

Further investigations by cardiac MRI and PET scan and biopsy of his neck node revealed he suffered from a combination of cardiac tuberculosis (TB) -- a common respiratory problem that rarely affects the heart -and cardiac sarcoidosis -- a rare inflammatory illness that affects the heart muscle.

The patient did not have any

previous history of tuberculosis. In a hospital statement, the doctors stated that the prevalence of cardiac sarcoidosis and tuberculosis simultaneously in Asians is five in one million cases.

They noted that the condition can be a frequently missed diagnosis given its rarity and the high index of suspicion needed to make the diagnosis.

"Myocardial tuberculosis is an exceptionally rare form of extrapulmonary TB with few cases reported world-wide. Sarcoidosis (CS) is a multisystem granulomatous inflammatory disease with formation of non-caseating granulomas (lumps of proteins) of unknown aetiology," said Dr Rahul Chhabria, the Primary Cardiologist, in the statement.

"Sarcoidosis is a rare heart disease that results from the immune system to overreact causing lumps of tissues (granulomas) in the heart muscle. Primary treatment for cardiac sarcoidosis is immunosuppression with corticosteroids with the goal of reducing inflammation and fibrosis, thereby preventing disease progression. Tuberculous Myocarditis is treated with a combination of four anti-TB drugs to achieve disease control. Raj was started on steroids and anti-TB drug treatment," the doctor explained.

RUINS OF ANCIENT BUDDHIST SITE DISCOVERED IN CUTTACK

Bhubaneswar, Feb 16: Remnants of a Buddhist site dating back to the 9th century CE were discovered near Ganeswarpur village of Cuttack district by the Indian National Trust for Art and Cultural Heritage (INTACH) team recently

The site, scattered with Buddhist archaeological remains, was found near a small mound inside a rice field at far end of the village. A five-member team from INTACH's Odisha chapter visited the site located just 150 metres away from the Birupa

embankment to conduct a preliminary survey and document the archaeological remains.

According to Deepak Kumar Nayak, co-convenor of INTACH's Cuttack Chapter, the present and ancient floodplains of the Birupa River are dotted with numerous Buddhist sites on both banks. The discovery of a large headless Abalokiteswar image, nearly six feet in height, on the ground near a small grassy mound is of historic significance, he said.

"Although the head is missing, the iconography closely matches the Abalokiteswar images found at the nearby



Buddhist sites of Ratnagiri, Udayagiri, and Lalitgiri," Nayak said. The excavated Buddhist stupa in the nearby Rameswar village is situated across the river, where the images are now

being worshipped by the villagers as Hanumancheswara Mahadev.

INTACH team member Biswajit Mohanty speculated about the existence of a Buddhist stupa, which had these large images and was buried under the silt due to frequent flooding of the Birupa River. The disfigured images lying at the site and a small shrine are also indicative of destruction by invaders during the Afghan-Mughal period, he added.

Mohanty said that two temples in the village, such as Panchapandavar Temple and Tareswara Temple, were demolished during Kalapahada's invasion in the 16th century CE. 'The remains of the base of a temple and many odd-shaped kiln-baked bricks suggest that either a temple or a stupa is buried in the mound," Mohanty said. The INTACH team has also discovered a large number of broken potsherds, which include both red and blackware.

The INTACH Cuttack chapter has sought help of the ASI, the State Archaeology Department, and the Culture Directorate of the Odisha government to dispatch experts to the spot for further detailed surveys of the ancient site.


Youth stabbed to death



Meanwhile, BJP is going to throw in all its might to wrest this seat from Congress and at the same time deny BJD of a possible victory. The saffron party, which was a close third in the 2019 elections, has reasons to sound confident given the voting pattern and number of votes the party pooled in the previous polls and the present religious fervour in people's mind.

"The difference is not very big for us. This time we are confident that Rajgangpur will be ours," said BJP state spokesperson Dhiren Senapaty.

Even today, saffron is the dominant colour in the skyline of Raigangpur. The flags of Lord Ram, hoisted January 22, are yet to be brought down. The city has a very strong trader base dominated by Marwaris along with Odias. In addition, the city has past records of severe communal tension.

The party is confident about the sizeable Hindu and small Sikh, Jain and other voters. However, infighting may prove detrimental for BJP because of the sheer numbers of the aspirants. Apart from 2019 candidate Minz, there are a couple of others interested in the party ticket. Another name in the front is Upendra Pradhan. He was given a party ticket on two occasions and he lost. However, he is quite active at constituency level nowadays. Apart from these two, Mahendra Majhi, a long time cadre of the party, and Santosh Tirkey, who is an Oram and has age to his favour, are in the race for the saffron ticket.

2 minor girls drown in Balimela reservoir

Malkangiri/Chitrakonda, Feb **16:** In a tragic incident, two minor girls from Kenduguda village under Nakamamudi panchayat and Korukonda block in Malkangiri district drowned in

the Balimela reservoir Thursday. The bodies of the deceased girls, identified as Sabitri Muduli, 7, daughter of Saniya Muduli and Dabili Kadangia, 7, daughter of Dhanu Kadangia of Kenduguda village, were recovered Friday.

According to reports, the deceased duo along with two other minor girls of the village had gone to the Balimela reservoir to take a bath Thursday afternoon. While bathing, Sabitri and Dabili

went missing in the deep water. The villagers then launched a search operation in the reservoir but could not trace the missing girls. The family members of the missing girls then informed the police and Fire brigade at Chitrakonda.

Chitrakonda police along with the Fire personnel reached the spot Friday morning and after launching a search operation along with the villagers, the bodies of the two missing girls were fished out of the reservoir and sent for post-mortem. Police registered a case of unnatural death and handed over the bodies of the deceased girls to their family members. A pall of gloom prevailed on the locality after the tragedy occurred.

BBMCH newborn lost with mom, paramour

Kendrapara, Feb 16: The National Human Rights Commission (NHRC) has issued a summons to the Puri District Magistrate (DM) to appear before it March 18 in connection with the death of a transgender inside Srimandir.

The District Collector was asked to appear before the commission along with the requisite additional report relating to the death of a 36-year-old transgender who fell from 30foot high 'Gumuta' of the shrine May 1, 2022.

The commission in its direction February 12 said if the requisite reports are received on or before March 11 then the personal appearance of the Collector will be dispensed with.

The order was issued acting on a petition filed by human rights defender Radhakanta Tripathy.

Tripathy in his petition stated that transgender Balaram Rout of Nimapara, deprived of many social welfare schemes of the State,



jumped from the 'Gumuta' of the famous Puri shrine May 1, 2022.

He alleged that the fatal incident happened due to the failure and negligence of police and inaction on the part of the Social Justice department and temple administration which amounts to a serious violation of human rights. The commission observed that the matter is pending for want of additional report in

light of the comment of the complainant wherein he made a submission that the deceased could not ensure social welfare schemes of the State and the next kin of the deceased has not received

any compensation/ex-gratia/rehabilitation. A request was further made to seek a compliance report on preventive, punitive, welfare, and

compensatory measures for

transgenders living in the state in the interest of justice and human rights. A reminder was issued to Puri District Magistrate August 25, 2023 for the filing of additional report in light of the

complainant's comments. But no additional report was sent forcing the commission to issue a final reminder to the DM for submission of the requisite report within four weeks failing which the commission would be constrained to invoke its coercive power u/s 13 of the PHR Act, 1993 calling for the personal appearance of the authority con-

cerned before the commission. The commission observed that despite the direction/reminders. the Puri DM failed to submit any report even to date.

Taking a serious view of the same, the commission directed its registry to issue a summons to Puri DM u/s 13 of the Protection of Human Rights Act, 1993 for appearance before the commission March 18 next along with requisite additional report on the matter.

Bolangir; Feb 16: A newborn boy allegedly went missing from the special newborn care unit (SNCU) of the Bhima Bhoi Medical College and Hospital (BBMCH) here Fridav and was later found and brought back to the hospital after 12 hours.

As per reports, Sushil Swain of Budhipadar village under Kantamal block in Boudh district had admitted his wife Jhumki to the Obstetrics and Gynaecology department of the BBMCH, Thursday. She gave birth to a boy Friday morning. As the newborn was underweight, he was admitted to the SNCU.

However, later the family members came to know that the infant was missing. Along with a voluntary organisation from Bolangir; they staged a sit-in protest questioning the safety of infants in the hospital and alleging that the child has been stolen.

The worried family members then lodged a complaint at the police outpost at the BBMCH in this regard. However, after about 12 hours the Town police recovered the boy from another couple at Sahajapita village near Kachermal forest under Kantamal police limits in Boudh district and brought him back to BBMCH around 9pm Friday.

However, neither the hospital authorities nor the police revealed any details. As per sources, the Child Welfare Committee is investigating the matter. Tension was palpable on the hospital premises with people demanding to know if the child was swapped or the hospital authorities were covering the matter to hide their goof-up.

Science park, planetarium await completion

Rourkela, Feb 16: The under-construction Science Park and Planetarium at Kalinga Vihar of Chhend Colony has been marred by inordinate delays. The project has two components -- a natural science park and a planetarium -- and both have jumped the deadline over 20 months back.

It was just before the election in 2019 that Chief Minister Naveen Patnaik laid the foundation stone for the park being built on 7.49 acre land. The construction started in 2021 by Rourkela Municipal Corporation (RMC)

The science park is being built at a cost of ₹8 crore, while the

cost of ₹19.70 crore. The science park, which will have exhibits of natural sciences like Newton's laws of gravity and the atomic structure along with statues of animals and birds such as dinosaur, elephant, pelican depicting their habits and habitat. Apart from a few structures of the animals, there is a pathway that has come up at the construction site. But nothing has yet been mentioned about the animals, their hunting habits and habitats in the park.

planetarium is coming up at a

Meanwhile, work on the boating lagoon has been completed. The pathway is being used by fitness enthusiasts for jogging and



morning walks. When the sun goes down, the park gets covered with darkness. Fortunately, it is vet to become a happy hunting ground for the anti-socials because it is surrounded on one side by a private management institute and on the other by busy roads. The market complex situated in front of the park is not ready yet to run businesses.

"I am sure people will visit the complex, which will have mostly eateries even if the park project is getting delayed. But the administration is not looking at this," said one of the shop owners.

Work on the planetarium began April 29, 2019 and was scheduled to be over by July 28, 2022. However, at this moment only the building stands and the entrance to the park awaits completion.

When this was brought to the notice of the Rourkela ADM Ashutosh Kulkarni, he said, "I will speak to the concerned department authorities and will find out the actual reasons for the delay. Once I get to know everything, I will take the necessary steps to complete it.'

The 'Paper' Wars

The white papers and the black papers on the economy have sent a lot of bureaucrats scurrying around for data. Everybody recognizes that these papers are almost political weaponizing of data figures. Still, at the moment, both former bureaucrats and current bureaucrats are locked in an almost death-like struggle to thread out new figures that can justify the policy measures that they had initiated during their terms in office.

Amid this struggle, there came an extremely erudite data stream from ex-Tamil Nadu finance minister and current DMK IT minister P. Thiaga Rajan, hailed by some as a financial statesman, who was able to show how the Dravidian model has outdone the Gujarat model and any national model, especially the current flavour, the Uttar Pradesh model, as far as economic growth and its benefits are concerned.

Rajan argues that the UP model is more a chimaera than a fact even with the continuous net transfer of tax revenues from better-off states such as Tamil Nadu to less developed Uttar Pradesh. He showed data that at an accelerated growth rate that is 2 per cent higher than Tamil Nadu's every year, it would still take 64 years for Uttar Pradesh's per capita net SDP to catch up with Tamil Nadu's!

But for the babus at the Centre, the UP success story is a great narrative to run with as we head into the poll season. Why let reality interfere with a dream?

Navigating Nexus

Serving and retired IAS officers, retired IPS and IFS officers, district judges and officials working in various departments are among the 370 people who have applied for the six posts of information commissioners in Karnataka.

The government issued a notification to fill six posts of information commissioners - five in Bengaluru and one in Belagavi in November. Among the applicants are IAS officers Mamata



BR and Richard Vincent D'Souza, and retired IAS, IPS, IFS officers AB Ibrahim, B Balagopal, Allappa R, M G Hiremath, Ashit Mohan Prasad. KT Balakrishna, M V Amaranath and Rajeev Ranjan. The list also has four district judges, over 30 retired officials who served in posts ranging from directors to joint secretary and first division assistants.

With a diverse pool of candidates, the process appears to be teeming with potential. However, beneath the surface lies a contentious issue that has plagued such appointments for years - the influence of political connections over meritocracy.

An activist who has revealed lapses in several departments through RTI said successive governments have ignored the basic principles during selection. Instances where individuals with dubious records or questionable integrity have been appointed to such positions undermine the very essence of transparency and erode public trust in institutions. The ramifications of such appointments are dire. How will Karnataka decide?

Mohan Yadav signals change in Madhya Pradesh

The winds of change are sweeping through the administrative corridors of Madhya Pradesh as new Chief Minister Mohan Yadav is moving quickly to assemble his core team of officers. Yadav's proactive approach hints at a shift in the state's governance dynamics, and an attempt, undoubtedly in close consultation with the Centre, to leave the legacy of his predecessor Shivraj Singh Chouhan behind.

In recent weeks, we've witnessed a flurry of appointments and reallocations, with senior babus, emblematic of Chouhan's tenure, gracefully stepping aside to make room for fresh faces and new perspectives. Sandeep Yadav's appointment as Commissioner of Public Relations and Sameer Yadav's assignment as the head of the CM's security, underscore the new CM's intent to infuse vigour and competence into critical positions. Additionally, the elevation of Raghuvendra Singh to the role of Principal Secretary in the Chief Minister's Office reflects a strategic move to blend experience with innovation. Others in the new team include Bharat Taday, Avinash Lavania, Chandrashekhar Walimbe, Aditi Garg and Anshul Gupta.

GOVT MUST LISTEN armers are protesting in

an election year all over the world. The day the Indian farmers were made to face severe assault on February 13 and the roads to Delhi were blocked with concrete walls, barbed wire and spikes; farmers in Brussels clogged streets, with 1300 tractors, leading to Paris pressing for fairer deals almost akin to their Indian brethren. They did not face any hostility anywhere, though agriculture according to Bloomsberg, has become a kev battleground in a wider culture war over money, food and climate change.

The list of "grievances long - soaring costs, increasing bureaucracy, new European Union regulations in its Green Deal and imports diluting their markets". A placard says: "He who sows misery reaps anger". What an irony! These farmers are agitating as the European Union goes to the polls. The government listens to them without accusing them of politicking.

Indian farmers in Punjab, Haryana and Uttar Pradesh travelling to Delhi on tractors with supplies for a long sit-in, have demands that are similar to the French farmers. Their placard says, India must quit WTO along with their demands for a guaranteed minimum support price (MSP), implying that the market must ensure fair prices, food, and sustainable farming. While Indian farmers are labelled as being "supported by Pakistan, Khalistanis, and other anti-country forces", the farmers in Paris are patiently heard by their government, and they put off protests.

The contrast is sharp. The government of Haryana blocked their roads at Puniab border. fired tear gas shells, lobbed shells from drones. They are alleged to be provoked by the opposition parties, AAP and

Congress in particular.

Among the 70 countries going to polls, is the EU, India and the US. In France, the farmers complain that politicians only want to get elected, so they are latching onto the farmers' movement. Most politicians and parties keep off them. Even Congress's Black Paper on the Economy only cursorily mentions them

The Manmohanomics of the Congress party is responsible for the beginning of corporatisation of farming, an aim of the International Monetary Fund and World Bank. Their successor government has been following the Manmohanomics and only aggravated the issues of marketing.

During the past few years, many long marches have been held by farmers even during UPA government, as also long dharnas during the NDA, as along Delhi borders with Haryana and UP in 2022. The similarities are stark. In Europe, farmers have been holding protests in Italy, Spain, Switzerland and Romania. Polish farmers have vociferously opposed food grain arriving from neighbouring Ukraine and forced the government to negotiate.

Indian farmers, so far, did not even protest petrol and diesel prices that are almost double that of international crude prices. They even did not protest against auto-lobby-NGT sponsored illegal seizures of their tenyear-new cars and tractors, for which they paid EMIs for seven years. They suffered takeover of their land for building of roads for irrationally high tolls. Climate issues for grain, horticulture or fish farmers are wrecking them.

Climate change is a big issue for European and US farmers. Though the governments there may not be that intent on the issues, they are not hostile. A US retired diplomat Hegadorn is quoted as saying, "You can live without an electric car, you can live without a mobile phone, but you're not going to live without farmers and the food they produce". Sensible approach in a country that has only a miniscule percentage left as farmers. Corporatisation of agriculture has neither helped the farming community in Europe nor in

the US. In contrast, India has over 54 per cent left in agriculture or over 75 crore people. Since the last farmers' agitation two years

ago and the withdrawal of three supposedly anti-farmer laws, the government has continued with the Manmohanomics and heaped miseries on the farm ers. It should not be obsessed with the factor that they are agitating during election time. The world over it is so.

The farmers are being neglected and overlooked in policy framing from the richest US and European countries to the poorest India, Pakistan and Bangladesh. In all these countries while corporate profits swell, farmers wages remain stagnant for decades. Their input costs on seed, fertilisers, machines or pesticides multiplied everywhere.

Economic Survey of 2016 says farmers income was Rs 1700 a month. This as per National Statistical Office was Rs 10218 a year or about Rs 2000 a month as per Rajya Sabha statement in December 2022. Market-linking of agriculture or corporatisation in the prevailing circumstances has failed in the affluent countries. In the US, farmers complain they are being priced out by big companies.

Those advising in India that it could be a success are apparently misleading policy planners. More sensitivity is required. Farmers the world over are agitating not because there are elections, they want patient hearing for solving the global crisis.

Delhi belongs to all countrymen. The government should invite the farmers with open arms and not with spiked roads. If attended, it is easy to solve as promising guaranteed MSP would not burden the exchequer with more than Rs 2.5 lakh crore (trillion) of additional expenses, which the government agencies recover as they sell the food grains. Listening in any regime is an asset.

Middle-class rage against military rule

February 8, marred by allegations of widespread voting irregularities, resulted in a hung parliament and the regions long considered bastions formation of a coalition gov- of military support? ernment consisting of the country's two major dynastic parties. Nevertheless, the outcome represents a stunning defeat for the country's powerful military, as candidates backed by the imprisoned former Prime Minister Îmran Khan's Tehreek-e-Insaf Party (PTI) secured more parliamentary seats than any other political bloc. Although PTI did not win enough seats to form a government on its own, its unexpectedly strong performance underscores Khan's popular appeal. In the run-up to the vote. PTI members and supporters have faced imprisonment, harassment, and the destruction of their businesses. On Election Day itself. cellular services were disabled in a last-ditch effort to disrupt turnout efforts. But despite these obstacles, Pakistani voters delivered a historic blow to the militarv. More than a competition between political parties, the Pakistani election represented a confrontation between those who oppose the military's increasingly blatant political meddling and those who collaborate with it to gain personal and professional benefits. But the out-

akistan's general election come raises an important question: Why has the regime encountered such widespread opposition now, particularly in

To be sure, PTI's str

the past two decades, with universities sprouting even in remote areas, facilitated by the support of the country's Higher Education Commission. While the quality of the education offered by these institutions is questionable, the surge in enrollment has given rise to what can be described as an "aspirational" middle class. Despite their lack of stable incomes, these households share the same dreams and ambitions as their middle-class counterparts. However, the section is grap pling not only with diminishing economic prospects but also with political repression. Once dismissed as a "chattering class" who preferred watching soap operas at home instead of voting, middle-class Pakistanis have become more politically engaged and now form the backbone of PTI's base. As the military intensified its crackdown on Khan's middle-class supporters-many of whom are women-the opposition has become more determined, largely owing to the enthusiasm of Pakistan's tech-savvy youth. Moreover, social media has emerged as a powerful tool for mobilizing voters. Following a controversial Supreme Court decision that prohibited Khan's party from using its traditional cricket-bat symbol, supporters flocked to social media to disseminate information about the new symbols assigned to PTI-

backed candidates.

In a country where rural politics has historically revolved around kinship networks and patronage systems, social media has made it possible for national issues to take precedence over parochial concerns. The longstanding notion that rural vote brokers could secure the support of entire clans is becoming obsolete. This shift severely impedes the military's ability to control politics through local notables. But while the results offer a glimmer of hope, Pakistan's postelection landscape is marked by a volatile combination of diminishing resources, a growing number of stakeholders, and an authoritarian elite unwilling to make any concessions. In the absence of institutional channels to resolve political disputes, conflicts are bound to be settled through violence. Therefore, it's time Pakistan's foreign partners used their influence to prevent further instability. Those who control the purse should press the military to loosen its economic and political grip on the country.

Sudhir Saxena signals an imminent reshuffle of IPS officers as well, sources have told DKB. With change comes opportunity, and Yadav's administration appears determined to capitalize on it.

Sir, The Supreme Court ruling the electoral bond scheme as 'unconstitutional' is most welcome, and the verdict is a slap on the face of the ruling BJP, as the scheme was introduced by the Narendra Modi government in 2018, which is a turbid affair. Political funding only helps big corporates, and it tends to placate political patrons through 'donations'. In turn, such donations become a cause for fudging books. To run their organisations and to conduct elections, political parties, especially the BJP, accept huge funds from these corporates, which allows for an inappropriate nexus between the two to emerge and grow. Electoral bonds contravene a citizen's fundamental right to know. Such an unreasonable and irrational restriction on information at the cost of larger public interest goes against the very spirit of our democracy and the rules of the law.

High fluoride found in Delhi's groundwater **GREEN COVER**



New Delhi, Feb 16: Groundwater samples collected from 58 tubewells in Delhi exceed permissible fluoride limits, according to a report submitted by the Delhi government to the National Green Tribunal (NGT).

The report said that the Delhi Jal Board (DJB) collected groundwater samples from 1,256 tubewells across the national capital following directions from the NGT

Union Minister of State for Jal Shakti, Bishweswar Tudu, informed the Rajya Sabha December 4 last year that arsenic had been detected in groundwater in parts of 230 districts in 25 states, and fluoride in 469 districts in 27 states.

Fluoride found in groundwater occurs naturally due to the breakdown of rocks and soils, weathering, and dep osition of atmospheric particles. Most fluorides are sparingly soluble and present in groundwater in small amounts.

Guj govt plans to develop open jungle safari in Barda sanctuary

Gandhinagar, Feb 16: An open jungle safari will be developed at Barda Wildlife Sanctuary in Gujarat's Porbandar district, state tourism minister Mulu Bera said Friday.

He was replying to a question in the Assembly from Congress leader Arjun Modhwadia regarding development of tourism in Porbandar.

"The state government plans to develop an open jungle safari at Barda Wildlife Sanctuary, which at present has four to five lions. More lions will be introduced. Several other animals, including sambhar, are present there," Bera said.

A proposal to develop 'Gandhi corridor' in Porbandar, the birthplace of the Father of the Nation. has also been sought from the col lector, while tenders have been issued to develop Mokarsagar lake there as an iconic tourist spot, he informed the House.

As per a document titled 'Project Lion: Lion @47 vision for Amrutkal,' Barda Wildlife Sanctuary, located near the coastal city of Porbandar and 100 kilometres from the Gir National Park, was identified as a potential second home for Asiatic lions.

Efforts have been underway since the 1990s to find a relocation site for the big cats within Gujarat.

Defence projects worth ₹84,560 crore cleared

Law panel suggests rules for **NRIs marrying Indian citizens**

New Delhi, Feb 16: Describing as a "worrisome trend" the "rising" cases of fraudulent marriages between NRIs and Indian citizens, the Law Commission has recommended a comprehensive law to deal with the situation and compulsory registration of such alliances.

While presenting the report "Law on Matrimonial Issues Relating to Non-Resident Indians and Overseas Citizens of India" to the law ministry, panel chairman Justice (Retd) Ritu Rai Awasthi said the commission is of the opinion that the proposed central legislation should be comprehensive enough to cater to all facets involving marriages of NRIs as well as foreign citizens of Indian origin with that of Indian citizens.

"The rising occurrence of fraudulent marriages involving Non-Resident Indians (NRIs) marrying Indian partners is a worrisome trend. Several reports highlight an increasing pattern where these marriages turn out to be deceptive, putting Indian spouses, especially women, in precarious situations." Justice Awasthi said in his covering letter to Law Minister Arjun Ram Meghwal Thursday.

Such a legislation, the panel said, should be made applicable not only to the NRIs but also to those individuals who come within the definition of 'Overseas Citizens of India' (OCIs) as laid down in the Citizenship Act, 1955.

1 in 5 cities under NCAP lacks real-time pollution data: Report **IED** explosion

New Delhi, Feb 16: One in five cities covered under India's National Clean Air Programme does not have a continuous ambient air quality monitoring station (CAAQMS), according to a new analysis.

The report by the independent research organisation Centre for Research on Energy and

Clean Air (CREA) also said that Delhi was the most polluted city in the country in January with a monthly average PM2.5 concentration of 206 micrograms per cubic metre, surpassing the daily National Ambient Air Quality Standards (NAAQS) each day of the month.

The daily average permissible limit (or NAAQS) for PM2.5 and PM10 is 60 micrograms per cubic



metre and 100 micrograms per cubic metre, respectively. Among India's top 10 polluted cities in

January, two were in Bihar, two in Rajasthan, two in Uttar Pradesh, one in Assam, one in

Haryana, and one in Himachal Pradesh.

The analysis by CREA showed that only 101 of the 131 cities covered under the NCAP have a CAAQMS installed as of January 2024, leaving 30 other cities without any transparent information on real-time pollution levels.

The 30 cities which do not have a CAAQMS include Ranchi, Jammu, Guntur, Nellore, Jammu, Vadodara, Madurai, and Raebareli, among others. The NCAP, initiated in 2019, aims for a 20-30 percent reduction in PM2.5 and PM10 concentrations by 2024 in 131 cities that had not met prescribed air quality standards from 2011 to 2015.

The government has now set

a new target of achieving a 40 percent reduction in particulate matter concentration in these cities by 2026."The combination of low wind speed and cooler temperatures in northern India led to the formation of stable atmospheric conditions, hindering the rapid dispersion of emissions and resulting in the accumulation of pollutants near the ground, elevating ambient air pollution levels," said Sunil Dahiya, analyst at CREA.

"While natural atmospheric conditions are beyond human control, it is the baseline emissions that primarily contribute to the escalation of hazardous air pollution levels in any region," — Dahiya said.

Curious deaths of Putin critics

THE PAST FEW YEARS. THE DEATHS OR ATTEMPTED MURDERS OF PUTIN'S OPPONENTS UNDER MYSTERIOUS CIRCUMSTANCES HAVE ATTRACTED ATTENTION

lexei Navalny has become the latest in a string of deaths of critics of Russian President Vladimir Putin. Navalny, who was serving a 19-year sentence on charges of extremism, felt unwell after a walk, according to the Federal Penitentiary Service, and lost consciousness.

An ambulance arrived to try to revive him, but he died. It said the cause of death was "being established."

Over his more than two decades at the top of the Kremlin, a number of Putin's opponents have suffered unfortunate fates including being jailed, shot dead in the street, or poisoned with tea spiked with polonium-210.

In the shadowy world of Russian politics, Opposition to President Vladimir Putin often comes with a steep price - a price paid with the ultimate currency of life itself. In a chilling pattern that seems straight out of a spy novel, critics of Putin have been dropping like flies, their voices silenced by imprisonment, assassination, or poisoning. Alexei Navalny has become the latest in a string of deaths of critics of Putin.

From accidental falls from windows to hangings, poisonings and health issues, the fates of some of those who dared to challenge the Kremlin are myriad.

Alexei Navalny

Born to factory owners in a village west of Moscow, Alexei Navalny grew to become perhaps the highest-profile critic of Putin's time in power. His political activism, including extensive investigations into high-level corruption and running to be mayor of Moscow, gained him fame - and many believed he posed a threat to Mr Putin. It was in August 2020 when his fight against the Russian President hit the global headlines. German medics confirmed that he had been poisoned with novichok a Soviet-era nerve agent - and his recovery took months. Despite the danger, Navalny elected to return to Russia where he was



motivated, and sent to a Russian penal colony.

Yevgeny Prigozhin

Whether or not Yevgeny Prigozhin, the head of the Wagner Group mercenaries. had indeed died in August 2023 when his plane crashed in the Tver region of Russia was initially unclear — though his name appeared on the passenger list for the flight. But Russian authorities said four days after the crash that DNA tests had confirmed that he was one of the 10 passengers who perished.

Anna Politkovskaya

On 7 October 2006, Putin's birthday - journalist Anna Politkovskaya was shot in the lobby of her apartment building. Before her death, she had specialised in investigating human rights abuses in Chechnya and corruption more broadly. Her killing led to claims that Putin had not done enough to protect the media.

Boris Nemtsov

A former deputy Prime Minister of Russia under

member of the State Duma and former colonel in the Soviet army, Yushenkov was shot several times outside his apartment building. He had been involved in setting up the Liberal Russia Party, which had achieved full registration just hours before he was killed.

Sergei Skripal

Formerly a colonel with Russian military intelligence before leaving in 1999, Sergei Skripal went on to work at the country's Foreign Ministry until 2003. He was arrested in Moscow a vear later and confessed to having been recruited by British intelligence in 1995. In 2018, along with his daughter, he was poisoned with the nerve agent novichok but the pair survived the attack.

Denis Voronenkov

A former Russian politician, Denis Voronenkov was an outspoken critic of Putin. Previously a member of the communist faction in the lower house of Russian Parliament, Voronenkov fled to Ukraine in

killed in Kyiv in March 2017. Ravil Maganov

The chairman of the board of Russia's second largest oil producer Lukoil, Ravil Maganov had openly criticised the war in Ukraine. In a statement in March 2022, the board called for the "soonest termination of the armed conflict" and expressed "sincere empathy for all victims". It added: "We strongly support a lasting ceasefire and a settlement of problems through serious negotiations and diplomacy." In September that year, 67-year-old Maganov died afterapparently falling from a sixth-floor window at the Central Clinical Hospital in Moscow.

Alexander Litvinenko

A former agent with the Russian FSB security service, Alexander Litvinenko fled Russia and eventually gained British citizenship. He had accused Putin of corruption and also blamed him for the infamous Moscow apartment bombings which Putin, then Prime Minister, had used as a reason to start the Second Chechen War in 1999. Litvinenko died in November 2006, weeks after drinking tea that had been poisoned with polonium-210, a rare and very potent radioactive isotope.

Paul Klebnikov

Investigative journalist, Paul Klebnikov, an American of Russian descent, was killed outside his office in a drive-by shooting in Moscow in 2004. He was the editor of Forbes Russia and had written about corruption. *Forbes* had also published a list of the country's richest people.

There are now no Opposition leaders of such prominence left in Russia. For some young urban Russians, Navalny offered hope of an alternative future to Putin, who has served as Russia's paramount leader longer than anyone since Josef Stalin.

Navalny long forecast Russia could face seismic political turmoil because he said Putin built a brittle system of

US President Joe Biden Friday blamed Russian President Vladimir Putin for Alexei Navalny's death, saying he was "not surprised" but "outraged" by the Opposition leader's passing. "It is obvious that he was killed

by Putin," said Ukrainian President Volodymyr Zelenskyy, who was visiting Berlin as he sought aid for his country as it fights off an invasion by Russia. "Putin doesn't care who dies —

only for him to hold his position. This is why he must hold onto nothing. Putin must lose everything and be held responsible for his deeds," Zelenskyy added.

German Chancellor Olaf Scholz, whose country temporarily took in Navalny in 2020 after he was poisoned with a nerve agent, said the Kremlin critic's death makes clear "what kind of regime this is."

Navalny was "brutally murdered by the Kremlin," said Latvian President Edgars Rinkevics in a post on X, formerly Twitter.

"If this is true, then no matter the formal cause the responsibility for the premature death is Vladimir Putin personally, who first gave the green light to the poisoning of Alexei and then put him in prison," said Mikhail Khodorkovsky, an exiled Russia tycoon turned opposition figure in exile, speaking in an online statement. Other Russian Opposition activists echoed him. "If it is confirmed, the death

Dubai, Feb 16: Egypt is building a wall and is levelling land near its border with the Gaza Strip ahead of a planned Israeli offensive targeting the border city of Rafah, satellite images analysed Friday.

Egypt, which has not publicly acknowledged the construction, repeatedly has warned Israel not to forcibly expel the over 1 million Palestinians now displaced in Rafah across the border into its territory while Israeli troops battle the militant group Hamas for a fifth month. However, the preparations on the Egyptian side of the border

in the Sinai Peninsula suggest Cairo is preparing for just that scenario, something that could threatened its 1979 peace deal with Israel that's been a linchpin for regional security.

The Egyptian government did not respond to requests for comment Friday from the AP. The Egyptian Foreign Ministry February 11 issued a statement warning Israel over its possible Rafah offensive and its "displacement of the Palestinian people." The satellite images, taken Thursday by Maxar Technologies, show construction ongoing on the wall, which sits along the Sheikh Zuweid-Rafah Road some 3.5 kilometers (2 miles) west of the border with Gaza.

The images show cranes, trucks and what appear to be precast concrete barriers being set up along the road. Those satellite images

correspond to features seen in a video released by the London-



based Sinai Foundation for Human Rights on February 12. The video shows a crane lifting concrete walls into place along the road

Egypt is building a fortified buffer zone near its border with the Gaza Strip as fears mount of an imminent Israeli ground invasion of the southern city of Rafah, which could displace hundreds of thousands of Palestinians across the frontier

The con-

struction "is intended to create a high-security gated and isolated area near the borders with the Gaza Strip, in preparation for the reception of Palestinian refugees in the case of (a) mass exodus," the foundation said. Nearby as well, construction crews appear to be levelling and



clearing ground for an unknown purpose. That can also be seen in imagery from Planet Labs PBC of the area. The Wall Street Journal, quoting anonymous Egyptian officials, described "an 8-square-mile (20-square-kilometer) walled

enclosure" being built in the area that could accommodate over 1,00,000 people.

Homes and farmland in the area previously had been razed during Egypt's war on an affiliate of the Islamic State group in the area.

Hard-line officials within Israeli Prime Minister Benjamin Netanyahu's government have raised the possibility of pushing Palestinians out of the Gaza Strip, something strongly opposed by Israel's main ally, the United States. The Gaza Strip and the occupied West Bank are lands the Palestinians hope to have for their future state.

The Israeli military referred questions regarding Egypt's construction to Netanvahu's office, which did not respond.

HK cracks its biggest money laundering case

Reacting to the disastrous outcome in two previously



Tory-held seats, the 43-year-old said they were "particularly challenging" by-elections. However, he stressed that the results did not reflect "enthusiasm" for the Opposition Labour Party. "Midterm by-elections are always difficult for incumbent governments, and the circumstances of these by-elections were of course particularly challenging," he told reporters during a trip to Essex.

Gaza hospital runs out of oxygen

Rafah (Gaza Strip): Five patients in intensive care died after their oxygen cut off in southern Gaza's main hospital that was stormed by Israeli troops, causing chaos for hundreds of staff and wounded inside, health officials said Friday. Troops were searching the complex where the military said it believes the remains of hostages abducted by Hamas might be located. The raid came after troops had besieged Nasser Hospital in the southern city of Khan Younis for nearly a



week, with staff, patients and others inside struggling under heavy fire and dwindling supplies, including food and water. The Israeli military said Friday it had detained dozens from the facility, including some it alleged were involved in Hamas' October 7 attack on Israel.

The 30-share BSE Sensex surged 376.26 points or 0.52 per cent to close at 72,426.64. The index touched a high of 72,545.33 and a low of 72,218.10 during intradav trade.

The broader NSE Nifty also climbed 129.95 points or 0.59 per cent to end at points 22,040.70.

"A surge in buying interest for large-cap stocks propelled the Nifty back above the recent consolidation level, leading to the highest-ever closing on the weekly timeframe," said Rupak De, Senior Technical Analyst, LKP Securities.

Wipro was the biggest gainer in the Sensex chart, rising 4.79 per cent, followed by M&M, L&T, Tata Motors, Maruti, Infosys, Nestle India and IndusInd Bank. Shares of M&M shot up 3.96 per

'NTPC signed a non-binding MoU with National Aluminium Company Limited (NALCO) to supply about 1,200 MW or more of round-the-clock uninterrupted power to cater to the requirement of NALCO for its expansion of smelter plant capacity in Angul, Odisha," the statement said. The supply options would include coal-based thermal, solar, wind, energy storage or any combination of the same, it added.

CRC, C-PACE and CPC will ensure speedy processing of applications and forms filed for incorporation, closure and for meeting regulatory requirements so that the companies are incorporated, closed, can alter and raise capital, and are able to complete their various compliances under the corporate laws

with ease, it said. A total of 1,02,063 companies and LLPs were incorporated in FY 2013-14 and the count rose 92 per cent to 1,95,586 in FY 2022-23.

The ministry said that incorporation of companies and LLPs till February 14 of the current financial year has been the highest as compared to any of the previous financial years.

Tech revenue to touch \$254bn this fiscal: Nasscom

THE PROJECTED 3.8% GROWTH IS DESPITE A 50% SLIDE IN TECH SPENDING AND 6% DIP IN TECH CONTRACTS IN 2023 GLOBALLY

Mumbai, Feb 16: The domestic technology industry's revenue is projected to grow 3.8 per cent to \$254 billion this fiscal, industry body Nasscom said Friday and highlighted creation of 60,000 more jobs during this period.

The industry had clocked a revenue of \$244.6 billion in the same period last year, according to Nasscom's annual strategic review report. Excluding hardware, the rev-

enue is expected to touch \$199 billion, a growth of 3.3 per cent over FY23, as per the report. Domestic revenue is estimated to log 5.9 per cent growth at \$54.4 billion from \$51.4 billion in FY23. This means the industry has

added \$9.3 billion incremental revenue in the fiscal, Nasscom said. The growth in the domes-

tic revenue was primarily driven by government and enterprise spending.



Nasscom President Debjani Ghosh said that some of the tailwinds that stood out for the industry last year was the Gulf Cooperation Council (GCC), adding that India continues to be the preferred hub for GCC countries and this is getting even stronger.

"As we see companies, as we see the GCC scope of work moving from just back and work to more of R&D and more of innovation, this is where the India attraction goes up significantly, primarily driven by talent and political stability and ease of doing business," Ghosh added.

The Engineering Research & Development (ERD) sector alone contributed 48 per cent to the total export revenue addition in FY24, Nasscom said.

The ERD sector, she said was

According to Nasscom, while there was a marginal growth in the deal pipeline, the big change

was the change in the deal size, which spiked 70 per cent. She said while there was a lot of talk about job losses in the face of AI, the industry grew in terms of employment.

Despite reports of massive retrenchments, the industry added net 60,000 jobs, taking the total headcount to 5.43 million in the year.

'We hired around 60,000 people in addition to over and above last year. (But) what we are seeing definitely there is a correction because there was also a lot of over hiring done during the Covid years. So we are seeing some level of correction happening which is expected and needed for the industry,' Ghosh stated.

Nasscom said it is seeing the hiring moving towards jobs in AI, data, clouds, cyber security.

'So the frontier technologies 🗎 is where we are seeing the demand growing and the industry is putting a lot of efforts to ensure that we continue to upskill existing workforce," she added. Globally, she said, nearly-6,50,000 employees are being trained on generative AI skills.

Duckett gives England edge

Rajkot, Feb 16: Ben Duckett's power-packed hundred overshadowed R Ashwin's monumental feat as England thrived on their belligerent Bazball tac tic to reach 207/2 at stumps on day two and put India under pressure in the third Test here Friday. Ashwin (1/37) dismissed Zak

Crawlev (15) in the final session to join Anil Kumble as the second Indian, and ninth overall, to take 500 wickets in Test history. But India's struggles to contain England's fearless and enterprising batters persisted as Duckett raced to his third Test hundred (133 batting, 118b, 21x4, 2x6) off only 88 balls.

England have already wiped off a chunk of their first innings deficit and trail India by 238 runs going into day three. India ended up with 445 in their first innings. At one stage, Duckett even flirted

briefly with the prospect of breaking Gilbert Jessop's record from 1902 for fastest Test ton (77 balls) for his country. Duckett peppered India were handed a 5-run penalty for a second offence of their batters running on the middle of the pitch as England started their first innings at 5/0 without even a ball being bowled. India were penalised as a result of all-rounder Ravichandran Ashwin running along the middle of the pitch. Ashwin was reprimanded by on-field umpire Joel Wilson. Earlier, Ravindra Jadeja was also guilty of committing the same offence

the field with powerful strokes all around the ground. Joe Root was at the other end on nine.

Ashwin struck immediately after his introduction into the attack to send Crawley packing, with the batter gift-wrapping his wicket to help the Indian spinner complete his milestone.

On an innocuous delivery from around the wicket, Crawley managed a connection that ballooned towards Rajat Patidar at short fine leg. Patidar only had to make a few paces on his left to grab the ball over his shoulder as each of Ashwin's teammates rushed to celebrate the feat.

The diminutive England opener Duckett, who looked a tad tentative outside the offstump before the tea break, came

nect with the ferocious yorker with the bottom of his bat.

Each of the three DRS reviews per innings would weigh in gold if the pitch continues to be as placid as it has been for the first two days, but this was a review which India would not have mind losing. India took the second DRS against Ollie Pope when Mohammed Siraj, deployed on short-ball tactics, pitched a fuller one to hit the pads.

Umpire Joel Wilson was unmoved but he had to overturn his appeal with the replays confirming that the ball was hitting the leg stump, ending Pope's entertaining stay (39, 55b, 5x4, 1x6).

Ashwin returned for the final over of the day to have one more crack. His fourth delivery turned sharply away from Duckett after pitching on leg and Rohit Sharma collected a catch believing there was an edge.

However, it culminated with replays showing the ball pitching outside leg and missing the bat completely, with India staring at a long third day in the field with only one DRS appeal left.

Earlier in the day, India's lower order did a fair job of collecting as many runs as possible before being bowled out for 445.

Debutant Dhruy Jurel (46 104b, 2x4, 3x6) missed out on a fifty in his maiden outing. The highlight of his knock was an uppercut off Mark Wood's 146 kmph delivery, which sent the ball flying into the stands over a helpless slip cordon.

Jurel partnered with Ashwin (39) to add 77 runs for the eighth wicket which pushed India past the 400-run mark while also steadying the ship after centurion Ravindra Jadeja (112) and Kuldeep Yadav (4) fell early. Bumrah (28) and Siraj (3) did their best in keeping England out on the park for longer with a quick 30-run stand from 42 balls. **BRIEF SCORES**

"Ravichandran Ashwin has withdrawn from the Test squad, effective immediately due to a family medical emergency. In these challenging times, the Board of Control for Cricket in India (BCCI) and the team fully supports Ashwin," BCCI said in a media release.

The Indian Cricket Board did not reveal the exact reason for Ashwin's withdrawal and requested all to respect the cricketer's privacy. "The BCCI extends its heartfelt support to the champion cricketer and his family. The health and well-being of the players and their loved ones are of utmost importance. The Board requests respect for the privacy of Ashwin and his family as they navigate through this challenging time," the statement added further.

Ashwin, who attended the post match media conference to speak on his milestone, flew back to Chennai. "The Board and the team will continue to provide any necessary assistance to Ashwin and will keep the lines of communication open to offer support as needed. Team India appreciates the understanding and empathy of the fans and media during this sensitive period," BCCI secretary Jay Shah was quoted as saying in the release.

India will play the remainder of the third Test with 10 men and four specialist bowlers. It is understood that Ashwin might not be available for the remaining two Test matches in Ranchi (Feb 25-29) and Dharamsala (March 7-11).

Jumbo feat not in Ashwin's mind

Ashwin is a content man after becoming only the second Indian to take 500 Test wickets and has no interest in chasing Anil Kumble's national record of 619 scalps. Ashwin dismissed England opener Zak Crawley in the final session on day two and became only the ninth bowler to scale 'Mount 500' in Test history.

The 37-year-old Ashwin said

Busan (South Korea), Feb 16: Ayhika Mukherjee and Sreeja Akula stunned the world's top two players, Sun Yingsha and Wang Yidi, in their respective singles matches to rattle the mighty China before the Indian women's table tennis team narrowly fell short in the World Team Championships here Friday.

Ranked a lowly 155, Mukherjee played the match of her life to pull off a stunning 12-10, 2-11, 13-11, 11-6 win over World No.1 Sun in the opening singles of the group stage contest. It was the first ever loss for Sun at the team

event of World Championships, summing up the enormity of Ayhika's achievement.

The unexpected win provided a massive boost to Sreeja, who made the day even more memorable for Indian table tennis by blanking World No.2 Wang Yidi in straight games 11-7, 11-9, 13-11 in the third singles.

However, star player Manika Batra losing both her singles and Ayhika going down in the fifth and deciding singles meant India lost the rubber 2-3. Nonetheless, it was a red letter day for the game in India with Avhika and Sreeja doing the uning to a 3-0 win over Hong Kong but their male counterparts failed to replicate the feat, going down narrowly 2-3 to Japan in the quarterfinals here Friday.

After stunning top seeds China to top the group stage, the India women blanked Hong Kong riding on wins from double Olympicmedallist PV Sindhu, Ashmita Chaliha and the doubles pair of

Ashwini Ponappa and Tanisha Crasto. The Indian women shuttlers will now face top seed Japan, who beat China 3-2 in another quarterfinal. The Indian men produced a gal-

lant effort but a nervous Kidambi Srikanth imploded in the end, blowing away a 19-12 lead in the third game of the deciding fifth match as they fell short against a second-string Japan in a tightlycontested quarterfinal.

India had won two bronze medals in men's team event in the 2016 and 2020 editions. Returning from a long injury layoff, Sindhu

For the Indian men, it turned out to be a pulsating contest even though Japan, the 2016 finalists, were without their top players -World No.6 Kodai Naroka and 2021 World Champion doubles pair of Takuro Hoki and Yugo Kobayashi.

HS Prannoy produced yet another spirited fight back as he recovered from 9-19 down in the second game after losing the opener. He even held game points twice but it was not to be as Kento Nishimoto managed to upstage the Indian.

After a 64-minute battle, it was World No.12 Nishimoto, who walked away with a 21-16, 26-24 win to give Japan a 1-0 lead in the five-match rubber.

pair of World No.1 Satwiksairaj Rankireddy and Chirag Shetty then dished out a splendid show to outwit World

MR Ariun and Dhruy Kapila. however, couldn't seal the match, going down 17-21, 15-21 to scratch pair of Akira Koga and Kazuki Shibata as Japan clawed back.

With the tie evenly poised at 2-2, Srikanth was entrusted with the job of taming his nemesis Kento Momota, a two-time former World Champion who has beaten the Indian 13 times in 16 meetings. The odds were against

Srikanth. The Indian put up a determined effort only to blow it away in the end. Srikanth was 16 11 up after a tooth and nail battle and closed out the opening game. After the change of ends, Momota got his act together and dictated the terms in the rallies to roar back into the contest.

In the deciding game, Srikanth recovered from a 0-3 deficit to zoom to a 19-12 lead but then tragedy struck as he made too many mistakes at the net. allowing the Japanese to reel off eight straight points to eventually seal the match.

Bhubaneswar, Feb 16: A lacklustre India survived a mighty scare but eventually beat lowerranked Ireland 1-0 through a Gurjant Singh strike in the final minute of their FIH Pro League match here Friday.

Ireland frustrated the Indians for most part of the match with resolute defending but Gurjant saved the blushes for the home side as his powerful shot from the top of the striking circle in the 60th minute beat the Irish goalkeeper: India also failed to convert any of their six penalty corners.

The Indians had a sloppy start and lacked the same level of energy which they showed in Thursday's 10-goal thriller against Australia. Ireland, on the other hand, had more ball pos-



session and were successful in cutting off Indian balls inside their circle.

India had the first real chance in the form of a penalty corner but captain Harmanpreet Singh's

flick was saved in the goal-line by an alert Irish defender. Ireland had their first chance in the 11th minute but Matthew Nelson's reverse hit was kept out by India goalkeeper Krishan Bahadur Pathak

The Indians put up a much better show in the second quarter as they slowly and steadily got back into the contest. India secured two more PCs in a span of five minutes but on both occasions.

India's struggle continued after the change of ends as they failed to breach the Irish defence despite making a number of circle penetrations.

It looked the deadlock was finally broken when Akashdeep found the back of the net from Abhishek's pass but the goal was overturned after Ireland asked for review for an infringement on goalie Carr.

The Indians had more ball possession in the third quarter and secured another penalty corner but Amit Rohidas' try was saved by Carr. India next play Spain in Rourkela February 19.

Senapati (109 batting, 184b, 13x4) was accompanied by experienced Biplab Samantray (40 batting, 97b, 5x4) when the bails

were taken off. Skipper Shantanu Mishra (76, 129b, 10x4) also chipped in with a half century at the top.

Earlier, Odisha, after winning the toss, opted to bat first on a good looking track for the batters. Openers Swastik Samal (38, 40b, 5x4, 1x6) and Shantanu started off well putting on a 58-run stand

with a healthy run-rate. After Swastik's departure, the runrate dipped a bit before No.3 batter Sandeep Pattnaik (12) got out after a 27-run stand.

Shantanu was then joined by Senapati and the duo played with caution stitching 80 runs for the third wicket before the Odisha skipper returned to the pavilion. Govinda Poddar (27) then joined Senapati at the middle.

They were looking good until Sumit Mathur (2/67), who made his first-class debut in this match, disturbed Poddar's stumps to break an impressive a 68-run partnership. Senapati and Biplab then ensured Odisha of no further hiccups until the umpires called off play for the day with an unbroken 81-run stand. Pranshu Vijayran (2/64) was the other wicket-taker for the home team.
