## The man is gone, the voice stays on

Mumbai: His was the voice that ruled the airwaves for decades and will forever echo through the winding roads of nostalgia. Ameen Sayani, who invited millions each week to tune into *Binaca* Geetmala, was India's radio man for the ages - and will continue to be

Sayani, who died in Mumbai at the 91 following a heart attack Tuesday, was not a singer or an orator. He was the presenter of a programme on Hindi film songs but one so compelling and so hugely popular that no history of Indian radio can ever be written without his contribution.

That voice, the deep timbre radiating cheer and warmth, has fallen silent but the refrain of that unforgettable "Namaste behno aur bhaiyo, main aapka dost Ameen Sayani bol raha *hoon*" will long ring loud and clear.

Sayani's inimitable greeting reached countless homes as Hindi film song aficionados tuned in week after week to Binaca Geetmala on Radio Ceylon from 1952 to 1988.

The programme moved to All India Radio's Vividh Bharti in 1989 but its popularity did not wane thanks to the connect that Savani had established with his listeners. There were several name changes as the toothpaste manufacturer went from Binaca to Cibaca and the show was also rechristened to Colgate Cibaca Geetmala. The listeners though kept listening in right till 1994 when it ended. **The Turning Point** 

Sometime in the late 60s, Sayani recalled in an interview with PTI, he encountered a lanky, tall man but he busy running 20 shows a week and just did

not have time to meet the stranger. "I had not a second to spare for this thin man. He waited and left and came back a few more times. But I could not see him and kept telling him through my receptionist to take an appointment and come,"Sayani said.

And yes, the young man was Amitabh Bachchan, the superstar with the deep baritone.

"Today, though I regret denying him an audition, I realise that what happened







## **New Barabati proposed**

Cuttack, Feb 21: The iconic Barabati Stadium in the Silver City here will be transformed into a world-class sporting facility under the state government's 5T initiative, official sources said, Wednesday.

After supporting hockey and football, Odisha government has now decided to focus on cricket in the state, they said, adding that Chief Minister Naveen Patnaik is likely to lay the foundation stone for the makeover February 27.

5T and Nabin Odisha Chairman Kartik Pandian visited the stadium Wednesday and discussed the development of the sport with Odisha Cricket Association (OCA) president Pranab Prakash Das (Bobby) and other officials. While reviewing the plans for the transformation of the stadium into a mega facility with a seating ca-



pacity of 60,000, Pandian said, "The area near Barabati Stadium will be developed into a worldclass sports campus with the best of facilities for cricketers and other sports disciplines.

The transformation will ensure international standards for spectators, including access to the stadium, comfortable viewing areas, and amenities such as food courts and washrooms. Additionally, facilities for other sports disciplines will be included on the campus, according to the Chief Minister's Office.

A mall, a five-star hotel and office spaces will be created in the

area adjacent to the stadium. The space in front of the stadium will be developed as a public plaza, it said. Pandian also interacted with coaches and players. He assured that cricket development will be a priority under the 5T transformation and cricket training centres with quality coaching will be developed across the state. The aim will be to make Odisha a major emerging state in the field of cricket, Pandian said.

To improve the competitiveness among Odisha cricket players, Pandian suggested starting a highstandard state-level cricket league this year with proper broadcast facilities. He said the state has women cricketers who have been displaying exceptional talent at the national level. To further encourage and promote the development of women's cricket, Odisha Women Cricket Academy will be started in Puri shortly, he said.

#### Farmer killed; 'Delhi Chalo' on hold

Chandigarh, Feb 21: Farmer leaders Wednesday put the 'Delhi Chalo' march on hold for two days after a protester was killed and about 12 police personnel injured in clashes at Khanauri, one of the two protest sites on the Punjab-Haryana border.

Farmer leader Sarwan Singh Pandher said that they will decide the next course of action Friday evening. Punjab farmers at Khanauri and Shambhu had resumed their agitation early in the morning after a two-day lull following the fourth round of talks Sunday night with a panel of three Union ministers in an attempt to break the deadlock.

Police fired tear gas shells at the two border points multiple times to disperse groups of protesters when they attempted to move towards the layers of barricades stalling their march to the national capital.

Earlier in the day, Agriculture Minister Arjun Munda, who is



among the Union ministers engaging with the farmer leaders, called for further talks and appealed to the protesters to maintain peace. Thousands of farmers remain camped at Khanauri and Shambhu with their tractortrolleys and trucks agitating for their demands, including a legal guarantee for minimum support price (MSP) for crops and farm debt waiver.

Farmer leader Baldev Singh Sirsa identified the dead farmer as Subhkaran Singh (21), a resident of Baloke village in Punjab's Bathinda district. A Haryana Police officer said around 12 police personnel were injured when they were attacked with lathis and stones thrown at them in Khanauri, located in Punjab's Sangrur district, close to the border with Haryana's Jind. ## Judiciary's 'Bhishma Pitamah' who minced no words

New Delhi, Feb 21: The name of constitutional jurist Fali Sam Nariman, who died at the age of 95 Wednesday, will go down in legal history for his pivotal contribution to cases that have shaped India – the basic structure doctrine judgement in Kesavananda Bharati being just one of them.

Nariman, variously termed Bhishma Pitamah, conscience keeper and the man with a giant intellect, was a recipient of Padma Vibhushan in 2007 and Padma Bhushan in 1991. He was a renowned votary of civil liberties and secularism. He was famously outspoken, a bold voice unhesitatingly taking on the State on a range of issues and articulating his views on ills plaguing the society at large.

For Nariman, a guiding light for lawyers down the decades, it didn't matter who was in power.

Appointed additional solicitor general of India in May 1972, he resigned from the post just a day after Indira Gandhi imposed Emergency June 26, 1975. Rare those days, and even now, this possibly deprived him of opportunities in the latter half of the career to

serve the nation as the solicitor general or attorney general for India That forthrightness stayed his

calling card right till the end. On February 9, just 12 days before he breathed his last, Nariman spoke at an IPI-India function. A "dissident press" is a "free press" and it is essential for democracy, the nonagenarian jurist said in what was possibly his last public speech. He described India slipping ranks in the press freedom index as a "matter of grave concern for

democracy' A week later, February 16, Nariman wrote to lawyer Prashant Bhushan to congratulate him for his victory in the electoral bond scheme case.

"His passing away at this critical juncture is an enormous loss for our country," Bhushan said in a post on X.

As rich tributes poured in from across the nation, Chief Justice of India DY Chandrachud termed him a "great giant of an intellectual"

Former CJI NV Ramana said he was a "conscience keeper for judicial institutions"

'Through his arguments in court rooms, widely read newspaper columns, public lectures, parliamentary interventions and

televised interviews he has educated generations of legal professionals and general public alike," Ramana said in a statement.

Nariman also served as a director on the PTI Board.

Born in Rangoon (now Yangon) to a well-off business executive, he joined the Bar as a lawyer in 1950 in Bombay, now Mumbai, and remained active for

over seven decades He initially practiced in Bombay and remained there till 1972 and then shifted to Delhi to practice law in the Supreme Court. It was a long and illus-

trious legal career. Nariman assisted Nanabhoy Palkhivala in the Kesavananda Bharati case, the most significant case in independent India. The 1973

verdict laid down "basic structure doctrine" of the Constitution, clipping the Parliament's power to amend the Constitution and simultaneously giving the judiciary the authority to review any amendment on grounds of its violation.

After the 1984 Bhopal gas tragedy, Nariman argued in favour of the Union Carbide Corporation but was candid enough to admit later that it was a mistake. Later, he was also instrumental in getting a deal between victims and the company

outside court. He represented the Gujarat government in the Narmada Rehabilitation case, but went on to resign following news reports of attacks on Christian community and the burning of copies of the Bible.

Nariman appeared and argued in the famous TMA Pai case, Jayalalithaa disproportionate assets case and the matter of the National Judicial Appointments Commission, which was struck down by the Supreme Court.

The top court in the TMA Pai Foundation case recognised the autonomy of private educational institutions under Article 19(1)(g) of the Constitution, and allowed them to operate without excessive governmental interference.

Nariman also argued for the Supreme Court Advocates-onrecord Association in its challenge to the National Judicial Appointment Commission. which was tasked with the responsibility of making judicial appointments. The top court quashed the NJAC on grounds that it violated the freedom of judiciary, one of the basic structures of the Constitution.

He was a lead counsel in the SP Gupta case, also known as the first judges cases, which finally led to the collegiums system of appointment of judges in higher judiciary.

Former Tamil Nadu CM J Jayalalitha had hired him to represent her in the disproportionate assets case. Nariman secured her bail from the top court.

Nariman was also a prolific author. His 'Before the Memory Fades' is a professional guide for new lawyers across the nation. He has also written 'The State of the Nation', 'India's Legal System: Can it be Saved? and 'God Save the Hon'ble Supreme Court'. Nariman was nominated as a member of the Rajya Sabha in November 1999.

The council unanimously decided to stop Rs 100 stamps of Advocate Welfare Corpus Fund and funding to all Bar Associations for elections.



## Old guards remain in fray in Balasore



■ With no new faces emerging, the BJP, BJD and the Congress may nominate the same candidates for the Balasore Lok Sabha seat

Balasore, Feb 21: With no new face in the race, candidates who have already contested from Balasore Lok Sabha constituency in 2019 are hopeful of getting tickets as 2024 elections draw near: The Balasore Lok Sabha segment comprises Balasore, Jaleswar, Bhograi, Basta, Remuna and Nilagiri Assembly segments. The neighbouring Badasahi Assembly segment in Mayurbhanj district also comes under the Balasore Lok Sabha seat. Rumours are rife as to who the BJD, the BJP and the Congress will field for the up-

In 2019, BJP's Pratap Sarangi was elected as the MP from this north Odisha constituency. Fondly addressed as 'Nana', he went on to become a minister in the Narendra Modi-led government. Sarangi is popular among the masses for his austerity and simple lifestyle. However, his absence in the constituency during the Covid-19 pandemic and inability to carry out development works led to a decline in his popularity, according to political analysts.

Earlier, there was speculation that the BJP might nominate Union Railways and Telecom Minister Ashwini Vaishnaw from Balasore. Now, however, it will not happen as Vaishnaw has filed his nomination for the Rajya Sabha.

In 2019, Sarangi got around 4,83,858 votes to emerge winner. Keeping in mind his popularity, it is expected that the BJP may field him again if the saffron party fails to find the right can-

In 2014, Rabindra Kumar Jena, an engineer by profession, was elected as MP from Balasore on a BJD ticket. However, in 2019 he lost to Sarangi by a margin of 13,000 votes. Despite the BJD emerging victorious in four of the seven Assembly segments, Jena could not capitalise on the situation. However, despite the setback, there is indication that the BJD may field him again, sources said.

Rumours are also flying that Jena may withdraw from the fray as his wife is expected to contest from the Basta Assembly constituency as a BJD candidate. Usually, the BJD does not nominate two members from the same family to contest elections. Hence, if Jena's wife contests, there is a possibility that the BJD will look for someone else to contest from Balasore.

There is also no clear picture on nomination of candidate by the Congress. In 2009, Srikant Jena had won as a Congress candidate from this constituency and was appointed as a Union minister. However, he received only 2.78 lakh votes in 2014 elections and was pushed to third position. The situation worsened in 2019 when Congress candidate Nabajyoti Patnaik got only 1.80 lakh votes. In such circumstances, with the vote bank rapidly dwindling, the Congress is at a loss to find a good candidate.

## Ousted BJD leader Panigrahi joins BJP

Bhubaneswar, Feb 21: Four years after he was expelled from the BJD, Gopalpur MLA and former minister Pradeep Kumar Panigrahi Wednesday joined the BJP ahead of the Lok Sabha and state Assembly polls.

Immediately after joining the saffron party in the presence of its state chief Manmohan Samal, Panigrahi vowed to oust the BJD from power.

He also termed the government headed by Chief Minister Naveen Patnaik as arrogant and autocratic, an allegation the ruling party denied.

Panigrahi, a critic of bureaucrat-turned-BJD leader VK

Pandian, was expelled from the ruling party in 2020 for being involved in anti-people activi-

The three-time lawmaker from Gopalpur in Ganjam district had earlier served as a higher education minister in the state gov-

Samal welcomed Panigrahi to the BJP and said the former state minister would strengthen the party in Ganjam.

"The BJP will emerge stronger in Ganjam and neighbouring districts with his entry to the party," he said.

Senior BJD leader Ramesh Chandra Chayupatnaik claimed that Panigrahi joining the saffron camp will have no impact on the Ganjam district politics.

Panigrahi also said, "Development work across various sectors taken up by Prime Minister Narendra Modi has infused faith in people and time is ripe for a change of government in Odisha to save democracy."

The Gopalpur MLA said that the chief minister had earlier got the support of the BJP and later snapped ties with the party in

Later in the day, BJD spokesperson Ipsita Sahoo claimed that the real face of the BJP has come to the fore with Panigrahi's induction to the

"He was expelled from the BJD for anti-people activities. He was involved in cheating job aspirants and was sent to jail,' Sahoo said.

Pangirahi, however, rejected all the allegations made by the BJD spokesperson and said the charges were politically moti-

### 4 UP men held for faking disability to beg



## World's biggest snake species found in Amazon rainforest

Until now, four species of anacondas were known, with the largest one - the green anaconda inhabiting tropical parts of South America such as the basins of the Amazon, Orinoco, and Esequibo rivers, as well as some smaller watersheds.

These anacondas, found in the rivers and wetlands of South America, are well known for their lightning speed and ability to squeeze the life out of prey by coiling around, asphyxiating them, and swallowing them

A newly published decadeslong study has now found that the green anaconda is genetically

two different species. Researchers working with the indigenous Waorani people captured and studied several specimens of the newly named north-



ern green anaconda (Eunectes akayima) in the Bameno region by only about 2 per cent. of Baihuaeri Waorani Territory in the Ecuadorian Amazon.

The species was found during filming for National Geographic's Disney+ series Pole to Pole with Will Smith.

Scientists documented several anacondas belonging to the new species 'lurking in the shallows, lying in wait for prey' as they paddled canoes down the Amazonian river system.

"The size of these magnificent creatures was incredible one female anaconda we encountered measured an astounding 6.3 metres long," study co-author Bryan Fry from the University of Queensland said in a statement."There are anecdotal reports from the Waorani people of other anacondas in the area measuring more than 7.5 metres long and weighing

around 500 kilograms," Fry said. The new species, described in the journal 'Diversity', diverged from the previously known southern green anaconda about 10

million years ago, differing genetically from it by 5.5 per cent. To put this in perspective, humans differ from chimpanzees

The finding, according to researchers, is pivotal for the conservation of anacondas, which are apex predators and vital to maintaining balance in their ecosystems.

A healthy anaconda population means their ecosystems are vibrant with ample food resources and clean water, while declining numbers of the snake may indicate environmental distress,

scientists say. "So knowing which anaconda species exist, and monitoring their numbers is crucial," researchers write in The

Conversation. The anacondas and their habitats are under increasing threat from land fragmentation caused by industrialised agriculture, forest fire, drought, climate change, as well as heavy metal pollution linked to spills from oil extraction activities.

"Of particular urgency is research into how petrochemicals from oil spills are affecting the fertility and reproductive biology of these rare snakes," Fry

### The Plastic Crisis

s the United Nations enters the final stretch of negotiations for a new treaty to end plastic pollution, governments must work to Lensure that the agreement not only reduces plastic production, but also strengthens local initiatives to remove and recycle existing plas-

Consider the Juan Díaz River, which runs through my hometown of Panama City. Tons of plastic – bottles and other detritus – bob in the river's currents, owing to poor waste management. Faced with this problem, Marea Verde ("Green Tide"), a non-profit organization that I cofounded, has installed a trash-trapping water wheel - dubbed the 'Wanda" device – that now collects much of this waste before it reaches the ocean.

Local initiatives like ours are necessary to achieve global climate goals. This is especially true for eliminating plastic pollution, which is largely driven by local consumption decisions. The new UN treaty, in my view, should thus balance top-down efforts to reduce plastic production and ban the use of toxic chemicals in these products with support for onthe-ground efforts to recycle, reuse, or transform in a sustainable way the billions of tons of plastic already clogging the world's waterways

and harming the environment. Otherwise, the ocean will contain more plastics than fish by 2050, and new diseases caused by microplastics - which have already been detected in human blood - could become commonplace.

So far, stakeholders are split on how best to proceed. During the latest round of treaty negotiations, held in Nairobi last November, the plastics industry and some oil- and petrochemical-exporting countries called for more emphasis on recycling and reuse, while environmental campaigners and other governments advocated curbs on production. To reach a consensus by late 2024, the two sides must be brought into alignment and agree on an integrated approach that links global goals to local action.

Working in government and nonprofits, I have experienced first-hand how a disconnect between international plans and on-the-ground realities can thwart progress and breed cynicism. That is why we at Marea Verde adapt ideas that have been successfully implemented elsewhere-from the United States to Nigeria and Australia to our context and culture.

For example, our Wanda device is based on Clearwater Mills' trash wheels, a cleanenergy technology that debuted in the US but is customised for a tropical ecosystem. Over the past year, Wanda has collected more than 130 tons of trash from the Juan Díaz River - a more effective intervention than fishing plastics from the sea or beach cleanups. Replicating this model worldwide could dramatically reduce landsourced debris, which accounts for 80% of ocean plastic pollution.

Fortunately, many other organisations are focusing on river cleanup to prevent new plastic waste from entering the ocean. Eight of these groups – including Marea Verde – are participating in the Clean Currents Coalition, a network of projects that are piloting innovative waste-removal technologies in river communities around the world. Coalition members can share knowledge and work collaboratively while also encouraging and facilitating effective on-the-ground action.

The plastic crisis is a result of human activities, and solving it calls for behavioural change, which can be accomplished only through initiatives that engage local communities. For example, Marea Verde organises and empowers residents in areas without recycling facilities by going door to door to collect plastic waste. As a result, many people have become aware of their ability to improve their surroundings, leading them to participate in neighbourhood cleanups, reclaim green spaces, and lobby for better waste management.

Efforts to counter plastic pollution must be equal to the size of the problem. To that end, the new UN treaty should include severe curbs on plastic production to choke off output and give clean-up efforts a fighting chance. But it must also support the local groups at the forefront of tackling the plastic problem. These groups' innovative strategies, tools, and data-gathering practices can serve as a model for the global community. This is not an either/or decision: both international regulations and local action are needed. The latter is already underway and is making a difference, one community and one river at a time.

## STRAINED FEDERAL TIES

series of strains test the nation today. Some strains bring protests on the streets, like the farmers' agitations earlier and underway now. But never before have elected Chief Ministers of states taken the route of street protests to make their point. The extreme actions point to a weakening of the internal fibre that makes the country, and is at odds with the narrative of a resurgent India playing out on the world stage. How can internal imbalance lead to external resilience? In this frame, of particular significance are the strains between the Central government and the Oppositionruled state governments.

In February, apart from the farmers, two CMs with their Cabinets and MPs have staged demonstrations in Delhi to protest what they see as discrimination in the distribution of federal funds. Kerala has taken its demand for funds to the Supreme Court and to New Delhi's doorstep for a protest. Kerala CM Pinarayi Vijayan, who says he has been forced to take this unprecedented step, led Cabinet ministers, legislators and MPs from his LDF government to protest at Jantar Mantar in Delhi against "financial injustice by the Centre and a breakdown in the federal structure of the country." He called 8 February, the day of the LDF protest, a "red letter" day in the history of India. On the same day, the SC asked the Central government to file its response to Kerala's interim application seeking an urgent release of funds. The Centre has argued that it cannot be blamed for Kerala's "financial mismanagement.'

A day before the Kerala CM's protest, Karnataka CM Siddaramaiah staged a protest surrounded by his Cabinet and MLAs to draw attention to an unfair allocation of funds and injustice in tax devolution. Karnataka has argued that while it ranks second in GST collections, it has lost nearly Rs 60,000

crore due to GST implementation and a little less than Rs. 63,000 crore on tax devolution. Karnataka and Kerala, supported by Tamil Nadu, have said that their protest is also to safeguard the constitutional rights of all states and secure their dues.

Centre-state relations and the complex issue of tax devolution have thus been turned into an ugly tug-of-war rather than a give-and-take that pushes the agenda for the betterment of the states and the nation. But for the present, whatever the state of the discourse, the states cannot be allowed to flounder to the extent that their elected heads have to stage protest marches in Delhi. This is a situation that is close to breakdown and serves no good.

A study of fiscal parameters of states by the RBI identified Bihar, Kerala, West Bengal, Punjab and Rajasthan as highly stressed due to their high debt levels and levels of fiscal deficit. High debt implies that the state spends a significant share of its revenues servicing debt. For instance, many states spend about 10% or more of revenue receipts on interest payments. Bengal and Punjab spend more than 20% on interest payments. Why is this so and how can this be addressed in the medium and long term is a matter of debate and dialogue and should not

be reduced to a slanging match. Kerala, for example, has run up a mountain of IOUs. The LDF government has blamed the Centre for the situation and alleges that it is being pushed into the worst financial crisis in the state's history. Flagging steps like the Central government reduction of Kerala's borrowing limit with retrospective effect from 2021-22, the LDF government has said the state suffered a cumulative loss of Rs 107513.09 cr for the period between 2016 and 2023. Comparing allocations, for example, it has been pointed out that Kerala was getting 3.8% of the divisible pool

enue deficit grants have also

been stopped. India works with the principles of cooperative federalism under which expenditure made and taxes raised are both responsibilities shared between states and the Centre. Ideally, these responsibilities are supposed to be shared in a fine balance between the Centre and states. However, in reality, while the Centre has a larger share of revenue, states have a bigger share of responsibility, which includes social service, economic and welfare schemes and projects. In India, states incur over 60% of total general government expenditure. This 'Vertical Imbalance,' as it is termed, is corrected through the transfer of funds from the Centre to states. It is this that the states, especially Opposition ruled Southern states, are irate about – the transfer and distribution of funds which they see as skewed.

At the time of the pandemic, former Kerala Finance Minister Dr. Thomas Isaac had said that the synchronisation of the responses of the Centre, states and local governments was necessary and inevitable if the pandemic was to be contained. "However, never have the fiscal relations between the Centre and States been so strained as is the case today. The rhetoric of co-operative federalism is being transformed into coercive fed eralism hampering the national response to COVID-19....," he had said then. He also warned that any squeeze on states' development expenditure, which accounts for 60% of the combined government expenditure, in a period of slump, would have a disastrous socio-economic impact.

Important issues of budgetary allocations, fiscal prudence, debt management and revenue expenditure must be discussed and debated, and guided by preagreed frameworks. This is how India has worked. A non-hostile and accommodative approach can help nudge the Centre and states to a more balanced and sustainable way of running their finances. There is a lot that the nation can learn from Kerala and its superior development indicators, and indeed from all the Southern states. Similarly, there is a lot that the states need to help fix in terms of reducing deficits. In the end, balancing budgets is important but a precondition to overall national development is managing federal relations.

## Month after consecration, all roads still lead to Ayodhya

#### MORE THAN 25 LAKH DEVOTEES VISITED THE TEMPLE IN THE FIRST 10 DAYS AFTER THE CONSECRATION CEREMONY

Ayodhya (UP), Feb 21: 12 kilometres from Ayodhya's Ram temple, sleeper buses that have ferried people from far-off places are lined up along the road to enter the huge parking lots. A month after the consecration at the new temple, the enthusiasm for a 'darshan' remains unabated.

In their unique traditional outfits, devotees from all parts of the country gather at holding areas from where they move towards the temple either in electric buses or e-rickshaws.

These devotees along with those coming from nearby places confluence on Ram Path that leads towards the grand temple. Barred from any traffic, one can only see devotees walking towards the temple on the left side of the road and those returning on the other side.

Festivities in Ayodhya are taking place with full vigour a month after the mega consecration ceremony, with lakhs of devotees

reaching the holy city to have darshan of Lord Ram's idol in the newly constructed temple.

One gets a sense of bustle of faith at Ram temple, the heart of Ayodhya, from more than 10 km away where buses ferrying devotees from far off places line up along the roads.

According to the officials of Ram Janmabhoomi Teerth Kshetra, more than 25 lakh devotees visited the temple in the first 10 days after the consecration ceremony.

"We receive anywhere between one to two lakh devotees every day in February. Going by the estimated number of devotees who have visited the temple till date is around 50-60 lakh," said Prakash Gupta, office in-charge of the temple trust.

On the way towards the temple, some devotees hail 'Jai Sri Ram' while others chant couplets from the Ramayan as they walk towards the temple. Most walk bare feet with their group. Along the road are small shops selling sweet.

meats and other items to be of-

fered inside the temple. Locals, especially teenagers, stand along the road carrying small tumblers filled with colour. On getting a nod from the devotees they dip three fingers in a yellow coloured liquid before applying it on the foreheads of the pilgrims.

They then dip an inch-long stencil with 'Ram' written in Hindi in a red coloured liquid before placing the stencil in the

middle of the marking made by the fingers before charging for it.

With the name of Lord Ram marked on their forehead, devotees continue the walk towards the temple. On looking from above, the rampart appears to be a confluence of India with people in different traditional clothes that give away the state or region they belong to.

On Tuesday, a group from Maharashtra, with women in sarees tied in unique Nauvaree

style walking with men donning a white shirt over a white lungi paired with a white Gandhi cap, walked behind a group from Rajasthan. The large bright coloured turbans donned by the men and the bright coloured sarees of the women from the desert state contrasted with a group from Uttarakhand in which the men wore a pahadi topi and women walked in their

Apart from local politicians from across party lines, Bollywood stars have also reached the temple for darshan.

Delhi Chief Minister Arvind Kejriwal accompanied with his counterpart in Punjab Bhagwat Mann visited the temple with their families.

## First-of-its-kind board game features Vijayanagara Empire

In little over two weeks, the game has already sold 1,020 copies and has piqued the curiosity of India's popular historians

Bangalore, Feb 21: It is that time of the year when Karnataka goes all out to celebrate Vijayanagara Empire (Hampi Utsav 2024 was held between February 2 and 5). But this year's biggest tribute to the medieval Hindu empire, which at its peak ruled most of the south, stretching its boundaries to Odisha and Maharashtra even, comes from the far-off America.

A mathematics professor at University of Wisconsin-Madison, Saverio E Spagnolie, has designed a board game based on the early strategic growth of the empire, along with three other designers – Mathieu Johnson, Cory Graham and Aman Matthews - and developer Joe Dewhurst.

'Vijayanagara: The Deccan Empires of Medieval India, 1290-1398,' published by GMT Games, is the first game in its new Irregular Conflicts Series, which explore complex interactions than counter insurgencies or COIN games.

Spagnolie said the team got together to participate in the first Consim Game Jam, a contest for designers to produce a game prototype in three days.

"I began to sift through periods with the potential for being modelled.



When I hit upon the political developments in the 14th century, it jumped off the page with its epic, sweeping scope – the rise and fall of powerful kingdoms, their beneficial and detrimental interactions, large personalities," said Spagnolie in an email interaction with the PTI.

When they won the contest, they were approached by GMT to publish

a refined version of the game, he said. "Little did we know at the time that the polishing would take about three

years of hard work," added Spagnolie. Previously, GMT has published two games inspired by the history of India. In 2008, it released 'Chandragupta', designed by Stephen R Welch, as part of their Great Battles of History series of games on ancient warfare. And in 2017, it released 'Gandhi The Decolonisation of British India', designed by Bruce Mansfield, considered non-conventional among the gamers because COIN games rely on violent wars unleashed in the annals of the history while Gandhi employed a non-violent method to win his war.

In fact, Spagnolie said his curiosity about India was sparked by Mansfield's 'Gandhi'.

"Historical board games transport players to distant places and times. In 2020, I wanted to spend more time outside of my apartment and a different time sounded pretty good too," added Spagnolie.

Vijayanagara, states the publisher note, lets players take on the roles of Delhi Sultanate, the Bahmani Kingdom and the Vijayanagara Empire – and rally local amirs and rajas to their cause, construct temples, forts and qasbahs – as they battle for supremacy over the Deccan Plateau.

On February 6, the very next day after Spagnolie announced the launch of the game on X (formerly Twitter), Anirudh Kanisetti, the author of 'Lords of the Deccan New History of Medieval South India', posted on X "How delightful to see boardgame about my beloved medieval India - love that cheeky reference to 'Lords of the Deccan' and to @UnamPillai's (Manu S Pillai) 'Rebel Sultans' in the game cards. Many congrats to @SaverioIV and team, And I can't wait to play this!" Spagnolie acknowledged that the research done by historians played an important role in the design of the game, considering he and his team had never been to India.



#### ■ Navalny's body: **Mother files suit**

Moscow: The mother of Russian opposition leader Alexei Navalny has filed a lawsuit at a court in the Arctic city of Salekhard contesting officials' refusal to release her son's body, Russia's state news agency Tass reported Wednesday. A closed-door hearing has been scheduled for March 4, the report said, quoting court officials. Lyudmila Navalnaya has been trying to retrieve her son's body since Saturday, following his death in a penal colony in Russia's far north a day earlier. She has been unable to find out where his body is being held, Navalny's team reported. Navalnaya appealed to Russian President Vladimir Putin Tuesday to release her son's remains so that she could bury him with dignity.

#### **UK missile misfire**

London: Britain's Trident nuclear-deterrent system misfired during a test last month, sending a missile crashing into the ocean off the Florida coast near the submarine that launched it. ## PAKISTAN ELECTIONS Political impasse ends

Islamabad, Feb 21: In a breakthrough that could end the political uncertainty in Pakistan, the Pakistan Muslim League-Nawaz and the Pakistan Peoples Party have agreed on a powersharing deal to form a new coalition government after intense negotiations following a fractured poll verdict.

In a joint news conference late Tuesday night at Zardari House here, Pakistan Peoples Party (PPP) Chairman Bilawal Bhutto-Zardari announced that Pakistan Muslim League-Nawaz (PML-N) president Shehbaz Sharif, 72, will assume the role of the prime minister once again.

Similarly, PPP co-chairman Asif Ali Zardari, 68, will be the joint candidate for the president's office.

"The PPP and PML-N have achieved the required number, and (now) we are in a position to form the government," Bilawal told reporters without revealing the number of lawmakers they have in the National Assembly after the February 8

To form a government, a party must win 133 out of 265 contested seats in the 266-member National Assembly or the lower

The apex court also imposed a fine on the petitioner, a former army officer, over his failure to appear before the court. Retired Brigadier Ali Khan last week urged the apex court to order new elections within 30 days to be held under the direct supervision and oversight of the judiciary "to ensure fairness, transparency and accountability".

#### Khan's party to hold organisational polls in 15 days

Islamabad: Jailed former prime minister Imran Khan's beleaguered party will conduct fresh organisational elections in 15 days, following the intra-party polls' postponement earlier this month, a media report said Wednesday. The 71-year-old former-cricketer-turned-politician's Pakistan Tehreek-e-Insaf (PTI) party postponed the scheduled intra-party polls earlier this month, asserting that it could "divert" attention from the February 8 general elections. Quoting sources, The Express Tribune newspaper reported that Barrister Gohar Ali Khan has been nominated as the chairman while Raoof Hassan will be the Chief Election Commissioner for PTI's intra-party polls, which will be conducted in 15 days.

"At the time of this incident, there was speculation circulating that this was connected to foreign interference. Investigators have not established any links to foreign interference in relation to this matter." the statement said.

It said that February 6, the Surrey RCMP Serious Crime Unit executed a search warrant on a residence and seized three firearms and multiple electronic devices during the search.

On February 12, two 16-yearold youths were arrested and the British Columbia Prosecution Service approved charges of discharging a firearm into a place and possessing a loaded prohibited firearm.

"Demanding an immediate, unconditional ceasefire without an agreement requiring Hamas to release the hostages will not bring about a durable peace. Instead, it could extend the fighting between Hamas and Israel," Thomas-Greenfield told the council ahead of the vote.

The Algerian-drafted resolution vetoed by the US did not link a ceasefire to the release of hostages. It separately demanded an immediate humanitarian ceasefire and the immediate and unconditional release of all

Israel's UN Ambassador Gilad Erdan said the word ceasefire was being mentioned "as if it is a silver bullet, a magical solution to all of the region's problems.'

"A ceasefire achieves one thing and one thing only - the survival of Hamas," Erdan told the council. "A ceasefire is a death sentence for many more Israelis and Gazans."

## China's childcare costs among highest globally

**IN 2023, CHINA'S TOTAL FERTILITY RATE WILL ONLY BE ABOUT** 1.0, ONE OF THE **LOWEST IN THE WORLD**

Hong Kong, Feb 21: China is one of the world's most expensive places to raise a child, relative to its GDP per capita, a prominent Chinese think tank said Wednesday as it detailed the time and opportunity costs for women who opt to have children in the country.

The cost of raising a child until they are 18 relative to per capita GDP is around 6.3 times in China versus 2.08 times in Australia, 2.24 times in France, 4.11 times in the U.S. and 4.26 times in Japan, said a report by the Beijing-based YuWa Population Research Institute.

Raising children also leads to a reduction in women's paid work hours and wage rates, while men's livelihoods remain largely



unchanged.

'Because the current social environment in China is not friendly to women's fertility, the time cost and opportunity cost for women to have children are too high," said the report, coauthored by Liang Jianzhang, founder of online travelling site Ctrip and also a founder of the YuWa institute.

told to seek refuge. The Al-Aqsa Martyrs hospital in Deir al-Balah says it received 44 bodies after multiple strikes in central Gaza, Associated Press reporters saw the bodies arriving in ambulances and private vehicles

Also Wednesday, the aid group Doctors Without Borders said that two people were killed when a shelter housing staff in the Gaza Strip was struck during an Israeli operation in an area where Palestinians have been told to seek shelter.

'While details are still emerging, ambulance crews have now reached the site, where at least



two family members of our colleagues have been killed and six people wounded. We are horrified by what has taken place," the group said in a post on X, formerly known as Twitter.

The attack took place in Muwasi, a sandy, mostly undeveloped strip of land along the coast that has been transformed into a sprawling tent camp with little in the way of basic services.

The war began when Hamasled militants rampaged into southern Israel on Oct 7, killing some 1,200 people and taking around 250 hostage. About a fourth of some 130 captives still being held are believed to be dead. Israel has laid waste to much of the Palestinian territory in response. Gaza's Health Ministry estimates more than 29,000 Palestinians have been killed.

New Delhi: Ambuja Cements, now a part of Adani Group, Wednesday said it has planned to invest ₹1,000 crore to set up a cement grinding unit in Godda district of Jharkhand. The new 4 Million Tonne Per Annum (MTPA) cement grinding unit would be set up after requisite approvals, Ambuja Cements Ltd (ACL) said. This project is "planned in the close proximity to Adani Power (Jharkhand) Ltd, as part of a comprehensive approach to disposing of fly ash in an environmentally safe manner and contributing to the circular economy," it said. The unit will generate direct and indirect employment for over 2,500 people, it added.

New Delhi, Feb 21: Over onethird of India's export of oil products to the G7-led coalition countries was derived from Russian crude, a European thinktank said, highlighting how the partners shunned buying Russian crude and imposed price caps but a loose policy on refined product allowed third countries to use Russian oil and legally export products to them.

While there are no restriction or sanctions on buying/using Russian crude oil and exporting fuels such as diesel derived from it, the Group of Seven (G7) rich nations, the European Union and Australia - called the price cap coalition countries - first set a crude price cap of \$60 per barrel starting December 5, 2022 and later on products like diesel to keep market supplied while limiting Moscow's revenue.

This was aimed at punishing Russia for its February 2022 invasion of Ukraine by depriving it of oil revenues while averting a surge in prices that could occur if Russian oil stopped flowing to global markets.

In 2023, there was a 44 per cent year-on-year increase in sanctioning countries' imports of oil products, by volume, produced from Russian crude, it said, adding the price cap coalition's (PCC) imports of oil products made from Russian crude oil generated EUR 1.7 billion of tax revenues for the Kremlin from December 2022 to December 2023.

Since the introduction of the price cap till December 2023, the USA imported EUR 1.6 billion worth of oil products derived from Russian crude. EUR 807 million of Russian crude was used to make these products for the USA, it said, adding price cap coalition countries imported EUR 2.4 billion of diesel derived from Russian crude.

The EU bars EU vessels as well as insurers from handling Russian-origin oil unless it is priced at or below the price cap.



Similarly, the broader Nifty also paired all its intraday gains before closing 141.90 points or 0.64 per cent down at 22,055.05 points. The 50-share barometer had

hit a lifetime peak of 22,196.95 points Tuesday and remained mostly in the upward trajectory on Wednesday. In the Sensex pack, 20 stocks

ended in the red while 37 of the Nifty constituents closed the session with losses.

NTPC was the biggest loser among the Sensex constituents, ending with a loss of 2.71 per cent. It was followed by PowerGrid, Wipro, HCLTech, L&T and Tech Mahindra. In contrast, Tata Steel, SBI,

JSW Steel and IndusInd Bank closed in the positive territory. Tata Steel gained 1.99 per cent and SBI ended 1.51 per cent higher. The BSE Midcap index de-

## Gill recalls tough time India go down against Dutch



Ranchi, Feb 21: Shubman Gill had twin challenges to tame when he entered the Test series against England – a barren run that gripped him for nine innings, which was made grimmer when he dropped down to bat at a rather new No.3 slot at this

Three Tests into the ongoing five-match rubber, Gill has managed to find some answers scoring 252 runs at 42 with a matchwinning 104 at Visakhapatnam and a classy 91 at Rajkot. For Gill, it was all about coping with the expectations he had placed on himself, rather than making any sweeping technical changes to his batting.

"It is a bit tough (living up to

his own expectations). When people from outside talk about all those things, it did not make much difference to me. But the expectations that I kept on myself made me a bit disappointed," Gill said in a press conference

here Wednesday. However, Gill said he has still placed the same level of expectations on him but has learned to adjust to them. "You will definitely have some expectations on you as to how you want to play for the team, the country. But I don't think that has changed my mindset. I still have the same

set of expectations for myself. "It is all about how you are able to forget them and move on quickly and be ready for the next challenge. That is the difference between a big player and an av-

erage player," he added. The 24-year-old could not score a fifty in 11 continuous innings, including the Hyderabad Test against England last month, once he started batting at No. 3, deviating from his preferred opening position. The rut set in during India's tour to the West Indies mid-last year till he broke it against England at

Visakhapatnam. Gill said batting at No.3 presented him with a different task even though he had batted in that slot in domestic matches earlier.

"I have batted at No.3 and No.4 for India A and in some Ranji Trophy matches, and as such, it was not something that I have never done in my life. There are not many technical changes that I had to make to my game.

Gill said playing in the middleorder made it mandatory for him to bat as per the situations. 'But when you bat at three or four, there is a certain situation that you have to bat at. "I would not have played any differently even if I was feeling any calm or composed (in Vizag). But definitely, what I was feeling at Vizag was a bit different from what I was feeling in the earlier matches for India (in terms of the match situation).

"But in Rajkot, the situation was different, we were in a very good position, leading by some 300 runs. So, keeping that in mind, it was a much calmer and composed innings.

Indian batters' failure to kick on after getting a start was a major reason behind their defeat in the first Test. Gill said there was a talk in the dressing room about converting the starts into big knocks to pile pressure on the

Ravindra Jadeja, who was the player-of-the-match in Raikot. also climbed up in the batting rankings from 41st to 34th position, the ICC said in a statement. He also returned with a seven-wicket match haul that lifted him three places to sixth in the bowling rankings. Veteran off-spinner Ravichandran Ashwin climbed a rung to the second position behind pace spearhead Jasprit Bumrah. Jadeja and Ashwin continued to hold on to the first two spots in the Test allrounders rankings.

#### Nagal out of 100

New Delhi: India's top singles player Sumit Nagal dropped out of top-100 after losing 16 points from his kitty, resulting in him sliding three spots to 101 in the latest ATP rankings. Last year in the same week, Nagal had earned 41 ranking points by reaching the semifinals of the Chennai Challenger as a qualifier. He was defending those points and could earn only 25 in Bengaluru last week. Nagal had become one of the few Indian tennis players to crack the top-100 following his tremendous show in Chennai where he won his fifth Challenger level title.

#### **Alcaraz retires hurt**

Rio de Janeiro: Two-time major winner Carlos Alcaraz retired hurt from the Rio Open Tuesday after two games due to a right ankle injury. The retirement at 1-1 meant Brazil's Thiago Monteiro advanced to the second round. He will face his compatriot Felipe Meligeni Alves for a place in the quarterfinals. Alcaraz twisted his ankle in the first game after only two points. He received medical attention, broke Monteiro's serve, but after the Brazilian pulled level he shook his rival's hand and left the court walking as his coach Juan Carlos Ferrero looked concerned. The Spanish player said his doctors said the injury was not serious. Alcaraz said he does feel pain when he walks and that he will have medical scans Wednesday.
