Bhubaneswar, Feb 24: Chief Minister Naveen Patnaik Saturday announced the formation of 34 new notified area councils (NACs) in 20 districts and the upgradation of five existing NACs into municipalities. The government, in a statement,

said the new NACs and municipalities were created in view of the public demand and increasing population and socio-economic development of the state.

The five NACs, which have been upgraded into municipalities, are Boudhgarh in Boudh district, Karanjia in Mayurbhanj, Kantabanji in Bolangir and Chhatrapur and Aska in Ganjam, official sources said.

in Kalahandi, and Raikia in Kandhamal also got the NAC status. Boriguma in Koraput, Sinapali in Nuapada, Chandili, Muniguda and Bisamakataka in Rayagada district, Dunguripali in Subarnapur, Bonai in Sundargarh were also declared as notified area councils.

Besides. Shergarh and Kukudakhandi in Ganjam, Kantilo in Nayagarh, Tangi and Begunia in Khurdha, Salipur, Badamba, Narasinghpur and Niali in Cuttack, Betnoti in Mayurbhanj, Parjang in Dhenkanal and Kantamal in Boudh would now be considered NACs.

The state currently has around 115 urban local bodies (ULBs) in 30 districts, including five municipal corporations, 47 municipalities and 63 NACs. After the formation of 34 more NACs and 5 additional municipalities, the total number of ULBs will increase to 154. The decision was taken following 5T Chairman Kartik Pandian's district tours and keeping the demands of people along with development of the areas in mind.

# AAP-Cong pact in Delhi, Haryana, Gujarat, Goa

New Delhi, Feb 24: The Aam Aadmi Party (AAP) will contest four Lok Sabha seats in Delhi and the Congress three, the parties said Saturday as they announced their seat-sharing arrangements for the national capital, Gujarat, Goa and Haryana.

AAP general secretary (organisation) Sandeep Pathak said that sidelining its own political interests, his party entered into an alliance with the Congress as it believes that the 'country is important and the party secondary.'

Senior BJP leader and Union Minister Hardeep Singh Puri termed the tie-up between the two parties an 'opportunist alliance.' In a joint press conference here, Congress leader Mukul Wasnik announced that the AAP will contest the New Delhi, the West Delhi, the South Delhi and the East Delhi seats, and his party the Chandni Chowk, the Northeast Delhi and the Northwest Delhi seats.

In Gujarat, the AAP will contest two of the 26 seats in the state -- Bharuch and Bhavnagar -- while the Congress will field candidates on the remaining 24, according to the arrangement.

The Congress will contest both the Lok Sabha seats in Goa and the lone seat in Chandigarh, Wasnik said.

In Haryana, the Congress will contest nine of the 10 Lok Sabha seats while the AAP will field its candidate in Kurukshetra, he added.

# New criminal justice laws from July 1

New Delhi, Feb 24: The newly enacted laws-Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita and Bharatiya Sakshya Act- to completely overhaul the criminal justice system in the country

"In exercise of the powers conferred by sub-section (2) of section 1 of the Bharatiya Nyaya Sanhita, 2023 (45 of 2023), the central government hereby appoints the 1st day of July, 2024 as the date on which the provisions of the said Sanhita, except the provision of subsection (2) of section 106, shall come into force," one of the notifications said. After the laws were enacted the truckers had protested the provision of Section 106 (2) which provides for 10 years imprisonment and fine to those who causes death of any person by rash and negligent driving of vehicle not amounting to culpable homicide, and escapes without reporting it to a police officer. will come into effect from July 1. However, the provision related to cases of hit and run by vehicle drivers will not be implemented immediately.

The three laws got the Parliament's approval December 21 last year and President Droupadi Murmu gave her assent December 25. According to three identical notifications issued by the Union home ministry, provisions of the new laws will come into force from July 1.

The laws will replace the colonial-era Indian Penal Code, the Code of Criminal Procedure and the Indian Evidence Act of 1872 respectively.

The three legislations aim at completely overhauling the criminal justice system in the country by giving definitions of various offences and their punishments.

The government, however, has decided not to implement the provision related to cases of hit and run by a vehicle driver as promised to truckers who had protested against it.

Bhalla had said the decision to invoke Section 106 (2) of the Bharatiya Nvav Sanhita will be taken only after consultation with the All India Motor Transport Congress.

According to the Section 106 (2) of the BNS, "Whoever causes death of any person by rash and negligent driving of vehicle not amounting to culpable homicide, and escapes without reporting it to a police officer or a magistrate soon after the incident, shall be punished with imprisonment of either description of a term which may extend to ten years, and shall also be liable to fine.

# Mandatory chips soon for Everest climbers

Kathmandu, Feb 24: Nepal will soon be making it mandatory for all climbers headed to Mount Everest to carry an electronic chip that would be helpful in rescue in case of any emergency at the world's highest peak.

The government will soon be formulating a rule for making such a chip mandatory starting from Spring this year when the climbing season starts with the opening of the narrow window available to climb extremely high altitudes.

Thousands of climbers from all over the world, including India and Nepal, are attracted to the 8,849 metres (29,032 feet) high Mt

Since 1953, at least 300 Everest persons have lost their lives, The Everest base camp is situated at an altitude of according to Nepal government data. In the 2023 18,000 feet. Any search and Spring season, till May 22, rescue operation from the Nepali officials said, as base camp onwards to the Summit becomes a tedious job because of the snow storms, avalanches, and other extreme weather events.

"All the climbers to Everest would be provided the electronic chip by the government after paying a certain amount. It will be fitted in the climber's jacket," Rakesh Gurung, Director at the Department of Tourism told PTI.

The chips would cost around USD 10 to USD 15, he said. According to Gurung, the chip will help make the expeditions safe and facilitate emergency rescue operations.

Some reputed climbing agencies have already provided the electronic chips to their climbers, Gurung said.

Bhubaneswar. Feb 24: On the direction of Chief Minister Naveen Patnaik, Chairman 5T and Nabin Odisha Kartik Pandian visited Bhadrak district, Saturday.

During his 50km journey along the Baitarani left embankment, the 5T Chairman also rode on a bike to review the progress of Baitarani Left Embankment Strengthening and Road Development Project which is

being constructed at a cost of Rs 150.24 crore. The project was taken up following the feedback he received from people during his visit to Dhamnagar in December 2023.

The embankment strengthening project will reduce the imof floods in Bhandaripokhari, Dhamnagar and Chandbali areas during flood situations in Baitarani. The pucca road from Biridi to Tintar Ghat over the river embankment will reduce the travel time

by 2 hours between Biridi to Tintar Ghat, provide faster access to Jajpur Medical College and NH 16. The project would benefit around 1,20,00 people in

Bhadrak district. He also reviewed the progress of Akhuapada and Kochila instream storage structures over river Baitarani at a total cost of Rs 681 crore. Both the projects would provide irrigation facilities to 81,200 acre land. Water would also be available in the rabi season for cultivation. It would also help in fishery sector development in the area.

The projects have been sance tioned and taken up based on people's grievances and demands to the Chairman Nabin Odisha during his visit to Bhadrak in June, 2023.

All along the route large number of people gathered and welcomed the 5T Chairman appreciating his pro-people approach and traveling all the way to review the ground works personally.

# 22 die as tractor falls into UP pond

Kasganj (UP), Feb 24: As many as 22 people, including eight children, died when their tractortrolley overturned and fell into a pond in Uttar Pradesh's Kasganj district Saturday morning, officials said.

Earlier, Inspector General of Aligarh range Shalabh Mathur had said that 24 passengers died in the accident and 15 to 20 people were injured.

However, later, Relief Commissioner of Uttar Pradesh Naveen Kumar GS, citing a statement of Kasganj Additional **District Magistrate Rakesh** Kumar Patel, said, "Twenty-two people died when the tractortrolley overturned and fell into a pond." "The deceased include 13 women, a man and eight children. Ten people are currently undergoing treatment." the statement said.

The Kasganj district administration said that Rs 4 lakh will be provided to the kin of each of the deceased, while Rs 50,000 will be provided to each of the injured persons.

President Droupadi Murmu, Prime Minister Narendra Modi and Uttar Pradesh Chief Minister Yogi Adityanath condoled the loss of lives in the incident.

More specifically, AI demonstrated superior performance in response to glaucoma questions and case-management advice, while reflecting a more balanced outcome in retina questions, where AI matched humans in accuracy but exceeded them in completeness. "AI was particularly surprising in its proficiency in handling both glaucoma and retina patient cases, matching the accuracy and completeness of diagnoses and treatment sugges tions made by human doctors in a clinical note format," said Louis R. Pasquale, Deputy Chair for Ophthalmology Research for Department the ot Ophthalmology.

The findings "could serve as a reliable assistant to eye specialists by providing diagnostic support and potentially easing their workload, especially in complex cases or areas of high

patient volume", Dr. Huang said. "For patients, the integration of AI into mainstream ophthalmic practice could result in quicker access to expert advice. coupled with more informed decision-making to guide their treatment.<sup>1</sup>

# **EPF** benefits soon for ASHAs, MDM, Anganwadi workers

Bhubaneswar, Feb 24: In what may come as good news for Accredited Social Health Activists (ASHAs), Anganwadi and mid-day meal workers of the state, Odisha office of the Employees' Provident Fund Organisation (EPFO) has directed the state government to extend to them the benefits of **Employees'** Provident Funds and Miscellaneous Provisions (EPF & MP Act. 1952).

This directive seeks to benefit about 1.20 lakh Anganwadi workers and helpers, 1 lakh middav meal workers and 49.000 ASHAs in Odisha.

Assistant Provident Fund Commissioner Maushumi Lata Padhi in a letter issued to Commissioner cum Secretary, Labour and ESI department February 20 has stated that EPF and MP Act, 1952 applies to all establishments employing 20 or more employees for extension of three different schemes such as Employees' Provident Fund Scheme 1952, Employees' Pension Scheme 1995, and Employees' Deposit Insurance Scheme 1976 for allowing provident fund, pension, and insurance to eligible employees of registered establishments. Padhi said appropriate communication should be issued to all departments engaging mid-day meal workers, cook-cum-helpers, ASHAs and

Anganwadi workers.

# **Unabated use of China salt** puts public health at stake

Berhampur, Feb 24: Silk City Berhampur is known as the food capital of Odisha owing to the many varieties of delicacies the city offers to the food lovers.

However, restaurateurs, eateries, hotels and fast food counters continue to add MSG (Monosodium Glutamate), commonly known as Chinese salt or ajinomoto, to food items during preparation as a taste enhancer notwithstanding the serious risks the salt poses to the health of the food lovers.

Reports said that rampant sale of MSG continues in the Silk City as around 15 tonne China salt is sold every month notwithstanding its adverse health effects Chinese salt is sold at ₹120 per

kilo in the wholesale market and ₹140 in the retail counters. The salt can be found easily in almost all grocery stores and its demand increases manifold during marriage and festive seasons.

Hotels, restaurants and various eateries in the city are thronged by people starting from daybreak till late night to satiate their hunger. With an aim to increase the footfall, these hotels, restaurants and eateries prepare the food early and try to



enhance the taste by adding various chemicals, sauces, food colours, vinegar and especially China salt. According to many physicians. Chinese salt is actually harmful for human health. Frequent consumption of food

laced with the chemicals and Chinese salt has disastrous effects on human health including palpitations, allergic reactions, headache, nausea, vomiting, hypertension, numbness or burning sensation in the mouth and chest pain. It also leads to gastric problems and brain cell degeneration according to many studies.

Pratap Chandra Sahu, a retail trader at Bada Bazaar, said he sells 25 kg or one sack of Chinese salt daily and the sale gets doubled in marriage and festive seasons.

The salt is sold in over 20 spices godowns in the city. A godown trader sells around 80 sacks of

Chinese salt on an ordinary day while during marriage season over 200 sacks are sold.

A godown owner said that around two truckloads of Chinese salt are bought to the city per month. As a result, around 15 tonne of China salt is sold in the Berhampur market which after being added to food items is consumed by people.

A hotel owner Jagannath Panigrahi said Chinese salt is added to the food, especially nonvegetarian items, to enhance its taste and cook it early. "We are forced to add this salt due to heavy competition among eateries to draw more customers," he said.

Medicine specialist Dr Suchitra Haldar said the chemicals present in Chinese salt triggers many health complications. Regular consumption of Chinese salt laced food heightens the possibility of liver cancer. She said people should observe utmost precaution and stay away from consuming such food items.

A foodie Jalal Khan said he loves to eat fast food and visits the fast food counters in the city to savour the delicacies. However, he admitted that Chinese salt and colours added to the food are really harmful for health.

am writing this from the United States, where I attended an inter-esting solidarity meeting that I thought I should write about. It was interesting because it combined two struggles — that for secularism in democratic India and against imperialism in occupied Palestine

Hosted by the Boston South Asian Coalition it featured two speakers. One was our Teesta Setalvad, heroine of the struggle for justice in Gujarat. The other was a young man from South Lebanon named Saleem Hallal. In the audience were a few dozen people including several desis and to my mind this was what made this gathering especially interesting and I will write about why that is later.

The talks by the two speakers were focussed on the facts. About communal crimes in one place condoned by the State (some would say encouraged by it) and in the other a national struggle for the liberation. There was also a common thread and that was historical revisionism and the rewriting of things. The idea in both Palestine and 'New India' that something else used to be here on the ground and in this land a thousand years ago or two thousand years ago. And that idea and that notion therefore justifies violence

against people and against structures and monuments in the present. A lot of peo ple in the audience including myself found themselves nodding at the parallels. Setalvad, who has been a friend for a few decades, was precise and deliberate in what she communicated to the gathering, most of whom may not have known of what had transpired in and after 2002 in Gujarat. She spoke of the 174 individuals who had been convicted because of the courage and persistence of the survivors and activists. Of these 124 were given life. These were convictions that came often in the face of resistance from the State to the idea of justice. To understand what sort of effort that took, consider only how rapist-murderer convicts are today mollycoddled by the government in India which wants to release them for no reason other than bigotry. Many might not know now and many who knew will have forgotten that the Supreme Court had moved trials out of Gujarat, something that to the best of my knowledge has not happened since or before. Hallal spoke directly and with passion about how unjust was both the reality on the ground and the falsity of the narrative constructed to sustain it. That early settlers

Solidarity is important not only because as humans we should understand the suffering of others but because such participation is our duty

into Israel survived because of the aid of Palestinians he said, just as the early settlers into America had. What was happening in Palestine was not a religious conflict but one of the occupied against the occupier. He exposed how hollow it was to describe the settler colonialism as the coming together of a "land without people for a people without a land." He explained how the narrative that the Israel Palestine issue was "complicated" was merely something used to complicate a more simple reality. That of occupation and colonialism and the rewriting history with a particular agenda. The talk is on the Boston South Asian Coalition YouTube page and I would encourage all to see it.

Why I said I found this gathering interesting was that it is not uncommon for Indian groups in the US to be shown as backing the government in India. Particularly on such issues as what the government does to minority Indians and in events that are organised by the State ('Howdy'). This is especially and unfortunately true of my own Gujarati community, who are often shown as being at the forefront of this defence of State communalism. But there is another side to this and there are other Indians, many of them, who are opposed to the path we have taken in recent years. It is those who I joined on that day.

At the gathering I spoke briefly on what it was that Indians abroad

# **OLDNESS OF OLD DELHI**

he "oldness" of Old Delhi is surprisingly not an easy question to answer. Connaught Place, for instance, dates back to almost a hundred years but it is firmly part of New Delhi. The area around Mehrauli dates back to before settlements came about in what is today called Old Delhi. Thus, it is clearly not due to the fact that it's the oldest inhabited part of the city. The answer lies, perhaps, in unravelling the history of Old Delhi over the last few centuries. The city of Delhi has gone through multiple processes of building and rebuilding, with seven (or eight if one separates Lal Kot from Mehrauli) crucial incarnations. The earliest city lies around the area of Qutb Minar, where Anangpal Tomar's Lal Kot fort is situated. The newest part of the Delhi was constructed by Edwin Lutyens. The first Mughal Emperor Babur remarked that the decay or "total destruction" of Indian cities is instantaneous given its populous nature. However, the fifth Mughal emperor Shah Jahan built the seventh incarnation of Delhi called Shahjahanabad which continues to thrive.

Though Shah Jahan inherited elegant Mughal cities like Lahore and Agra, he was dissatisfied. His friend and contemporary Inayat Khan writes that Shah Jahan wanted a "pleasant site on the banks of river with a fort whose terraces "overlook the river." The region of Delhi was chosen while incorporating older cities of Sher Shah Suri and Feroze Shah. Shahjahanabad was characterised by its expansive gardens, open areas and the river Yamuna providing its inhabitants with a general sense of tranquillity. To the contemporary Delhiwalla, such a description



Contemporary Old Delhi fits the stereotypical or 'exotic' view of India that one witnesses in the caricatures made by a non-Indian unfamiliar with the city as well as the country

sounds like the opposite of Old Delhi. Saleh Kamboh, the court historian of Shah Jahan, mentions that the walled city of Shahjahanabad served as an alternative to t-he perceived chaos of Agra, along with its con-

gested urban development. Shahjahanabad went through many tumultuous changes after the death of Shah Jahan. A significant blow was Nadir Shah's invasion of Delhi in the aftermath of the death of Aurangzeb. Shah's primary intention was to loot, not conquer. He ordered a massacre which resulted in Chandni Chown being filled with corpses. Once Delhi's vulnerability was exposed, the Afghans, the Marathas and the Jats ravaged the city soon after. As the British took over the city, the Mughal patronage for the artists and poets of Delhi declined. Even before Bahadur Shah Zafar's reign, Delhi's decline was mourned by the poet Mir Taqi Mir: There was a city, famed

throughout the world, Where dwelt the chosen spirits of the age; Delhi its name, fairest among

the fair. Fate looted it and laid it desolate.

And to that ravaged city I belong.

Towards the end of the mutiny, Delhi's traditional elites i.e. its poets, artisans and chefs had lost their source of patronage. This included Mirza Ghalib, the Shakespeare of Urdu poetry.

Over the years Shahjahanabad's chaos has only increased. Apart from the unnerving crowd, enmeshed electric wires and construction material are the first impressions of most people who enter the space for the first time. Contemporary Old Delhi fits the stereotypical or "exotic" view of India that one witnesses in the caricatures made by a non-Indian unfamiliar with the city as well as the country.

As one walks through the lanes of Old Delhi, the smell of kebabs, biryani, sheermal, nihari and attar fills the air. Not all smells are pleasant. However,

the diverse variety as well as their intensity balance each other out. One of the things that characterises Old Delhi and plays a crucial role in retaining its "oldness" is its cuisine. The first two restaurants that one witnesses while entering Old Delhi through Gate no. 1 of Jama Masjid, are Karim's and Al-Jawahar. Karim's legacy goes back to a hundred years, being established by the descendants of cooks who worked at the royal Mughal kitchens. Al-Jawahar, which Jawaharlal Nehru is said to have inaugurated, also serves traditional Mughlai dishes. There is, at least, an attempt by these outlets and many others to provide authentic Mughlai dishes through the descendants who trace their ancestry and traditional recipes to the peak of Shahjahanabad. Moreover, the Kurtas and Burkhas that one witnesses in Old Delhi are in sharp contrast to the rest of the Delhi, which is rapidly modernising and whose denizens prefer to imitate American fashion. New Delhi, which resides in an altogether separate space

separate article. Delhi has gone through waves of migrations. We see, for instance, the refugee communities settling in places like Chittaranjan Park and Khan Market. A significant portion of Old Delhi's inhabitants, on the other hand, trace their ancestry to its seventh incarnation. Thus, they are the "old" inhabitants of the city. The continuity of the culture, the language, the cuisine as well as the people are what justifies Old Delhi's name.

# **Empowering the Pandemic Accord**



The COVID-19 pandemic taught us several lessons, many of which came at great cost. Chief among them Organisation's member states was that, despite years of rehearsals, the world was not prepared for a fast-moving outbreak of a novel infectious disease. Countries failed their own citizens, but the global response was even more inadequate. It was marked by an inexcusable absence of cooperation and coordination, ugly nationalism that included vaccine hoarding, and greed on the part of Western countries, which refused to share information, pathogens, and therapeutics. I would say that the response was - to use a word that may seem old-fashioned and out of favour in some quarters - sinful. The overwhelming lesson we learned the hard way is that no one is safe anywhere until everyone is safe everywhere. Could the wave of infections caused by the second Omicron variant have been avoided if the Global South had been vaccinated more quickly? We cannot be sure. But we do know that international cooperation is not compatible with nationalism, xenophobia, and new forms of colonialism. We need a form of globalisation that works for everyone, because while our world may be deeply fractured, we are all still in-

escapably interdependent.

In response to our collective failures, the World Health decided to negotiate a Pandemic Accord, an international legal in-

lifetime opportunity to improve the world we live in, especially for young people and future generations. Young people, in particular, suffered greatly during the pandemic:

the flexibilities in TRIPS, the  $\overline{\phantom{a}}$ World Trade Organisation's intellectual-property agreement. Compromise on this issue and others requires recognising that the private and public sectors must work together in the fight against infectious diseases. But above all, security, equity, and equal access to information, technology, and products must be at the heart of the Accord. People all around the world are desperate for hope. They want assurance that the future will be better than the past. Countries must recognise that adopting a give-andtake approach during the final negotiations is critical to reaching an agreement on the Pandemic Accord, which in turn could provide some muchneeded optimism. We must demonstrate through our deeds as well as our words that we live in a deeply interconnected world in which we share each other's burdens, even when times are difficult. Establishing an effective model of open and inclusive health multilateralism will deliver the crucial message that cross-border cooperation can deliver global solutions to global problems.

# **Sheikh tortured tribals: Probe team** PRESS TRUST OF INDIA

New Delhi, Feb 24: TMC leader Sheikh Shahjahan and his associates, accused of land grab and sexual assault under coercion in West Bengal's Sandeshkhali, would forcibly take MNREGA wages from poor tribal families and torture them for voting against the party, the National Commission for Scheduled Tribes (NCST) has learned.

Complainants told a threemember National Commission for Scheduled Tribes (NCST) team, led by its Vice-Chairperson Ananta Nayak, that the West Bengal Police allegedly "protected" Shahjahan and his accomplices.

The probe team is back in Delhi and is in the process of filing a report, which will be sent to the government. Nayak said that the panel has received more than 50 complaints of sexual harassment of tribal women and land grab by Shahjahan and his associates.

The riverine Sandeshkhali area in West Bengal's North 24 Parganas district -- situated on the borders of the Sunderbans, about 100 kilometres from

Kolkata -- has been on the boil for more than a month with protests against Trinamool Congress (TMC) leader Shahjahan, who is absconding, and his supporters.

'The NCST team learned that Shahjahan would instruct poor tribal people to give him their MNREGA earnings. And in case they had already exhausted it, he would ask them to borrow money from lenders and give it to him," Nayak said and added he has not seen anything "like this across the country'

The complaints, the majority of whom are Hindus, told the

probe team that the accused and his associates tortured people who voted for other parties in elections, the NCST vice-chairperson said. The panel learned that Shahjahan and his associates would ask local women to come for meetings late at night. torturing the family members of those who did not comply with his demands, he said.

"If the victim approached the police, they would not file an FIR or a complaint and instead ask the complainants to 'negotiate' with Shahjahan. The police backed the accused in this case, the NCST vice-chairperson said. The complaints also told the

NCST team that the accused would ask tribal families to hand over their land to him and release saltwater in the fields if they protested. Nayak said Shahjahan allegedly grabbed land of more than a thousand tribal and nontribal people in an area stretching more than 10 kilometres.

February 20, the commission issued notices to the chief secretary of West Bengal and the state's police head, asking them to submit factual and action taken reports on the matter within three days.

# '36% RS candidates have criminal cases'

The ADR and the National Election Watch analysed the self-sworn affidavits of 58 out of the 59 candidates in the frav for 56 seats in 15 states. The Rajya Sabha polls are scheduled for February 27

New Delhi, Feb 24: Thirty-six per cent of Rajva Sabha candidates have declared criminal cases against themselves while the average assets of candidates analysed stood at Rs 127.81 crore, according to poll rights body Association for Democratic Reforms (ADR).

The ADR and the National Election Watch analysed the selfsworn affidavits of 58 out of the 59 candidates in the fray for 56 seats in 15 states. The Rajya Sabha polls are scheduled for February 27.

Congress candidate from Karnataka G C Chandrashekar was omitted from the analysis due to poorly scanned documents. The analysis found that 36 per cent of the scrutinised candidates have declared criminal cases against themselves.

Additionally, 17 per cent of these individuals face serious criminal charges with one candidate having cases related to attempted murder. According to the analysis, eight (27 per cent) out of 30 BJP candidates, six (67 per cent) out of nine Congress candidates, one (25 per cent) out of four TMC candidates, two (67 per cent) out of three SP candidates, one (33 per cent) out of three YSRCP candidates, one (50 per cent) out of two RJD nominees, one (50 per cent) out of two BJD candidates, and one (100 per cent) BRS candidate have declared criminal

Moreover, the analysis delved into the financial backgrounds of the candidates. Approximately 21 per cent of the candidates are billionaires, boasting of assets exceeding Rs 100 crore. The average assets of Rajya Sabha candidates stand at Rs 127.81 crore. Congress nominee from

Himachal Pradesh Abhishek Manu Singhvi with total assets worth Rs 1,872 crore, Samajwadi Party nominee from Uttar Pradesh Jaya Amitabh Bachchan with assets worth Rs 1,578 crore and JD(S) nominee from Karnataka Kupendra Reddy with assets amounting to Rs 871 crore are among the top three wealthiest candidates, according to the

analysis. Among the poorest candidates are BJP's Madhya Pradesh candidate Balyogi Umesh Nath with assets worth over Rs 47 lakh. BJP's West Bengal candidate Samik Bhattacharya with assets worth Rs 1 crore and BJP's Uttar Pradesh candidate Sangita

with assets worth Rs 1 crore. While 17 per cent of the candidates have educational qualifications ranging from 5th pass to 12th pass, a significant 79 per cent hold graduate or higher degrees. A majority (76 per cent) of the candidates fall in the 51-70 age group with a smaller proportion (16 per cent) in the 31-50 age group. Only 19 per cent of the candidates are women, according\_\_\_ to the analysis.

Thousands of farmers have been staying put at Khanauri and Shambhu points on Punjab's border with Haryana along with their tractor-trolleys and trucks after their march to the national capital to press the Centre for various demands, including a legal guarantee of minimum support price (MSP) for crops, was stopped by security forces.

Last Wednesday, the 'Delhi Chalo' march, spearheaded by the Samyukta Kisan Morcha (Non-Political) and Kisan Mazdoor Morcha (KMM), was put on hold by farmer leaders for two days after a protester was killed and around 12 police personnel were injured in clashes at Khanauri. The incident took place when some protesting farmers were trying to head towards barricades.

Speaking to reporters at the Shambhu border point, KMM leader Pandher said they will announce their next course of action February 29

"It is certain that this agitation will continue as long as (our) demands are not met. If they (Centre) accept our demands tomorrow, we will take a decision on the agitation, he said.

# repeal Muslim Marriage Act

Guwahati, Feb 24: The Assam Cabinet has given its nod to repeal the Assam Muslim Marriages and Divorces Registration Act, 1935 in a bid to end child marriage, Chief Minister Himanta Biswa Sarma said

"This Act contained provisions allowing marriage registration even if the bride and groom had not reached the legal ages of 18 and 21 respectively, as required by law. This move marks another significant step towards prohibiting child marriages in Assam," the Chief Minister posted on X.

Opposition parties, however, termed the decision "discriminatory against Muslims" and "attempt to polarise voters in an election year". Congress MLA Abdul Rashid Mandal alleged that by taking a decision to repeal the Act in the year of Lok Saha polls, the government "was trying to polarise voters... It is nothing but a discriminatory decision against Muslims.'

The Goalpara (West) MLA added, "The government talks about Uniform Civil Code (UCC) and banning polygamy in the state but no such Bill or ordinance has been brought in the assembly so far for reasons best known to them."

"The BJP government is calling it (Assam Muslim Marriages and Divorces Registration Act, 1935) an obsolete Act and that registration of child marriages is happening under it, but that is not a fact. This is the only mechanism for registration of marriages and divorce for Muslims and is valid under the Constitution," he said.

**OPPOSITION PARTIES, HOWEVER, TERMED THE DECISION 'DISCRIMINATORY** AGAINST MUSLIMS' **AND 'ATTEMPT TO POLARISE VOTERS IN AN ELECTION YEAR'** 

The CM said that the district commissioners and district registrars will be authorised to take "custody of registration records" currently with 94 Muslim Marriage Registrars on the repeal of the legislation under overall supervision and control of the Assam Inspector General of Registration.

A one-time compensation of Rs 2 lakh will be provided to Muslim Marriage Registrars for their rehabilitation after the Act is repealed. The decision to repeal the Act was taken

at a late-night cabinet meeting Friday as it is an obsolete pre-Independence Act of the British for the then province of Assam, the CM said.

Registration of marriages and divorces is not mandatory as per the Act and the machinery of registration is informal, leaving a lot of scope for non-compliance with extant norms, he said. It was pointed out at the meeting that as per the provisions of the Act, there remains scope for registering marriages of intended persons below 21 years for men and 18 years for women and there is hardly any monitoring for implementation of the Act. AIUDF MLA Rafikul Islam alleged that the cabinet decision was taken with an "intention to target Muslims in an election year"."There were attempts to bring the UCC in Assam but they will not be able to do so as there are several castes and communities and they know it will not be legally tenable," he said.

# PM to inaugurate Sudarshan Setu today

New Delhi, Feb 24: Prime Minister Narendra Modi February 25 will dedicate to the nation Sudarshan Setu -- the country's longest cable-stayed bridge -- which will connect Okha mainland and Beyt Dwarka island.

# **US reverses West Bank policy**

Charleston (US), Feb 24: The new Israeli settlements in the West Bank are illegal and inconsistent with international law, US Secretary of State Antony Blinken has said, reversing a Trump-era policy.

Blinken, at a joint press conference with the Argentine Foreign Minister Diana Mondino in Buenos Aires, said he was disappointed with Israel's latest plans for settlement expansion.

"We have seen the reports, and I have to say we're disappointed in the announcement. It's been long-standing US policy under Republican and Democratic administrations alike that new settlements are counterproductive to reaching an enduring peace," Blinken said in response to a question.

'They're also inconsistent with international law. Our ad ministration maintains a firm opposition to settlement expansion. And in our judgement, this only weakens -- it doesn't strengthen – Israel's security," said the top American diplomat, a day after Israel's far-right Finance Minister Bezalel

WASHINGTON: India's consulate in Seattle has raised with authorities the case of Indian student Jaahnavi Kandula after the prosecution attorney said an overspeeding Seattle police officer who struck and killed her while responding to a drug overdose call will not face any criminal charges citing lack of "sufficient" evidence. Kandula, 23, from Andhra Pradesh, was struck by a police vehicle driven by Officer Kevin Dave when she was crossing a street in Seattle January 23 last year. He was driving 74 mph (more than 119 km/h) on the way to a report of a drug overdose call. Kandula was thrown 100 feet when she was struck by the speeding police patrol vehicle. In bodycam footage released by the Seattle Police Department, Officer Daniel Auderer laughed about the deadly crash and dismissed any implication Dave might be at fault or that a criminal investigation was necessary.

Kyiv, Feb 24: European **Commission President Ursula** von der Leven vowed that Europe would back Ukraine until it was "finally free" as she and three other Western leaders arrived in Kyiv to show solidarity on the second anniversary of Russia's fullscale invasion.

"More than ever, we stand firmly by Ukraine. Financially, economically, militarily, morally, Until the country is finally free," Von der Leyen, who came with the others on an overnight train from neighbouring Poland, wrote on the social media platform X.

The leaders visited Hostomel airport, site of a ferocious battle at the start of the invasion as Russia tried to fly in paratroopers

to seize the capital Kyiv a few kilometres away. Ukrainian President Volodymyr Zelenskiy embraced the Western leaders and delivered a televised speech against a backdrop of wrecked aircraft.

# Germany joins legal cannabis club

The country becomes the ninth nation to legalise recreational use of the drug, which is also legal in some sub-national jurisdictions in the US, Australia

Berlin, Feb 24: Germany Friday joined the small group of countries and jurisdictions that have legalised cannabis when the Bundestag passed a law allowing individuals and voluntary associations to grow and hold limited quantities of the drug.

The law passed by Chancellor Olaf Scholz's ruling three-party coalition legalises cultivating up to three plants for private consumption and owning up to 25 grams of cannabis.

Larger-scale, but still non-commercial, cannabis production will be allowed for members of so-called cannabis clubs with no more than 500 members, all of whom must be adults. Only club members can consume their product. "We have two goals: to crack down on the black market and improved protection of children and young people," Health Minister Karl Lauterbach

said at the start of a rowdy debate where the opposition accused him of promoting drug use.

You are asserting in all seriousness that by legalising more drugs we will contain drug use among young people,' said Christian Democrat legislator Tino Sorge. "That is the most stupid thing I've ever heard."

But Lauterbach said that this amounted to "sticking our heads in the sand": not only had cannabis use soared among young people, whose developing brains were particularly endangered. but drugs on the streets were both stronger and more impure nowadays, greatly increasing their harm.

Some 4.5 million Germans are estimated to use cannabis.

Germany becomes the ninth country to legalise recreational use of the drug, which is also legal in some sub-national jurisdictions in the United States and Australia.

Many more countries allow its medical use as a painkiller. Cannabis remains illegal for minors as does consuming it near schools and playgrounds.

Some legislators questioned whether the new regulations would have much impact on dealing, since those who are unwilling to grow their own cannabis or join a cannabis club may still prefer to buy the drug.

BYJU'S founder, CEO Byju Raveendran says *management remains* unchanged, a day after EGM by select investors to oust him and his family from the company

New Delhi. Feb 24: A day after investors of the troubled edtech firm BYJU'S voted for a leadership change, Byju Raveendran has penned a note to employees saying he continues to remain CEO and the management remains unchanged, as he dubbed Friday's EGM as a 'farce"

The note to employees assumes significance as it comes after BYJU'S shareholders (prominent investors) Friday voted for removing Founder-CEO Raveendran and his family from the board over alleged "mismanagement and failures" at what was once India's hottest tech startup, but the company dug in its heels, calling the voting done in absence of founders as invalid and ineffective.

In a note to employees Saturday, Raveendran alleged that a lot of essential rules were "violated" at Friday's



Extraordinary General Meeting (EGM).

"This means that whatever was decided in that meeting does not count, because it didn't stick to the established rules ... It is crucial for everyone to understand the specific issues that make this EGM a farce," he wrote. PTI has seen a copy of the

letter. Raveendran said he firmly believes that the truth will inevitably prevail, despite the "relentless trial by the media"

"I am writing this letter to you as the CEO of our company. Contrary to what you may have read in the media, I continue to remain CEO, the management remains unchanged, and the board remains the same," he said, adding it is "business as usual" at BYJU'S.

"To reemphasise, the rumours of my firing have been greatly exaggerated and highly inac-

curate," Raveendran said. Outlining what he claimed were "key discrepancies" at the EGM, he said the meeting was convened without fol lowing the proper procedure set out by the law and the company's Articles of Association.

"To pass any resolution the meeting needs to have a proper quorum, a set of people who are mandatory. Our articles are clear on the quorum requiring the presence of at least one founder director. Consequently, any resolutions taken at the meeting are not enforceable as per law," he said.

He also stated, "The claims made by a small group of select minority shareholders that they have unanimously passed the resolution in the EGM is completely wrong. Only 35 out of 170 shareholders (representing around 45 per cent of shareholding) voted in favour of the resolution. That in itself shows the very limited support that this irrelevant meeting received.

BYJU'S Founder CEO Raveendran Byju, his wife and brother -- the only three members on the company board as of now -- stayed away from the EGM called by a group of six investors, who collectively hold more than 32 per cent in Think & Learn (T&L), the firm that operates online tuition platform BYJU'S.

At the end, more than 60 per cent of the shareholders voted in favour of all the seven resolutions, which included removing the current management, reconfiguration of the board and a third party forensic investigation into acquisitions by the company, sources close to the investors said.

However, sources close to BYJU'S put the number at 47 per cent Friday.

Prosus -- one of the six investors who had called the EGM -- in a statement Friday said, "shareholders unanimously passed all resolutions put forward for vote".

# **Zurich Insurance** to buy 70% stake in Kotak General

New Delhi, Feb 24: Kotak Mahindra Bank Friday said Zurich Insurance Company has agreed to pick up 70 per cent stake instead of 51 per cent in its general insurance arm.

In November, Zurich Insurance Company had announced plans to acquire a 51 per cent stake in Kotak Mahindra General through a combination of capital infusion and share purchase, followed by a subsequent acquisition of an additional stake of 19 per cent within a period of three years from the initial acquisition.

"The parties to the aforesaid transaction, viz, the bank, Zurich, and Kotak General have mutually agreed that Zurich will acquire 70 per cent stake in Kotak General by way of a combination of primary and secondary acquisitions in a single tranche, for a total consideration of approximately Rs 5.560 crore, instead of the proposal announced in our earlier disclosure," the bank said in a regaction remain unchanged, it said. The proposed 70 per cent ac-

quisition would be subject to fulfilment of customary conditions precedent, including the receipt of regulatory approvals from the Reserve Bank of India (RBI) and the Insurance Regulatory and Development Authority of India (Irdai), it said.

As per the current regulatory guidelines, a foreign entity can own up to 74 per cent in an insurance venture in India.

"The plan includes additional fund infusion to restart the air-



line's operations," said a banker with a state-run bank that has exposure to Go First.

The bankers did not wish to be identified as they are not authorised to speak to the media.

Go First's resolution professional, who conducts the bankruptcy process, Singh and Spiceiet did not respond to emails seeking comment.

"Our bid for launching the airline remains confidential, guarded by the Committee of Creditors (CoC) until a successful bidder is announced." Nishant Pitti, majority shareholder of Busy Bee Airways, said.

The airline has also received a financial bid from Sharjahbased Sky One Airways which is lower than the competing bid,

one of the bankers said, without disclosing the amount. Sky One Airways did not im-

mediately respond to a request for comment.

Due diligence on the bids is expected to be completed next month, the second banker, also with a state-run bank, said.

Go First filed for bankruptcy in May last year. Its bankruptcy filing lists Central Bank of India, Bank of Baroda, IDBI Bank and Deutsche Bank among creditors to which the carrier owes a total of Rs 65.21 billion.

Creditors face haircut of 68% on admitted claims under IBC

New Delhi: The Insolvency and Bankruptcy Code (IBC) seems to be incentivising debtors to settle their defaults even before the cases are admitted under the code with over 27,500 applications for initiation of CIRPs with



an underlying default of Rs 9.74 lakh crore withdrawn before their admission, as per an analysis by Care Edge Ratings. The average time taken for resolution or liquidation continues to increase for operational creditors (OCs) and financial creditors (FCs) during the December quarter. Meanwhile, the overall recovery rate till Q3FY24 was 31.86 per cent, implying a haircut of approximately 68 per cent, the analysis said. The cumulative recovery rate has been on a downtrend, decreasing from 43 per cent in Q1FY20 and 32.9 per cent in Q4FY22 as larger resolutions have already been executed and a significant number of liquidated cases were either BIFR cases and/or defunct with high-resolution time, the analysis said. After slowing in the pandemic period of FY21 and FY22, the number of insolvency cases referred has increased by around 19 per cent y-o-y in Q2FY24. However, despite the increase, the number of cases admitted to the insolvency process continued to be lower compared to earlier quarters in FY20, the analysis said.

# Solar installations dip 44% in '23

New Delhi: India has reported a 44 per cent fall in solar installations at 7.5 gigawatt in 2023 due to land acquisitionrelated issues, research firm Mercom Capital said. According to the US-based research firm's latest report, a total of 13.4 gigawatt (GW) solar capacity was installed in the country in 2022. As of December 2023, the cumulative



installed solar capacity stood at 72 GW. Of which utility-scale projects accounted for 85.4 per cent, and rooftop solar accounted for 14.6 per cent, the report said. "In 2023, large-scale solar installations fell 51 per cent to 5.8 GW from 11.7 GW in 2022. Extensions granted to several large-scale projects and delays primarily due to land (acquisition) and transmission (connectivity) issues impacted capacity additions during the year. Large-scale solar accounted for 77.2 per cent of annual solar capacity additions, and rooftop solar contributed 22.8 per cent," it said. Rajasthan followed by Karnataka, and Gujarat were the top three states for cumulative large-scale solar capacity, accounting for 54.8 per cent of installations in the country as of December 2023. India's large-scale solar project pipeline stood at 105.3 GW, with another 70.6 GW of projects tendered and pending auction, the report said.

# WTO agreement to permanently prohibit countries from subjecting cross-border data and digital tools to customs duties and procedures REUTERS Bangalore, Feb 24: A global consortium of semiconductor

industry groups has asked India to reconsider its plan to push for duties on cross-border digital e-commerce and data transfers at an upcoming global trade meeting, warning that India's stance will stifle its own chip design industry.

Ministers from across the globe are convening for a World Trade Organization meeting in Abu Dhabi early next week to try to

discuss several trade-related issues, including extending a moratorium in place since 1998 on applying duties on electronic transmissions. Developing nations like India,

South Africa and Indonesia are set to oppose efforts by US and Europe to extend the moratorium. If no agreement is made, the moratorium would expire this year.

The moratorium collapse would mean tariffs on digital ecommerce and an innumerable number of transfers of chip de-



sign data across countries, raising costs and worsening chip shortages, the World Semiconductor Council (WSC) wrote to Indian Prime Minister Narendra Modi Thursday.

The chips sector is a key plank of Modi's agenda to push India's economic growth, with a \$10 billion incentive package in place to boost the Industry.

Duties on data transfers would "also impede India's efforts to advance its semiconductor industry and attract semiconductor investment, especially as more than 20% of the world's semiconductor design workforce is based in India," the group wrote in the letter, a copy of

Ranchi: Opening batter Yashasvi Jaiswal Saturday became only the fifth Indian to score 600 or more runs in a Test series, during the second day's play of the fourth match against England here. The 22-year-old Jaiswal joined Indian batting legends Sunil Gavaskar, Virat Kohli, Rahul Dravid as well as Dilip Sardesai to amass more than 600 runs in a Test series. It was in the away series against West Indies in 1970-71 that Gavaskar created the record of most runs for any

Indian batter in a Test series, garnering 774 runs. Gavaskar holds the distinction of being the only Indian to have scored more than 700 runs in a Test series on two occasions. The 'Little Master' also churned out 732 runs in six Tests when the West Indies toured India in 1978-79. The world record for most runs in a Test series is held by Australian batting legend Donald Bradman (974 runs in five Tests against England).
