### Seoul gives docs 4 days to end walkouts

Seoul: Junior doctors in South Korea have four days to end their walkouts. the government said Monday, or they could face prosecution or have their medical licenses suspended. About 9.000 medical interns and residents have stayed off the job since early last week to protest a government plan to increase medical school admissions by about 65 per cent.

### US airman dies after setting himself on fire

Washington: An active member of the US Air Force has died after setting himself on fire outside the Israeli embassy in Washington over the weekend in protest of the war in Gaza, the Pentagon said Monday. Emergency responders Sunday had rushed to the scene just before 1:00 pm (1800 GMT) in response to a "call for person on fire outside the Israeli Embassy," according to a message on X, formerly Twitter, by the capital city's fire department.

### Hungary's Parl ratifies Sweden's NATO bid

Budapest (Hungary): Hungary's Parliament voted Monday to ratify Sweden's bid to join NATO, bringing an end to more than 18 months of delays that have frustrated the alliance as it seeks to expand in response to Russia's war in Ukraine. The vote, which passed with 188 votes for and six against, was the culmination of months of wrangling by Hungary's allies to convince its nationalist government to lift its block on Sweden's membership. The government of Prime Minister Viktor Orban submitted the protocols for approving Sweden's entry into NATO in July 2022, but the matter stalled in Parliament over Opposition

by governing party lawmakers.

## **Farmers protest across Europe**

The protests are the latest in a series of rallies & demonstrations by farmers across Europe



### Brussels/Madrid/Warsaw, Feb 26: Farmers Monday blocked a border crossing between Poland and Germany, threw bottles at police in Brussels and gathered in Madrid to demand action on cheap supermarket prices and what they say is unfair compe-

tition from abroad. Agricultural ministers from across the European Union pledged to do more to cut red tape and help farmers as they convened in Brussels to discuss the crisis in the sector after weeks of angry protests.

The 27-nation EU has already weakened some parts of its flagship Green Deal environmental

policies, removing a goal to cut farming emissions from its 2040 climate roadmap. But farmers are demanding more.

Farmers clashed with police in Belgium Monday, spraying officers with liquid manure and throwing eggs and flares at them in a fresh show of force as the European Union's agriculture ministers met in search of ways to address the protesters' concerns.

"We're here again in Brussels today as farmers because the European Union is not listening to our demands. Our demands are for fair revenue," said Morgan Ody, general coordinator of farming organisation La Via Campesina. "We produce the food and we don't make a living. Why is that? Because of free trade agreements. Because of deregulation. Because the prices are below the cost of production. So we demand the EU to move on this." On the margins of the Brussels rally, riot police fired water cannon at protesters throwing bottles and eggs, while about 900 tractors jammed parts of the Belgian capital, not far from the cordoned-off area where ministers were meeting.

At a protest in Madrid, farmers from across Spain blew whistles, rang cowbells and beat drums, urging the EU to loosen regulations and drop some changes to its Common Agriculture Policy (CAP) of subsidies and other programmes.

"It's impossible to put up with these rules, they want us to work in the field during the day and deal with paperwork at night we're sick of the bureaucracy,' said Roberto Rodriguez, who grows cereal and beetroots in the central province of Avila.

In Poland, farmers angry with cheap imports from non-EU Ukraine blocked the A2 highway at a border crossing with Germany. The EU decided two years ago to waive duties on Ukraine's food exports as Kyiv battles a Russian invasion.

"This is a show of common solidarity, that both Polish and German farmers will not allow these goods from Ukraine to continue to enter the European market," said Adrian Wawrzyniak, a spokesperson for the Solidarity farmers' union.



Palestinian PM resigns

Palestinian Prime Minister Mohammad Shtayyeh convenes a cabinet meeting in Ramallah, West Bank

Ramallah, Feb 26: Palestinian Prime Minister Mohammad Shtayyeh announced his resignation Monday, as the Palestinian Authority looks to build support for an expanded role following Israel's war against the Islamist group Hamas in Gaza.

Shtayyeh's resignation must still be accepted by Abbas, who may ask him to stay on as caretaker until a permanent replacement is appointed.

The Palestinian Authority, created around 30 years ago as part of the interim Oslo peace accords, has been badly undermined by accusations of ineffectiveness and corruption and the prime minister holds little effective power.

But Shtayyeh's departure marks a symbolic shift that underlines Abbas' determination to ensure the Authority maintains its claim to leadership as international pressure grows for a revival of efforts to create a Palestinian state alongside Israel. In a statement to cabinet, Shtavveh, an academic economist who took office in 2019, said the next administration would need to take account of the emerging reality in Gaza,

which has been laid waste by nearly five months of heavy fighting. He said the next stage would "require new governmental and political arrangements that take into account the emerging reality in the Gaza Strip, the national unity talks, and the urgent need for an inter-Palestinian consensus".

In addition, it would require "the extension of the Authority's authority over the entire land, Palestine". No successor has been appointed but Abbas is widely expected to name Mohammad Mustafa, a former World Bank official who is chairman of the Palestine Investment Fund (PIF) with experience of rebuilding Gaza after a previous war in 2014. There has been no word on elections, which have not been held since 2006. The Palestinian Authority

exercises limited governance over parts of the occupied West Bank but lost power in Gaza following a factional struggle with Hamas in 2007.

It has been badly weakened over the years and surveys show it is deeply unpopular among Palestinians. But it remains the only leadership body generally recognised by the international community.

Lahore, Feb 26: Senior PML-N leader Maryam Nawaz, the daughter of three-time former prime minister Nawaz Sharif, Monday took oath as the first-ever woman Chief Minister of Pakistan's most populous and politically crucial Punjab province, a development described by her party as a "giant leap" for the country.

Maryam, the 50-year-old senior vice president of the Pakistan Muslim League-Nawaz (PML-N) party, took oath as the Punjab chief minister at a ceremony at the Governor House in the presence of her father Nawaz Sharif and uncle Shehbaz Sharif. She

earlier won the chief ministerial elections amidst a walkout by lawmakers of former prime minister Imran Khan's party-backed

Sunni Ittehad Council (SIC).

The headcount was done between October 15, 2023, to February 10 this year. In 2018, the survey had found 28 tigers in the state.

## PERMANENT COMMISSION IN ICG Women cannot be left out: CJI

New Delhi, Feb 26: Declaring that women cannot be left out, the Supreme Court Monday told the Centre to ensure that women are granted permanent commission in the Indian Coast Guard and said the court will do it if the government doesn't.

A bench comprising Chief Justice DY Chandrachud and Justices JB Pardiwala and Manoi Misra said this while taking note of submissions by Attorney General R Venkataramani that there were some functional and operational difficulties in granting permanent commissions to Short Service Commission Officers (SSCOs).

"All these functionality etc argument does not hold water in the year 2024. Women cannot be left out. If you do not do it, we will do it. So take a look at that," the CJI said. The attorney general also apprised the bench that a board has been set up by the Indian Coast Guard (ICG) to look into the issues.

'You must have women on

board," the bench said, fixing the plea for hearing Friday as

the matter could not be taken up due to paucity of time Monday. Previously, the bench had said that the maritime force must come up with a policy which treats women fairly.

The top court was hearing a plea filed by Indian Coast Guard officer Priyanka Tyagi seeking the grant of permanent commission to eligible women short-service commission officers of the force. "You speak of 'nari shakti'

(woman power). Now show it here. You are in the deep end of the sea in this matter. You must come up with a policy which treats women fairly," the bench had observed then.

It had also asked whether the Union was still adopting a patriarchal approach despite the judgments of the top court on the grant of permanent commission to women officers in the three armed forces – Army, Air Force and the Navy. "Why are you being so patriarchal? You do not want to see the face of women in the Coast Guard." the bench had asked.

## CM LAUNCHES NUA-O SCHOLARSHIP

Bhubaneswar, Feb 26: Chief Minister Naveen Patnaik launched the NUA-O Scholarship, with distribution of ₹28 crore worth sanction orders among 28,112 students of 57 colleges in Sambalpur, Deogarh and Angul districts, Monday.

5T and Nabin Odisha Chairman Kartik Pandian, as per the directive of the CM, visited the three districts and distributed the scholarship sanction orders among the eligible students.

"As many as 13,423 students from 21 colleges of Sambalpur district, 11,265 students from 25 colleges of Angul district and 3,424 students from 11 colleges of Deogarh district will get their scholarship amount in their bank accounts," the 5T Chairman said, while distributing the sanction orders.

He also interacted with students from 57 colleges of these districts.

According to sources, NUA-O Scholarship will be available for students pursuing UG and PG programmes in state universities and government and non-government aided colleges, including Sanskrit colleges under the Higher Education department.

Under the initiative, male students will get ₹9,000 annually, while female students will re-



ceive ₹10,000. Male students belonging to SC/ST and Nirman Shramik (construction worker) families will get ₹10,000, while female students of the categories will receive ₹11,000 annually. The NUA (Nutana Unnata

Abhilasha)-O initiative of the state government aims at empowering youth with continuous skilling, re-skilling, and upskilling opportunities. With a budgetary allocation of ₹385 crore for 2023-24 to 2025-26 fiscals, the initiative will cover all 30 districts, prioritising tribal and remote areas

and remote areas. Pandian said the decade of 2024-34 will be the era of the youth, who will be empowered by the state government to achieve the goal of NUA Odisha. "Like the empowerment ini-

tiatives for women through 15. Mission Shakti, major inter-

ventions for youth engagement, empowerment and development will be implemented in the next 10 years. The process has already started through the college transformation projects across the state. In this context, the NUA-O program has been launched last year and has been a major success and as a next step, the NUA-O scholarship program has been launched," the 5T Chairman said.

Pandian said that the government's next major initiative will be to cover all the students through the launching of the Nabin Odisha Magic Card which will be a 'passport to prosperity'. Online registration portal for the card will be launched March 5, 2024. And distribution of the card will begin August

> . "Based on points earned

through various activities and parameters, the cards will be upgraded to 'silver, gold and platinum' level. The cards will be allotted and upgraded based on the performance of student in terms of attendance, discipline, academic performance, participation in extracurricular activities, sports, online courses and personality development courses," he said.

These cards can provide access to various facilities like bus, train and flight concession, access to data recharge and Wi-Fi, e-libraries, online academic courses, personality development courses, coaching centres, skill development courses, career counselling, language courses including Odia and English, 'Earn While You Learn' opportunities and volunteering opportunities.

Banki, Feb 26: Election for the Banki Assembly segment in Cuttack district has turned out to be a prestige battle for the three mainstream political parties - BJD, BJP and Congress - as the announcement of dates for the 2024 election draws near, a report stated.

Bhadrak, Feb 26: The district headquarters hospital (DHH) here at Gelpur Monday remained tense following the death of a pregnant woman allegedly due to medical negligence, Sunday night.

The deceased was identified as Manjulata Ghadei, 28, wife of Abhimanyu Ghadei, a resident of Biridi village under Agarpada police limits in this district.

Sources said Manjulata complained of labour pain Sunday and was taken to Agarpada community health centre (CHC).

The woman was later shifted to the maternal and child health (MCH) unit of the DHH around 11:30pm. However, her family members alleged that doctors did not provide proper treatment to the woman till 2am, except for administering an injection.

Though her husband informed the doctors and nurses about the excruciating pain Manjulata was going through and requested them for a C-section delivery, they allegedly didn't pay any



heed. Later, after getting Abhimanyu signed on the necessary papers, doctors told him that they are going to conduct an operation on her wife

However, around 3am a nurse came out of the OT and told Abhimanyu that his wife Manjulata is no more. The irate family members and relatives of the deceased created ruckus at the hospital, leaving the hospital tense.

A helpless and frustrated Abhimanyu lodged a complaint at Bhadrak rural police station alleging medical negligence for his wife's death. He also demanded stringent action against persons responsible for Manjulata's death.

Police reached the spot and started an investigation into the matter after sending the body for post-mortem.

Chief District Medical Officer (CDMO), Bhadrak Santosh Kumar Patra said the condition of the pregnant woman was not critical. However, she died at 3am. "The exact cause of death will be ascertained once the postmortem report comes. Action will be taken against the guilty, if medical negligence is proved, he added.

## Traces of ancient civilisation found in Kuakhai riverbed

Bhubaneswar, Feb 26: Traces of an early period civilisation have resurfaced in Kuakhai riverbed near Cuttack with the discovery of several archaeological remains by a team led by co-convener of INTACH's Cuttack chapter Deepak Kumar Nayak.

The remnants of an old settlement that once flourished near Balimangala Devi Pitha, near Uttampur village under Cuttack Sadar block have resurfaced recently in a large area spread over the dunes about 200 metres from the present embankment.

The INTACH team found a large number of fragmented pieces of redware, blackware, grey ware, rings of mud well and bone pieces from a small mound-like structure inside the river. Pieces of sculpted images that were unidentifiable were also discovered. According to Nayak, the site has a lot of historical significance as it is situated midway between Barabati Fort and Chudangagada Fort in Barang.



Similar pottery and ware have also been found in the ongoing excavation work being carried on inside Barabati Fort by Archaeological Survey of India (ASI).

The type of potteries found are very much identical to those found in the excavated sites at places like Khalakatapatana, Manikapatana and Sisupalagada establishing that there has been significant maritime trade in the waterway of Kuakhai river in early centuries.

According to INTACH Bhubaneswar chapter sources, the findings suggested that there was either a riverside port or a large settlement in the place that had been abandoned due to frequent flooding.

A small-scale archaeological excavation in the riverbed is required to determine relevant history associated with these finds, they said, adding that INTACH will soon write to ASI and state Archaeology department to survey the area.

Biswajit Mohanty of INTACH thinks that the remnants have resurfaced due to erosion of the riverbed due to rampant sand mining. Mahanadi and its delta system have rich archaeological remnants spread on its riverbed and banks, he claimed.

During INTACH's recent comprehensive survey of the Mahanadi Valley, many new sites and heritage structures have been reported and documented.

The report also had details of 63 submerged ancient temples in the Mahanadi which are being destroyed and vandalised by illegal sand mining, Mohanty said.

## **Food Politics**

he All India Household Consumption Expenditure Survey 2022-23 report released on 24 February throws up interesting facts and figures about the patterns and preferences of different food items being consumed by rural and urban India. But, its timing and the main drift of the findings raise more questions than give answers. For, the survey has been made public 11 years after the last one. It is usually conducted by the National Statistical Office every five years, but the last report based on the survey in 2017-18 after the botched up Demonetization and implementation of the Goods and Services Tax (GST) was not released. The government cited "data quality" issues to stop its release. The Central government was criticised for not collecting and sharing proper data on the economy. The reason, as it could be justifiably presumed, was to hide from the electorate the stark reality of the havoc played with the country's economy by the ill-conceived Demonetization and shoddy implementation of the GST regime. The country is again in election mode now and the ruling alliance is in a better position to take on the Opposition. This seems to explain the release of the survey this time around.

There is another weighty reason for the timing of making the survey public. It suits the current dispensation's agricultural policies and electoral purpose. The farmers' agitation over legal guarantee of minimum support price for a slew of agricultural items is snowballing and threatening to be the BJP's Achilles' heel. The release of the survey and its contents may not only divert the attention from the angry farmers' agitation, but change the electoral-political discourse in a different gear.

The figures are being interpreted differently by different stakeholders to suit their political interests. But, the stark reality, as revealed by the survey, is that the poorest 5 per cent of India spend, on an average, merely Rs 46 daily in rural areas and Rs 67 in urban areas against the richest 5 per cent whose daily consumption is Rs 350 in rural areas and Rs 700 in urban parts, indicating a huge inequality in incomes.

The latest report showed that although the average Monthly Per Capita Consumption Expenditure (MPCE) in urban households rose to Rs 3,510 - an increase by 33.5 per cent since 2011-12 - and rural households to Rs 2008 that is a 40-42 per cent uptick, the jump is more owing to steep inflationary trends than any real rise in incomes. This is borne out by the fact that the proportion of spending on food, as the survey revealed, slid to 46.4 per cent from 52.9 per cent in 2011-12 in rural households, while it dropped from 42.6 per cent to 39.2 per cent in the corresponding period for urban households. The figure points to two possibilities - either people are cutting down on spending on food because of high retail inflation or have been relieved by the government's free ration scheme to 80 crore Indians. The MPCE figures are based on data collected from 2,61,746 households, of which 1,55,014 were in rural areas, spread over all states and Union Territories.

Interestingly, Sikkim's MPCE is the highest among Indian states at Rs 7,731 in rural and Rs 12, 105 in urban households. Chhattisgarh is at the bottom of the ladder where the MPCE is Rs 2,466 for rural and Rs 4,483 for urban households.

A BJP apologist predictably finds the survey results highly encouraging for the country's state of economy under the current dispensation. The data relied on for this is the household consumption expenditure for the year 2022-23 which shows per capita monthly household expenditure more than doubled in 2022-23 as compared to 2011-12. From this the conclusion that the ruling party draws is that the government's poverty alleviation measures have been successful

An interesting finding is the kind of food items on which people are spending more or less. The share of cereals and pulses within overall food consumption expenditure has come down both in rural and urban areas. But, the share of spending on milk has increased to an extent that it has overtaken that on cereals and pulses combined in 2022-23. The same also applies to fruits and vegetables, i.e. foods high in vitamins and minerals.

The political implication of these findings is that the demand for a 'legal guarantee" to MSP is mainly from farmers of 23 crops, including foodgrains and sugarcane. But the farm sector's growth is being led by livestock, fisheries and horticulture crops which are outside MSP purview.

All these lead to the inescapable conclusion that one main objective

armers are once again barricading roads and highways to the national capital. It seems like a repeat of what happened three years ago, when the three farm laws tabled in Parliament had to be withdrawn due to farm unrest. This time the agitation is for a law to make Minimum Support Price (MSP) a legal guarantee. MSP was introduced in 1967 and is a price support scheme which covers 23 crops, including cereals, pulses, oilseeds and commercial crops like copra and cotton. Sugarcane also has support prices given both by the Centre and the states. But the MSP scheme does not have statutory backing in law. The MSP for crops is set every year on the advice of the Commission for Agricultural Costs and Prices. That advice may or may not be taken fully by the Union Cabinet. Further, even after announcement of MSP for various crops, it is enforced only for a few crops, mostly for wheat and rice. The Union government (along with some state governments)

procures wheat and rice at MSP. The procurement benefit goes only to a few select states. The mandi tax collection which goes to state governments is proportional to the amount of procurement. For a state like Punjab, it is a significant source of the state's revenue. Some states like Madhya Pradesh have occasionally applied MSP based procurement to pulses also. In Maharashtra the government tried to enforce MSP based procurement of pulses on all private traders, who were immediately up in arms and refused to cooperate. Maharashtra was hoping that higher prices could be extracted from private traders and need not be paid from the state's own budget. That scheme had to be given up. So, MSP in practice only helps rice and wheat farmers, and that too those who have large marketable surpluses, and who seem to be confined to Punjab, Haryana and western Uttar Pradesh.

Is converting MSP into a legal guarantee a bad idea? Not really. For several reasons. Firstly, it won't be a fiscal disaster as some fear. MSP comes into the picture only when free market prices dip below, which on an average will happen only half the time. Secondly, as soon as the government intervenes to procure crops, the prices start moving up negating the need to continue indefinitely. Thirdly, in effect it is a price insurance mechanism, needed because forward markets and commodity derivatives markets are not fully developed and are beyond the reach of most farmers.

Crop prices are extremely volatile and need some insurance coverage, and MSP is like an "option" which protects the downside. The PM Fasal Bima Yojana has not been as effective in providing insurance against a fall in prices. Fourthly, the proposed MSP "guarantee" is much like the rural employment guarantee (NREGA) which works as a proxy for unemployment insurance. That scheme has proved to be a safety net during times of distress such as famines, droughts or a pandemic. Similarly, MSP guarantee is a proxy for price insurance absent forward markets. Sixth, the time has come for an MSP law because of the several woes of farming households. Hence it is no longer relevant to merely evaluate the

prospect of a law in terms of costs and benefits. Farming households are in distress.

Stepping away from the MSP issue, let's look at some stylised facts. The most stark and relevant data for farm households is that from the 70th and 77th rounds of the National Sample Survey, which had a Situation Assessment of Agricultural Households, respectively in 2013 and 2019. During this period, the farm household saw wage income overtake income from cultivation. And monthly household income at around Rs 10.000 in 2019 is far below the national average. The level of indebtedness remains constant at around 50% of households. Much of the debt is for current expenses and consumption and not for investment purposes. In fact, the farmers' income growth has slowed down from 3.4% per annum during 2004 till 2011 to 2.5% p.a. from 2012 till 2019. Keep in mind, that national income was rising much faster during these periods. So, farming households are falling behind, and it is no wonder that poverty is largely confined to agricultural or rural households. The government had announced in 2016 that farmers' incomes would double by 2022, but that did not happen. A recent government release says it did double in ten years from 2011 onwards, but that includes imputed income of free food distributed under the National Food Security Act.

Farm sector woes are many. Risks arise from multiple sources. Price volatility, climate change induced unseasonal wet and dry spells, pest attacks, world geopolitics spiking prices, frequent bans on exports deny ing farmers windfall gains, and an anti-farmer pro-urban consumer bias in policies. The adverse terms of trade for farm goods vis-à-vis industrial goods or services, and the frequent ban on exports is like a de facto tax on farm incomes. So those people who complain that farm incomes are not taxed, are not fully cognisant of the burden on the farmer. To add to these woes, land fragmentation is relent less and continues in every successive generation. India now has 141 million small land parcels, double of what we had 50 years ago. Smaller land parcels mean lower productivity and less scope for exploiting economies of scale. Nearly 90% farming households have less than two hectares of land holding. How can their income growth keep pace with national GDP growth? Productivity is low and they are stuck in farming, because there are no large scale, higher paying, secure jobs available in the industrial or services sector. Indeed, the lack of large-scale employment creation outside of farming is a major cause of farm sector woes in India. The sustainable solution to farm distress lies outside of agriculture, in industry and services. Meanwhile several initiatives like the mandi law reform, relaxing export bans, allowing contract farming, credit to tenant farmers, incentives for crop diversification, electronic linking of mandis, all these make a difference, large or small. In this messy and second-best world, the enactment of MSP law, without being fiscally too costly, will give a strong positive signal.

Mitsotakis made a forceful plea for proceeding with India-Middle East Economic Corridor (IMEC) despite the continuing conflict in Gaza. This corridor was conceived as a counterweight to Beijing's BRI which made the participating countries debt-prone and impaired their sovereignty. The founding members of IMEC could not meet due to the war in Gaza. Also, Israel's Haifa port owned by Adani Group was expected to be a key point for the ship-and-rail route proposed under IMEC. As per the Commonwealth War Graves Commission, 518 identified soldiers of undivided India defending Southern Europe in World War-I were buried in Greece. A Greek national Dimitrios Galanos born in Athens spent 47 years in India. He translated Indians scriptures

Both countries are 'prisoners' of geography. But their strategic locations are important to the global system and geopolitical prosperity. Recent events in Red Sea have demonstrated that the security of East Mediterranean region where Greece is located virtually depends upon the stability of the Indian Ocean region. That is why perhaps Greece decided to join the Indo-Pacific Ocean Initiatives launched by India during its G20 presidency. Greece has the world's biggest merchant fleet, and its geographical position makes it an ob-

vious partner for the project. On trade and commerce, India exports aluminium, organic chemicals, fish and crustaceans, plastics, textile articles, chemicals, iron and steel. It imports from Greece minerals, mineral fuels, oil, sulphur, aluminium foil, mineral oils, lime and cement, products for their distilPrime Minister, who was accompanied by senior officials and business executives, several agreements were signed. These related to collaboration on startups, cooperation in shipping and connectivity, collaboration in higher education, support in defence, cyber security, maritime security and counter terrorism.

Mitsotakis said India should be a corner stone of Europe's foreign policy. In any case, this is certainly the case for Greece. The leadership in Greece has been pushing for a closer India and EU relations. In particular, Athens is nudging the EU to sign the Bilateral Trade and Investment Agreement between EU and India. These legislative reforms mark a crucial step towards enhancing the efficiency, transparency, and accessibility of the country's legal system. One of the key objectives of these new laws is to make the criminal justice system more citizen-friendly by introducing measures such as online filing of FIRs, digital evidence submission, and video conferencing for court proceedings. By leveraging modern technologies, the aim is to streamline procedures for investigation, arrest, bail, trial, and appeal in criminal cases. Additionally, the introduction of new offenses like terrorism, secession, and subversion reflects an effort to address contemporary challenges and ensure that the legal framework remains relevant in a rapidly evolving societal landscape. With provisions allowing FIRs to be filed online and enabling individuals to approach any police station within their state or Union -Territory, regardless of the location of the crime, barriers to accessing legal recourse are expected to diminish. ## PM's Kerala visits spark political fervour

Thiruvananthapuram, Feb 26: Ahead of the Lok Sabha polls, Prime Minister Narendra Modí is making his third visit to Kerala in less than two months with the aim of fulfilling his dream of ending the electoral drought for the BJP in the southern state, where the party has historically faced challenges in winning elections.

Almost a year ago, Modi unveiled his party's aspiration to secure power in Kerala. The announcement, made on March 2, 2023, came following the BJP's notable performance in elections within the Christian-majority states of Nagaland and Meghalaya, boosting confidence within the party.

According to party sources, Modi is scheduled to arrive in the Kerala state capital Tuesday for an official programme, where he will also participate in the concluding ceremony of the 'padayatra' organised by the BJP's state unit.

While the state BJP is elated by the back-to-back visits of the Prime Minister to Kerala, hoping to win a few seats in the Lok Sabha polls in the southern state, both the CPI(M) and the Congress assert that the lotus will not bloom in the muddy political waters of the southern state.

Encouraged by the Prime Minister's flurry of visits to Kerala as the state braces for the upcoming Lok Sabha elections, Sandeep Vachasapathi, spokesperson of Kerala BJP, expressed confidence in the party's prospects, citing increased focus from the central leadership and

He dismissed concerns about past electoral setbacks, banking on Modi's charisma to overcome obstacles and secure electoral success for the BJP in Kerala. The BJP functionary said that their duty is to meet Modi's expectations, noting a rise in the PM's popularity among Kerala's people.

"According to surveys, about 40 per cent of voters in the state see Modi as the next Prime Minister of India," he claimed.

Vachaspathi said that a noticeable change is visible in favour of the BJP on the ground compared to the 2014 and 2019

cruitment of Assam Chief Minister Himanta Biswa Sarma, formerly of the Congress, as an example of this alleged political opportunism.

He asserted that such tactics would not succeed in Kerala, implying that Modi is yet to understand this reality.

Dismissing the notion that Modi's personal image would sway voters in Kerala, the CPI(M) politburo member said that the BJP has only managed to secure one seat in the Kerala Assembly way back in 2016.

According to Baby, any significant breakthrough for the BJP in Kerala would require cooperation from the Congress and the UDF, which he doubted would occur due to the risk of damaging their credibility.

"Therefore, the repeated visits by Modi would not pose a threat to the CPI(M) and its allies in Kerala," he told PTI.

Senior Congress leader Kodikkunnil Suresh reiterated the state's resistance to the BJP, citing concerns among minorities about their safety under BJP rule.

"Let Modi come to Kerala many times; there will not be any change in the anti-BJP approach of the people of the state. Because the majority of voters align with the democratic-secular sections of society," he said.

Suresh, one of the senior most members in the Lok Sabha, criticised Modi's alleged inaction on issues like the Manipur violence, asserting that the BJP's attempts to court the Christian community would falter due to apprehensions about right-wing groups.

## Human-animal conflict: Kerala sees decline in fatalities

THE HILLY DISTRICT **OF WAYANAD HAS BECOME THE CORE AREA FOR HUMAN-ANIMAL** CONFLICT

Thiruvananthapuram, Feb 26: Amid escalating protests against wild animal attacks threatening lives and property in Kerala, particularly in the hill district of Wayanad, recent data from the State Forest Department shows that human fatalities resulting from such encounters have notably declined over the past three years.

According to Forest depart ment data available with the PTI, the number of fatalities due to elephant attacks in Kerala during the period 2023-2024 decreased compared to numbers recorded in 2021-2022

In Kerala, 17 people lost their lives in elephant attacks during 2023-2024. This is a decrease from the 27 deaths reported in 2022-2023 and 35 in 2021-2022, it says.

These numbers, when compared to states like Odisha, Jharkhand and Karnataka, that are infamous for human-animal conflict, are much lesser. According to Forest sources in Jharkhand, over 100 people are killed annually in elephant attacks on an average.

The Karnataka Forest department reported 148 human fatalities due to human-elephant conflict in the last five years. Additionally, Odisha, Assam,



and West Bengal collectively lost 499, 385, and 358 people, respectively in human-animal conflicts over the same five-year period, as stated by the Union Ministry of Environment and Forests in response to an RTI query. The Kerala Forest department

data shows that over the past five years, fatalities from wild boar attacks have shown a significant increase in the state.

In 2016-2017, only four human casualties were reported in wild boar attacks, but by 2023-2024, this number had risen to 11, revealed the data.

Conversely, tiger attacks have resulted in one death per year for the last four years. Additionally, in 2023-2024, three deaths were reported due to Indian gaur attacks

According to the data, instances of injuries in wild animal attacks have also decreased. The highest number of injuries was reported during the 2020-2021 period, with 988 cases recorded. However, this number decreased to 758 during the

2021-2022 period, says the data. Officials have highlighted that current data includes snake bite deaths in the tally of fatalities from wild animal attacks, potentially leading to a misleading perception of the numbers. In Kerala, the hilly district of Wayanad has become the core area for human-animal conflict. Similar cases are also reported in Aralam in Kannur,

Coimbatore-Palakkad border areas and in various areas of Idukki district.

Amid heightened protests in Wayanad following the recent deaths of two persons in elephant attacks, state forest officials underscored the necessity for coordinated efforts among all departments to prevent such incidents.

"Prevention of human-animal conflict is not an exclusive forest department work. Many other departments like revenue, LSGD and police also have an active role. All these departments have been working together with us to do whatever best we could do," D Jayaprasad, Principal Chief Conservator of Forests and Chief Wildlife Warden (PCCF&CWW), Kerala told PTI.

"We are implementing mitigation measures, including the development of a 'smart-fence'

system for tigers and elephants, with a model set to be erected in the Chethalayam range in Wayanad," said Jayaprasad, who was present in Wayanad during violent protests triggered by recent elephant attacks resulting in two fatalities.

He said that the Kerala Forest Department has also urged a team from the Ministry of Environment and Forests, which has arrived in Wayanad, to conduct an animal carrying capacity study not only within the hill district but also in the neighbouring forest areas of Tamil Nadu and Karnataka.

'We have told them that if the study finds excess animals above the carrying capacity, then we will translocate them," he added.

The official said there has been a remarkable improvement in the dispensation of compensation to the livestock and crop loss in wildlife attacks.

"Not even a penny will be pending towards compensation payment. All the backlogs have been cleared by the present government and we are getting excellent support from the Chief Minister to find a solution for the problem," Jayaprasad added.

'We have proposed a 50 per cent hike in compensation for fatal attacks and a two-fold increase in damage compensation to agriculture. This proposal is now under the consideration of the cabinet," another official said.

According to conservation and animal experts, the government and its departments only look for temporary solutions based on the intensity of the public protest.

New Delhi, Feb 26: The National Commission for Scheduled Tribes has issued notices to the Centre and the West Bengal government, seeking factual and action-taken reports on the issues of child marriage, human trafficking, human-wildlife conflict and corruption plaguing the state's Sundarbans region.

The commission issued the notices last week following a representation from rights activist and Supreme Court lawyer Radhakanta Tripathy. The tribal population (2,11,927) in the region, comprising primarily the Munda, Santhal, Bhumij and Oraon tribes, remains marginalised despite being the earliest settlers, Tripathy said in his representation to the National Commission for Scheduled Tribes (NCST). He highlighted that child marriages were prevalent in the Sundarbans, a cluster of lowlying islands in the Bay of Bengal famous for its unique mangrove forests. It is common for girls to marry at 15-16 years. Around 15 cases of underage marriages are reported annually in the Hasnabad panchayat, Tripathy

said, adding that conservative attitudes contribute to the high rate of child marriages. Human trafficking is a major concern, with West Bengal ranking second in the number of missing women and girls, the activist said.

According to the National Crime Records Bureau (NCRB), 1,56,905 women and 36,606 girls were reported missing in the state in 2019-20."Traffickers exploit economic needs, dysfunctional families, romantic relationships, and mental disorders. Lack of education and poor socioeconomic conditions in North 24 Parganas villages are major factors," the representation said.

The rights activists said the struggle for survival of indigenous people in the Indian Sundarbans, home to over 100 tigers, is intensified by environmental challenges, leading to human-animal conflicts and hardships for affected families. He pointed out that illegal construction and environmental violations in Ramsar sites, including the East Kolkata Wetlands and the Sunderbans, have been highlighted in a recentaudit report by the Comptroller and Auditor General (CAG).

Prayagraj, Feb 26: Hindu prayers will continue in the southern cellar of the Gyanvapi mosque in Varanasi, the Allahabad High Court said Monday while dis-missing a plea that had challenged the district court's order to this effect

### 'Made mistake by retweeting video defaming BJP'

### PRESS TRUST OF INDIA

New Delhi, Feb 26: Delhi Chief Minister Arvind Kejriwal Monday told the Supreme Court that he made a mistake by retweeting an allegedly defamatory video circulated by YouTuber Dhruv Rathee related to the BJP IT Cell.

A bench of Justice Sanjiv Khanna and Justice Dipankar Datta, without issuing notice on a plea of Kejriwal challenging a Delhi High Court order which upheld summons issued to him as an accused in the criminal defamation case, asked the complainant whether he wanted to close the matter in view of the Chief Minister's apology.

The bench also asked the trial court not to take up the defamation case involving Kejriwal till March 11. Senior advocate Abhishek

Singhvi, appearing for Kejriwal, said, "I can say this much that I made a mistake by retweeting." He added that it is a case for retweeting on social media platform 'X' and the complaint filed was immediately followed by recording of pre-summoning evidence.

Thereafter, the complaint was withdrawn. When it was refiled, after nine months of the retweeting, it was suppressed that the original complaint was withdrawn," the senior lawyer said."Look, you are on a technical point, that may not be good enough," Justice Khanna said and asked Singhvi to show the picture of what was retweeted.

After perusing the retweeted message, the bench said, "When it comes to the question of retweeting, there may be two ways of looking at it. First, it may be an endorsement, which may have consequences. The other is say you spot something on the platform and share it for information. Will all these not be a matter of evidence in the case." Singhvi said that the High Court has taken a view.

**RWS&S** Division, Sundargarh OIPR-25009/11/0003/2324 New Delhi, Feb 26: An interesting news caught the attention of many Indians this past week. It was primarily an expose about the Russian Army recruiting scores of young Indians to fight in the war against Ukraine.

Those in the know were aware that modern warfare was starting to accept the existence of organizations like the Wagner group which was tasked with the initial invasion of Ukraine.

Wagner was a private army headed by Yevgeny Prigozhin who later died under mysterious circumstances when his aircraft exploded before landing at Moscow. Some claim that the young Indians,

aged between 22 and 31 were hired as 'helpers in the military establishment in Russia'

However, after the frontline death of Hemal Ashwinbhai from Gujarat last week, the matter drew serious notice globally.

The Government of India first claimed

it had no knowledge of any Indian national joining the Russian Army.

Later after the death of an Indian soldier it changed tack and admitted some young men had been 'duped' by recruiters and 'these Indian nationals have enlisted for support roles with the Russian Army'.

The BBC has extensively reported on this issue and reports from other sources claim these men were willingly enlisted as there were no job opportunities for them at home now.

The Ministry of External Affairs admitted February 26 that several Indians who joined the Russian Army were already discharged after such cases were "strongly" taken up with the Russian authorities.

The Ministry said it has "seen some inaccurate reports in the media regarding Indians with the Russian Army seeking help for discharge." Under pressure of the MEA, the Russian Army has discharged these men from their duties. Now they will come back home jobless and without an income

PPBL has reconstituted its Board of Directors with the appointment of Ex-Central Bank of India Chairman Srinivasan Sridhar, retired IAS officer Debendranath Sarangi, former Executive Director of Bank of Baroda Ashok Kumar Garg, and former IAS officer Rajni

Sekhri Sibal, Paytm said in a regulatory filing Monday. These persons had recently joined as Independent Directors, it said

One 97 Communications Ltd (OCL) is the owner of the Paytm brand.

'The company has been separately informed that Vijay Shekhar Sharma has also resigned from the Board of Paytm Payments Bank to enable this transition. PPBL has informed us that they will commence the process of appointing a new

Chairman," the filing said. OCL supports PPBL's move of opting for a board with only independent and executive di-

New Delhi, Feb 26: India Monday called on WTO members to find a permanent solution to the long-pending public food stockpile issue, saying it is directly related to achieving the sustainable development goal of zero hunger by 2030

Commerce and Industry Minister Piyush Goyal said that the World Trade Organisation (WTO) should not negotiate rules on nontrade-related subjects like climate change, gender, and labour and rather these should be ad dressed in respective intergovernmental organizations.

"I re-emphasize that the development agenda would remain incomplete without a permanent solution on public stockholding (PSH) for food security purposes which is directly related to achieving the Sustainable Development Goal of Zero Hunger by 2030," Goyal said.

"This continues to be a longpending issue for the last few decades and despite having a clear mandate agreed by the members in the past, finding a permanent solution on PSH remains an unaccomplished agenda on which we have to deliver in MC13".

Trade ministers of 164 WTOmember countries are gathering in Abu Dhabi for the 13th ministerial conference (MC13). The highest decision-making body started the four-day meet on February 26 in the UAE.

The PSH programme is a policy tool under which the government procures crops like rice and wheat from farmers at the minimum support price (MSP) and stores and distributes foodgrain to the poor.

Under the global trade norms, a WTO member country's food subsidy bill should not breach the limit of 10 per cent of the value of production based on the reference price of 1986-88. India has been seeking amend-

ments to the formula for calculating the food subsidy cap.

As an interim measure, the WTO members at the Bali ministerial meeting in December 2013 had agreed to put in place a mechanism popularly called the Peace Clause and committed to negotiating an agreement for a permanent solution. Under the Peace Clause, WTO

members agreed to refrain from challenging any breach of the prescribed ceiling by a developing nation at the dispute settlement forum of the WTO. This clause will be there till a permanent solution is found to the food stockpiling issue.

Goyal also said that In India. fishermen largely undertake sustenance fishing which addresses hunger, poverty, food and nutrition insecurity of millions of traditional fishers.

Ranchi, Feb 26: India's home supremacy weathered the 'Bazball' storm as Rohit Sharma's men secured a hard-fought fivewicket win over England in the fourth and penultimate Test for a 17th consecutive series triumph in their own backyard here Monday, handing a harsh reality check to the visitors' unidimensional approach.

Overnight 40/0 in a chase of 192 here, India romped home after surviving a few hiccups with the opening duo of skipper Rohit Sharma (55, 81b, 5x4, 1x6) and Yashasvi Jaiswal (37, 44b, 5x4) providing the perfect platform for others to build with their 84-run stand on day four of the match.

There were some jitters after the two departed in close succession followed by Rajat Patidar and Ravindra Jadeja's dismissal but Shubman Gill (52 n o, 124b, 2x6) and Dhruv Jurel (39 n o, 77b, 2x4) guided the side past the finishing line with an unbeaten 72-run partnership.

Left-arm spinner Tom Hartley (1/64) took the prized scalp of Rohit, while Shoaib Bashir was the most successful English bowler, scalping 3/79 in the second innings for a match haul of eight wickets.

India lead 3-1 in the series with the last game scheduled in Dharamsala from March 7. The team's last home series loss was a 1-2 defeat to an Alastair Cookled England in 2012-13. Since

Bashir operated from the other end as runs came thick and fast for India, be it in singles or in boundaries.

The duo swept and reverse swept to tackle the low bounce from the spinners with Rohit playing the lead role in the partnership. He also got past 9,000 runs in first-class cricket.

With nothing going their way, Stokes brought in Root to unsettle the rhythm and the parttimer did just that by exploiting the rough against the Indian left-hander. Jaiswal failed to control his inside-out shot and Anderson pulled off an absolute stunner with a forward diving catch at backward point.

Stokes was quick to take Root out of the attack and operated with his two spin twins in Bashir and Hartley, who did a decent

job in stopping the run flow. Hartley was rewarded for his miserly spell with the prized scalp of the Indian captain.

Rohit came down the track only to be beaten by the flight and spin from Hartley and Ben Foakes did the needful behind the stumps. Though Rohit was way out of the crease, he was adjudged caught behind after getting a faint tickle on the way to

the wicketkeeper. Bashir sent back Jadeja and Sarfaraz off successive deliveries right after the lunch break. The Indian chase began to unravel with those dismissals but Gill and Jurel teamed up to steady the ship. And they ensured India of no further hiccups taking the hosts home comfortably.

Dubai: India consolidated their second spot in the World Test Championship (WTC) standings following their win against England in the fourth Test in Ranchi Monday. India's point-percentage jumped from 59.52 to 64.58 follow ing the hard-fought win and they further extended the gap with Australia (55%) and Bangladesh (50%), third and fourth-placed teams, respectively. England, on the other hand, are languishing at eighth with 19.44%, just a spot ahead of bottom-placed Sri Lanka, who are yet to open their account. India have so far played eight Tests in the current WTC cycle, winning five, losing two and drawing one match. New Zealand are leading the standing with 75 percentage points and have played just four Test so far.

### **TRIO INVITED FOR NAT'L TRIALS**

New Delhi, Feb 26: The Wrestling Federation of India (WFI) Monday invited protesting grapplers Bajrang Punia, Vinesh Phogat and retired Sakshi Malik to come for the national trials in March to select the team for two Asian competitions, including the 2024 Paris Games Qualifiers in Kyrgyzstan.

One of the conditions put by the United World Wrestling (UWW) while lifting the suspension on WFI earlier this month was that the three grapplers would not be discriminated against for protesting against former national federation chief Brij Bhushan Sharan Singh.

The three have been demanding the arrest of Brij Bhushan for his alleged sexual harassment of women wrestlers. The sports

ministry had also suspended the WFI last year in the wake of the serious allegations and instituted an ad-hoc panel to run the affairs of the sport. The ministry had also ordered fresh elections, which were held in December last year, but the newly-elected body was suspended by the ministry three days after its formation for not giving enough time to age-group wrestlers to prepare and travel before announcing the dates for the nationals. The ministry again instituted a three-member ad-hoc panel to run the affairs.

The WFI, while announcing the trials March 10-11, also included the names of Bajrang (65kg), Vinesh (55kg) and Sakshi (62kg), who had announced her retirement from the sport in "frustration" the day Sanjay <del>(</del> Singh was elected president.
