### **US SC restores**

Washington: The Supreme Court Monday restored Donald Trump to 2024 presidential primary ballots, rejecting state attempts to hold the Republican former president accountable for the Capitol riot. The justices ruled a day before the Super Tuesday primaries that states cannot invoke a post-Civil War constitutional provision to keep presidential candidates from appearing on ballots. That power resides with Congress, the court wrote in an unsigned opinion. The outcome ends efforts in Colorado, Illinois, Maine and elsewhere to kick Trump, the front-runner for his party's nomination, off the ballot.

At least 10 people were injured when a blast took place at Rameshwaram Cafe in Brookfield in East Bengaluru March 1. So far, Karnataka Police's investigation of the blast has been assisted by officials of the NIA. National Security Group (NSG) and Intelligence Bureau (IB). A man wearing a cap, mask and glasses is the prime suspect in the case and is still untraceable, the sources said. The explosion is suspected to be carried out through an Improvised Explosive

### HC annuls Congress MLA Moquim's 2019 election Cuttack, March 4: The Orissa

High Court Monday declared the election of Congress leader Mohammed Moquim from the Cuttack-Barabati Assembly seat in 2019 as null and void.

Adjudicating over a petition

filed by BJD leader Debasis Samantray, Justice Sangam Kumar Sahoo annulled the election of Moquim for failing to furnish detailed criminal antecedents during the time of filing his nomination in April 2019. Samantray, a BJD leader and

former MLA of Cuttack-Barabati who was recently elected as a Rajya Sabha member, had moved the high court in July 2019, alleging that Moquim had submitted false affidavits along with his nomination during the May 2019 elections.

The Congress leader was twice fined ₹10,000 by the court during the adjudication of the case for

non-appearance. Moquim had won the Assembly election for the first time in 2019 by defeating Samantray by a narrow margin

of a little over 2,000 votes. Meanwhile, the Congress leader after the high court ruling said he will contest the upcoming Assembly polls from the same constituency. "I will examine the verdict of the high court and challenge it, if needed," he said.

It is pertinent to mention here that the Madras HC, in a significant judgment in 2019, had held that MPs as well as MLAs are liable to refund salaries, along with penalty, if a court of law declares their election to be illegal, null and void either before or after the completion of their tenure.

### BREACH IN INDRAVATI CANAL FLOODS VILLAGE, FARMLANDS

Bhawanipatna, March 4: Over 250 acres of agricultural land and houses were submerged as gushing water from a 20-feet breach created in the Indravati Right canal around 3.30am Monday flooded several parts of Kalampur block in Kalahandi

Water also entered some houses in Deypur village due to the breach, officials said. Executive engineer of Indravati Right canal division, Rajkumar Behera, said the breach took place in the canal's left bank.

The spot where the breach took place was weak as it hadn't been renovated for the construction of a bridge, officials added.

Behera said the breach took place as farmers had closed three of the five canal gates located near the spot, creating additional pressure at the spot.



Canal engineers have reached the spot and are taking stock of the situation. Water supply will resume tonight, he said.

After water recedes from the fields, officials of the Agriculture and Revenue departments will assess damages to the fields and standing crops, Behera said.

As water gushed inside houses while people were asleep, villagers had to rescue family members stuck inside three houses.

Many have also lost their food stock and other valuables as their houses were inundated.

On being informed, Kalampur tehsildar Smrutirekha Tula, BDO Bijay Kumar Mandangi, assistant engineer Shvamsundar Marndi, former minister Pushpendra Singhdeo visited the spot and held discussion with the affected farmers. Officials said that the repairing works will start Tuesday.

## parks, sanctuaries PNN & AGENCIES

Bhubaneswar, March 4: At a time when the existing prohibition on single use plastic bags has failed miserably in Odisha, the state government Monday imposed a fresh ban on the use of single-use plastic in national parks, tiger reserves, wildlife sanctuaries and eco-tourism sites in the state from April 1.

Chief Wildlife Warden Susanta Nanda said in an order. "In exercise of the power conferred under Section 33 of Wildlife (Protection) Act, 1972, it is hereby ordered that single-use plastic shall be prohibited inside sanctuaries/national parks/tiger reserves of the state with effect from April 1, 2024.

As the use of plastic water bottles will also be banned inside the protected forest areas, alternate drinking water facilities will be arranged for the tourists, Nanda, who is also the Principal Chief Conservator of Forests (Wildlife), said.

He asked the forest officials to widely publicise the plastic ban order so that tourists do not face any inconvenience from April 1.

He warned that violation of the order would invite arrest and jail term, besides fines. Resorts and eateries would be

also informed about the order. The Forest department would seek the assistance of the Odisha State Pollution Control Board and the district admin-

istration to enforce the ban order, Nanda said. Notably, in a bid to curb the

rampant use of single-use plastic bags, the government had enacted a state-wide ban October 2, 2019. However, about five years after its implementation, the rule has gone for a toss. It remains to be seen how strictlythe government will enforce the new ban.

## Fans bid adieu to Flaco the owl in NYC memorial

Efforts also are underway to put a statue of Flaco in Central Park with people calling for new laws aimed at preventing birds from flying into buildings

New York, March 4: Dozens of mournful fans of Flaco the Eurasian eagle-owl gathered in New York City Sunday to say goodbye to the beloved celebrity creature who became an inspiration and joy to many as he flew around Manhattan after someone let him out of his zoo enclosure.

A memorial featuring speeches, songs and poems was held in the late afternoon in Central Park at what organisers call Flaco's favorite oak tree.

Flaco was found dead on the Upper West Side February 23 after apparently hitting a building. Testing by zoologists concluded he suffered traumatic impact injuries, but more testing



he may have been sick.

His death was a heartbreaking end for the birders who documented his daily movements and the legions of admirers who followed along, as people posted photos and videos of the ma-

wingspan perched on tree branches, fence posts, fire escapes and water towers — as well as his hours of hooting.

"With all of this challenging time that is happening all over the world, this bird really became a symbol of hope and brought so many of us together," Breanne Delgado said at the gathering. David Lei, an avid birder in the

city, said losing Flaco was hard to put into words. He said the owl faced the same fate as many other birds in Manhattan - flying into the deceptive windows of tall buildings.

Flaco was larger than life and is leaving behind a legacy to match, Lei said. "I thank him today as I did every day I got to see him, for the joy, awe and wonder he inspired in us throughout his journey.

People at the ceremony also advocated for new laws aimed at helping to prevent birds from flying into buildings and curbing the use of rat poison that

larger birds can ingest while eating prey. Efforts also are underway to put a statue of Flaco in Central Park.

Flaco was freed from his cage at the Central Park Zoo a little over a year ago by a vandal who breached a waist-high fence and cut a hole through a steel mesh cage. The owl had arrived at the zoo as a fledgling 13 years earlier.

Zoo officials and his fans were at first worried about his survival, but he soon proved adept at catching rats and other prey. The zoo later suspended efforts to re-capture him after failed attempts. Tributes poured in from across the globe after his death. Police are still seeking to arrest whoever let him out of his enclosure.

# 22 projects worth ₹4k-cr okayed

**Bhubaneswar, March 4:** Furthering its industrialisation process, the state government Monday approved 22 projects worth an investment of ₹4,066 crore.

The proposals got the state government's nod at the State-Level Single Window Clearance Authority (SLSWCA) meeting chaired by Chief Secretary Pradeep Kumar Jena.

The projects are in different sectors such as green energy equipment, chemicals, textiles and apparel, steel, iron & ferro alloys, aluminium downstream, food processing, power & renewable energy, IT infrastructure and infrastructure & logistics, a release said.

The projects after proper implementation are likely to generate 25,525 jobs in 12 districts, officials said.

In the green energy sector, Waaree Clean Energy Solutions Pvt Limited is planning to establish its electrolyser manufacturing plant in Khurda, with



a project cost of ₹435 crore, promising 300 jobs.

In the chemical sector, Shalimar Paints has proposed to set up its unit in Balasore for paints varnish and its applied products project, with an investment of ₹135 crore. This project is estimated to generate 200 jobs.

Reliance Bio Energy Limited has introduced two new projects on compressed biogas and fermented organic manure in Dhenkanal and Cuttack, with a total investment of ₹242.42 crore and offering 138 jobs.

SSIL Paint Industries Private Limited intends to manufacture paint and allied products, with investment plans of ₹150 crore and potentially employing 200 people in Khurda.

In the textile and apparel sec-

tor, OFB Tech Private Limited has proposed to set up its project in Khurda at an investment of ₹857 crore and 15,000 job opportunities. In the technical textile sector, Shalimar Wires Industries Limited in Khurda unveils its project synthetic fabric for industrial filtration with a project cost of ₹76 crore and em-

ployment to 100 people.

In the metal downstream sector, BMW Industries Limited is introducing its project in galvanised plain coil, color coating line, and cold rolling mill in Jajpur with a project cost of ₹713 crore and offering 276 potential job opportunities.

Segma Profiles Private Ltd is initiating its steel structure profiles and pipes manufacturing unit in Sambalpur with a project cost of ₹54.26 crore and 250

mployment opportunities.

In the food processing sector, Bajrangbali Minmet Private Limited is initiating a unit for instant pasta and vermicelli, sweet potato powder production, contributing ₹52.10 crore and potentially employing 50 people in Sundargarh.

OFB Tech Private Limited also plans to produce maize starch powder, maize germ, maize gluten, bran fibre, and enriched bran fibre for ₹150 crore, potentially employing 400 people in Nabarangapur.

In the power & renewable energy sector, Hindalco Industries Limited is investing in Solar PV Power in Koratpur with an investment of ₹200 crore and 80 potential job opportunities.

Steel Limited is investing in a 22 MW Solar PV Power Plant in Sundargarh, with an investment of ₹125.69 crore and offering job employment to 23 people. Adani Total Energies Biomass Limited aims to produce compressed biogas for this sector, with a project cost of ₹136.50 crore and potential employment for 180 people in Sambalpur.

"In a collective effort, these 22 transformative projects, with a cumulative investment of ₹4,066.71 crore, are poised to create 25,525 employment opportunities, paving the way for enhanced industrial growth and economic prosperity in Odisha," the release said.

## 1 arrested from AP in inter–state job fraud

Bhubaneswar, March 4: A man was arrested from Andhra Pradesh by the Odisha Police's Economic Offences Wing (EOW) in connection with its investigation into an interstate job fraud racket, officials said.

Akashpu Veera Chaitanya, a resident of West Godavari district of Andhra Pradesh, was produced before a court in Cuttack Monday, they said.

This was the fourth arrest made in connection with the case, which was registered based on a suo motu inquiry conducted by the EOW on a fake advertisement published in local newspapers, they added.

Earlier, the agency had ar-Mohammad Sanaullah, who was identified as the mastermind, one Sakshi Jain from Hyderabad and one Surat Dalai from Balasore. The gang published the advertisement in newspapers in different states. They collected ₹1,000 from each candidate as an application fee for jobs, and then cheated the aspirants, officials said. The gang allegedly collected crores of rupees from job aspirants, they said.

Chaitanya was arrested as it was found during the investigation that ₹60 lakh of this money went to his account, they said.

The investigation would continue, officials said.

# Research funds now at govt medical colleges

Bhubaneswar, March 4: To strengthen the quality of medical education and research in the state, the government decided Monday to create a research fund under the deans or principals of all government medical, dental colleges and hospitals and post graduate institutes for meeting expenditure towards research activities undertaken by these institutions.

In a notification, Health and Family Welfare department said, "For imparting quality education to medical students, conducting research activities along with participation of faculties in seminars and conferences are essential. These help the faculties to remain updated in the field of advanced treatment and teaching methodologies which in turn will help in providing better healthcare services to the people."

A total annual provision of ₹9 crore has been made by the government for this purpose. The notification informed that every year, a total research fund of ₹1 crore each will be provided to SCBMCH, Cuttack, MKCG MCH, Berhampur and VIMSAR, Burla. And a research fund of ₹50 lakh each per annum will be provided to the new government medical colleges and SCB Dental College, Cuttack.



A total annual provision of Rs 9 crore has been made by the government for this purpose

The PG institutes will be provided with a total research fund of ₹25 lakh each per annum.

"The provision of research fund will enhance the quality of medical education by facilitating research, publication, participation in seminars and conferences within the country and will facilitate research in subjects specific to the state by creating an environment for inquiry and innovation in health sector of Odisha," said a department official.

This inititative will yield qualitative and quantitative outcomes and enable the institutes to undertake appropriate actions to improve the quality of research, medical education and the patient care in the state, he added.

# Sub-plot regularisation cell launched by BDA

Bhubaneswar, March 4: The Bhubaneswar Development Authority (BDA) has established four facilitation cells for subplot regularisation and proposed layout plan approval.

These cells have been set up in the offices of District Sub Registrar, Bhubaneswar, Khandagiri, Balianta and Jatni for convenience of general public, official sources said, Monday.

The cell will assist the general public either seeking to sub-divide their land or to regularise the unauthorisedly sub-divided land for the purpose of converting in to homestead (Gharabari Kisam) purpose. The cell will further assist in

preparation of plan and making application for approval of layout plan by the urban local bodies or BDA.

The cell will function on all working days during the working hours while the details of the cell and the location have been uploaded on the official website of the BDA (www.bda.gov.in). BDA said that two employees each have been deployed to the cells.

The state government in 2015 had imposed restrictions on grant of building permissions on plots which have been sub-divided into sub-plot unauthorisedly without obtaining approval of the concerned Development Authorities/ULBs under provisions of ODA Act 1982.

At a later stage, in 2017 and 2022, the government had brought two different schemes of regularisation of such unauthorised layout by depositing required compounding fee, as applicable. The facilitation cell will help the applicants seeking to regularise their unauthorised subplots under these schemes.

### Govt, IIT sign MoU for blind students' edu

Bhubaneswar, March 4: State government signed a memorandum of understanding (MoU) with the Indian Institute of Technology (IIT), Bhubaneswar Monday to provide inclusive and quality education to visually impaired students in the state.

The Social Security and Empowerment of Persons with Disabilities Department (SSEPD) signed agreement with the institute in presence of department Minister Ashok Panda and principal secretary Bishnupada Sethi.

Panda said that improvements in assistive technology, particularly with regard to computers, tablets and smartphones, have made it possible for visually impaired people to read and write in standard scripts.

"IIT-Bhubaneswar will provide technical guidance and support for identification of the right assistive devices as per the identified needs of blind students," Sethi said.

The Research and Industrial Consultancy (SRIC) of IIT will work in collaboration with Exclusive Tinker Lab to provide these students modern learning opportunities via coding, micro bit, 3D painting, game development, animation, mobile apps, machine learning, artifi-

cial intelligence and robotics.

Through the initiative, tabs and smart phones will be provided to secondary students as necessary support for online classes. The students will also be offered career guidance, soft skills training, workshops on personality development, with facilities like digital library and distribution of audio books.

"There will be provision of Kibo Device for visually impaired students in high schools and higher secondary schools and we will conduct regular monitoring of the activities implemented through the MoU," said Sethi.

He further said that IIT, Bhubaneswar will work to enhance the educational outcomes by broadening avenues for professional development in terms of inclusion.

Niyati Patnaik, director of SSEPD department and Dinakar Pasla, professor and dean of Sponsored Research and Industrial Consultancy (SRIC) of IIT, Bhubaneswar were signatories in the MoU on behalf of the government and IIT. Senior officers of the department and academicians from IIT were present during the signing event.





### **Religion & Rhetoric**

n the day the Opposition put up a big show of unity in Patna 3 March for fighting the coming Lok Sabha polls together, the Narendra Modi government unveiled the grand action plan of 'Vikshit Bharat 2047' in New Delhi. This 25 long years vision document for Developed India aims to focus on economic growth, ease of doing business, infrastructure development and such areas. There was detailed discussion on an action plan of 5 years and a 100 day agenda for quick implementation after formation of new government in May 2024. This betrays either overconfidence or bravado before facing elections. Whether it be accusations of EVM hacking or survey reports, maybe the BJP knows something that we commoners don't.

The meeting of the Union Council of Ministers in New Delhi was described as the last before the announcement of the Lok Sabha poll schedule which is to be made shortly. The whole show seemed to be intended to send the message across to the electorate that the ruling alliance is confident of retaining power for a third consecutive term for which the government can afford to chalk out its plan of action for the first 100 days of the new government as if the party has already

Reports suggest during the day-long meeting, chaired by the Prime Minister, secretaries presented a vision document for Viksit Bharat 2047 and a detailed action plan for the next five years. The presentations outlined the vision for 'Viksit Bharat' of the PM that underlined, among other things, zero poverty, skill to every youth and 100 per cent saturation of welfare schemes. PM Modi was quoted as having told the top bureaucrats that they should work on preparing the future roadmap of the country during the elections. His exact words were - "aap chhutti mat samajhiye, kaam par lag jaaiye (don't think you are on holiday, get down to work)." This is in keeping with the PM's proclivity for coining catchy phrases.

To give the rhetoric a veneer of credibility, facts and statistics were dished out with the claim that the roadmap for Viksit Bharat is a result of over two years of intensive preparation involving all ministries and wide-ranging consultations with state governments, academia, industry bodies, civil society, scientific organisations and mobilisation of youth for seeking their ideas. It has been stated that over 2,700 meetings, workshops and seminars were held at various levels, while suggestions of more than 20 lakh youth were received for the purpose.

The roadmap is said to be a "comprehensive blueprint with clearly articulated national vision, aspirations, goals and action points." The target is to achieve economic growth, sustainable development goals (SDGs), ease of living, ease of doing business, infrastructure and social welfare. Critics have pointed out that in the past, people have seen a scandalous mismatch between words and actions of this particular

On the other side, the Opposition sought to put up a brave front in Patna that the partners are driven by the sole aim of ousting a "nonperforming" government that is adept at whipping up religious passions through Ram temple construction and minority-bashing, while failing to lift the people from the morass of poverty and joblessness. But, they seem to have again fallen into the BJP's trap of harping on religion as a tool of capturing power. In his usual style, Rashtriya Janata Dal (RJD) chief Lalu Prasad commented that PM Modi "is not even a Hindoo as he did not shave his head and beard after the death of his mother." This would only help the BJP play its communal card with renewed vigour.

In any case, the Opposition has miles to go before it can present a credible alternative to the ruling dispensation despite its grand show of leaders of a host of parties sharing the dais in Patna. It is yet to hammer out a seat-sharing formula and electoral strategy to take on the BJP. These are the starting points for electioneering. The more the Opposition dithers and delays, the more the advantage goes to the BJP-led National Democratic Alliance.

## **INCONSISTENT FIGURES**

**ANOTHER PUZZLE APART** FROM THE **GDP AND GVA DIVERGENCE IS** THE GROWTH **RATE OF CONSUMPTION EXPENDITURE** 

ndia's GDP during the three months ending in December grew at 8.4%. This is the highest among all large economies of the world. It is extremely heartening to have the economy growing at a relatively healthy pace for three years in a row after the pandemic. It brings good cheer, and the stock markets responded resoundingly. The stock market index keeps attaining new peaks, indicating investor optimism. The slew of announcements, such as approval for setting up of 15 billion dollars of investment in semiconductor manufacturing speaks of the enthusiasm and confidence of a bright outlook for the economy.

It is important to go "below the hood" to understand the significance of the headline of 8.4% growth for the December quarter. This is particularly so, because the news of such high growth beat all expectations by a wide margin. For instance, the Survey of Professional Forecasters on Macroeconomic Indicators, conducted regularly by the Reserve Bank of India, had predicted a GDP growth rate between 6 to 6.9% for this year ending in March, very recently. The actual number for December quarter is nearly 2% higher than the annual forecast. Of course, forecasters go wrong quite often, but not by such a big margin. These forecasters are tracking the economy based on high frequency data all the time.

The other puzzle is the gap between GDP growth rate and that of Gross Value Added (GVA) for the same quarter. The latter gives a true measure of the real value of goods and services produced and sold. The world over it is the preferred indicator of economic health. The difference between GDP and GVA is usually minor and reflects the net effect of taxes minus subsidies. Indirect tax collection adds to GDP while subsidy outgo reduces GDP. These two mostly balance each other out. The GVA growth for December quarter is only 6.5%, nearly 2% lower

than GDP growth. This gap is the highest reported in the past ten years. It has been caused by a steep fall (more than 50%) in subsidy outgo, and a big increase in indirect tax collection. We need to probe deeper to understand whether these are one off spikes (both positive and negative) or whether such volatility will continue. GVA growth reported for past three quarters has been sliding down from 8.2% down to 6.5% now. Since the total growth rate for 2023-24 is around 7.3% or 7.5%, it means that the fourth quarter will likely report a GVA growth rate below 6%. That data is released only by the end of May.

Another puzzle apart from the GDP and GVA divergence is the growth rate of consumption expenditure. This constitutes more than 55% of GDP and forms the bulk. That is growing only at 3% and is at a multi-year low. High growth cannot be sustained without a big push from consumer spending. That in turn depends on the sentiment of consumers, their current spending and their plan for future spending (like on white goods, furniture, tourism travel, etc). Consumers feel optimistic about the future when their job prospects are bright High unemployment rates, especially among the college educated youth can discourage consumption spending. The recently released fact

sheet on the household consumption survey gives a granular view of monthly spending on consumption. The survey came after a gap of 11 years, and over this period the growth on average has been 164% in rural areas, and 146% in urban areas. These numbers are in nominal terms i.e. they do not account for inflation adjustment. Adjusted for inflation, the real growth in consumption as per the survey works out to 40% for rural areas and 34% for urban areas, over a period of 11 years. Thus, the consumption growth based on National Sample Survey (NSS) is barely 3.5% over a long period. Of course, there has been this wellknown discrepancy between consumer spending as revealed by NSS and as revealed by the Central Statistical Organisation (CSO). And this gap is still too wide. But it is important to look at the data from these two lenses, and try to get some consistency and remove defects in measurement if any. The fact is high GDP growth and low consumption spending growth do not sound consistent.

A third aspect when we look "under the hood" is the performance of industry and the

agriculture sectors. GDP can be measured from the spending side (i.e. consumption, investment, net exports and government), or it can be measured from the production side (i.e. agriculture, industry and services). When we look at the latter, agriculture growth has fallen below zero for the December quarter. This negative number is explained as a base effect since the quarterly numbers are growth over corresponding numbers one year ago. Since that number for the December 2022 quarter was above 5%, and was a "high base" the present num ber is negative. Be that as it may, the overall contribution of agriculture to GDP growth this year will be below 1% as per latest estimates. This is worrying for various reasons, most importantly for what it means for the livelihoods and incomes of rural families. Industrial growth at 11% too is because of the "base effect" of just 0.6% a year ago.

Finally, one more piece of the puzzle is the difference between nominal and real GDP growth It is because of inflation, and the correction at the national level is done by the GDP deflator. This number has been reported to be just 1.6% indicating nearly no inflation at all. But surely that is a gross underestimate. If GDP growth is 8.4% then nominal GDP growth is expected to be at least 12 or 13%. It was only 10% higher in nominal terms during the December quarter, as compared to one year ago. The GDP deflator is too low.

Whether it is the gap between GDP and GVA growth rates, or between GDP and consumption spending, or the relatively low sectoral rates, or the very low deflator, all of these point to the need to triangulate the aggregate GDP data with more granular and high frequency sectoral data. This calls for a massive overhaul of the machinery that collects data on a real time basis

n Christopher Nolan's 2010 cently reported that global fossilthat eliminating these subsidies with technological innovations film Inception, the line between reality and illusion becomes increasingly blurred. When it comes to fossil-fuel subsidies, life imitates art. Distinguishing between their perceived benefits and actual impact has proven to be a critical global challenge. While such subsidies may appear beneficial in the short term, they mask the profound environmental and economic consequences of our dependence on fossil fuels. Given the interconnected threats posed by climate change, the question remains: Can we come to terms with reality and make decisions that genuinely benefit both ourselves and our planet? Despite the international

pledges made at the G20 summit in 2009 and the COP26 in 2021, along with the EU's Green Deal and its eighth Environment Action Program, fossil-fuel subsidies remain entrenched. According to the European Environment Agency, annual subsidies in EU hovered around \$61 billion between 2015 and 2021, with only a few member states taking steps to phase them out.

To be sure, the lack of action is not limited to the EU. The International Energy Agency remore than \$1 trillion in 2022, a spike largely attributed to geopolitical shocks like Russia's invasion of Ukraine, which significantly disrupted energy markets.

The IMF paints an even bleaker picture: accounting for the insufficient taxation of carbon dioxide emissions implies that fossil-fuel subsidies surged to a record \$7 trillion in 2022. This figure, the equivalent of 7.1% of the world's GDP, surpasses global spending on education and nearly matches worldwide health-care expenditures. While subsidies are often

viewed as a means to address social inequalities and offer relief to poorer households through reduced food and energy prices, they often have the opposite effect. In reality, these subsidies disproportionately benefit wealthier households and perpetuate unequal access to energy. Moreover, they divert crucial public funds from more effective investments that could reduce our reliance on fossil fuels and improve infrastructure, social protection, and healthcare services, all of which offer greater benefits to low-income communities.

By contrast, the IMF estimates

fuel subsidies skyrocketed to could prevent 1.6 million premature deaths annually, generate \$4.4 trillion in revenues, and accelerate progress toward global climate goals. By maintaining energy subsidies initially designed as temporary measures, we risk perpetuating our dependence on fossil fuels.

But given that tackling social inequalities requires a phased approach, a balanced long-term climate strategy must include targeted financial support to vulnerable populations. Similarly, low- and middle-income countries must pursue structural reforms to enhance economic stability, deepen financial markets, and strengthen their institutions, thereby improving their credit ratings and reducing their borrowing costs.

The Green Climate Fund underscores the crucial role of blended finance in helping developing countries decarbonise. Created under the UN Framework Convention on Climate Change, the Fund currently manages 216 projects with a combined value of \$12 billion. When accounting for co-financing, its overall assets exceed \$45 billion. The next few years will be critical for the global transition to net-zero emissions,

plan to achieve energy independence and a 55% reduction in greenhouse-gas emissions by 2030, for example, depends heavily on the development of a thriving climate-tech sector.

A future of sustainable growth is within reach if we acknowledge the real costs of fossil fuels and adjust our financial and political priorities accordingly. By redirecting funds currently allocated to fossil-fuel subsidies, governments could meet their climate targets by 2030 and accelerate the shift to a net-zero economy.

As climate change worsens, it is increasingly evident that ignoring the devastating consequences of our dependence on fossil fuels is no longer an option. Achieving net-zero emissions requires bold policies such as the phaseout of fossil-fuel subsidies, as well as investment in technological innovation and a global commitment to a fair and equitable energy transition.

### AI & elections

Sir, AI's influence on elections is a double-edged sword. On the positive side, it can streamline processes like voter registration, ballot counting, and fraud detection, contributing to more efficient and secure elections. However, the dark side emerges in the form of deepfakes and synthetic media, allowing the creation of deceptive content that can manipulate public perception and potentially disrupt the democratic process. A notable example is the use of an AI-generated video by the Republican National Committee to criticise Joe Biden, emphasising the need for vigilance against malicious applications of AI in political contexts. Micro-targeting and personalisation, driven by AI's data analysis capabilities, enable political campaigns to tailor messages to specific voter groups. While this enhances campaign efficiency, it also raises ethical concerns about privacy, potential manipulation, and the creation of echo chambers that contribute to increased polarisation. Misinformation and disinformation, propagated by AI-generated content on social media, pose a significant threat to the reliability of information, eroding trust in democratic institutions. This underscores the importance of addressing the challenges associated with AI's role in disseminating false or misleading information. Furthermore, the risk of cyberattacks and hacking is heightened with AI, as malicious actors can exploit its capabilities to compromise electoral systems. From infiltrating voter databases to tampering with voting machines, the potential threats demand robust cybersecurity measures.







## WHEN BIJU ASKED KALAM: CAN YOU HIT BEIJING?

n a lazy afternoon in 1993, well before the scheduled time, senior DRDO scientific officer RK Sahoo along with his boss Chief Scientific Adviser to the Prime Minister and Secretary, Defence Research and Development Organisation (DRDO), Dr APJ Kalam had entered the Odisha Secretariat in Bhubaneswar. They had an important meeting with the legendary CM Biju Patnaik.

Dr Kalam had gone through the Odisha bureaucracy for the Wheeler Island on the Bay of Bengal in Bhadrak district to build a missile testing facility.

"Even close to a year after, no reply was coming from the Odisha government," recalls Sahoo, who retired as Major General. He was also conferred the prestigious AVSM award. Sahoo carried all the relevant

documents which included a letter from PM Narasimha Rao addressed to Biju Babu. Incidentally, Dr Kalam had appraised the PM of the status of the project, so he had penned the letter.

"As soon as we reached his office, the tall leader walked up to the door and received Dr Kalam. Both Biju Babu and Dr Kalam had great respect for each other. Biju Babu addressed my boss as Dr Saab," narrates Sahoo.

Apart from the two great men and Sahoo, ex-IAS officer and Secretary to the CM, Aurobindo Behera was also present in the meeting. It's a lively meeting which lasted for less than half an hour.

An aviator par excellence, Patnaik had a great understanding of different subjects including space science, engineering and technology. "He was familiar with Odisha's coastline, knew everything



about it," says Behera. In the meeting, Biju Babu sug-

gested that Dr Kalam and his scientists "should develop something like long range missiles which can target China.'

"I am not interested in fire-crackers," he joked. Seconds later, he asked, "Can you hit

"One day, we will fulfill your dream, Sir," promised a smiling Dr Kalam.

 $Biju\,Babu\,also\,suggested\,that$ Olive Ridley's at Gahiramatha - the world's largest rookery of the endangered sea turtle - near the proposed site should not be disturbed at all. Dr Kalam promised to ensure that. Biju Babu also asked Dr Kalam to try and develop a floating (platform) launch pad.

In between the lively discussion, Sahoo had spread the map of the Wheeler Island on the CM's table. He also handed over the letter of the PM. "Biju Babu didn't pay a glance at the letter. While talking, he wrote on the map, approved," remi-

nisces Sahoo. After the meeting, Biju Babu even saw off Dr Kalam at the door of his office.

"I had heard from many people that Biju Babu's a large hearted person, but that day I experienced it," claims Sahoo. "He's a statesman, could foresee things well in advance," adds Sahoo.

Even the same day, after this meeting, orders were issued to concerned bureaucrats to ensure that the island was transferred to the Defence Ministry in quick time.

"He grasped things very quickly and once he's convinced, nothing could stop him from doing the job," says Behera. "Extremely punctual and decisive, he wouldn't shy away from owning responsibility of his decisions, would never pass the buck on others. He always encouraged younger officers and trusted and backed them," adds Behera.

### SBI requests SC to extend deadline

New Delhi, March 4: State Bank of India Monday moved the Supreme Court seeking an extension of time till June 30 to disclose details of each electoral bond encashed by political parties.

In its verdict last month, the top court directed the SBI to furnish the details to the poll panel by March 6.

In an application filed before the top court, State Bank of India (SBI) contended that retrieval of information from "each silo" and the procedure of matching the information of one silo to that of the other would be a timeconsuming exercise.

The plea submitted that due to stringent measures undertaken to ensure that the identity of the donors was kept anonymous, 'decoding' the electoral bonds and matching donors to the donations made would be a complex process." "It submitted that the data related to the issuance of the bond and the data related to the redemption of the bond was kept recorded in two different silos. No central database was maintained. This was done to ensure that donors' anonymity would be

In its verdict months ahead of the Lok Sabha polls, the apex court ordered SBI to disclose to the Election Commission the names of the contributors to the six-year-old scheme. A five-judge Constitution bench headed by Chief Justice D Y Chandrachud directed that the SBI must disclose details of each electoral bond encashed by political parties.

The information should include the date of encashment and the denomination of the bonds and be submitted to the poll panel by March 6.

### Supreme Court restores Trump to ballot

Washington, March 4: The Supreme Court Monday restored Donald Trump to 2024 presidential primary ballots, rejecting state attempts to hold the Republican former president accountable for the Capitol riot. The justices ruled a day before the

Super Tuesday primaries that states cannot invoke a post-Civil War constitutional provision to keep presidential candidates from appearing on ballots. That power resides with Congress, the court wrote in an unsigned opinion.

The outcome ends efforts in Colorado, Illinois, Maine and elsewhere to kick Trump, the front-runner for his party's nomination, off the ballot because of his attempts to undo his loss in the 2020 election to Democrat Joe Biden, culminating in the January 66, 2021, attack on the Capitol.

Trump's case was the first at the Supreme Court dealing with a provision of the 14th Amendment that was adopted after the Civil War to prevent former officeholders who "engaged in insurrection" from holding office again.

Colorado's Supreme Court, in a first-of-its-kind ruling, had decided that the provision, Section 3, could be applied to Trump, who that court found incited the Capitol attack. No court before had applied Section 3 to



a presidential candidate.

Some election observers have warned that a ruling requiring congressional action to implement Section 3 could leave the door open to a renewed fight over trying to use the provision to disqualify Trump in the event he wins the election. In one scenario, a Democratic-controlled Congress could try to reject certifying Trump's election January 6, 2025, under the clause. The issue then could return to the court, possibly in the midst of a full-blown constitutional crisis.

Both sides had requested fast work by the court, which heard arguments less than a month ago, February 8. The justices seemed poised then to rule in Trump's favour. Trump had been kicked off the ballots in Colorado, Maine and Illinois, but all three rulings were on hold awaiting the Supreme Court's decision.

Washington: Indian-American presidential candidate Nikki Haley has won her first Republican nominating contest by trumping rival Donald Trump in Washington DC, injecting new life into her 2024 campaign ahead of the crucial Super Tuesday contest. With her win, Haley scripted history by becoming the first woman ever to win a Republican presidential primary. She is also the first Indian-American to have won either the Democratic or the Republican primaries. The three other previous Indian American presidential aspirants - Bobby Jindal in 2016. Kamala Harris in 2020 and Vivek Ramaswamy in 2024 – had failed to win even one primary. Haley, 51, received 1.274 votes (62.9 per cent) against 676 votes (33.2 per cent) received by her main rival and former President Trump.



#### **Ola's S1 Pro gets PLI certification**

Bangalore: Ola Electric's S1 Pro electric scooter has received the domestic value addition (DVA) certification under the production-linked incentive (PLI) scheme for the automobile and auto component industry, the Centre said Monday. The S1 Pro scooter met the stringent minimum localisation criteria of 50 per cent, as mandated by the Ministry of Heavy Industries. The International Centre for Automotive Technology (ICAT), Manesar, one of the divisions of the National Automotive Board (NAB) under Ministry of Heavy Industries, awarded its first PLI-automotive certificate to Ola Electric. Under the leadership of Prime Minister Narendra Modi, the government introduced the National Electric Mobility Mission Plan (NEMMP) 2020 to realise the goal of 'Green Mobility'. This plan sets out the goals and time frame for the nation to manufacture and adopt electric vehicles (EVs).

### Nayara exports dip

New Delhi: Nayara Energy, India's largest private fuel retailer, saw petroleum product exports drop by 10 per cent in 2023 as it supplied more products domestically to meet the fuel demands of a growing economy, sources said, Navara, which operates a 20 million tonne a vear oil refinery at Vadinar in Guiarat and a network of over 6.500 petrol pumps, exported 6,21 million tonne of petroleum products, including jet fuel, gasoil (diesel) and gasoline (petrol) between January 2023 and December 2023, down 10 per cent year-on-year. This was primarily because of larger consumption at home. The company is catering to the domestic market through institutional business, sales to other oil companies and its own retail chain.

New Delhi: The country's sugar production declined 1.19 per cent to 25.53 million tonne so far in the ongoing 2023-24 marketing year, industry body ISMA said Monday. Sugar production stood at 25.84 MT till February in the year-ago period. Sugar marketing year runs from October to September. In its second estimate, the Indian Sugar Mills Association (ISMA) has projected sugar output to decline by 10 per cent to 33.05 MT in the current 2023-24 marketing year as against 36.62 MT in the previous year.

## RBI bars IIFL Fin from disbursing gold loans

Mumbai, March 4: The Reserve Bank Monday barred IIFL Finance Ltd from disbursing gold loans, with immediate effect following multiple supervisory concerns, including serious deviations in assaying and certifying the purity of the yellow

A leading financial services provider, IIFL Finance offers a range of loans and mortgages. The latest directions from the Reserve Bank of India (RBI) pertain to only the gold loan business.

In a statement, the RBI said it has directed IIFL Finance Ltd "to cease and desist, with immediate effect, from sanctioning or disbursing gold loans or assigning/ securitising/ selling any of its gold loans'

The company can, however, continue to service its existing gold loan portfolio through the usual collection and recovery processes, it added.

The supervisory restrictions will be reviewed upon completion of a special audit to be instituted by the RBI and after rectification by the company of the special audit findings and the findings of RBI Inspection to the satisfaction of the central bank, it added.

Giving details, the central bank said an inspection of the company was carried out by it with reference to its financial position as of March 31, 2023.

Certain material supervisory concerns were observed in the gold loan portfolio of the company.

The concerns include serious deviations in assaying and certifying purity and net weight of the gold at the time of sanction of loans and at the time of auction upon default; breaches in Loan-to-Value ratio; significant disbursal and collection of the loan amount in cash far in excess of the statutory limit; non-adherence to the standard auction process; and lack of transparency



in charges being levied to customer accounts

"These practices, apart from being regulatory violations, also significantly and adversely impact the interest of the customers," the RBI said

The central bank said it was engaged with senior management and the statutory auditors of the company on the deficiencies over the last few months. however, no "meaningful corrective action" has been evidenced so far.

'This has necessitated the imposition of business restrictions with immediate effect, in the overall interest of customers, the central bank said.

The business restriction is without prejudice to any other Regulatory or Supervisory action that may be initiated by the RBI against the company, it added.

The broader Nifty rose by 27.20 points or 0.12 per cent to close at a lifetime high of 22,405.60 points. During the day, it hit a record intra-day level of 22,440.90.

In the four-day record-breaking spree, Sensex rallied 1,567 points or 2.15 per cent while Nifty shot up 454 points or around 2 per cent.

Analysts said though benchmark indices closed at record levels, the market traded in a range. Gains were driven by buying in banks, energy and pharma shares while IT, FMCG and auto shares retreated, analysts said.

'The market traded in a range bound manner due to weak global cues, while investors turned stock-specific due to the prevailing caution on broader indices. Further, the tepid con sumption data influenced investors to refrain from FMCG and discretionary stocks," said Vinod Nair, Head of Research, Geojit Financial Services.

"The three automotive business units are now operating independently and delivering consistent performance. This demerger will help them better capitalise on the opportunities provided by the market by en-

### Moody's raises 2024 growth hope

New Delhi, March 4: Global rating agency Moody's Monday raised India's growth forecast for 2024 calendar year to 6.8 per cent on "stronger-than-expected" economic data and said that the country will remain the fastest growing among G20 countries.

In its Global Macroeconomic Outlook for 2024, Moody's Investors Service said with global headwinds fading, the Indian economy should be able to register 6-7 per cent real GDP growth comfortably. For 2025, the GDP growth is estimated at 6.4 per cent. Moody's had projected a

### 6.1 per cent growth for 2024 ear-

"India's economy has performed well and stronger-thanexpected data in 2023 has caused us to raise our 2024 growth estimate to 6.8 per cent from 6.1 per cent. India is likely to remain the fastest-growing among G-20 economies over our forecast horizon," Moody's said.

India's real GDP expanded by 8.4 per cent year-on-year in the fourth quarter of calendar year 2023, resulting in a 7.7 per cent growth for full-year 2023. The GDP grew by 8.2 per cent in the April-June quarter and by 8.1 per cent in the July-September quarter.

# Root heaps praise on Ashwin

Bangalore, March 4: Mighty impressed with Ravichandran Ashwin's range, aggressive mindset and relentless pursuit of wickets, senior England batter Joe Root has said that the veteran Indian off-spinner is a constant threat who hardly believes in the concept of wearing the opposition down

Ashwin, who recently went past the 500-wicket milestone in the traditional format becoming only the second Indian after Anil Kumble to do so, will play his 100th Test during the fifth match against England, starting March 7 at Dharamsala.

"Ashwin is always trying to find ways of getting you out rather than trying to wear you down, over long periods of time,' Root said on Sky Sports cricket podcast hosted by former England captains Mike Atherton and Nasser Hussain.

Root, who along with his teammates is currently enjoying a break in the series, said the infinite variety that Ashwin has in his bowling keeps the batters

"He uses creases differently from traditional off-spinners. He uses over-spin, side-spin, can get really tight to the stumps. can go wider and he has got the carrom ball, you know, a lot of dif-

"So, you will have to be really wary of different threats that he poses and make sure that you have very good skill sets to counter (him) and be on top of him," said the ex-England skip-


Giving an insight into the way Ashwin operates, Root said the Tamil Nadu man often bowls six different deliveries in an over. "Ashwin is making sure that you don't play the previous ball. He is very good at trying to drag you across the crease and get your

edges quite frequently," he said.

Root said Ashwin poses different threats while bowling with new and old balls. "There are different things to contend with because of his seam position and how cleverly he can move around the shiny side that has got some extra skid

"So, you have to make sure that you are in position a little bit quicker. He can also drift the ball away and bring the slip fielder into play," he explained. Root also offered a com-

parison between Ashwin and Nathan Lyon, the other



"With Lyon it is all about, I think, especially in the first half of the Test match, to get over the top of the ball, get the bowl bounce, knee roll high, in between and try to bring short leg and leg slip into the game as much as he can.

### Green likely to focus on Tests against India

Wellington, March 4: Australia batter Cameron Green is likely to skip the white-ball series in Pakistan later this year and instead play Sheffield Shield to prepare himself for the big-ticket home Test series against India in December, according to head coach Andrew McDonald.

He was not included in the recent T20I series against the West Indies and New Zealand and instead earmarked him for West Australia's Sheffield Shield fixture against Tasmania in Hobart, where he struck an unbeaten 103 to provide an ideal warmup for the first Test against the

"It's a big decision to leave anyone out of international cricket when they're potentially in the best eleven, so I'm glad he (Green) embraced that when we had that conversation with him, and the return on it is pretty immediate," McDonald said.

'The next stress point on that will be next summer, leading into the Indian Test series where we've got Pakistan in ODI cricket and T20 cricket. I'd like to probably err on the side of preparing him through red-ball - we know how good a white-ball player he is, so you put a priority on what

'The white-ball cricket's important, but geez that Test summer's important, so I think with the results he's had (at Wellington) he'll probably come to us and say 'can you give us a couple of Shield games before the

Other players can go (more readily) from one-day international cricket into Test cricket, and it's probably the more experienced players who have done it over a period of time.

Even though Australia are also preparing for a T20 World Cup later this year, for which Green remains in the selection mix, it was deemed more valuable for him to play Shield cricket than in recent T20Is given he will be exposed to plenty of 20over cricket in his upcoming
