Indian dies in Russia

Moscow: An Indian national has died in Russia and authorities are making efforts to send his mortal remains back home, the Indian mission here announced Wednesday.

A day after the public bonhomie between Prime Minister Narendra Modi and Chief Minister Naveen Patnaik at a meeting in Jajpur just ahead of the upcoming polls added fuel to the speculations of a possible understanding between the two main political parties in the state. Wednesday's quick developments cemented it further. While BJD leaders reportedly ensconced in closed door meetings over seat sharing with the saffron party in Bhubaneswar, the BJP's central leadership held discussions over the same in New Delhi. However, till late in the evening, leaders emerging out of these meetings gave guarded statements, leaving everyone to guess about the shape of such an alliance which observers feel was far from being necessary for both the

After over three hours of discussion, BJD vice-president and MLA Debi Prasad Mishra acknowledged discussions about a possible alliance with the BJP but did not explicitly confirm its formation.

"Biju Janata Dal will prioritise the greater interests of the people of Odisha. Yes, there were discussions on the issue (alliance)," Mishra told reporters.

Claiming that Odisha had progressed significantly under Naveen Patnaik's leadership, Mishra emphasised the need to take

the state's development to the next level. In a press release issued by Mishra and BJD's senior general secretary Arun Kumar Sahoo, it was stated, "An extensive discussion was held under the leadership of BJD president and CM Naveen Patnaik with the senior leaders of the party today regarding the strategy of the upcoming Lok Sabha and Vidhan Sabha elections.'

Meanwhile, after a meeting presided over by BJP president JP Nadda in Delhi, senior BJP leader and MP Jual Oram admitted to discussions on a pre-poll alliance with the BJD. However, he said the party's central leadership would make the final decision on the matter.

"Yes, there were discussions on the al-

liance among other issues. The party's central leadership will make the final call," Oram, who personally opposed the

alliance, said. Top leaders of the state including Odisha BJP president Manmohan Samal, and Union Minister Dharmendra Pradhan, attended the core committee meeting chaired by Nadda.

Both parties had previously rejected media reports about a potential pre-poll alliance February 29.

BJD national spokesperson Sasmit Patra and BJP's Odisha election in-charge Vijay Pal Singh Tomar had dismissed the reports as rumours.

Meanwhile, sources in the BJD said that another round of discussions would be held Thursday over the possible alliance with the saffron party.

5 get death for killing former Block chairman

BSKY Nabin Card for rural areas

Bhubaneswar, March 6: Chief Minister Naveen Patnaik Wednesday launched a health scheme - Biju Swasthya Kalyan Yojana (BSKY) Nabin Card - for people of the rural areas of the state.

Launching the BSKY Nabin Card, Patnaik said that people living in villages, except regular government employees and income taxpayers, will get this benefit.

The people will be able to get the benefits from May 1, a statement issued by the CMO said, adding that the scheme will be implemented under the "5T initiative" of the state government.

5T is a governance model in Odisha, based on teamwork, transparency, technology and time leading to transformation. The Nabin Card is an extension of the BSKY scheme under which about 1 crore families, around 80

per cent of the state's popula-

tion, are availing cashless health services, an official said.

In the new scheme, there is a provision of medical benefits up to ₹5 lakh for each member of

a family. The women, however are entitled to ₹10 lakh. Patnaik said the BSKY Nabin Card will help cover more families in this

Beneficiaries with BSKY Nabin Card are entitled to get cashless treatment for identified critical diseases - heart diseases, kidney diseases, liver diseases, brain stroke, severe head injury, brain tumour, burns management, nerve & muscle diseases and cancer - at all empanelled hospitals both inside and outside Odisha.

The card holders will also get cashless coverage at empanelled private hospitals from May 1. In the next phase, the benefit will be extended to all the people in the urban areas.

CM lays stone for ₹100cr Adivasi Bhawan

Bhubaneswar, March 6: Chief Minister Naveen Patnaik laid the foundation stone for state's maiden Adivasi Bhawan at Gothapatana here, Wednesday.

Estimated to be constructed at an approximate cost of ₹100 crore, the facility will serve as a versatile centre for deliberation, meetings, conferences, and showcasing of tribal art, culture, and development initiatives.

Dedicated to the tribal populace of the state, it is envisioned to be the focal point for tribal gatherings, contributing to the realisation of 'Nabin Odisha, Sashakt Odisha' (New Odisha



Strong Odisha), Patnaik said in a statement.

The ST and SC Development, Minorities and Backward Classes Welfare department, catering primarily to the needs of 22.85 per cent of the state's population, highlighted the repeated demand for this proposed facility from all communities.

Once completed, Adivasi

Bhawan will benefit tribal people from 64 ST categories, including Particularly Vulnerable Tribal Groups (PVTGs). It will include accommodation facilities, conference halls, and an outlet for Adisha with Koraput Coffee Café.

Managed as a project under the State-Level Administrative Unit for the Special Development Council (SDC), this multifaceted facility will address the needs of indigenous people, offering accommodation to visiting tribals and promoting cultural sensitivity and access to services.

The facility is envisioned to provide a comfortable stay for tribal community members, re-

specting their distinct cultural practices, dietary preferences, and social norms, thereby ensuring a more inclusive environment, the statement added.

Moreover, it will serve as a convenient base for accessing essential services and resources in Bhubaneswar, offering information and assistance regarding healthcare, education. government offices, and other amenities, it added.

Additionally, it will exhibit artefacts, traditional textiles, and other art forms for display and sale, enriching the cultural experience and promoting the region's artistic heritage, the state-

'Wife doing household chores not cruelty'

New Delhi, March 6: Setting aside a family court's order denying grant of divorce to a man, the Delhi High Court recently clarified that expecting a wife to undertake household chores does not amount to cruelty.

The judgement came from a division bench, comprising Justice Suresh Kumar Kait and Justice Neena Bansal Krishna, which was hearing an appeal filed by a man against a family court's ruling that had dismissed his request for marriage dissolution over alleged cruelty by his wife.

The bench stressed the shared responsibilities that come with marriage, stating that tasks done by a wife for her household stem from love and affection, and should not be compared to the work of a maid-servant.

The expectation from a wife to manage household duties, according to the court, falls within the traditional division of responsibilities and cannot be viewed as cruelty.

Despite setting aside the family court's judgement and granting the man divorce based on other grounds of cruelty under Section 13(1)(ia) of the Hindu Marriage Act, 1955, the court's observation on household chores drew attention to the balancing of roles within a marriage.

The couple, who got married in 2007 and became parents to a son born in 2008, experienced a strained relationship from the

The husband accused the wife of reluctance to perform household duties and failing to integrate with his family, claims the woman contested by stating that her contributions went unappreciated.

The bench noted the husband's efforts to salvage the marriage, including arranging separate accommodation to please his wife. However, the court observed that her frequent departures to live with her parents suggested a reluctance to uphold matrimonial unity, and depriving the husband of a shared life with

Kolkata, March 6: The CBI Wednesday got the custody of Sandeshkhali Enforcement Directorate (ED) official

attack case accused Shahjahan Sheikh from the West Bengal CID, following two orders by the Calcutta High Court to do so on two consecutive days. In a fresh directive Wednesday, the

HC directed the state government to 'immediately implement' its Tuesday's judgement to transfer a case on the attack on ED officials at Sandeshkhali to the CBI and hand over custody of the main accused Sheikh to the central agency.

A team of CBI officials reached CID headquarters Bhawani Bhawan before 4pm. But the handover from the state agency took place at around 6:48pm, despite the Calcutta HC setting a deadline of 4:15pm. "Shahjahan Sheikh was handed over to CBI." a CID official said.

The CID took him to a state-run hospital for a medical check-up before handing him over to the CBI.

The CBI officials are likely to take him to an ESI Hospital and then to Nizam Palace, the city office of the central investigating agency. He was arrested in a case related to a mob attack on ED officials at Sandeshkhali January 5 when the central agency had gone to search his premises in connection with an alleged ration distribution scam

high court setting a 4:15pm deadline, Shahjahan Sheikh was handed after more than two hours. This only proves that the TMC government has the least regard for the judiciary," BJP MLA Shankar Ghosh said. The CBI Tuesday failed to get the custody of suspended TMC leader Shahjahan Sheikh from the West Bengal CID even after waiting for more than two hours.

The CID said the leader of Sandeshkhali was not handed over to the central agency as the state government had moved the Supreme Court against an order of the Calcutta HC.

But an apex court bench refused an urgent listing of the plea and asked the state's counsel to mention the matter before the Registrar General.

Sheikh, one of the key accused in cases of atrocities against women in Sandeshkhali, was arrested last Thursday by the West Bengal police. The case was later taken over to the West Bengal CID.

Earlier in the day, the ED moved a contempt petition before a division bench presided by Justice Harish Tandon against the state government claiming that it did not implement Tuesday's orders of a division bench presided by Chief Justice TS Sivagnanam

The court noted that though the state pleaded that it has filed before the Supreme Court an SLP challenging Tuesday's judgement, there is no interim stay granted on the implementation of the orders till the time it was passing its order.

in EV sales in 2023, with volumes sur-

passing 1.5 million-marking a 50 per cent increase from previous year. The overall share of EVs in India's auto sales has risen sharply to 6.38 per cent in 2023 from 1.75 per cent in 2021, reflecting a growing consumer pref-

erence for electric vehicles over a twoyear period.

Blockchain Primetime

s the crypto winter thaws, and financial institutions renew their interest in digital assets, an old debate has re-emerged over whether blockchain is truly a "trust machine," as The Economist

A figure from fifteenth-century Venice can help answer that question. Though he was neither a technologist nor a banker, the friar Luca Pacioli is remembered today for developing the double-entry bookkeeping accounting system that underpins much of the modern economy. It was his ingenious model that introduced debits and credits to the method of recording transactions in two separate accounts.

This seemingly boring and cumbersome tweak to a core business function didn't just ensure accuracy and curb fraud; it also gave owners new insights into how to run and improve their businesses and cut costs. Under Pacioli's system, efficiencies soared, commerce accelerated, and the Renaissance took flight. Double-entry accounting became a cornerstone of economic activity because it was simple, easily shared, and undeniably useful. Centuries later, financial statements based on Pacioli's work became mandatory for any business. Such is the power of a basic infrastructure upgrade.

The broader lesson is that an innovation that makes it from conception to global adoption typically passes three tests of public trust: Does it work? Is it useful? Is it safe? Or put another way, users expect competence, value, and reliability.

Today, blockchain's advocates see the technology as the next great leap toward making financial transactions massively more efficient. "The root problem with conventional currency is all the trust that's required to make it work," wrote Bitcoin's pseudonymous creator Satoshi Nakamoto "With e-currency based on cryptographic proof, without the need to trust a third-party middleman, money can be secure and transactions effortless." Nakamoto envisioned crypto proofs replacing human trust to create a truly peer-to-peer, trustless financial system.

The underlying blockchain technology that Bitcoin's creator(s) deployed builds elegantly on the foundation that Pacioli laid. Imagine if a fifteenth-century Florentine merchant's ledger entry showed up instantly on the books of every other merchant. Such a distributed ledger creates triple-entry (or effectively infinite-entry) accounting, making the data immutable and

incontestable. That functionality alone is transformative, but the architecture of blockchain networks gives them superpowers well beyond financial applications. As the tech entrepreneur Chris Dixon notes, "[I]t's wrong to think of blockchains as mere ledgers for tabulating numbers.

Blockchains are not databases; they're full-fledged computers.' Of course, one of the great ironies of the crypto industry is that a technology grounded in a desire to strengthen financial trust has generated so much mistrust. But while The Economist was not wrong to call blockchain a trust machine nearly a decade ago, its assessment may have been incomplete. After settling literally trillions of transactions, blockchain's fundamental claim to facilitate the reliable exchange of value has been well verified. Though it is little solace to those who lost funds during the industry's implosions in recent years, those episodes reflected irrational exuberance and old-fashioned fraud, not any flaws

of distributed-ledger protocols. These failures were as predictable as they were regrettable. Excitement about emerging technologies typically outpaces their utility, leaving a wake of disappointments. Even the most promising technologies struggle with early design flaws. AI chatbots can hallucinate. Electricvehicle batteries can fail in extreme cold or heat. New software is often buggy. And blockchain networks have not been fully immune to hacks and performance issues. But their battle-tested durability makes

them well positioned to upgrade the way we move money. What about usefulness? This quality is more subjective. Obviously, collectible cartoon apes and purely speculative trading do not amount to a transformative, more inclusive upgrade to the global financial

Fortunately, responsible market players today are using blockchain to do many other things: delivering mobile, corruption-resistant humanitarian aid to refugees; lowering the costs of charitable giving, remittances, and cross-border payments by 80%; expanding access to basic financial services; giving workers in high-inflation countries a portable store of value; establishing provenance to power the "creator economy;" transmitting money at scale with the ease, security, and speed with which the internet transmits data; and upgrading legacy financial rails that date back to the 1970s.

While still nascent, these applications undeniably deliver high social and economic value. That brings us to the third question: whether blockchain-based financial rails are safe – which, in financial services, means regulated. Can users expect common, high standards around the world? Not quite yet, but we're getting close.

This is another irony for crypto. What began as a libertarian vision $\,$ for a code-based financial system air-gapped from government is colliding with regulatory reality. There is a growing recognition that blockchain-based networks and financial applications are not displacing so much as modernising and democratising traditional financial infrastructure. That means working with - not against - regulators and policymakers.

The good news is that 2024 is poised to bring greater regulatory certainty. Japan, Hong Kong, Singapore, and the European Union have all established strong standards and consumer protections for this growing ecosystem. And the US Congress could follow suit this year with bipartisan digital-asset and stablecoin legislation that would crack down on illicit financing and counterfeit digital currencies. That would make a material difference in public confidence.

Is blockchain a trust machine? The year ahead could give us a definitive

OLD PENSION, NEW CHALLENGES



PSM Rao **THE OPS BEING FAR SUPERIOR AND MORE** BENEFICIAL **COMPARED TO** NPS, THE **GOVERNMENT EMPLOYEES ARE AVERSE TO ACCEPTING THE** LATTER

he OPS enemies are honing their lethal weapons by the day to bludgeon the NPS. Yet the governments of five states, Rajasthan, Chhattisgarh, Jharkhand, Punjab, and Himachal Pradesh have already reintroduced the Old Pension Scheme. The Karnataka government is in the process of reverting to OPS and Telangana is likely to follow suit soon since the ruling Congress promised it in its poll manifesto. Rebirth of OPS in every state and may be at the Centre seems to be the fait accompli for the new government after the 2024 election given the success of the employees achieving their demand in these states and the intense battle elsewhere chiefly enthused with this success despite tough opposition by the government at Centre and it supporters and despite some new hurdles in process of switching to OPS.

First a brief recapitulation of OPS, before going deeper into the current tussle. The government employees enjoyed pension even during British time; pension was introduced in 1881. The Royal Commission on Civil Establishments (Lee Commission) of 1924 recommended half the salary as pension for its recruits serving in India. The Government of India Act 1935 further strengthened pension provision. Lee Commission's suggestion. So, government employees have been enjoying pension benefit for more than a hundred years.

Notwithstanding this deeply entrenched post-retiral security, the government of India notified in December 2003 the replacement of OPS to prospectively take effect from January 1, 2004 (applicable for those who were recruited after that date). The OPS entailed a pension of about half the last drawn salary to its employees without any contribution from them towards any pension fund while the NPS required the employees to contribute 10% of their basic and DA to the pension fund and a matching contribution from the employer (the employers' share, however, was raised to 14% in 2019).

Not going into too much detail. the fund collected from the employees under NPS will be paid

to them on retirement, along with returns on it, partly in lumpsum and partly (at least 40% of accumulated amount) as annuities/periodic pension through Annuity Service Providers, life insurance companies. Thus, OPS accrued to employees as a right and without any contribution from them; clearly, it is a defined benefit with no contribution scheme whereas NPS entailed a defined contribution without a defined benefit.

The OPS being far superior and more beneficial compared to NPS, the government employees are averse to accepting the latter. When they see their counterparts in some states succeeding in dumping NPS, they do not want to be silent spectators without themselves launching a similar movement. Already the process is on. Indian Railways employees have already threatened to go on a nationwide strike from 1 May if their demand for the restoration of OPS is not met by then.

The additional impetus: West Bengal government has never accepted NPS while Tamil Nadu though accepted it in 2003 has never implemented the scheme in its true earnest. As employees have been enjoying this benefit for ages it is not an easy task for governments to convince their employees to accept an inferior benefit. The government knew this very well. So it made its 2003 notification to be effective from 1 January 2004 to those employees who were recruited after that date. As it did not affect the existing employees there was not enough resistance to stall the move in the beginning. The

protest started very late. Intense agitation is seen now, two decades after the launch of NPS.

Then what are the objections of the pundits who oppose the OPS and what are the counterarguments? Their main argument is the burgeoning financial burden on the government if the OPS is restored. A recent RBI Bulletin article (September 2023) argues that "the cumulative fiscal burden in case of OPS could be as high as 4.5 times that of NPS, with the additional burden reaching 0.9% of GDP annually by 2060." The short-run reduction in the outgo with the discarding of NPS and the monthly payments towards it is no comfort because the long-run burden with the reintroduction of OPS will be untenably high since it is an unfunded pay-as-yougo model which entails payment out of the current revenues whereby the governments' capital expenditure gets eroded with the resultant adverse impact on output, income and employment.

One reason for the increasing burden as per the OPS critics is the increasing life expectancy. The UN projected average global life expectancy will go up to 77.2 years in 2050 from 72.9 years in 2022. The share of people above 65 years will increase from 10% to 16% over the same period. So, a larger pension outgo.

Also, they ridicule the argument of OPS as a good old-age social security because it pertains only to government employees whose proportion is less than 4% of the country's total workforce and therefore it would be unjust to spend public money on this minuscule share of workers

Now absurdity of these arguments. When the critics themselves say that the OPS is for a small proportion of workforce, how can they say the burden increases in proportion to GDP? While the government boasts of the fast growth of the economy, the fastest in the world with the likelihood of reaching a \$5 trillion level, how can it be a burden to pay pension under OPS, asks noted economist Prabhat Patnaik in his recent article in People's Democracy. Patnaik also says that the pension burden will not increase in real terms since the governments do not revise the pension amount in tandem with rising inflation. He asserts the burden would proportionately decrease, not increase if the growth claims of the govern-

ment are valid. The extremely materialistic approach of OPS haters is that the burden would be higher on account of the increased longevity of people. The government should welcome and feel happy if life expectancy is increasing and should not feel it as a burden. The welfare of the people which includes senior citizens should be its responsibility. Also, it should be understood that the longevity increase will require continued and better support to senior citizens to ensure their dignified life without financially depending on others.

The claim that government employees' share is very small should not make the government stop providing necessary support on the fiscal constraint's plea. The government in a welfare state should act as an ideal employer and pay decent wages and pension to its employees. It should not stop at that but should work towards a pension scheme in the non-government sector. too, on par with its pension. It should discuss with stakehold ers on the modalities and define the benefits - Discuss and Define the Benefit - a DDB Scheme. The goal should be to revert to OPS to government employees and take the initiative to provide adequate pension to all employees in private sector, not reduction.





Bhubaneswar, March 6: The Odisha Congress Wednesday accused Prime Minister Narendra Modi of falsely claiming credit for establishing the Indian Oil re-finery at Paradip in Jagatsinghpur district.

Addressing a press conference, Odisha Pradesh Congress Committee (OPCC) president Sarat Pattanavak and former chief Prasad Harichandan asserted that the project was initiated by ex-PM Manmohan Singh.

Inaugurating the mono ethylene glycol project in Paradip refinery, along with several other projects, Modi Tuesday said the

previous governments had not shown interest in completing projects on time. He claimed that projects stalled during previous administrations were completed during the tenure of the BJP-led Centre in the past 10 years.

The project was started in 2002. However, no progress was made till 2013-14. It is the NDA government which completed it. Modi had said at the event. which was attended by Chief Minister Naveen Patnaik.

OCC president Pattanayak claimed the UPA government had allocated Rs 35,000 crore for the project and criticised both the BJP and BJD for attempting to take credit for it.

Harichandan added that former prime minister Narasimha Rao had decided to set up the project in Odisha and proposed land acquisition for it. JB Patnaik then acquired the land. He said former prime minister AB Vajpayee laid the foundation stone in 2000 with the aim to complete the project by 2003, but it faced delays.

The Congress leader noted that the Manmohan Singh government allocated funds for the refinery in 2004, and it was nearly completed by the end of 2013. After assuming power in 2014, Modi inaugurated the project and took credit for it, he claimed.

Winter snow deficit poses growing risk of **GLOFs in Himalayas**

According to meteorologists, increasing global warming has been altering the weather patterns, leading to anomalies in the temperatures and rainfall patterns

Shimla, March 6: The reduced snowfall in the Himalayas increases glacial lakes that pose a growing risk of lake outburst floods (GLOF) in the Himalayas, warn glaciologists.

They call for increasing preparedness, international cooperation and climate adaptation.

The Himalayan state of Himachal Pradesh received large deficit winter precipitation of 31 per cent since January 1 with nine out of 12 districts having received deficient precipitation, says the Meteorological Centre in Shimla.

The highest cumulative monthly rainfall in winter in Himachal Pradesh occurred in 1954, it says, adding the state received isolated rainfall in January with weak activity on many days and one day of normal activity January 31.

In February, the state received five spells of precipitation with moderate precipitation at few places. Kullu and Mandi districts received normal rainfall with excess precipitation in Chamba district.

Meteorologists told IANS that warmer winters continued for the second consecutive year across India. The cumulative countrywide rainfall from January 1 to February 29 is a large deficit by 33 per cent. The actual rainfall recorded during the winter season was 26.8 mm against the normal average of 39.8 mm. The prime weather system, western disturbances, continued to dodge western Himalayas as they mostly trav

Western disturbance is known to drive the weather activities and bring winters to northwest India and adjoining areas of central India. Both the intensity as well as frequency of western disturbances has been on the lower side this winter season.

Western disturbances are primarily disturbances originating in the west and travelling in the upper atmosphere in the subtropical westerly jet and arriving in the Indian sub-continent during the winter time. Their frequency peaks during December to February, with an average number of four to five per month.

Climate change and associated glacier recession have led to the formation of new glacial lakes and the expansion of existing ones across the Himalayas.

Many pose a potential glacial lake outburst flood threat, a climate change-induced threat, to downstream communities and infrastructure.

The term glacial lake outburst flood refers to the catastrophic release of a water reservoir that has formed at the site of a glacier. Glaciologists warn of last year's Sikkim-like glacial lake outburst in other Himalayan

According to a recent report on the Himalayas by the University of Zurich, glacial lakes are highly dynamic water reservoirs that respond to climate change by expanding in number, size and volume. This is particularly evident across the mountains of Asia, including in the Hindu Kush Karakoram Himalayas, Tien Shan and Tibet.

Cong removes HP leader from party secy's post

New Delhi/Shimla, March 6: The Congress has stepped up efforts to set its house in order in Himachal Pradesh and is holding parleys with senior ministers of the state where its government was on the edge after six party MLAs switched sides and helped the BJP nominee win the lone Rajya Sabha seat in the state.

The party Wednesday removed former minister Sudhir Sharma, who was among the six rebel MLAs who were later disqualified for defying party whip on the state budget, from the post of Secretary immediate effect

Sharma is a senior leader from Dharamshala and a former Himachal Pradesh minister.

In a release, Congress general secretary K C Venugopal said party president Mallikarjun Kharge has removed Sharma from the post of secretary with immediate effect.

Sharma responded in a Facebook post saying, "I have been relieved as if all the burden was on my shoulders. One who does not need anything is Shehanshah.'

In another post, he quoted the Bhagwad Gita which said, "Suffering injustice is as much a crime as committing it" and asserted that the decisions taken by them are based on it.



He also said that he will continue to remain dedicated to the state of Himachal Pradesh and its people.

Senior party legislator Rajinder Rana also announced his resignation from the post of working president of Himachal

"I do hereby resign from the post of working president of HPCC with immediate effect," Rana said in his resignation letter to Kharge that he shared in a post on Facebook.

"Running from Suja Shimla and from Shimla to Delhi with folded hands for the fulfilment of the promises made by the Congress in the run-up to the last Assembly polls in Himachal Pradesh did not yield results. I wished for justice, but got only humiliation," he had said in a Facebook post addressed to people of Himachal Tuesday.

Sources said Kharge and general secretaries Priyanka Gandhi Vadra and K C Venugopal have been meeting senior legislators and ministers from Himachal Pradesh after the party managed to save its government in the state by getting the state budget passed through voice vote.

The Congress currently has 34 MLAs while the BJP has 25 and three are independents who had also sided with the BJP in Rajya Sabha polls. The six rebel Congress MLAs have meanwhile challenged their disqualification in Supreme Court.

The sources add that the Congress leadership met state deputy chief minister Mukesh Agnihotri this weekend, while Priyanka Gandhi spoke to senior minister Vikramaditya Singh

to help address their concerns. Efforts are being made by the party leadership to end the rebellion against the Sukhu government in the hill state and Priyanka Gandhi has also stepped up efforts to assuage the feelings of some rebels.

Asked about the possibility of the rebels returning to the party fold, Vikramaditya Singh, who is among the disgruntled leaders and had even submitted his resignation in the midst of the crisis, said, "Everything is possible in politics and all doors are open in politics.'

Singh recently met senior Congress leaders in New Delhi, including Priyanka Gandhi, after holding talks with the six rebel MLAs in Panchkula. "I was officially assigned the responsibility of meeting the rebels and have done my duty," he said in Shimla.

Himachal Chief Minister Sukhwinder Singh Sukhu also held consultations with the party leadership in Delhi.

Training his guns on Congress ebels. Chief Minister Sukhu. in his address at a public event in Hamirpur Wednesday, said he never imagined that a few MLAs from the district will go against the party and hinder the pace of development in the district.

Water situation grim in Shahapur

Thane, March 6: The number of hamlets and villages affected by acute water shortage in Shahapur taluka of Maharashtra's Thane district has gone up to 42 so far this year as compared to 26 in the corresponding period in 2023,



prompting the administration to rope in more water tankers, officials said.

These figures were revealed by the Thane Zilla Parishad in its report Wednesday. Till March 4 this year, the population affected by water shortage in the taluka stood at 12,683 as compared to_ 9,871 last year.

Eight villages and 34 hamlets were affected by acute water shortage this year as compared to eight villages and 18 hamlets in the corresponding period last year, the report said.

A total of eight tankers were used last year to supply water to these affected villages and hamlets, which has now gone up to 15 this year, it added.

Mumbai, March 6: The Maharashtra government Tuesday announced that a pod taxi service will be launched to ease commute to the business hub of Bandra-Kurla Complex. The Mumbai Metropolitan

Region Development Authority (MMRDA) has approved a pod taxi service on the 8.8 km route between Bandra and Kurla railway stations, the chief minister's office said in a release. Pod taxis are small automated

cars that operate on a network of specially built guideways. With a capacity of six passengers each, the pods will run at the speed of 40 km per hour and will have 38 halts, it stated.

The project will be implemented on a public-private partnership basis and will ease the commute to BKC from the two railway stations. The project on the busy Bandra-BKC-Kurla route is expected to cost Rs 1016 crore, an MMRDA official said.

A reputed consultant has conducted the techno-economic feasibility study for this Automated Rapid Transit System. "It will take three years to build the Advance Rapid Transit System after receiving all the necessary



permissions," the official said. He said Chief Minister Eknath Shinde has given his approval for issuing a tender for POD taxis on the route. Every day, more than 4 lakh passengers travel to BKC for work, and as per the feasibility report, 1.09 lakh people are expected to use the POD taxi service by 2031, the official added.

"Daily 1.09 lakh passengers are expected to travel on these POD taxis by 2032 and the estimated per km travel cost is Rs 21 per kilometre. This (POD Taxi) will not only help people who will get down at BKC, but it will also provide first and last-mile connectivity in the stretch," said the official.

MMRDA is the regional planning and executing body for the Mumbai Metropolitan Region that includes some areas in neighbouring Thane, Raigad and Palghar districts along with Mumbai.

Himachal CM Sukhu **launches Mobile Veterinary Service**

Sukhu said that with the launch of these services, the farmers from any part of the state can call on toll-free number 1962 and get veterinary services at their doorstep for the treatment of serious animal diseases in case of any emergency.

He said that a veterinary doctor and a pharmacist would be available with each ambulance and added that this service would be expanded in a phased manner in the near future. The Chief Minister said that cattle breeders would be able to call the toll-free number 1962 and help will be provided to them through the nearest veterinary service.

Not answerable to Shah: NCP (SP)

Mumbai, March 6: The Nationalist Congress Party (SP) Wednesday said that it was not answerable to senior Bharatiya Janata Party (BJP) leader and Home Minister Amit Shah - a day after he criticised party leader Sharad Pawar.

The response of NCP (SP) by national spokesperson Clyde Crasto and chief spokesperson Mahesh Tapase came after Amit Shah slammed Sharad Pawar, saying the "people of Maharashtra suffered him for 50 years", and questioned his contribution to the state.

India to grow at 6.8% in FY25: Crisil

The country to become upper middle-income country by 2031, says the ratings agency

New Delhi, March 6: Crisil Ratings Wednesday projected India's GDP growth at 6.8 per cent in the next fiscal and said the country will become an upper middle-income nation by 2031 with the economy doubling to \$7 trillion.

In its India Outlook report, Crisil said the Indian economy will take support from domestic structural reforms and cyclical levers and can retain -- perhaps even improve -- its growth prospects to become the third largest economy by 2031.

"After a better-than-expected 7.6 per cent this fiscal, India's real GDP growth will likely moderate to 6.8 per cent in fiscal 2025,' said the Crisil India Outlook re-

It said that the next seven fiscals (2025-2031) will see the Indian economy crossing the \$5 trillion-mark and inching closer to \$7 trillion.

"A projected average expansion of 6.7 per cent in this period will make India the third-largest economy in the world and lift per capita income to the uppermiddle income category by 2031,"

India, with a GDP size of \$3.6 trillion, is currently the fifth largest economy in the world, after the US, China, Japan and Crisil expects the economy to

expand to \$6.7 trillion by fiscal

RBI asks card insurers to give users choice of selecting network

Mumbai, March 6: Reserve Bank has directed banks to provide their eligible customers with an option to choose from multiple card networks at the time of issuing credit or debit cards, a move which will benefit card users.



The central bank also asked issuers of credit cards not to enter into any arrangement or agreement with card networks that restrain customers from availing the services of other networks.

On a review, it is observed that some arrangements existing between card networks and card issuers are not conducive to the availability of choice for customers," the Reserve Bank said in a circular.

For the existing cardholders, this option may be provided at the time of the next renewal, it

"The RBI being satisfied that it is necessary and expedient, in the interest of payment system and public interest, to do so, hereby, directs... Card issuers shall not enter into any arrangement or agreement with card networks that restrain them from availing the services of other card networks," it said.

The circular listed authorised card networks -- American Express Banking Corp, Diners Club International Ltd, MasterCard Asia/Pacific Pte Ltd, and National Payments Corporation of India -- Rupay and Visa Worldwide Pte Limited.

Card issuers and networks_ will have to ensure adherence to the RBI's guidelines in existing agreements at the time of amendment or renewal and when fresh agreements are executed, it said.

However, it said the direction would not be applicable to credit card issuers with number of active cards issued by them being 10 lakh or less in number. 'Card issuers who issue credit

cards on their own authorised card network are excluded from the applicability of the circular," it said. The directions of providing

options to the eligible customers to choose from multiple card networks would be effective 6 months from the date of this circular, it added

Musk vs Altman is a battle everyone loses

New York, March 6: Who decides what's best for humanity? Elon Musk thinks that

OpenAI, run by Sam Altman, is shirking its responsibilities on the matter. Tesla's chief executive filed a lawsuit last week claiming Altman's shop is being run for profits instead of the greater good. But the whole dispute rests on

the assumption that it is up to heroic tech entrepreneurs to shape the development of an existentially dangerous technology. Regulating issues affecting

the fate of everyone is the remit of a democratic government. Artificial intelligence is no dif-It is easy to be cynical about

Musk's attack on OpenAI. He launched his own AI company, xAI, in July last year. It is a bit player compared to Altman's Microsoft-backed outfit.

Any effort to force OpenAI to open up its technology or relinquish funding, as this lawsuit demands, could weaken the com-



pany and allow Musk's version to take market share.

That's bad news for Altman. The worse news for humanity is that the proceeding posits either Musk or Altman to be arbiters of the species' best

AI promises to totally reshape how people interact with the world around them, from entertainment to health to information. Mapping that interaction shouldn't be the responsibility of one human. In fact, demoexistentially risky technologies

and forces. Musk has already shown the dangers of foregoing those guardrails. He was lauded for allowing Ukrainians to use his company's Starlink satellites to facilitate communications after Russia invaded the country.

According to a recent article in the Wall Street Journal, however, Russian troops have access to "thousands" of Starlink systems. Biographer Walter Isaacson wrote that Musk restricted access Gallagher has claimed that Musk may have withheld Starlink service over Taiwan.

Tech founders, including Musk and Altman, regularly preach the libertarian notion that governments meddle too much, or in the wrong way. It's one thing to argue over entrepreneurialism when it comes to gadgets. But when it comes to defense and technology, their idiosyncratic ideologies may be more dangerous than even corporate profitmaximizing. Regulating their actions isn't antithetical to the foundations of either U.S. political party, either. Both Democrats and Republicans agree that the actions of social media firms like Meta Platforms should be tempered.

If cutting-edge technologies can tip the balance of global power, forcing AI companies to use their smarts to publicly identify whether a person is interacting with algorithms or humans, say, would be a start.

85% Paytm wallet users not to face disruption: RBI Guv

New Delhi, March 6: As many as 80-85 per cent Paytm wallet users will not face any disruption because of regulatory actions. and the remaining users have been advised to link their apps to other banks, RBI Governor Shaktikanta Das said Wednesday.

The Reserve Bank of India January 31 barred Paytm Payments Bank Ltd (PPBL) from accepting deposits, credit transactions, or top-ups in any customer accounts.

The deadline for linking the wallet attached with PPBL with other banks has been fixed for March 15, the governor said, ruling out any further extension.

The time given up to March 15 is sufficient and there is no need for further extension, he said, adding that 80-85 per cent Paytm wallets are linked to other banks, and the remaining 15 per cent have been advised to move on to other banks.

Dharamsala, March 6: The contest against England's 'Bazballers' was probably the biggest Test of Rohit Sharma's captaincy at home and not only did the India skipper ace it, he also got to "learn a lot" about his leadership in what he described as a "series of comebacks'

India have been put under pressure in all the four Tests played thus far but after the Hyderabad debacle, the hosts managed to put the pressure back on the opposition to seal the series in Ranchi. The finale starts here Thursday.

Rohit struggled to define the 'Bazball' approach adopted by England but gave the opponents due credit. "Honestly, I don't know what Bazball means... Whether it is to go and strike? whether it is to go and defend and wait for the loose ball? because I've not seen any wild swinging from anyone. I don't know exactly what this term means," Rohit said Wednesday.

"But yeah clearly they've played better cricket than the last series they were here. And you've got to give credit to two of their batters who got big hundreds (Ollie Pope and Ben Duckett," he added.

Earlier, Duckett had suggested that the series' leading run-getter Yashasvi Jaiswal learned a lot from the opponents' fearless approach. Rohit was amused when reminded of that remark. "I think there was this guy called Rishabh Pant in our team. Probably Ben Duckett hasn't seen him bat," he quipped.

Kane steers Bayern into CL quarterfinals

Munich, March 6: Harry Kane scored twice to steer Bavern Munich into the quarterfinals of the Champions League with a 3-0 win over Lazio Tuesday. Kane's 32nd and 33rd goals this season for Bayern ensured the Bayarian powerhouse recovered from losing the first leg of the last 16 tie 1-0 in Rome to win 3-1 on aggregate over two legs.

The win will ease the pressure on Bayern coach Thomas Tuchel, whose premature departure at the end of the season was announced by Bayern after the team's three-game losing run — including the defeat in Rome.

Bayern's new sporting director Max Eberl said before Tuesday's game that Tuchel would remain in charge afterward even if the team lost, but there had been a feeling defeat would bring forward the coach's exit. Bayern, which is 10 points be-

hind Bayer Leverkusen in the Bundesliga, was facing the prospect of just its second elimination in 12 appearances at this stage of the Champions League.

Kane broke the deadlock in the 38th minute after Ciro Immobile had gone close for Lazio at the other end. Thomas Muller headed Aleksandar Pavlovic's cross back for Raphael Guerreiro to mishit it, and Kane threw himself at the ball to just

head it past Ivan Provedel in the Lazio goal.

There was still time before the break for Muller to score in first-half stoppage time with a glancing header to Matthijs de Ligt's shot after a corner.

Kane sealed the result in the 66th by firing in the rebound after Leroy Sané drew a save from Provedel. It was the England captain's sixth Champions League goal this season.

Mbappe scores twice

Kylian Mbappe led Paris Saint-Germain back to the Champions League quarterfinals Tuesday, scoring both goals in a 2-1 win over Real Sociedad that kept alive the French club's hopes of winning the European title in its last season with the France forward. Mikel Merino scored Sociedad's lone goal in the 89th to give the home crowd some reason to celebrate.

PSG advanced 4-1 on aggregate, with Mbappe also scoring one of the goals in the 2-0 win in the first leg in Paris three weeks ago. Mbappe has already told PSG he will not stay with the club after this season.
