








Taapsee spills beans on showbiz's harsh realities



Fall of an Institution

The out of the blue resignation of Election Commissioner (EC) Arun Goel just days ahead of the possible announcement of dates for the general elections has sparked a political firestorm and triggered a flurry of speculations. Whether he resigned due to differences with the Chief Election Commissioner (CEC) or the government at the Centre or he has intentions to contest elections on the ruling party's ticket, just like the former Calcutta High Court judge Abhijit Gangopadhyay who resigned recently to join the BJP, he has caused quite a stir.

Whatever the case, the unexpected move has only weakened one more institution mandated to uphold Indian democracy, that too when the nation is on the cusp of going to the all important Lok Sabha polls. There are allegations from various quarters that the independence of the country's institutions is being undermined, one institution at a time, while premier probe agencies like the ED, CBI and Income Tax department have all become puppets of the government at Centre.

With Goel's resignation, the three-member Election Commission of India (ECI) is now left with only one member - CEC Rajiv Kumar. The other member, EC Anup Chandra Pandey, had retired last month. Goel's tenure was to end on 5 December, 2027, and he would have become the CEC after incumbent Rajiv Kumar's retirement in February 2025.

Reacting to Goel's shock exit, Opposition Congress has said that if the "systematic decimation of independent institutions is not stopped then democracy shall be usurped by dictatorship." In a post on X, Congress president Mallikarjun Kharge wrote: "Election Commission or Election OMISSION? India now has only one Election Commissioner, even as Lok Sabha elections are to be announced in few days. Why? The Congress has affirmed that Goel's exit is indicative of the government's unwillingness to conduct a "free and fair election."

Goel is not new to controversies. In fact, this is not the first time he has hit the headlines. The former IAS officer assumed charge as EC in January 2022. His appointment had triggered a controversy when he voluntarily retired from the Indian Administrative Service on 18 January, when he was Union Heavy Industries Secretary and was appointed as EC the very next day. The Association of Democratic Reforms (ADR) filed a petition in the Supreme Court challenging Goel's appointment, claiming it was arbitrary and undermined the institutional integrity and independence of the ECI. During the hearing, the SC commented on the haste in which he was appointed. The SC referred to the "tearing hurry" with which the Law Minister and the Prime Minister recommended Goel's name, emphasising the need for a transparent and deliberate process. However, in August 2023, the court rejected the petition stating that a Constitutional Bench had earlier considered the matter and decided against annulling the appointment.

As per the new legislation regarding selection process for the CEC and ECs, a search committee will be formed to identify five potential candidates. This committee will be chaired by the Minister of Law and include two secretaries. Following the shortlisting process, a selection committee will be formed to make the final decision. This committee will be led by the Prime Minister and include a Union Cabinet Minister chosen by the Prime Minister, as well as the Leader of the Opposition in the Lok Sabha or the leader of the largest Opposition party in the House. Together, they will select one candidate from the list of five. Ultimately, the chosen CEC or EC will be appointed by the President. Now, all this has to be done in haste, a trademark of the present dispensation, as the polls are only weeks away

Goel's resignation is reminiscent of Ashok Lavasa's resignation as EC in August 2020. Lavasa had given dissenting notes on various model code violation decisions taken by the EC in the 2019 Lok Sabha polls. As matters stand, the ECI, which has already become an extended arm of the government, will further lose credibility. Mallikarjun Kharge was right when he remarked: "The ECI will now be among the last Constitutional institutions to fall.

Subverting Justice

The way the State Bank of India (SBI) has sought to interpret the Supreme Court's order declaring the Centre's Electoral Bond Scheme S) unconstitutional and virtually declined to disclose the identities of both the buyers and recipients of the bonds tends to confirm the fact that law is often "more honoured in the breach than the observance." The judgement on the EBS is a watershed moment in exposing wrongdoing of monumental proportions by the government. The SC in its order directed the SBI to submit by 6 March details of electoral bonds purchased since 12 April, 2019, to the Election Commission of India (ECI). This would have disclosed the names of the beneficiaries of the scheme, i.e. the political parties, and names of those who donated to political parties through buying the bonds for electioneering. The allegation that the ruling BJP got the lion's share of the funds generated in this manner by tampering with the laws of the land and Constitutional provisions may seem true. This is said to have disproportionately favoured the ruling party in enriching itself through a quid pro quo letting the contributors influence government policies to augment their profits in return for the money they had given in the name of purchasing the electoral bonds.

The apex court judgement was hailed as a triumph of democracy which

struck at the roots of a dubious scheme.

However, far from complying with the court order, the SBI in a brazen show of defiance and seeming intent to shield the current dispensation, moved on 4 March its plea for extension of time till 30 June arguing that "decoding" the data and matching donors to the donations would be a "complex process". This meant not only the court order on submission of the data to the ECI by 6 March was flouted, but also the very purpose of the judiciary's laudable efforts to prevent the misuse of money for electioneering in the name of the EBS before the next Lok Sabha election to be held soon was defeated.

Banking experts have questioned the SBI's plea that it would take a long time to compute the details of the purchasers of the bonds and their beneficiaries since they point to the digitised system where it takes only a click of the mouse to get all the data and this can be done in 24 hours. The government has risked its reputation of being transparent. Its 'zero-tolerance towards corruption' claim is also proven untrue. Obviously it is pulling the strings from behind to make the SBI approach the SC with the absurd and motivated plea seeking enough time to ensure the general elections are over before the disclosure is made public. In that case the revelation of names of the donors and their main

beneficiary would be inconsequential.

The Association for Democratic Reforms (ADR), the lead petitioner, has done a commendable job by approaching the SC a day after the deadline for SBI to submit details of electoral bonds to the ECI ended in demanding contempt action against the bank for defying the court's directive. The SC immediately responded and Advocate Prashant Bhushan appearing for the NGO, urged the bench presided by the CJI to hear the plea on 11 March when he said the SBI application too is likely to be taken up. ADR contended that SBI "has deliberately filed" the application on 4 March, 2024, "at the last moment in order to ensure that the details of donors and the amount of donations are not disclosed to the public before the coming Lok Sabha elections." The petitioner has made the interesting plea that the SBI has the record of the unique number allotted to each electoral bond and KYC details of its purchaser. In fact, the requirement of KYC is mentioned in Section 4 of the EBS itself and as such SBI is well aware of the identity of purchasers of each electoral bond. The nation is waiting to see the SC act with firmness it has already shown and bring to book those trying to make a mockery of its momentous judgement. Along with this may come the next hurdle of getting the ECI to divulge the details, even if SBI should agree to give the details of electoral bonds in a reasonable time period.

FREE TRADE CONUNDRUM



Dani Rodrik THE LESSON OF **HISTORY IS THAT TURNING** TRADE INTO A **POSITIVE FORCE REQUIRES DEMOCRATISE IT**

ew terms in economics are as ideologically loaded as "free trade." Advocate it nowadays, and you are likely to be regarded as an apologist for plutocrats, financiers, and footloose corporations. Defend open economic borders, and you will be labeled naive or, worse, a stooge of the Communist Party of China who cares little about human rights or the fate of ordinary workers at home

As with all caricatures, there is a grain of truth in the antitrade stance. Growing trade did contribute to rising inequality and the erosion of the middle class in the United States and other advanced economies in recent decades. If free trade got a bad name, that is because globalisation's boosters ignored its downsides or acted as if nothing could be done about them. This blind spot empowered demagogues like Donald Trump to weaponise trade and demonise racial and ethnic minorities, immigrants, and economic rivals.

Nor is antipathy to trade the province only of right-wing populists. It also includes radical leftists, climate activists, foodsafety advocates, human-rights campaigners, labour unions, consumer advocates, and anticorporate groups. US President Joe Biden, too, has noticeably distanced himself from free trade. His administration believes that building a secure, green, equitable, and resilient US economy must take precedence over hyperglobalisation. All progressives, it seems, believe that free trade stands in the way of social justice, however understood.

It wasn't always this way. Free trade was the rallying cry of nineteenth-century political reformers, who saw it as a vehicle for defeating despotism, ending wars, and reducing crushing inequalities in wealth. As University of Exeter historian Marc-William Palen reminds us in Pax Economica: Left-Wing Visions of a Free Trade World, the era's economic cosmopolitanism encapsulated progressive causes such as anti-militarism, antislavery, and anti-imperialism.

And it wasn't just political liberals who supported free trade. US populists in the late nineteenth century staunchly op-

posed the gold standard, but they were also against import tariffs, which they thought benefited big business and harmed ordinary people. They pushed to replace tariffs with a more equitable progressive income tax. Then, during the early part of the twentieth century, many socialists viewed free trade, supported by supranational regulation, as the antidote to militarism, wealth gaps, and monopolies.

These conflicting views would seem to pose a conundrum. Does trade promote peace, freedom, and economic opportunity, or does it foster conflict, repression, and inequality? In fact, the enigma is more apparent than real. Either outcome – or anything in between – depends on whom trade empowers.

Nineteenth-century liberals and reformers were free traders because they thought protectionism served retrograde interests, including landed aristocrats, business monopolies, and warmongers. They believed economic nationalism went hand in hand with imperialism and aggression. Palen cites a 1919 essay by the economist Joseph Schumpeter, who depicted imperialism as a "monopolistic symptom of atavistic militarism and protectionism – an ailment that only democratic free-trade forces could cure."

It was this vision that informed the post-World War II international trade system. The American architects of the International Trade Organization followed in the footsteps of Cordell Hull, President Franklin D. Roosevelt's secretary of state, believing they were pursuing world peace through free trade. Hull was an economic cosmopolitan and a devotee of the nineteenth-century radical free-trade advocate Richard Cobden. Unlike previous regimes, the postwar order was meant to be a system of global rules that did away with bilateralism and imperial privileges. While the US Congress ultimately failed to ratify the ITO, some of its key principles including multilateralism and non-discrimination - survived in the General Agreement on Tariffs and Trade (GATT), the precursor to the World Trade Organization.

But trade can be instrumentalised just as easily for authoritarian and militaristic ends. A particularly egregious example is Antebellum America, where free trade served to entrench slavery. During the drafting of the US Constitution in 1787, slave-owning Southerners ensured that the text would prohibit the taxation of exports. They well understood that free trade would ensure that plantation agriculture remained profitable and safeguard the system of slavery on which it was based. When the North defeated the South in the Civil War, slaverv was abolished and free trade was replaced with protectionism, which suited Northern business interests better.

The situation under British imperialism was similar. After the repeal of the Corn Laws in 1846, the British government nominally turned its back on protectionism and led Europe in signing free-trade agreements But in Africa, the Middle East, and Asia, free trade was imposed through the barrel of a gun whenever the British encountered weak potentates ruling over valuable commodities and markets.

The British fought the infamous Opium Wars of the midnineteenth century to force Chinese rulers to open their markets to British and other Western goods (opium chief among them), so that Western countries in turn could buy China's tea, silk, and porcelain without draining their gold. The opium was grown in India, where, as Amitav Ghosh details in his new book, Smoke and Ashes, a British monopoly forced farmers to work under horrendous conditions that left long-term scars Free trade served repression and war, and vice versa.

The post-WWII regime of multilateral free trade under American leadership would fare much better. Under GATT, commercial diplomacy replaced wars, and many non-Western countries – such as Japan, South Korea, Taiwan, and, most spectacularly, China – expanded their economies rapidly by leveraging global markets.

By the 1990s, however, the trade regime had become a victim of its own success. Large corporations and multinationals, empowered by the expansion of the global economy, increasingly drove trade negotiations. The environment, public health, human rights, economic security, and domestic equity took a back seat International trade had yet again moved away from Cobden and Hull's original vision, turning into a source of international discord instead of harmony.

The lesson of history is that turning trade into a positive force requires that we democratise it. That is the only way to ensure it serves the common good, rather than narrow interests – an important lesson to keep in mind as we reconstruct the world trade regime in the years ahead.

wo landmark judgements, one on the electoral bonds scheme and the other JMM - Jharkhand Mukti Morcha bribery case, should call for introspection into the myriad ways of graft. The nation despite vociferously discussing it for decades has not found a way out. No wonder India has the onerous ranking of 93 out of 180 on the global corruption index in 2023.

The recent Rajya Sabha crossvoting in Himachal Padesh, Uttar Pradesh and Karnataka are blatant instances that money or other quid pro quo is routine. This has been happening in the Rajya Sabha elections for quite some time causing some change of rules, including open ballot system making it mandatory for MLAs to exhibit how they voted. Still, it is happening.

TMC MP Mohua Moitra was expelled in 2023 for alleged links with a businessman, who was reportedly allowed to use her official email. The new SC verdict now does away with the immunity to MPs granted by a judgement in 1998 under Article 105.

Since the bogey of Bofors bribery, there would be hardly a deal which might not have seen the "cut money" phenomenon from an innocuous object to the purchases of arms, aircraft, drones or contracts for constructions. Sadly, corruption is built into the system. Even currency note exchange during the demonetisation had built into it. It is difficult to quantify but Transparency International (TI) had indicated in 2005, truckers paid Rs 222 crore in bribes. Both government regulators and police share bribe money to the tune of 43% and 45% each, respectively. The volume must have increased though the formula may remain valid now.

Notably, a 2005 TI report states that over 62% of Indians confirmed that they had to bribe a public official at some point to get something done or enjoy services provided by them (public officials). As of December 2009, 120 of India's 542 MPs have accusations of partaking in corruption-related crimes like bribing under FIR. Many of the biggest scandals since 2010 have involved high-level government officials, including Cabinet ministers and Chief Ministers, such as the 2010 Commonwealth Games Scam, the Adarsh Housing Society Scam, the Mining Scandal in Karnataka and the cash for vote scams. In 2019, an online petition exposed the ineffectiveness of the country's top anti-corruption authority, Lokpal, which is supposed to stop corruption. The petition addressed to the Chairperson of Lokpal asserts that the Lokpal officials are squandering enormous amounts of public money without accountability.

Professor Bibek Debroy and Laveesh Bhandari claim in their book Corruption in India: The DNA and RNA, in 2010, that public officials in India may be cornering as much as Rs 921 billion (\$12 billion), or 1.26% of GDP through corruption. Corruption also results in lower economic

growth for a given level of income. With the reduction in corruption level in India the growth rate of GDP might increase by 5 to 7%. As per an estimate, corruption in India causes a loss of growth in terms of investment and employment to the tune of Rs 25.000 crores.

The government has been pur suing zero tolerance against corruption and has taken several measures. There are 3745 cases of corruption lodged in 2021, according to the National Crime Records Bureau Report (NCRB). In addition, 457 cases are there against 549 public servants. A series of raids were conducted by Enforcement Directorate on a series of politicians, businessmen and other across the country.

However, the level of graft is not coming down. Despite digitisation, the rent seeking has not come to an end. It calls for an effort across social boundaries. The elections might see more of it in different forms and the colour may change but not the graft.

TMC picks names for all 42 seats

Kolkata, March 10: The TMC Sunday ended speculations of a possible seat adjustment with the Congress in Bengal by unveiling its candidate list for all 42 Lok Sabha seats, marking a significant overhaul by replacing seven sitting MPs and introducing several new faces, including former cricketer Yusuf Pathan.

Facing political heat over the incidents in Sandeshkhali, where allegations of sexual abuse against TMC leaders surfaced. the party brought in former MP Haji Nurul Islam replacing actor Nusrat Jahan in the Basirhat Lok Sabha seat, where the trouble-torn area is situated.

While 16 of 23 sitting MPs were retained, the TMC opted not to re-nominate seven incumbents and notably excluded BJP defector Arjun Singh from Barrackpore, who joined the TMC two years ago. In the candidate list, 12 are women. Among the 26 new candidates, six are entirely new to the political arena.

Former cricketer Yusuf Pathan has been nominated from Baharampur, historically a stronghold of state Congress chief and five-term MP Adhir Ranjan Chowdhury. Mahua Moitra, who was expelled from the Lok Sabha last year in cash for a query case, has been reaffirmed as the party's candidate from Krishnanagar.

LS polls: Demand for jets, choppers to rise by 40%

Bhubaneswar, March 10: A day after BJD president and Chief Minister Naveen Patnaik issued a one line statement saying that "rumour" and "lies" are worst aspect of politics, the BJP top brass Sunday called its state unit leaders and those in charge of elections in Odisha to the national capital for a discussion.

Patnaik in an Instagram video Saturday had said "rumour" and "lies" were worst aspects in politics. The BJD president's statement came barely hours after Odisha BJP election in-charge Vijaypal Singh Tomar and party's state president Manmohan Samal publicly said there were no talks on alliance with the BJD.

Both Tomar and Samal also said the BJP in Odisha will fight all the 147 assembly and 21 Lok Sabha seats alone. Tomar even claimed that he was not aware of talks between BJD leaders and BJP central leaders on alliance. BJP MP Jual Oram had, however, said the BJP's core committee meeting had discussed the alliance matter, but nothing___ was finalised.

While denving alliance talks with the BJD leaders, Tomar had exuded confidence that BJP in

Odisha will win more than 80 seats in assembly and 16 Lok Sabha seats. Similar was the statement of Samal, BJP's Odisha election deputy in-charge Lata Usendi also made a similar statement and rejected the possibility of an alliance before the twin polls in the state. Odisha has been conducting simultaneous polls for Lok Sabha and Assembly since 2004.

However, after getting a call from the BJP top brass, leaders including Samal, general secretary (organisation) Manas Mohanty, Tomar and Usendi left for New Delhi Sunday. At the airport, Samal said a team of state leaders of the party was going to hold a meeting with central leaders on the elections.

Asked about the possibility of discussions on alliance, Samal said, "It will not be wise on my part to say anything about it.'

TWO PRISONERS ESCAPE FROM TITILAGARH SUB-JAIL

Titilagarh, March 10: Two undertrial prisoners accused of murder, escaped from Titilagarh sub-jail in Bolangir district, Saturday night.

The absconding prisoners were identified as Sobhaban Rana and Sumit Bihari. Rana was lodged in the Titilagarh subjail following his arrest in a case of human sacrifice while Bihari is accused of murdering a minor boy by throwing him into a well.

Jailor Chaitanya Pradhan confirmed their escape. He said the two prisoners escaped by scaling the boundary wall of the sub-jail at around 8 pm, Saturday adding that he has lodged a complaint at the Titilagarh police station in this regard.

Sources, however, said that the two were very trusted aides of the jailor and used to move freely in and outside the jail. Sources claimed that Rana used

to work as a domestic help in the jailor's house which is outside the compound wall of the iail. Similarly, Bihari used to call the shots on the jail premises and dictated terms on the inmates.

When questioned, the jailor said that both used to work as computer operators in the jail office. However, questions have arisen how Rana could work as a computer operator when he is not literate. But the jailor tried to brush aside the matter stating that he had very good working knowledge of computer.

Notably, Rana tried to facilitate his release from jail custody by behaving as a lunatic person. He even got himself admitted to SCB Medical College and Hospital in Cuttack to prove his claims but his efforts were unsuccessful. If Rana's efforts to prove himself mentally unstable are to be believed then questions are being raised how he could be appointed in the jail office as per the jailor's claim.

Helicopters are anticipated to be more in demand compared to fixed-wing aircraft as choppers will help in

providing accessibility to

PRESS TRUST OF INDIA New Delhi, March 10: As political parties prepare to fight it out in the Lok Sabha polls, the demand for chartered planes and helicopters is expected to jump by up to 40 per cent compared to the previous general elections, according

to industry experts. Helicopters are anticipated to be more in demand compared to fixed-wing aircraft as choppers will help in providing accessibility to rural and remote areas



in a shorter time. "There will be an exponential demand for private jets and the demand is ex pected to outstrip the availability of chartered planes and helicopters. There is a limited supply of chartered planes and helicopters," Club One Air CEO Rajan Mehra said.

With increased demand, some players will be taking chartered planes and helicopters on lease during the general elections for which the dates are expected to be announced in the coming days. Chartered plane and helicopter services are charged on an hourly basis.

The industry experts opined that the prices can vary between ₹4.5 lakh to ₹5.25 lakh per hour for a chartered plane. For a helicopter, the hourly charge will be around ₹1.5 lakh. Business Aircraft Operators Association (BAOA) Managing Director Captain R K Bali said that during the Lok Sabha polls, the demand for private chartered planes and helicopters is expected to increase by 30 to 40 per cent compared to the previous elections. Official data showed that there were 112 Non-Scheduled Operators (NSOPs) at the end of December 2023. Generally, NSOPs are entities that do not have a particular fixed schedule and fly when there is a requirement.

Since the demand will be high, players are expected to take planes on lease for chartered operations, especially helicopters, Bali said and added that there are around 111-112 NSOPs and out of them, 40-50 per cent operate single aircraft. He said that NSOPs are estimated to have around 450 planes, including choppers.

These operators have aircraft and helicopters, with seating capacities varying from 3 to 37. The planes include Falcon 2000, Bombardier Global 5000, Twin Otter DHC-6-300, Hawker Beechcraft, Gulfstream G-200 and Cessna Citation 560XL, as per the data available with the Directorate General of Civil Aviation (DGCA).

Most of the aircraft and helicopters have seating capacities of less than 10, the data showed. Mehra said the size of the chartered fleet will be around 350 and out of them, about 175 are helicopters.


A chartered operator, Club One has a fleet of 5 Falcon 2000, 4 Cessna Citation and 1 Bombardier CRJ200. "Political leaders will opt for helicopters to travel to small towns and hence more demand is likely for the choppers," Mehra said.

There are several brokers in the segment and sometimes they book a specific number of hours for a chartered plane and later, those hours are sold to the end users, including political parties, Mehra said. Bali said there are a lot of brokers providing chartered plane services and the hourly pricing will also depend on the negotiations and generally, hours are booked in bulk.

'RAIL ROKO' PROTEST

Farmers squat on tracks

Chandigarh, March 10: Movement of several trains was affected in Punjab Sunday after agitating farmers squatted on tracks at many places in the state as part of a nationwide 'rail roko' protest.

The protest, called by the Samyukta Kisan Morcha (Non-Political) and the Kisan Mazdoor Morcha to press the Centre to accept their demands, including a legal guarantee of minimum support price (MSP), was held from 12 noon till 4 pm.

In Punjab, farmers sat on railway tracks at many locations in



22 districts, including Amritsar, Ludhiana, Tarn Taran, Hoshiarpur, Firozpur, Fazilka, Sangrur, Mansa, Moga and Bathinda. Because of the disruption of train services, passengers experienced inconvenience. According to railway authorities, nine trains including Ferozepur to Bathinda, Jalandhar City to Hoshiarpur, and Jalandhar City to Pathankot were cancelled and many trains were either short-terminated or short-originated. Farmer leaders Sarwan Singh Pandher and Jagjit Singh Dallewal claimed that their 'rail roko' agitation was successful.

"Till a concrete resolution is offered by the government to our demands, we will continue our struggle," Pandher said. They claimed that the 'rail roko' protest was held at 75 locations in Punjab, five in Harvana, three each in Madhya Pradesh and Rajasthan and 20 locations in Tamil Nadu. During the protest, farmers raised slogans against

the Centre for not accepting their demands.

Bharti Kisan Union (Ekta Ugrahan), BKU (Dakaunda-Dhaner) and Krantikari Kisan Union - farmer bodies that are part of the Samyukta Kisan Morcha (SKM) - also participated in the 'rail roko' agitation.

The SKM, which had spearheaded the farmers' 2020-21 agitation against the nowscrapped three central agri laws, is not part of the 'Delhi Chalo' protest but has extended its support to the ongoing farmers' agitation at Shambhu and Khanauri points on the Punjab-Haryana border.

HP police book independent MLA, Congress rebel's father

A case of criminal conspiracy, corruption practices and undue influence on election has been registered on the complaint of two Congress MLAs, police said Sunday. Adding a new dimension to the current political crisis in Himachal Pradesh, the two Congress MLAs Sanjay Avasthi and Bhuvneshwar Gaur Sunday filed a complaint with the police seeking investigation into electoral offences, corrupt practices and criminal conspiracy in the whole sequence of events since the Rajya Sabha polls held February 27. Firms' mcap climbs

New Delhi: The combined market valuation of seven of the top-10 most valued firms climbed Rs 71.301.34 crore in the holiday-shortened last week, with Bharti Airtel emerging as the lead gainer. In a record-breaking rally last week, the BSE benchmark climbed 374.04 points or 0.50 per cent. The 30-share BSE Sensex Thursday settled at a new closing peak of 74,119.39. The Nifty also ended at a fresh closing high of 22,493.55. Reliance Industries continued to rule the chart of the most valued firms followed by TCS, HDFC Bank, ICICI Bank, State Bank of India, Bharti Airtel, Infosys, LIC, Hindustan Unilever and ITC.

Aramco profit dips

Dubai: Saudi oil giant Aramco reported Sunday a \$121 billion profit last year, down from its 2022 record due to lower energy prices. Aramco made the announcement in a filing in Riyadh's Tadawul stock market. It had reported a \$161 billion profit in 2022, likely the largest ever reported by a publicly traded company. "The decrease mainly reflects the impact of lower crude oil prices and lower volumes sold, and weakening refining and chemicals margins," the company said in its filing. Aramco reported overall revenue of \$440 billion last year, down from \$535 billion

India, EFTA ink deal

GROUP COMMITS TO \$100BN 15-YEAR DEAL

New Delhi, March 10: India will lift most import tariffs on industrial products from four European countries in return for investment of \$100 billion over 15 years, its trade minister said, after an economic pact signed Sunday that concluded nearly 16 years of negotiations.

The signing is a watershed moment, as it is India's first modern trade pact with a bloc having developed countries

The deal follows trade pacts over the last two years with Australia and the United Arab Emirates, while officials say a another, with Britain, is in its final stages, as Prime Minister Narendra Modi aims for annual exports of \$1 trillion by 2030.

It envisages that the European Free Trade Association, comprised of Switzerland, Norway, Iceland and Liechtenstein, will invest \$100 billion over 15 years in India's fast-growing market of 1.4 billion people, Trade Minister Piyush Goyal said.

He added that for the first time in a trade agreement, EFTA had committed to invest \$ 100 billion in the next 15 years.

In turn, India will lift, or partially remove, very high customs duties on 95.3% of industrial imports from Switzerland, excluding gold, either immediately or over time, the Swiss government said in a statement.

"Norwegian companies exporting to India today meet high import taxes of up to 40% on certain goods," Industry Minister Jan Christian Vestre said in a separate statement. "With the new deal, we have secured nil import taxes on nearly every Norwegian good.'

The pact covers some new elements such as intellectual rights



and gender equity, Goyal added, telling a press conference, "It is a modern trade agreement, fair, equitable and win-win for all five countries.

India has committed to cut its 'bound tariff rate' on gold to 39% from 40%, but does not anticipate much impact on imports of the metal from Switzerland,

which were estimated at \$16 bil lion last fiscal year, an Indian government official said.

India is the EFTA grouping's fifth-largest trading partner after the European Union, the United States, Britain and China, with total two-way trade of \$25 billion in 2023, its trade ministry estimates.

India not to tailor policy for Tesla FPIs inject more than

New Delhi, March 10: India will not tailor its policies to suit US EV maker Tesla, and its laws and tariff rules will be formulated to attract all-electric vehicle manufacturers from across the world to set up a base in the world's fastest-growing economy, Commerce and Industry Minister Piyush Goyal said.

Tesla has been seeking an initial tariff concession that would allow it to offset 70 per cent customs duty for cars priced less than \$40,000, and 100 per cent for cars of higher value.



In an interview with PTI, Goyal said the government recognises the need for a vibrant EV ecosystem as greater use of battery-run vehicles will cut carbon emissions as well as the staggering oil import bill.

policies that suit any one company and would rather frame ones that will encourage all-electric vehicle manufacturers from across the world to set up shop in India, he said. "We are working on several initiatives where we are having inter-ministerial (consultations) and a dialogue with the stakeholders, with potential investors from across the world from Europe, from the United States, from the Far East, from Japan, from Korea," he said.

Tesla made the concession demand a precondition to build a plant in India. High tariffs on motor duction, have been a lingering issue for foreign carmakers too.

"However, high valuations are a matter of concern. Valuations in the mid and small cap segments are excessive and unjustifiable. Correction in this segment is only a matter of time,' Vijayakumar said.

Apart from equities, FPIs have injected Rs 1,025 crore in the debt market during the period under review. This came in the backdrop of Bloomberg announcing India's bonds inclusion in its Emerging Market (EM) Local Currency Government Index and related in-

New Delhi, March 10: After delivering back-to-back innovations in fuel grades, Indian Oil Corporation (IOC) has now set sight on the Grand Prix and will in next three months start producing fuel used in adrenaline-pumping Formula One or F1,

motor racing. The firm's refinery at Paradip in Odisha will in three months produce the petrol used in F1 car racing, its chairman Shrikant Madhav Vaidya said.

Vaidya said the company expects to get its Formula 1 fuel certified in around three months, after which it will start competing with other global majors like Shell to supply it to the F1

F1 fuel is essentially high-octane petrol and the standards are heavily regulated by global motor sport governing body Federation Internationale de l'Automobile (FIA) on various counts, including permissible additives and blending agents.

IOC had in October last year helped India join a select league of nations when it began producing highly specialised 'reference' petrol and diesel that are used for testing automobiles.

There are only three suppliers of reference fuels globally including US giant Chevron. IOC's Paradip refinery in Odisha is producing 'reference' grade petrol and its Panipat unit in Haryana

produces similar quality diesel. Prior to this, Indian automobile manufacturers had to use im-



ported reference fuel for testing cars and motorcycles. Now, IOC is supplying them the same grade fuel at much cheaper cost.

Fuel retailers like IOC sell petrol and diesel of primarily two kinds - regular and premium, through their fuel station network. The biggest difference between the normal and premium fuel lies in the octane number. The regular fuel has an octane number of 87, but premium fuel has an octane number of 91. Reference grade fuel comes with a 97 octane number.

The octane number is nothing but a unit to measure the ignition quality of petrol or diesel.

Vaidya said his company has three premium fuels - 95-Octane XP95 petrol and 100-Octane XP100 petrol used in high-end luxury cars and bikes. It also has high performance XtraGreen diesel that offers higher fuel economy, reduced noise and emits lesser particulate matter, carbon monoxide and nitrogen oxides.

"XtraGreen diesel is a real game changer fuel. It is catching up fast and now makes up for expects to produce the F1 fuel in three months at Odisha's Paradip plant

about 8 per cent of all diesel that IOC sells," he said. He said IOC has entered the racing fuels segment with its high-octane 'Storm' petrol for

motorcycle racing.

The company will be the official fuel partner for the Federation Internationale De Motocyclisme (FIM) Asia Road Racing Championship (ARRC) for three years -- 2024 to 2026,

supplying 'Storm' petrol across

all ARRC race rounds. IOC will supply fuel for all the motorcyclists from 15 countries that will participate in the FIM Asia Road Racing Championship.

"Our R&D (research and development) in two months will be able to produce Category-1 fuel and in three months Formula 1 fuel," he said.

"Unless we go to F1, the journey is not complete.'

Army hunts for missing kids

The kidnappings are a stark reminder of the security crisis plaguing *Africa's most populous* country

Kuriga, March 10: Armed men have kidnapped 15 pupils from a boarding school in northwestern Nigeria days after more than 200 students were abducted from another school with the army still searching for them.

The men broke into the Islamic seminary in the village of Gidan Bakuso in Sokoto state Saturday and seized 15 children from the hostel as they slept, police told The Associated Press news agency. The mass kidnapping in Kuriga was the third in northern Nigeria since last week; a group of gunmen abducted 15 children from a school in another northwestern state, Sokoto, before dawn Saturday, and a few days earlier 200 people, mostly women and children displaced by conflict, were kidnapped in northeastern Borno State. The kidnappings are a stark reminder of the security crisis plaguing

Africa's most populous country. No group claimed responsibility for any of the recent abductions. But Islamic extremists waging an insurgency in the northeast are suspected of carrying out the kidnapping in Borno. Locals blame the school



abductions on herders who are in conflict with the settled

It's not the first time for a student kidnapping in Nigeria to shock the world. In 2014, Islamic extremists abducted more than 200 schoolgirls from Borno's Chibok, sparking the global #BringBackOurGirls social media campaign. A decade later, at least 1.400 Nigerian students have so far been abducted from their schools in similar circumstances. Some are still held captive, including nearly 100 of the Chibok girls.

Recalling Thursday's kidnapping, Nura Ahmad, a teacher, told the AP that students were just settling into their classrooms at the government primary and secondary school when gunmen "came in dozens, riding on bikes and shooting sporadically."

The LEA Primary and Secondary School, one of the few educational facilities in this area, sits by the road just at the entrance of the town, tucked in the middle of forests and savannah. Even with its decaying roof and wrecked walls, it gave parents hope for a better

future for their children. Nigerian police and soldiers headed into the forests Friday to search for the missing children, but combing the wooded expanses of northwestern Nigeria could take weeks, observers said.

"Since this happened, my brain has been muddled," said Shehu Lawal, the father of a 13-yearold boy who is among those abducted. "My child didn't even eat breakfast before leaving. His mother fainted (upon hearing the news)," he said. Some villagers like Lawan Yaro, whose five grandchildren are among the abducted, say their hopes are already fading. People are used to the region's insecurity, "but it has never been in this man-

Saturday's kidnappings come as the Nigerian government launched a search and rescue mission for hundreds ofmissing children who were taken from Kuriga, in northwestern Kaduna state Thursday in the largest mass abduction in three years

Kuriga residents told Al Jazeera that the children were seized by more than 100 attackers shortly after their daily assembly as they spoke of feeling abandoned by the

ner," he said. More than 3,500 people have been abducted across Nigeria in the last year, according to the Armed Conflict Location and Event Data Project. Some were even kidnapped from their

homes in the capital of Abuja. Last year, President Bola Tinubu took office after he successfully campaigned on the promise to tighten security and stop the kidnappings. Experts say it is easy to smuggle in arms, used in kidnappings, over Nigeria's poorly policed borders. More than half of its 1,500-kilometer (932-mile) border with Niger, for instance, stretches

across the northwest. Though mostly covered in woodland savannah, the region also has vast ungoverned and unoccupied forests where organised gangs hide and keep their kidnap victims

US airlifts embassy personnel from Haiti

Washington, March 10: The US military said Sunday it has carried out an operation in Haiti to airlift non-essential embassy personnel from the country and added US forces bolster embassy security, as Caribbean nation reels under a state of emergency.

The operation was the latest sign of Haiti's troubles as gang violence threatens to bring down the government and has led thousands to flee their homes.

"This airlift of personnel into and out of the embassy is consistent with our standard practice for embassy security augmentation worldwide, and no Haitians were on board the military aircraft," the US military's Southern Command said in a statement.

Haiti entered a state of emergency last Sunday after fighting escalated while Prime Minister Ariel Henry was in Nairobi seeking a deal for the long-delayed UN-backed mission.

Kenya announced last year it would lead the force but months of domestic legal wrangling have effectively placed the mission on hold.

On Saturday, the US State Department said Secretary of State Antony Blinken spoke with Kenyan President William Ruto about the Haiti crisis and the two men underscored their commitment to a multinational security mission to restore order.

In Southern Command's statement, it said Washington remained committed to those goals.

Zardari sworn in as Pak's 14th President

Islamabad, March 10: Asif Ali Zardari Sunday took oath as Pakistan's 14th President, a day after the veteran politician staged a remarkable comeback when he was overwhelmingly elected as the only civilian president of the coup-prone country for a second time.

Chief Justice of Pakistan Qazi Faez Isa administered the oath to the 68-year-old Zardari in a small yet formal ceremony at Aiwan-e-Sadr, the Presidential Palace. Zardari replaces Dr Arif Alvi, who stayed in office for five months after completing his five-year term in September 2023.

The swearing-in ceremony was attended by Prime Minister Shehbaz Sharif, Chief of Army Staff General Asim Munir and Chairman of Joint Chiefs of Staff Committee General Sahir Shamshad Mirza among other senior army and civilian officials and diplomats.

The outgoing president Alvi, a senior member of jailed former prime minister Imran Khan's Pakistan Tehreek-e-Insaf (PTI) party, also attended the oathtaking ceremony. Former prime minister Nawaz Sharif and Zardari's son Bilawal Bhutto Zardari, his daughters Aseefa Bhutto Zardari and Bakhtawar Bhutto Zardari and other family members were present on the occasion.

Prime Minister Shehbaz Sharif has congratulated Zardari on his election as the president for

the second term. In a message,

Shehbaz Sharif said that the Senate, National Assembly and elected members of all the four provincial assemblies have expressed their confidence in Zardari. He said that the Zardari will be a symbol of the strength of the federation.

This is the second time that Zardari has won the presidency, a record for any civilian. Earlier he served as the 11th president of Pakistan from 2008 to 2013 and is one of the four democratically elected presidents to have completed their five-year constitutional term. He has been a member of the National Assembly of Pakistan since August 2018.

Co-chairman of the Pakistan Peoples Party (PPP), Zardari was the joint candidate of the ruling alliance and was elected Saturday after he defeated Mahmood Khan Achakzai, a candidate backed by jailed former prime minister Imran Khan's Pakistan Tehreek-e-Insaf (PTI) and Sunni Ittehad Council (SIC) by a huge margin. Born in 1955, Zardari was brought up and educated in Karachi.



Dharamsala, March 10: Rahul Dravid underlined the imporfunctioning as a unit to be triumphant in the tough world of Test cricket while delivering a motivational dressing room speech after India registered a memorable 4-1 series win over

After losing the opening Test in Hvderabad, the hosts bounced back in stunning fashion to win the next four matches to claim

"Series like this have to be earned and this is tough. Test cricket is hard at times. It's hard in terms of your skill. It's hard physically, as you've seen, it's hard mentally," Dravid said in a video posted on 'bcci.tv'.

"But it's great satisfaction at the end of it. The satisfaction that you get winning a series like this coming from one behind to be able to win four. I think it's just phenomenal," he

As key players like Virat Kohli and Mohammed Shami and KL found heroes in some young side handed debuts to five players - Rajat Patidar, Dhruv Jurel, Devdutt Padikkal, Sarfaraz Khan and Akash Deep – in the marquee series. In fact, Jasprit Bumrah and Ravindra Jadeja too missed a Test each.

The Indian coach was a chuffed man after some of those young names emerged with flying colours from the series. "For a lot of you young guys, especially coming into this group, you are going to need each other to succeed. Whether you're a batsman or bowler or whatever you are, your success is tied in with other people's success.

"All of you are invested in each other's success. And that's really important going forward. It's not about your success, but it's about how you can help other people succeed, which will also help you succeed," he said.

The 51-year-old was delighted to see the players finding ways to turn the tide whenever they were put under pressure. "There were times in the series that we were really challenged and pushed and we found a way to bounce back, which speaks to the skills that we have, the resilience that we have, the character that we have.

"On many occasions in this se-

praised the team for emerging winners from a long, gruelling series against a quality opposition. "We talked about this at the start of the series as well. Irrespective of whether we win or lose this is going to teach us a lot – a five Test match series. You're going to go through a lot of ups and downs. 'It's a long series, you're going to be tested. And it was going

to teach us a lot about us as players or some as a team, and a lot about us and we've come through that exceptionally with terrific flying colours and we face challenges both on and off the field.'

Satwik-Chirag pair claims French Open doubles title



Paris, March 10: Satwiksairaj Rankireddy and Chirag Shetty enjoyed another memorable 'Evening in Paris', lifting the French Open badminton crown for the second time with a dominating straight-game victory over Chinese Taipei's Lee Jhe-Huei and Yang Po-Hsuan in the men's doubles final here Sunday.

The World No.1 Indian pair had finished runners-up in the French Open in 2019 before winning the title in 2022. Sunday, the Asian Games champions outwitted Lee and Yang 21-11, 21-17 in 37 minutes to regain the Super 750 tournament title and also win their first crown of the season after reaching the summit clash for the third time in 2023.

The Indian duo had finished second best at Malaysia Super 1000, India Super 750 this year, while signing off as runners-up at China Masters Super 750 as well last year.

Satwik and Chirag proved third time lucky and their stellar show this week only reconfirmed chief coach Pullela Gopichand's assertion that the duo will be the favourites to win Paris Olympics gold.

This was the Indians' seventh BWF World Tour title (Super 300 events and above) and they won it without dropping a single game this week.

Soon after the win, the Indians celebrated in their traditional style with Satwik lifting Chirag in his lap as he had his hands eyeing towards the sky. Satwik also broke into a dance with his racquet.

Satwik and Chirag forced op-

ponents to commit errors regularly as they rushed to 11-6 lead at the break. Later, the Indians grabbed 10 game points. The duo converted on the second chance with Satwik dishing out a cross

court smash.

Lee and Yang started on an attacking note after the change of ends to open up a 4-1 lead. With coach Mathias constantly giving instructions from the sidelines. The Indians grabbed four match points when the Taiwanese found the net. Lee and Yang saved one but then sent the next one wide as the Indians celebrated in unison.


