## 2 held for posing as ED officers

But as the term of the two assemblies is ending June 2, the date has been advanced, the EC said."There shall be no change in respect of schedule for Parliamentary constituencies of Arunachal Pradesh and Sikkim," it noted. Assembly polls are also being held in Andhra Pradesh and Odisha along with parliamentary elections.

## Two dead in Koraput road mishap

Kundura, March 17: Two persons were killed and 40 people injured as a pick-up van on which they were travelling to attend a wedding overturned in Odisha's Koraput district Sunday,

The accident happened near Khatalapadar bridge in Kundura police station area, they said. The vehicle was heading to Nuagaon village in Borigumma block from Dalapur village in Boipariguda block for the marriage ceremony. Those travelling in it were guests of the bride's family.

The driver lost control of the crowded vehicle, following which it fell on its side, police said. After getting information about the accident, police and fire service personnel reached the spot and rescued the injured persons from the vehicle. While two persons died on the spot, 40 people were rushed to the district hospital in Jeypore, police said. The condition of six injured persons is stated to be critical and they were shifted to the Koraput Medical College and Hospital for better treatment, they said.

# **BJP top beneficiary**

The Election Commission Sunday made public fresh data on electoral bonds, which it had submitted in sealed covers to the Supreme Court and was later asked to put it in public domain. These details are believed to be pertaining to the period before April 12, 2019. Electoral bond details after this date was made public by the poll panel last week. Political parties had filed data on electoral bonds in sealed cover as directed by the Supreme Court's interim order dated April 12, 2019, the poll panel said in a statement.

New Delhi, March 17: Top purchaser of electoral bonds Future Gaming and Hotel Services donated ₹509 crore to Tamil Nadu's ruling party DMK through the now-scrapped payment mode, the Election Commission's (EC) data showed Sunday.

The donations given by Future Gaming, whose owner, 'lottery king' Santiago Martin, has been under the Enforcement Directorate's (ED) scanner, accounted for more than 77 per cent of the total receipts from electoral bonds of ₹656.5 crore disclosed by the DMK.

Since most political parties have not fully disclosed the names of the donors, it was not known



who were the beneficiaries of the balance ₹859 crore worth bonds purchased by Future Gaming. The disclosure is part of the data dump pertaining to a total of 523 recognised and non-recognised political parties made public by the EC on the Supreme Court's orders. This was followed by another dataset published by the EC last week based on the information submitted by the State Bank of India (SBI), the sole bank authorised to sell and redeem electoral bonds.

The latest dataset released by the EC included scanned copies of the disclosures made by the political parties, running into hundreds of pages. While initially the data submitted by the SBI pertained to a period from April 12, 2019 till the scrapping of the bonds by the apex court last month, the latest disclosure is based on the declarations given by various political parties in November last year on the bonds redeemed by them since the scheme was launched in early

tranches. The ruling BJP at the Centre received the maximum funds through these bonds at ₹6,986.5 crore since they were introduced in 2018, followed by West Bengal's ruling party Trinamool Congress (₹1,397 crore), Congress (₹1,334 crore) and Bharat Rashtra Samithi (₹1,322 crore), according to the latest data shared by the EC.

Janata Dal was the fourth-largest recipient at ₹944.5 crore, followed by the DMK at ₹656.5 crore and Andhra Pradesh's ruling party YSR Congress at nearly ₹442.8 crore. According to an earlier report compiled by NGO Association of Democratic Reforms (ADR), electoral bonds worth ₹16,518 crore were sold from March 2018 to January 2024.

Collating the two datasets, the BJP is estimated to have received a total amount of ₹7,700 crore during the entire duration of the scheme. According to the data released Sunday, the Janata Dal (Secular) received bonds worth ₹89.75 crore, including ₹50 crore from Megha Engineering, the second-largest purchaser of electoral bonds. Future Gaming was the biggest purchaser of electoral bonds at ₹1,368 crore, of which nearly 37 per cent went to the DMK.

## Labourer killed in crusher unit

Jajpur, March 17: A labourer was killed while another sustained critical injuries after the two were allegedly trapped in the belt while changing the wheels of a crusher machine at a stone crusher unit near Rahadpur black stone quarry under Dharmasala block in this district, Sunday morning.

The deceased was identified as Shyamsundar Hansda, 30, a native of Barikul area in Bankura district of neighbouring West Bengal. The critically injured labourer was identified as Anil Soren, 30, of the same area in West Bengal. Soren was rescued

and admitted to a nearby hospital. However, he was shifted to SCB Medical College and Hospital in Cuttack for better treatment.

The mishap sparked tension in the area as Rahadpur villagers staged a demonstration alleging that the owner was trying to hush up the matter. They also alleged that labourers are being engaged in the crusher unit without registration.

However, no case has been filed in the Jenapur police station. When contacted, IIC Subhendu Kumar Sahu said that the family members of the deceased have been informed and case will be registered after they arrive here and file an FIR.

## Foreign students in Guj varsity attacked

New Delhi, March 17: India Sunday said the Gujarat government is taking strict action against the perpetrators of violence at a university in Ahmedabad in which two foreign students sustained injuries.

Local police said it arrested two men and are looking for more after students hailing from different foreign countries were allegedly assaulted by a group at one of the hostels of the Gujarat University in Ahmedabad for offering namaz.

External affairs ministry spokesperson Randhir Jaiswal said one of the two foreign students injured in the violence has been discharged from hospital."An incidence of violence took place at Gujarat University in Ahmedabad vesterday. State government is taking strict action against the perpetrators, he said on 'X'.

"Two foreign students were injured in the clash. One of them has been discharged from hospital after receiving medical attention," he said. Two students -- one from Sri Lanka and another from Tajikistan -- were hospitalised after the incident that took place at the univer-



sity's A-block hostel Saturday night, according to the police. An FIR was registered against

20-25 unidentified accused persons under the Indian Penal Code (IPC) for rioting, unlawful assembly, voluntarily causing hurt, damage to property, and criminal trespass, among others, senior police official Tarun Duggal said in Ahmedabad. Nine teams have been formed to conduct the probe into the incident, Police Commissioner G S Malik said.

The incident was reported at around 10:50 pm Saturday when nearly two dozen people barged into the hostel and raised an objection to students from foreign countries offering namaz in the facility where they stayed, the police said.

## MORE TROUBLE FOR KEJRIWAL

New Delhi, March 17: The Enforcement Directorate has summoned Delhi Chief Minister Arvind Kejriwal in a money laundering probe linked to al leged irregularities in the Delhi Jal Board, with the Aam Aadmi Party terming it a 'backup' plan to stop him from campaigning in the Lok Sabha polls.

According to the officials. Kejriwal is required to present himself before the agency at its office on A P J Abdul Kalam Road March 18 to provide his statement under the Prevention of Money Laundering Act.

This latest development marks the second instance where Kejriwal has been summoned under the anti-money laundering law. He is also facing inquiries in the Delhi excise policy-related money laundering case and has previously disregarded eight

New Delhi, March 17: As the country gears up for the world's biggest electoral exercise, messaging platforms like WhatsApp and social media influencers have emerged as the go to mediums for political parties to influence voter psychology, ad gurus and political analysts say.

In the run-up to the 2024 Lok Sabha elections, political parties are extensively using social media to propagate their achievements and seek support from voters.

## **How parties are wooing voters**

The BJP is trying to engage with the voters by sending them a personalised 'Letter from the Prime Minister' on WhatsApp which has over 500 million active users monthly in India — highlighting the achievements of the

Narendra Modi government and seeking feedback from voters. The party launched the website 'My First Vote For Modi,' which allows visitors to pledge to vote for Modi and submit a video stating the reason behind their choice. The website also hosts several short videos highlighting the development work done under the NDA government.

On the other hand, the Congress runs a Rahul Gandhi WhatsApp group in which the leader is said to interact with people and respond to their queries. The circulation of WhatsApp information is monitored at the district level to ensure it reaches the masses and corrects the party's voter base.

"Whichever political party has higher WhatsApp groups under its banner can communicate faster and better with the voters. It helps them to high-



light their achievements instantly with a large user base and influence the voters by drawing parallels with the opposition," Amitabh Tiwari, an election analyst and commentator, said. According to Tiwari, Facebook, once the most preferred platform for social media

campaigning, has seen a

on political pages.

#### Post-pandemic boom in social media

After the COVID-19 pandemic. perspective towards social media as a tool of information significantly changed, Ankit Lal, founder of Politique Advisor and former IT Cell head of Aam Aadmi Party, said."Many political parties now adopt a digital-first strategy for their poll campaigns to connect with the voters who heavily depend on social media to get information. Social media influencers have become another important medium through which parties try to influence the floating audience of those who do not vote but engage in consuming the narratives," he said.

#### Social media influencers take the lead

In the last few months, several political leaders have appeared on YouTube channels of popular social media influencers to connect with the younger audience. BJP leaders like S Jaishankar, Smriti Irani, Piyush Goval. and Rajeev Chandrasekhar have given interviews to podcaster Ranveer-Allahabadia, who has over 7 million followers on YouTube.

# Plea in SC for disclosure of bond data from '18 to '19

The fresh petition filed by Citizen's Rights Trust has submitted that 9,159 bonds worth ₹4,002 crore have been sold between March 2018 and April 2019 which should also be disclosed



New Delhi, March 17: A petition has been filed in the Supreme Court seeking disclosure of the details of electoral bonds sold from March 1, 2018, to April 11, 2019, saying voters are entitled to know funding to political parties for the entire period since the start of the scheme.

In a landmark verdict last month, the top court scrapped the Centre's electoral bonds scheme that allowed anonymous political funding calling it "unconstitutional" and ordered the State Bank of India (SBI), the authorised financial institution under the scheme, to submit the details of the bonds purchased from April 12, 2019 to February 15, 2024 to the Election Commission of India (ECI).

A new application, filed by Citizen's Rights Trust, has submitted that 9,159 bonds worth ₹4,002 crore have been sold between March 2018 and April 2019 which should also be disclosed.

The petition seeks a direction to the SBI to share the details of electoral bonds sold and redeemed from March 1, 2018, to April 11, 2019, including the alphanumeric number, date of purchase, denomination, names



of donors and parties to the ECL "It is submitted that once the entire Electoral Bond Scheme is held to be violative of Article 19(1)(a) of the Constitution, the citizens are entitled to know the details of the donor and donee of the entire period from March 2018 onwards (the date when the scheme became functional). The data available on the platform of the Election Commission represents only 76 per cent of the total bonds and the voters are not aware of the details of the remaining 24 per cent of the Electoral Bonds," the plea said.

The association, represented through senior advocate Vijay Hansaria and advocate Sneha Kalita, submitted that the cut-off date of April 12, 2019, is relevant only for furnishing information by political parties to the Election Commission as an interim arrangement when the matter was sub-judice before the apex court.

"Once, this court, in the final judgement and order dated February 15, 2024, has struck down the entire Electoral Bond Scheme and the amendments to the Representation of the People Act, 1951, the Companies Act, 2013 and the Income Tax Act, 1961 by the Finance Act, 2017, the voters are entitled to know the funding to the political parties by the Electoral Bond for the entire period," it said.

While the SBI was directed to submit the details of electoral bonds purchased from April 12, 2019, to February 15, 2024, to the ECI by March 6, the bank moved the top court seeking an extension of time till June 30 to furnish the details. However, the Supreme Court turned down the petition and ordered it to disclose the details by the close of business hours March 12.

The ECI was directed to publish the information shared by the bank on its official website by 5 pm March 15 which it did.



## Brothers held for duping govt officials

The sleuths also seized one laptop, one desktop, five cellphones, bank passbook and cheque book, fake identity cards and 17 ATM-cum-debit cards.

About their modus operandi, Panigrahi stated the duo used to send the text message- "This side Sanjaya Mishra, Director of Enforcement Department .... My investigation officer trying to connect you but you did not attend the call. Make an instant call. It's very urgent else I can't control the vigilance", particularly

when the government officials did not receive their phone calls. Adding further, Panigrahi said

the duo teamed up to produce fake documents and ID cards, introducing them as ED officials. Following the payments, the duo would send fabricated clearance letters to the concerned government officials, it added.

So far, the sleuths have tracked down online transaction receipts of more than ₹16 lakh from both brothers, said an official. The fraudsters pulled off the heist by introducing themselves as Additional Director of ED, Bhubaneswar from top brass officials, including officials of tehsil, RTO and collectorate, it added.

The notification for nominations will be issued April 29 and the process of submitting nomination papers will start May 6. Similarly, the nomination papers will be verified May 7 and the last date for withdrawal of nomination papers has been fixed May 9. The counting of votes will be held June 4 along with the rest of the country.

The district has a total of 18.65.455 electorates.

Bhubaneswar, March 17: With the Election Commission of India (ECI) unveiling the dates for the simultaneous Lok Sabha and Odisha Assembly elections, the spotlight shifts to farmers of the western region, whose votes hold significant sway over at least five parliamentary constituencies and 35 Vidhan Sabha

In Odisha, which comprises 21 Lok Sabha seats and 147 Assembly segments, elections are scheduled to be held in four phases May 13, May 20, May 25,

Historically, the farmers of the western region, once a stronghold of the Congress, have wielded considerable electoral influence by voting en masse.

In the 2019 general elections, all five western Odisha Lok Sabha seats were secured by the opposition BJP, while the ruling BJD, led by Naveen Patnaik, failed to secure a single seat in this agriculturally rich region, often referred to as the 'Anna datas' (providers of food) region, with areas like Bargarh and Kalahandi being prominent rice-producing hubs.

Out of the eight seats won by the BJP in the state in 2019, the party secured victories in all five Lok Sabha seats in the western region, including Sambalpur, Bargarh, Bolangir, Kalahandi, and Sundargarh. The remaining three seats were won in northern Odisha's Balasore and Mayurbhanj, as well as the coastal belt's Bhubaneswar.

However, despite the BJP's



success in the Lok Sabha elections, the people of the region predominantly favoured Naveen's

BJD in the Assembly polls. Out of the 35 Assembly segments within these five western LS constituencies, BJP candidates only managed to secure victories in eight, with the majority going in favour of the BJD. The Congress also secured victories in three assembly segments in the western region.

Recognising the significance of farmers in the western region and aiming to regain their support, the Odisha Pradesh Congress Committee (OPCC) has promised various agricul tural incentives in its recently re-

leased election manifesto. These include farm loan waivers, a guaranteed minimum support price (MSP) of ₹3,000 per quintal of paddy, pensions for farmers, allowances for agricultural workers, complete GST withdrawal on agricultural products, among others.

OPCC president Sarat Pattanayak emphasised the importance of farmers in the rural

economy and pledged support to them if the Congress comes to power after the 2024 elections.

Farmers are the backbone of rural economy and the Congress will do everything possible for the 'Anna Datas' if it comes to power after 2024 elections," Pattanayak, who also hails from Bolangir district, a

part of the western region, said. On the other hand, the ruling BJD, which has governed the state since 2000, has not yet released its election manifesto but claims to have implemented several schemes for the welfare of

farmers Notably, initiatives like Indravati Irrigation project and the recently launched Lower Suktel irrigation project aim to benefit farmers in regions like Kalahandi and Bolangir. Additionally, the BJD government has undertaken significant water infrastructure projects in various districts, further emphasising its commitment to

agricultural development. The BJP, meanwhile, has been appealing to farmers in the region through schemes like the Pradhan Mantri Fasal Bima Yojana, particularly crucial for the drought-prone KBK (Kalahandi-Bolangir-Koraput) region.

Pradip Purohit, a BJP leader and former MLA, asserted that the farmers of the western region strongly support the saffron party, citing confidence in Prime

Minister Narendra Modi. Despite agriculture being the primary livelihood for 70 per cent of the state's population, farmers in western Odisha have been notably organised in articulating their concerns to the government, unlike their counterparts in other parts of the

While the BJD has a stronghold in coastal and central Odisha, winning 12 Lok Sabha seats in 2019, the BJP and Congress have also secured victories in different regions, indicating a three-way competition as the election dates approach, with all parties vyingfor the support of the crucial farming community.

Bhubaneswar, March 17: As sweltering heat continues to dominate Odisha, the regional centre of India Meteorological Department (IMD) Sunday, issued a warning for heavy rainfall with hailstorm for next two days in 12 districts of Odisha, including Capital City.

In its mid-day bulletin, the IMD centre said, "Maximum temperatures observed appreciable fall at one or two places over the districts of Odisha. They were below normal at a few places over the districts of Coastal Odisha and at one or two places over the districts of Interior Odisha, and normal at elsewhere over the districts

Heavy rainfall may occur at one or two places in Dhenkanal. Cuttack, Nayagarh, Kandhamal, Ganjam, and Khurda districts March 19. Thunderstorm with lightning and hail accompanied with gusty surface wind speed reaching 40-50 kmph is also likely at one or two places in Boudh, Kandhamal, Kalahandi, Bolangir, Rayagada, Nabarangpur, Angul, Nayagarh, and Dhenkanal, and Khurda districts.

On March 20, heavy rainfall is likely at one or two places in Cuttack, Nayagarh, Khurda, and

Kandhamal. Thunderstorm with lightning accompanied with gusty surface wind speed reaching 30-40 kmph may also occur at one or two places in Koraput, Ganjam, Gajapati, Puri, and Jagatsinghpur districts.

IMD Scientist Uma Shankar Das said a low-pressure has been formed over the Bay of Bengal (BoB), which would fetch moisture and wind in the surface temperature. This would lead into light shower (drizzle) in several parts of Odisha, over the next 24 hours.

Furthermore, Das stated the temperature would see a slight dip of 3-5 degrees, resulting immediate respite from the humid temperature.

People have been advised to keep a watch on the weather and move to safer places accordingly. They have been asked to take shelter in pukka structures and avoid trees and also move away from electric poles and wires. Farming operations should be temporarily suspended during worsening of weather conditions. Farmers have advised to stake plants with stems with a string or twist-ties to build support, the weather agency said in an advisory

## IIT Guwahati researchers explore mystery of dark matter

esearchers at Indian Institute of Technology (IIT), Guwahati in collaboration with international scientists have proposed a novel scenario to explain the matterantimatter imbalance in the

A study by the researchers sheds light on one of the longstanding mysteries in the field of cosmology surrounding dark matter and Baryon Asymmetry in the Universe (BAU). The research which has been funded by the Science and Engineering Research Board (SERB), has been published in Physical Review D.

According to officials, only about five per cent of the Universe comprises visible or baryonic matter, such as stars and galaxies. The remaining approximately five times this visible matter is composed of dark matter, a substance that does not emit light. While the origin of dark matter remains elusive, visible matter is known to consist of baryons (matter) and a minimal amount of antibaryons (antimatter).

"The Universe was expected to have an equal amount of matter and antimatter in the beginning. Any initial imbalance should have been rectified during the rapid expansion phase known as inflation. But today we observe surplus matter. This mystery, known as the baryon asymmetry in the Universe (BAU) contradicts our predictions and remains unsolved, challenging our understanding of the early Universe," said Debasish Borah, Associate Professor, department of Physics, IIT Guwahati.

Borah, who led the research, said the fact that neither the mystery of dark matter nor the BAU puzzle can be solved using



the standard model of particle physics, challenged the researchers to go beyond the stan-

mological timescales, we are proposing the possibility of its decay in the early Universe due to specific temperature-induced corrections to its mass, making its decay energetically feasible, he said.

International researchers includes Arnab Dasgupta from University of Pittsburgh, Matthew Knauss from the High Energy Theory Group at William and Mary university in the US and Rishav Roshan from Kyungpook National University

"In our model of the early Universe, dark matter transforms into regular matter due to temperature effects, generating an imbalance between matter and antimatter. We first propose a unique type of dark matter, a singlet fermion, influenced by a scalar field. The associated scalar field may act as inflation during the Universe's early expansion or can lead to a strong first order phase transition," Borah

"Due to energetically feasible decay in the early Universe, dark matter partially decays into ordinary matter creating the BAU. As the Universe cools, dark matter stabilises, leaving a residue observed as dark matter today. This process not only explains dark matter but also contributes to the creation of visible matter, affecting matter-antimatter asym-

## ITI students create giant fish sculpture from plastic waste

Berhampur, March 17: Students of the state government-run **Industrial Training Institute** (ITI) Berhampur have made a giant fish sculpture from plastic waste with an aim to reduce plastic pollution.

A 30-foot high and 1,500 kg heavy fish sculpture was made by the students using iron scraps. Around 20,000 used plastic bottles of different sizes were collected by students, mostly from seashores. After filling, the weight of the sculpture was around 1,500 kg, said Rajat Panigrahy, Principal, ITI Berhampur.

The sculpture was installed near the institute's campus for public view and to educate the people about plastic pollution with the objective of 'Swachhata Hi Seva', he said.

'We have created this unique sculpture with the objectives of the United Nations Sustainable Development Goal (SDG). This



emphasises the crucial need to conserve and sustainably use oceans, seas and marine resources, by preventing thousands of plastic bottles from entering landfills or potentially ending up in the oceans," said the principal

He said plastic pollution is a major threat to aquatic ecosystems. Plastic debris entangles and harms marine life,

disrupts food chains and pollutes the delicate ocean environment. By effectively up-cycling plastic bottles into an impactful art installation, the institute creates awareness about this critical issue, he added.

On Gandhi Jayanti, last year, the institute unveiled a 23-foot tall elephant sculpture from 30,000 used plastic bottles, which won appreciation from the Prime Minister's Office (PMO).

Earlier, the students of the institute had made sculptures like Dashavatar (10 incarnations of Lord Vishnu), Mahatma Gandhi, Netaji Subash Chandra Bose and former Odisha chief minister Biju Patnaik by using the discarded materials.

All these sculptures have been installed in its open scrap park. Sri Ganesh by using automo-

## Parents steal minor girl's body from morgue to resurrect her

Rourkela, March 17: In a bizarre incident, family members of a minor girl who died from snakebite Saturday forcibly took her body from the morgue of a hospital here by breaking open the main door lock as they 'believed' she will be resurrected in 21 days through sorcery.

As per reports, Sohani Singh, daughter of Devraj Singh, was bitten by a poisonous snake at Sonaparbat near Fertiliser Township, Saturday evening. The parents brought the kid to the Rourkela Government Hospital (RGH) for treatment where the

doctors pronounced her dead. The hospital authorities shifted the body to the morgue. However, the deceased girl's mother was not ready to accept the death. She was adamant that she would be alive after 21 days through sorcery.

At around 8pm Saturday, the parents of the deceased girl broke open the lock of the morgue and took away her body



and left for their home

When the hospital authorities discovered that the body was missing Sunday morning, they informed Tangarpalli police about the incident. For the police, the issue was sensitive as the girl was a tribal. They held discussions with some influential people of the region and finally managed to persuade the parents to leave the body.

The body was brought back to RGH and later post-mortem was done. Speaking about the incident, Tangarpalli IIC Rameswar Singh said, "We finally got thebody and handed it over for postmortem.'

## Clear The Cloud

fter "wilful disobedience" of the Supreme Court's historic order, the State Bank of India (SBI) has submitted incomplete data on the electoral bonds to the Election Commission of India (ECI), an act for which the bank got a rap on the knuckles from the Apex Court. The bank was asked to provide the number unique to each electoral bond that would disclose the link between the buyer and the recipient political party. At whose behest the SBI has got the audacity to frequently disregard the top court's orders is anybody's guess.

The release of the electoral bonds data by the ECI acting on the Supreme Court's order, meanwhile, has opened a Pandora's Box. Whatever data has been made public so far is so replete with opacity that a closer scrutiny is in the order. According to an analysis conducted by the Project Electoral Bond, a number of companies have purchased electoral bonds following probe from various Central agencies including the Enforcement Directorate (ED), the Income Tax Department (IT Dept), the Central Bureau of Investigation (CBI), and the Goods and Service Tax (GST) authorities. Among them are prominent companies featured in the top five donors list, such as Future Gaming and Hotel Services, Megha Engineering and Infrastructure Ltd, and Yashoda Super Specialty Hospital.

A total of 43 newly established companies, founded in 2018 or later, have collectively purchased electoral bonds amounting more than Rs 384.5 crore. Among these, four companies founded in 2023 in Hyderabad, acquired bonds worth millions of rupees shortly after their establishment. Additionally, nine companies formed in 2020 and eleven companies set up in 2021 during the peak of the COVID-19 pandemic managed to procure bonds amounting to nearly Rs 100 crore within just one or two years of their inception.

Upon examining the list of companies that bought electoral bonds, it has come to light that at least 19 of them were classified as 'high risk' by the Ministry of Finance for breaching regulations outlined under the Prevention of Money Laundering Act (PMLA). These companies collectively bought electoral bonds amounting to a staggering Rs 2,717 crore. Sixteen of these companies were based in Kolkata, with some even located in areas such as Lal Bazar, infamous for housing shell companies.

Since the release of the data, there has been a significant amount of public interest in the identities of bond purchasers, the amounts they purchased, and the dates of their purchases. This information has uncovered possible quid pro quo, as anticipated. However, voters are still unaware of the individuals who bought electoral bonds amounting more than Rs 4,000 crore before April 12, 2019.

In this regard, a plea was submitted in the Supreme Court on 17 March asking for transparency regarding the sale of electoral bonds during the period from March 1, 2018, to April 11, 2019. The plea argues that voters have the right to know where political parties are receiving their funding from since the inception of the now-scrapped electoral bonds scheme. The petition, filed by Citizen's Rights Trust, reveals that a total of 9,159 bonds amounting to Rs 4,002 crore were sold during the specified time period, and this information should be made public. The petition calls for the SBI to provide details on the electoral bonds that were sold and redeemed between March 1, 2018, and April 11, 2019, which includes the alphanumeric number; purchase date, denomination, and the names of both donors and parties involved.

"It is submitted that once the entire Electoral Bond Scheme is held to be violative of Article 19(1)(a) of the Constitution, the citizens are entitled to know the details of the donor and donee of the entire period from March 2018 onwards (the date when the scheme became functional). The data available on the platform of the Election Commission represents only 76 per cent of the total bonds and the voters are not aware of the details of the remaining 24 per cent of the Electoral Bonds," the plea said.

Meanwhile, the ECI released a fresh set of data regarding electoral bonds that had previously been submitted in sealed envelopes to the Supreme Court. Political parties had filed data on electoral bonds in sealed covers as directed by the Supreme Court's interim order, the poll panel said in a statement.

According to the data and not surprisingly, the BJP has received the highest amount of funds through these bonds, amounting to Rs 6,986.5 crore. This was followed by the Trinamool Congress with Rs 1,397 crore, the Congress with Rs 1,334 crore, and the Bharat Rashtra Samithi with Rs 1,322 crore.

Future Gaming, the top spender on electoral bonds, invested a whopping Rs 1,368 crore. Surprisingly, almost 37 per cent of this amount was directed towards the DMK. Other notable contributors to the DMK included Megha Engineering with Rs 105 crore, India Cements Rs 14 crore, and Sun TV with Rs 100 crore. It is worth noting that the DMK stands out as one of the few major regional parties that have chosen to disclose the identities of their donors. In contrast, parties like the BJP, Congress, TMC, and AAP have kept this information confidential, despite a Supreme Court order mandating the Election Commission to make these details public.

Now, it is incumbent upon the SBI and ECI to make the whole picture regarding the electoral bonds clear. This will enable the voter, who is going to polls four weeks from now, to exercise her right in an informed manner after knowing the whole truth.

And yes, while saying this, none should forget that almost all actual election expenses are made in cash and the known culprits, whose names have not figured anywhere, must have definitely donated much larger sums in hard cash which would never come to the surface.

## **WISHING AWAY POVERTY**

he late, sharp-witted economist Michael Mussa, my first boss at the International Monetary Fund (IMF), once told me that every statistic must pass the "smell test." I recalled this sage advice recently when Indian authorities published the first driblets of a consumption survey in over a decade. The numbers stink.


Economists have long maintained that India's official GDP data overstate growth. Before the September 2023 G20 summit in New Delhi, the Indian National Statistical Office issued a particularly brazen overestimate. The last decennial census was in 2011. A survey highlighting stubbornly high malnutrition and anaemia cost the survey's director his job.

The last comprehensive consumption-expenditure survey in 2012 showed 22 per cent living in poverty. The government iunked a 2018 survey when leaked data indicated an increase in the poverty rate. Not surprisingly, the new partial consumption figures generated much excitement. Hastily, Surjit Bhalla, India's former executive director at the IMF, and economist Karan Bhasin proclaimed - under the Brookings Institution's imprimatur - that extreme poverty has been "elim-

But while such misuse of statistics will amplify the India hype in elite echo chambers, poverty remains deeply entrenched in India, and broader deprivation appears to have increased as inflation erodes incomes of the poor.

Measuring poverty is a complicated task, the essence of which lies in establishing a poverty threshold. The World Bank, which initially set the international poverty line at \$1 per day in 1990, updated this figure to \$1.90 in 2011 to account for inflation. Only those who cannot afford to spend \$1.90 per day are classified as "extremely poor."

For India, however, the \$1.90 threshold represents below-sub-sistence-level consumption. As economists Shaohua Chen and Martin Ravallion have noted, it allows for minimal food consumption and little else. In 2012, \$1.90 translated to a meagre 30 rupees a day in purchasing-power-parity terms – barely



While the publication of India's first consumption figures in over a decade has generated much excitement, the official data appear to have been chosen to align with the government's preferred narrative. In reality, poverty remains deeply

entrenched in India and appears to have increased significantly

enough for two basic meals, according to the poverty expert S. Subramanian.

In analysing the recently released consumption-expenditure data, Bhalla and Bhasin seem to have converted the \$1.90 threshold into rupees at the IMF-reported PPP rate of 22.9 rupees per dollar. Consequently, their analysis categorises people as poor only if they cannot spend 45 rupees a day.

This approach is tantamount to wishing away poverty. Assuming an average annual inflation rate of 6 per cent, as stated in the government's press release, the set of goods that cost 30 rupees in 2012 would now cost at least 58 rupees. Moreover, low-income households face diabolical inflation inequality - higher-than-average inflation rates due to the type of goods they buy, their limited mobility (which leaves them at the mercy of local monopolists), and their inability to buy in

Regrettably, Indian authorities do not provide inflation data segmented by household income. If the annual inflation were 8.5 per cent for the bottom half of Indian households, they would need roughly 80 rupees per day to cover their basic needs. In that case, India's poverty rate would be around 22 per cent, essentially the same as in 2012. Setting the bar slightly higher

underscores the grim reality. In 2014, a committee led by Chakravarthi Rangarajan, the former governor of the Reserve Bank of India, concluded that the appropriate poverty line for rural regions was 33 rupees a day - close to the World Bank's line – while urban residents required at least 47 rupees per day to cover commuting and housing expenses. Subramanian emphasised that the urban poverty line was a gross underestimate; he estimated a daily expenditure of 88 rupees to avoid severe deprivation.

Adjusting the Rangarajan and Subramanian estimates using plausible current inflation rates leads to a stark conclusion: Urban poverty rates range between 40 per cent and 60 per cent, which means that 30-40 per cent of all Indians are poor. This is likely conservative, given the sharp increase in education, transportation, and housing costs, as well as out-of-

pocket medical expenses. With numerous parents forced to choose between food and their children's education, is it any wonder that the government feels obliged to provide free supplementary grain rations to 60 per cent of the population?

High, possibly rising, poverty can be partly attributed to the 2016 demonetization that nullified 86 per cent of India's currency and to the haphazard implementation of the Goods and Services Tax of 2017, both of which caused huge distress to the vulnerable.

The COVID-19 pandemic delivered another harsh blow, causing millions of Indian workers to revert to low-productivity agricultural jobs. Today, 70 million more Indians work in agriculture than in 2018, owing to the scarcity of non-agricultural job opportunities, which are mostly confined to financially and physically precarious sectors such as construction, street vending,

security, and domestic work. Given the significant hardship faced by millions of Indians, the pre-election release of partial consumption data invites suspicion. And the Bhalla and Bhasin declaration of the end of poverty borders on the malicious. Moreover, their assertion that consumption inequality has declined sharply is risible: wealthy Indians do not report their \$400 designer sneakers, Lamborghinis, or lavish parties to government surveyors.

The gap between India's rich and poor is startling. Consider the \$120 million pre-wedding celebrations for tycoon Mukesh Ambani's son: the lad wore a \$1 million watch, a superstar received \$6 million to perform, and the Indian aviation authority temporarily cleared a nearby airport to fly in inter-

national celebrities.

Meanwhile, the lack of comprehensive consumption – and inflation – data makes it impossible to get an accurate picture of Indian poverty. Sadly, the government's strategically released data and cherry-picked analysis both continue to reek.

## Regulators need course correction

IN TWO MONTHS, THE MARKET HAS DUMPED A HUGE LOSS OF RS 29 LAKH CRORE

The Indian economy may or may not have matured, it has specialised in its murky Bombay stock operations. It did not crash alone on last Wednesday. Two days earlier, on last Monday, too the chinks were noticed in the State Bank of India shares in the wake of the Supreme Court's firmness on submission of details on electoral bonds. In two months, the market has dumped a huge loss of Rs 29 lakh crore. The small caps also took a hit of Rs 30,246 crore portraying far from a glowing picture.

The losses are the biggest since Covid-19. On 11 March, the market lost Rs 3.15 lakh crore mostly hitting the SBI, followed by Rs 13.9 lakh crore losses across the board, including the Adani group, on 14 March. In two sessions the market lost Rs 17.05 lakh crore or almost 30 per cent equivalent of the total central budgetary amount. Together it is a bigger loss than 13 March, 2020, when the fall was estimated at minus 14.2 per cent.

Not to forget that in the wake of the Hindenberg disclosures, the stock market crashed by 1168 points or almost Rs 12 lakh crore on 23 January, 2024, the biggest in recent times. Most hits were taken by the groups of Adani, Zee and IRCON.

Complicating the issue, the retail traders as a new phenomenon are also suffering. Volumes in retail trades multiplied since 2019, when it overtook the US. Murkier operations are in sight. An index of small-cap stocks lost more than Rs 30,246 crore in market value in less than two weeks through 13 March.

In 2021-22, investors lost \$ 5.4 billion, or \$ 1468 apiece, a big sum, for a country with per capita GDP of \$2300. This happens through dream cyber kiosks that mushroomed on WhatsApp, Facebook, Telegram and Instagram. The online media carry advertisements by CEOs of top companies alluring to multiply Rs 500 investments. As per SEBI these are mere traps.

Are the electoral bonds the big shakers? Perhaps. Investors are wary of disclosures of their identities during election time. The way foreign portfolio investors withdrew from the market faintly indicates this.

Some days back, SEBI Chairperson Madhabi Puri Buch had raised concern over "frothiness and bubbliness." Uday Kotak of the Kotak group also says there is "frothiness." The jar-

gon does not say much except that the regulators' lack of awareness of the murkiness and their inability to check it.

The stock market is not an indication of economic growth. A small fall in the market cap, however, severely impacts the health of the banks. Since the Harshad Mehta scam in 1992, a number of Indian banks and financial institutions collapsed or merged. The market may recover, but the banking process takes a severe beating.

Market regulators need severe course correction. Losing such huge amount of money in just two months is a serious jolt to the economy and the banking sector. And it may not be the last of such national trauma. Undoubtedly, it would be interesting to watch how it impacts the elections.



Mumbai, March 17: The Maratha reservation demand, big-ticket infrastructuré development and farmers' problems would be prominent issues during the ensuing Lok Sabha elections in Maharashtra, which elects the second highest number of members of the Lower House, after Uttar Pradesh.

Mumbai, March 17: Three decades after the 1992 communal riots and the 1993 serial bomb blasts in Mumbai, the Maharashtra government has initiated steps to compensate the legal heirs of persons who were killed or went missing during the tragic events.

The government issued an appeal letter March 14, urging the legal representatives or heirs of those who lost their lives or went missing in the aftermath of the riots and blasts to approach offices of the city and suburban collectors within the next month.

The move was prompted by a Supreme Court order of November 2022, directing the Maharashtra government to locate the legal heirs of the deceased or missing individuals from the period between the communal riots in December 1992 and the bomb blasts in March 1993 in Mumbai, and provide them with compensation and interest arrears.

During the turbulent period of December 1992 and January 1993, Mumbai was engulfed in com-

munal tensions and riots, resulting in approximately 900 deaths and 168 persons missing. On March 12, 1993, a series of 13 blasts rocked various parts

of the city, claiming 257 lives. According to the Supreme Court's ruling, the state government in 1998 issued a compensation of ₹2 lakh to the families of each of the deceased or missing victims from the riots and blasts incidents.

While the government had compensated the legal heirs of all 900 deceased and 60 missing

persons, the remaining missing persons' legal heirs were yet to be located for disbursing the compensation

Criticising the government for not adequately pursuing the missing persons' legal heirs, the Supreme Court mandated that the compensation amount, along with a 9 per cent interest from 1998, be paid to all the victims families.

Kolkata, March 17: Established in 1774 by the then Governor General of Bengal, Warren Hastings, Kolkata GPO holds the distinction of being India's first general post office.

Over its 250-year history, it has served as a testament to the evolution of postal services in the country.

The authorities are leaving no stone unturned to showcase the rich heritage and legacy of GPO Kolkata with a series of events such as postal and philatelic exhibitions on 'Journey of Mails', the release of a special cover on a boat, heritage walk and several cultural programmes during the March 14-19 period.

The 250th anniversary celebration of the Kolkata GPO is a "testament to its enduring legacy and unwavering commitment to serving the people, reflecting its timeless relevance in an ever-changing world", Kumar said.

Flanked by the Hooghly river and a water body 'Laldighi', GPO Kolkata building, the white edifice among many British-era buildings in the Dalhousie Square area of the city, has been given a spectacular look with illumination during the ongoing celebrations.

The old GPO was relocated numerous times to various locations from 1774 to 1868, and the present GPO building was opened to the public October 2, 1868. As part of the 250-year celebrations, homage was paid to the grand clock of the GPO through the release of a special philatelic cover.

As the Dalhousie Square area transformed into a bustling administrative and commercial hub, the installation of a clock became necessary to keep pace with time.

In 1896, this grand clock, imported from the manufacturer of the famous Big Ben in London,

## CAPF deployment to progressively increase in WB

The fact that 250 companies of CAPF will be deployed in the first phase April 19 for just three constituencies of Cooch Behar, Alipurduar and Jalpaiguri in north Bengal, shows how determined the Commission is to ensure free and fair polls

Kolkata, March 17: Starting with deployment of 250 companies of Central Armed Police Forces (CAPF) in the first phase of the seven-phase Lok Sabha elections in West Bengal, the deployment will be progressively increased in subsequent phases, insiders in the office of the Chief Electoral Officer (CEO), West Bengal said.

"While 250 companies will be deployed for polls in just three Lok Sabha constituencies in north Bengal in the first phase April 19, the deployment will gradually be increased in the subsequent phases with the maximum deployment being on the on the seventh and last phase June 1, where a total of nine constituencies in south Bengal



will be going for the polls," said a senior official from the office of CEO, West Bengal who did not wish to be named.

He said that although, right now it cannot be said about the exact deployment in the seventh phase, it is possible that it will be of over 900 companies.

Election Commission of India has already proposed a deployment of 920 companies of CAPF in West Bengal for the polls -- the highest among all Indian states

According to West Bengal CEO Ariz Aftab, the phase-wise deployment is being determined through "vulnerability mapping" of each polling station in each constituency, on the basis of past polling records in all these stations.

'Barring a couple of pockets under Cooch Behar, especially Sitalkuchi, the other pockets in these three constituencies have past records of overall peaceful polls. Still, 250 companies are deployed in the first phase to give a message that no foul play on the polling date will be tolerated," a senior official from the CEO office said.

Likewise, the number of "highly sensitive pockets" are far more on the seventh phase on June 1 when the nine constituencies in south Bengal, namely Kolkata (South), Kolkata (North), Jadavpur, Jaynagar, Basirhat, Barasat, Mathurapur, Diamond Harbour and Dum Dum, will vote. The "highly sensitive" pockets in these constituencies, as per past records, include Sandeshkhali under Basirhat, Bhangar under Jadavpur, Magrahat Paschim under Mathurapur, Basanti, Canning Purba, Canning Paschim and Magrahat Purba under Jaynagar and Metizburuz under Diamond Harbour, among others.

The deployment of CAPF will be maximum in this phase.

# Resentment brewing against sitting MLA

Hatadihi, March 17: At a time when voters and party workers are in a dilemma over the possible alliance between the BJD and BJP, ticket aspirants are pulling out all the stops to strengthen their base to emerge victorious in the upcoming elections. However, the ruling BJD in Anandapur Assembly segment in Keonjhar district is facing an awkward situation as resentment is brewing against the incumbent MLA Bhagirathi Sethi as well as the former legislator Mayadhar Jena.

According to sources, it may not be a cakewalk for Sethi even if he retains the ticket for the forthcoming Assembly polls as odds appear heavily stacked against him. If reports are to be believed, Sethi will have a tough time in quelling the simmering resentment among party cadres before he faced the voters who appear equally dissatisfied.

It is learnt that, several BJD workers and locals have written a letter to the BJD supremo to replace Sethi and field a new candidate in his place.

Reports said that party workers are organising 'Bhagirathi Hatao Abhiyan' (Oust Bhagirathi movement) and venting their ire against him for neglecting them. The campaign is intensifying only more as the general election draws near in the state. Reports said that Jena won



the Anandapur seat as the joint candidate of BJD-BJP alliance in 2000. However, Congress candidate Jayadev Jena defeated the alliance candidate in 2004 election. Later, the ruling BJD has retained the seat since 2009.

In 2014 election, Sethi filed nomination as an independent candidate and later withdrew his nomination after he didn't get a ticket from BJD. He then left BJD and joined BJP while Jena. who was in BJP then, joined BJD. Jena contested the election on a BJD ticket and won the 2014 election from Anandapur

Assembly constituency. In 2019, BJP fielded Sethi as its candidate from this constituency but all of a sudden he quit the saffron camp and contested the election on a BJD ticket. He won the poll in 2019.

Frequent party hopping by Sethi and Jena has sparked resentment among the voters and party workers. Party workers

are opposing the possible re-

nomination of Sethi from this

constituency.

Sources said BJD workers are peeved at the behaviour and attitude of Sethi. Several party workers had organised a meeting against Sethi for neglecting the workers at Chhenapadi recently. They demanded to bring a new face instead of Sethi.

Political analysts believe that if Sethi is fielded again from this constituency then the ruling party might face defeat and the Congress party will be able to

wrest the seat. On the other hand, Mayadhar, who left BJP and won as MLA from BJD, is conspicuous by his absence at various party programme of BJD after the 2019 election. Party workers and locals alleged that both Sethi and Jena are regular party hoppers

and opportunistic leaders.

## BJP may pull out all stops to win Bonai

Rourkela, March 17: Of all the Assembly constituencies in Sundargarh district, Bonai holds a special significance as it was among the first constituencies from where the saffron party opened its account in Odisha, and made its presence felt as a political force.

However, over the years, Bonai changed its profile from a stronghold of the right-wing party to a left bastion, notably the CPM. The constituency has a feudal past with a royal family having its sway even after independence, though never active in politics. However, some glimpses of royal activism were noticed when Jual Oram contested from here for the first time.

Apart from Jual (in 2009), Bhimsen aka Bhima Choudhury had won from here on a BJP ticket. However, this time, Bhimsen is a potential BJD candidate after he joined the party sometime back after being reportedly 'overlooked' by the BJP.

Many in the BJP camp, who

wished not to be named, said Jual didn't want any secondrung leaders to emerge in the party. That is the reason, they claimed, Jual would back candidates who are sure losers. "Bhima bhai (Bhimsen Choudhury) is the best example of Jual's politics. As long as he is around, he would never let anyone to grow," said a BJP activist from Bonai. Seconding him, another party activist said, "For his (Jual's) whimsical decisions the party has suffered a lot, and today Bonai has become a red bastion. Rather than realizing his folly, he is happy."

The CPM meanwhile, has strengthened its base. The soft spoken Laxman Munda has tightened his grip. He had won from here for the first time in 2004. In 2009, he lost to Bhimsen Choudhury. However, in 2014 he emerged triumphant and repeated his performance it in 2019 by defeating Ranjit Kissan of BJD. There is no palpable anti-incumbency against him. Mining and sponge iron industries make considerable contri-

butions to this tribal rural dominated constituency. And Munda has always stood by voters through thick and thin.

Among the several ticket aspirants in BJD, Bhimsen appears to be the front runner. In case there is no tie-up between the BJP and BJD, candidate from the latter party will find it tough to win. Locals said that would ensure sure shot victory for the left candidate.

BJP insiders said Jual is serious about winning the Bonai

seat this time. He is backing Sebati Nayak, a Zilla Parishad member who is a near novice in politics. "Getting her through will be a tough task for BJP. The CPM is deeply entrenched here, and her candidature would only irk some of the other aspirants as well as cadres" they said.

Nevertheless, Bonai will be an interesting constituency to look for as BJP will galvanise all its resources to secure a win for its candidate.

## 'Modi Ki Guarantee' vs Cong's Nyay guarantees

New Delhi, March 17: Promises galore during poll season and the Lok Sabha elections would be no different with guarantees from various political parties set to compete during the highdecibel campaign.

Elections are often won or lost on narratives and it is the issues that connect on the ground which decides the fate of the political parties. Here is a look at the 10 key is-

sues that are likely to be talked about during the poll campaign by various political parties --

### **Modi Ki Guarantee**

Prime Minister Narendra Modi, who is brimming with confidence for bagging a third term, has pitched 'Modi Ki Guarantee' as the main theme of his campaign. 'Modi Ki Guarantee', as described on the PM's website, is a guarantee for the development of the youth, empowerment of the women, welfare of the farmers, and all those marginalised and vulnerable who have been ignored for decades. The idea is also about the government's aim of ensuring saturation of all welfare schemes. It is likely to be the 'catchphrase' in this election around which much of the war of words between rivals would

gravitate. **Congress' 'Nyay' guarantees** 

The grand old party found its mojo back to some extent in the state elections of Himachal Pradesh, Karnataka and Telangana when it pitched guarantees to the people which clicked electorally. Now for the Lok Sabha polls, the party has strongly pitched for its five 'Nyay' guarantees aimed at ensuring justice for youth, farmers, women, labourers, as well as participatory justice. The 'Nyay' guarantees have been presented before the people during the Manipur to Mumbai Rahul Gandhi-led Bharat Jodo Nyay Yatra. The Congress' manifesto is likely to be framed around these guarantees and the party would design its campaign around them. Whether it will result in the party's electoral resurgence, only time will tell.

Unemployment and price rise The INDIA bloc, including the Congress, has been raising the issue of unemployment and rising prices of essential commodities. They have stated repeatedly that lack of jobs is the single biggest issue and have sought to corner the government over the issue. The BJP has hit back citing job growth and a fast-growing economy. The poll season would see intensifying debate over these bread-and-but-

ment of implementation of the Citizenship (Amendment) Act, 2019, and the abrogation of Article 370 for Jammu and Kashmir. The party's government has also passed a law on the Uniform Civil Code in Uttarakhand as a precursor to its objective of devising such a law nationally. The Modi government has projected these actions to assert that it believes in the mantra of walking the talk. The Opposition has slammed these moves as attempts to create, divide and impose uniformity. The debate on these issues is likely to get sharper and more aggressive in the poll season.

with tremendous enthusiasm. The symbolism of Prime Minister Narendra Modi leading the ceremony and RSS chief Mohan Bhagwat along with Uttar Pradesh Chief Minister Yogi Adityanath being at the forefront during the ceremony was not lost on anybody. The BJP leaders have credited the prime minister for making a centuriesold dream come true. With saffron flags fluttering in most parts of the Hindi-speaking belt to mark the occasion, the impact of this can be felt by everyone. Even the Opposition leaders concede that the Ram Temple has given the BJP the advantage in northern India. Analysts believe that much of the BJP's confidence of getting at least 370 seats stems from this 'Ram temple wave'.

Another likely recurrent campaign theme during the poll season would be the BJP's assertion that the Modi dispensation assured good governance, fast paced growth and a vision for the future. The Congress on the other hand has dubbed the 10 years of the Modi government as 'anyay kaal' marked by unemployment, rising prices, capture of institutions, attack on the Constitution, and rising economic inequalities. While the opposition INDIA bloc is likely to highlight the government's 'failures' to claim that the last 10 years have been about show over substance, the BJP would counter it with arguments such as tiding over the pandemic, reducing poverty, free ration scheme and other welfare measures for the poor.

Farmers' issues and legal guar-

antee of MSP The farmers' agitation at the

borders of Delhi just ahead of polls is also likely to dominate the discourse with the opposition alleging that the tillers had been betrayed by the government and promising to provide legal guarantee for MSP if its bloc comes to power. The BJP leaders have been holding talks with farmer leaders to assuage their concerns and have been alleging that many of the agitators were politically motivated. The government has also stressed how its PM-KISAN scheme aid has transformed the lives of tillers. As with most elections, farmers' issues would be critical to the discourse.

**Clash of ideologies** 

This election also marks a crucial phase in what many call the battle of ideologies between the BJP and the Congress. Both parties would present their ideological principles before the people and ask them to choose one.

**Viksit Bharat vision** 

Prime Minister Narendra Modi has asserted that the goal of the country is to become a developed nation. He has stated that his government's actions are committed to achieve the goal by 2047. The vision for a Viksit Bharat is likely to dominate the BJP's campaign while the Opposition has been dubbing it as another 'jumla'. However, it would remain a dominant theme during the course of the campaign.

## INDIA bloc to trounce **BJP in UP: SP leader**

Etawah, March 17: Samajwadi Party (SP) leader Ram Gopal strong anti-incumbency in Uttar Pradesh and the INDIA bloc will defeat the BJP in at least 40 seats the ruling party won last time.

Uttar Pradesh goes to the polls on all seven phases of the Lok Sabha elections, beginning April 19 and ending June 1. The BJPled ruling coalition won 64 seats - BJP 62, Apna Dal(S) 2 - out of the total 80 constituencies in

"There is a strong anti-incumbency in Uttar Pradesh against both the state and the central governments. The situation of the alliance will be very good in UP and we will win in at least 40 seats the BJP won (last time), Yaday said to reporters here.

In the 2019 Lok Sabha elections, the Samajwadi Party and the Bahujan Samaj Party were in alliance. While the SP secured victory on five seats, the BSP won 10.

This time, the SP has joined the opposition INDIA grouping to fight the BJP-led NDA.

On the electoral bonds issue, the Rajya Sabha member said, "People say that they have ended corruption. But corruption (electoral bonds) bigger than this has never happened in any part of the world. They make ED conduct raids and stop the action once a donation is made.'

"Had it been any other country, the government that has given contracts in lieu for donations had been removed," he said.

Speaking on the arrest of BRS leader K Kavitha in connection with the Delhi liquor policy case, Yadav alleged that the ED and CBI only take action against opposition leaders and not against those in the BJP.

### Factory blast: CM orders probe

Rewari/Chandigarh: Haryana Chief Minister Nayab Singh Saini has ordered a magisterial probe into the boiler blast at a spare parts manufacturing facility in the district, which left 40 workers injured, Officials said Sunday that the Chief Minister has ordered a probe under a Sub Divisional Magistrate. Nineteen seriously injured workers had been referred to PGIMS, Rohtak while 10 of the injured are being treated at a trauma centre in Rewari. Some others are being treated in private hospitals in Rewari and Dharuhera.

### 1 killed, 13 injured as truck falls into valley

Panaii: One person was killed and 13 others were seriously injured after a truck fell into a valley in Goa, police said Sunday, as Chief Minister Pramod Sawant who was passing by the spot rushed to help the victims. The accident took place near Quepem town in South Goa district Saturday night. Goa CM Sawant and state social welfare minister Subhash Phal Desai, who were passing by the spot after participating in poll campaign, got down from their cars to help the victims.

### SC to deliver verdict on Jain's bail plea today

New Delhi: The Supreme Court is scheduled to pronounce Monday its verdict on the regular bail plea of Aam Aadmi Party (AAP) leader Satyendar Jain in a money laundering case. A bench of Justices Bela M Trivedi and Pankaj Mithal had reserved its judgement January 17 after hearing the arguments of senior advocate Abhishek Singhvi, appearing for Jain, and Additional Solicitor General SV Raiu. representing the Enforcement Directorate. On December 14, 2023, the top court had extended till January 8 the interim bail granted to Jain, a former minister in the AAP government, in the case on medical grounds.

## KTR meets Kavitha

New Delhi: BRS leader K T Rama Rao Sunday met his sister K Kavitha, who is in the Enforcement Directorate custody in a money laundering case linked to the now-scrapped Delhi Excise Policy case, at the agency office Sunday. Kavitha, 46, was arrested from her Banjara Hills residence in Hyderabad Friday and was brought to Delhi. She was produced before a special PMLA court the next day, which sent her to ED custody until March 23.



# 35 pirates surrender, 17 crew members freed

New Delhi, March 17: In projection of India's growing maritime power, the Indian Navy executed a dramatic midsea operation ending a threemonth hijacking of a bulk carrier with deployment of its warship INS Kolkata, long-endurance Sea Guardian drones, P-8I surveillance aircraft and airdropping of elite MARCOS commandos from a C-17 plane.

The Navy seized the former Maltese-flagged vessel, rescued 17 hostages and captured 35 armed pirates in the nearly 40-hour operation around 2.600 km from the Indian coast that experts say was the first such successful takeover of a cargo ship from the Somali pirates in the last around seven years.

The Navy said after it confirmed the presence of armed pirates onboard the vessel MV Ruen through a ship-launched drone, the drone was shot down by the pirates March 15.

As the well-coordinated operation came amid rising concerns over safety of critical sea lanes, the Navy Sunday asserted that it is resolved to "reinforce" peace and stability in the Indian Ocean and to thwart resurgence of piracy in the region.

It is learnt that Navy Chief Admiral R Hari Kumar minutely monitored the operation. "I congratulate the Indian Navy and the

Bulgaria's Foreign Minister Mariya Gabriel expressed gratitude to the Indian Navy for the successful operation to rescue the hijacked vessel and crew members, including seven nationals of her country. Responding to Gabriel's post on 'X', External Affairs Minister S Jaishankar said, "That's what friends are for." The merchant vessel Ruen was seized by the Somali pirates December 14 off the coast of Somalia.

In a statement, the Navy said the seaworthiness of MV Ruen is being assessed and the vessel carrying approximately 37,800 tonnes of cargo worth around \$1 million will be brought safely to India. "The culmination of the ongoing anti-piracy operation involving pirate ship Ruen in the Southern Indian Ocean Region

highlights the commitment of the Indian Navy towards reinforcing peace and stability, and also to thwart the resurgence of piracy in the region," it said. Sharing some aspects of the operation, the Navy said its warship INS Kolkata intercepted Ruen Wednesday morning and confirmed the presence of armed pirates through a ship-launched drone. "In a reckless hostile act, the pirates shot down the drone and fired at the Indian Naval warship," it said, adding INS Kolkata disabled the vessel's steering system and navigational aids, forcing it to stop sailing. Following this, the MARCOS commandos seized the vessel, captured the pirates and rescued the crew members of Ruen.

Separately, the Indian Air Force described the airdropping of the Combat Rubberised Raiding Craft (CRRC) boats and the MARCOS commandos as a "remarkable display" of "jointness" between the two forces.

## Kerala moves top court seeking stay on CAA rules

New Delhi, March 17: Kerala has filed a fresh plea in the Supreme Court seeking a stay on the implementation of the Citizenship (Amendment) Rules 2024, contending it was discriminatory, arbitrary and contravened the principles of secularism.

The Centre had March 11 paved the way for the implementation of the Citizenship (Amendment) Act, 2019, with the notification of the relevant rules, four years after the contentious law was passed by Parliament to fast-track Indian citizenship for undocumented non-Muslim migrants from Pakistan, Bangladesh and Afghanistan who came to India before December 31, 2014.

Terming the CAA Rules as 'unconstitutional', the state government said classifications based on religion and country are discriminatory, arbitrary, unreasonable, and contravened the

principles of secularism. The Kerala government, which had earlier filed an original suit against the validity of the Citizenship Amendment Act (CAA), said the Amendment Act and Rules and Orders are bereft of any standard principle or norm in discriminating migrants from other countries such as Sri Lanka, Myanmar and Bhutan, which are sharing international borders with India and to which and from which there has been trans-border migration. "Classifications based on religion and country are manifestly discriminatory. It is trite and settled law that a legislation discriminating on the basis of an intrinsic and core trait of an individual cannot form a reasonable classification based on an intelligible differentia," the plea said.

## PM asks ministers to work on roadmap for new govt, say sources

New Delhi, March 17: Prime Minister Narendra Modi Sunday told ministers to draft a roadmap for the first 100 days and next five years for new government, sources said.

Chairing a Cabinet meeting here this morning, the PM also asked them to meet secretaries and other officials of their respective ministries to discuss how the agenda for the first 100 days and the next five years can be better implemented.

The meeting took place a day after the Election Commission announced schedule for the Lok Sabha polls 2024.

The Cabinet also initiated the process of notifying the dates of the seven-phase parliamentary elections by sending the Election Commission's recommendation to President Droupadi Murmu.

The first notification will be issued March 20 for the first phase of polls April 19 on 102 seats. The nomination process begins for a particular phase with the issuance of the notification. Prime Minister Modi and his Council of Ministers had March 3 had brainstormed over the vision document for "Viksit Bharat: 2047" and a detailed action plan for the next five years. A 100-day agenda for immediate steps to be taken after a new government is formed in June was deliberated upon during the daylong meeting of the Council. Sources had then said that the roadmap for "Viksit Bharat" was a result of more than two years of intensive preparation and entailed a "whole-of-

## **EOW registers FIR against Bhupesh Baghel**

Raipur: The Economic Offences Wing (EOW) in Chhattisgarh has registered a case against former Chief Minister Bhupesh Baghel and others in the alleged Mahadev online betting scam based on a probe report submitted by the ED, officials said Sunday. The projected proceeds of crime in this case are about ₹6,000 crore, according to the ED.

## Fresh protests erupt in Sandeshkhali

Kolkata: Fresh protests erupted at certain pockets in Sandeshkhali in West Bengal Sunday after locals demanded the immediate arrest of three more local Trinamool Congress leaders. The three leaders include a ruling party village Panchavat Chief Haii Siddik Molla and two of his associates Zulfikar Molla and Hasem Molla. All of them are known to be the close associates of nowsuspended Trinamool Congress leader Sheikh Shahjahan, the alleged accused mastermind behind the attack on ED and CAPF at Sandeshkhali January 5. Shahjahan is currently in the custody of the Central Bureau of Investigation (CBI). Meanwhile, West Bengal Governor CV Ananda Bose has decided to form a committee to evaluate how the illegally grabbed can be brought back again to the cultivable conditions before being given back to the original owners.

## India, Maldives hold core group meeting

New Delhi: India and the Maldives Sunday reviewed the ongoing process of replacing Indian military personnel from the island nation with Male saying the second group will leave by April 10. The two sides held the third meeting of the bilateral high-level core group in Male, days after India withdrew the first team of military personnel that was operating an advanced light helicopter in the Indian Ocean archipelago. The military team has been replaced by civilian technical experts. The Indian personnel are operating three aviation platforms in the Maldives and New Delhi is now deploying civilian personnel to operate them. 



According to an earlier report compiled by NGO Association of Democratic Reforms (ADR), electoral bonds worth ₹16,518 crore were sold from March 2018 to January 2024.

### **EU, Egypt boost ties**

Cairo: The European Union Sunday announced a \$8 billion aid package for cash-strapped Egypt amid concerns that economic pressure and conflicts and chaos in neighbouring countries could drive more migrants to European shores. The deal is scheduled to be signed during a visit by European Commission president Ursula von der Leyen and the leaders of Belgium, Italy, Austria, Cyprus and Greece, according to Egyptian officials. The package includes both grants and loans over the next three years for the Arab world's most populous country, according to the European Union Mission in Cairo.

## Niger, US end accord

Niamey: Niger's ruling junta has revoked with immediate effect a military accord that allows military personnel and civilian staff from the US Department of Defense on its soil, junta spokesperson Colonel Amadou Abdram said Saturday. The decision follows a visit by US officials this week which was led by Assistant Secretary of State for African Affairs Molly Phee and included General Michael Langley, commander of the US Africa Command. Abdramane, speaking on television in the West African nation, said the US delegation did not follow diplomatic protocol, and that Niger was not informed about the composition of the delegation, the date of its arrival or the agenda.

## Aid container looted

Port-Au-Prince: The UN children's agency said Saturday one of its aid containers at Haiti's main port, stocked with "essential items for maternal, neonatal and child survival," was looted, as gangs increasingly control the capital. Haiti is struggling to resolve a long-running political and humanitarian crisis that the children's agency, UNICEF, has warned is causing record hunger and life-threatening malnutrition in parts of the capital Port-au-Prince. The unelected prime minister, Ariel Henry, said this week he would step down once a transitional council was in place. Heavily armed gangs have taken over much of the city, and rights groups have reported widespread killings, kidnappings and sexual

# **Putin set to tighten grip**

Putin, who rose to power in 1999, is poised to win a new six-year term that, if he completes it, would enable him to overtake Josef Stalin and become Russia's longest-serving leader for more than 200 years

Moscow, March 17: President Vladimir Putin is poised to tighten his grip on power Sunday in a Russian election that is certain to deliver him a landslide victory, though some opponents staged a symbolic noon protest at polling stations against his rule.

The election comes just over two years since Putin triggered the deadliest European conflict since World War Two by ordering the invasion of Ukraine. He casts it as a "special military operation"

War has hung over the three day election: Ukraine has repeatedly attacked oil refineries in Russia, shelled Russian regions and sought to pierce Russian borders with proxy forces - a move Putin said would not be left unpunished.

While Putin's re-election is not in doubt given his control over Russia and the absence of any real challengers, the former KGB spy wants to show that he has the overwhelming support of Russians.

The Kremlin has sought a high turnout, and as polls opened for a third day in western Russia, officials said the turnout in the first two days had already reached 63% nationwide. An exit poll will be published shortly after voting ends at 18:00 GMT.

There was no independent tally of how many of Russia's 114 million voters turned out at noon to show opposition to Putin, amid extremely tight security involving tens of thousands of police and security officials **'NOON AGAINST PUTIN'** 

Supporters of Alexei Navalny, who died in an Arctic prison last month, had called on

Russians to come out at a "Noon against Putin" protest to show their dissent against a leader they cast as a corrupt autocrat.

"Alexei was fighting for very simple things: for freedom of speech, for fair elections, for democracy and our right to live without corruption and war," Navalny's widow, Yulia, said in a message to a rally in Budapest March 15. "Putin is not Russia. Russia is not Putin."

Reuters journalists saw a slight increase in the flow of voters, especially younger people, at noon at some polling stations in Moscow and Yekaterinburg, with queues of several hundred people. Some said they were protesting.

Leonid Volkov, an exiled Navalny aide who was attacked with a hammer last week in Vilnius, estimated hundreds of thousands of people had come out to polling stations in Moscow,

St Petersburg, Yekaterinburg

and other cities.

At polling stations at Russian diplomatic missions from Australia and Japan to Armenia, Kazakhstan and Georgia, hundreds of Russians stood in line at noon.

Over the previous two days, there were scattered incidents of protest as some Russians set fire to voting booths and poured dye into ballot boxes, drawing a rebuke from Russian officials who called them scumbags and traitors. Opponents posted some pictures of ballots spoiled with slogans insulting Putin.

But Navalny's death has left the scattered opposition deprived of its most formidable leader.

# Netanyahu rails against US flak

Israel PM says won't stop until 'total victory'; will push ahead with Rafah offensive

Tel Aviv, March 17: Israeli Prime Minister Benjamin Netanyahu railed Sunday against growing criticism from the United States against his leadership amid the devasting war with Hamas, saying the pressure won't stop Israel from achieving "total victory."

In recent days, top officials from the US, Israel's staunchest ally which has provided key military and diplomatic support during the war, have publicly voiced their frustration with

Netanyahu and his government. US President Joe Biden accused Netanyahu of hurting Israel because of the huge civilian death toll in Gaza.

US Senate Majority Leader Chuck Schumer, the highestranking Jewish official in the country and a strong Israel supporter, then called on Israel to hold a new election, saying Netanyahu had "lost his way." Biden then expressed support for what he called Schumer's "good speech."

The US also has expressed concerns about a planned Israeli assault on the southern Gaza city of Rafah, where about 1.4 million displaced Palestinians are sheltering, and support for a new round of talks aimed at securing a cease-fire in exchange for the return of Israeli hostages.

Despite the talks, Netanyahu made it clear Sunday he had no plans of backing down from the fighting that has already killed

Beijing, March 17: The Chinese military has reiterated its claim over Arunachal Pradesh, calling the area an "inherent part of China's territory", days after India rejected Beijing's objection to Prime Minister Narendra Modi's visit to the state.

The Chinese Defence Ministry spokesman Senior Colonel Zhang Xiaogang said that the southern part of Xizang (the Chinese name for Tibet) is an inherent part of China's territory, and Beijing "never acknowledges and firmly opposes" the "socalled Arunachal Pradesh illegally established by India", official media here reported.

Zhang made the remarks in response to India's enhancement of its military readiness through the Sela Tunnel in Arunachal Pradesh, according to a report posted on the Chinese Defence Ministry's website Friday.

India has repeatedly rejected China's territorial claims over Arunachal Pradesh, asserting that the state is an integral part of the country. New Delhi has also dismissed Beijing's move to assign "invented" names to the area, saying it did not alter the reality.

Zhang said that the current border situation is generally stable, with effective diplomatic and military communication between the two sides on border issues of common concern. He urged India to "stop actions that complicate the border issue and to earnestly maintain peace and stability in the border area."

He "stressed" that the Chinese military remains highly alert in defending national sovereignty and territorial integrity, according to the report.

Zhang's reaction follows China's foreign ministry spokesperson's remark Monday about lodging a diplomatic protest with India over Modi's recent visit to Arunachal Pradesh.



### Five of top ten firms' mcap tanks

New Delhi: Five of the top 10 valued firms faced a combined erosion of ₹2,23,660 crore from their market valuation last week, with Reliance Industries and Life Insurance Corporation of India taking the steepest hit amid an overall bearish trend in equities. Last week, the BSE benchmark tanked 1,475.96 points or 1.99 per cent. While Reliance Industries, ICICI Bank, State Bank of India, Life Insurance Corporation of India (LIC) and Hindustan Unilever suffered erosion from their market capitalisation (mcap), Tata Consultancy Services (TCS), HDFC Bank, Bharti Airtel, Infosys and ITC were the gainers. Reliance Industries continued to rule the chart of the most valued firms followed by TCS, HDFC Bank, ICICI Bank, Bharti Airtel, Infosys, State Bank of India, LIC, Hindustan Unilever and ITC.

### Midcap, small cap funds' flow rises

New Delhi: Mid and small cap funds accounted for 59 per cent of assets under management (AUM) and 87 per cent of flows in FY24, global brokerage firm Jefferies said. # FPIs make strong

Foreign investors infuse ₹40K-cr in equity markets

New Delhi, March 17: FPIs came back strongly to invest in the Indian equity markets, buying shares worth ₹ 40,710 crore in the first fortnight of the month amid an improvement in the global economic landscape and robust domestic macroeconomic

The inflows came following a modest investment of ₹1,539 crore in February and an outflow of ₹25,743 crore in January, data with the depositories snowed.

FPIs have been changing their strategy in response to the changes in the bond yields in the US. Therefore, now that US bond yields have again spiked up in response to stubborn inflation, they may again turn sellers in some of the days, going forward, VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said.

## Adani plans ₹1.2L-cr return to equities investment in FY25

New Delhi, March 17: Adani group plans to invest more than ₹1.2 lakh crore (about \$14 billion) across its portfolio companies that range from ports to energy, airports, commodities, cement and media in fiscal year starting April 1, as it doubles down on its \$100 billion investment guidance over the next 7-10 years to grow businesses, sources said.

The projected capital expenditure or capex for 2024-25 (April 2024 to March 2025) fiscal is 40 per cent higher than what the portfolio is estimated to have incurred in FY24. According to analysts, the portfolio is estimated to have incurred a capex of around \$10 billion in FY24 that ends March 31.

Sources said these investments will set the stage for exponential profit growth. The group had previously guided a \$100 billion capex over the next 7-10 years. Most of this investment is going to go into group fast growing businesses -- renewable, green hydrogen and airports.

As much as 70 per cent of the planned capex will go into its green portfolio -- primarily renewable power, green hydrogen, green evacuation. Of the remaining 30 per cent, the majority will be spent towards airports and ports businesses, they said.

## Flipkart valuation declines by over ₹41K-cr in 2 yrs

New Delhi, March 17: E-commerce firm Flipkart's valuation has declined by \$5 billion or around ₹41.000 crore as of January 2024 compared to that in January 2022, according to equity transactions carried out by its US-based parent firm Walmart.

The valuation of the e-commerce firm declined to \$35 billion as of January 31, 2024, from \$40 billion in the financial year ended January 31, 2022, as per Walmart's change in equity structure in Flipkart.

Flipkart attributed the decline in valuation to the demerger of fintech firm PhonePe into a separate company. Sources, however, peg the current valuation of Flipkart in the range of \$38-40 billion.

Walmart diluted 8 per cent equity in Flipkart for \$3.2 billion in fiscal year (FY) 2022 reflecting the enterprise value of the e-commerce at \$40 billion.

The US retail giant in FY2024 increased its shareholding by 10 per cent to approximately 85 per cent by paying \$3.5 billion, reflecting the enterprise valuation of Flipkart at \$35 billion.

"During fiscal 2024, the company paid \$3.5 billion to acquire shares from certain Flipkart noncontrolling interest holders and settle the liability to former noncontrolling interest holders of PhonePe. The company's ownership of Flipkart increased from approximately 75 per cent as of January 31, 2023, to approximately 85 per cent as of January 31, 2024," Walmart said.



## India's smartphone exports to US jump

New Delhi, March 17: India's smartphone exports to the US jumped to \$3.53 billion in April-December this fiscal against \$998 million in the same period last year, according to the Commerce Ministry data. The increasing outbound ship-

ments led to an increase in the smarphones' market share to 7.76 per cent during April-December this fiscal from 2 per cent in the same period of last year, the data showed.

the Bureau of Indian Standards (BIS) approval for the sale of toys in India, protectionism, China-Plus-One strategy and an increase in basic customs duty to 70 per cent have led to a boom in India's toy industry.

According to industry players, while global brands like Hasbro, Mattel, Spin Master, and Early Learning Centre depend more on the country for sourcing, major manufacturers like Italian major Dream Plast, Microplast, and Incas are gradually shifting focus to India from China.

"I don't think any Chinese capacity is approved by BIS. Imports have been replaced by domestic Indian products. Ten years ago, hardly any sourcing was happening from India. Now, many companies have set up a base in India." said R Jeswant. chief executive officer of the Chennai-based Funskool, owned by tyre maker MRF and associates. The company also supplies to international toy majors such as Hasbro, Spin Master, Early Learning Centre, Flair and Drumond Park Games.

"The Indian production has gone up and many people have set up their base in India. Many of the buyers, who were sourcing from China, are trying to shift to other countries and India is one of them. There are many big companies like Microplast, Dream Plast and Incas in this list," said Pawan Gupta, owner of RP Associates, a distributor, importer and exporter based out



On Jan 1, 2021, India banned the sale of toys not certified by BIS. To support the domestic industry, the govt raised the basic customs duty on toys from 20% to 60% in Feb 2020. This was further increased to 70% in March 2023

of Delhi. "Companies like Hasbro and Mattel are also sourcing from India on a large scale,' Gupta added.

The Toy Association of India (TAI), however, believes that the BIS rules need to be further relaxed to support micro, small, and medium enterprises. The association said that out of the 6,000odd toy manufacturing units in the country, only 1,500 have obtained a BIS licence.

"In the MSME sector, the government has relaxed a lot in the last two years. Despite that, it is not manufacture-friendly. But it is a fact that a lot of startups are emerging, and Gujarat is fast becoming a toy manufacturing hub," said Ajay Aggarwal, president of TAI.

According to a report by market research firm IMARC, the toy industry in India was valued at \$1.7 billion in 2023 and is expected to reach \$4.4 billion by-2032, exhibiting a growth rate of 10.6 per cent.

## India's economic boom feels like 2003-07: Morgan Stanley

**IN 2003-07, THE CAPEX BOOM LED TO ACCELERATION IN PRODUCTIVITY, JOB CREATION AND INCOME GROWTH**

New Delhi, Mar 17: India's current world-beating economic growth rate on the back of an investment boom resembles that of 2003-07 when growth averaged more than 8 per cent, according to economists at Morgan

In a report 'The Viewpoint: India - Why this feels like 2003-07', Morgan Stanley said after a decade of investment to GDP steadily declining, capex has emerged as a key growth driver in India. "We think the capex cycle has more room to run, therefore the current expansion closely resembles that of 2003-07.'

The current cycle is driven by investment outperforming consumption, public capex lead-



ing initially but private capex rapidly catching up, the urban consumer leading consumption followed by catch-up in rural demand, market share in global exports rising and macro stability risks kept in check.

We think the defining characteristic of the current expansion is the rise in the investment-to-GDP ratio. Similarly, in the 2003-07 cycle investment to GDP rose from 27 per cent in F2003 (fiscal year ending March 2003) to 39 per cent in F2008, which was close to the peak. Investment to GDP then hov-

ered around those levels until it peaked in F2011. 2011 to 2021 then registered a decade of decline - but the ratio has now inflected again to 34 per cent of GDP and we expect it to rise further to 36 per cent of GDP in F2027E," it said.

In 2003-07, the capex boom led to acceleration in productivity, job creation and income growth. As more labour was absorbed into employment by the strengthening economy, savings to GDP also rose from 28 per cent in F2003 to 39 per cent in F2008.

During 2003-07, GDP growth av-

eraged 8.6 per cent and headline CPI inflation averaged 4.8 per cent. The current account balance stayed within the central bank's comfort zone, ranging between 2.8 per cent to -1.4 per cent of GDP on a 4Q trailing sum basis. Even when oil prices shot up to USD 145 per barrel in July 2008, the current account deficit only widened to 2.4 per cent of GDP the following quarter, the research report said. Gross fixed capital formation

(GFCF) growth in India accelerated sharply from 8.2 per cent in 2002 to 17.5 per cent in 2004, and the pace of growth held firm at 16.2 per cent in 2005-07. In that cycle, the fiscal deficit was already consolidated, the banking system's non-performing loan issues were cleaned up and the economy was poised for a capex upswing.

"However, the initial pick-up in private consumption growth was more modest, averaging just 4.8 per cent in 2003-04," it said.

In the current cycle, real GFCF growth continued to hold strong at 10.5 per cent in October-December, staying above the pre-Covid 2017-18 average of 9.6 per cent. 'This has been mainly driven

by public capex so far, as the corporate sector has been working through multiple shocks from previous years that have weighed on its ability to invest," it said adding now that corporate profit (based on bottom-up company data) to GDP has picked up from a trough of 1.1 per cent in F2020 to 5.4 per cent in F2023, early signs of private capex gaining momentum are being seen.

On the flip side, private consumption is still relatively weak, tracking at just 3.5 per cent in the December quarter, below the pre-Covid 2017-18 average of 6.5 Morgan Stanley said policy-

makers' concerted policy push on supply-side reforms in recent years has meant that real government fixed capex growth inflected higher from F2020. Government fixed capex as a percentage of GDP rose from a trough of 3.6 per cent in F2019 to 4.0 per cent in F2021, again picking up ahead of private capex.

Mumbai, March 17: In his desperation to regain fitness for the remaining World Cup matches last year, India all-rounder Hardik Pandya said he resorted to extreme measures like taking multiple injections and removing blood clots from his ankle but pushing the boundaries only aggravated the injury, forcing him to sit out of the showpiece.

Pandya injured his ankle during India's fourth World Cup game against Bangladesh while bowling his first over of that match, and had to limp off the field with the help of the team physio. He did not play any further part in the tournament.

"I got injections done on my ankles at three different places and I had to remove blood from my ankle because of the swelling. I didn't want to give up (on playing the remainder of the World Cup); for the team I will give my best. If there is one percent chance that I can be with the team I will try my best," Pandya told Star Sports.

However, Pandya said he was aware that pushing himself hard could bring adverse results, but that's the risk he took to be with the team during a home World Cup.

"I was aware that (if) I keep pushing myself I might get in-

jured for (a) long time. For me. that was never the answer. While I was pushing myself, I had this re-occurrence (of injury) and it became a three-month injury. I was not able to walk but I was trying to run (at) that point of time, Pandya recalled.

At that time, the 30-year-old was confident of coming back in five days, but the recuperation took much longer than he expected. "When I came out (of the field following injury), I informed team that I will be back in five days. I tried to push myself for 10 days, took pain-killers to make a comeback and rejoin the team. But this was a freak injury and very few people know about it. My injury got extended and I had to take more time because when I got injured, it was

a 25-day rehab injury," he added. Pandya said that not being able to play fully in the World Cup would always weigh heavily on his heart. "For me the biggest pride is to play for the country. This was my baby; playing the World Cup at home is my child. So, I wanted to be there for them (the team).

"Nonetheless, whether we win or not, all I wanted (was) to be there for my child. Obviously, I missed out and that is something which is always going to (be)

## Vinicius brace guides Real inch closer to title

Barcelona, March 17: Days after being targeted by racist taunts before games not even involving his team, Vinicius Junior scored twice to lead Spanish league leaders Real Madrid to a dominant 4-2 win at Osasuna Saturday.

Vinicius, who is Black, has endured racist insults during away games especially over the last two seasons. This week he was subjected to racist chants by groups of fans gathered outside the stadiums of Atletico Madrid and Barcelona before Champions League games.

Players wore T-shirts promoting a Spanish league anti-

racism campaign before kickoff for the day's games. Local media reports said some fans at El Sadar Stadium chanted "Die Vinicius" after he celebrated his second goal by holding a hand to his ear while facing the stands. The referee's report made no mention of any incidents involving fans.

Brazil forward Vinicius wa unfazed on the field in Pamplona, scoring Madrid's fourth-minute opener and adding a fourth goal to complete the rout. Dani Carvajal and Brahim Diaz also scored for the visitors, which picked apart Osasuna's high defensive line.



## Alcaraz ends Sinner streak

Indian Wells (California), March 17: Carlos Alcaraz defeated Jannik Sinner 1-6, 6-3, 6-2 to end the Italian's 19-match winning streak and advance to the BNP Paribas Open final Saturday night.

Alcaraz retained his World No.2 ranking with the victory and extended his winning streak to 11 matches at Indian Wells, where he'll play either Tommy Paul or Daniil Medvedev in

Sunday's title match. Sinner led 2-1 in the first set when the match was suspended for more than three hours because of rain in the Southern California desert. Rain also affected the women's semifinals Friday night.

Sinner went on to dominate the first set before Alcaraz changed his tactics. The Spaniard started

ing Sinner up and back. Sinner could have knocked Alcaraz out of the second spot with a win. He had won 19 matches in a row dating to last year, including 16 straight this year.

Alcaraz earned the only break of the second set in the fourth game with a forehand drop volley winner. He faced a break point on his serve in the seventh game, but shook it off eventually served out the set.

Alcaraz broke Sinner in the third and fifth games of the third. The players were blasting the ball from both sides and attacking the net, which made for several entertaining and sharply angled volley exchanges

Alcaraz led 40-love on his serve for his first match point when he netted a backhand. Sinner's smash dashed Alcaraz's second match point before the Spaniard closed it out with a forehand crosscourt winner. The batter landed in Mumbai Sunday, and he is expected to join the RCB training camp soon.

## Gulveer shatters 16-year-old NR in 10000m

New Delhi: Asian Games bronze medallist athlete Gulveer Singh shattered a 16-yearold national record (NR) in the men's 10000m to finish second in his heat at The Ten in San Juan Capistrano in California. The 25-year-old clocked 27.41.81 Saturday to better the earlier national mark of 28:02.89 by over 20 seconds that stood in Surendra Singh's name since 2008. However, Gulveer's effort was not enough for Olympic qualification as he missed the Paris Games qualification time of 27:00.00 by over 41 seconds.

## India rope in Dutch goalkeeping coach

New Delhi: India have roped in Dutch goalkeeping expert Dennis van de Pol to aid the men's hockey team's preparations for the Paris Olympics. A well-known hockey goalkeeping coach, Van de Pol has been working with the Indian goalies for nearly four years now, with his first stint in 2019. He will join the ongoing national coaching camp at the Kalinga Stadium in Bhubaneswar, where he will work closely with PR Sreejesh, Krishan Pathak and Suraj Karkera. The 10-day special goalkeeping camp, overseen by chief coach Craig Fulton, will end March 26, a week before the team leaves for the Australia tour.

## Manchester City march into FA Cup semifinals

of sixth-place Manchester United and both have 10 matches remaining. The Premier League looks increasingly likely to have five berths in next season's expanded Champions League because of the strong showing of English teams in European competition this campaign.
