AAP leaders' day-long fast protesting Kejriwal arrest

New Delhi, April 7: Top AAP leaders held a day-long fast at Jantar Mantar here Sunday to protest against Delhi Chief Minister Arvind Kejriwal's arrest by the ED and asserted that people will give a fitting reply to the BJP in the upcoming Lok Sabha polls for

sending him to jail. Scores of volunteers and supporters of the Aam Aadmi Party (AAP) took part in the fast, singing patriotic songs and carrying posters bearing an image of Kejriwal behind bars.

Similar protests were held in other states as well as by Indians abroad, including at the Harvard Square in Boston, the Hollywood Sign in Los Angeles, outside the Indian embassy in Washington DC, at the Times Square in New York and in Toronto, London and Melbourne, among other places, AAP leaders said.

Gopal Rai, the convenor of the party's Delhi unit, asserted that Kejriwal will come out of jail and join the country's fight against the dictatorship of the ruling Bharatiya Janata Party (BJP) at the Centre.

The stage in which the AAP leaders were seated during the six-hour fast had an image of Kejriwal behind bars in the backdrop. Portraits of BR Ambedkar and Bhagat Singh flanking Mahatma Gandhi's photo were kept in front of the stage.

Addressing the protesters at Jantar Mantar, the AAP's Rajya Sabha MP Sanjay Singh, who was recently granted bail by the Supreme Court in the Delhi excise scam case, asserted that Kejriwal was, is and will remain honest.

Delhi minister Atishi accused the BJP of resorting to dictatorship and claimed that the fast will give sleepless nights to the saffron party. She said there is anger among people over Kejriwal's arrest and it will prove to be the final nail in the coffin of the BJP. Chief Minister Bhagwant Mann and several of his cabinet colleagues in the AAP-ruled Punjab observed a fast at Bhagat Singh's village, Khatkar Kalan.



New Delhi, April 7: In a concerning development, at least four rivers flowing through southern Odisha have no water at present according to data released by the Central Water Commission. With the mercury soaring high right from the beginning of summer, this acquires much importance as far as availability of water is concerned. Data released by the Central Water Commission reveal that rivers between Mahanadi and Pennar basins that flow through Andhra Pradesh, Telangana and Odisha have no water at present. Rushikulya, Bahuda, Vamsadhara, and Nagavali in Odisha, apart from Sarada, Varaha, Tandava, Eluru, Gundlakamma, Tammileru,



Musi, Paleru and Manneru rivers Experts blame reduced monsoon

this year, having a 100 per cent departure with respect to an average of ten years.

The east flowing rivers between Pennar and Kanyakumari are also deficit and have just 12 per cent storage and a departure of over 50 per cent with respect to an average of ten years.

The data, issued April 4, presents a stark comparison to the same period last year, highlighting a substantial decline in available water resources.

Nitin Bassi from the Council on Energy, Environment and Water (CEEW) said their analysis of the Mahanadi river basin has suggested adoption of micro irrigation systems and altering cropping patterns could reduce the water deficit from 24 per cent (in a business-as-usual scenario) to about 18 per cent of the water supply requirement.

The Central Water Commission (CWC) has detailed the state of water storage in reservoirs, noting that live storchanging rainfall patterns, catchment degradation and groundwater depletion

Live storage capacity of reservoirs across the country has dwindled to just 35 per cent of the total capacity

age capacity has dwindled to just 35 per cent of the total capacity. The reservoirs in Andhra Pradesh, Telangana, Karnataka, Kerala, and Tamil Nadu are experiencing a significant drop in storage levels, currently at only 20 per cent of their total capacity.

According to the data, the east flowing rivers between Mahanadi and Pennar had zero storage total live storage capacity of 150 monitored reservoirs in India amounts to 178.784 billion cubic metres (BCM), which accounts for about 69.35 per cent of the estimated total capacity of 257.812 BCM across the country.

However, the actual live storage available in these reservoirs stands at a mere 61.801 BCM, representing only 35 per cent of their total capacity.

Himanshu Thakkar, coordinator of SANDRP, highlighted multiple reasons for the decline in reservoir water levels, including reduced monsoon rainfall, changing rainfall patterns, degradation of catchment areas and groundwater depletion.

2 UNDERTRIALS ESCAPE FROM 19 cats 'dominate' Mexico's presidential palace

Mexico City, April 7: They prowl through palace gardens stalking pigeons and make cameos on televised press briefings. Some greet tourists at the doors, while others take a sneaky lick of ice cream from staff.

Nineteen feral cats have free rein of Mexico's National Palace. long roaming the lush gardens



and historic colonial halls of the most iconic buildings in the country. "They have access to every part of the palace, so they walk in on meetings, interviews and wander onto camera," said Jesús Arias, the palace veterinarian, as a handful of feline friends brush against his ankles. Now, the palace cats have made

hiss-tory after the government of Mexican President Andrés Manuel López Obrador declared

them to be "living fixed assets," the first animals in Mexico to receive the title.

The investment term "fixed assets" usually applies to buildings and furniture, but by applying it to cats, López Obrador's government has obligated the country's Treasury to give them food and care for them for the rest of their lives, even after the leader leaves office in October. "The cats are now a symbol of the National Palace. Just as we understand this world, I wouldn't understand the National Palace without the presence of these cats," said Adriana Castillo Román, general director of the National Palace and Cultural Heritage Conservancy. "We have to make sure the cats are taken care of."

Nestled in the heart of Mexico City, the presidential palace has long been the seat of Mexico's executive branch. Now the residence of López Obrador, it is built upon the former palace of Indigenous Emperor Moctezuma. Ironically, Moctezuma's ancient Aztec culture honoured not cats. but hairless dogs known as Xoloitzcuintle, who were even buried with their masters.

But these days, López Obrador is accompanied by Bowie, Bellof, Nube, Coco, Yema, Ollin, Balam and more, who seem to have found a purr-fect home in the building. López Obrador himself has said the cats "dominate" the palace and often walk in front of him during official ceremonies.

Staffers say they remember the feral cats living among the cacti and dense brush of the gardens as far back as 50 vears ago.

But it's unclear when they first appeared or how they even got into the building. While 19 live in the building full time, many more come and go, and staff suspect they slip under a small crack in the palace gate by night.

One cat named Zeus, who has since passed away, even became famous in July when he meandered into the president's morning press briefing. The gray cat stood in front of cameras and wandered among reporters until palace staff had to carry him off. Neither Bowie, Coco or Ollin commented when asked how they feel about being living fixed

assets. Coco swished his tail, while Ollin stretched out below a palace pillar and fell asleep. "Meow," responded Nube, a

gray cat named after the Spanish word for "cloud", who enjoys greeting visitors at the door of the palace.



The Lok Sabha and the Assembly elections in Odisha will be held simultaneously.

The ruling party had won 113 of the 147 assembly seats five years ago.

Bhubaneswar, April 7: Forest department officials have busted an inter-state wildlife smuggling racket in Gajapati district and arrested seven persons of the gang.

The officials seized skins of five leopards, one fishing cat and one leopard cat along with a huge quantity of pangolin scales from their possession, the Principal Chief Conservator of Forests (PCCF) Wildlife, Susanta Nanda, said in a post on X.

Meta, owner of Facebook and Instagram, said Fridav it would start putting "Made with AI labels" on AI-generated content in May. AI presents a huge business opportunity for content creators: The influencer market is expected to grow rapidly, from \$16.5 billion in 2022 to nearly \$200 billion by 2032, according to Allied Market Research.

Using virtual influencers not new:

Barbie already has millions of followers on Instagram. But they are now being used in advertisements where they can't be told apart from a real person.

Take Lil Miquela, a "19-yearold Robot living in LA" created by a California agency in 2016.

With 2.6 million followers on Instagram and 3.5 million on TikTok, Lil Maqueta has promoted brands as big as BMW.

The idea was to "create something never seen before," the German premium carmaker said in a statement to AFP.

"Attracting a younger, technology-savvy generation is for us the icing on the cake," it said.

Maud Lejeune, who heads up the Paris-based digital strategy

agency AD Crew, said that it isn't difficult for the public to accept AI influencers.

'It's like actors on TV: we know it isn't real vet we follow them and we find it interesting, it's like watching a mini-series.

AD Crew represents more than 30 influencers, but Lejeune created her own virtual influencer, Metagaya, two years ago.

'The current level of design didn't exist then. It's technical,

you've got to dress them, take photos for the background, create a story," said Lejeune, acknowledging that Metagaya didn't turn out very well.

The rapid technological progress brought by the likes of OpenAI's Sora video generator could make it easier to create and operate realistic virtual influencers.

Deepfakes

Human influencers are also seizing on AI technology to make better videos. France's Charles Sterlings sees an opportunity to improve translations.

He uses different tools on platforms like HeyGen and Rask.ai to automatically translate and lipsync his video posts into English

and Spanish. Sterlings also uses Deepshot, a platform that allows users to create deepfakes by changing the words and mouth movement of people in real videos.

He said it took him just a few minutes and a few dollars to manipulate a video of French President Emmanuel Macron.

But Sterlings sees the technology as a competitor as well as a useful tool

"Anyone with a phone can be an influencer. But eventually, it will be artificial intelligence, available 24 hours a day, and much cheaper to develop," he said. For Maud Lejeune, AI can help influencers produce more content.

"It's tough to put yourself in front of the camera for a long time and certain creators burn out... Maybe AI will provide a new way to create without exposing oneself," she said.

The Clueless has no qualms about its AI models taking away business from real influencers.

"We don't foresee real models becoming obsolete or replaced by AI-generated models like Aitana. They can coexist as another competition of the industry said Novales.

Patient treated for GI bleeding at KIMS

Bhubaneswar, April 7: The Kalinga Institute of Medical Sciences (KIMS) successfully treated a woman suffering from severe gastrointestinal (GI) problem post-surgery by administering Hemospray Powder (HP).

The application of the Endoscopic Hemospray yielded instantaneous results, allowing the patient to be discharged from the ICU the following day.

It was India's second-ever HP treatment, considered as groundbreaking advancement in medical science, capable of halting GI bleeding within ten minutes and reducing the mortality rates.

Researchers warn of extreme heat impact on outdoor workers

According to the study, the world is edging closer to breaching the

A s the country braces for extreme heat in the April-June period with the temperatures already starting to rise, researchers have sounded the alarm over detrimental effects it can have on outdoor workers in farming, construction and other sectors.

The India Meteorological Department recently said abovenormal maximum temperatures were likely over most parts of the country in April-June this year, and the central and western peninsular parts are expected to face the worst impact. Abovenormal heatwave days are likely over most parts of the plains, it said.

Following the adverse weather warning, researchers are advocating for novel ways of working outdoors, including flexible hours and mandatory breaks, to help workers adapt to the effects of heat, made increasingly humid because of climate change.

"Dry heat is relatively easier to handle. When the body heats up and we drink water, there is evaporation and the body cools down. However, in humid heat, evaporation reduces because of high moisture in the air which hampers the body's cooling mechanism," Vimal Mishra, Vikram Sarabhai Chair Professor, Civil Engineering and Earth Sciences, IIT Gandhinagar, told PTI.

"Doing intensive labour in such conditions can raise body heat to a level where it can also cause mortality," he warned. An international study examining how tropical heat impacts outdoor workers has found that for one degree Celsius of

The study, co-led by the USbased Paul G Allen Family Foundation, was published in the journal One Earth in March 2024. According to the study, the world is edging closer to breaching the temperature goals of the Paris Agreement, with heat and humidity levels in the tropics having been studied to be closer than ever to human tolerance thresholds.

The increasingly humid heat is likely to affect outdoor workers in Africa and Asia the most because of their large workingage populations, likely to rise in coming decades, coupled with high reliance on agriculture, forestry and fisheries, the authors said.

Another study, conducted in Tamil Nadu and published in October last year, found that occupational exposure to extreme heat more than doubled the risk of miscarriage in pregnant women, with the heat generally raising the overall risk of adverse pregnancy and birth outcomes.

"We also observed that because of limited access to toilets, the women were eating and drinking less, resulting in malnutrition. This too can impact pregnancy outcomes," Vidhya Venugopal, the study's corresponding author and professor at the Faculty of Public Health of the Sri Ramachandra Institute of Higher Education and Research in Chennai, told PTI. The study assessed 800 pregnant women, 47 per cent of whom were exposed to heat while working outdoors.

Among the women exposed to extreme heat, 6.1 per cent had still and preterm births, compared to 2.6 per cent of the women exposed to heat within safe limits, it said.

Further, 8.4 per cent of the women exposed to high heat levels birthed babies having low weight, compared to 4.5 per cent of the women exposed to safe levels of heat, the "first-of-itskind" study to be conducted in India found. It is published in the British Journal of Obstetrics and Gynaecology.

"Biologically, the external heat adds to the internal heat generated in pregnant women because of hormones. So, when these women sweat in the heat, the blood flow rushes more towards their organs, which lowers the amount flowing towards the foetus, thereby hindering their growth and development," Venugopal said.

Acute drinking water crisis hits Keonjhar



Laying of pipelines for transportation of iron ore has damaged pipes supplying water, allege locals

Keonjhar, April 7: Drinking water supply to this town has suffered severe disruption for the last couple of days. This has happened as the pipelines supplying water suffered damages while a trench was being dug up, sources informed Sunday. More than 50,000 people living in Ward Nos nine, 10, 11, 12, 13, 14, 15, 16, 17 and 18 Keonjhargarh under Municipality have been severely hit. With no signs of the heat decreasing, the acute drinking water crisis has made the lives of the people living in the above mentioned wards miserable. Sources said that a private

agency is involved in digging up a trench for construction of slurry pipelines. The pipelines are being laid adjacent to NH-20 and will run through the Sadar and Ghatagaon blocks in this district. The mindless digging of the trench has also led to destruction of forest cover on large tracts of land posing serious

threats to wildlife. This development has sparked resentment and anger among the residents. Locals blamed hasty implementation of work for the acute water crisis. They alleged that the pipelines have suffered damages due to the digging of the trench in a haphazard manner. They alleged that the construction agency is flouting norms as the Public Health Engineering department (PHED) is taking no steps

against it. Former Keonjhar MLA Subarna Naik alleged that despite damage to the water pipelines the administration is not showing any urgency or taking action to reduce the pain of the people. He added that this proves that the district administration has tacit understanding with the construction agency. Sources added that for construction of any pipeline, prior permission has to be taken from the PHED.

Narad Rath, general manager WATCO said 'the pipes got ruptured due to the reckless attitude of the agency. "However, efforts are being made to normalise supply of drinking water to the affected wards," Rath informed. He assured that proper water supply will be restored by Monday.

Residents have demanded strict action against the construction company and to stop them from continuing with the work. They said earlier also there were allegations against the same company for allegedly laying pipes on routes frequented by animals.

Even though pits were dug up and the pipes were laid, the soil was not levelled properly. As a result, the pits have become dangerous for animals when they move. There is always the chance of animals suffering injuries if they fall into

the pits, locals pointed out. Local residents also added that the digging up of land and laying of the pipelines are being done in a rough and shoddy manner. They pointed out that a large number of trees have been felled in the Naranpur and Atei protected forest ranges. People have expressed resentment over the development as the interests of the agency and the mining firm have been given preference

over the protection of wildlife.

Jumbo death: Experts demand DNA test

Keonjhar, April 7: The recov erv of the decomposed carcass of an elephant from Chamakpur reserve forest of Balibandh forest section under Champua forest range in Keonjhar district has kicked off a controversy.

Keonjhar Divisional Forest Officer (DFO) Dhanraj HD said that the carcass was that of an old elephant which died due to age related ailments and other natural reasons. The deceased jumbo was with the herd at the time of its death. while its tusks have been recovered, the DFO said.

It was revealed that the animal was lying dead for a long time, but the Forest department discovered it late. The Forest department seized the bones and skin of the elephant. Later, a joint task force accompanied by Keonjhar DFO conducted a probe into its death.

The death of the animal has resulted in a controversy re-



garding the actual reason behind and its age at the time of death. A joint task force has gone to the scene and conducted an investigation. It is feared that efforts are being made to suppress the matter as the Forest department has not blamed anyone or taken any action in this regard so far.

Moreover, while no ivory was found during the recovery of carcass Saturday, the Forest department claimed to have recovered the tusks, Sunday. The department also claimed the deceased animal to be a female elephant.

This has given rise to doubts among wildlife experts regarding the cause of death and gender of the deceased elephant.

Wildlife expert Shubhendu Mallik said, "Looking at the elephant's molted skeleton and the cavity in its mouth, it is assumed

to be a male elephant that died about a month back.' A discussion with various ex-

perts and comparing the photos it is assumed to be a male elephant. So if the DNA test of the elephant's skeleton and teeth are done, the truth will be known, he said.

He further questioned that the Forest department regularly monitors the movement of the elephants by tracking them and submits reports to their higher authorities. "How could they fail to know that the elephant was missing for almost a month as well as its gender," he asked.

He suspected that the tracking reporting is going in pen and papers and many such elephants might have gone missing or have died in Keonjhar forest, but the Forest department is yet to know about, he said.

'The whole issue will come to light if the DNA test report of tusk is compared with the DNA test report of old female carcass," he added.

Boasting Bore

efence Minister Rajnath Singh's latest remarks may be perceived as India's acknowledgment of assassinations by its intelligence operatives on foreign soil. "If any terrorist from a neighbouring country tries to disturb India or carry out terrorist activities here, he will be given a fitting reply. If he escapes to Pakistan we will go to Pakistan and kill him there," Singh said in an interview to News18 television channel. This comes at a time when Canada and even the US have accused Indian agents of carrying out extrajudicial killings or attempts to murder in those countries.

Rajnath's comments came in the wake of a report published in UK-based The Guardian newspaper that has claimed that the Indian government has ordered at least 20 killings in Pakistan since 2020 as part of a wider strategy to eliminate terrorists living on foreign soil. The Guardian interviewed both Indian and Pakistani intelligence operatives and accessed documents shared by Pakistani investigators for the report. Citing sources within the Indian intelligence community, the report stated that there was a change in the strategy towards targeting terrorists in Pakistan in 2019. This shift supposedly occurred following the Pulwama attack, where members of the Pakistan-based terrorist outfit Jaish-e-Mohammed killed 40 Indian paramilitary personnel in Kashmir. At that time, Prime Minister Narendra Modi was seeking a second term in office. Indian intelligence officials claimed that their country had taken cues from intelligence agencies like the Mossad of Israel and events such as the assassination of Saudi journalist Jamal Khashoggi in the Saudi embassy in Istanbul in 2018, according to the report. On the other hand, officials from two different Pakistani intelligence agencies provided detailed evidence of investigations into seven killings allegedly carried out by the Research and Analysis Wing (RAW), India's secret service agency. They also expressed suspicions of India's involvement in as many as 20 deaths.

India faced accusations from both Washington and Ottawa regarding its alleged involvement in the killing of Khalistani activist Hardeep Singh Nijjar in Canada and a botched assassination attempt on another Khalistani activist Gurpatwant Singh Pannun in the United States last vear. The Indian Ministry of External Affairs (MEA) in its response to both the US and Canada had lame refutations of the allegations

Following The Guardian report, MEA has denied India's involvement in the killings in Pakistan. The allegations are "false and malicious anti-India propaganda," the MEA told The Guardian in response to the report. The ministry also highlighted an earlier statement by EAM S Jaishankar in which he said that targeted killings in other countries were "not the policy of the government of India."

In light of this, Rajnath Singh's remarks appear to be contradicting the MEA and the EAM. The Defence Minister and many others in his government may be obsessed with the "ghar mein ghus kar maarengey" rhetoric and such language may be appealing to their vote-bank in the election season, but this needless boasting may not be appreciated by other countries across the world and can potentially damage India's foreign relations.

A perfect example of this, which I have noted previously, occurred in late August 2023, when a priest known as "Father Anthony" ceremoniously doused holy water on a 26-foot-tall statue of Stalin in Russia's Pskov region. Though the Church had suffered during the Stalin era, he explained, "thanks to this we have lots of new Russian martyrs and confessors to whom we now pray and are helping us in our Motherland's resurgence." This logic is just a step away from claiming that Jews should thank Hitler for creating the conditions that allowed for the State of Israel. If that sounds hyperbolic, or like a bad joke, consider that some Zionist extremists close to the Israeli government openly advocate exactly this position.

To understand the success of such perverted argumentation, we should first note that, in developed countries, unrest and revolts tend to explode when poverty has ebbed. The protests of the 1960s-from the soixantehuitards in France to the hippies and Yippies in the United States - unfolded during the golden age of the welfare state. When people are living well, they come to desire even more.

One must also account for the surplus enjoyment that social and moral perversion can bring. Consider the Islamic State's recent attack on Crocus City Hall in Moscow, in which 144 people were killed. What some call a terrorist attack oth-

ers call an act of armed resistance in response to the massive destruction wrought by the Russian military in Syria. But whatever the case, something notable happened after the attack: Russian security forces not only admitted to torturing the suspects whom they had arrested; they publicly displayed it.

"In a graphic video posted on Telegram," writes Julia Davis of the Center for European Policy Analysis, "one of the detained had his ear cut off and was then forced to eat it by one of his interrogators." No wonder some Israeli hardliners look to Russia as a model for dealing with arrested Hamas members. Russian officials did it not just to deter potential future attackers, but also to give pleasure to fellow members of the tribe. "I never expected this from myself," writes Margarita Simonyan, a Russian propagandist who heads the stateowned media outlet RT, "but when I see how they are brought into the court crooked, and even

this ear, I feel extremely satisfied." Nor is this phenomenon confined to Russia. In Tennessee, some lawmakers want to restore public hangings (from trees, no less) for those who receive the death penalty.

Where do such acts end? Why not just bring back the premodern practice of publicly torturing alleged criminals to death? More to the point, how can "normal" people be brought to the point where they would enjoy such sadistic spectacles?

The short answer is that it requires the unique power of some kind of mythic discourse, religion, or poetry. As the reluctant Nazi fellow-traveler Ernst Jünger explained, "Any power struggle is preceded by a verification of images and iconoclasm. This is why we need poets - they initiate the overthrow, even that of titans.'

One finds poetry playing an important role in Israel. On 26 March, Haaretz ran a story explaining "how Israel's army

uses revenge poetry to boost morale." An anthology published by the Israel Defense Forces includes poems that "express a desire for vengeance and paint the combat in Gaza as a religious war." In a 13 October announcement soliciting submissions, the IDF invited potential contributors "to embark on a poetic journey and reignite the great Israeli spirit," so as to "raise the spirit in wartime."

Apparently, Israeli Prime Minister Binyamin Netanyahu's references to Amalek (the Jews biblical enemy in the Torah) after 7 October were not enough. They needed to be supplemented by modern verse. Or perhaps Netanyahu's biblical reference conveyed more than he wanted to say. After all, according to the Old Testament, when the wandering Jews reached the hills above the valley in Judea where the Amalekites lived, Jehovah appeared and ordered Joshua to kill them all, including their children and animals. If that is not "ethnic cleansing," the term has no meaning at all.

It is worth remembering that Germany was known as the land of Dichter und Denker (poets and thinkers), before its turn toward Richter und Henker (judges and executioners). But what if the two versions are more similar than they appear? If our world is gradually becoming a world of poets and executioners, we will need more judges and thinkers to counter the new tendency and regain our moral footing.

Pawar, Uddhav fighting for political survival

Mumbai. April 7: As the campaign for the Lok Sabha elections gathers momentum, Sharad Pawar and Uddhav Thackeray, the leaders of two prominent regional parties in Maharashtra, are fighting a battle for political survival

The polls are also an acid test for Chief Minister Eknath Shinde and his deputy and NCP chief Ajit Pawar as they have cast their lots with the Bharatiya Janata Party (BJP) by splitting their respective parties.

But the challenge is tougher for Thackeray and Sharad Pawar as they are out of power and have lost control of their parties -- Shiv Sena and Nationalist Congress Party (NCP), respectively -- along with the original name and electoral symbol.

The Election Commission and the Maharashtra assembly Speaker have recognised the Aiit Pawar-led NCP and Shinde-led Sena as the real NCP and the real Shiv Sena. Senior journalist and political analyst Prakash Akolkar said that both the leaders need to put up an impressive performance in the polls, or else they risk political extinction

"Uddhav Thackeray needs to get at least six to seven MPs elected to keep his flock together till the assembly polls which are due later this year," Akolkar said. Thackeray had to contest as many Lok Sabha seats as his party contested when he was a BJP ally in 2019, and he is doing just that, declaring 21 candidates so far notwithstanding the Congress staking claim to some of these seats, the senior journalist noted.

The NCP (Sharadchandra Pawar) is contesting 10 seats as

Indore, April 7: Eight persons allegedly suffered from side-effects after cataract surgery at a hospital in Indore last month, prompting the local administration to seal the medical facility's operation theatre and launch a probe into the matter, officials said Sunday.

It is difficult to say whether these patients have lost their evesight or not and things will be clear after the investigation, they said. A managing trustee of the hospital, however said there was no negligence and claimed the eight patients had a "reaction" in their eves due to unknown reasons and all of them were discharged after treatment.

The local administration has constituted a three-member committee which has started the probe into the reasons for the side-effects suffered by the patients, District Blindness Control Society manager Dr Pradeep Goyal said.

The cataract surgeries were carried out on 79 patients at government expenses March 20 at the Choithram Netralaya here in

Madhya Pradesh under the National Programme for Control of Blindness, he said.

After the surgeries, the health department got information through the hospital management about side-effects on the eves of eight of these patients. he said."It is very difficult to tell right now whether the eight patients who underwent the cataract surgery have lost their evesight or not. The situation will become clear only after the investigation is completed," the official said

The hospital's operation theatre where the cataract surgeries were performed on these patients has been sealed, he said. Ashwini Verma, a managing trustee of the Choithram Nethralaya, claimed there was no negligence at the hospital level in the cataract operation

The ashram is now home to_ children between the ages of six and 16 years, some of whom are enrolled in a day school nearby while the rest are taught at the ashram itself. For an all-round development, the timetable at the ashram has been designed to include yoga, pranayam, voluntary labour and sports, apart from regular classes, which are run by socially conscious teacher, who offer their services for free. The couple kept up their efforts even during the COVID-19 pandemic by starting 'shala baherchi shala' for the children of sugarcane cutters."There are many drawbacks in our education system. Modern technology has forced children to depend on bookish knowledge. It is necessary to teach them skills and make them self-reliant," he said

Pune, April 7: The sitars and tanpuras of Miraj, a small town in Maharashtra's Sangli district known for its craftsmanship in making musical instruments, have been awarded the coveted Geographical Indication (GI) tags.

These instruments made in Miraj are much in demand among some of the prominent artistes, including those renowned in the field of classical music as well as film industry, the makers claim. The GI tag denotes the product comes from a particular geographical area, and often enhances its commercial value.

The tradition of making sitars

and tanpuras in Miraj goes back more than 300 years, with over seven generations of craftsmen having worked towards making these string instruments, the makers say

March 30, the government of India's intellectual property office issued GI tag to the Miraj Musical Instruments Cluster for its sitars and to the Soultune Musical Instrument Producer firm for tanpuras. The Miraj Musical Instruments Cluster functions as the apex body for both the sitar and tanpura makers in the town, its chairman Mohsin Mirajkar said.

As part of the body, more than 450 craftsmen are engaged in the production of musical instruments, including sitars and tanpuras, he said. The sitars and tanpuras made in Miraj have a high demand, which cannot be met due to the limited resources available locally. Hence instruments from many other parts of the country are often sold under the guise of being Mirajmade, he claimed.

"When we started receiving complaints about such products, we decided to pursue for the GI tag and applied for it in 2021," said



Mirajkar. The wood for making the sitars and tanpuras is procured from forests in Karnataka, while pumpkin gourds are sourced from Mangalvedha region of Maharashtra's Solapur district. he said

"In a month, the cluster manufactures 60 to 70 sitars and around 100 tanpuras," stated Miraikar."The online business accounts for around 10 per cent, while 30 to 40 per cent comes from the retail music instrument shops and the remaining 50 per cent are direct customers, including some well-known artistes," he said.

The clientele includes yesteryear classical singers and founders of the Kirana gharana, such as Ustad Abdul Karim Khan Saheb, late Pandit Bhimsen Joshi, and Rashid Khan, who recently passed away, he claimed. Artistes like Shubha Mudgal and singers from the film industry, such as Javed Ali, Hariharan, Sonu Nigam and A R Rahman have used instruments made in Miraj, he added.

On the origin of the art of making sitars, tanpuras and other musical instruments in Miraj, he said, "During the Adilshahi period, king Adil Shah sent skilled workers to Miraj to craft the dome of a dargah. These workers were originally trained in weapon-making.'

"However, with the decline of battles during the British era, they transitioned to making musical instruments. The princely state of Miraj patronised this art, and we are the descendants of these skilled workers who continue this tradition," he said.

Speaking about the history of tanpura-making in the small Maharashtra town, Mirajkar recounted an incident from more than 200 years ago when a renowned classical singer visited Miraj and his tanpura developed a problem.

'Upon enquiring about a skilled worker who could fix the tanpura, he was directed to Patwardhan Sarkar of the Miraj Sansthan (part of the then princely state of Miraj). Two brothers, our ancestors, Farid Mohideen Saheb Shikalgar and Farid Saheb Shikalgar, who were skilled workers, were approached to fix the tanpura," he said.

"Despite being unfamiliar with the instrument, they attempted to repair it and succeeded so well that the classical singer praised their work, saving they had improved the tanpura," he added.

Mirajkar said he got to know

about the incident from his ancestors but nobody could recall the vocalist's name. After this, Patwardhan Sarkar

recognised the potential of these workers and decided to establish an industry for making instruments, providing patronage to the craft, Mirajkar said. The farming of pumpkin gourd, required for making sitars and tanpuras, was encouraged along the banks of the Krishna river, he said.

'Whenever classical artistes visited the sansthan, discussions were held on how sitars or tanpuras needed to be made according to their specifications, leading to improvements in the quality of the musical instruments," Mirajkar said.

Asked about how the GI tag will boost the manufacturing of sitars, tanpuras and other musical instruments in Miraj, Mirajkar said, "This will put Miraj on the global map, and the craftsmen will also gain recognition."

He said they also plan to establish a training and research centre for musical instrumentmaking. "Interested individu-+als can participate in the training programmes here," he added.





Lavrov to visit China

Scientists hope to learn a lot from rare total solar eclipse

RESEARCHERS ARE PARTICULARLY THRILLED ABOUT THE SUN BEING NEAR THE PEAK OF ITS **11-YEAR CYCLE**

Washington, April 7: When a rare total solar eclipse sweeps across North America on Monday, scientists will be able to gather invaluable data on everything from the Sun's atmosphere to strange animal behaviors -- and even possible effects on humans.

It comes with the Sun near the peak of its 11-year solar cycle, setting the stage for a breathtaking display: The corona will glow spectacularly from the Moon's silhouette along the path of totality, a corridor stretching from Mexico to Canada via the United States.

Total solar eclipses offer "incredible scientific opportunities, NASA Deputy Administrator Pam Melroy told a press conference this week about the celestial event.

The US space agency is one of the institutions at the ready for the eclipse, with plans to launch so-called "sounding rockets" to study the effects on Earth's upper atmosphere

Here is a look at what researchers are hoping to learn from the upcoming eclipse: SUN'S ATMOSPHERE

When the Moon passes directly in front of the Sun and blocks it, the elusive outermost edge of the Sun's atmosphere, or corona, will be visible "in a very special way," Melroy said.

"Things are happening with the corona that we don't fully understand," she said.

The heat within the corona intensifies with distance from the Sun's surface -- a counterintuitive phenomenon that scientists struggle to fully comprehend or explain.

Solar flares, a sudden explosion of energy that releases radiation into space, take place in the corona as do solar prominences. enormous plasma formations that loop out from the Sun's surface.



The total eclipse also will afford scientists a chance to study changes in part of the Earth's upper atmosphere known as the ionosphere, important because it affects radio waves used for communication and navigation. "Disturbances in this laver can

cause issues with GPS and communications," said Kelly Korreck, the eclipse program manager at NASA headquarters

The ionosphere, which is where Earth's atmosphere meets space, is affected by the ADMINISTRATOR. Sun, which electrically charges the particles

there during the day. NASA's three sounding rockets will be launched before, during and just after the eclipse

changes.

The major decrease in sunlight provoked by the eclipse -more rapid and localized than a simple sunset -- should allow researchers to learn more about how light affects the ionosphere so they can better predict potential problematic disruptions. **ANIMAL BEHAVIORS**

Startling animal behavior has been noted during eclipses: Giraffes have been seen galloping, while roosters and crickets can start crowing and chirping. Beyond the drop in sunlight,

temperatures and wind -- conditions to which animals are sensitive -- can also decrease significantly

> during an eclipse. Andrew

Farnsworth, a researcher in ornithology at Cornell University in New York State, studies how

eclipses affect birds, using weather surveillance radar to detect birds in flight.

During the last total solar eclipse visible from the United States in August 2017, scientists observed a "decline in the number of animals flying around," Farnsworth told reporters.

The 2017 eclipse disrupted the daily activities of insects and birds, but did not trigger usual animal nocturnal behaviors such as birds migrating or bats emerging, the expert said.

This time around, birds might be more apt to migrate during the eclipse, given that it's in April, he said.

"These kinds of patterns they're important for understanding the ways animals perceive their worlds," Farnsworth said.

CITIZEN SCIENTISTS

About 40 citizen science projects are planned around the eclipse, from using a phone app to register the temperature and cloud cover to recording ambient noise during the event.

"Eclipses have a special power. They move people to feel a kind of reverence for the beauty of our universe," NASA Administrator Bill Nelson told reporters. "We encourage vou to help NASA

observe the sights and sounds

around you," Nelson said.

COMPENSATION OVER LNG SUPPLIES Former Gazprom unit rejects GAIL demand

New Delhi, April 7: A former unit of Russian energy giant Gazprom has rejected stateowned GAIL (India) Ltd's demand for compensation for non-delivery of LNG supplies in the aftermath of Russia's invasion of Ukraine.

In a stock exchange filing, GAIL said SEFE Marketing Trading Singapore Pte Ltd has stated that it does not owe anything other than the defaulted cargoes. GAIL in December last year filed an arbitration claim before the London Court of International Arbitration seeking \$1.8 billion for non-supply of LNG cargoes under a long-

term contract. This included compensation for non-supply besides making up for the defaulted volumes. GAIL in 2012 signed a 20-year deal to buy as much as 2.85 million tonnes per annum of liquefied natural gas (LNG) with Russian energy giant Gazprom. The deal was signed with Gazprom Marketing and Singapore (GMTS), which at the time was a unit of Gazprom Germania, now called Sefe. The Russian parent gave up ownership of Sefe after Western sanc-

tions were imposed on Moscow

over its invasion of Ukraine in

2022. Sefe had stopped supplying LNG to the Indian company in

June 2022 to meet its own demand. The German government acquired Sefe after the start of the Ukraine war in February 2022 and prohibited it from taking volumes from Russia. Supplies were resumed in March last year.

GAIL in December stated that it has sued "SEFE Marketing & Trading Singapore Pte Ltd (erstwhile Gazprom Marketing and Trading Singapore Pte Ltd)" and has sought "up to USD 1.817 billion and alternative relief including non-monetary reliefs". Originally, GAIL had signed up with the German subsidiary of Gazprom, and a step-down company based in Singapore for sourcing of gas. After the invasion, the German government took over the company and the supplies were hindered as the German government debarred the company from picking up any cargo from Russia

he Latin phrase "caveat emptor," meaning "let the buyer beware," is especially relevant when selecting a financial education programme for your teenagers.

As a parent, it is your responsibility to carefully consider which programme will shape your child's understanding of finances. This decision is crucial, as financial literacy is not a topic to be taken lightly. Your teenager's understanding of financial matters will impact many important aspects of their life.

Therefore, settling for a mediocre programme is not sufficient. You should strive for an exceptional programme that will provide your teen with the knowledge and skills they need to succeed. You don't want someone playing fast and loose with the foundations and principles of smart money management and investing. The programme you choose needs: i) To have been



and be better for it; ii) To go far beyond just building awareness to focusing on the implementation of the learning; iii) To challenge your teenager to think differently and then act in accordance with their beliefs; iv) To be trusted that there will be no hidden commercial agendas your son or daughter will be subject to.

There's been a lot of talk about the net effectiveness of financial education programmes,

which, according to some studies, is marginal, if non-existent. Frankly, that's not surprising. If you take a look at the way many financial education programmes are run, in terms of the content they cover and their delivery process, it's a far from surprising conclusion.

From simplistic perspectives and volunteer staff who aren't trained to teach teenagers to shameless product pushing and content that is commercially coloured, there is a lot to beware of. Caveat emptor!

Then there is the actual content, which is tedious, uninteresting and mainly taught as a maths-based skill.

Personal finance isn't a mathsbased skill; it has much to do with mindset, attitude and behaviour. Yet, behavioural finance and an understanding of the interplay of various socio-economic factors are not covered. Caveat emptor!

Parents should be especially aware of financial education programmes delivered by financial institutions.

There's nothing wrong with financial institutions sponsoring financial education programmes in schools and colleges; that might be a solution to the budgetary issue most schools claim to have when faced with teaching this subject on their own.

The problem arises when these financial institutions flog their own "bespoke curriculum", highlighting their products and services targeted at teenagers. One solution would be to have financial education programmes curated and delivered by a vetted independent third party of trained and trusted experts.

This would ensure that the students get the benefit of the programmes without being subject to implicit or explicit marketing messages. It would also ensure a quality standard and unbiased content.

Financial education, and more importantly financial empowerment, isn't just a score on a "three-question quiz"

While that might be a basic measure, it does not even begin to cover what we need our teenagers to know, understand and use about money.

Especially in today's time, our definition of what constitutes a financial education needs to change dramatically - it needs to provide our teenagers with deep insights, an evolved understanding and a higher consciousness about money. Mumbai register first win in this year's IPL with fine all-round show



Tokyo, April 7: Triple World Champion Max Verstappen 🦉 romped to victory at the Japanese Grand Prix here Sunday leading teammate Sergio Perez to a dominant one-two finish for Red Bull.

Verstappen failed to finish in Australia a fortnight ago but he was in control for the entire race at the 'Suzuka' circuit here after starting from pole and claimed his third win from four Grands Prix this season. The Dutchman finished 12.535 seconds ahead of the Mexican Perez, who came home in front of Ferrari's Carlos

Sainz in dry, sunny conditions. Verstappen said 'the critical bit was the start, to stay ahead'. "After that, the car just got better and better. Everything just went very well. It couldn't have been any better," the Dutchman added.

Sainz, who triumphed in Australia, took third ahead of Ferrari teammate Charles Leclerc, who started from eighth on the grid. McLaren's Lando Norris, second in last year's race,
