Tattoos banned for SSB personnel

Bhubaneswar: The Odisha Police have asked its Special Security Battalion (SSB) personnel to remove tattoos on their bodies within 15 days as these skin markings are easily noticeable with uniform and considered 'obscene and derogatory'. The deputy commissioner of police (security), Bhubaneswar issued an order to this effect Tuesday and asked all officials concerned to prepare a list of SSB men having "easily noticeable tattoos" on their bodies. SSB personnel provide security coverage to vital installations like the Chief Minister's residence, Raj Bhawan, Secretariat, Odisha Legislative **P**3 Assembly and the High Court.

Privatising Sainik Schools: Kharge writes to President

New Delhi, April 10: Congress president Mallikarjun Kharge Wednesday wrote to President Droupadi Murmu against the Centre's move to 'privatise' Sainik Schools, and demanded a complete rollback of the policy and the annulment of agreements signed in this regard.

Kharge said there are 33 Sainik schools in the country and they were fully government-funded institutions operated under the aegis of Sainik Schools Society (SSS), an autonomous body under the Ministry of Defence (MoD).

In a two-page letter to the President, Kharge said Indian democracy has conventionally kept armed forces away from any partisan politics, but the Union government has "broken" this well-enshrined convention. "Having undermined institutions after institutions, in the grand plan of RSS to hurriedly thrust its ideology, they have dealt a body blow to the very nature and ethos of the Armed Forces," he said. Imparting ideologically slanted knowledge in such institutions shall not only destroy inclusiveness but also damage the national character of the Sainik Schools, by influencing their character through partisan religious/corporate/family/social/cultural credos, he added.

Cuttack, April 10: In a fresh blow to Congress leader Mohammed Moquim, the Orissa High Court Wednesday dismissed a plea challenging his conviction by a Vigilance court in connection with the ORHDC corruption case. Justice Bibhu Prasad Routray

upheld the judgement of the Special Vigilance Court of Bhubaneswar that held Moquim, the Managing Director of M/s. Metro Builders Private Limited, guilty under Sections 120B, 468,



471 and 420 of the IPC and 13(2) r/w 13(1)(d) of Prevention of Corruption Act, 1988 September 29, 2022, according to senior standing counsel Srimanta Das and standing counsel Sanjaya Kumar Das.

Moquim and ORHDC top official Vinod Kumar were convicted and sentenced to undergo RI for three years and to pay fine of ₹50,000 each by the Vigilance court.

"In default of payment of the fine, Moquim would undergo further RI for six months for obtaining pecuniary advantage in favour of M/s. Metro Builders Private Limited under the guise of loans meant for the rural poor from the ORHDC," the Vigilance court had ruled.

Moquim, however, moved the High Court challenging the conviction. The High Court judgement

came as a severe jolt to Moquim ahead of the upcoming elections as he is likely to be re-nominated by the Congress to contest the Barabati-Cuttack Assembly seat.

The HC had in the first week of March this year nullified the election of Moquim from the Assembly constituency.

While upholding the conviction of the lower court, Justice Routray observed that 'there is sufficient evidence available on record against Moquim for his active role in getting the loan sanctioned in favour of the company'.

"It is further indicated from the evidence that the appellant, along with other co-accused persons, intentionally and knowingly used a series of forged documents to get the loan sanctioned in favour of the accused company without any justification,' the court observed, while dismissing the plea.

Jeypore, April 10: Three people were killed and four others sustained severe injuries in collision between two bikes near Gagnapur under Jeypore Sadar police limits in Koraput district, late Tuesday night.

The deceased were identified as Padman Harijan of Dhanapur village, Gopal Harijan of Jayantgiri and Durjya Keuta of Sanamundapadar village in the area.

The police, with the help of locals, rushed the injured bikers to the district headquarters hospital at Jeypore, IIC of Jeypore Sadar police station Ishwar Tandi said. However, doctors pronounced three of them dead. Four injured bikers are being treated at the hospital, the IIC added. Later, police seized the two motorcycles and launched an investigation.

Police said three persons were on their way to Dhanapur from Jeypore on a motorcycle. In the meantime, four persons on another bike were also travelling Dhanapur from to Sanamundapadar area.

However, the two vehicles collided with each other at Gagnapur resulting in the death of three persons and injuries to four others.

Washington, April 10: It may surprise you but true. A woman from US who described herself as a former 'cat burglar' has broken into more than 200 homes and decamped with over \$7 million (Rs 58,22,71,550). Jennifer Gomez recently appeared on 'Locked In with Ian Bick' – a podcast - and revealed details of her modus operandi, the 'New York Post' reported.

'Cat burglars', as the name suggests, are essentially thieves who are adept at entering and leaving the burglarised place without attracting notice.

Gomez, who was in prison be-

They were warned that if the order was not implemented, necessary departmental actions would be initiated against those who would not follow the directive.

parency in poll campaigning. The poll authority said the decision was taken after representations were received stating that in hoarding spaces controlled by municipal authorities, hoardings without the identity of the printer or publisher have been noticed.

The Aam Aadmi Party had also approached the EC on the issue recently.

The EC also drew attention to the instructions issued by the Municipal Corporation of Delhi earlier this month to all its licensees and contractors regarding political advertisements on outdoor media of the body.

New Delhi, April 10: Around 50.56 per cent of the sanctioned posts in 28 state pollution control boards, including Odisha State Pollution Board (58 per cent), and eight pollution control committees are vacant, according to Central government data.

The data is part of a report submitted to the National Green Tribunal Tuesday.

India's Central Pollution Control Board (CPCB) report revealed that 6,075 (50.56 per cent) of the 12,016 sanctioned posts in 28 state pollution control boards and eight pollution control committees are vacant.

The Bihar State Pollution Control Board has the maximum vacancy, with 209 (84 per cent) of the 249 posts unoccupied. In Jharkhand, 198 (73 per cent)

Odisha State Pollution Control Board has 58% positions unoccupied

of the 271 posts are vacant.

Delhi, which grapples with hazardous air pollution levels every winter, has 153 (44 per cent) vacancies against its 344 sanctioned posts. The Delhi Pollution Control Committee has, however, engaged 111 contractual employees

Cong forms 59-member India ranks 2nd in hepatitis B, C cases after China: WHO campaign committee

Bhubaneswar, April 10: The All India Congress Committee (AICC) has constituted a 59-member campaign committee for its Odisha unit for the upcoming polls in the state. ndia accounted for the second-highest number of cases of hepatitis B and C in 2022 after China, with 3.5 crore infections, according to a report by the World Health Organisation (WHO).

Hepatitis is an inflammation of the liver that can cause a range of health problems and can be fatal.

According to the WHO's 2024 Global Hepatitis Report released Tuesday, 254 million people lived with hepatitis B and 50 million with hepatitis C in 2022 globally.

India, which was second only to China in the viral hepatitis burden, registered 2.98 crore hepatitis B cases in 2022 while the number of hepatitis C infections stood at 55 lakh.

China registered 8.3 crore cases of hepatitis B and C, representing 27.5 per cent of the total disease burden.

The report said that with a



total of 3.5 crore cases, India accounted for 11.6 per cent of the total disease burden globally

that year. There are five main strains of the hepatitis virus, referred to as types A, B, C, D and E. While they all cause liver disease, they differ in important ways including modes of transmission, severity of the illness, geo-

graphical distribution and prevention methods.

In particular, types B and C lead to chronic disease in hundreds of millions of people and together are the most common cause of liver cirrhosis, liver cancer and viral hepatitis-related deaths.

The WHO Tuesday flagged that the number of lives lost

due to viral hepatitis is increasing with the disease being the second leading infectious cause of death globally - with 1.3 million deaths per year - the same as tuberculosis.

The WHO report said new data from 187 countries show that the estimated number of deaths from

viral hepatitis increased from 1.1 million in 2019 to 1.3 million in 2022. Of these, 83 per cent were caused by hepatitis B and 17 per cent by hepatitis C.

'Every day, there are 3,500 people dying globally due to hepatitis B and C infections," the report released at the World Hepatitis Summit said.

"This report paints a troubling picture: despite progress globally in preventing hepatitis infections, deaths are rising because far too few people with hepatitis are being diagnosed and treated," said WHO Director-General Dr Tedros Adhanom Ghebrevesus.

"WHO is committed to supporting countries to use all the

tools at their disposal - at access prices - to save lives and turn this trend around," it said. According to the report, half the burden of chronic hepatitis

B and C infections is among peo-

ple 30-54 years old, with 12 per cent among children under 18 years of age. Men account for 58 per cent of all cases. Apart from talking about

global progress and gaps in diagnosis and treatment, the WHO 2024 Global Hepatitis Report also pointed out disparities in pricing and service delivery, and said, funding remains a challenge.

The report outlined a series of actions to advance a public health approach to viral hepatitis, designed to accelerate progress towards ending the epidemic by 2030.

These include: expanding access to testing and diagnostics; shifting from policies to implementation for equitable treatment; strengthening primary care prevention efforts: using improved data for action; andengaging affected communities and civil society among others.

responders". This means not everyone loses as much weight as the average, and some don't lose weight at all. For some people, the side-effects will outweigh the benefits.

When people are on drugs like Ozempic, their blood sugar is better controlled by enhancing the release of insulin and reducing the levels of another hormone called glucagon.

One study found an average

weight loss of more than 17 per cent after a year on Ozempic became an average net weight loss of 5.6 per cent more than two years after stopping treatment.

Short-term side effects of drugs like Ozempic include dizziness, nausea, vomiting and other gastrointestinal upsets.

For some people, using GLP-1-mimicking drugs like Ozempic will be validating and empowering. They will feel like their biology has been 'normalised' in the same way that blood pressure or cholesterol medication can return people to the "normal" range of measures.

But biologically, obesity isn't solely about GLP-1 activity with many other hormones, physical activity, and even our gut microbes involved

Overall, obesity is complex

and multifaceted. Obesity isn't just driven by personal biology and choice; it has social, cultural, political, environmental and economic determinants.

Obesity often co-exists with malnutrition. We try to separate the effects in research using statistics, but focusing on the benefits of weight-loss drugs without addressing the underlying malnutrition means we aren't likely to see the improved health outcomes in everyone who loses weight.

Even when it is well-intentioned, the rhetoric around the joy of "ending the obesity epidemic" can harm people. Obesity doesn't occur in isolation. It is people who are obese. And the celebration and hype of these weight-loss drugs can reinforce harmful fat stigma.

Rampant illegal mining funding poll expenses

Jajpur, April 10: Illegal mining of various minerals are growing rampant by the day in this district as the Lok Sabha and the Assembly elections approach. It has been alleged that illegal mining is being carried out to fund the campaigns of candidates belonging to various political parties including the ruling one.

This district has rich deposits of minor minerals like black stones, murrams, sand and laterite stones. More than a vear back. the Odisha government had transferred the management of minor minerals from the Revenue to the Mining department. Many alleged that since then illegal mining of these minerals have grown manifold.

The Mining department has leased out 35 of the 90 black stone quarries on lease. However, black stone is being extracted rampantly from the remaining 55 quarries. Also murram, sand and laterite stone quarries are being plundered on a regular basis. According to sources, all this is allegedly happening in connivance with officials of the Revenue and Mining departments and police.

Sources said that the



Dharmasala tehsil area is known as the storehouse of black stone. They alleged that more than 10,000 tonne of black stone are being smuggled from Aruha hill under this tensil on a daily basis. The miscreants are using sophisticated and high-powered equipment to extract black stone. Four concretebreaker machines and over 40 Hyva trucks are being used for mining and smuggling of stones. Sources added that a similar

modus operandi is being followed

at the Dankari, Rahadpur, Lunibar, Bichhakhandi and Anjira hills in the district

Experts observed that black stones worth ₹500 crore have been smuggled from these areas in the last 12 months. Satellite mapping of the areas will reveal the true picture, they said.

Sources pointed out that illegal mining and smuggling of murram are also taking place daily. A case in point is the 15 acres of government land provided to in-

dustrial firm 'VCI Chemical Industries Private Ltd' a few years back. However, the firm never set up its unit. Currently miscreants are smuggling murram from large areas of the land and smuggling it, sources added. They further said that murram worth ₹50 lakh has been smuggled and a major amount of the money is being used to fund the election expenses of some candidates

On being tipped off, officials of the Mining department inspected the land in question recently. However, the reason they gave for not taking any action is deplorable. They said that since the extraction and smuggling of murram happen during the night, they can't take any action.

Similarly it has been alleged that on an average 50 trucks of laterite stones are being smuggled from the district daily. The stone-laden trucks pass by the Bairi police station but the cops have so far not taken any action, sources said.

When contacted, Deputy Director Mines (DDM), Jayaprakash Nayak said that illegal quarries are being raided on a regular basis and fines are being collected. He however, could not throw any light as to when such activities will stop.

RDA employees suffer as salaries get delayed

Rourkela, April 10: Salaries of the employees of Rourkela Development Authority (RDA) for the month of March have been delayed due to transfer of an officer, sources stated here Wednesday. They said that employees are yet to receive their salaries as the signing authority, RDA secretary Chandrakant Mallick has been transferred on the orders of the Election Commission.

Employees on condition of anonymity pointed out that such a delay has never occurred earlier. Even though the first week of April has elapsed, employees are not sure when they will get their salaries for March. "Usually we get our salaries on the 1st of every month unless it is a Sunday or a public holiday. Then we get salaries on the 2nd of the month. This time however, everything has gone haywire," said an employee. After Mallick's transfer, asITT

sistant commissioner of Rourkela Municipal Corporation (RMC) Pallabini Nayak has been posted in his place with the additional charge of secretary, RDA. However, she has not been given any financial power or signing authority. "She (Pallabini) has been posted without any powers. Hence our salaries have been delayed, and we are not sure when we will get it as the Model Code of Conduct has come into force." said another employee.

We hope at least someone will notice our plight and do the needful. Or else we will go

without salaries for more than three months and it will be very difficult for us to manage things," informed another employee.

Due to the absence of a fulltime secretary in the RDA, other official matters are also getting delayed. Work like approval of plans, selling and purchasing of plots and transfer of ownerships have more or less stopped.

Unfortunately for the RDA following the transfer of Dolamani Kandher in 2004, the office never got a fulltime secretary. Following Kandher's transfer, the responsibilities associated with the post have always been entrusted to the additional district magistrate (ADM), Rourkela. Sources pointed out that in the absence of a full-time secretary, the RDA has failed to start any housing projects in the last 20 years. For its income, the RDA has to depend on rents and fees associated with various other types of work.

Koel Bridge turns game-changer for many

NEWLY-CONSTRUCTED BRIDGE CONTRIBUTES TO FINANCIAL DEVELOPMENT ON BOTH SIDES OF RIVER

Rourkela, April 10: The bridge over river Koel connecting Kuarmunda block on one side with Nuagaon block on the other, has indeed proved to be a gamechanger in the lives of people living on both sides. Since it was inaugurated in February 2016, the 'Koel Bridge' (sometimes also called 'Jhirpani Bridge') has indeed affected the lives of thousands in a very positive manner.

The bridge has helped in giving new dimensions and dynamics to business, means of livelihood and economic prosperity. Today, it has brought financial affluence to a large number of people and also created new business opportunities.

Let Polluters Pay

fter years of avoiding any explicit mention of the primary cause of climate change, negotiators at the United Nations Climate Change Conference (COP28) in Dubai last year finally reached an agreement calling for a "transition away from fossil fuels." But another uncomfortable question still looms large: How will that transition be financed? As Simon Stiell, the UN's climate chief, recently observed, "it's blazingly obvious that finance is the make-or-break factor in the world's climate fight.

Climate finance will be the single most important issue both at COP29 in Azerbaijan this year and at COP30 in Brazil in 2025. Notwithstanding recent pledges of money for a new "loss and damage" fund to help developing countries deal with climate change, current financing falls far short of what is required. The European Union estimates that it must invest €1.5 trillion (\$1.63 trillion) per year from 2031 to achieve net-zero emissions by 2050, and developing countries (excluding China) are expected to need \$2.4 trillion per year by 2030. Brazil alone will have to find an additional \$200 billion to reach its 2030 emissionsreduction goals.

There are no simple solutions. The sluggish growth and tight monetary conditions following the pandemic mean that even rich countries are operating with limited fiscal headroom. While more private capital is needed everywhere, its role will be smaller in low- and middle-income countries, owing to the significant premiums they face when borrowing for green projects.

Bold new policies are needed to mobilise public funding, and there is a strong case to be made for progressive taxes on carbonintensive activities and extreme wealth. Both would generate revenues while also extending the principle of "common but differentiated responsibility" to industries and individuals.

Taxation is the standard instrument for states to raise funds reliably and at scale, and thus to commit to long-term spending and investment plans. For developing countries, in particular, the predictability of taxes makes them more useful than concessional finance. Moreover, new taxes can unlock additional resources for countries to dedicate to climate-related investments, sparing them from having to reallocate scarce funding within existing budgets. Globally, a 0.1 per cent financialtransactions tax could raise up to \$418 billion per year, while a relatively modest

levy of \$5 per ton of carbon dioxide emissions could bring in \$210 billion per year.

The International Monetary Fund has long advocated taxes on CO2 emissions and fossil-fuel extraction, both as a source of climate finance and to shape incentives by ensuring that polluters pay. The extra revenue from such taxes would help high-income countries (the leading historical source of emissions) fulfill their moral obligations toward poorer, more vulnerable countries. As matters stand, rich countries' financial assistance for developing countries needs to be an order of magnitude greater than the current pledge of \$100 billion per year.

Pollution taxes would also help to redress inequalities within countries. Even in those economies with lower historical and per capita emissions, there is a significant gap between most of the population's emissions and the highest emitters. The economist Lucas Chancel finds that 'carbon inequality" is greater within countries than between them, and that it tracks inequalities in income and wealth. This should come as no surprise. Globally, the wealthiest 1 per cent emit the same as the poorest 66 per cent combined.

This injustice is not lost on ordinary citizens. In fact, it increasingly threatens our ability to build and sustain a political consensus for effective climate policies. Taxes to ensure that those with the greatest means and the highest emissions pay their fair share would go a long way toward convincing the public that a "just transition" is not just an empty slogan. But while the theoretical case for such taxes is strong, adoption and implementation has proven difficult. Capital, people (particularly the wealthy), and emissions all move easily across borders, undermining the efficacy of national or regional tax regimes. Though cross-border cooperation on taxation is never easy, an international agreement would give countries more leverage over their own resources, allowing them to protect those most in need. Multilateralism would be in every country's interest.

assets (working capital) is called 'advance' in banking parlance. Credit (loans and advances)

portfolio constitutes a predominant part of asset side of banks' balance sheets. Loans and advances ('loans' in short) are classified as standard assets or stressed assets in bank's books depending upon whether servicing of debt (interest and principal) is regular or irregular. Banks create provisions for their credit portfolio to cover the inherent risks. While general provision in small degree is earmarked for standard assets, banks create specific provision for stressed assets taking into account period of stress and availability of collateral securities. Provisions are created out of profit & loss (P&L) account and are shown on liability side of banks' balance sheets.

A loan account becomes eligible for write-off whenever the specific provision against it gets accumulated to 100% of outstanding after a certain number of years it has been irregular. In order to cleanse the balance sheet, the banks resort to removing the outstanding in a particular loan account from the asset side and the equivalent provision from the liability side of balance sheet. This is called given for financing of current write-off in accounting parl-

ance. P&L is charged at the time of creation of provision rather than at the time of write-off.

The writing-off of loan amounts from the balance sheet does not ipso facto absolve the concerned defaulters of their liabilities to repay. Such writtenoff amounts, where legal action has been initiated or is contemplated, are parked in a proforma account outside the balance sheet for recovery follow-up. Other written-off accounts, where legal action is not considered viable due to small outstanding or absence of collateral, are simply recorded in a kachcha (plain) register. But the dictum 'out of sight, out of mind' kicks in. As the outstanding amount moves out of balance sheet, there is a proclivity for slackness in the follow-up for recovery. More attention of the bankers is riveted to balance sheet credit portfolio to prevent further slippages. However, liability of defaulters in the written-off accounts continues unless dues are settled through compromise settlement or some other mechanism which necessitates waiver (haircut for bank). Once the bank concludes an outstanding to be irrecoverable, the entry is removed from the proforma account and

Movement to kachcha register is deemed to be virtual waiver. Defaulters, however, aren't given no-dues certificate by the lender unless there is complete liquidation or partial liquidation under settlement.

The amounts written off from the balance sheets by banks reflect principal amounts only. If a loan account remains irregular for more than 90 days, further application of interest in the borrowal account is stopped. In other words, booking of interest income is suspended when a loan account remains irregular for more than 90 days. From the beginning of stress in a loan account till it gets written off the entire process normally takes more than 3 years - there is no booking of interest income. That's why stressed assets are called non-performing assets (NPA) because there is no interest income earned from them. The interest income forgone doesn't reflect in the written-

off amounts. Therefore, the actual loss to the banks or the equivalent liability of the borrower is much higher than the figures of writeoffs The correct indicator of loss to bank in a written-off ac count will be the total of 'written-off outstanding' and the 'interest accrued but not applied'. Recovery, if any, in the writtenoff accounts is straight away income for the bank.

There is a need for evolving robust accounting principles for declaring the figures of 'interest accrued but not applied' and recovery amounts in written-off ac counts as annexures to the balance sheets of banks. Plugging of accounting loophole is the need of the hour for ensuring structured disclosure of accurate data on loss accruing to banks on account of stressed assets. The process of so-called cleansing of balance sheets through the convenient medium of writeoffs should be made more rigorous and transparent.

There are encouraging signs that the political taboo against taxation is weakening. The text agreed by all parties at COP28 explicitly called "for accelerating the ongoing establishment of new and innovative sources of finance, including taxation." And last November, UN member states passed a resolution to establish a Framework Convention on International Tax Cooperation, paving the way for a fairer approach to setting global rules.

Now, the G20, led by Brazil, is considering a global minimum tax on the world's 3,000 billionaires, who currently pay a much lower effective tax rate than the rest of the population. The EU Tax Observatory estimates that a 2 per cent annual levy on their wealth - if properly coordinated - could raise \$250 billion per year.

Capitalising on this momentum, a diverse group of countries has launched a new international tax taskforce. Chaired jointly by the leaders of Kenya, Barbados, and France, its mandate is to explore tax policies that could raise the equivalent of at least 0.1 per cent of global GDP to finance sustainable development and climate action. The point is not to prescribe a single solution for all countries, but rather to assess the political and technical obstacles to many plausible options, drawing on a diverse range of experts and perspectives.

Many options are on the table, including taxes on aviation and shipping, in addition to fossil-fuel extraction and financial transactions. The taskforce will seek to advance our understanding of how such taxes could be applied equitably, perhaps paving the way for an agreement on particular policies.

Fair taxation could be a powerful lever for accelerating a just transition. By contributing fresh empirical findings and fostering trust and cooperation between countries, the new taskforce can help everyone to address the injustices at the heart of the climate crisis and unlock the resources they need to address it. Elections divide families as fathers, sons take different political routes

for my son, but when people are asking me if they should cast their votes for my son, I am telling them yes," Suresh said. "Yes, I have told people to vote

for my son because they ask me what to do. If AICC or the PCC wants to punish me, I will accept it. But I will be a Congressman till my death,' Routray said. He further claimed that he is a man of principles.

"I have informed BJP state president Manmohan Samal about the activities of Bijoy. The party will soon take proper action against him," said Kishor Panda, president of the Kendrapara district unit of BJP. Senior BJP leader Baidyanath

Chatterjee said it is illegal to campaign for the BJD candidate, maybe his son since he (Bijoy) is still a member of the saffron party.

During the 2000 elections, Bijoy, one of the founders of the ruling party, was barred from contesting from the Patkura Assembly seat after the BJD denied him a party ticket at the very last moment.

Jual is a five-time MP from here. Had he not lost to former Odisha CM Hemanada Biswal in 2009 in a neck to neck race, the number would have been six. Hemananda had pooled 2,80,054 (36.47%) against Jual, who had garnered 2,68,430 votes (34.96%). BJD was not contesting then.

In 2014, Jual pooled 3,40,508 votes (33.69%) and found a formidable opposition in BJD's Dilip Tirkey, who got 3,21,679 votes (31.83%). Dilip was then considered by many as an 'also ran' candidate but the margin was only 18,829 votes. Post election, a jolted Jual grudgingly accepted, "The fight was very close and I never expected it to be so.'

In 2019, Jual got 5,00,056 votes (45.45%) and an astounding rise of 11.76% in his vote share. He almost steamrolled his opponent BJD's Sunita Biswal, who received 2,76,991 votes (25.18%), and the party's vote share fell by 6.65%. INC's George Tirkey polled 2,68,218 votes, (24.38%) with a very marginal fall of 2.30% in vote share. Political pundits say INC's vote share would have reduced by a lakh if George had not been the candidate.

Between Dilip and Jual, the public views the former as someone well-behaved, soft spoken and simple, while for Jual, it is "rude and clever enough to understand the TINA factor in favour of him." Apart from Dilip's personality,

the other factors that favour him are hockey, Christian votes and the indirect comeback of George Tirkey into BJD's fold. Dilip remained instrumental in the lay-

Reports said that the Palaspanga-Bamebari road, the lifeline of the mining area in Keonjhar district, is dilapidated due to lack of repair.

Traffic as well as pollution problems in the area have become acute due to bad road conditions. As a result, local people have been suffering immensely for past many years.

Even the three-km stretch of road from Palaspanga to Kandrapasi is not being repaired despite several protests. Residents of the panchayat, led by Sarpanch Ayodhya Naik, Monday met the District Collector and submitted a memorandum warning to boycott the upcoming polls if the road is not repaired immediately. They also demanded sprinkling of water on the road to prevent air pollution.

They alleged that many a time

trucks transporting minerals and other goods break down on the road, causing traffic snarls and accidents. Long queues of thousands of trucks standing on both sides of the road are a usual scene to behold here.

The mining and industrial companies had promised to sprinkle water daily on the road to prevent air and dust pollution during an agitation staged by locals October 19, last year. However, that did not happen as was promised, locals alleged.

Warning of intensifying their protest otherwise, they demanded to start work on the road and arrange for sprinkling of water on the road within 24 hours.

SDPO Mahendra Nath Murmu discussed with them and gave assurance that the problem will be resolved after the election while sprinkling of water will be arranged to control the pollution immediately.

Mayadhar Mohanta, former sarpanch of Kandarapasi panchayat, said they have been agitating for the last two years for repairing of the three-kilometer stretch but it is not being done. He said that if iron ore transportation is obstructed during the movement, the companies come and give false promises requesting to withdraw movement.

They promise that water will be sprinkled regularly until the road work is taken up. However,

The Aam Aadmi Party claimed Anand's resignation vindicated its stand that Chief Minister Arvind Kejriwal's arrest was aimed at finishing the party and accused the BJP of using the ED and the CBI to "break" its ministers and MLAs.

The BJP hit back, claiming the minister's resignation revealed AAP's "corrupt ways and how the entire party extorts like mafias"

AAP's Sanjay Singh said that although the resignation may demotivate some party workers, the Aam Aadmi Party will largely stand strong against attempts to break the organisation.

The latest setback to the party came a day after the Delhi High Court upheld Chief Minister Kejriwal's arrest by the Enforcement Directorate in a money laundering case linked to the now-scrapped Delhi

son behind the investigations and raids by ED is to destroy the AAP. BJP is a criminal party which has been doing this type of hooliganism," he alleged

In November last year, the Enforcement Directorate raided the premises of Anand and some others as part of a money laundering probe.

Anand, who is an MLA from the Patel Nagar, constituency, said that "if someone is feeling suffocated for a long time, then it becomes difficult" to continue in the party.

"But when High Court's decision came yesterday and what it said categorically, then it felt that somewhere our party was at fault," he said in a statement. The high court, in its order, had said the ED had "enough material" which led to Kejriwal's arrest, and the trial court remanded him in the custody of the agency by a well-reasoned order. 'From Jantar Mantar, Arvind Kejriwal had said that the country will change once politics changes. The politics hasn't

changed but the politician has changed," Anand told reporters. BJP national general secretary Tarun Chugh said the resignation shows "that people are feeling suffocated in the party (AAP) because they have institutionalised corruption".

"The AAP minister's resignation Wednesday has revealed the party's corrupt ways. It is now clear how the entire party extorts like mafia and how they spent in the Goa elections... It is unfortunate how the people who wanted to bring change have now become 'the mother of corruption'," he alleged.

Delhi minister Saurabh Bharadwaj claimed that Anand may have been threatened to quit AAP.

'Time and again we said that the intention behind arresting Arvind Kejriwal was to break the party and governments of Delhi and Punjab. Many of our colleagues will feel that we hate Raaj Kumar (Anand) and will call him dishonest and cheater. We will not say any such thing"

"Not everyone is Sanjay Singh. I believe that he was scared, Bharadwaj said.

Singh said that earlier the BJP used to call Anand corrupt 'when a raid was conducted against him by the Enforcement Directorate (ED) but now the party will welcome him into its fold with garlands".

Nearly 200 babies born in shelters for displaced in Manipur

India expands strategic presence

THE VIOLENCE DISPLACED THOUSANDS, WITH OFFICIALS SAYING MORE THAN 50,000 PEOPLE ARE LIVING IN CAMPS FOLLOWING THE UNREST

Imphal, April 10: Cradling her baby born in a shelter for the displaced in Manipur, Hatneu says she has named her daughter Nganthoibi which aptly means shining light.

Dispelling some of the darkness of 11 months of conflict and continuing uncertainty, Nganthoibi is one of the 200 babies born to displaced women who have taken shelter in different relief camps across the state. For the women like Hatneu, the last months have been unforgettable. Not just because their lives were upended when violence broke out in Manipur last year in May but because they welcomed their newborns. "When I held my twins in my

arms, all my miseries melted away," a 26-year-old woman at a

relief camp in Kakching district told PTI, requesting not to be identified or photographed.

Her twin boys are now four months old. "When they grow up, I will tell them these stories.'

"This is an unforgettable period for me for a different reason and I want to remember it as such years later. I don't want any memory of this period to haunt my children when they grow up," she said. When she landed at the relief camp, she knew it was going to be very tough.

"Pregnancy is a period when we are told to take extra care of ourselves, not do any heavy-lifting, not take stress, and eat well. However, for me, this period was all about survival.

Hatneu, who found shelter at a camp in Churachandpur, the epicentre of the violence then, ran a bamboo goods shop in



Imphal Valley. "I am a Kuki but I have always lived in the Valley only. We were forced to relocate here due to circumstances. Last month I gave birth to my baby at a nearby health facility. I have named my baby girl Nganthoibi, which means shining light," she said. Hatneu said at least 15 babies have been born in her camp. PTI visited six relief camps in

the Meiti-dominated Imphal Valley and Kuki-zo-dominated

Churachandpur district. According to official estimates, at least 200 children were born in the six camps. Over 280 relief camps are operational across the state. The hill state has witnessed sporadic, sometimes intense, ethnic clashes since May 3 last year between the majority Meitei community and Kukis, resulting in loss of over 200 lives. While Meiteis population is concentrated in Imphal city, Kukis have shifted to the hills.

The violence displaced thousands of people, with officials saying more than 50,000 people are living in camps following the unrest. Ngahjemkim, who is also in a camp in Churachanpur, said she wants to remember this period for the gift she got in her baby. "Despite all odds, my daughter was born here and is healthy today. At a time when I thought none of us would survive... this seems like a miracle," she said.

Lu Lamva Ngahjemkim was eight months pregnant when the clashes broke out. She and her family landed at a relief camp in Churachandpur.

Among the women counting their blessings in form of their newborns at the relief camps are four who gave birth to twins. A dedicated camp set up for pregnant women in Imphal Valley

saw the birth of 168 babies.

The facility, which was opened May 21 last year, hosted 164 women, who were brought there from different relief camps around the state. The camp wound up in February when no pregnant women were found in the relief camps in the valley. As Manipur goes through a

period of uncertainty, there is an anti-poll sentiment in the state among the displaced. But the elections for the two Lok Sabha seats in Manipur have been announced alongside the general elections.

They will be held in Manipur in two phases April 19 and 26. While Inner Manipur and some segments of Outer Manipur will vote in the first phase April 19, the remaining segments of Outer Manipur will vote in Phase 2 April 26.

Council (ECOSOC) held elections to fill vacancies in 17 of its subsidiary bodies Tuesday. These vacancies were filled through election by acclamation, secret ballot and nomination.

"Today, a significant triumph for India at the UN, clinching a prestigious re-election to the International Narcotics Control Board for 2025-2030 and earning seats across several key UN bodies," the Permanent Mission of India to the UN said on X.

"India will continue, as always, to actively contribute towards deliberations in these bodies in keeping with our overall philosophy of 'Vasudaiva Kutumbakam'," the Indian Mission said.

The 54-member **ECOSOC** is one of the six main organs of the **United Nations and** deals with economic, social, cultural and health matters as well as human rights and fundamental freedoms

However, the dangers of inaction are significant, particularly benefitting Iran, a regional actor seeking to exploit Washington's reluctance or withdrawal. The ongoing quagmire in the Middle East presents Iran with an opportunity to weaken Israel, a longstanding adversary, and diminish US influence in the region.



Iran's Islamic regime aimed to inspire copycat religious uprisings after its own 1979 revolution, and to many observers, it may appear to have failed. Indeed, the conventional wisdom in Washington and elsewhere has often held that Iran has become contained, even isolated. But this was never true. Instead, Tehran developed a calculated strategy to empower proxy militias and to influence operations in its neighbourhood while maintaining plausible deniabilitya scheme whose canniness was vindicated by the devastating scope of Hamas' assault and subsequent attacks by Iranianaffiliated militias in Iraq, Lebanon, and Yemen.

The post-October 7 strategic landscape in the Middle East is one that was largely created by Iran and that plays to its strengths. Tehran sees opportunity in chaos. Iranian leaders are exploiting and escalating the war in Gaza to elevate their regime's stature, weaken and delegitimise Israel, undermine US interests, and further shape the regional order in their favour. The truth is that the Islamic Republic is now in a better position than ever to dominate the Middle East, including by attaining the ability to disrupt shipping at multiple critical chokepoints.

Left unchecked, the dramatic expansion of Iran's influence would have a catastrophic impact on Israel, the wider region, and the global economy. To disrupt this amplification of Iranian power, Biden urgently needs to articulate and then implement a clear strategy to protect Palestinian civilians from bearing the brunt of Israel's military operations, counter Iran's corrosive war-by-proxy strategy, and blunt the capabilities of Tehran's accomplices. Achieving these goals will require a tricky set of moves by Washington, and Americans are weary of the military, economic, and human toll of their country's commitments in the Middle East. But no world

power other than the United States has the military and diplomatic capacity to frustrate Iran's most destructive ambitions by managing the spiraling conflict between Israel and Hamas and containing its most devastating long-term consequences.

In a sense, Iran now has the default advantage over the United States because it does not actually have to achieve anything material in the near term. Chaos itself will constitute a victory. By contrast, the bar for US success is high. Like it or not, however, the United States remains an indispensable player in the region despite its dubious record over the past several decades. Standing by its allies-and safeguarding access to oil that remains vital to the world economy-with a delicate balance of support and restraint requires commitment. Several US presidents hoped to downsize America's role in the Middle East on the cheap—in Biden's case, to focus on China's challenge and Russia's growing threat. Icra downgrades banking sector outlook

Mumbai, April 10: Domestic rating agency Icra Wednesday revised downwards its outlook for the banking sector to 'stable from 'positive' on expectations of moderation in credit growth and profitability.

The agency said the credit growth will moderate to 11.6-12.5 per cent in FY25 from 16.3 per cent (excluding the impact of the HDFC twins merger) in FY24,



while the lower net interest income margins on higher deposit rate payouts will lead to a dip in profits.

On the asset quality front, it expects a further moderation in the gross non-performing assets ratio for the banking system at 2.2 per cent by March 2025 from 3 per cent likely in March 2024, its vice president Sachin Sachdeva told reporters.

This will be the lowest level since September 2011, Sachdeva added. Unsecured retail advances and loans to non-bank finance companies will slow

down in FY25, leading to a dip in the overall non-food credit growth in the system, the agency said.

The RBI's curbs on unsecured lending by way of increasing the risk weights in November

have already led to a reduction in the incremental disbursements of such loans to over 23 per cent from 29.4 per cent earlier, it pointed out.

However, challenges on deposit mobilisation will continue in FY25, and banks will have to hike deposit rates to attract the funds, the agency said, adding that the credit deposit ratio, which has reportedly come under the regulatory gaze lately, will continue to be elevated at over 80 per cent.

The agency said it expects a "convergence" between credit and deposit growth in FY25, which will be helpful for the system, given the four percentage point gap that exists at present.

The share of the low-cost current and savings account deposits will also moderate as customers continue preferring the higher-yielding term deposits. This will put pressure on the net interest margins (NIMs) for banks, it added.

A growth in operating expenses will also hurt the profits, it noted.

Alibaba's Jack Ma steps out from shadows

Shanghai: Alibaba co-founder Jack Ma has penned a lengthy memo to employees that expresses support for the internet giant's restructuring efforts, a rare move from the billionaire after spending the last few years out of the spotlight. Alibaba's Hong Kong-listed shares surged 5% after the post. The post, made in an internal company forum, comes one year after Alibaba announced its decision to split into six units - the biggest shake-up in its 25-year history. It has had a tumultuous time since then, installing a new CEO, announcing and then abandoning the listings of its cloud and logistics units. At the same time, it has lost



ground in e-commerce to low-cost rivals such as PDD Holdings and ByteDance-owned Douyin, the Chinese version of TikTok. "We must not only have the courage to admit and correct yesterday's problems in a timely manner but also make reforms for the future," he said in the post.

China rejects Fitch Ratings downgrade

Bangkok: China's Finance Ministry denounced a report by Fitch Ratings that kept its sovereign debt rated at A+ but downgraded its outlook to negative, saying Wednesday that China's deficit is at a moderate and reasonable level and risks are under control. Risks to China's public finances are rising, Fitch said,

as Beijing works to resolve mounting local and regional government debts and to shift away from heavy reliance on its troubled property industry to drive economic growth. But while slower growth is adding to the challenges of coping with heavy borrowing, Fitch said it kept China's A+ rating due to its "large and diversified economy's," vital role in global trade and its huge foreign exchange reserves. The Finance Ministry said it was a "pity" that Fitch had downgraded its sovereign debt and faulted its methods, saying it had failed to take into account Beijing's moves toward "appropriately intensifying, improving quality and efficiency" of its government spending.

American Hikaru Nakamura was the other winner on the day against Firouza Alireza of France while Indian teen R Praggnanandhaa played out a draw with overnight sole leader Nepomniachtchi. Vidit Gujrathi also put an end to his losses by settling for a draw with Caruana.

Praggnanandhaa and Nakamura share the fourth spot with 2.5 points followed closely by Gujrathi on two points. Alireza and Abasov share the last position on 1.5 points apiece.

In the Women's competition, nothing changed in terms of standings with all the four games ending in draws. Praggnanandhaa's sister R Vaishali could not dent the

defenses of Anna Muzychuk and Koneru Humpy recovered with a draw against Aleksandra Goryachkina of Russia.

Madrid, April 10: Three goals in the first 14 minutes. Backand-forth attacking. Stunning second-half strikes. It was an instant classic between the newest Champions League rivals, with Real Madrid and Manchester City drawing 3-3 in a frantic first leg of the quarterfinals Tuesday.

Federico Valverde scored a 79th-minute equaliser for Madrid after City had rallied with Phil Foden and Josko Gvardiol scoring goals five minutes apart midway through the second half at the Santiago Bernabeu Stadium. The second leg will be next Wednesday in Manchester.

Bernardo Silva had put City ahead two minutes into the match,

but Madrid rallied with an owngoal by City defender Ruben Dias in the 12th and a score by forward Rodrygo in the 14th.

It is the third consecutive encounter between the clubs in the knockout stages of the Champions League. Madrid eliminated City in the semifinals in 2022, while City got the best of Madrid at the same stage last year. Both teams went on to win the title after eliminating their rivals.

The match at the Bernabeu went on as scheduled despite of a possible terror threat by the Islamic State, with no security incidents being immediately reported.

The result extended Madrid's 28-match unbeaten streak in all competitions, as well as City's 26-match unbeaten run across all tournaments. Defending cham-
