### **Heatwave: Schools** closed till April 20

### **Russian missiles** kill 17 in Ukraine

Kyiv: Three Russian missiles slammed into a downtown area of the northern Ukrainian city of Chernihiv Wednesday, hitting an eight-floor apartment building and killing at least 17 people, authorities said. At least 61 people, including two children, were wounded in the morning attack, Ukrainian emergency services said. Chernihiv lies about 150 km north of the capital, Kyiv, near the border with Russia and Belarus.

### 10 killed as car rams into truck in Gujarat

Nadiad: As many as 10 persons travelling in a car died after their speeding vehicle rammed into a truck on Ahmedabad-Vadodara Expresswav near this town of Gujarat's Kheda district Wednesday, police officials said. "The car was going towards Ahmedabad from Vadodara when it rammed into the rear side of the truck on the expressway. While eight people died on the spot, two injured persons, who were shifted to a nearby hospital in an ambulance, succumbed later," said inspector of Nadiad Rural police station Kirit Chaudharv.

Bhubaneswar, April 17: Gone are the days when political parties were considering the candidatures of leaders who have sacrificed a lot for the party and stood with the organisation during adversities. There is, however, a swift change in the scenario, if 2024 election is an indication. Ideology is put on the back burner insofar as the criteria for handing over tickets are concerned. Now, a candidate's power (both money and muscle) is



weighed before awarding tickets while turncoats are having a field day as part of revenge politics.

At a time when corporate financing of elections through electoral bonds has become the order of the day, what matters the most is performance in the battlefield. Electoral bonds scheme functions on the basis of quid pro quo relationship and companies dole out thousands of crores to various parties and expect favour from the party in power or to be in power.

Therefore, it may not be wrong

to say that corporate financing is a precursor to political parties becoming full-fledged corporate entities. Davs are not far when parties would turn into limited companies.

Parties and candidates calculate profit and loss while taking any significant decision without caring a fig for the ideology they have long cherished or their true role as people's leaders.

In Odisha, many retired bureaucrats, police officers, corporate honchos and industrialists have forayed into politics while film stars, who are no ensure that the party candidates come out with flying colours in the upcoming polls, Chief Minister Naveen Patnaik, while announcing the fifth list of Assembly candidates, revealed that he would also contest from Kantabanii under Bolangir Lok Sabha segment apart from Hinjili. He had also contested the 2019 polls from Hinjili in Ganjam and Bijepur in Bargarh.

The nine BJD candidates announced by Patnaik include six women and four turncoats. The party has dropped four sitting MLAs - Purna Chandra Baka (Chitrakonda), Kishore Chandra Naik (Kuchinda), Rajanikanta Singh (Angul) and Samir Ranjan Dash (Nimapara).

He has rewarded four turncoats. They are: Arundhati Devi (Deogarh), Dillip Kumar Nayak (Nimapara), Rajendra Chhatria (Kuchinda) and Laxmipriya Nayak (Chitrakonda). The six women candidates are: Laxmipriya,

Barsha Singh Bariha (Padampur), Arundhati Devi (Deogarh), Sanjukta Singh (Angul), Sulakshana Gitanajali Devi (Samakhemundi) and Indira Nanda (Jeypore).

While denying party ticket to Angul MLA Rajanikanta Singh, BJD nominated his wife Sanjukta Singh from the same seat. Former minister and ex-MLA Rabi Nanda was also denied ticket while his wife Indira was picked for Jeypore seat. Patnaik also nominated S Gitanajali Devi, daughter of former MLA Nandini Devi in Sanakhemundi.

Patnaik also swapped the candidatures of Rohit Pujari and Prasanna Acharva, Acharva will now contest from Rairakhol and Pujari from Sambalpur.

## **SOREN** ED nabs 4 more over LINK money laundering

Ranchi, April 17: Enforcement Directorate (ED) has made four fresh arrests in connection with the alleged illegal land grablinked money laundering case against former Jharkhand chief minister Hemant Soren and others, official sources said Wednesday.

Those taken into custody under the provisions of Prevention of Money Laundering Act (PMLA) have been identified as Antu Tirkey, Priya Ranjan Sahay, Bipin Singh and Irshad, they said

The ED had Tuesday conducted searches at the premises of Tirkey and some others here and the four were arrested following their questioning.

Tirkey is allegedly linked to Soren while Singh is a real estate businessman. Sahay 'forged' some land-related documents along with others, according to the chargesheet filed in the case.

With these arrests, the total number of people taken into custody in this case has risen to eight. Soren, 48, was arrested by ED in January shortly after he resigned as the CM of Jharkhand. He is currently lodged in Birsa Munda jail at Hotwar here under judicial cus-

tody. The probe against Soren pertains to an 8.86-acre plot of land in Ranchi that the ED has alleged was illegally acquired.

## India's population crosses 144cr; 24% children PRESS TRUST OF INDIA

New Delhi, April 17: India's population is estimated to have reached 144 crore, with 24 per cent in the 0-14 age bracket, according to a report by United Nations Population Fund (UNFPA). The UNFPA State of World Population - 2024 report, 'Interwoven Lives. Threads of Hope: Ending Inequalities in Sexual and Reproductive Health and Rights', revealed that India's population is estimated to double in 77 years

India leads globally with an estimated population of 144.17 crore, followed by China at 142.5 crore, said the report. India's population was

recorded at 121 crore during the last census, conducted in 2011



The report further detailed that an estimated 24 per cent of India's population is aged 0-14 while 17 per cent is within the 10-19 age range.

The segment aged 10-24 is estimated to constitute 26 per cent, with the 15-64 age group making up 68 per cent. Additionally, 7 per cent of India's population is aged 65 years and above, with men having a life expectancy of 71 years and women 74 years. The report has found that 30

years of progress in sexual and reproductive health has mostly

According to the report, the child marriage percentage in India was at 23 between 2006 and 2023. The report noted that maternal deaths in India have fallen considerably, accounting for 8 per cent of all such fatalities worldwide.

'India's success is often attributed to improved access to affordable, quality maternal health services as well as efforts to address the impact of gender discrimination on health outcomes," the report said. However, the report noted that India continues to see dramatic inequities in maternal death risk

The report said millions of women and girls remain far behind, and progress is slowing or  $\rightarrow$ stalled on key measures -- 800 women die every day giving birth, unchanged since 2016.

The report noted that women with disabilities are up to 10 times more likely to experiencegender-based violence than their peers without disabilities.







Bhubaneswar, April 17: Entire Odisha reeled under intense heatwave conditions, with the temperature touching 40 degrees Celsius in at least 30 places of the state Wednesday.

Talcher in Angul district recorded the state's highest temperature of 43.2 degrees Celsius while the mercury crossed the 41 degrees Celsius-mark for the first time this summer at twin cities of Bhubaneswar and Cuttack during the day, according to a bulletin of IMD's regional centre here.

### SRC's working hour ban goes for a toss



The site, initially built in 1908 to construct and maintain steam locomotives, started its new life in munitions after being purchased by the US government in 1953.

Back then, it was used to make ammunition for use in the Korean War. Some of the manufacturing equipment in use today dates back nearly to that time. The buildings, listed on the National Register of Historic Places, are hardly the picture of 21st-century high-tech efficiency. There is no computeraided automated production here. AI? Forget about it.

The red-hot steel tubes, just formed in three successive forges, are cooling for three hours in



racks hanging from a conveyor belt in the factory's basement, before the next phase of production.

The basement is a maze of dark nooks and crannies -- lit up from time to time by flame or searing metal.

Visitors have to pay close attention not to tumble into disused pits or trip on narrow staircases. all while enduring deafening noise - despite earplugs - and the smell of hot steel.

The tubes are then treated in a variety of ways -- heat, ultrasound, polishing and submersion in oil, among others -- to remove the tiniest flaw, inside and out, and identify any defects.

Measurements are checked from all angles several times, using tools that seem like they could be on display in a museum of antique hardware.

## WORLD HAEMOPHILIA DAY Gene therapy: A paradigm shift in haemophilia treatment

ene therapy offers hope of a cure to people with haemophilia, a hereditary blood disorder, where a person is born without one clotting factor in the blood, required for forming a blood clot, said doctors on World Haemophilia Day (WHD) Wednesday.

WHD is observed every year April 17 to raise awareness of the debilitating blood disorder, caused by missing or defective factor VIII (FVIII), a clotting protein.

The patients with haemophilia are unable to form a strong blood clot after injuries and they continue to bleed, raising the risk of death in severe cases. Even with a minor bleeding episode, haemophilia patients run the risk of joint damage, which can later lead to crippling and other

tor IX in haemophilia B. It's inherited in an X-linked recessive pattern, explaining its prevalence in males. Females can be carriers or experience milder symptoms due to their two X chromosomes," consultant general paediatrics, paediatric genetics and metabolic diseases specialist Tanmay Deshpande said.

Hence, understanding the genetic basis is vital for affected individuals and healthcare providers. Genetic counseling can help assess inheritance risk and inform reproductive decisions, the doctor said. According to data from

Haemophilia and Health Collective of North (HHCN), India is home to an estimated 1,36,000 people living with haemophilia A- the second largest globally. Of these, only 21,000 are registered at present.



About 80 per cent of haemophilia cases go undiagnosed in India as several hospitals and medical institutions lack screening capabilities for blood clotting, affecting the diagnosis of new cases.

"In the realm of haemophilia

treatment, gene therapy emerges as a tool with transformative potential," Tanmay said.

He explained that the therapy involves the precise delivery of functional genes to correct the underlying genetic defect responsible for deficient clotting factor production in patients.

With the help of viral vectors or other delivery systems. gene therapy aims to restore physiological balance and enable sustained production of clotting factors within the body," he added.

Recent clinical trials display encouraging outcomes, highlighting both the safety and efficacy of this approach. This includes the human clinical trial at the Christian Medical College (CMC) Vellore, a first for India. Scientists at the CMC deployed

a novel technology of using a lentiviral vector to express a FVIII transgene in the patient's haematopoietic stem cell which will then express FVIII from specific differentiated blood cells.

Currently, haemophilia can only be defeated by factor VIII infusions. Complications can be prevented if there is preventative administration of factor VIII, which is unfortunately very expensive for low and middleincome countries. However, gene therapy may help cure the disease.

"Gene therapy is a potentially curative treatment for haemophilia. It uses an adenovirus vector where the defective gene of a haemophilia patient is replaced by a functional gene. This treatment is not yet available in routine clinical practice even in Western countries,' Haematology senior consultant Anoop P said.

"Gene therapy enables editing the faulty gene of a baby, while inside the uterus, who is known to be born with haemophilia, because of strong family history," he added.

With ongoing research diving deep into optimisation and long-term effects, gene therapy promises a paradigm shift in the management and potentially the cure of haemophilia, the doctors said.

## Girl attempts suicide; succumbs to injuries

Berhampur, April 17: A girl who tried to die by suicide by jumping before a moving train succumbed to her injuries at the MKCG Medical College and Hospital here, late Tuesday night. The deceased was identified as Jenna Litikika of Krushna-chandrapur locality near Tekkali in Srikakulam district of Andhra Pradesh. She was a student of Plus II and was pursuing her education while staying at her uncle's house at Khajuria locality under Gosaninuagaon police limits here.

Officials said that she had jumped before the train wanting to end her life Tuesday morning Instead she suffered serious injuries after being hit by the train. She was rushed to the hospital, but succumbed to her injuries The uncle of the deceased Santosh Kumar Swain identified her in the presence of officials of the Government Railway Police (GRP) after which the body was sent for post-mortem. Police have lodged a case of unnatural death and have initiated a probe.

Environmentalist Bimbadhar Behera pointed out that mass poaching during 'Pana Sankranti' endangers the lives of wild animals to a great extent. He pointed out that the Forest department needs to conduct awareness programme before the 'Akhand Shikar' ritual to prevent poaching of animals. Moreover, Forest department officials should chalk out concrete plans to prevent the unnecessary slaughter of animals, Behera opined.

Bhakta Batshal Mohanty, another environmentalist lamented the unnecessary killing of animals. "Keonjhar town is surrounded by forests and hills where various species of wild

animals live. They frequently stray into human habitats in search of food and water. On many occasions animals are killed after they enter residential areas. The Forest department should give priority to the protection of these animals,"

Mohanty pointed out. The environmentalist also informed that a large number of Sal trees have been felled during 'Pana Sankranti'. "This should have been prevented at any cost as it is loss of forest cover." he opined.

Paralakhemundi, April 17: In a bid to promote the elections as a 'festival of democracy' among tribal people, the Gajapati district administration has adorned polling booths with 'Idital', a unique type of painting by the 'Souras'. The 'Souras' are classified as a particularly vulnerable tribal group (PVTG) in the state.

When people go to polling booths May 13 to cast their votes, they may find their own paintings in the polling stations," a senior official of the district administration said.

'Soura' and 'Lanjia Soura' communities traditionally adorn their homes and villages with such paintings during festivals and ceremonies, including marriages. Polling booths have been set up in schools in PVTG-inhabited areas. Additionally, the administration has also roped in



members of 'Soura' tribe to create awareness about voting by using tribal language This initiative is part of the



booths and increasing the turnout, an official said. "The aim behind setting up of the ethnic booths is to attract tribals, who seldom exercise their franchise and remain busy with their routine work, to vote," said Birendra Kumar Das, Additional District Magistrate-cum-Returning Officer, Mohana Assembly constituency.

Most of the 'Soura' and 'Lanjia Soura' people live in Mohana and Gumma blocks of Gajapati district. There are approximately 33,000 in numbers ('Soura'-18,600 and 'Lanjia Soura'-14,670), spread over two Assembly segments -

Mohana, reserved for the Scheduled Caste, and this segment under the Lok Sabha constituency of the same name.

'The administration has de cided to set up 33 ethnic booths, which will be managed by the polling personnel of tribal communities," informed Das.

Meanwhile, a team of officers is working round the clock to raise awareness in remote villages to enhance voter turnout. According to sources, the polling percentages in Mohana and this town were 75.65 per cent and 69.31 per cent, respectively in the 2019 elections.

## Act Now For Peace

t is hard to imagine that anyone in the Levant or the broader Middle East managed to sleep on Saturday night, as Iran launched hundreds L of drones and ballistic missiles toward strategic sites in Israel and Israeli settlements in the occupied West Bank

Almost all of the drones and missiles were intercepted before reaching their targets, as a result of a coordinated effort by the United States, Israel, Jordan, and the United Kingdom. The trigger for Saturday's attack was Israel's bombing of the Iranian consulate in Damascus on 1 April, which killed 13 people, including several high-ranking members of Iran's Islamic Revolutionary Guard Corps. This act, a clear violation of the 1961 Vienna Convention on Diplomatic Relations, compelled the Islamic Republic to respond.

Iran chose to strike Israel directly, a decision likely driven by a desire to defend its national pride following the attack on its consulate, which, according to the Vienna Convention, is the Islamic Republic's sovereign territory

Paradoxically, this dangerous escalation presents a unique opportunity for a regional ceasefire – potentially ending the war between Israel and Hamas, preventing a direct military showdown between Israel and Iran, and stopping the Yemeni Houthi at-

tacks on commercial vessels in the Red Sea. With both sides having demonstrated their military capabilities, and assuming that Israeli Prime Minister Binvamin Netanyahu heeds US President Joe Biden's warning not to retaliate against Iran, the region could revert to an uneasy equilibrium. As the Cold War showed, a balance of terror can act as a powerful deterrent, fostering peace and stability.

But to capitalise on this narrow window of opportunity, the United Nations Security Council must pass a robust, binding resolution calling for a regional ceasefire. In addition to Israel and Iran, this resolution should apply to all the countries of the region and third-party combatants

Moreover, this binding resolution must address the central issue driving the current bout of regional instability - the war in Gaza. In line with its previous 25 March resolution, from which the US abstained the Security Council must demand an immediate cessation of Israel's ongoing bombardment of Gaza and the release of all Israeli hostages and detainees. By requiring both parties to "comply with their obligations under international law in relation to all persons they detain," the resolution could also facilitate a release of Palestinians detained by Israel.

Contrary to the claims of some US representatives, the 25 March resolution was binding. But given the risk of an all-out war, the Security Council must immediately

draft and vote on a new resolution, under Chapter 7 of the UN Charter, covering the entire region. The new resolution should aim to facilitate a permanent and just solution to the Israeli-Palestinian conflict, providing a detailed roadmap for establishing an independent Palestinian state based on the 1967 borders. As Saudi Arabia has stated, a credible "pathway to a solution" is a precondition for normalising relations with Israel.

Over the past six months, the Biden administration has backed Israel unreservedly, even at the cost of losing political support among progressive and Arab-American voters. Now, US policymakers must make the Israeli government understand that they will not tolerate further delays or gamesmanship when it comes to pursuing peace.

To be sure, rebuilding Gaza will take years and require a significant nternational effort. But achieving an effective, enforceable regional

## **Villagers displaced by** erosion in Lakhimpur still await new homes

North Lakhimpur (Assam), **April 17:** It has been nearly two-and-a-half-decades since a bustling village perished to erosion in Assam's Lakhimpur district. and for an entire generation, homes were all but temporary shacks on the embankment of river Subansiri. The residents of Kasomari

village, which was swept away following floods in 2001, were finally rehabilitated in 2018 to the 'No. 1 Hindu Adarsha Gaon' (model village), about five kilometers from here.

Locals, however, claimed that the process of land allotment and introduction of welfare schemes have moved at a glacial pace in the new village, though Lakhimpur MP Pradan Baruah maintained that swift progress has been made in the last couple of years

Monikanta Das, a resident of the model village, said they had got in touch with the state government for land soon after settling on the embankment, but it was only in 2012 that the land advisory committee approved a plot for rehabilitating them.

"For over five years, due to some political pressure, we were not handed over the land. It took a Right to Information Act application for the allotment to be made April 9, 2018," Das claimed. Guwahati, April 17: Around 4.500 contractual teachers working in various high schools in Assam have been on the same pay scale as regular employees, and they are also entitled to serve till the age of 60 years. Hence, the Education Department has no immediate plans to transition them to permanent appointments said a senior government official

The Director of Secondary Education in Assam, Mamata Hojai told IANS: "The contractual teachers who have been working in schools were given the benefits of permanent teachers. They can continue their jobs till they are 60 years of age along with other benefits like a regular teacher of the high school. The state government provided these facilities around three and half years ago.'

Hojai asked: "After all these benefits already provided to those teachers, why should the government take additional steps of giving them regular appointments?" He also mentioned that the Education Department doesn't have any such plans.

Earlier, Assam Education Minister Ranoj Pegu said: "There

around 3.500 teachers from this cohort transitioned to other employment opportunities.

## **Prepare action plan** to protect people: **Health department**

Jaipur. April 17: As Rajasthan braces for high temperatures this summer, the health department has asked its officers to prepare an action plan to protect people from heat-related illnesses.

Necessary steps will be taken to protect the common people from such diseases by preparing a 'Heat Action Plan' at the state, district, and block levels, the spokesperson said.

Shubhra Singh, Additional Chief Secretary of Medical and Health Department, gave instructions in this regard in during the video conference regarding prevention, treatment, and awareness activities against heat waves. She said that if the mercury level keeps rising, necessary steps should be taken by preparing a 'graded system' with yellow, orange, and red alerts.

## **Bhoi emerges favourite** after Cong axes Prabodh

Rourkela, April 17: The battle lines are drawn for the Talsara Assembly constituency in Sundargarh district. The BJP has re-nominated Bhabani Shankar Bhoi to contest from this constituency while BJD has announced Binay Toppo as its candidate.

However, the decision of the Congress to replace former captain of the Indian hockey team Prabodh Tirkey with Devendra Bhitaria sent shockwaves through the constituency. Even Prabodh has been stunned by the decision and he was campaigning in full swing a few days back when he came to know that he has been axed. A dejected Prabodh may soon join the BJD, sources informed.

Talsara with a sizeable population of the Bhuyan clan as well as Christians has always been a Congress bastion. On most occasions, the Congress candidate emerged victorious from this constituency Gajadhara Majhi, a Bhuyan, won from this seat on five occasions from 1980, before his untimely demise in 2006.

After Gajadhara's death, it was his nephew, Dr Prafulla Majhi who took over the mantle. He won from the constituency on three successive occasions - 2006, 2009 and 2014. He remained undefeated despite the strong BJD wave in that period. However, he failed to do a repeat act in 2019 as Bhoi won.

In fact in the 2019 Assembly polls Bhoi (60,264 votes) emerged a surprise winner over BJD's

Wilson Soreng (44,076). Majhi finished a distant third with 41,111 votes, a result that he never expected. In the 2019 polls, the BJP vote share went up by 9.63 per cent while that of the BJD and the Congress decreased by 3.08 per cent and 6.04 per cent respectively.

The Bhuyan and the Christian communities in this constituency play an influential role in the outcome of the polls. The Congress decided to replace Prabodh with Bhitaria keeping this aspect in mind. However, many feel that by replacing Prabodh, the Congress has handed the advantage to BJP's Bhoi again. Many feel that this 'suicidal' decision at the very last moment will enable the BJP candidate to win the seat in a canter.

"Now there are two Bhuyans and one Christian candidate in the race. Amid all this vote sharing of the two different communities, the chances are that Bhoi will emerge the best among all the three," said an independent observer. "Had Prabodh been in the fray, it would have been a close fight as he would have been a more acceptable

The agitation started February 13 with the organisations' calling for a 'Delhi Chalo' march, and since then, farmers, mainly from Punjab, are camping at the Shambhu border after being stopped by the Haryana Police. Referring to the past clashes

between protesters and police at the border, Tikait said the SKM has condemned the use of force against farmers. "Our efforts for the last two years have been that the SKM remains together and any call is given together. The SKM is not a part of the (Delhi Chalo) movement, informed Tikait.

The SKM was created so that farmers can be united, said Tikait. His outfit was among the 41 organisations that came together under the banner of the SKM to protest against the laws. Now, a number of new unions are being formed to divide farmers, he claimed and added that this is part of a 'conspiracy'.

"I said at the beginning that this Delhi Chalo protest will go on till the (Lok Sabha) elections are over. Some members of the RSS posing as farmers misguided people. Some ministers talked to them about how to break the SKM. This could be done only by creating a new SKM, which the government can hold dialogues with and take decisions that will

New Delhi, April 17: For 20-yearold Roushan Kumar, who sells flowers for a living in West Bengal, more jobs and better education are priorities. And the first-time voter wants to pick a government that will provide just that.

The seven-phase elections start Friday in India with more than 18 million people voting for the first time. While polls project Prime Minister Narendra Modi will win a third term, new voters like Kumar are determined to make their voices count.

"I will vote for a party that works for development in education, that will provide employment – so that there are jobs," Kumar, a Modi supmany his age. Rising tensions between religious groups, inflation and lack of jobs were the top concerns emerging from Modi's decade-long rule, according to a survey of 1,290 first-time voters in New Delhi by pollsters 'CSDS-Lokniti'.

Nearly two-thirds of those polled said they would vote for Modi's BJP given the government's strong record of economic growth, amid a sense of pride over construction of the massive Ram Temple in Ayodhya.

Despite world-beating growth, India's economy has scrambled to generate enough work for its people. Its youth make for most of the nation's unemployed workforce



according to various reports. Akansha Majumdar, a 20-yearold engineering student in West Bengal said India's government needs to eradicate illiteracy and provide job security.

To tap into such disenchantment, main opposition Congress has promised paid apprenticeships. Modi's party manifesto also focuses on creating jobs.

Beyond jobs and rising costs, communal harmony is another priority for many young voters. Delhi-based laptop repairer Mohammad Ajaz Ansari, 19, said not happen. He will vote for the Aam Aadmi Party (AAP), a Congress ally.

"There are so many unemployed people. Many people in my locality keep asking for work, but they don't get any. They work for private firms for meagre amounts of ₹10,000 – ₹12,000 per month which is not enough for a household to survive,<sup>3</sup> Ansari stated.

In reports released last year, the US State Department raised concerns over the treatment of Muslims and other religious minorities in India. Modi denies discriminating against minorities.

"I think one major hope for India would be being more sowards economy and societal problems. As a Gen-Z, I want my country to be global but not copy the West; transcending towards a more solid global position, writing our own path," said Dhriti Jain, 21.

Abbaas Kashmiri, 23, a student and first-time voter rows a boat in Dal Lake in Srinagar for living. He feels the gap between the rich and poor is getting bigger. "I don't like how public services are being privatised for profit. I want a government that helps everyone, not just the rich, and treats everyone fairly. When I vote, I want to make India more fair and inclusive, especially for those who need it most," asserted Kashmiri.

Thus the visit of the governor would be a diversion for them from time-bound poll-related work as they will have to provide protocol and local security cover to the 'unexpected' proposed visit 'without an imminently known requirement'.

According to Section 126 of the Representation of the People Act 1951, the 'silence period' for Cooch Behar starts from 6.00pm April 17, which brings in a multitude of restrictions and a higher level of enforcements by election authorities, the sources said.





Releasing the manifesto at the party headquarters here, TMC's Rajya Sabha party leader Derek O'Brien said, "These are the



provisions of the anti-defection law more explicit and immediate in their application," he said. The manifesto also mentioned that the next round of India's decadal population census, which has not happened since 2011, will be conducted.

The manifesto promised to ensure that the country's judiciary remains free from political pressures or inducements, advocating instead for a neutral, impartial, transparent commission.

The manifesto also promised to institute a mandatory three-year 'cooling-off period' before retired judges can accept government appointments or political roles.

The TMC pledged to restore the autonomy of agencies such as CBI. ED. NIA. and Income Tax. as well as bodies like the Reserve Bank of India (RBI) and the University Grants Commission (UGC), by amending their respective foundational Acts to regulate the Union Government's

role in their operational decisions Critiquing the BJP for undermining the communal fab-

ric of the country, the manifesto promised to establish a National Integration Council (NIC) comprising the Centre and states and take cooperative measures to strengthen India's communal harmony and manage threats arising from disharmony.

On the financial front, the party promised a comprehensive reform of the GST system.

The party also promised to delink the Railway Budget from the Union budget and allocate 5 per cent of the country's overall GDP for education.

In regards to national security, the party promised to do away with the Agnipath Scheme and restore "the Indian Armed Forces' traditional recruitment mechanisms."

'We will amend the current BSF Act to establish an independent oversight committee to promptly investigate allegations of misuse of force against innocent citizens during peacetime. We will revert BSF's jurisdiction to 15 km from the International border in West Bengal," it said.

The manifesto also promised to provide ration at the doorstep and 10 free cooking cylinders yearly for BPL families.

Reaching out to MGNREGA workers, the party promised increased income for labourers and a guarantee of 100 days of work for job card holders with a daily wage of ₹400.

## **Elgar Parishad case** accused Shoma Sen walks out of prison PRESS TRUST OF INDIA

Mumbai, April 17: Elgar Parishad-Maoist links case accused and former Nagpur University professor Shoma Sen was released from a prison here Wednesday afternoon, an official said.

The 66-year-old professor of English literature had obtained bail from the Supreme Court April 5. Sen, arrested in the case June 6, 2018, walked out of the Byculla jail in central Mumbai after the completion of all formalities, the senior prison official told PTI.

Her lawyer Indira Jaising tweeted about her release on X, saying, "She is finally out, Shoma Sen with her daughter outside Byculla jail." Sen was one of the 16 persons including activists and academics arrested in the case, related to the Elgar Parishad conclave held in Pune December 31, 2017. Pune Police had alleged that the conclave was backed by Maoists, and the 'inflammatory speeches made there fuelled caste violence near the Bhima Koregaon war memorial in Pune district next day. Of the accused, P Varavara Rao, Sudha Bharadwaj, Vernon Gonsalves, Arun Ferreira and Anand Teltumbde are already out on bail, while Gautam Navlakha is under house arrest after initial incarceration

## Ram Lalla honoured with 'Surya Tilak' on 'Ram Navmi'

Ayodhya, April 17: A beam of sunlight fell directly on Ram Lalla's idol at the new temple here on noon Wednesday, marking the "Surya Tilak" of the idol on the first Ram Navami since its consecration.

Devotees began queuing up at the Ram temple here before the break of dawn, district officials said. The local administration and the temple authorities had made special arrangements to handle the crowds on Ram Navami.

"After my Nalbari (Assam) rally, I watched the Surya Tilak on Ram Lalla. Like crores of Indians, this is a very emotional moment for me. The grand Ram Navami in Ayodhya is historic. May this Surya Tilak bring energy to our lives and may it inspire our nation to scale new heights and glory," he wrote on X.

He also shared pictures of him watching the 'Surya Tilak'. Uttar Pradesh Chief Minister

As the "Surya Tilak" of the deity took place, devotees outside in the sanctum sanctorum hailed the event by chanting "Jai Shri Ram". Inside, priests conducted an "aarti".

The Ram idol was consecrated in a ceremony led by Prime Minister Narendra Modi January 22

The "Surya Tilak" was made possible by an elaborate apparatus involving mirrors and lenses that directed sun rays into the sanctum sanctorum of the temple, and onto the deity's forehead

Yogi Adityanath also shared a video of the 'Surva Tilak' on his official handle on X.

'The grand 'Surya Tilak' adorned on the forehead of Suryakul Bhushan Shri Ram Lalla is today illuminating the entire nation with its eternal glory. Jai Jai Shri Ram!," he

wrote.mTemple spokesperson Prakash Gupta said, "The Surya Tilak was done for around four or five minutes when the sun rays were directly focused on the forehead of the Ram Lalla idol.'

"The temple administration prevented the devotees from entering the sanctum sanctorum at the time of the Surya Tilak to avoid overcrowding, Gupta said in a statement.

Dr DP Kanungo, Chief Scientist at CSIR-CBRI, Roorkee, told PTI, "As planned, the Surya Tilak of Ram Lalla was executed at 12:00 pm." As per an official statement, a crown made of sustainable precious gemstones was adorned by the idol of Ram Lalla on the occasion.

In consultation with the Indian Institute of Astrophysics (IIA), Bangalore, the CSIR-CBRI, Roorkee team developed a mechanism for 19 years to steer the sunlight from the third floor of the temple to the 'garbha griha'. A detailed design to bring sunlight to the 'garbha griha' was developed by CBRI, with the IIA providing consultancy for the optical design.

The system was tested by the scientists Tuesday. Dr S K Panigrahi, a scientist at CSIR-CBRI Roorkee, who was also associated with the project said that the basic objective of the Surya Ttilak project is to focus on the 'Tilak' on the forehead of Shri Ram idol on every Shri Ram Navami day.

Under the project, sunlight will be brought on the forehead of Lord Ram at noon on Shri Ram Navami in the Chaitra month every year.

## **3 powerful IEDs** seized in Poonch

Mendhar/Jammu, April 17: Three ready-to-use improvised explosive devices (IED), each weighing between three to 20 kgs, were recovered from a terrorist hideout in the border district of Poonch Wednesday, officials said.

They termed it a "major breakthrough" ahead of Lok Sabha elections in Jammu and Kashmir.

The IEDs, planted inside steel containers of five-kg, 10kg and 20-kg capacity, were found hidden inside a cave hideout during a joint search operation by the police, CRPF and Rashtriya Rifles in the forest area of Sanai-Gursai in the 🗎 Mendhar sub-division, the officials said.

They said the bomb disposal squad later destroyed all the three IEDs in a controlled explosion, scuttling terrorists' plan to carry out blasts in the Union Territory.

### Tax hike for rich

Ottawa: Canadian Prime Minister Justin Trudeau's government announced Tuesday it is imposing higher taxes on the wealthiest Canadians as part of the federal budget. The budget proposes to increase the capital gains inclusion rate, which refers to the taxable share of profit made on the sale of assets. The taxable portion of capital gains above \$250.000 Canadian (US\$181,000) would rise from half to two-thirds, which the federal government says will only affect 0.1% of Canadians and raise nearly \$20 billion Canadian (US\$14.5 billion) in revenue over five years. "I know there will be many voices raised in protest. No one likes paving more tax. even - or perhaps particularly those who can afford it the most." Finance Minister Chrystia Freeland said.

**UK'S CAMERON SAYS ISRAELIS HAVE DECIDED TO RETALIATE AGAINST IRAN**

Jerusalem, April 17: Israel has clearly decided to retaliate against Iran for missile and drone attacks, Britain's foreign minister David Cameron said during a visit to Israel Wednesday, the starkest warning yet of another volley coming in regional escalation

World powers are striving to prevent a wider outbreak of conflict in the Middle East after Iran's attacks on Saturday night, which involved hundreds of missiles and drones, the first time Iran has directly attacked Israel after decades of confrontation by proxies.

Iran launched the attacks in response to a presumed Israeli airstrike on its embassy compound in Damascus April 1, which killed two generals and several other Iranian officers.

More than six months into a war between Israel and the Iranbacked Palestinian militant group Hamas that has seen flareups in violence across the Middle East, diplomats are searching for a way to avert direct battle between Israel and Iran.

### Raisi warns of massive response

Tehran: Iran's president has warned that the "tiniest invasion" by Israel would bring a "massive and harsh" response, as the region braces for potential Israeli retaliation after Iran's attack over the weekend. President Ebrahim Raisi spoke Wednesday at an annual army parade that was relocated to a barracks north of the capital, Tehran, from its usual venue on a highway in the city's southern outskirts. Iranian authorities gave no explanation for its relocation, and state TV did not broadcast it live, as it has in previous years. Raisi said Saturday's attack was a limited one, and that if Iran had wanted to carry out a bigger attack, "nothing would remain from the Zionist regime." His remarks were carried by the official IRNA news agency.

London April 17: More than\_\_\_ 50,000 Russian military personnel have died during the Ukraine conflict, the BBC reported Wednesday, citing its own reporters, independent media group Mediazona and volunteers. They found that more than 27,300 Russian soldiers died during the second year of the war, a 25-percent increase on the first year. BBC Russian, Mediazona and volunteers have been counting deaths since February 2022, using open-source information from official reports and the media, as well as using satellite images of Russian cemeteries to estimate the number of new graves. The figure of more than 50,000 is eight times higher than the official death count acknowledged by Moscow in September 2022. It does not include deaths of militia in Donetsk and Lugansk in eastern Ukraine Ukraine said in February that it had lost 31,000 soldiers, but that figure is also likely to be significantly lower than the true death count.



### **Power rationed**

Quito: Ecuador Tuesday began to ration electricity in the country's main cities as a drought linked to the El Niño weather pattern depletes reservoirs and limits output at hydroelectric plants that produce about 75 per cent of the nation's power. The power cuts were announced Monday night by the ministry of energy, which said in a statement that it would review its decision Wednesday night. "We urge Ecuadorians to cut their electricity consumption in this critical week," the statement read. The power cuts in Ecuador come days after dry weather forced Colombia's capital city of Bogotá to ration water as its reservoirs reached record lows, threatening local supplies of tap water.

London, April 17: The British government's plan for a landmark smoking ban that aims to stop young people from ever smoking cleared its first hurdle in Parliament Tuesday despite vocal opposition from within Prime Minister Rishi Sunak's

Conservative Party. The bill, a key policy announced by Sunak last year, would make it illegal to sell tobacco products to anyone born after January 1, 2009. If passed, the bill will give Britain some of

the toughest anti-smoking measures in the world. Under the Tobacco and Vapes Bill, children turning 15 this year or younger will never be legally sold tobacco. Once im-

plemented - officials are aiming for 2027 — the legal age of sale that people in England can buy cigarettes will be raised by one year, every year until it is eventually illegal for the whole population. The bill also includes measures to crack down on youth vaping,

The bill was a "virtue-signalling piece of legislation about protecting adults from themselves in the future," Truss told Parliament during Tuesday's debate. Other high-profile Tories, in-

cluding business secretary Kemi Badenoch, a Cabinet minister, also opposed the bill or abstained. Conservative lawmakers were granted a free vote, meaning

they could vote with their per-

sonal conscience rather than follow the official party line.

The plans were believed to have been inspired by similar policies proposed by New Zealand under former Prime Minister Jacinda Ardern, but the country's new coalition government repealed the bill earlier this year.

The government said that smoking won't be criminalised, and the phased changes mean that anyone who can legally buy cigarettes now won't be prevented from doing so in the future.

The number of people who smoke in the UK has declined by two-thirds since the 1970s, but some 6.4 million people in the country — or about 13 per cent of the population — still smoke, according to official figures.



"Gradually after 2035, the growth rate will start decelerating from the peak, and on an average, our growth rate, the real GDP (gross domestic product), will be 6.7 per cent overall in the next 23 years," Sharma noted. India's economy will attain the size of \$34.7 trillion by 2047 with a per capita income of \$21,000, the industry body said.

New Delhi, April 17: India's crude oil import dropped 16 per cent in the fiscal year ended March 31 as lower international rates but the dependency on overseas suppliers rose to a new high, official data showed.

India imported 232.5 million tonne of crude oil, which is refined into fuels like petrol and diesel, in the 2023-24 fiscal (April 2023 to March 2024), almost the same as in the previous financial year. But it paid \$132.4 billion for the imports in FY24 as against \$157.5 billion import bill in 2022-23, oil ministry's



\$23.4 billion on import of 48.1 million tonne of petroleum products like LPG. It also exported 62.2 million tonne of products for \$47.4 billion.

Other than oil, India also imports gas in its liquid form, called LNG.

After the price shock of 2022-23, import of 30.91 billion cubic

The deficit was 5.89 trillion yen (\$38 billion) for the fiscal year that ended in March, according to Finance Ministry data released Wednesday. Japan had a trade surplus with the US and some European countries. Annual exports to China slipped slightly, declining for the first time in four years.

## PhonePe, Google Pay creating UPI duopoly

New Delhi, April 17: The National Payments Corporation of India (NPCI) will engage with fintech startups in April to address the growing market dominance of PhonePe and Google Pay in the Unified Payments Interface (UPI) ecosystem, according to reports.

NPCI is reaching out amid concerns about the market share concentration of Google Pay



and PhonePe, which together account for nearly 86 per cent of UPI transactions by volume.

PhonePe has signed several agreements to promote UPI payments in Nepal, Singapore, and the United Arab Emirates. Earlier this year, Google Pay also signed an agreement with NPCI to expand UPI for international payments.

Paytm, the third-largest UPI player, has seen its market share decline this year, partly due to regulatory actions by the Reserve Bank of India (RBI).

The RBI has reportedly expressed "displeasure" to the NPCI over the growing duopoly in the payments space.

A parliamentary panel has urged the government to support the growth of domestic fintech players to offer alternatives to PhonePe and Google Pay.

To address these concerns, NPCI executives will meet with representatives of CRED, Flipkart, Fampay, Amazon and other fintech firm to discuss initiatives aimed at boosting UPI transactions on their platforms. The meeting is also expected to help NPCI better understand the support these companies require to grow.

NPCI has advocated for capping the market share of individual companies in the UPI ecosystem at 30 per cent, with a deadline extended to the end of December 2024. However, enforcement remains challenging due to technical limitations.

Separately, the RBI is considering a plan to create a more favourable competitive landscape for emerging UPI players. The NPCI is encouraging fintech companies to offer incentives to users to promote UPI transactions through their apps.

UPI, developed by Indian banks, has become one of the most popular methods in the country to make online payments and processes more than 10 billion transactions monthly. It has also gained momentum abroad with countries like Singapore, Malaysia, the United Arab Emirates, France, Nepal, the United Kingdom, Mauritius, and Sri Lanka also accepting payments through this format.

## Small-cap MFs' assets soar 83%

New Delhi, April 17: Influx of flows, upsurge in retail investors' participation and bullish market conditions have boosted the assets for the small-cap mutual fund category to Rs 2.43 lakh crore mark at the end of March 2024, marking an 83 per cent surge compared to the previous year.

The surge in assets was complemented by an increase in the number of investors, with the number of folios reaching 1.9 crore in March 2024 from 1.09 crore a year ago, adding an investor base of 81 lakh. This shows investors' inclination for small-cap funds.

Gopal Kavalireddi, Vice President - Research at FYERS, said that the growth trajectory of India's economy is attracting increased interest, leading many unlisted small-cap firms to seek support from the capital market. This trend offers promising opportunities for investors eyeing long-term growth prospects.

Barcelona, April 17: Playing with an extra man for more than an hour, Paris Saint-Germain rallied against Barcelona to reach the Champions League semifinals.

Kylian Mbappe scored twice as PSG reversed its first-leg loss at home with a 4-1 win at Barcelona Tuesday to advance 6-4 on aggregate and keep alive their hopes of a first European title in what is the France star's final season with the club.

Former Barcelona forward Ousmane Dembele and Vitinha also scored for PSG, which took advantage of a 29th-minute red card to Barcelona defender Ronald Araujo after he fouled Bradley Barcola while trying to stop a breakaway.

Barcelona had gotten off to a good start and opened the scoring with a goal by Raphinha in the 12th. but the visitors took control with the man advantage and didn't let Barcelona get back into the game. Xavi had to replace young forward Lamine Yamal with defender Inigo Martinez after the red card to Araujo, who was deemed by the referee to be the last defender when he fouled Barcola.

The Catalan side, which won the first leg 3-2 in Paris last week. made it to the knockout stage

of Europe's top club competition after back-to-back eliminations in the group stage

Mbappe scored his goals in the 61st and 89th minutes. The France star is hoping to win what would be a first Champions League title for himself and for

PSG before he leaves the club. Barcelona opened the scoring in their first attack with a fortuitous goal by Raphinha after Yamal's low cross from the right side bounced off the shin of the Brazil forward and went into the net.

PSG equalised about 10 minutes after Araujo was sent off, with Dembele finding the net by the far post after a cross by Barcola. Dembele was loudly jeered by the Barcelona crowd when he was substituted in the final minutes. He had also scored in the first leg in Paris.

PSG took the lead when Vitinha fired a low shot from outside the area in the 54th. The visitors increased their lead when Mbappe converted a penalty kick after Dembele was brought down by Joao Cancelo inside the area.

Barcelona had chances to get back into the game, with Ilkay Gundogan hitting the post in the 56th and both Robert Lewandowski and Raphinha squandering chances toward the end of the match.

Mbappe's second goal came

from close range in a breakaway in the final minutes. Xavi was sent off after kicking a cushion protecting a sideline camera in the 56th.

### **Dortmund beat Atletico**

Marcel Sabitzer scored late and set up two goals to send Borussia Dortmund into the Champions League semifinals with a helter-skelter 4-2 win over Atletico Madrid. After losing the first leg of their quarterfinal 1-2 in Madrid, Dortmund had to come from behind twice over two legs to advance 5-4 on aggregate.

Julian Brandt opened the scoring to level the tie before Sabitzer set up Ian Maatsen to give Dortmund a 2-0 lead on the night. Atletico coach Diego Simeone responded with three changes at the break and they all paid off. A Mats Hummels own goal and goal from substitute Joaquin

Correa put the Spanish side back in front on aggregate. Then Sabitzer set up Niclas Fullkrug in the 71st minute for the Germany forward's first goal after nine scoreless games, and Sabitzer scored himself three minutes later to send Dortmund

into the last four. Dortmund will face Paris Saint-Germain again in the semifinals. The final will be played June 1 in London, where Dortmund lost the 2013 final 1-2 to bitter rivals Bayern Munich.
