

# not mandatory to pursue PhD: UGC PRESS TRUST OF INDIA

Master's degree

New Delhi, April 21: Students with four-year undergraduate degrees can now directly appear for NET and pursue PhD, according to University Grants Commission (UGC) Chairman Jagadesh Kumar.

To pursue a PhD with or without a Junior Research Fellowship (JRF), the candidates will require a minimum of 75 per cent marks or equivalent grades in their four-year undergraduate course. So far, a candidate for the National Eligibility Test (NET) needed a master's degree with a minimum of 55 per cent marks.

The candidates with four-year un-Now. dergraduate destudents grees can now diwith 4-yr rectly pursue PhD bachelor's and appear for degrees, 75% marks NET. Such candican directly dates are allowed pursue PhD to appear in a sub-

ject in which they want to pursue a PhD irrespective of the discipline in which they have obtained the four-year bachelor's degree, Kumar told PTI.

The candidates having passed a four-year or eight-semester bachelor's degree should have a minimum of 75 pc marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed, the UGC chairman said.

# Age no barrier for health insurance

New Delhi, April 21: With a view to widen the market and foster adequate protection from healthcare expenses, insurance regulator IRDAI has removed the age limit of 65 years for individuals buying health insurance policies.

This marks a significant departure from the conventional constraints that limited individuals in securing comprehensive coverage

By abolishing the maximum age restriction on purchasing health insurance plans, the Insurance Regulatory and Development Authority of India (IRDAI) aims to foster a more inclusive and accessible healthcare ecosystem, ensuring adequate protection against unforeseen medical expenses.

As per the earlier guidelines, individuals were allowed to purchase a new insurance policy only till the age of 65. However, with the recent amendment. which has been effective from April 1, anyone, regardless of age, is eligible to buy a new




Insurers have been mandated to offer health policies to individuals with pre-existing medical conditions of any kind

Consequently, insurers are prohibited from refusing to issue policies to individuals with severe medical conditions like cancer, heart or renal failure, and AIDS

### health insurance policy.

In a recent gazette notification, IRDAI said, "Insurers shall ensure that they offer health insurance products to cater to all age groups. Insurers may design products specifically for senior citizens, students, children, maternity, and any other group as specified by the Competent Authority.'

Besides, insurers have been mandated to offer health policies to individuals with pre-ex-



According to the notification, insurers are allowed to offer premium payment in instalments for the convenience of policyholders. Travel policies can only be offered by general and health

insurers, it said. There is no limit on AYUSH treatment coverage. Treatments under systems like Ayurveda, Yoga, Naturopathy, Unani, Siddha, and Homeopathy will receive coverage up to the sum

insured without any cap, it said. Policyholders with benefitbased policies can file multiple claims with various insurers, enhancing flexibility and options, it said.

The proposed regulation seeks to handle the complaints and claims of senior citizens via a specialised channel, ensuring a more tailored and responsive approach to their requirements, it added.

# 'Devil Comet' closest to Earth after 71 yrs



Mumbai, April 21: The periodical comet, named '12P/Pons-Brooks' finally reached closest to greet Earth Sunday, as it hurtles towards the sun on its return journey after 71 years, thrilling the Indian and global scientific community.

The celestial visitor, also nicknamed 'Devil Comet' has been affording its glimpses to humanity since early March, appearing as a bright, tiny spot that was captured on cameras by some astronomers from India, said scientist and Founder-Secretary of Amateur Astronomers Association (Mumbai), Bharat Adur.

'From tomorrow, the comet will start its 'perihelion passage', meaning its closest point to the sun when it will shine the brightest. Then it will approach Earth till about 232 million km by June, when it will be visible from many parts of the world, but would appear fainter," said Adur to IANS.

He shared an exclusive photo by Ashish Sinojia, an amateur astronomer, who trudged out to the stark barren land of the Kachchh district of Gujarat this week, to capture the sky visitor in its full glory.



The 12P/Pons-Brooks comet is estimated to be bigger than Mt. Everest (8.84 km tall), and as per scientific experts' calculations in a 2020 research paper, the chunks of ice and rocks were nearly 17 km across, or more than double the world's tallest mountain.

It has a nucleus estimated to be around 30 km in diameter and everything zooms in space at mind-boggling speeds of 26,000 km/hour, with the streak increasing as it approaches the sun.

The inter-galactic visitor is actually a cold, active cryovolcanic comet, zipping through the skies and has earned a wicked nickname -- the 'Devil

Comet' -- since it periodically explodes violently, releases 'cryo-magma' comprising billions of kg of ice, water, and gases (meteoric shower) that give it an irregular shape resembling a Devil's horns. In fact, in the last week of December 2023, the 12P/Pons-Brooks suddenly caught attention after a series of violent explosions rocked it and let off the 'meteor showers', very far away from Earth.

Adur urged the people, especially the youth to scan the skies, on the western horizon in the Aries Constellation, after sunset till around 8:15pm and avail a 'darshan' of the comet, "as its next visit to the solar system will be only in August 2095"

He added that as per the StarWalk app, the 12P/Pons-Brooks was last witnessed at perihelion May 22, 1954, and later, humanity witnessed and wowed at the electrifying Halley's Comet (1986) spectacle in the skies.

'This is truly a historical, oncein-a-lifetime astronomical spectacle... Nobody currently living on Earth may recall having seen the 12P/Pons-Brooks back in 1954, and hardly anybody will live to witness it on its next interplanetary journey in 2095," said a smiling Adur.





# **Baripada boils at 44.6°C**

**30 PLACES RECORD 40 DEGREES OR MORE; RAIN, THUNDERSTORM** LIKELY TO BRING DOWN HEAT TODAY, SAYS WEATHER BUREAU

Bhubaneswar, April 21: Odisha continued to reel under blistering heat with Baripada emerging the hottest place in the state, Sunday after the northern city recorded a maximum temperature of 44.6 degrees Celsius Nuapada came a close second at 44 degrees Celsius.

However, the consolation is that the Regional Meteorological Department (IMD), Bhubaneswar has predicted reduction in the day temperature from tomorrow (Monday) with several places likely to experience rains.

The weather bureau Sunday said that though the highest maximum temperature (day temperature) in the state was less by a few notches, at least 9 cities recorded maximum temperatures of 43 degrees Celsius or more. At the same



time, 30 places recorded maximum temperatures of 40 degrees Celsius or more.

While Baripada recorded the highest maximum temperature Sunday, both Paradip and Gopalpur experienced the lowest maximum temperatures at 33.5 degrees Celsius. The maximum temperature in the Capital City of Bhubaneswar and Cuttack stood at 41.6 degrees Celsius during the day.

Meanwhile, the IMD has forecast that the day temperatures are likely to abate from tomorrow and several places in the state are likely to experience moderate thunderstorms ac-

companied by lightning and rain - bringing the much-needed relief to the people.

As per IMD, the day temperature (maximum temperature) is very likely to be 40°C or above at many places in interior Odisha and above normal by 3 to 5°C in some districts of the state during the next two days due to prevailing northwesterly/westerly dry air and high solar insolation.

However, due to the likely interaction of the middle tropospheric westerly trough with lower-level moist air from the Bay of Bengal, meteorological conditions are becoming favourable for moderate thunderstorm activity with lightning, gusty surface wind, with wind speed reaching 40 to 50 kph and scattered to Isolated rainfall over the districts of Odisha within the next 3-4-days.

# Democracy will end if BJP returns to power: Kharge

Satna (MP), April 21: Launching a scathing attack on BJP-led National Democratic Alliance, Congress president Mallikarjun Kharge Sunday claimed that democracy will end in the country if the "Modi-Shah sarkar" returns to power.

**Targeting Prime Minister** Narendra Modi and Union Home Minister Amit Shah while addressing a public meeting in Madhya Pradesh's Satna district, Kharge said they will also scrap the Constitution.

"They will scrap the Constitution scripted by Babasaheb Bhimrao Ambedkar. If you want to keep it alive, the right to vote for women,

labourers and farmers, then vote for the Congress and its 'panja' (hand) symbol," he appealed to the voters.

Former Congress president Rahul Gandhi was scheduled to address the rally in Satna but his visit was cancelled as he took ill, a party leader said earlier, adding that Kharge would fill in for him. The Satna Lok Sabha seat will go to polls in the second phase April 26.

"Democracy will end if Modi-Shah's government returns to power," Kharge claimed addressing the public meeting held in support of Congress candidate Siddharth Kushwaha.

Accusing PM Modi of telling lies, Kharge said the PM keeps talking about "Modi ki guaran-

tee" without taking his party's name. "He had said that if he became the prime minister, ₹15 lakh would be given to every person by bringing back the black money stashed abroad. Did you get it," he asked.

Modi had also told the young people of this country that 2 crore jobs would be generated every year, said Kharge continuing his criticism of the PM.

"Now 10 years have gone. Did you all get 20 crore jobs... Ask the BJP about their 20 crore jobs (promise). Ask them where is ₹15 lakh when they come seeking your votes," the senior Congress leader said.

# Surveillance stepped up along Odisha-Andhra border for polls

Berhampur April 21: Security surveillance in Odisha-Andhra Pradesh border areas has been intensified by the police ahead of the twin elections for the Lok Sabha and the Assembly in the state, a senior officer said, Sunday.

Joint checkings by the police of the two states have been carried out in border areas in Ganiam and Gajapati districts following the direction of the Election Commission of India, he said. Odisha DGP Arun Kumar Sarangi held a daylong meeting with the SPs of Ganjam, Gajapati, Kandhamal, Boudh and Berhampur about poll preparedness

The simultaneous polls for the Lok Sabha and the state will be held May 13 and 20 in these areas. The DGP said the joint patrolling was going on along the inter-state boundary after the coordination meeting with the SPs of the border districts of both states.

Sarangi said they would give special focus on Kandhamal and Boudh districts because of the

movement of Maoists. "We are chalking out a plan for the deployment of forces during the polls. We will deploy adequate security personnel to ensure free elections in these districts," the DGP said.

The combing operation in the vulnerable areas was going on, he said. Twenty-five companies of Central forces from Odisha have moved to other states, like Karnataka, Tamil Nadu and Arunachal Pradesh, to deploy in the first phase of the polls held, April 19.

The police have launched a special drive to crack down on ganja smuggling and plantation of the narcotic substance in the areas. From January till now, around 340 quintals of ganja have been seized and around 700 acres of ganja plantations de-

stroyed by the police, he said.

Violent threats tend to increase when combined with discrimination linked to skin colour. religion or sexual orientation. Physical violence

Posetti and two other researchers have built a guide and toolbox on the topic targeting journalists, together with the Organization for Cooperation and Security in Europe (OSCE).

Filipino journalist Maria Ressa, the 2021 Nobel Peace Prize winner, was a victim of online abuse, as she explained in the ICFJ-UNESCO report.

"I was a CNN war correspondent for two decades, but nothing in the field prepared me for the orchestrated, misogynistic attacks on me and our women-led news outlet, Rappler,' she said.



BBC disinformation specialist Marianna Spring received an avalanche of abusive tweets last year, threatening to kidnap her or slit her throat

Much of the abuse followed her investigation into the takeover of social media network X, then known as Twitter.

In some cases, online threats can translate into physical violence

A fifth of women surveyed said they had suffered attacks or insults in real life that were linked to online abuse.

The consequences can be farreaching, with some journalists

potentially dissuaded from covering sensitive topics and some choosing to opt out of the industry altogether.

Paris-based media rights campaigners Reporters Without Borders (RSF) has warned that this type of harassment forms a new threat to press freedom.

Developing counter measures French journalist Nadia Daam told AFP that she received a flood of hateful messages in 2017 after a column that criticised

an online forum. Since then, she has moved house twice and tends to stay away from social media, but says she still gets cyber-bullying messages and 'doesn't work the same anymore'.

However, she thinks there is more awareness of the problem now, saying that she believes the wider industry "talks more about cyberharassment", with more severe legal sentences.

Freelancer Melina Huet covered the war in Ukraine as well as the Israel-Hamas conflict, and said she regularly gets online threats related to her coverage. "I received threats of be-

heading and rape on Instagram," she said. "The perpetrators can easily re-create accounts, there is impunity.'

Some media have put protocols in place to try and tackle cyberbullying.

New Delhi, April 21: The Ministry of Health and Family Welfare (MoHFW) has asked all states and UTs to investigate any violations and take appropriate action, including suspension of registration, against hospitals performing illegal organ transplants, officials said Sunday. It also asked all states and Union Territories (UTs) to submit an action-taken report (ATR) on the instructions within 15 days

In a letter issued April 10, Director General of Health Services (DGHS) Atul Goel urged all states and UTs to ensure regular collection and sharing of data of all transplant cases, including those of foreigners, with the National Organ and Tissue Transplant Organisation (NOTTO) on a monthly basis.

The ministry's direction comes over two weeks after an organ trafficking racket, involving Bangladeshi nationals, being run in Haryana and Rajasthan was busted. Referring to media reports



mentioning commercial dealings in organs involving foreign citizens. Goel stated. "It has also been noted from the registry of NOTTO that there has been a surge in the number of organ transplants of foreigners in the country, which calls for monitoring of such transplants by



He also asked the officials to take appropriate actions whenever a breach of any provision of the Act or any of the rules made thereunder are noted.

"Investigate any violation of the THOTA, 1994 and rules thereunder and take appropriate action including suspension of registration for performing Organ Transplant, of the hospitals involved in illegal activities," the letter said.

"It should be ensured that a unique NOTTO-ID for both donor and recipient is generated by the hospital from NOTTO website, in all cases of organ transplant, whether from a living donor or deceased donor," the letter said.

Besides NOTTO-ID being mandatory for considering allocation of organ in case of deceased donor transplant, this ID in case of a living donor transplant, shall also be generated at the earliest, at least within 48 hours of the transplant surgery,

# Boats in Kendrapara lack safety measures

Kendrapara, April 21: Despite the recent boat mishap in which eight persons lost their lives in Jharsuguda district, people continue to use this mode of transport from 63 ferry ghats in this district. Most of these boats do not have adequate number of life jackets and other safety measures for the passengers At times the boats are also overloaded, sources pointed out Sunday. However, the boats continue to ply violating rules as the district administration has failed to implement disciplinary actions against the offenders, the sources added.

This district is no stranger to boat mishaps and the casualties arising out of it with seven rivers and several water bodies flowing through it. Last year two persons including the boatman met their watery graves when a motorboat from Keredagad ghat carrying 30 passengers capsized in the river.

In March 2013, 13 youngsters all of whom were cricket players, drowned when their boat capsized near Pitapata under Mahakalapara block in this district. Similarly in January 2019, 10 people including kids, died when the boat they were travelling on, capsized at Nipania. However, despite the mishaps it

# 70-year-old man dies of 'sunstroke'

He pointed out that 60 such boats are operating in the vicinity of Bhitarkanika National Park on rivers full of crocodiles. He shuddered as to what will happen to people if a boat capsizes in the river full of crocs. Bibhuti Bhushan Rout, a resident of Mahakalapara said that delay in construction of bridges is helping the owners of the boats to run their operations without proper safety measures.

When contacted, ADM Pitambar Tarai said awareness programmes are being conducted at frequent intervals among the boatmen. He said that the district administration is taking strict action against boats violating rules.

# Wild animals hit hard by water shortage

Keonjhar, April 21: Once famous for its pleasant climate, this natural environment rich district has now become a hot cauldron. The heat has not only affected people but also wild animals as they are suffering under the scorching sun. To compound their problems, most of the water bodies have dried with the mercury soaring to over 43 degrees Celsius in many parts of this district. Sources informed that many of the animals have died due to the heat, but the Forest department is not reporting the incidents.

DFO Keonjhar division Dhanraj HD however ruled out water scarcity in the jungles under Keonjhar division. "Forest department personnel are on alert to all possible situations. They will take steps when the need arises. Water bodies have been dug in various forest range areas to quench the thirst of wild animals," Dhanraj said.

Dhanraj may say that the animals are not facing water shortage. However, the fact is that major rivers like the Baitarani, Kanjhari, Karo, Sona, Kusei and Aradei have dried up due to the high temperatures. Sources said that a herd of 90 elephants including 29 calves in Keonjhar forest division are suffering due to acute shortage of water.

Other animals like monkeys, bears,




jackals, deer, squirrel, snakes and hares are also facing similar problems. They are trying to stay as close as they can to the water bodies. However, even then the quantity of water available is too little for them.

"The animals are suffering due shortage of food and water. Most of the trees and plants have been affected due to the heat. The problem is acute for herbivorous animals. They are neither getting food nor water. They cannot even come out of the forest," pointed out Duskar Barik, an environmentalist.

Hundreds of monkeys near Anjara (Talakainsari panchayat) under Bhuyan and Juanga Pidha forest ranges are also suffering due to soaring temperatures and lack of water. Many bats and owls in Raisuan village under Sadar block and Balabhadrapur village under Ghatagaon block have died due to the heat, sources said.

"I have never seen such high temperatures since my birth. In our time 35 degrees Celsius was considered very high. Due to mining activities, massive deforestation and unnecessary felling of trees, the situation has changed drastically," said 70vear-old writer. Karunakar Barik.

According to environmentalists, trouble started after 1998 and became acute after 2002. Today many places in this district have turned into furnaces. It is due to heavy mining and industry operations, destruction of forest cover, plying of heavy vehicles creating pollution that have led to temperatures rising, they said. To add to the woes, sparse rainfall has affected the district leading to acute water shortage, they added.

# **Corporate Racism**

n investigative report published recently by Public Eye, a Switzerland-based non-governmental organisation, has revealed disconcerting findings on infant food products made by Nestlé. The Swiss FMCG giant's two best-selling brands, Cerelac and Nido, have high levels of added sugar in the form of sucrose and honey in lowand middle-income countries, while surprisingly these products are sugar free in Switzerland, the brand's home country, and in other European nations, according to the report. This double standard has been called out by some as corporate racism.

The investigation by Public Eye in collaboration with International Baby Food Action Network delved into the practices of the renowned brand. The research was based on tests carried out on Nestlé products in a laboratory in Belgium. The resulting report, titled "How Nestle gets children hooked on sugar in lower-income countries" highlighted the brand's inconsistent nutritional standards across different countries. It criticised the company for failing to provide clear information about the sugar content in its products. Shockingly, out of the 115 Nestlé products analysed, 108 were found to contain added sugars in markets in Asia, Africa, and Latin America.

Cerelac baby cereals, designed for infants aged six months and above, have been found to contain added sugar levels of around four grams per serving on average, equivalent to approximately one sugar cube. In the Philippines, the highest amount of added sugar per serving at 7.3 grams was reported, whereas in India, where sales exceeded 250 million US dollars in 2022, the added sugar content per serving is 2.7 grams. Similarly, Nido powdered-milk products, intended for children aged 1-3 years, contain an average of nearly two grams of added sugar per serving. In Panama, it was found to have the highest added sugar content per serving at 5.3 grams.

"On the eve of its Annual General Meeting, a petition demands that Nestlé put an end to this unjustifiable and harmful double standard, which contributes to the explosive rise of obesity and leads children to develop a life-long preference for sugary products... While Nestlé recommends publicly to avoid baby foods that contain added sugar, it takes advantage of the weakness of existing regulations to continue selling such products in lower-income countries." the report said.

Meanwhile, in response to the findings of the report, the Union Consumer Affairs Ministry has directed the Food Safety and Standards Authority of India (FSSAI) to take necessary action against the company.

Nestlé has a history of being embroiled in controversies. Previously, their Maggi instant noodles were banned in the country due to the presence of MSG (monosodium glutamate) and lead, with the latter surpassing Nestle India's stated levels by over one thousand times. Between 5 June and 1 September, 2015, around 38,000 tonnes of Maggi were removed from stores nationwide and subsequently disposed of.

While MNCs like Nestle and Johnson & Johnson, whose baby products were found having carcinogenic substances, are definitely at fault, the clear lack of regulatory guidelines in countries like India cannot be overstated. MNCs are attracted towards India as it is the world's largest consumer market but unfortunately our governments have been bending backwards and are more than willing to accommodate these companies even at the cost of the population's health and well-being simply because of the immense kickbacks that these multinationals offer.

# **AN AWFUL STATUS QUO**

<sup>-</sup>t is time for Israel to recognise the force of the rapidly growing international movement to recognise Palestinian statehood, not as the final outcome of a political settlement but as a path to achieving it. Were Israel to get serious again about pursuing a two-state solution, it would not be rewarding Hamas, but benefiting itself.

The awful reality, as the horrendous attacks of 7 October, 2023, made clear, is that without a political solution that satisfies legitimate Palestinian aspirations, Israel will never be free of the spectre of terrorism.

with conflict prevention and resolution, including years of talking to all sides in the Middle East have drummed home the truth that despair can all too easily turn into rage, and then into indefensible outrage. By the same token, the threat of violence diminishes rapidly during those periods of genuine hope for a just and dignified settlement.

To understand the roots of 7 October is not to justify the slaughter of innocents, then or ever. Israel was undoubtedly entitled to respond with all the force that international law allows. But for Israeli Prime Minister Binyamin Netanyahu's government - and those who blindly support it – to remain in denial about those roots, and to offer no political way forward, is simply to invite more of the same. This is especially true now that so many ordinary. decent Palestinians have been displaced, traumatised, and angered by the disproportionate savagery of the Israeli response.

As I have argued elsewhere, the moral, legal, and political case for recognising Palestinian statehood has always been strong. Some 140 United Nations member states - albeit nearly all of them from the Global South have already done so. The Gaza war has now lent the issue new relevance and urgency. More and more countries see Israel's intransigence as not only perpetuating Palestinian misery but also guaranteeing its own. Australia, in a pathbreaking

speech by Foreign Minister Penny Wong on 9 April, became

The international community should make it a top priority

the latest of a host of formerly cautious countries - including the United Kingdom, Ireland, Spain, Norway, and even the United States - to make clear that it is actively considering early recognition of Palestinian statehood. True, the timing is an issue. With UN votes on full membership for Palestine expected at the Security Council and in the General Assembly this month, the US and some others may not yet be willing to issue formal declarations. Nonetheless, the direction of travel is clear, and momentum is building.

Many argue, nonetheless, that recognition of Palestinian statehood is an empty, quixotic gesture. Practically, a two-state solution now looks unattainable, owing to the territorial fragmentation created by Israel's increasingly unrestrained West Bank settlementbuilding programme. And Israeli hostility to a two-state solution, and Palestinian support for its own one-state solution, have both grown steadily and likely become more entrenched since 7 October.

All true enough, but the dream of a two-state solution must be kept alive, not only because it remains overwhelmingly the preferred policy internationally. but also because it is so obviously in Israel's own long-term interest. As many commentators over the years have pointed out,

Israel potentially can be a Jewish state, a democratic state, and a state occupying the whole of historical Judea and Samaria. But it cannot be all three at the same time. (This was a favourite line of my old boss. Australian Prime Minister Bob Hawke, in offering tough love to the Jewish community in Australia.)

The argument for recognising Palestinian statehood is that doing so is vital to restore a balance that has tipped overwhelmingly in favour of Israel. No peace negotiation can succeed if the parties at the table are completely mismatched. For the foreseeable future, the best – and possibly the only – way to counter the current mismatch is to show that Palestine has legitimacy not only in the Islamic world and the Global South, but globally, including in traditional pillars of the Global North, like the UK, Australia, and other US allies and partners.

While it is not necessary for a state to be recognised as such to have a government in effective control of its entire territory, the issue is made more complicated by governance problems on the Palestinian side. The Palestinian Authority is a gerontocracy in desperate need of reform, and Hamas has dealt itself out of any international acceptance with its military wing's terrorist excesses.

Constructing a viable pan Palestinian government - preferably with the support of key regional players - will certainly be a long haul. I am among those who have long believed that the imprisoned Palestinian activist Marwan Barghouti – popular in both Gaza and the West Bank - could be the Mandela-like unifier that Palestinians desperately need. But for precisely that reason, persuading Israel to release him will be a Herculean task, at least as long as Netanyahu remains in power.

Regardless of whether the two-state solution proves to have any life left in it, conferring Palestine the extra legitimacy, leverage, and bargaining power inherent in recognised statehood would help achieve for both sides a future that is bet ter than the awful status quo.

If it does still have life, as we must all hope, Palestinian leverage will be crucial in producing just and sustainable solutions to the big outstanding issues, including those concerning boundaries, credible security guarantees for both sides, the protection of holy sites, and the fraught question of refugee rights.

But even if the only remaining option is to negotiate a new, democratic, non-apartheid single state (in which Palestinians enjoy fully equal rights alongside Israel's Jewish population), giving Palestinians more legitimacy and heft at the bargaining table serves the goal of securing a sustainable peace.

At a time of dramatically height ened tension with Iran, and all the renewed sense of insecurity that comes with it, it has never been more important for Israel to defuse the visceral anger of Palestinians in the Occupied Territories. Most of the rest of the world is now telling Israel that the best way to start is to accept the force of Palestinians' claim to statehood. If Israelis really want a more secure future, it is time for them to listen.

Kolkata, April 21: Dynastic politics has been a prominent feature of Indian democracy, but its increased presence in Bengal this Lok Sabha election marks a significant departure from the state's tradition of cultivating leaders from grassroots politics

West Bengal BJP spokesperson Samik Bhattacharya said the party has been vocal against dynasty politics, but in the case of Thakur and Soumendu Adhikari, both are well-known leaders. "Both are leaders in their own right and got party tickets based on their winnability," he said.

Although political dynasties have been prevalent in Bengal politics since pre-independence era, post-independence, especially since the late Fifties, student politics was considered the breeding ground for next-generation politicians.

CM Mamata Banerjee, former CM Buddhadeb Bhattacharya, Left Front chairman Biman Bose, and Congress leaders Somen Mitra and Priya Ranjan Dasmunsi are products of student politics.

Political scientist Biswanath Chakraborty said the trend of dynasty politics will gain momentum due to a lack of leaders emerging from campuses.

"Earlier, colleges and universities were breeding grounds for the next-generation politicians. But except for Presidency College and Jadavpur University, none of the universities and colleges had a student body election in last five years. So there is hardly any new batch of leaders, forcing the political parties to rely on dynasties," he said.



Chennai, April 21: The first synchronised census of the endangered Nilgiri tahr will commence April 29 and around 700 personnel, including volunteers and officials, will participate in the exercise that will take three days.

The Kerala Forest Department will also be part of the survey. The Nilgiri tahr habitat is spread across 13 forest divisions, 100 beats and 140 blocks. The terrain in some of the areas is highly challenging.

The volunteers are chosen based on physical fitness and



past trekking experience, besides having a wildlife conservation background.

The World Wide Fund for Nature - India (WWF-India), which has been studying the Nilgiri tahr for several years, the Wildlife Institute of India (WII) and the Advanced Institute of Wildlife Sciences (AIWC) will be part of the synchronised survey.

WWF-India in association with the Tamil Nadu forest department in a study found that the Nilgiri tahr has become locally extinct from around 14 per cent of its shola-grassland habitat within the past few decades.

An official with the Tamil Nadu Forest Department told IANS that necessary training on the synchronised census of the Nilgiri tahr has been given to personnel of the Coimbatore, Pollachi, Gudalur, Udumalpet and Kanniyakumari forest range. He also said that training for

personnel in the Mudumalai and Sriviliputhur forest ranges will be completed Monday. It may be recalled that Tamil

Nadu Chief Minister MK Stalin had launched Project Nilgiri tahr nine months ago.

An officer with the Project Nilgiri tahr while speaking to IANS said, "The project team was able to identify and catalogue nine major plant species and three grass varieties that the Nilgiri tahr predominantly feed on.'

The official added that the identification and cataloguing were very important for habitat assessment as the main goal is reintroducing this endangered species in their original habitat.

The Tamil Nadu forest department had successfully radiocollared a Nilgiri tahr a month ago in Mukurthi National Park. The department said that the radio collaring has already givenseveral valuable insights about the animal.



# CHHATTISGARH LIQUOR SCAM **ED** arrests ex-IAS officer

Raipur, April 21: Days after filing a fresh case, the Enforcement Directorate Sunday arrested retired Chhattisgarh IAS officer Anil Tuteja in connection with a Rs 2,000 crore alleged liquor-scam linked money laundering case in the state, officials said

The federal agency detained the 2003-batch officer from the Economic Offences Wing (EOW)/Anti Corruption Bureau (ACB) office in Raipur Saturday evening where the bureaucrat and his son Yash Tuteja had gone to record their statements in the same case.

They were issued a summons by the ED at the EOW/ACB office to join the investigation and record their statements following which they were taken to the central agency's office here. The retired IAS officer was questioned and was taken into custody in the early hours of Sunday under the provisions of the Prevention of Money Laundering Act (PMLA). Yash Tuteja was allowed to leave after questioning.

Anil Tuteja was produced before a jurisdictional magistrate that sent him to one-day judicial custody, ED counsel Saurabh Pandev said. He added that theagency had sought 14-day custody of Tuteja from the magistrate.

Court declares marriage invalid due to husband's 'relative impotency'

Mumbai, April 21: The Aurangabad bench of the Bombay High Court has annulled the marriage of a young couple that could not consummate it due to the man's 'relative impotency', noting their agony of frustration cannot be ignored.

A division bench of Justices Vibha Kankanwadi and S G Chapalgaonkar in the judgment April 15 also noted that this was a fit case to help "young sufferers of marriage" who could not connect with each other mentally, emotionally or physically.

A 27-year-old man had approached the bench after a family court in February 2024 refused an application filed by his 26-year-old wife, seeking to annul the marriage on the admission

#### stage itself.

The high court in its order said the expression 'relative impotency' is a known phenomenon and is different from the normal impotency, which means the inability to copulate in general.

Relative impotency broadly points to a situation where a person might be capable of having intercourse but incapable of performing it with the spouse. The court said there could be various physical and mental causes for such relative impotency.

"In the present case, it can be easily gathered that the husband has relative impotency qua (towards) the wife. The reason for non-consummation of the marriage is this apparent relative impotency of the husband," the



HC said.

The high court said it could not ignore the fact that this was a matter concerning a young couple who faced the agony of frustration in the marriage. The man may have initially

blamed his wife for non-con-

summation as he was hesitant to admit he had relative impotency towards her, it said.

"However, subsequently, he candidly admitted the same, being satisfied with the fact that it would not put lifelong stigma on him. The relative impotency is somewhat different than the general notion of impotency and the acceptance of relative impotency would not brand him impotent in general parlance," the HC said.

The couple got married in March 2023 but separated after 17 days. The couple said their marriage was not consummated. The woman claimed the man had declined physical relations with her.

In her plea seeking for annulment of marriage filed before the family court, the woman said the man had 'relative impotency'. She said they could not connect with each other mentally, emotionally, or physically.

The man initially filed an affidavit before the family court stating that the marriage was not consummated but blamed

the woman for it. He later submitted a written statement admitting relative impotency.

The man claimed he was unable to establish physical relations with his wife but otherwise he was normal. In the statement, he said he did not want any stigma that he was impotent in general.

Following this, the wife filed an application seeking the family court to decide the divorce plea at the admission stage itself as per provisions of the Civil Procedure Code instead of conducting a trial.

The family court, however, rejected the application claiming the man and woman had raised collusive claims. The HC bench quashed the family court order and annulled the marriage declaring it null and void.

Nur Shams, April 21: Israeli strikes on the southern Gaza city of Rafah overnight killed 22 people, including 18 children, health officials said Sunday, as the United States was on track to approve billions of dollars of additional military aid to Israel, its close ally.

Israel has carried out neardaily air raids on Rafah, where more than half of Gaza's population of 2.3 million has sought refuge from fighting elsewhere. It has also vowed to expand its ground offensive against the Hamas militant group to the city on the border with Egypt despite international calls for restraint, including from the US.

The first Israeli strike in Rafah killed a man, his wife and their 3-year-old child, according to the nearby Kuwaiti Hospital, which received the bodies. The woman was pregnant and the doctors managed to save the baby, the hospital said.

The second strike killed 17



children and two women, all from an extended family, according to hospital records. Mohammed al-Beheiri said his daughter, Rasha, and her six children, the youngest 18 months old, were among those killed. Her husband's second wife and their three children were still under the rubble, al-Beheiri said. The Israel-Hamas war has

killed over 34.000 Palestinians. according to local health officials, devastated Gaza's two largest cities and left a swath of destruction. Around 80 per cent of the ter-

ritory's population have fled to other parts of the besieged coastal enclave.

The \$26 billion aid package approved by the House of Representatives Saturday includes around \$9 billion in humanitarian assistance for Gaza, which experts say is on the brink of famine. The Senate could pass the package as soon as Tuesday, and President Joe Biden has promised to sign it immediately.

## Sanctions on soldiers: Israel hits out at US

Tel Aviv: Israel Prime Minister Benjamin Netanyahu has denounced a reported move by US to issue sanctions against the Netzah Yehuda battalion of the Israel Defense Forces (IDF). The sanctions, according to reports, are for alleged human rights violations committed against Palestinians in the West Bank by the battalion's soldiers. There are reports that the Biden administration is set to blacklist the battalion considered elite by the IDF. "The Israel Defense Forces (IDF) must not be sanctioned. Our soldiers are fighting terrorist monsters, and the intention to impose sanctions on an IDF unit is the height of absurdity and a moral nadir (the lowest point)," Netanyahu said in a statement Saturday night. "The government of Israel that I lead will act with all means against these moves," he said. Israeli ministers Itamar Ben Gvir and Bezalel Smotrich also slammed the US move. "Imposing sanctions on our soldiers is a red line," Gvir said, adding that the move was extremely serious and "The members of the Netzah Yehuda must be protected." He also called upon the Israeli Defence Minister, Yoav Gallant, considered a hawk in the Israeli government, not to submit before the US diktat. Finance Minister Bezalel Smotrich in a statement on social media platform, X, came out strongly against the US plans to impose sanctions on Netzah Yehuda. "The move to sanction IDF battalion, while Israel is fighting for its existence is complete madness. This is part of a planned move to force the State of Israel to agree to the establishment of a Palestinian state and to forsake Israel's security," he said.

# Delhi-born man in **London Mayor race**

## 'Apple may employ 5L in India in 3 yrs'

# **Direct tax collection jumps 17.7%**

New Delhi, April 21: India's net direct tax collections surged by a massive 17.7 per cent year-on-year to ₹19.58 crore in the fiscal year ended March 2024, surpassing even revised estimates by a wide margin, the tax department said Sunday.

Net collections of income and corporate taxes, which make up for most of the direct taxes, in 2023-24 financial year exceeded the Budget estimates by ₹1.35 lakh crore (7.40 per cent) and the revised estimates by ₹13.000 crore.

The government had raised the target for direct tax collection in FY24 (April 2023 to March 2024) to ₹19.45 lakh crore in the interim Budget presented February 1.

With this, the gross tax collection target as per the revised estimate stood at ₹34.37 lakh crore for FY24.



While gross direct This tax collections (provisional) for the growth FY 2023-24 rose surpassed even 18.48 per cent to ₹23.37 lakh crore, the most optimistic net proceeds revised (after accounting for refunds) surged estimates 17.7 per cent to ₹19.58

lakh crore, reflecting buoyancy in the economy and rise in income levels of individuals and corporates. Refunds aggregating to ₹3.79 lakh crore have been issued in

FY 2023-24, the CBDT said in a statement. "The provisional figures of Direct Tax collections for the financial year (FY) 2023-24 show that net collections are at ₹19.58 lakh crore, compared to ₹16.64 lakh crore in the preceding fi-

nancial year i.e. FY 2022-23," it said, adding the Budget for 2023-24 fiscal had pegged the collec-

tions for the year at ₹18.23 lakh crore, which were revised to ₹19.45 lakh crore later. "The provisional Direct Tax collections (net of the refunds) have exceeded the Budget Estimate by 7.40 per cent and Revised Estimates

by 0.67 per cent," it said. The gross collection (provi-

sional) of Direct Taxes (before adjusting for refunds) for the FY 2023-24 stood at ₹23.37 lakh crore, showing a growth of 18.48 per cent over the gross collection of ₹19.72 lakh crore in FY 2022-23.

The gross corporate tax collection (provisional) in FY 2023-24 was up 13.06 per cent to ₹11.32 lakh crore as compared to the gross corporate tax collection of ₹10 lakh crore of the preceding year.

The Net Corporate Tax col-

lection (provisional) in FY 2023-24 at ₹9.11 lakh crore showed a growth of 10.26 per cent over the net corporate tax collection of ₹8.26 lakh crore of the preceding year.

The Gross Personal Income Tax collection including Securities Transaction Tax (provisional) in FY 2023-24 at ₹12.01 lakh crore was up 24.26 per cent over previous year's collection of ₹9.67 lakh crore.

The Net Personal Income Tax collection including STT (provisional) in FY 2023-24 at ₹10.44 lakh crore showed a growth of 25.23 per cent over preceding fiscal year's figure of ₹8.33 lakh crore.

Refunds of ₹3.79 lakh crore have been issued in the FY 2023-24 showing an increase of 22 74 per cent over the refunds of ₹3.09 lakh crore issued in FY 2022-23, the statement added.

Even the indirect tax collection for FY24 has exceeded the revised estimates (RE) of ₹14.84 lakh crore by "a handsome margin", helped by a record GST mop-up, a top government official said.

CBIC chairman Sanjay Kumar Agarwal, in a letter to field officials, recently said, "I am happy to inform that the indirect tax collections for the Financial Year 2023-24, including Customs and Union Excise Duty have exceeded the Revised Estimates by a handsome margin.'

# TWEAKS IN INDIA-MAURITIUS TAX TREATY FPIs withdraw over ₹5,200cr in April so far

New Delhi, April 21: Foreign investors dumped domestic equities worth over ₹ 5,200 crore in April so far on concerns over tweaks in India's tax treaty with Mauritius, which would now impose higher scrutiny on investments made here via the island nation.

This came following a staggering net investment of ₹ 35,098 crore in March and ₹1,539 crore in February, data with the depositories showed.

According to the data with the depositories, Foreign Portfolio Investors (FPIs) made a net outflow of ₹ 5,254 crore in Indian equities this month (till April 19).

The major trigger for FPI selling was the tweak in India's tax treaty with Mauritius, which would now impose higher scrutiny on investments made in India via the island nation. Himanshu Srivastava, Associate Director, Manager Research, Morningstar Investment Research India, said.

The two nations have reached a consensus on a protocol amending a double taxation avoidance agreement (DTAA). The protocol specifies that tax relief cannot be utilized for the indirect advantage of residents from another country. In fact, most of the investors investing through

Mauritius entities into Indian markets are from other countries, he added.

Additionally, hotter-than-expected US inflation and the consequent spike in bond yield (the 10-year rising above 4.6 per cent) led to big selling in the Indian market, VK Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said.

Another major concern is the surcharged geopolitical situation in the Middle East with heightened tensions between Iran and Israel, he added.

Since domestic institutional investors (DIIs) are sitting on huge liquidity and the retail and high net-worth individual (HNI) investors in India are highly optimistic about the Indian market, FPI selling will be largely absorbed by domestic money.

Apart from equities, FPIs withdrew ₹6,174 crore from the debt market during the period under review.

Before this, foreign investors invested ₹13,602 crore in March, ₹22,419 crore in February, and ₹19,836 crore in January.

# Top Indian firms lose $\pm$ ₹1.40L-cr in m-cap

The market valuation of TCS tanked by ₹62,538.64 crore to ₹13,84,804.91 crore, the most among the top 10 firms. Infosys faced an erosion of ₹30,488.12 crore from its valuation which stood at ₹5,85,936.45 crore. Shares of Infosys Friday ended nearly 1 per cent lower after the company's revenue growth guidance for FY25 failed to meet market expectations. The market capitalisation (mcap) of ICICI Bank diminished by ₹26,423.74 crore to ₹7,49,023.89 crore and that of State Bank of India declined by ₹14,234.76 crore to ₹6,70,059.86 crore. The valuation of ITC slumped ₹6,616.9 crore to ₹5,30,350.97 crore and that of Hindustan Unilever went lower by ₹176.22 crore to ₹5,24,487.51 crore However, Bharti Airtel's mcap zoomed ₹37,797.09 crore to ₹7.30.658.36 crore and that of HDFC Bank climbed ₹9,420.17 crore to ₹11,63,314.93 crore. Reliance Industries added ₹4,397.82 crore taking its valuation to ₹19,90,195.52 crore and the mcap of LIC advanced ₹1,201.75 crore to ₹6,15,453.90 crore. # Land deals on upswing

New Delhi: Builders and other entities have closed at least 29 land deals involving 721 acres during January-March this year to expand their businesses amid surge in demand especially for housing, according to Anarock. During the entire 2023-24 fiscal, property consultant Anarock said that real estate developers and other entities have closed 101 land deals, cumulatively accounting for 2,989 acres. Land deals in terms of acres have increased 61 per cent annually in January-March 2024 and 58 per cent annually in 2023-24. At least 26 land deals for around 449 acres were closed during January March 2023, while 88 land deals for 1.886 acres were struck during the full 2022-23 fiscal. These land deals, which were struck across major tier I, tier II and tier III cities, include outright purchase-sale transactions and also partnerships with landlords called Joint Development Agreements (JDAs).

# Oil, LNG prices to shoot up if Tehran blocks Strait of Hormuz

India, which is more than

85% dependent on overseas suppliers to meet its crude oil needs, imports oil from Saudi, Iraq and UAE as well as liquefied natural gas (LNG) from *Qatar through the* Strait of Hormuz

New Delhi, April 21: Oil and LNG prices are likely to shoot up if Iran is to block Strait of Hormuz, through which countries like India import crude oil from Saudi Arabia, Iraq and UAE, leading to a spike in inflation, analysts said on the Iran-Israel conflict In a note, Motilal Oswal

Financial Services said while de-escalation efforts will likely control the crisis, oil and LNG prices will spike in case Iran



completely or partially blocks the Strait of Hormuz.

The Strait of Hormuz is a narrow sea passage between Oman and Iran. It is about 40 km wide at the narrowest point, with 2 km of navigable channels for incoming and outgoing ships. It is the key route through which crude oil is exported by Saudi Arabia (6.3 million barrels per day), the UAE, Kuwait, Qatar, Iraq (3.3 million bpd) and Iran (1.3 million bpd).

Oil flow via the Strait was 21 million barrels per day or 21 per cent of global oil consumption in 2022. Also, about 20 per cent of global LNG trade moves through it, including almost all LNG exports from Qatar and the UAE

Unlike oil, for which alternative routes via the Red Sea are available, no alternative routes are available for liquefied natural gas, it said. In the event of blockade of the Strait, "we anticipate materially higher crude oil prices, refining margins, and spot LNG prices", it said.

While alternative routes do exist, they may only be able to accommodate a fraction (around 7-8 million bpd of crude oil/refined products) of the volume currently passing through the Strait (21 million bpd), and that too at elevated freight costs.

"While investors focus on oil, we believe that spot LNG prices will witness even sharper escalation if the Strait of Hormuz is closed due to the absence of alternative routes," it said.

Both Saudi Arabia and the UAE have alternative export routes, which avoid the Strait. Saudi Arabia has the East-West pipeline with a capacity of 7 million bpd, according to the IEA. However, this pipeline opens up into the Red Sea, where traffic flow has already been disrupted due to attacks by Houthi rebels. The UAE has onshore oil fields linked with Fujairah export

terminal with a capacity of 1.5 million bpd; however, of this, 30-40 per cent capacity is already

being utilized as per the IEA. Hardik Shah, Director, CareEdge Ratings, said the crude prices were on an increasing trend since the start of calendar year 2024.

"In case the situation worsens between Israel and Iran, it may lead to a spike in crude prices."Moody's Analytics in an April 15 report said the escalation of tensions in the Middle East poses a significant threat to Asia-Pacific economies. "The key risk comes from higher oil prices". Higher oil prices, it said, threaten to derail the region's already choppy progress on inflation.

"Most Asia-Pacific economies are net oil importers, leaving them vulnerable to global oil spikes. Impacts vary across countries, but broadly there are three main challenges from rising oil prices,

Toronto, April 21: Teenaged Indian Grandmaster D Gukesh shot into sole lead after defeating Firouzja Alireza of France in the 13th and penultimate round of Candidates Chess tournament here Saturday. The victory placed him on the cusp of becoming the youngest ever World Championship contender.

If the 17-year-old from Chennai emerges victorious at the Candidates, he will take on China's Ding Liren for the World Champion's crown.

#### In the women's event, Humpy Koneru drew with Anna Muzychuk while Vaishali Rameshbabu got the better of Lei Tingiie. The 22-year-old Vaishali has now registered four consecutive wins in her last four games. Needing a win to go ahead

after the other overnight leaders, Russian Ian Nepomniachtchi and American Hikaru Nakamura played out a quick draw, Gukesh was awarded for his perseverance as he capitalised on a late blunder by Alireza in a difficult situation. Gukesh took his tally to 8.5 points out of a possible 13 to emerge a half point ahead of Nepomniachtchi, Nakamura and Fabiano Caruana of the United States. R Praggnanandhaa and Vidit

Gujrathi share the fifth spot on six points apiece with Firouzja on 4.5 and Abasov has 3.5 points. Gukesh will next meet Nakamura who plays white in the last round game and Caurana will have the advantage of the

favourable colour against Nepomniachtchi. While anyone among the four

players can win the event, the

odds are hugely in favour of Gukesh as the pundits believe that a draw might just be enough to see him emerge as the youngest ever contender for the World Championship match.

Gukesh, by consent, is made for big games on his day and the 13th round was no different. Playing the white side of a Berlin defense out of a Ruy Lopez, Gukesh went for a line known to have a sound reputation with little risk for white.

It was on the 47th move that Alireza finally faltered and allowed Gukesh to reach a winning Rook and minor piece endgame. Gukesh knocked down a few pawns en route to finishing the technicalities in style. The game lasted 63 moves.

Nepomniachtchi decided against taking a risk even as Nakamura chose a rare variation as black in another Ruy Lopez of the day. The Russian had reasons to be pleased as his position was preferable in the middle game but the absence of any real threats did not leave much to be desired. Nakamura drew vide repetition in a mere 26 moves.

Praggnanandhaa was outdone out of a Rossolimo opening as white against Caruana and lost in 89 moves, the longest game played on the day.

Shanghai, April 21: Max Verstappen rounded off a dominant weekend with victory in the first Chinese Grand Prix for five vears here Sunday to extend his World Championship lead. The three-time World Champion controlled the race on its return to the Shanghai International Circuit for the first time since 2019 to finish 13.7 seconds ahead of McLaren's Lando Norris with Red Bull teammate Sergio Perez third.

Verstappen was only denied a 100 per cent points-scoring weekend when Fernando Alonso picked up the bonus for the fastest lap around the 5.451 kilometres track on the outskirts of the Chinese megacity after a late switch to fresh tyres. It was Verstappen's fourth Grand Prix title this season. Only a rare brake failure in
