#### 10 Naxals killed in **Chhattisgarh encounter**

Narayanpur/ Raipur: Ten Naxalites including three women were killed in an encounter with security forces on the border of Narayanpur and Kanker districts of Chhattisgarh Tuesday morning, police said. This was a second major blow to the Naxalites within 15 days. The site of Tuesday's encounter was 30 km south of Kalper village in Kanker where 29 Naxalites were killed in a gunfight with security forces April 16, said a senior police official.

#### **NAVEEN FILES NOMINATION** FROM HINJILI

Berhampur, April 30: Ruling Biju Janata Dal (BJD) president and Chief Minister Naveen Patnaik Tuesday filed his nomination papers for the Odisha Assembly elections from Hinjili seat in Ganjam district.

Accompanied by ministers and party leaders including his close aide VK Pandian, the chief minister reached the sub-Collector's office at Chhatrapur and submitted his papers for the sixth time seeking re-election from the Hinjili Assembly segment.

Patnaik has earlier been elected as a legislator from the Hinjili Assembly segment five times in a row since 2000. Hinjili comes under the Aska Lok Sabha seat and will go to polls, May 20. Along with Hinjili, Patnaik, this time will also contest from the Kantabanji Assembly segment

# **Parties neglect health**

In what came as a severe beating to the tom-tommings of the BJP-led Union government about revving up public health and wellness of citizens through a slew of schemes ahead of the elections, the chief of the Indian Medical Association (IMA) Dr RV Asokan Tuesday termed the flagship Ayushman Bharat health insurance programme as 'poorly structured and underfunded'. He said the pompous scheme, structured by NITI Aayog and bureaucrats, failed to give anything 'new' to the patients. He also took a dig at the political spectrum for their 'all is well'attitude, and relegating 'health' to the state of an 'orphan' in their scheme of things, despite the lessons taught by Covid pandemic

New Delhi, April 30: Terming health an 'orphan', Indian Medical Association chief Dr RV Asokan says no lessons have been learnt after the Covid crisis and it doesn't figure as a top priority for political parties with everyone in the 'all is well' zone.

In an interaction with PTI editors, Asokan also described the government's flagship Ayushman Bharat health insurance scheme as 'poorly structured and underfunded' and called for increasing investments in the health sector.

"Health is an orphan. Nobody wants to talk about health even after the Covid pandemic, where it was acutely felt even as a matter of internal security. We have



not learnt any lessons. We continue to be in the same 'all is well'zone," he said. "Health sadly does not figure among the top priorities of political parties," Asokan said in response to a question on attention to the sector during the ongoing elections.

Dwelling at length on the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), Asokan said it had 'great vision' and there were great expectations from it.

'But it was structured poorly and underfunded to the extent that it will collapse. Why I say this is because it was envisioned by the prime minister for people below the poverty line but perhaps it was structured by the NITI Aayog and bureaucrats," Asokan said.

"The care in government hospitals is already free. So what is the new that the patient gets? Whether it is routed through the government hospital or through Ayushman Bharat, the patient does not get anything new. So the goodwill that had to be generated in the public did not develop. That political dividend didn't occur," Asokan added.

"As per the calculations that

they themselves have given before the nation, we need at least Rs 1.6 lakh crore annually to run that scheme. It started with Rs 6,800 crore. And it is now Rs 12,000 crore," he stated. The IMA president said they would like the government to be in charge of ealth, invest in public hospitals, and in public infrastructure and public human resources.

"Whatever has been invested in health is too inadequate. The people spend around 3.9 per cent of the GDP on health. The Central and state governments put together spend 1.1 to 1.3 per cent of the GDP, which is inadequate," he said.

He cited a 2011 high level expert group report on Universal Health Coverage for India by the erstwhile Planning Commission to say that the government has to ensure a basic package for all citizens, whether poor or rich. "Beyond that, they can buy care," Asokan explained.

The same document stated that the government should buy strate gically from the private sector for people below the poverty line. "And the 2021 report titled Health Insurance for India's Missing Middle by NITI Aayog said 10 per cent of Indians can pay for themselves, 25 per cent will be taken care of by the Ayushman Bharat scheme and the rest of them, which amounts to around 90 crore, are being thrown to private health insurance," he said.

He added, "After 10 years of the Planning Commission document, throwing us to the insurance industry is not acceptable.

#### **Australia examines** possible toxicity of Indian spices

Hyderabad/New Delhi, April 30: Australia's food safety agency is collecting information on the possible contamination of spice mixes sold by Indian companies MDH and Everest to decide if a food recall is required, it said. Tuesday, the latest regulator to step up scrutiny.

Hong Kong suspended sales this month of three MDH spice blends and an Everest mix for fish curry. Singapore ordered a recall of the same Everest mix as well, flagging high levels of ethylene oxide, which is unfit for human consumption and a cancer risk over long exposure

"We are working with international counterparts to understand the issue and with federal, state and territory food enforcement agencies to determine if further action is required in Australia,' Food Standards Australia New Zealand said in a state-

Such action could include a recall, it said, adding, "Ethylene oxide is not permitted to be used as a treatment for foods sold in Australia'

MDH and Everest did not immediately respond to Reuters' requests for comment. They have previously said their products are safe for consumption.

Their spice brands, among the most popular in India, are also sold in Europe, Asia and

### SC questions ED on timing of Kejri's arrest binations from Wednesday.

New Delhi, April 30: Terming life and liberty as 'exceedingly important', the Supreme Court Tuesday questioned the Enforcement Directorate (ED) on the timing of Delhi Chief Minister Arvind Keiriwal's arrest ahead of the general elections in the excise policy-linked money laundering case.

A bench of Justices Sanjiv Khanna and Dipankar Datta, which continued hearing on the Keiriwal's plea challenging his arrest for the consecutive day, posed several queries to Additional Solicitor General S V Raju, appearing for the ED, and sought his reply, Friday.

"Life and liberty are exceedingly important. You can't deny that," the bench told Raju and sought his reply, saying, "The last question is with regard to the timing of the arrest, which they have pointed out, the timing of the arrest, soon before the general elections.

The bench also flagged the long time gap between initiation of adjudication proceedings in the case and the action of arrest, saying the Section 8 of the Prevention of Money Laundering Act (PMLA) provides a maximum limit of 365 days. The apex court is likely to continue hearing on Kejriwal's plea on Friday as the two judges will be sitting in different com-

It said, "Mr. Raju, we have some questions, which we would like you to answer, when you

make your submissions. First is without there being any adjudicatory proceedings, can the ED initiate a criminal proceedings in view of several judge ments of this court on PMLA. The bench said in this case

there are no proceedings of attachments so far and if there are any such proceedings, then the ED will have to show how petitioner (Kejriwal) is connected to it. Justice Khanna said the ver-

dict on the bail plea of former deputy chief minister Manish Sisodia, who is in custody in the excise policy scam case, was divided into two parts – the first part was in favour of Sisodia and the second part was against him. "You (Raju) have to tell us

which part of Sisodia verdict does the petitioner (Kejriwal) case lie," the bench said. Justice Khanna said the third

important question relates to ED's power of arrest as it is the reason why Kejriwal has repeatedly approached the court.

"Look, they have not openly stated but it is quite apparent why they are repeatedly coming up against the remand because what they believe is that the threshold of section 19 of PMLA casts an onus on the prosecution and not on the accused,"







The maximum temperature in Angul was 44.7 degrees Celsius, followed by Talcher, Dhenkanal and Jajpur at 44.5 degrees Celsius. Boudh was at 44.3 degrees Celsius, while Jharsuguda, Cuttack and Kendrapara were at 44.2 de-

grees Celsius. The weather office issued a alert for Mayurbhanj, Keonjhar, Sundargarh, Jharsuguda, Angul,

Dhenkanal, Balasore, Bhadrak, Jajpur, Cuttack and Boudh districts for May 1. Amid the heat, campaigning is in full swing for the elections in the state.

Odisha will vote in the Lok Sabha elections and Assembly polls simultaneously in four phases, starting on May 13. There are 21 Lok Sabha seats in the state and a 147-member

# **Naveen files nomination** from home turf Hinjili

Berhampur, April 30: Ruling Biju Janata Dal (BJD) president and Chief Minister Naveen Patnaik filed his nomination papers for the Assembly elections from Hinjili seat in Ganjam district, Tuesday.

Accompanied by ministers and party leaders, including his close aide Kartik Pandian, Patnaik reached the sub-collector's office at Chhatrapur and submitted his papers for the sixth time seeking re-election from the Hinjili Assembly segment.

Patnaik has earlier been elected as a legislator from the Hinjili Assembly seat five times in a row since 2000.

Hinjili will go to the polls May 20. Along with Hinjili, Patnaik, this time will also contest from Kantabanji in Bolangir district.

Patnaik had won the Hinjili seat for the first time in 2000 by a margin of 29,826 votes. In 2004, his winning margin increased to 42,642 and in the 2009 and 2014 elections, it went up to 61,773 and 76,586, respectively.

In 2019, he won the seat by a margin of 60,160 votes. In all these elections, Patnaik's vote

share has never dropped below 65 per cent, official sources said.

Earlier, Patnaik sought blessings at Maa Tara Tarini, the presiding deity of the locality ahead of filing nominations for the election. Meanwhile, BJD candidate from Sambalpur Lok Sabha seat Pranab Prakash Das, who is also the organisational secretary of the BJD, also filed his nomination paper for the Lok Sabha elections from Sambalpur seat.

Patnaik wished Pranab Prakash Das, who is popularly called 'Bobby'.

"All the best Bobby. I am sure you will win," the BJD chief said in a video message to Das, who has been pitted by the ruling party against BJP leader and Union Minister Dharmendra Pradhan in Sambalpur.

BJD vice-president Debi Prasad Mishra also filed his nomination papers from the Badamba Assembly segment in Cuttack district.

Former India Hockey captain Dilip Tirkey also filed his nomination papers from the Sundargarh Lok Sabha seat as BJD candidate.

# Puri rly stn to showcase chariot wheels

New Delhi, April 30: Indian Railways will procure three wheels, one each from the three chariots that represent the famous Rath Yatra, to place them at the centre of the concourse of Puri railway station that is being redeveloped under Amrit Bharat Station Scheme.

"Every year when Rath Yatra ends, the three chariots are dismantled and the timber is used in the temple kitchen to cook "Kotha Bhoga" (dishes for the gods)," said Manonjaya Rath, one of the principal architects from Rath Architectonic that has designed the new station.

He added, "However, the Indian Railways, in accordance with our design, will procure one wheel from each of the three chariots from the upcoming Rath Yatra to be held in late June or early July this year and these will be placed in the world-class railway station at Puri."

Puri railway station is one of the 1,321 stations of the country which is being redeveloped to offer world-class passenger amenities under Amrit Bharat Station Scheme, and it is ex-

pected to be ready by July 2024. As per the approved design plan, the three wheels would be placed at the centre of the concourse at the Puri railway station.

"This installation will serve as a gateway to the holy city of deities (Jagannath, his brother convenience of passengers.



Puri for all devotees and tourists arriving at the station. Not only will it reflect the history and traditions of the city, it will also invoke a religious and spiritual feeling in the mind of the devotees even before visiting the Jagannath Temple," said Manonjaya.

Prateek Rath, another principal architect, said that the Puri station has been conceptualised by taking the local culture into consideration and the 'Three Chariot Wheel' concept has been integrated into the concourse of the railway station.

Balabhadra and sister Subhadra) are drawn by a multitude of devotees in three massive, wooden chariots to Gundicha temple whereby they reside there for a week and then return to the Jagnannath Temple," Prateek said, highlighting the religious aspects of the festival.

He added, "This festival celebrates Lord Jagannath's journey with his brother Balabhadra and sister Subhadra from the Jagannath Temple to their aunt's house, the Gundicha temple.'

In January this year, the East Coast Railway Zone, in a press briefing, had announced that the redeveloped Puri railway station would reflect the traditional architectural features of the famed Srimandir and have all modern amenities for the

Railway officials said that the station is being rebuilt in accordance with the Kalinga architecture that originated in the fourth century BC and since the iconic Jagannath Temple is a living example of Kalinga style of architecture, the exterior of the station will reflect that.

The Indian Railways awarded the station redevelopment contract to Rath Architectonic in July 2022 and the construction work was started in January

According to Prateek, the station is being redeveloped keeping in mind the passenger footfall 40 to 50 years from now.

"At present, around 6,000 to 7,000 passengers arrive at the station daily. The redevelopment will enhance the capacity to 40,000, which is the projected footfall in 2060-65," Prateek said.

"Our aim is to make the station a monument so that people, who come to visit the Puri temple, carry that feeling of grandness till the railway station while leaving the city," he added.

As per the redevelopment plan,

the station is proposed to have three floors with world-class amenities, starting from easy access to the station, convenient and spacious parking to accommodate more than 500 cars. energy-efficient building, physical as well as automatic ticket counters, and waiting lounge. among others.

From March 1 to April 17, different enforcement agencies have seized cash, liquor, drugs and other items worth ₹118.65 crore in the state.



### MAN GETS 20-YR RI FOR MINOR'S RAPE IN CI

Bhubaneswar, April 30: The Fast Track Special Court here Tuesday awarded 20 years of rigorous imprisonment (RI) to a 30-year-old man after holding him guilty of raping a minor girl in the City in 2018.

The court also slapped a penalty of ₹10,000 on the convict, identified as Ramjan Khan of Raghunath Nagar under Khandagiri police limits in Khurda, for the offence under Section 376AB of the IPC. Failure to pay the fine would entail additional two months jail term, special public prosecutor Rajib Samal and



additional public prosecutor Balaram Sahoo said.

According to sources, Khan was selling toys in Dumduma area of the City when he saw the minor girl waiting for an autorickshaw October 26, 2018. Finding the girl alone, Khan raped her.



A passerby heard the girl crying and came to her rescue. Later, locals nabbed Khan and handed him over to Khandagiri police.

Khandagiri police booked Khan under multiple Sections of the IPC including 341 and 354 and Section 6 of POCSO Act.

nhaling the synthetic opioid fentanyl -- approved by the LUS Food and Drug Administration for use as pain relief and anaesthetic -- can cause irreversible brain dam-

age, according to a new study. Fentanyl is cheap, readily available, and 50 times more potent than heroin, warned doctors in the journal BMJ Case Reports after treating a 47-year-old man found unresponsive in his hotel room after snorting the drug.

'We know very well the classic opiate side effects: respiratory depression, loss of consciousness, disorientation," said lead author Chris Eden, now a secondyear resident in internal medicine at the Oregon Health &

Science University. "But we don't classically think of it causing possibly irreversible brain damage and affecting the brain, as it did in this case," he added. The middle-aged man was diagnosed with toxic leukoencephalopathy by fentanyl inhalation, which means the substance caused inflammation and damage to the brain's white matter. This led to unconsciousness and also to potentially irreversible loss

of brain function, or possibly death. The condition is manifest in various signs and symptoms, the most obvious of which are



neurological and behavioural changes, ranging from mild confusion to stupor, coma, and death.

Although the recovery is slow. some people will recover fully, while others will progressively get

worse. In this case, a brain scan revealed white matter inflammation, swelling, and injury in his

cerebellum -- part of the brain responsible for gait and balance.

The man remained bed-bound for 18 days later and was fed via a tube. Doctors prescribed several different drugs to treat urinary incontinence, kidney injury, cognitive impairment, suspected opioid withdrawal, pain and agitation, and pneumonia.

After 26 days, he underwent rehabilitation, and after another month, he returned home. However, outpatient physiotherapy and occupational therapy continued. The study reported that it took him almost avear to fully recover and return to work full-time.

New Delhi, April 30: The Supreme Court Tuesday appreciated the 'marked improvement' in the unconditional public apology published in newspapers by yoga guru Ramdev, his aide Balkrishna and Patanjali Ayurved Limited (PAL) in the misleading advertisements case.

A bench of Justice Hima Kohli and Ahsanuddin Amanullah told senior advocate Mukul Rohatgi, appearing for Ramdev, Balkrishna and PAL that language of the apology was adequate and the names were also

"I don't know the second apology is on whose vetting. There has been marked improvement,' Justice Amanullah said, adding, "We appreciate that. Now finally they have understood.

He said earlier when the apology was published, only the company's name was there.

"Now the names have come. It is a marked improvement, we appreciate that," Justice Amanullah observed, adding, "The language is adequate."

During the hearing, the apex court asked the firm's counsel as to why they have e-filed the apolplea filed in 2022 by the Indian Medical Association alleging a smear campaign against the Covid vaccination drive and modern systems of medicine.

While hearing the matter April 23, the top court had said the public apology published in newspapers were not on record and asked those to be filed within two days.

PAL had assured the top court November 21 last year that it will not violate any law, especially those relating to advertising or branding of products manufactured and marketed by it.

It had also assured the bench that "no casual statements claiming medicinal efficacy or against any system of medicine will be released to the media in any form".

The top court had said PAL is "bound down to such assurance."

The non-observance of the specific undertaking and subsequent media statements had irked the bench, which later issued notices to show cause why contempt proceedings should be not initiated against them.

On March 19, the top court had directed Ramdev and Balkrishna, who is the managing director of PAL, to appear before it after taking exception to the company's failure to respond to the notice issued in the case relating to advertisements of the firm's products and their medicinal efficacy.

The top court had said it deemed it appropriate to issue Ramdev a show cause notice as advertisements issued by Patanjali, which were in the teeth of the undertaking given to the court November 21, 2023, reflect an endorsement by him.

# Observations of galaxies support existence of dark matter

The findings on dark matter were arrived at using "real, observed relationships" between stars and galaxies could be a basis to test two different models to describe the universe, according to Francisco Mercado, lead author of the study published in the journal Monthly Notices of the Royal Astronomy Society

y observing motions of stars and gas across galaxies, researchers have found evidence that they said supports the existence of dark matter.

While dark matter has not yet been directly detected and is therefore considered 'invisible', it is thought to explain various aspects of the observed universe.

The findings on dark matter were arrived at using "real, observed relationships" between stars and galaxies could be a basis to test two different models to describe the universe, according to Francisco Mercado, lead author of the study published in the journal Monthly Notices of the Royal Astronomy

One of these models works to answer the question -- does invisible dark matter need to exist to explain how the universe works the way it does?

On the other hand, according to the other model, can physicists



explain how the universe works solely from matter that can be di-

rectly observed? While currently, many physi-

cists think that dark matter must

exist to explain the motions of stars and galaxies, Mercado said his team "put forth a powerful test to discriminate between the

For the test, the researchers performed computer simulations using both normal and dark matter on observed features measured in real galaxies. The features included patterns in the motions of stars and gas in these galaxies.

The study led by the University of California, Irvine, US found that these features "are expected to appear in a universe with dark matter but would be difficult to explain in a universe without it.

'We show that such features appear in observations of many real galaxies. If we take these data at face value, this reaffirms the position of the dark matter model as the one that best describes the universe we live in, said Mercado.

While the team expects more

debate within the research community to follow in the wake of the study, they said there "may be room for common ground" as they found that only the simulations involving both normal and dark matter could explain the observed features of real galax-

"Simply put, the features we examined in observations require both the existence of dark matter and the incorporation of normal-matter physics," said co-author Jorge Moreno, associate professor of physics and astronomy at Pomona College, California, US.

Now that the dark matter model of the universe appears to be the leading one, the next step is to see if it remains consistent across a dark matter universe, said Mercado

# Weavers in lurch as 70% handloom units shut Truck falls off bridge,

Kendrapara, April 30: As many as 7,000 artisans have been rendered jobless following the closure of 70 per cent of the handloom units in Kendrapara district during the last three decades.

The handloom units had to close down following the arrival of modern machines and quality threads in the market. As a result, over 7,000 artisans earning their livelihood by weaving handloom clothes lost jobs to the modernisation wave sweeping the textile industry in the

Absence of government sponsorship, publicity and marketing facility is stated to be the reason behind the closure of these handloom units. Moreover, lack of modern weaving machines and quality threads dealt a body blow to the traditional handloom sector in this district.

The dhoti, napkin (gamchha) and clothes manufactured by these handloom units were once in great demand among the consumers in the state. However, with the passage of time, modern manufacturing machines and high quality cotton thread forayed into the market and spelt disaster for these handloom units

Moreover, several handloom weavers' cooperative societies which had been marketing their products have now become a thing of the past.

A weaver Kishore Dey of Thakurhat village said many looms have fallen silent as several weavers are now not keen on weaving sarees, lungis, dhotis, and towels. The increasing cost of raw materials has robbed the sheen off their businesses.

He said over 10,000 residents of Kushiapal, Dihasahi, Haripur, Korua, Kutaranga, Keutagada, and other villages were into weaving clothes. Handwoven napkins, dhotis, and shawls produced by these units were in great demand even in foreign countries, he added.

Weaving clothes in the loom was part of the school curriculum and a school was established for the purpose during the freedom movement launched by Mahatma Gandhi to overthrow the British rule. Currently, there is great demand for handloom products in the country and abroad but many units are on the verge of closure while others

have shut down due to absence

of government sponsorship, Dey

Another weaver Narayan Bhadra of Korua village said handloom products are in great demand in and outside the state as well as in foreign countries. Weaving is the second source of livelihood for many after agri-

Over 3,000 people are still engaged in weaving handloom clothes.

However, a fall in income has forced many youths to migrate to other states and abroad for a decent livelihood. Plagued by a series of problems and dwindling income, the youths have lost their faith in this business, he

Harekrushna Das, president of the Kushiapal handloom weavers' cooperative society, said the demand for handloom products is still high among the customers despite sharp rise in the business of machine woven

in great demand during marriages and various other festivals. However, lack of marketing facilities is troubling them, he said. Another weaver Ajay Kumar Behera said the increasing cost of raw materials and their shortage have hit the weavers hard.

Moreover, the government restrictions imposed on purchase of some chemicals have also hit the weavers hard as they have failed to prepare quality clothes and sarees. Things have come such a pass that weavers now fail to recover even the production cost of a handloom product due to a drop in profit mar-

ised at Tihidi police station Tuesday. According to the police, Akhilata was in love with Madhusudan and they got married in 2019. However, Akhilata's in-laws were not happy with their marriage



and there used to be frequent quarrels within the family due to various reasons since their marriage. When Madhusudan was not home, Akhilata's motherin-law asked her to give a bowl to eat Monday morning but when she denied the same an argument broke out between them. Akhilata's father-in-law, who was present at the scene, started beating her mercilessly with a bamboo stick and then in a fit of rage caught hold of her neck with a saree with the

help of his wife. When Akhilata died of suffocation, they took the body inside the room and hanged her from the ceiling to give it the shape of suicide. Later they informed police that Akhilata committed suicide. However, Akhilata's brother lodged a complaint at Tihidi police station alleging that his sister was murdered by her in-laws

over ₹50,000 dowry. Acting on the complaint, police along with a scientific team reached the spot, seized the body and initiated an investigation. 



### **Rights & India**

ndia's record of human rights in the past few years has come under serious international scanner. The recent ethnic strife in Manipur, when the state machinery was blatantly used to help the majority ethnic community to settle scores with a minority group in genocidal attacks, brought worldwide condemnation. In this backdrop, the United Nations Global Alliance of National Human Rights Institutions (GANHRI) will hold its session in the first week of May to decide, among other things, whether the National Human Rights Commission of India (NHRC) will retain its "A" status. The NHRC's ratings were put on hold in 2023 when the UN body took exception to the presence of police personnel in human rights investigation and the lack of gender and minority representation. Police inclusions violate international conventions and defeat the very rationale of protection of human rights. Downgrading NHRC's rating from A to B, which is in the realm of possibility, would affect its ability to vote at the UN Human Rights Council and some other UN General Assembly bodies.

The meeting of the Sub-Committee on Accreditation (SCA) of the GANHRI in May is part of the five-year peer review for each member of the 114-member alliance. Sensing the reservations the world body has for India's recent human rights record, the Ministry of External Affairs (MEA) is reportedly reaching out to various countries involved in the review process to make its case through diplomatic channels.

Since being accredited in 1999, India had retained its 'A' ranking in 2006 and 2011. But, two years after the BJP-led National Democratic Alliance (NDA) assumed power in 2014, its status was first downgraded and then restored after a year. This is the second time during the Modi government that it is facing a possible listing downgrade. There are reasons for being concerned. In March, 2023 the SCA made a six-point submission to slam India for the involvement of police officers in its investigative process, calling it a "conflict of interest." The NHRC, however, sought to rebut the charge arguing that the presence of government officials, including Secretary-General and CEO, NHRC, former Gujarat-cadre IAS officer Bharat Lal, adds to the effectiveness of the body. At present, of the two individual members of the NHRC, one member Rajiv Jain is an IPS officer who was Director of the Intelligence Bureau, while the Director-General of Investigation is former Special Director, CBI, Ajay

The criticism stems from the fact that the appointment of a police officer who had worked as the country's intelligence chief undermines the neutrality of the human rights body as his pro-government bias after having served it for years cannot be ruled out, to say the least. This makes human rights watchdogs suspect that the NHRC is turning into a coercive mechanism to stifle protest and assertion of human rights by civil society activists, journalists or any other individuals. In fact, the suspicion has been strengthened by umpteen cases of incarceration of advocates of free speech in India under the current regime. The death in custody, that too in very inhuman conditions of Stan Swamy, who raised his voice for justice to the downtrodden, is a case still fresh in public memory.

In a joint letter to GANHRI dated 26 March, 2024, nine human rights groups, including Amnesty International, expressed growing concerns about increasing restrictions on civil society and "discrimination against minorities ahead of the country's General Elections." They also cited various development and human rights indices that have downgraded India's ratings in the past few years.

These groups reportedly have urged the GANHRI-SCA to amend the current 'A' rating of the NHRC to accurately reflect its failure to comply with the Paris Principles and address the deteriorating human rights situation in India. In a related development, the US State Department's latest global report spoke of "significant" human rights concerns in India. Predictably, the MEA has rubbished the report calling it biased and reflecting a "poor understanding of India." But, that is too simplistic an observation and it skirts the main issue. Being in a denial mode is no answer. This is especially so when India has seen too many cases of civil society activists either dying in custody or languishing in jail after having been put behind bars under draconian laws on trumped-

Spewing hatred against minority groups for capturing power and taking ruthless measures against critics of the government may bring short term benefits. But, in the long run such blinkered policies lower a country's standing in the comity of nations and harm its social fabric.

# **DISTRESSED WORKFORCE**

ONE OF THE **BIGGEST CHALLENGES FOR INDIAN LABOUR MARKET IS THE DWINDLING WORKERS EARNINGS IN REAL TERMS** 

ndia has stood out to be the second largest labour market in the world with a little under 600 million people, six in 10 working-age people, working or seeking jobs. However, around 400 million people belonging to the working age cohort are still out of the labour force. The India Employment Report 2024, jointly prepared and produced by the Institute for Human Development (IHD) and the International Labour Organisation (ILO), highlights the key issues pertaining to Indian labour market keeping an eye on the dynamics of social. educational, and economic structure of the country in the last two decades. The report, drawing insights from the nationally representative data, argues that the Indian labour market confronts several acute challenges, despite some of the positive outcomes, in recent days such as the declining share of regular and casual work opportunities and falling real wages of self-employed and regular workers. The periodic labour force sur-

vey 2022-23 reveals that Labour Force Participation Rate (LFPR) and Worker Population Ratio (WPR) continue to increase, being consistent with their respective recent past trends. Between 2000 and 2022, the size of the labour force has increased by 171.1 million to 567.4 million, approximately 8 million annually. Likewise, the size of the workforce has gone up by 157.4 million to 544.5 million, by around 7 million annually during this period. The unemployment rate too has declined between 2022 and 2023. The LFPR of Indian adults has gone up from 55.2 per cent in 2022 to 57.9 per cent in 2023. This increase holds for both rural and urban India, with a substantial increase in the former (3.3 percentage points) relative to the latter (0.7 percentage points). A large part of the increase is due to a higher fraction of women joining the labour force with a 4.2 percentage point increase in their LFPR. For the men counterparts, on the other hand, it was observed that LFPR increased

only by 1.3 percentage points. However, the World Bank data reveals that India is markedly lagging behind in terms of the magnitude of LFPR when compared with its South Asian peers like Bangladesh and Sri Lanka as well as other comparable middleincome countries.

It is worth noting down that female LFPR is sharply lower than that of men in India. According to PLFS 2022-23 (National Statistical Office) data, less than four in ten working-age women enter the labour force as compared to eight in ten men. Though female LFPRs are lower than those of males in several other parts of the world, this gap remains quite sharp in India. Only 180 million women are present in India's labour force, compared to 380 million men.

A sector-wise break-up reveals some of the spectacular changes. Improvements in employment outcomes can largely be attributed to the agriculture and construction sectors. Between 2019 and 2022, the compound growth rate of the agriculture sector workforce has increased markedly by 8.9 per cent, though it has been steadily declining since 2000. The workforce in the construction sector was growing very slowly during 2012-19 (by 2.2 per cent); it accelerated by 6.4 per cent in 2019-22. Employment growth also remained positive, though minuscule in magnitude, in the manufacturing sector - it gained momentum from negative to 3 per cent during this period. It was

the service sector that slumped sharply in terms of employment acceleration - the growth of employment dropped markedly from 10.8 per cent to 1.1 per cent during the same period. Hence, positive labour market outcomes can largely be attributed to agriculture and construction sectors only. Such a dynamic can well be understood by observing the changing nature of the Indian labour market during the COVID-19 pandemic - a large fraction of rural labourers who were earlier working in towns and cities migrated back to their native places and preferred to work in agriculture and construction sectors.

The quality of employment shows a grim picture. Employment in the informal sector has increased spectacularly with around half the jobs performed in the formal sector turning out to be informal in nature. As the India Employment Report 2024 suggests, nearly 82 per cent of the workforce is working in the informal sector, and around 90 per cent is informally employed. Self-employment remains to be the key source of overall employment growth - as is evident from the report, both self-employment and unpaid family work has spurred substantially, especially for women. It is quite clearly evident that the share of self-employment accelerated markedly, whereas, the share of casual and regular employment decelerated during 2019-22. It is worth mentioning here that

such a trend is quite contrary to the pre-pandemic scenario - before 2019, employment in informal sector was falling steadily and reflected a reversed trend in the aftermath of 2019; likewise the share of formal sector employment was moving up since long back which slipped during the post-2019 period.

One of the biggest challenges for Indian labour market is the dwindling workers' earnings in real terms. The monthly real wages of regular and self-employed workers declined by Rs 230 and Rs 174, respectively. The overall employment quality, measured by the 'employment condition index', shows a varied picture for different states. The workers' employment conditions are worst, as the report highlights, in Odisha, Madhya Pradesh, Bihar, Jharkhand, and Uttar Pradesh; whereas, the conditions are relatively better in Delhi, Himachal Pradesh, Telangana, Uttarakhand, and Gujarat. Though state-level policies are a dire necessity, especially in the states crippled at the bottom of the pyramid of employment quality, to improve the employment conditions of the workers, the Centre ought to extend support to economically backward regions.

Given the evolving dynamics of the economic landscape, the Indian labour market is passing through remarkable transformations shaped by technological innovations, demographic shifts, and evolving work paradigms. With the advent of artificial intelligence, robotics, and big data analytics, the industrial sector is leveraging gains owing to enhanced productivity in the production process. However, such transformations require new skill sets and competencies which constrain a large fraction of the distressed workforce in finding a job of their choice. Given such a trajectory, the Centre and states should come forward with robust frameworks of labour reforms and social security measures thereby safeguarding the rights and well-being of workers.

# Divide your day wisely for optimum health

IF YOU WORK IN AN **OFFICE, YOU PROBABLY NEED** TO CUT BACK ON **YOUR SITTING. YOU MAY NEED TO GET A STANDING DESK** 

ave you ever wondered whether you are doing enough sitting for optimum health? Is eight hours of sitting per day enough or should you aim for 10 hours?

Thankfully, an international team of researchers has provided us with some answers, telling us exactly how we should divide our time every day for optimum health.

The researchers, led by Dr. Christian Brakenridge of Australia's Swinburne University of Technology, analysed how 2,000 people spent their days and determined that the ideal daily balance is six hours of sitting. five hours and 10 minutes of standing, eight hours and 20 minutes of sleeping, and four hours and 20 minutes of physical activity.

Before you panic about the imbalance in your daily routine, let me break down each of the "24hour time-use compositions," as the researchers called them:

SITTING: The recommended daily amount is only six hours. Depending on your job, this may seem too little or too much. If

you're a construction foreman, you probably don't sit much on your job. When you return home, you need to plan your evening to incorporate enough sitting.

Spouse: "Do you want to go to the gym with me?

Foreman: "I'd love to, but I didn't do enough sitting today. I'll be on the couch for the next five hours.

Spouse: "Oh honey, I'm proud of you. You're so disciplined!"

If you work in an office, you probably need to cut back on your sitting. You may need to get a standing desk. You can also take short walks around your desk whenever you aren't occupied or your boss is.

When you get home, you need to plan your evening to incorporate less sitting.

Spouse: "Do you want to go to a Vir Das comedy show with Bank clerk: "I'd love to, but

please make sure it's standingroom only." Spouse: "We'll probably have

seats. It isn't sold out.' Clerk: "Okay then. I guess I'll

have to keep giving him a stand-

ing ovation.'

STANDING: The ideal amount is 5 hours and 10 minutes. In other words, you need to do almost as much standing as you do sitting. If you're going to be sitting in an airplane for a threehour flight, don't complain if you spend half the time standing in line to use the restroom. The same applies to all the other lines you find yourself in, whether at the voting booth or the supermarket.

Customer: "This line isn't moving at all. I can't stand it, all this standing." Manager: "I'd offer you a chair,

but I care about your health."

SLEEPING: The recommended amount is eight hours and 20 minutes. For many of us, it's hard to sleep for that long. That's because we go to bed too late. after spending too much time sitting. But if we incorporate more standing and more exercise into our lives, we'll be eager to do more sleeping.

EXERCISE: We should ideally get four hours and 20 minutes of exercise, which seems excessive. But you'll be glad to know that

we can divide this into two hours and 10 minutes of light-intensity physical activity, and two hours and 10 minutes of moderate-to-vigorous intensity physical activity.

Any activity that doesn't increase your heart rate or make you tired probably qualifies as light-intensive. Washing the dishes or cooking would be lightintensive -- and so would changing a light bulb. For moderate-to-vigorous phys-

ical activity, you'd need to do something more demanding, such as running, walking fast, or working out in the gym.

Can you really complete two hours and 10 minutes of moderate-to-vigorous physical activity in an average day? Probably not, unless you're training for the Olympics or have a job that keeps you moving briskly.

But don't worry: the ideal daily balance is based on a variety of health outcomes. You can still improve your health by shifting the balance slightly, especially if it means spending more time on your feet and less time on your butt.

#### Global scourge

Sir, Antimicrobial resistance (AMR) has not received the crucial importance it deserves. When bacteria, virus, fungus, and parasite are resistant to the drugs that are designated to kill them, and free the patient of the prevalent infection caused by them, the resultant AMR could prove to be catastrophic. During the COVID-19 pandemic, 75 per cent of patients used "precautionary antibiotics" that was really unnecessary because antibiotics act against bacteria, not viruses. Nowadays, there has been an increase in over the counter (OTC) buying of antibiotics and, if this trend continues, AMR may become the global leader of mortality over the next two decades. Unnecessary intake of antibiotics should be discouraged at the level of family doctors too. Patients attending clinics and hospitals should be made aware of the side-effects and complications of overuse of antibiotics.

# **CBI chargesheet: Manipur cops** drove two Kuki women to mob

A video showing two women being paraded naked surrounded by a mob of men went viral leading to country-wide outrage last year in July, nearly two months after the incident that took place May 4

New Delhi, April 30: The Manipur Police personnel allegedly drove the two women from the Kuki-Zomi community, who had sought refuge in their official gypsy to a mob of around 1,000 Meiti rioters in Kangpokpi district, the CBI chargesheet

The two women were subsequently stripped naked and paraded before being sexually assaulted during the ethnic violence in the state, the chargesheet added.

The women, one of whom was the wife of a Kargil war veteran. desperately asked the police personnel to drive them to a safe location but were allegedly told by them that there was no key (of the vehicle) and did not provide any help, the officials giving details of the chargesheet said.

A video showing two women being paraded naked surrounded by a mob of men went viral last year in July, nearly two months after the incident that took place May 4.

The CBI filed its chargesheet against six accused and a report against one Child in Conflict with the Law (CCL) before the Special Judge, CBI Court at

Guwahati October 16 last year.

It has alleged that the two women

were running away from a mob

of around 900-1,000 persons car-

rying sophisticated weapons like

AK rifles, SLR, INSAS and .303 The mob had forcefully entered their village in Kangpokpi district, about 68 km south of

Saikul police station, it said.

The women, along with other victims, ran into the forest to escape from the mob but were spotted by the rioters who had separated the victims. Some members of the mob told the women to reach the police vehicle parked on the roadside to seek help, officials in the know of the development said.

The two women managed to get inside the vehicle, in which two police personnel and the driver were sitting. Three to four personnel were outside the vehicle.

One of the male victims, who

also managed to make his way inside the vehicle, kept pleading with the driver to drive them to a safe place but was told there was no key

The husband of one of the victims had served the Indian Army as a subedar of the Assam

The police also did not help the father of the man sitting in the vehicle from being assaulted by the mob, the CBI alleged.

Later, the driver of the police gypsy drove the vehicle towards a mob of around 1,000 people and stopped it in front of them. The victims desperately asked the police personnel to drive them to safety, but no help was provided

The mob had already killed the father of one of the male victims who was sitting in the gypsy along with the two women, the agency has said. The violent mob came towards the gypsy when the police personnel fled from the scene, leaving the victims at the mercy of the crowd.

The rioters dragged the women out, stripped them of their clothes and paraded them naked before sexually assaulting them, the chargesheet has said. The CBI has chargesheeted

Huirem Herodas Meitei, who was nabbed by Manipur Police in July, and five others, and a report has been filed against a The accused have been charged

under various sections of the Indian Penal Code, including those pertaining to gangrape, murder, outraging the modesty of a woman and criminal conspiracy, the CBI has said.

### Man-eater tiger captured after 2-month operation

Chandrapur, April 30: A nineyear-old tiger that had killed six persons in Chandrapur district of Maharashtra in the last two months has been caged, marking the successful culmination of a two-month-long operation to capture the elusive big cat on the prowl which had struck terror

The tiger which managed to throw foresters off his trail with his sharp animal instincts finally took the bait placed inside a cage Monday night in the Karva-Ballarpur forest area, a senior official said Tuesday.

The tiger had killed four per-

sons in the Central Chanda di-

vision and two others in the Chandrapur division in the last two months, the official added.

In view of the human-tiger conflict, villagers in the forest area were living in the atmosphere of terror, prompting the Forest department to set up a team to capture the big cat, said Swetha Boddu, Deputy Conservator of Forests (DCF). Central Chanda division.

She said the operation to capture the tiger was going on continuously for the last two months.

As the tiger was more cautious, it became difficult to capture him. The team initially faced a tough time, but with persistence and patience, the Forest department succeeded in the operation by caging the tiger Monday night in the Karva-Ballarpur forest area, said Boddu.

The caging of the troublesome tiger before the start of the Tendu leaf collection season came as a huge relief for forest department personnel and villagers in the central Chanda division.

Further action about the tiger will be taken on directions from senior officials, the DCF said.

Another official said troublesome tigers are generally shifted to a zoo in Nagpur and not released in the wild again.

### Congress under pressure to field Muslim candidate from Mumbai

Last week, Congress Working President M Arif Naseem *Khan stoked a major row after he guit as the party's* Star Campaigner and the poll campaign panel to protest against the failure of the MVA to field a single Muslim nominee for the 48 LS seats in Maharashtra

Mumbai, April 30: Amid fingerpointing and an eyeball-to-eyeball row unfolding, pressure is now building on the top Congress leadership to field a Muslim candidate from Mumbai for the upcoming May 20 Lok Sabha elections, as per sources. The development came a day after Congress President Mallikarjun Kharge -- without taking names -- indicated in Assam that the Maha Vikas Aghadi allies in Maharashtra could probably have reservations about fielding a Muslim candidate in the state or Mumbai.

Taking umbrage, Shiv Sena (UBT) MP Sanjay Raut painstakingly cleared the air to say that any such impression conveyed to the Congress leadership was misleading and erroneous.

Congress to field this candidate or not nominate some other contender... it is the party's internal matter. We shall welcome any candidate they decide and work wholeheartedly to ensure their victory," asserted Raut. Apprehensive of a possible

backlash, senior Congress leaders like Chandrakant Handore, MP, ex-Minister Suresh Shetty, MLC Bhai Jagtap and MPCC treasurer Amarjit Manhas held a meeting to soothe state Congress Working President M Arif Naseem Khan, besides assuring that they would take up the matter with the party top levels.

A senior source said that a letter had been sent to the central party leadership to reconsider Prof. Gaikwad's nomination and accommodate Khan in Mumbai North Central since he



is a prominent local leader

The leaders have also urged the party to field Gaikwad from Mumbai North constituency which has a fair sprinkling of Dalit, minorities and OBC voters, and expressed optimism that this could resolve the problem amicably plus save the Muslim support base of the

Raut declared that Khan is a senior and respected Muslim community leader; an ex-Minister with good credentials and has excellent rapport with the SS (UBT) President and ex-CM Uddhav

Thackeray and other leaders. 'We have absolutely no objections if the Congress fields Khan 'saheb' from anywhere, we shall support wholeheartedly to ensure his victory," said Raut, as Congress leaders heaved

a sigh of relief. Last week, Khan stoked a major row after he quit as the party's Star Campaigner and the poll campaign panel to protest against the failure of the Maha Vikas Aghadi (MVA) to field a single Muslim nominee for the 48 LS

seats in Maharashtra. A peeved Khan dropped dark hints that the blunder could prove costly and the MVA nominees may forfeit the Muslim and other minority votes in the states, particularly where the minorities dominate, amid speculation that the SS (UBT) reportedly was reluctant to support a Muslim candidate.

Assuring that he was not a rebel, Khan, an ex-Minister, made his displeasure public after the Congress named city party President Varsha Gaikwad as the Mumbai North Central constituency candidate but did not oppose her nomination.

Now, it is up to the Central leadership in Delhi to take a call on Khan for Mumbai North Central, which he was very keen to contest, and nominate Gaikwad from Mumbai North, said a state party leader.

Incidentally, around 35 years ago, there was a precedent when the Congress had nominated late ex-Minster Celine D'Silva from Mumbai North East, but following an uproar had replaced her with the late ex-Union Minister Gurudas Kamat, in the 1989 LS polls, he added.

### 81.16 pc turnout in Manipur repoll

### 'Migrants from Myanmar have set up 996 villages in Manipur'

Imphal, April 30: Manipur Chief Minister N Biren Singh said Tuesday that the influx of illegal immigrants from Myanmar led to the emergence of 996 new villages in the state in the past 18 years.

In a series of posts on social media, the Chief Minister said the unnatural growth of 996 new villages since 2006 and illegal immigration from Myanmar is a threat to the indigenous people and national security.

"Will anyone accept the unnatural growth of new villages and population, causing massive changes to the demography of the state and the country due to the influx of illegal immigrants? We're confronting a serious issue within our nation, especially in Manipur, where several new villages have emerged due to a massive influx of illegal immigrants from



Myanmar since 2006 till date. During this period, massive forest covers have been destroyed to establish settlements and carry out poppy plantations,' the chief minister said

CM Singh also said that these illegal immigrants have started encroaching on the resources, job opportunities, land, and the rights of the indigenous people.

'We have started collecting biometric data of the illegal immigrants besides geo-tagging their settlements," the chief minister said, as he appealed to everyone in the country to support the government in keeping the nation safe and secure from illegal immigrants.

CM Singh also said that when the UK Prime Minister Rishi Sunak recently asserted the nation's unyielding commitment to deporting illegal immigrants and even claimed that no foreign court can stop them, nobody dared to question the British government.

"But when the Ministry of Home Affairs and the Manipur government are adopting a similar stance and initiating the deportation of illegal immigrants from Manipur, certain sections of people are losing their sleep. They have been persistently spreading false propaganda to portray the Manipur government as communal," he said.

A Manipur government report said that since 2006, the state has witnessed a substantial increase in the number of new villages, primarily attributed to the influx of illegal immigrants from Myanmar.

These immigrants have set up settlements by encroaching upon forest lands, leading to deforestation and environmental degradation, the report said, adding that they have engaged in illicit activities such as poppy cultivation, further exacerbating the socioeconomic and ecological challenges faced by the region.

In response to these challenges, the Manipur government has initiated several measures aimed at addressing the issue of illegal immigration and its associated

Besides collecting biometric data of the illegal immigrants and geo-tagging their settlements, the other measures include enhancing security along around 400 km India-Myanmar border in Manipur, engagement of indigenous communities, and empowering them to safeguard their rights and interests against encroachment and exploitation.

### Row in Manipur as NCERT textbook links traditional sport with Mizoram

Imphal, April 30: The Manipur government is likely to take up with the National Council of Educational Research and Training (NCERT) the issue of the popular Manipuri game of 'Mukna-Kangjei' being identified as that of Mizoram in one of its textbooks, officials said

A Manipur government official said that the state authority noticed this incorrect mentioning of the game as of Mizoram.

Earlier terming it as a gross error, BJP legislator Rajkumar Imo Singh requested state Education Minister Basanta Kumar Singh to take up the matter with the Central government to resolve the issue.

Singh, the son-in-law of Chief Minister N Biren Singh, said on



X, "Mukna-Kangjei is a traditional sport of Manipur, a variant of hockey and involves

wrestling too, thus known as Wrestling-Hockey. NCERT has made a gross error by publishing the association of this traditional sport with Mizoram. It is purely a traditional sport of the state of Manipur. NCERT needs to rectify this mistake immediately. Our state Education Minister Shri Th Basanta Singh should take this matter up with the Government of India to solve this issue and ensure that such errors are not repeated again

Citing the mistake, the Physical Education Teachers' Association emphasised the importance of accuracy in educational curriculum, particularly those relating to cultural heritage and indigenous games, and urged the government authorities to take suitable steps to correct it.

# Phase I turnout 66.14%, Phase II 66.71%: EC ADMIN PULLS UP SLEEVES

IN THE 2019 ELECTIONS, THE TURNOUT IN THE FIRST PHASE STOOD AT 69.43 PER CENT

New Delhi, April 30: Hours after the opposition parties questioned the alleged delay on the part of the Election Commission of India (ECI) in announcing the final voter turnout for the two phases of the ongoing Lok Sabha polls, the EC Tuesday said a voter turnout of 66.14 per cent was recorded in Phase I and 66.71 per cent in Phase II.

Officially sharing the turnout figure, the poll panel said in Phase I of the elections, 66.22 per cent of male and 66.07 female electors turned up to vote. The turnout for registered third-gender voters stood at 31.32 per cent.

In the 2019 polls, the turnout in the first phase stood at 69.43

In the second phase of elections held April 26, the male voter turnout was recorded at 66.99 per cent, while the female turnout stood at 66.42 per cent. As many as 23.86 per cent of the registered third-gender voters came out to vote.

In the 2019 Lok Sabha polls in Phase II, the turnout was

69.64 per cent. In Phase I, 102 seats went to poll



this time, while in Phase II elections were held in 88 constituencies.

According to the poll panel, out of 21 states and Union territories which went to polls in the first phase, 11 recorded a higher turnout of women voters. These are Arunachal Pradesh, Assam, Jammu and Kashmir, Lakshadweep, Manipur, Nagaland, Meghalaya, Puducherry, Tamil Nadu, Uttarakhand and West Bengal.

In the second phase where 13 states and UTs went to poll, six registered a higher women voter turnout. These are Assam, Bihar, Jammu and Kashmir, Uttarakhand, Kerala and West Bengal.

The EC made it clear that the final turnout will only be available post-counting with the counting of postal ballots and its addition to the total vote count.

Postal ballots include postal ballots given to service voters, ab-

years of age, persons with disabilities (PwDs), those on essential services and voters on election duty.

Daily accounts of such postal ballots received are given to all candidates, it noted.

Earlier in the day, the Congress, CPI-M and TMC questioned the EC over the delay in announcing the final voter turnout figures for the first two phases of the Lok Sabha polls, 11 days after the first round of polling April 19.

Congress general secretary Jairam Ramesh said it is essential for the Election Commission of India (ECI) to be timely and transparent about all election-related data, and it should come out with the figures and make them public.

"For the first time, even 11 days after the first phase of the polls and four days after the second phase, the final voter turnout has not been published by the ECI. In the past, ECI used to publish the final voter turnout immediately after voting or within 24 hours. Only approximate polling figures are available on ECI's website. What accounts for this delay," he asked in a post on X.

### FOR 100 PER CENT VOTING POST NEWS NETWORK

Balasore, April 30: The district administration here has taken a slew of initiatives to ensure 100 per cent voting in the upcoming Lok Sabha and Assembly elections in the state, a report said Tuesday.



#### **Devender Yadav** to be interim **Delhi Cong chief**

New Delhi, April 30: The Congress Tuesday appointed former MLA Devender Yadav as interim president of its Delhi unit, two days after Arvinder Singh Lovely resigned from the post while criticising the alliance with AAP and statements of the party's candidates in the national capital.

Yadav, who won from the Badli Assembly constituency in Delhi in 2008 and 2013 and lost to Ajesh Yadav of AAP in 2015, is currently the All India Congress Committee's (AICC) Punjab in-charge.

"My heartfelt thanks to Sh Kharge ji, Smt Sonia Gandhi ji, Rahul Gandhi ji, KC Venugopal ji and Smt Priyanka Gandhi ji and all senior leaders of the Congress, for the faith they have bestowed in me yet again!" Yadav said in a post on X.

'Will try my best to tread the coveted and ideological vision party has laid for me and give my 100 per cent!" he said.

According to a statement issued by the party, "Congress President Mallikarjun Kharge has appointed Yadav as the interim president of the Delhi Pradesh Congress Committee (DPCC) with immediate effect.'

The development comes as the Congress and AAP prepare for the May 25 election to the seven Lok Sabha seats in Delhi.

In his resignation letter sent to the Congress president Saturday, Lovely had said that he found himself "handicapped" as all unanimous decisions taken by senior Delhi unit leaders were "unilaterally vetoed" by the AICC's Delhi in-charge Deepak Babaria.

The Delhi Congress unit was against the alliance with AAP but the party high command went ahead with it, Lovely had said as his resignation brought to the fore the party's factional feud.

### **MEA slams** Washington Post report

New Delhi, April 30: A day after The Washington Post named an Indian official for allegedly plotting to assassinate Sikh extremist Gurpatwant Singh Pannun, India Tuesday said the report made "unwarranted and unsubstantiated" imputations on a serious matter and that investigation into the case was underway.

The newspaper, citing unnamed sources, named a Research and Analysis Wing (RAW) officer in connection with the alleged plot to kill Pannun on American soil last year.

"The report in question makes unwarranted and unsubstantiated imputations on a serious matter," External Affairs Ministry Spokesperson Randhir Jaiswal said. He said a high-level inquiry committee set up by New Delhi to look into inputs provided by the US on the alleged plot was still probing

the case.
"There is an ongoing investigation of the high level committee set up by the Government of India to look into the security concerns shared by the US government on networks of organised criminals, terrorists and others," he said. Jaiswal was responding to media queries on the report.

"Speculative and irresponsi ble comments on it are not helpful," Jaiswal said, slamming the report by the US daily.

The Washington Post report identified the RAW officer as Vikram Yadav and alleged that he was involved in the plot to assassinate Pannun.

In November last year, US federal prosecutors charged Indian national Nikhil Gupta of working with an Indian government employee in the foiled plot to kill Pannun.

Pannun, wanted in India on terror charges, holds dual citizenship of the US and Canada. He has been designated as a terrorist by the Union home ministry under the anti-terror law Unlawful Activities (Prevention) Act.

The allegations about the failed plot to kill Pannun came to fore weeks after the Canadian Prime Minister claimed in September of a "potential" involvement of Indian agents in the killing of Khalistani separatist Hardeep Singh Nijjar June 18 in British Columbia. India had strongly rejected the charges.

External Affairs Minister S Jaishankar December 7 said in Parliament that India instituted an inquiry committee to look into the inputs received from the US in the Pannun case as the matter has a bearing on national security.

New Delhi, April 30: The Supreme Court Tuesday came down heavily on the Uttarakhand State Licensing Authority for its "inaction" for six years in the misleading advertisements case involving Patanjali Avurved Limited, saying it has to be honest with the court if it wanted 'sympathy and compassion".

While expressing dissatisfaction over the explanation offered in the affidavits, including the one filed by the State Licensing Authority (SLA), the apex court questioned why the authority has "woken up" only after the court's April 10 order.

"The long and short of it is, when you want to move, you move like lightning and if you don't want to move, you drag your feet forever and ever. This is what it shows," a bench of justices Hima Kohli and Ahsanuddin Amanullah observed after perusing the affidavit filed by the SLA.

# Rising STDs a concern for increasing infertility in India: Docs

New Delhi, April 30: The spike in the number of Sexually Transmitted Diseases (STDs) like chlamydia, gonorrhoea, syphilis, and mycoplasma genitalium are contributing to infertility in India, warned doctors Tuesday.

Sexually Transmitted Infections (STIs) may pass from one infected person to another via blood, semen, vaginal, and other bodily fluids through sexual contact.

While these are usually asymptomatic, they can cause serious complications like infertility, both in men and

women, if left untreated. According to the World Health Organisation (WHO), almost 1

million people worldwide contract STDs.

Each year, about 30 million people in India alone contract

On the other hand, a recent Lancet study showed that India's Total Fertility Rate (TFR) -- the average number of children born per woman -- is dipping irreversibly to 1.29, far lower than the replacement rate of 2.1.

Explaining the link between the two, gynaecologist Dr Manisha Singh from Fortis Hospital, Bengaluru, told IANS, "STIs like chlamydia, gonorrhoea, syphilis, and Mycoplasma genitalium can sneakily mess with fertility. They cause inflammation and scarring in reproductive organs, like the fallopian tubes in women or sperm



ducts in men.

"Chlamydia and gonorrhoea are the two most common infections in women that can cause infertility. These infections cause pelvic inflammatory disease (PID) which can lead to chronic inflammation and damage to reproductive organs, like the fallopian tubes and uterus, making it difficult to conceive, added Dr. Dhivya Chandrasekar, Consultant - Obstetrician & Gynecologist, Motherhood Hospitals, Bangalore.

"In men, it results in inflammation of the urethra, testicles, and other reproductive organs,



The doctors said detecting and treating these infections early and having safe sex, are crucial to protect fertility.

When the tubes get blocked, one may require In Vitro Fertilisation (IVF), where fertilisation happens outside the body in a lab, as it can't occur naturally within the fallopian tubes.

'If you suspect the presence of an STI, it is best to get it diagnosed at the earliest. One must prioritise preventive measures like when used correctly and consistently, condoms offer one of the most effective methods of protection against STIs, including

HIV," Dr Dhivya said.

#### Toll in Kenya flash floods rises to 169

Nairobi: The death toll due to heavy rains pounding several parts of Kenya and devastating flash floods has mounted to 169 people, a government official said. New York, April 30: Donald Trump was held in contempt of court Tuesday and fined \$9,000 for repeatedly violating a gag order that barred him from making public statements about witnesses, jurors and some others connected to his New York hush money case. Prosecutors had alleged 10 violations, but New York Judge Juan M Merchan found there were nine. The ruling was a stinging rebuke for the Republican former President, who had insisted he was exercising his free speech rights.

Merchan wrote that Trump "is hereby warned that the Court will not tolerate continued willful violations of its lawful orders and that if necessary and appropriate under the circumstances, it will impose an incarceratory punishment."

Trump stared down at the table in front of him as the judge read the ruling, frowning slightly. The ruling came at the start of

Shanghai, April 30: The first scientist to publish a sequence of the COVID-19 virus in China staged a sit-in protest outside his lab after authorities locked him out of the facility — a sign of the Beijing's continuing pressure on scientists conducting research on the coronavirus.

Zhang Yongzhen wrote in an online post Monday that he and his team had been suddenly notified they were being evicted from their lab, the latest in a series of setbacks, demotions and ousters since the virologist published the sequence in January 2020 without state approval.

When Zhang tried to go to the lab over the weekend, guards barred him from entering. In protest, he sat outside on flattened cardboard in drizzling rain, pictures from the scene posted online show. News of the protest spread widely on Chinese social media and Zhang told a colleague he slept outside the lab — but it was not clear Tuesday if he remained there.

"I won't leave, I won't quit, I am pursuing science and the truth!" he wrote in a post on Chinese social media platform Weibo that was later deleted.

In an online statement, the

Shanghai Public Health Clinical Center said that Zhang's lab was being renovated and was closed for "safety reasons." It added that it had provided Zhang's team an alternative laboratory space. But Zhang wrote online that his team wasn't offered an alternative until after they were notified of their eviction and that the lab offered didn't

meet safety standards for

conducting their research, leav-

ing his team in limbo. Zhang's latest difficulty reflects how China has sought to control information related to the virus: An Associated Press investigation found that the government froze meaningful domestic and international efforts to trace it from the first weeks of the outbreak. That pattern continues to this day, with labs closed, collaborations shattered, foreign scientists forced out and Chinese researchers barred from leaving the country. When reached by phone Tuesday, Zhang said it was "inconvenient" for him to speak, saying there were other people listening in. In an email Monday to collaborator Edward Holmes seen by AP, Zhang confirmed he was sleeping outside his lab after guards barred him from entering.

#### India to grant full cost of SL northern port development

Colombo, April 30: The Sri Lankan Cabinet Tuesday decided to implement the renovation of the Kankesanthurai Port in the Northern Province with India agreeing to grant \$61.5 million - the entire cost of the project.

Situated in the northern region of Sri Lanka, the Kankesanthurai Port or the KKS Port, with an area of approximately 16 acres, is located at a distance of 104 kilometres (56 nautical miles) from Karaikal Port in Pondicherry.

The direct passenger ship service connecting Nagapattinam in Tamil Nadu to Kankesanthurai port near Jaffna covers a distance of 111 kilometres (60 nautical miles) in approximately three and a half

"Considering the importance of the project, the Indian government has agreed to grant the entire estimated cost of the project," a statement said Tuesdav.

It added that the project implementation had been delayed as the Economic Value of Equity (EVE) estimated cost provided by consulting service agencies was higher than the relevant loan amount.

'Therefore, further discussions have been held with the Government of India regarding the possibility of completing the project under the Public Private Partnership Method," the statement said. The original cabinet approval for the project was given May 2, 2017.

Thereafter, the approval for offering Project Management Consultant Services was given December 18, 2019. It was announced in March this year that the project's full cost was \$61.5 million.

#### King Charles III returns to public duties

London: Britain's King Charles III, who was diagnosed with cancer earlier this year, Tuesday resumed his public-facing duties with a planned visit to a cancer centre in London where he held hands with a number of patients. The 75-year-old monarch, still undergoing treatment which Buckingham Palace earlier said has been rated as "very encouraging" by his medical team, was also named Cancer Research UK's new patron as he joined wife Queen Camilla at the Macmillan Cancer Centre at University College Hospital. Smiling and cheerful Charles and Camilla spoke to staff and patients at the centre where the King was overheard saying it was important to get enough people diagnosed early. "This visit will be the first in a number of external engagements. His Majesty will undertake in the weeks ahead," Buckingham Palace has said.

#### AstraZeneca makes big u-turn

London: UK-headquartered pharmaceutical giant AstraZeneca (AZ) has admitted that in "very rare cases" its COVID vaccine can cause a blood clot related side effect but the causal link is unknown, according to court papers being quoted in the UK media. The Daily Telegraph reports that in a legal document submitted to the High Court in London in February for a group action being brought by 51 claimants, AZ admitted that the vaccine developed with the University of Oxford to protect against COVID-19 may cause Thrombosis with Thrombocytopenia Syndrome (TTS) in "very rare cases". The AZ Vaxzevria vaccine, also manufactured by the Serum Institute of India (SII), was known in India as Covishield.

#### IMF approves disbursal of \$1.1bn loan tranche to Pak

Washington/Islamabad: The IMF has approved an immediate disbursal of the final tranche of \$ 1.1 billion to Pakistan as part of a bailout package, emphasising that the cash-strapped country needs to take tough measures to bring its economy back on track. The International Monetary Fund (IMF) Executive Board's decision Monday came after the global lender completed the second and final review of Pakistan's economic reform programme supported by the IMF's Stand-By Arrangement (SBA). With this development, the disbursements under the SBA reached around \$3 billion. All board members favoured the release of the last instalment. India. however, abstained from voting.

# 5 takeaways from global negotiations

Ottawa (Ontario), April 30: The world's nations finished a round of negotiations early Tuesday on a treaty to end plastic pollution and made more progress than they have in three prior meetings.

Coming into Ottawa, many feared the effort would stall to craft the first legally binding treaty on plastics pollution, including in the oceans. The last meeting was marred by disagreements and there was much left to do. But instead, there has been a "monumental change in the tone and in the energy," said Julie Dabrusin, a Canadian parliamentary secretary.

It was the fourth Intergovernmental Negotiating Committee on Plastic Pollution session. For the first time, the nations began negotiating over the text of what is supposed to become a global treaty. They agreed to keep working between now and the next and final committee meeting this fall in South Korea

Waste pickers have been on the frontlines of trying to solve plastic pollution for decades, said John Chweya, a 33-year-old waste picker representing Kenyan waste pickers.

They collect, sort, recycle and sell plastics that would otherwise pile up or be burned. They're exposed to hazardous materials and can suffer from respiratory illnesses, skin infections and other diseases. They want a treaty that recognizes the role they play and helps waste pickers transition to safer jobs. In Malawi, Tiwonge Mzumara-Gawa sees plastic bags littering the lands where goats and cows graze and peo-

ple burning waste behind their homes because there is no waste collection. She believes it'll take a global agreement for the national government to do more to address plastic pollution. Mzumara-Gawa is a campaigner for the Christian charity Tearfund.

Frankie Orona told negotiators their decisions affect peoples' lives and health. #### **BoM net profit jumps 45%**

Bhubaneswar: Bank of Maharashtra (BoM) reported a 45 per cent year-on-year (Y-o-Y) jump in net profit at ₹1,218 crore in Q4FY24, buoyed by healthy growth in net interest income and non-interest income, and relatively lower tax provision burden. The Bank also announced a dividend of ₹1.40 per equity share of ₹10 face value for FY24 and approved raising of ₹7,500 crore capital, including equity issuance, in FY25. Nidhu Saxena, MD & CEO, said the bank will sustain the profitability and efficiency parameters assiduously built over the last 15 quarters or so even as it has set its sights on turning into a bank of great significance through a notch up in its ranking (by business size) among public sector banks in the next one year and by two notches in 2-3 years.

#### **Indian Oil net** profit halves

**New Delhi:** Indian Oil Corporation (IOC) Tuesday reported halving of its March quarter net profit largely because of losses in the petrochemical business and shrinking margin after it announced a pre-election fuel price cut despite rising input costs. The net profit of ₹4.837.69 crore in January March compared to ₹10,058.69 crore a year back and ₹8,063.39 crore in the October December quarter, according to a stock exchange filing by the company. Profit was lower as refining margins dipped, the petrochemical segment turned negative, and the firm, last month, cut petrol and diesel prices by ₹2 per litre each despite crude prices edging up.

#### **REC net profit** grows 33%

New Delhi: State-owned REC Ltd Tuesday posted a 33 per cent rise in its consolidated net profit to ₹4,079.09 crore during the March quarter on account of higher income. The company had clocked a net profit of ₹3,065.37 crore during the January-March quarter preceding FY 2022-23, REC said in a regulatory filing. The company's total income during the fourth quarter rose to ₹12,706.66 crore from ₹10,254.63 crore in the yearago period. Total expenses were ₹7,477.18 crore in the March quarter as against ₹6,353.40 crore. For the entire FY24, the company's net profit was ₹14,145.46 crore, up from ₹11,166.98 crore in

# India's oil import bill could swell in FY25

ANY ESCALATION IN THE IRAN-ISRAEL **CONFLICT COULD IMPART AN UPWARD** PRESSURE ON THE **VALUE OF IMPORTS, ACCORDING TO AN ICRA ANALYSIS**

New Delhi, April 30: India's net oil import bill could widen to \$101-104 billion in current fiscal from \$96.1 billion in 2023-24 and any escalation in the Iran-Israel conflict could impart an upward pressure on the value of imports, ICRA said Tuesday.

The domestic rating agency said based on its analysis, lower value of Russian oil imports is estimated to have led to savings of \$7.9 billion in 11 months (April-February) of 2023-24, up from \$5.1 billion in 2022-23.

'With India's oil import dependency expected to remain high, if the discounts on purchases of Russian crude persist at the prevailing low levels, ICRA bill to widen to \$101-104 billion in FY2025 from \$96.1 billion in FY2024, assuming an average crude oil price of \$85/bbl in the fiscal," ICRA said.

Additionally, any escalation in the Iran–Israel conflict and an associated rise in crude oil prices could impart an upward pressure on the value of net oil imports in the current fiscal year,

As per ICRA's calculations, a \$10/barrel uptick in the average crude oil price for this fiscal pushes up the net oil imports by \$12-13 billion during the year, thereby enlarging the current account deficit (CAD) by 0.3 per cent of GDP.

Accordingly, if the average crude oil price rises to \$95/barrel in FY2025, then the CAD is likely to widen to 1.5 per cent of GDP from ICRA's current estimate of 1.2 per cent of GDP for

CAD, which is the difference between value of India's imports and exports, is estimated at 0.8 per cent in 2023-24.

India is more than 85 per cent dependent on imports for its needs of crude oil, which is con- CRUDE OIL

verted into fuels such as petrol and diesel at refineries.

ICRA said the value of India's imports of petroleum crude and products declined by 15.2 per cent Y-o-Y during April-February of last fiscal, even as volumes rose slightly in this period.

This was supported by the fall in average global crude oil prices as well as savings from stepped up purchases of discounted Russian crude.

In volume terms, the share of crude petroleum imported from Russia jumped to 36 per cent in April-February FY2024 from 2

ICRA estimates that the lower of Russian oil, compared to im-

per cent in FY2022, while that from West Asian countries (Saudi Arabia, the UAE and Kuwait) fell to 23 per cent from 34 per cent, respectively.

imputed unit value of imports ports from West Asia, has led to savings in India's oil import bill amounting to \$5.1 billion in 2022-23 and \$7.9 billion in 11 months of 2023-24, thereby compressing

India's CAD/GDP ratio by 15–22 basis points in FY2023-24.

However, the extent of monthly discounts relative to price narrowed sharply over the fiscal, to 8 per cent on an average in September-February FY2024 from 23 per cent in April-August

Consequently, the savings related to purchase of Russian crude are likely to have dipped to USD 2 billion in September-February FY2024 from USD 5.8 billion in April-August FY2024, ICRA said.

Post the Ukraine war, some Western nations shunned Russian oil, leading to Moscow offering discounts. This led to Indian refiners lapping up the discounted oil.

The recent conflict in the Middle East also poses threat to crude oil import route. Earlier this month, Iran first launched drone and rocket attacks on Israel, which retaliated by firing a missile.

India imports oil from Saudi Arabia, Iraq and the UAE as well as liquefied natural gas (LNG) from Qatar through the Strait of Hormuz, which is a narrow sea passage between Oman and Iran.

#### March infra output rises 5.2% y-o-y

New Delhi, April 30: India's infrastructure output in March rose 5.2% year-on-year, compared with a revised 7.1% growth in February, government data showed Tuesday. Infrastructure output, which

accounts for 40% of industrial production, measures activity in eight sectors, including refinery products and electricity. In the financial year ended

March 31, infrastructure output was up 7.5% from the yearago period. Cement production rose the

most at 10.6% in March yearon-year, compared with a 9.1% growth a month earlier. Coal production grew 8.7%,

while electricity generation rose 8%. In February, coal production rose 11.6% and electricity generation grew 7.5%.

Two of the eight core sectors, however, posted a drop in output. Fertiliser production registered a smaller fall of 1.3% in March, compared with a 9.5% de-

cline in February, while refinery products dropped 0.3%, against a 2.6% rise in the previous month. Steel production grew at 5.5%

#### India likely to grow over 7 pc in 2024-25: NCAER

New Delhi, April 30: The Indian economy could grow more than 7 per cent during the current fiscal amid a benign global outlook and expected above-normal monsoon, economic think tank NCAER has said. In its April 2024 issue of

Monthly Economic Review (MER), NCAER said a range of high-frequency indicators reveal the resilience of the domestic economy with the Purchasing Managers' Index (PMI) for manufacturing at a 16vear high and UPI, the leading digital payments system, touching the highest volume since its inception in 2016.

"Projected acceleration in both global growth and trade volumes, as well as a forecast of an above-normal monsoon, indicate that the Indian economy can again attain growth rates higher than 7 per cent during the current fiscal year," said NCAER Director General Poonam Gupta.

According to NCAER, Goods and Services Tax (GST) collections reached ₹1.8 lakh crore in March, the second best since its rollout in 2017, while UPI recorded 13.4 billion transactions (in volume) in March 2024, the highest since its introduction, registering a growth of 55.3 per cent on a year-on-year basis.

# India's gold demand up 8% in Jan-Mar despite high price

New Delhi, April 30: India's gold demand rose 8 per cent annually to 136.6 tonne in the March quarter helped by a strong economic environment despite prices touching historic highs, according to the World Gold Council.

The aggressive gold buying by the Reserve Bank of India (RBI) also contributed to the rise in demand.

India's gold demand in value terms rose 20 per cent on an annual basis to ₹75,470 crore during the January-March period of this year on volume growth as well as a rise in quarterly average prices by 11 per cent.

Tuesday, the World Gold Council (WGC) released its global report 'Gold Demand Trends Q1 2024', showing that India's total gold demand, including both jewellery and investment, increased to 136.6 tonne in January-March this year from 126.3 tonne in the year-ago period.

Out of the total gold demand, the iewellery demand in India increased 4 per cent to 95.5 tonne from 91.9 tonne. The total investment demand (in the form of bar, coin among others) grew 19 per cent to 41.1 tonne from 34.4

Sachin Jain, Regional CEO, India, WGC, said the rise in gold demand reaffirms Indians' enduring relationship with gold. "India's continued strong

macroeconomic environment was supportive for gold jewellery consumption even though prices reached a historic high in March leading to a slowdown in sales as the quarter ended," he added. Jain expects the gold demand

in India to be in the range of 700-800 tonne during this year.

If the price rally continues, he said the demand could be at the lower end of this range. In 2023, the country's gold demand was 747.5 tonne.

Asked about the factors driv-



ing demand growth in January-March, Jain told PTI, "Historically, eastern markets of the world including India and China respond when the prices are going down and there is a fluctuation, whereas western markets respond when the prices

are going up. "For the first time we have seen a complete reversal where Indian and Chinese markets have responded to an increase in prices of gold," he said.

Jain said the demand for jewellery as well as investment products like bar, coin and ETF has gone up.

"The second reason for the increase in demand has been the buying by the central bank RBI," he said.

While the RBI bought 16 tonne of gold in the full 2023, it has already purchased 19 tonne in the first quarter of this calendar year, Jain highlighted.

He mentioned that the RBI has indicated that it would continue buying.

Asked about the outlook for the April-June quarter, Jain said the demand might slow down due to a sharp rally in gold prices and the ongoing election process.

As per the WGC data, India's gold demand in value terms rose 20 per cent to ₹75,470 crore from

₹63,090 crore. Out of this, the jewellery demand grew 15 per cent to ₹52,750 crore from ₹45,890 crore, while gold investment demand went up 32 per cent to ₹22,720 crore from ₹17,200 crore.

The WGC also mentioned that the total gold recycled in India stood at 38.3 tonne in January-March, up 10 per cent from 34.8

"Total gold imports in India in Q1 2024 was 179.4 tonne, up by 25 per cent compared to 143.4 tonne in Q1 2023," the Council said. The average quarterly price in

Q1 2024 was ₹55,247.20 per 10 gm of gold as against ₹49,943.80 per 10 gm in Q1 2023 (without import duty and GST) "Q1'24 also saw healthy lev-

els of gold bar and coin demand in India, up 19 per cent year-onyear at 41 tonne. This was on a par with Q1'22, which was itself the strongest first quarter since 2014," Jain said.

The price correction in February sparked investors' interest, with anticipation of a rebound driving purchases, he added. "As the price rallied to suc-

cessive record highs, investors remained bullish, contributing to the robust demand," Jain said. Investments into gold ETF too-

All-rounder Hardik Pandya was retained as vice-captain despite his poor recent form after taking over Mumbai Indians leadership in the ongoing IPL. Hard-hitting batter Shivam Dube also made the cut following a strong IPL showing for Chennai Super Kings.

Samson, who has had a good IPL both as a batter and captain for Rajasthan Royals, was included as the second wicketkeeper-batter behind Rishabh Pant, pipping the likes of KL

Rahul and Ishan Kishan. Leg-spinner Chahal, who last played for India in August 2023, is the second wrist-spinner in the team alongside Kuldeep

However, Gill, who is enjoying a good run in the IPL as Gujarat Titans captain, found himself among the standbys along with Kolkata Knight Riders' big-hitter Rinkıı

The selectors decided to show faith in Yashasvi Jaiswal, who had a slow start in the IPL but

There was a lot of debate over Hardik's place in the squad while Samson was not debated much. Rinku was just unlucky. It was a toss-up between (Dube and Rinku with Hardik also in the squad

regained his touch with swashbuckling hundred recently for Rajasthan Royals. The redoubtable Virat Kohli completed the Indian top order after pulling off strong batting performances

The T20 World cup begins June 2 in the USA and the Caribbean. India will open their campaign against Ireland June 5 in New York.

Chasing a modest total, India lost an early wicket as Shafali Verma (0) was caught down the leg side after she tried to flick it through fine leg. Hemalatha, however, blazed away to a 24ball 41 (5x4, 2x6) as India raced to 47/1 in 5.2 overs, when the heaven opened up for the second time during the match.

The par score was 28 and the Indian eves were ahead by 19 runs, and with the surface rendered unplayable by the heavy rain, the visitors were declared winners. India thus took a 2-0

lead in the five-match series. Earlier, Dilara Akter got the Bangladesh innings underway when she pulled Renuka Singh, the star of the five-match series opener, over mid-wicket for a four in only the second ball of the match. Akter got into a good position and whipped off her pads a swinging Renuka deliv-

Third-seeded Daniil Medvedev was two points from defeat before he rallied to beat Sebastian Korda 5-7, 7-6(7-4), 6-3. Fifth-seeded Casper Ruud beat Cameron Norrie 6-2, 6-4.
