BJP releases 'Sankalp Patra'

Claiming that manifestos were just a formality during the Congress regime, BJP national president Nadda asserted the election booklets have gained importance and both people as well as parties are taking them as serious documents. Nadda listed the major promises -- 3.5 lakh jobs in five years, cash voucher of ₹50,000 for women, 'Odia Samudaya Bhawan' in all metro cities, return of money lost in chit fund scam, and procurement of paddy at ₹3,100 per quintal. He also raked up the Ratna Bhandar issue and promised opening of all four gates of Srimandir and restoration of evicted mutts. However the 'Sankalp Patra' was silent on pressing issues such as the Mahanadi water dispute and border conflicts with neighbouring states.

Bhubaneswar, May 5: Bharatiya Janata Party (BJP) national president Jagat Prakash Nadda Sunday released the party's 'Sankalp Patra' (election manifesto) bearing the tagline 'Modi ki Guarantee' for the upcoming Assembly polls in state and termed it as the blueprint for the state's development

In its manifesto, the BJP has promised 'Samrudh Krushak Niti', under which paddy will be procured at ₹3,100 per quintal and the money will be credited to the bank accounts of farmers within 48 hours

If voted to power, the BJP said it will launch 'Subhadra Yojana'

'We will aim to create 25 lakh 'Lakhpati Didis' in Odisha by 2027. For this, we will create industrial clusters for every 500 self-help groups, wherein we will provide facility management for product marketing and promotion," Nadda said.

The BJP made a promise to build 'Odia Samudaya Bhawan' in all metro cities of the country for the welfare of Odia people living outside the state.

The party promised an annual lean period allowance of ₹10,000 to every fisherman, construction of 75,000 km of roads in the state,



₹5,000 scholarship per year to tribal students, and ₹3,000 monthly pension for all senior citizens, physically disabled persons, widows and destitute.

The BJP promised to provide 3.5 lakh jobs by 2029 and said it will fill up 65,000 vacant government posts in a transparent manner within two years.

It promised that it would return the money people lost by investing in chit-fund companies within 18 months, and implement the Ayushman Bharat scheme within 100 days.

The BJP also promised medical, engineering and law courses in Odia, and set up IT parks at Bhubaneswar, Rourkela, Berhampur and Balasore, besides textile parks in western Odisha.

If voted to power, the BJP said it would expand the capacity of government hospitals by 36,000

beds, modernise ICUs, dialysis units and operations theaters, and establish nursing colleges, medical colleges and super speciality hospitals in every district.

Alleging that the BJD government in the state mismanaged the Jagannath temple in Puri, Nadda said, "We will expedite the investigation of the

EBS potentially country's biggest scam: Bhushan

Bhubaneswar, May 5: Terming the Electoral Bond Scheme as "potentially the biggest corruption scam in the country", Supreme Court Lawyer Prashant Bhushan called for a thorough probe by an independent body while attending a seminar here



The seminar 'Electoral Bonds and our Right to Information' was organised Odisha bv Suchana Adhikar

Abhiyan (OSAA) at Bharatiya Vidya Bhawan in the Capital City. Supreme Court lawyer Prashant Bhushan, social activists and members of National Campaign for People's Right to Information (NCPRI) and Satark Nagrik Sangathan (SNS) Anjali Bharadwaj and Amrita Johri were present in the seminar.

"The Electoral Bond Scheme is potentially the biggest corruption scam in the country, which requires thorough probe by an independent body," Prashant Bushan said adding that people have to take the lead to bring political reform. Electoral bond distribution to big parties disrupts the level playing field during elections with difference in funds among the political parties.

In addition to potential kickbacks, data suggest regulatory inaction on companies that donated through electoral bonds and reveal potential money laundering, with loss making and shell companies donating funds to political parties. The experts demanded for a court monitored SIT into the Electoral Bond Scheme.

Cong changes 5 candidates for Assembly polls

Bhubaneswar, May 5: The Congress Sunday changed its candidates in five Assembly constituencies in state while naming Akshaya Acharya from the Nilagiri Assembly seat.

The party has nominated former minister and four-time MLA Debashish Nayak for the Bari Assembly constituency replacing Arati Deo. Nayak had joined the Congress Saturday after BJP denied him a ticket.

Nayak had joined the BJP in February from the BJD. Navak was elected to the state Assembly from the Bari Assembly seat in 2000, 2004, 2009 and 2014 on BJD ticket.

Congress spokesperson Sudarshan Das has been nominated for the Jaleswar Assembly constituency



replacing Debi Prasanna Chand. For the Athamallik Assembly segment, the party has fielded Himanshu Chaulia in place of Bijayananda Chaulia while Sujit

Mahapatra has been replaced by Uma Ballav Rath for the Puri Assembly segment.

Sudarshan Sahoo is the new Congress nominee for the Athagarh Assembly segment. The party had earlier nominated Maheboob Ahmad Khan for the seat. On Saturday, the party changed its Puri Lok Sabha constituency candidate Sucharita Mohanty after she returned the ticket due to alleged lack of funding from the party. The Congress has nominated Jay Narayan Patnaik for the Puri Lok Sabha constituency.

Cong candidate attacked

Puri: Congress nominee for Puri Assembly seat Uma Ballav Rath was seriously injured Sunday after he was assaulted by unknown miscreants, police said. Rath. who sustained head and body injuries, filed a complaint at Kumbharpada police station. He claimed that while canvassing near the bus stand, he was suddenly attacked by unknown people with bricks and glass bottles. Local residents intervened and saved him. prompting a police response led by the City DSP. It is suspected that Rath's candidature as the Congress nominee could have been a reason for the attack. Meanwhile, angry over the change of candidate by the Congress leadership, supporters of Mohapatra ransacked the party's district office in the town, police said.











BJD seeks curbs on Chhattisgarh Governor's visit till end of polls

Bhubaneswar, May 5: Accusing Chhattisgarh Governor Biswabhusan Harichandan of violating the model code of conduct (MCC), the BJD Sunday urged the Election Commission to restrict his visit to Odisha till the completion of the simultaneous Lok Sabha and Assembly polls in the state.

The Naveen Patnaik-led party alleged that Harichandan, who hails from Odisha, violated the MCC by influencing voters in person and over the phone to support his son Prithiviraj, who is contesting from the Chilika Assembly seat on a BJP ticket.

The BJD has mailed a complaint petition to Chief Election Commissioner (CEC) Rajiv Kumar and submitted a copy to the chief electoral officer (CEO) of Odisha in this regard, BJD MP Sasmit Patra said.

The Chhattisgarh governor, during his stay in Bhubaneswar from April 30 to May 4, engaged in indirect campaigning for his

son Prithviraj, Patra alleged. He called up political leaders and important persons in Chilika Assembly constituency and requested them to support his son Prithviraj in this election, the BJD leader alleged.

"He invited several eminent intellectuals and opinion makers of Chilika area to his residence from time to time and held consultations with them, with a view to garner electoral support for his son Prithviraj," the party said in its petition to the CEC. The governor's act is a 'gross

The ruling party in the state requested the CEC to conduct an inquiry into these MCC violations allegedly committed by the Chhattisgarh governor.

"He be suitably cautioned and told to refrain from coming to Odisha till the completion of the elections here, more so since his son is contesting as a BJP candidate from Chilika," the BJD said in the petition.

Reacting to the allegations, Prithiviraj Harichandan said, "The BJD is leveling these charges as the party has realised that it is losing ground and will face defeat in this election."

"As my father is a governor of a state, many people, including political leaders from different parties and eminent personalities, usually meet him. Will it be stopped for the election?" Prithiviraj told PTI over the phone.

Bhubaneswar, May 5: The Special Task Force (STF) has seized 49 kg marijuana by intercepting two vehicles on National Highway-16 near Tangi area of Cuttack and claimed to have arrested five peddlers, including one from Bihar.

Two four-wheelers and several incriminating materials have been seized from the possession of the accused, said a senior STF officer.

According STF Superintendent Police (SP) Kishore Kumar Panigrahi, the accused were identified as Roshan Kumar Choudhury, 30, a native of Samastipur district in Bihar, Purna Chandra Mallik, 36, a native of Cuttack, Sandip Digal, 24, a native of Kandhamal, Bikash Kumar Pradhan, 30, a resident of Kandhamal and Manas Kumar Mallick, 22, of Cuttack.

Central govt making attempts to weaken RTI Act: Anjali Bharadwaj

Bhubaneswar, May 5: Noted social activist and co-convenor of the National Campaign for People's Right to Information (NCPRI) and founding member of Satark Nagrik Sangathan (SNS), Anjali Bharadwaj, accused the Central government of making every attempt to weaken the Right to Information (RTI) Act that makes the country truly democratic and gives people the power to question. "This is because they (Central govt) do not want to be answerable to the people and wishes to continue with corruption," said Bharadwaj while speaking at a seminar, titled, 'Electoral Bonds and our Right to Information (RTI)' at the Bharatiya Vidya Bhawan, here, Sunday. The event was organised by Odisha Suchana Adhikar Abhiuyan (OSAA). Elaborating, Bharadwaj said the Central government, through

many amendments, tried to weaken the RTI act, including controlling the salary and tenure of Information Commissions. "The government is also trying to effect more amendments to exclude different schemes under the act's purview so that the information can't be disclosed. This will further weaken the act," she said, adding that four states – Tripura, Madhya Prashant Bhusan and Amrita Johri, member of NCPI and SNS, also addressed the seminar.



Shedding light on the Electoral Bonds scheme, Bharadwaj said it is a Central government's ploy to make corruption legal wherein big corporates provide large sums of money through bonds to parties. "And the BJP is the biggest beneficiary of these bonds. Even BJD also get ₹1,000 crore worth bonds. The non disclosure of the received money is a clear violation of Right to Information," she added.

PoK is back in national AI, ML tools to check money laundering consciousness: Jaishankar

Cuttack, May 5: Emphasising that Pakistan-occupied Kashmir (PoK) has always been a part of India, External Affairs Minister S. Jaishankar Sunday, said that the "very sorry state of affairs" has continued because the earlier governments did not pursue Pakistan's vacation from the region after Independence.

"PoK has never been out of this country. It has always been a part of this country. There is a resolution of the Indian Parliament that PoK is very much a part of India. Now, how did other people get control? Ab ho jaata hai (it happens) when you have someone who is not a responsible custodian of a house an outsider will come and steal something," Jaishankar said during an interactive session in Odisha's Cuttack.

"Here you have allowed another country... It was because we did not pursue the vacation of Pakistan from these territories in the early years of Independence that this very sorry state of affairs has continued. What will happen in the future is very difficult to tell. But, I always tell peo-



ple one thing that today PoK is in the consciousness once again of the people of India. We had forgotten about it, we were made to forget about it but it is back now, definitely," he added.

It is not for the first time that the EAM has blamed the previous Congress governments for several problems that had emerged on the foreign policy front, post Independence. Last week in Hyderabad, Jaishankar told a gathering that Sardar Patel had opposed India approaching the UN on the Kashmir issue, but India's first PM

Jawaharlal Nehru disregarded it. "Today, there is a lot of interest in Pakistan-occupied Kashmir (PoK), but we should not forget how the problem originated. The doors of international pressure opened in 1947 and continued all the way till Article 370 was repealed (in 2019). We have corrected an enormous

mistake that we had made in

1947," said Jaishankar.

r ndia's Financial Intelligence Unit (FIU) has operationalised Lan advanced 2.0 version of its information technology system, armed with artificial intelligence and machine learning tools, to check money laundering and terrorist financing crimes in the country's

economic channels. The upgrade of the technological backbone was required as the volume of data (suspicious transaction reports) flagged by banks and various other financial institutions to the FIU for analysis and further dissemination to investigative and

intelligence organisations has been 'increasing', a latest report for the 2022-23 fiscal said. The agency was set up in 2004 to 'play a decisive role in India's fight against the menace of money laundering and terror-

ism financing' under the legal setup of the Prevention of Money Laundering Act (PMLA). The recently released report has been accessed by PTI which says that the Financial Intelligence Network (FINnet)

2.0 was envisaged as the country's regulatory environment has been changing, technology land-

scape has been evolving and hence an overhaul of the existing FINnet 1.0 system was required to achieve an efficient system of collection, processing and dissemination of financial intelligence.

"FINnet 2.0 leverages emerging technologies for superior analytical competencies, data quality improvement, incisive compliance monitoring and cutting-edge security tools for strengthening anti-money laundering and combating the financing of terrorism capabilities of FIU-India and its reporting universe," the report said.

It enables generation of risk scores for individuals, businesses, reports, networks and cases to be able to flag high risk cases, entities or reports for immediate action and it prioritises cases by using risk analytics, it said.

The 2.0 version has capabilities of 'advanced analytics' by employing artificial intelligence and machine learning tools and a strategic analysis lab to stay abreast with the developments in anti-money laundering and emerging technologies, the report said.



The new system also uses natural language processing (NLP) and text mining tools to analyse textual inputs like 'grounds of suspicion'.

The FINnet 2.0 is aimed to provide sophistication in FIU's 'analytical and data processing capacity' and it comprises three sub-systems.

While FINGate is meant for information collection from banks, financial institutions and intermediaries. FINCore is for analytics by FIU experts and FINex

is used for disseminating financial intelligence reports to probe agencies like the Incometax department, ED, CBI, DRI and snooping organisations like the IB, military intelligence (MI) and the NTRO among others.

FINCore, the most important vertical of this technology setup, uses artificial intelligence and machine learning to generate summaries and sharing suspicious transaction reports with various law enforcement agencies based on risk profile, it said.

This third sub-system uses information from external databases like the Central Board of Direct Taxes (CBDT), Ministry of Corporate Affairs, National Payments Corporation of India (NPCI), Central Registry of Securitisation Asset **Reconstruction and Security** Interest (CERSAI), Central Depository Services Ltd. (CDSL) and National Securities Depository Limited (NSDL) to draw a 'holistic picture of the entity in question and helps in more effective resolution and identification of the entity'.

The report stated that as the FIU deals with 'sensitive' financial data, confidentiality and data security were important component of the upgraded IT system.

"Various measures are put in place to ensure security of data, including strong, end-to-end encryption, automatic blocking of logins after a set number of unsuccessful login attempts, controlled access to content stored on the portal, logging of security incidents, identity management solution capable of managingsecurity rights and privileges by individuals," it said.



'Water pollution will have disastrous effects'

Bhubaneswar; May 5: Using polluted water for domestic, commercial, industrial and agricultural purposes, including fish and aquaculture farms can be hazardous to public health, opined experts in a seminar titled 'Pollution of Coastal and Inland Waters,' organised by Orissa Environmental Society (OES) here recently.

The programme was held under the chairmanship of the OES president Sundar Narayan Patro. Former professor of department of Naval Architecture in IIT Kharagpur Suresh Chandra Misra attended as the chief speaker. Misra explained that polluted water is harmful to public health and its use in domestic, commercial, industrial



and agricultural sectors is detrimental. "Pollutants are mostly carried through the river system, which includes, wastes from shipping operations, leaked oil, discarded fishing nets, micro plastics and industrial and commercial wastes," he said.

"These wastes products are

illegally dumped into the river channels without carrying out proper treatment procedure. If precautionary measures are not taken immediately, the entire living world will face the disastrous consequences of water pollution in future," Misra warned. Patro, in his speech, laid em-

phasis on preventing water pollution without affecting the process of development which is need of the hour. In his welcome speech, OES

secretary Jayakrushna Panigrahi said that increase in pollution of water resources is due to lack of awareness and sensitivity in the society, which leads to several serious health hazards, including cancer.

"Life is intensely dependent on natural resources and all living organisms need water for survival. However, changes in lifestyle through industrialisation, increased use of automobiles, advancements in technology and many other factors have led to an increase in production processes, which ultimately affect the natural resources," Panigrahi added.

(NOTTO) director Anil Kumar said, "The organ donation rate in India continues to be low (less than one donor per million populations in a year). One of the key challenges identified in this is poor identification and certification of BSD cases despite availability of many such potential cases. "As per provisions of "The Transplantation of Human Organs Tissues Act, 1994", it is required to identify potential brain stem death cases in the ICU," he observed.



Can an organ transplant change someone's personality?

hanges in personality following a heart transplant have been noted pretty much ever since transplants began. In one case, a person who hated classical music developed a passion for the genre after receiving a musician's heart. The recipient later died holding a violin case.

In another case, a 45-year-old man remarked how, since receiving the heart of a 17-year-old boy, he loves to put on headphones and listen to loud music - something he had never done before the transplant.

A recent study suggests that heart transplant recipients may not be unique in experiencing personality changes. These changes can occur following the transplantation of any organ.

What might explain this? One suggestion could be that this is a placebo effect where the overwhelming joy of receiving a new

lease on life gives the person a sunnier disposition. Other transplant recipients suffer from guilt and bouts of depression and other psychological issues that might also be seen as personality changes.

However, there is some evidence to suggest that these personality changes aren't all psychological. Biology may play a role, too.

The cells of the transplanted organ will perform their expected function - heart cells will beat, kidney cells will filter and liver cells will metabolise – but they also play a role elsewhere in the body. Many organs and their cells release hormones or signalling molecules that have an effect locally and elsewhere in the body.

The heart seems to be most commonly associated with personality changes. The chambers release peptide hormones, in-



cluding "atrial natriuretic peptide" and "brain natriuretic peptide", which help regulate the balance of fluid in the body by affecting the kidneys.

They also play a role in electrolyte balance and inhibiting the activity of the part of our nervous system responsible for the fight-or-flight response. The cells

in charge of this are in the hypothalamus - a part of the brain that plays a role in everything from homeostasis (balancing biological systems) to mood.

So the donor organ, which may have a different base level of hormones and peptide production from the original organ, could change the recipient's mood and personality through the substances it releases.

It has been shown that natriuretic peptide levels are higher following transplantation - and never return to normal. Although some of the elevation is probably a response to the trauma of surgery, it may not account for everything.

The body stores memories in the brain. We access them when thinking or they can be triggered by sight or smell. But memories are basically neurochemical processes where nerves convey impulses to each other and exchange specialised chemicals (neurotransmitters) at the interface between them.

While in transplant surgery, many of the nerves that govern the function of the organ are cut and are not able to be reattached, this doesn't mean that the nerves within the organ do not still function. In fact, there is

Pollution wreaking havoc in Kendrapara

Kendrapara, May 5: This coastal district lacks a major industry with most of the residents earning their livelihood from agriculture. However, toxic effluents discharged by companies spread across four neighbouring districts, have made it living hell for people residing here. These chemicals have turned the waters of the seven rivers flowing through this district toxic. Sources pointed out Sunday that the water is not fit for consumption by either human beings or animals. It also cannot be used for agriculture purposes.

Most of these industrial units are located in Jagatsinghpur, Cuttack, Jajpur and Bhadrak districts. These companies are polluting the water as well as the atmosphere, locals informed. The chemicals are also harming marine life and the green cover in this district, they added.

Residents here pointed out that administration in this district is not making any effort to prevent or control pollution. They said that they have approached officials time and again to take steps to prevent pollu-



tion, but to no avail. Some of them stated that the only way left is to approach the National Green Tribunal (NGT)

Environmentalist Samarendra Mahali pointed out that the toxic effluents and fumes emitted by the industrial units are also causing various forms of diseases including cancer. "The district administration has been informed a number of times on this issue, but it has not taken any steps," Mahali alleged. He threatened that he will soon file a case on this issue, he informed.

Mahali stated that 16 mega industries in Jagatsinghpur district lie close to Mahakalpara block. Toxic chemicals and gases like ammonia, nitrogen, hydrogen, sulphur dioxide and chlorine are regularly being discharged by these units. He stated that not only the rivers have been

polluted, but along with those 27 other water bodies have been affected. Social activist Pratap Chandra Padhi said that the Central Ground Water Board had conducted a survey of the water samples collected from several

parts of this district in 2011, 2017 and 2021. It was found that the samples had toxic chemicals content like nitrate, iron and fluoride and that too more than the permissible limits. A team of experts compris-

ing Biotechnology Reader, BC Behera of North Odisha University at Baripada, SK Dutta from IRS in Bangalore and RR Mishra from the School of Biotechnology at MITS in Bhubaneswar had also filed a report on pollution and how it is affecting this district. They stated in the report that the industrial units in the four neighbouring districts are responsible for the alarming pollution level.

They have said that industries in Talcher and Angul are discharging effluents in the Brahmani river while those in Cuttack and Jagatsinghpur are responsible in polluting the Mahanadi.

Social activist Subhasis Sarangi said that pollution has deprived the 'Bhitarkanika National Park' from finding a place in the 'World Heritage List' He pointed out that if this situation persists it will lead to the extinction of many animals and marine creatures.

When contacted, ADM Pitambar Samal said that the district administration has written a letter to state Environment department urging it to take action against the industries responsible for pollution.



More Strain

Just when we thought that ties between India and Canada were at their lowest ebb and cannot deteriorate any further, three Indian nationals were arrested on the charges of Khalistani separatist Hardeep Singh Nijjar's murder in British Columbia. Karan Brar, Kamalpreet Singh and Karanpreet Singh have been charged by the Royal Canadian Mounted Police (RCMP) with firstdegree murder and conspiracy to commit murder. With the RCMP suggesting that more arrests in the case could be coming and Canadian Prime Minister Justin Trudeau saying that "every Canadian has the fundamental right to live safely and free from discrimination and threats of violence in Canada," a day after the arrests, it appears that tensions between the two nations are not going to ease anytime soon.

In response to the arrests, External Affairs Minister (EAM) S Jaishankar has said that the events surrounding Nijjar's death in Canada, a country in the midst of elections, are primarily tied to their domestic politics and do not involve India. Jaishankar pointed out that certain individuals supporting the Khalistani movement are manipulating Canada's democratic system, forming a lobby, and establishing a voting bloc. He mentioned that the ruling party in Canada lacks a parliamentary majority and relies on support from pro-Khalistan figures. "We have convinced them several times not to give visa, legitimacy or political space to such people which is causing problems for them (Canada), for us and also for our relationship," the EAM said.

In September last year, Trudeau had stirred up a hornet's nest when he alleged the "potential" involvement of Indian agents in Nijjar's killing. The full-blown diplomatic row led to both countries expelling senior diplomats in reciprocal moves. Though India dismissed the accusation as "absurd" and "motivated," Canada stated that it had credible intelligence shared by the "Five Eyes" network of the US, the UK, Canada, Australia and New Zealand. Months after Trudeau's allegation, the US Justice Department indicted an Indian national for a plot to murder another Khalistani separatist Gurpatwant Singh Pannun, who holds dual citizenship of the US and Canada, on US soil.

Meanwhile, an official investigation in Ottawa has reported that Indian authorities, along with representatives based in Canada, are involved in various efforts to sway Canadian communities and political figures towards supporting New Delhi's stance on significant matters, specifically when it comes to addressing worries regarding Khalistani separatists in Canada. Commissioner Marie-Josee Hogue's interim report revealed foreign interference in Canada's previous federal elections in 2019 and 2021. "India does not differentiate between lawful, pro-Khalistani political advocacy and the relatively small Canada-based Khalistani violent extremism. It views anyone aligned with Khalistani separatism as a seditious threat to India," the report said.

No doubt the thriving of Khalistani supporters on Canadian soil has remained a bone of contention between both countries, but the present Indian dispensation's foreign policy is doing more harm than good to the country. When a country is accused of sanctioning state-sponsored murder on foreign soil, it speaks volumes of that country's diplomatic acumen, or the clear lack of it. While jingoism may garner votes to the ruling party in domestic elections, it is certainly not appreciated in foreign relations, not least, when dealing with the developed world. India's foreign policy has been failing miserably since the last two decades. While the UPA wallowed in self pity with weak kneed responses and allowed issues to get the better against India's interests, the BJP government on the other hand, trying to prove its muscular character, is destroying India's image on a long term basis which may be very difficult to redeem in the future.

ACHIEVING NET-ZERO EMISSIONS REQUIRES TRILLIONS OF DOLLARS IN INVESTMENT, WHICH WILL ADD TO, NOT SUBTRACT FROM, ECONOMIC GROWTH not simply doing less. The idea that sufficiency, and by association degrowth, could serve as a blueprint for reaching our climate goals gained traction after the COVID-19 lockdowns, when humans retreated indoors and global carbon dioxide emissions fell sharply, and Russia's invasion of Ukraine, which triggered energy-security concerns in Europe. In our hyper-consumerist society, the argument goes, consumption offers diminishing returns for human happiness, which implies that embracing minimalism would yield a double dividend: environmental preservation and improved wellbeing. Under this approach, wealthy countries would stop expanding their economies, while even the most strident degrowth advocates contend that poorer countries would still need to boost consumption and investment to escape destitution.

If this sounds too good to be true, that's because it is. First, some clarifications. Degrowth calls for an absolute reduction in consumption, rather than merely a shift in its composition. But such shifts - such as ditching the car and commuting by bicycle - have been a constant throughout history, and are what green growth strategies aim to achieve. To be sure, there is nothing wrong with slowing down and choosing to earn less (and apparently achieving inner peace in the process). But one should not be led to believe that

doing so holds the key to addressing the climate crisis. Consider a simple thought

experiment. Let's start with the global economy in a steady state, neither growing nor contracting, and assume an annual decarbonisation rate of 2.4 per cent-our calculation of the average over the past two decades, based on IMF economic statistics and emissions data from the Global Carbon Project. In such a world, global CO2 emissions would fall by 48 per cent by 2050. While far from reaching the goal of netzero emissions, this hypothetical global economy would be nearly twice as carbon-efficient as today's.

Now imagine if decarbonisation were to depend entirely on decreasing economic output. To achieve the same outcome – almost halving global CO2 emissions – world GDP would need to shrink by 5 per cent every year for the next three decades. To put this in perspective, global GDP contracted by 2.7 per cent in 2020, at the height of the pandemic. As successful as lockdowns were at slowing the spread of COVID-19, they were a terrible way to cut CO2 emissions.

Limiting this thought experiment to rich countries – as degrowthers propose – makes a weak argument an absurd one. Economic output in the G7 countries would need to shrink 17 per cent in 2024 alone, followed by an annual shock the size of the Great Depression. By 2030, purchasing power in the G7 would be roughly equivalent to South Sudan's today. How many climate-conscious Western consumers would be willing to endure this?

What's more, this thought experiment is necessarily limited. Our hypothetical began with a zero-growth economy, whereas over the past two decades global per capita GDP has grown by 6.8 per cent annually. Coupled with an increase in population, this steady growth has contributed to rising, not falling, CO2 emissions. Nothing short of a cleanenergy revolution, complete with clean transport systems and industry, will turn the climate ship around. Moreover, achieving net-zero emissions requires trillions of dollars in investment, which will add to, not subtract from, economic growth.

That is not to say that improving energy efficiency is futile. In 2007, the United States passed a law that helped phase out incandescent lightbulbs. As shown by McKinsey's famous marginal abatement cost curve in 2010, there were large monetary savings associated with switching from incandescent to LED bulbs. But this does not imply that the change would have happened automatically. Instead, it shows that the policy paid for itself, with Americans free to spend or save the leftover money. Either way, economic growth was inevitable.

The growth potential for large scale efficiency improvements is significantly greater than that from switching to LED lightbulbs. In fact, using limited inputs more efficiently is the def inition of economic productivity which, in turn, boosts growth Moreover, the need to accelerate our economies' decarbonisa tion requires rolling out green technologies at a much faster pace. Technology & the future of learning

n the recent student protests at Columbia University in New York City, the university administration decided to use online classes as a way to mitigate the potential danger to students. Globally, online classes were widely adopted during the COVID pandemic to keep students from spreading the virus through proximate contact with each other. These examples may suggest that online education is a means to be adopted under extreme circumstances. This article presents an alternate view: that online education is an ideal solution for a variety of reasons and whose time has come. Distance education, a precursor to online education, is not new. Some of the earliest versions of distance education were correspondence courses as far back as the 1950s and 60s. Written course materials were sent by mail to students. The students completed the assignments at home and sent in their answer sheets to be evaluated. The quality of these programmes was not very good and they did not receive any recognition from companies looking for qualified candidates for potential hiring. In the 1980s, a different form of distance education began in the US. In these programmes, video tapes of lectures were recorded and mailed out to students at different learning centres. A sizeable group of stu-

dents watched the tapes at these learning centres. Proctored exams were conducted at these learning centres. This form of distance learning was a major improvement from the earlier correspondence courses. However,

This is why a number of uni versities in India and abroad have been offering online courses successfully. Some examples are BITS Pilani in India, and the University of Phoenix in the US. In addition to degree programmes, leading universities such as Stanford and MIT have collaborated in offering free online courses on various topics. These are known as Massive Open Online Courses (MOOC). Coursera, Udacity, and edX offer a large number of MOOC courses where the student can choose to either attend for free, or pay a nominal fee to get a certificate. The faculty who record the lectures for these MOOC courses are from leading global universities and the quality of lectures is excellent. Although the number of online courses and their quality has grown exponentially, there is still a perception that the quality of online courses is inferior to live inperson classes. Universities have to focus on maintaining quality and invest in technology and faculty who can deliver online. It may not be too long before online education is accorded its rightful place in academia.

The days of the British Prime Minister Rishi Sunak and his Conservative Party government are numbered. What had been fast becoming clear now tends to be confirmed following results this week from local elections across England. There are clear current indications that the Tories are on their way out. The chances of the Labour Party capturing power ousting the Conservative Party have brightened after what is being stated as one of the worst, if not the worst, Conservative performances in local government elections in the last 40 years. It has, so far, lost over 500 council seats. Quick to understand the implications of the defeat of his party in the local body elections and byelection to one national seat, Sunak has conceded that the results were disappointing, though that is understandably a gross understatement. For, the Tories have already lost over half the council seats they were trying to defend.

The upshot of the results is that the voters have stopped pinning their faith on the Conservatives. They are fed up with rising bills and the failure of the government to cushion them against the cost of living crisis. In other words, they are in a mood to punish the Conservatives who were given reasonably enough time to fix the problems. The reelection of Ben Houchen as Tees Valley mayor appears to be a poor consolation for the Conservatives and seems to be the proverbial straw that the drowning man clutches. There are other tell-tale signs that the Conservatives' fate is sealed. The most significant of these is the Labour's stunning victory in Blackpool which will now have Chris Webb as its MP who defeated the Conservative candidate with a 26% swing against the Tories. This is a clear message to Sunak that his time is up. The Labour also secured the newly enlarged north-east mayoralty and claimed victory in Sunak's back yard with its candidate winning the race to be mayor of York and North Yorkshire.

Labour is getting traction across England. It has wrested control of several decisive councils such as Hartlepool, Thurrock, Rushmoor and Redditch. These crucial contests show that the Labour's stand against Brexit is getting approval from a vast swath of the population. Surely, these are essentially domestic elections, but they reflect the mood of the people who are disenchanted with the internal bickering among the Conservatives which have already installed three Prime Ministers by turn since 2019. There are now talks about yet another change of leadership to replace Sunak. But, this eventuality is doubtful despite a muted demand for it. Those among the Conservatives, who are reluctant to effect yet another change of Prime Minister with the elections due in November, argue that this would only turn the party into a laughing stock. This appears to be the dominant thinking in the party and those who are opposed to Sunak's leadership are in the minority. But, such a tactic is no answer to the huge trust deficit of the electorate the party is facing. The Conservatives are on 25% of the projected national vote share, the lowest level since 2013.

However, despite the lack of a clear-cut replacement for Sunak there is no shortage of would-be contenders. There are the critics who resigned from Sunak's government such as Suella Braverman, who quit as Sunak's home secretary and Robert Jenrick, who left his job as immigration minister. There are also those disgruntled elements in the form of former Home Secretary Priti Patel and some others who are still serving in Sunak's Cabinet.

These indicators prove things look bleak for the Conservative Party in the November general elections. It seems to have reached the dead end and has nothing to offer to the deeply disillusioned electorate.

So, what are the main advantages and disadvantages of an online education system? There are three major, and compelling, reasons in favour of online ed-

especially in a country such as India. is that online education can help bring education to a larger section of the population without having students travel to a limited number of locations where high quality educational institutions are situated. Every year, cutoff percentages for admission to sought-after colleges seem to get further out of reach of a large section of students graduating from schools. In the last couple of decades, a number of colleges and institutions of dubious quality have sprung up in the country in response to the increased demand. It would be preferable for well established institutions to expand their offerings via on-line classes as there would be an expectation of quality from established insti-

Finally, online education has a major impact on working professionals. It has been well established that with technological change, and new research, a lot of what people learn in coltleges and universities becomes obsolete in a few years. This phenomenon has resulted in working professionals having to keep their knowledge up to date either through evening or full-time

Youngsters take up arms to 'protect' villages

TRAINED IN BASIC COMBAT TACTICS, THE VILLAGE FORCES HAVE VOWED TO KEEP THEIR AREAS SAFE FROM THE ETHNIC VIOLENCE THAT HAS LEFT MANY DEAD, INJURED AND DISPLACED

Imphal, May 5: Every day in shifts, morning and night, a group of armed youngsters patrol roads around Manipur's Koutruk village. Their objective: Keep residents safe from the warring factions of Meitei and Kuki, two communities that have been in conflict since last year.


These youngsters, mostly in their late 20s and early 30s, identify themselves as volunteers and say they have taken up the responsibility to keep their own safe as security forces "could not do enough to protect us".

Kotruk in the Imphal Valley is one of the many villages in the state that is "protected" by groups which go by the names "Village Volunteers", "Village Volunteer Force", "Village Defence Force" and "Village Protection Force".

These groups, officials say, are not associated with any security agency or the armed forces.

Their presence in villages in the valley and Churachandpur in the hills cannot be missed. They are in uniform and can be spotted manning bunkers made of sandbags or patrolling with weapons, including sticks, batons and rifles -- some country-made, and

some stolen or smuggled. Patrolling duties are assigned

through a roster system. Each shift is between six and seven hours with small groups of five to six sent out to keep a watch on highways, village roads and narrow pathways that pass through hills and dense forests.

"Clearly our (security) forces could not do enough to protect us. Now, we know that they cannot be trusted with the task of ensuring our safety. So, we had to do it ourself and we decided to take up the task according to our calibre and capacity...we were forced to take matters into our own hands," a village volunteer told PTI on the condition of anonymity.

Though patrolling is effective,

drones allowed teams to keep a vigil on a wider area, he said. "Earlier, we were operating

drones to keep a vigil but now jammers have been installed by the central forces and, so, we cannot assess the situation that way," the volunteer said.

This PTI reporter visited a camp of these volunteers, most of whom earned their living from farming. There are also those who have left their jobs or studies for the security of their villages. They showed this reporter the bullet holes on walls of houses and the measures in place to the security

place to thwart threats. As some volunteers prepared for the morning patrol, others, including women from displaced families that now reside in relief

camps, attend to daily tasks, including cooking meals.

Recalling an incident of violence, another volunteer said, "We were having dinner when bullets started raining from above (hills)... we could hear it but we thought we are safe inside. But a bullet pierced through our wall...luckily my fa-

ther escaped it." "The next morning, we decided to send women, the elderly and children to the relief camps in the valley and decided to set up our bunkers," he said.

On their training, another village volunteer said, "It varied from 20 days to up to two months, including training in basic NCC skills. Some training in country-made weapons too". He refused to comment on

who trained them.

Local officials maintain caution, allowing their activities as long as they "remain peaceful".

"We do recognise their presence...we do not object unless they come with weapons in front of security forces or government officials because then we are bound to ask for a (firearm) licence and take action under the Arms Act. As long as they are guarding peacefully, we do not interfere," an official said requesting anonymity.

Areas in the hills and the valley have been marked following the ethnic violence - some local describe it as "new borders". And, keeping a vigil on these borders are these volunteers, who screen passing vehicles and occasionally frisk people to prevent "unwanted intrusions".

Be it at the border between Bishnupur and Churachandpur, or Imphal West and Kangpokpi, the situation remains precarious, with checkpoints resembling those at boundaries between hostile nations.

These volunteers, numbering more than 50,000 in Meitei-dominated regions and more in Kuki areas, operate under commanders.

Kukis and Meities cannot travel between the hills and the valley. Others such as Nagas and Muslims can move between the regions provided they pass certain checks. They are given an escort from the border checkpoints.

The region remains on the edge with even a small incident such as sporadic clashes between volunteer groups capable of tipping it over. More so as security agencies are yet to recover all the firearms looted during the violence last year that left 200 dead and displaced 60,000 people.

'Modi's political history based on Hindu-Muslim dispute'

Congress leader Digvijaya Singh targeted the BJP for seeking votes on lines of caste and religion instead of real issues

Rajgarh, May 5: Prime Minister Narendra Modi's political history is based on the "Hindu-Muslim dispute" and he should do some soul-searching as to who is benefiting from it, senior Congress leader Digvijaya Singh has claimed.

Singh, who has been fielded by the Congress from Rajgarh Lok Sabha seat in Madhya Pradesh, also said that he was not satisfied with the recent Supreme Court ruling on Electronic Voting Machines (EVMs).

The former Madhya Pradesh chief minister spoke to PTI while campaigning in the rural areas of Raghogarh assembly segment that falls under Rajgarh parliamentary constituency.

"If you look at the political history of Modi ji, it is based on the Hindu-Muslim dispute. It would be better if Narendra Modi does some soul-searching as to who is benefiting from it and who all are suffering due to it," Singh said.

Polling will be held in Rajgarh in the third phase of the Lok Sabha polls May 7. Singh asked, "Where are polls

being fought on the basis of real issues?"

The BJP has attacked the Congress over issues like inheritance tax. It has accused the Congress of planning to snatch the OBC quota to give it to Muslims as well as to "redistribute wealth to infiltrators".



Singh also hit out at the "Gujarat model of development", saying, "If you look at the Human Development Index (HDI) of Gujarat, then you will find that it doesn't even figure among the top 10 (states) in the country."

On the BJP's slogan 'Ab ki baar, 400 paar', Singh said the BJP managed to predict the number of seats it would win in the 2014 and 2019 Lok Sabha polls with "total precision".

"If you look at 2014 and 2019, whatever figure they gave, they crossed it. In 2014, they gave the slogan of '272 paar' and won 284 seats. Similarly, in 2019, they gave the slogan '300 paar' and won 303 seats."

Asked if he believes that EVMs had a role in the BJP's electoral success, Singh said, "At least I believe in this."

He also said he was not satisfied with the Supreme Court's recent ruling on EVMs but would talk about it after the polls.

Terming the suspicion of manipulation of the EVMs "unfounded", the Supreme Court had on April 26 rejected the demand for reverting to the old paper ballot system, saying the polling devices were "secure" and eliminate booth capturing

and bogus voting. Singh had won the seat in 1984 and 1991. His younger brother Lakshman Singh represented the constituency as a Congress candidate four times and once as a BJP candidate.

In 34 years, 877 sq/km of forest cover destroyed for poppy farming: Biren

Imphal, May 5: Manipur Chief Minister N Biren Singh Saturday said that 877 square km of forest cover in the northeastern state were destroyed in 34 years (1987-2021), primarily for the illegal cultivation of poppy, which has been used to manufacture various drugs.

Singh, who also holds the Home portfolio, said that forest cover in Manipur was 17,475 sq km in 1987 and in 2021, it was destroyed to 16,598 sq km, primarily for the cultivation of poppy.

The eviction of unauthorised encroachers carried out ever since the BJP government led by him came to power in Manipur in 2017 and 291 encroachers were evicted from the Reserve Forest and Protected Forest throughout the state, the Chief Minister said in a post on X.

It was never targeted towards any particular community, the Chief Minister pointed out.

Singh earlier said that the influx of illegal immigrants from Myanmar led to the emergence of 996 new villages in the state in the past 18 years.

He had said that between 2006 and 2024, massive deforestation occurred to establish settlements and carry out poppy plantations while these illegal immigrants started encroaching on the resources, job opportunities, land, and rights of the indigenous people.

Dacoits long gone but caste still thrives in Chambal ravines

Bhopal, May 5: Madhya Pradesh's Chambal region, once the staple for Bollywood's dacoit and gunslinger dramas, is also a massive caste cauldron where change is seeping in due to modernisation, say a section of people.

The Gwalior-Chambal region, which is in the northern part of the state, borders Uttar Pradesh and Rajasthan and has three seats, namely Gwalior, Morena and Bhind, which is reserved for Scheduled Castes. A part of the Chambal region is in Shivpuri district and falls under Guna Lok Sabha seat.

Gwalior, Morena and Bhind (SC) Lok Sabha seats are dominated by Other Backward Classes with a sizable population of SCs.

Of the 24 assembly constituencies falling under these three Lok Sabha seats, the Congress had won 13 and the BJP 12 in the November 2023 elections, which was otherwise swept by the ruling party.

Of the eight assembly segments of Gwalior and Bhind Lok Sabha seats, the BJP and the Congress won four each, while in Morena, the score was five in favour of the Congress and four for the BJP.

The three assembly seats in



Shivpuri were swept by the BJP.

Bhuvnesh Singh Tomar, a professor at Centre for Studies in Journalism and Mass Communication in Gwalior's Jiwaji University, told PTI that caste sentiments were rooted even when the Gwalior-Chambal region was infested with bandits, dacoits or "baghis" (rebels) as these outlaws loved to call themselves.

"Casteism in politics is not new. It always existed in the Chambal region, except on occasions when towering leaders, like those from the Scindia family, contested. But a lot of social changes have taken place in the past three decades due to increased road connectivity and modernisation," Tomar said.

Over the last two decades, the Dalits and backwards have become assertive and are playing a dominant role in politics, he said.

"The last two Lok Sabha elections in this area were held around the narrative set by the BJP. The indication this time is not clear as campaigning is very low-key. BJP candidates were looking weak earlier as the party fielded leaders from Gwalior and Morena, who lost polls earlier," he said.

However, a strong organisational set-up and the Narendra Modi effect will benefit BJP candidates, Tomar claimed, adding that several leaders from the Congress, including sitting party MLA from Vijaypur (Morena LS seat) Ramniwas Rawat have joined the ruling dispensation. Devesh Sharma, a Morena-

based lawyer, claimed caste politics had managed to segregate society, government offices, markets etc in the past three to four decades.

"Caste came first and then nationalism for the people of this region, which inspired so many films due to its ravines and bandits. These bandits used to influence politics in rural areas earlier but those days are long gone," he said.

KK Mishra, media advisor to state Congress chief Jitu Patwari, told PTI that his party will win half the Lok Sabha seats in the Gwalior-Chambal region.

"Gwalior-Chambal region has traditionally supported the Congress and we will win half the seats here. The BJP knows this fact and will try to manipulate the elections through EVMs. The BJP is ahead only in publicity," Mishra alleged.

The Congress is on very strong ground as was evident in the assembly polls results, he pointed out.

However, state BJP spokesperson Pankaj Chaturvedi told PTI that his party would win all the Lok Sabha seats in the region.

"The BJP has gone to the voters on the guarantees of Prime Minister Narendra Modi and the developmental works done by him as well as welfare schemes for the poor. We don't contest on the basis of caste or religion like Congress," he claimed.

Chaturvedi further claimed that the people are aware that the Congress wants to snatch the quota of OBCs and give it Muslims on the basis of religion like they did in Andhra Pradesh and Karnataka.

The ravines along the river Chambal, which runs through Madhya Pradesh, Uttar Pradesh and Rajasthan and gives the region its name, was infested with dacoits, though the last major gang, led by Rambabu Gadariya, ended some 15 years ago.

Among the blockbuster films that had Chambal and its bandit lore as base include "Sholay", "Mera Gaon Mera Desh", "Gunga Jumna", "Mujhe Jeene Do" and "Bandit Queen".

Unemployment, civic woes hold the key: City youths

Bhubaneswar, May 5: With less than a month left for the polls in Bhubaneswar Lok Sabha constituency and three Assembly seats in the City, the youths here seem to have decided to vote for leaders who can take steps to address the issues like unemployment and civic problems.

According to the latest data released by Chief Electoral Officer Nikunja Bihari Dhal. around 2.78 lakh voters in the age group of 20 to 29 years would exercise their franchise in the upcoming Lok Sabha and Assembly elections in the Capital city, out of the total 16.6

lakh voters. Similarly more than 34,000 first-time voters have been added to the electoral roll in the City, it added. Since young voters play a

crucial role in shaping the election results, their choices and as-

pirations can never be ignored. Speaking to OrissaPOST, several youths revealed about the kind of leadership they want in the upcoming polls.

Sanjit Kumar Shaw, a resident of Vani Vihar area and a final year PG student of Mass Communication in Utkal University, said, "Lack of employment opportunities in Bhubaneswar has been forcing the youths to relocate to other cities. Several MNCs and startup firms have expanded their operations in Bhubaneswar, and prioritised hiring of local talents. However, there is no drastic change in the job scenario.' Shaw also said that the government has pumped in huge amount of funds and resources to build startup-friendly ecosystems, but this too has failed to create any lasting impact on the ground.

India According to Employment Report 2024, Odisha has 33.1 per cent of population migrating to other states in search of employment opportunities, which is higher than the national average of 28.9 per cent. Amongst the 22 states taken for survey, Odisha hits the bottom rank, only performing better than Bihar in creating employment.

Apart from joblessness, some of the youths also indicated at civic issues in the City which may decide the electoral fate of the leaders.

Khusbu Sahu, a PG student of Ramadevi University and a Jharpada resident, said, "The sole issue is promises made during poll campaigning never get translated into action. For ex-

ample, Bhubaneswar-Ekamra MLA Ashok Chandra Panda had promised in the last election to fix the sew erage issue, which causes waterlogging in our area during monsoon. However, the issue still persists even though his term has come to an end. Sahu also said the

leaders need to focus on revamping waste management facilities in the City. Dedicated zones need to be created from where these facilities would operate, she said, adding how the whimsical decision to set up TTS facility in Gadakana choked the nearby slums and spread diseases

Manisha Khora, a Rasulgarh resident and a student of Utkal University, said despite being the premier educational institute of the state, there is no emphasis on placements by the authorities. "Our problems remain unresolved even after lodging complaints with the authorities," she said.

Since higher education plays a crucial role in shaping the career of the students, lawmakers need to focus on adequate expenditure in this sector, she stated. "Infrastructure overhaul in the university is a must while the library needs more books. Students aspiring for government jobs are dependent on these resources," Khora added.

Lack of industry, joblessness major poll issues in Nabarangpur **3** relatives pitted against each other in Gunupur

Gunupur Assembly constituency has 2, 21,495 voters, including 1.14.762 female voters who are eligible to exercise their franchise.

BJD has fielded Pradeep Majhi, a former Congress MP who had joined BJD in 2021, while BJP nominee is Balabhadra Majhi, also a former MP, and Congress has nominated Bhujabal Majhi, a veteran tribal leader and three-time MLA from Dabugaon for Nabarangpur Lok Sabha constituency

BJD has fielded Pradeep Majhi, a former Congress MP who had joined BJD in 2021, while BJP nominee is Balabhadra Majhi, also a former MP, and Congress has nominated Bhujabal Majhi, a veteran tribal leader and threetime MLA from Dabugaon for Nabarangpur Lok Sabha con-

stituency. There is no industry in Nabarangpur district. The government has also failed to provide irrigation facilities to farmers while unemployment is at

an alarming stage in the area, the Congress candidate alleged. "I was an MLA for three terms and the people are praising the works done in Dabugaon during my tenure. People have voted for other candidates and have seen that no work was done during their tenure. I hope that this time people of Nabarangpur will vote for me because I am a new face for Nabarangpur Lok Sabha constituency," he said.

Nabarangpur Lok Sabha (ST) constituency was traditionally a Congress bastion. Of the 17 general elections held since



Independence, Congress has won the seat 12 times.

In the first Lok Sabha election in 1951, Ponada Subarao of Gantantra Parishad won the seat by defeating Jagdish Chandra Naik of Congress. Khagapati Pradhani of the Congress party won the seat 10 times in a row from 1967 to 1998. The Congress retained the

seat in 2009. However, the Congress narrowly lost the Lok Sabha seat in the last two elections.

BJD candidate Pradeep Majhi said, "Due to the efforts of Chief Minister Naveen Patnaik, Malkangiri district has become a leading district in Odisha. We will seek votes presenting our developmental programmes in the

constituency during the BJD regime.'

Pradeep Majhi had won the Nabarangpur Lok Sabha con-stituency in 2009 Lok Sabha elections on a Congress ticket.

BJP candidate Balabhadra Majhi alleged that Nabarangpur constituency was totally neglected by the BJD government.

"People have a strong feeling that until BJD is removed from the helm, no development activity can take place in the area. People want a change this time," Balabhadra claimed. He had won the Nabarangpur Lok Sabha constituency in 2014 on a BJD ticket.

In 2019 Lok Sabha elections, Ramesh Chandra Majhi of BJD had won the seat by defeating his Congress rival Pradeep Majhi.

Bangalore, May 5: Senior JD(S) leader and party MLA H D Revanna was remanded to police custody till May 8 by a city court Sunday in connection with a case of alleged kidnapping and illegal confining of a woman.

Revanna, who is the son of former Prime Minister and JD(S) patriarch HD Deve Gowda, was arrested Saturday by a Special Investigation Team (SIT) after his bail plea was rejected in a case related to kidnapping and illegally confining a woman who is the mother of three children.

The FIR was registered against 66-year-old Revanna based on a complaint by the woman's son Thursday.

After his medical examination at the Bowring and Lady Curzon Hospital here, the former minister was produced before the Additional Chief Metropolitan Magistrate, who remanded him to the custody of the SIT. The SIT was formed by the Karnataka government on the recommendation of the Karnataka State Commission for Women chief Nagalakshmi Chowdhary after a huge cache of explicit videos of Revanna's



son, JD(S) MP from Hassan Prajwal Revanna became public. Prajwal Revanna (33), who is

the BJP-JD(S) Hassan Lok Sabha candidate, faces rape and molestation charges In the complaint of abduction

against H D Revanna to the K R Nagar police, the 20-year-old son of the victim had alleged that the MLA's close aide Sathish Babanna had taken his mother away on a motorcycle April 29, stating that JD(S) leader wanted to see her. The complainant stated that Babanna told him that if his mother

"opened her mouth before the police", she and her family members would be arrested. Later, the 20-year-old

complainant got to know from a friend and relative that his mother was among the women in the cache of videos that has gone public, and that it showed her being tied up and raped allegedly by Prajwal.

As he expressed fear that his mother was in danger, police arrested Sathish Babanna and secured the victim from a farmhouse. There are three FIRs registered in connection the sexual abuse allegations, involving the father and son, in total. In the first case in

Holenarasipura, the cook and relative of the Revannas complained that HD Revanna and his son Prajwal had molested her.

In the second complaint at CID Bangalore, a JD(S) leader accused Prajwal of raping her at gunpoint, videographing the incident and then blackmailing her. The third complaint is against HD Revanna pertaining to the abduction and illegal detention of a woman.

Before being produced before the magistrate, Revanna claimed there is no evidence of his involvement in the case based on the complaint against him registered May 2.

There are no evidences pertaining to the May 2 complaint. It's a big political conspiracy... A conspiracy was hatched against me," Revanna told reporters at the Bowring and Lady Curzon Hospital, where he was taken for a medical checkup. He also said that there is no stain in his 40 years of political career. Prajwal is abroad and a blue corner notice has been issued against him, according to the Karnataka Home Minister Dr G Parameshwara.

A Blue Corner notice has been issued and Interpol's help is being taken to bring Prajwal back to India, the minister said.

A Blue Corner Notice is issued by the international police cooperation body to collect additional information from its member countries about a person's identity, location or activities in relation to a crime.

Campaigning ends for third phase of LS polls

Ahmedabad/Bangalore, May 5: The high-octane campaign for the third phase of Lok Sabha elections that saw the BJP-led NDA and the INDIA bloc fiercely attacking each other on issues like reservations and sexual harassment charges against JD(S) leader Prajwal Revanna concluded Sunday evening in 92 seats spread over 11 states and Union Territories.

The stakes are significant for the BJP in this round as the party had in 2019 won an overwhelming majority of these seats, including all in Gujarat, Chhattisgarh, Bihar and Madhya Pradesh, that will go to polls May 7.

Prime Minister Narendra Modi led the BJP charge, asking the Congress to give in writing that it will not hand over the quota for Scheduled Castes. Scheduled Tribes and Other Backward Classes to Muslims.

The Congress and its allies accused the BJP of trying to tamper with the Constitution and do away with reservations. The principal opposition party, which has promised to remove the 50 per cent cap on reservations, also asked the BJP to clear its stance on the issue.

Congress chief Mallikarjun Kharge along with party leaders Rahul Gandhi and Priyanka Gandhi Vadra focused on issues of social justice, unemployment, 'injustice" to farmers and alleged favourable treatment to select businessmen.

The BJP leaders targeted the Congress over wealth redistribution and inheritance tax issues and accused it of pursuing appeasement politics, while Rahul Gandhi reiterated Congress' commitment to conduct a caste census and economic survey if voted to power.

Over 1300 candidates, including around 120 women, are in the fray. Among the bigwigs are Union ministers Amit Shah (Gandhinagar), Jyotiraditya Scindia (Guna), Mansukh Mandaviya (Porbandar). Parshottam Rupala (Rajkot). Pralhad Joshi (Dharwad) and SP Singh Baghel (Agra).

A 16-year-old girl and an 18-year-old boy are among those who turned themselves in before the police, he said. These cadres were tasked with digging roads, felling trees to block roads and putting up posters and banners during shutdowns called by Naxalites, the official said. Of the surrendered Naxalites, Baman Kartam (39) was the Jivakodta Panchavat Militia Platoon Commander of the outlawed Maoists organisation, while Bhima Kunjam (28) was the Aranpur Panchayat CNM president, Dantewada Superintendent of Police Gaurav Rai said. Chetna Natva Mandli (CNM) is a cultural wing of Maoists. Woman Naxalite Kumme Lekam (35), who carried a reward of ₹1 lakh, was the Hurrepal Panchayat Krantikari Mahila Adivasi Sangthan (KAMS) president, he said. "They were part of Bhairamgarh, Malanger and Katekalyan area committees of the Maoists in south Bastar. They said they were impressed by the police's rehabilitation drive 'Lon Varratu' (return to your home) and disappointed with the hollow Maoist ideology." Rai said.



Kolkata, May 5: West Bengal Governor C V Ananda Bose Sunday directed all staffers of Raj Bhavan to ignore any communication from the Kolkata Police in connection with a woman employee's complaint of molestation against him.

The direction comes after Kolkata Police constituted an inquiry team to probe into the woman's allegation against the governor.

Bose, in a post on X, said, "It is clear that in view of Article 361 (2) and (3) of the Constitution of India, the state police cannot act in any manner whatsoever to inquire/investigate/set in motion any kind of proceedings against the hon'ble governor.'

He also asserted that no criminal proceedings whatsoever shall be instituted or continued against the President, or the governor of a state in any court during his or her term of office.

"No process for the arrest or imprisonment...shall issue from any court during his term of office," the governor said in the post, drafted as a communique to Raj Bhavan employees.

It is clear that the state machinery cannot set in motion any sort of criminal proceedings, whatsoever, against the governor, he said on the microblogging site.

"The reports from the media indicate that the police propose to conduct an inquiry into the incident and that they would be examining the staff of Raj Bhavan. It is also reported that the investigating team intends to collect the CCTV footage from Raj Bhavan.'

"The question that arises is whether the police can conduct an inquiry and collect evidence in view of the immunity -(enjoyed by the governor...., Bose said in the post.











Israel shuts down Al Jazeera offices

Cairo, May 5: Israel ordered the local offices of Qatar's Al Jazeera satellite news network to close Sunday, escalating a long-running feud between the broadcaster and Prime Minister Benjamin Netanyahu's hardline government as Doha-mediated cease-fire negotiations with Hamas hang in the balance.

The extraordinary order, which includes confiscating broadcast equipment, preventing the broadcast of the channel's reports and blocking its websites, is believed to be the first time Israel has ever shuttered a foreign news outlet.

The network has reported the Israeli-Hamas war nonstop since the militants' initial cross-border attack October 7 and has maintained 24-hour coverage in the Gaza Strip amid Israel's grinding ground offensive that has killed and wounded members of its own staff. While including on-the-ground reporting of the war's casualties, its Arabic arm often publishes verbatim video statements from Hamas and other militant groups in the region, drawing Netanyahu's ire. "Al Jazeera reporters harmed

Israel's security and incited against soldiers," Netanyahu said in a statement. "It's time to remove the Hamas mouthpiece from our country.³ Al Jazeera issued a statement

The decision threatens to heighten tensions with Qatar at a time when the Doha government is playing a key role in mediation efforts to halt the war in Gaza, along with Egypt and the United States

Qatar has had strained ties with Netanyahu in particular since he made comments suggesting that Qatar is not exerting enough pressure on Hamas to prompt it to relent in its terms

for a truce deal. Qatar hosts Hamas leaders in exile at a political office in Doha.

The sides appear to be close to striking a deal, but multiple previous rounds of talks have ended with no agreement. In a statement Sunday

Hamas condemned the Israeli government order, calling on international organisations to take measures against Israel. Shortly after the government's

decision. Cabinet members from the National Unity party criticized its timing, saying it "may sabotage the efforts to finalise the negotiations and stems from political considerations.' The party said that in general, it supported the decision.

Israel has long had a rocky relationship with Al Jazeera, accusing it of bias. Relations took a major downturn nearly two years ago when Al Jazeera correspondent Shireen Abu Akleh was killed during an Israeli military raid in the occupied West Bank.

Those relations further deteriorated following the outbreak of Israel's war against Hamas October 7, when the militant group carried out a cross border attack in southern Israel that killed 1,200 people and took 250 others hostage. Washington, May 5: Los Angeles police in riot gear swarmed a pro-Palestinian encampment at the University of Southern California early Sunday to clear away demonstrators, after warning everyone to leave the area or be arrested, officials and media reported.

"If you are in the center of campus, please leave," police said on the social media site X. "People who don't leave will be arrested. We will issue another alert when it is clear to return.' Police entered the

encampment about 5 a.m. local time and began removing tents, the Los Angeles Times and other media reported. It was unclear if any arrests were made, and a spokesperson for the police provided no further information. The anti-war protests have



been staged at campuses across the nation in response to Israel's offensive in Gaza, which it launched after a Hamas attack October 7 that Israel says killed 1,200 people.

Israel has killed over 34,600 people in retaliation, according to Gaza health authorities, and flattened the Palestinian territory.

The protests have roiled campuses at numerous schools and police have arrested hundreds of protesters and cleared campuses such as Columbia University, University of Virginia, Northeastern University and many more.

In Moscow, worshippers including President Vladimir Putin packed Moscow's landmark Christ the Savior Cathedral late Saturday for a nighttime Easter service led by Patriarch Kirill, head of the Russian Orthodox Church and an out spoken supporter of the Kremlin.

Southern Brazil rains: Over 100 still missing

Sao Paulo: Massive floods in Brazil's southern Rio Grande do Sul state killed at least 60 people and another 101 were reported missing, according to Sunday's toll from local authorities. At least 155 people were injured, while damage from the rains forced more than 80,000 people from their homes. Approximately 15,000 took refuge in schools, gymnasiums and other temporary shelters. The floods left a wake of devastation, including landslides, washed-out roads and collapsed bridges across the state. Operators reported electricity and communications cuts. More than 800,000 people are without a water supply. Brazilian President Luiz Inácio Lula da Silva arrived in Rio Grande do Sul Sunday, accompanied by Defence Minister José Múcio, Finance Minister Fernando Haddad and Environment Minister Marina Silva, among others.

Toll from Kenya floods rises to 228

Nairobi: The number of people killed by flooding and other impacts of the heavy rains battering Kenya has risen to 228, the interior ministry said Sunday. The torrential rains that have caused widespread flooding and landslides across the country in recent weeks are forecast to worsen in May. In a statement, the ministry said further flooding was "expected in low lying areas, riparian areas and urban areas while andslides/mudslides may occur in areas with steep slopes, escarpments and ravines." The deluges have destroyed homes, roads, bridges and other infrastructure across East Africa's largest economy. At least 164 people have been injured by the adverse weather, while 212,630 have been displaced, the ministry said.

Hundreds rescued from Texas floods

Houston: High waters flooded neighborhoods around Houston Saturday following heavy rains that resulted in crews rescuing more than 400 people from homes, rooftops and roads engulfed in murky water. Others prepared to evacuate their properties. A flood watch remained in effect through Sunday afternoon as forecasters predicted additional rainfall Saturday night and the likelihood of major flooding in Harris County, the nation's third-largest county which includes Houston, and nearby areas. "A lull in heavy rain is expected through (Saturday) evening," the National Weather Service reported.

Cyclone Hidaya weakens

Nairobi: Cyclone Hidaya significantly weakened as it approached Tanzania's coastline, the country's meteorology department said Saturday. Officials warned residents to remain cautious, however, as the cyclone brings heavy rain and strong winds to the country through Sunday. The meteorology department did not say what the cyclone's updated maximum wind speeds were. A major blackout hit most of Tanzania Saturday as heavy rains and strong winds from Hidaya lashed the country following weeks of flooding in the region. Ferry services between Tanzania's commercial hub, Dar es Salaam, and Zanzibar were suspended as Hidaya earlier approached the East African coast with maximum winds of 120 kph (33 mph) and powerful gusts.

Met coal imports from Russia rise 3X in last 3 fiscals

New Delhi, May 5: Imports of metallurgical coal from Russia have spurted around three-fold in the last three years to around 15.1 million tonne in 2023-24 mainly due to lower prices while the same from Australia have declined, according to a research firm.

Russia's share in India's metallurgical coal imports of 73.2 million tonne (MT) has risen to around 21 per cent from around 8 per cent in 2021-22, research firm Big Mint said in a statement.

The import of metallurgical coal, which includes coking coal and pulverised coal injection (PCI), from Russia, stood at 5.1 MT. accounting for 8 per cent of India's total imports of 65.6 MT of the commodity in 2021-22.

Metallurgical coal imports from Russia rose to 11.3 MT in 2022-23, accounting for 16 per cent of 69.9 MT met coal imports in that year. In 2023-24, met coal imports from Russia were 15.1 MT or 21 per cent of total met coal imports of 73.2 MT.

Australia, a major supplier of met coal to India, saw a decline in the commodity's exports to India. Australia supplied 50.7 MT of met coal in FY22, or 77 per cent of the total imports of India. Met coal shipments dropped to 42.2 MT in FY22, while market share also declined to 60 per cent. In the last fiscal, met coal imports from Australia dropped further to 40.4 MT, resulting in

a market share of 55 per cent. Iron ore and metallurgical coal or met coal are essential ingredients in steel production. India is dependent on imports to

meet its domestic demand for met coal. According to BigMint analysts, "cost-benefit" is the main reason for the rise in imports of metallurgical coal from Russia. Imports from Russia are costing less to domestic steel players because of low prices, a BigMint

analyst said. However, in the long run, imports from Russia are projected to whittle down as the country is expected to impose an export tax on met coal and an increase in logistics cost, another analyst said.

New Delhi, May 5: Credit outstanding to the housing sector rose by nearly ₹10 lakh crore in the last two fiscals to reach a record ₹27.23 lakh crore in March this year, according to RBI's data on 'Sectoral Deployment of Bank Credit'.

Experts from banking and real estate sectors attributed this growth in housing credit outstanding to a strong revival in the residential property market post-Covid pandemic on pentup demand.

According to the data of the Reserve Bank of India (RBI) on sectoral deployment of bank credit for March 2024, the credit outstanding to the housing (including priority sector housing) stood at ₹27.22.720 crore in March 2024, up from ₹19,88,532 crore in March 2023, and ₹17,26,697 crore in March 2022

The data also showed that the credit outstanding towards commercial real estate stood at ₹4,48,145 crore in March 2024. It was at ₹2,97,231 crore in March 2022.

According to reports from various property consultants, housing sales and prices have surged significantly in the past two financial years

When contacted, Madan Sabnavis, Chief Economist with Bank of Baroda, said the high growth in home loans can be attributed to the housing boom seen across all segments.

In particular, Sabnavis said the affordable housing segment has witnessed an uptick due to the government push.




