Girls outshine boys in CISCE

Bhubaneswar, May 6: Girls outshone boys yet again in the Class X and XII board exams conducted by the Council for the Indian School Certificate Examinations (CISCE) the results of which were declared, Monday.

In Odisha, the pass percentage of boys in Class X exams is 98.86 per cent, while that of girls is 99.34 per cent. In the Class XII exams, girls achieved a pass percentage of 98.95 per cent, while boys' pass percentage stood at 98.85 per cent, it was learnt.

While a total of 8,739 students (4,629 boys and 4,110 girls) appeared in the Class X examination, a total of 1,726 students (872 boys and 854 girls) appeared for the Class XII exams in the state.

In this City, Loyola School stu-dents did well both in the Class X and XII exams. The premier school achieved 100 per cent pass percentage in Class X as all 217 examinees came out with flying colours. Similarly, 72 students of the school appeared for the Class XII exams and pass percentage was 97.22 per cent. **P3**

Modi: BJD govt | Naveen says BJP to expire June 4 is 'daydreaming'

Despite BJD leader Kartik Pandian claiming that both Narendra Modi and Naveen Patnaik are 'statesmen' who do not require each other to win the elections, there were no holds barred when the Prime Minister and the Odisha Chief Minister hit the campaign trail Monday. Both these two leaders were observed fighting each other with daggers drawn. With Modi asserting that the BJD government in Odisha will 'expire' June 4, the day results of the Assembly elections are announced, Patnaik was quick to retort that the BJP is daydreaming'. While Modi urged the people to give the BJP a chance to form the government, Patnaik pointed out that the opposition leaders always lie and can only be seen during the elections.

ing at Berhampur, Modi said, 'The BJP will form a doubleengine government here after the ongoing elections. The expiry date of the BJD government is June 4, 2024.' Addressing another rally in

Nabarangpur, the tribal heartland of Odisha, Modi claimed that his government has been working for the welfare of indigenous people. "You have seen the track record of 10 years of Modi's leadership. Modi increased the budget for tribal welfare by five times than the earlier allocations," the PM said.

Bhubaneswar, May 6: The BJD was quick to hit back and rebut Prime Minister Narendra Modi's claim that the Naveen Patnaik-led government will have its expiry day June 4, the day the Assembly elections results are announced.

"BJP has been daydreaming for many days," said Patnaik who undertook whirlwind tours of Kalahandi and Nuapada districts to address election rallies at Bhawanipatna and Khariar. He was responding to a query by close aide Kartik Pandian while travelling.

Responding to Modi's claim

that BJP will form the government in Odisha, Pandian said: "Naveen Patnaik will take oath as the Chief Minister of Odisha for the sixth consecutive time between 11.30am to 1.30pm on June 9." His statement came after Modi said in Berhampur, "I have come here to invite you to the swearing-in ceremony of BJP's CM June 10. On that day, we will implement the 'Ayushman Bharat-Pradhan Mantri Jan Arogya Yoiana', which the Naveen Patnaik government has been resisting.

Patnaik alleged that his opponents remember the people of the state only during elections and have no sincerity towards them. Addressing back-to-back election rallies in Bhawanipatna and Khariar, the BJD supremo claimed that they disappeared after the elections. "Leaders of the opposition party tell lies to the people and shed crocodile tears during elections. They are only seen during elections and then they dis-

World drinking whisky the Indian way

3rd phase of polls today

New Delhi, May 6: A total of 93 seats across 11 states will be up for grabs in the third phase of Lok Sabha polls that will be held Tuesday. As per data available from 2019, the majority of these seats are BJP strongholds. They had won 71 of the 93 seats with the Congress winning only four.

Over 1,300 candidates, including 120 women, are in the fray. Among the bigwigs are Union Ministers Amit Shah (Gandhinagar), Jyotiraditya Scindia (Guna), Mansukh Mandaviya (Porbandar), Parshottam Rupala (Rajkot), Pralhad Joshi (Dharwad) and SP Singh Baghel (Agra).

The states that will vote in this phase include Gujarat, Uttar Pradesh and Madhya Pradesh. All the three states are wellknown BJP bastions. Hence the opposition including the Congress will have to do something special to keep their prospects bright.

Four seats in Assam, five in Bihar, seven in Chhattisgarh, two each in Dadra and Nagar Haveli, Daman and Diu and Goa, 25 in Gujarat, 14 in Karnataka, nine in Madhya Pradesh, 11 in Maharashtra, 10 in Uttar Pradesh and four in West Bengal will be voting May 7. Surat, which was



- Elections will be held in 93 LS constituencies in 11 states
- BJP and its allies had won 78 of these seats while the constituents of the INDIA bloc

has already been won uncontested by the BJP.

At 81 out of 93, the BJP is contesting the maximum seats from the National Democratic Alliance (NDA). Similarly, from the INDIA bloc, the Congress will fight in 68 seats. In 2019, the NDA had won 78 of the total 93 seats, while the current constituents of the INDIA bloc together got 12. Other parties won three seats

The NDA's average victory margin of 21 per cent was much higher than that of the INDIA bloc's 11 per cent. Hence to turn the results in their favour the bloc needs a major swing in votes.

Terror threat looms over T20 World Cup

Port of Spain, May 6: The T20 World Cup in the Americas has received a terror threat. Trinidad's Prime Minister Dr Keith Rowley revealed here Sunday. However, the ICC asserted that a 'comprehensive and robust security plan' is in place to 'mitigate any risks' to the showpiece beginning June 1 in the US and the West Indies.

The tournament - featuring 20 teams, including India - is scattered across nine venues, six of them in the West Indies.

As of now, the threat, according to media reports, is specific to the West Indies, which aside from some preliminary matches will be hosting the entire Super 8 stage along with the semifinals and the final June 29.

"Unfortunately, the threat of

terrorism in its many and varied expressions is an ever-present danger in the world of the 21st century," Rowley was quoted as saying by 'Trinidad Daily Express' here Sunday.

Rowley did not name any organisation but reports here stated that the Islamic State (IS) made the threat through its propaganda channel.

The ICC responded to the development with a statement assuring preparedness. "Safety and security of everyone at the event is our number one priority and we have a comprehensive and robust plan in place," a spokesperson of the global body said. in a

Rowley said 'extra effort in national security preparations and response readiness' will be but in to neutralise the danger. We are ready to tackle any situation," Rowley stated.

SINGLE MALT CULTURE GROWING IN INDIA WITH THE AVAILABILITY OF NEW BRANDS

New Delhi, May 6: For more than a decade, Hemanth Rao has been leading the only club in India dedicated to single malts. And at present, he sounds very happy. It is because the old-fashioned Indian way of having whisky, which snobs would once scoff at, is now being adopted by the world.

Rao is the founder of the Bangalore-based 'Single Malt Amateur Club' (SMAC). He pointed out that the borrowed wisdom on all matters connected with whisky is that it's best drunk with a splash of water at room temperature. But, today, one of the most fashionable cocktails – *Japanese Highball* – is a combination of whisky, soda and ice, just the way our elders would imbibe their favourite poison. Whisky snobs would shudder at such blasphemy!

Rao recently presided over a guided tasting of two lesserknown single malts - Ardmore and Bowmore at a restaurant in Noida before he spoke to this news agency. Looking back at SMAC's evolution from a 'friendintroduces-friend type of casual club' in 2011 to a formal group with over 7,500 members, including a good number from overseas, notably Dubai and Singapore, Rao said the expansion mirrored the single malt

culture's growth in India. Rao quoted a survey the 'SMAC' conducted last year among 750-plus people across India. He said the Indian single



malt drinker has evolved from a mindset dominated by Glenlivet and *Glenfiddich* to one that is curious about all the 50-odd variants now available in India.

Easier availability of information and foreign travel has ensured that whisky lovers are looking beyond familiar labels and exploring single malts from

around the world. The proliferation of Japanese single malts in the Indian market is a testament to this fact, Rao said.

Japanese single malts, in fact became fashionable in India around the same time as the rest of the world after Jim Murray, in the 2013 edition of the 'Whisky Bible', declared the Yamazaki 25 Years Old to be the best Buoyed by this heightened curiosity, Indian producers have upped the ante and moved from producing mere IMFL to rolling out single malts, including the now-globally-acclaimed brands

Indri, Rampur Asava, Amrut

Neidhal and Godawan 02.

The lively growth in popular interest in single malts has accelerated SMAC's activities, too, so much so that Rao now has a business partner, Harsh Thimmaiah, who also works as the manager of Indian tennis star Rohan Bopanna.

Rao pointed out that his job takes him abroad frequently. During his visits he said that he noticed more and more people are drinking single malts the 'Indian way'. "Today they don't have any problems to add a pinch of ice and a dash of soda to the single malt. It proves tastesare evolving with scotch lovers also," Rao pointed out.







65 candidates in Phase I polls have criminal cases



FOUR CANDIDATES ARE ILL ITERATE

Bhubaneswar, May 6: As many as 65 of 243 candidates remained in the fray for the first phase of Assembly elections in Odisha have criminal cases pending against them, according to a report of the Association for Democratic Reforms (ADR).

In the first phase, voting for 28 Assembly constituencies along with four Lok Sabha seats will be held May 13.

Out of 65 (27 per cent) candidates, who have declared criminal cases against themselves, 48 (20 per cent) face serious criminal charges, said the ADR in its report released, Monday.

Among the major parties,18 BJP candidates, 17 Congress, 9 BJD and 3 from AAP have declared criminal cases against them in their affidavits.

Out of the 243 candidates, including 32 females, 70 (29 per cent) are crorepatis.

While 13 candidates have assets worth more than Rs 5 crore, 25 others have declared assets of Rs 2 crore to Rs 5 crore, the report said.

With a total wealth of Rs 33.36 crore, Biplab Patro, BJD candidate for the Digapahandi Assembly segment in Ganjam district is the richest person in the fray for the first phase poll. BJD nominee for the Gopalpur

Assembly seat, Bikram Kumar Panda and BJP candidate for Dharamgarh, Sudhir Ranjan Pattjoshi are the second and third richest candidates in the race, respectively.

Panda has assets worth Rs 15.94 crore, while Pattjoshi owns properties worth Rs 12 crore.

Independent candidate for Bhawanipatna, Ramesh Kumar Mahanand and BSP candidate for Rayagada, Purna Chandra Majhi have declared that they have zero assets.

Informing about the educational qualifications of the candidates, the ADR report said 132 (54 per cent) candidates have declared their educational qualifications to be between 5th and 12th standard while 100 (41 per cent) candidates have an educational qualification of graduate

Besides, seven candidates are diploma holders and four others are literate.

A total of 26 candidates in the race have declared their age to be between 61 to 80 years, and 73 candidates between 25 to 40 years, while 144 candidates are in the age group of 41 to 60 years.

CM's aircraft diverted to Jharsuguda

Bhubaneswar, May 6: An aircraft carrying Chief Minister Naveen Patnaik was diverted to Jharsuguda Monday, as it could not land at the Biju Patnaik International Airport (BPIA) here due to inclement weather, officials said.

Patnaik and his close aide Kartik Pandian were in the aircraft while returning to Bhubaneswar after an election meeting at Khariar in Nuapada

It could not land at BPIA due to heavy rain and gusty winds. Pandian said in a video mes-

He said the aircraft hovered over the Capital City for around half-an-hour before it was diverted to Veer Surendra Sai Airport at Jharsuguda.

BJD moves **EC** against Jagdev

Bhubaneswar, May 6: The BJD Monday filed a complaint with the Election Commission (EC), alleging that BJP candidate for the Khurda Assembly seat Prashant Jagdev threatened office-bearers of staterun Mission Shakti

A delegation of BJD leaders, which included Raiva Sabha MPs Sulata Deo and Sasmit Patra, filed the complaint with the chief electoral officer (CEO) of the state. The BJD alleged that Jagdev

has been intimidating and coercing the master bookkeepers participating in Mission Shakti in the Tangi block of Khurda district.

The BJD urged the EC to take action against him and ensure that the polls are held in a free, fair, and transpar-

Meanwhile, the BJP alleged that BJD's candidate for Cuttack Lok Sabha constituency Santrupt Misra has used the logo of 'Ama Odisha Nabin Odisha', a state government programme, in his campaign hoardings

Misra has put up the hoardings in public places and along the roadside, which is also a violation of the model code of conduct, alleged state BJP spokesperson Dilip Mallick.

He urged the EC to remove the hoardings and take action against the BJD candidate.

New Delhi, May 6: The Congress Monday said the BJP has steadily reduced Odisha's Central funding in recent years and accused Prime Minister Narendra Modi of 'neglecting' the people of the state.

Congress general secretary Jairam Ramesh posed questions

to the prime minister ahead of his rallies in Odisha. 'Why has Odisha's Central

funding steadily decreased? Will the PM commit to legal status for the SC-ST subplan? Will the Sitalapalli wagon factory ever be

completed?" Ramesh said in a post on X.

Elaborating on what he said were 'jumla details', Ramesh alleged that Odisha has suffered 'gross neglect' at the hands of the Modi government.

"In their usual style, the BJP has steadily reduced Odisha's Central funding in recent years. According to CAG reports, Central transfers as percentage of revenue receipts have been consistently decreasing from 57 per cent in 2017-18 to 38 per cent in 2021-22," he said.

Similarly, the CAG noted that the state's share of Union taxes, as a percentage of revenue receipts of the state, has been continuously decreasing from 201819 to 2021-22, Ramesh said.

"Grants under recommendation of the Fifteenth Finance Commission have also decreased recently. What happened to the PM's favourite slogan - Sabka Saath Sabka Vikas? Why is the PM neglecting the people of Odisha?" the Congress leader

Ramesh said the BJP has had an incredibly poor record when it comes to tribal welfare.

> 'The BJP has overseen a consistent rise in crimes against Adivasi persons according to latest data from the National Records Bureau (NCRB). The crime rate has increased from 21.6%

in 2018 to 28.6% in 2022," he said. The BJP's allocation for Adivasis in the Central Budget has also consistently fallen short of the 8.2% target set by the NITI Aavog in 2017, he pointed out.

Why have the PM and the BJP ignored India's Adivasi communities, Ramesh asked.

He said the Congress Party has guaranteed a legal status to the SC-ST sub-plan, which would require the Central government to meet this 8.2% budget target. Can the PM commit to the same, he asked.

Ramesh further said the Sitalapalli rail wagon factory has been in cold storage ever since it was sanctioned by the UPA government in 2013.

During the pandemic, when board exams were not conducted due to closure of schools and students were marked using alternative evaluation methods, both CBSE and CISCE had not issued any merit list. However, the practice was resumed after the schools reopened.

'EVERY SAINT HAS A PAST AND EVERY SINNER HAS A FUTURE' ORISSA HC COMMU DEATH SENTENCE OF MAN

Bhubaneswar, May 6: Observing that 'every saint has a past and every sinner has a future', the Orissa High Court Monday commuted the death sentence awarded by a lower court to a man for rape and murder of a six-year-old girl in Cuttack in 2018 to life impris-

A division bench of Justices Sangam Kumar Sahoo and Radha Krishna Pattanaik reduced the capital punishment awarded to Mohammad Mustak by the 3rd Additional Sessions Judge-cum-Presiding Officer of Children's Court in Cuttack, who had convicted him under Sections 363 (kidnapping), 376AB (rape on a woman under 12 years) and 302 (murder) of IPC and 6 of the POCSO Act.

According to the case details, the minor girl went missing from her home under Salipur police limits in Cuttack April 21, 2018 evening. A few hours later, locals found her lying naked on the verandah of a nearby school and shifted her to a local hospital after informing the family.

As her health deteriorated, she was referred to SCB Medical College and Hospital in Cuttack, where she remained in coma and succumbed a few days later.

On a complaint filed by the victim's grandfather, the police, during investigation, found that Mustak had taken the minor to a shop in the locality to buy her



chocolates before taking her to wards the school. The victim's brother also saw Mustak following her before the incident.

Taking into account forensic evidence and medical reports, the trial court concluded that the victim had been subjected to rape. It awarded death penalty for the offences under Sections 302 and 376AB of the IPC.

The court also awarded jail term to the convict and slapped penalty on him for offence under Sections 363 of IPC. However, no separate sentence was awarded for offence under Section 6 of POCSO Act.

Challenging the trial court's conviction, Mustak moved HC. In its order, the HC observed

that the injuries inflicted upon the victim by Mustak were fatal and death was proved to have

result of blunt trauma injury to head. "Thus, the commission of offence under Section 302 of IPC was proved against the appellant," the bench observed.

However, the HC was of the view that there is no clinching evidence on record to convict Mustak under Section 376AB of IPC or 6 of POCSO Act.

Instead, it was convinced that offence under Section 354 of IPC

was squarely made out against Mustak. position of capital punishment

was concerned, the HC held that no material was produced to show that the possibility of reformation has been fore-The HC held Mustak guilty

for murder. But his sentence was commuted to the imprisonment for life. However, a rider was imposed that he shall undergo minimum sentence of 20 years before which he shall not be eligible for consideration of remission

The HC also sentenced him to undergo five years of RI under Section 354 of IPC and seven years RI under Section 363.

The HC ordered the District Legal Services Authority, Cuttack for grant of compensation to the parents of the victim under the Odisha Victim Compensation Scheme, 2017, if the same has not already been granted to them pursuant to the trial court's order.

Not lack of oxygen, genetic defects cause cerebral palsy

Cerebral palsy is a disorder affecting one's ability to move. It is the most common motor disability in children, with symptoms emerging in infancy and early childhood

enetic defects underlie about a fourth of Chinese children affected by cerebral palsy, and not a lack of oxygen at birth as previously

thought, new research has found. Cerebral palsy is a disorder affecting one's ability to move. It is the most common motor disability in children, with symptoms emerging in infancy and early childhood.

The disability is sometimes also associated with autism and intellectual deficiencies.

Birth asphyxia, or receiving insufficient oxygen at the time of being born, can cause physical harm, especially to the brain,

and is considered one of the

main causes of cerebral palsy. The world's largest study of cerebral palsy genetics, involving more than 1,500 affected Chinese children, found that mutations were significantly higher in a fourth of these children receiving insufficient oxygen at birth.

Researchers said this indicated that birth asphyxia could be secondary to the underlying genetic defects.

The results, published in the journal Nature Medicine, are consistent with smaller studies globally, they said.

According to human geneticist

Josef Gecz from the University of Adelaide, who co-led the Australian team, 24.5 per cent of



Chinese children in the study had rare genetic variations linked to cerebral palsy.

"This revelation mirrors our earlier findings in our Australian cerebral palsy cohort, where up to one-third of cases have genetic causes

'Our research shows at least some babies who experience birth asphyxia and are diagnosed with CP (cerebral palsy) may have improper brain development as a result of the underlying genetic variants rather than a lack of oxygen," said

The researchers identified 81 mutated or altered genes that caused cerebral palsy in the children. These genes are known to be important to brain and embryo development, and may also affect molecular processes responsible for respiration, they

"A lack of oxygen at birth is

often claimed to be the cause of CP in medical litigation following a diagnosis and this has led to the presumption that the condition is preventable with better obstetrics or midwifery. This is simply not the case," said colead author Alastair MacLennan, an obstetrician and a professor, the University of Adelaide.

"Crucially clinically actionable treatments were found in 8.5 per cent of cases with a genetic cause. It is exciting to see how genetic pathways to cerebral palsy inform tailored treatments for these individuals," said Gecz.

The results highlighted the need for early genetic testing in children having cerebral palsy, especially those with risk factors like birth asphyxia, to ensure medical care and treatment, said

MacLennan.

TB scare in Ganjam due to short-supply of medicines

Berhampur, May 6: After HIV AIDS, nowadays tuberculosis (TB) has acquired an alarming proportion in Ganjam district with 18,669 patients being identified during last three years.

Spread of the bacterial disease has worsened due to short supply of free medicines by the Union government. As a result, people suffering from the disease are being pushed into the jaws of death.

Sources said that TB patients were being given free medicines every month in the past. However. the essential medicines are not available as per demand in the district due to disruption in supply of medicines by the Union government.

In case of emergency, the district health department is purchasing medicines from various pharmaceutical companies and delivering those to the pa-

tients, a health official said.

However, patients have to consume around 10-12 tablets as they fail to get medicines with various compositions which they used to get earlier, the official said.

Thousands of patients afflicted with TB are being identified in the district every year. The rapid spread of the disease is attributed to migration of the district's residents to other states in search of livelihood. Health officials said people infected with HIV have 70 per cent chance of getting afflicted with TB.

A person gets afflicted with TB when his immunity to diseases declines. Moreover, the bacteria spread through cough and sneezes of an affected person. An affected person can only be saved when there is an early detection and treatment

Notice to shift medicine store from CHC campus

Tihidi, May 6: A notice has been served Monday to vacate a medicine store running inside the community health centre (CHC) campus at Tihidi in Bhadrak district. As per reports, acting on the direction of the Health Secretary, Bhadrak CDMO and Tihidi medical officer sent a notice by post to the medicine store owner asking him to shift the store out of the CHC campus within 15 days.

As per reports, the state government through a circular (No-4538/H) in 2015 had directed not to extend the contract validity of the existing medicine stores and disallow opening of any new medicine store inside the health centres. The circular was issued following the decision of the state government to provide free health services with round-theclock free medicine distribution to patients.

Some medicine store owners had challenged the instruction of the state government in the Orissa High Court and a stay order was issued by the court in this regard. However, the state Health Secretary has questioned why the medicine stores have been operating inside the hospital campuses in the absence of any interim order from the court and also sought a reply in this regard within three days of receiving the letter.

ijab is back with full fury in Iran. The white vans of the morality police patrol, known as Guidance Patrols (Gasht-e-Ershad) are out in force once again. Videos show women and girls being dragged from the streets and detainees reportedly being beaten and abused Adding fuel to fire, fresh details of the case of Nika Shakarami, reportedly sexually assaulted and killed by men working for the security forces in 2022, have emerged buttressing the charge of brutality by the morality police. Her family said last week that her sister Aida had just been arrested for breaching the dress code.

Supporters of the jailed Nobel Peace laureate Narges Mohammadi are circulating her purported message from prison urging Iranians to protest against what she describes as a "war against women." All this is happening at a time when the attention of the world has shifted from the acts of omission and commission of the repressive regime in Tehran to the outbreak of hostilities between Iran and Israel over the latter's recent air strike hitting Iran's embassy in Damascus.

However, the women of Iran have been singled out by the regime not only for curbing their freedom to choose what they would wear, but making them an object lesson for defiance of authorities that has emboldened the population, irrespective of genders, to voice protest against alleged rampant corruption by government officials and religious

Harsh "hijab and chastity" legislation is on its way and the authorities have started using traffic camera footage to fine women driving bareheaded or in hats, confiscate their cars, sentence them to morality classes or flogging. In many cases, women are being denied access to public transport or banks by officials accusing them of flouting the dress rules. Even businesses have been closed for not enforcing the law for employees or customers. As international attention is now focused elsewhere, like the conflict in Gaza for example, the regime in Iran seems to have found it an opportune moment to intensify pressure on defiant women and their male supporters who are seen protesting when women are being picked up from the streets by morality police personnel in notorious white vans. The movement for the rights of Iranian women to dress the way they choose got a shot in the arm when Mahsa Amini died in custody in September 2022. The young Iranian-Kurdish woman had been detained by the morality police for "improper hijab." In protest, young women of Iran took to the streets and cast off their scarves in fury. Their parents too joined the chorus of condemnation of the government. Men lent force to the cries of "woman, life, freedom." That became a turning point and the regime responded with vengeance, killing hundreds and arresting thousands. In no time, the demonstrations were quelled successfully with speed. But many women refused to

The authorities in Iran are a worried lot because the protesting women are effectively encouraging the men folk to question President Ebrahim Raisi's failure to fulfil his electoral promises to pursue rampant corruption among top government officials that has led to many recent scandals. The situation has become so explosive that the Raisi government has become an advocate of Guidance Patrols and has completely forgotten its election promises of dismantling them. Some newspapers have even written editorials sharply criticising the Raisi government for resuming the white vans, reneging on its election pledge to dismantle them and sanctioning their resurgence on the streets. Raisi had made the promise during his election campaign in 2021. The official media such as the government mouthpiece, the Islamic Republic News Agency (IRNA), however, claims the government had promised to launch special investigative units as guidance patrols to clamp down on corruption and made significant progress in this regard. But, there is no substantive evidence to prove the claim that the government had dismissed scores of administrators for misconduct or incompetence. These included officials appointed by previous administrations as well as Raisi's own.

There is hardly any doubt that the repressive administration in Iran is less busy in curbing corruption and inefficiency than using its resources to purge dissenting voices to establish even harder control over state institutions, including universities - the cradle of free spirit and youth rebellion. The women of the country have not only proved to be soft targets, but also scapegoats.

A society incapable or unwilling to protect its children and women is destined to perish. The ancient people of Persia (today's Iran) may not be exceptions.

PRO-POOR POSITIONING

A COMMITMENT **TO THIS SHARP IDEOLOGICAL POSITIONING IS CRITICAL TO THE REVIVAL OF THE CONGRESS**

s the long-winded election campaign plods changed on the Indian political scene. For one, the Congress for the first time in more than a decade is able to clearly and in sharp relief articulate its political position before the electorate. This is the Indian National Congress firmly to the Left of Centre, less a question of degree and more a question of direction and position and the quadrant in which the party sits in the current political landscape. What is emerging from the party of liberalisation and privatisation is now no more a tentativeness with the agenda of social justice, wealth/income inequality or workers' rights; it is a clear placing of the flag, a sharp turn to the Left never before as clear as it was during the era of bank nationalisation under Indira Gandhi. The response of the electorate, just anecdotal at this stage, shows that the party is finding resonance and is in sync with the mood of the nation.

A commitment to this sharp ideological positioning is critical to the revival of the Congress, and while some will say the position has been forced by circumstance, it nevertheless appears to have been embraced whole-heartedly by the rank and file and the top leadership. This is one significant election outcome long before the announcement of the poll results on 4 June. Do note that the BJP because of its own sloganeering and expectation-setting has to cross its previous mark of 303 to be seen as victorious; the INDIA bloc has to pull the BJP below 272 to claim victory. Barring the possibility, extremely remote at this time, of the Congress and/or the INDIA bloc faring very poorly at these polls, what we have is a party that will shape the direction of policy in India in the days ahead. This is a role that the Congress had abdicated, sliding into irrelevance and ceding ground to the BJP in

the absence of a clear political direction tied into a cogent positioning of the 'what', 'how' and 'why' of the party. Without that, what we had was a plain and toothless attack on the communalism and corruption of the BJP that did not carry conviction and did not work with the electorate. The story has now changed.

The decade-long slide of the Congress, and its quieter slide even while it held power at the Centre, was the inevitable consequence of a party noted for leading a neo-liberal agenda. given that its only accomplishment in recent times was the 1991 economic reforms. The reforms, too, were forced by circumstance. They attempted an unleashing of "animal spirits" on the one hand but also led to curbing of workers' rights and the fuelling of widespread corruption on the other hand, this corruption moving from public sector hegemony to private sector brazenness in the absence of strong governance and weak or non-existent policing or collusion. Broadly speaking, these developments unsurprisingly fuelled the rise of the pro-BJP moneyed classes, who in alignment with the other assorted gentry in terms of class, caste and status, cited the cases of high corruption under the Congress to work for bringing the BJP to power. The deplorable

role played by Anna Hazare, who led the India Against Corruption movement but has stayed silent since then, even in the face of emerging monumental corruption scandals from the BJP stable, has already been exposed.

In this frame, GDP growth at any cost became the talking point of the Indian elite looking to cash in on the coming business boom. The BJP in power took it to its extreme by handpicking its favourite business houses for special honours while others were asked to settle disputes via the Enforcement Directorate. The rest of India was left to wallow in the failed ideas of trickle-down economics and food coupons that feed 80 crore Indians today, more than half of India, under the Pradhan Mantri Garib Kalyan

Anna Yojana. Adding further strength to the Congress today is a leadership that is looking ready and robust, willing to take on the challenges before the nation. Rahul Gandhi has bloomed in the leadership role, and is looking good in the seat, sending out the right messages and signals as he mixes stories and experiences from the Nyay Yatra to create exciting political narratives that are bold, grounded and refreshing. It is remarkable that Rahul has been able to do that with a campaign that

terness in the face of innumerable odds, and a bitter and hateful BJP campaign that has focused a large amount of its resources to denigrate him and his family. Rahul's emergence also proves that there is a limit to reliance on 'pundits', some of them giving questionable advice and one even questioning the timing and wisdom of the hugely successful Nyay Yatra.

What this resurgence of the Congress has also done is to derail in part the BJP campaign, which led from the very top by the Prime Minister himself has tended to focus on what the Congress is doing or its perceived ills rather than what the BJP has done and what it promises for the next five years. This marks an internal collapse for the BJP, and if the party is not careful to pull back that slide, it will be walking into a trap of talking more about the opponent than about itself.

Lastly, it is important to note that the Congress has rejected Manmohan Singh and all that he brought to the table, whether it says so explicitly or not. This is a necessary condition for the new Congress to build credibility. In the end, Manmohan Singh was a bureaucrat who may have succeeded in the sub set of economics but failed miserably in the super set of politics. The former is a tool; the latter is a philosophy. Efficient use of any tool is dangerous in the absence of an understanding of why it is being used and where it will lead. This should be a warning to today's Congress to stay away from retired bureaucrats. It will have to keep a sharp eye on corruption. And the Congress will need more young blood and people of commitment to build a team so that the party can remain vibrant, whether it is in power or not.

cal cancer at the age of 36. Her untimely death - and those of countless other women - probably could have been prevented, thanks to an effective vaccine for human papillomavirus (HPV), which is responsible for about 95% of cervical cancers. But not nearly enough people are getting it.

A recent Public Health Scotland study shows just how effective the HPV vaccine is at preventing cervical cancer. Among the 40,000 women born between 1988 and 1996 who received the vaccine before turning 14, there has not been a single case of cervical cancer. This includes women who received only one or two doses, rather than the full threedose protocol. The implication is clear: if all eligible girls and women are vaccinated globally, we could eliminate nearly all cervical cancers.

Moreover, because HPV is typically transmitted sexually, protecting boys also means protecting girls. That is why all girls and boys aged 9-14 years – and, ideally, women and men until the age of 45 – should be getting the vaccine. The good news is that HPV-vaccine programmes have been introduced in many

But eliminating cervical cancer will require governments everywhere to get on board. The top priority for effective

HPV-vaccination programmes is to vaccinate girls before they become sexually active - the recommended age is 9-14 years. School-based programmes are a good place to start, but in many countries, one cannot expect all – or even most – girls to be in school. Nigeria, for example, has more than 12 million out-of-school children, some 60% of whom are girls. Given this, governments must work with community leaders, community-based organisations, and community health workers to take HPV vaccine to people where they live.

But ensuring that girls get vaccinated is not just a logistical challenge; there is also an important social component. A recent Behavioural Insights Lab survey, in which I was principal investigator, showed that just 60% of the male and female caregivers

Community perceptions were a major determinant of respondents' stances on the vaccine. Most caregivers (72%) reported that they were very likely to discuss HPV vaccination with their family and friends, and those who perceived that their family and friends supported it were more likely to believe that their female child would get vaccinated. We thus concluded that interventions that leverage positive family and peer influences and encourage discussion of HPV vaccination within caregivers' social networks are likely to boost vaccine uptake.

Knowledge about the HPV vaccine also makes a big difference, though the type of messaging used in any educational campaign is crucial. Depending on the context, a focus on the vaccine's general health benefits, rather than its role in preventing sexually transmitted infections, can help to reduce stigma. In our study, caregivers were 30% more likely to have their child vaccinated against HPV if they were exposed to messaging emphasising the vaccine's positive effect on girls' future prospects. And, again, vaccination protially life-saving - intervention. Countries where HPV vaccines are already approved for males – including Australia, Canada, Hong Kong, Ireland, the Netherlands, New Zealand, Portugal, South Korea, Switzerland, the UK, and the US - should be leading the way. The US Centers for Disease Control recommends boys get the HPV vaccine between the ages of 11 and 12.

People who were not vaccinated in adolescence should also have access to the vaccine. In the Scotland study, women who received the three-dose protocol between the ages of 14 and 22 had significantly reduced incidence of cervical cancer compared to the unvaccinated. In fact, one can receive the HPV vaccine until age 45.

No one should die from a vaccine-preventable cancer. It is too late to save Jessica, but we can honour her memory - and those of all the people who have died of HPV-linked cancers - by radically expanding access to HPV vaccination.

Yadavs in focus as 3rd phase a litmus test for SP

Lucknow, May 5: Ten Parliamentary constituencies of Uttar Pradesh will go to polls in the third phase of Lok Sabha elections Tuesday, with all eyes on Samajwadi Party patriarch Mulayam Singh Yadav's family members.

These 10 Lok Sabha constituencies -- Sambhal, Hathras, Agra, Fatehpur Sikri, Firozabad, Mainpuri, Etah, Badaun, Bareilly and Aonla -- witnessed the culmination of a high-pitched campaign Sunday evening.

Of the 10 seats that will vote Tuesday, the BJP won eight in 2019 -- Hathras, Agra, Firozabad, Fatehpur Sikri, Etah, Badaun, Bareilly and Aonla -- while Mainpuri and Sambhal went to the Samajwadi Party.

This phase will be a test for the Samajwadi Party's (SP) first family as well, with Dimple Yadav, Akshav Yadav and Aditva Yadav contesting Mainpuri, Firozabad and Budaun respectively.

In Mainpuri, an SP bastion that the party has never lost, sitting MP Dimple Yadav will take on Jaiveer Singh of the BJP.

In Firozabad, BJP candidate Chandra Sen Jadon is contesting against Akshay Yadav and in Budaun, Aditya Yadav - the son of Shivpal Yadav -- is making his electoral debut against Durvijay Shakya of BJP.

The third phase unfolds with the emergence of Other Backward Classes (OBCs), prominently including Yadavs, Lodhs, and Kachhi/Shakva/Murao communities, exerting influence as decisive factors across various



constituencies. Alongside, the enduring impact of Muslim and Jat demographics remains significant in select areas.

The third phase has also seen some high-pitched campaigns by leaders of all parties.

Prime Minister Narendra Modi, Union Home Minister Amit Shah and UP Chief

Minister Yogi Adityanath led the BJP's campaign against, what they called, dynasty and appeasement politics of the Congress and the Samajwadi Party (SP), and slammed the Opposition for declining the Ram Temple invitation.

The SP, which has much at stake in phase three, pushed its caste census pitch and alleged that the BJP will end reservation and hence is seeking 400-plus seats in the Lok Sabha.

Several constituencies, including Sambhal, Agra, Fatehpur Sikri, Mainpuri and Aonla are witnessing a three-way battle between the NDA and INDIA alliances and the Bahujan Samaj be conducted. Party (BSP) while others like Hathras, Firozabad, Etah and Budaun will see a two-way con-

Samajwadi Party.

The saffron party retained the winning candidates from Etah. Agra (SC), Aonla, and Fatehpur Sikri. It also gave a ticket to Parameshwar Lal Saini from Sambhal Lok Sabha seat.

The Congress has fielded one candidate -- Ramnath Singh Sikarwar from Fatehpur Sikri, while its INDIA bloc ally, the Samajwadi Party, has fielded candidates in the remaining

nine seats in this phase. Sambhal, Hathras (SC), Agra (SC), Fatehpur Sikri, Firozabad, Mainpuri, Etah, Budaun, Aonla and Bareilly are the constituencies where polling will

Over 1.88 crore voters are eligible to decide the fate of 100 candidates in this phase.

HC seeks Delhi govt, police plan for handling bomb threats in schools

New Delhi, May 6: The Delhi High Court Monday sought a detailed response from the Delhi Government and Delhi Police regarding their preparedness and procedures for handling bomb threats in schools.

Justice Subramonium Prasad was hearing a plea filed by lawyer Arpit Bhargava after a bomb threat email was received from Delhi Public School, Mathura Road, last year, which later turned out to be a prank by one of the students "just for fun".

Bhargava, who is a parent, recently also filed an application contending the lack of progress in investigating and resolving three out of five bomb threat incidents reported in schools last year.

Last week, a total of 125 bomb

threat complaints were received from different schools on the emergency helpline number 112 from 5.47am to 2.13pm.

Bhargava's plea contends the

lack of a coordinated action plan

to ensure the safety and security of schoolchildren, teachers, and staff in response to bomb threats. Justice Prasad sought information on the specific roles of nodal officers assigned to han-

dle such threats, the number of mock drills conducted, and the preparedness measures in place across different zones. The court has given the authorities 10 days to file an affidavit detailing their current proto-

cols and the circulars issued on this matter over time. Bhargava stressed the urgency of establishing a comprehen-



sive action plan, criticising the current lack of specific procedures tailored to the unique en-

vironment of schools. In court, the counsel for the Delhi Government, Santosh Kumar Tripathi, assured that

Operating Procedure (SOP) for responding to both hoax and real threats, which includes immediate police notification and

evacuation protocols. However, Justice Prasad expressed concern that these SOPs not sufficiently focused on the specific needs of schools, which range from nursery to high school levels

Further submissions revealed that while mock drills are reging need for a more specialised SOP that addresses the unique vulnerabilities of educational institutions

The court stressed the necessity of involving parents in these drills and ensuring that every school has a robust and rehearsed evacuation plan.

The matter is set to be heard

next May 16. Last week, the Directorate of Education (DoE) apprised the High Court of its "zero-tolerance policy" regarding safety in schools, particularly amid concerns related to bomb threats.

served, can access and download such content from the internet,

which, by itself, is not a crime. Merely because the mobile device of the appellant was found carrying incriminating material including photographs of

terrorist Osama bin Laden, Jihad Promotion, ISIS flags, etc. and he was also accessing lectures of hard-liner Muslim preachers would not be enough to brand him as a member of such terrorist organisation, much less his being acting in furtherance of its cause, the bench, also comprising Justice Manoj Jain, said.

Such type of incriminating material, in today's electronic era, is freely available online and mere accessing the same would not be sufficient to hold that he had associated himself with ISIS.

Lucknow, May 6: Everyone wants their votes but no one wants to campaign in these areas. These are the red light areas of major cities in Uttar Pradesh where politicians don't dare to

Candidates are hesitant to be

Satya Gali, Julaha Gali and Pahadi Gali; which are largely inhabited by sex workers. According to a source, the

women in the area are politically aware and familiar with local politics.

"They have their own political affiliations and watch television to remain abreast with political activities. Some leaders even talk to them on phone and provide whatever facilities they



need. However, no candidate is ever seen here. They campaign by proxy," said a source.

A local trader who owns a garment shop in the area, said, 'Campaigning here is done by those who are involved in the 'trade'. They work on behalf of various parties during elections and even ensure a voter turnout

on polling day." Interestingly, he added, most houses in the area hoist flags of whichever party is in power. This is done to avoid police action. In Safedabad in Barabanki

District, the red light area is

said to be a SP stronghold. The maze of narrow lanes and bylanes, with drains overflowing, has SP flags in abundance. Pradeep Yadav, in his early forties, is the "guardian" of the area. "We did not let the BJP win even during the Modi wave. We will again make the SP win this time," he said. There are about 800 women living in these lanes and there is no poll talk.

'These women will vote wherever Yadav says," informed a candidate and added, "There is no point campaigning because no one listens to us.'

Civic amenities in the area are deplorable but no one is concerned — neither the residents.

nor the authorities In Varanasi, about half a kilometre from the railway station is Shivdaspur. Songs play loudly through the day and night in the lanes that are strewn with garbage. The women here say that they have never seen a leader in person. "Sirf TV par dekha

hai," they say. Similarly, political leaders have never campaigned in Lucknow's 'Chawal wali gali' in the old city area. The 'Chawal wali gali', incidentally, never sold rice. The lane is full of sex workers living here since ages. No one knows how the lane got its name but it is now synonymous with the sex trade.

Remove fake content within three hours: EC

New Delhi, May 6: The Election Commission (EC) Monday directed political parties to remove fake content from their social media platforms within three hours of such content being brought to their notice.

This is part of directives issued by the poll panel to political parties for responsible and ethical use of social media in election campaigning to ensure a level playing field for all stakeholders after taking cognisance of certain violations by them.

Recently, deepfake videos featuring Union Home Minister Amit Shah. Congress leader Rahul Gandhi and actors Aamir Khan and Ranveer Singh posted on certain social media handles were taken down and criminal complaints were filed.

The election watchdog also warned the parties against misuse of AI-based tools.

"Taking cognisance of certain violations of MCC and the extant legal provisions by Political Parties/their representatives while using social media for election campaigning, the Commission today has issued directions to political parties for responsible and ethical use of social media in election campaigning to ensure level playing field among all stakeholders," a EC statement said.

For instance, in 2017 UP Assembly elections, the relatively unknown Pichhda Varg Mahapanchayat Party (PVMP) contested the polls with the matchstick as its poll symbol.

The party claimed to have the support of OBCs "who have been betrayed by almost all parties' and said it would contest all 403 seats. The PVMP failed to make any waves in the polls and its performance was not even worth recording.

The party vanished from the political horizon after that.

The Sarv Sambhav Party (SSP), headed by Bollywood actor Rajpal

Yadav, met with a similar fate. The SSP entered the poll arena in the state in 2017 but nothing was heard about the SSP or its

leaders after that. An SEC official said that the registration of political parties was often done with ulterior mo-

'The Election Commission should debar parties that register themselves and then do not contest elections or even get a specified number of votes. Many

of these outfits make good money during elections by outsourcing their agents and vehicles. Strict action needs to be taken in cases of such parties," he said.



MARINE HEATWAVE Coral bleaching in Lakshadweep intensifies

Marine heatwaves are rare extreme weather events that involve prolonged periods of abnormally high ocean temperatures

Kochi, May 6: Researchers at the ICAR-Central Marine Fisheries Research Institute (CMFRI) have recorded widespread bleaching affecting the coral reefs in the Lakshadweep Sea due to marine heatwaves.

A survey from several Lakshadweep islands showed that a considerable percentage of the hard coral species have undergone severe bleaching, primarily due to a prolonged period of marine heatwave affecting the region since late October 2023.

These temperatures often exceed the 90th percentile of typical regional ocean tempera-

tures based on historical data. In Lakshadweep, the Degree Heating Week (DHW) indicator,



which measures accumulated heat stress, has surged above 4 degrees Celsius-weeks.

According to the National Oceanic and Atmospheric Administration (NOAA), this level of DHW poses a substantial risk of coral bleaching, threatening the region's diverse marine

Dr KR Sreenath, senior scientist of CMFRI said such heat stress levels signify a severe threat to coral health, leading to extensive bleaching where corals lose the symbiotic algae (zooxanthellae), compromising their survival by depriving them of essential nutrients.

"If the DHW continues to rise, reaching beyond 12 degrees Celsius weeks, it could precipitate an unprecedented biodiversity crisis due to multispecies mortality," said Dr Sreenath.

According to Dr Shelton Padua, senior scientist at CMFRI, the primary causes of these marine heatwaves are excessive heat atmospheric transfer coupled with shifts in ocean currents, leading to unusually high water temperatures.

"Since October 27, 2023, the Lakshadweep Sea, spanning from 80.0 to 12.0 N latitude and 71.0 to 75.0 E longitude, has been experiencing these conditions, with temperatures consistently registering rises greater than 1 degree Celsius above the norm. said Dr Padua.

Viewing that the health of marine ecosystems is integral to the livelihoods of coastal communities, influencing tourism and fisheries sectors, Dr Sreenath said that the ongoing marine heatwaves are likely to cause significant economic losses by disrupting their vital ecosystem services

"Death and disintegration of coral reefs can threaten the coastal communities, leaving them vulnerable to the impacts of sea level aggressions," added Dr Sreenath.

CMFRI has been actively undertaking studies to better understand ecological changes affecting coral reefs besides initiating a comprehensive national project aimed at investigating the resilience potential of various coral reefs in India.

Reports of NEET-UG question paper leak baseless, says NTA

New Delhi, May 6: The reports claiming question paper leak in the medical entrance exam NEET-UG are "completely baseless and without any ground", the National Testing Agency (NTA) clarified Monday.

Stressing that every question paper has been "accounted for", the NTA said that purported images of the question paper circulating on social media have no relation with the actual paper.

"It has been ascertained from NTA's security protocols and Standard Operating Procedures that the social media posts pointing towards any paper leak are completely baseless and without any ground. To put rumours to rest, it is also stated that every single question paper has been accounted for,' said Sadhana Parashar, Senior Director, NTA

Parashar said that no external person or agency can access the centres once the examination starts.

She said that after the gates of the examination centres are closed, no one from outside is permitted access inside the halls, which are under CCTV

surveillance. "All other photographs of question papers circulating in social media have no relation to the actual examination question paper which has been administered," she added.

The entrance exam was conducted Sunday at 4,750 centresin 571 cities including 14 cities abroad.



Rio De Janeiro: Massive floods in Brazil's southern Rio Grande do Sul state have killed at least 75 people over the last seven days, and another 103 were reported missing, local authorities said Sunday. At least 155 people were injured, while damage from the rains forced more than 88,000 people from their homes. Approximately 16,000 took refuge in schools, gymnasiums and other temporary shelters. The floods left a wake of devastation, including landslides, washedout roads and collapsed bridges across the state. More than 800,000 people are without a water supply, according to the civil defence

Flee Rafah: Israel orders Gazans

Rafah, May 6: Israel's military carried out airstrikes in Rafah Monday, residents said, hours after Israel told Palestinians to evacuate parts of the southern Gaza city where more than a million people uprooted by the war have been sheltering.

Fears are growing of a fullblown assault in Rafah, long threatened by Israel, against holdouts of the Palestinian militant group Hamas as ceasefire talks in Cairo stall.

Instructed by Arabic text messages, phone calls, and flyers to move to what the Israeli military called an "expanded humanitarian zone" 20 km (7 miles) away, some Palestinian families began trundling away under chilly spring rain.

A senior Hamas official said the evacuation order was a "dangerous escalation" that would have consequences. "The US administration, alongside the occupation, bears responsibility for this terrorism," the official, Sami Abu Zuhri, told Reuters, referring to Israel's alliance with Washington.

Aid agencies have warned that the evacuation order will lead to an even worse humanitarian disaster in the crowded coastal enclave of 2.3 million people reeling from seven months of war.

EU ends rule of law proceedings against **Poland under Tusk**

Brussels, May 6: The European Union Commission is to end six years of rule of law proceedings against Poland, Commission President Ursula von der Leyen said Monday, marking the opening of a "new chapter" for the country.

The proceedings were launched when far-right populist party PiS ruled the country. Donald Tusk, a pro-EU liberal, became prime minister last year, putting Poland on a more pro-EU course.

The EU said in a statement that Poland had launched a series of legislative and non-legislative measures to address concerns about the independence of the justice system.

"Today marks the opening of a new chapter for Poland," Von der Leyen said in a post on X.

Poland had recognised the primacy of EU law and was committed to implementing the judgements of the Court of Justice of the European Union and the European Court of Human Rights, the EU said.

Poland's Law and Justice (PiS) party, which ruled for eight years, had carried out a deep overhaul of the judiciary which the EU said damaged democratic checks and balances and brought courts under political influence.

Ferry service to resume between Lanka's Jaffna, Nagapattinam in Tamil Nadu



Colombo: The passenger ferry service between Nagapattinam in India and Kankesanthurai (KKS) suburb of Jaffna district in the Northern Province of Sri Lanka is set to resume May 13, the Indian High Commission said Monday. The service, which had been launched in October last year after nearly 40 years, was halted a few

days later owing to rough weather. "Strengthening maritime connectivity between India and Sri Lanka was a vital component of the vision document for economic partnership jointly adopted during the visit of the president of Sri Lanka to India in July 2023. The resumption of the ferry service is an affirmation of the people-centric policies of the Government of India," the high commission said in a statement.

Williams set for 3rd space trip

Washington: Indian-origin astronaut Sunita Williams is ready to fly into space for the third time Tuesday as the pilot aboard Boeing's Starliner spacecraft in its the first crewed test flight. Boeing's Starliner will blast off for the International Space Station from Cape Canaveral in Florida. Starliner will carry Williams, 58, and Butch Wilmore to the International Space Station, marking what could be a momentous and longawaited victory for the beleaguered Boeing programme. "We are all here because we are all ready. Our friends and family have heard about it and we've talked about it and they are happy and proud that we are part of the process to fix it all," the BBC quoted Williams as saying. The mission has been delayed for several years because of setbacks in the spacecraft's development.

Moscow, May 6: Russian President Vladimir Putin has ordered nuclear weapons drills near Ukraine, Moscow said Monday, in response to "threats" from Western officials to deploy NATO troops to Ukraine.

The announcement came as Russian forces said they captured two villages in the warbattered regions of Donetsk and Kharkiv in eastern Ukraine. where outgunned and outmanned Ukrainian troops have struggled to hold the line.

Russian officials in the border region of Belgorod meanwhile announced that Ukrainian attack drones had killed six people and wounded over 30, including several children.

Putin has upped his nuclear rhetoric since ordering his army into Ukraine in 2022, warning in February there was a "real" risk of nuclear war.

The defence ministry gave no date for the drills, but said they would involve the air force, navy Ukraine. It said they were aimed at ensuring Russian territorial integrity in the face of Western "threats.

The Kremlin specified that the exercises were a response to statements by French President Emmanuel Macron and British officials.

Russia has in recent days hit out at Macron for telling The Economist magazine he was "not ruling anything out" in the West's response to the conflict in Ukraine, including sending troops to the country.

It has also blasted UK Foreign Secretary David Cameron for saying Kyiv has the right to strike targets inside Russia.

"They are talking about the readiness and even the intention of sending armed contingents to Ukraine -- that is, in fact, to put NATO soldiers in front of the Russian military," Kremlin spokesman Dmitry Peskov said.

Peskov singled out "dangerous rhetoric" issued by Macron, who said the question of sending troops to Ukraine would "legitimately" arise if Russia broke through Ukrainian front lines and Kyiv made such a request. Macron made similar state-

Russia also threatened to strike British military facilities and said it would hold drills simulating the use of battlefield nuclear weapons amid sharply rising tensions over comments by senior Western officials about possibly deeper involvement in the war in Ukraine.

After summoning the British ambassador to the Foreign Ministry, Moscow warned that Ukrainian strikes on Russian territory with UK-supplied weapons could bring retaliatory strikes against British military facilities and equipment on Ukrainian soil or elsewhere.

Houthi, Ukraine sea drone attacks reshape ocean warfare

SEA DRONE WARFARE HAS ARRIVED AS AMERICA IS FLOUNDERING, SEEKING TO **COUNTER CHINA'S NAVAL POWER**

Washinton, May 6: The US Navy's efforts to build a fleet of unmanned vessels are faltering because the Pentagon remains wedded to big shipbuilding projects, according to some officials and company executives, exposing a weakness as sea drones reshape naval warfare.

The lethal effectiveness of sea drones has been demonstrated in the Black Sea where Ukraine has deployed remote-controlled speed boats packed with explosives to sink Russian frigates and minesweepers since late

Yemeni-backed Houthi rebels have employed similar vessels against commercial shipping in the Red Sea in recent months, albeit without success

These tactics have caught the attention of the Pentagon, which

is incorporating lessons from Ukraine and the Red Sea into its plans to counter China's rising naval power in the Pacific, Pentagon Spokesman Eric Pahon told Reuters

In a signal of the Pentagon's intent, Deputy Secretary of Defense Kathleen Hicks announced an initiative in August - named Replicator - to deploy hundreds of small, relatively cheap air and sea drones within the next 18-24 months to match China's growing military threat.

This public show of commitment masks years of hesitation by the US Navy to build a fleet of unmanned vessels despite repeated warnings this was the future of maritime warfare, according to interviews with a dozen people with direct knowledge of the US sea drone plans, including Navy officers, Pentagon officials, and sea drone company



executives.

Two Navy sources and three executives at sea drone manufacturers said the biggest impediment to progress has been a Department of Defense (DoD) budget process that prioritizes big ships and submarines built by legacy defense contractors.

"At some point, you hit the DC problem," said Philipp Stratmann, CEO at Ocean Power Technologies (OPT), a New Jersey-based firm that supplies

the US Navy with the WAM-V, an autonomous surface drone. "You hit the fact that there is a military industrial complex that has the best lobbyists and knows exactly how the money flows and contracting works in the DoD.'

A Navy spokesperson said it "acquires capabilities based on fleet demand signals", referring to the messages headquarters

receive from commanders at sea. The Navy has a budget of \$172 million this year for small and

medium-sized underwater sea drones, falling to \$101.8 million in 2025, the spokesperson said. That's a tiny fraction of the \$63 billion Navy procurement budget proposed by President Joe Biden's administration for 2025.

Military sea drones can range from missile-armed speed boats to minehunting miniature submarines and solar-powered sailboats equipped with high-definition spy cameras, underwater sensors and loudspeakers used to holler warnings at enemy ships.

There aren't enough Navy sailors trained to pilot drones or to analyze vast swathes of data sent back from the craft's cameras and sensors, the sources said.

The spokesperson said the Navy was in the process of improving its data collection and analysis from sensors.

Pentagon spokesman Pahon said the DoD has been "laserfocused on accelerating innovation over the last three years",

including the use of sea drones. Acknowledging budget chal-

lenges, Pahon said the Pentagon was using innovative ways to cross "the valley of death", a term used to describe the torturous approval process new inventions travel through to be purchased in large quantities. **REPLICATOR PROGRAMME**

One example Pahon cited was the Replicator program: the short-term, \$500 million-a-year project is designed to cut through bureaucracy and fast track the deployment of thousands of cheap aerial and sea drones.

These drones will be used to match China's rapidly-growing air and naval power in the Asia-Pacific region, the Pentagon's Hicks said at the project's launch in August. She said Replicator is being funded mainly by reallocating funds from the existing Pentagon budget.

As part of the initiative, the Pentagon in January issued a solicitation for private companies to deliver small sea drones to the Navy, demanding production capacity of 120 vessels per year, with deployment beginning in April 2025.

New Delhi, May 6: India's services sector growth eased slightly ness and output remained sharp and among the fastest in 14 years amid favourable economic conditions and strong demand, a monthly survey said Monday.

The seasonally adjusted HSBC India Services Business Activity Index fell from 61.2 in March to 60.8 in April, highlighting one of the strongest growth rates seen in just under 14 years.

Survey members attributed the latest upturn in output to favourable economic conditions, demand strength and rising intakes of new work

In the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

"India's service activity rose at a slightly softer pace in April, backed by a further rise in new orders, with a notable strength in domestic demand," said Pranjul Bhandari, Chief India Economist at HSBC.

In addition to buoyant domestic demand, firms noted new business gains from several parts of the world, which collectively underpinned the second-quickest upturn in international sales since the series started in



On the job front, a few service providers in India showed an increased appetite for new hires in April, amid rising inflows of new business. However, several companies indicated that payroll numbers were sufficient for current reguirements, and the rate of job creation was marginal and softer than that seen at the end of the previous fiscal year.

"In response to increased new orders, firms expanded their staffing levels, though the pace of hiring growth decelerated,'

On the price front, wage pressures and higher food prices meanwhile led to another increase in cost burdens, which firms partially passed on to their customers.

"Input costs continued to rise sharply, albeit slower than in March, but resulted in squeezed margins for service firms, as only part of the price rise was passed on to clients through output charges," Bhandari said.

Meanwhile, confidence among service providers towards the year-ahead outlook for business activity improved to a 3-month

Marketing efforts and efficiency gains, alongside plans to price competitively and predictions that demand conditions will remain favourable, boosted

optimism, the survey said. Meanwhile, the HSBC India Composite PMI Output Index moderated to 61.5 in April, from 61.8 in March, the latest reading was one of the highest seen in close to 14 years and signalled a substantial rate of expansion across the private sector.

"In terms of overall activity, aggregate output across both the manufacturing and service sectors rose significantly in April, albeit at a slightly slower pace, indicating sustained health in these sectors," Bhandari said.

During April, manufacturers continued to note a stronger increase in new business intakes than service providers. Aggregate sales rose sharply, and at one of the fastest rates since mid-2010. Composite PMI indices are

BSNL to launch 4G services across **India in August**

New Delhi, May 6: State-owned BSNL will start rolling out 4G services across the country from August, using completely indigenous technology in line with the government's 'Atmanirbhar' policy, according to official sources.

BSNL officials claimed to have recorded peak speed of 40-45 megabit per second on the 4G network which has been rolled out in the premium spectrum band of 700 megahertz (Mhz) as well as in 2,100 Mhz band during the pilot phase.

The company has rolled out 4G services in Punjab using indigenously developed technology by IT company TCS and state-run telecom research organisation C-DoT-led consortium and onboarded around 8 lakh subscribers


"The 4G core developed by C-DoT is performing very well in the BSNL network in Puniab. It was installed in July last year. It takes 12 month to prove the success of such complex technology but the C-DoT core has stabilised within 10 months.

BSNL will launch atmanirbhar 4G technology across the country in August. a senior government official, who did not wish to be named,

The core network is a collection of network hardware, devices, and software that provides fundamental services in a telecommunication network. Telecom regulator Trai in a recent paper explained core as part of a network that offers the functionality of aggregation, call control, switching, authentication, charging, gateway functionality, etc.

In comparison, the holding of mutual funds was at 8.81 per cent in the quarter ended December 2023. LIC, the single-largest domestic institutional investor, saw its share (across 280 companies where it owns more than 1 per cent) increasing to 3.75 per cent as of March 2024 from 3.64 per cent as of December 2023.

The share of Domestic Institutional Investors (DIIs), which includes domestic mutual funds, insurance companies, banks, financial institupension funds,

Non-Banking Financial Companies (NBFCs) as a whole increased to 16.05 per cent in the quarter under review from 15.96 per cent in the preceding quarter. This increase was on the back of a huge inflow of ₹1.08 lakh crore. Indian airlines to cater to half of int'l traffic by FY'28: CRISIL

Mumbai, May 6: As much as half of the country's international air passenger traffic is expected to be catered by Indian airlines by financial year 2027-28, credit ratings agency CRISIL said Monday

The share of Indian airlines in international passenger traffic, including originating or terminating as well as the traffic transitioning through the country, is seen surging 700 basis points to around 50 per cent by 2027-28, from 43 per cent in the previous fiscal, it said.

The improvement would be driven by Indian airlines deploying additional aircraft and adding new routes in the international segment, as well as their inherent advantage of superior domestic connectivity

The report noted that business profiles of Indian carriers will strengthen as a result of their rising share in international traffic, which is more profitable than the domestic segment.

India's international passenger traffic grew to around 70 million in fiscal 2024, from a low of 10 million in pandemic-hit fiscal 2021, and has surpassed the pre-pandemic level, according to CRISIL.

The share of Indian airlines, which was rising steadily earlier, picked up pace since the pandemic, it said.

"A noticeable shift in spending patterns has emerged after the pandemic, as evident in the increasing inclination of Indians towards international leisure travel. Increasing disposable incomes, easing visa requirements,



travel," said Manish Gupta, Senior Director and Deputy Chief Ratings Officer at CRISIL Ratings.

The government's focus on making India a hub for tourism is also expected to provide a filcompound annual growth rate (CAGR) of 10-11 per cent over the next four fiscals, against a mere 5 per cent CAGR in the four years prior to the pandemic,

Indian airlines have added 55

These include direct flights originating from additional cities to popular long-haul destinations in the United States, Europe and Australia, effectively reducing flying time and eliminating layovers, CRISIL said.

It also said that Indian airlines are also aiming to deploy additional aircraft on the shortand medium-haul international routes and leveraging codeshare agreements with major global airlines to offer onward connectivity to passengers.

As such, CRISIL said, Indian airlines have certain natural advantages in cornering a larger share of the country's international traffic compared with foreign airlines.

They have superior domestic connectivity than their overseas counterparts, which serve only

travellers from tier 2 and tier 3 cities, the report stated.

India's geographic location also lends itself well to air connections between the Europe, Middle East, and Africa (EMEA) and Asia Pacific regions, potentially positioning the country as a hub for international travel, the report noted.

"To capitalise on the growth in international travel, Indian airlines are investing in widebody and long-range narrow body aircraft for network expansion, adding new international routes and introducing long-haul nonstop flights to key destinations, " said Ankit Kedia, Director, CRISIL Ratings.

Aided by the planned fleet addition and network expansion strategy, Indian airlines could log a CAGR of 14-15 per cent in the international segment over the next four fiscals, taking their $\overline{}$ market share to 50 per cent,

Nassau (Bahamas), May 6: The Indian men's and women's 4x400m relay teams qualified for Paris Olympics after finishing second in their respective second-round heats at the World Athletics Relays here Monday.

In the women's competition. the quartet of Rupal Chaudhary, MR Poovamma, Jyothika Sri Dandi and Subha Venkatesan clocked 3 minutes and 29.35 seconds to finish second behind Jamaica (3:28.54) in heat number one to book a Paris Games ticket.

Later, the men's squad of Muhammed Anas Yahiya, Muhammed Ajmal, Arokia Rajiv and Amoi Jacob finished with a collective timing of 3 minutes and 3.23 seconds to also finish second in their heat, behind USA

The top two teams in each of the three heats in the second round were to qualify for the Olympics to be held from July 26 to August 11.

It was a sort of a surprise that the women's 4x400m team qualified for the Olympics as the focus was more on the men's 4x400m team which has broken Asian record in back-to-back global events – Tokyo Olympics and 2023 World Championships as well as winning 2023 Asian Games gold.

The Indian women's team had finished fifth in the first-round qualifying heat Sunday with a time of 3 minutes and 29.74 sec-

The men's team had failed to finish in the first-round qualifying heat after second leg runner Rajesh Ramesh pulled out midway due to cramps. Arokia Rajiv took the place of Ramesh in the team and he ran the third leg after Anas and Ajmal.

The Indian men's 4x400m team was on third position when anchor-leg runner Jacob took the baton from Arokia but the Delhi boy ran a fantastic race to overtake his Mexican opponent and finish second.

It was not about the timing but more about Olympics qualification for the Indian men's team which ran 3:00.25 at the Tokyo Olympics for the then Asian record before bettering it during the 2023 World Championships with yet another Asian record of 2:59.05. Monday's timing was well below the team's

India had even given a mighty scare to formidable USA during the heat race at the 2023 **Budapest World Championships** before settling for the second

Meanwhile, India pulled out of the mixed 4x400m relay second round heat races Monday as Ramesh was not available after suffering muscle cramps while running the men's 4x400m first round heat Sunday.

India had featured in mixed 4x400m relay in the Tokyo Olympics where the event made its debut. The Indian women's 4x400m relay team will be returning to Olympics after missing out in Tokyo Games. The Paris participation will be the eighth time for the Indian women's 4x400m team, the first being in 1984 Games.

For the men's 4x400m, this will be the fourth time India will be taking part in the Olympics, the first being in the 2000 Sydney Games. With this, India now have at least 19 Paris-bound track and field athletes and the list includes defending javelin throw champion Neeraj Chopra among

The athletics events at the Games will begin August 1. A total of 70 teams have qualified for relay events at the Paris Olympics following two days of thrilling action at the World Athletics Relays Bahamas.


Norris holds off Max to win Miami Grand Prix

Miami, May 6: McLaren's Lando Norris capitalised on a bit of good fortune to win the Miami Grand Prix Sunday, holding off Red Bull's triple world champion Max Verstappen for his first Formula One victory.

It was a long overdue triumph for the Briton who held the record for most podiums without a win (15), having finished runner-up an agonising eight times in 110 grand prix.

Verstappen had seemed well placed to claim a fifth win in six races until a midway crash allowed McLaren to cash in on a safety car period, with Norris pitting and coming out with the lead.

Seeking a hat-trick of wins here, the Dutchman filled Norris's mirrors on the restart but his Red Bull could offer no challenge as the McLaren pulled clear. Ferrari's Charles Leclerc completed the podium, coming home third ahead of teammate



Sainz was later penalised five seconds for his involvement in a collision with McLaren's Oscar Piastri dropping the Spaniard to fifth. The penalty moved Verstappen's Red Bull teammate Sergio Perez up one spot to

In a season dominated by Red Bull it was a hugely popular win by the 24-year-old Briton. Pulling into the pit lane Norris was mobbed by his team, congratulated by the other drivers. Mercedes' seven-time World Champion Lewis Hamilton was sixth.

RUBLEV OVERCOMES FEVER TO WIN MADRID OPEN TITLE

Madrid, May 6: Despite sleepless nights struggling with a fever, Andrey Rublev found a way to fight back and win the Madrid Open for the first time. Rublev was feeling sick all week but rallied to beat Felix Auger-Aliassime in three sets Sunday and clinch his second Masters

1000 title. Rublev won 4-6, 7-5, 7-5 after Auger-Aliassime double-faulted on the last point of the final at the clay-court tournament in

the Spanish capital. "I would say this is the most proud title of my career," Rublev said. "I was almost dead every day. I was not sleeping at night. The last three, four days I didn't sleep." Rublev gave "full credit to the doctors," who were "doing some tricky things" just to make sure he could play.

"I have no words," the eighthranked Rublev said. "If you knew what I had been through in the past nine days you would not imagine that I would be able to win a title.'

The 26-year-old Russian won his first Masters 1000 title at Monte Carlo last year. Auger-Aliassime was playing in his first final at this level.

Rublev entered Madrid on a four-game losing streak after early exits at Indian Wells,



Miami, Monte Carlo and Barcelona. One of his victories in Madrid came in the quarterfinals against home-crowd favorite Carlos Alcaraz.

He now has 16 career titles, and two this season after Hong Kong in January. He had arrived with a 5-1 record against Auger-Aliassime, including a win in their sole matchup on clay.

Auger-Aliassime's path to the final saw second-ranked Jannik Sinner withdraw because of an

injury ahead of the quarterfinals, and Jiri Lehecka retired against the Canadian in the first set of the semifinals.

Other injuries hit the men's draw in Madrid, starting with Novak Djokovic's withdrawal before the tournament. Daniil Medvedev retired in the quarterfinals, while Alcaraz was hampered by a sore right arm and Rafael Nadal bowed out of what was likely his last appearance in his home country.
