64% polling in Odisha

Bhubaneswar, May 13: The first phase of Lok Sabha and Assembly elections in Odisha Monday was peaceful barring some sporadic incidents of violence, with a voter turnout of over 64 per cent, officials said.

The electoral fate of 280 candidates contesting in four Lok Sabha seats and 28 Assembly segments in the first phase was sealed in the EVM.

The polling was by and large peaceful barring some sporadic incidents in Ganjam and Nabarangpur districts, while two persons were injured in a clash between rival groups during polling in Chikiti Assembly segment, a police official said.

Voting started at 7am in 7,303 polling stations in Berhampur, Koraput, Nabarangpur, and Kalahandi Parliamentary constituencies along with 28 Assembly segments within the jurisdiction of these Lok Sabha seats. Lok Sabha and Assembly elections are being held simultaneously in Odisha.

Officials said that 64.81 per cent of voters exercised their franchise. The highest voter turnout was recorded in tribal-majority Nabarangpur LS seat at 68.74 per cent followed by Kalahandi (68.50), Koraput (61.43) and Berhampur (60.28)

(60.26). For Assembly segments, the highest 71.30 per cent of voting was recorded at Dabugam and the lowest 47.90 per cent in Chhatrapur.

"The voter turnout could increase as the polling continued in certain booths even after the end of voting time at 6pm," an official said.

There was no major law and order issue and the voting was peaceful in the Left Wing Extremism hit places like Swabhiman Anchal (earlier known as cut off area) in Malkangiri district and Sunabeda sanctuary area in Nuapada district.

equipment were airdropped in Nuapada in view of the situation there, a senior official said. Chief Electoral Officer Nikunja Bhiari Dhal said that EVM glitches were detected in several places and the machines were replaced within 30 minutes.

"People of Kotia area under Koraput LS seat also participated in large numbers," Dhal said. Kotia area is located bordering Andhra Pradesh. The CEO also said that the Election Commission received reports of poll boycott from some places over local issues.

Meanwhile, both the ruling BJD and the Opposition BJP have claimed that they performed exceptionally well in the first phase of the elections.

Bhubaneswar: Chief Electoral Officer Nikunja Bihari Dhal Monday suspended three polling officials and directed the police to arrest two of them for serious dereliction of duty. Speaking to reporters, Dhal said, "We have directed the Ganjam Collector to suspend three presiding officers of three polling booths and arrest two of them for serious dereliction of duty." The presiding officer of polling booth number 193 in Gopalpur Assembly constituency has been put under suspension while the presiding officers of booth numbers 27 and 163 in Chhatrapur Assembly segment in Ganiam district have been suspended and police were directed to arrest them, he said.Earlier in the day, the CEO suspended one polling official in Narla Assembly constituency in Kalahandi district and another in Chikiti Assembly seat in Ganjam district. So far, five polling officials have been suspended after they were engaged in serious misconduct during the election, officials said.

4th phase turnout at 64%


NEW DELHI: A voter turnout of over 64 per cent was recorded Monday in the fourth phase of the Lok Sabha elections covering 96 constituencies spread over 10 states and Union territories, with scattered incidents of violence reported in West Bengal and Andhra Pradesh.

West Bengal, where polling was held in eight constituencies, again recorded an impressive turnout at 76.56 per cent, the highest among states/UTs in this phase.

Srinagar constituency in Jammu and Kashmir witnessed 37.93 per cent voting in the first Lok Sabha election in the Valley since the scrapping of Article 370, with the EC stating that it was the highest turnout in decades.

According to the EC's voter turnout app at 10 pm, the overall voting in this phase was 64.05 per cent. However, it said that this was an approximate trend as data from polling stations was still being collated.







Girls outshine boys again

New Delhi, May 13: Girls continued to outperform boys yet again in the Central Board of Secondary Education (CBSE) Class X and XII exams the results of which were announced, Monday

While the pass percentage in Class X stood at 93.6 – a rise of 0.48 percentage points from last year, Class XII pass percentage stood at 87.98 - a marginal increase of 0.65 percentage points from last year.

In the Class X exams, girls nave performed better than boys by 2.04 percentage points. While 94.75 per cent girls cleared the exams, 92.71 per cent boys managed to pass the exams.

IRREGULAR by MANJUL

In Class XII, girls have done better than boys by 6.4 percentage points. The pass percentage for girls stood at 91.5 while that of boys was 85.12.

CBSE officials attributed the rise in the pass percentage to the increase in the number of competency-based questions in the exams this year. The CBSE revamped its assessment practices for the academic session 2023-24 by introducing more competency-based questions in the papers and reducing the weightage given to short and long answer-type questions.

A similar trend was in the number of students who scored above 90 per cent and 95

per cent marks. In Class XII, a total of 1.16

students scored above 95 per cent and over 2.12 lakh above 90 per cent. Last year, 1.95 lakh students scored above 90 per cent and 44,297 above 95 per cent.

In category-wise performance, the overall pass percentage among general students in Class XII was 90.06, for students in the Scheduled Caste (SC) category, it was 85.51, for Scheduled Tribe (ST) students, it was 77.73 and for

OBC students, it was 93.92. The CBSE has announced that there will be no merit list to 'avoid unhealthy competition'. Officials said the board has also decided to scrap awarding first, second and third divisions based

on the students' scores. The CBSE also announced that it will conduct the board exams for Class X and XII for the 2024-25 academic session from February 15 next year. The 2024 board exams for Class X and XII also began February 15.

MUMBAI DUST STORM

8 killed, 70 hurt as billboard collapses

Mumbai, May 13: A 100-foot tall illegal billboard fell on a petrol pump at the Cheddanagar Junction in Ghatkopar area amid unseasonal rains, accompanied by a dust storm Monday, killing at least eight persons and injuring 70 others, even as a search and rescue operation was still un-

"78 people have been pulled out so far from under the hoarding, of which eight are declared dead, while 70 others were injured. They were rushed to various hospitals," a senior police officer said.

Meanwhile in Bandra, a branch of a tree fell on a shop, trapping two persons. "Of them, a 38-year-old man died while another person was seriously injured," a civic official said.

In Wadala, an under-construction metal parking tower collapsed on a road amid gusty winds, injuring three persons and damaging vehicles.

Of the total injured persons, 56 were admitted to Rajawadi Hospital and others at three separate hospitals.

The unseasonal rain and dust storms led to the suspension of flight operations at Mumbai airport for an hour in the evening due to low visibility, services of local trains were delayed while traffic snarls were seen in several areas.

As many as 15 flights were diverted to different airports and the runways operation resumed at 5.03 pm, the airport operator

Chief Minister Eknath Shinde visited the spot of the hoarding collapse incident in Ghatkopar late in the evening and ordered a structural audit of all hoardings in Mumbai city.

"The hoardings, if found illegal and dangerous, would be removed immediately," he said.

"It is a very unfortunate incident. The government will probe it, and the people responsible will face action. I have also asked the BMC commissioner to conduct a structural audit of all the hoardings in the city. Those found illegal and dangerous will be removed," Shinde told reporters.

He announced aid of ₹5 lakh to the kin of each person killed in the hoarding collapse. Speaking to media persons

after visiting the disaster control room at the civic headquarters, Mumbai Municipal Corporation Commissioner Bhushan Gagrani said the hoarding was illegal as the Brihanmumbai Municipal Corporation (BMC) had not given permission. "The Railways has permitted to erect

the hoarding," Gagrani claimed.
According to BMC officials, the hoarding measuring 120 \boldsymbol{x} 120 feet crashed on the petrol pump at around 4:30pm. An official said the civic body doesn't permit any hoarding measuring above 40 x 40 feet.

SUSHIL MODI LOSES BATTLE TO CANCER

New Delhi: Veteran BJP leader and former Bihar Deputy Chief Minister Sushil Kumar Modi passed away at the AIIMS here Monday evening a little over a month after he revealed he had cancer. He was 72, Modi, who was a Raiva Sabha member, had declined to contest the ongoing LS elections on account of his health after he revealed the deadly disease he was suffering from in a post on X April 3. Spanning 11 years between 2005 and 2020, Modi had served as the Deputy of CM Nitish Kumar in two stints. Leaders across party lines condoled his demise.

ARREST WARRANT **AGAINST ANUBHAV**

Cuttack: A court here in Cuttack district Monday issued a nonbailable warrant (NBW) against actor-turned-Lok Sabha MP Anubhav Mohanty in connection with a four-vear-old domestic violence case registered against him by his now-divorced wife. The iudicial magistrate's court issued the warrant after Mohanty failed to appear before it for the second time and asked the police to execute the NBW by May 23. The cine star who was the Kendrapara MP of BJD ioined the BJP April 1.

Keonjhar, May 13: Government Railway Police (GRP) in Bhadrak Monday recovered the mutilated body of Assistant Block Development Officer (ABDO) of Harichandanpur from the railway track near Harichandanpur railway station in Keonjhar district.

The deceased ABDO was identified as Bidhubhushan Jena, 50, a native of Nisankhapur village under Hatadihi block of Keonjhar district.

The matter came to the fore when locals spotted the body lying on the railway track near the railway over-bridge about 1 km from the railway station and informed the Harichandanpur police. His head and body bore

After Delhi, over 50 Jaipur schools get bomb threat; turns out hoax

Jaipur, May 13: Over 50 schools here received bomb threats via email Monday morning, triggering panic among students and their parents, police said.

However, no explosive or anything suspicious has been found so far in these schools, they

The threatening emails to schools came 12 days after a similar scare in Delhi-NCR where 150 schools received bomb threat emails from a Russiabased mailing service May 1. triggering massive evacuations and searches. On Sunday, 20 hospitals, including the IGI Airport and the Northern Railways' CPRO office, in Delhi received similar emails. The authorities declared both the incidents as hoax

The emails to schools in Jaipur also happen to come on the 16th anniversary of the serial bomb blast incident in the Rajasthan capital. A series of blasts had rocked the city on this day in 2008 claiming 71 lives and injuring 180 people.

According to the police, 56 schools in Jaipur received emails stating explosives were planted on their premises. On being informed, squads were rushed to these locations to check for suspicious objects or devices.

No suspicious objects were found wherever the checks have been completed, the police said.

Illness took away her voice; AI brings it back!

Rapidly improving AI voice-cloning technology can amplify phone scams, disrupt democratic elections and violate the dignity of people — living or dead — who never consented to having their voice recreated to say things they never spoke. But Bogan and a team of doctors at Rhode Island's Lifespan hospital group believe they've found a use that justifies the risks

Providence, May 13: The voice Alexis "Lexi" Bogan had before last summer was exuberant. She loved to belt out Taylor Swift and Zach Bryan ballads in the car. She laughed all the time — even while corralling misbehaving preschoolers or debating politics with friends over a backyard fire pit. In high school, she was a soprano in the chorus.

Then that voice was gone. Doctors in August removed a life-threatening tumour lodged near the back of her brain. When the breathing tube came out a month later, Bogan had trouble swallowing and strained to say "hi" to her parents. Months of rehabilitation aided her recovery,



but her speech is still impaired. Friends, strangers and her own family members struggle to understand what she is trying to tell

a voice clone generated by artificial intelligence that she can summon from a phone app. Trained on a 15-second time capsule of her In April, the 21-year-old got her teenage voice — sourced from a cooking demonstration video she recorded for a high school project – her synthetic but remarkably real-sounding AI voice can now say almost anything she wants. She types a few words or sentences into her phone and the app instantly reads it aloud.

"Hi, can I please get a grande iced brown sugar oat milk shaken espresso," said Bogan's AI voice as she held the phone out her car's window at a Starbucks drivethru. One of her first experiments was to speak to the kids at the preschool where she works as a teaching assistant. She typed in "ha ha ha ha" expecting a robotic response. To her surprise,

it sounded like her old laugh. "I get so emotional every time Pamela Bogan, tears in her eyes. "I think it's awesome that I can have that sound again,' added Lexi Bogan, saying it

I hear her voice," said her mother,

helped "boost my confidence to somewhat where it was before all this happened." Bogan is one of the first people — the only one with her condition — who have been able to recreate a lost voice with OpenAI's new Voice Engine.

ODISHA RECORDS PASS PERCENTAGE OF 80.85 IN CLASS XII AND 91.53 IN CLASS X

Bhubaneswar, May 13: The Central Board of Secondary Education (CBSE) exam results for Class X and XII were announced Monday. The state registered a pass percentage of 80.85 in Class XII and 91.53 in Class X. City schools recorded good results this year as well.

In the Class XII results, BJEM School students both in Science and Commerce streams performed overwhelmingly. Out of 145 students, who appeared in the Science stream, six secured 95 per cent marks and above, 23 secured 90 per cent and above with 100 students clearing the exam.

Ashutosh Kar with 99 per cent is the school topper in Science, while Saikh Haamid Razaa with 93 per cent is the school topper in Commerce. In total, 25 students have secured 90 per cent and above marks in aggregate. Similarly, in Class X, 249 stu-

dents of BJEM School scored cent percent results. While 69 students secured 90 per cent and above, 90 per cent students cleared the exams with first division marks. Shreya Rath got the top rank with 99.4 per cent, securing 497 out of 500 marks.

Pan-India probe on e-mail threats

New Delhi: The Delhi Police is likely to conduct a pan-India investigation with its counterparts in other states to crack the conspiracy behind e-mail threats sent to various installations, including schools, hospitals and airports, in other states, officials said Monday, According to a Delhi Police officer, the officers here are analysing the pattern of the e-mails and planning to approach the police forces of other states. In the last two weeks, schools and hospitals in cities like Delhi, Bengaluru, Ahmedabad, Jaipur and Lucknow, and airports in Delhi, Mumbai, Goa, Nagpur and Kolkata, besides various government buildings received the threats from foreign-based mailing service companies that have advanced data encryption. Investigations in these cities are under way, police said. Twenty hospitals, the Delhi airport and the Northern Railway's chief public relations officer's (CPRO) office received the e-mails warning about the "placing of explosive devices inside the buildings" on Sunday. The Delhi Police carried out searches but nothing suspicious was found. The officer said Sunday's threat was sent from Europe-based mailing service company beeble.com. Police will soon write to Interpol to get information about the IP (internet protocol) address of the device from which the email was sent, he added

New exoplanet displays volcanic activity like Jupiter's Io

covered a new 'fiery, glowing red' exoplanet displaying intense volcanic activity similar to Jupiter's

Further, the many active volcanoes on the exoplanet could be making its surface hotter than some stars, they said.

In a known star system about 66 light years away from Sun, the astrophysicists discovered signals for a new rocky planet about a third larger than Earth. The signals were captured by NASA's Transiting Exoplanet Survey Satellite (TESS), which searches for exoplanets or planets outside our solar system, orbiting the brightest stars in

The team, including researchers from the University of California Riverside, US, said that the star system, called HD

harbour a giant planet. While gathering data on the planet, Stephen Kane, a professor of Planetary Astrophysics, "unexpectedly" found another "fiery" one, taking the count of planets in the star system to three.

"At optical wavelengths, you would be able to see a glowing, red-hot planet with a molten lava surface," Kane, lead author of the study published in The Astronomical Journal, said.

The newly discovered rocky exoplanet, named TOI-6713.01, has a lot in common with Jupiter's rocky innermost moon, Io, and is known to be the most volcanically active body in our solar system, Kane said.

The researchers explained that gravitational forces exerted by the other two planets in the system force this rocky planet into an elliptical or "eccentric"

form of volcanoes.

Likening the scenario to "racquetball", Kane explained that the rocky inner planet gets hotter as it is constantly bounced around by the other two planets and squeezed by the star.

"It's been forced into a situation where it's constantly exploding with volcanoes." he said.

The extreme volcanic activity could be making the surface of TOI-6713.01 hotter than some stars. Kane said, as he calculated the surface temperature to be 2,600 degrees Kelvin or 2,330 degrees Celsius.

The intense volcanic activity on Jupiter's Io is also due to the gravity exerted by the other moons of the solar system's biggest planet, which itself has a strong gravitational pull, the researchers said.

Io is thus "forced" into an ec-

Kane explained.

"If the other moons weren't there, Io would be in a circular orbit around the planet and it would be quiet on the surface. Instead, Jupiter's gravity squeezes Io so much that it erupts in volcanoes constantly." Kane said. On Earth, tides are the effect of moon's gravity on our oceans.

The researchers said the findings reveal a lot about the extremes in amounts of energy that can be pumped into a rocky planet, such as TOI-6713.01. Further, tidal effects on plan-

ets haven't historically been a focus of exoplanet research, which Kane hopes might change with this discovery.

"While we know that stars contribute to the heat of a planet, the vast majority of the energy here is tidal and that cannot be ignored," he said.

Kendrapara villages face extinction

Inhabitants blame admin for not taking proper measures to tackle natural calamities

Kendrapara, May 13: Absence of a long-term plan in preventing natural calamities is posing serious threats to several villages under Mahakalapada block of this district. Locals alleged that every year the administration holds meetings to tackle the situation in the aftermath of natural calamities. However, no concrete steps have ever been taken to prevent impending danger. "The effort is always to act after destruction, but not to prevent it," pointed out a local.

The frequent ingress of seawater into residences located in villages under Satabhaya, Lanjuda, Suniti and Babar panchayats is giving sleepless nights to the inhabitants. They stated that unless preventive measures are implemented quickly the sea will gobble up the villages in these panchayats within the next four to five years. They added that even a slight increase in the speed of wind gives rise to tidal waves at many places of the 48 kilometres long coastline resulting in rapid soil erosion.

Environmentalists and scientists pointed out that if soil erosion continues in the manner it is happening now, the day is not far when many villages will be swallowed up by the sea. They blamed the district administration for the current state of affairs. "We have been harping on



development of mangrove plantations in a planned manner to stop soil erosion, but nothing has been done to combat the situation," they stated. The environmentalists warned that 90 per cent of land under Satabhaya panchayat has disappeared into the sea and other panchayats

Nabarangpur, May 13: BJP candidate from the Jharigaon Assembly constituency in this district, Narsingh Bhatra alleged Monday that he was assaulted by BJD workers and supporters when he tried to prevent the casting of false votes in a polling booth.

Bhatra said that while he was going around his Assembly constituency, he received news that some anti-socials had entered a booth in Deulakana village. He promptly arrived at the spot. However, he alleged that he was prevented from entering the polling station by BJD workers who also assaulted him. "When I protested, they attacked me physically," Bhatra

Bhatra informed that he has already lodged an FIR with the police regarding the incident. "However, those who attacked me are yet to be arrested even though they are well-known faces, Bhatra said.

Bhatra is contesting the elections against BJD nomi-Ramesh Chandra Majhi and Congress candidate Herabati Gond.



In another incident, two BJP agents were attacked near booths (Nos 79 and 80) in Berhampur Lok Sabha constituency. The incident sparked tension in the area leading to a clash between BJP and BJD workers. Police had to resort to a mild lathicharge to disperse the two warring groups. Officials however, assured that polling in the two booths were not affected and went on smoothly.

Xi In Europe

hinese President Xi Jinping's recent tour of Europe - first in five years - is being regarded as an opportunity to reaffirm Beijing's economic and geopolitical ambitions. Xi used it to the hilt and sent strong messages to Europe and NATO about China's keenness to build bridges with Europe while expressing solidarity with his ally, Russian President Vladimir Putin.

The trip took Xi to France, Serbia and Hungary and helped him mainly to showcase the commercial and geopolitical objectives of Chinese power. He seems to have played his cards well and operated from a position of advantage without virtually offering any concessions to the leaders of the European Union. The itinerary itself was chosen by Xi in a shrewd manner which itself had a message. For, Serbian President Aleksandar Vucic and Hungarian Prime Minister Viktor Orban are both no easy partners for European leaders and they make no secret of their hobnobbing with the Kremlin. Xi used this political climate consciously and chose Belgrade and Budapest after Paris. This left no one in doubt about his intent to highlight Europe's divisions.

In Paris, President Emmanuel Macron had accordingly planned his strategy in advance and included European Commission President Ursula von der Leyen in his first talks with Xi. Macron wanted to show to Xi that he was no lone voice and he had the backing of other European nations. However, he failed to win over German Chancellor Olaf Scholz in this endeavour. But, this was predictable, given Scholz's policy toward China that is dictated by the interests of his country's industrialists. The decision of the German Chancellor to stay away from the meeting in Paris weakened the firm stand made by von der Leyen and Macron on the serious trade disputes between China and the EU. This was one of the two big issues discussed in Paris with the Chinese President. Chinese producers of electric cars in particular have, for some time, been flooding European markets with their low cost products, thereby hurting the interests of automobile manufacturers of Europe. Brussels sought to raise the issue with Xi in earnest. But the latter virtually poured water on it by denying that the manufacturers of his country had stepped up normal production.

Similarly, Xi astutely handled the issue of Russia's war with Ukraine which constituted the second priority for Paris and Brussels. When asked not to support Russia's war effort, Xi, it was reported, was noncommittal during private discussions with European leaders. But, in public he went on the offensive and said that such a stance of China could be used to "blacken" its image and even trigger "a new Cold War." This is only natural and in keeping with China's pro-Russia policy. Incidentally, the Chinese President will roll out a red carpet welcome to Russian President Putin in Beijing later this month.

In sharp contrast to Xi's trip to France, his engagements with Serbia and Hungary were more cordial and economically more fruitful. The visit to Belgrade coincided with the anniversary of the bombing of the Chinese embassy by NATO during the Kosovo war on 7 May, 1999. This does not seem to be a coincidence. For, Beijing has never accepted Washington's claim that the bombing was a mistake. It believes the bombing was a way of perpetuating NATO's image as an aggressor. At this time when a major reason for Russia's war with Ukraine is the latter's attempt to join NATO, Xi's Serbian visit on the anniversary of NATO bombing assumes added geopolitical significance.

Xi amply rewarded Hungary for its "independent" foreign policy by signing 18 economic cooperation agreements with it. Hungary was also promoted to one of the highest ranks in the qualification of its strategic partnership with Beijing. It is also significant that Xi has chosen autocratic rulers of Europe to provide assistance and pump in more

Many experts thought Xi would try to consolidate Chinese ties with European powers so as to drive a wedge with the United States and reinforce his idea of a multi-polar world with Chinese features. But, obviously, they have been proved wrong. Xi, it seems, is quite happy with his closeness to Putin and wants to bring more autocrats in Europe into the China-Russia axis.

SURGE IN REMITTANCES

THE BULK OF INDIA'S **INBOUND REMITTANCE COMES IN FROM THE GULF STATES WHICH ARE HOME TO BLUE COLLAR WORKERS IN FIELDS LIKE** CONSTRUCTION, RETAIL. SECURITY, **TRANSPORT AND SEMI-SKILLED**

The International Organisation for Migration, an agency of the United Nations, has released its World Migration Report for 2024. This report, which is rich in data, is released along with many data tools that help researchers, policymakers and media. That data dominates discourse, especially in these times of rising anti-immigrant sentiment across the world. Is migration a human right? The Indian Constitution gives a right to every citizen to move freely to any part of the country. But moving across borders is not the same. The United Nations while not explicitly recognising the right to migrate as a human right, does have the right to leave any country, including your own, as a fundamental right. This might sound contradictory but is not. You have the negative right to not be coerced, or persecuted, and hence can migrate. But you may not have the right to be automatically allowed entry into any other country. The UN also recognises the right to seek asylum and the right to not be forced to return to one's country. These are recognised because of the risk of persecution, torture or serious harm. The UN estimates that during 2022, there were 281 million international migrants representing 3.6% of the world's population. These include migrants fleeing conflict or persecution, violence, political instability and also those seeking

Migrating for economic reasons is certainly not a human right. But once an economic migrant is in a foreign country, there are international agreements and laws that seek to protect workers from exploitation and safeguard some basic rights. India's international economic migrants have a stellar record. For nearly three decades, they have been sending their hardearned earnings home, making India by far the highest receiver of remittances. During 2022, India received \$111 billion which

was nearly half of the merchandise trade deficit of the country. It was also more than twice as much as the second and third remittance recipients, Mexico and China.

India's inward remittances keep growing, having more than doubled since 2010, and showing a growth of 6% plus per year, ahead of the GDP growth. By comparison, China's inbound remittances have been falling. Pakistan and Bangladesh get about one fourth of what India gets. The bulk of India's inbound remittance comes in from the Gulf states, which are home to blue collar workers in fields like construction, retail, security. transport and semi-skilled work. More granular data will reveal that the average remittance from a blue-collar worker is a few thousand dollars, which forms a significant portion of his or her income and helps the family back in India. Such remittances face hurdles of high transaction cost, as high as 6% and also exchange rate risk

By contrast India's outbound remittance has also been growing. Under the Liberalised Remittance Scheme (LRS) of the RBI the latest data shows that it might have crossed \$32 billion during 2023-24, with a growth rate of 25% over the previous year. Unlike inbound remittances which come from

blue-collar workers, the outbound is typically from the rich segment, supporting the education of their children or maintenance costs of loved ones, or buying foreign assets. There is thus a stark divide in the profile of inbound and outbound remitters. It would of course be imprudent to put any restriction on outbound remittances, on the suspicion that precious foreign exchange is leaving India. One has to examine the root cause, rather than clamp the

outflow in a knee-jerk fashion. India's reputation as number one recipient of inward remittance is not without its worrying aspect. On one hand, it shows the loyalty and diligence of those remitting money home. It brings some macro-economic stability to the trade deficit and foreign exchange fluctuations. It is a natural corollary that India is de facto exporting surplus labour. The troubling aspect is that this is relatively low productivity labour. Should not these labourers have found jobs in India? Is it leading to a dependency syndrome? Kerala used to get 25% of the state's income from remittances (now reduced to below 20%). That made Kerala one of the richest states in per capita consumption, but it was also a state with notorious labour shortages. Workers have to be imported

Jharkhand and Odisha to make up for the shortfall. The huge influx of Gulf dollars also led to high inflation in the local real estate market in Kerala. So. a strong and unlimited inflow of remittances whether at the statelevel or at an all-India level is a mixed blessing. Unless the remittance money goes into productive investments and in manufacturing and high-tech industries, and instead of going only into real estate, it can cause long-term problems. For India, there is also a gender angle, in that more than two-third of economic migrants from India are males. So, the females are left behind to care for the children and the elderly, as is the social norm. This gender skew is not there for economic migrants from Sri Lanka and Philippines.

India is the world's most populated country, with a paucity of high-quality jobs, and its per capita income is low. So, it is nat ural to expect it to be a leader in economic migration. Domestically too, one-third of the population are internal migrants, in search of jobs and livelihoods. Much of the internal migration tends to be seasonal, circular and often intrastate too. International migration of Indians is a totally different matter. There is much more vulnerability, possibility of exploitation and discrimination, especially since the migrants are mostly in blue-collar work. It requires proactive intervention from our consular staff India has also been advocating for a special WTO work permit system, which allows people to travel for work, and not get treated as potential immigrants every time they stand in line for a visa. In these times of fierce anti-immigrant sentiment, it will take time to push for freer movement of economic migrants and service providers. Till then we can cherish the strong remittance earnings.

Mid-segment biz hit hard in Assam

13: Guwahati, May Businessmen, traders and contractors in Assam are keeping their fingers crossed as they hope that crucial issues such as high taxes, exclusion from financial schemes and inflationary pressure that are affecting the mid-segment businesses will be resolved by the new dispensation at the Centre after the ongoing Lok Sabha elections.

They felt that there would be an adverse impact on the economy if the mid-segment businesses continued to reel under pressure, despite being one of the biggest employment-generating sectors after the railways.

While interacting with PTI, businessmen and traders, who are from Marwari and Bengali communities in the state, also alleged that the government has "totally neglected" the medium segment of businesses across

"In the present scenario, the government is focussing on industrialisation. But the medium size businesses are not progressing. The government has not rolled out any scheme targetting the medium scale units, Sivasagar-based garment trader Rupchand Karnani said.

The government claims that many schemes are launched, High tax, inflation, absence of schemes major hurdles

Karnani, also the Sivasagar District Secretary of All India Marwari Federation, claimed that the sales of every trader were down, as compared to the previous years, during the recent Rongali Bihu, which is the main festival of Assam.

With voting for Lok Sabha elections in Assam coming to an end, the mid-segment business community is optimistic that a new government at the

Centre will look into their problems for long-lasting solutions. Stating that the outgoing gov-

ernment was "only concerned about the rich and small businesses", Karnani hoped that the new government at the "Centre would encourage all sections of businessmen and only then India

'You have to look after the middle-class citizens as well as the business community. The highest sale is in this middle segment. All people do not go to high-end malls for shopping," he said, adding that online businesses have also impacted the traders to a large extent.

Telecom contractor Suresh Kumar Berlia seconded him and claimed that the mid-segment businesses are "deprived" of a beneficiary scheme.

"When we go for a loan, they (financial institutions) ask for more collateral than the borrowing amount. If they give us a ₹50 lakh loan, collateral or mortgage worth ₹1 crore is

needed," he claimed. Expressing disappointment over the current situation, Berlia alleged that the government waived loans amounting to crores of rupees for big industrialists, but "loan accounts of mid-segment businesses are

termed as non-performing assets (NPA) even if a single instalment is misused".

'Trading by the mid-segment businesses is the biggest industry after the railways as per my estimation. If the segment gets weakened, everything surrounding these businesses will suffer. Unfortunately, we have never got the due recognition and respect for our service," he added.

However, Berlia does not have much expectation from the new dispensation at the Centre as "all governments go for populist schemes and ignore the mid-segment business community'

Gopal Ghosh, who runs a sweet-meat shop at Borjuri in Golaghat district of Assam, lamented that he has applied to several state-sponsored schemes to expand his eatery but has not received any positive response.

"High inflation is affecting my business. With prices of all raw materials rising regularly in the last few years, the rates of tea and sweets have also increased accordingly. Sales are also affected," he said.

Guwahati-based hardware trader Sandeep Sharma said online businesses are creating hurdles, which, in a way, are weakening the trade prospect as his shop does not sell products through digital platforms.

"What is the legal right? On propriety you may certainly have something to say, but there is no legal right. It's up to the LG (Lieutenant Governor) to take action if he wants to. We are not inclined to entertain this (petition)," the bench told petitioner Kant Bhati's counsel.

The bench, while dismissing the appeal challenging the April 10 order of the Delhi High Court said, "When the matter (Kejriwal's petition against ar-



rest) was being heard, we had posed the same question to them. Ultimately, it is a matter of propriety and there is no legal right."

It pointed out that several pe-

titions on the issue have been dis-

missed by the high court. On April 10, the high court had expressed its displeasure over repeated filing of petitions seeking Kejriwal's removal.

The government also said there are 1,584 toilets meant for persons with disabilities that are designated for the use of transgender persons.

The Delhi High Court took on record the government's January status report and closed the proceedings in a PIL filed by Jasmine Kaur Chhabra, seeking direction for constructing separate washrooms for the third gender on the ground that their absence makes transgender population prone to sexual

Central Ridge 'green heritage', can't allow degeneration: HC

New Delhi: Calling the Central Ridge the national capital's "green heritage", the Delhi High Court has said it cannot be allowed to degenerate when the city is already grappling with rising pollution levels that have attained "dangerous proportions". The court took a "serious view" of the Central Ridge being used as a garbage dumping ground as well as the felling of trees and removal of the shrubs there, and sought an explanation from the Forest department on these lapses. The court, while hearing a case concerning the well-being of the ridge, directed Forest department and other local authorities to ensure that no dumping of garbage or any other waste material is carried out in the Central Ridge. It also ordered that no further felling of trees or removal of shrubs and other bushes will be allowed in the area without its permission. The court, in an order passed May 6, noted that certain photographs showed large scale dumping of garbage in the Central Ridge as well as presence of black soil, indicating that the area was burnt down which led to trees and shrubs being destroyed.

New Delhi, May 13: The Supreme Court Monday termed as "horrible" the situation where 3,800 tonnes of solid waste in Delhi and its surrounding areas go untreated every day, and observed it. violated the fundamental right of citizens to live in a pollutionfree environment.

Referring to data on generation of solid waste per day and the capacity to treat them in areas like Gurugram, Faridabad and Greater Noida, the top court observed that considering the development work which was taking place in Delhi and the surrounding areas, it was obvious that it would in-

crease. A bench of Justices AS Oka and Ujjal Bhuyan said immediate measures should be undertaken to ensure that the quantity of untreated solid waste does not increase till proper facilities are



thorities will have to consider various methods to do that, including putting restraints on construction activity in these areas, it said. It directed the secretary of the Ministry of Housing and Urban Affairs of the Government of India to convene a meeting of all authorities concerned to find a solution and place it before the court.

"In the event the authorities fail to come out with any concrete proposals, we will have to consider passing drastic order with a view to take care of the environment in the capital city of Delhi and surrounding areas, the bench said

"We hope and trust that all the authorities will take the issue with great seriousness as prima facie impression which we gather is that none of the authorities have bothered to consider the drastic consequences of not having adequate capacity to deal with solid waste generated every day," it said. The bench said a report

shall be prepared by the secretary of the Ministry of Housing and Urban Affairs and placed before the court by July 19.

The apex court noted it was an admitted position by all concerned that within the limits of the Municipal Corporation of Delhi (MCD), every day 3,800 tonnes of solid waste was generated which cannot be treated as the existing plants do not have the capacity to treat them.

"This is a sorry state of affairs in the capital city of Delhi," it said. Calling it a "very vital issue" for Delhi, the bench observed there should be no politics over it. It noted that the MCD's coun-

sel has apprised the court that it will be possible to treat such excess waste only by June 2027 when an additional facility will come into existence.

It said this means that for a period of more than three years from now, Delhi will have 3,800 tonnes of untreated solid waste accumulating in some place every day.

Referring to an affidavit filed by the Union Ministry of Housing and Urban Affair, the bench said "something more shocking" has been brought on record.

It noted that as per the affidavit, 1,200 tonnes of solid waste was generated in Gurugram daily while the capacity of processing

was only 150 tonnes per day. "Everywhere the situation is horrible," the court said, while posting the matter for hearing July 26.

Guwahati, May 13: Padma Shri awardee Birubala Rabha, renowned for her fight against witch hunting, passed away at a hospital here Monday after a long battle with cancer, doctors

Survived by two sons, a daughter, and other relatives, Rabha, 75, was admitted to the State Cancer Institute of Gauhati Medical College and Hospital (GMCH) April 22 due to severe weakness, GMCH superintendent Abhijit Sarma said.

"She has been a patient of advanced stage carcinoma oesophagus since 2021 and was undergoing treatment at our hospital. She was put on a metallic stent because of difficulty in swallowing six month ago," he

As Rabha's condition deteri-

orated, she was admitted to the hospital last month and was


shifted to ICU May 4, followed by mechanical ventilator support Sunday as she developed respiratory distress, Sarma said.


married to a farmer with whom she had three children.

Rabha was instrumental in enactment of the Assam Witch Hunting (Prohibition, Prevention and Protection) Act, 2015, which made every offence related to witch hunting as cognizable, non-bailable and non-compoundable, making provisions for imprisonment up to seven years along with a fine of up to ₹5 lakh for identifying and calling a person witch.

Her struggle against the menace began when her son was branded a 'witch' and diagnosed to die within three days because he was mentally not sound. Her family was isolated for three years after she started raising her voice against witch hunting.

Rabha formed 'Mission Birubala' in 2012 to create awareness among people against the social evil and all forms of superstitious beliefs, besides providing rehabilitation to the victims of witch hunting menace. The organisation has saved lives of 55 victims so far in Majuli,-Kokrajhar, Goalpara and

Samal made the remark during a press conference, attended by senior leaders including Union Minister Dharmendra Pradhan, former Union minister and Balasore MP Pratap Sarangi, Bhubaneswar MP Aparajita Sarangi, and the party's national vice-president Baijyant Panda.

Earlier in the day, the ruling BJD leaders came up with several posts in social media forecasting that the BJP will announce its CM face Monday.

Samal said, "They (BJD) should think about their own party rather than focusing on us. The BJD lacks a proper leader while an agent is running the regional party. Our parliamentary committee will decide the BJP's CM candidate.'

On the other hand, BJD MP and party's national spokesperson Sasmit Patra said the BJP could not announce its CM can-



didate due to dispute among as-

"All of us had heard that Odisha BJP will declare their CM candidate today, but there was so much quarrelling among aspirants that they could not announce it. Odisha BJP cannot announce the CM candidate because if they do, their party in Odisha will break into four parts," Patra posted on X.

BJD leader and CM's close aide Kartik Pandian had also asked the BJP to announce its CM face before elections and claimed that the saffron party would not get even 10 per cent of votes if they make such a declaration.

Thiruvananthapuram, May 13: Unprecedented climate change disasters — prolonged heatwaves, flash floods, drought, agricultural devastation and landslides — are affecting people in India.

As 968 million people head to polling booths across the nation, the Election Commission of India (ECI) is going to great lengths to ensure that a 'green election' is conducted.

In the southern state of Kerala, for instance, the commission collaborated with the Local Self Government Department to ensure plastic-free polling, with election officials served tea in steel mugs instead of the standard paper cups with a thin plastic coating.

However, this attention to detail isn't matched by political parties contesting the election. Or by voters, who don't seem to care about climate change.

A detailed review of the election manifestos revealed that, except for the regional party Dravida Munnetra Kazhagam (DMK), none of the major political parties in India have concrete grassroots-level plans to mitigate the impact of climate

India's electoral scene features only a modest and oblique reflection of issues related to cli-

mate change. In forest-adjoining areas throughout the country, it's increasingly common for wild animals to enter human settlements and cause damage. This is mostly caused by food and water shortages in summer and alterations in wildlife habitats

because of climate change. In the Wayanad constituency where Congress leader Rahul Gandhi is contesting, humanwildlife conflicts have already become a hot electoral issue.

A poster on a street wall in a village on the Kerala-Tamil Nadu border reads, "It is the people who vote in elections, not the animals that are encroaching into human settlements. Stop ani-

Such sentiment arises from a prevalent anthropocentric worldview, where the state forest and wildlife departments are criticised for prioritising animals over human beings.

In Lok Sabha constituencies in the Western Ghats, the authors observed that environmental concerns hardly influ-



ence electoral politics, despite the fact that the daily lives of people in those regions are closely

intertwined with nature. Perhaps the best illustration of this would be the popular protests a decade ago against the Madhav Gadgil-K. Kasturirangan committee reports. These reports aimed at safeguarding the ecologically fragile Western Ghats, a 1.600km-long mountain range from Gujarat to Tamil Nadu, by restricting human construction

and certain types of agriculture. The inhabitants of the Western Ghats, which is identified as one of the world's eight 'hottest hotspots' of biological diversity, managed to win a Lok Sabha seat in the 2014 election with the support of Left parties and succeeded in stopping the committee's pro-environment recommendations from being implemented

Even though the Western Ghats are one of the worst-hit areas in terms of climate changetriggered casualties, especially from landslides and agricultural loss, the electoral politics of the region largely revolve around conventional issues.

The attitude in the Western Ghats is in stark contrast to Europe, which votes in early June to elect the next European Parliament. A poll conducted by Euronews and Ipsos in 18 countries found that 52 per cent of voters prioritise the fight against climate change over other issues.

The so-called 'climate voters' in Europe are mostly young people. One of the hot topics during elections is the European Green Deal, which aims to make the continent climate-neutral by 2050.

A World Wildlife Fund survey showed that European political parties are particularly focused on combating climate change, as they "shared support for ending fossil fuel use, transitioning to 100 percent renewable energy, and adopting nature-based solutions to tackle climate change".

In Europe, green parties have been actively pushing environmental issues since the 1970s, now holding a major share of the vote in many countries and are putting the climate agenda

at the forefront of elections. However, Indian democracy is yet to breed a new category of 'climate voters' as its electoral landscape is still conservative with practically very little space for environmental politics or green agendas.

No bail for Soren

Ranchi: A special PMLA court here Monday rejected former Jharkhand chief minister Hemant Soren's bail plea in an alleged land grab linked money laundering case in which he was arrested January 31, official sources said. New Delhi. May 13: A voter turnout of over 64 per cent was recorded Monday in the fourth phase of the Lok Sabha elections covering 96 constituencies spread over 10 states and Union territories, with scattered incidents of violence reported in West Bengal and Andhra Pradesh.

West Bengal, where polling was held in eight constituencies, again recorded an impressive turnout at 76.56 per cent, the highest among states/UTs in this phase.

Srinagar constituency in Jammu and Kashmir witnessed 37.93 per cent voting in the first Lok Sabha election in the Valley since the scrapping of Article 370, with the EC stating that it was the "highest turnout in decades".

According to the EC's voter turnout app at 10pm, the overall voting in this phase was 64.05 per cent. However, it said that this was an "approximate" trend as data from polling stations was still being collated.

A large number of voters were in the queue at polling stations even after the fixed time of polling ended at 6pm, the Election Commission said in a statement

Among other states, Andhra Pradesh (25 seats) recorded 68.20 per cent polling, Bihar (five seats) 56.75 per cent, Jharkhand (four seats) 64.59 per cent, Maharashtra (11 seats) 57.58 per cent, Odisha (four seats) 64.81 per cent, Telangana (17 seats) 62.28 per cent and Uttar Pradesh (13) 58.05

per cent. A provisional voter turnout of 71.72 per cent was recorded in Madhya Pradesh

(eight seats). The overall voter turnout in the first three phases of the Lok Sabha elections was 66.14 per cent, 66.71 per cent and 65.68 per cent, respectively.

With the conclusion of Phase 4, polling for general elections has crossed the halfway mark as it has been completed in 23 states/UTs and 379 Lok Sabha constituencies out of 543.

Also, assembly elections were held in Andhra Pradesh Monday, apart from polling in 28 assembly seats in Odisha.

BJP candidate in Telangana's Hyderabad Lok Sabha seat K Madhavi Latha, who is contesting against AIMIM's Asaduddin Owaisi, was booked by election authorities after a video clip surfaced online in which she was purportedly seen asking burqa-clad women voters to show their faces to compare with the photo identity cards.

In Andhra Pradesh, the TDP

Meanwhile, TDP supremo Chandrababu Naidu alleged that there was "no peaceful atmosphere in the state for people to exercise their franchise"

"I severely condemn the violence reported since morning. YSRCP is implementing its plots in a concerted manner. Local police officials failed in averting violence in Macherla constituency," he said in a post on 'X'.

Sporadic incidents of violence marred the fourth phase of Lok Sabha polls in the eight parliamentary constituencies of West Bengal as TMC and BJP workers clashed in various areas under Birbhum and Bardhaman-Durgapur Lok Sabha seats.

Around 1,700 complaints of EVM malfunction and obstruction of agents entering booths were recorded till 1pm, the EC said, adding the TMC, Congress, and BJP filed hundreds of complaints related to poll violence, voter intimidation, and assaults on agents.

Two security personnel of the CISF deployed to protect West Bengal BJP leader Dilip Ghosh were injured in a stone-pelting incident at Bardhaman.

'An incident of stone-pelting on CISF SSG protectee and attack on his vehicle by some miscreants occurred at Bardhaman (WB) in which two CISF personnel sustained head injuries. The protectee was safely evacuated without the use of force," the central paramilitary force said in a post on 'X'.

Ghosh (59) is a 'Y' category protectee of the Central Industrial Security Force (CISF) VIP security wing called the Special Security Group (SSG).

In Jharkhand, security forces thwarted an attempt by Maoists to obstruct voter access to polling booths by felling a tree and blocking a road leading to remote Sonapi and Morangponga areas of West Singhbhum district.

JD(S) MLA HD Revanna gets bail in kidnap case

Bangalore, May 13: A Special Court for Elected Representatives Monday granted bail to JD(S) MLA HD Revanna in connection with a kidnap case.

The 66-year-old former Minister was arrested by the Special Investigation Team (SIT) in an alleged case of abduction of a woman, linked to the allegations of sexual abuse of women by his son and Hassan MP Prajwal Revanna, May 4.

The special court judge Santhosh Gajanan Bhat heard the matter and granted conditional bail to Revanna. While granting the bail, the

court invoked conditions, as per which Revanna will be given bail upon executing ₹5 lakh bond, he shouldn't be allowed to leave the country, and he should not try to influence the victim or other related parties to the case. According to sources, he is

likely to be released from prison Tuesday.

Revanna's three-day police custody ended May 8, following which he was produced in the XVII Additional Chief Metropolitan Magistrate Court, which remanded him to seven days' judicial custody, till May 14.

The case was registered following a complaint by the woman's son, who alleged that his mother was sexually abused by Revanna's son Prajwal.

The woman was allegedly abducted to prevent her from testifying against Prajwal, police sources have said. The SIT has also secured the custody of Revanna's confidant Sathish Babanna in connection with the case.

HOAX BOMB E-MAIL THREAT

Delhi Police may conduct pan-India investigation

New Delhi, May 13: The Delhi Police is likely to conduct a pan-India investigation with its counterparts in other states to crack the conspiracy behind e-mail threats sent to various installations, including schools, hospitals and airports, in other states, officials said Monday.

According to a Delhi Police officer, the officers here are analysing the pattern of the emails and planning to approach the police forces of other states.

In the last two weeks, schools and hospitals in cities like Delhi, Bangalore, Ahmedabad, Jaipur and Lucknow, and airports in Delhi, Mumbai, Goa, Nagpur and Kolkata, besides various government buildings received the threats from foreign-based mailing service companies that have advanced data encryption. Investigations in these cities are underway, police said. Twenty hospitals, the Delhi

airport and the Northern Railway's chief public relations officer's (CPRO) office received the e-mails warning about the "placing of explosive devices inside the buildings" Sunday. The Delhi Police carried out searches but nothing suspicious was found.

The officer said Sunday's threat was sent from Europebased mailing service company beeble.com. Police will soon write to Interpol to get information about the IP (internet protocol) address of the device from which the e-mail was sent,

The Special Cell of the Delhi Police is conducting the investigation, he said.

The officer further said the sender had used a similar domain service provider while sending the threats to 70 schools in Bangalore a few days ago.

PM to file nomination from Varanasi today

Varanasi, May 13: A day before filing his nomination papers from the Varanasi Lok Sabha seat, Prime Minister Narendra Modi held a six-kilometre-long roadshow Monday evening and said the warmth and affection of people is "unbelievable".

People lined the barricaded roads, some of them holding saffron flags, balloons and small "trishuls". Small stages were set up along the route where cultural performances were held. Cutouts of famous people from Kashi were installed in many

People from different communities, including Marathi, Gujarati, Bengali, Maheshwari, Marwari, Tamil and Punjabi, welcomed Modi at 100 points in 11 zones marked out on the route of the roadshow.

Two hours after the roadshow began from the Malviya Chauraha in Varanasi's Lanka area, the prime minister reached the Kashi Vishwanath temple and offered prayers.

Addressing his Aam Aadmi Party (AAP) councillors, Kejriwal said he was under CCTV surveillance and 13 officers were monitoring the feed.

Over 9,600 children wrongly jailed in adult prisons: Study

PRISONS IN ODISHA AND TAMIL NADU **DEMONSTRATED EXTREMELY LOW RESPONSE** RATES TO THE QUERIES, WITH NO CHILDREN REPORTED TO HAVE BEEN TRANSFERRED FROM PRISONS TO JUVENILE HOMES

New Delhi, May 13: More than 9,600 children were wrongly incarcerated in adult prisons across India between January 1, 2016, and December 31, 2021, a new study has found.

The data for the study -"Incarceration of Children in Prisons in India" -- was obtained under the Right to Information (RTI) Act.

The study by legal rights body iProbono sheds light on a deeply concerning issue affecting the

juvenile justice system in India. The data indicates that at least 9,681 children were wrongly incarcerated in adult prisons between January 1, 2016, and December 31, 2021.

"This means an average of

over 1,600 children were transferred out of prisons across the country every year," the study said, referring to the children identified by Juvenile Justice Boards (JJB) and moved to juvenile homes from adult jails.

This figure was ascertained on the basis of responses to RTI requests by 285 district and central prisons out of a total of 570.

'This also does not include the 749 other prisons from which we did not request data, including sub jails, women's prisons, open prisons, special prisons, borstal schools and other prisons. It also, as previously mentioned, only includes those who were successfully identified and transferred, not all those who were juveniles at the time of their alleged offence, including those



identified by prison visitors, families or through self-identifica-

tion." it said Several states failed to adequately respond to enquiries, with notable non-compliance from Madhya Pradesh, West Bengal, Nagaland and the Union Territory of Ladakh.

Among the states that responded, the study said the figures reveal alarming patterns.

With a response rate -- jails that provided data -- of 71 per cent, Uttar Pradesh reported that 2,914 children were transferred from prisons to juvenile homes. However, the data indicates discrepancies, with some prisons showing high numbers of detained children despite no visits from JJBs.

In Bihar, where 34 per cent of prisons responded, 1,518 children were transferred out of adult jails. Instances were noted of more children being identified by JJBs than those transferred.

Madhya Pradesh provided no data despite repeated appeals under the RTI Act. West Bengal also provided no data.

Responses from 35 per cent of prisons in Maharashtra revealed that only 34 children were transferred, significantly lower than those identified by JJBs.

The study found that Delhi demonstrated a highly organised approach to juvenile justice, with clear directives from Delhi High Court aimed at preventing the incarceration of children in adult facilities.

Haryana -- where data was provided by 90 per cent of prisons -- transferred 1,621 children, correlating well with the number identified during JJB visits.

In Rajasthan, 108 children were transferred, according to data from 51 per cent of its prisons, with a notable lack of information on children identified during JJB visits.

Chhattisgarh transferred 159 children, data from 44 per cent of its jails showed, revealing disparities in JJB visitation patterns across prisons.

Jharkhand transferred 1,115 children, also highlighting discrepancies in JJB visitations 60 per cent of its prisons responding to RTI queries for the

Prisons in Odisha and Tamil Nadu demonstrated extremely low response rates to the queries, with no children reported to have been transferred from prisons to juvenile homes.

The report relied on data obtained under Section 6 of the RTI Act, which pertains to the Request for Obtaining Information.

Between April 2022 and March 2023, 124 RTI applications were filed across 28 states and two Union Territories, primarily directed to Prison Headquarters. except for Uttar Pradesh and Chhattisgarh, where applications were filed in each district and central jail at the directions

of the Prison Headquarters. The data excludes the Union Territory jurisdictions of the Andaman and Nicobar Islands, Dadra and Nagar Haveli and Daman and Diu, and Lakshadweep due to the absence of district and central jails there.

Flood toll rises

Tanah Datar: Flash floods and mud slides in Indonesia's West Sumatra province killed at least 43 people over the weekend while a search for 15 missing people continued, authorities said Monday Torrential rain Saturday evening triggered flash floods, landslides, and cold lava flow - a mud-like mixture of volcanic ash, rock debris and water - in three districts in West Sumatra province. Abdul Malik, chief of the provincial rescue team, told Reuters. The cold lava flow, known in Indonesia as a lahar, came from Mount Marapi, one of Sumatra's most active volcanoes. Footage shared by BNPB showed roads and rice fields covered by mud. Video also showed the wreckage of damaged homes and buildings, while the floods brought logs and large rocks into settlements.

151 detained

Yerevan: Armenian police said Monday they had detained dozens of people attempting to block streets in the capital Yerevan as part of protests against government plans to concede land to Azerbaijan. CABINET SHAKEUP Putin replaces Shoigu as defence minister

Moscow, May 13: Russian President Vladimir Putin Sunday replaced Sergei Shoigu as defence minister in a Cabinet shakeup that comes as he be gins his fifth term in office.

In line with Russian law, the entire Russian Cabinet resigned Tuesday following Putin's glittering inauguration in the Kremlin, and most members have been widely expected to keep their jobs, while Shoigu's fate had appeared uncertain.

Putin signed a decree Sunday appointing Shoigu as secretary of Russia's Security Council, the Kremlin said. The appointment was announced shortly after Putin proposed Andrei Belousov to become the country's defence minister in place of Shoigu.

The announcement of Shoigu's new role came as 13 people were reported dead and 20 more wounded in Russia's border city of Belgorod, where a 10-story apartment building partially collapsed after what Russian officials said was Ukrainian shelling. Ukraine hasn't commented on the incident.

Belousov's candidacy will need to be approved by Russia's upper house in parliament, the Federation Council. It reported Sunday that Putin introduced proposals for other Cabinet positions as well but Shoigu is the only minister on that list who is being replaced. Several other new candidates for federal ministers were proposed Saturday by Prime Minister Mikhail Mishustin, reappointed by Putin Friday.

Belousov, 65, held leading positions in the finances and economic department of the prime minister's office and the Ministry of Economic Development.

India extends budgetary support to Maldives

Political dissent: China targeting overseas citizens

Beijing, May 13: China is targeting citizens studying abroad for their political activism, rights group Amnesty International said Monday, with some students reporting harassment of family members back home.

China does not tolerate political dissent and has used sophisticated tech tools as well as intimidation to crack down on domestic protestors and activists.

And Beijing's curbs on political activism are increasingly expanding abroad in the form of "transnational repression", Amnesty International said in a report, citing interviews with dozens of students in eight European and North American countries.

Overseas students reported that family members in China re-



events abroad including commemorations of the bloody 1989 Tiananmen Square crackdown, according to the group.

"Threats made to family members in mainland China included to revoke their passports, get them fired from their jobs, prevent them from receiving promotions and retirement benefits, or even limiting their

physical freedom," it claimed. Students also said they had been blocked from posting and surveilled on Chinese social apps -- often the only way to communicate with family members due to Beijing's internet firewall.

Students said they actively self-censored during classes and social interactions and complained of mental health problems caused by the feeling of pervasive surveillance, "ranging from stress and trauma to

paranoia and depression".
"I would really want to publish my thesis... but I'm worried, so I chose not to," one student told Amnesty.

Beijing has not yet responded to Monday's report, but has previously rejected mounting criticism in recent years that it targets citizens living abroad, insisting that it respects other countries' sovereignty and that any law enforcement operations are conducted in accordance with the law.

Pillai, 56, will be appointed and sworn in July 1, according to a report by The Straits Times newspaper while others will be sworn in May 15. Pillai, a member of the ruling People's Action Party, is a lawyer. Among other Indian-origin politicians, Dr Vivian Balakrishnan will remain as Foreign Affairs Minister, K Shanmugam will continue as Minister of Home Affairs and Law, and Indranee Rajah as the Minister in the Prime Minister's Office. The new cabinet line-up was announced by the Singapore Prime Minister's Office Monday.



The company, which follows a calendar year (January-December) of reporting, had posted consolidated profit after tax (PAT) of ₹438.57 crore in the same quarter last year, Varun Beverages said in a regulatory filing. Consolidated revenue from operations in the first quarter stood at ₹4,397.98 crore as against ₹3,952.59 crore in the year-ago period, it added. Total expenses were higher in the quarter at ₹3,609.76 crore compared to ₹3,329.7 crore in the year-ago period.

Retail inflation eases slightly

New Delhi, May 13: India's retail inflation rate eased slightly in April, partly due to lower fuel prices, although food prices remained elevated, government data showed Monday.

Annual retail inflation in April was 4.83%, down from 4.85% in March. Economists polled by Reuters had forecast April retail inflation at 4.80%.



New Delhi, May 13: Finance Minister Nirmala Sitharman said Monday that India has fared relatively well compared with other countries as far as the government debt to GDP ratio is concerned and the country is the third least indebted nation among low- and middle-income countries (LMIC).

India had a debt to GDP ratio of 81 per cent in 2022. This is significantly lower than economies like Japan (260.1 per cent), Italy (140.5 per cent), the USA (121.3 per cent). France (111.8 per cent), and the UK (101.9 per cent) in the same period. On the other hand, several countries have faced the risk of sovereign default in recent years. The number of countries facing high debt levels increased from 22 in 2011 to almost 60 in 2022, she said.

The Finance Minister said that in a comparative analysis with other LMICs. India's external debt scenario is robust. Considering the ratio of total external debt to Gross National Income (GNI), India emerges as the 3rd least indebted country among all LMICs. This is a vital

indicator of a country's ability to handle its external debt. The ratio of India's total external debt to its exports is 91.9 per cent, positioning it as the fifth least indebted country among LMICs in this aspect. India's share of short-term debt in the total external debt is 18.7 per cent. This is lower than that of other LMICs like China, Thailand, Turkey, Vietnam, South Africa, and Bangladesh, which have higher percentages, she added.

A lower proportion of shortterm debt is beneficial as it implies less immediate repayment pressure. Regarding Central government debt, it is also important to note that it is overwhelmingly rupee-denominated, with external borrowings (from bilateral & multilateral sources) contributing a minimal amount (less than 5 per cent of total debt), which signifies that exposure to volatility in exchange rates tend to be on the lower end.

Domestically issued debt of the Central government, which is mostly raised through government securities, has a weighted average maturity of roughly 12 years, which indicates low rollover risk

Indian banks' underwriting standards at risk: Fitch

Mumbai, May 13: Asset quality of Indian banks' consumer loans has held up well so far, but an accumulation of 'untested risks' due to rapid growth may challenge

lenders' underwriting standards and risk controls, Fitch Ratings said Monday. "Fitch's as-

sessment of Indian banks' risk profiles also factors in lower

transparency in terms of data disclosures on retail underwriting, such as loan-to-value ratio, borrower debt serviceability, credit bureau scores, and recovery rates, than most Asian banking systems," the rating agency said in a statement.

Indian banks have reported strong loan growth over the last few quarters, boosted by consumer spending amid firm economic growth.

Banks' loans rose 19% in the two weeks to April 19 from a year earlier, latest data from the central bank showed.

Retail loans, or loans given to consumers, which constitute about 10% of all bank loans, have grown at an annual rate of 20% since 2020-21, Fitch esti-

Most lenders have reported an improvement in their asset quality, but have banked on unsecured credit to expand margins.

The Reserve Bank of India (RBI), in November, increased risk-weights on certain loan cat-

egories to improve buffers against the potential for buildup of risks. It has also applied business restrictions on certain entities in case of supervisory concerns, and is proposing to increase provisioning on project

While the RBI's measures can foster greater caution towards risk-taking, their effectiveness 'through the cycle' is not yet proven, Fitch said.

Asset quality pressures from the previous credit cycle are subsiding, creating a favorable business environment. Still, loss absorption buffers, particularly at state-run banks, remain 'moderate' against high concentration risks and renewed interest towards sectors such as infrastructure and construction, Fitch

Banks' risk appetite through higher loan growth will remain a key consideration for their intrinsic creditworthiness despite improved financial perform-

during the financial year 2023-24, the EPFO settled around 4.45 crore claims, of which more than 60 per cent (2.84 crore) claims were advance claims (for withdrawal of funds on grounds like illness, marriage, education).

Of total advance claims settled during the year, about 89.52 lakh claims were settled using auto-

The entire process in auto-settlement is IT system driven, eliminating human intervention. As a result, the periodicity of

claim settlement is reduced significantly from 10 days to 3-4 days for such advances.

The claims that are not validated by system are not returned or rejected. They are further undertaken for second level of scrutiny and approvals.

India inks 10-year deal to operate Iran's Chabahar port

New Delhi, May 13: India and Iran Monday signed a 10-year contract for the operation of a terminal at the strategically important Chabahar port in Iran, a move that will boost regional connectivity as well as trade

This is the first time India will take over the management of an overseas port that will also have a multiplier effect on trade among India, Iran and Afghanistan as efforts continue to directly tap the potential in Central Asia, bypassing neighbouring Pakistan

According to an official statement, the contract was signed by India Ports Global Ltd (IPGL) and Iran's Port & Maritime Organisation (PMO), in the presence of Ports, Shipping and Waterways Minister Sarbananda Sonowal

"The long-term bilateral contract on Chabahar Port Operation was signed between Indian Ports Global Limited (IPGL) of India and the Port & Maritime Organisation (PMO) of Iran, enabling operation of Shahid-Beheshti in Chabahar Port Development Project for a period of 10 years," the statement

This is the first time India will take over the management of an overseas port. "This agreement aims to enhance regional connectivity and facilitate trade, particularly between India, Iran and Afghanistan," the statement

The India Ports Global Chabahar Free Zone (IPGCFZ), a subsidiary of IPGL, facilitated the first consignment of exports from Afghanistan to India in

As part of the agreement, the statement said India will procure MHCs, RMQCs, RTGCs, Reach Stackers, Forklifts, Pneumatic Unloaders etc at Chabahar Port. "The agreement paves the way for enhanced trade and investment opportunities which will potentially boost India's economic development,"

it added.

Speaking at the occasion, Sonowal said, "With the signature of this contract, we have laid the foundations of India's long-term involvement at Chabahar."

Sonowal added that the signing of this contract will have a multiplier effect on the viability and visibility of Chabahar port. According to him, Chabahar is not only the closest Iranian port to India but it is also an excellent

port from nautical point of view. Sonowal also held a meeting with Iranian Minister of Roads & Urban Development Mehrdad Bazrpash.

Located in Sistan-Balochistan province on the energy-rich Iran's southern coast, the Chabahar port is being developed by India and Iran to boost connectivity and trade ties.

India has been pushing for the Chabahar port project to boost regional trade, especially for its connectivity to Afghanistan

India and Iran have projected the port as a key hub for the INSTC project. The INSTC is a 7,200-km-long multi-mode transport project for moving freight among India, Iran, Afghanistan, Armenia, Azerbaijan, Russia, Central Asia and Europe.

India has been developing a part of Chabahar Port and discussions on the development of the port dates back to 2003 during Iranian President Muhammad Khatami's visit to India In 2013, India committed to

investing \$100 million towards the development of Chabahar Port. Earlier, a memorandum of understanding (MoU) for develop-

ment of Chabahar Port by India was signed in May 2015. Thereafter, the contract was executed May 23, 2016, at Tehran (Iran) during the visit of Prime Minister Narendra Modi to Iran. Chabahar is an oceanic port. By leveraging Chabahar Port,

India aims to bypass Pakistan and establish direct access to Afghanistan and beyond, into Central Asia. Kandla port in Gujarat is the closest to the Chabahar port at 550 Nautical Miles while the distance between Chabahar and Mumbai is 786 Nautical Miles

Since 2019, it has handled container traffic of more than 80,000 TEUs and bulk and general cargo of more than 8 million tonnes.

The Ministry of External Affairs (MEA) had allocated ₹100 crore for Chabahar Port for 2024-25, underlining India's focus on connectivity projects with Iran.

Chopra, Jena in finals

Javelin duo to directly compete in Federation Cup finals thanks to AFI's qualification rules

Bhubaneswar, May 13: Star Indian javelin throwers Neeraj Chopra and Kishore Jena have been given direct entry into the Federation Cup finals here May 15, having already bettered the minimum qualification mark of 75m multiple times in their

Olympic and World Champion Chopra is coming off a fairly good outing at the Doha Diamond League last week where he finished second with a throw of 88.38m. Asian Games silver-winner Jena's Diamond League debut, however, ended in disappointment as he was eliminated after three rounds with 76.31m being his best.

DP Manu, who finished sixth 2023 World Championships and who is looking to qualify for the upcoming Paris Olympics by breaching the 85.50m mark, will also

compete directly in the finals. "All those who have crossed

75m will not compete in the qualifying round Tuesday. There are nine of them from among those who had made entries, including Neeraj and Jena. They will directly compete in the final, Wednesday," Indian athhead Radhakrishnan Nair said, quoting the Athletics Federation of India's qualification rules.

"The remaining participants who have below 75m mark will compete in the qualifying round and the top three will join the nine above-75m throwers in the

The AFI is quite looking forward to 26-year-old Chopra's first home competitive outing in three years. "The AFI is not at all surprised at Neeraj taking part in the Federation Cup. His participation in domestic event is no doubt a very good thing for Indian athletics," a top official of the AFI told PTI.

It is learnt that the AFI wanted Chopra to compete in a domestic event after he won gold in



Tokyo Olympics and before the Paris Games. He did not take part in any domestic event in 2022 and 2023 as he was training or competing abroad. His last domestic event was the Federation Cup in March 2021.

It is learnt that Chopra has reached India from Doha but will land here only Tuesday. Asian Games medallist Jena was scheduled to arrive Monday.

Nair played down the injury to men's 4x400m relay squad member Rajesh Ramesh who pulled out midway during the second leg of the first round qualifying heat in Bahamas earlier this month.

Ramesh was replaced by Arokia Rajiv, who was also not fully fit, in the second round of the Olympic qualifying heat and the Indian team booked a Paris ticket.

'Ramesh's injury is not a hamstring pull, it's related to tendon in thigh. So, it is not a major injury. He is expected to start training in 10-15 days. Rajiy will

Animesh misses nat'l record PROMISING ODISHA SPRINTER BAGS GOLD IN MEN'S 200M, WHILE

SRABANI, SWADHIN MISS OUT ON YELLOW METALS BY A WHISKER

Bhubaneswar, May 13: Promising Odisha sprinter Animesh Kujur was impressive on the second day of the National Federation Cup athletics competition at the Kalinga Stadium here winning the gold medal in the men's 200m Monday, but he narrowly missed the national record in the event.

Animesh's gold winning time of 20.62 seconds fell short of the national and meet record of 20.52 seconds which are in the name of Amlan Borgohain set in 2022. It was after Animesh topped Heat 3 with a timing of 20.81 seconds.

Nalubothu Shanumaga S of Andhra Pradesh and Jay Shah of Maharashtra clinched the silver and bronze medals, respectively. Nalubothu clocked 20.97 seconds, while Shah finished the race with a timing of 21.31s.

"I'm happy that I came so close to improving the national record," the Odisha sprinter said. He was confident of further improving his performance during upcoming international exposure in Europe. "I will be competing in two-three quality races in Europe, which will be a good chance to break the national record."

It was, however, a disappointing day for state star Srabani Nanda, who had to settle for silver in the women's 200m losing the top position of the podium by a whisker. She was edged past by Karnataka's promising sprinter Unnati Aiyappa Bolland in the last five meters of an exciting race. Gujarat's Devyaniba Mahendrasinh (24.14s) completed the podium in the event.

Swadhin Kumar Majhi too missed out on the gold by a
