

Two election officials killed in road mishaps

Malkangiri/Nuapada, May 14: Two government employees engaged in election duty died in separate road accidents after completing their duties in Malkangiri and Nuapada districts, respectively, Tuesday.

In the first incident, Indrajit Kirsani, a teacher from Khairput and resident of Bandhaguda village under Mudulipada panchayat in Malkangiri district was killed when a bus collided with his motorcycle Tuesday morning while he was returning after election-related works. Indrajit was engaged as a presiding officer at booth no-122 of Malkangiri Assembly constituency, Monday.

In the other incident, Prasanna Kumar Nayak, 58, a cashier at Sinapali BCC Bank was died after the motorcycle he was riding was hit by a speeding car near Tarbod police outpost in Nuapada district while he was returning home after completing election duty, Tuesday morning. Nayak was the presiding officer at booth no- 184 at Ranimunda village of Khadial Assembly constituency. Chief Electoral Officer (CEO) NB Dhal has announced an ex-gratia payment of ₹15 lakh to each of the next of kin of the two officials as per the ECI guidelines.

Bhubaneswar/Bijapur, May 14: Three days after the police claimed to have killed 12 Naxalites during an encounter in Chhattisgarh's Bijapur district, locals and activists have alleged that the exchange of fire was fake and those killed were not Maoists

The police Friday had claimed that they had neutralised 12 Naxalites in a forest near Pidia village under Gangaloor police station limits in an encounter during an anti-Naxalite operation. Police also identified the dead Naxalites and claimed that they

all carried cash rewards.

Local villagers, mostly women, and family members of the deceased who had been camping in Bijapur district headquarters since Saturday accused the police of staging a fake encounter.

The protesting women claimed that police gunned down residents of Pidia and nearby Itawar village when they had gone to pluck kendu leaves, a source of livelihood for many in the region.

A woman, who identified herself as Avlam Budri, said her husband was picked up by the police when he had gone to pluck kendu leaves Friday and she is unaware whether he is alive. Tribal activist Soni Sori, who

was accompanying them, said Friday's encounter was fake and police opened fire on people from Pidia and Itawar villages out in the forest to pluck kendu leaves. Echoing similar claims, Rakesh Avlam told some local media persons in his Pidia village that police chased villagers who were plucking kendu leaves

and gunned them down.

Avlam, who is associated with kendu leaf collection work claimed his cousin brother Motu Avlam who was also collecting the leaves suffered bullet injuries in police firing.

According to reports in a leading national daily, Gurunanda, a resident of Pedia village who witnessed the encounter, said that some villagers had gone to pluck kendu leaves from the forest when the security forces came towards them. Seeing this, the villagers started running away. "They were shot down by the forces while they were running in fear and surprise," he said, according to the newspaper.

DIG (Dantewada region-South Bastar) Kamlochan Kashyap refuted the claims, asserting that those killed in the encounter were Maoists and carrying cash rewards.

Former Chhattisgarh CM Bhupesh Baghel of Congress said that unexpected political pressure on security forces should not be such that their actions are questioned.

While these Assembly and Lok Sabha segments had witnessed average voter turnout of 74.18 per cent in 2019, this time (till 00.30am Wednesday) they recorded 75.68 per cent polling.

BJD leader Kartik Pandian Tuesday claimed that the regional party will secure at least 24 of the 28 Assembly seats in the phase I elections.

"BJD is sweeping the elections whether it is first, second, third or fourth phase. In the first phase, BJD is winning a minimum of 24 out of 28 seats,' Pandian said.

The regional party in 2019 had won 20 of the 28 Assembly seats while BJP got 4 Assembly seats, followed by Congress 3 and an Independent.

However, Pandian did not give any figures on the Lok Sabha seats. "I will not speak on Lok Sabha results. It is a big thing. However, we will definitely per-

form better than 2019," he said.

BJP Odisha election In-charge Vijaypal Singh Tomar Tuesday claimed that his party will win all four Lok Sabha constituencies and 18 out of 28 Assembly seats that went to polls in the first round of voting in the state May 13.

Asserting that the saffron party will form the government in Odisha, Tomar said BJP will win at least 16 of the 21 Lok Sabha seats in Odisha

It is worth mentioning that the highest voter turnout of 82.16 per cent was recorded in the tribal-dominated Nabarangpur Parliamentary seat, followed by Koraput (77.53 per cent), Kalahandi (77.90 per cent) and Berhampur (65.41 per cent).

In 2019 elections, in the first phase, the same four Lok Sabha and 28 Assembly seats had witnessed high polling of over 74 per cent. Berhampur Lok Sabha constituency had also recorded the lowest turnout of 65.89 per cent then.

He took 200 flights to steal fliers' jewellery

New Delhi, May 14: He took at least 200 flights and travelled for over 110 days during the past year to steal jewellerv and other valuables from handbags of co-passengers.

The Delhi Police cut short the long run of Rajesh Kapoor from law when they arrested the 40-yearold man from a hideout in Paharganj, here, where he allegedly kept the stolen jewellery. Deputy Commissioner of Police

(IGI) Usha Rangnani Monday said Kapoor was planning to sell the booty to Sharad Jain, 46, who has been arrested from Karol Bagh. Rangnani said two separate cases of thefts were reported on separate



flights in the past three months, after which a dedicated team from IGI Airport was formed to nab the culprits.

On April 11, a passenger lost her jewellery worth ₹7 lakh while travelling from Hyderabad to Delhi. Another theft was reported February 2, where a passenger had lost jewellery items worth ₹20

lakh while he was travelling from Amritsar to Delhi.

Rangnani said that during investigations, CCTV footage from Delhi and Amritsar airports and the flight manifests were analysed. A suspect was shortlisted as he was seen on both flights on which theft incidents were reported, she said.

The officer said the phone number of the suspect passenger was obtained from the airlines concerned, but he had provided a fake number at the time of booking.

After technical surveillance, Kapoor's original phone number was traced and he was caught.

On sustained interrogation, he confessed to have been involved in five such cases, including one in

Hyderabad, the police said. He disclosed that he spent most

of the cash on online and offline gambling.

Kapoor was found involved in 11 cases of theft, gambling and criminal breach of trust. out of which five cases were of airport.

Another police officer said Kapoor would target vulnerable passengers, particularly elderly women travelling internationally.

"Recognising the tendency of such passengers to carry valuables in their handbags, he strategically travelled in premium domestic flights, notably Air India and Vistara, bound for destinations like Delhi, Chandigarh, and Hyderabad," the officer said.

Lawyers can't be sued for 'deficiency in service': SC

New Delhi, May 14: In a significant verdict, the Supreme Court Tuesday held that the lawyers do not come within the purview of Consumer Protection Act and cannot be sued for 'deficiency in service' before the consumer courts.

The top court said a considerable amount of direct control is exercised by the client over the manner in which an advocate renders his services during the course of his employment. The services hired or availed

of an advocate would be that of a contract 'of personal service' and would, therefore, stand excluded from the definition of 'service', it said.

A bench of justices Bela M Trivedi and Pankaj Mithal said the legal profession is sui generis (unique) and the nature of work is specialised and cannot be compared with other professions. The top court said the very

purpose and object of the Consumer Protection Act 1986 as re-enacted in 2019 was to provide protection to the consumers from unfair trade practices and unethical business practices. and the legislature never intended to include either the professions or the services rendered by the professionals within the purview of the said Act.

"A service hired or availed of an advocate is a service under 'a contract of personal service', and therefore would fall within the exclusionary part of the definition of 'Service' contained in Section 2 (42) of the Consumer Protection Act, 2019. A complaint alleging 'deficiency in service' against Advocates practising legal profession would not be maintainable under the Consumer Protection Act, 2019," the bench said.

The judgment came on a plea filed by the bar bodies and other individuals challenging a 2007 verdict of the National Consumer Disputes Redressal Commission



(NCDRC), which has ruled that advocates and their services come under the purview of the Consumer Protection Act, 1986.

The top court said the object of the Consumer Protection Act was to provide to the consumers timely and effective administration and settlement of their

disputes. "If the services provided by all the professionals are also brought within the purview of the Act, there would be flood-gate of litigations in the commissions/forums established under the Act. particularly because the remedy provided under the Act is inexpensive and summary in na-

ture," the bench said. Observing that the legal profession cannot be equated with any other traditional professions, the bench said it is not commercial in nature but is essentially a service-oriented and noble profession. "It cannot be gainsaid that the role of Advocates is indispensable in the Justice Delivery System. An evolution of jurisprudence to keep our Constitution vibrant is possible only with the positive contribution of the Advocates. The Advocates are expected to be fearless and independent for protecting the rights of citizens, for upholding the Rule of law and also for protecting the

Independence of Judiciary. "People repose immense faith in the Judiciary, and the Bar being an integral part of the Judicial System has been as-

signed a very crucial role for preserving the independence of the Judiciary, and in turn the very democratic set up of the Nation. The advocates are perceived to be the intellectuals amongst the elites and social activists amongst the downtrodden," it said.

That is the reason they are expected to act according to the principles of "uberrima fides". - the utmost good faith, integrity, fairness and loyalty while handling the legal proceedings of his client, it added.

The top court said being a responsible officer of the court and an important adjunct of the administration of justice, an advocate owes his duty not only

to his client but also to the court as well as to the opposite side. "The legal profession is different from the other professions also for the reason that what the Advocates do, affects not only an individual but the entire administration of justice, which is the foundation of the civilised society. It must be remembered that the legal profession is a solemn and serious profession," it said. The apex court said the legal profession has always been held in very high esteem because of the stellar role played by the stalwarts in the profession

to strengthen the judicial system in the country. "Therefore, having regard to the role, status and duties of the Advocates as the professionals, we are of the opinion that the legal profession is sui generis i.e., unique in nature and cannot be compared with any other profession," it said. In its 2007 judgment, the consumer commission held that advocates come under the purview of the Consumer Protection Act and can be sued in a consumer court by their clients for any deficiency in service. The national consumer forum's verdict had held that the legal services rendered by lawyers would come within the ambit of

section 2(1)(0) of the 1986 Act.

Among the major parties, 28 (80 per cent) candidates from BJP, 17 (52 per cent) from Congress, nine (26 per cent) from BJD and four (40 per cent) out of 10 AAP candidates have declared criminal cases against themselves in their affidavits, it said.

On education details of candidates, the report said that 130 nominees have declared their qualifications to be between 5th and 12th standard pass, while 122 candidates are graduates or above.

OVER 1,000 SKYPE ACCOUNTS BLOCKED

New Delhi, May 14: Over 1,000 Skype IDs run by cross-border cybercriminals engaged in online intimidation, blackmail, extortion and "digital arrests" have been blocked by the government, according to an official statement Tuesday.

Issuing a warning to internet users, Indian Cyber Crime Coordination Centre (I4C), set up under the Ministry of Home Affairs for coordination on activities related to combating cybercrime, said a large number of complaints are being reported where criminals posing as officials of regulators and enforcement agencies are indulging in intimidation, blackmail, extortion and 'digital arrests'.



"This is an organised online economic crime and is learnt to be operated by cross-border crime syndicates," the statement from the Home Ministry said Tuesday.

Commonly known as the 'parcel scam', the cyber criminals call victims informing about a parcel ad-

dressed to them which contains contraband items like illegal goods, drugs, or fake passports, among others

In other cases, cyber fraudsters call to convey that a near or dear one of the victim has been found to be involved in a crime or an accident and is in their custody.

"A demand for money is made to compromise in the 'case'. In certain instances, unsuspecting victims are made to undergo 'digital arrest' and remain visually available over Skype or other video conferencing platform to the fraudsters, till their demands are met. The fraudsters are known to use studios modelled on police stations and government offices and wear uniforms to appear genuine," the statement from I4C said.

The Union Home Ministry is closely working with other ministries and their agencies, RBI and other organisations to counter these frauds

"I4C is also providing inputs and technical support to Police Authorities of States/UTs for identifying and investigating the cases. I4C has also blocked more than 1,000 Skype IDs involved in such activities, in collaboration with Microsoft. It is also facilitating blocking of SIM cards, mobile devices and mule accounts used by such fraudsters," it said.

The agency said a number of victims have lost large amounts of money to such criminals and urged the citizens to call 1930 or visit www.cybercrime.gov.in for assistance in such cases.

CIVIL SOCIETY TO EC Ensure transparency of electoral process

New Delhi, May 14: A civil society delegation submitted a petition signed by over 4,000 people to the Election Commission (EC) Tuesday, demanding greater transparency in the disclosure of voter turnout figures during the ongoing general elections.

The petition highlighted fluctuations in reported voter turnout figures during the first two phases of the elections.

The letter, which was physically submitted at the poll body's office Tuesday, said there were discrepancies between initial estimates and later revisions, which have sparked doubts and concerns among the public regarding the accuracy and transparency of the electoral process

The EC has previously said that constituency and boothwise data of actual number of votes polled is available with the candidates.

In their letter, the delegation references Rule 49S of the Conduct of Elections Rules, which mandates that the presiding officer at each polling station prepares an account of votes, recorded in Part I of Form 17C and provides authenticated copies to polling agents.

Citing specific instances from the first and second phases of polling, the letter pointed out instances where initial turnout estimates of around 60 per cent surged by over six per cent later in the official release of the fig-

We, therefore, urge the ECI to immediately upload on the Commission's website a scanned legible copy of Part I of Form 17C (Account of Votes Recorded) of every polling station where voting took place in the first three phases. Further, for the remaining phases, this information must be publicly displayed on the ECI website within 48 hours of the close of polls," the letter said.

In addition to uploading a scanned copy of the forms, they demanded that a tabulation of the constituency and polling station-wise figures of voter turnout in absolute numbers must also be publicly displayed on the ECI website. The petition seeking greater

Rising myopia among kids due to increased screen time

STUDIES SHOW THAT IN THE 20-YEAR PERIOD FROM 1999 TO 2019, THE INCIDENCE OF MYOPIA AMONG URBAN CHILDREN HAS TRIPLED IN INDIA, FROM 4.44% TO 21.15%, RESPECTIVELY

s many as one-third of all children in urban India aged 5-15 years are expected to suffer from myopia by 2030, eye doctors said, as a result of increased sedentary lifestyle and prolonged use of screens.

Myopia, commonly known as near-sightedness, is a condition where objects are clear, but those farther away appear blurred.

It has become a significant public health issue worldwide with one in every two individuals being myopic as early as 2050, with a rising prevalence among children and young adults.

Myopia rates are indeed rising globally, including in India, there

is evidence suggesting a significant increase in myopia prevalence among urban children in India, said the experts as part of the ongoing Myopia Awareness Week.

Studies show that in the 20-year period from 1999 to 2019, the incidence of myopia among urban children has tripled in India, from 4.44 per cent to 21.15 per cent, respectively.

"We have been witnessing a steady increase in the number of myopia cases in urban children over the last few years. Our predictions, based on the slope of 0.8 per cent every year, indicate that the prevalence of my-



opia among urban children will increase to 31.89 per cent in 2030. 40 per cent in 2040 and 48.1 per cent in 2050. This means that one out of every two children in India will be suffering from myopia in the next 25 years, up from one in four currently," Smit M Bavariya, cataract surgeon with Dr Agarwals Eye Hospital, Thane, Mumbai, told IANS.

"Indeed, myopia is becoming more common in India, espe-

cially among the urban population. This tendency has been confirmed by a number of studies and reports, which show that myopia has become more common among kids and teenagers in recent years," added Mahipal Singh Sachdev, chairman and managing director, Center for

The symptoms include blurry vision, difficulty seeing distant objects, eye strain, headaches,

doors also affects eye health, Mahipal told IANS.

The experts also blamed changes in lifestyle brought about by urbanisation, including an increase in near-work activities like studying, reading and extended durations of near-work caused by demanding academic contexts in metropolitan locations.

"Genetic predisposition also matters; it's possible that urban populations have a higher prevalence of genetic risk factors linked to myopia. These all factors put a lot of pressure and strain to our eyes, retina and nerves, as a result of which the incidences are gradually rising," Mahipal said.

To tackle the rising health issue, the experts called for public health initiatives, education campaigns, lifestyle adjustments and enhanced access to eye care services.

Ethanol plant construction sparks row in Nayagarh

VILLAGERS ALLEGE THAT THE UNIT WILL AFFECT WILDLIFE AND ENVIRONMENT DRASTICALLY

Nayagarh, May 14: Construction of a new ethanol plant by 'Juststrive Industries Private Ltd', which has its headquarters in Hvderabad, has sparked resentment among locals and environmentalists in Nayagarh district. It is coming up in Haridabandha mouza of Badagotha panchayat under Nuagaon block. However, locals pointed out that it is being constructed on a plot of 60 acres of land which is close to an elephant corridor. This will certainly affect wildlife and the en-

vironment, they added. The matter came to the fore after members of local outfit. 'Anchalik Vikash Parishad' and



residents of Mahipur and Badagotha areas met Navagarh District Collector Swadha Dev Singh and submitted a written complaint in this regard Monday. They urged the district collector to intervene and stop the construction of the ethanol plant. The agitators have also alleged that the management of the

company has illegally acquired 26 acres of 'pasture land' for construction of a road adjacent to the plant. They added that

despite repeated protests, road construction has started on the land. The locals also alleged that the plant authorities are going ahead with their plans without the necessary clearances from the State Pollution Control Board (SPCB), They pointed out that their livestock will suffer if the pasture land is converted into a road.

The registration of 60 acres of land in the name of 'Juststrive Industries Private Ltd' without

a proper road connection has come as a huge shock to the residents of the area. Usually in such cases, companies have to show that they have acquired industrial land with road connectivity. However, in this case, the rules have not been followed. the members of 'Anchalik Vikash Parishad' pointed out. They added that the status of the land has been changed to 'Gharabari' (homestead) which indicates ample proof of foul play.

The villagers informed that when a common man purchases land without having proper road connection, registration is denied. However, in this case all rules have been waived. They added that the 26 acres of land couldn't have been acquired by the plant management without the tacit involvement of the local administration. One of the owners of the com-

pany, Ajay Kumar Mohanty however, asserted that the plant is being constructed after getting all the necessary permissions and clearances from state-owned IPICOL. He also said that permission to construct the road on pasture land has been obtained. Mohanty added that they are holding discussions with villagers who are against road construction, to solve the matter amicably. He pointed out that setting up of the plant will help people as local residents will get jobs and there will be many who will indirectly benefit from the unit.

Businessman arrested for grabbing forest land

Rourkela, May 14: A businessman, identified as Rajesh Agarwal, and two of his accomplices have been arrested for allegedly encroaching on forest land and trying to construct a house on it, officials informed here Tuesday. Following the scuffle, the BJP nominee suffered injuries on his neck and chest. Initially Panigrahy was admitted to the MKCG Medical College and Hospital here before being transferred to AIIMS in Bhubaneswar where he is currently undergoing treatment.

He decided to contest as an independent candidate after failing to get a ticket from the BJP for the Berhampur Assembly constituency. He had alleged earlier Panigrahy played a key role in preventing his nomination. He had contested from the same constituency twice in the past, but on both occasions he was unsuccessful.

Rourkela, May 14: Rourkela Steel Plant (RSP) achieved a significant milestone Monday with the lighting up of the rebuilt Coke Oven Battery#2 (COB#2). This marked the initiation of the heating up process of the battery. SR Suryawanshi, Executive Director (Works) ignited the state-of-the-art COB#2. Also present on the occasion were other senior officers and employees of RSP, CET and MECON.

The 4.5 metres tall COB#2, was first commissioned in 1958 and it had undergone rebuilding and modification for the last time in 1995. With the objective of operational flexibility and meeting demands for coke as well as for precision adherence to environmental standards, the rebuilding of the oven was initiated December 15, 2020.

The battery was dismantled up to the nozzle deck slab along with associated equipment and refractory. Notably, the

Illegal liquor-making units busted in Keonjhar



Hatadihi: Acting on a tip-off, police busted a number of country-liquor manufacturing units and seized huge quantities of mahua during raids at the Hadagarh Wildlife Sanctuary under Soso police limits in Keonjhar district Tuesday. The police team was led by DSP Prasant Kumar Behera of Anandapur sub-division. The team first raided villages under Soso and Nandipada police limits from where they seized huge quantities of mahua. Later, the team raided Sundarapal, Sangam and Andhari areas within the sanctuary and busted the manufacturing units. Officials said that 8,000 litres of fermented Mahua brew were seized during the raids. Locals are alarmed at the presence of such illegal liquormanufacturing units within the sanctuary. They said that people involved in the activities might also be associated with poaching. The presence of criminals will only endanger the lives of elephants and other animals in the sanctuary, they opined. However, the miscreants working in these units managed to escape and evaded arrest. Three cases in this regard have been registered at the Soso police station, cops said. They added that raids will be conducted again in the near future to nab people dealing in illegal liquor.

battery has 70 ovens equally distributed in two blocks (2A & 2B). The rebuilt COB#2 is designed to comply with stipulated emission standards and guidelines laid by the Ministry of Environment and Forest (MoEF) to prevent pollution and also to maintain environment quality in the work area. they added. The officials informed that with the lighting up, controlled heating process of the new refractory lining has commenced. It will now take approximately 90 days to obtain the desired temperature of 1.160 degrees Celsius before charging of coal and pushing of coke into COB#2 starts. It is expected to happen by mid-August, officials informed

Meloni & Media

here is bad news from Italy. The Far-Right government of Giorgia Meloni is virtually gagging the media and using the country's public broadcaster for the ruling alliance's propaganda. On the other hand, there is also good news. It is observed that Italian journalists are not taking the blatant attempt to control the media lying down. According to the latest audit of Press freedom by Reporters Without Borders, Italy has slipped down in international rankings. The report stated the Meloni government is going ahead with its plan to sell off a state-controlled news agency to a Press baron who is also an MP in her ruling coalition. However, we in India should not find these acts strange. Such manipulations by the party in power to control both state and private media to launch pro-government propaganda, has become common practise. What is happening in Italy now is causing serious concern for the fate of freedom of speech in the country as neo-Fascist powers are at the helm of affairs. Interestingly it is in Italy that fascist forces, under the leadership of Benito Mussolini, had grabbed power over a century ago. Time seems to have turned full circle.

As has been the case in India where the government has been using the law of sedition to intimidate journalists and social activists critical of the government's acts of omission and commission, the radical Right government of Italy is using the country's draconian defamation law to silence independent voices. This week, a philosopher from Rome's Sapienza University will become the latest public intellectual to face court proceedings after having been accused of defamation by a government figure. In a talk show, Donatella Di Cesare described the language used by the agriculture minister, Francesco Lollobrigida (Meloni's brother-in-law), as neo-Nazi in tone. Under Italy's strict defamation laws, she risks a substantial prison sentence if eventually found guilty in a criminal court.

But. Di Cesare is not an isolated case. Meloni herself is pursuing an aggravated defamation case, on similar grounds, against an 81-year-old historian. She has also sued the writer and journalist Roberto Saviano apart from journalists working at the Left-wing newspaper Domani.

In broadcasting, the situation is even more grim. The tradition in the state broadcaster, RAI, has for decades been that the ruling party uses it as a political prize. Even then no party in power in the past took control of the news outlet so brazenly as Meloni's administration is doing for which it has already earned the sobriquet of "Tele Meloni." The corporation's director-general, Giampaolo Rossi, a close Meloni ally is an admirer of Viktor Orban and a onetime apologist for Vladimir Putin. A year after he was appointed, internal dissension has come out in the open. Last week, disgusted journalists began a series of strikes mainly against "deteriorating" working conditions and alleged editorial interference and pressure from Meloni's government. At a Press conference, Enrica Agostini, a senior political reporter, said that in 25 years at RAI she had "never experienced pressure and censorship like now.'

That things were heading towards undeclared censorship became clear last month when one of Italy's leading authors, Antonio Scurati, accused RAI of censorship after an invitation to deliver an anti-Fascism talk to mark Italy's Liberation Day was withdrawn at the last minute. Scurati had shot into international limelight through his 2018 novel -M: Son of the Century -, based on the rise of Benito Mussolini. His crime, in the eyes of Meloni's Brothers of Italy, is that in an interview following the election victory of Meloni and her party in 2022, he sought to differentiate between 20th-century Fascism and the modern radical Right. He said the real danger now is not the survival of democracy, but "the quality of that democracy." What he meant is the current global phenomenon of neo-Fascist, neo-Nazi parties using the democratic route of elections to seize power and then impose authoritarian, intolerant rule on the people.

Meloni's high esteem for the Hungarian Prime Minister Victor Orban, the self-styled champion of "illiberal democracy," is well known. Since taking office 18 months ago, she has – unlike the Hungarian PM - supported Europe's political mainstream views on issues such as Ukraine. But at home, her government's policy of bullying critics follows the example of Orban

Another sign of protest is journalists at Italy's state broadcaster went on strike protesting what their union termed "suffocating control" by Meloni's administration. They expressed their resolve not to allow the government to turn RAI into a mouthpiece for the government. Their counterparts in India can take a leaf out of their book.

RISE OF 'FINTERNET'

There has been some progress on technology to enable such a new reality, as evidenced by the proliferation of mobile-payment apps. But transforming financial services will require creating an entirely new system to match the advances made in communications since the advent of the internet and smartphones. Today's mobile phones are powerful computers, after all, so it would be a waste not to maximise their use.

To this end, we have drawn on our joint expertise in economics and technology to offer a blueprint for the future financial architecture. What we call the "Finternet" is a vision of multiple financial ecosystems that connect with one another, much like the internet, in order to give individuals and businesses full control over their fi nancial lives. We foresee a world in which people and companies can use any device to transfer any financial asset - no matter the amount - to anyone in the world. These transactions would be cheap, secure, near-instan-

taneous, and available to all. This new system would be particularly important for emerging and developing economies, where large gaps in access to financial services remain despite efforts to bolster inclusion. Many services are simply unavailable or not widely available, particularly to people living in remote areas and with low incomes. And even when people are able to access financial products, using them is often expensive and slow.

Important breakthroughs in recent years have paved the way for the Finternet. One example is tokenisation, whereby tokens representing digital assets can uniquely identify ownership as well as applicable rules. Another is programmable ledgers, the digital platforms that combine



What we call the 'Finternet' is a vision of multiple financial ecosystems that connect with one another, much like the internet, in order to give individuals and businesses full control over their financial lives. We foresee a world in which people and companies can use any device to transfer any financial asset - no matter the amount - to anyone in the world. the record-keeping functions of traditional databases with the governance arrangements required to update them.

To unlock the value of financial innovation and build a seamless, interconnected net work, we must combine all these elements and break down the current financial system's barriers and silos. Specifically, bringing together different tokenised assets on unified programmable ledgers would drastically reduce the need for lengthy messaging, clearing, and settlement systems that create extra costs, take more time. and limit access to credit and other financial services

Unified ledgers would also enable "smart contracts," which can trigger an action - transferring ownership of a house, for example - if prespecified conditions are met. They could even bundle together numerous automated transactions. So, in the case of a property transfer, the payment of the purchase price and anti-money laundering checks could happen at the same time and take seconds rather than weeks. Overall, these ledgers would meet - and perhaps surpass - today's regulatory and supervisory standards, while also being faster, cheaper, and more reliable than current svstems.

But technology is not enough. Central banks, as the guardians of public money, have a major role to play in the new financial architecture. The money they issue is the vehicle through which all economic transactions are ultimately settled. A

digital form of this money is thus a necessary foundation for the Finternet. Commercial banks will also play a crucial role in interacting with consumers, not least by providing tokenised bank deposits that will form the lifeblood of the Finternet's monetary system.

Moreover, a robust regulatory and supervisory structure must underpin the Finternet Safeguards such as deposit insurance and public oversight of financial-services providers should be maintained to protect customers and ensure that money has the same value regardless of whether it is issued by a central bank or a commercial bank.

The radical use of new tech nology could streamline the layers of manual checks now required to comply with rules and regulations. This would enable the creation of products that otherwise might not be developed due to compliance burdens, while also ensuring that the Finternet is not used by bad actors seeking to exploit loopholes.

Making the Finternet a reality will take years, but we must start now. The technology is mature enough, and, crucially, we are not yet locked into rigid institutional frameworks or trapped in "walled gardens" of services created by monopolies. This is a once-in-a-lifetime opportunity to redesign the architecture of the financial system, and we should be thinking big and imaginatively, instead of focusing narrowly on individual technologies.

We know where we need to go Equally important, we have the tools to get there. Now the global financial system just needs its "Neil Armstrong moment" – a small step that represents a giant leap for mankind.

lug a tree & show your love

do not remember the last time I hugged a tree.

This is embarrassing partly because I have a dozen trees around my house and appreciate them greatly, not just for their beauty but for all the benefits they provide. Even so, I have not taken the trouble to hug any of my trees. nor given any of them a loving tap, not even the maple tree.

I wouldn't normally feel guilty about this — after all, I'm not the only person who is slacking off in tree hugging — but then I heard about Abubakar Tahiru. a 29-year-old Ghanaian forestry student who has hugged more trees than Pope Francis has hugged people.

Well, perhaps that's not quite true. The Pope has probably hugged more than a million people in his lifetime (that's just 30 per day). But the Pope, unlike Tahiru, does not have a Guinness World Record for hugging.

Tahiru, who is pursuing a master's degree in forestry at

have a confession to make: I Auburn University in the US, recently set a world record for the most trees hugged in one hour. In just 60 minutes, he hugged a staggering 1,123 trees, averaging almost 19 per minute. Each tree got just 3.2 seconds of his love.

"Achieving this world record feels incredibly rewarding.' said Tahiru, who went to America last year after earning a bachelor's degree in Ghana. "It's a meaningful gesture to highlight the crucial role of trees in our ecosystem and the urgency of environmental conservation.'

Where did all this hugging take place? It happened at Tuskegee National Forest in Alabama, a conservative state where the majority of people are probably frowning at all this tree-hugging.

Husband: "I don't know how I feel about this. This man has barely been in our country for a year and he's already hugging all our trees.

Capital outflow

Wife: "I suppose it's okay, as long as he got their consent." Tahiru did not break a previ-

ous world record -- he just set a new one. Guinness told him that he needed to hug 700 trees to become the first holder of this record, and he easily beat that mark.

In case you are interested in breaking his record, you should know that Guinness, for the purpose of this record, defines a hug as "both arms wrapped around a tree in a close embrace." Don't try to get away with halfhugs or pretend hugs like you do with people! Each tree should feel like it got an authentic hug.

Guinness also states that "no tree may be hugged more than once." This is a good rule. After all, if one tree got hugged more than once, the other trees would be jealous. Please remember this rule the next time you're in a forest

Another Guinness rule is that "no damage can be caused to any tree or else the attempt is dis-

qualified." Tahiru had to hug each tree quickly, but also gently. After each hug, a Guinness official apparently checked to make sure the tree was fine.

Official: "You okay?" Tree: "Hurt. Definitely hurt."

Official: "Physically?" Tree: "Emotionally. He just

hugged me and moved on to the next tree, like it didn't mean anything to him. Official: "He cares for you --

more than most humans do. That's why he's doing this -- to bring more attention to the importance of trees.

Tree: "Please tell him to bring more hugs for me. And longer than three seconds this time please.

Official: "Okay, I'll tell him. Once he has set the record, he can come back and hug you all he wants.

Tree: "I'll be right here. I'm not going anywhere. That's the thing about trees. We are reliable. You can count on us. Can we count on you?"

However, India's net remittance position remains heavily skewed at -\$94 billion, indicating a significant outflow of talent and capital from the country. To sustain India's growth trajectory and address the persistent net remittance deficit, it is crucial to prioritise talent retention and domestic innovation. By fostering an environment that nurtures creativity, offers competitive opportunities, and rewards excellence, India can harness the -(full potential of its human capital.

Death toll at 14; search and rescue ops still on

Mumbai, May 14: The death toll in the hoarding collapse incident in Mumbai has risen to 14 while 75 others are injured, civic officials Tuesday said as rescue and search operations continued a day after the tragedy.

Mumbai Police Commissioner Vivek Phansalkar assured strict action against those responsible for the incident, while the Brihanmumbai Municipal Corporation (BMC) said it will take down the remaining billboards on the GRP land where the hoarding collapsed. The 120 x 120 square feet illegal hoarding fell at a petrol pump in Ghatkopar area during dust storms and unseasonal rains that lashed Mumbai on Monday.

Rescue teams were facing a challenge as they cannot use gasoline-powered cutter equipment and oxyfuel cutter which can result in a blast or fire as there is a petrol pump at the site, an official of the National Disaster Response Force (NDRF) said.

At least 12 fire engines and other vehicles were involved in the search and rescue operation since the incident Monday. Two NDRF teams, comprising 100 personnel, also joined the operation Monday evening.

Two heavy duty cranes and two hydra cranes were being used in the operation along with two earth-excavating machines and 25 ambulances, the civic official said.

The NDRF teams used two cranes weighing 500 tonnes each to pull up the hoarding from both sides. After creating a gap of about 3.5 to 4 feet, the rescuers crouched into the tiny space to look for people trapped underneath, NDRF assistant commandant Nikhil Mudholkar said

During the search Monday night, three girders of the hoarding were pulled using two hydraulic cranes. Efforts are underway to pull two more big girders using hydraulic cranes, and once this is done, the NDRF will be able to find out if more people are trapped inside, he said.

So far, 89 persons were pulled out from under the collapsed hoarding, of whom 14 were declared dead, officials said. The injured persons were ad-

mitted to six hospitals in Mumbai and neighbouring Thane and 32 of them were discharged so far, they said.

The condition of one of the injured persons admitted to the Rajawadi Hospital was critical, a BMC official said.

Commissioner Police Phansalkar visited the spot late Monday evening and assured of

strict action against those responsible for the incident. A case has been registered against Bhayesh Bhinde, the owner of Ms Ego Media Private Limited and others for culpable homicide not amounting to murder and other relevant sections of the Indian Penal Code at Pant Nagar police station, another official said.

The billboard was illegal and no permission was taken to in-

stall it, as per civic officials. An Assistant Police Commissioner (Admin) had given permission for erecting four hoardings on behalf of the Commissioner of Railway Police, Mumbai, including the one which collapsed, but no official permission or NOC was obtained from the BMC, as per

a civic official.

BJP leader Kirit Somaiya asked how the permission for erecting the billboard was given by a police officer when the city civic body is the authority for it. The former MP also claimed permissions for the hoarding and a petrol pump (where the billboard collapsed) were given when Uddhav Thackeray was the chief minister of Maharashtra.

Had the then director general of police been strict, such a hoarding would not have come up, he told reporters

Somaiya said the permission on paper was given for a 40 feet hoarding whereas the billboard which collapsed was 120 feet tall. "I believe that there are sim-

ilar 400 hoardings in various parts of Mumbai, which are exceeding their size limits and standing on a weak foundation like the one in Ghatkopar." he said.

Somaiya said he has requested Maharashtra Chief Minister Eknath Shinde and Deputy CM Devendra Fadnavis to get such dangerous hoardings removed across Mumbai immediately.

The civic body has prepared a plan to raze the remaining hoardings on the GRP land where the billboard collapsed, an official said.

The BMC had earlier said that it issued a notice to Ms Ego Media Private Limited for installing the hoarding that collapsed on the petrol pump.

A senior civic official said the assistant municipal commissioner of the N-ward had issued a notice to an advertisement agency to remove these hoardings with immediate effect, but the civic body has not received any response so far.

Mahindra Group Chairman Anand Mahindra posted a clip on his X handle showing the hoarding collapsing and said such an incident was unacceptable.

"And we're a city trying to transform itself into a modern metropolis. CM Shinde has ordered a probe into all hoardings. Stringent rules must follow," he added.

CM Shinde visited the incident spot late Monday evening and ordered a structural audit of all hoardings in the city.

The hoardings, if found illegal and dangerous, would be removed immediately, he said.

It is a very unfortunate incident. The government will probe it, and the people responsible will face action, Shinde told reporters

He announced an aid of ₹5 lakh to the kin of each person killed in the incident.

BMC, GRP dispute delayed action on illegal billboards

Mumbai, May 14: No action was taken in the past against the giant hoarding that crashed on a petrol pump in Chheda Nagar area Monday evening as a dispute was going on between the Brihanmumbai Municipal Corporation (BMC) and Government Railway Police (GRP), an official said.

A day after the collapse of an illegal hoarding claimed 14 lives in Ghatkopar, the Mumbai civic body Tuesday said it would take action against all hoardings erected without its permission. The drive will start with the

removal of the remaining three hoardings on the GRP land in Ghatkopar, said municipal commissioner Bhushan Gagrani Tuesday after visiting the site where rescue operation is underway.

"Regarding this incident, a case has been registered. We have also directed all civic officials and assistant commissioners to remove such hoardings erected without our permission or which are dangerous in their respective wards immediately. In the next few days you will find this action completed," he said.

Maharashtra Chief Minister Eknath Shinde also gave directives in this regard to the civic body, Gagrani added. The BMC does not have an elected body at present as civic elections are pending for more than two years. Reiterating that the BMC had

not given any permission for the hoarding that collapsed Monday, Gagrani said it had been conducting correspondence (with the owner and concerned

agencies) regarding it for the last two years, and also lodged a police complaint for the poisoning of trees on its periphery.

"A stand was taken that we (GRP) do not need permission (for a hoarding on railway land) under the Railway Act. The BMC's response was that it was not legally correct. And hence, in the whole episode, so far there was no action," the commissioner claimed.

An assistant police commissioner (admin) had given permission for the four hoardings on the GRP land (including the one that collapsed) on behalf of the commissioner of railway police, Mumbai, but no permission had been obtained from the BMC, a civic official had claimed earlier.

The death toll in the incident stands at 14 while the condition of two injured persons was critical, Gagrani said, adding that most of the injured are admitted to the Rajawadi hospital while those who require neurosurgery have been shifted to the KEM hospital. Both hospitals are run by the BMC.

Priests, locals stir in Badrinath against **DI KAILASH YATRA BEGINS** 'mismanagement' of Char Dham Yatra

Pithoragarh, May 14: The Adi Kailash yatra commenced Tuesday with the first batch of 49 pilgrims arriving at Dharchula base camp en route to Jolingkong which offers a view of the sacred peak.

The first batch of 49 pilgrims. including 32 men and 17 women from different parts of the country, reached the base camp of the vatra at Dharchula. Kumaon Mandal Vikas Nigam (KMVN) general manager Vijay Nath Shukla said. The pilgrims are on their way to the Shiv-Parvati temple, which is situated alongside a lake at a height of 18,500 feet in Jolingkong from where one can see the sacred Adi Kailash peak. The temple was opened Monday. Over 200 devotees were present on the occasion of the opening of the temple for the year, said Gopal Singh Kutiyal, the chief priest of the temple. Jolingkong came into prominence in October last year when prime minister Narendra Modi paid obeisance at the lakeside temple and had a darshan of the Adi Kailash peak from there.

Gopeshwar (U'khand), May 14: Priests and locals protested in Uttarakhand's Badrinath Monday against the alleged mismanagement of the Char Dham Yatra by the district administration, causing inconvenience to people. Shops were kept closed at the Himalayan temple in protest and the Panda community and locals hit the streets. The agitators created a ruckus in support of more than half-adozen of their demands, including stopping the VIP darshan system in Badrinath, removing barricades from the traditional routes for the locals and the facility of entering the temple as before. Later, after talks between the agitators and officials of the temple committee, the barricading was removed from the roads.



Talking to PTI Bhasha, Parveen Dhyani, who is associated with the Badrinath Teerth Purohit organisation, alleged that the houses of more than a dozen members of the Panda community have been demolished. On the other hand, he said chaos has been created by the temple committee in the name of VIP darshan and the main pedestrian route leading to the houses of the locals closed. However, after the agitation, the administration removed the barricades from the pedestrian paths and also closed the counter for VIP darshan. Dhvani said.

U'khand forest fires threaten rare Himalayan fauna: Experts

Pithoragarh, May 14: Forest fires that occur annually in Uttarakhand not only cause significant damage to the region's precious forest resources like trees, plants, bushes, herbs and thick layer of soil but also threaten rare Himalayan fauna -- wild animals, reptiles, mammals, birds, butterflies, common flies honey bees and soil-enriching bacteria.

"We have several rare species of birds whose breeding season coincides with the forest fire season, from April to June. Frequent and uncontrolled forest fires are gradually making these species highly endangered in Uttarakhand forests," Sanjeev Chaturvedi, chief conservator of forest (Research), said.

According to the CCF, avian species like the cheer pheasant, kalij pheasant, rufous-bellied woodpecker; common rose, chocolate pansy and common crow have their breeding season from March to June, which is also the



period when most fires occur in the region's forest area.

The cheer pheasant, a native bird of western Himalayas, which inhabits at altitudes of 1800-3200 metres is highly vulnerable to forest fires as it makes its nest in deep bushes on ground and its breeding season coin-

cides with the forest fire season, Chaturvedi said

According to him, the cheer pheasant is included in the list of endangered bird species internationally.

Not only the cheer pheasant but rare birds like the pipit bird, rose finch and the Himalayan

monal have also become endangered due to several reasons, including forests fires in the breeding season, Surendra Panwar, a researcher and keen watcher of the Himalavan birds in Munsiyari, said.

According to Panwar, the number of the rarest of rare Himalayan quail, a species known to be beloved by world-famous ornithologist late Salim Ali, is also declining in the region due to the carelessness of the stakeholders of Himalayan fauna. Jagdish Bhatt, founder director of Wings Foundation, an NGO working towards preserving the Himalayan butterflies, says that of the total 350 species of butterflies found in the Himalayan region, 120 are on the verge of getting endangered as they breed in host plants that are destroyed in forest fires.

Even their caterpillar larvae get destroyed in fires making these varieties highly endangered. Bhatt said.

The Dehradun-based Forest Research Institute is also re-

searching the impact of forest fires on the yellow-headed tortoise that is found throughout the South Asian region. It is listed in schedule 4th of the Wildlife Protection Act, 1972 and also ap pears in appendix of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) due to its being endangered, sources said.

Under the study to find the impact of forest fires on its (yellow-headed tortoise) existence, we will deploy radio transmitters on tortoise track for two years in the Chilla range of the Rajaji National Park, CCF Chaturvedi said.

Forest fires in Uttarakhand have affected more than 1,437 hectares of forests since November last year, according to a forest department bulletin.

The recent spell of rains in various parts of the state provided much-needed respite from them with no fresh inci-dents reported in the past few days, it said.

According to police, the emails were sent from 'beeble.com', a Europe-based mailing service company, with the same content sent to hospitals Sunday.

The officer said Tuesday the email had come from the ID courtisgod123@beeble.com".

The content of the letter read, "I have placed explosive devices inside your building. They will explode in the following hour. This isn't a threat, you have a few hours to disarm the bomb or else the blood of innocent people inside the building will be on your hands. "The group called 'Court' is behind this massacre," it said.

The officer said the e-mail was sent to one hospital with copies marked to others and Tihar Jail. According to a DFS official. the spate of calls began at 10.45 am. The first hospital to call was Deep Chand Bandhu Hospital in north Delhi's Ashok Vihar at 9.45 am. The second call came at 10.55 am from Dada Dev Hospital in Dabri in southwest Delhi, the third at 11.01 am from Hedgewar Hospital in east Delhi's Farsh Bazar and the fourth at 11.12 am from GTB Hospital in Shahdara, also in east Delhi.

POLL AFFIDAVIT Modi declares total assets worth ₹3 crore

Varanasi (UP), May 14: Prime Minister Narendra Modi possesses assets amounting to a little over ₹3 crore, most of it in bank fixed deposits, according to his election affidavit.

As required, Modi submitted the affidavit while filing his nomination papers Tuesday as an election candidate from the Varanasi parliamentary constituency, a seat he has held twice earlier.

According to the affidavit displayed on the Election Commission website, his movable assets are worth ₹3,02,06,889. Most of this amount is in the form of fixed deposits with the State Bank of India that total over 2.85 crore.

Other assets include four gold rings weighing 45 grams valued at ₹2.67 lakh, cash in hand totalling ₹52,920, National Savings Certificates worth ₹9.12 lakh and income tax deduction of ₹3.33 lakh for the past financial year.

Under "immovable assets" the affidavit says "Nil" Typically, land and houses fall

CLIMATE DISASTERS HIT INDIA Over half million displaced in 2023: Report

According to meteorologists, cyclonic storms are intensifying rapidly and retaining their intensity for longer durations due to global warming

New Delhi, May 14: India experienced over half a million internal displacements due to floods, storms, earthquakes, and other disasters in 2023, a sharp dip from around 2.5 million displacements in 2022, according to a global report released Tuesday.

Deadly floods left behind a trail of destruction in the Himalayan states of Himachal Pradesh and Uttarakhand last vear. The glacial lake outburst flood in Sikkim in October 2023 led to the collapse of a hydroelectric dam, killed more than 100 people, and affected

more than 88,000. In Delhi, identified as a "flood displacement hotspot", the Yamuna River overflowed after heavy rains July 9, 2023, prompting authorities to evacuate r esidents from their homes. The report by the Geneva-based Internal Displacement Monitoring Centre (IDMC) said around 27,000 displacements in

the national capital. Delhi recorded 153 mm of rainfall July 9 in just 24 hours,

the highest single-day rainfall since July 25, 1982. Overall, South Asia reported around 3.7 million internal displacements in 2023, with disasters causing 3.6 million, the lowest figure since 2018.

Researchers attributed the decline in displacements due to disasters partly to the El Nino event, which brought below-average rainfall during the monsoon and a weaker cyclone season. However, floods and storms continued to displace people, often in the same areas.

At 3,52,000, India's flood displacement figure was the lowest since 2008, with the largest event triggering about 91,000 displacements in Assam in June, affecting 20 districts. Cyclone



Biparjoy, which formed in the Arabian Sea in early June, led to widespread flooding across Gujarat and Rajasthan, causing 105,000 displacements as it moved inland. Cyclone Mocha, the largest disaster displacement event of 2023 in South Asia, triggered 1.3 million displace ments in Bangladesh, mainly in Cox's Bazar district.

Government-led pre-emptive evacuations accounted for at least three-quarters of this figure. According to the report, disasters triggered 26.4 million displacements in 2023, the third highest annual total in the last 10 years. No country is immune to disaster displacement, said Alexandra Bilak, the director of IDMC.

Extreme weather events such as floods and heatwaves are becoming more frequent and are projected to increase manifold in India in the future due to climate change, according to a 2022 report by researchers atthe Indian Institute of Technology, Gandhinagar.

Cave-in leaves 2 miners dead

Warsaw: Two miners were killed and one remains missing after a cave-in at the Myslowice-Wesola coal mine in southern Poland early Tuesday in which 12 other miners were hurt, mining authorities said Tuesday. The cave-in happened around 3:30 am some 870 metres (2,800 feet) underground in an area where 15 miners were working, said Rajmund Horst, the deputy head of the company that runs the mine. He said two of the miners located by rescuers and brought to the surface were declared dead, while one was being taken to the hospital.

Ex-Indian Army officer with UN killed in Gaza

United Nations, May 14: A former Indian Army officer, who had joined one of the UN agencies three weeks ago, was killed in war-torn Rafah in Gaza, becoming the "first international casualty" for the world body since the Israel-Hamas conflict started last year.

The United Nations has called for a full investigation while Israel has ordered a separate investigation into the attack.

Col Waibhav Anil Kale, 46, who took premature retirement from the Indian Army in 2022, joined the UN as a Security Coordination Officer in the United Nations Department of Safety and Security (DSS) recently, officials in New Delhi said Tuesday.

Kale, who had commanded the 11 Jammu & Kashmir Rifles in Kashmir and had been an instructor at the army's Infantry School in Mhow, was travelling along with another DSS staffer to the European Hospital in Rafah when their UN vehicle was struck Monday morning. The other person, not identified, was seriously injured.

"Kale had joined as a security service coordinator with the UN three weeks ago. The former infantry officer decided to join the UN to pursue his career and also because he was keen on humanitarian mission work," his brother-in-law Wing Commander Prashant Karde (Retd) told PTI in Mumbai.

He is survived by wife Amruta and two teenage children, Karde "The last rites of the 46said. year-old will be held in Pune in two days after his body is flown via Cairo. His mortal remains will land either in Mumbai or Pune depending on the availability of flights," Karde, a senior commander with IndiGo, said. Kale had joined the Indian Army in 1998 and had also served as Contingent Chief Security Officer with the United Nations between 2009 and 2010, Karde said. According to his LinkedIn profile, he earned his BA from the Jawaharlal Nehru University in New Delhi and had degrees in Behavioral Science and International Humanitarian Law and had studied at, among other institutions, the Indian Institute of Management at Lucknow and Indore.

UN Secretary-General Antonio Guterres was "deeply saddened to learn of the death of a United Nations Department of Safety and Security (DSS) staff member and injury to another DSS staffer." Georgia approves controversial law

Tbilisi: The Georgian Parliament Tuesday approved in the third and final reading a divisive Bill that sparked weeks of mass protests, with critics seeing it as a threat to democratic freedoms and the country's aspirations to join the European Union. The Bill requires media and nongovernmental organisations and other nonprofits to register as "pursuing the interests of a foreign power" if they receive more than 20 per cent of their funding from abroad. The government says the bill is necessary to stem what it deems as harmful foreign influence over the country's politics and to prevent unspecified foreign actors from trying to destabilise it.

Israeli tanks push into Gaza's Rafah

Cairo: Israeli tanks forged deeper into eastern Rafah Tuesday, reaching some residential districts of the southern border city where more than a million people had been sheltering, raising fears of yet further civilian casualties. Israel's international allies and aid groups have repeatedly warned against a ground incursion into refugee-packed Rafah, where Israel says four Hamas battalions are holed up. The World Court, also known as the International Court of Justice (ICJ), said it would hold hearings Thursday and Friday to discuss a request by South Africa seeking new emergency measures over the Rafah incursion, which Qatar says has stalled efforts to reach a ceasefire. South Africa's demand is part of a case it brought against Israel accusing it of violating the genocide convention in Gaza, and which Israel has called baseless. Israel will provide its views on the latest petition Friday, the ICJ said. Israel has vowed to press on into Rafah even without its allies' support, saying the operation is necessary to root out remaining Hamas fighters.

New York, May 14: A New York appeals court Tuesday upheld the gag order in Donald Trump's hush money trial, finding that the judge "properly determined" that Trump's public statements "posed a significant threat to the integrity of the testimony of witnesses and potential witnesses in this case as well."

Trump had asked the state's intermediate appeals court to lift or modify the gag order, which bars him from commenting publicly about jurors, witnesses and others connected to the case, including Judge Juan M Merchan's family and prosecutors other than District Attorney Alvin Bragg.

At an emergency hearing last nonth, just days before the trial started, Trump's lawyers argued that the gag order is an unconstitutional curb on the presumptive Republican nominee's free speech rights while he's campaigning for president and fighting criminal charges. In its ruling, the five-judge appeals panel noted that Trump wasn't claiming that the gag order had infringed on his right to a fair trial. The appeals court ruled that Merchan "properly weighed" Trump's free speech rights against the "historical commitment to ensuring the fair administration of justice in criminal cases, and the right of persons related or tangentially related to the criminal proceedings from being free from threats, intimidation, harassment, and harm.'

The paramilitary Rangers, which were called in to maintain law and order in the disputed region, came under attack in the regional capital Muzaffarabad while moving out of the town, the Dawn newspa-



per reported. Instead of exiting via Brarkot, the village bordering Khyber Pakhtunkhwa, the 19vehicle convoy, including five trucks, chose to exit the region from Kohala, it said.

As the convoy reached Muzaffarabad in a "charged atmosphere", it was pelted with rocks near Shorran da Nakka

village, to which they responded with teargas and firing, the report said. A social media clip verified by Dawn showed three Rangers vehicles ablaze on the Muzaffarabad-Brarkot road.

After entering the city through the Western Bypass, the Rangers were welcomed with rocks again, prompting them to use teargas and bullets. The shelling was so intense that the entire neighbourhood reeled from it, the report said.

Biden hikes US tariffs on an array of Chinese imports

Washington, May 14: The Biden administration announced plans to slap new tariffs on Chinese electric vehicles, advanced batteries, solar cells, steel, alu-

minum and medical equipment – an election year move that's likely to increase friction between the world's two largest economies

The tariffs are to be phased in over the next three years, with those that take effect in 2024 covering EVs, solar cells, syringes, needles, steel and aluminum and more. There are currently very few EVs from China in the US, but officials worry low-priced models made possible by Chinese government subsidies could soon start flooding the US market.

Chinese firms can sell EVs for as little as \$12,000. Their solar cell plants and steel and aluminum mills have enough capacity to meet much of the world's demand, with Chinese officials arguing their production keeps prices low and would aid a transition to the green economy. Lael Brainard, director of the



White House National Economic Council, said the tariffs will raise the cost of select Chinese goods and help thwart Beijing's efforts to dominate the market for emerging technologies in ways that pose risks to US national security and economic stability. "China is simply too big to play by its own rules,

Brainard told reporters on a Monday call previewing the announcement. Administration officials have stressed the decision on tariffs was made independently of November's presidential election. But Brainard noted in her remarks the tariffs would help workers in Pennsylvania and Michigan,

- The tariffs are unlikely to have much of an inflationary impact because of how they're structured
- Administration officials said they think the tariffs won't escalate tensions with China, yet they expect China will explore ways to respond to the new taxes on its products
- It's uncertain what the longterm impact on prices could be if the tariffs contribute to a wider trade dispute

Under the findings of a fourvear review on trade with China. the tax rate on imported Chinese EVs will rise to 102.5 per cent this year, up from total levels of 27.5 per cent. The review was undertaken under Section 301 of the Trade Act of 1974, which allows the government to retaliate against trade practices deemed unfair or in violation of global standards.

Under the 301 guidelines, the tariff rate is to double to 50 per cent on solar cell imports this year. Tariffs on certain Chinese steel and aluminum products will climb to 25 per cent this year. Computer chip tariffs will double to 50 per cent by 2025.

For lithium-ion EV batteries, tariffs will rise from 7.5 per cent to 25 per cent this year. But for non-EV batteries of the same type, the tariff increase will be implemented in 2026. There are also higher tariffs on ship-toshore cranes, critical minerals and medical products.

The new tariffs, at least initially, are largely symbolic since they will apply to only about \$18 billion in imports. A new analysis by Oxford Economics estimates the tariffs will have a barely noticeableimpact on inflation by pushing up inflation by just 0.01 per cent.

New Delhi, May 14: The wholesale inflation rose to a 13-month high of 1.26 per cent in April fuelled by rising prices of food articles, especially vegetables, amid expectations of RBI holding interest rates in the policy review next month.

(WPI) based inflation has been rising for two months in a row. It was 0.20 per cent in February and 0.53 per cent in March. WPI inflation was 0.79 per cent in April last year.

The April WPI print is at a 13-month high. The last high was seen in March 2023, when inflation was 1.41 per cent.

"Positive rate of inflation in April 2024 is primarily due to increase in prices of food articles, electricity, crude petroleum and natural gas, manufacture of food products, other manufacturing etc," Ministry of Commerce & Industry said in a statement Tuesday.

As per the data, inflation in food articles rose to 7.74 per cent in April as against 6.88 per cent in March. In the fuel and power basket, inflation stood at 1.38 per cent in April, up from (-)0.77 per cent in the previous month.

ICRA Chief Economist Aditi Navar said WPI inflation is heavily sensitive to global commodity prices which is undergoing upturn year after year.

"A lot of commodity prices have shown an uptrend in last few months, including the crude oil prices that we saw in April. As of now what we have seen in commodity prices, I would expect

RBI last month kept interest rate unchanged for seventh time in a row and said that it remains vigilant towards upside risks to food inflation.

The next meeting of the interest rate setting panel of RBI is scheduled for June 5-7.

Nayar said based on the current growth-inflation dynamics, the chance of change in monetary policy stance in June looks extremely dim.

'We are still waiting for the fourth (January-March) quarter GDP growth estimate which is scheduled to come this month end. Also, how the monsoon kicks off will be part of MPC's tone. Interest rate cut is likely only in second half of the fiscal, maybe in October-December,' Nayar said.

Sebi plans tighter rules for listing of small businesses

Mumbai, May 14: India's markets regulator and exchanges will tighten rules for public offers of small and medium enterprises (SMEs), according to two sources, after complaints of misuse of a separate listing platform introduced in 2012 to enable small businesses access the cap-

ital markets. The regulator, the Securities and Exchange Board of India (Sebi), is considering raising the minimum size of such public offers to 300 million-500 million Indian rupees (\$3.59 million-\$5.99 million), said the two sources who are directly familiar with the discussions.

The new rules are slated to be issued later this year after the regulator and exchanges consult stakeholders, they said. Currently there is no minimum issue size prescribed but companies listing on the platform are required to have a post issue capital base of 250 million rupees

"A minimum offer size will ensure that serious companies are accessing the capital markets and in turn safeguard the interest of investors," said one of the two sources. The sources declined to be identified as they were not authorised to speak to media.

The markets regulator and exchanges, who implement the policies on behalf of the regulator, did not reply to requests for comment

Buoyed by India's surging equity markets, public issues by



SMEs soared in the financial year ending March 2024 to 205 companies raising 60 billion rupees compared to the 125 firms that raised 22 billion rupees in the previous year, according to PRIME Database, a capital markets data provider.

SMEs in India are defined as companies with an annual turnover of 50 million to 2.5 billion rupees. Some of these issues were subscribed 500-1000 times, raising concerns around misuse of the platform, the sources said.

Alongside introducing a minimum issue size, these companies will also be asked to make more disclosures, the sources said.

"The merchant bankers will be asked to make more upfront disclosures of objects of the issue, financials of the issuer and risk factors," said the first source.

Earlier this year, SEBI chairperson Madhabi Puri Buch said some issuers and bankers were misusing the framework provided for SME listing. SEBI is collecting evidence following complaints of price manipulation in the segment, Buch said.

High hopes for athletics in Paris DC keep playoff hopes alive with win over LSG

AFI PRESIDENT **SUMARIWALLA BELIEVES INDIA CAN** WIN TWO ATHLETICS **MEDALS IN 2024 OLYMPICS, INCLUDING ONE FROM NEERAJ**

Bhubaneswar, May 14: India have the potential to surpass the single-medal achievement from the Tokyo Olympics in the track and field events at the Paris Games, Athletics Federation of India (AFI) president Adille Sumariwalla said Tuesday.

At the Tokyo Games, Neeraj Chopra had become the first Indian track and field athlete to win a gold in the Olympics as he clinched the men's javelin event with a throw of 87.58m. He became only the second Indian to win an Olympic individual gold after shooter Abhinav Bindra, who stood on top of the podium during the 2008 Beijing Games.

"We can no doubt perform better in the Paris Olympics than in Tokyo. We can win more medal in Paris," Sumariwalla said in a press conference.

Reigning Olympic and World Champion Chopra is expected to win a medal in Paris. "I had never in the past given any prediction of any event in which we can win a medal. But, if we our athletes performed their best (betters their personal best) in

many events, we can win medals or finish in top four," he said, mentioning men's 4x400m relay, men's long jump and men's 3000m steeplechase, among others.

The AFI president also made it clear that except for Chopra, it will be mandatory for all the other athletes to participate in the National Inter-State Athletics Championships to be held in Panchkula from June 27 to 30 to get selected for the Paris Olympics.

AFI rules state that all the athletes will have to participate in the National Inter-State Championships if they have to get selected for major multisport events like the Olympics, Asian Games or the Commonwealth Games, unless the federation gives an exemp-
