

## CAA: 14 people get citizenship certs

New Delhi, May 15: The first set of citizenship certificates under the Citizenship (Amendment) Act (CAA) was issued Wednesday to 14 people, nearly two months after rules under the contentious law were notified to grant Indian nationality to persecuted non-Muslim migrants from three neighbouring countries.

Union Home Minister Amit Shah termed it a "historic day" saving the decades-long wait of those who faced religious persecution in Pakistan, Bangladesh and Afghanistan is over.

Home Secretary Ajay Kumar Bhalla handed over the certificates to the 14 people after their applications were processed online through a designated portal, an official spokesperson said.

This comes in the midst of the general elections which started April 19. The CAA was enacted in December 2019 for granting Indian nationality to persecuted Hindu, Sikh, Jain, Buddhist, Parsi and Christian migrants from the three countries who came to India on or before December 31, 2014.

### Monsoon to reach Kerala by May 31

NEW DELHI: Southwest Monsoon is likely to arrive over Kerala around May 31, setting the stage for the four-month rainfall season crucial for India's farm-based economy. "This year, the Southwest Monsoon is likely to set over Kerala May 31 with a model error of four days,"

the India Meteorological Department (IMD) said Wednesday. 'This is not early; it's close to the normal date." IMD Director General Mrutyunjay Mohapatra said. The date of monsoon onset over Kerala has varied widely over the last 150 years, the earliest being May 11, 1918, and the most delayed being June 18, 1972, according to the IMD data

the rules under which the Indian citizenship was granted were issued March 11 this year after over a delay of four years.


While granting citizenship certificates, the Home secretary congratulated the 14 applicants and highlighted the salient features of CAA Rules, 2024.

Shah said the Hindu, Sikh, Buddhist, Jain, Parsi and Christian brothers and sisters who fled religious persecution in the three countries have started getting Indian citizenship and PM Narendra Modi has fulfilled the promise made at the time of the country's independence.

The CAA rules envisage the manner of application form, procedure for processing applications by the District Level Committee, scrutiny and grant of citizenship by State Level Empowered Committee.

"In pursuance of these rules, applications have been received from persons belonging to Hindu, Sikh, Jain, Buddhist, Parsi and Christian communities from Pakistan, Bangladesh and Afghanistan who have entered into India up to December 31, 2014 on account of persecution on grounds of religion or fear of such persecution," the spokesper-

son said.

# **SC clicks reject button**

The Supreme Court terming the arrest of NewsClick founder Prabir Purkayastha, accused of receiving huge amount of funds from China "to disrupt the sovereignty of India", 'invalid in the eyes of law' and ordering his release from custody expose the Delhi Police's procedural flaws. Delhi Police, which functions under the Union govt, failed to inform Purkayastha the grounds of his arrest before taking him into custody, prompting the top court to quash the order issued by the Delhi High Court. The bench led by Justice BR Gavai said the right to be informed about the grounds of arrest flows from Article 22(1) of the Constitution and any infringement of this fundamental right would vitiate the process of arrest and remand


If this vital magnetic field disappears, the consequences would be profound. affecting everything from the environment to human health and technology

mans and migratory animals. such as birds and sea turtles, who rely on it to traverse long distances. But the Earth's magnetic field, with a North and South Pole, is not stable. According to BBC Science Focus, the poles are gradually drifting. According to the report quoted

by 'NDTV', till 1990s, the North Pole moved at about 15 km per year. But in years after that, the rate has sped up to 55 km per year towards Siberia.

This movement could lead to a 'magnetic reversal' in which the north and south poles change locations. This has happened 183 times in the past 83 million years, according to NASA. Research done on the Earth's magnetic field based on satellite observations has revealed that the current change is happening due to 'blobs' of unusually intense magnetic fields deep inside the planet. But experts have been unable to explain why the activity has increased.





# **Nabarangpur LS seat** sees highest turnout



Bhubaneswar/Koraput, May **15:** Chief Electoral Officer (CEO) Nikunja Bihari Dhal Wednesday said the voter turnout in the first phase of polling in four Lok Sabha seats and 28 Assembly segments in the state May 13 was 75.68 per cent, with the highest polling of 82.16 per cent being recorded in Nabarangpur LS constituency

The CEO said the voter turnout may further increase after receipt of postal votes.

Dhal said Nabarangpur (82.16 per cent) was followed by Kalahandi (77.90 per cent), Koraput (77.53 per cent) and Berhampur (65.41 per cent).

Lok Sabha and Assembly elections are being held simultaneously in Odisha.

Meanwhile, a report said the tribal tribal-dominated Nabarangpur district with four Assembly segments under the Nabarangpur Lok Sabha seat said the district recorded an impressive voter turnout of over 84.57 per cent, surpassing its previous record of approximately 80 per cent set in 2019.

District Election Officer-cum Collector (Nabarangpur) Kamal Lochan Mishra attributed this high voter turnout to extensive voter awareness campaigns conducted under the Systematic Voters' Education and Electoral Participation (SVEEP) initiative. "Several voter awareness pro-

Bhubaneswar, May 15: A local court here Wednesday awarded life imprisonment to a man after holding him guilty of killing a woman under Nayapalli police limits in the City in 2017.

Additional Sessions Judge Sasmita Parhi also slapped a penalty of ₹20,000 on the convict, Dambarudhar Das. Failure to pay the penalty would entail one year of rigorous imprisonment (RI), Additional Public Prosecutor (APP) Pradipta Kumar Mishra said.

According to the prosecution, Dambarudhar was having a one-



sided love affair with Puspanjali Mohapatra, a resident of Tarini slum under Nayapalli police limits in the City.

"On many occasions, Dambarudhar forced Puspanjali, a mother of two children, to elope with him so as to start a new life. However, she declined,'

Mishra said the incident took place July 7, 2017.

'On fateful day, an infuriated Dambarudhar barged into Puspanjali's house and found her in the washroom and her children playing nearby. After sending the kids to play in the courtyard, Dambarudhar poured petrol on Puspanjali and set her on fire," Mishra said, adding that Dambarudhar managed to flee the scene.

Soon, Puspanjali was rushed to SCB Medical College and Hospital in Cuttack, where she succumbed to burns five days later, Mishra said.

'Super fluffy' planet bigger than Jupiter discovered

esearchers have discovered a 'super fluffy' exoplanet, 50 per cent larger than Jupiter and weighing only a seventh of it, giving it a 'cotton candy'-like density

The new, 'super fluffy' planet has been named 'WASP-193b' and was found to be located about 1,200 light years away from Earth, roughly equivalent to 10,800 trillion kilometres. Exoplanets exist outside the solar system and help us understand a bit more about how the universe works.

"The planet is so light that it's difficult to think of an analogous, solid-state material," said study co-author Julien de Wit, a professor at Massachusetts Institute of Technology (MIT), US. "The reason why it's close to

cotton candy is because both are pretty much air. The planet is basically super fluffy," he said. The international team of researchers said that the exoplanet is the second least dense planet

discovered and its extremely low density makes it a 'real anomaly' among the more than five thousand exoplanets discovered to date.

'This extremely low density cannot be reproduced by standard models of irradiated gas giants, even under the unrealistic assumption of a coreless structure," said Khalid Barkaoui, a postdoctoral researcher at the University of Liège, Belgium, and first author of the study published in the journal Nature Astronomy.

The exoplanet was initially spotted by the Wide Angle Search for Planets (WASP), an international collaboration of aca-

demic institutions. Dips in light or 'periodic transits' had been detected from the star WASP-193 in the data taken between 2006 and 2008, and again from 2011 to 2012.

Astronomers had determined that the star's periodic dips in brightness were consistent with a planet passing in front of it every 6.25 days. They estimated the planet's size by measuring the light from the star it blocked each time it passed in front of it.

In this study, the researchers used data from observatories based in the Atacama Desert, Chile, to measure the planet's weight.

Their calculations revealed an 'extremely low density' for the planet - 0.059 grams per cubic centimetre.

The substance closest in density, according to the researchers - the cotton candy - has a density of about 0.05 grams per cubic centimetre, they said. Water is known to have a density of 1

gram per cubic centimetre.

Providing more context, the researchers said that while Jupiter has a density of about 1.33 grams per cubic centimetre, Earth is a more substantial 5.51 grams per cubic centimetre.

# Arrest not necessary in all GST cases: SC

New Delhi, May 15: The Supreme Court Wednesday told the Centre that there is no need for making arrests in all Goods and Services Tax (GST) cases and that it can be done only if there is credible evidence and tangible material to prove culpability.

A bench of Justices Sanjiv Khanna, MM Sundresh and Bela M Trivedi, which reserved its verdict on a batch of pleas challenging the constitutional validity and interpretation of provisions relating to the Customs Act and Goods and Services Tax Act, said the power of arrest is different from necessity of arrest. The legislation does not say

that for completion of investigation you need to be arrested. It is not the object of the legislation. It is not necessary for you to arrest in each and every case of GST. It has to be based on some credible evidence and tangible material,' the bench told Additional Solicitor General SV Raju

The bench, which posed several questions to Raju on provisions of arrest under the GST law. said the legislation has itself kept liberty on a high pedestal and it should not be diluted.

Raju said arrests are mostly made during the investigation as there can be no arrest after the probe in a case has been completed.

"The arrest is not based on mere suspicion but when there are reasons to believe indicating commission of some grave offence," he said, adding that reasons to believe cannot be on

strict interpretation of commission of offence.

"Adjudication must precede arrest," the bench said, adding that it will examine the question of 'reason to believe' and 'grounds of arrest' under the Customs Act and the GST Act.

The top court said while there were instances of high-handedness by the GST authorities, there were also cases of wrongdoing on the part of tax pavers, and it will take into account all these aspects when giving its decision.

The petitioners who have challenged various provisions of the Customs Act and the GST Act have alleged gross misuse of arrest provisions under both the laws. They have claimed that they are being threatened and coerced to pay liability without following the due procedure under the laws.

Section 69 of the GST Act deals with the powers of arrest, while section 104 of the Customs Act of 1962 allows an officer to arrest someone if they have reason to believe the person has committed an offence.

On May 9, the top court had told the Centre that any arrest under the GST Act should not be

on mere suspicion but based on cogent material and in adherence to proper procedure. It had said the material upon which an arrest is made should

be verifiable by a magistrate. The court had earlier directed the Centre to not use "threat and coercion" during search and seizure operations against traders for recovery of GST and instead persuade them to clear the dues voluntarily.

On May 2, the top court had asked the Centre to furnish details about the issuance of notices and arrests effected under the provisions of the GST Act, saying it may interpret the law and lay down appropriate guidelines to avoid harassment of citizens by depriving them of their liberty.

It voiced concern over the 'ambiguity' in section 69 of the GST Act that deals with the powers of arrest.

The top court had said it would interpret the law to 'strengthen' the concept of liberty.

# Climate change leading to extreme heatwaves

nnu Mishra kept her food stall shut as temperatures in Bhubaneswar remained above 40 degrees Celsius for 17 consecutive days in April. This streak was the longest since 1969, severely impacting health and livelihoods.

"The crippling heat made it extremely difficult to stand near the gas stove," said 51-year-old Mishra, noting that the only time her food stall remained shut for such a long duration was after Cyclone Fani in 2019.

Similar heatwaves could occur once every 30 years and they have already become about 45 times more likely due to climate change, scientists said Wednesday, citing historical weather data. The scientists belonging to the World Weather Attribution (WWA) group emphasised that heatwaves intensified by climate change are making life very tough

The oppressive heat also shattered temperature records in

Philippines, the Bangladesh, Indonesia, Malaysia and Myanmar. In West Asia, including Syria, Lebanon, Israel, Palestine and Jordan, heatwaves with temperatures above 40 degrees Celsius in April have become more frequent due to climate change

As global average temperatures have risen by 1.2 degrees Celsius compared to the cooler pre-industrial climate, scientists predict that West Asia is expected to experience similar heatwaves about once every 10 years. If warming reaches two degrees



Celsius, similar heatwaves will occur about once every five years. Such heatwaves can be deadly for the elderly and kids.

According to World Health Organisation (WHO), more than 1,66,000 people have died as a result of heatwave between 1998 and 2017.

In Bhubaneswar, Mishra suffered losses to the tune ₹20,000 as owners had suffered heat strokes. Experts suggest that the pop-

ulation aged above 65 years and below 15 years needs special attention in terms of preparedness to reduce the impact of extreme heat on health.

"Cities in India need to identify vulnerable populations and prepare heat action plans accordingly," said Vishwas Chitale, Senior Programme Lead at the Council on Energy Environment and Water

The WWA emphasised that some countries, such as India, have comprehensive heat action plans in place. Yet, to protect some of the most vulnerable people, these plans must be expanded with mandatory regulations, such as workplace interventions for all workers to address heat stress, it added, PT

## **Cops bust IPL betting racket**

Rourkela: Four persons were arrested Tuesday evening after police busted a racket involved in online betting during IPL matches in Sundargarh town. It was being operated from a house in Mahadevpada locality under Town police limits. A cybercrime team also helped the cops to track down the culprits. The four arrested were produced in court Wednesday which sent them to judicial custody. ## The Financing Gap

The international development sector has become fixated on calculating financing gaps. Hardly a day goes by without new estimates of the funds low- and middle-income countries (LMICs) need to meet their climate targets and achieve the United Nations Sustainable Development Goals (SDGs).

The Independent High-Level Expert Group on Climate Finance, for example, estimates that developing and emerging economies (excluding China) need \$2.4 trillion annually by 2030 to close the financing gap for investments in mitigation and adaptation. Achieving the SDGs would require an extra \$3.5 trillion per year. Similarly, the UN's 2023 Trade and Development Report suggests that LMICs need roughly \$4 trillion per year to meet their climate and development goals.

Such estimates can elicit a range of psychological and policy responses. Ideally, they would encourage greater ambition and urgency in crafting and implementing policies at both the national and international levels. But they can also be distracting and demoralising, especially given the current shortfalls in climate and development financing. Consequently, a growing number of commentators argue that governments and multilateral lenders alone cannot meet developing countries' financing needs.

At first glance, this argument is difficult to dispute. The vast majority of the world's financial assets, currently valued at roughly \$470 trillion, are privately held. Redirecting just 1 per cent of these resources toward climate and development initiatives would be enough to meet even the highest annual estimates. This math has helped popularise the "billions to trillions" slogan, which calls for governments and development banks to incentivise and mobilise private-sector investment

The World Bank has been a leading proponent of this approach, especially under the leadership of President Ajay Banga, who has spent most of his career in the private sector. The Bank's newfound pri vate-sector-oriented strategy focuses on four key priorities: ensuring regulatory certainty, providing insurance against political risks, mitigating foreign-exchange risks, and implementing an originate-todistribute model, which typically involves securitising loans and selling them to investors

Some of these priorities are not new. The World Bank has long championed regulatory certainty, which often translates into advocating deregulation. Managing political risks has also always been a priority, though success remains notoriously difficult to measure. It is unclear whether the Bank's solution - providing data on sovereign defaults and recovery rates across countries dating back to 1985 - actually leads to effective risk mitigation.

model is puzzling, given securitisation's track record of triggering financial crises in both developed and developing countries. Unsurprisingly, the various Bank funds established to encourage private investment have had a limited impact so far

confined to the World Bank. For starters, this strategy's potential impact on the availability of funds for public spending remains unclear. Then there is the challenge of ensuring that "incentivised" private capital actually delivers the promised results.

It is important to remember that international financial institutions, particularly multilateral development banks (MDBs), have been underperforming for years. A 2023 report by the G20's Independent Expert Group highlights the procyclical behaviour of these institutions, which were originally established to counteract such trends. According to the report, net transfers from the International Monetary Fund to LMICs fell by \$19 billion from 2022 to 2023, while those from the World Bank Group decreased by \$6 billion. Regional development banks also experienced declines. Overall, net resource transfers from MDBs turned negative in 2023, owing partly to a downturn in private financial flows. Simply put, MDBs reduced lending just when it was most needed. If they allocate more resources to mitigating risks for private investors, available funds for essential public services will shrink even further. Historically, private investors have relied on the public sector to finance infrastructure projects and riskier, less profitable ventures. If governments and international institutions remain resourceconstrained, it is highly unlikely that private entities will step in to bridge the gap. The problem is compounded by the difficulty of ensuring that private entities fulfill their commitments. The prevailing approach involves offering incentives, such as subsidies and risk underwriting. but not at the same time establishing clear conditions, enforcement mechanisms, and regulations to curb monopolistic and anticompetitive behaviour. Countries like China have successfully mobilised significant private investment for their energy transitions by wielding carrots and sticks. By contrast, many LMICs and the international financial institutions that advise them have relied heavily on incentives without making any effort to shape markets through effective regulation and controls. It is time to move beyond the hollow "billions to trillions" mindset and ensure that the billions we do have are spent wisely. This requires boosting LMICs' public revenues by facilitating sovereign-debt reductions, enhancing cooperation to ensure that multinational companies and the super-rich are properly taxed, and advancing new allocations of special drawing rights (the IMF's reserve asset). Together, these measures are far more likely to generate the trillions of dollars needed to close development- and climate-financing gaps in the developing world.

ill Delhi Chief Minister Arvind Kejriwal gain electorally with his interim bail? Did Prime Minister Modi take the wrong step with the ill-timed arrest of Arvind Kejriwal? Did the Supreme Court do the right thing in temporarily releasing the Delhi CM? The first two questions will be answered on 4 June 4. when the results of the Lok Sabha elections are out. So, that leaves the third question which is the issue of the SC order granting Kejriwal limited liberty to campaign for his party and poll partners till 1 June, a decision that must be lauded.

This decision of the SC is a proud moment for the country, for the rule of law and above all. for democracy. Here's why: prior to this ruling, the SC had in two watershed judgements, spoken stridently to uphold our most fundamental value, democracy. The first such ruling may not have been nationally consequential when it struck down and removed the illegally elected BJP mayor of Chandigarh and described the process by which he was surreptitiously elected as a "murder of democracy" This utterance by the Chief Justice of India must resonate in the hearts and minds of everyone who values freedom. And the next judgement by the full bench of the SC was to declare the Electoral Bond Scheme unconstitutional, again thereby upholding the democratic principles of our polity, the fundamental right of Indian citizens to receive information vital to the governance of the country. So why should the temporary bail given to Arvind Kejriwal be bracketed with the earlier two rulings. And have the same degree of significance and importance as the earlier two momentous rulings? It's simply because the foundation of the release order is the same, namely in the interest of "fair and free elections," a principle that's inalienable to our liberty.

Vote My Voice' mission for the 2024 Lok Sabha polls, Chief Justice of India DY Chandrachud said: "The Constitution gives us a multitude of rights as citizens but it also expects that each of us performs the duty, which is cast upon us." He has urged citizens not to miss the opportunity to vote in the general elections, saying that it is the "foremost duty" in a constitutional democracy.

We fully endorse his views that one should exercise the right to franchise. However, there is limited option before a voter as elections these days have become a game of money and criminal power. For example, the Association for Democratic Reforms (ADR) and National Election Watch analysed the affidavits of 763 sitting MPs out of 776 seats of Lok Sabha and Rajya Sabha in September 2023. While 306 (40%) MPs have declared criminal cases, around 194 (25%) MPs have declared serious criminal cases, including cases related to murder, attempt to murder, kidnapping, crimes against women et al.

In the first four phases of the 18th Lok Sabha election, out of

Perhaps, one of the most detrimental attacks on the virtues of democracy is the helplessness of governments to control the flood of money in politics. That is why, in the increasingly high stakes world of election campaigning, belligerent and vulgar displays of candidate wealth, from cash handouts to alcohol distribution, to big rallies, are becoming more common and more profligate.

According to The Economist, the 2024 Lok Sabha elections are the most expensive polls not just in India's history but in the world. The estimated expenditure is expected to reach an astounding ₹1.35 lakh crore, more than double the ₹60.000 crore spent in 2019, claimed N Bhaskara Rao,

## Inflation concerns

Sir, This refers to "Wholesale inflation at 13-month high," Orissa POST, May 15. The good news is that retail inflation has marginally eased for the second month in a row to 4.83 per cent in April. The fall was mainly driven by lower fuel prices. The bad news is that food inflation shot up to 8.70 per cent in April. This was pushed by a sharp price rise in a wide spectrum of food items. For the common man, the heaviest burden is the persistent rise in the price of vegetables and pulses at 27.8 per cent and 16.8 per cent, respectively. Food inflation, which hits the poor harder, has been at more than 8 per cent year-on-year since November 2023. The continuing heatwave is expected to hit vegetable supplies further, possibly pushing up prices in May too; and the high prices in cereals and pulses will likely continue till the next crop comes in. Food inflation continues to be a worry. Not only do food items account for almost half the basket that makes up the consumer price index, they also have a direct bearing on the living standards of people.

"It is even more shocking that the biggest scandal of this magnitude is being used for political mileage during elections by political parties and leaders," the letter mentions.

"The statements and counterstatements, caste-based remarks. and gender-insensitive comments by politicians, as well as reports projecting victims as criminals, have shattered societv and peace of mind. This development is demeaning the honour of victims, who are further finding themselves in a difficult position and are hesitant to lodge complaints," the letter observes.

'The families of the victims who have been exposed are subjected to severe mental harassment. Family members and children of those families are unable to find solutions and are under great stress. Reports suggest that three to four victims have attempted suicide," the letter underlines

"In this context, we demand the immediate arrest of Prajwal Revanna and the creation of a fearless atmosphere for lodging complaints. We also urge you, CM, to address the victims and provide them with strength and release video statements," the authors demand.

## Water tanker drivers keep Silicon Valley going

Bangalore, May 15: Basavaraj, a water tanker driver in India's tech hub Bangalore, has to leave home by 6.30am each day to collect enough water for his customers, who now depend on his services for a very basic need.

Residents of the southern city of 14 million people, capital of Karnataka

state and often called India's Silicon Valley, have been reeling due to water shortages amid unusually hot weather. The 22-year-old fills up his tanker at a man-made pool fed by four boreholes in the north of the city, then does rounds of four or five buildings whose residents are his regular customers. The pool's owner Nandish says he can supply fewer tankers now.

Around 40 tankers used to come here every day earlier but now only about 15-20 come as water from the bore wells has also reduced, he said.

Once dotted by lakes and forest cover, Bangalore has lost 79 per cent of its bodies of water and 88 per cent of its green cover over 40 years, while areas covered by concrete have increased 11-fold, according to the Indian Institute of Science.

With summer yet to reach its peak, water tanker dealers began charging some residents almost double the amount per tanker, forcing the state government to cap prices at 1,200 rupees per unit - triggering a brief strike by some water tank providers.

Daisy, 60, lives close to Basavaraj and next to a privately-owned borehole supplying water locally for free. The water is purified for drinking, and the waste water is drained out, but even that liquid is in demand now.

"We had to fight with the owner of the borewell to give us waste water," Daisy said. "We use it to wash dishes and clothes.'

# **'Dream-come-true'** moment for many

New Delhi, May 15: Bharat Kumar's protracted struggle to call India home after escaping religious persecution in Pakistan ended following an 11-year wait as he become one of the 14 people who were granted Indian nationality under the Citizenship (Amendment) Act (CAA) Wednesday.

"It is a great feeling to be an Indian. It has given a new life to me," the 24-year-old told PTI minutes after he received the citizenship certificate from Union Home Secretary Ajay Kumar Bhalla at a special function held here.

Kumar said his family came to India to escape religious persecution in the Sindh province of Pakistan. 'When we came here, I was just

13 years old. We had to leave Pakistan as it was difficult to live there under constant fear," he said about the life of his early years. In Delhi, Kumar's family lived

in the Majnu Ka Tila area and engaged in small-time business. He said a total of five people got Indian citizenship in his locality on Wednesday even though over a hundred had applied for it.

We were told that rest of the applicants will also get the citizenship in due course," he said, adding that getting Indian citizenship is a "dream come true" for him.

## PoK is part of India, we will take it: Shah

Serampore, May 15: Union Home Minister Amit Shah Wednesday referred to protests in Pakistan-occupied Kashmir and said "PoK is part of India and we will take it".

Addressing a rally in Serampore, Shah said while peace has returned to once trouble-torn Kashmir after abrogation of Article 370 in 2019, Pakistan-occupied Kashmir "now echoes with slogans of Azadi and protests.



"After the abrogation of Article 370 by the government in 2019 peace has returned to Kashmir. But now we witness protests in Pakistan-occupied Kashmir. Earlier slogans of Azadi were heard here, now the same slogans are heard in PoK. Earlier stones were pelted here, now stones are pelted in PoK," he said.

Hitting out at Congress lead ers for not supporting the demand of taking over PoK, Shah said, "Congress leaders like Mani Shankar Aiyar say it should not be done as they have an atom bomb. But let me say this Pakistan-occupied Kashmir is part of India and we will take it."

Shah said the present Lok Sabha elections are about "choosing between corrupt leaders of INDI alliance and honest politician Narendra Modi, who despite being Chief Minister and then Prime Minister never had an allegation of single paisa against him.'

"It's a fight between the 'Chinese guarantee' of the INDI

#### Alliance and the concrete promises of Modi Ji. It's a fight between infiltration and the guarantee of citizenship under the CAA. It's a fight between 'Vote for Vikas' and 'Vote for Jihad'! The choice is yours," he said.

Dubbing West Bengal Chief Minister Mamata Banerjee as "Hirak Rani" in an apparent reference to the film "Hirak Rajar Deshe" by Oscar-awarded filmmaker Satyajit Ray, Shah said, "Satyajit Ray was a great artist and filmmaker. He made a movie - Hirak Rajar Deshe. It was quite a famous movie.'

"But when Mamata ji came to power, Satyajit Ray was not there, otherwise, he would have made a movie named 'Hirak Rani', instead of 'Hirak Rajar Deshe'. Mamata Banerjee is the Hirak Rani," he said.

"Bengal is the land which gave us Vande Mataram and the national anthem Jana Gana Mana and played a key role in Bengal's freedom struggle. Both the communists and the TMC tried to end nationalism and patriotism in Bengal," he said. Hitting out at the TMC over various scams, Shah said,"No one will be spared even if Mamata Banerjee tries to protect them.

Shah slammed Banerjee for opposing the CAA and "taking out rallies in support of infiltrators" to appease her vote bank.

"Mamata Banerjee is spreading lies and canards about CAA. Why is she against refugees obtaining citizenship? She is supporting infiltration in Bengal but opposes Hindu refugees getting citizenship. She is taking of supporting infiltrators and Mullahs," he said.

**ED nabs Jharkhand**

Ranchi. May 15: The **Enforcement Directorate** Wednesday arrested Congress leader and Jharkhand Rural Development Minister Alamgir Alam in a money laundering case. official sources said.

The 70-year-old was taken into custody at the agency's zonal office here under the provisions of the Prevention of Money Laundering Act (PMLA) after about six hours of interroga tion on the second day of questioning, the sources said.

He was grilled by the federal agency Tuesday for over nine hours and his statement was also recorded.

The agency had last week arrested Alam's personal secretary and state administrative service officer Sanjeev Kumar Lal (52) and the latter's domestic help Jahangir Alam (42) following the seizure of more than ₹32 crore cash from a flat linked to them.

The money laundering investigation pertains to alleged irregularities and payment of "bribes" in the state rural development department.

While seeking the remand of the two arrested persons, the ED had informed a special PMLA court here that Lal collected "commission" on behalf of some influential people and that government officials from "top to bottom" in the rural department are involved in the alleged ille-

gal cash payments nexus. The total seizure of cash by the ED in this case has been recorded at around ₹36.75 crore as the agency seized about ₹3 crore from other locations including ₹10.05 lakh from Lal's place and ₹1.5 crore from a contractor's place.

## Sisodia's judicial custody extended

New Delhi: A Delhi court Wednesday extended the judicial custody of AAP leader and former deputy chief minister Manish Sisodia till May 30 in a corruption case related to an alleged excise scam. Special judge for CBI and ED Kaveri Baweja also fixed May 30 for further arguments on framing of charges in the case. The judge noted that an application for postponement of arguments on the charge is pending before the high court. Sisodia and other accused persons in custody were produced before the court through videoconferencing from prison. The court had on April 30 dismissed the bail pleas of Sisodia in corruption and money laundering cases, lodged by the CBI and the ED in relation to the alleged scam. The court had reserved the order after hearing arguments from the CBI and ED as well as the counse appearing for Sisodia.

Hyderabad, May 15: New Zealand's food safety regulator Wednesday said it is investigating possible contamination in spice products of top Indian brands MDH and Everest after they faced scrutiny in other countries

The United States and Australia have been looking into contamination after Hong Kong last month suspended sales of three spice blends of MDH and one of Everest, saying they contained high levels of a cancercausing pesticide, ethylene oxide. Singapore ordered a recall of the Everest spice mix.

"Ethylene oxide is a chemical known to cause cancer in humans, and its use for food sterilisation has been phased out in New Zealand and other countries. As MDH and Everest spices are also available in New Zealand, we are looking into this issue," said Jenny Bishop, the regulator's acting deputy director general.

The bench said the duration of pregnancy was over seven months now. "What about the right of the child to survive? How do you address that?" the bench asked. The counsel said the foetus is in the womb and till the child is delivered, it is the right of the mother. "The petitioner at this stage is under severe traumatic condition. She can't come outside also. She is taking classes for NEET exam. She is under highly traumatic condition. She can't face the society at this stage,' he said. The lawyer argued that her mental and physical well-being should be considered. "Sorry," the bench said. In its May 3 order, the high court had noted that on April 25, the court had directed the All India Institute of Medical Sciences (AIIMS) to constitute a medical board to ascertain the condition of the foetus and the petitioner.

New Delhi: Slamming the Uttarakhand government for its "lackadaisical" approach in controlling forest fires, the Supreme Court Wednesday directed the state's chief secretary to personally present himself before it May 17 to give explanation, including on utilisation of funds and vacancies in forest department. Terming it a "very sorry state of affairs", the apex court said the state was just trying to find some excuse or the other. A bench headed by Justice B R Gavai directed that

the staff and vehicles of the forest departments of states shall not be requisitioned for election purposes or any other purposes like the 'Char Dham Yatra'. "We are at pains to say that the approach of state of Uttarakhand in controlling the fires is, to say the least, lackadaisical. Though action plans

have been prepared and finalised, no steps are being taken for implementation of the same," said the bench, also comprising Justices SVN Bhatti and Sandeep Mehta. The top court was hearing a plea on raging forest fires in Uttarakhand. The bench said when funds from the Compensatory Afforestation Fund Management and Planning Authority (CAMPA) were available and also sanctioned by the central authority, it saw no reason as to why only ₹3.41 crore out of the ₹9.12 crore was utilised for forest related activity in Uttarakhand in 2023-24. The bench observed it also saw no reason as to why the balance amount was not utilised for forestry. "Another issue that needs to be addressed is with regard to huge vacancies in the forest department of the State of Uttarakhand," it said.


New Delhi, May 15: More than 1.53 lakh deaths a year were associated with heatwaves around the world, with over a fifth of these deaths - the greatest share - coming from India, according to new research looking at data over 30 years since 1990.

India was followed by China and Russia, with each experiencing roughly 14 per cent and and more than 30 per cent from Europe.

Further, the largest estimated death rates (deaths per population) were seen in regions with dry climates and lower-middle incomes. The findings are published in PLoS Medicine.

"During the warm seasons from 1990 to 2019, heatwave-related excess deaths accounted for 1.53.078 deaths per year, a total of 236 deaths per ten million residents or 1 per cent of global deaths," the authors wrote.

For the study, the researchers used data from the UK-based Multi-Country Multi-City (MCC) Collaborative Research Network that included daily deaths and



13.4 to 13.7 days on average around the world, with average ambient temperature warming by 0.35 degrees Celsius every decade.

The researchers said that while previous studies have quantified excess deaths due to heatwaves locally, they have not compared these estimates across the globe over a prolonged duration.

"Heatwayes are associated with substantial mortality burden that varies spatiotemporally (with space and time) over the globe in the past 30 years," the authors wrote.

The findings show that government actions taken to enhance health sector adaptation

and resilience can have potential benefits, the authors said.

They called for a "comprehensive approach" tackling not only immediate health risks during heatwaves but also implementing long-term strategies to minimise vulnerability and inequalities across communities.

'The strategies include climate change mitigation policy, heat action plans (e.g., heat early warning system), urban planning and green structure, social support program, healthcare and public health services, education awareness, and community engagement and-participation," the authors wrote.



Jerusalem, May 15: Palestinians across the Middle East Wednesday are marking the anniversary of their mass expulsion from what is now Israel with protests and other events across the region at a time of mounting concern over the humanitarian catastrophe in Gaza

The Nakba, Arabic for "catastrophe," refers to the 7,00,000 Palestinians who fled or were driven out of what today is Israel before and during the war surrounding its creation in 1948.

More than twice that number have been displaced within Gaza since the start of the latest war, which was triggered by

Hamas' October 7 attack into Israel.

UN agencies say 550,000 people, nearly a quarter of Gaza's 2.3 million people, have been newly displaced in just the last week, as Israeli forces have pushed into the southern city of Rafah, along the border with Egypt, and reinvaded parts of north-

ern Gaza. 'We lived through the Nakba not just once, but several times, said Umm Shadi Sheikh Khalil, who was displaced from Gaza City and now lives in a tent in the central Gaza town of Deir al-Balah.

The refugees and their descendants number some 6 million and live in built-up refugee camps in Lebanon, Syria, Jordan and the Israeli-occupied West Bank. In Gaza, they are the majority of the population, with most families having relocated from what is now central and southern Israel.

Israel rejects what the Palestinians say is their right



of return because if it was fully implemented, it would likely result in a Palestinian majority within Israel's borders.

**MORE CATASTROPHE LOOMS IN GAZA** 

The refugee camps in Gaza have seen some of the heaviest fighting of the war. In other camps across the region, the fighting has revived painful memories from earlier rounds of violence in a decades-old conflict with no end in sight.

#### NO END TO WAR

The latest war began with Hamas' rampage across southern Israel, through some of the same areas where Palestinians fled from their villages 75 years earlier. Palestinian militants killed some 1,200 people that day, mostly civilians, and took another 250 hostage.

Israel responded with one of the heaviest military onslaughts

in recent history, obliterating entire neighbourhoods in Gaza and forcing some 80 per cent of the population to flee their homes. Gaza's Health Ministry says

over 35.000 Palestinians have been killed, without distinguishing between civilians and combatants in its count. The UN says there is widespread hunger and that northern Gaza is in a 'full-blown famine.

Israel says its goal is to dismantle Hamas and return the estimated 100 hostages, and the remains of more than 30 others, still held by the group after it released most of the rest during a cease-fire last year.

Israeli troops pushed into Rafah last week. Prime Minister Benjamin Netanyahu has portrayed the city on Gaza's southern border with Egypt as Hamas' last stronghold, promising victory.

But the militants have regrouped elsewhere in Gaza, even in some of the hardest-hit areas, raising the prospect of a prolonged insurgency.

Singapore, May 15: Economist Lawrence Wong was Wednesday sworn in as Singapore's fourth prime minister in a planned political transition for the island state.

Wong, 51, succeeded Lee Hsien Loong, 72, who relinquished his position after two decades; both belong to the ruling People's Action Party (PAP) that has been driving Singapore's economic progress for more than five decades.

Wong, who was the deputy prime minister, will be leading the fourth generation PAP politicians' government as the Prime Minister and the Finance Minister.

President Tharman Shanmugaratnam, 67, administered the oath to Wong, described by the local media as a low-key leadership transition.

Wong cited continuity, stability and the need to avoid disruptions as reasons for not making major changes at the minister (cabinet) level.

"With all other ministers holding on to their portfolios across the leadership transition from Lee Hsien Loong's government to Wong's, it also testifies to the consistency in Wong's decisionmaking," a Channel News Asia report said.

Among Indian PAP parliamentarians, Murali Pillai, 56, has been promoted as minister of state in the Ministry of Law and the Ministry of Transport. Pillai, a lawyer, will be sworn in July 1, 2024.

The other Indian origin ministers in the cabinet - Dr Vivian Balakrishnan, 63, remains the Foreign Minister; K Shanmugam, 65, as Minister of Law and Home Affairs, and Indranee Rajah, 61, as Minister in the Prime Minister's Office.

Handlova, May 15: Slovak Prime Minister Robert Fico suffered life-threatening injuries when he was shot and wounded in an attempted assassination Wednesday, the government office said.

Fico, 59, was rushed to hospital in the central city of Handlova after holding a government meeting there, and was being transported by helicopter to the city of Banska Bystrica for urgent treatment, it said.

A Reuters witness heard several shots fired after the meeting in Handlova northeast of the capital Bratislava. Police detained a man and security officials pushed someone into a car and drove off, the witness said.

"An assassination (attempt) on Prime Minister Robert Fico was carried out today at the government's off-site meeting in Handlova." the government office said in a statement.

K Eshwaran, 26, pleaded guilty to 10 charges under the Computer Misuse Act. Another 21 charges were considered for sentencing, Channel News Asia reported. From 2019 to 2023, he sent phishing links to 22 victims to get login credentials for their social media, cloud server and email accounts.

**PROJECTIONS CONSISTENTLY SHOW THAT** LOW-LYING BANGKOK RISKS BEING INUNDATED BY THE OCEAN BEFORE THE END OF THE CENTURY

Bangkok, May 15: Thailand may have to consider relocating its capital Bangkok because of rising sea levels, a senior official in the country's climate change office told AFP Wednesday.

Projections consistently show that low-lying Bangkok risks being inundated by the ocean before the end of the century.

Much of the bustling capital already battles flooding during the rainy season.

Pavich Kesavawong, deputy director-general of the government's department of climate change and environment, warned that the city might not be able to adapt with the world on its current warming pathway.

"I think we are beyond the 1.5 (degrees Celsius) already," he told AFP, referring to the increase in global temperatures from pre-industrial levels. "Now we have to come back and think about adaptation. I imagine Bangkok will be under water already, if we stay in our (current) circumstance.

Bangkok's city government is exploring measures that include building dikes, along the lines of those used in the Netherlands, he said.

But "we've been thinking about moving", Pavich said, noting that the discussions were still hypothetical and the issue was "very complex"

"Personally I think it's a good choice, so we can separate the capital, the government areas,



and business areas," he said. "Bangkok (would) still be the government capital, but move the business.

Climate impacts

While a move is still a long way from being adopted as policy, it would not be unprecedented in the region.

of sectors, from farmers struggling with heat and drought to tourism businesses affected by coral bleaching and pollution.

It has closed several national parks in response to recent coral bleaching and Pavich said further closures were possible.

However, Pavich acknowledged that government efforts to tackle the growing problem of air pollution, particularly in Thailand's north, had yet to bear fruit.

Legislation focused on clean air passed this year and Pavich

said national parks officials had stepped up efforts to prevent and put out fires in protected areas.

"The agriculture sector is very challenging for us," he said, referring to continued post-harvest burning that is a major contributor to seasonal haze. An improvement is not likely for several years.

More immediately, his department -- part of the Ministry of Natural Resources and Environment -- is pushing Thailand's first climate change legislation, which has been in the works since at least 2019 but was shelved during the Covid-19 pandemic.

Pavich said the legislation, which includes provisions on everything from carbon pricing to mitigation and adaptation measures, is likely to pass into law this year.

# **Trade deficit at 4-month high of \$19.1bn**

New Delhi, May 15: India's merchandise exports rose by 1 per cent to USD 34.99 billion in April even as the trade deficit widened to a four-month high of USD 19.1 billion during the month, according to government data.

Healthy growth in sectors such as electronics, chemicals, petroleum products and pharmaceuticals has helped register growth in exports despite global economic uncertainties

Imports also increased by 10.25 per cent to USD 54.09 billion in the month under review from USD 49.06 billion in April 2023 due to a significant jump in gold imports.Imports of precious metals more than doubled to USD 3.11 billion in April this year. Crude oil imports rose 20.22 per cent to USD 16.5 billion.

Trade deficit, or the gap between imports and exports, in April 2023 stood at USD 14.44 billion. The previous high in the deficit was recorded in December 2023 at USD 19.8 billion.

In March 2024, the outbound shipments dipped to USD 41.68 billion from USD 41.96 billion a year ago.

Briefing media on the data, **Commerce Secretary Sunil** Barthwal said the figures show that the new fiscal year started on a good note and hoped that it would continue.

He said that the data for the country's total exports in goods and services for 2023-24 has been revised to USD 778.21 billion,

which is the "highest" so far. Merchandise exports in the last fiscal aggregated at USD 437.1 billion, while services exports stood

at USD 341.1 billion. In merchandise exports, 13 of the 30 key sectors exhibited growth in April 2024 as compared to the same period last year. These include coffee, tobacco, spices, plastic and

handicraft. According to the commerce ministry data, released Wednesday, the estimated value of services exports for April is USD 29.57 billion compared to USD 25.78 billion in April 2023. Imports of services are estimated to be increased to USD

16.97 billion during the month as compared to USD 13.96 billion in April 2023.

Commenting on the data, Federation of Indian Export Organisations (FIEO) President Ashwani Kumar said the ongoing Russia-Ukraine war coupled with various major geopolitical tensions including the Red Sea crisis and Israel-Hamas conflict has made the international trade scenario much tougher for Indian exporters.

"We hope that exports will start showing better growth numbers with improved demand in the European Union, UK, West Asia and the US, which has given boost to the order bookings by over 10 per cent," Kumar said. He added that the need of the hour is to take steps on the liquidity front with deeper interest subvention support and continuation of interest equalisation scheme

Sanjeev Agrawal, President, PHD Chamber of Commerce and Industry, said India's exports increased significantly despite geopolitical headwinds.

'Further, recently India signed a monumental Long-Term Contract for the development of Shahid Beheshti Port Terminal, Chabahar. 

# Coal's share in power generation capacity drops below 50%

New Delhi, May 15: The share of coal in India's total power generation capacity dipped below 50 percent in the first quarter of 2024, the first time since the

1960s The latest POWERup quarterly report from the Institute for **Energy Economics and Financial** Analysis (IEEFA) showed that renewable energy accounted for 71.5 percent of the record 13,669 megawatts (MW) power generation capacity added by India

in the first quarter (January-March) of this year. Coal's share, including lignite, in India's total power generation capacity dropped below 50 percent for the first time since

the 1960s. The report noted that the renewable energy trend is well ahead of India's target of achieving 50 percent cumulative power generation capacity from non-fossil fuel-based sources by 2030.

The decline in coal's share of power generation capacity mirrors a global trend, with demand for coal in G7 countries hitting record lows in 2023, levels not seen since 1900.

To accelerate the transition, G7 countries pledged last month to phase out all unabated coal power generation by 2035, building on their commitment to halt all construction of new coal-fired power plants. The term 'unabated' gener-

ally refers to the continued use of coal, oil, and gas without efforts to curtail emissions.

At the United Nations' COP28 climate change conference in December last year, world leaders reached a historic agreement to transition away from planet-warming fossil fuels and triple the global renewable energy capacity by 2030.

According to the report, a record 69 gigawatts (GW) of renewable energy tenders were issued in India in the fiscal year



(FY) 2023-24, surpassing the central government's target of 50 GW per year.

"After a downturn from 2019 to 2022 due to supply-chain issues and global price spikes brought on by the COVID-19 pandemic and Russia's invasion of Ukraine, the market has rebounded and gone from strength to strength,' Vibhuti Garg, Director - South Asia, IEEFA, said.

India has risen to third place in the world's solar power generation rankings, trailing only China and the US, according to Ember's fifth annual Global Electricity Review of 80 countries.

Ranked ninth in 2015, India has now overtaken Japan, which, along with fellow G7 member Germany, has a persistently high demand for coal.

Solar power generated a record 5.5 percent of global electricity in 2023, with India generating 5.8 percent of its electricity from solar last year.

Solar remained the world's fastest-growing electricity source for the 19th consecutive year in 2023, adding more than twice as much new electricity worldwide as coal.

India witnessed the world's fourth-largest increase in solar generation in 2023 (+18 terawatt hour or TWh), behind China (+156 TWh), the United States (+33 TWh), and Brazil (+22 TWh). Together, the top four solar growth countries accounted for

75 percent of growth in 2023.

Solar's contribution to electricity generation in India surged from 0.5 percent in 2015 to 5.8 percent in 2023.

According to the International Energy Agency's (IEA) 'Net Zero Emissions' scenario, solar would make up 22 percent of global electricity generation by 2030.

Given that electricity generation accounts for nearly half of India's annual carbon dioxide emissions (1.18 gigatonnes in 2023), accelerating the transition to cleaner generation sources is crucial for the country to meet both its developmental and climate goals. The IEA says tripling global renewable energy capacity and doubling energy efficiency are essential to limit the average temperature rise to 1.5 degrees Celsius, a political target set in 2015 to prevent further worsening of climate impacts.

India is among the few countries aiming to triple renewable capacity by 2030.

# Neeraj strikes gold at Kalinga

Bhubaneswar, May 15: Olympic champion Neeraj Chopra won the gold medal in men's javelin throw event of the Federation Cup here, his spear shimmering through the balmy Wednesday evening sky after an unusually slow start in his first competitive outing on Indian soil in three vears

Having arrived in the city on the eve of his competition after finishing second in the Doha Diamond League, the 26-yearold superstar did not set the stage ablaze and was placed second after three rounds.

Chopra, however, took the lead in the fourth round with an effort of 82.27m and did not take the last two throws (fifth and sixth) as he was leading after DP Manu, who settled for silver, had finished his final round throw

Chopra was representing Haryana. Manu of Karnataka came second with 82.06m effort, while Uttam Balasaheb Patil of Maharashtra was third with 78.39m.

Local man and Asian Games silver medallist Kishore Jena finished fifth with a disappointing 75.49m. Jena had qualified for the Paris Olympics when he threw 87.54m for the Asian Games silver medal in Hangzhou, China last year.

Meanwhile, SS Sneha of Karnataka became the fastest woman of the meet, winning the 100m gold with a time of 11.63 seconds. Giridhrani Ravi of Tamil Nadu (11.67) and Srabani Nanda (11.76) of Odisha were second and third respectively.

Gurindervir Singh of Punjab took the 100m dash gold with a time of 10.35 seconds. Odisha's Animesh Kujur, who won 200m
