Reiterating its stand on an ageold judicial maxim that likens delayed justice to a denial of the same, which has been ascribed in many judicial pronouncements in the past, the Supreme Court Friday took strong exceptions to the Delhi High Court sitting over the bail application of a petitioner for almost 11 months. The top court observed that every single day counts in matters of citizens' liberty. The top court had in another ruling in February described Article 21, which deals with the protection of life and personal liberty, as 'the soul of the Constitution' and observed that the liberty of a citizen is of paramount importance

New Delhi, May 17: Every single day counts in matters concerning the liberty of citizens, the Supreme Court said Friday while asking the Delhi High Court to decide on the regular bail plea of a businessman in a corruption case related to the now scrapped Delhi excise policy.

The petitioner's regular bail application has been heard by the High Court on 40 occasions and



now the matter has been adjourned to July 8, a bench of Justices BR Gavai and Sandeep Mehta was told by senior advocate Kapil Sibal, appearing for businessman Amandeep Singh Dhall. "This cannot be that after 40 hearings, you don't decide the regular bail," he said.

The bench noted it has been informed that his regular bail plea was filed in July last year.

"In matters concerning the liberty of citizens, every single day counts. Keeping the matter of regular bail pending after almost 11 months deprives the petitioner of his liberty," the bench said. "We request the high court to decide the bail application

prior to the closure for summer vacations," it said.

Summer vacations in the high court start from June 3. May 31 will be the last working day.

Dhall is an accused in separate cases linked to the excise policy which are being probed by the Central Bureau of Investigation (CBI) and the Enforcement Directorate (ED). The ED's money laundering case stems from a CBI FIR. A trial court had earlier dismissed Dhall's regular bail plea in a corruption case lodged by the CBI.

According to the probe agencies, Dhall allegedly conspired with other accused and was 'actively' involved in the formulation of the liquor policy and facilitating kickbacks to the Aam Aadmi Party (AAP) and its recoupment by the 'South Group' through various means.

According to the CBI and the ED, irregularities were committed while modifying the excise policy and undue favours extended to licence holders.

The Delhi government implemented the policy November 17, 2021 and scrapped it at the end of September 2022 amid allegations of corruption.

SIT to probe BJP worker's death

Bhubaneswar, May 17: The Odisha Police Friday constituted a special investigation team (SIT) to probe into the killing of a BJP worker in a clash between supporters of the ruling BJD and the saffron party in Ganjam

The SIT, headed by ADG R K Sharma, will submit the chargesheet within 30 days, officials said. Nine people have been arrested in connection with the death of the BJP worker, the police said.

The deceased, Dilip Kumar Pahana (28), was killed and seven BJP supporters were injured in the clash at Sri Krushna Saranapur village in the district Wednesday.

According to preliminary investigation, the clash occurred over putting up posters of a candidate and both sides used sharpedged weapons in the fight, police had said. Simultaneous Lok Sabha and Assembly elections are underway in Odisha.

Abusive language not 'Odisha to turn saffron' appreciated: Naveen

Bhubaneswar, May 17: Chief Minister Naveen Patnaik Friday denounced the campaign speeches by his counterparts from other states and Union ministers terming them as 'derogatory and abusive', and claimed that those 'political tourists' have no impact on people of his state.

In the last few days, a number of BJP CMs and Union ministers campaigned in the state, and altogether 14 rallies were addressed by them Friday at various places across the state

"Some Chief Ministers and Union ministers come as political tourists only at the time of elections and then they disappear," Patnaik told PTI Videos.

The ruling Biju Janata Dal (BJD) chief claimed that the speeches of those political leaders and ministers have no effect on the people of Odisha at all. "And it's most unfortunate



that many of them use derogatory and abusive language. I never believe in doing that and the people in our state don't appreciate such language,' Patnaik asserted.

During the last few days, Assam Chief Minister Himanta Biswa Sarma, Chhattisgarh CM Vishnu Deo Sai, Rajasthan Chief Minister Bhajan Lal Sharma, former Tripura CM Biplab Kumar Deb and at least eight Union ministers along with several senior BJP leaders have campaigned in Odisha, where Assembly and Lok Sabha polls are taking place together.

Rourkela, May 17: Union Home Minister Amit Shah Friday predicted a saffron surge in Odisha, claiming that the BJP will win over 75 Assembly and 15 Lok Sabha seats.

In response to Congress president Mallikarjun Kharge's assertion at an election rally that the BJP was struggling to reach 200 seats, Shah countered by saying that Prime Minister Narendra Modi had already secured 270 Lok Sabha seats in the first four phases of elections and was now aiming for 400.

Addressing a rally, Shah said, "With more than 15 MPs and 75 MLAs, Odisha is set to become saffron. This election is to make Narendra Modi the PM for the third time."

Shah also criticised the BJD government, accusing it of insulting Odisha's 'asmita' (pride)

Emphasising the significance of Lord Jagannath to the people of Odisha, Shah promised that a BJP government would open



all the four gates of the Puri temple for devotees.

He also raised concerns about the missing keys of Srimandir's 'Ratna Bhandar' (treasure chest) and promised to make the judicial commission report public within a month of coming to

power.
"Why is the Patnaik government sitting on the judicial commission report. After coming to power, BJP government will publish the report within a month," he said.

"Crores of Jagannath devotees want to know about the original key of Ratna Bhandar, which has been missing for years. Why was the duplicate key made,' Shah asked.

Butter chicken battle heats up with new court evidence

New Delhi, May 17: With new photographic and video evidence, an Indian court battle over the origins of the world famous butter chicken is set to get spicier.

Two Indian restaurant chains have been sparring since January at the Delhi High Court, both claiming credit for inventing the dish in a lawsuit that has grabbed the attention of social media users, food critics, editorials and

TV channels across the globe. The popular Moti Mahal restaurant chain said it had the sole right to be recognised as the inventor of the curry and demanded its rival, the Daryaganj chain, to stop claiming credit and pay \$240,000 in damages. Moti Mahal said founder Kundan Lal Gujral created the cream-loaded dish in the 1930s at an eatery in Peshawar, now in Pakistan, before relocating to Delhi. That "story of invention of butter chicken does not ring true" and is aimed at misleading the court, Daryaganj said in a new, 642-page counterfiling reviewed by Reuters. Daryaganj says a late member

of its founding family, Kundan Lal Jaggi, created the disputed dish when he helmed the kitchen at the relocated Delhi eatery, where Guiral, his friend-cum-partner from Peshawar only handled marketing. Both men are dead,

Butter chicken is ranked 43rd in a list of world's 'best dishes' by TasteAtlas, and bragging rights about who invented

it can matter, brand experts said. "Being an inventor has a huge advantage globally and in terms of consumer appeal. You are also entitled to charge more,' said Dilip Cherian, an image guru and co-founder of Indian PR firm Perfect Relations.

Moti Mahal operates a franchisee model with over 100 outlets globally. Its butter chicken dishes start at \$8 in New Delhi, and are priced at \$23 in New York. Late US President Richard Nixon and India's first Prime Minister Jawaharlal Nehru are among the famous clients to have visited its primary outlet in Delhi.

Daryaganj started in 2019 and its butter chicken costs \$7.50. It has 10 outlets, mostly in New-Delhi, with plans to expand to other Indian cities and Bangkok.







New Delhi, May 17: The Supreme Court Friday sought the Centre's stand on a petition challenging the marital rape exception under the new criminal

A bench, headed by Chief Justice DY Chandrachud, issued notice on the petition by the All India Democratic Women's Association (AIDWA) and said it would be listed for hearing in July along with other petitions seeking to criminalise marital

"It is a constitutional issue. This will be live even after the new code," the bench, also comprising Justice JB Pardiwala and Justice Manoi Misra, said

The SC had January 16, 2023 sought the Centre's response on certain petitions assailing the Indian Penal Code (IPC) provision which provides protection to a husband against prosecution for forcible sexual intercourse if the wife is an adult

Under the exception given in Section 375 of the IPC, sexual intercourse or sexual acts by a man with his wife - the wife not being a minor - is not rape.

Even under the new law Bharatiya Nyaya Sanhita (BNS), exception 2 to Section 63 (rape) has clarified that 'sexual intercourse or sexual acts by a man with his wife, the wife not being under eighteen years of age, is

status, are manifestly arbitrary. There is no determining principle to justify the select deprivation of married women of a legal right to complain of the commission of the offence under Section 63 of the BNS by her husband," the petition said.

It further stated that the protection of the 'institution' of marriage as the 'objective' to sustain the exception is wholly unjust and unfair.

The petition also stated that the marital rape exception is against Article 19(1)(a) and Article 21 of the Constitution because it takes away a married women's rights to bodily integrity, decisional autonomy, and dignity.

One of pending pleas in the Supreme Court has been filed in relation to the Delhi High Court's split verdict of May 11, 2022 on the issue. This appeal has been filed by a woman, one of the petitioners before the Delhi HC.

However, two HC judges --Justice Rajiv Shakdher and Justice C Hari Shankar -- had concurred on granting a certificate of leave to appeal in the Supreme Court as the matter involved substantial questions of law which required a decision from the top court.

AIDWA was also one of the petitioners before the HC.

While Justice Shakdher, who headed the division bench, favoured striking down the marital rape exception for being 'unconstitutional' and said it would be 'tragic if a married woman's call for justice is not heard even after 162 years' since the enactment of the IPC, Justice Shankar said the exception under the rape law is not 'unconstitutional and was based on an intelligible differentia'.

Another plea has been filed by a man against the Karnataka HC verdict which had paved the way for his prosecution for allegedly raping his wife.

When contacted, Mohapatra called the party's decision to expel him as 'ridiculous'.

The veteran political leader said that over the last five years, he has dissociated himself from party activities and has not attended any party meetings or functions. Mohapatra was also not seen with any senior party leaders during this period.

Mohapatra held the Patkura Assembly seat for four times.

Keonjhar, May 17: Three days after the mutilated body of an Assistant Block Development Officer (ABDO) was found close to the railway tracks near Harichandanpur railway station in Keonjhar district Monday, the body of a Junior Engineer (JE) was recovered from the farmlands near Banachakulia village, under Ghatagaon police station limits of the district, late Thursday.

Police said the deceased, Chandrahasya Naik, a native of Sukurli village of Mayurbhanj district, worked as a JE in Saharpada block of Keonjhar district. Police sources said that Chandrahasva was last seen travelling on a motorcycle with three others to Banachakulia village, Wednesday. While the other three riders were traced to a hospital, Chandrahasya's body was found in a farmland surrounded by forests Thursday

worked as a JE in Saharpada block of Keonihar district hey said Naik was last seen travelling with three others on a bike to Banachakulia village

On being informed, police reached the spot with a scientific team and began an investigation after recovering the body.

Wednesday

Police said the trio who accompanied the deceased on the bike had been hospitalized after they met with an accident. They allegedly told the police that since one of them got drunk it was difficult for all the four to return on the bike together. Therefore, three of them first came back on the vehicle, leaving the JE in that village. They had plans to pick him up in the second trip. However, while returning, they met with an acci-

dent and got themselves admitted to the hospital for treatment.

Meanwhile, Sub Divisional Police Officer (SDPO) Prabhat Kumar Tripathy said, "No external injury mark was found on the deceased's body. We are waiting for the post mortem report to know the cause of death. Meanwhile, we are questioning the trio who accompanied the deceased. We will get a clear picture soon.

Lifespan to grow by 5 yrs in men, 4 yrs in women by 2050

A Lancet study has projected that in India, men could have an average life expectancy of over 75 years, while that of women could be almost 80 years by the middle of this century

ife expectancy around the world is projected to improve by almost five years in men and by over four years in women between 2022 and 2050, according to a global study published in The Lancet journal.

Researchers said that the improvements are expected to be the highest in countries where life expectancy is lower, thereby contributing to an overall enhancement of life expectancy across geographies.

Public health measures preventing and improving survival rates from cardiovascular diseases, COVID-19, and a range of communicable, maternal, neonatal, and nutritional diseases, are largely driving the trend of increasing life expectancy globally, the authors said.

"In addition to an increase in life expectancy overall, we have found that the disparity in life expectancy across geographies will lessen," said Chris Murray, director of the Institute for Health Metrics and Evaluation (IHME), University of Washington, US.

"This is an indicator that while health inequalities between the



highest and lowest income regions will remain, the gaps are shrinking, with the biggest increases anticipated in Sub-Saharan Africa," said Murray. The IHME coordinates the Global Burden of Disease (GBD) study, the "largest and most compre-

loss across places and over time.' However, the researchers from the GBD 2021 Forecasting Collaborators said that the ongoing shift in disease burden to non-communicable diseases such as cardiovascular ones, cancer

hensive effort to quantify health

and diabetes, and exposure to associated risk factors including obesity and high blood pressure, will have the most impact on the next generation.

This shift was analysed to increase an individual's years lived with disability or YLDs. Disease burden is the impact of a health problem on a given population, measured through varied indicators such as deaths, disabil-

ity, or financial costs. Therefore, as the disease burden shifts from that of communicable ones to non-communicable health problems, people are expected to live longer, but with more years spent in poor health, the researchers said.

They said that healthy life expectancy around the world, referring to the number of years one could expect to live in good health, will increase by 2.6 years in the coming years - from 64.8 years in 2022 to 67.4 years in

For India, the study has projected that by 2050, on average, men could have a life expectancy of over 75 years, while that for women could be almost 80 years.

Healthy life expectancy, however, was projected to be over 65 years for both men and women

in India. Drawing on the work of more than 11,000 collaborators, the GBD 2021 includes more than 607 billion estimates of 371 diseases and injuries and 88 risk factors in 204 countries and territories, ac-

cording to the IHME.

EC's response sought on turnout data plea

New Delhi, May 17: Holding an urgent hearing at 6:30pm Friday evening, the Supreme Court sought a response within a week from the Election Commission on a plea by an NGO seeking a direction to upload polling station-wise voter turnout data on its website within 48 hours of conclusion of polling for each phase of the Lok Sabha elections.

The top court, which was urged earlier in the day by lawyer Prashant Bhushan that the plea be heard today itself, assembled in the evening after the conclusion of an SCBA function to bid farewell to Justice AS Bopanna.

Chief Justice D Y Chandrachud termed the request of the poll panel seeking time to respond to the plea

The bench said the EC should be given some reasonable time to respond to the plea and listed it for hearing before an appropriate bench during the summer vacation May 24, a day before the sixth phase of the seven-phase Lok Sabha polls.

During brief hearing, senior advocate Maninder Singh, appearing for the poll panel, said NGO Association for Democratic Reforms (ADR) has levelled "absolutely false allegations" in the plea and, moreover, a recent judgment of another bench of the apex court headed by Justice Sanjiv Khanna has dealt with the issues which are also part of the present case.

On April 26, the Justice Khanna-led bench rejected the pleas for reviving paper ballots and also 100 per cent cross-ver-

Bhushan, on the other hand, opposed the submission, saying that the issue relating to voter turnout data was not part of the earlier petition.

The CJI, earlier in the day, asked the counsel appearing for the Election Commission to take instructions and said it will hear the matter at the end of the

The ADR had last week filed an interim application in its 2019 PIL seeking directions to the poll panel that "scanned legible copies of Form 17C Part-I (Account of Votes Recorded)" of all polling stations be uploaded immediately after the polls.

Election "Direct the Commission to provide tabulated polling station-wise data in absolute figures of the number of votes polled as recorded in Form 17C Part- I after each phase of polling in the ongoing 2024 Lok Sabha elections and also a tabulation of constituency-wise figures of voter turnout in absolute numbers in the ongoing 2024 Lok Sabha elections," the NGO said. It said the plea was filed to ensure that the democratic process is not subverted by elec-

toral irregularities. The voter turnout data for the first two phases of the ongoing 2024 Lok Sabha elections published by ECI April 30 has been published after 11 days of the first phase of polling April 19 and four days after second phase of polling April 26.

"The data, as published by the ECI in its press release dated April 30 shows a sharp increase (by about 5-6 per cent) as compared to the initial percentages announced by ECI as of 7pm on the day of polling," the plea said.

The petition said the "inordinate" delay in the release of the final voter turnout data, coupled with the unusually high revision of over five per cent in the poll panel's press note of April 30 has raised concerns and public suspicion regarding the correctness of the said data.

The non-release of the absolute number of votes polled coupled with the "unreasonable delay" in the release of votes polled data has led to apprehensions in the mind of the electorate about the sharp increase between initial data and data released April 30, it said.

"These apprehensions must be addressed and put to rest. That in order to uphold the voter's confidence it is necessary that the ECI be directed to disclose on its website scanned legible copies of Form 17C Part-I (Account of Votes Recorded) of all polling stations which contains the authenticated figures for votes polled, within 48 hours of the close of polling," it said.

Constitution bench verdict cannot be undermined: SC

New Delhi, May 17: A judgement of a Constitution bench would be 'binding' on benches of lesser strength, the Supreme Court has held while recalling its April 2022 verdict in a matter related to land which was meant exclusively for common use by the inhabitants of a village in Haryana.

In its order dated April 7, 2022, the apex court had held that a panchayat cannot claim ownership of the land which has been taken from the real owners from their permissible ceiling limits

under the land law in Haryana. The apex court had consequently said panchayats can only manage and control the land which has been taken from the owners and cannot claim title. "It is pertinent to note here that

for the land taken from the proprietors by applying pro-rata cut from the permissible ceiling limits of the proprietors, management and control alone vests with the panchayat but such vesting of management and control is irreversible and the land would not revert to the proprietors for redistribution as the common purposes for which land has been carved out not only include the present requirements but the future re-

quirements as well," it had said. The top court had delivered the verdict on a batch of appeals against a full bench verdict of the Punjab and Haryana High Court which had examined the legality of sub-section 6 of Section 2(g)

of the Haryana Village Common Lands (Regulation) Act, 1961.

In a judgement delivered Thursday, a bench of Justices B R Gavai and Sandeep Mehta said that when the high court verdict rested on the law laid down by the apex court's Constitution bench in 1966, "the least that was expected" of the court in the judgement under review was to explain as to why the high court was wrong in relying on the

"No law is required to state that a judgement of the Constitution bench would be binding on the benches of a lesser strength. Bhagat Ram (1966 verdict) has been decided by a strength of five judges, this court having a bench strength of two judges could not have ignored the law laid down by the Constitution bench in paragraph

The top court delivered its verdict on a plea seeking review of the April 2022 judgement. It said that "ignoring" the law

Variation in El Nino, La Nina causes coral reef bleaching

cean temperatures that have gone "crazy haywire" hot, especially in the Atlantic, are close to making the current global coral bleaching event the worst in history. It's so bad that scientists are hoping for a few hurricanes to cool things off.

More than three-fifths — 62.9 per cent— of the world's coral reefs are badly hurting from a bleaching event that began last year and is continuing. That's nearing the record of 65.7 per cent in 2017, when from 2009 to 2017 about one-seventh of the world's coral died, said Derek Manzello, coordinator of the National Oceanic and Atmospheric Administration Coral Reef Watch Programme.

When water gets too hot, coral, which are living creatures, bleach

In the Atlantic, off the Florida coast and in the Caribbean, about 99.7 per cent of the coral reefs have been hit with 'severe' losses in staghorn and elkhorn species, Manzello said recently in NOAA's monthly climate briefing. Sixtytwo countries are seeing damaged coral, with Thailand shutting off a tourist-laden island to try to save the coral there

Meteorologists say a La Nina a natural cooling of parts of the Pacific that changes the weather worldwide — is forecast to develop soon and perhaps cool oceans a bit, but Manzello said it may be too little and too late.

"I still am very worried about the state of the world's coral reefs just because we're seeing things play out right now that are just very unexpected and ex-



"This wouldn't be happening without climate change. That's basically the cornerstone of all the ocean warming we're seeing," Manzello said. But on top of that are changes in El Nino,

the reverse of La Nina and a natural warming of ocean waters; reduced Sulphur pollution from ships and an undersea vol-

cano eruption. Former top NASA climate scientist James Hansen said "acceleration of global warming is now hard to deny" in a new analysis and statement recently.

For coral, it comes down to how hot the water is and "things have just gone crazy haywire with ocean temperatures in the last year." Manzello said. He said hurricanes bring up cool water from deep and benefit coral reefs if they don't hit them directly.

'Hurricanes can be devastating for reefs," Manzello. "But in the grand scheme of things and given the current situation we are in on planet Earth, they're now a good thing essentially, which is kind of mind-blowing.'

On Wednesday, parts of the Atlantic where hurricanes often develop had an ocean heat content — which measures water warmth at depths — equivalent to mid-August, said hurricane reUniversity of Miami and Phil Klotzbach at Colorado State University

The world's oceans last month broke a record for the hottest April on record. It was the 13th straight month global seas broke records, and because the oceans are slow to cool or warm, more records are likely, said Karin Gleason, NOAA's climate monitoring chief.

Coral reefs are key to seafood production and tourism worldwide. Scientific reports have long said loss of coral is one of the big tipping points of future warming as the world nears 1.5 degrees Celsius (2.7 degrees Fahrenheit) of warming since pre-industrial time. That's a limit that countries agreed to try to hold to in the 2015 Paris climate agreement.

Rayagada staring at acute water crisis

Declining groundwater level a matter of great concern, say environmentalists

Rayagada, May 17: Residents in this district stare at a major water crisis in the near future with the sharp decline in groundwater level, sources said Friday. Establishment of a number of industries and a rise in population are two of the main reasons for the ter level, they pointed out. Rampant digging up of bore wells is another reason for the shrinking groundwater level, sources added.

Environmentalists apprehend that a major crisis is in store in future as no steps have been taken for conservation of water. They added that unless digging up of bore wells is curtailed, the water crisis cannot be controlled. It should be added that district administration officials are clueless about the bore well issue. They do not even know how many bore wells have been set up in the district. Residents pointed out that the administration is not taking any concrete steps for



preserving water below the soil. Sources said that there is a groundwater division (GWD) office in the district but it remains non-functional due to lack of adequate number of employees. People in the know of things informed that groundwater level

now the pinch is already being felt. This district has 11 blocks and 78 points for checking groundwater level. In most of the blocks

started decreasing from 2019 and

the water level has decreased substantially, sources pointed out. The groundwater level is satisfactory at Padmapur block while it is the worst in Rayagada block.

Reports available from the Rayagada Groundwater Development department said that water was earlier available at 4.96 metres below soil in Bissam Cuttack block. However, it depleted to 7.77 metres in 2023. Similarly, water level at Gudari

block stood at 10.46 metres in 2019 but now has gone down to 12.39 metres. The water level at Gunupur was 13.01 metres and 6.20 metres at two check points in 2019. However, now it stands at 13.49 metres and 3.45 metres. At Rayagada block, the water level has reduced to 29.31 metres now as against 22.24 metres in 2019.

According to information available the situation is the same for most of the other blocks including Kalyansingpur, Kashipur, Kolnara and Muniguda. Environmentalists stated that the way the water level is falling, the district stares at a bleak future.

When contacted, hydrologist Jyotiprasad Das working at the GWD office stated that the current groundwater level is indeed concerning. He however, pointed out that it is the responsibility of all residents in the district to conserve and preserve water. He informed that he has not received any instruction to impose restrictions on the digging up of

15 fall sick after inhaling toxic gas

Balasore: Fifteen people fell ill after inhaling toxic gas emitted from a prawn processing unit near Nilagiri in this district, police said Friday, They added that workers, mostly women, engaged in processing work complained of vomiting, nausea and difficulty in breathing Thursday night. Among those who fell ill were some minors also. All of them were immediately taken to the Nilagiri hospital by co-workers where after treatment they were discharged, hospital sources said. Rourkela, May 17: Four people were killed and seven others suffered serious injuries Friday when the vehicle they were travelling in overturned near Bonai. All the passengers of the car were coming here to attend the last rites of Swapan Kumar Mohanty an RSP employee who breathed his last Thursday after a prolonged battle with cancer.

The car was travelling with people from Chandaneswar in Balasore district and Digha in West Bengal. Eve-witnesses said that it was moving at high speed. Near Bonai, the driver of the vehicle tried to evade a big crater and while swerving, the vehicle

turned turtle. Swapan's sister and brother-in-law died on the spot, informed officials later. Police arrived at the spot and

with the help of locals rescued the nine others trapped inside the overturned car. Initially, they were taken to the Rourkela Government Hospital (RGH). However, after their conditions deteriorated, they were shifted to a nursing home. Two more persons including a woman breathed their last at the nursing home.

Doctors informed that even though the seven others have suffered serious injuries their conditions are stable now. Police after post-mortem handed over the bodies to family members of the deceased.

"It is very tragic. Swapan babu's sister and brother-in-law were coming to pay their last respects and now they are dead. It couldn't have been more heartbreaking," said a family member.

Climate change harming Koraput coffee

Koraput, May 17: Koraput coffee which has carved a niche for itself in the world map has been hit hard by climate change, a report said. It seems that global warming has affected the coffee plants badly as the output has decreased considerably. This has prompted the officials of the Koraput Coffee Board to replace plants that are 20 to 25 years old in various plantations of the district to combat the adverse impacts of climate change. The board is working hard to prevent the plants from get-



ting affected due to climate change,

PRO, Upendra Shah informed. The immunity and output of a coffee plant declines as it ages. The output from a coffee plant reduces

substantially when it attains the age of 25 years. Keeping this in mind, the authorities are pruning the tip of the plants to achieve better output. However, when this procedure is failing to increase production, the plants are being uprooted and replaced by new ones, Shah informed.

A new coffee plant starts bearing beans within three to four years after it is planted. Officials at the Koraput Coffee Board are hopeful that within the next few years, the new plants will definitely play a major role in increasing production and help in reducing losses.

Shah informed that the board is providing financial assistance for the upkeep of the coffee plants to individual farmers. He stated that the aid is helping farmers recover from their losses and going a long way in enhancing their livelihood.

More than 3.500 hectares of land in this district are now being used for growing coffee. Close to 5,000 farmers including tribals earn their livelihood from coffee plantations. It definitely has transformed the lives of people in the district, Koraput Coffee Board officials said.

Major Overhaul

erhaps stung by all the criticism of the changes to the current laws. the Ministry of Home Affairs (MHA) is actively seeking input from the Directors-General of Police across all states and union territories on a proposal to modernise and streamline over a dozen pre-independence laws. This significant move is notably timed alongside the Lok Sabha elections and aims to update antiquated laws such as the Registration of Foreigners Act, Official Secrets Act, and Explosive

Substances Act, among others. In March, Prime Minister Narendra Modi directed Union government secretaries to prepare reform plans for the initial 100 days of the new government, spurring this effort. According to sources, one major proposal is to merge the Registration of Foreigners Act, Passport Act and Foreigners Act into a single law, provisionally titled the Immigrants and Foreigners Bill. Discussions on this possible consolidation have already taken place with the Law Ministry.

Updating the Official Secrets Act (OSA) to keep pace with technological advancements is also under consideration. The OSA, which deals with espionage and unauthorised handling of sensitive information, has a draft bill prepared with inputs from key intelligence and defence agencies, including the Intelligence Bureau, Research and Analysis Wing, and the Defence Ministry, among others.

Moreover, the MHA aims to combine two Acts concerning explosive substances, currently overseen separately by the MHA and the Department for Promotion of Industry and Internal Trade. The ministry has also sought feedback on updating laws within state jurisdictions, including a new Police Act, based on the MHA's Model Police Act of 2006, which has already influenced legislation in at least 15 states.

The exit of a go-to babu

It went down to the wire, with babus in a quandary until the last moment, whether to throw a farewell party or quietly bid goodbye to a colleague. Finally, the uncertainty over the com-



pletion of the Central deputation tenure of Sunil Kumar, senior joint secretary at the Ministry of Petroleum and Natural Gas, ended with the issue of a final relieving order.

He looked after upstream exploration and production matters, petrochemicals, import and export of crude oil and petroleum products, ethanol blending programme and other biofuels, green hydrogen and renewable energy, etc. That's a lot to deal with, for any babu. But even the most dedicated and popular babu is not irreplaceable, and so Kumar had to finally exit.

The IAS Association has called on Chief Secretary Dr V. Venu to address the recent doctors' protest triggered by Thiruvananthapuram District Collector Geromick Georges. The 2015-batch IAS officer caused an uproar when he summoned a doctor from a busy outpatient surgery to treat his nail infection at home

Sources have informed DKB that the doctor reportedly ended up waiting an hour at the Collector's residence before finally treating and clearing the infection before returning to the hospital. The entire situation set off a wave of anger among the doctors, raising serious questions about the abuse of administrative privileges.

The IAS Association, however, defended the Collector, citing the civil service rules, which allow doctors to visit civil servants at home for medical exams, with the timing decided by the medical officer and the costs reimbursed. The babus have also slammed the breach of medical ethics in making the Collector's health condition public.

On the flip side, the state Medical Officers Association reported that the Health Secretary had spoken with the Collector to ensure this kind of incident doesn't happen again.

But as the controversy builds up, Chief Secretary Venu has stated that he will review a detailed report submitted by the Health Secretary before deciding on the matter.



The BJP rushed to deny Kejriwal's claim that Narendra Modi would retire as prime minister when he turns 75 in September 2025 and join the 'margdarshak mandal'. It asserted loudly that there was no such rule in the party's constitution and that he would complete his full term. (If he secures a third term, that is, which is not quite the foregone conclusion BJP thinks it is.) In the retrospective way taxmen are familiar with, Kejriwal proved that the 75year age limit had been invoked in 2014 only to keep the old warhorses, LK Advani and Murli Manohar Joshi, out of the new government.

It is the sub-clause of Kejriwal's main charge—"Modi is not seeking votes himself in this election but for Amit Shah to take over from him next year"—that has set the proverbial billi among the bhakts. By prefacing that claim with the assertion that Yogi Adityanath would be ejected out of office as Uttar Pradesh chief minister if BJP wins the general election, to pave the way for Shah to succeed Modi, Kejriwal has exposed a major fault line in the emerging game of thrones. that everyone was hissing about is now headline news. Except that it isn't.

With mainstream media in full cheerleader mode, it has been left to digital and social media to suss out the juice of this story—and distill it into a 'Yogi vs Gujarat Lobby' bottle. It is not gone unnoticed by influential YouTube commentators that the BJP top guns who were rolled out to counter Kejriwal only refuted his claim on Modi relinquishing office on turning 75. No one sought to erase the "best before June 4" label the Delhi CM had slapped on his UP counterpart's tenure should BJP win a third term. So, is there more to Kejriwal's charge than just smart, diversionary politics?

Now is not the time to discuss the relative merits and demerits of the two aspirants. Shah, 60, is a first-term MP; by 45, Yogi was into his fifth term. Shah runs a couple of departments after being party president; Yogi shepherds a state that is the size of the world's fifth biggest nation. As a saffronclad monk, Yogi ticks the bachelor box middle-class India is in awe of; Shah has installed a nepobaby at the helm of the cricket board while flailing at 'parivaarvad'. For every police excess under 'Chanakya', there is a JCB under 'Bulldozer Baba'; for every Kafeel Khan, there

is a Umar Khalid. The big difference is only one of them speaks Gujarati and has the

Yogi was reputed to have fought tooth and nail an earlier attempt to get him out. And the PM's body language with Shah and Yogi tells its own story for all who care to see.

By hinting at a 'Yogi vs Shah' tussle, Kejriwal has killed three birds with one grenade. One, he has pushed a belligerent BJP into a defensive mode. Two, he has artfully underlined the frustrations of Rainath Singh and Nitin Gadkari. And three, with 41 of UP's 80 seats still to vote, he has created enough disincentives for Yogi's supporters to plump for the BJP. Given Yogi's apparently high popularity, would it really be in his interest to work full pelt for Modi's win, if it will only result in his exit and remove him from the race?

Inherent in the BJP's Methuselah defence—"Modiji will complete his full term"is a staggering unpreparedness for life after Modi. Its overthe-top reaction to a Congressman's intimation of Modi's mortality is further proof. But the lack of clarity on who is next in line when the time comes, as indeed it will someday, reflects poorly on the management of the world's largest political party. It scarcely need be said that a squabble between the contenders is exactly what Dr Kejriwal ordered for the Opposition.

ithin hours of his stepping out of jail, Delhi Chief Minister Arvind Kejriwal hooked the ball. Instead of name calling the BJP, he hit where it hurt the most

Prime Minister Narendra Modi. Keiriwal said, is turning 75 in September this year. Were he to follow his own rule that had axed party veterans like LK Advani and Murli Manohar Joshi, then Modi should relinquish office before the year is out.

For the uninitiated, Prime Minister Modi had introduced an age bar to retire partymen from active politics at 75 years. The rule came handy to axe detractors.

Kejriwal is now hurling the same clause at Modi daring him to do what he did to others.

Kejriwal did not say Modi should retire or sought to know whether he would. Instead he tapped the electorate and told them that a vote for Modi actually means a vote for Union Minister Amit Shah: Modi's trusted lieutenant.

Kejriwal's take: the electorate is being hoodwinked into believing that Modi will lead the country for the next five years. Reality check: "Modi is asking for votes for Amit Shah" to quote Kejriwal.

Clearly, Kejriwal has put the BJP in a bind. It has targeted minds and perhaps led a Modidriven electorate to stop and think: Will a vote for Modi be a waste?

Not the one to take chances, Shah stepped in. He not only debunked Kejriwal's diatribe but also assured the electorate that Modi will complete his term The age-bar, he clarified, is "not written anywhere in the BJP's Constitution"

The twist has put a question mark on Modi's credibility. Since he is central to this debate, the focus is on him to see if he acts on what he, himself, had initiated in 2014.

Shah's assertion makes it clear that he won't.

So what does this do to Modi? For one, it exposes his doublespeak. Another, it demonstrates his ability to bend rules at will and widen the gap between words and action: something the Opposition has accused him of, often calling him a liar. Therefore to say that this is

Kejriwal's masterstroke is stating the obvious. Would it pay dividends? Yes and no. For starters, it has put Modi

on the backfoot which is good news for the Opposition, in case it can exploit the issue to its advantage. As for Kejriwal he has to fend

for himself. Age imbroglio apart, he has been crying hoarse about BJP's vendetta politics. For record, Kejriwal was

jailed after the Enforcement Directorate accused him of corruption in an excise scam. Last week, the Supreme Court granted him interim bail. Kejriwal has charged the BJP

with vendetta politics. While painting it black he has tried to emerge a martyr: a Chief Minister victimised by the BJP: yet a phoenix rising from the ashes. On the face of it a good script

but one that has failed to resonate with the people. Clearly in this case, one man's loss is not another's gain so if Modi is on a sticky wicket it does not, necessarily, mean that Kejriwal has

In other words, making Modi a villain does not translate into Kejriwal emerging a hero. It is not a quid pro quo. Kejriwal is being assessed on his own deeds or misdeeds while the BJP's vendetta politics is an albatross of its own making.

Throwing political opponents in jail, Kejriwal included, does not augur well for the government. If anything it could cancel the grandeur of Brand Modi that the BJP is fervently marketing.

Consequently, nothing stops the electorate from battling the 'if it is them today it could be us tomorrow' syndrome. This perhaps could checkmate the B.IP in its illusionary 'abki baar 400 paar, 'or 400 plus seats

AGRA ADDS A NEW ATTRACTION TO IT

Agra May 17: A new white marble structure in Agra that took 104 years to build is daily drawing hordes of spiritually inclined tourists.

The visitors often draw comparisons between the iconic Taj Mahal and the newly built mausoleum of the founder of the Radhasoami sect in Soami Bagh, located about 12 km away from the Taj Mahal.

The immaculate white marble structure has become a popular attraction for tourists exploring Agra. Many are in awe of the grandeur of the mausoleum and consider it a wor-

thy rival to the Taj Mahal, adding to the architectural splendour of the city known for its Mughal monuments.

Unlike the Taj Mahal, which was completed in 22 years with the labour of thousands of skilled artisans and craftsmen in the 17th century under a medieval authoritarian regime, the construction of the Soami Bagh mausoleum spanned over a century in an open society.

A devoted follower of the faith Pramod Kumar mentioned that the construction of the mausoleum was a testament to the unwavering faith, fervour, and dedication of its creators, who were driven by their religious beliefs.



Resting on a foundation of 52 wells, the 193-foot tall structure, all in white marble from

Makrana in Rajasthan, is undoubtedly one of the most ambitious projects in India.

The mausoleum is dedicated to the founder of the Radha Soami faith Param Purush Pooran Dhani Swamiji Maharaj. The grand mausoleum is situated in the Soami Bagh colony in Agra's Dayalbagh area.

Each day bus loads of tourists visit the mausoleum and express their admiration and awe at the exquisite craftsmanship on display. The entrance is free while the photography is not permitted.

Some minor additions are yet to be made. One can see scores of craftsmen at the workshop equipped with huge machines using state-of-the-art technology. "Now of course we have huge grinders, cutters, finishers, lorries, lifters, and all kinds of machines and computer technology, all of which were employed to advantage here, and the results show," an official connected with the project said.

Already visitors have begun comparing the Soami Bagh mausoleum with the world heritage monument, the Taj Mahal which draws thousands of tourists from all over the world daily. The Taj Mahal houses the mausoleum of Mughal Emperor Shah Jahan and his wife Mumtaz Mahal.

Officials who supervised the construction said, "It is a form of worship that has been going on and will go on relentlessly.'

Calcutta HC grants bail to Piyali Das

Kolkata, May 17: The Calcutta High Court Friday granted bail to Sandeshkhali BJP worker Piyali Das who surrendered before a lower court three days ago over a criminal case lodged against her.

Justice Jay Sengupta also directed that she be released from jail on personal bond forthwith.

A case was filed against Das alleging that she got the signature of a woman of Sandeshkhali on a blank paper which was later filled up as complaints of sexual assault against TMC leaders.

After she surrendered May 14, the additional chief judicial magistrate of Basirhat sub-divisional court rejected the bail prayer of Das and remanded her to eight days' judicial custody.

The BJP worker moved the Calcutta High Court seeking bail. Advocate Rajdeep Majumder submitted before the court that IPC 195A (forcing a person to give false evidence), a non-bailable section, was added against her by the police after she surrendered before the lower court.

The West Bengal government opposed the bail prayer. The court directed that a final report on the investigation in the case lodged against Das could not be submitted without its permission. The matter will be taken up for hearing again June 19.

Mercury breaches 45°C mark in UP

Lucknow, May 17: For the first time this season, the maximum temperature in the state crossed the 45-degree Celsius mark.

Kanpur was the hottest at 45.1 degrees Celsius Thursday, while the temperature in Agra and Bundelkhand region remained between 43-45 degrees Celsius. Due to favourable synoptic

conditions and the increasing speed of hot Westerly Winds, there is a possibility of a gradual increase of 1-3 degrees Celsius in the temperature of the state during the next 3-4 days, due to which heatwave is likely to start from Friday and

continue during the next fortnight of May.

Maximum and minimum temperatures in Lucknow Friday will be around 43 degrees Celsius and 27 degrees Celsius respectively. The day temperature in the state capital soared to 42.4 degrees Celsius on Thursday, said Mohd Danish, Lucknow Meteorological (MeT) office in

As per the state forecast, the weather is likely to remain dry over the state. The MeT Department has issued a warning of heatwave conditions very likely at isolated places over the state.

According to the state department, the Bundelkhand region and districts bordering Delhi and Rajasthan will be swept by a heatwave Friday. It will spread gradually to most parts of southeastern, central and northeast UP Saturday.

The entire state, barring the Terai belt bordering Nepal, will reel under the heatwave Sunday and Monday.

Temperatures are expected to increase gradually and touch or cross the 45 degrees Celsius mark



Sunday and Monday when Lucknow goes to polls in the fifth phase of Lok Sabha elec-

"Clear skies and dry hot winds blowing from the desert region of Rajasthan are responsible for the heatwave. Mercury levels will soar during this period. The state will also be lashed by dry hot westerly winds for the next five days," said Mohammad Danish.

The southwest monsoon is likely to enter the South Andaman Sea on its normal date of May 19 and Kerala May 31, one day before its normal date of June 1. Only after this, will the progress of the monsoon in the rest of India be determined.

Phoolkali celebrates 12 yrs of freedom from forced begging

Agra, May 17: Rescued from the grips of a harrowing existence spent begging on the unforgiving streets, Phoolkali – a resilient female elephant - found freedom in 2012. The conservation NGO

CBI looking for 6 absconders; houses of 2 TMC leaders raided

Kolkata, May 17: The CBI conducted raids at various locations in West Bengal Friday, looking for six absconders in a post-poll violence case, including some Trinamool Congress (TMC) leaders, officials said.

The Central Bureau of Investigation's (CBI) search operation was aimed at tracing

the whereabouts of the six absconding accused against whom non-bailable warrants have been issued by a special court, the officials said.

The court has issued the warrants against Buddhadeb Maity, Pradip Mandal, Debabrata Panda, Tapas Bej, Arjun Kumar Maity and Bikramjit Das, they said. The CBI team searched the residences of two TMC leaders



in Purba Medinipur district of West Bengal in connection with its ongoing probe into the killing of a Bharatiya Janata Party (BJP) worker in post-poll violence in 2021, an officer said.

A team of CBI officers raided the houses of Debabrata Panda, a TMC leader from Kathi Block number 3, and block president Nandadulal Maiti in the early hours, he said.

"Panda, Nandadulal's son and 52 others have been named in the FIR lodged in connection

with the killing of Janmejay Dolui," the CBI officer told PTI. Dolui, a BJP worker, was killed in violence following the 2021 West Bengal Assembly polls.

The officer said 30 people were summoned for questioning in connection with the matter but none turned up. "We are conducting raids at places associatedwith these people. We need to question them," he said.

Migration key issue in Hinjili, Kantabanji

Though there is no official data on the number of migrants from Hinjili and Kantabanji, unofficial estimates say more than a lakh people have left their homes in these two constituencies in search of jobs in Gujarat, Andhra _ Pradesh, Telangana, Tamil Nadu and other states

Hinjili/Kantabanji, May 17: Located at a distance of about 350 km from each other, Hinjili and Kantabanji Assembly constituencies share two commonalities - both hold migration as the key issue and Chief Minister Naveen Patnaik as the BJD candidate.

Though local voters talk about infrastructure development, lack of job opportunities plagues the two rural constituencies for several years.

Though there is no official data on the number of migrants from these two places, unofficial estimates say more than a lakh people have left their homes in Hinjili and Kantabanji in search of jobs in Gujarat, Andhra Pradesh, Telangana, Tamil Nadu and other states

While Kantabanji is in the western region of Odisha, Hinjili is in the southern part of the state.

However, the ruling BJD claimed that the rate of migration has drastically come down

These migrant workers are now in high demand as political parties bring them back to their homes to cast votes in the

"We had to return from Surat in Gujarat to cast votes in Hinjili as our family lives here. Unless we cast our votes, the local Sarpanch may deny us free rice or other such benefits being availed from the government, said Santosh Gouda, 35, a migrant worker.

Similar is the story of other migrant workers. Each migrant worker is paid train fare and food allowance of Rs 500 to return to the village and cast votes, Gouda said, adding that all parties including BJD, BJP and Congress adopt this approach to raise their vote share in the elections.

Patnaik has been elected from Hinjili Assembly segment

"It is our pride that our MLA is the Chief Minister of Odisha. During the last 24 years, he has improved certain infrastructure but has not solved the basic problem of migration. Had there been sufficient work here, why should our husband, brother and son go to another state in search of jobs," said Bilasini Behera, of Sheragada area under Hinjili assembly segment.

During Patnaik's tenure Hinjili, a small rural pocket, has became a municipality. Now it has sub-divisional hospital, rural industrial park, skill development centre, fire stations, Harabhangi irrigation project and drinking water supply for every household but migration is still a problem.

"Hinjili is basically an agrarian economy where its residents mostly undertake vegetable cultivation. But, they are forced to undertake distress sale of their produce due to lack of cold storages, claimed Sisir Mishra," the BJP candidate pitted against Patnaik.

Mishra says if adequate cold storage facilities are made available, migration could be curbed



to a great extent. This apart, the CM has not been able to set up even a pin factory so that the migration could be arrested.

'Though Patnaik has been representing Hinjili seat for about two-and-half-a-decades, the area does not look like a VVIP constituency. The officers manage the show here on behalf of the Chief Minister which is again a curse for the local people," the BJP candidate said.

Patnaik is seeking re-election for the sixth time in a row from Hinjili. Congress has pitted Rajani Kanta Padhi against the BJD supremo. Though there are 10 candidates in the fray from this constituency, the main contest is likely to be witnessed between the BJD and BJP in Hinjili which comes under Aska Lok Sabha constituency.

The over 2.31 lakh voters of Hinjili are dependent on agriculture and business. "We are concentrating only on increasing the victory margin," said Nibedita Pradhan, BJD's Zilla Parishad member.

Patnaik's close aide and BJD leader Kartik Pandian said: "You can see ILO data, UNDP data and even Government of India data. The rate of migration has drastically come down from Odisha, distress migration, which is the negative side of migration has completely come down. Naveen Babu has been taking all measures. In fact, we have the biggest skill development programmes in the country. The World Skill Centre is here in Odisha.

Patnaik is also contesting Kantabanji Assembly segment in Bolangir district. This is for the second time that Patnaik has been contesting from two Assembly segments. In 2019 elections, he had also contested Hinjili along with Bijepur, a western Odisha Assembly seat. He had won both the seats. He, however, retained Hinjili following the request of the people.

While the migrant workers from Hinjili work in different spinning mills in Surat, the people from Kantabanji run either to Andhra Pradesh or Telangana to work as daily labourers in different brick kilns. Many times they face torture at the brick kiln. "Can Patnaik assure the people of Kantabanji to stop migration," asked sitting Congress MLA Santosh Singh Saluja, who is contesting against the chief

minister in Kantabanii. Saluja, who has been elected to the Assembly from Kantabanji four times - 1995, 2000, 2009 and 2019, said the BJD government "failed" to set up any industry in the area and the people do not get

MGNREGA work. "We will vote for the CM with the expectation that our area gets priority in BJD government. He may quit, but if elected, the CM would ensure development of the area," said Basanti Tandi, a woman SHG member.

Bhubaneswar-Ekamra braces for fierce battle

Bhubaneswar, May 17: Even though BJD's Bhubaneswar-Ekamra Assembly nominee Ashok Chandra Panda has been on a winning streak from the constituency for the last three elections, since 2009, it would not be a cakewalk for him this time thanks to the 'rising popularity' of BJP candidate Babu

Sources said riding the 'antiincumbency wave' against Panda, Singh has raised the poll pitch by meeting people at their doorsteps for the last two years and has been taking up issues related to sewerage, sanitation, roads and public amenities.

Significantly, the saffron party's vote share in Ekamra seat has witnessed a rise from 13.19 per cent in 2009 to 35.27 per cent in 2019.

Speaking to OrissaPOST, Singh said the dismal state of civic amenities, has put the denizens in this constituency under immense trouble. The situation gets exacerbated during the rains when roads and building compounds get waterlogged due to lack of proper drainage.

"During the last monsoon, the deities of Lingaraj Temple faced almost a hostage-like situation due to unprecedented waterlogging. The severe waterlogging caused inconvenience to the servitors and devotees as well. This is also an embarrassment for us. If this was not enough, there is utter indiscipline in conduct of temple rituals as priests have been whimsically stopping the daily rituals

of the Lord. The BJP nominee added that Panda has miserably failed in







restoring heritage waterbodies like Bindu Sagar and others.

Alleging negligence by the incumbent MLA, an Old Town resident Nishikant Tarenia said developmental initiatives like better roads and amenities have been eluding the Ekamra constituency for long. "This has further added fuel to the debate of Old Town versus other parts of the City like Infocity and Saheed Nagar," Tarenia added.

The Congress first-timer, Prasant Kumar Champati, said his foremost priority would be to improve civic amenities in the slums under the constituency. Stressing the manifesto of Odisha unit of Congress, Prasant said he is reaching out to voters with the key promises of Rs 3,000 unemployment allowance, cooking gas cylinder at subsidised rate of Rs 500 and monthly allowance of Rs 2,000 to SC women among others.

Besides, Prasant said after winning he would focus on cleaning Gangua nullah and Daya River. "The Congress party never believes in awarding fake land pattas to slum dwellers, which the BJD government did. Upon winning, we would ensure that these dwellers get land pattas for free," he added.

The BJD government, in a bid to revamp the heritage of ancient shrines such as Lingaraj Temple and Anant Basudev

Temple, launched Ekamra Prakalpa in 2019 with a budget of Rs 280 crore. The project, touted to be similar to Puri Srimandir Heritage Corridor Project, aimed to restore the shrines and preserve holy water bodies with an allocated area of 80 acre.

However, the project faced ire of locals when it announced the eviction of commercial establishments and shops to carve passage for smooth commutation. Though, it promised financial rehabilitation for the evicted shop owners, the irate locals hit the streets in protest.

Swati Maliwal vs AAP

New Delhi, May 1: AAP MP Swati Maliwal has alleged Delhi Chief Minister Arvind Kejriwal's aide attacked her with full force, slapping and kicking her in the chest and abdomen, charges rejected as "baseless" by the party, which accused her of being the face of a BJP conspiracy to frame Kejriwal.

The allegations are part of an $\,$ FIR registered by the Civil Lines police station here Thursday against Keiriwal's personal assistant Bibhay Kumar, Maliwal. a member of the Rajya Sabha, has alleged that she was assaulted by him at the CM's official residence May 13.

Hitting back at the Aam Aadmi Party (AAP), Maliwal, a former chief of the Delhi Commission for Women (DCW), said the party has given in under a "goon's pressure" and is now questioning her character.

Without naming Kumar, she said, "This goon is threatening the party (AAP) saying that 'if I



get arrested, I will reveal all the secrets'". Maliwal added that party has taken a "U-turn" two days after it accepted that Kumar had "misbehaved" with her.

In its probe into the incident, the Delhi Police took Maliwal to the CM's residence to recreate the crime scene, an official said, adding that her statement was also recorded before a magistrate at the Tis Hazari court.

In the FIR, Maliwal claimed that Kumar hit her with "full force again and again" and she was "kicked and slapped seven to eight times". She also alleged that despite telling him that she was menstruating and in pain, he did not budge.

Addressing a press conference, senior AAP leader Atishi said Maliwal had reached the CM's residence without an appointment and her intention was to level allegations against Kejriwal. "Today a video has surfaced that has exposed the lie of Maliwal. In her FIR, she has said she was brutally assaulted and she was in pain, and buttons of her shirt were torn.

ED names Kejri, AAP as accused

New Delhi, May 17: The **Enforcement Directorate Friday** filed a fresh charge sheet in the Delhi excise policy case, naming Arvind Kejriwal and his Aam Aadmi Party (AAP) as accused, the first time that a sitting Chief Minister and a political party face money laundering charges.

Official sources said the prosecution complaint, spanning about 200 pages, has been filed before a special court here. Special Judge Kaveri Baweja is likely to take up the chargesheet for cognisance in coming days.

The accused have been sought to be charged under the provisions of the Prevention of Money Laundering Act (PMLA), the sources said. They said Kejriwal has been made made an accused in his personal capacity as well as the national convenor of his political outfit AAP.

The federal agency had arrested 55-year-old Kejriwal from his official residence here March 21. He is currently out of jail on interim bail.

This is the eighth charge sheet filed by the $E\bar{D}$ in this case in which it has arrested 18 people so far, made a total of 38 entities as accused and attached assets worth Rs 243 crore. Last week, a similar complaint was filed by the agency against BRS leader

and former Telangana Chief Minister Chandrashekar Rao's daughter K Kavitha and four

The CM was earlier called the "kingpin and key conspirator" of the Delhi excise "scam" by the ED. It was alleged that he acted in collusion with Delhi government minister, AAP leaders and others. Additional Solicitor General S V Raju told the Supreme Court Thursday that Kejriwal played a key role in the formulation of the now-scrapped excise policy.

"We have direct evidence that Kejriwal stayed in a seven-star hotel, whose bills were partly paid by an accused in the case, he said, adding that Kejriwal, as the national convenor of the AAP, was vicariously responsible for the alleged scam.

The ED had earlier claimed that AAP, being a political party, is defined as an association or a body of individual citizens of India under the Representation of the People Act, and hence it can be categorised as a "company" as contemplated under section 70 of the PMLA. As Arvind Kejriwal was "in-charge of and responsible" for the said company i.e. AAP during the time of offence, he and his party "shall be deemed guilty" of offences mentioned under the anti-money laundering law and liable to be prosecuted and punished, it had said.

EC show-cause to BJP's Abhijit Gangopadhyay

New Delhi/Kolkata, May 17: The Election Commission Friday issued a show-cause notice to former high court judge and BJP Lok Sabha candidate Abhijit Gangopadhyay for his "improper, injudicious and undignified" remarks against Bengal Chief__ Minister Mamata Banerjee.

The comments Bandopadhyay triggered a war of words in poll-bound West Bengal, with TMC claiming that the comments reflect the 'misogynist mindset of the BJP,"and the BJP claiming that his remarks have been "misconstrued by the TMC."

Gangopadhyay is the fourth politician in the ongoing Lok Sabha elections to have been served a notice for undignified remarks against women.

BJP's Dilip Ghosh and Congress's Supriya Shrinate were censured by the EC after being served notices for their remarks against Mamata Banerjee and Kangana Ranaut respectively. Randeep Surjewala of the Congress was barred from campaigning for 48 hours for his remarks against BJP's Hema Malini.

The poll panel acted on a complaint by the Trinamool Congress against Gangopadhyay for his remarks against Banerjee while addressing a public meeting held May 15 in Haldia. The BJP has fielded Gangopadhyay from Tamluk seat in West Bengal where voting will be held May 25.

The EC in its notice noted that Gangopadhyay's comment has been found to be "improper, injudicious, beyond dignity in every sense of the term, in bad taste" and prima facie violative of the provisions of the Model Code of Conduct and its advisory to political parties. The EC has sought a response by 5 pm of May 20. The notice reminded the former Calcutta High Court judge about its recent advisory which said that political parties and candidates should refrain from any deeds or actions or utterances that may be construed as being repugnant to the honour and dignity of women.



Climate change affecting 85% of Indians: Survey

Severe heatwaves have impacted a large number of people in parts of India for three years in a row, affecting health, water availability, agriculture, power generation and other sectors of the economy

New Delhi, May 17: Eightyfive per cent of people surveyed in India say they are already experiencing the effects of climate change, and more than a third of them have either already moved or considered moving because of extreme weather events such as severe heat, droughts and floods.

Ninety-one per cent of 2,178 adults surveyed between September 5 and November 1 last year by the Yale Program on Climate Change Communication and CVoter are "worried about global warming". Eighty-five per cent of the people said they are already experiencing the

effects of climate change. Thirty-eight per cent had to go without enough clean drinking

water for at least one day in the past year and 72 per cent experience electricity disruptions on a typical day

According to the Yale Program Climate Change Communication-CVoter survey, more than 70 per cent of people think global warming affects weather in their local areas and monsoons in India but only 64 per cent usually receive warnings ahead of an extreme weather event.

While 86 per cent of the respondents favour India's commitment to achieving net-zero carbon emissions by 2070, 78 per cent say the government should be doing more to address global warming.

Sixty-one per cent think India should augment the use of renewable energy while only 14



per cent think the country should expand the use of fossil fuels.

India accounts for nearly 18 per cent of the global population but uses only 6 per cent of the world's primary energy, according to the International Energy Agency.

However, due to its large population, India is currently the third-largest greenhouse gas emitter behind China and the US. Research shows India is

among the countries most vulnerable to climate impacts. Climate change has already begun to alter growing seasons in the country and, with around 50 per cent of its population engaged in agriculture and other climate-sensitive sectors, the damage to productivity and health is significant.

According to the independent think tank Council on Energy, Environment and Water, more

Zelenskyy signs law

Kyiv, May 17: Ukrainian President Volodymyr Zelenskyy signed a law allowing some categories of convicts to serve in the army, parliament's database showed Friday.

A separate law enhancing fines for those not abiding by army mobilization rules was signed as well, its entry on the parliament's website showed.

Manpower has long been an issue for Kyiv's military as it fights a much larger and betterequipped foe. The problem has grown more acute in recent months, prompting authorities to introduce stricter measures for draft evaders.

The new law offers parole to convicts who sign a contract to ioin the army, a move that some officials have said could generate a maximum of 20,000 soldiers for the Ukrainian war effort.

Those convicted of the most serious crimes, such as the premeditated murder of two or more people, rape and crimes against national security, would still not be allowed to enlist.

Separately, Zelenskyy signed a law increasing fines for draft dodgers to up to 8,500 hryvnias (\$218), according to the parliament's website. The average monthly wage in Ukraine is about \$560.

The lack of manpower is seen by some military analysts as Ukraine's biggest problem. Weapons supplies that have been significantly delayed, particularly from Washington, are expected to reach the frontline soon.

Ukraine has already lowered the draft mobilisation age from 27 to 25. The upper limit is 60.

In tandem, the government has also temporarily suspended consular services for men of military age who reside abroad, complaining they were not helping the Ukrainian state fight for

Taiwan lawmakers exchange blows

Taipei, May 17: Taiwanese lawmakers shoved, tackled and hit each other in parliament Friday in a bitter dispute about reforms to the chamber, just days before President-elect Lai Ching-te takes office without a legislative majority.

Even before votes started to be cast, some lawmakers screamed at and shoved each other outside the legislative chamber, before the action moved onto the floor of parliament itself.

In chaotic scenes, lawmakers surged around the speaker's seat, some leaping over tables and pulling colleagues to the floor.

Though calm soon returned,

the Kuomintang (KMT), has more seats than the DPP but not enough to form a majority on its own, so it has been working with small Taiwan People's Party (TPP) to promote their mutual ideas.

Peace in South Sudan: Govt, rebels sign declaration



Nairobi: The government of South Sudan opposition groups Thursday signed a 'commitment

declaration" for peace during high-level mediation talks in Kenya, described as key step in efforts to end the conflict in South Sudan that has long crippled its economy. The content of the agreement was not made public during the signing ceremony, attended by diplomats and civil society groups. The rebel opposition groups were not part of the 2018 agreement that ended South Sudan's five-year civil war that left 400,000 people dead and millions displaced. Kenya's foreign office said the agreement was a "first milestone" in the ongoing talks in which warring sides pledged their commitment to end the violence and hostilities. South Sudan is due to hold elections in December but remains politically fragile, in part because the 2018 peace agreement is vet to be fully implemented and because conflict and violence continues in different parts of the country over ethnic and political differences.

Visa-free group travel between Russia, India soon

Moscow: Consultations between Russia and India on a bilateral agreement to ease travel will begin in June, a Russian minister has said, adding that tourism ties by launching visa-free group tourist exchanges. "India is at the final stage of internal state coordination," Nikita Kondratyev, director of the Russian Economic Development Ministry's Department of Multilateral Economic Cooperation and Special Projects, was quoted by RT News as saying Wednesday. The minister at the sidelines of the International Economic Forum "Russia Islamic World: KazanForum 2024" in Kazan said the first discussion on a draft agreement was scheduled to take place in June, and a signing was expected by the end of the year. "Russia and India are set to strengthen their tourism ties as they gear up for the launch of visa-free group tourist exchanges. The first

round of consultations between the two nations is scheduled for June, with an aim to finalise a bilateral agreement by the end of the year," the minister said.



Joint child custody to divorced parents in Japan

Tokyo: Japan's parliament Friday passed a revision to code that will allow divorced parents the option of joint child custody, a change that brings the nation in line



with many other countries. The revision, the first to custody rights in nearly 80 years, is to take effect by 2026. It will allow divorced parents to choose either dual or single custody while requiring them to cooperate in ensuring their children's rights and wellbeing. Under the current law, child custody is granted to only one divorced parent, almost always the mother. The change comes as divorces are increasing in Japan and a growing number of divorced fathers hope to stay in touch with their children. A number of high-profile allegations by divorced foreign fathers of child abductions by former partners who returned to Japan also encouraged the change. The revision requires the sharing of child rearing costs by the parent who is not the main custodian. Currently, most divorced mothers, who often are part-time workers with low incomes, do not receive financial support from their former husbands.

Abu Dhabi sees first brewery open as UAE eases alcohol laws

Abu Dhabi, May 17: In 2018, Chad McGehee opened Side Hustle Brews and Spirits, an Abu Dhabi-branded brewery and distillery with funky camels on its cans and playful names familiar to anyone living in the United Arab Emirates.

The only problem was it was illegal to produce alcohol in the country, so his company made its hoppy India pale ale in the United States and it then imported to the UAE for sale.

That's all changed as Abu Dhabi has overhauled its laws to allow for the micro and craft breweries that have taken the rest of the world by storm, part of a wider reconsideration of alcohol policies in the Islamic nation increasingly drawing tourists. And McGehee's dream

of IPAs in Arabia became a reality - though it took hard work as they were the first to open.

"The government had created a regulation around fermentation, but the steps of getting a permit, the steps of inspection, all of these things were not put on paper yet. So that had to be built out as we were going through this process," McGehee said on a recent afternoon at his brew pub on Abu Dhabi's Al Maryah Island.

Abu Dhabi long has been considered by those living in the UAE to be more buttoned-up than the rambunctious neighbouring emirate of Dubai, home to night clubs, beach bars and pubs drawing tourists and residents to imbibe. In the seven emirates of the UAE, Sharjah outright bans the sale and consumption of alcohol, like neighbouring Saudi Arabia, as well as



Iran and Kuwait.

But beginning in 2020, Abu Dhabi changed its policies. It eliminated its licensing system for alcohol purchases for drinkers to boost sales and tourism during the coronavirus pandemic. Eliminating the licenses allowed Muslims, if they chose, to drink, as well as decriminalised alcohol possession for those without a license.

The Emirates still maintains a strict no-tolerance policy on drunken driving and public intoxication. Islam also considers alcohol consumption as "haram", or forbidden.

But alcohol sales long have been a major driver of tax revenue and a moneymaker for the UAE. Dubai Duty Free, for instance, sold 6 million cans of beer last year, as well as 3.8 million bottles of liquor and 2.3 million bottles of whiskey for thirsty travellers.

But despite that demand, there was no local equipment available to open a brewery in the UAE. McGehee ended up importing almost everything for the brewery, nearly all of it coming from the US.

Abu Dhabi represents a completely untapped market for Side Hustle.


"The idea for me was like going back in time, when I started almost 20 years ago," said Mitchell Dougherty, Side Hustle's brewmaster.

At any given point, Craft has

14 beers on tap. So far this year they have brewed 34 and aim to reach up to 100 by the end of the year. The names of the beers include some winking reminders of life in the UAE, including one called "Massage Card Ninja" a nod to business cards showing scantily clad women that appear under car windshield wipers in some Dubai neighbourhoods.

McGehee said the different types of beers include ingredients from the Czech Republic, the United Kingdom, Japan and the US, covering a variety of palates for their international customers.

"If you look at Abu Dhabi, you have people from almost 200 countries," he said. "They all have their own definition of what beer is, what craft beer is, or what lager is, or what IPA is,so we're trying to cater to as

NEPAL BANS EVEREST, MDH SPICES

After Singapore and Hong Kong, Nepal has banned the consumption and sale of Spices made through Everest and MDH amid concerns over traces of harmful chemicals in the products. As per reports, Nepal's Food Technology and Quality Control Department has started testing two Indian brands of spices for cancercausing pesticide ethylene oxide. This decisive action marks a significant step in Nepal's efforts to ensure food safety and protect public health. Nepal's Food Technology spokesperson, Mohan Krishna Maharajan said, "The import of Everest and MDH brand spices has been banned. We have also banned their sale in the market. This decision confirms the presence of harmful chemicals in the spices.

Chairman Ashwin Nayak said that misinformation is being spread about EtO, which according to him, is widely used

across the world and Indian firms are exporting EtO-treated spices to the US for nearly 30 to 40 years now.

"EtO is not a pesticide which is directly sprayed on crops. EtO is an gaseous agent used only by approved organisations to remove or control harmful microbiological and bacterial elements from the spices, such as E. coli, coliform, aflatoxins and yeast. This is a widely used technique in most parts of the world," Nayak told reporters.

According to the co-chairman of FISS, U Karthik, most countries have set their own maximum residue limit (MRL) of EtO. For example, the US allows spices with 7 ppm (parts per million), while the same is 0.1 for the European Union

Creditors' haircuts in bankruptcy cases rises to 73% in FY24

Mumbai, May 17: The haircuts taken by creditors in bankruptcy resolutions have increased to 73 per cent in FY24 from the 64 per cent in FY23, a report said

A total of 269 resolution plans were approved by the National Company Law Tribunals (NCLTs) in FY24, up from 189 in the year-ago period, the report by domestic rating agency



The new admissions declined to 987 in FY24 from the 1,263 in FY23, the agency said, attributing the same to a higher base in the previous fiscal because of the Covid-19 pandemic-related stress. It can be noted that the hair-

cuts, or sacrifices, in comparison to the total dues, which are done by lenders when it comes to corporate insolvency resolutions has led to some concerns in the past about the value at which a new bidder is getting the assets.

Its group head for structured finance ratings, Abhishek Dafria said there has been a "worsening" of the haircuts which are taken by the creditors through the Insolvency and Bankruptcy Code (IBC) process to a steep 73per cent as against 64 per cent in FY23, which was already high.

He said the average time taken for a resolution has increased to 843 days in FY24, up from 831 days in 831 days because of the litigations, and called it out as among the reasons why the haircuts have also gone up. It can be noted that the bankruptcy law envisaged a resolution to take 330

The agency feels the average recoveries for lenders will continue to be in the 30-35 per cent__ range in FY25.

Dafria said the increase in the number of CIRPs (corporate insolvency resolution process) to 269 has been heartening, and added that an entity continues

as a going concern through this. The decline in fresh additions has helped to bring down the ongoing CIRPs at NCLTs to 1,920 as March 31, 2024, from 1,953 a year ago.

In addition to the CIRPs, the NCLT also passed liquidation orders for 446 corporate debtors in FY24 against 400 corporate debtors in FY23. The number of CIRPs that have resulted in liquidation continues to be significantly high, at 45 per cent of the 5,467 closed CIRPs, since the

inception of IBC, it said. Only 17 per cent yielded a resolution plan with the remaining cases withdrawn post NCLT admission, the agency said, adding that liquidation for 960 corporate debtors had been completed by March 2024 wherein the creditors realised a paltry 4 per cent of their total admitted

UN revises India's for 2nd day in row growth forecast

The 6.9% economic growth projections for *India* in the mid-year update is an upward revision from the 6.2% *GDP* forecast made by the UN in January

United Nations, May 17: The United Nations has revised upwards India's growth projections for 2024, with the country's economy now forecast to expand by close to seven per cent this year, mainly driven by strong public investment and resilient private consumption.

The World Economic Situation and Prospects as of mid-2024, released Thursday, said, "India's economy is forecast to expand by 6.9 per cent in 2024 and 6.6 per cent in 2025, mainly driven by strong public investment and resilient private consumption. Although subdued external demand will continue to weigh on merchandise export growth, pharmaceuticals and chemicals exports are expected to expand strongly.

The UN World Economic Situation and Prospects (WESP) 2024 report that was launched in January had said that growth in India was projected to reach 6.2 per cent in 2024, amid robust domestic demand and strong growth in the manufacturing and services sectors. The projection in January for India's GDP growth for 2025 remains unchanged at 6.6 per cent in the latest assessment of the economic situation.



The update said that consumer price inflation in India is projected to decelerate from 5.6 per cent in 2023 to 4.5 per cent in 2024, staying within the central bank's two to six per cent medium-term target range. Similarly, inflation rates in other South Asian countries declined in 2023 and are expected to decelerate further in 2024, ranging from 2.2 per cent in the Maldives to 33.6 per cent in Iran. Despite some moderation, food prices remained elevated in the first quarter of 2024, especially in Bangladesh and India.

In India, labour market indicators have also improved amid robust growth and higher labour force participation, it said. India's government remains committed to gradually reduce the fiscal deficit, while seeking to increase capital investment.

South Asia's economic outlook is expected to remain strong, supported by a robust performance of India's economy and a slight recovery in Pakistan and Sri Lanka. Regional GDP is projected to grow by 5.8 per cent in 2024 (an upward revision of 0.6 percentage points since January)

UN reports improved prospects for the world economy and forecasts 2.7% growth in 2024

and 5.7 per cent in 2025, below the 6.2 per cent recorded in 2023.

However, still tight financial conditions and fiscal and external imbalances will continue to weigh on South Asia's growth performance. In addition, potential increases in energy prices amid geopolitical tensions and the ongoing disruption in the Red Sea pose a risk to the regional economic outlook, it said.

The world economy is now forecast to grow by 2.7 per cent in 2024 (an increase of 0.3 percentage points from the forecast in January) and 2.8 per cent in 2025 (an increase of 0.1 percentage points).

The upward revisions mainly reflect a better outlook in the United States, where the latest forecast points to 2.3 per cent growth in 2024 (an upward revision of 0.9 percentage points since January), and several large emerging economies, notably Brazil, India and Russia.

It noted that several large developing economies – Indonesia, India and Mexico - are benefiting from strong domestic and external demand. In comparison, many economies in Africa and Latin America and the Caribbean are on a low-growth trajectory, facing high inflation, elevated borrowing costs, persistent exchange rate pressures and lingering political

New Delhi, May 17: Be it international or domestic, more Indians are travelling than ever before, claims a new report, as a whopping "97 million passengers" travelled through Indian airports in the first three months of 2024 alone.

"Travel Trends 2024: Breaking Boundaries", conducted by the Mastercard Economics Institute (MEI), provides comprehensive insights into the evolving landscape of the travel industry across 74 markets, including 13 in the Asia Pacific region (APAC).

"In 2024, fuelled by a growing middle class and expanded route capacity, more Indians are travelling internationally than ever before. In the first three months of 2024. 97 million passengers travelled through Indian airports. Just 10 years ago, the same



port. While domestic air passenger traffic surged 21 per cent above 2019 levels, international travel rose by 4 per cent.

Indian travellers, according to the report, are increasingly exploring key markets, with a 53 per cent increase in visits to Japan, a 248 per cent growth to Vietnam, and a 59 per cent rise in visits to the United States, compared to 2019, despite a stronger US dollar.

Also, Amsterdam, followed by Singapore, London, Frankfurt, and Melbourne are the top five trending destinations that Indian

It is a non-profit company, which has formulated a set of standards for voluntary adoption by sellers or logistics providers or payments gateway operators. He was addressing media after



INDIA FORCED TO CONCEDE PARIS QUOTA FOLLOWING PARVEEN'S SUSPENSION

India to fight afresh for 57kg

New Delhi, May 17: In an unprecedented embarrassment for Indian boxing, the country will fight afresh for qualification in the women's 57kg category after being forced to surrender the quota owing to holder Parveen Hooda's international suspension for three whereabout failures in 12 months.

Hooda was handed a 22-month suspension by the World Anti-Doping Agency (WADA). The 2022 world championship bronze medallist boxer, who fetched the Olympic quota with an Asian Games bronze last year, failed to file her whereabouts in the period from April 2022 to March 2023 as per WADA rules.

"Parveen Hooda has been suspended for 22 months by the International Testing Agency (ITA) for Whereabouts Failures, the Boxing Federation of India said in a media release.

However, after discussion with the concerned agencies. Parveen's sanction has been back-dated and she has to now serve a 14-month suspension starting Friday.

"Pursuant to multiple discussions and representations, the ITA has proposed a sanction on Parveen, entailing the imposition of an ineligibility period of 22-months, which has been now backdated by eight months as compared to initial suspension period of 24 months backdated by six months. In essence the sanction is of 14 months, starting from May 17, 2024."

This means Parveen will not be able to compete at the Paris Games in July-August this year.

In boxing, a quota is awarded to the athlete not the country. This leaves only three Indian boxers - Nikhat Zareen (50kg), Preeti (54kg) and Lovlina Borgohain (75kg) – in the Olympic-bound group for now.

With the final Olympic qualifier scheduled to begin May 24 in Bangkok, India will have another chance to qualify for the women's 57kg weight category. But the country can only field reserves who were registered by April 11. "...which means that



only two boxers, named as reserves in 60kg and 66 kg category, are eligible to compete in Bangkok," the BFI stated.

Athletes included in the Registered Testing Pool (RTP) must provide full address of their overnight location, the name and full address of each location where they train, work or conduct other regular scheduled activities, as well as the usual time-frames of each ac-

World No.1 golfer Scheffler detained

Louisville (US), May 17: Masters champion Scottie Scheffler was detained by police Friday morning on his way to the PGA Championship, with stunning images showing him handcuffed as he was led to a police car. ESPN reported he failed to follow police orders during a pedestrian fatality investigation.

Traffic was backed up for about a mile in both directions on the only road that leads to Valhalla Golf Club, with dozens of police cars flashing red-and-blue lights near the entrance.

Police said a pedestrian had been struck by a bus while crossing the road in a lane that was dedicated to tournament traf-

ESPN said Scheffler, the No. 1 player in the world who was to start the second round at 8:48 a.m., drove past a police officer in his SUV with markings on the door indicating it was a PGA Championship vehicle. ESPN said Scheffler drove past an of ficer, who screamed at him to stop and then attached himself to the car until Scheffler stopped about 10 yards later.

Jeff Darlington of ESPN watched this unfold. He said police pulled Scheffler out of the car. pushed him up against the car and immediately placed him in handcuffs. "Scheffler was then walked over to the police car,



placed in the back, in handcuffs, very stunned about what was happening, looked toward me as he was in those handcuffs and said, 'Please help me',' Darlington said. The PGA of America did not immediately have a comment.

Darlington said police were not sure who he was. He said an officer asked him to leave and when he identified himself being with the media, he was told, "There's nothing you can do. He's going to jail."

Darlington said another police officer later approached with a notepad and asked if he knew the name of the person they put in handcuffs. Scheffler opened with a 4-under 67 and was five shots out of the lead as he tries to become only the fifth player since 1960 to win the first two majors of the year.

Swiatek to play -Sabalenka in final

Rome, May 17: The top-ranked Iga Swiatek extended her winning streak to 11 matches with a 6-4, 6-3 victory over US Open champion Coco Gauff and she will face second-ranked Aryna Sabalenka in the Italian Open final.

Swiatek is attempting to complete the "dirt double" by winning the Madrid Open and Italian Open back-to-back. Sabalenka got rid of Danielle Collins 7-5, 6-2 to hand the retiring American only her second loss since early March. It's a rematch of the Madrid final.

Unlike most Americans who can't find their footing on clay when they come to Europe, Tommy Paul feels right at home on the red dirt. That's because he grew up playing on the surface in Greenville, North Carolina

Paul beat ninth-ranked Hubert Hurkacz 7-5, 3-6, 6-3 Thursday to reach the Italian Open semifinals and follow up his straight-set victory over defending champion Daniil Medvedev two days earlier.

It's the best result on red clay of his career. At least at the senior level. Paul broke the big-serving Hurkacz seven times but also dropped his own serve six times. As a junior, Paul won the French Open boys' title in 2015.

In the semifinals, the 16th-ranked Paul will face Nicolas Jarry, who rallied past Monte Carlo Masters champion Stefanos Tsitsipas 3-6, 7-5, 6-4. Before beating Medvedev, Paul had never defeated a top-20 player on clay. Now he's defeated two top-10 players back-to-back for the first time in his career on any surface.

LSG SIGN OFF WITH WIN OVER MUMBAI

Mumbai, May 17: Nicholas Pooran (75, 29b, 5x4, 8x6) was absolutely destructive with the willow and having some support from a sedate knock by skipper KL Rahul (55, 41b, 3x4, 3x6) helped Lucknow Super Giants to a comfortable 18-run win against Mumbai Indians, Friday. It was the last match for both the sides in this season's IPL. LSG ended their campaign with 14 points while MI finished at the bottom of the table with only eight points.

Pooran and Rahul contrasting knocks led LSG to 214/6 after being invited to bat. In response, MI could reach 196/6, courtesy a splendid start by Rohit Sharma (68, 38b, 10x4, 3x6) and stunning late counter attack by Naman Dhir (62 n o, 28b, 4x4, 5x6).

Chasing a challenging 215-run target, MI were looking on course for a win with Rohit playing the

aggressor's role in 88-run opening stand with the South African Dewald Brevis (23). There was a rain-interruption when MI were 33/0 in 3.5 overs.

However, MI lost three wickets Brevis off Naveen-ul-Haq (2/50), Suryakumar Yadav off Krunal Pandva (1/29) and Rohit off Ravi Bishnoi (2/37) – in just 14 deliveries to be reduced to 97/3 in 10.5overs. Dhir, who joined Ishan Kishan (14) at 120/5 in the 15th over, struck some boundaries to the delight of Wankhede crowd as the duo stitched 68 runs for the sixth wicket.

Earlier, Pooran's whirlwind knock covered for Rahul's sedate innings, providing a muchneeded impetus to LSG's impressive total. LSG could only manage 69/3 at the halfway stage but Pooran's stunning knock made up for another shoddy

powerplay effort by Rahul. On their part, MI's bowling

woes persisted with skipper Hardik Pandya using as many as eight different bowling options but only seasoned Piyush Chawla (3/29) and Nuwan Thushara (3/28) were impressive.

Pooran's dismissal in the 17th over followed Rahul's exit after their 44-ball stand for 109 runs for the fourth wicket, which gave LSG the platform to push for a total exceeding 200.
