

UK GOES TO POLLS JULY 4

AGENCIES

London, May 22: Rishi Sunak, Britain's first Prime Minister of Indian heritage, Wednesday announced that the UK's general election will be held July 4, saying it is time for the country to choose its future.

In an address from the lectern on the steps of 10 Downing Street on a rainy London evening, Sunak confirmed a summer poll in six weeks' time and that the Parliament would soon be dissolved after he formally informed King Charles III of the election timeline. The announcement comes as the governing Conservative Party is forecast for a general election drubbing by most opinion polls, with the Opposition Labour Party holding a firm lead after a series of recent byelections and local election victories.

The 44-year-old leader laid out his record dating back to his term as finance minister during the COVID lockdowns in his pitch to the British electorate, who will soon give their verdict at the ballot box.

"Earlier today, I spoke with His Majesty the King to request the dissolution of Parliament and the King has granted this request and we will have a general election on the fourth of July," said Sunak, as he was drenched in the pouring rain.

HUGE DIFFERENCE

It seems the apprehensions about the actual number of votes cast during initial four phases of the ongoing general elections are coming true with the Congress party flagging a whopping dif-ference of 1.7 crore votes between the EC's final turnout figures and the real-time data. This comes in the backdrop of a petition filed by poll watchdog ADR in the Supreme Court demanding the EC to upload an account of votes recorded at all polling stations 48 hours after the end of polling in each phase. The top court has scheduled the hearing on the petition May 24.

New Delhi, May 22: The Congress Wednesday raised questions over the big difference between the real time voter turnout data and the final figures released by the Election Commission (EC), and said voters are worried over the "strange goings-on" in the poll body.

Congress leader and head of media and publicity department of the party Pawan Khera said the difference is around 1.7 crore votes, and termed it as "unprecedented".

"Voters are worried about the strange goings-on in the Election Commission through the four

phases of voting. First, the Election Commission takes 10-11 days to bring out the final figure of voting and then the difference between real time data and final figure turns out to be 1.7 crore votes. This is truly unprecedented," Khera said on X.

"Unanswered questions about the missing EVMs are also very worrying," he added.

AICC general secretary Jairam Ramesh said, "This difference of 1.07 crore overall translates into an increase of 28,000 in each LS seat. This is HUGE.'

"The discrepancy is maximum in states where BJP is expected to lose seats heavily. What is happening?" Ramesh asked.

Even though the business end of India's mammoth seven-week long election comes closer, the EC has been facing public ire over not releasing the exact voter turnout numbers and instead supplying only the percentage of voter turnout.

TMC joins chorus **NEW DELHI:** The Trinamool Congress

Wednesday voiced concern over the Election Commission (EC) "not releasing" the actual numbers of voter turnout in the ongoing general elections, and questioned why the BJP is the only party that has not sought this information so far. In a post on X, TMC Rajya Sabha MP Saket Gokhale shared a copy of an application filed by him under the RTI Act May 1 and said he has not received any reply from the EC. Gokhale had asked the EC to furnish the details of the total number of electors, total number of voters, and total turnout for voting in the 102 Parliamentary constituencies that went to polls in the first two phases.

India DY Chandrachud, Justices JB Pardiwala and Sanjiv Khanna sought a response within a week from the EC on the application filed by ADR.

The poll body has only been releasing the voter turnout percentage in stark contrast to 2019 general elections, when it published data with actual total voters and gender-wise breakup with absolute numbers.

Other Opposition parties have also raised questions over the delay in release of final voter turnout. Lok Sabha polls are being held in seven phases and the results will be declared June 4.

Fresh hurdle for Patra

Bhubaneswar, May 22: Ruling Biju Janata Dal (BJD) Wednesday lodged a complaint with the Election Commission (EC) against BJP's Puri Parliamentary Constituency candidate Sambit Patra for using a photo of Srimandir in an advertisement issued by him in the local

Election Commissioner Rajiv Kumar, the BJD highlighted that the full-page advertisement featuring Patra's picture with Srimandir in the background also had the BJP's lotus symbol. The BJD also noted that

Patra made an offensive comment Monday stating that Lord Jagannath is the devotee of Modi, which severely affected the sentiments of millions of Odias worldwide.

Although Patra later clarified that his remark was inadvertently made and expressed regret, the BJD argued that the advertisement violated the Model Code of Conduct for political parties and candidates.

But the issue here is issuing a full-page advertisement with his photo and the temple in background along with party symbol. "We strongly object to it and consider this to be a violation of the poll code for political parties and candidates," the BJD said. The party demanded that immediate action be taken against Patra,

with a formal notice issued and made public. They also argued that

since Patra's picture appeared in the advertisement, the expenditure should be accounted under his personal campaign expenses, not the party's. The BJD estimated the total cost of the advertisement at around ₹2.5 crore.

They also noted that expenses for the Prime Minister's roadshow in support of Patra have not been allocated to his campaign expenses account. The BJD urged the EC to ensure that all related expenses be appropriately recorded in Patra's expense account.

Neither BJP, nor Patra was available for comment.

Turbulence terror takeaway: Buckle up CLEAR-AIR TURBULENCE CANNOT BE SEEN AND IS VIRTUALLY UNDETECTABLE WITH CURRENT TECHNOLOGY,

MAKING IT ALL THE MORE IMPORTANT FOR PASSENGERS TO WEAR SEATBELTS WHENEVER SEATED

Chicago, May 22: Buckle up. That is the message from flight attendants and pilots following the severe turbulence encountered by a Singapore Airlines flight Tuesday that resulted in the death of one passenger and injured dozens of

The London-to-Singapore flight hit heavy turbulence over the Indian Ocean and descended 6,000 feet in about three minutes, before an emergency landing in Bangkok.

Weather forecasting service AccuWeather said satellite and lightning data showed "explosive thunderstorms" developing close to the flight path. Developing thunderstorms can leave pilots with little time to react, it said.

Airlines are required by law to switch on the seatbelt

A witness on the Singapore Airlines flight said numerous people who were not in their seatbelt were thrown around the cabin when the plane dipped, many hitting their

plane encountered sudden, extreme turbulence.

Sara Nelson, international president of the Association of Flight Attendants-CWA representing over 50,000 at 20 airlines, said initial reports seemed to indicate clearair turbulence, considered to be the most dangerous

type of turbulence. Clear-air turbulence cannot be seen and is virtually undetectable with current technology, making it all the more important for passengers to wear seatbelts whenever seated, she said. "It is a matter of life and death," Nelson said.

The Air Line Pilots Association (ALPA), which represents more than 77,000 pilots at 41 US and Canadian airlines, echoed that message, saying the safest way for passengers to protect themselves is by making sure their seatbelts are always fastened.

Turbulence-related airline accidents are the most common type of accident, a 2021 study by the US National Transportation Safety Board said.

Most recently, in March, a Boeing 787 plane operated by LATAM Airlines dropped abruptly mid-flight, causing injuries to more than 50 people.

Bhubaneswar, May 22: A lowpressure area has formed in the Bay of Bengal (BoB) and under its influence northern Odisha districts are likely to receive rainfall, the India Meteorological Department (IMD) said Wednesday.

The fishermen out at sea are advised to return to the shore by May 23, it said.



The researchers found that while the brains of the babies of monolingual mothers had learned to respond in a heightened manner to the pitch of one language, those of the babies of bilingual mothers seem to have become sensitive to a wider range of pitches, without giving a heightened response to any one of them. The findings are published in the journal Frontiers in Human Neuroscience.

Studies have estimated the global bilingual population to be from 43 per cent to over 50

per cent, with bilingualism or multilingualism being the norm in many countries

"Languages vary in the timing aspects of speech, such as rhythm and accentuation, but also pitch and phonetic information. This means that fetuses from bilingual mothers are expected to be immersed in a more complex acoustic environment than those from monolingual mothers,' said co-corresponding author Carles Escera.

Escera is a professor at Sant Joan de Déu Barcelona Children's Hospital, from where the researchers recruited mothers of 131 one-to-three-day-old newborns for the study

Responding to a questionnaire, 41 per cent of the mothers said they spoke exclusively Spanish or Catalan, which is related to Spanish and spoken in Catalonia in eastern Spain. The remaining were bilingual - most of them speaking Spanish and Catalan. Other languages spoken by some of the bilingual mothers in-



cluded Arabic, English, German and Portuguese.

The researchers measured the babies' specific responses to four types of sounds lasting 0.25 seconds long. The sounds were of vowels used in both Spanish and Catalan.

"Here we show that exposure to monolingual or bilingual speech has different effects at

birth on 'neural encoding' of voice pitch and vowel sounds: that is, how information about these aspects of speech has been initially learned by the foetus, said co-first author Natàlia Gorina-Careta, a researcher at the University of Barcelona.

"At birth, newborns from bilingual mothers appear more sensitive to a wider range of acoustic

Tuberose farmers lament lack of marketing facilities

Berhampur, May 22: Cultivation of tuberose (Rajanigandha) flowers is a lucrative business. If marketed properly, it is a source of substantial earnings for farmers. However, lack of marketing facilities is having an adverse impact on tuberose farmers in Ganjam district, locals informed Wednesday. The effort and energy spent in producing tuberose flowers pales in comparison to the meagre amounts earned, they added.

Rajanigandha flowers are mainly cultivated in Digapahandi and Hinjilicut blocks of Ganjam district. More than 100 acres of land are used for production of Rajanigandha flowers, officials of the district Horticulture department informed Farmers however, alleged that as the state government has not put up a proper marketing system in place, they have to incur heavy losses.

Ralabha village under Hinjilicut block is famous for its Rajanigandha cultivation. In fact, the place has been nicknamed 'Rajanigandha village'. Rajanigandha cultivation in the village started after the 1999 Super Cyclone. A resident of the village Jhumar Dalai, along with some young farmers started tuberose cultivation. Now more than 107 families of the village are engaged in the cultivation of Rajanigandha. Each of the families cultivates tuberose on lands measuring 0.4 acre to one acre. The daily

production ranges from 300-400kgs. Flowers are supplied to florists in this city, Aska, Sorada, Bhanjanagar, Bhubaneswar, Bhawanipatna, Puri and Nabarangpur.

"Tuberose flowers grown in Ralabha are in great demand in various parts of the state. The total income for all the families can be well over rupees one crore annually if the product is marketed properly," Kalu Charan Dalai, a young farmer informed.

The 'Krishi Vigyan Kendra' here is encouraging farmers of Ralabha village to take up cultivation of the

'Prajwal' variety of tuberose. It is a better product, officials said. "The new variety has two petals and hence weighs more. It is a better product for making garlands," opined chief and senior scientist of 'Krishi Vigyan Kendra', Dr Sujit Kumar Nath.

Scientists are also training the Rajanigandha farmers of Ralabha village by regularly organising discussion sessions. Farmers are attending workshops on soil testing, use of organic manures, benefits of using bio-fertilisers and phospho bacteria on their farmlands for better yields. Farmers have also welcomed this move, officials informed.

Rajanigandha farmers meanwhile informed that they get an annual financial assistance of ₹6,000 for cultivation of tuberose on 1.5 acres of land. They use the money to buy shoots and fertilisers, farmers said. However, they reiterated that absence of a proper marketing system is hurting them badly. They also lamented the lack of storage facilities. Farmers added that the government should address these issues.

When contacted, assistant director Subhash Chandra Panda of the district Horticulture department informed that recently the state government has fixed the selling price at ₹50 per kilogram for Rajanigandha farmers. He said that the collector of Ganjam has welcomed the move and will soon implement the rate in the district.

Despite the construction of a new parking bay at Angulia on the highway, illegal parking continues unabated. The parking bay was completed more than two years back, but

since then has remained non-operational. Had it opened for public use, parking issues would have been solved to a great extent, locals said Absence of street

lights, CCTV cameras and speed-breakers are other reasons why the stretch has turned into a death trap, observed local resident

Prasanna Kumar Behera. Others in cluding Tankadhar Patra and Madhay Chandra Behera pointed out that the apathy of the NHAI in solving the issues is creating confusion. The three alleged that NHAI collects

tolls from commuters who travel from Keonihar to Barbil at two counters, but does nothing to improve the condition of the road or prevent illegal parking. They along with a few others threatened long-term agitation if the NHAI does not take preventive measures to stop illegal parking and improve the deplorable road conditions found at various stretches of NH-520.

Deterring Aggressors

t the signing ceremony of the North Atlantic Treaty on 4 April, 1949, then-US President Harry Truman remarked that if this "simple document" had existed in 1914 and 1939, "it would have prevented the acts of aggression which led to two world wars." The newly established alliance, he suggested, would ensure peace by deterring po-

The success of this collective security strategy is reflected in the number of countries that have taken advantage of NATO's open-door policy. Since 1949, the alliance has expanded from 12 to 32 members, with Finland and Sweden being the most recent additions. Now, member countries must commit to admitting Ukraine.

Bringing Ukraine into NATO is important for several reasons. For starters, any doubt about the alliance's commitment to defend current or prospective members invites aggression. Russia is a case in point. The decision to shelve Ukraine and Georgia's membership aspirations during the 2008 Bucharest summit led to Russia's invasion of Georgia later that year. Similarly, turning a blind eye to Russia's 2014 annexation of Crimea resulted in the full-scale invasion of Ukraine in 2022. Failing to defeat Russia in Ukraine would inevitably lead to more wars

of aggression. But by admitting Ukraine, NATO could tip the balance decisively in its favour and dispel any doubt about the alliance's future, ensuring a lasting peace.

Moreover, appearing fearful of escalation or allowing its actions to be dictated by another power could push NATO into a death spiral. Giving in to threats would just lead to more threats and concessions. And if Ukraine falls, Estonia, Poland, Finland, or Taiwan will be next.

One of the basic tenets of NATO's Cold War strategy was that force must be met with even greater force. In 1946, the late American diplomat George Kennan summarised this strategic principle, explaining that while the Soviet Union was "impervious to the logic of reason," it was "highly sensitive" to the "logic of force." Whenever its aggression met strong resistance, it retreated.

The following decades vindicated Kennan. When Western powers showed they were determined to protect West Germany and South Korea during the Cold War, the Soviet Union backed down. Conversely, when the West hesitated, the Soviets at-

While US President Dwight Eisenhower's invocation of the United Nations Charter failed to deter the USSR from invading Hungary in 1956, his successor, John F. Kennedy, spared West Berlin from meeting the same fate. Similarly, the West's lackluster response to the Soviet-led invasion of Czechoslovakia in 1968 was followed by the Soviet invasion of Afghanistan in 1979.

By refusing to set a clear timetable for Ukrainian accession, NATO is capitulating to Russia's demands, signaling to President Vladimir Putin that his dream of restoring the Russian empire is feasible and thus making World War III all but inevitable.

Russia's invasion of Ukraine exposed NATO's vulnerabilities. German Chancellor Olaf Scholz recently declared that Germany is willing to send 35,000 troops to defend "every square foot" of NATO territory. But that commitment, while significant, pales in significance when one considers that 500,000 Russian troops are currently fighting in Ukraine. Moreover, the European defense industry has proven unable to supply Ukraine with sufficient weapons and equipment.

Had Ukraine fallen in three days, as many "experts" predicted in early 2022, Russian forces would now be in Kazakhstan, Moldova, and possibly the Baltic states and Poland. Given that Ukraine has the only European army that is both motivated and battle-hardened enough to resist Russia, admitting Ukraine would undoubtedly bolster NATO's military capabilities.

While some might argue that such a move would force the Kremlin to respond, it is highly unlikely to use nuclear weapons. The USSR posed a much greater nuclear threat, yet the West did not surrender to Soviet blackmail. As German Chancellor Konrad Adenauer put it in 1961, while the nuclear threats "directed from time to time against one or other of the NATO partners" were dangerous, the "Soviet government must know that by any such blow, it would touch off a counter-blow by

Was there truly zero probability of the USSR using nuclear weapons? Certainly not. But Western policymakers at the time understood that giving in to extortion would increase the likelihood of such an attack,

Lastly, the West must realise that Russia is already at war with NATO. The Kremlin is financing terrorism, engaging in disinformation campaigns, fueling domestic conflicts, meddling in the elections of democratic countries, and reportedly planning a sabotage campaign across Europe.

Unfortunately, Western democracies have been too slow to accept reality. While political leaders debated whether NATO "provoked" Putin and whether they should allow Putin to "save face," China and Russia have deepened their "no limits" military partnership and formed an "axis of upheaval" that is now threatening to undermine the US-led international order.

In 1988, then-US President Ronald Reagan explained that NATO is not about "today or tomorrow" but rather about "what Europe [will] look like in 15 years." While we cannot predict the future, two things are clear. If Ukraine falls, Europe could bleed for decades because Russia will not stop in Ukraine. Alternatively, with Ukraine as a member, the alliance could promote peace through deterrence, as it did during the Cold War.

The destinies of Ukraine, Europe, and NATO are inextricably linked. As French President Emmanuel Macron recently acknowledged, "Europe is mortal," and its demise may already be in sight. The acute threat posed by Russia's revanchist ambitions underscores the need for urgent action. NATO members must use the July summit in Washington to invite Ukraine to join the alliance.

RIGHT TO CLEAN ENVIRONMENT

MORE THAN 85% OF UN MEMBER COUNTRIES HAVE RECOGNISED THE RIGHT TO A **HEALTHY ENVIRONMENT**

o we have the right to a clean, healthy and sustainable environment? This is one of the most obvious questions missing during the ongoing general elections in India. Election manifestos of political parties - national and regional – have no pledges to provide the right to a healthy environment for all Indians if voted to power on 4 June. At best, environmental well-being is a non-issue. Can Indian voters especially the newly registered voters and future voters afford such a lapse?

While we are just completing the hottest decade of the century, is there any prime-time debate in electronic media on provisions of the right to a healthy environment? The earth is experiencing multiple crises that reinforce each other: climate change, water scarcity, loss of biodiversity, pollution, pandemics, wars and conflict leading to widening poverty and inequality. Among all, climate change is the defining crisis of our generation. It is faster than we project, predict and prepare.

In a historic, bold, and transformational intervention between people and the planet, in July 2022, the UN General Assembly (UNGA) adopted a resolution on "the right to a clean, healthy and sustainable environment as a human right.' Among 193 member countries, no one opposed this resolution while 161 voted for it, eight countries including India and Kyrgyzstan abstained from voting. It doesn't matter if the likes of India and Kyrgyzstan abstained as the highest court of India and the constitution of Kyrgyzstan have already spelt out the right to a healthy environment for their respective citizens. More than 85% of UN member countries have recognised the right to a healthy environment.

A healthy environment and human rights are interdependent and complementary to each other. Without one, the other is inadequate. Without a healthy environment, protecting, advocating and preserving various recognised human rights is incomplete and unattainable. But,

neither the Universal Declaration of Human Rights (1948) nor any other UN human rights instruments like the International Covenant on Civil and Political Rights and the International Covenant on Economic, Social and Cultural Rights, both adopted in 1966 by UNGA, were not able to spell out the environmental rights. In 1995, the UN Commission of Human Rights refused to adopt "the right to a secure, healthy and ecologically sound environment.'

Likewise, intergovernmental institutions like the World Bank, the European Bank for Reconstruction and Development and the Asian Development Bank (ADB) have maintained a stubborn reluctancy to accept environmental rights as human rights in their respective institutional policy documents. In the draft Environmental and Social Framework (2023), the ADB despite recognising the human rights of indigenous people and restricting child labour in unhealthy working conditions, has distanced itself from acknowledging the 2022 UNGA resolution on the obligation to provide the right to a healthy environ-

Interestingly, in more than 50 years of UN environmental summit declarations none have successfully linked environmental rights to human rights. The UN had come close to pronouncing the environmental rights in Principle 1 of the 1972 Stockholm Declaration (first UN Conference on Human Environment) as the "fundamental right to freedom, equality and adequate conditions of life, in an environment of a quality that permits a life of dignity and well-being." In the 1992 Earth Summit, the Rio Declaration avoided mentioning any environmental rights due to developed countries.

Nevertheless, the gradual codification of environmental rights as substantive rights in the form of safe climate, healthy ecosystems and biodiversity, safe and sufficient water, healthy and sustainable food and non-toxic environment has been emerging from regional treaties like the African Charter on Human and Peoples' Rights (1981), the American Convention on Human Rights (1988), the Arab Charter on Human Rights (2004), the ASEAN Declaration on Human Rights (2012). Simultaneously, explicit provisions of the right to a healthy environment in more than 100 national constitutions and judicial interventions and interpretations from more than 30 countries like in India in linking environmental issues to the rights to life and health have strengthened environmental rights.

Some of the recent judicial pronouncements related to pe

titions on the right to a healthy environment and climate change have drawn substantial attention. In August 2023 in Montana, the US, the Court ruled in favour of young people that the state must protect the right to a healthy environment for present and future generations. The Supreme Court of India on 5 April, 2024, for the first time, recognised the right against the adverse impacts of climate change, saying it is intertwined with the right to life (Article 21) and equality (Article 14) that are Fundamental Rights guaranteed by the Constitution of India. In the same month, the European Court of Human Rights, an international court, ruled that Switzerland had violated the rights of a group of older Swiss women to 'family life' as the country has failed to comply with its duties to stop climate change. In March 2024, the Inter-American Court of Human Rights found the Peruvian government responsible for violating the right to a healthy environment, among other rights, of residents of La Oroya, a town exposed to toxic pollution from a mine and smelter complex There are nearly 40 such climate change litigations in various national and international courts. Further, the UN Committee on the Rights of the Child issued new guidance in August 2023 that calls for governments to take action to protect boys and girls in the face of the deepening climate crisis.

Though there is no consensus on what constitutes a healthy environment, the right to a healthy, clean and sustainable environment has been positioned formidably to re-evaluate the state's obligations towards its citizens. The right to a healthy environment encourages the obligation of co-protection, co-conservation, co-preservation and comanagement of the ecosphere by the government and citizens. At last, the people and the planet are linked with the umbilical cord

This parliamentary election has seen a lot of talk of guarantees and new offers are being pledged during campaigning, now in its sixth phase. Will the guarantees come to the aid of the common man? Will the economy be able to bear the burden of the guarantees? The GDP growth rates that have been announced by various institutions of around 7% in the current fiscal are no doubt encouraging, but this may not be an indicator of the prevailing situation. As India strides on the path of rapid economic growth, it grapples with a number of challenges. In this race towards the future, the government cannot afford to neglect a major section of the population, which too must be given its share of the so-called prosperity.

It is here that welfare measures assume significance, though it appears that political parties may be talking about these only for garnering votes. But going through the guarantees on the face of it, it appears these are justified, keeping in view the need to uplift the conditions of the economically weaker sections. Some analysts have said that implementing these guarantees may result in fiscal profligacy, but these need to be overlooked from a broader perspective.

Recently, Finance Minister Sitharaman accused the Congress that it has made promises without calculating the cost of implementation. Accusing the UPA of 'fiscal short-sightedness', she asked its leader, Rahul Gandhi, to answer if the announcements made by him would translate into higher borrowings or higher taxes. Obviously, taxes would need to be increased. While the finance minister has kept the fiscal narrative, is she aware of the other side -- direct and/or indirect subsidies given to corporate houses by her government in the past five years or so? What has been the result of such subsidies to the rich? Employment generation has been negligible. Governance may have improved to some extent, but the 'pro-rich policy' of the ruling dispensation is being seen to be coming in the way of grassroots development.

Take the example of the issue of employment, which made a tangential entry into PM Modi's campaign speech. It seemed that

the PM was trying to defend the Opposition charge of the government's scant regard for generating employment. However, he sought to project employment merely as a corollary of government development projects, reeling off statistics on construction of roads, flyovers, railway tracks and factories and asking whether these initiatives would not have provided employment. It is believed that such infrastructure development does not result in permanent employment but provides contractual or informal employment where payments are rather poor.

While the public sector units are playing a key role, it is the private sector investment which has been lagging. Recall, former RBI Governor, Raghuram Rajan had observed: "I would love more Indians to have jobs outside agriculture, and manufacturing is certainly one important possibility. I have long been an advocate for enhancing domestic defence production wherever possible." He had expressed concerns about government policies regarding manufacturing as its labour-intensive sections have been 'ignored' even while offering enormous subsidies to areas like chip manufacturing. Though the finance minister contested Rajan's observation, the fact remains that there is a need to think much more seriously on employment generation. Even if the number of days of rural employment scheme are not increased, adequate funds should be provided so that the beneficiaries are assured of full 100 days' work, which unfortunately is not the case.

Many economists, including Nobel laureate Abhijit Banerjee, have suggested starting a similar scheme for the urban poor and that it could be started for say 75 days or so. They could be engaged in waste management operations, promoting urban forestry, cleaning and maintaining parks and gardens. Modi's bid to emerge strong and make India's presence felt in the global arena is welcome, but serious efforts must be made to ensure majority of the population is not left behind. The marginalised and backward sections need to be integrated into the development process. Poll guarantees should not be election time mantras.

Severe turbulence

Sir, The severe turbulence on the London-Singapore flight, carrying 211 passengers claiming one life and injuring at least 70 others has sent shockwaves across the world. A dramatic drop from 36000 feet to 31000 feet in a matter of seconds led to serious laceration injuries among fliers and the flight interiors were reduced into shambles: almost unheard of in modern aviation history. A study has said that climate change across the globe has made air travel bumpy, and this trend may further augment because climate change is never static. Wind shear, which is nothing but change in wind speed and/or direction over a short distance in jet streams, is increased by warm air from carbon dioxide emissions causing turbulence. These changes are consistent with climate shift. A better turbulence forecasting system and the most important protection system for anticipated or ongoing turbulence -- strapping into one's seat-- cannot be emphasised enough.

HC orders abolition of century-old practice



Nainital, May 22: The Uttarakhand High Court has directed the state government to totally abolish the system of revenue police within a year and hand over areas under its jurisdiction to regular police.

Uttarakhand is the only state in the country where the system of revenue police coexists alongside regular police.

Revenue police, which is manned by revenue department officials, has limited powers with only remote rural areas of the hill state coming under its ju-

Ritu Bahri and Justice Rakesh Kumar Thapliyal issued the order Tuesday while hearing a PIL seeking abolition of the

The high court had ordered removal of the nearly a centuryold practice of revenue police from the state also in 2018 while hearing a dowry death related case which was handled shoddily

by the revenue police.

Again in 2022, a division bench of the high court comprising the then Chief Justice Vipin Sanghi and Justice RC Khulbe passed similar orders while hearing a PIL which alleged that the investigation into the murder of resort receptionist Ankita Bhandari would not have been delayed if it came directly to regular police rather than being handled initially by revenue police.

The orders were passed in a PIL which said that had the government followed this order, there would not have been so much delay in the investigation of Ankita's murder.

The state cabinet also passed a resolution in October 2022 for abolishing the revenue police system in a phased manner.

In 2004, the Supreme Court, in the case of Navin Chandra vs State Government, had felt the need to abolish this system. The SC had observed that the revenue police are not given training like the regular police.

Lack of basic facilities makes it difficult for the revenue police to review a crime, it had said. The top court had also observed that there should be a uniform system of policing in



Pithoragarh, May 22: Uttarakhand Forest Department (UFD) has conserved a total of 2,447 plant species through in-situ and ex-situ methods across all seven ranges of the state, officials

said Wednesday. In-situ is the method of conserving the species, especially the wild and endangered species in their natural habitats and environment and ex-situ is the method in which a plant species is conserved outside its natural habitat.

The information was mentioned in the 5th annual report of the research wing of UFD, which was released on the occasion of the International Day for Biological Diversity.

"Our preservation programme is the biggest in Uttarakhand and one of the biggest in India and the world," head of the research wing and Chief Conservator of Forests Sanjeev Chaturvedi said.

The programme began in 2020 and covers all groups of plant

species in Uttarakhand, he said. The preserved species include 493 trees, 184 herbs, 168 shrubs, 46 bamboo species, 12 cane and 86 wild species, 107 types of grass, 191 ferns, 114 orchids, 88 palms, 20 cycads, 285 cacti and succulents, 50 acquific 28 insectivorous, 85 lichens, 107 bryobhyls 14 algae and 15 air plants,

Of these species under preservation, 59 are endemic to the Uttarakhand region, he said.

Chaturvedi said.

According to the report, the forest research wing initially took up the task of preserving 1,145 plant species when the wing was started in 2020.

'The number of preserved plants has doubled over the past four years," Chaturvedi said.

"Of these plant species under preservation, 109 are listed under threat category, 12 endangered category and 16 vulnerable category in the International Union for Conservation of Nature (IUCN) list," he said.

The issue of women's political representation extends beyond numerical quotas to encompass systemic changes in party dynamics and electoral processes noted Farhat Jahan, a retired faculty member at Abdullah Women's College at AMU.

Prof Mohammad Aftab Alam from Political Science department at AMU pointed out the challenges women often face in forming independent political opinions amidst societal influences.



National security of paramount importance: SC

New Delhi: The Supreme Court Wednesday set aside a verdict of the Madras High Court which had granted bail to eight alleged PFI members and office bearers, saying national security is always of "paramount importance" and any act aiding terrorist activity is liable to be restricted. The apex court said it was satisfied with the charge sheet filed in the case and material and documents relied upon by the National Investigation Agency (NIA) that there were reasonable grounds for believing that the accusations against them were "prima facie true".

Pune car crash: Accused teen's bail cancelled

Pune: Following an outcry, the Juvenile Justice Board here Wednesday cancelled the bail granted to a 17-year-old youth allegedly involved in a car accident and remanded him to an observation home till June 5. The board had granted bail to him Sunday hours after the accident in which two persons were killed, while also asking him to write a 300-word essay on road accidents, an order that drew an onslaught of criticism from various quarters. Police then approached the Board again, seeking a review of its order and permission to treat the teenager as an adult accused on the ground that the crime was of heinous nature. Police have registered a First Information Report against the minor, son of a real estate developer, under IPC sections 304 (culpable homicide not amounting to murder), 304 A (causing death by negligence), 279 (rash driving), 337 (causing hurt by an act which endangers human life), 338 (causing grievous hurt by an act endangering life or personal safety) and relevant sections of the Motor Vehicles Act.

Top court refuses to entertain Soren's plea

New Delhi, May 22: Jailed former Jharkhand Chief Minister Hemant Soren Wednesday failed to get any relief from the Supreme Court which pulled him up for "suppressing material facts" in his plea against his arrest in a money laundering case linked to an alleged land scam.

A vacation bench of justices Dipankar Datta and Satish Chandra Sharma allowed Soren's counsel Kapil Sibal to withdraw the pleas for interim bail for Lok Sabha poll campaigning and against his arrest after the apex court indicated that it would dismiss them as Soren has not approached

Questioning Soren's conduct of not disclosing complete facts before the court, Justice Datta said that he should have informed the bench that he had already applied for bail before the special PMLA court in Ranchi and it had been dismissed.

Kejriwal demands 'fair

More than half of the mangroves at risk of collapse: IUCN

DEFORESTATION, DEVELOPMENT, POLLUTION AND DAM CONSTRUCTION POSE A SERIOUS THREAT TO MANGROVES, BUT THE RISK TO THESE ECOSYSTEMS IS INCREASING DUE TO SEA-LEVEL RISE AND THE INCREASED FREQUENCY OF SEVERE STORMS DUE TO CLIMATE CHANGE

New Delhi, May 22: More than half of the world's mangrove ecosystems are at risk of collapse, with nearly one in five facing severe risk, according to the findings of the first global mangrove assessment.

Climate change threatens onethird (33 %) of the mangrove ecosystems, according to the study done using the International Union for Conservation of Nature's (IUCN) Red List of Ecosystems -- a global standard for measuring the health of ecosystems.

Deforestation, development, pollution and dam construction pose a serious threat to mangroves, but the risk to these ecosystems is increasing due to sea-level rise and the increased frequency of severe storms due According to the assessment, without significant changes by 2050, climate change and sea level rise will result in the loss of

1.8 billion tonnes of carbon stored (16% of the total current carbon stored in

protection for 2.1 million lives exposed to coastal flooding (14.5% of current lives exposed)

1 7 million days of fishing effort per year (14% of current fishing effort is supported by mangroves)

to climate change.

"IUCN's Red List of Ecosystems is key to tracking



progress towards the goal of halting and reversing biodiversity loss, in line with the Kunming-Montreal Global Biodiversity Framework. The first global assessment of mangrove ecosystems gives key guidance that highlights the urgent need for coordinated conservation of mangroves - crucial habitats for millions in vulnerable communities worldwide. The assessment's findings will help us work together to restore the

mangrove forests that we have lost and protect the ones we still have," Grethel Aguilar, IUCN Director General, said.

This study classified the world's mangrove ecosystems in 36 different regions called provinces and assessed the threats and risk of collapse in each region.

"Mangrove ecosystems are exceptional in their ability to provide essential services to people, including coastal disaster risk reduction, carbon storage and sequestration, and support for fisheries. Their loss stands to be disastrous for nature and people across the globe. That is why this assessment is so important,' Angela Andrade, Chair of IUCN Commission on Ecosystem Management, said.


One-third of the world's mangrove ecosystem provinces will be severely affected by sea-level rise, with 25% of the global mangrove area predicted to be submerged in the next 50 years.

The Northwest Atlantic, North Indian Ocean, Red Sea, South China Sea, and Gulf of Aden coasts are expected to be particularly severely affected, it said.

Mangroves store around 11 billion tonnes of carbon, which is almost three times the amount of carbon stored by tropical

forests of the same size. The assessment finds that maintaining mangrove ecosystems across the globe will be key for mitigating the impacts of climate change, with healthy

mangroves able to better cope with sea level rise and offering inland protection from the impacts of hurricanes, typhoons and cyclones.

Imran Khan hints at street agitation

In a message to his party workers, Khan claimed that during the "past two darkest years in Pakistan's history, PTI's political persecution was carried on with complete impunity". The cricketer-turnedpolitician is currently imprisoned in Rawalnindi's Adiala Iail as he serves several sentences in the Toshakana, un-Islamic marriage, and the cipher cases.

Three PIO students killed in accident

Washington: Three Indian-American students were killed and two others were injured in a fatal road accident as their speeding car flipped over in the US state of Georgia, according to the nolice. The deceased were identified as Sriva Avasarala Anvi Sharma and Arvan Joshi were passengers in a singlevehicle crash last week on Westside Parkway in Alpharetta, according to local police. Based on evidence at the scene, it is believed that the driver lost control of their car which then came to rest upside down in the tree line.

Vietnam security chief becomes new Prez

Bangkok: Vietnam's top security official To Lam was confirmed Wednesday as the nation's new president. He oversaw police and intelligence operations over a period when rights groups say basic liberties have been systematically suppressed, and its secret service was accused of violating international law. Lam was confirmed by Vietnam's National Assembly after his predecessor resigned amid an ongoing anticorruption campaign that has shaken the country's political establishment and business elites and has resulted in multiple top-level changes in government.

Tornado hits Lowa

Greenfield (lowa): Multiple people were killed when a tornado tore through a small town in Iowa and left a wide swath of obliterated homes and crumpled cars, while the howling winds also twisted and toppled wind turbines. After devastating Greenfield. a town of 2.000. Tuesday the storms moved eastward to pummel parts of Illinois and Wisconsin, knocking out power to tens of thousands of customers in the two states.

Norway, Spain, Ireland to recognise Palestinian state

Barcelona, May 22: Spain, Ireland and Norway said Wednesday that they would recognise a Palestinian state May 28, a step toward a long-held Palestinian aspiration that came amid international outrage over the civilian death toll and humanitarian crisis in the Gaza Strip following Israel's offensive.

The almost simultaneous decisions by two European Union countries, and Norway, may generate momentum for the recognition of a Palestinian state by other EU countries and could spur further steps at the United Nations, deepening Israel's isolation.

Currently, seven members of the 27-nation European Union officially recognize a Palestinian state. Five of them are former east bloc countries who announced recognition in 1988, as did Cyprus, before joining the bloc. Sweden announced recognition in 2014. The Czech Republic, an EU member, says that the 1988 recognition by the former Czechoslovakia — of which it then formed a part does not apply to the modern state. Slovakia's Foreign Ministry says that the two sides confirmed their recognition as Slovakia was becoming independent in 1992-93, and that the Palestinian state has a fully-functioning embassy in Bratislava since 2006.

EU members Malta and Slovenia say they may follow suit. Some 140 of the about 190 countries represented in the UN have already recognised a Palestinian state. Here's a look at how and why the new European announcements could



WHAT IS ISRAEL'S RESPONSE?

srael reacted rapidly Wednesday by recalling its ambassadors to Ireland, Norway and Spain. The Israeli government slams talk of Palestinian independence as a "reward" for the Hamas October 7 attack on southern Israel that killed 1,200 people and led to the abduction of over 250 others. It rejects any move to legitimise the Palestinians internationally. Steps like the ones by the three European countries Wednesday will harden the Palestinian position and undermine the negotiating process, Israel says, insisting that all issues should be solved through negotiations. Israel often responds to foreign countries' decisions deemed as going against its interests by summoning those countries' ambassadors and also punishing the Palestinians through measures such as freezing tax transfers to the cash-strapped Palestinian Authority.

WHY DOES IT MATTER?

A UN partition plan in 1947 called for the creation of a Jewish state alongside a Palestinian state, but Palestinians and the wider Arab world rejected it because it would have given them less than half of the land even though Palestinians made up two-thirds of the population.

The Arab-Israeli war the following year left Israel with even more territory, Jordan in control of the West Bank and east

Jerusalem, and Egypt in control of Gaza. In the 1967 war, Israel seized all three territories, and decades of on-again. off-again peace talks have failed. The United States, Britain and other Western countries have backed the idea of an independent Palestinian state existing alongside Israel as a solution to the Middle East's most intractable conflict, but they insist Palestinian statehood should come as part of a negotiated settlement.

Russia captured village previously claimed by Ukraine

Kyiv, May 22: Russia said Wednesday that its forces had retaken Klishchiivka, one of a handful of villages on the eastern front that Ukraine claimed back in a 2023 counteroffensive.

Russia's forces have in recent weeks made their biggest territorial gains in the war-battered east in the last 18 months as Ukraine waits for desperatelyneeded US and European weapon supplies.

Klishchiivka lies in the industrial Donetsk territory that the Kremlin claimed to have annexed in late 2022 even as its forces were struggling to gain ground there and at a great cost.

The Ukrainian army has come under intense pressure in the past two weeks, fighting off a fresh ground offensive in the Kharkiv region and further stretching critically short supplies of soldiers and ammunition.

"Units of the Southern grouping of troops liberated the village of Klishchiivka" in the eastern Donetsk region, the Russian defence ministry said.

Russian troops originally captured Klishchiivka in January 2023, but Ukraine clawed it back in September at the end of its mostly unsuccessful counter offensive.

Ukraine did not immediately comment but President Volodymyr Zelenskyy warned in an evening address Tuesday that the frontline was "extremely difficult." Russia's gains since launching its ground assault in Ukraine's northeast has forced Kyiv's already stretched army to rush in resources and troops from elsewhere. Russia Monday said it had captured the coveted Ukrainian stronghold of Bilogorivka, paving the way for it to fully control the eastern Lugansk region.

Climate change making flying more dangerous

Singapore, May 22: Most of us have experienced turbulence while traveling: when your plane flies through clashing bodies of air moving at widely different speeds.

Severe turbulence can put even the most seasoned flier on edge and make five minutes seem like an eternity. Usually it results in nothing more than a bumpy ride, but in the worst cases it can cause damage, injury and – in the case of Singapore Airlines flight SQ321 May 21 - fatality.

The death of the 73-year-old British man on a Singapore Airlines flight has again raised concerns about how climate change is increasing instances of flight turbulence.

Geoffrey Kitchen was among 211 passengers onboard the Boeing flight from London to Singapore when it plunged 6,000ft within minutes amid extreme weather. Kitchen was killed, while around 70 others were injured, after what passengers de-



scribed a "dramatic drop" with some people's heads slammed

into the ceiling above their seats. As air safety officials started their investigation into what happened, attention has focused on the role of climate change with a growing number of studies indicating erratic air circulation patterns are being ag-

gravated by the change in the earth's temperatures It follows a number of other incidents including a Spicejet flight from Kolkata to Mumbai that was hit by severe turbulence in May 2022, injuring 14 passengers. In March 2019, a Turkish Airlines flight from Istanbul to New York was also buffeted by severe turbulence over Maine, injuring 30 people, including a flight attendant who suffered a broken leg.

evidence that turbulence is increasing because of climate

Williams said his research team recently discovered that severe clear-air turbulence in the North Atlantic has increased by 55 per cent since 1979, for example.

The team's latest projections signal that severe turbulence in the jet streams could double or triple in the coming decades if global conditions continue as expected, he said.

In short, buckle up. Turbulence can be tricky to predict, but experts stress that the first line of defense in the air is keeping the seat belt fastened, whenever possible.

"Planes are generally built to withstand turbulence," Guinn said, noting that passengers not wearing their seat belts is a large source of injuries from in-flight turbulence. While no precaution is foolproof, wearing a seat belt greatly increases an individual's chances of avoiding serious injuries, he said in a statement.

India, China agree to use local currencies for imports: Maldives

Male, May 22: The Maldives Wednesday said both India and China have agreed to cooperate in efforts to pay for imports in their respective countries' currency instead of the US dollar, which is likely to help Male save almost 50 per cent of the annual \$1.5 million imports bill from the two countries.

Maldives' Development Minister Mohamed Saeed said he met with the Indian High Commissioner Munu Mahawar two weeks ago, who in turn, said that New Delhi would support and cooperate in arranging for the settlement of import payments in Indian Rupee.

Similarly, Saeed said, he received a letter from China's Commerce Ministry, two days ago, in which Beijing provided assurance it will cooperate in allowing the option to settle import payments in Yuan, the Chinese currency, as requested by President Mohamed Muizzu.

Annually, Maldives imports goods worth \$780 million and \$720 million from India and China respectively, the minister had said in April when he had first announced that the Maldives was discussing with India and China if the island nation can make payments for its imports from the country in Maldivian Rufiyaa.

International trade between two countries in local currency is a mutually beneficial mechanism as it helps in saving each other's foreign exchange reserves. Moreover, the move will mark a significant shift away from the dominant use of the US dollar in international transactions.

In July 2023, the Government of India declared that Maldives was among the 22 countries that were permitted by the Reserve Bank of India to open Special Rupee Vostro Accounts (SRVAs) as part of efforts to promote bilateral trade in local currencies.





Power Grid net profit dips slightly

New Delhi: State-owned Power Grid Corporation on Wednesday reported a nearly four per cent dip in its consolidated net profit to ₹4,166.33 crore in the March 2024 quarter, mainly due to a marginal decline in income. The company reported a consolidated net profit of ₹4,322.87 crore in the quarter ended March 31, 2023, a BSE filing showed. Total income declined to ₹12,305.39 crore in the quarter as compared to ₹12,557.44 crore in the same period a year ago. For fiscal 2023-24, the consolidated net profit rose to ₹15,573.16 crore from ₹15,419.74 crore a year ago. Total income in the fiscal rose to ₹46,913.12 crore as the year-ago period.

Petronet LNG net rises 20%

New Delhi: Petronet LNG Ltd -- India's largest liquefied natural gas importer -Wednesday reported a 20 per cent rise in the March quarter net profit on the back of importing higher LNG volumes. For the entire 2023-24 fiscal (April 2023 to March 2024), Petronet reported highest-ever net profit of ₹3.536 crore on the back of a 22 per cent growth in volume throughput. The net profit reported in the March quarter was ₹738 crore as compared with ₹614 crore in the same period of the previous year, Petronet MD & CEO Akshay Kumar Singh told reporters. The profit was, however, lower than ₹1,191 crore earned in the preceding quarter.

Sun Pharma net profit at ₹2,654cr

New Delhi: Sun Pharmaceutical Industries Ltd Wednesday reported a consolidated net profit of ₹2,654.58 crore in the fourth quarter ended on March 31, 2024. The company had posted a consolidated net profit of ₹1,984.47 crore in the fourth quarter of the previous fiscal, Sun Pharmaceutical Industries said in a regulatory filing. Consolidated total revenue from operations in the fourth quarter was at ₹11,982.9 crore in the quarter under review. It was at ₹10,930.67 crore in the same quarter a year ago, it added. Mumbai, May 22: The Reserve Bank of India will pay a record ₹2.1 lakh crore dividend to the government for the fiscal ended March 31, more than double of what was budgeted expectation, helping shore up revenue ahead of a new government taking of-

The RBI board, at its 608th meeting Wednesday, approved the transfer of surplus, the central bank said in a statement.

The government had budgeted a receipt of ₹1.02 lakh crore as dividends from the RBI, public sector banks and financial institutions in the interim budget for the fiscal year 2024-25 (April 2024 to March 2025) presented in February this year.

fer by the RBI to the Centre was ₹87,416 crore for the fiscal 2022-23. The previous high was ₹1.76 lakh crore in 2018-19.

"The Board...approved the transfer of ₹2,10,874 crore as surnlus to the Central Government for the accounting year 2023-24," the RBI said in a statement.

The central government aims to contain the fiscal deficit or gap between expenditure and revenue to ₹17.34 lakh crore (5.1 per cent of the GDP) during the current financial year.

Experts opined that higherthan-budgeted dividend payout will provide headroom to the new government to enhance expenditure and better manage the fiscal deficit. The results of the ongoing

Lok Sabha elections will be declared June 4 and the new government will assume power shortly thereafter. The RBI board also re-

viewed the global and domestic economic scenario, including risks to the growth outlook. The Board discussed the

working of the Reserve Bank during 2023-24 and approved its Annual Report and Financial Statements for the



last fiscal.

The RBI said that during accounting years 2018-19 to 2021-22, owing to the prevailing macroeconomic conditions and the onslaught of the Covid-19 pandemic, the Board had decided to maintain the Contingent Risk Buffer (CRB) at 5.50 per cent of the Reserve Bank's balance sheet size to support growth and overall economic activity.

"With the revival in economic growth in FY 2022-23, the CRB was increased to 6.00 per cent. As the economy remains robust and resilient, the Board has decided to increase the CRB to 6.50 per cent for FY 2023-24," the central bank added.

The transferable surplus for 2023-24, the RBI said, has been arrived at on the basis of the Economic Capital Framework (ECF) adopted by it in August 2019, as per recommendations of the Bimal Jalan-headed expert committee.

The committee had recommended that the risk provisioning under the CRB be maintained within a range of 6.5 to 5.5 per cent of the RBI's balance sheet.

Upasna Bhardwaj, Chief Economist, Kotak Mahindra Bank, said such a windfall will ease the fiscal deficit by 0.4 per cent in 2024-25.

"Higher interest rates both

rities, significantly high gross sale of forex, along with limited drag from liquidity operations compared to the previous year have probably led to such a whopping dividend. Positively, this comes with the contingency risk buffer being kept at the higher end of the statutory requirement," she said.

Scope for lower borrowing being announced in the upcoming Budget will now provide significant respite to the bond markets, Bhardwaj added.

Aditi Nayar, Chief Economist, Head Research and Outreach, Icra Ltd said that the higher-than-budgeted RBI surplus transfer would help to boost the Centre's resource envelope in the current fiscal, allowing for enhanced expenditures or a sharper fiscal consolidation than what was pencilled into the Interim Budget for 2024-25.

"Increasing the funds available for capex would certainly boost the quality of the fiscal deficit. However, the additional spending may be difficult to be incurred within the 8-odd months left after the Final Budget is presented and approved by Parliament." Navar said.

Hotel industry sees strong demand during Jan-Mar: Report

New Delhi, May 22: India's hotel industry saw strong demand at both business and leisure destinations during the January-March period this year leading to an 11 per cent annual rise in revenue per available room, according to JLL.

In a statement Wednesday, real estate consultant JLL India said that the hospitality sector saw an increase in Average Daily Rate (ADR) of 8.5 per cent yearon-year, resulting in a revenue per available room (RevPAR) growth of 11.4 per cent.

Chennai recorded the strongest growth in RevPAR at 21.7 per cent in January-March.

"Major factors contributing to this growth included an increase in corporate travel, weddings, and Meetings, Incentives, Conferences and Exhibitions (MICE) demand," the consultant said.

During the first quarter of 2024, there was a robust demand for hotel rooms in both business and leisure destinations. The occupancy levels in key business markets were strong, averaging around 70 per cent, and supported by significant growth in average daily occupancy levels

There were 90 branded hotel signings comprising 9,710 rooms during January-March 2024. Furthermore, 13 hotels signed were conversions of other hotels, accounting for 12 per cent of the inventory signed in Q1 2024. "Branded hotel openings com-

prised 36 hotels with 2,316 keys, of which 75 per cent of the total number of keys were in Tier II and III cities, including Jaipur, Indore, Surat, and Ayodhya, to name a few." the consultant said.

India exports over 45,000 tonnes onion after lifting ban



New Delhi, May 22: India has exported more than 45,000 tonnes of onion since the ban on outbound shipments was lifted early_ this month, a top government official said Wednesday.

These exports provided relief to farmers after curbs were imposed to keep domestic supplies steady ahead of general elections. The world's biggest vegetable exporter banned exports of the bulb last December and then extended it in March, after a rise in prices triggered by slug-

gish production. "Since the ban was lifted, more than 45,000 tonnes of onions have been exported, mostly to the Middle East and Bangladesh,' Nidhi Khare, Secretary of the Consumer Affairs Ministry, told PTI. To keep onion prices affordable during the election period. the government on May 4 lifted the ban but imposed a minimum export price (MEP) of USD 550 per tonne. Khare said the forecast of a good monsoon this year will ensure better sowing of kharif (summer) crops, including onion

The 30-share BSE Sensex climbed 267.75 points or 0.36 per cent to settle at 74.221.06. During the day, it jumped 354.48 points or 0.47 per cent to 74,307.79.

Extending gains to the fifth day in a row, the NSE Nifty rose by 68.75 points or 0.31 per cent to finish at 22,597.80. FMCG and realty shares supported the uptrend while banking and metal shares declined.

"Despite mixed global market sentiments ahead of the US Fed minutes, Indian markets exhibited a subtle positive trend. Investors are optimistic about stable Q4 earnings and easing election jitters that had previously increased volatility. Interest in the FMCG sector has risen due to the potential for an early onset of monsoon. Nevertheless, markets may underperform in the short term as they wait for the election outcome, with FIIs staying on the sidelines," Vinod Nair, Head of Research, Geojit Financial Services, said.

Hindustan Unilever, Reliance Industries, Infosys, Asian Paints, ITC and UltraTech Cement were the major gainers.

Among the Sensex firms,

State Bank of India, JSW Steel, Axis Bank, ICICI Bank, Tata Steel and Tata Motors were among the laggards

"Nifty ended a range-bound session in the positive. Nifty settled higher for the fifth consecutive session and recorded its longest winning streak since April 25," said Deepak Jasani, Head of Retail Research, HDFC Securities.

ket capitalisation of BSE-listed companies stood at ₹4,15,94,033.72 crore (USD 5 trillion) -- its alltime high. Investor wealth rose for the

ninth straight trading session Wednesday. Investors gained ₹22.59 lakh crore Wednesday.

"Despite weak global cues, markets moved in a range and were positive for most part of the trading session aided by selective buying in IT, FMCG and realty stocks," said Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd.

The combined market capitalisation of BSE-listed companies hit the USD 5-trillion milestone for the first time in intra-day trade Tuesday. At the close of trade, the total valuation of the exchange-listed companies stood at ₹4,14,62,306.56 crore (USD 4.97 trillion), the BSE data showed.

The combined market valuation of all listed companies on the BSE reached the USD 4 trillion milestone for the first time ever on November 29 last

The m-cap of all listed companies on the BSE touched the USD 3 trillion mark May 24, 2021.The total valuation of ex-

change-listed companies went past the USD 1 trillion level May 28, 2007. The journey from USD 1 tril-

lion to USD 1.5 trillion was covered in 2,566 days, or just over seven years June 6, 2014. The m-cap of listed companies

reached USD 2 trillion July 10, 2017 -- taking 1,130 days from the USD 1.5 trillion level. It took ten years for the exchange to reach from USD 1 trillion level to USD 2 trillion in market capitalisation. From there, it took 1,255 days

to go past the USD 2.5-trillion mark December 16, 2020.

So far this year, the BSE benchmark has climbed 1,980.8 points, or 2.74 per cent. It hit an all-time peak of 75,124.28 April 9 this year.

Mumbai, May 22: India's gold imports in 2024 could fall by nearly a fifth from the previous year, as record high prices spur retail consumers to exchange old jewellery for new items, the head of an industry body told

Lower imports by India, the world's second biggest consumer of the precious metal, could cap a rally that carried global prices to a record this week. "Affordability is severely af-

fected by the rapid price increase," said Prithviraj Kothari, president of the India Bullion and Jewellers Association (IBJA). "Retail buyers prefer exchanging old jewellery for new."

Buyers save money as they only pay the jewellery making charges and tax when exchanging old ornaments for new ones, since they do not have to pay for

Preparing for his daughter's wedding, Vinayak Patil exchanged 50 grams of old jewellery for new ornaments this month as prices put new jewellery out of reach financially.

Jewellery demand accounts for three-quarters of the total demand, while investment demand makes up the rest.

Investment demand was strong earlier this year, but now record prices are prompting some investors to liquidate holdings and book profits, said Ashok Jain, proprietor of Mumbai-based gold wholesaler Chenaji Narsinghji.

Rajasthan win 'Royal faceoff'

Ahmedabad, May 22: Rajasthan Royals ended Royal Challengers Bengaluru's roller coaster run in the Indian Premier League with a scratchy four-wicket win in the Eliminator here Wednesday, The 2008 winners Royals face Sunrisers Hyderabad in Chennai Friday for a place in the IPL final.

After their bowlers had done their part well to keep RCB to 172/8, RR batters stuttered in the middle overs to allow RCB back into the contest which remained hung in balance for the majority of the second half, but the 2008 winners eventually got home with an over to spare.

Chasing 173, Rajasthan ended with 174/6 as Rovman Powell (16 n o) provided the finishing touches in a tense finish. As he has done several times before this season, Riyan Parag (36) showcased deep resolve in an adverse situation to help Rajasthan stay alive in the tournament. It was Royals' first win after four losses and an abandoned game.

In a contest wherein fortunes swung from one side to another, RR remained ahead with impactful performances through out even though Mohammed Siraj (2/33) raised late hopes for RCB with wickets of Parag and Hetmyer in the 18th over. With 13 needed off last two overs, Powell found two fours off Lockie Ferguson to seal the deal in favour of his side.

Earlier, it was Yashasvi Jaiswal (45 off 30 balls) who gave them the impetus at the top. Off to an unconvincing start with his ini-



tial runs coming off the outside edge, Jaiswal grew in confidence. At the other end, Tom Kohler-Cadmore (20) also hit a couple of fours against Siraj and while getting a lifeline from Glenn Maxwell, who spilled a sitter at deep square leg off Dayal.

With RR's acceleration rapidly shaving runs off the target, RCB needed a breakthrough and Ferguson provided the first success when he foxed Kohler-Cadmore with a slow yorker which crashed into the stumps.

The gradual progression of Jaiswal's innings saw the batter finding his rhythm, but the extreme heat sapped him out completely. In between the ninth and the 10th over, Jaiswal received on-field treatment and got back up only to play a loose shot — an attempted ramp off Cameron Green but only gloved it to the 'keeper.

Soon after, Karn Sharma dealt a body blow by having Sanju Samson (17) stumped. With their tails up, RCB continued making inroads with Dhruv Jurel (8) being run out after a brilliant effort from Virat Kohli and Green.

RR were firmly under pressure heading into the 15th over when they chose to go after Green, who had been all over them with three tidy overs and a wicket up until then.

Earlier, Rajasthan Royals put forth a sharp bowling effort. Led by Trent Boult (1/16), who produced an opening spell of 3-0-6-1, RR bowlers kept taking wickets at crucial stages to control the

The venerable Ravichandran Ashwin (2/19) left an indelible mark with wickets Green (27) and Maxwell (0) on consecutive deliveries while Avesh Khan (3/44) also chipped in. Rajasthan's bowling was adequately backed up by their fielders, particularly Rovman Powell, who took two stunning catches that clipped

Kobe (Japan), May 22: India's Sachin Sarjerao Khilari defended his gold medal in the men's shot put F46 category with an Asian record at the World Para Athletics Championship as the country surpassed its best-ever haul in the global competition here Wednesday.

Dharambir claimed a bronze medal in the men's club throw F51 category to take India's tally to 12 medals (five gold, four silver and three bronze) and maintain their third spot in the standings behind China (18-16-14) and Brazil (17-8-5).

Sachin's gold earlier in the day bettered India's previous best tally of 10 (3 gold, 4 silver and 3 bronze) in the 2023 edition in Paris. Sachin heaved the iron ball to a distance of 16.30 metres, bettering his own Asian record of 16.21 metres set during the World Para Athletics Championship in Paris last year. His effort also earned him a place in Paris Paralympics.

The F46 category in para athletics events is for those with moderately affected movement in one or both arms or the absence of limbs. These athletes have to transmit power from hips and legs into the throw.

Sachin, who hails from Karagani village Maharashtra's Sangli district, he suffered a mishap during his school days leading to disability in his left arm. The stocky 34year-old lost his muscles from the elbow due to gangrene and despite multiple surgeries, his arm never recovered.

In the men's club throw F51 final, Dharambir gradually improved his throws and propelled

the club to a distance of 33.61 metres in his fifth and penultimate attempt to secure the bronze.

Zelijko Dimitrijevic of Serbia smashed the meet record with a throw of 34.20m to win the gold, while Mario Santana Hernandez of Mexico bagged the silver with a season's best effort of 33.62m.

The men's club throw F51 category is for para athletes with severe trunk and limb impairments. Competitors throw a club from a seated position, relying solely on their arm and shoulder strength. F51 classification is reserved for athletes with the most significant impairments in this category.

India had reaped a rich haul of five medals Tuesday to swell its tally to 10 (4 gold, 4 silver, 2 bronze). China is currently leading the medals tally followed by Brazil. With three more days still to go, India are in with a chance of winning a few more medals including gold and head coach Satyanarayan said he was quite optimistic.

Reigning Paralympics champion Sumit Antil had defended his F64 javelin throw world title Tuesday, while Thangavelu Mariyappan and Ekta Bhyan also grabbed gold medals in their respective events as India jumped to third place in the World Para Athletics Championships here. Antil sent his spear to a distance of 69.50m to stand on top of the

The 25-year-old Haryana athlete thus continued his global domination in the F64 javelin event. He is the current world record holder also, courtesy his massive 73.29m throw while winning gold in the Para Asian Games in Hangzhou, China last year.

Sindhu sails into Rd 2 at Malaysia Masters

Kuala Lumpur, May 22: Returning from a break, twotime Olympic medallist PV Sindhu progressed to the women's singles second round with a straight-game win over Scotland's Kirsty Gilmour at the Malaysia Masters Super 500 badminton tournament here Wednesday.

World No.15 Sindhu, who had skipped the Uber Cup and Thailand Open, notched up a 21-17, 21-16 win over Gilmour, who is ranked 22nd, in the opening-round match that lasted 46 minutes. The fifth-seeded Indian, who last won a title in 2022 Singapore Open, will next face Korea's Sim Yu Jin.

In mixed doubles, B Sumeeth Reddy and N Sikki Reddy, World No.53, also advanced to the second round after outlasting Hong Kong qualifiers Lui Chun Wai and Fu Chi Yan 21-15, 12-21, 21-17 in 47 minutes. The husbandwife duo will have the task of taming the top seeds Chen Tang Jie and Toh Ee Wei of Malaysia

For Sindhu, it was her third win over Gilmour, a two-time medallist in the Commonwealth Games. The 28-year-old Sindhu was quick to open up a 7-1 lead but Gilmour managed to claw



back at 14-14 and 15-15. The Indian, however, dashed her hopes of a challenge as she grabbed six of the next eight points to take the first game.

After the change of sides, Sindhu was more ruthless as she didn't allow her opponent to make any comeback after once again gaining an early 3-0 lead. Sindhu was 11-6 at the break and kept moving ahead to grab eight match points. To her credit, Gilmour saved four match points before Sindhu sealed the match comfortably.

Compound eve archers in final

Yecheon (South Korea), May 22: World No.1 Indian women's compound team stormed into the final of the archery World Cup Stage II but the men's team will return empty-handed from the tournament after losing the bronze medal clash to Australia here Wednesday.

The trio of Jyothi Surekha Vennam, Parneet Kaur and Aditi Swami, that had clinched gold medal in World Cup Stage 1 in Shanghai leg last month, knocked out World No.4 USA 233-229 in the semifinal.

India will now clash with world number seven Turkey in the gold medal clash Saturday. Turkey had stunned top-seed and local favourites South Korea 234-233 in the other semifinal.

It was an overall easy sailing for the Indian women's team, which got a bye into the quarters after finishing second in the qualifying round. They eliminated Italy 236-234 in the lasteight.

The World No.1 men's team of Priyansh, Prathamesh Fuge and veteran Abhishek Verma, who had slipped to fourth in the qualifying round Tuesday, lost to lowly-ranked Australia 133-133 (10-10*) in a shoot-off.

The Aussies, who are world ranked 21st, took the Indian trio by surprise starting with a 59, dropping just one point. The Aussies team of Bailey Wildman,

four ended The two teams were 30-all in the ensuing shoot-off but the Aussies edged out the inconsistent Indians by shooting two Xs (arrows closer to centre) to

secure the bronze medal. Having started their campaign with an easy 235-212 win over lowly-ranked Vietnam, India overcame tough competition from Denmark and top seed USA, winning both the matches in shoot-off.

Meanwhile, the veteran duo of Tarundeep Rai and Deepika Kumari finished fourth and sixth in their respective quali-

The 2010 Asian Games silver medalist Rai shot 681 points for a sixth spot in rankings, while Dhiraj Bommadevara narrowly missed a top 10 finish on X (closer to centre) count after five archers shot 678 with the Indian finishing 11th.

MEN BEAT ARGENTINA IN SHOOTOUT, WHILE THE EVES HUMBLED BY SAME OPPOSITION

Antwerp (Belgium), May 22: It was a day of contrasting fortunes for Indian hockey teams against Argentina in the FIH Pro League as the men's side registered a 5-4 win in the shootout, while the women's team suffer a humiliating 0-5 defeat.

In the shootout, skipper Harmanpreet Singh and Sukhjeet Singh scored twice each with Abhishek being the other scorer.

The eyes, on the other hand, suffered a humiliating defeat to

Argentina to begin their European leg of the Pro League campaign on a disappointing note. Julieta Jankunas (53rd, 59th minutes) struck a brace, while Agustina Gorzelany (13th), Valentina Raposo (24th) and Victoria Miranda (41st) were the other goal getters for the Argentines.

match into shootout. The Indian women's and men's teams will take on hosts Belgium Thursday and Friday, respectively, in the European leg of the Pro League.

Playing Carlsen in his home turf not a challenge for Pragg

Stavanger (Norway), May 22: Having beaten Magnus Carlsen several times in the last couple of years, young Indian Grandmaster R Praggnanandhaa feels he will be under no pressure when he takes on the multipletime world champion in his home turf during the Norway Chess tournament, which gets underway here May 27.

Pragg last beat the 33-year-old Carlsen in the Superbet rapid and blitz tournament, a part of the Grand Chess Tour, in Warsaw earlier this month.

"I don't think playing Magnus in his home turf is a challenge for me. Usually, it matters to the player playing in his home but it won't matter so much for me. said Praggnanandhaa, who will also have his sister R Vaishali playing the Norway Chess Women's Tournament for the first time.

The 11-day tournament will

see a very strong field including the likes of world champion Ding Liren and Hikaru Nakamura besides home favourite Carlsen. Reflecting on his contest with Carlsen at last year's FIDE World Cup where Praggnanandhaa gave the Norwegian a tough challenge, the Indian GM said the experience here would help him in future competitions.

"I always enjoy a good challenge. After the World Cup last year, this will be my first classical game with him. I am quite excited to play him and equally excited to play the others. No doubt the experience here will help me in future tournaments," said Praggnanandhaa in a Norway Chess release.

"I am very happy and excited to play in Norway Chess. The field is extremely strong. This is perhaps the strongest field I have played and I see this as an opportunity and a challenge to givemy best," added the 18-year-old.
